OSHA Pulls Guidance Stating Employers May Be Held Liable For 'Adverse Reactions' If They Mandate Vaxx

The Occupational Safety and Health Administration threw workers under the bus over the weekend by pulling their new guidance which stated that <u>employers they</u> may be held liable for "any adverse reactions" if they mandate employees take COVID-19 vaccines "as a condition of their employment."

On April 20, OSHA released a new **FAQ** on their website stating that if employers require their employees to be Vaxxed *"then any adverse reaction to the COVID-19 vaccine is work-related"* (and therefore must be recorded for, at the very least, worker compensation claims).

Vaccine Related

Are adverse reactions to the COVID-19 vaccine recordable on the OSHA recordkeeping log?

If I require my employees to take the COVID-19 vaccine as a condition of their employment, are adverse reactions to the vaccine recordable?

If you *require* your employees to be vaccinated as a condition of employment (i.e., for work-related reasons), then any adverse reaction to the COVID-19 vaccine is work-related. The adverse reaction is recordable if it is a new case under 29 CFR 1904.6 and meets one or more of the general recording criteria in 29 CFR 1904.7.

I do not require my employees to get the COVID-19 vaccine. However, I do recommend that they receive the vaccine and may provide it to them or make arrangements for them to receive it offsite. If an employee has an adverse reaction to the vaccine, am I required to record it?

OSHA appears to have caved to political pressure and scrapped their own wellthought-out, pro-worker guidance after just one month so as not to "disincentivize employers' vaccination efforts." Their FAQ now states: DOL and OSHA, as well as other federal agencies, are working diligently to encourage COVID-19 vaccinations. OSHA does not wish to have any appearance of discouraging workers from receiving COVID-19 vaccination, and also does not wish to disincentivize employers' vaccination efforts. As a result, OSHA will not enforce 29 CFR 1904's recording requirements to require any employers to record worker side effects from COVID-19 vaccination through May 2022. We will re-evaluate the agency's position at that time to determine the best course of action moving forward.

OSHA was created to protect workers' rights and instead it's trampling all over them on behalf of Big Pharma.

Nobel Prize Winner says Covid Vaccination is an "Unacceptable Mistake" That's Spreading "Variants"

There is no legitimate excuse for the medical police state to have unleashed "vaccines" for the Wuhan coronavirus (Covid-19) when the jabs are known to create and spread "variants" of the disease, warns French virologist and Nobel Prize winner Dr. Luc Montagnier.

Calling the injections an "<u>enormous</u>" and "<u>unacceptable mistake</u>," <u>Montagnier is</u> sounding the alarm about how the jabs are causing and spreading the Chinese Virus among both the vaccinated and the unvaccinated, which is going to lead to disaster.

"It's an enormous mistake, isn't it? A scientific error as well as a medical error. It is an <u>unacceptable mistake</u>," he stated during a recent interview. "<u>The history books will show</u> that because it is the vaccination that is creating the variants."

Many believe that Montagnier is being too kind by calling it a mistake when it seems obvious that this was all planned long in advance for this very purpose to create the problem rather than "cure" it. One need to remember, even his guarded words are being heavily censored in every area of media.

At least he is talking about it, though. Many other epidemiologists and virologists are choosing to remain "silent" about the *"antibody-dependent enhancement"* that occurs after people are injected with these chemical cocktails.

"It is the antibodies produced by the virus that enable an infection to become stronger," he told Pierre Barnérias of Hold-Up Media in an interview earlier this month.

While it is certainly possible that some variants are occurring without the help of vaccines, the mass vaccination drive, he says, is clearly causing a bulk of the problem.

"What does the virus do? Does it die or find another solution?" he asked. "It is clear that the new variants are created by antibody-mediated selection due to the vaccination."

Vaccinating during a pandemic is "*unthinkable*," Montagnier says.

There should not even be vaccinations being administered during a pandemic, Montagnier added, calling the notion *"unthinkable"* – and yet here we are with medical "experts" everywhere telling us that this is a good thing.

Injecting people with chemicals directly associated with a circulating virus will only make the problem worse, he implied, noting that we are now seeing the same trends all over the world post-injection.


"The new variants are a production and result from the vaccination. You see it in each country, it's the same: in every country, deaths follow vaccination."

Montagnier spoke out last spring as well, warning that the Wuhan Flu was clearly labcreated and did not just come from some bats at a wet market.

He also warned the world that the genetically modified (GMO) virus had been spliced to contain 18 fragments of the DNA of HIV genome, which just so happens to be what Anthony Fauci was focused on during the early days of his decades-long federal

The CDC Misled the U.S. by Implying That There Is a 10% Risk of COVID Transmission Outdoors. Instead, It Is Close to Zero.

The CDC claimed that the risk of transmitting Covid outdoors was *less* than 10% if wearing mask, but the *'New York Times'* discovered that the agency's number was grossly exaggerated, and is likely less than .01%. The CDC used data from a study from Singapore that combined indoor with outdoor construction sites. The CDC figure is important because it recommended that vaccinated people still wear masks outdoors in large venues, and that the unvaccinated mask up in almost all outdoor settings. The CDC's false information was used to push for mail-in voting that encouraged fraud, in addition to other harmful policies.

When the Centers for Disease Control and Prevention released new guidelines last month for mask wearing, it announced that "less than 10 percent" of Covid-19 transmission was occurring outdoors. Media organizations repeated the statistic, and it quickly became a standard description of the frequency of outdoor transmission.

But the number is almost certainly misleading. It appears to be based partly on a misclassification of some Covid transmission that actually took place in enclosed spaces (as I explain below). An even bigger issue is the extreme caution of CDC officials, who picked a benchmark — 10 percent — so high that nobody could reasonably dispute it.

That benchmark "<u>seems to be a huge exaggeration</u>," as Dr. Muge Cevik, a virologist at the University of St. Andrews, said. In truth, the share of transmission that has occurred outdoors seems to be below 1 percent and <u>may be below 0.1 percent</u>, multiple epidemiologists told me. The rare outdoor transmission that has happened almost all seems to have involved crowded places or close conversation.

Saying that less than 10 percent of Covid transmission occurs outdoors is akin to saying that <u>sharks</u> attack fewer than 20,000 swimmers a year. (The actual worldwide number is around 150.) It's both true and deceiving.

This isn't just a gotcha math issue. It is an example of how the CDC is struggling to communicate effectively, and leaving many people confused about what's truly risky. CDC officials have placed such a high priority on caution that many Americans are bewildered by the agency's long list of recommendations. Zeynep Tufekci of the University of North Carolina, writing in '*The Atlantic*', called those recommendations "simultaneously too timid and too complicated."

They continue to treat outdoor transmission as a major risk. The CDC says that unvaccinated people should wear masks in most outdoor settings and vaccinated people should wear them at "large public venues"; summer camps should require children to wear masks virtually "at all times."

These recommendations would be more grounded in science if anywhere close to 10 percent of Covid transmission were occurring outdoors. But it is not. There is not a single documented Covid infection anywhere in the world from casual outdoor interactions, such as walking past someone on a street or eating at a nearby table. It is further evidence of the corruption going on at the CDC.

A New Report Has Determined the Pfizer Vaccine May Cause Alzheimer's and Other Conditions

In a shocking new report on the COVID-19 vaccines, it has been discovered that the Pfizer coronavirus vaccine may have long term health effects not previously disclosed, including "ALS, Alzheimer's, and other neurological degenerative diseases."

"The current RNA based SARSCoV-2 vaccines were approved in the US using an emergency order without extensive long term safety testing," the report declares. "In this paper the Pfizer COVID-19 vaccine was evaluated for the potential to induce prionbased disease in vaccine recipients." Prion-based diseases are, according to the CDC, a form of neurodegenerative diseases, meaning that the Pfizer vaccine is potentially likely to cause long term damage and negative health effects with regards to the brain.

This is especially concerning since the Pfizer vaccine is an mRNA vaccine, an untested type of vaccine which creates new proteins and can actually <u>integrate into the human</u> <u>genome</u>, according to a report from the National Library of Medicine. In other words, degenerative brain conditions may appear at any time in your life after receiving the vaccine.

"The RNA sequence of the vaccine as well as the spike protein target interaction were analyzed for the potential to convert intracellular RNA binding proteins TAR DNA binding protein (TDP-43) and Fused in Sarcoma (FUS) into their pathologic prion conformations," explains the report. TDP-43 is a protein known to cause dementia, ALS and even Alzheimer's, according to <u>Alzpedia</u>. Similarly, the FUS protein is known to cause ALS and Hereditary Essential Tremors, according to the <u>Human Genome</u> <u>Database</u>.

The experiment done for the report was to determine whether or not these two harmful proteins embed themselves into our DNA, as an mRNA vaccine is expected to do. The report determined that *"the vaccine RNA has specific sequences that may induce TDP-43 and FUS to fold into their pathologic prion confirmations,"* meaning that both proteins have the potential to embed themselves into our DNA and cause harmful neurological diseases.

The report's abstract summary concludes that "The enclosed finding as well as additional potential risks leads the author to believe that regulatory approval of the RNA based vaccines for SARS-CoV-2 was premature and that the vaccine may cause much more harm than benefit." The report itself ends with this warning: "The vaccine could be a bioweapon and even more dangerous than the original infection."

National File actually reached out to the CDC to inquire as to why the Pfizer vaccine is still being distributed despite these credible allegations. No response was received prior to publication.

New Pfizer Study: Four Fifths of All Vaccinated Children Aged 12 and Over Complain of Side Effects

Pfizer/BioNTech published a study on the safety and use of their vaccine last Wednesday. It refers to the current status of the vaccination studies in the context of emergency approval. Some 78,9 percent of the vaccinated children developed some form of side effect. Published: May 26, 2021,

The pharmaceutical giant released a 37-page "fact sheet" of its product on May 19, 2021 on security and application republished by <u>*Report24*</u>. It refers to the current status of vaccination studies in the context of the emergency approval EUA (Emergency Use Authorization).

The U.S. health authority CDC has confirmed that children and adolescents develop Covid-19 in an extremely mild manner, if at all. Also, children and adolescents from the age of 12 cannot make the decision about an injection alone. <u>Despite this, children are being targeted</u>. The study showed that up to 80 percent of children develop side effects that can lead to severe trauma.

The new "factsheet" showed that the *BioNTech/Pfizer* vaccination was tested on 1097 children and adolescents from 12 to 15 years of age. At least 866 out of 1097 children developed some form of unpleasant side effect. In 466 the side effects were described as "mild", in 393 they were "moderate" and in 7 they were described as "severe".

The study was set up as a double-blind study, one in which neither the participants nor the experimenters know who is receiving a particular treatment. In addition to the 1127 children and adolescents injected with the first dose and 1097 with the second dose,

1127 and 1078 were injected with a saline solution as a placebo. The differences were remarkable: of the children vaccinated with the real vaccine, over five times as many complained of side effects within the first seven days.

In detail these were: <u>First vaccination</u> Fever over 38 degrees C (114) Fatigue (677) Headache (623) Shivering (311) Vomiting (31) Diarrhea (90) Muscle pain (272) Joint pain (109)

<u>Second vaccination</u> Fever over 38 degrees C (215) Fatigue (726) Headache (708) Shivering (455) Vomiting (29) Diarrhea (65) Muscle pain (355) Joint pain (173)

Potentially fatal appendicitis is one of the potentially serious side effects that were seen more frequently in those injected with the product than in the comparison group.

The number of short-term serious side effects is given by *Pfizer/BioNTech* as 0,4 to 0,8 percent of those injected. Over the long term, these may increase. There are currently around 82 million people between the ages of 0 and 19 in the US. If all of these children and adolescents were to be vaccinated, between 330 000 to 660 000 recipients could be expected to have <u>immediate severe side effects</u>.

Nevertheless, the system media and health authorities are making children and their parents believe that they urgently need to be vaccinated with the experimental mRNA products.

Relative to those vaccinated so far, something that has not been mentioned is the question, of the Vaxxs offered, there is a potential issue that has not been discussed. I questioned such a possibility in January when the Vaxx campaign got underway the possibility that maybe their Vaxx plan might create a confusing situation for analysts by administering the saline placebo to some and not others. Such an attempt would make sense if you wanted to deceive and create a situation that might throw off any deliberate effort to mislead the many agencies tracking and studying the facts. The European database of suspected drug reaction reports is <u>EudraVigilance</u>, which also tracks reports of injuries and deaths following the experimental COVID-19 "vaccines."

Here is what **<u>EudraVigilance</u>** states about their database:

This website was launched by the <u>European Medicines Agency</u> in 2012 to provide public access to reports of suspected side effects (also known as suspected adverse drug reactions). These reports are submitted electronically to EudraVigilance by national medicines regulatory authorities and by pharmaceutical companies that hold marketing authorizations (licenses) for the medicines.

EudraVigilance is a system designed for collecting reports of suspected side effects. These reports are used for evaluating the benefits and risks of medicines during their

development and monitoring their safety following their authorization in the European Economic Area (EEA). EudraVigilance has been in use since December 2001.

Thousands of Americans have caught Covid-19 despite being fully vaccinated, the U.S. Centers for Disease Control and Prevention have said – but they insist the data suggests such *"breakthrough"* infections are relatively rare.

There were 10,262 cases of fully vaccinated people being infected with Covid-19 as of April 30, the CDC said on Tuesday, citing reports from 46 U.S. states and territories. Less than 7% of the patients were hospitalized with Covid-19 symptoms, and 1.6%, or 160, died. The median age for all cases was 58 and 63% of those infected were female. It begs the question, Why get the Vaxx if you can be re-infected?

The number of breakthrough infections was equivalent to around 1 in every 10,000 fully vaccinated people, but the total was substantially undercounted. The CDC said reporting of such cases is voluntary and doesn't include vaccinated people who had no Covid-19 symptoms and weren't tested. But it also noted that 101 million Americans were fully vaccinated as of April 30, and the vast majority of those inoculated were protected from the virus.

"The number of Covid-19 cases, hospitalizations and deaths that will be prevented among vaccinated persons will far exceed the number of vaccine breakthrough cases," the CDC said.

Sequencing data on breakthrough infections suggests that the Covid-19 vaccines being used in the US are about equally effective against various variants of the virus. Around 64% of the cases involved *"variants of concern,"* such as the UK Covid-19 variant, the CDC said. As of late March and early April, those same variants accounted for approximately 70% of the overall Covid-19 cases in the US, the agency said.

VAERS data released today showed 262,521 reports of adverse events following COVID vaccines, including **4,406 deaths** and **21,537 serious injuries** between Dec. 14, 2020 and May 21, 2021.

The number of reported adverse events following COVID vaccines continues to climb, according to data released today by the Centers for Disease Control and Prevention (CDC). The data comes directly from reports submitted to the <u>Vaccine Adverse Event</u> <u>Reporting System</u> (VAERS).

<u>VAERS</u> is the primary government-funded system for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Every Friday, VAERS makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date. Today's data show that between Dec. 14, 2020 and May 21, a total of <u>227,521 total adverse events</u> were reported to VAERS, including **4,406 deaths** — an increase of **205** over the previous week — and <u>21,537 serious injuries</u>, up 3,009 since last week.

This week's data showed 3,449 total adverse events, including 58 rated as serious, among 12- to -17-year-olds.

In the U.S <u>281.6 million</u> COVID vaccine doses had been administered as of May 21. This <u>includes</u> 120 million doses of <u>Moderna's</u> vaccine, 152 million doses of <u>Pfizer</u> and 10 million doses of the <u>Johnson & Johnson</u> (J&J) COVID vaccine.

Of the **4,406 deaths** reported as of May 21, 23% occurred within 48 hours of vaccination, 16% occurred within 24 hours and <u>38% occurred</u> in people who became ill <u>within 48 hours</u> of being vaccinated.

This week's VAERS data show:

- 20% of deaths were related to cardiac disorders.
- 54% of those who died were male, 44% were female and the remaining death reports did not include gender of the deceased.
- The <u>average age</u> of death was 74.4 and the <u>youngest deaths</u> reported include two 15-year-olds (VAERS I.D. <u>1187918</u> and <u>1242573</u>) and a 16-year-old (VAERS I.D. <u>1225942</u>). There were other reported deaths in children under 16 that could not be confirmed or contained obvious errors.
- As of May 21, <u>1,641 pregnant women</u> reported adverse events related to COVID vaccines, including 527 reports of <u>miscarriage or premature birth</u>.
- Of the <u>2,577 cases of Bell's Palsy reported</u>, 52% were reported after <u>Pfizer-BioNTech</u> vaccinations, 41% following vaccination with the Moderna vaccine and 192 cases, or 9%, of Bell's Palsy cases were reported in conjunction with J&J.
- There were <u>238 reports of Guillain-Barré Syndrome</u> with 43% of cases attributed to Pfizer, 38% to Moderna and 23% to J&J.
- There were <u>74,781 reports of anaphylaxis</u> with 39% of cases attributed to <u>Pfizer's</u> <u>vaccine</u>, 50% to <u>Moderna</u> and 10% to <u>J&J</u>.
- There were <u>4,433 reports</u> of blood clotting disorders. Of those, <u>1,842 reports</u> were attributed to Pfizer, <u>1,359 reports</u> to Moderna and <u>1,194 reports</u> to J&J.

CDC investigating heart problems in teens, adolescents after COVID vaccine

On May 24, <u>The Defender reported</u> the CDC is investigating reports of teens and young adults vaccinated against COVID who experienced heart problems. The CDC's Advisory Committee on Immunization Practices <u>released an advisory</u> May 17 alerting doctors to reports of myocarditis, which seemed to occur predominantly in adolescents and young adults, more often in males than females, more often following the second dose and typically within four days after vaccination with <u>Pfizer or Moderna vaccines</u>. Most cases appeared to be "mild" and follow-up is ongoing.

The <u>CDC said</u> its monitoring systems had not found more cases of myocarditis than would be expected in the population, but members of the committee on vaccinations said healthcare providers should be made aware of the reports of the "potential adverse event."

<u>Myocarditis</u> is inflammation of the heart muscle that can lead to cardiac arrhythmia and death. According to the <u>National Organization for Rare Disorders</u>, myocarditis can result from infections, but "more commonly the myocarditis is a result of the body's immune reaction to the initial heart damage." <u>Pericarditis</u> is inflammation of the tissue surrounding the heart that can cause sharp chest pain and other symptoms.

As <u>The Defender reported</u> May 26, one week after the CDC <u>announced</u> it was investigating heart inflammation in recently vaccinated young adults, Connecticut reported 18 new cases of heart problems among teens who had received a COVID vaccine. All 18 cases resulted in hospitalization — the vast majority for a couple of days, while one individual remained hospitalized as of May 26.

White House press secretary Jen Psaki said during a <u>press briefing</u> Monday the Biden administration will continue to advise young people to get vaccinated, despite reported cases of myocarditis.

A search in VAERS revealed <u>419 cases</u> of pericarditis and myocarditis, among all age, groups reported in the U.S following COVID vaccination between Dec.14, 2020 and May 21. Of the 288 cases reported, <u>247 cases</u> were attributed to Pfizer, <u>151 cases</u> to Moderna and <u>20 cases</u> to J&J's COVID vaccine.

<u>CHD Calls on FDA to Take COVID Vaccines Off the Market - Submit a Comment</u> Moderna to seek FDA authorization for 12- to 17-year-olds in early June

On May 25, Moderna <u>announced</u> its vaccine was found to be safe and <u>100% effective</u> at protecting against COVID in a phase 3 trial of more than 3,700 participants between the ages of 12 and 17, <u>Axios reported</u>. No significant safety concerns were identified and side effects were generally consistent with those seen in an earlier trial of adults, <u>the company said</u>.

Moderna plans to seek <u>expanded Emergency Use Authorization</u> of its COVID vaccine for teens from the U.S. Food and Drug Administration next month. If approved, it would be the second vaccine available to young teens.

Number of kids hospitalized for COVID inflated by at least 40%

On May 26, <u>The Defender reported</u> that two papers published in the journal of Hospital Pediatrics found pediatric hospitalizations for COVID were over counted by at least 40%, carrying potential implications for nationwide figures used to justify vaccinating children.

One <u>study</u> by researchers at the <u>Stanford University School of Medicine</u> found that counting <u>SARS-CoV-2</u> infections in hospitalized children <u>overestimated the impact</u> of COVID in pediatric populations because the numbers included many asymptomatic patients.

Out of 117 hospital admissions, the authors concluded 53 patients (45%) were admitted for reasons unrelated to the virus. The study also found 39.3% (or 46 patients) coded as SARS-CoV-2 were actually asymptomatic.

In the <u>second study</u>, out of 146 records listing patients as positive for SARS-CoV-2 from May 1, 2020, to Sept. 30, 2020, the authors classified 58 patients (40%) as having "incidental" diagnosis — meaning there was no documentation of COVID symptoms prior to hospitalization.

The same study categorized 68 patients, or 47%, as "potentially symptomatic," which was defined as when "COVID-19 was not the primary reason for admission for these

patients, and COVID-19 alone did not directly require hospitalization without the concomitant condition."

"Our goal is to <u>make sure we have accurate data</u> on how sick children are getting," said <u>Dr. Alan Schroeder</u>, a clinical professor of pediatric critical care and of pediatric hospital medicine. "If we rely on hospitals' positive SARS-CoV-2 test results, we are inflating by about twofold the actual risk of hospitalization from the disease in kids."

OSHA abruptly reverses course, says employers will not be liable for COVID vaccine injuries

The federal Occupational Safety and Health Administration (<u>OSHA</u>) quickly reversed its position on requiring companies that mandate COVID vaccines to treat adverse reactions as "recordable injuries," announcing that it will no longer <u>enforce its previous</u> ruling.

OSHA said it made the change in order to avoid "the appearance of discouraging workers" from getting the <u>COVID</u> vaccine and also because it did not wish to "disincentivize employers' vaccination efforts."

<u>The Defender</u> reached out to OSHA and asked why the agency abruptly changed its policy, who pressured OSHA to change its position and why adverse reactions caused by COVID vaccines that an employee may be required to receive as a condition of employment and would fall under <u>29 CFR 1904.7</u> would not be recorded as a work-related injury.

OSHA responded by referring us to the Centers for Disease Control and Prevention to read more about coronavirus, local and regional OSHA facilities, and the U.S. Department of Labor's website. An OSHA spokesperson declined to provide any additional information.

Belgium suspends J&J vaccine for people under age 41

On May 27, <u>The Defender reported</u> that Belgium announced it was suspending vaccinations with <u>J&J's vaccine</u>, for people under the age of 41, following the death of a woman from blood clots after she received the shot.

The EMA is <u>reviewing the woman's death</u> along with other reports of blood clots, with the Belgian and Slovenian medicines agencies, and has asked J&J to carry out a series of additional studies to help assess a possible link between the shot and rare blood clots.

Researchers link AstraZeneca to strokes in young adults

On May 27, <u>The Defender reported</u> on the first cases of large-vessel arterial occlusion strokes in young adults linked to AstraZeneca's vaccine, which were described in detail for the first time in a letter <u>published online</u> in the Journal of Neurology Neurosurgery & Psychiatry.

The <u>three cases</u>, one of which was fatal, occurred in two women and one man in their 30s or 40s who developed characteristics of VITT, a reaction associated with the AstraZeneca vaccine.

"These are the first detailed reports of arterial stroke believed to be caused by VITT after the AstraZeneca COVID vaccine, although stroke has been mentioned previously in the VITT data," senior author, Dr. David Werring, professor of clinical neurology at the Stroke Research Centre, University College London Queen Square Institute of Neurology, told Medscape Medical News.

Deaths due to blood clots from AstraZeneca vaccine increase

On May 27, The Defender <u>reported</u> that an Ontario man in his 40s died after receiving his first dose of the AstraZeneca vaccine. Dr. Barbara Yaffe, Ontario's associate chief medical officer of health, said his death is being investigated, but the man suffered from <u>vaccine-induced immune thrombotic thrombocytopenia</u>. Chief Medical Officer Dr. David Williams restricted <u>AstraZeneca</u> vaccinations for people who have not yet received the first dose as of May 11, due to a higher-than-expected rate of blood clots.

In Greece, a <u>63-year-old woman</u> died of blood clots after vaccination with AstraZeneca. The case was one of four being investigated by the National Organization for Medicines for a potential correlation between AstraZeneca's vaccine and rare blood clots.

On May 27, The Guardian <u>reported</u> that award-winning BBC radio presenter Lisa Shaw died after suffering blood clots following AstraZeneca vaccination, according to her family. The 44-year-old developed severe headaches a week after having the jab and fell seriously ill a few days later, relatives said in a statement. Shaw died at the Royal Victoria infirmary May 21 after being treated in intensive care for blood clots and bleeding.

The UK Medicines and Healthcare products Regulatory Agency said the benefits of the vaccine continue to outweigh the risks for most people. It has not proved the vaccine causes the clots, but has said the link is getting firmer.

As The Defender <u>reported</u> May 25, the European Medicines Agency is investigating the death of British fashion model Stephanie Dubois, who died from a blood clot days after receiving her first dose of AstraZeneca's COVID vaccine. Dubois, 39, had no underlying health conditions according to health officials at the hospital in Nicosia, where she was hospitalized May 14, after experiencing breathing issues. The fashion model suffered a brain hemorrhage and was in a coma before she <u>passed away</u> May 21.

Two-time <u>Olympic archer Haziq Kamaruddin</u>, died at the age of 27 on May 14, after collapsing at his home days after receiving Pfizer's COVID vaccine. Kamaruddin died of a blocked coronary artery, the Health Ministry said Saturday, adding there was no evidence of a link to the vaccine.

There are multiple reasons a coronary artery can become blocked, including by a blood clot, <u>according to Yale Medicine</u>.

As The Defender <u>reported</u> last month, <u>all three vaccines authorized in the U.S.</u>, <u>including Pfizer, can potentially cause blood clots</u>.

81 days and counting, CDC ignores The Defender's inquiries

According to the <u>CDC website</u>, "the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated."

On March 8, <u>The Defender</u> contacted the CDC with a <u>written list of questions</u> about reported deaths and injuries related to COVID vaccines. On May 19, a CDC employee said our questions had been reviewed and our inquiry was pending in their system, but would not provide us with a copy of the response.

It has been 81 days since we sent our first email inquiring into VAERS data and reports. <u>Children's Health Defense</u> asks anyone who has experienced an adverse reaction, to any vaccine, to file a report following <u>these three steps</u>.
