


# Mass Murder





## **Big: Corporations Backing Away from Covid Vaccine Mandates as Injuries, Deaths Mount**

A recent pulse survey from the Fisher Phillips law firm has found that at least 83 percent of employers are not even considering trying to implement an employee mandate for Wuhan coronavirus (Covid-19) vaccines.

As corporations like Delta Airlines and Houston Methodist Hospital proudly flaunt their foolishness in attempting to outlaw bodily autonomy, most other corporations are wisely taking a step back, if not for any other reason than to avoid the inevitable lawsuits.

That 83 percent figure is up from 64 percent back in January, showing that many more employers are wising up to the fact that it is a really bad idea to try to force Chinese Virus injections on their employees.

While most employers, around 75 percent, say they are encouraging workers to get vaccinated, only a very small percentage are even attempting to try to force it as a condition of employment.

Thirty-two percent of respondents say they would prefer to avoid running afoul of anti-discrimination laws, while 54 percent said they believe that all employees willing to get injected without a mandate have already done so.

Fisher Phillips found that most employers are keener on encouraging vaccination rather than trying to require it. This is a wise approach as any company that attempts to force vaccination is likely to get under in the end from all the resultant litigation.

At the time when the survey was conducted, the U.S. Equal Employment Opportunity Commission (EEOC) had already released its own guidance claiming that employers can require their employees to get jabbed with Wuhan Flu shots.

This is, of course, a poor guidance because it will only lead employers that attempt to do so right into the trap of endless litigation. For this reason, the smarter ones have already decided not to even attempt to go there.

The dumb ones, like Delta and Houston Methodist, have made themselves targets for potentially multi-million-dollar payouts once the inevitable lawsuits run their course.

It is almost as if some companies want to be driven out of business due to their insistence on being medical fascists. Delta and Houston Methodist clearly need a reminder that they are not their employees' doctors, and thus have no right to impose a medical intervention that could end up killing them. That has not stopped Houston Methodist Hospital from firing nearly 200 employees who were fired this week.

It is important to note that the federal Occupational Safety and Health Administration (OSHA) has already made it clear that employees who become injured or die from

mandatory Wuhan Flu shots at their places of employment are free to sue their employers for maximum damages.

This could spell serious financial drain on any company that is dumb enough to attempt such a thing, which a few are. Most, thankfully, are staying in their lane and letting their employees make their own health decisions through informed consent.

While OSHA dropped the requirement that employers report covid vaccine injuries, employers can still be held liable for any vaccine injuries that arise due to company mandates.

*“The Windex in your office requires, by OSHA, to have a Material Data Sheet, but reactions to experimental ‘vaccinations’ i.e. deaths as a result in the workplace, are no longer reportable. Wow!”* noted one ‘Natural News’ commenter.

*“In my opinion, any person injecting another person with an experimental drug without full informed consent, which leads to death, is an accessory to murder. But, I’m sure that’s been waived, too.”*

*“It is amazing the ‘protections’ required by OSHA, and yet, experimental, emergency use drugs just skipped a page or 2 of the rules,”* responded another.

## **Important Point Confirmed in 2 Previous Articles**

I should have noted an important fact in the last segment of Mass Murder – part 14, an important point. Both in the Japanese study and the remarks by Judy Mikovits, once the injection takes place, within 15 minutes, the spike protein in this “gene” therapy, the ingredients are deposited in virtually the entire human body, and they do not remain in the shoulder muscle as public health people are saying. ## **Fauci Emails: Top Public Health Officials Spun a Web of Lies Around COVID Origin & Treatments**

***Could four key public health officials have been intimately involved in the creation of the pandemic, as well as the prolongation and improper treatments used during the pandemic?***

In early 2020, there was a lot of chatter about where the virus, later named SARS-CoV-2, actually came from.

In an excellent, [detailed article](#) written earlier this month for the Bulletin of the Atomic Scientists, former ‘*New York Times*’ science writer Nicholas Wade described how two short pieces published in March 2020 — one in [The Lancet](#) and one in [Nature Medicine](#) — determined how this chatter would be channeled to the public.

These two extraordinarily influential pieces, each published under the heading “correspondence,” were parroted by mainstream media for a year. Both were plainly intended to shut down any discussion of the possibility that the virus [originated in a lab](#).

*Listen here as Robert F. Kennedy, Jr. and I discuss these issues:*

As I read both the ‘*Lancet*’ and ‘*Nature*’ papers in March 2020, it became immediately apparent each was designed as a propagandist tool. Neither was based on science.

I was so intrigued by these articles, I searched the web to better understand them. That’s when I discovered Francis Collins, director of the National Institutes of Health (NIH), who had [blogged](#) on March 26, 2020, about the ‘*Nature*’ article, suggesting the article should put an end to conspiracy theories about lab origin.

Collins wrote:

“Either way, this study leaves little room to refute a natural origin for COVID-19. And that’s a good thing because it helps us keep focused on what really matters: observing [good hygiene](#), practicing [social distancing](#), and supporting the efforts of all the dedicated [health-care professionals](#) and [researchers](#) who are working so hard to address this major public health challenge.”

I wondered why five otherwise credible scientists would sign their names to the ‘*Nature*’ article — and why Collins would endorse the article’s conclusion — when the arguments made in the paper were nonsensical, in my opinion.

I eventually concluded the authors had been put up to writing the paper by a “hidden hand.”

How had I reached that conclusion, even before [Dr. Anthony Fauci's](#) emails were uncovered Wednesday?

Months ago, in another email drop obtained by [U.S. Right to Know](#), we [learned Peter Daszac](#), CEO of the nonprofit [EcoHealth Alliance](#), was the primary but hidden author of the ‘*Lancet*’ article.

Daszac was also the primary beneficiary of the article’s conclusion — that the virus evolved in nature — as his organization had been used as the pass-through to send money from the National Institute of Allergy & Infectious Diseases (NIAID), headed by Fauci, to the Wuhan Institute of Virology, in Wuhan, China. (Some might consider this method of giving out grants as a fancy way of money laundering.)

Daszac, like Fauci, earned more than \$400,000/year. He was also a member of the World Health Organization’s (WHO) COVID origins [investigative team](#), and had been selected as the head of the ‘*Lancet*’ COVID origins investigative team, which appears now to be dead in the water.

The WHO and the ‘*Lancet*’ thus seem to be co-conspirators, choosing the fox (Daszac) to guard the henhouse (the theory that COVID evolved in nature).

The release Wednesday of [Fauci's emails, obtained by BuzzFeed News](#) through the Freedom of Information Act, help to further clear up some of the mystery behind why five well-known scientists co-authored drivel — which the venerable *Nature* journal published, and which was then used as the foundation to support the natural origin theory.

One of the [emails strongly indicates Andersen](#), lead author of the ‘*Nature*’ paper, knew he was participating in a con job. In a Feb. 1, 2020, email to Fauci, Andersen expressed his own concerns about some of the “unusual features of the virus.” Andersen appears to be worried these features suggest laboratory tampering.

But Andersen then reassures Fauci these “*unusual features of the virus make up a really small part of the genome (<0.1%) so one has to look really closely at all the sequences to see that some of the features (potentially) look engineered.*”

In [another email to Fauci](#), Andersen thanks three incredibly important people — Fauci, Collins and Sir Jeremy Farrar — for their “advice and leadership” regarding the paper. All three are M.D. researchers who dole out more money for medical research than anyone else in the world, with the exception perhaps of [Bill Gates](#).

Fauci runs the NIAID, Collins is the NIH director (nominally Fauci’s boss) and Farrar is director of the [Wellcome Trust](#). Farrar also signed the ‘*Lancet*’ letter. And he is [chair](#) of

the WHO's R&D Blueprint Scientific Advisory Group, which put him in the driver's seat of the WHO's [Solidarity trial](#), in which 1,000 unwitting subjects were overdosed with hydroxychloroquine in order to sink the use of that drug for COVID.

Farrar had worked in Vietnam, where there was lots of malaria, and he had also been [involved with SARS-1](#) there. He additionally was central in setting up the [UK Recovery trial](#), where 1,600 subjects were overdosed with hydroxychloroquine.



Even if Farrar didn't have some idea of the proper dose of chloroquine drugs from his experience in Vietnam, he, Fauci and Collins would have learned about such overdoses after Brazil told the world about how they mistakenly overdosed patients in a trial of chloroquine for COVID. The revelation was made in an [article](#) published in the 'JAMA' in mid-April 2020. Thirty-nine percent of the subjects in Brazil who were given high doses of chloroquine died, average age 50.

Yet the Solidarity and Recovery hydroxychloroquine trials continued into June, stopping only after their extreme doses were exposed.

Fauci made sure to control the treatment guidelines for COVID that came out of the NIAID, advising against both chloroquine drugs and ivermectin. Fauci's NIAID also

cancelled the first large-scale trial of hydroxychloroquine treatment in early disease, after only 20 of the expected 2,000 subjects were enrolled.


### What does all this mean?

**VAERS data released today showed 329,021 reports of adverse events following COVID vaccines, including 5,888 deaths and 28,441 serious injuries between Dec. 14, 2020 and June 4, 2021.**

This week’s number of reported adverse events among all age groups following COVID vaccines surpassed 329,000, according to data released today by the Centers for Disease Control and Prevention (CDC). The data comes directly from reports submitted to the [Vaccine Adverse Event Reporting System](#) (VAERS).

[VAERS](#) is the primary government-funded system for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Every Friday, VAERS makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date. Today’s data show that between Dec. 14, 2020 and June 4, a total of **329,021 total adverse events** were reported to VAERS, including **5,888 deaths** — an increase of **723 deaths** over the previous week. There were [28,441 serious injury reports](#), up 3,082 compared with last week.

Among 12- to 17-year-olds, there were [59 reports](#) of heart inflammation and [19 cases](#) of blood clotting disorders.

In the U.S., [299.1 million](#) COVID vaccine doses had been administered as of June 4. This [includes](#) 126 million doses of [Moderna's](#) vaccine, 162 million doses of [Pfizer](#) and 11 million doses of the [Johnson & Johnson](#) (J&J) COVID vaccine.

Of the 5,888 deaths reported as of June 4, [23% occurred](#) within 48 hours of vaccination, [16% occurred](#) within 24 hours and [39% occurred](#) in people who became ill [within 48 hours](#) of being vaccinated.

This week's data for 12- to 17-year-olds show:

- [5,367](#) total adverse events, including [165](#) rated as serious and [four reported deaths](#) among 12 to 17-year-olds. The [youngest deaths](#) reported include two 15-year-olds (VAERS I.D. [1187918](#) and [1242573](#)), a 16-year-old (VAERS I.D. [1225942](#)) and one 17-year-old (VAERS I.D. [1199455](#)).
- [773 reports](#) of anaphylaxis among 12- to 17-year-olds with 98% of cases attributed to [Pfizer's vaccine](#), 1.8% to [Moderna](#) and 0.5% (or four cases) to [J&J](#).
- [59 reports](#) of myocarditis and pericarditis (heart inflammation) with 58 [attributed](#) to Pfizer's COVID vaccine.
- [16 reports](#) of blood clotting disorders, all [attributed to Pfizer](#).

CDC to hold emergency hearing after identifying 226 cases of heart inflammation in young people.

As [The Defender reported](#) today, the CDC on Thursday announced plans to convene an [emergency meeting](#) of its advisers on June 18 to discuss higher-than-expected reports of heart inflammation following doses of Pfizer and Moderna COVID vaccines.

As [The Defender reported](#) Thursday, before the announcement, the CDC on June 1 had quietly updated its website to acknowledge a higher-than-expected number of cases of myocarditis among young teens after the second dose of an mRNA COVID vaccine.

Based on a [May 24 report](#) from the CDC's Advisory Committee on Immunization Practices COVID-19 Vaccine Safety Technical Work Group, the CDC on June 1 added [new language](#) to its guidance:

“Data from VAERS [Vaccine Adverse Events Reporting System] show that in the 30-day window following dose 2 mRNA COVID-19 vaccination, there was a higher number of observed than expected myocarditis/pericarditis cases in 16–24-year-olds.”

The updated language differed significantly from the CDC's [statement two weeks earlier](#), which said rates of myocarditis were not higher among vaccinated people.

During a [Thursday meeting](#) of advisors to the U.S. Food and Drug Administration, CDC officials presented data showing a total of [475 cases](#) of myocarditis or pericarditis [were recorded](#) in patients 30 and younger following mRNA vaccines.

[CHD Calls on FDA to Take COVID Vaccines Off the Market - Submit a Comment](#)

The CDC identified 226 reports that might meet the agency's “working case definition” of myocarditis. The majority of those affected have recovered, but 41 had ongoing symptoms, 15 are still hospitalized and three are in the intensive care unit.

On June 10, [The Defender reported](#) the Oregon Health Authority said it was aware of at least 11 cases of myocarditis or [pericarditis](#) — inflammation of the sac surrounding the heart — in all age groups following COVID vaccination. One of the cases is a 15-year-old teen in Beaverton, Oregon, who was hospitalized for heart inflammation after receiving his second dose of the [Pfizer](#) vaccine.

“The hallmark symptom of myocarditis and pericarditis is chest pain or shortness of breath,” Jonathan Modie, an Oregon Health Authority spokesperson, [said in an email](#). “In rare cases, it can also present in the form of heart palpitations. Anyone suffering from unexplained chest pain should contact a medical provider or seek immediate emergency care.”

A search of the latest available data in VAERS revealed [900 cases](#) of myocarditis and pericarditis, among all age groups reported in the U.S following COVID vaccination between Dec.14, 2020 and June 4, 2021. Of the 900 cases reported, [533 cases](#) were attributed to Pfizer, [331 cases](#) to Moderna and [32 cases](#) to J&J's COVID vaccine.

Experts tell FDA for kids, benefits of COVID vaccines don't outweigh the risks.

As [The Defender reported](#) June 11, an FDA advisory committee held a [virtual meeting](#) Thursday to discuss what data would be needed to vaccinate children under 12 against COVID under Emergency Use Authorization (EUA) or licensure.

Several experts spoke out against the plan, saying the benefits don't outweigh the risks for young children. Peter Doshi, Ph.D, associate professor University of Maryland School of Pharmacy and senior editor of The BMJ, [said](#) during the open public hearing



session, there is no emergency that would warrant using EUA to authorize COVID vaccines for children.

[Kim Witczak](#), an FDA consumer representative, expressed great concerns over the premature approval of COVID vaccines for children. Witczak said data shows children are neither in danger or dangerous and questioned the timing of last Friday's CDC announcement of the [rise in children being hospitalized](#) with COVID.

Dr. Cody Meissner, director of pediatric infectious diseases at Tufts University School of Medicine, [said](#) children are at low risk of severe disease from the virus and more study is needed about safety in younger age groups.

Witczak and Doshi were two of 27 researchers and clinicians around the world who [launched a citizen's petition](#) demanding the FDA withhold full approval of COVID vaccines until efficacy and safety measures are met.

The members of the FDA's Vaccines and Related Biological Products Advisory Committee were not asked to provide specific advice or to vote during the meeting.

Moderna this week asked the FDA to expand emergency use of its COVID vaccine for adolescents aged 12 to 17. The vaccine maker said its COVID vaccine was 100% effective in a study of 3,700 12-to-17-year-olds.

Moderna and Pfizer both this week said they expect to make their vaccines available to children as young as 5 by September.

As [The Defender reported](#) this week, Pfizer is advancing late-stage clinical trials of its COVID vaccine, in lower doses, on children ages 5 to 11 years old and expects to apply for approval early this fall. The study will enroll up to 4,500 children at more than 90 clinical sites in the U.S., Finland, Poland and Spain, the company said.

Based on [safety, efficacy and tolerability data](#) from the 144 children included in Pfizer's phase 1 trial, the company will use 10 micrograms of each vaccine dose for kids between the ages of 5 and 11 in phase 2/3 trials, and 3 micrograms of each dose for those 5 and younger.

Moderna [said](#) it also expects its COVID vaccine will be available for kids as young as 5 by early fall. CEO Stéphane Bancel [said](#) Monday he thinks the data will become available sometime in September.

A new Cleveland Clinic study shows vaccine provides no added benefit to those who already had COVID.

A [new preprint study](#) by the Cleveland Clinic found people previously infected with SARS-CoV-2 were less likely to be reinfected than fully vaccinated individuals who

never had the virus — suggesting the vaccine is of no benefit to people who already had COVID.

As [The Defender reported](#), the study, available on medRxiv, provides insight into how the immune system protects the body once a COVID infection is confirmed.

The clinic studied 52,238 employees. Of those, 49,659 never had the virus and 2,579 had COVID and recovered. Of the 2,579 who previously were infected, 1,359, or 53%, remained unvaccinated, compared with 41%, or 22,777 who were vaccinated.

Of all [infections during the study period](#), 99.3% occurred in participants who were not infected previously and remained unvaccinated. In contrast, 0.7% of infections occurred in participants who were not previously infected but were currently vaccinated. Significantly, not one of the 1,359 previously infected subjects who remained unvaccinated had a SARS-CoV-2 infection over the duration of the study.

Pfizer skipped critical testing, documents reveal.

New documents obtained by [TrialSite News](#) suggest routine quality testing issues were overlooked in the rush to authorize use of Pfizer's COVID vaccine, and that U.S. and other governments are conducting a massive vaccination program with an incompletely characterized experimental vaccine.

As [The Defender reported](#) June 7, regulatory documents revealed Pfizer didn't thoroughly examine bio-distribution and pharmacokinetics issues relating to its vaccine before submitting the vaccine to the European Medicines Agency (EMA) for review.

Pfizer also did not use the commercial vaccine (BNT162b2) for all of its studies, but instead relied on a "surrogate" mRNA that produced the [luciferase protein](#).

According to 'Trial Site News', its standard practice for the EMA to disclose its assessment of investigational new drug submissions. In the case of [Pfizer's vaccine](#), the EMA assessment included a summary of the agency's evaluation of the non-clinical vaccine distribution studies reported to EMA by Pfizer — but the EMA [did not disclose](#) the results of Pfizer's bio-distribution studies in its public EMA summary.

95 days and counting, CDC ignores The Defender's inquiries

According to the [CDC website](#), "the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated."

On March 8, [The Defender](#) contacted the CDC with a [written list of questions](#) about reported deaths and injuries related to COVID vaccines. After repeated attempts, by phone and email, to obtain a response to our questions, a health communications specialist from the CDC's Vaccine Task Force contacted us on March 29 — three weeks after our initial inquiry.

The individual received our request for information from VAERS, but said she had never received our list of questions, even though employees we talked to several times said CDC press officers were working through the questions and confirmed the representative had received them. We provided the list of questions again along with a new deadline, but never received a response.

On May 19, a CDC employee said our questions had been reviewed and our inquiry was pending in their system, but would not provide us with a copy of the response. We were told we would be contacted by phone or email with the response.

On June 4, the CDC employee we contacted said nobody had responded to our inquiries. We were advised to submit our questions again, which we have done numerous times.

It has been 95 days since we sent our first email inquiring into VAERS data and reports and we have yet to receive a response.

He changed his tune just days later, referring to theories that COVID-19 was engineered as *"crackpot theories."*

Fauci acknowledged receipt of the initial [email](#), thanking him and saying they would "talk soon." Andersen later published a paper in *'Nature'* attempting to dispel the lab-leak

✓ **Biden Claimed Trump “Muzzled” Fauci — But Emails Reveal Fauci Said Otherwise**

Biden has claimed at multiple points that former President Donald Trump prevented Fauci from speaking the truth about the pandemic, but Fauci’s own emails refute that assertion.

Fauci implied it could be the case himself in a January 2021 interview with The New York Times: *“The people around him, his inner circle, were quite upset that I would dare publicly contradict the president. That’s when we started getting into things I felt were unfortunate and somewhat nefarious — namely, allowing Peter Navarro to write an editorial in USA Today saying I’m wrong on most of the things I say. Or to have the White House press office send out a detailed list of things I said that turned out to be not true — all of which were nonsense because they were all true. The very press office that was making decisions as to whether I can go on a TV show or talk to you.”*

However, [Fauci assured people that wasn’t the case](#) in his private correspondence. *“Please stay silent since I have not been muzzled,”* he wrote to a Thomas Murray in March 2020. *“I will be on multiple TV shows tomorrow and was on FOX this AM. No one is censoring me.”*

In another email the following day, he reiterated the point: *“I could not possibly be more public about this. No censor. No muzzle. Free to speak out.”*

✓ **Chinese CDC Director Apologized To Fauci After Appearing To Promote Masks**

Fauci’s guidance on masks was infamously different early in the pandemic compared to what it has been since. That may be why Chinese CDC head Dr. George Gao [apologized to Fauci](#) in March 2020 for the perception that he may have promoted masks in a recent interview.

*“The big mistake in the U.S. and Europe, in my opinion, is that people aren’t wearing masks,”* Gao reportedly said in an interview with [Science Magazine](#) published March 2020. The following day, he [emailed Fauci](#) to assure him that the interview was tainted by a *“journalist’s wording.”*

*“It was NOT a real interview,”* Gao insisted. *“I understand completely. No problem,”*

Fauci replied.

✓ **U.S. Researcher With Ties To Wuhan Lab Personally Thanked Fauci In April 2020 For Dispelling Lab Leak Theory “Myths”**

Dr. Peter Daszak, head of the nonprofit EcoHealth Alliance, which shared millions of dollars of NIH grant money to the Wuhan Institute of Virology over a span of several years. After a lab-leak theory of COVID-19 origin began gaining some traction in the early days of the pandemic, Daszak [took multiple steps](#) to try and repress discussion of the possibility.

In April 2020, [he thanked Fauci for aiding him](#) in that effort. “I just wanted to say a personal thank you on behalf of our staff and collaborators, for publicly standing up and stating that the scientific evidence supports a natural origin for COVID-19 from a bat-to-human spillover, not a lab release from the Wuhan Institute of Virology,” Daszak said to Fauci in the email.

Fauci had downplayed the possibility of a lab-leak origin at a White House press briefing, spawning the appreciation from Daszak. A significant portion of Daszak’s email was redacted with a FOIA exemption indicating that the text may interfere with law enforcement proceedings. *“The paper you sent me says the experiments were performed before the gain of function pause [in October 2014] but have since been reviewed and approved by NIH,” [Auchincloss emailed Fauci](#). “Not sure what that means since Emily is sure that no Coronavirus work has gone through the P3 framework. She will try to determine if we have any distant ties to this work abroad.”*

✓ **Fauci Was Speaking With Mark Zuckerberg About Facebook’s Information Policies**

[Some of Fauci’s emails show](#) that Facebook chief Mark Zuckerberg was seeking advice from Fauci on how to craft [Facebook’s policies](#) for steering users to accurate health information. The emails prompted House Republicans to request all communications between the two to determine if Fauci played a role in guiding Facebook’s decision to  [censor some information](#), including discussion of the lab-leak theory.


“Instead of fixing it, they proposed repeating it and just phrasing their mistake differently,” Massie says about the CDC’s deception.
