'Urgent' British Report Calls for Complete Cessation of COVID Vaccines in Humans

An "[urgent preliminary report of Yellow Card data](#)" issued by the UK-based [Evidence-Based Medicine Consultancy Ltd](#) submitted to the Medicines and Healthcare Products Regulatory Agency (MHRA) states that "the MHRA now has more than enough evidence on the [Yellow Card](#) system to declare the [COVID-19 vaccines](#) unsafe for use in humans."

Similar to the U.S. [Vaccine Adverse Events Reporting System](#) (VAERS), the MHRA describes the purpose of its Yellow Card system as providing "an early warning that the safety of a medicine or a medical device may require further investigation."

The report, signed by Evidence-based Medicine Consultancy Ltd and EbMC Squared CiC Director Dr. Tess Lawrie (MBBCh, PhD), says: "we have searched the Yellow Card reports using pathology-specific key words to group the data according to the following five [sic] broad, clinically relevant categories:

- Bleeding, Clotting and Ischaemic ADRs
- Immune System ADRs
- 'Pain' ADRs
- Neurological ADRs
- ADRs involving loss of Sight, Hearing, Speech or Smell
- Pregnancy ADRs"

The report goes on to say:

"We are aware of the limitations of pharmacovigilance data and understand that information on reported Adverse Drug Reactions should not be interpreted as meaning that the medicine in question generally causes the observed effect or is unsafe to use.

We are sharing this preliminary report due to the urgent need to communicate information that should lead to cessation of the vaccination roll out while a full investigation is conducted.

According to the recent paper by Seneff and Nigh, potential acute and long-term pathologies include:

- Pathogenic priming, multisystem inflammatory disease and autoimmunity
- Allergic reactions and anaphylaxis
- Antibody dependent enhancement
- Activation of latent viral infections
- Neurodegeneration and prion diseases
- Emergence of novel variants of SARSCoV2
- Integration of the spike protein gene into the human DNA

“It is now apparent that these products in the blood stream are toxic to humans. An immediate halt to the vaccination program is required whilst a full and independent safety analysis is undertaken to investigate the full extent of the harms, which the UK Yellow Card data suggest include thromboembolism, multisystem inflammatory disease, immune suppression, autoimmunity and anaphylaxis, as well as Antibody Dependent Enhancement (ADE).”

The report concludes:

“The MHRA now has more than enough evidence on the Yellow Card system to declare the COVID-19 vaccines unsafe for use in humans. Preparation should be made to scale up humanitarian efforts to assist those harmed by the [COVID-19 vaccines](#) and to anticipate and ameliorate medium to longer term effects.

As the mechanism for harms from the vaccines appears to be similar to COVID-19 itself, this includes engaging with numerous international doctors and scientists with expertise in [successfully treating COVID-19](#).

- How many people have died within 28 days of vaccination?
- How many people have been hospitalized within 28 days of vaccination?
- How many people have been disabled by the vaccination?”

tools. Later, EUAs (collectively, the “Vaccine EUAs”) were issued for the so-called “Pfizer-BioNTech COVID-19 Vaccine,”² “Moderna COVID-19 Vaccine”³ and the “Johnson & Johnson (Janssen) COVID-19 Vaccine”⁴ (collectively, the “Vaccines”).⁵

3. The Emergency Declaration and the Vaccine EUAs were the keys that unlocked the profit potential of the COVID-19 crisis. They enabled the Vaccine manufacturers to open the door to the vast American market, enter and reap billions of dollars in profit by exploiting the fears of the American people. In the first quarter of 2021 alone, Pfizer has

earned \$3.5 billion, and Moderna has earned \$1.7 billion, in revenues generated from the sale of their respective EUA Vaccines. Plaintiffs' investigation has revealed that the Defendants appear to have numerous disclosed and undisclosed conflicts-of-interest that should deeply trouble any reasonable observer concerned about the integrity of the EUA process. For instance, Defendant the National Institutes of Health ("NIH") appears to be a co-creator and co-owner of the intellectual property in the "Moderna COVID-19 Vaccine."

4. The Vaccines are unapproved, inadequately tested, experimental and dangerous biological agents that have the potential to cause substantially greater harm than the SARS-CoV-2 virus and the COVID-19 disease itself. According to data extracted from the Defendants' Vaccine Adverse Events Reporting System ("VAERS"), 99% of all deaths attributed to vaccines in the first quarter of 2021 are attributed to the COVID-19 Vaccines, and only 1% is attributed to all other vaccines. The number of vaccine deaths reported in the same period constitutes a 12,000% to 25,000% increase in vaccine deaths, year-on-year. Serious medical complications, among them myocarditis, miscarriage, irregular vaginal bleeding, clotting disorders, strokes, vascular damage and autoimmune disease. Meanwhile, Pfizer, Moderna and Janssen enjoy statutorily conferred immunity from liability for any harm caused by their experimental products.

5. The Vaccine EUAs are unlawful on multiple different grounds and must be terminated immediately. First, the Emergency Declaration upon which they are all based was unjustified. As Plaintiffs allege in detail and will show at trial with expert medical and scientific evidence, including the Defendants' own data and studies, there is not now, and there never has been, a bona fide "public health emergency" due to the SARS-Cov-2 virus or the disease COVID-19. Virtually all of the PCR tests were calibrated to produce false positive results, which has enabled the Defendants and their counterparts in state governments to publish daily reports containing seriously inflated COVID-19 "case" and "death" counts that grossly exaggerate the public health threat.

Even assuming the accuracy of these counts, we now know that COVID-19 has a fatality rate far below that originally anticipated – 0.2% globally, and 0.03% for persons under the age of 70. According to the CDC, 95% of "COVID-19" deaths involve at least four additional co-morbidities. *[Emphasis added.]*

Medical professionals are reporting serious health issues following the covid shots

Dr. Brian Lenzkes said most of his patients have not had severe side effects, but he has seen neurological changes in some of his patients. In one case, an elderly male suffered from severe ataxia just two weeks after the Pfizer shot. Just three hours after taking the shot, a 28-year-old came down with acute seizures that devolved into severe tachycardia. Dr. Lenzkes also lost a former patient, who was “extremely healthy with normal labs,” but passed away just eight days after the second shot.

Dr. Cassandra Balomiri, a previously healthy 29-year-old resident doctor, has been experiencing side effects for 15 weeks, post vaccination. She says these adverse events are being ignored en masse. “For the first time in my life I got the feeling that people are just ignored!” she said. It doesn’t matter how many adverse events that she and her colleagues report, “nothing comes out officially.” The information is buried, and patients are left feeling alone, [stuck with the problems](#).

Dr. Candice Black reports “lower leg muscle twitching” post vaccination, a sudden issue that gives her anxiety. She says, “it doesn’t seem to be going away” and is only getting worse.

Dr. Alex Vasquez pointed out that fraud was used to determine the vaccine’s efficacy. “At first the FDA gave emergency authorization based on antibody response which they mislabeled as “efficacy” and now they say that antibodies are [meaningless and should not be measured](#),” he said.

Dr. Peter Angelin said the FDA’s emergency use authorization (EUA) bypasses serious safety concerns, inflicting “short and long-term side effects on different populations.”

Dr. Ivan Iriarte is concerned that the “safe and effective” mantra is being used deceptively and in a violently coercive manner, subjecting countless young, healthy people to serious problems like myocarditis and blood clots. He warns, “This vaccine, if offered at all, should be given only to adults at high risk of COVID, only voluntarily, and only with full disclosure of information.”

Jack Holder, a physical therapist from the UK is disgusted that healthcare practitioners can't express their concerns without being "branded as an anti-vaxxer or conspiracy theorist." He has witnessed a surge in patients (recently vaccinated) with "foot pains, inflammation, burning and tingling sensations in feet and legs as well as sciatic pains." These pains did not exist before, he said, but the patients often do not link the "newly developed pains" to the vaccine, so countless side effects go unreported.

Dr. Signee Hoffman works in a musculoskeletal clinic. He reports on several patients who come in with severe inflammation and musculoskeletal issues after taking the shots. One patient was a 76-year-old woman who was rushed to the ER 72 hours post injection. The shot caused atrial fibrillation, but she was ultimately coerced to get a second dose regardless of her hospitalization. Another patient is a 66-year-old nurse who began vomiting with dry heaves and cold sweats, post vaccination. Her medical doctor said the vaccine reaction was normal! A third patient of his suffered from neuropathy on the left side of her face. She suddenly came down with TMJ pains, severe migraines and was eventually diagnosed with a blood clot in her left popliteal vein.

Sonya T, an RN and hospital administrator, experienced neurological symptoms that lasted twelve hours after the first dose. After the second dose, the neurological symptoms worsened and lasted several months. These symptoms included involuntary movement of the hand and thumb of the vaccinated arm. She also dealt with "muscle twitching" throughout her face and suffered from unexplained headaches and fatigue for four months. She says she would never let her children take the vaccines.

Kids Up Next: Pfizer Pushes for Pediatric Indication for Its Controversial COVID Jab

([NaturalHealth365](#)) The United States recently hit a historical milestone. According to the Centers for Disease Control and Prevention, half of all Americans age 12 and up have now received full doses of a COVID shot – nearly 141 million people.

Meanwhile, COVID shot producer Pfizer-BioNTech is turning its needles toward younger and [younger participants](#), moving full steam ahead despite growing reports of heart inflammation, blood clots, and other adverse events among young adult and teen recipients.

Do the benefits of jabbing kids with experimental shots outweigh the risks? The answer may surprise you.

On June 4, Children’s Health Defense reported that the U.S. Food and Drug Administration would hold a meeting on June 10 to discuss “the possible licensure” of

the experimental [COVID injection](#) from Pfizer for use in children. This hasty push toward injecting as many people as possible comes despite concerning issues.

COVID-19 among children (age 0 to 19) is less common than COVID-19 reported among adults. Should an infection occur, the under 18 population is much less likely to experience severe illness, boasting a reported survival rate of over 99.9 percent. (As noted in a 2020 *BMJ* article, the *overall* survival rate of COVID-19 is still greater than 99 percent).

The CDC says (presumably in defense of their push to get kids jabbed with the experimental [mRNA](#) drug) that children can still carry SARS-CoV-2 and infect others. But does this justify the potential damage caused by the COVID shot among this younger population?

Just last month, Pfizer released a fact sheet describing the results of a clinical trial of its COVID shot on 12- to 15-year-old children. In the double-blind study, 1,097 children received both doses of the Pfizer injection, and 1,078 received placebo saline injections. **Of the children who received the investigational drugs, 4 out of 5 experienced side effects, ranging from headaches and joint pain to fever, fatigue, and vomiting.** In almost half of these children, their side effects were considered moderate (393) to severe (7).

Looking at this data differently:

Short-term serious side effects (to say nothing of long-term side effects) following the administration of this drug occurred at a rate of roughly 0.6 percent in kids. Right now, about 74.2 million people under the age of 18 live in the U.S. Based on this information, nearly half a million American children would expect to experience serious adverse effects if all kids in the country received this experimental drug.

Currently, Pfizer is running Phase 2 and 3 clinical trials on their money-making drug on kids even younger than 12, including babies as young as 6 months old.

Worth reiterating: once mass injection programs begin, more serious side effects can come to light that *aren't* captured in clinical trials. Indeed, we're already seeing this.

Blood clots, heart inflammation, and more – teens and young adults suffer life-threatening effects of COVID shots

Children's Health Defense recently reported that a 17-year-old boy from Utah ended up in the intensive care unit after suffering from blood clots after just one dose of the Pfizer shot. Dozens of other similar cases are being reported among younger people, including heart inflammation and other cardiovascular problems.

Meanwhile, US health officials continue to bribe people with free beer, ice cream, and donuts to line up for the jab. These propagandized incentives stand in stark contrast to

the known negative effects of sugar and alcohol on the immune system, health advocates say.

In some states, including Alabama, Oregon, Rhode Island, and South Carolina, children will likely be able to get this experimental drug even without parental consent. No word on whether these children are being provided proper *informed* consent, at least by being made aware of the potential risks of these investigational drugs.

To Date Only Two Autopsies Have Been Held for Covid-19 Victims!!!!

This is the strangest story I have encountered in monitoring deaths alleged to be from Covid-19. About three or four weeks ago it was reported that Russian Prime Minister Putin went against the World Health Organization (WHO) instructions not to conduct autopsies of Covid-19 victims. That fact about the WHO ordering no autopsies is highly suspicious, in medical studies it would be an automatic event if for no other reason than to know what the cause of death of a person alleged to have died from Covid actually was. This report raises suspicion of those desiring to hide the evidence, or any proof of cause of death.

The first-ever postmortem study of a patient vaccinated against COVID-19 has revealed that viral mRNA was found in every organ of the patient's body, meaning that the vaccine is either ineffective or the coronavirus actually spreads faster in vaccinated individuals.

The scientific report out of [Germany published](#) by the International Journal of Infectious Diseases in June examined the autopsy of an 86-year-old man who had received a single dose of the SARS-CoV-2 vaccine but died 4 weeks later after becoming infected with the virus by a nearby patient at a hospital.

From the "[First case of postmortem study in a patient vaccinated against SARS-CoV-2](#)": We report on an 86-year-old male resident of a retirement home who received vaccine against SARS-CoV-2. Past medical history included systemic arterial hypertension, chronic venous insufficiency, dementia and prostate carcinoma. On January 9, 2021, the man received lipid nanoparticle-formulated, nucleoside-modified RNA vaccine BNT162b2 in a 30 µg dose. On that day and in the following 2 weeks, he presented with no clinical symptoms.

On day 18, he was admitted to hospital for worsening diarrhea. Since he did not present with any clinical signs of COVID-19, isolation in a specific setting did not occur. Laboratory testing revealed hypochromic anemia and increased creatinine serum levels. Antigen test and polymerase chain reaction (PCR) for SARS-CoV-2 were negative.

But the study notes that by day 25, that vaccinated patient had tested positive for COVID-19, presumably from a nearby COVID-infected patient in his hospital room, and died of kidney and respiratory failure the following day.

SARS-CoV-2 spike proteins were present in nearly all the vaccinated patient's organs. "In summary, the results of our autopsy case study in a patient with mRNA vaccine confirm the view that by first dose of vaccination against SARS-CoV-2 immunogenicity can already be induced, while sterile immunity is not adequately developed," the study concluded.

In other words, although the COVID-19 vaccine triggered an immune response within the body, it didn't appear to stop the spread of the virus, and therefore the spread of harmful viral spike proteins, throughout the body.

This is just more bombshell scientific evidence that the COVID-19 vaccine likely does more harm than good, and may actually even accelerate the spread of the coronavirus. The vaccine used is BNT162b2. This is the Pfizer BioNTech vaccine.

In the case of the Russian who was autopsied, the deceased was not vaccinated but had simply died of the alleged virus, and yet the autopsy confirmed there was no evidence to suggest that was the case at all.

US Government Spends Extra \$3 Billion on Vaccine Hesitancy Propaganda Ads – As Vaccine Deaths Surpass 5,000



The U.S. government [has spent billions of dollars](#) into the Wuhan coronavirus (COVID-19) vaccine and its related programs. However, no amount of money can conceal the fact that there have been [more than 5,000 deaths](#) (now just over 6,000 officially) related to the COVID-19

vaccines reported to the government. The *Centers for Disease Control and Prevention* (CDC) maintains a record of adverse events related to vaccines. It updates the Vaccine Adverse Event Reporting System (VAERS) on a weekly basis, with new reports released every Friday. According to VAERS data between Dec. 14 of last year and May 28 of this year, the number of vaccine-related deaths reached 5,165. This current figure was the result of 759 fatalities being added to the system over the previous week. The data also showed a total of 25,359 serious injuries reported – an increase of 3,822 compared to the week prior. All in all, the VAERS data registered a total of 294,801 adverse events related to the COVID-19 vaccines. But the number of deaths and adverse events being reported are at historical levels – with more reported in just the last six months than the previous 20 years combined. The VAERS website stated that one of the main limitations of its data is its inability to determine if the vaccine caused the reported adverse event. It added that this limitation "has caused confusion in the publicly available data, ... specifically regarding the number of reported deaths." Furthermore, the VAERS website mentioned that it "accepts all reports of adverse health events following vaccinations without judging whether the vaccine caused the adverse health event" – further muddling the waters. Ultimately, it acknowledged that information from a VAERS report alone is insufficient to establish a causal link between vaccines and reported fatalities. "The trickiest part of this effort from day one has been timing messaging with vaccine supply, and that magic moment is fast approaching, the official said." According to the report, it sought to hit two birds with one stone. First, it strived to reach Americans who have second thoughts about vaccination or do not know where to get their COVID-19 vaccine doses. Second, it aimed to combat misinformation about the effectiveness and safety of COVID-19 vaccines. The federal government also partnered with two groups – the Ad Council and the Covid Collaborative project – to create public service announcements targeting vaccine hesitancy. Both entities have worked with the CDC and *Department of Health and Human Services* on such advertisements. One of the fruits of their collaboration involved an ad featuring four erstwhile U.S. presidents. The ad showed former presidents Jimmy Carter, Bill Clinton, George W. Bush and Barack

Obama getting vaccinated alongside their wives. Another ad featured incumbent President Joe Biden – with much of the footage shot during his Jan. 20 inauguration. Covid Collaborative Co-Founder John Bridgeland voiced concerns about polls showing the prevalence of vaccine hesitancy among conservatives. He said his group has sought conservative-leaning influencers willing to promote the COVID-19 vaccine. "We have to make sure this transcends politics. It can't be the mask game again. Vaccines are not political," Bridgeland continued. According to Bridgeland, research has shown that there is already a high demand for information on the COVID-19 vaccines. Philippines Offering Free Cow to Those Who Sign Up for COVID Vaccine



Under two percent Filipinos have received the second vaccination shot.

People in the Philippines are [so loath to get the COVID-19 vaccine](#), one town is offering free cows as an incentive, a report said Monday.

Local officials in San Luis, within the Pampanga province about 50 miles north of Manila, are raffling off a cow each month to inoculated residents as a means to encourage people to get the jab, [Al Jazeera reported](#).

“Winning a cow might not mean much in other places but here in San Luis, we’re agricultural, so it’s the ideal incentive,” Ardee Taruc, the town’s disaster mitigation officer, told the outlet.

The cows, supplied by local donors and worth about \$628, could be a ticket out of extreme poverty for some residents, the outlet said. It’d be able to eat for free on an abundant supply of grass in the locale and a farmer could start a herd, use the cow to carry heavy goods and sell its milk, the outlet said.

“It’s up to the winners if they want to slaughter the cows,” Taruc said.

Vaccine hesitancy, coupled with a sluggish roll out, has been a major issue in the southeast Asian country, which is grappling with one of the worst outbreaks in the region.



Local donors will provide the cows, worth roughly \$628, in a raffle for residents.

As of June 6, a mere four percent of Filipinos out of roughly 110 million people have received at least one dose of the vaccine and only 1.4 percent has gotten the second shot.

A local polling service, Social Weather Stations, found only a third of residents were willing to get the jab and the hesitancy has been driven largely by concerns over the vaccine's side effects and doubts about how effective the shots are.

To combat the hesitancy, local governments are offering a range of incentives, including raffles for free sacks of rice and other grocery items and in one town, anyone who signs up for the vaccine is entered into a raffle for a house and an accompanying lot.

"I heard a house-and-lot was at stake. I want that, of course," Fannie Taladro Pestaño, who was concerned about the vaccine's side effects, told the outlet as she lined up for her first dose.

"We need it... Whatever happens, happens. It's all up to God."

Some states in the US, which has also grappled with vaccine hesitancy, [have offered lottery raffles as high as \\$1 million](#) for those who sign up for the shot.

The doctor predicted an increase in Parkinson’s disease, Alzheimer’s and other neurodegenerative diseases.

A Florida urologist says that Wuhan coronavirus (Covid-19) vaccines appear to be triggering a massive uptick in prostate cancer and infertility among his male patients.

Dr. Diego Rubinowicz spoke with local media recently, revealing that men’s prostate-specific antigen (PSA) values are mysteriously spiking after they receive an experimental injection for the Chinese Virus, which has him concerned.

“Essentially, the anonymous individual went from having the PSA levels of a healthy person in their twenties or thirties to having the levels of a 60 or 70-year-old man,” Infowars reports.

While much of the media’s attention has remained fixated on how Chinese Virus injections are negatively affecting female sexual health, Rubinowicz’s warnings point to serious problems for men, too.

In fact, she states that not only was she not going to inject anyone, she was actually going to try to convince CVS customers NOT to take the injections.

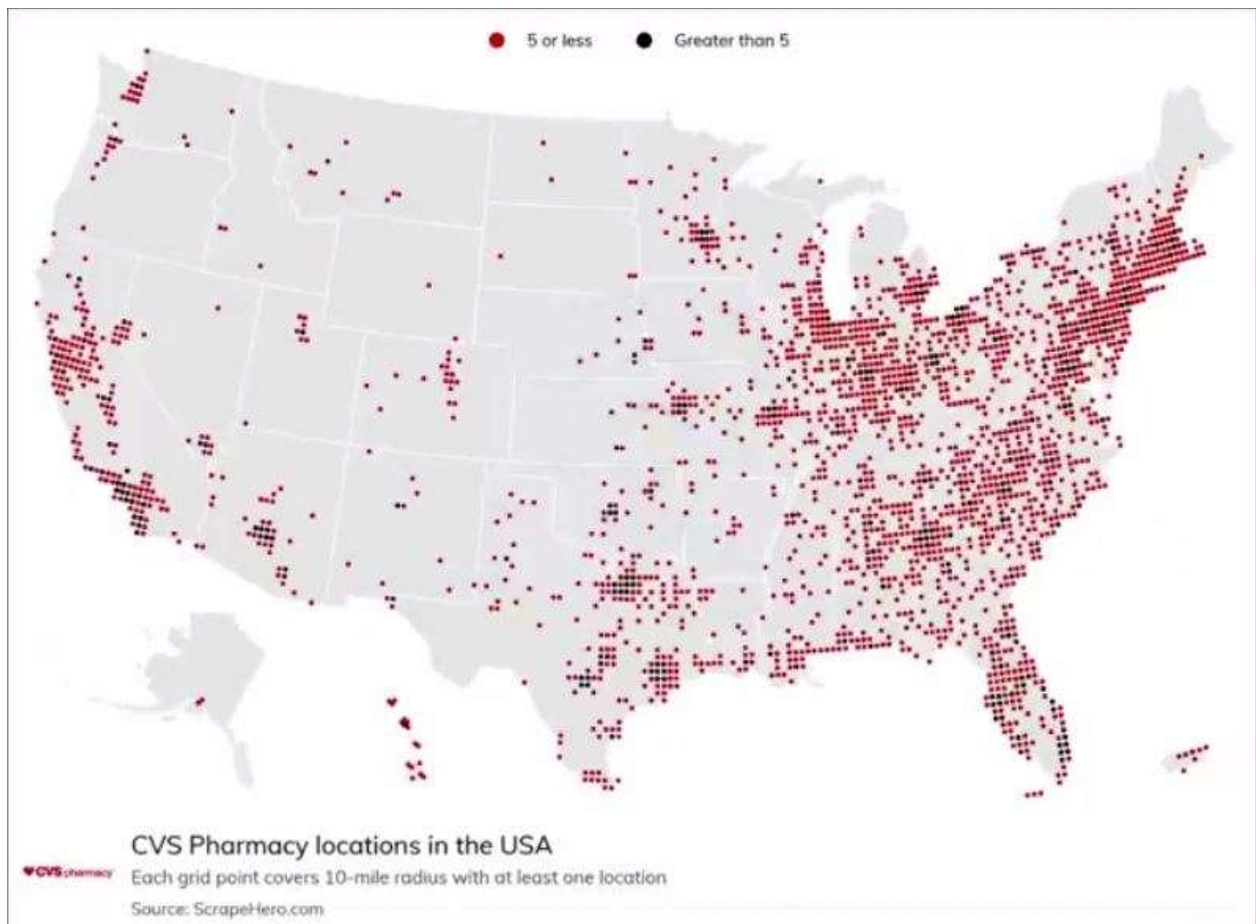
She laments the fact that most people did not care, and took the shots anyway.

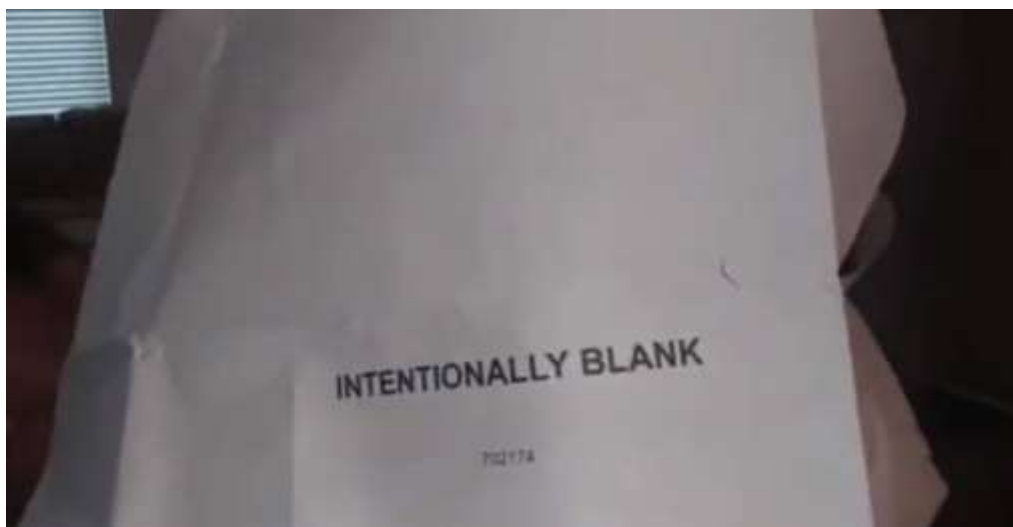
She continues with what she said to her former employer:

And what does it say?*

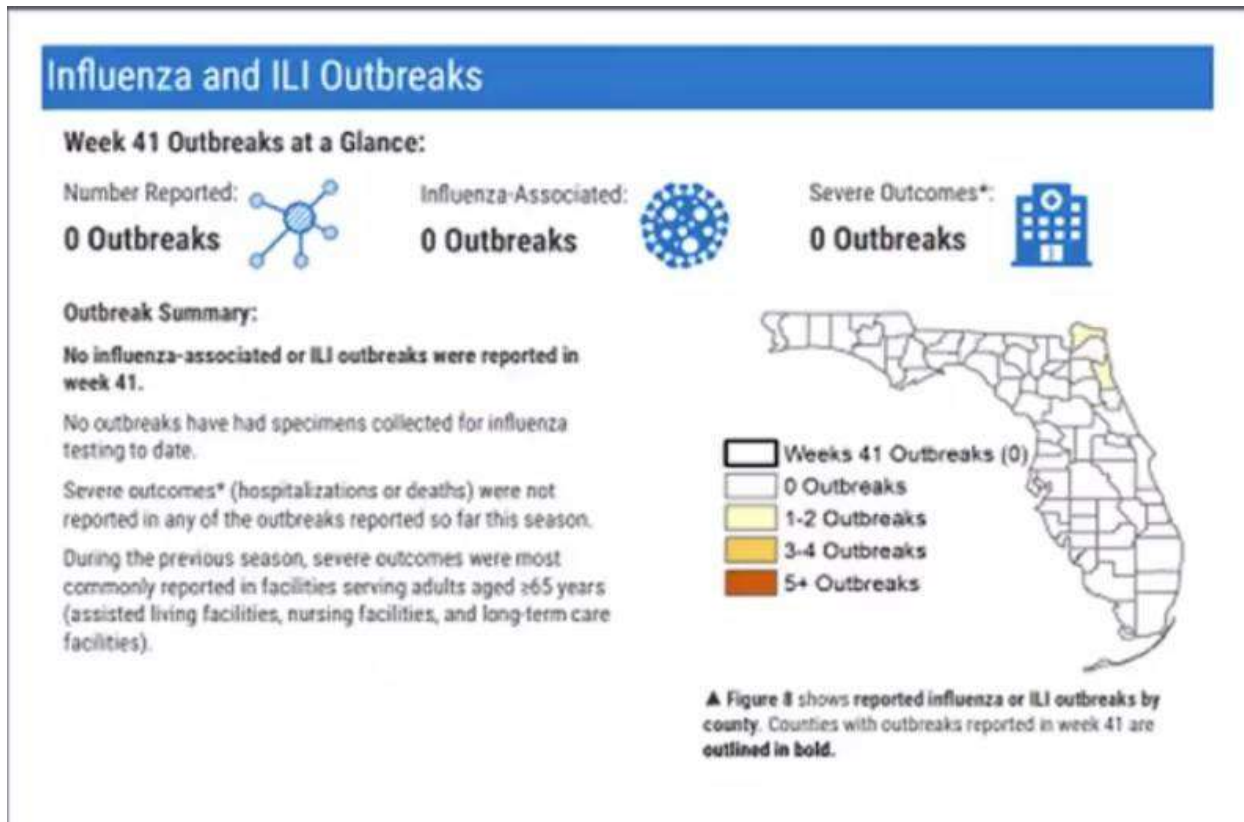

New Discovery Shows Human Cells can Write RNA Sequences Into DNA - June 11, 2021

Summary:

In a discovery that challenges long-held dogma in biology, researchers show that mammalian cells can convert RNA sequences back into DNA, a feat more common in viruses than eukaryotic cells.

Cells contain machinery that duplicates DNA into a new set that goes into a newly formed cell. That same class of machines, called polymerases, also builds RNA messages, which are like notes copied from the central DNA repository of recipes, so they can be read more efficiently into proteins. But polymerases were thought to only work in one direction DNA into DNA or RNA. This prevents RNA messages from being rewritten back into the master recipe book of genomic DNA. Now, Thomas Jefferson University researchers provide the first evidence that RNA segments can be written back into DNA, which potentially challenges the central dogma in biology and could have wide implications affecting many fields of biology.

"This work opens the door to many other studies that will help us understand the significance of having a mechanism for converting RNA messages into DNA in our own cells," says Richard Pomerantz, PhD, associate professor of biochemistry and molecular biology at Thomas Jefferson University. *"The reality that a human polymerase can do this with high efficiency, raises many questions."* For example, this finding

suggests that RNA messages can be used as templates for repairing or re-writing genomic DNA.

The work was published June 11th in the journal '*Science Advances*'.

Together with first author Gurushankar Chandramouly and other collaborators, Dr. Pomerantz's team started by investigating one very unusual polymerase, called polymerase theta. Of the 14 DNA polymerases in mammalian cells, only three do the bulk of the work of duplicating the entire genome to prepare for cell division. The remaining 11 are mostly involved in detecting and making repairs when there's a break or error in the DNA strands. Polymerase theta repairs DNA, but is very error-prone and makes many errors or mutations. The researchers therefore noticed that some of polymerase theta's "bad" qualities were ones it shared with another cellular machine, albeit one more common in viruses -- the reverse transcriptase. Like Pol theta, HIV reverse transcriptase acts as a DNA polymerase, but can also bind RNA and read RNA back into a DNA strand. [We know from Indian scientists last year, and confirmed by Nobel Peace Prize in Medicine Dr. Luc Montagnier that 18 fragments of the HIV virus were inserted in the Covid-19 genome.]

In a series of elegant experiments, the researchers tested polymerase theta against the reverse transcriptase from HIV, which is one of the best studied of its kind. They showed that polymerase theta was capable of converting RNA messages into DNA, which it did as well as HIV reverse transcriptase, and that it actually did a better job than when duplicating DNA to DNA. Polymerase theta was more efficient and introduced fewer errors when using an RNA template to write new DNA messages, than when duplicating DNA into DNA, suggesting that this function could be its primary purpose in the cell.

The group collaborated with Dr. Xiaojiang S. Chen's lab at USC and used x-ray crystallography to define the structure and found that this molecule was able to change shape in order to accommodate the more bulky RNA molecule -- a feat unique among polymerases.

"Our research suggests that polymerase theta's main function is to act as a reverse transcriptase," says Dr. Pomerantz. "In healthy cells, the purpose of this molecule may be toward RNA-mediated DNA repair. In unhealthy cells, such as cancer cells, polymerase theta is highly expressed and promotes cancer cell growth and drug resistance. It will be exciting to further understand how polymerase theta's activity on RNA contributes to DNA repair and cancer-cell proliferation."

According to the news article, a 33-year-old nurse practitioner named Anna Kern got her first dose of the Pfizer-BioNTech shot in December (2020) and the second dose weeks after, and it has now been five months ago being fully vaccinated, however it wasn't a ticket to normality she has found out. Because Kern has tested positive for COVID-19 in April (2021) and has been struggling with what is termed "long COVID" ever since. In her battle with the post-viral illness her symptoms had gotten steadily worse, feeling chills and rundown, experiencing extreme fatigue after minor activities.

Latest CDC VAERS Data for 12- to 17-Year-Olds Include 7 Deaths, 271 Serious Adverse Events Following COVID Vaccines

VAERS data released today by the CDC showed a total of 358,379 reports of adverse events from all age groups following COVID vaccines, including 5,993 deaths and 29,871 serious injuries between Dec. 14, 2020 and June 11, 2021.

This week's number of reported adverse events among all age groups following COVID vaccines surpassed 350,000, according to data released today by the Centers for Disease Control and Prevention (CDC). The data comes directly from reports submitted to the [Vaccine Adverse Event Reporting System](#) (VAERS).

[VAERS](#) is the primary government-funded system for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Every Friday, [VAERS](#) makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date.

Data released today show that between Dec. 14, 2020 and June 11, 2021, a total of [358,379 total adverse events](#) were reported to VAERS, including [5,993 deaths](#) — an increase of **105 deaths over the previous week**. There were [29,871 serious injury reports](#), up 1,430 compared with last week. [The number of deaths is suspiciously lower and may be an indicator that the CDC is hiding or masking reports]

Of the 5,993 deaths reported as of June 11, [23% occurred](#) within 48 hours of vaccination, [16% occurred](#) within 24 hours and [38% occurred](#) in people who became ill [within 48 hours](#) of being vaccinated.

In the U.S., [306.5 million](#) COVID vaccine doses had been administered as of June 11. This [includes](#) 128 million doses of [Moderna's](#) vaccine, 167 million doses of [Pfizer](#) and 11 million doses of the [Johnson & Johnson](#) (J&J) COVID vaccine.

This week's data, from Dec. 14, 2020 to June 11, 2021, for 12- to 17-year-olds show:

- [6,332](#) total adverse events, including [271](#) rated as serious and [seven reported deaths](#) among 12- to 17-year-olds.

The most recent [reported](#) deaths include a 15-year-old male (VAERS I.D. [1383620](#)) who reportedly died one day after receiving his second Pfizer dose, a 15-year-old male (VAERS I.D. [1382906](#)) who received Pfizer and a 16-year-old male (VAERS I.D. [1386841](#)) who reportedly suffered a hemorrhage and died four days after receiving a Pfizer vaccine. An autopsy is pending.

Other deaths include two 15-year-olds (VAERS I.D. [1187918](#) and [1242573](#)), a 16-year-old (VAERS I.D. [1225942](#)) and one 17-year-old (VAERS I.D. [1199455](#)).

- [974 reports](#) of anaphylaxis among 12- to 17-year-olds with 98% of cases attributed to [Pfizer's vaccine](#), 1.4% to [Moderna](#) and 0.2% (or two cases) to [J&J](#).
- [109 reports](#) of myocarditis and pericarditis (heart inflammation) with 108 [attributed](#) to Pfizer's COVID vaccine.

This week's total VAERS data, from Dec. 14, 2020 to June 11, 2021, for all age groups show:

- **358,379 total adverse events**, including **29,871 serious injuries** and **5,993 reported deaths**
- 21% of deaths were related to cardiac disorders.
- 51% of those who died were male, 45% were female and the remaining death reports did not include gender of the deceased.
- The [average age](#) of death was **74.4**.
- As of June 11, [2,136 pregnant women](#) reported adverse events related to COVID vaccines, including 707 reports of [miscarriage or premature birth](#).
- Of the [3,516 cases of Bell's Palsy reported](#), 54% were reported after [Pfizer](#) vaccinations, 42% following vaccination with the Moderna vaccine and 267 cases, or 8%, of Bell's Palsy cases were reported in conjunction with J&J.
- [332 reports of Guillain-Barré Syndrome](#), with 45% of cases attributed to Pfizer, 40% to Moderna and 21% to J&J.
- [100,736 reports of anaphylaxis](#) with 42% of cases attributed to [Pfizer's vaccine](#), 50% to [Moderna](#) and 8% to [J&J](#).
- [6,352 reports](#) of blood clotting disorders. Of those, [2,705 reports](#) were attributed to Pfizer, [2,197 reports](#) to Moderna and [1,408 reports](#) to J&J.

CDC reschedules emergency meeting to discuss reports of young people developing serious heart issues after mRNA vaccines

The CDC's Advisory Committee on Immunization Practices (ACIP) planned to hold an [emergency meeting](#) today to discuss the benefit-risk of COVID mRNA vaccines in adolescents and young adults. The agency rescheduled the meeting late Thursday, after Congress officially established Juneteenth National Independence Day (observed today) as a federal holiday.

The meeting will now be held during a regularly scheduled ACIP meeting on June 23 – 25.

The emergency meeting was [announced](#) last week after the CDC [acknowledged](#) a higher-than-expected number of reports of heart inflammation in young people after they received a [Pfizer](#) or [Moderna](#) vaccine.

The CDC on June 10 said it was aware of a total of [475 cases](#) of [myocarditis](#) or [pericarditis](#) in patients 30 and younger. The disclosure was made during a U.S. Food and Drug Administration (FDA) [hearing](#) to consider what data the agency would need in order to extend [Emergency Use Authorization](#) of COVID vaccines for children under 12. CDC [data showed](#) 196 reports of myocarditis and pericarditis among 18- to 24-year-olds through May 31, compared with an expected rate of between eight and 83 cases. Among 16- to 17-year-olds, 79 cases of myocarditis and pericarditis were reported through May 31. The [expected rate](#) among people in this age group is between two and 19 cases.

A search of the latest available data in VAERS revealed [1,117 cases](#) of myocarditis and pericarditis, among all age groups reported in the U.S following COVID vaccination between Dec.14, 2020 and June 11, 2021. Of the 900 cases reported, [686 cases](#) were attributed to Pfizer, [391 cases](#) to Moderna and [36 cases](#) to J&J's COVID vaccine.

Parents share horror stories of death, illness after Moderna vaccine

This week, [The Defender](#) reported on two cases of young people who developed heart complications after being vaccinated with the Moderna COVID vaccine, including a 19-year-old college freshman who died, and a 21-year-old student who is recovering.

On June 15, [The Defender reported](#) that Simone Scott, a 19-year-old freshman at Northwestern University, died of complications from a heart transplant she underwent after developing what her doctors believe was myocarditis following her second dose of the Moderna COVID vaccine.

Scott received the second dose on May 1, and on May 11, visited a doctor on campus because she wasn't feeling well. On May 16, she texted her father complaining of dizziness and fatigue. He called campus police who, when they checked in on her, had to administer CPR.

After multiple interventions, including hooking Scott to an ECMO machine that mirrors the function of the heart so her own heart could rest, doctors determined she needed a heart replacement. She died June 11.

Scott's mother [told local media](#), "I still feel like she's here, even though I know she's not and it just feels like such a waste."

Scott's doctors have [not fully confirmed](#) the cause of her death, but they said it appears she suffered from myocarditis.

On June 15, [The Defender reported](#) that a 21-year-old New Jersey student suffered severe heart inflammation after receiving his second dose of Moderna's COVID vaccine. Justin Harrington, whose school required him to get the vaccine in order to attend classes in the fall, experienced flu-like symptoms followed by heart pain within eight to 12 hours of receiving the vaccine.

In an exclusive interview with [The Defender](#), Justin's father, Timothy Harrington, said his son felt different after the second shot. Every time his heart beat it hurt and he felt pressure," Harrington said. "Then he developed heart pain down both arms."

Harrington said his son, who has no underlying medical conditions, did not experience heart pain with his first dose of the vaccine. Although Justin has since been released from the hospital, he has to wear a heart monitor and take four different medications for six months, has to sleep propped up, can't exert himself and he's missing out on one of the most important times of his life, his father said.

As for Justin's recovery, Harrington said, *"He has minor scarring on his heart and doctors hope they caught it early enough that there will be no other issues — but it's pure conjecture at this point."*

8 fully vaccinated die of COVID in Maine, as U.S. breakthrough cases rise

As [The Defender reported](#) June 14, eight people in Maine died with COVID after being fully vaccinated, according to the latest numbers from [Maine's Centers for Disease Control and Prevention](#) (CDC), which confirmed a total of [457 breakthrough cases](#) in the state.

Initial [data suggest](#) breakthrough cases in Maine are more common in older individuals and people with underlying health conditions — the same populations that, among the unvaccinated, are [most at risk](#) of hospitalization or death from the virus. About half of the vaccinated people in Maine who tested positive for [COVID](#) had not experienced symptoms when contacted by case investigators, according to the Maine CDC.

On June 3, Napa County California [announced](#) a fully vaccinated woman, who was more than a month past her second Moderna shot, died after being hospitalized with COVID. The 65-year-old woman had underlying conditions and tested positive for the Alpha variant.

As of June 9, the California Department of Public Health had identified more than 5,723 [breakthrough COVID cases](#). Of the 5,723 cases, at least 417 people were hospitalized and least 47 died. Approximately 48% of cases were missing hospitalization data. It is not known if the primary cause of hospitalization or death was COVID or if there were other causes.

Other states continue to report breakthrough cases, among them Texas, which recorded more than [768 breakthrough COVID cases](#) through June 1, with 8% (61 cases) resulting in death.

In Washington, the state's Department of Health [reported 1,837 cases](#) of breakthrough infection through June 9. Of those, 10% resulted in hospitalization and 31 people died from COVID-related illness. The majority of cases occurred in the 35 to 49 age group.

Health officials push vaccines, ignore natural immunity

The CDC conservatively estimates more than a third of Americans (at least [114.6 million](#)) have been infected with SARS-CoV-2.

As [The Defender reported](#) June 16, there is ample reason to believe that in [most of these individuals](#), SARS-CoV-2 infection “induces long-term immunity.”

For example, a December 2020 [study](#) by Singapore researchers found neutralizing antibodies (one prong of the immune response) remained present in high concentrations for 17 years or more in individuals who recovered from the original SARS-CoV.

More recently, the [World Health Organization](#) (WHO) and the [National Institutes of Health](#) (NIH) published evidence of durable immune responses to natural infection with SARS-CoV-2.

Yet health authorities are largely [ignoring](#) this fact as they continue to push for everyone to get the vaccine. As the American Institute of Economic Research [reported](#), it appears in order to promote the COVID vaccine agenda, key organizations are not only [“downplaying” natural immunity](#) but may be seeking to “erase” it altogether.

102 days and counting, CDC ignores The Defender's inquiries

According to the [CDC website](#), “the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated.”

On March 8, [The Defender](#) contacted the CDC with a [written list of questions](#) about reported deaths and injuries related to COVID vaccines. After repeated attempts, by phone and email, to obtain a response to our questions, a health communications specialist from the CDC's Vaccine Task Force contacted us on March 29 — three weeks after our initial inquiry.

The individual received our request for information from VAERS, but said she had never received our list of questions, even though employees we talked to several times said CDC press officers were working through the questions and confirmed the

representative had received them. We provided the list of questions again along with a new deadline, but never received a response.

On May 19, a CDC employee said our questions had been reviewed and our inquiry was pending in their system, but would not provide us with a copy of the response. We were told we would be contacted by phone or email with the response.

We've contacted the CDC numerous times since and there is no change in the status of our questions, to re-submit our questions or to callback later. It has been 102 days since we sent our first email inquiring into VAERS data and reports and we have yet to receive a response.

Dr. Peter McCullough - COVID Vaccines Have Already Killed 50,000 Americans June 18, 2021

In an extraordinary interview last week, Dr. Peter McCullough, an American professor of Medicine and Vice Chief of Internal Medicine at Baylor University, declared that the world has been subjected to a form of bioterrorism, and that the suppression of early treatments for COVID-19--such as hydroxychloroquine-- *"was tightly linked to the development of a vaccine."*

Dr. McCullough made the explosive comments during a webinar on June 11, with Dr. Reiner Fuellmich, a German trial lawyer, who believes the pandemic was planned, and is "a crime against humanity."

McCullough said he believes the bioterrorism has come in two stages--the first wave being the rollout of the coronavirus, and the second, the rollout of the dangerous vaccines, which **he said may already be responsible for the deaths of up to 50,000 Americans.**

Dr. McCullough practices internal medicine and cardiology, is the editor of *'Reviews in Cardiovascular Medicine'*, senior editor of the *'American Journal of Cardiology'*, editor of the textbook *'Cardiorenal Medicine'*, and president of the Cardiorenal Society.

"The first wave of the bioterrorism is a respiratory virus that spread across the world, and affected relatively few people--about one percent of many populations--but generated great fear," McCullough explained during the Oval Media webinar with other doctors. He noted that the virus targeted *"mostly the frail and the elderly, but for otherwise well people, it was much like having the common cold."*

Dr. McCullough later elaborated that he has treated many patients with the disease, written papers on it, had the disease himself, and has also seen a death in his own family due to COVID.

The doctor said he believes that fear of the virus was used very quickly to generate policies that would hugely impact human life, such as the draconian lockdowns.

"Every single thing that was done in public health in response to the pandemic made it worse," he pointed out.

McCullough explained that early on, as a doctor treating COVID patients, he came up with an early treatment regimen for those struck with the virus, which reduced hospital stays by about 85 percent, and said he began publishing papers on what he had learned. The doctor noted that he was "met with resistance at all levels" in terms of actually treating patients and publishing his papers.

"Fortunately I had enough publication strength to publish the only two papers in the entire medical literature that teaches doctors how to treat COVID-19 patients at home to prevent hospitalization," he said.

"What we have discovered is that the suppression of early treatment was tightly linked to the development of a vaccine, and the entire program--and in a sense, bioterrorism phase one-- was rolled out, [and] was really about keeping the population in fear, and in isolation preparing them to accept the vaccine, which appears to be phase two of a bioterrorism operation."

McCullough explained that both the coronavirus and the vaccines deliver "to the human body, the spike protein, [which is] the gain of function target of this bioterrorism research."

He acknowledged that he couldn't come out and say all that on national television because the medical establishment has done such a thorough job of propagandizing the issue.

"What we have learned over time is that we could no longer communicate with government agencies. We actually couldn't communicate with our propagandized colleagues in major medical centers, all of which appear to be under a spell, almost as if they've been hypnotized."

"Good doctors are doing unthinkable things like injecting biologically active messenger RNA that produces this pathogenic spike protein into pregnant women. I think when these doctors wake up from their trance, they're going to be shocked to think what they've done to people," he said, echoing what he, and Dr. Harvey Risch, professor at the Yale School of Public Health, told Fox News host Laura Ingraham during an interview last month.

McCullough told Fuellmich that last summer, he started an early treatment initiative to keep COVID patients out of the hospital, which involved organizing multiple groups of medical doctors in the United States and abroad. The doctor noted that some governments tried to block these doctors from providing the treatments, but with the help of the Association of Physicians and Surgeons, they were able to put out a home patient guide, and in the U.S., organized four different tele-medical services, and fifteen regional tele-medical services.

This way, people who were stricken with COVID-19, were able to call in to these services and get the medications they needed prescribed to local pharmacies, or mail order distribution pharmacies, he explained.

"Without the government really even understanding what was going on, we crushed the epidemic curve of the United States," McCullough claimed. ***"Toward the end of December and January, we basically took care of the pandemic with about 500 doctors and telemedicine services, and to this day, we treat about 25***

percent of the U.S. COVID-19 population that are actually at high risk, over age 50 with medical problems that present with severe symptoms."

The doctor said that his belief that the suppression of early treatment was "tightly linked" to the vaccines, is what that led him to focus his attention on warning the public about the vaccines.

"We know that this is phase two of bioterrorism, we don't know who's behind it, but we know that they want a needle in every arm to inject messenger RNA, or adenoviral DNA into every human being," he said. "They want every human being." The doctor later warned that the experimental vaccines could ultimately lead to cancers, and sterilize young women.

Dr. McCullough said his goal is to set apart a large group of people that the system cannot get to, which would include those who have already had the virus, those with immunity, children, pregnant women, and child-bearing women.

The cardiologist went on to say that because there is no clinical benefit in young people whatsoever to get the vaccine, even one case of myocarditis or pericarditis following the shots *"is too many,"* yet even though the CDC is aware of hundreds of alarming reports of cases of heart swelling in teenagers and young adults, they're only going to reevaluate the matter later on in June. He accused the medical establishment of neglecting to do anything to reduce the risks of the vaccines.

As someone who has chaired over two dozen vaccine safety monitoring boards for the FDA, and National Institute for Health, McCullough had room to criticize how the vaccines have been rolled out.

"With this program, there is no critical event committee, there is no data-safety monitoring board, and there's no human ethics committee. Those structures are mandatory for all large clinical investigations, and so the word that's really used for what's going on is malfeasance, that's wrongdoing of people in authority," the doctor explained.

"Without any safety measures in place, you can see what's going on," he continued.

"Basically it's the largest application of a biological product with the greatest amount of morbidity and mortality in the history of our country."

"We are at over 5,000 deaths so far, as you know, and I think about 15,000 hospitalizations. In the EU it's over 10,000 deaths. We are working with the Center for Medicaid (CMS) data, and we have a pretty good lead that the real number is tenfold."

McCullough explained that because the Vaccine Adverse Event Reporting System (VAERS) database only amounts to about 10 percent of the bad reactions to the vaccines, his team has had to go to other sources for information.

"We have now a whistleblower inside the CMS, and we have two whistleblowers in the CDC," the doctor revealed. "We think we have 50,000 dead Americans. Fifty thousand deaths. So we actually have more deaths due to the vaccine per day than certainly the viral illness by far. It's basically propagandized bioterrorism by injection."

Dr. McCullough said he's seen people in his office with cases of portal vein thrombosis, myocarditis, and serious memory problems post-vaccination. "It's so disconcerting," he said.

He said he was recently viciously attacked in the media by a woman from Singapore who is linked to the Gates Foundation.

Dr. McCullough went on to express a chilling theory that the vaccines could have been designed to reduce the world's population.

"If you said this is all a Gates Foundation program to reduce the population, it's fitting very well with that hypothesis, right? The first wave was to kill the old people by the respiratory infection, the second wave is to take the survivors and target the young people and sterilize them," he said.

"If you notice the messaging in the country, in the United States, they're not even interested in old people now. They want the kids. They want the kids, kids, kids, kids, kids! They're such a focus on the kids," he said, noting that in Toronto, Canada, last month, they lured the children with promises of ice-cream to get the jab. According to one report, the government of Ontario--which doesn't require parental consent for children to get vaccinated--encouraged the kids to get the Pfizer vaccine at a pop-up vaccine event.

"They held the parents back, and they were vaccinating the kids," the doctor railed. He said his Canadian wife's mother was forcibly vaccinated against her will.

McCullough predicted that the United States is gearing up to force people into getting the injections.
