A QUARTER of American adults under 40 do not plan to get a COVID-19 shot due lack of trust in vaccines and fears of potential side effects

Almost a quarter of Americans under the age of 40 do not intend to get vaccinated against COVID-19, a new report finds.

At least 24.9% of adults aged 18 to 39 said they 'probably' or 'definitely' will not get a shot, the Centers for Disease Control and Prevention (CDC) revealed on Monday.

Among the reasons why they won't get immunized include the mistrust of vaccines and fear of potential side effects. I can think of many reasons but these are significant!

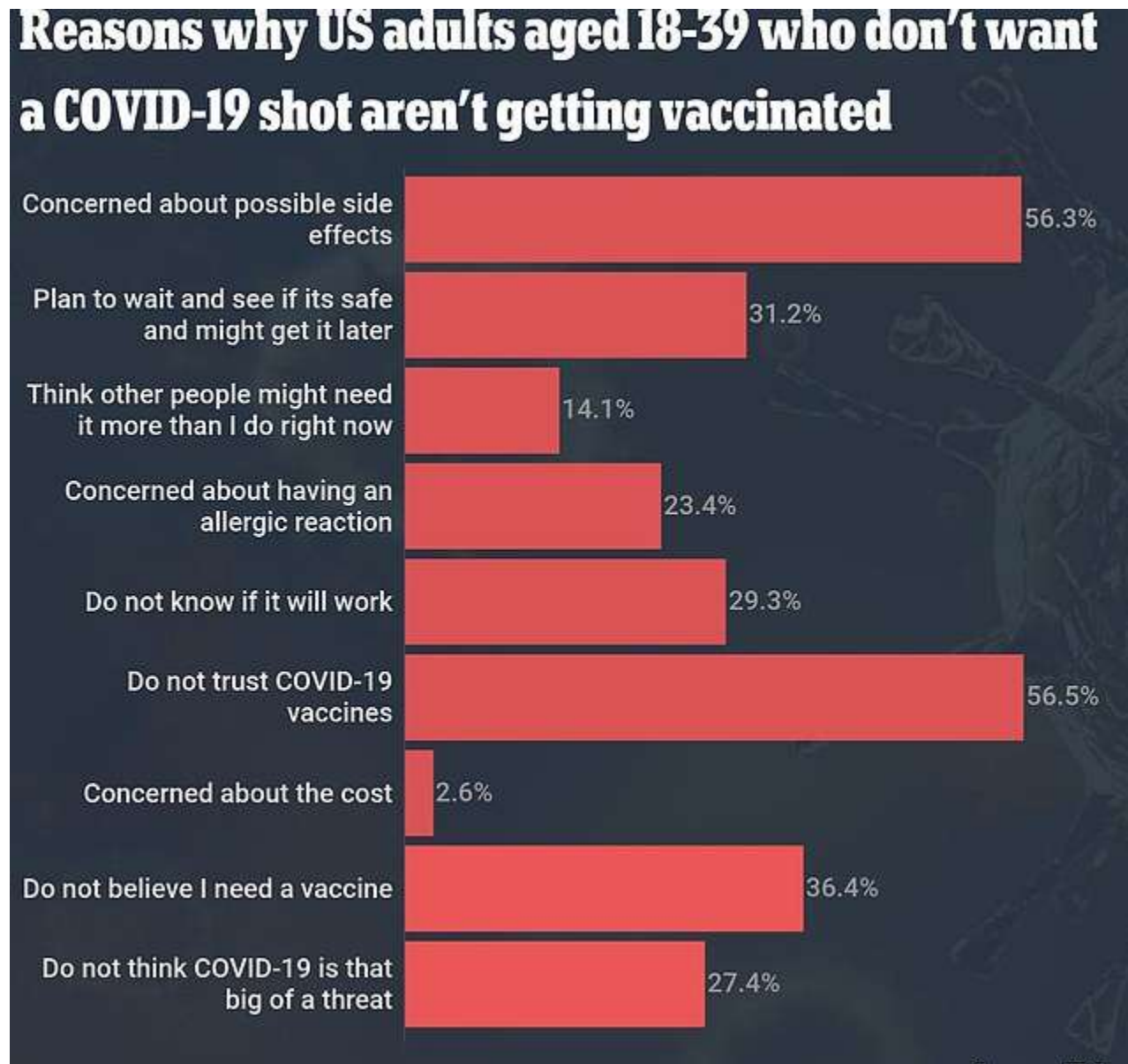
It comes as President Joe Biden's target date of July 4th to get 70 percent of American adults with at least one dose approaches. I'm LOL!

As of now, it seems unlikely the country will reach the mark, with only 65 percent at least partially immunized with only two weeks to go.



The CDC's own recovery rate shows that there is no need for people to take any Vaxx, especially since it is not a vaccine, but rather something hatched in a lab where in the original animal tests, the ferrets, animals all died! Even scientists who understand

virology, immunology, and viruses would not approve it. Then there is the other issue that more than half of all physicians do not plan to take it.



The most common reasons people under the age of 40 do not plan on getting vaccinated is a **lack of trust in the vaccines and fear of the vaccines potential side effects.**

The CDC surveyed 2,726 Americans aged 18 to 39 on their COVID-19 vaccine status, and why or why not they chose to get vaccinated.

More than half of the group, 51 percent, were either vaccinated or planned to get vaccinated.

Of the remaining group, 23.3 percent said they are unsure if they will get vaccinated, while 24.9 percent report that they either probably not or will not get the shots.

Black Americans are most likely to not want the vaccine, per the survey, with nearly a third - 32.3 percent - reporting they had no intention of getting the vaccine. Can anyone fault them? Not me!

There is also a direct correlation between higher levels of education attainment and income and being more likely to have received, or want, the vaccine.

The most common reason for vaccine hesitancy among the younger generations is a lack of trust and fears of adverse reactions.

More than half, 56.5 percent, of vaccine hesitant adults reported a lack of trust, with 56.3 percent reporting that they are concerned about potential side effects.

Side effects of the COVID vaccine often include a headache, fatigue, chills and other common symptoms of respiratory illness.

More serious side effects have been discovered, though. Then there is the issue of the CDC hiding the data on 50,000 unreported deaths from those fully vaxxed!

The Johnson & Johnson COVID-19 vaccine had its authorization paused earlier this year after reports of it causing blood clots in 17 people.

There was also a recent report by the CDC that some young males were experiencing heart inflammation after receiving the second dose of a two-shot vaccine.

Despite the side effects, the agency still recommends the vaccine to all Americans 12 years of age or older. It's time to double-down on the scam!

More than a third of people, 36.4 percent, who do not intend to get the vaccine, reported that they believe they do not need it, while 27.4 percent said they do not think COVID is a big threat to them.

Younger Americans not getting vaccinated due to a lack of fear of the virus has become a common concern among health officials.

Many millennials and members of Generation Z have skipped on the vaccine due to the extremely low chance of death for them if they do get the virus.

Younger Americans can still die from the virus, though, and even those that survive may contract long term conditions like myocarditis. This has no substantive evidence when you look at the deaths directly from Covid. The actual number of deaths for June 21st was just **90** for the entire country, lowest since the CDC began reporting numbers. This is what the CDC reported for Monday, June 21st, 2021.

Some experts also believe the long-haul COVID, where someone exhibits symptoms of the virus long after recovering from it, is more common among younger people.

Younger people will also need to get vaccinated in order for the nation to reach herd immunity, which is believed to be when around 80 percent of the population is vaccinated.

Those among the group who say they will not get vaccinated are also least likely to wear a mask in public (66.5 percent) and least likely to be concerned about COVID (26.1 percent).

While potential barriers such as time constraints or lack of available travel have been cited as reasons for some not getting vaccinated in the past, 62.6 percent of respondents who say they do not plan to get vaccinated also reported they have no barriers to vaccine access.

Currently, 65 percent of U.S. adults and 53 percent of the total American population have received at least one shot of a COVID-19 vaccine.

The CDC reports that just under 150 million Americans are fully vaccinated, having received either both shots of an mRNA vaccine or the one-shot Johnson and Johnson vaccine.

While America has still not reached total herd immunity, case rates across the nation have plummeted as the vaccine has become more common.

The nation is averaging around 80,000 cases a week, a sharp decline from over winter, where over 1.5 million cases were being recorded a week at some points over the holiday season. The number of new cases for June 21st, 2021 reported by the CDC was **4,063**. When you look at the big picture, things simply do not add up and justify one's position to pass on this Vaxx Bovine Excrement!

One might consider the other healing treatments for Covid, such as Ivermectin and the one mentioned by President Trump last year, hydroxychloroquine. British Airways Refuse to Deny Four Pilots Died After Covid Jab This report should be a concern to anyone contemplating flying!

SOCIAL media is alive with the story that four British Airways pilots died within a few weeks of each other, with the suggestion that Covid vaccine is involved. A photograph

showing condolence books for four male pilots at BA's headquarters that was circulated on Twitter fanned the flames. As did a voice recording, allegedly from the independent radio station English 909, with a man saying:

"Things are getting crazy here. I don't know if I told you but my friend who's a BA pilot, has just told me that they've had the third BA pilot die in the last seven days. The first two were in their 40s and 50s and the third in his mid-thirties. Perfectly fit, no underlying conditions. Gets his second jab and he's dead within days. Exactly the same as the first two . . ."

Our national airline issued a statement saying that the deaths were not connected. This has been presented by [Reuters](#) fact-checkers as a denial, but in fact BA refuse to say whether the pilots had received a Covid-19 vaccine or not.

Pilot deaths are rare, and it may well just be 'bad luck' or a 'coincidence', but according to a retired RAF pilot who was also an airline captain who flew for several independent British airlines:

"Airline pilots are a very healthy bunch. I worked for a number of airlines, and I actually cannot recall a pilot dying of any illness before retirement. Four in a few weeks? unheard of."

"I am a retired pilot, not a medic, but common sense tells me that if there is a clotting problem with the [AstraZeneca or Johnson & Johnson/Janssen] vaccine then exposure to deep vein thrombosis [a known problem with long haul flying] might be relevant."

Information about cause of death in the deceased pilots is sketchy but all had been fully vaccinated. The first to die, on May 4, was Senior First Officer Grant Mercer, age unknown, a keen hockey player described on a [crowd-fundraising](#) page set up to pay for his funeral as:

"An awesome friend who lived for his friends and loved ones. He was where the action was, anything fun or adrenaline-filled he would do and make sure everyone was involved too." As the picture of him holding a hockey stick shows, he was a fit man who loved sport. The page does not say how he died.

Pilot Edward Brice-Bennett, 33, died on June 2. His widow Kate is six months pregnant. They also have a daughter Illa, two, and had been married for four years.

An inquest in Salisbury heard how Mr. Brice-Bennett was found unconscious beside his bicycle on a public bike trail in Tidworth, Wiltshire, at midday by a member of the public. Paramedics failed to revive him, [and he was pronounced dead after 45 minutes](#).

The inquest was told that Mr. Brice-Bennett had suffered internal bleeding, but no cause of death has been ascertained. Toxicology and histology tests were ordered and the inquest adjourned.

Father-of-two Nicholas Synnott, 60, died three weeks ago. He had spent a record 243 days in a Texas hospital battling Covid-19 after being admitted in March last year. His death came six months after he had been discharged from intensive care to his home in Betchworth, Surrey. He punched the air as he left the hospital with his wife Nicola, 54, leaving. Their two children are Rebecca, 24, a charity worker, and George, 21, who is understood to be training to be a pilot like his father.

Mr. Synnott's cause of death has not been revealed but the speculation is that he died from complications caused by Covid-19. However, it is known that patients who have had Covid and then receive the vaccine can suffer from [antibody dependent enhancement](#) (ADE), which can make the disease worse if you then contract it.

On June 17 via Twitter, BA spokeswoman Helen said: *"There is no truth whatsoever in the claims that the four deaths are linked."* She did not say whether the pilots had been vaccinated. Family members confirmed they all had been fully vaccinated.

Yesterday, British Airways said that they do not tell staff whether or not to get vaccinated. Asked three times to confirm or deny whether the dead pilots had had Covid vaccines, they declined to comment. BA representatives must know about the 5th Amendment of self-incrimination!

They did say that their colleagues had not all died within the last seven days, which is true, but they did not respond when sent the following request for further information about vaccination:

'We know that the AZ vax causes blood clots and thrombosis, we know that the Pfizer can cause heart problems. These side effects were not picked up during the trials and jabs will not have been tested on pilots or frequent flying passengers. Is the fact that four BA pilots died within a few weeks connected to the jab? We know that Air India have had 5 pilots die too.

"There seems to be a pattern developing which needs to be investigated. If air travel can aggravate the recently vaccinated, it may only be a question of taking some time to allow the jab to settle. That way lives could be saved. If we cannot investigate this, many more pilots/passengers may die before a link is confirmed or ruled out. It is really important information."

Both spokespersons from the pilots' union, the British Airline Pilots Association (BALPA), Nancy Jackson and Brian Strutton, refused to comment as they said they consider the story to be fake news. They declined to say whether they had investigated. According to lawyers, three BA captains and other airline crew contacted them back in February concerned that BA was pushing them to take an experimental jab. BALPA were disinterested in taking up their case and they felt stonewalled. The personnel sought legal advice but the result of their negotiations is unknown.

The airline regulator, the Civil Aviation Authority (CAA), have yet to respond. The as yet unidentified voice in the radio recording says:

“Because of [the deaths] BA are now in crisis talks with the government about whether to allow vaccinated pilots to fly. The issue with that of course is that about 80 per cent, according to my friend in BA, 80-85 per cent have been injected. You might be down to 10 per cent of pilots able to fly. It’s a small number and a serious issue.”

BA deny that they’re in ‘crisis talks’ with the government and refer to a statement from the Medicines and Healthcare products Regulatory Agency in which Dr. Sarah Branch, the director of vigilance and risk management of medicines for the MHRA said:

“There are currently no restrictions on aviation or other industries and activities post-vaccination. Our advice remains that the benefits of the vaccine outweigh the risks in the majority of people. It is still vitally important that people come forward for their vaccination and for their second dose when invited to do so. We ask anyone who suspects they have experienced a side effect linked with their Covid-19 vaccine to report it to the [Coronavirus Yellow Card](#) website.”

U.S. airlines have been quiet about any of their pilots dying, but they have experienced thousands of cancelled flights, something that is considered to be a minor issue, however, cancellations for various reasons have been running as many as 4,000+ a week.

Pilots have an increased risk of blood clots. COVID-19 vaccine recipients have an increased risk of blood clots. Reuter’s and Fact Checkers cannot hide the fact that an increased risk on top of an increased risk is potentially a disaster, but neither has any regard for human life or the truth, as evidenced by the propaganda they’re currently creating by the minute.

Delta Airlines now requires the COVID-19 vaccine for all new employees, potentially putting Delta employees at risk of blood clots and death. American Airlines doesn’t require the vaccine but gives its employees one day off of work and \$50 for getting the vaccine. No mention of the inherent risk for non-air employees, let alone those who spend ample time in the clouds, is ever made by Delta or American.

According to flightaware.com, 120,000 cancellations per year is the average for global flights. An average day would see 329 cancellations. A 2-day average would see 658 cancellations. But between Friday and Saturday of last week, 3,533 cancellations occurred. That’s a 580% increase in cancellations globally in the past 2 days.

People that have been vaccinated and flying need to be aware of their own personal health conditions as well. Cramped seats inhibit good circulation of the legs, and since all airlines have this mandate for pilots to be vaccinated, there is an increased risk for crew and passengers flying.

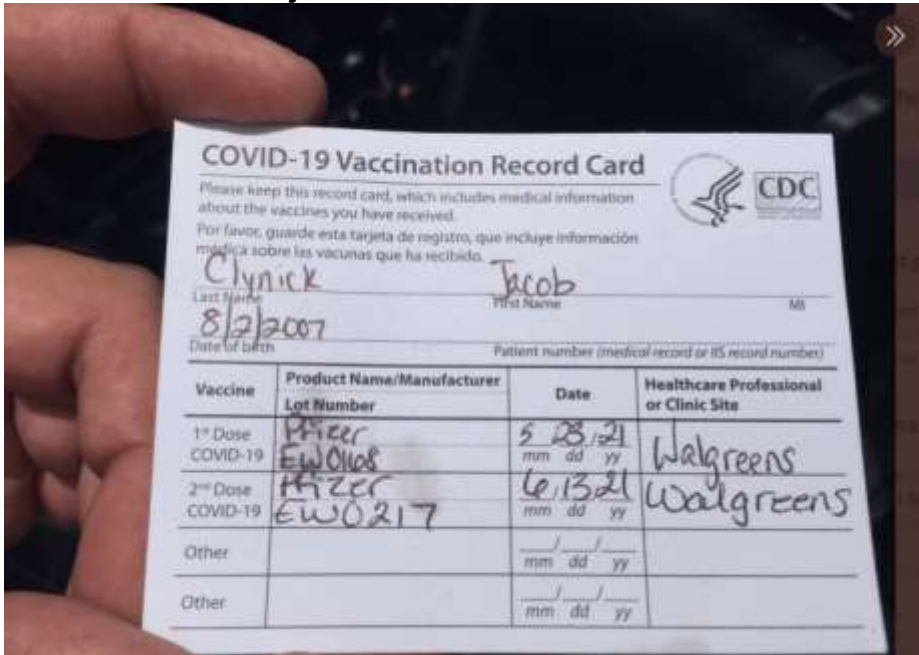
Jacob Clynick: 13-year-old Michigan boy develops myocarditis, dead three days after second experimental Pfizer mRNA shot

Ms. Burages said her nephew died from an “enlarged heart.” That is called myocarditis, which has now killed god-knows-how-many teenagers [after receiving the experimental mRNA shots](#). Ms. Burages posted a series of very strange tweets thereafter. She seems conflicted as to whether she supports injecting children with experimental shots or not.

First she blames Pfizer for her nephew’s death. But then she says the shots “save lives” and that others should get their kids vaccinated. She also said that her own 14-year-old son has already received the experimental injection.

Vaccines cause the variants?

Nos Tayons is run by a division of the Belgian government that specifically guarantees “dignified living conditions for all.” Christie Morreale, a Regional Health Minister, said in a statement that vaccines are effective and have dropped hospitalization rates in nursing homes. Anne-Catherine Roobaert, the director of Nos Tayons, said in a statement that the worst is behind them. French virologist and Nobel Prize winner Luc Montagnier hypothesized that the vaccines are causing the so-called COVID-19 variants. The English variant, also known as the Alpha variant, seems to positively correlate with Oxford-AstraZeneca injections. For instance, Thailand will eventually get 61 million AstraZeneca doses and started administering them on June 7. The Bangkok Post reported on June 11 that the Alpha variant is the most dominant in Thailand. Further a study by Israeli researchers in April found that the South African variant was eight times more prevalent in Pfizer vaxxed people than in non-vaxxed people.

It’s also no secret that the most-vaccinated countries in the world are experiencing surges in COVID-19 cases. The Next Lock Down Will Be the Delta Variant!

A number of governments have warned about the rapidly spreading Delta variant of the Wuhan coronavirus (COVID-19). Because of its spread, authorities have warned that the biggest wave of the pandemic is yet to come. These same authorities are implementing [measures that curtail people's freedoms](#) – such as lockdowns and mask mandates – under the guise of keeping the Delta variant at bay.

The "Delta variant" may actually be a euphemism for people who are harmed by Covid vaccines. By blaming a "variant" instead of the vaccine, the Covid vaccine mythology narrative can be perpetuated until global depopulation goals are achieved.

According to the now-discredited "science" establishment, [the Delta or B16172 variant](#) first detected in India is described as a sub-strain of the original B1617 variant that initially circulated there. It possessed three notable mutations that set it apart from earlier strains. The E484Q mutation allowed it to escape immunity from vaccines or earlier infection. The L452R mutation enabled it to become 20 percent more transmissible, while the P681R mutation contributed to its increased infectiousness.

[A report by the Times of India](#) (TOI) said the Delta variant even mutated further in some instances, becoming the Delta plus or AY1 strain. This strain possessed the K417N mutation at the virus's spike protein, which enables it to enter and infect human cells. The TOI report added that the AY1 variant showed resistance to monoclonal antibody treatments for COVID-19.

Author Michael Snyder [wrote in his blog](#) that the Delta variant is "wreaking havoc" in different countries worldwide. It caused new COVID-19 cases in the U.K. to rise by 109 percent in a week's time. Of these new cases, the Delta variant accounted for 91 percent. Because of this, the British government has considered extending lockdown restrictions by another month, [the Daily Mail reported](#).

The same report added that a study by *Public Health England* (PHE) found that 29 percent of the 42 fatalities caused by the new strain were fully vaccinated against the disease. The PHE study only reignited fears of another outbreak, as cases and deaths there were on a downtrend. Many Britons also called for lifting the unnecessary lockdowns.

Variants of concern such as the Delta strain will serve as basis for new lockdowns. The powers at be need this as their excuse to lock down the public!

Chile is another country that has locked itself down over fears of another circulating COVID-19 variant, namely the Brazilian P1 strain. Health authorities in the South American nation [announced a blanket lockdown](#) across its capital city of Santiago on June 10. The lockdown followed Chile's daily nationwide caseload surging 17 percent in the past two weeks. Concurrently, the daily caseload for the Santiago Metropolitan region also spiked by 25 percent in the same period.

[The lockdown starkly contrasted](#) with Chile's mass vaccination drive to protect its population against the Wuhan coronavirus. It boasted of having one of the highest vaccination rates worldwide, alongside countries such as the U.S. and Israel. According to *Reuter's* data, around three-fourths of Chile's 15 million population have already received at least one COVID-19 vaccine dose. Meanwhile, almost 58 percent of Chileans are completely vaccinated against the disease.

As of this writing, the Delta variant accounted for about 10 percent of all new COVID-19 cases in the U.S. The current number was a one percent increase from figures a month ago. But many have expressed fear that the B16172 strain will become the dominant variant in the U.S. – prompting another round of tyrannical public health mandates.

During a June 13 appearance in the CBS program *Face the Nation*, former *Food and Drug Administration* (FDA) Commissioner [Dr. Scott Gottlieb projected](#) that the Delta strain would be likely to become dominant in the U.S. He added that it could lead to new COVID-19 outbreaks in the fall – with unvaccinated Americans facing the most risk.

The erstwhile FDA commissioner said: *“Right now in the U.S., it's about 10 percent of infections [and it's] doubling every two weeks. That doesn't mean that we're going to see a sharp uptick in infections, but it does mean that this is going to take over. And I think the risk is really ... that this could spike a new epidemic heading into the fall.”*

Gottlieb added that the risk of outbreaks caused by the Delta strain would most likely be higher in areas with low vaccination rates, particularly in some cities in the southern U.S. He continued that *“there's a risk ... [of] outbreaks with this new variant”* in the aforementioned areas. The former FDA head also cited data from British epidemiologist Neil Ferguson showing that the B16172 strain was 60 percent more transmissible than the earlier B117 variant.

Ultimately, Gottlieb [doubled down on the use of vaccines](#) to fight the spread of the Delta variant. He remarked that COVID-19 vaccines approved for use in the U.S. and other countries appear to be effective in containing the strain. *“We have the tools to control [the Delta variant] and defeat it. We just need to use those tools,”* he said.

Gottlieb is sending the message that the fault for this is those who are not vaccinated, a disingenuous if not an outright lie, are to blame. He is a shill for Big Pharma!

Prominent scientists sound the alarm, call for more intensive investigations into COVID-19 lab-leak theory

Back in January and February of this year, the World Health Organization (WHO) sponsored an initial investigation into the origins of the pandemic virus. At the time, the WHO concluded it was “*extremely unlikely*” that the pandemic virus came from the now infamous Wuhan laboratory and that a zoonotic transmission (animal to human) was most likely to blame.

The BSL-4 lab in Wuhan is one of the few laboratories in the world certified to perform research on viruses, including Smallpox, Ebola, and Coronavirus.

But in a May 2021 letter published in the peer-reviewed journal ‘*Science*’, some of the world’s leading scientists call this conclusion into serious doubt, saying it was not scientifically justifiable.

In the ‘*Science*’ letter, the researchers also urge officials to scrutinize the Wuhan lab’s involvement in gain-of-function research more closely.

[Gain-of-function research](#) is essentially the process of engineering powerful pathogens. In the laboratory setting, researchers genetically manipulate and modify viruses to make them more infectious.

The fact that gain-of-function research on bat viruses was occurring in a laboratory that *just so happened to be in the same city where the first reports of COVID-19 broke* might

be circumstantial at this point – but even mainstream media has to admit that the lab-leak theory is no longer just a “conspiracy theory.”

The authors of the powerful letter – including a prominent Stanford microbiologist, Harvard epidemiologist, and one of the world’s leading coronavirus researchers – conclude that any future investigations into the origin story of this pandemic virus should be *“transparent, objective, data-driven, inclusive of broad expertise, subject to independent oversight, and responsibly managed to minimize the impact of conflicts of interest.”*

Latest CDC VAERS Data Show Reported Injuries Surpass 7,000 in Ages 12 to 17 Following COVID Vaccines

VAERS data released today by the CDC showed a total of **387,087 reports of adverse events** from all age groups following COVID vaccines, including **6,113 deaths** and **31,240 serious injuries** between Dec. 14, 2020 and June 18, 2021.

This week’s number of reported deaths among all age groups following COVID vaccines surpassed **6,000** according to data released today by the Centers for Disease Control and Prevention (CDC). The data comes directly from reports submitted to the [Vaccine Adverse Event Reporting System](#) (VAERS).

[VAERS](#) is the primary government-funded system for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Every Friday, [VAERS](#) makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date.

Data released today show that between Dec. 14, 2020 and June 18, 2021, a total of [387,087 total adverse events](#) were reported to VAERS, including [6,113 deaths](#) — an increase of **120** deaths over the previous week. There were [31,240 serious injury reports](#), up 1,369 compared with last week.

In the U.S. [316.1 million](#) COVID vaccine doses had been administered as of June 18. This [includes](#): 131 million doses of [Moderna's](#) vaccine, 173 million doses of [Pfizer](#) and 12 million doses of the [Johnson & Johnson](#) (J&J) COVID vaccine.

Of the **6,113 deaths** reported as of June 18, [23% occurred](#) within 48 hours of vaccination, [16% occurred](#) within 24 hours and [38% occurred](#) in people who became ill [within 48 hours](#) of being vaccinated.

This week's data for 12- to 17-year-olds show:

- [7,294](#) total adverse events, including [423](#) rated as serious and [nine reported deaths](#) among 12- to 17-year-olds. Four deaths (or 44%) were cardiac-related and three were sudden, unexplained deaths.

The most recent reported death includes a [13-year-old boy](#) (VAERS I.D. [1406840](#)) who died two days after receiving a Pfizer vaccine. Other deaths include three 15-year-olds (VAERS I.D. [1187918](#), [1382906](#) and [1242573](#)) and two 16-year-olds (VAERS I.D. [1225942](#) and [1386841](#)) and one 17-year-old (VAERS I.D. [1199455](#)).

The report of a 15-year-old male (VAERS I.D. [1383620](#)) who reportedly died after receiving a Pfizer vaccine was removed from the database on June 18. It was a duplicate of VAERS I.D. 1382096. Two of the nine deaths were suicides.

CDC finds 'likely' link between heart inflammation and mRNA COVID vaccines

As [The Defender reported](#) June 23, the CDC's Advisory Committee on Immunization Practices (ACIP) said there is a "likely association" of "mild" heart inflammation in adolescents and young adults after vaccination.

Members of a CDC advisory committee acknowledged 1,200 cases of heart inflammation in 16- to 24-year-olds, mostly occurring in males, and said mRNA COVID vaccines should carry a warning statement — but physicians and other public commenters accused the CDC of exaggerating the risk to young people of COVID, and minimizing the risk of the vaccines.

Dr. Tom Shimabukuro, deputy director of the CDC's Immunization Safety Office, [said in a presentation](#) that data from one of the agency's safety monitoring systems — [Vaccine Safety Datalink](#) (VSD) — suggests a [rate of 12.6 cases per million](#) in 12- to 39-year-olds during the three weeks after the second shot.

[The Defender](#) has been unable to report on VSD data related to COVID vaccine adverse events, including heart inflammation, as the VSD does not make data collected through the system readily available to the public.

The VSD is a collaborative project between the CDC and “several large health plans,” according to its [website](#). Though the public can’t access the VSD data, there is a process whereby researchers can apply to access data.

According to the VSD website: “There are [several ways](#) interested researchers can access VSD data. In 2002, the VSD established a data sharing program at the [National Center for Health Statistics \(NCHS\) Research Data Center \(RDC\)](#) to allow external Guest Analysts to (1) [conduct](#) new vaccine safety studies using VSD data files available at CDC or (2) to [reanalyze](#) study-specific datasets from published VSD studies.”

The VSD data sharing program is a three-step process:

1. Submission of proposals to CDC’s RDC at NCHS
2. Submission of proposals to VSD site Institutional Review Boards
3. Use of CDC’s RDC at NCHS

FDA to add warning about rare heart inflammation to Pfizer and Moderna vaccines

On June 24, [The Guardian reported](#) the U.S. Food and Drug Administration will add a warning to COVID vaccines produced by [Pfizer /BioNTech](#) and [Moderna](#) about rare cases of heart inflammation in adolescents and young adults, the agency announced Wednesday.

Health regulators in several countries have been investigating whether the Pfizer and Moderna vaccines using mRNA technology present a risk and, if so, how serious. The CDC advisory group found the inflammation in adolescents and young adults is likely linked to the vaccines, but the benefits of the shots outweigh the risk.

18-year-old has a heart attack after second dose of Pfizer vaccine

As [The Defender reported](#) June 22, 18-year-old Isaiah Harris was hospitalized after suffering a heart attack within 48 hours of his second dose of the Pfizer vaccine and is on total bed rest for six months. Isaiah Harris and his father, Justin Harris, described the traumatic ordeal in an exclusive interview.

“We took him to the hospital but they didn’t take him seriously,” Harris said. “We waited in the waiting room for over two hours and then they left him in a hallway for six hours. At one point, 80% of Isaiah’s heart was inflamed and only 40% was functioning. Isaiah’s [troponin levels](#) were so high doctors said he had suffered a heart attack. Dr. Anthony Fauci, the top medical adviser to President Joe Biden and perhaps now America's most famous physician, isn't leaving the spotlight just yet. In addition to warning America about [continually emerging variants](#) and other COVID-19 risks, Fauci is on the defensive after emails were leaked revealing he downplayed the lab-leak theory of the novel coronavirus origin; and hid his Gain-of-Function activities with the Chinese CCP.

The head of the National Institute for Allergy and Infectious Diseases (NIAID) has done the media rounds in recent weeks to accuse his opponents of "distortion" and taking his emails out of context. He's insisted in media appearances that he kept an "open mind" throughout the pandemic to the lab-leak theory as a possibility. "Even if you lean that this is more likely a natural occurrence, we always felt that you got to keep an open mind, all of us. We didn't get up and start announcing it, but we said, 'keep an open mind,' and continue to look. So I think it is a bit of distortion to say that we deliberately suppressed that," [he recently told CBS This Morning.](#)

While not entirely dismissive, Fauci certainly downplayed on the national stage the likelihood of a lab leak from the early months of the pandemic. *"If you look at the evolution of the virus in bats, and what's out there now is very, very strongly leaning*

toward this [virus] could not have been artificially or deliberately manipulated,” [he said in May 2020](#).

He said arguments that the virus had developed naturally, been brought to a lab, and accidentally leaked from there amounted to “circular” logic: “That’s why I don’t get what they’re talking about [and] why I don’t spend a lot of time going in on this circular argument.” I doubt seriously that the Jesuit Dr. Fauci will ever face prosecution because of the Biden administration.

Around the same time, [Fauci strongly suggested](#) to reporters at the White House that many scientists believed that a “jump of species from [a bat] to a human” was “totally consistent” with the sequences they looked into.

He said, “a group of highly qualified evolutionary virologists looked at the sequences ... in bats as they evolve. And the mutations that it took to get to the point where it is now is totally consistent with a jump of a species from an animal to a human.”

The study Fauci was referencing was a [paper published in Nature Medicine](#), which concluded: “We do not believe that any type of laboratory-based scenario is plausible.”

More recently, Fauci pushed back on former CDC Director Robert Redfield’s claim that he believed a lab leak was the origin of COVID-19. “Dr. Redfield was mentioning that he was giving an opinion as to a possibility, but again, there are other alternatives – others, that most people hold by,” [Fauci said in March](#).

Fauci may have not outwardly denied the possibility of a lab leak, but he certainly diminished it. His early remarks on the comments were to the point where Peter Daszak, now most known for [aiding and abetting the Chinese government](#) in kneecapping the [WHO’s COVID-19 origins probe](#), thanked him for dispelling the theory in a now-public email.

“I just wanted to say a personal thank you on behalf of our staff and collaborators, for publicly standing up and stating that the scientific evidence supports a natural origin for COVID-19 from a bat-to-human spillover, not a lab release from the Wuhan Institute of Virology,” [Daszak emailed to Fauci](#) in April 2020.

Fauci responded to Daszak’s email to thank him for his “kind note.”

Fauci still says he finds a natural origin to be more likely, but he’s gone out of his way not to diminish the lab leak in recent interviews. He has yet to seriously explain why he’s made this shift in tone, or really acknowledge that he’s even made it. Typically Fauci says his changes in position are due to new and evolving evidence. For instance, after changing his [stance on mask-wearing](#) from early in the pandemic, he said he did so because the evidence and knowledge of the virus changed. “It was not a

change because I felt like flip-flopping. It was a change because the evidence changed, the data changed,” he [recently told The New York Times](#).

Though, the evidence hasn't particularly changed. Proponents of the theory argue that most of the information they cite was available to Fauci, and everyone else, back in early 2020.

There is no—absolutely no—scientific evidence that “points” in either direction.

The totality of the evidence cited by those asserting “evidence.. points to nature” is the banal, jejune observation that natural spillover has occurred in the past and thus may have occurred again.

“All evidence available today was available twelve months ago, and most evidence available today was available fifteen months ago,” Rutgers University molecular biologist Dr. Richard Ebright told the Daily Caller in May. “All that has changed is that the small group that seized control of the narrative in February 2020 and deceived the public and policy-makers for fifteen months now has lost control of the narrative,” Ebright continued.

Ebright has been persistent in insisting that the evidence hasn't changed, and the public record backs him up. It was known early on that the epicenter of the pandemic was Wuhan, just miles away from the Wuhan Institute of Virology. It was also known that Dr. Shi Zhengli was an expert in working on bat-based coronaviruses at that facility, and that dangerous gain-of-function research had been performed there.

Most of the evidence, albeit circumstantial, was evident. Ebright also contends, counter to Fauci, that there's no evidence to suggest that the virus naturally transferred from animals to humans other than that such an occurrence has happened with past pandemics.

NEW: Dr. Fauci tells me that his opinion about the origins of COVID-19 have not changed: He believes that it is “*highly likely*” that it first occurred naturally before spreading from animal to human. Since no one is 100% sure, he's open to a thorough investigation.

Fauci has repeatedly claimed that past precedent is a major factor that he believes natural spillover is the likely source of COVID-19. *“I believe if you look historically, what happens in the animal-human interface, that, in fact, the more likelihood is that you're dealing with a jump of species,”* [he told CNN](#).

But Fauci's emails prove he was aware of the evidence of a lab leak, and apparently didn't take it seriously in the public. Infectious disease expert Kristian Anderson [explained to Fauci in January 2020](#) that the virus looked potentially "engineered." At the clinic, the president thanked medical staff and volunteers for their work getting shots in arms. He also spoke with four people waiting to get their shots, asking them their ages and thanking them for getting vaccinated.

Joe Biden was greeted with shouts of *"Uncle Joe"* and *"We love you"* when he made his remarks on the pandemic at the Green Road Community Center. The crowd, made up of a volunteers to do canvassing efforts to get people vaccinated, was made up of mainly African Americans and Latinos. The president gave them a wave and thumbs' up.

“There are some things that transcend even hockey,” she noted. *“Getting Americans vaccinated is one of them.”*

She pointed out that people who get their vaccine that day can win tickets to Friday's game hockey game.

The first lady and Fauci were at a pop-up clinic at the hockey arena. Both ventured out onto the ice great people getting vaccinated.

Jill Biden and Dr. Fauci arrive to tour the pop-up clinic

Thursday marked an all-administration effort from Biden officials as the Delta variant causes concern among health officials about a potential surge in COVID cases.

Vice President Kamala Harris met virtually with local community groups and members that are doing the grassroots work to encourage vaccinations.

Second gentleman Doug Emhoff and Surgeon General Vivek Murthy held a press call on the administration's efforts to get young people vaccinated.

The White House is pushing hard to raise vaccination rates - particularly among younger adults who have a lower one compared to older members of the population.

In North Carolina, 55 percent of adults have had one COVID shot, according to the N.C. Department of Health and Human Services.

Officials are emphasizing the new Delta strain of COVID, which is 60% more contagious, and causing an increased number of [coronavirus](#) cases in some Southern and Western states.

In a video posted to Biden's social media accounts on Thursday, Fauci warned that younger people are at greater risk of getting infected thanks to the new Delta strain.

Fauci pointed out the Delta variant is 'transmitted much more efficiently, which means the chances of getting infected upon exposure is greater.'

'Anyone who is not vaccinated are most at risk,' he warned. 'Younger people are less likely to be vaccinated and that puts the entire cohort of younger people at greater risk.' He added: 'The way you stop this Delta variant is to get vaccinated.'

The push comes as the White House has said it will go ahead with its July 4th celebrations even as the administration failed to meet its goal of getting 70% of adults partially vaccinated by Independence Day.

Officials are still urging shots in arms as the holiday - which typically features large gatherings of people to barbeque and watch fireworks - approaches.

In North Carolina the vaccination rate is falling week by week with the weekly rate of vaccinations in the state has dropped by 83% since April.

At the current pace of vaccinations, North Carolina isn't expected to meet Biden's goal of 70% of adults vaccinated until November, The Raleigh News & Observer calculated.

Health officials in the state have unveiled a variety of financial incentives to get shots in arms, including a \$1 million cash jackpot to be given to four randomly selected North Carolinians who have been vaccinated.

Of the 10 states with the lowest vaccination rates, eight are in the South and, four - [Alabama](#), [Louisiana](#), [Mississippi](#) and Wyoming - have yet to partially vaccinate half of those aged 18 and older. Daily doses administered have fallen by as much as 90 percent since the spring.

Health officials warn regional surges of COVID cases are possible as the Delta variant gains steam. Those officials also note such outbreaks are avoidable if people get vaccinated. Double-down on the propaganda is their only answer to admitting their guilt!

"The Delta variant is currently the greatest threat in the U.S. to our attempt to eliminate Covid-19," Fauci warned at a COVID briefing on Wednesday.

"There will be local, type of regional outbreaks," he noted, saying it was *"totally and completely avoidable by getting vaccinated."*

As of Wednesday, 65.5 percent of adults in the U.S. have received at least an initial dose, and experts say boosting rates in the Southern states will be key to beating back the virus.

Officials in the Biden administration are on a national tour to as part of their efforts to boost vaccination rates and combat vaccine hesitancy.

Jill Biden was in Mississippi and Tennessee on Tuesday. On Thursday, the first lady will be in Kissimmee and Tampa, Florida, where the Tampa Bay Lightning hockey team will join her in encouraging people to get vaccinated. Only 44 per cent of the state's population is fully vaccinated.

Vice President Kamala Harris kicked off the vaccination tour last week, making two Southern stops - in Greenville, South Carolina, and Atlanta.

Second gentleman Doug Emhoff was in Chicago on Wednesday.

The push comes after Biden's administration conceded Tuesday that it will fall short of its goal of having partially vaccinated 70 per cent of adult Americans by July 4th - but officials vowed they would 'crush' COVID-19 and said they have incentives in the work to raise the vaccination rate. They could tell the truth and reveal there is really no Covid virus as noted in several of the sources that have come forth with!

Officials blamed the missed goal - of having one shot in the arm of 70% of adult Americans - because of the slow vaccination rate among 18-to-26-year-olds. They are either liars, lunatics, or part of the globalist plan to enslave and microchip the world!

"The country has more work to do, particularly with 18-to-26 year-olds. The reality is many younger Americans have felt like COVID-19 is not something that impacts them, and they've been less eager to get the shot," Jeffrey Zients, the head of the White House COVID response team, said at a press briefing.

"It'll take a few extra weeks to get to 70% of all adults with at least one shot with the 18-to-26-year-olds factored in," he added.

He also conceded the White House would fall short on Biden's goal to have 150 million Americans fully vaccinated by Independence Day, coming in a few weeks late.

"We will hit 160 million Americans fully vaccinated no later than mid July," he said.
