## **Mask & Social Distancing Policies Need To Continue Indefinitely Says WHO**

Summit News reports: According to Nabarro, mask mandates and social distancing need to remain in place for the foreseeable future “*as part of our defense*” against COVID, particularly in regions which have high infection rates.

As we highlighted earlier, England is set to drop all face mask rules on July 19 after it was revealed that they were having a massive negative impact on businesses and wiping billions off the economy. That has changed according to UK news sources.

Several government advisers have called for coronavirus restrictions to continue forever, not just to defend against COVID, but also to fight influenza.

Former Communist Party member and SAGE adviser Susan Michie said earlier this month that mask mandates and social distancing should continue “forever” and that people should adopt such behavior just as they did with wearing seatbelts.

**Since the mid-1980s, the number of childhood shots on the Centers for Disease Control and Prevention (CDC) vaccine schedule has more than quadrupled.**

When parents express reluctance about turning their little ones into perpetual pin cushions, drug makers and doctors have a ready answer — combination vaccines that “simplify” the schedule by decreasing the number of injections administered.

This month marks the U.S. launch of the Merck/Sanofi joint-venture vaccine, Vaxelis, a six-in-one (hexavalent) combination vaccine that contains diphtheria, tetanus and acellular pertussis (DTaP) components as well as components said to protect against polio, Haemophilus influenzae type b (Hib) and hepatitis B.

Public health officials optimistically believe that bundling all of these components into one shot will help close noncompliance loopholes and increase the likelihood that children will complete “*all recommended vaccinations.*”

Though Vaxelis is the nation’s first hexavalent injection, it joins other four- or five-in-one vaccines already on the CDC schedule. The U.S. Food and Drug Administration (FDA) approved Vaxelis in late 2018 — as a three-dose series for 2-, 4- and 6-month-old infants — but it is only now, two-and-a-half years later, that the shot is being readied for widespread distribution.

Warning signs were ignored.

There are numerous warning signs that potent all-in-one vaccines are too much for immature immune systems to handle. Concerning safety signals have emerged not just for hexavalent but also pentavalent (five-in-one) vaccines.

In Europe, where infants have been given hexavalent vaccines for some years (including Vaxelis since 2016), the formulations have produced many troubling reports of sudden infant death.

Absurdly, none of the clinical studies assessing Vaxelis safety and efficacy conducted fair comparisons against an inert placebo. Instead, in the two U.S. clinical trials for Vaxelis, not only did investigators compare infants receiving Vaxelis to babies who received Sanofi’s five-in-one Pentacel — but babies in both groups also received rotavirus and pneumococcal vaccines at the same time!

In this context, the CDC’s sales pitch to the public — and its claims that side effects are “usually mild” — cannot be considered credible.

Here are some of the other facts missing from the CDC’s communications:

- In the two U.S. trials six infants died (slide #27) in the Vaxelis group (some after receiving just one dose); one infant also died in the “control” group that received five-in-one vaccines.
- All six Vaxelis recipients died within six weeks of vaccination. This timing matches other published accounts of infant deaths “clustering” following hexavalent vaccination.

- The reported causes of death for the infants who received Vaxelis included asphyxia, sepsis, fluid in the brain and sudden infant death syndrome (SIDS). These outcomes correspond to the types of adverse events reported following hexavalent vaccination in Europe.
- Package inserts for other vaccines on the CDC schedule list similar causes of death, suggesting these fatal Vaxelis outcomes are plausibly associated with vaccination.
- In the clinical trials, the rate of fever was notably higher in Vaxelis recipients even when compared to children receiving five-in-one vaccines (47% vs. 34%).

Juicing vaccine sales!

In the no-liability context enjoyed by vaccine makers in the U.S., combination vaccines are already quite popular. In fact, market watchers and health economists praise the jumbo shots as being a catalyst for positive industry trends and a “key to commercial success.”

Thus, financial analysts expect Vaxelis to “garner significant patient share following its [U.S.] launch” — predicting that it will account for almost a third of U.S. DTaP vaccinations by 2028 — or \$841 million in annual sales.


These predictions represent good news for Merck and Sanofi, two of the “big four” pharma giants that dominate the childhood vaccine market in the United States. Merck is already doing a booming vaccine business, recently reporting annual sales growth of 14.8% for its pneumococcal vaccine (Pneumovax 23) and 5.4% for its human papillomavirus (HPV) vaccine Gardasil-9.

However, Merck also faces proliferating Gardasil-related lawsuits — including legal actions alleging that the company knew about and ignored life-changing adverse events from the get-go, many of which (when not fatal) have involved autoimmunity and chronic pain. In fact, before the advent of emergency use COVID vaccines (responsible for an alarming escalation of vaccine-related adverse events), Gardasil had had “more side effects reported than all other vaccines combined.”

Sanofi, too, is embroiled in thousands of lawsuits worldwide — notably for its disastrous and sometimes fatal dengue vaccine. As with Merck, this has not dampened overall vaccine sales growth, which continues its strong upward trajectory, likely to be further strengthened by the U.S. Vaxelis rollout.

Although Sanofi has not been a front-runner in the COVID vaccine race, the company is currently running clinical trials for messenger RNA (mRNA) vaccines for both COVID and seasonal influenza.

The average time it has taken for all vaccines on the market to be approved is around eight years. They began administering the Covid-19 vaccines into the arms of the general public within 11 months of them allegedly being created, but even then they weren't approved like other vaccines, they were instead given emergency use authorization. The second step the WEF recommend public health officials implement involves propaganda and harassment. This revolves around the “feel” stage of the advertising theory and states that the vaccine hesitant should be bombarded with phone calls and discussions, and harassed on social media to persuade them to get the Covid jab.

The WEF also suggest another way to improve vaccine skeptics’ feelings is to play into a fear of missing out (FOMO), both socially and economically. To achieve this WEF recommend that public health officials use tactics that induce guilt and regret.

They suggest this can be done in a similar fashion as was successfully employed in Canada during the 1930’s and 1940’s to confront diphtheria. During this period, they used messages such as “if your children die of diphtheria, it is your fault because you prefer not to take the trouble to protect against it.”

The problem here is that the [Covid vaccines do not prevent infection or transmission](#), therefore using messaging such as what the WEF recommends is coercion and would not amount to informed consent, because instead the person would be extremely misinformed.

The Covid jabs have only allegedly been proven to reduce the risk of being hospitalized or dying from Covid-19, a risk that is already incredibly small for most people amounting to around 0.02% on average.

The limited trials carried out only measured whether or not a vaccinated person suffered serious disease if infected with Covid-19, but they were flawed as nobody was exposed to the virus during the study, they only measured what occurred when out in the general population.

They did not measure whether a vaccinated person could still become infected with Covid-19, and they did not measure whether or not a vaccinated person could still spread the virus in line with the [mainstream accepted germ theory](#).

Pretty disgraceful advice from the WEF considering the above isn't it?

The third and final step the WEF recommend public health officials implement involves bribery, and cold-calling. This revolves around the “do” stage of the advertising theory and states that incentives should be offered to coerce people to get the Covid-19 vaccine, as well as harassing people at their homes in an attempt to persuade them to have the jab there and then.

The WEF advises public health officials to offer cash incentives, free transportation, paid time-off, free products, and lottery giveaways as bribes to “encourage” take up of the Covid jab.

They also advise that pop-up clinics are set up in under-served areas with vaccine-hesitant populations and to create “vaccine swat teams” that harass people in their homes under the guise of reaching people who are “home-bound” or “experience difficulty” in getting to vaccination centers.

The World Economic Forum state that they “believe applying the “**think – feel – do**” patient-centered approach to the COVID-19 vaccine communication problem will improve efforts at accelerating global herd immunity. Ensuring a safe economic reopening and recovery and overcoming this significant health and economic challenge could depend on such tactics.”

When I contacted Blaxill to ask how to run a patent search, he was kind enough to do it for me. He found 57 granted US patents with the CDC listed as an assignee. You can see the [search results here](#).

Upon cursory review of the patents, I found that one did not seem applicable to vaccination, but merely referenced an article on vaccination. That leaves us with 56 CDC patents to scrutinize.

Here is what I found.

There are CDC patents applicable to vaccines for [Flu](#), [Rotavirus](#), [Hepatitis A](#), [HIV](#), [Anthrax](#), [Rabies](#), [Dengue fever](#), [West Nile virus](#), [Group A Strep](#), [Pneumococcal disease](#), [Meningococcal disease](#), [RSV](#), [Gastroenteritis](#), [Japanese encephalitis](#), [SARS](#), [Rift Valley Fever](#), and [chlamydomphila pneumoniae](#).

There is a CDC patent for "[Nucleic acid vaccines for prevention of flavivirus infection](#)," which has applications in vaccines for Zika, West Nile virus, Dengue fever, tick-borne encephalitis virus, yellow fever, Palm Creek virus, and Parramatta River virus.

**CDC also has several patents for administering various "shots" via [aerosol delivery systems for vaccines](#). [Think Chemtrail spraying!]**

There's a CDC patent on a process for vaccine quality control by "quantifying proteins in a complex preparation of uni- or multivalent commercial or research vaccine preparations."

There's a CDC patent on a method "for producing a model for evaluating the antiretroviral effects of drugs and vaccines."

CDC has a patent for companies who want to [test their respiratory system](#) applicable vaccine on an artificial lung system.

If a vaccine maker is concerned that their vaccine might contain a [human rhinovirus](#), CDC has a patent on a process for determining if such contamination exists.

CDC has a patent on an assay to assist vaccine makers in finding [antigen-specific antibodies](#) in a biological sample.

CDC holds a patent that provides vaccine makers with a method of "reducing the replicative fitness of a pathogen by deoptimizing codons." Asserting that, "pathogens with deoptimized codons can be used to increase the phenotypic stability of attenuated vaccines."

The agency also holds a patent on [adjuvants](#) for a vaccine used on premature infants and young babies.

There is a CDC patent to cover a vaccine for an infection induced by a [tape worm found in pork](#).

They even have patents that cover vaccines for animal illnesses including [Canarypox virus](#), [Fowlpox virus](#), [Sealpox virus](#), [dog flu](#) and [monkey cancer](#).

**Does this seem like a public health agency making "independent" vaccine recommendations, or a private company with an impressive portfolio to which one might look for investment opportunities?**

The CDC is reputed to be an independent government agency making vaccine recommendations to the public, only for the public good. They are the agency charged with vaccine safety oversight, via their [Immunization Safety Office](#).

Here is how the office describes its charge:

*“CDC’s Immunization Safety Office plays a vital role in ensuring our nation’s vaccine safety.*

*Sound immunization policies affecting children and adults in the U.S. depend on continuous monitoring of the safety and effectiveness of vaccines. CDC uses many strategies to assess vaccine safety, to identify health problems possibly related to vaccines, and to conduct studies that help determine whether a health problem is caused by a specific vaccine. CDC also works with other federal government agencies and other stakeholders to determine the appropriate public health response to vaccine safety concerns and to communicate the benefits and risks of vaccines.*

*The Immunization Safety Office regularly reports on vaccine safety monitoring findings and any concerns to CDC’s Advisory Committee on Immunization Practices (ACIP). This advisory group develops the recommended vaccine schedule for children and adults in the U.S. ACIP considers the safety and effectiveness of vaccines before making recommendations to the vaccine schedule or changing recommendations for vaccine use.”*

Note that they proudly state that they report to the ACIP – the same committee on which Paul Offit infamously served, as if this reporting somehow adds legitimacy to their vaccine safety work. The same committee that [Congress has excoriated for their long history of conflicts of interests.](#)

Nowhere on the CDC’s web site can I find the disclosure that the agency is a profit partner with the vaccine makers for whom it is supposed to be providing safety oversight.

Mr. Kennedy is in very safe territory by reporting that the CDC has over 20 patents that create vast, undisclosed conflicts of interests in vaccine safety. He is understating the problem by more than half.

This brief look at current patents held by the CDC deserves an in-depth review to determine exactly what current financial relationships with vaccine makers now exist and what the current impact those revenue streams are likely having on vaccine safety positions. Furthermore, one must closely look at the financial relationships between the CDC and vaccine makers it is currently courting, to include the potential exploitation of new patents for financial gain. These are merely a few lines of inquiry, among hundreds, needing to be examined and why the potential RFK commission on vaccine safety must be impaneled.

**DEPOPULATION ALERT: Shocking new study reveals covid vaccine TERMINATES 4 out of 5 pregnancies via "spontaneous abortions"**

(Natural News) A shocking new study published in the New England Journal of Medicine reveals that when pregnant women are given covid vaccinations during their first or second trimesters, **they suffer an 82% spontaneous abortion rate, killing 4 out of 5 unborn babies.**

This stunning finding, explained below, is self-evident from the data published in a new study entitled, "Preliminary Findings of mRNA Covid-19 Vaccine Safety in Pregnant Persons." Just as disturbing as the data is the fact that the study authors apparently sought to deliberately obfuscate the truth about vaccines causing spontaneous abortions by obfuscating numbers in their own calculations.

Originally brought to our attention by a Life Site News article, we checked with our own science contacts to review the data and double check all the math. In doing so, we were able to confirm two things:

1. Yes, the study shows an 82% rate of spontaneous abortions in expectant mothers given covid vaccines during their first or second trimesters.
2. Yes, the study authors either deliberately sought to hide this fact with dishonest obfuscation (explained below) or they are incompetent and made a glaring error that brings into question their credibility.

In other words, this study was almost certainly a cover-up to try to claim vaccinating pregnant women is perfectly safe. But the study data actually show quite the opposite.

Here's how:

700 of the 827 women were vaccinated in the third trimester.

Table 4 from the study, shown below, reveals that a total of 827 pregnant women were studied. Out of the 827 women, 700 of them received their first vaccine in their third trimester of pregnancy. This means 127 women (which is  $827 - 700$ ) received a vaccine during their first or second trimesters. (You have to read the fine print below the table to see this disclosure.)

Out of the 127 women receiving vaccines during their first or second trimesters, 104 spontaneous abortions occurred before their pregnancies hit the 20-week mark. These are indicated as "spontaneous abortions" in the table.

In simple math, 104 spontaneous abortions (during the first 20 weeks) out of 127 women who received vaccines in their first or second trimesters calculates to an 82% rate of spontaneous abortions among these pregnant women who were vaccinated.

It is important to note that deaths of unborn babies during the third trimester are known as "stillbirths" and not spontaneous abortions. Thus, the spontaneous abortions could not have possibly occurred in women vaccinated during their third trimester, by definition.

Thus, the study authors dishonestly used the wrong denominator of 827 in their “spontaneous abortions” calculation, when they should have used a denominator of 127, which is the number of women receiving vaccines during their first or second trimesters.

Put another way, it is impossible for a woman who was vaccinated for the first time during her *third* trimester to have a “spontaneous abortion” in the first 20 weeks, since they weren’t vaccinated during the first 20 weeks (and pregnant women aren’t time travelers). Thus, those women shouldn’t be included in the denominator used to calculate the spontaneous abortion rate.

The authors of this study should receive an award in the category of, “How to lie with statistics,” because they apparently tried to pull a sleight-of-hand trick to make it appear that vaccines are safe for pregnant women. In reality, they seem to be killing more than 4 out of 5 unborn babies in the first 20 weeks of gestation, at least in this data set. (It’s a small set of 127 pregnant women, so we’d like to see a larger review of many thousands of pregnancies in order to get a more clear picture.)

Apples and oranges, lemons and limes.

A simple way to explain this with a metaphor is to imagine a bag of 50 lemons and 50 limes, with a science study asking the question, “What percentage of lemons are yellow?” The scientists count all the yellow fruit and reach the number 50. They

mistakenly divide 50 into 100 because there are 100 total piece of fruit, then they declare, “50% of lemons are yellow” because it’s 50/100.

But the other 50 pieces of fruit can’t possibly be included because they’re limes, not lemons. So the correct math is 50/50, which means 100% of the lemons are yellow. That’s the correct answer.

In this science paper, they are using 827 as the denominator, even when 700 out of those 827 women were only vaccinated in the third trimester, which is *long past* the time window during which a “spontaneous abortion” can occur. And since pregnant women aren’t time travelers, they can’t go back in time and report a spontaneous abortion from months earlier.

If vaccine scientists either can’t do this basic math — or are willfully deceiving the world with dishonest obfuscation of the numbers — then “science” has already failed its core promise: to offer “evidence-based” conclusions to understand the world around us.

Yet when 4 out of 5 pregnant women lose their babies in the first 20 weeks, these scientists falsely claim the spontaneous abortion rate is only 12.6%. Why? Because they’re covering up the atrocities of the vaccine for political reasons, most likely.

In fact, the key author of the study, Tom T. Shimabukuro, is also [named in numerous other studies](#) that claim to document adverse reactions in various vaccines, ranging from rotavirus vaccines to the H1N1 vaccine from 2009. It raises the obvious question: Did Shimabukuro make the same error in other studies that concluded vaccines posed no significant risk of adverse events? For example, here’s another study he co-authored: [“Adverse events after Fluzone ® Intradermal vaccine reported to the Vaccine Adverse Event Reporting System \(VAERS\), 2011-2013.”](#)

That study concluded, “Review of VAERS reports did not identify any new or unexpected safety concerns after TIV-ID.”

But is that conclusion based on bad math, like the study on covid vaccines given to pregnant women? We call for a review of all his methods and conclusions. Perhaps this same study architect has made the same systematic error (or possibly a deliberate obfuscation) for many years, spanning many previous studies. It wouldn’t be the first time one author was found to have made systematic mistakes across dozens of papers and is forced to retract them.

And isn’t that what the “scientific method” demands? Peer review. Double checking the math. Admitting to mistakes in conclusions. This is how science progresses, by pointing out errors and demanding they be addressed and corrected. We can’t just accept bad math and call it “science” when the bad math doesn’t check out.

**New report stuns the world: The vast majority of those now dying with covid are people who were VACCINATED against it**

The news just so happened to come out the same day that the mainstream media ran a distraction story about British politician Matt Hancock having a secret affair with his aide

Gina Coladangelo. Many people missed it the day it broke, in other words, but now it is circulating the web and causing many to question whether the jabs are truly safe and effective as the government claims.

Fresh data out of the U.K. shows that injected people are three times more likely to die from the so-called “delta variant” than people who left their immune systems and DNA alone by *just saying no*, as Nancy Reagan once said, to dangerous drugs.

Titled, “SARS-CoV-2 variants of concern and variants under investigation in England,” the paper, which is the 17th technical briefing to be released thus far on the matter, is highly telling as to what is in store for the jabbed later on down the road.

A table in the report shows that between Feb. 1, 2021, and June 21, 2021, there have been 9,571 confirmed cases of the “delta variant” in British people over the age of 50. Of these, 8,025 were confirmed just within the past 28 days alone.

This sudden spike in new cases directly coincides with the U.K.’s vaccine push, showing that the more people are getting vaccinated, the higher the rate of infections.

## **Face Masks Cause Children to Inhale Dangerous Levels of Carbon Dioxide at SIX TIMES the Safe Limit, Study Finds**

New research published in [JAMA](#) (*Journal of the American Medical Association*) has found that wearing a face mask causes children to inhale dangerous levels of carbon dioxide that becomes trapped behind the mask.

The peer-reviewed research letter from Dr. Harald Walach and colleagues found that the air masked children inhaled contained more than six times the legal safe limit set down for closed rooms by the German Federal Environmental Office. The safe limit is 0.2% while the air the masked children inhaled was over 1.3% carbon dioxide.

The effect was worse for younger children, with one seven year-old child inhaling air with 2.5% carbon dioxide, over 12 times the safe limit.

The study looked at two types of mask, FFP2 masks and surgical masks, and found no significant difference between the two.

The authors explained that this alarming result likely explains the complaints from children who wear face masks for long periods.

Most of the complaints reported by children can be understood as consequences of elevated carbon dioxide levels in inhaled air. This is because of the dead-space volume of the masks, which collects exhaled carbon dioxide quickly after a short time. This

carbon dioxide mixes with fresh air and elevates the carbon dioxide content of inhaled air under the mask, and this was more pronounced in this study for younger children.

This leads in turn to impairments attributable to hypercapnia. A recent [review](#) concluded that there was ample evidence for adverse effects of wearing such masks. We suggest that decision-makers weigh the hard evidence produced by these experimental measurements accordingly, which suggest that children should not be forced to wear face masks.

With face masks [shown](#) to have little to no impact in reducing infection or transmission, this suggests the policy is all pain and no gain and should be abandoned without delay.

### **Heart Inflammation Linked to COVID Vaccines in Study of U.S. Military, Department of Defense Confirms**

In a study published June 29 in JAMA Cardiology, researchers described 23 cases of myocarditis in healthy military members who developed the condition within four days of receiving the Pfizer or Moderna COVID vaccines.

A [new study](#) of U.S. service members found higher than expected rates of heart inflammation following receipt of a COVID vaccine. It's a finding [Defense Department researchers](#) say should call attention to the condition, known as [myocarditis](#), as a potential side effect of vaccinations.

In a study published June 29 in JAMA Cardiology, U.S. military physicians described 23 cases of myocarditis in previously healthy males who developed the condition within four days of receiving a [COVID vaccine](#).

A [total of 23 male patients](#) (22 currently serving in the military and 1 retiree) with a median age range of 25 years were evaluated between January and April 2021 for acute-onset chest pain following vaccination with an mRNA COVID vaccine.

All military members were previously healthy with a high level of fitness. They were physically fit by military standards and lacked any known history of cardiac disease, significant cardiac risk factors or exposure to cardiotoxic agents.

Seven military members received [Pfizer's](#) COVID vaccine and 16 received the [Moderna](#) vaccine. Each patient had a final diagnosis of myocarditis without infectious, ischemic or autoimmune etiologies identified. Diagnoses were reviewed and met the U.S. Centers for Disease Control and Prevention's (CDC) case definition criteria for probable [myocarditis](#).

All patients presented with acute chest pain and significantly elevated [cardiac troponin levels](#) (10-fold to 400-fold the upper limits of their respective reference ranges) with symptom onset within 12 to 96 hours following COVID vaccination.

According to the [study](#), physicians expected to find eight or fewer cases of myocarditis among the 436,000 male military members who received two mRNA doses. But 20 military members [developed inflammation](#) after their second dose, including 14 after the Moderna shot and six after the Pfizer shot. Three developed myocarditis after their first vaccine.

Cardiac symptoms resolved within a week of onset for 16 patients, but seven continued to have chest pain at the time of publication.

The [researchers stated](#) that while the true incidence of myocarditis is unknown at this time, the presentation pattern and clinical course suggest an association with an inflammatory response to vaccination.

The team concluded that increased attention to myocarditis as a potential adverse event following vaccination is warranted.

New study supports link between mRNA COVID vaccines and heart inflammation

A separate [study](#) published in JAMA Cardiology on June 29 investigated seven cases of acute myocarditis. Four cases occurred within five days of COVID vaccination between Feb. 1 and April 30.

All four patients had received the second dose of an mRNA vaccine and presented with severe chest pain, had biomarker evidence of myocardial injury, were hospitalized and had test results consistent with myocarditis.

“It is possible that these four cases of acute myocarditis represent a rare, potential adverse event linked to mRNA COVID-19 vaccination,” researchers wrote. “The findings from the present report raise the possibility of an association between mRNA COVID-19 vaccination and acute myocarditis.”

An association between COVID vaccines and myocarditis was [first reported](#) in Israel with a case study in February involving a 19-year-old male.

On April 26, [details leaked](#) from an Israeli Health Ministry report raising concerns among experts about a possible link between the Pfizer-BioNTech COVID vaccine and myocarditis.

A [preliminary report](#) by an Israeli committee tasked with monitoring vaccine side effects found 62 cases of myocarditis, including two deaths, in people who received the Pfizer vaccine. Fifty-six cases occurred after the second dose of the vaccine, and 55 cases occurred in men — most between the ages of 18 and 30.

The two patients who died were [reportedly healthy](#) until receiving the vaccine and had no pre-existing conditions.

## **1,007,253 Injuries 1,403 DEAD in the UK Following COVID-19 Injections According to UK Government**

The UK Government's [reporting system for COVID vaccine adverse reactions](#) from the *Medicines and Healthcare products Regulatory Agency* released their latest report today, July 1, 2021.

The report covers data collected from December 9, 2020, through June 23, 2021, for the three experimental COVID “vaccines” currently in use in the U.K. from Pfizer, AstraZeneca, and Moderna.

They report a total of **1,403 deaths** and **1,007,253 injuries** recorded following the experimental COVID injections.

Here are the breakdowns from the three shots:

- AstraZeneca: 936 deaths and 762,706 injuries. ([Source.](#))

- Pfizer- BioNTech: 439 deaths and 223,404 injuries. ([Source.](#))
- Moderna: 5 deaths and 18,548 injuries. ([Source.](#))
- Unspecified COVID-19 injections: 23 deaths and 2595 injuries. ([Source.](#))

In addition to these official UK Government statistics, last Friday, 25 June 2021, *Public Health England* released a report showing that those dying in the UK with a diagnosis of “COVID”, usually referred to as “COVID deaths” whether or not it can be proven that a positive COVID test result means that COVID *caused* the death, 62% of these deaths were people who had already received one of the COVID-19 jabs.

### VAERS data released today by Latest CDC VAERS Data Show Reported Injuries Surpass 400,000 Following COVID Vaccines

The CDC showed a total of **441,931 reports of adverse events** from all age groups following COVID vaccines, including **6,985 deaths** and **34,065 serious injuries** between Dec. 14, 2020 and June 25, 2021.

This week’s number of total adverse events for all age groups following COVID vaccines surpassed 400,000, according to data released today by the Centers for Disease Control and Prevention (CDC). The data comes directly from reports submitted to the [Vaccine Adverse Event Reporting System \(VAERS\)](#).

[VAERS](#) is the primary government-funded system for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Every Friday, [VAERS](#) makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date.

Data released today show that between Dec. 14, 2020 and June 25, 2021, a total of **[411,931 total adverse events](#)** were reported to VAERS, including **6,985 deaths** — an increase of **872 deaths** over the previous week. There were **34,065** serious injury reports, up **2,825** compared with last week.

In the U.S, **[321.2 million](#)** COVID vaccine doses had been administered as of June 25. This **[includes](#)**: 132 million doses of [Moderna’s](#) vaccine, 177 million doses of [Pfizer](#) and 12 million doses of the [Johnson & Johnson](#) (J&J) COVID vaccine.

Of the 6,985 deaths reported as of June 25, **22% occurred** within 48 hours of vaccination, **15% occurred** within 24 hours and **38% occurred** in people who became ill within 48 hours of being vaccinated.

Pfizer to request emergency approval of COVID vaccine for kids ages 5-11 by fall.

[Fox News reported](#) July 1, younger children could become eligible for a COVID vaccine this fall, according to a top executive at Pfizer who said the company has plans to request emergency approval of its vaccine in kids aged 5 to 11 by September or October. [Pfizer's vaccine](#) is currently authorized for use in individuals aged 12 and older.
