

As many countries around the world now begin another round of lockdowns, and take steps to cut off citizens from social life if they do not consent to receive one of the deadly COVID-19 shots and carry around some kind of identification that marks them as “vaccinated,” (See: [Mapping Tyranny: The Countries Where Vaccination Is Mandatory](#)) the death tolls following these injections continue to rapidly increase. And yet, most people around the world still seem to be completely ignorant regarding how many deaths following COVID-19 injections are actually being recorded by government health agencies, as the corporate media around the world for the most part is not allowed to cover these verifiable statistics showing unprecedented amounts of deaths and crippling injuries following these shots, all of which are still in the experimental phase and have not even completed Phase 3 trials yet.

What we are witnessing is quite clearly a worldwide genocide and the implementation of a plan to reduce the world’s population.

Never before in modern, or even ancient history, have governments around the world acted in unison to force a medical procedure upon all their populations, and silence all dissenters who try to sound the warning alarm, which include tens of thousands of doctors and scientists.

The European Union database of suspected drug reaction reports is [EudraVigilance](#), and they are now reporting **18,928 fatalities**, and **1,823,219 injuries**, following COVID-19 injections.

A ‘*Health Impact News*’ subscriber from Europe reminded us that this database maintained at EudraVigilance is only for countries in Europe who are part of the European Union (EU), which comprises 27 countries.

The total number of countries in Europe is much higher, almost twice as many, numbering around 50. (There are some differences of opinion as to which countries is technically part of Europe.)

So as high as these numbers are, they do NOT reflect all of Europe. The actual number in Europe who are reported dead or injured due to COVID-19 shots would be much higher than what we are reporting here.

CDC Sued for Cover-up of 45,000 Covid Deaths Not Reported

Ohio-based **Attorney Thomas Renz** was one of several speakers this past weekend at a conference in Anaheim, California, where he announced that with the help of [America’s Frontline Doctors](#), he was filing a federal lawsuit in Alabama based on a “*sworn declaration, under threat of perjury,*” from an alleged whistleblower who claims to have inside knowledge of a cover-up of reported deaths filed with the Vaccine Adverse Event Reporting System (VAERS), which is operated by the CDC.

This whistleblower has allegedly claimed, under oath, that there are at least 45,000 reported deaths that have occurred within 3 days of receiving a COVID-19 “vaccine.”

Renz states that this report of 45,000 deaths is just from “one system” that reports to VAERS.

AMERICA'S FRONTLINE DOCTORS LAWSUIT

Attorney Thomas Renz has filed a Motion for Preliminary Injunction on behalf of AFD in the Northern District of Alabama against Xavier Becerra, Secretary of the U.S. Department of Health and Human Services (DHHS) to halt the COVID-19 vaccine roll-out for:

- 1) Children 18-years-old and younger
- 2) Adults previously infected with SARS-CoV-2 and
- 3) Until such time as the vaccine companies provide ALL vaccine candidates with "truly voluntary, informed consent," about what is actually in the vaccines, per FDA law.

The lawsuit claims the Emergency Use Authorization (EUA) of the COVID-19 vaccines is unlawful, because:

- 1) There is No Emergency
- 2) There is in Fact no Serious or Life-Threatening Disease or Condition
- 3) The Vaccines Do Not Diagnose, Treat or Prevent SARS-CoV-2 or COVID-19
- 4) The Known and Potential Risks of the Vaccines Outweigh their Known and Potential Benefits
- 5) There Are Adequate, Approved and Available Alternatives to the Vaccines
- 6) Healthcare Professionals and Vaccine Candidates are Not Adequately Informed
- 7) Monitoring and Reporting of Adverse Events is Inadequate.

The case makes use of the testimony of an expert witness, "Jane Doe", who:

"...is a computer programmer with subject matter expertise in the healthcare data analytics field, and access to Medicare and Medicaid data maintained by the Centers for Medicare and Medicaid Services (CMS). Over the last 20 years, she has developed over 100 distinct healthcare fraud detection algorithms for use in the public and private sectors. In her expert opinion, VAERS under-reports deaths caused by the Vaccines by a conservative factor of at least 5."

"As of July 9, 2021, VAERS reported 9,048 deaths associated with the Vaccines. Jane Doe queried data from CMS medical claims, and has determined that the number of deaths occurring within 3 days of injection with the Vaccines exceeds those reported by VAERS by a factor of at least 5, indicating that the true number of deaths caused by the Vaccines is at least 45,000. She notes that in the 1976 Swine Flu vaccine campaign (in

which 25% of the U.S. population at that time, 55 million Americans, were vaccinated), the Swine Flu vaccine was deemed dangerous and unsafe, and removed from the market, even though the vaccine resulted in only 53 deaths."

The case slams the *"The gross and willful under-reporting of Vaccine-caused deaths, which is substantiated by Jane Doe's Declaration,"* whose evidence *"makes it irrefutable that the public will suffer irreparable injury if this Motion is denied."*

Furthermore, the lawsuit challenges the legality of the Emergency Use Authorization (EUA), as the law states that children must be at risk in order to be vaccine candidates, whereas the "CDC states that children are statistically at ZERO percent mortality rates by COVID-19". It also cites a study commissioned by the U.S. Department of Health and Human Services, which concluded that less than 1% of adverse reactions are ever reported to the VAERS system.

While announcing his filing last weekend to the crowd at Clay Clark's Awaken America event in Anaheim, Thomas Renz asked *"How many have really died and why are they covering it up?"* because, obviously, this lawsuit will not be reported in the Mainstream Media and it will likely be censored by Big Tech corporations like YouTube, Facebook, and Google. Renz said that these Big Tech giants are *"complicit in causing death"*, and said that he cannot wait to sue them *"over and over again."*

ER Editor: Dr. Jane Ruby on the Stew Peters' show (11-minute video) shows us some blood profiles or blood 'smears' done under a microscope showing what Ruby calls 'poisoned' blood or blood where the **cells clump together**, along with the presence of **tube-like structures** (image on right below). These pictures have been provided to her

by a UK doctor whose vaccinated patients have been coming to him complaining of feeling unwell. The particular vaccine given is the Moderna.

Here are some main points raised in the video:

- See Ruby's description of the pictures of vaccinated and unvaccinated blood under the microscope – **vaccinated blood has cells clumping together**. (*ER: So is this the precursor to clotting?*) Also present are **'tubes' whose beginning and end points can be seen**.

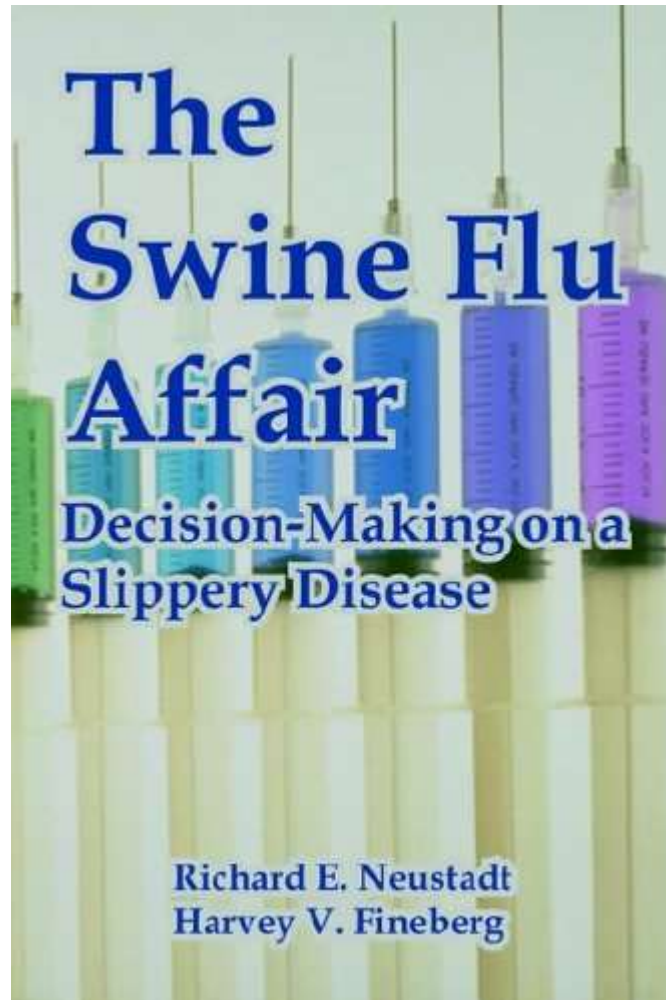
- We know that it is the **mRNA vaccines** (Pfizer & Moderna) that are causing the blood clots, the strokes, the heart attacks, myocarditis, and neurological conditions similar to MS and Guillain-Barré syndrome.
- Reminder: The 'vaccine' package inserts are blank. And insurers aren't covering vaccinated people.
- Many people, such as **Dr. Judy Mikovits**, are now talking about graphene oxide hypothesis. The research efforts of the Spanish team seem to have validity to date.
- Red blood cells can't work if they're clumped together and forced to change shape. Their main job is to **carry oxygen to all of our cells**. This helps to explain why people are tired and dizzy, not feeling well, mentally confused, etc.

The U.S. Government Faked a Pandemic In 1976

This rush to Vaxx everyone is not the first time the country has been fear-mongered into a Eugenics depopulation plan. Being an old guy that I am, I remember an earlier scandemic in which the virus hoax was tried on the country but with little secrecy like today.

In 1976, an outbreak of the swine flu, influenza A virus subtype H1N1 at Fort Dix, New Jersey caused a mass vaccination of Americans. After the program began, the vaccine was associated with an increase in reports of Guillain-Barré Syndrome, which can cause paralysis, respiratory arrest, and death. This is the story of how in 1976, the U.S. government faked a pandemic.

This chronology is heavily influenced by the official history of the affair, published in 1978 by the National Academies Press: *'The Swine Flu Affair: Decision-Making on a Slippery Disease'*.



In January 1976, several soldiers at Fort Dix complained of a respiratory illness diagnosed as influenza. The next month, Private David Lewis, who had the symptoms, participated in a five-mile forced march, collapsed and died.

The New Jersey Department of Health tested samples from the Fort Dix soldiers. While the majority of samples were of the more common A Victoria flu strain, two were not. The atypical samples were sent to the Centers for Disease Control in Atlanta, Georgia, which found evidence of swine influenza A related to the 1918 flu pandemic, which killed 50 to 100 million people worldwide.

The Center for Disease Control (now the Centers for Disease Control and Prevention) verified the findings and informed both the World Health Organization and the state of New Jersey. On February 13, CDC Director David Sencer completed a memo calling for mass vaccination for the swine flu.

The CDC Assistant Director for Programs of the Center for Disease Control, Bruce Dull, [held a press conference](#) on February 19 to discuss the flu outbreak at Fort Dix and, in response to questions from reporters, mentioned the relationship of the flu strain to the 1918 outbreak. There was no relationship whatsoever.

US President Gerald Ford was officially informed of the outbreak memo on March 15 and **the [suggested vaccination program](#)**. He met with a “blue ribbon” panel that included Jonas Salk and Albert Sabin. Ford then made a televised announcement in support of the mass vaccination program. Salk and Sabin were responsible for SV-40 being inserted in their polio virus that led to cancer for millions of Americans.

A hearing was held before the United States Senate Appropriations Subcommittee on Labor, Health and Human Services, Education, and Related Agencies, and C. Joseph Stetler, a drug company spokesman, [requested government indemnity for the vaccine manufacturers](#).

Pharmaceutical companies Sharp & Dohme (Merck & Co.), Merrell, Wyeth, and Parke-Davis also [refused to sell doses to the government unless they were guaranteed a profit](#), a concession that the government also eventually made.

The House Appropriations Committee reported out a special appropriations bill, including \$135 million for the swine flu vaccination program, which was approved on April 5. Two days later, the World Health Organization held a conference to discuss the implications of a swine flu outbreak for poorer nations.

On April 8, an official from the Federal Insurance Company informed Merck & Co., a manufacturer of the swine flu vaccine, that it would exclude indemnity on Merck’s product liability for the swine flu vaccine on July 1, 1976.

T. Lawrence Jones, president of the American Insurance Association, informed the Office of Management and Budget that the insurance industry would not cover liability for the vaccine unless the government extended liability protection.

The chairman of Merck wrote a memo a day later, April 13, to various government agencies, including the White House emphasizing the “duty to warn”. In May, other vaccine manufacturers including Marion Merrell Dow, Parke-Davis, and Wyeth, were notified of indemnity problems by their respective insurers.

Assistant Secretary Theodore Cooper (HEW) informed the White House on June 2 that indemnity legislation would be needed to secure Merrell’s cooperation. In June, other vaccine manufacturers requested the same legislation. A little more than two weeks later, the Ford administration submitted a proposal to Congress that offered indemnity to vaccine manufacturers.

Bruce Dull stated at a flu conference on July 1 that there were no parallels between the 1918 flu pandemic and the current situation.

Later that month, J. Anthony Morris, a researcher in the Food and Drug Administration's Bureau of Biologics (BoB), was dismissed for insubordination and went public with [findings that cast doubt on the safety of the vaccine](#), which was produced in fertilized hen's eggs.

Three days later, several manufacturers announced that they had ceased production of the vaccine. Later that month, investigations into alleged swine flu outbreaks in other parts of the world found no cases of the strain. On July 23, the President sent a letter that urged Congress to take action on indemnification.

In early August, an outbreak of illness in Philadelphia was thought to be related to swine flu. It was later found to be an atypical pneumonia that is now called Legionnaires' disease. On August 6, Ford held a press conference and urged Congress to take action on the indemnification legislation. Four days later, both houses of Congress passed the legislation. Legionnaires' was eventually discovered as the result of mold in air-conditioning duct work at a Philadelphia Veterans Hospital.

Merrill became the first company to submit samples to the FDA's Bureau of Biologics for safety testing, which approved it on September 2. Merck made the first shipment of vaccines to state health departments by September 22. The first swine flu inoculations were given at the Indiana State Fair.

In October, three people died of heart attacks after they had received the vaccine at the same Pittsburgh clinic, which sparked an investigation and the recall of that batch of vaccine.

The investigation showed that the deaths were not related to the vaccination. The President and his family received their vaccinations before the television cameras. On November 2, Ford lost the presidential election to Jimmy Carter.

Also in early November, Albert Sabin published a '*New York Times*' editorial, "Washington and the Flu." He agreed with the decision to create the vaccine and to be prepared for an outbreak but criticized the "scare tactics" that had been used by Washington to achieve that. He suggested to stockpile the vaccine and to have a wait-and-see strategy.

By December 15, **cases of Guillain-Barré syndrome (GBS) affecting vaccinated patients** were reported in 10 states, including Minnesota, Maryland, and Alabama. Three more cases of Guillain-Barré were reported in early December, and the investigation into cases of it spread to eleven states.

On December 16, a one-month suspension of the vaccination program was announced by Sencer. William Foege of the CDC estimated that the incidence of GBS was four times higher in vaccinated people than in those not receiving the swine flu vaccine.

Ford told reporters that he agreed with the suspension, but he defended the decision to create the vaccination program. Joseph A. Califano, Jr., was sworn in as Secretary of Health, Education, and Welfare on January 20, 1977. On February 4, Sencer was informed that he would be replaced as the head of the CDC. The vaccination program was not reinstated.

Laurence Gostin, in his article [“At Law: Swine Flu Vaccine: What Is Fair?”](#), wrote that *“the swine flu affair fails to tell us whether, in the face of scientific uncertainty, it is better to err on the side of caution or aggressive intervention.”*

There is not even complete agreement about the causal relationship between the swine flu vaccine and Guillain-Barré syndrome, as noted in Gina Kolata’s book [Flu: The Story of the Great Influenza Pandemic of 1918 and the Search for the Virus That Caused It](#).

She wrote that the CDC did not have a “specific set of tests and symptoms to define Guillain-Barré” and that since doctors who reported cases already knew that a link was suspected, a bias in reporting was introduced. She quoted Keiji Fukuda: *“if a new virus gets identified or reappears, you don’t want to jump the gun and assume a pandemic is happening.”*

The nation has long forgotten this attempt to use a vaccine to exterminate the population. After approximately 125 people died, the entire Swine Flu vaccination program was shut down. The taxpayer ended up paying for the damage caused by Here we are 18 months into the Covid-19 scam and they are continuing to claim that the Vaxxes from the major pharmaceutical companies is safe and efficacious, while along laughing at the public as the government shuts down any site that claims massive deaths are resulting. With Biden and his Nazi propagandists focusing on 12 major names who refute the propaganda narrative it does not take much in the way of common sense to know they are lying when there are now over 12,000 deaths linked directly to the Vaxxes, and ask the question, when do they plan to stop the shots?

NIH KNOWS EXACTLY WHO'S GOTTEN WHAT

Meanwhile, Dr. Ruby directs our attention to the [ClinicalTrials.gov](#) website, which she says is the NIH's National Library of Medicine, aka U.S. Government's repository for the data on all clinical trials and she says that Pfizer initially posted the trials of their "vaccine", which included all of the information on the dosing, the lot numbers, the expiration dates, etc.

She says, *“They know where those vials have gone, they know who's gotten what, they know everything about it. They know who's been sick, they know the exact numbers of the deaths and of the permanent disability.”*

In other words, not only does Pfizer know how many people have been injured and are confirmed dead, but they're dosing up and they're ready for 3rd and 4th booster shots.

PRE-MEDITATED MURDER

Stew asks, "How else can you refer to this other than pre-meditated mass murder?"
"I can't think of anything else, Stew," she replies. "A lot of it's starting to make sense."

Dr. Ruby talks about how many of us who have been paying attention have had this working hypothesis that there are different batches and that some people have been receiving placebos. (For whatever it's worth, I saw a photo posted on Twitter of a batch of vaccines that was labeled "Control").

She says, "It's worse than that. They actually have it parceled-out. They know where each dose is going, they know what age group it's going to. It's just unbelievably diabolical. And in the words of Dr. Peter McCollough, 'It's gotta stop!'"

Stew Peters calls this **"Pre-meditated Murder."** He brings on Dr. David Martin and asks him if this is a correct assessment and David doesn't skip a beat, saying, "Well, there's no question. When you inject a known toxin – and we're going to get into this, when talk about the biological weapons laws and treaties of the United States and the world, for that matter – when you inject a known toxin into a person, you are actually injecting an agent of death."

"That's what you're doing and you cannot sit there and hide behind the diaphanous fig leaf of 'Well, we're doing it in the public interest' when you know. Know. Not have a hunch. You know that it is, in fact lethal in many instances. Pfizer has even stated that have an 'acceptable death rate'. I dunno, Stew. Do you have an 'acceptable death rate'?"

Stew says, "A lot of people say there are risks with every vaccine."
"Yeah, but it's not a risk when you know you're putting – and get this very carefully, because this is where the RNA story falls apart – people think that a piece of SARS coronavirus was turned into a vaccine. That is not true. A computer-simulated, synthetic, chimeric, computer-generated code, uploaded by the Chinese in January was given to Moderna to put into an injection, so that your cells, in the case of the RNA vaccines...would produce the S1 spike protein synthesis – not the actual virus, the way that we used to do vaccines – this was a computer code uploaded by the Chinese into US manufacturing to inject a pathogen stimulant into the American population."

Stew says, "This was pre-meditated. There are patents, from what you have discovered going back to 2002, at minimum. This is a planned genocide. There's no two ways about it."

DEATH FOR PROFIT

David says, "So let's take this out of the risk of hyperbole and let's give it to you in the criminals' own words. Remember, that the person I'm going to now quote is the veterinarian – not physician – veterinarian who was responsible on February 6th and

February 7th of 2020 to control the message that this pathogen came from a bat somewhere in China. That's the story and we have in Fauci's emails now. We have, on February 6th and on February 7th, Peter Daszak, on the record, stating that we need a cover story that distances him and the Chinese from this particular pathogen. And that's in public records. That's not my opinion but let's listen to his words in 2015, shall we? Because, this is the criminal indicting himself."

"We need to increase for medical countermeasures, such as a pan-coronavirus vaccine. A key driver is the media, and the economics will follow the hype. We need to use that hype to our advantage to get to the real issues. Investors will respond if they see profit at the end of the process."

"Now, Stew, I'm not going out on a limb. That's not a public health statement. That is a mercenary...of death."

"For profit. Death for profit."

"Oh - and what does he say? 'Investors will respond if they see profit at the end of the process,' –"

"So, let's identify those investors. Who, exactly is he talking about?"

"He's talking about the investors in Moderna, in Pfizer and the NIAID and CDC. Remember, that NIAID and CDC, as much as we pretend these are public organizations and public institutions, they are what we call 'regulatory capture'. They are the front. Think of them as the R&D shop for the Modernas and for the Pfizers and for the AstraZenecas and for the Johnson & Johnsons and the fact of the matter is, these companies, going back to 1990 – remember, the first spike protein, the first one was issued to Pfizer in 1990."

"We're being told this is some sort of new thing, new response, new pathogen, new whatever else. No, it isn't. Pfizer patented the first, in this case, canine S1 spike protein coronavirus vaccine in 1990. And we have, without question, the architect of this scam on record, in 2015, stating that, 'A key driver is the media and economics will follow the hype.'"

"That is collusion. That is racketeering. And that is, under the Patriot Act – Section 802 of the Patriot Act – that is domestic terrorism."

Stew responds, "Violation of US law. The injection of a bioweapon, according to US Code."

"Yep."

They then quote [US Law on bioweapons](#):

18 US CODE § 175 - PROHIBITIONS WITH RESPECT TO BIOLOGICAL WEAPONS

"(a) In General.—

"Whoever knowingly develops, produces, stockpiles, transfers, acquires, retains, or possesses any [biological agent](#), [toxin](#), or [delivery system for use as a weapon](#), or knowingly assists a foreign state [CHINA] or any organization to do so, or attempts, threatens, or conspires to do the same, shall be fined under this title or imprisoned for life or any term of years, or both. There is extraterritorial Federal jurisdiction over an offense under this section committed by or against a [national of the United States](#)."

Stew asks, *"So what is keeping Anthony Fauci...what is keeping these people free?"*

David responds, ***"The US Department of Justice. The US Department of Justice has failed the American People and has had this information since April of 2020. All of the information I'm sharing with you. And they have sat on it and done nothing. This has gone to US attorneys, this has gone to the Department of Justice. I sent this in April of 2020, I sent his to the Inspector General and the Department of Health and Human Services and not a single law enforcement agency in the United States has taken this seriously. Not one."***

"Can you speculate why that might be?"

"Well, it's not a speculation. It's very clearly the situation where they have been ordered not to. [By whom, one wonders?] The crime is, we have collusion between what is called interlocking directorates inside of anti-trust law, we have Anthony Fauci at NIAID, we have the director of the Centers for Disease Control in China and we have Dr. Elias from the Bill & Melinda Gates Foundation, all sitting on a board, all colluding to actually create, price-fix and market-direct this pandemic."

"So there really is no virus."

"No."

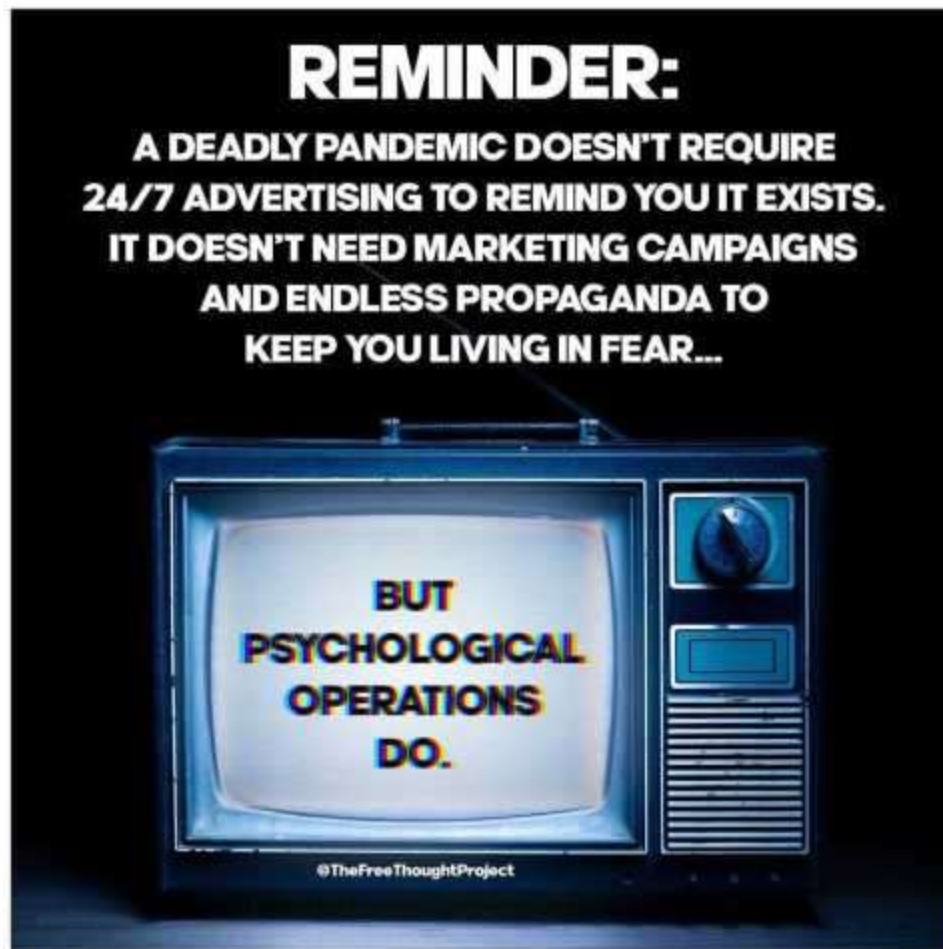
An investigation by Kaiser Health News and The Guardian recently revealed that more than 3,600 health care workers died in COVID-19's first year in the U.S. Medscape has curated a continually updated list to honor the fallen health care workers.

What is interesting about this report is that it comes from a media propaganda site that offers pointers to promote to the public the propaganda that they should use to get people vaxxed. CDC Shares VAERS for COVID-19 Vaccines: 12,313 Reports of Deaths but No Causal Link According to Agency

Recently, the chatter online about deaths associated with COVID-19 vaccines was confirmed by the U.S. Centers for Disease Control and Prevention (CDC) between

the dates of December 14, 2020, through July 19, 2021, based on entries into the Vaccine Adverse Event Reporting System (VAERS). Apparently, the CDC has shared publicly that the federal health agency has received 12,313 individual reports of actual death among those who have received one of the COVID-19 vaccines—that is, one of the vaccines under Food and Drug Administration (FDA) emergency use authorization (EUA). That’s overall a small number when accounting for the 338 million doses of the vaccines administered across America, representing a death rate of only 0.0036%. On the other hand, this is an unprecedented number of fatalities when compared to any other vaccination initiative over the past few decades given it’s only been available for just over half a year.

As of July 22, 2021 the CDC now reports that this number was a mistake and the revised number is 6,207. It really speaks to the CDC’s dishonesty in what it reports to the public.

A system to track safety reports, the cases are open to the public. However, *TrialSite* has published that about 60% of the VAERS cases are submitted by health care professionals. But it is an open system that is overseen by the CDC in conjunction with the FDA. *TrialSite* encourages transparency and open dialogue, including scientific debate and a number of OpEd articles questioning the number of deaths associated with the current batch of COVID-19 vaccines.

Interestingly, the website was updated to include 12,313 deaths as is depicted in the image below. A recent visit to the website now declares 6,207 deaths.

part of that failure by enabling a cutting edge commercial business to focus all its resources on solving one of the world's most pressing public health issues," he added. Again, nothing is 'free,' these 'philanthropists' actions by Gates and Soros notwithstanding. “By tracking only cases requiring hospitalization or causing death, we may miss the chance to learn how people with ‘milder’ disease are affected by Delta or other variant infections, such as how long their symptoms last and how the infection may disrupt their lives,” lamented Robert Shmerling, an associate professor of medicine at [Harvard Medical School](#).

According to Shmerling, there will be no way to truly know how effective or ineffective Chinese Virus injections are at keeping variants at bay if the CDC refuses to maintain accurate datasets across the full spectrum of vaccinated versus unvaccinated people.

An insider at the CDC reportedly told *Business Insider* that the reason the federal agency, which is actually [a private corporation](#), is hiding the truth has to do with data on symptoms that is supposedly “missing.”

Studies prove that vitamin D³ works against the Coronavirus

(Natural News) Ever since the Wuhan coronavirus (COVID-19) pandemic struck, a number of cures for COVID have been espoused. These cures included hydroxychloroquine, ivermectin and vitamin D³. Despite being suppressed by Big Pharma, many studies have shown that vitamin D³ plays a role in preventing hospitalizations and deaths from COVID-19.

One such study done in November 2020 found that COVID-19 patients who had low levels of vitamin D³ had a higher chance of dying from the disease. The study published in ‘*Scientific Reports*’ found that severe COVID-19 patients had “*markedly low*” vitamin D³ levels and high inflammatory responses. The Indian authors recommended “mass administration of vitamin D³ supplements” to populations at risk for COVID-19.

A later study from May 2021, also published in ‘*Scientific Reports*’, noted the positive effects of vitamin D³ on the immune system. It argued that vitamin D³ promotes the expression of anti-inflammatory cytokines and reduces pro-inflammatory cytokines. Many COVID-19 treatments focused on eliminating the virus in the body instead of regulating the hyper-inflammation caused by these cytokines.

Cytokines are proteins produced by the body to control inflammation. These cytokines are released in the case of infections, but there are times that excess cytokines than needed are produced. This resulting “cytokine storm” becomes dangerous – and has been linked to the deaths of COVID-19 patients.

The authors of the May 2021 study then looked at the effects of Pulse D³ therapy on COVID-19 patients’ cytokine levels. Pulse D³ therapy involved daily high-dose supplementation with vitamin D³ – as much as 60,000 international units (IU) – for a period of eight to 10 days. The therapy was done alongside standard therapy that COVID-19 patients received.

The patients who underwent Pulse D³ therapy saw their vitamin D³ levels increase significantly. Meanwhile, their inflammatory markers significantly decreased without any side effects. Thus, the study authors concluded that Pulse D³ therapy could be safely added to COVID-19 treatment protocols for improved outcomes.

A study using vitamin D3 also reported the same effect

[Another study from June 2021](#) noted the positive effects of a type of vitamin D³ on COVID-19 patients in Spain. The study published in the *'Journal of Clinical Endocrinology & Metabolism'* involved researchers giving vitamin D³, also called calcifediol, to patients in the COVID-19 ward of Hospital del Mar in Barcelona.

About half of the patients received 21,280 IU of vitamin D³ on the first day of the study, while the other half did not. The vitamin D³ group received an extra 10,640 IU of calcifediol on the third, seventh, 15th and 30th day of the study.

COVID-19 patients who received vitamin D³ fared significantly better, with only 4.5 percent requiring intensive care unit (ICU) admission. On the other hand, 21 percent of patients in the group that did not receive vitamin D³ required ICU admission. Treatment with vitamin D³ also reduced the COVID-19 fatality rate, with only 4.7 percent of the vitamin D³ group dying compared to the 15.9 percent death rate in the non-vitamin D³ group.

The authors of the June 2021 study concluded: "In patients hospitalized with COVID-19, calcifediol treatment significantly reduced ICU admission and mortality." Initially submitted in January 2021, it was only published in June.

U.S. remains unconvinced of the effectiveness of vitamin D (No surprise here!)

British Member of Parliament David Davis welcomed the study's findings at the time of its submission. [He tweeted back in February 2021](#): "*This is a very important study on vitamin D and COVID-19. Its findings are incredibly clear.*" He further remarked that the study's conclusion "*should result in this therapy being administered to every [COVID-19] patient in every hospital.*"

[A May 2020 statement](#) by the [French National Academy of Medicine](#) (ANM) also espoused vitamin D³ as a "simple and inexpensive measure" against COVID-19. It elaborated: "*Vitamin D³ cannot be considered as a preventive or a curative treatment for [SARS-CoV-2] infection. However, by mitigating the inflammatory [cytokine] storm and its consequences, it could be considered as an adjunct to any form of therapy.*"

The ANM recommended that COVID-19 patients above 60 years old get tested for vitamin D³ levels. It advised that the same patients take 50,000 IU to 100,000 IU of vitamin D³ once the deficiency is confirmed to "help limit respiratory complications." Furthermore, the ANM suggested that people below 60 years old who test positive for COVID-19 take a daily dose of 800 IU to 1,000 IU of vitamin D³.

But in spite of the positive effects of vitamin D³ on COVID-19 patients, the U.S. has refused to acknowledge its potential as a treatment. The U.S. *National Institutes of Health* noted that low vitamin D³ levels "have been associated with an increased risk of community-acquired pneumonia in older adults and children" in observational studies. However, [its guidance from April 21](#) said: "There is insufficient evidence to recommend either for or against the use of vitamin D³ for the prevention or treatment of COVID-19."

Daily CDC Death Report Numbers for Covid-19 Excerpt from My Media Exaggeration of Covid Pandemic Data

Since December, 2020, I have been keeping score you might say of the daily death reports released to the media. A CNN executive has hinted that there need to be more forceful measures to increase Covid vaccine uptake in the U.S., after grumbling about the issue in an email that he mistakenly sent to a conservative activist.

The peculiar message was revealed by Fox News host Tucker Carlson, who showed a screengrab of the email in question.

“FW: #NEWS: A majority of unvaccinated Americans say they’re unlikely to get the Covid-19 vaccine, regardless of outreach efforts,” read the email’s subject line.

The author of the email, identified by Carlson as CNN’s Washington bureau chief, wrote to a colleague: *“This is the point re: carrot vs. stick. The carrot is no longer going to work...”*

Although the Fox host didn't identify him by name, CNN's Washington bureau is currently headed by the network's senior vice president, Sam Feist.

The suggestive commentary likely would have remained shielded from public scrutiny had the CNN bigwig in question not accidentally sent it to Charlie Kirk, a popular conservative activist and commentator.

CNN confirmed the authenticity of the email, but insisted that there was nothing newsworthy about its contents.

"The email, mistakenly sent to Kirk, was simply acknowledging that current vaccination incentives are losing steam," the network said in a statement.

Kirk appeared on Carlson's program to discuss the strange email.

"Is it CNN's stated position now that they're going to try to administer medicine under the threat of punishment?" the conservative pundit asked. Referring to the "carrot vs. stick" analogy used in the email, Kirk wondered aloud: *"What does the stick look like in CNN's world?"*

Reacting to the segment on Twitter, CNN's Brian Stelter argued that Carlson had twisted the email to push an "outright lie" about the news network. *"CNN has 4,000 staffers. One exec sends an email about vaccine hostility opining that 'the carrot is no longer going to work.' Carlson obtains it. And his show turns it into an outright lie: 'CNN WANTS TO USE A 'STICK' ON THE UNVACCINATED,'" Stelter wrote.*

DUTCH NEWS — Around 1,000 visitors to a festival in Utrecht held over the first weekend in July are now known to have picked up coronavirus there.

In total, 20,000 people attended the Verknipt outdoor festival and the infections were spread over both days, according to local health board figures. The festival was a ‘test for entry’ event, meaning visitors were admitted if they could show a QR code which showed they had either been vaccinated, had a negative coronavirus test or had recently had the disease.

It is the first time so many infections have been traced back to a single event and more cases are likely to be identified in the coming days, a health board spokesman said.

Utrecht’s mayor Sharon Dijksma, who attended the event herself, had described the presence of so many people without masks and social distancing as ‘special and a little tense’ on social media.

This was an outdoor festival and an ideal setting where a large crowd could be attacked by **5G** Directed Energy Weaponry (DEW) from a satellite 60-miles above and causes the symptoms identified as Covid-19 which also mimic **5G** radiation sickness, noted on pages 17-19 above. In fact, in the picture on page 17, it mentions 60 **5G** satellites over the Netherlands. Elon Musk is pictured on the right hand side of the same photo. As of May 16th, 2021, 1,617 Starlink satellites have already launched SpaceX for the Internet Starlink. SpaceX, founded by Elon Musk, once again launched the Falcon 9 launch-vehicle with 52 satellites for the global Internet project Starlink. In total, more than 1,600 such vehicles are now in orbit.

It is worth noting that Starlink's competitors have so far launched a much smaller number of satellites into orbit. For example, the OneWeb project has 182 devices out of 648. In the future, SpaceX may launch 1,197 more satellites, but this is not the limit.

Over the next few decades, Elon Musk is hoping to send 42,000 [satellites](#) to space. He is hoping those satellites bring [high-speed internet](#) to every corner of the world - from the rainforest to Antarctica. Elon Musk plans to send 42,000 of these satellites to space, 15 times the number of operational satellites in orbit today. It’s part of Starlink, the expansive constellation from Musk and SpaceX that hopes to bring the world low-latency high-speed internet, promising no more buffering and nearly instantaneous internet in every corner of the world.

With all of the different telecoms like AT&T, T-Mobile, Verizon, etc. there will be in the range of 100,000 **5G** satellites in orbit around the globe. This may seem to be

all well and good, but do not lose sight of the fact that **5G** was a weapons system, first and foremost, regardless of what anyone tells you.

Those, such as Klaus Schwab, Prince Charles, Ted Turner and Bill Gates, who want to reduce the world's population to 500-million, down from 7.8-billion and they will be able to kill you one of two ways that I am already aware of:

CDC Panel Signals Support for Booster Shots, as Reports of Injuries, Deaths After COVID Vaccines Near 500,000

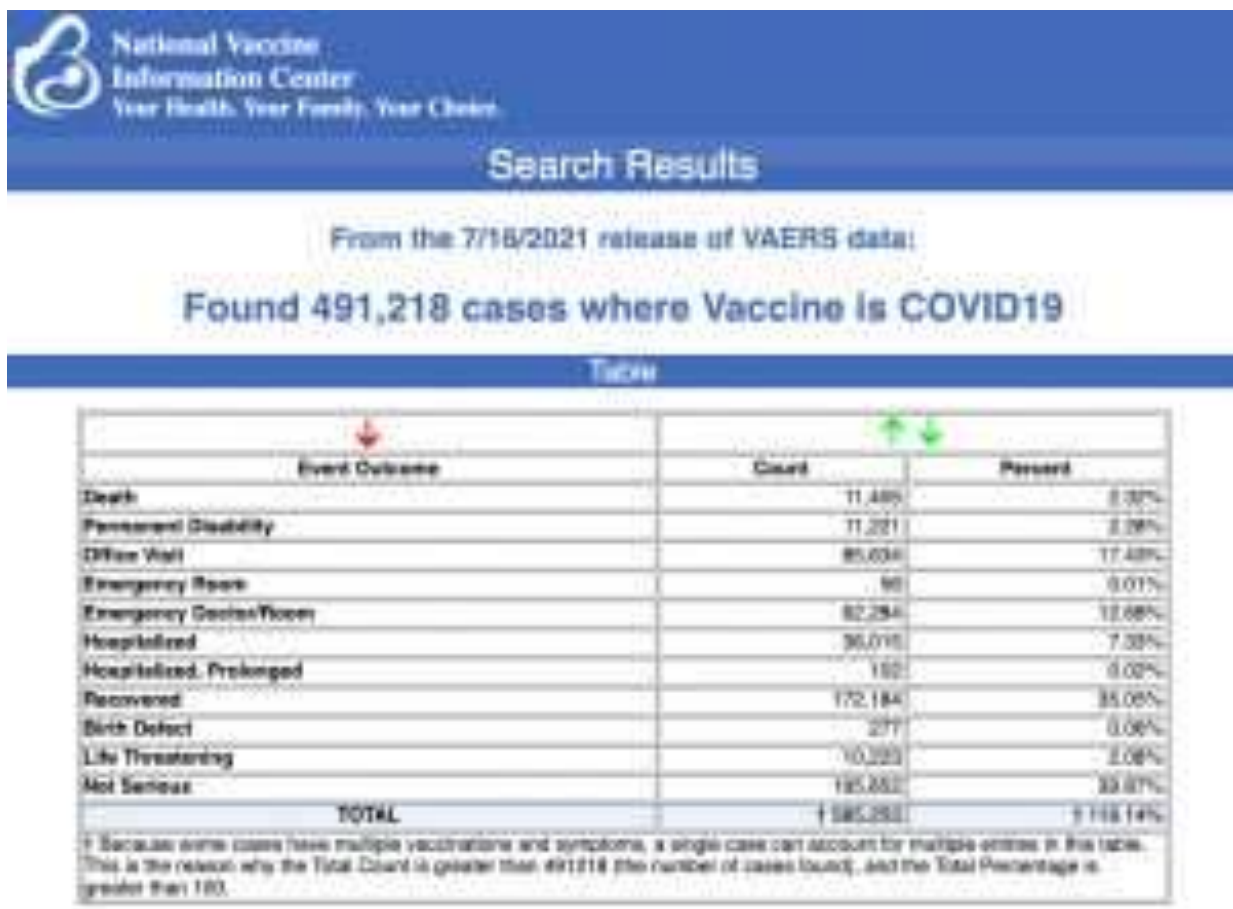
VAERS data released today by the CDC showed a total of 491,218 reports of adverse events from all age groups following COVID vaccines, including **11,405 deaths** and **48,385 serious injuries** between Dec. 14, 2020 and July 16, 2021.

Data released today by the Centers for Disease Control and Prevention (CDC) included a total of almost 500,000 reports of injuries and deaths, across all age groups, following COVID vaccines — an increase of 27,761 compared with the previous week.

The data comes directly from reports submitted to the [Vaccine Adverse Event Reporting System](#) (VAERS), the primary government-funded system for reporting adverse vaccine reactions in the U.S.

Every Friday, [VAERS](#) makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Data released today show that between Dec. 14, 2020 and July 16, 2021, a total of [491,218 total adverse events](#) were reported to VAERS, including [11,405 deaths](#) — and increase of 414 over the previous week. There were [48,385 serious injuries](#) reported during the same time period — up 7,767 compared with the previous week.



Excluding “[foreign reports](#)” filed in VAERS, there were [425,950 adverse events](#) reported, including [5,467 deaths](#) and [33,748 serious injuries](#), reported in the U.S.

In the U.S., [336.6 million](#) COVID vaccine doses had been administered as of July 16. This [includes](#): 137 million doses of [Moderna’s](#) vaccine, 187 million doses of [Pfizer](#) and 13 million doses of the [Johnson & Johnson \(J&J\)](#) COVID vaccine.

Of the 5,467 U.S. deaths reported as of July 16, **20% occurred** within 48 hours of vaccination, 14% occurred within 24 hours and **34% occurred** in people who became ill within 48 hours of being vaccinated.

This week's U.S. data for 12- to 17-year-olds show:

- **14,494** total adverse events, including **871 rated as serious** and **17 reported deaths**. Two of the nine deaths were suicides.
- The most recent reported deaths include a 13-year-old boy (VAERS I.D. **1463061**) who died after receiving a Moderna vaccine, a 16-year-old boy (VAERS I.D. **1466009**) who died after receiving his second dose of Pfizer and a 16-year-old boy (VAERS I.D. **1475434**) who died with an enlarged heart six days after receiving his first Pfizer dose.

Other reports include three **13-year-old boys** (VAERS I.D. **1406840**, **1431289** and **1429457**) who died two days after receiving a Pfizer vaccine, three 15-year-olds (VAERS I.D. **1187918**, **1382906** and **1242573**), three 16-year-olds (VAERS I.D. **1420630**, **1225942** and **1386841**) and three 17-year-olds (VAERS I.D. **1199455**, **1388042** and **1420762**).

- **2,127 reports** of anaphylaxis among 12- to 17-year-olds with 99% of cases attributed to **Pfizer's vaccine**.
- **383 reports** of myocarditis and pericarditis (heart inflammation) with **379 cases** attributed to Pfizer's vaccine.
- **68 reports** of blood clotting disorders, with all cases attributed to Pfizer.

This week's total U.S. VAERS data, from Dec. 14, 2020 to July 16, 2021, for all age groups combined show:

- 21% of deaths were related to cardiac disorders.
- 54% of those who died were male, 43% were female and the remaining death reports did not include gender of the deceased.
- The **average age** of death was **74.3** years.
- As of July 16, **2,488 pregnant women** reported adverse events related to COVID vaccines, including 850 reports of **miscarriage or premature birth**.
- Of the **2,428 cases of Bell's Palsy** reported, 50% were attributed to **Pfizer** vaccinations, 43% to **Moderna** and 7% to **J&J**.
- 429 reports of **Guillain-Barré Syndrome**, with 41% of cases **attributed to Pfizer**, 36% to **Moderna** and 22% to **J&J**.
- **117,379 reports of anaphylaxis** with 44% of cases attributed to **Pfizer's vaccine**, 48% to **Moderna** and 8% to **J&J**.
- **7,633 reports** of blood clotting disorders. Of those, **3,221 reports** were attributed to Pfizer, **2,779 reports** to Moderna and **1,588 reports** to J&J.
- **1,848 cases** of myocarditis and pericarditis with **1,176 cases** attributed to Pfizer, **606 cases** to Moderna and **62 cases** to J&J's COVID vaccine.

CDC ‘corrects’ number of reported deaths after COVID vaccines by dumping foreign reports.

As [The Defender reported](#) July 22, a sudden increase in the number of deaths reported to VAERS following COVID vaccination is not correct and was the result of an “error,” according to the CDC.

The CDC said July 16 that since the mid-December rollout of COVID vaccines in the U.S., VAERS had received 12,313 reports of death among people who received a [COVID](#) vaccine — a sharp increase from the [6,079 U.S. deaths](#) reported by the CDC the previous week.

Over the past few weeks, The Defender noticed thousands of “foreign reports” entered into VAERS, mostly associated with the [Pfizer/BioNTech vaccine](#). According to the [CDC website](#), when searching VAERS, the “United States, Territories and Unknown” group includes all of the location values, except for “Foreign” locations.

The “Foreign” group includes reports from any location other than U.S. states/territories included in the drop-down list. The “Unknown” group includes reports where a U.S. state is not identified.

We reached out to the CDC to ask why there were thousands of reports suddenly dumped into VAERS, why the CDC doesn’t publicize the total number of reported deaths — which includes foreign reports — and why there are foreign entities using the U.S. VAERS system. We did not hear back by the set deadline.

The [CDC website](#) states:

“VAERS occasionally receives case reports from U.S. manufacturers that were reported to their foreign subsidiaries. Under FDA regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and unexpected (in other words, it does not appear in the product labeling), they are required to submit it to VAERS.”

The Defender will continue to post the latest VAERS numbers weekly, but will differentiate between foreign reports and U.S. reports.

The CDC and NIAID directors are placing the blame of reinfections of those already vaccinated on the unvaccinated public in an effort to force the 35% who have for their own reasons chose not take the unproven experimental “gene” therapy which never followed the protocols of testing. Students can become paid COVID vaccine influencers through a new Student Social Media Engagement Campaign program.

The campaign recruits students to ‘combat vaccine misinformation and build vaccine confidence within their campus communities’ through TikTok, Instagram, and other platforms.

In partnership with the Centers for Disease Control and Prevention (CDC), the American College Health Association (ACHA), and Youth Marketing Connection (YMC), universities are promoting paid internships for students who push COVID vaccines.

Students chosen for the [Student Social Media Engagement Campaign](#) program will act as influencers who *“combat vaccine misinformation and build vaccine confidence within their campus communities.”*

The program launched in June 2021 and will continue through the fall semester. Each student influencer will receive a cash stipend, according to a July 8 announcement put out by the [University of Nevada, Las Vegas](#) (UNLV).

Job requirements include promoting the vaccine by sharing information on Instagram and TikTok, advocating for the ACHA’s CoVAC initiative, and leading “digital outreach efforts to increase vaccine confidence among peers.” Students are also expected to provide updates on campus COVID-19 vaccine attitudes.

The Student Social Media Engagement Campaign is part of the ACHA’s broader CoVAC initiative, which is designed to increase campus vaccinations and includes [\\$3,000 mini-grants](#) for colleges that want to implement marketing for the vaccine. Many campuses across the country have already [mandated](#) the vaccine for the Fall semester.

Similar student influencer efforts have been independently sponsored at other universities. In the fall 2020, the University of Missouri hired five students to become campus influencers for COVID-19 safety. The university paid Canadian company Glacier \$10,300 to run the project, according to [Columbia Missourian](#).

The University of Miami likewise [hired 75 students](#) in fall 2020 to serve as “Public Health Ambassadors,” strategically placing them in high-traffic areas of campus to encourage peers to follow social distancing and masking. The practice, one student told News@TheU, was highly effective.

“We are becoming recognized now by our shirts. So, when they see me approach, I don’t even have to tell someone to do something—they automatically see me, and they’ll fix their mask or something,” UM senior Camille told [News@TheU](#).

The CDC has no shame folks, I would not be surprised by any of their tactics in this war for the minds of people. The CDC has a terrible track record when it comes to being honest in their data reporting, obfuscation of the facts, and outright lying to health and safety organizations. There is corruption and conflicts of interest in the CDC, FDA, WHO and NIH whereby big pharma [has influence and power](#) over the interpretation of the outcomes/science and the related safety of vaccines. The Institute of Medicine (IOM) has persistently [urged HHS to perform such studies](#) since 1991. HHS has assiduously refused. There is, therefore, no way to scientifically claim that a specific vaccine averts more harms, including deaths, than it causes.
2. The latest data and science show that specific vaccines are unequivocally not safe. Yet government officials – with [well-documented conflicts of interest](#) with the \$50 billion vaccine industry – systematically obscure the risks while exaggerating the benefits of vaccines.
3. The government has quietly admitted culpability by paying out over [\\$4 billion for thousands of injuries and deaths](#) caused by vaccines underscoring that vaccine injuries can and do happen, including autism. The pharmaceutical industry enforces policy discipline through agency budgets. The World Health Organization (WHO) gets roughly half its budget from [private sources](#), including Pharma and its allied foundations. And CDC, frankly, is a vaccine company; it owns [56 vaccine patents](#) and buys and distributes [\\$4.6 billion](#) in vaccines annually through the Vaccines for Children program, which is over 40% of its total budget. It is outrageous that industry is apparently allowed to punish the CDC if the agency conducts research that has potential to cut into profits."*

Collected from many sources, this page lists the conflicts of interest and financial entanglements of the WHO and the CDC that should be considered when determining the validity of statements made by either organization. This compilation doesn't even include the twenty seven years of pharmaceutical industry [criminal and civil penalties](#) from 1991 through 2017 reported in a *Public Citizen* expose.

CDC Director Resigns, but CDC Conflicts of Interest are Par for the Course

Media outlets are announcing the abrupt resignation of Brenda Fitzgerald, the physician appointed in July, 2017 to head the Centers for Disease Control and Prevention (CDC). The resignation follows on the heels of reporting by Politico, which uncovered conflicts of interest including a personal financial stake in companies such as Merck and Bayer. This only illustrates, in microcosm, the CDC's longstanding willingness to cozy up to Big Pharma and Big Health Care in defiance of ethics rules.

CDC Scientists Expose Agency Corruption

The move expands on a recall—covering 9 lots—issued to warehouses last week.
