## This is Nuts, Moderna and Pfizer Intentionally Lost The Clinical Trial Control Group Testing Vaccine Efficacy and Safety

This is not just scientific madness; it appears to be very intentional and purposeful.

The Moderna and Pfizer vaccine tests were conducted, as customary, with a control group; a group within the trial who were given a placebo and not the test vaccine. However, during the trial -and after the untested vaccines were given emergency use authorization- the vaccine companies conducting the trial decided to break protocol and notify the control group they were not vaccinated. Almost all the control group was then given the vaccine.



Purposefully dissolving the placebo group violates the scientific purpose to test whether the vaccine has any efficacy; any actual benefit and/or safety issues. Without a control group there is nothing to compare the vaccinated group against. [According to NPR](#), the doctors lost the control group in the Johnson County Clinical Trial (Lexena, Kansas) on purpose:

*(Via NPR) [...] “Dr. Carlos Fierro, who runs the study there, says every participant was called back after the Food and Drug Administration authorized the vaccine.”*

*“During that visit we discussed the options, which included staying in the study without the vaccine,” he says, “and amazingly there were people — a couple of people — who chose that.”*

*“He suspects those individuals got spooked by rumors about the vaccine. But everybody else who had the placebo shot went ahead and got the actual vaccine. So now Fierro has essentially no comparison group left for the ongoing study. “It’s a loss from a scientific standpoint, but given the circumstances I think it’s the right thing to do,” he says.*

*“People signing up for these studies were not promised special treatment, but once the FDA authorized the vaccines, their developers decided to offer the shots.”*

Just so we are clear, the final FDA authorization and approval for the vaccines are based on the outcome of these trials. As noted in the example above, the control group was intentionally lost under the auspices of “the right thing to do”, so there is no way for the efficacy, effectiveness or safety of the vaccine itself to be measured.

There’s no one left within the control group, of a statistically valid value, to give an adequate comparison of outcomes for vaxxed -vs- non-vaxxed.

### HAS THE COVID-19 VIRUS BEEN ISOLATED?

Has all of this been smoke and mirrors? Has SARS-CoV-2 really never been isolated? Some argue that [viruses don't even exist](#), which is a whole other topic that further confuses matters.

Mike Adams is joined by virologist, Dr. Judy Mikovits to explain all of this. He tells her that he has a food and supplement safety laboratory and that he has not found any certified reference material for the COVID-19 virus. He says, *"Apparently, it does not exist. Why would that be?"*

Vaccine purchasers must *“indemnify, defend and hold harmless Pfizer ... from and against any and all suits, claims, actions, demands, losses, damages, liabilities, settlements, penalties, fines, costs and expenses ... arising out of, relating to, or resulting from the vaccine.”*

Vaccine makers have nothing to lose by marketing their experimental COVID-19 shots, even if they cause serious injury and death, as they enjoy full indemnity against injuries occurring from COVID-19 vaccines or any other pandemic vaccine under the Public Readiness and Emergency Preparedness (PREP) Act, passed in the U.S. in 2005.

The full extent of their COVID-19 vaccine indemnification agreements with countries, however, is a closely guarded secret, one that has remained highly confidential — until now. A leaked document broken down by Twitter user Ehden reveals the shocking terms of Pfizer’s international COVID-19 vaccine agreements.

**PFIZERLEAK: EXPOSING THE PFIZER MANUFACTURING AND SUPPLY AGREEMENT.**

Background:

Pfizer has been extremely aggressive in trying to protect the details of their international COVID19 vaccine agreements.

*“These agreements are confidential, but luckily one country did not protect the contract document well enough, so I managed to get a hold of a copy,” he wrote. “As you are about to see, there is a good reason why Pfizer was fighting to hide the details of these contracts.”*

An ironclad agreement, all on Pfizer’s terms

The alleged indemnification agreement, reportedly between Pfizer and Albania, was originally posted in snippets on Twitter, but Twitter now has them marked as “unavailable.” Copies of the tweets are available on Treadreader, however.

The Albania agreement appears very similar to another contract, published online, between Pfizer and the Dominican Republic. It covers not only COVID-19 vaccines, but any product that enhances the use or effects of such vaccines.

Countries that purchase Pfizer’s COVID-19 shot must acknowledge that *“Pfizer’s efforts to develop and manufacture the Product” are “subject to significant risks and uncertainties.”*

And in the event that a drug or other treatment comes out that can prevent, treat or cure COVID-19, the agreement stands, and the country must follow through with their order. Ivermectin, for instance, is not only safe, inexpensive and widely available but has been found to reduce COVID-19 mortality by 81%. Yet, it continues to be ignored in favor of more expensive, and less effective, treatments and mass experimental vaccination.

*“If you were wondering why #Ivermectin was suppressed,” Ehden wrote, “well, it is because the agreement that countries had with Pfizer does not allow them to escape their contract, which states that even if a drug will be found to treat COVID19 the contract cannot be voided.”*

Even if Pfizer fails to deliver vaccine doses within their estimated delivery period, the purchaser may not cancel the order. Further, Pfizer can make adjustments to the number of contracted doses and their delivery schedule, *“based on principles to be determined by Pfizer,”* and the country buying the vaccines must *“agree to any revision.”*

It doesn’t matter if the vaccines are delivered severely late, even at a point when they’re no longer needed, as it’s made clear that *“Under no circumstances will Pfizer be subject*



to or liable for any late delivery penalties.” As you might suspect, the contract also forbids returns “under any circumstances.”

### **The big secret: Pfizer charged U.S. More Than Other Countries**

While COVID-19 vaccines are “free” to receive in the U.S., they’re being paid for by taxpayer dollars at a rate of \$19.5011 per dose. Albania, the leaked contract revealed, paid \$12 per dose, while the EU paid \$14.70 per shot. While charging different prices to different purchasers is common in the drug industry, it’s often frowned upon.

In the case of the price disparity between the U.S. and the EU, Pfizer is said to have given a price break to the EU because it financially supported the development of their COVID-19 vaccine. Still, Ehden noted, “U.S. taxpayers got screwed by Pfizer, probably also Israel.” Also, Pfizer makes a point to note that countries have no right to withhold payment to the company for any reason.

Apparently, this includes in the case of receiving damaged goods. Purchasers of Pfizer’s COVID-19 vaccines are not entitled to reject them “based on service complaints,” unless they do not conform to specifications or the FDA’s Current Good Manufacturing Practice regulations. And, Ehden adds, “This agreement is above any local law of the state.”

While the purchaser has virtually no way of canceling the contract, Pfizer can terminate the agreement in the event of a “material breach” of any term in their contract.

Safety and efficacy ‘not currently known’

The purchaser of Pfizer’s COVID-19 vaccine must also acknowledge two facts that have largely been brushed under the rug: Both their efficacy and risks are unknown. According to section 5.5 of the contract:

*“Purchaser acknowledges that the Vaccine and materials related to the Vaccine, and their components and constituent materials are being rapidly developed due to the emergency circumstances of the COVID-19 pandemic and will continue to be studied after provision of the Vaccine to Purchaser under this Agreement.”*

*“Purchaser further acknowledges that the long-term effects and efficacy of the Vaccine are not currently known and that there may be adverse effects of the Vaccine that are not currently known.”*

Indemnification by the purchaser is also explicitly required by the contract, which states, under section 8.1:

*“Purchaser hereby agrees to indemnify, defend and hold harmless Pfizer, BioNTech, each of their Affiliates, contractors, sub-contractors, licensors, licensees, sub-licensees, distributors, contract manufacturers, services providers, clinical trial researchers, third*

*parties to whom Pfizer or BioNTech or any of their respective Affiliates may directly or indirectly owe an indemnity based on the research ...”*

*“from and against any and all suits, claims, actions, demands, losses, damages, liabilities, settlements, penalties, fines, costs and expenses (including, without limitation, reasonable attorneys’ fees and other expenses of an investigation or litigation ... arising out of, relating to, or resulting from the Vaccine ...”*

Meanwhile, the purchaser must also keep the terms of the contract confidential for a period of 10 years.

Purchasers must protect and defend Pfizer

Not only does Pfizer have total indemnification, but there’s also a section in the contract titled, **“Assumption of Defense by Purchaser,”** which states that in the event Pfizer suffers losses for which it is seeking indemnification, the purchaser *“shall promptly assume conduct and control of the defense of such Indemnified Claims on behalf of the Indemnitee with counsel acceptable to Indemnitee(s), whether or not the Indemnified Claim is rightfully brought.”* Ehdén notes:

*“Pfizer is making sure the country will pay for everything: ‘Costs and expenses, including ... fees and disbursements of counsel, incurred by the Indemnitee(s) in connection with any Indemnified Claim shall be reimbursed on a quarterly basis by Purchaser.’”*

Buried in the March 17, 2020, Federal Register — the daily journal of the U.S. government — in a document titled, *“Declaration Under the Public Readiness and Emergency Preparedness Act for Medical Countermeasures Against COVID-19,”* is language that establishes a new COVID-19 vaccine court — similar to the federal vaccine court that already exists.

In the U.S., vaccine makers already enjoy full indemnity against injuries occurring from this or any other pandemic vaccine under the PREP Act. If you’re injured by a COVID vaccine (or a select group of other vaccines designated under the act), you’d have to file a compensation claim with the Countermeasures Injury Compensation Program (CICP), which is funded by U.S. taxpayers via Congressional appropriation to the Department of Health and Human Services (DHHS).

While similar to the National Vaccine Injury Compensation Program (NVICP), which applies to nonpandemic vaccines, the CICP is even less generous when it comes to compensation. As reported by Dr. Meryl Nass, 25 the maximum payout you can receive — even in cases of permanent disability or death — is \$250,000 per person; however, you’d have to exhaust your private insurance policy before the CICP gives you a dime.

The CICP also has a one-year statute of limitations, so you have to act quickly, which is also difficult since its unknown if long-term effects could occur more than a year later.

Pfizer accused of abuse of power

As is apparent in Pfizer's confidential contract with Albania, the drug giant wants governments to guarantee the company will be compensated for any expenses resulting from injury lawsuits against it. Pfizer has also demanded that countries put up sovereign assets, including bank reserves, military bases and embassy buildings, as collateral for expected vaccine injury lawsuits resulting from its COVID-19 inoculation.

New Delhi-based World Is One News (WION) reported in February 2021 that Brazil rejected Pfizer's demands, calling them "abusive." The demands included that Brazil:

1. "Waives sovereignty of its assets abroad in favor of Pfizer."
2. Not apply its domestic laws to the company.
3. Not penalize Pfizer for vaccine delivery delays.
4. Exempt Pfizer from all civil liability for side effects.

STAT News also referred to concerns by legal experts, who also suggested Pfizer's demands were an abuse of power. Mark Eccleston-Turner, a lecturer in global health law at Keele University in England, told STAT:

*"[Pfizer] is trying to eke out as much profit and minimize its risk at every juncture with this vaccine development then this vaccine rollout. Now, the vaccine development has been heavily subsidized already. So there's very minimal risk for the manufacturer involved there."*

Signs of COVID vaccine failure, adverse effects rise.

Pfizer continues to sign lucrative secret vaccine deals across the globe. In June 2021, they signed one of their biggest contracts to date — with the Philippine government for 40 million doses.

Meanwhile, COVID-19 "*breakthrough cases*," which used to be called vaccine failures, are on the rise. According to the U.S. Centers for Disease Control and Prevention (CDC), as of July 19, 5,914 people who had been fully vaccinated for COVID-19 were hospitalized or died from COVID-19.

In the U.K., as of July 15, 87.5% of the adult population had received one dose of COVID-19 vaccine and 67.1% had received two. Yet, symptomatic cases among partially and fully vaccinated are on the rise, with an average of 15,537 new infections a day being detected, a 40% increase from the week before.

In a July 19 report from the CDC, the agency also reported that the Vaccine Adverse Event Reporting System (VAERS) had received 12,313 reports of death among people who received a COVID-19 vaccine — more than doubling from the 6,079 reports of death from the week before.

Soon after the report, however, they reverted the number to the 6,079 from the week before, indicating by default that no deaths from the vaccine had occurred that week, raising serious questions about transparency and vaccine safety.

The CDC revised downward its official number of deaths reported to VAERS following COVID vaccines, but an analysis of VAERS data shows the CDC arrived at the new, lower number, by excluding reports of deaths from outside the U.S. <https://t.co/HA2n8lkuMw>

Many other adverse events are also appearing, ranging from risks from the biologically active SARS-CoV-2 spike protein used in the vaccine to blood clots, reproductive toxicity and myocarditis (heart inflammation). - **Who's behind this?** Shanghai Nanotechnology filed a patent for the use of graphene oxide as excipients in the vaccines. On their website, **Tal Zaks**, the Moderna CEO, was there. Surely, I mistakenly thought, it had been isolated, purified and determined to be the cause of covid-19 sickness.



A year later, it turns out the skeptics were right. And the warnings of people like Dr. Thomas Cowan, Sally Fallon, Dr. Andrew Kaufman, Jon Rappoport, David Icke and others were right on the mark. (I have since apologized to them all in a public podcast.)

How did I come to realize the medical and scientific establishment has fabricated all this? And what's the explanation for the very real sickness that people are experiencing?

I'll share that story here, but in short, common cold viruses and monkey virus fragments found in flu shots are being mislabeled "covid," and there is a weaponized spike protein bioweapon that's being distributed via vaccine injections. That's all real. But there's no such thing as a real, physical, isolated covid-19 virus that has been harvested from sick people and shown to infect other people and make them sick. What we're really witnessing here, it now seems, is three distinct things:

1). A cocktail of common cold viruses labeled "covid" which are circulating and causing sickness in some people, most likely because of the lack of immune system exposure to wild type viruses during all the global lockdowns.

2). A weaponized spike protein toxic nanoparticle that's being injected into people as a "clot shot" ... and it's likely shedding, causing harmful side effects in other, unvaccinated people.

3). A wholly fraudulent PCR "casedemic" scheme that's designed to flag almost anyone as "positive" based almost entirely on how many cycles the PCR sample prep instruments are instructed to carry out, thereby amplifying instrument noise to the point of a "positive" hit. Almost anything can be flagged as "positive," including genetic material fragments from previous years' flu shots.

These three things — combined with the media's mass hysteria programming — have achieved a level of global fear and psychological terrorism that the world has never seen before. But it's all based on lies, it turns out. And here's how we know.

### **No certified reference materials for isolated SARS-CoV-2 "covid-19" virus.**

As a lab owner, published scientist and mass spec analyst myself, I am extremely familiar with the process of using certified reference materials (CRMs) to validate analysis methods and instrument calibration sequences. (I've spent far too many evenings creating serial dilutions of standards using a Gilson pipette, trust me...)

Here's how the process normally works in a legitimate science lab:

Step 1) Acquire the CRM of the thing you want to test ("analyte"). This means acquiring a purified, isolated standard with a known concentration, usually in a carrier such as water, or as a dry powder. For example, when I'm testing for mercury in food, I have a certified mercury standard with a known concentration of mercury, dissolved in water, nitric acid and hydrochloric acid.

Step 2) Run the CRM as a sample, at different concentrations, to build a "curve" that effectively teaches the instrument what the analyte looks like and how the instrument



detector responds to different concentrations of the analyte. The end result is a “quant curve” that will be used in step 3.

NOTE: Instruments will “match” the thing you’re looking for by a variety of methods, filtering out all other things that don’t match. In mass spec work, molecules are identified by their molecular mass, ion fragmentation patterns, and elution time on chromatography columns. For a substance to match, it has to hit all these parameters. In PCR testing, a “match” is a genomic sequence made of base pairs, defined in a digital library that may or may not have ever been run against a real, physical standard in the real world.

Step 3) Run unknown samples through the instrument (of blood serum, urine, saliva, water, food sample extracts, etc.) and see if the unknown sample contains any of the thing you were looking for (the analyte). Because you built a quant curve, you can also then determine the concentration of the analyte in the original sample. This is typically described as mass over volume, such as ng / ml (nanograms per milliliter). A nanogram is a billionth of a gram. When we test foods for glyphosate, we can detect as little as 1 nanogram per milliliter, which tells you something about the extreme sensitivity of high-end instruments.

This is the process to test something and identify how much of something is found in something else. For example, if you were going to determine if someone was sick with “covid,” you would need to determine the concentration of covid-19 viruses in their blood (i.e. the “viral load”). This is science / biology 101.

So what’s the problem, then?

You’d be stunned to realize how deep the science fraud really goes. Consider these critical points:

Point #1: There appear to be no isolated, purified Certified Reference Materials available for SARS-CoV-2 “covid”. I’ve seen companies that claim to be selling “isolates” containing covid viruses, but in their own description, they explain that their vials contain genetic material from “host cells” (human cells) as well as bovine serum cells, which means it’s a cocktail stew of who-knows-what. Yet it’s called an “isolate.”

Case in point: BEI Resources, which offers something they call an “isolate” of covid-19, [that you can find at this link](#). As the description states for this covid-19 “isolate:”

... [T]his product is not suitable as a whole cell antigen preparation because the protein content is largely contributed by the host cell and the fetal bovine serum used during virus propagation.

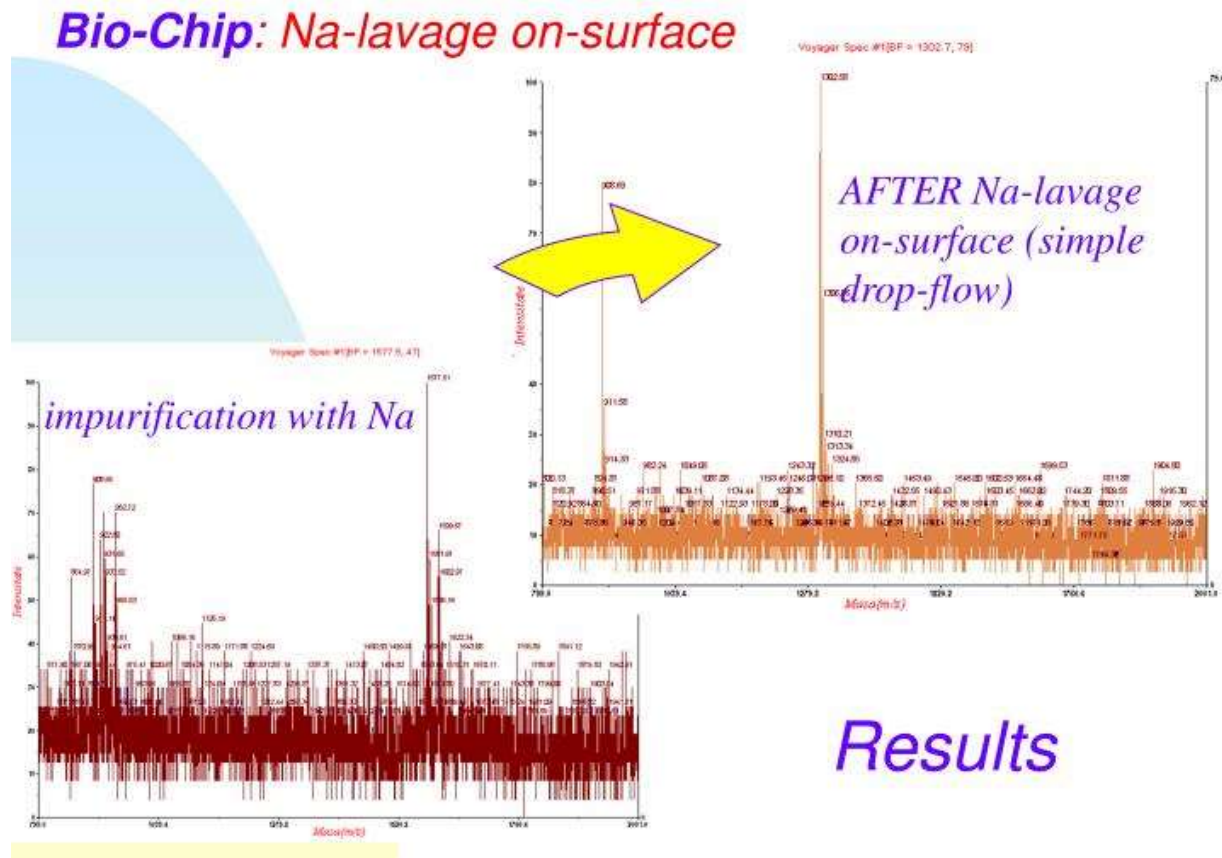
In other words, most of the genetic material in the “isolate” is actually from human cells. So it’s not an isolate at all. The covid virus isn’t isolated. In fact, this “isolate” contains viral genetic material, human genetic material and bovine genetic material, plus whatever other viruses were present in the blood of the people and the cows. This could

be millions of different nanoparticles present, each containing their own sequences of genetic material.

Point #2: If you have no isolated, certified reference materials, you can't develop a legitimate analysis test. And this is exactly what the FDA admits in its own documents, which state that since covid-19 viruses weren't available for the development of the PCR test, they "simulated" it by using human cells and gene bank coronavirus fragments. From the FDA's own document:

Since no quantified virus isolates of the 2019-nCoV were available for CDC use at the time the test was developed and this study conducted, assays designed for detection of the 2019-nCoV RNA were tested with characterized stocks of in vitro transcribed full length RNA ... spiked into a diluent consisting of a suspension of human A549 cells and viral transport medium (VTM) to mimic clinical specimen.

In other words, they faked the covid virus by using gene bank cells which were deliberately and falsely labeled "covid." This is how the PCR test was developed. The FDA admits it all. The PCR test is a fraud.



Point #3: If you don't have a CRM isolate, you can't calibrate instruments against a known sample. And this means the PCR tests aren't being calibrated against anything

real and physical. Instead, they're relying on downloaded digital libraries provided by none of them the CDC, the very same Big Pharma front group that's spearheading this covid scam.

Point #4: PCR instruments are incapable of quantitative analysis. The "positive" hits are nothing but amplified background noise. No PCR instrument can tell you how much of some genetic material was found in an original sample. It can merely detect the presence of material on a yes / no basis. In lab science, this is called a "qualitative" analysis, not a quantitative analysis.

In qualitative analysis, the key factor is the "Limit of Detection" (LOD) of the instrument. How little of the sample will still create a "hit" for the instrument? In all instruments, for the LOD to be scientifically valid, it must be something that rises above background noise, or it's scientifically meaningless. All instruments produce background noise, which are "peaks" or "hits" that represent detector static, you might say. These exist at a background level even when you're running nothing in the instrument.

To show you what this looks like, consider the following graphic. It shows some mass spec results across a spectrum of masses. The horizontal axis here is  $m/z$  (mass over charge), which is simplified to just "mass" for general discussion. It's the mass of the molecules or particles being detected.

Notice the red and orange lines across the bottom of each chart. That's largely "background" noise across all the masses. Then notice the very tall orange peak which rises above the background. This is the mass of the molecule they're looking for. It might be a pesticide, or a contaminant, or a nutrient, etc..

Importantly, if I were to turn up the amplification of the detector, the "background noise" at the bottom of the screen would vertically expand to fill the screen. The entire screen would be a "hit" on every mass, because the amplification is turned way up. That's the equivalent to what PCR instruments are doing when they run 30+ cycles. They are amplifying noise, and then pretending they got a "hit" on covid.

But because they've amplified it so many times, they've obliterated any ability to say with certainty what they have, or even how much they have. Because the LOD (Limit of Detection) is scientifically invalid if it can't pick a peak out of the background noise.

Typically in method validation, your LOD needs to be at least three times higher than background noise, which means a "peak" must be three times higher than the background. Anything less than that is considered bogus background noise. And when you're doing quantitative work, you typically need a signal that's at least 10 times higher than background.

Yet PCR instruments are taking background noise and amplifying it until they get a "positive" hit. This "positive" is then absurdly called a "covid case," even though it means literally nothing from a legitimate science point of view.

The entire process being used today via PCR is complete junk science that wouldn't pass even the most basic science lab audit. That's why most of these PCR outfits aren't ISO accredited, by the way. They couldn't pass a single audit. (My lab is ISO accredited with an annual audit, including blind quantitation accuracy tests via mass spec instruments to make sure we are hitting our accuracy targets.)

Not only did she confirm that there is no isolated covid-19 virus that has been harvested and purified from a sick person and proven to cause disease in another person; she also confirmed that Dr. Fauci specifically chose a weaponized lab sample that was infected with a cocktail of coronaviruses to use as a basis for gain-of-function research via the Wuhan Institute of Virology.

In other words, Dr. Fauci knew he was building a Frankensteinian viral stew that the fraudulent CDC and complicit scientific community would simply label "covid." Augmented by mass media hysteria, they could drive most of the population into submitting to vaccines which were engineered to inoculate the population with spike protein bioweapons, also developed under Fauci's guidance and funding directives.

Finally, new FOIA documents have surfaced, revealing the CDC has never isolated any covid-19 virus. A Canadian named Christine Massey has reportedly filed multiple FOIA requests with the CDC, requesting the following via the Freedom of Information Act:

All studies and/or reports in the possession, custody or control of the CDC and/or the Agency for Toxic Substances and Disease Registry (ATSDR) describing the purification of any "COVID-19" virus (including B.1.1.7", "B.1.351", "P.1" and any other "variant") (via

maceration, filtration and use of an ultracentrifuge; also referred to at times by some people as “isolation”), directly from a sample taken from a diseased human, where the patient sample was not first combined with any other source of genetic material (i.e. monkey kidney cells aka Vero cells; fetal bovine serum).

In a response letter dated June 7th, 2021, the CDC responded:

A search of our records failed to reveal any documents pertaining to your request. Specifically, the National Center for Immunization and Respiratory Disease apprises that CDC does not purify or isolate any COVID-19 virus in the manner the requestor describes.

The FOIA request is identified as #21-01075-FOIA.

In other words, the CDC has never isolated and purified any covid-19 virus, period.

[The website of Dr. Robert O. Young](#) reveals additional documents showing that the CDC has never isolated and purified the HPV virus, the Measles virus, the MERS virus, the Zika virus or the Polio virus, among others.

(We are working to reach out to Christine Massey to confirm the extent of her FOIA requests and invite her for an interview.)

On July 21st of this year, [the CDC announced it is withdrawing its authorization of the current PCR test for covid-19](#), saying the PCR test would no longer be considered valid science after December 31st of this year. It then states that a new PCR test will, “facilitate detection and differentiation of SARS-CoV-2 and influenza viruses,” meaning the new test will reportedly be able to tell the difference between covid and the common cold. This implies that the current test — the one used to push global covid pandemic hysteria — does not achieve such a differentiation.

In effect, it appears the CDC has been fabricating the science behind global “pandemics” for decades, using the media to spread mass hysteria where no pandemic existed. One of the best and most recent cases is the recent Zika virus, where mainstream media outlets were screaming that babies born to new mothers in Florida would be born with shrunken heads (microcephaly) because of the Zika virus. Just as with the covid scheme, [billions of dollars were funneled into pharmaceutical companies to research a vaccine for Zika](#), which turned out to be nothing more than fictional hype.

The CDC director Walensky admits the covid vaccine does not prevent covid infection or Delta variant transmission.

Adding to the unraveling of this covid-19 vaccine hoax, the Director of the CDC, Dr. Rochelle Walensky, just admitted something astonishing on CNN: Covid-19 vaccines do NOT prevent covid-19 infections. They also do not stop people from transmitting the “Delta variant” of what the CDC calls the covid virus.

The covid-19 virus is a hoax, but the weaponized spike protein is very real and quite deadly

...[T]he paper provides clear confirmation and a detailed explanation of the mechanism through which the protein damages vascular cells for the first time. There’s been a growing consensus that SARS-CoV-2 affects the vascular system, but exactly how it did so was not understood. Similarly, scientists studying other coronaviruses have long suspected that the spike protein contributed to damaging vascular endothelial cells, but this is the first time the process has been documented.

In the new study, the researchers created a “pseudovirus” that was surrounded by SARS-CoV-2 classic crown of spike proteins, but did not contain any actual virus. Exposure to this pseudovirus resulted in damage to the lungs and arteries of an animal model—proving that the spike protein alone was enough to cause disease. Tissue samples showed inflammation in endothelial cells lining the pulmonary artery walls.

The spike protein was developed as a bioweapon in order to cause widespread symptoms that can then be falsely labeled “covid” and then cited to push even more vaccine injections containing more spike protein bioweapons. ### **Dr. Mikovits: SARS-CoV-2 is actually a lab-made monkey cell virus, readily deployed through the flu, MMR and polio vaccine supply**

Dr. Judy Mikovits was [recently interviewed on Brighteon Conversations](#), and she did not hold back unveiling the real causes of transfection behind SARS-CoV-2 and the scientific fraud that was used to promote a pandemic and suppress people's immune systems. Dr. Mikovits was formerly a government virologist who purified and studied viruses. She created cell lines that support viral replication, to understand how they create infection in humans. She is the author of *'Ending Plague, A Scholar's Obligation in an Age of Corruption.'*

Dr. Mikovits confirmed that isolated, certified reference material for SARS-CoV-2 does not exist. The virus has never been isolated from human cells and was never a human virus in the first place. The SARS-CoV-2 virus can only be manufactured and replicated in the vero monkey kidney cell line, which is a group of epithelial cells extracted from African green monkeys in the 1960s. These monkey cell lines, readily contaminated with latent retroviruses, have been injected into the population since the mid-90s through the flu, MMR and polio vaccine supply, and are the only originating vector by which SARS-CoV-2 can manifest disease in humans.

### **Evidence points to SARS-CoV-2 being deployed through vaccine supply.**

Every bio-safety level 4 lab that claimed to isolate SARS-CoV-2 from humans ultimately placed the sample in a monkey kidney cell line to "prove" its replication. This virus is not a truly isolated human virus because it could only be replicated in the monkey kidney cell line. To determine whether SARS-CoV-2 is an infectious human virus, it must be taken from the blood, sputum, or lung lavage of an infected human, but the infectious RNA of SARS-CoV-2 was never cultured in a continuously growing human cell line that



supports the replication of SARS-CoV-2. Since this novel coronavirus only replicates demonstrably in vero monkey cell lines, it has never been proven to originate or spread from human-to-human, let alone spread from healthy people.

Since the current flu, MMR and polio vaccines contain these same vero monkey cell lines, the only way to deploy SARS-CoV-2 is through transfection via these needles. SARS-CoV-2 is a lab-made sequence that originates and spreads through the existing influenza vaccine supply. This could be why the Department of Defense discovered that flu vaccine recipients from 2017-2018 were [increasingly susceptible to coronavirus interference](#).

*“When you take a synthetic part of a virus and you grow it in the monkey cells, you can get recombination events of all the monkey viruses, so it’s a monkey virus,”* Mikovits confirmed, referring to the respiratory infections seen in covid-19. The HIV component comes from the Simian immune deficiency virus, which is also a natural monkey virus.

**FDA approves COVID booster shots: Agency says transplant patients and others with weakened immune systems can get third shot of Moderna or Pfizer vaccine** [Apparently the FDA has not got the news from the WHO about Covid-19 being the ordinary flu!]

U.S. regulators on Thursday said transplant recipients and others with severely weakened immune systems can get an extra dose of the Pfizer or Moderna COVID-19 vaccines to better protect them as the Indian Delta variant continues to surge.

The late-night announcement by the Food and Drug Administration (FDA) applies to several million Americans who are especially vulnerable due to organ transplants, certain cancers or other disorders.

No guidance was given for people who had Johnson & Johnson's single-shot COVID-19 vaccination.



Several other countries, including France and Israel, have similar recommendations. It's harder for vaccines to rev up an immune system suppressed by certain medications and diseases, so those patients don't always get the same protection as otherwise healthy people - and small studies suggest for at least some, an extra dose may be the solution.

Such people – including cancer and HIV patients – in general do not produce an adequate immune response after receiving two doses of a vaccine, U.S. officials say but you better get that “booster” shot so we can call your death the result of the unvaxxed resisters! **This is total B.S. There are no such things as “Breakthrough Cases.” The vaxx is causing re-infections, not the unvaxxed. This is a word game and not real science. Numerous studies show that up to 85% of previously vaxxed are getting re-infected from their first two shots.**

Growing evidence has suggested select immune-compromised patients mount a diminished protective immune response, even after two doses of vaccine. An Army medical study two years ago showed those who had taken yearly flu shots were more susceptible to any additional shots of any kind! *“Today’s action allows doctors to boost immunity in certain immunocompromised individuals who need extra protection from COVID-19,” Dr. Janet Woodcock, the FDA’s acting commissioner,*” said in a statement. **Dr. Judy Mikovitzs and Dr. Andrew Kaufman would vehemently disagree with that statement.**



According to Dr. Janet Woodcock, today's COVID-19 climate allows doctors to boost immunity in certain immunocompromised individuals who need extra protection from coronavirus.

The FDA determined that transplant recipients and others with a similar level of compromised immunity can receive a third dose of the vaccines from Pfizer and Moderna at least 28 days after getting their second shot.

The announcement comes as the “alleged” extra-contagious Delta version of the coronavirus surges through much of America, pushing new cases, hospitalizations and deaths to heights not seen since winter 2020.

Importantly, the FDA’s decision only applies to a specific high-risk group, estimated to be no more than 3% of U.S. adults.

It's not an opening for booster doses for the general population. Instead, health authorities consider the extra dose part of the initial prescription for the immune-compromised.

Separately, U.S. health officials are continuing to closely monitor if and when average people's immunity wanes enough for to be required - but for now, the vaccines continue to offer robust protection for the general population. **More B.S.!**



**Dr. Fauci told several news networks, including NBC and CNN, that COVID-19 Booster shots are needed for those who are immunocompromised.**

The Centers for Disease Control and Prevention is expected to formally recommend the extra shots for certain immune-compromised groups after a meeting on Friday with its outside advisers. **In that the CDC has taken down their VAERS reporting site of vaxx reactions, why should anyone believe this nonsense?**

Transplant recipients and others with suppressed immune systems know they're at more risk than the average American and some have been seeking out extra doses on their own, even if it means lying about their vaccination status.

The change means now the high-risk groups can and will have easier access to get another shot - but experts caution it's not yet clear exactly who should.

*"This is all going to be very personalized,"* cautioned Dr. Dorry Segev, a transplant surgeon at Johns Hopkins University who is running a major National Institutes of Health study of extra shots for organ recipients.

**The FDA determined that transplant recipients and others with weak immune systems can receive a third dose of vaccines from Pfizer and Moderna 28 days after getting double jabbed. Shame on these evil people!**

For some people, a third dose 'increases their immune response. Yet for some people it does not seem to. We don't quite know who's who yet.'

Recently, one study of more than 650 transplant recipients found more than half harbored virus-fighting antibodies after two doses of the Pfizer or Moderna vaccines - although generally less than in otherwise healthy vaccinated people. Another study of people with rheumatoid arthritis and similar autoimmune diseases found only those who use particular medications have very poor vaccine responses.

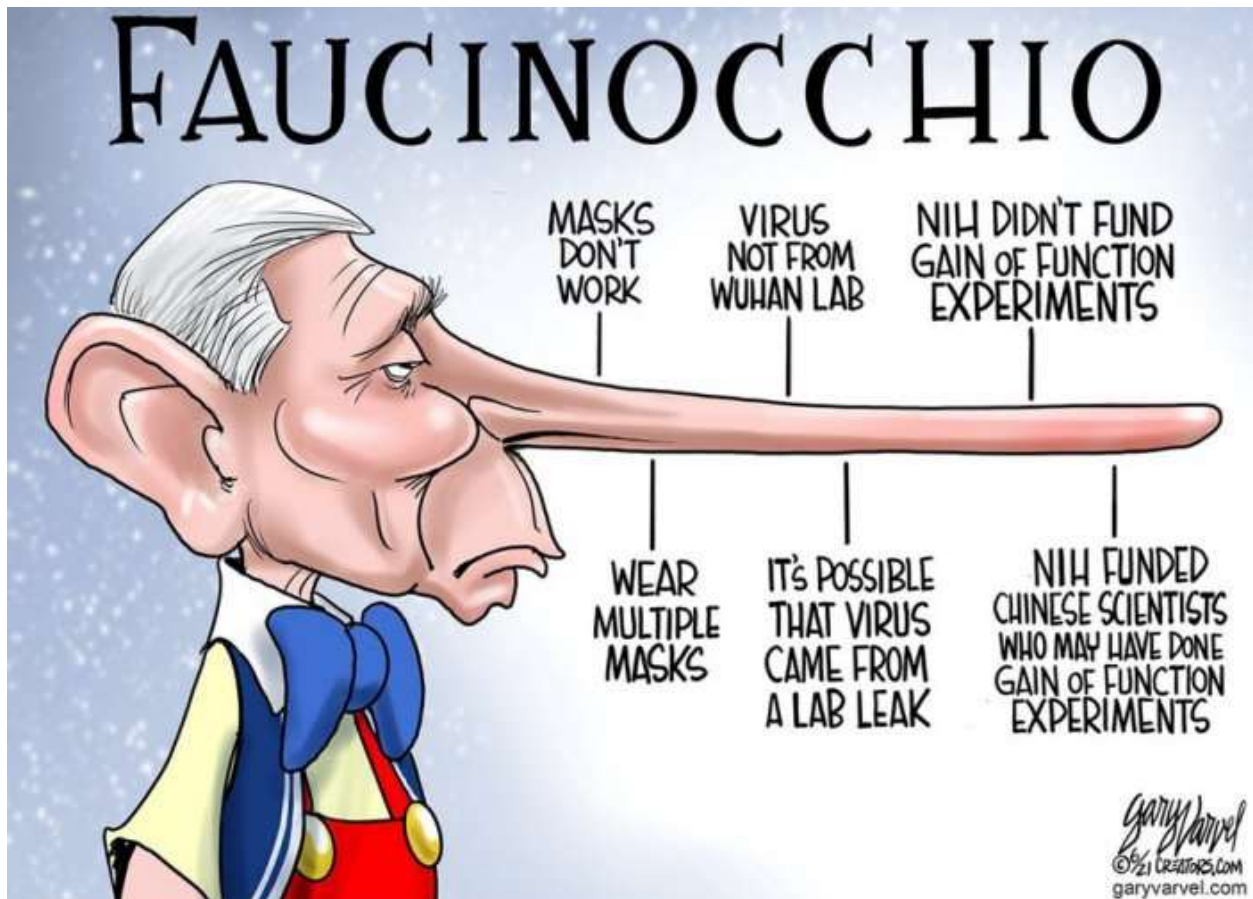
There's little data on how well a third dose works, and if it causes any safety problems such as an increased risk of organ rejection. Wednesday, Canadian researchers reported that transplant recipients were more likely to have high levels of antibodies if they got a third dose than those given a dummy shot for comparison. Other small studies have similarly found that some transplant recipients respond to a third dose while others still lack enough protection.

## *Dr. Fauci Will Hang Himself by His Lies!*

*"We know a lot more than we did to start, but there's obviously, you know, we need to be humble in the face of this virus,"* Fauci said.

Fauci said *"there are a lot of factors"* that go into making decisions such as whether people will routinely have to get vaccinated against COVID-19 like an annual flu shot.

He said researchers have already started conducting studies giving boosters to people who have already been full vaccinated, which have shown hopeful promise that future booster shots beyond a third jab may not be needed.

This is clear evidence of the criminal nature of what the pharmaceuticals are doing. They canceled animal safety tests last fall because the animals all died, but then chose to proceed with humans as the guinea pigs. If the animals died why would you assume the human test subjects will live! Every safety protocol has been thrown out the

window for which the vaccine industry has followed since its beginning. Have they forgot about the Thalidomide scandal of the 1950s and 1960s.

In a post-war era when sleeplessness was prevalent, thalidomide was marketed to a world hooked on tranquilizers and sleeping pills. At the time, one out of seven Americans took them regularly. The demand for sedatives was even higher in some European markets, and the presumed safety of thalidomide, the only non-barbiturate sedative known at the time, gave the drug massive appeal. Sadly, tragedy followed its release, catalyzing the beginnings of the rigorous drug approval and monitoring systems in place at the United States Food and Drug Administration (FDA) today.

Thalidomide first entered the German market in 1957 as an over-the-counter remedy, based on the maker's safety claims. They advertised their product as "completely safe" for everyone, including mother and child, "even during pregnancy," as its developers "could not find a dose high enough to kill a rat." By 1960, thalidomide was marketed in 46 countries, with sales nearly matching those of aspirin.

Around this time, Australian obstetrician Dr. William McBride discovered that the drug also alleviated morning sickness. He started recommending this off-label use of the drug to his pregnant patients, setting a worldwide trend. Prescribing drugs for off-label purposes, or purposes other than those for which the drug was approved, is still a common practice in many countries today, including the U.S. In many cases, these off-



label prescriptions are very effective, such as prescribing depression medication to treat chronic pain.

However, this practice can also lead to a more prevalent occurrence of unanticipated, and often serious, adverse drug reactions. In 1961, McBride began to associate this so-called harmless compound with severe birth defects in the babies he delivered. The drug interfered with the babies' normal development, causing many of them to be born with phocomelia, resulting in shortened, absent, or flipper-like limbs. A German newspaper soon reported 161 babies were adversely affected by thalidomide, leading the makers of the drug—who had ignored reports of the birth defects associated with the it—to finally stop distribution within Germany. Other countries followed suit and, by March of 1962, the drug was banned in most countries where it was previously sold.

In July of 1962, president John F. Kennedy and the American press began praising their heroine, FDA inspector Frances Kelsey, who prevented the drug's approval within the United States despite pressure from the pharmaceutical company and FDA supervisors. Kelsey felt the application for thalidomide contained incomplete and insufficient data on its safety and effectiveness. Among her concerns was the lack of data indicating whether the drug could cross the placenta, which provides nourishment to a developing fetus.

She was also concerned that there were not yet any results available from U.S. clinical trials of the drug. Even if these data were available, however, they may not have been entirely reliable. At the time, clinical trials did not require FDA approval, nor were they subject to oversight. The “clinical trials” of thalidomide involved distributing more than two and a half million tablets of thalidomide to approximately 20,000 patients across the nation—approximately 3,760 women of childbearing age, at least 207 of whom were pregnant. More than one thousand physicians participated in these trials, but few tracked their patients after dispensing the drug.

The tragedy surrounding thalidomide and Kelsey's wise refusal to approve the drug helped motivate profound changes in the FDA. By passing the Kefauver-Harris Drug Amendments Act in 1962, legislators tightened restrictions surrounding the surveillance and approval process for drugs to be sold in the U.S., requiring that manufacturers prove they are both safe and effective before they are marketed. Now, drug approval can take between eight and twelve years, involving animal testing and tightly regulated human clinical trials.

Despite its harmful side effects, thalidomide is FDA-approved for two uses today—the treatment of inflammation associated with Hansen's disease (leprosy) and as a chemotherapeutic agent for patients with multiple myeloma, purposes for which it was originally prescribed off-label. Because of its known adverse effects on fetal development, the dispensing of thalidomide is regulated by the System for Thalidomide Education and Prescribing Safety (S.T.E.P.S.) program. The S.T.E.P.S. program, designed by Celgene pharmaceuticals and carried out in pharmacies where thalidomide

prescriptions are filled, educates all patients who receive thalidomide about potential risks associated with the drug.

Thalidomide has also been associated with a higher occurrence of blood clots and nerve and blood disorders. Northwestern University's pharma-covigilance team, Research on Adverse Drug Events And Reports (RADAR), has launched a joint project with the Walgreens pharmacy at Northwestern Memorial Hospital so that these side effects may be understood and monitored, like those affecting fetal development. RADAR, led by Dr. Charles Bennett of the Feinberg School of Medicine, combines the expertise of clinicians, academics, pharmacists, and statisticians to monitor and disseminate information about adverse drug reactions to cancer drugs.



Dr. Fauci continues his lies.

*"The good news about that is that the acceleration of the response goes way up. I mean even better than what you get with the two doses together. In other words, it goes up and up and then if you give a boost, it goes way up," he said.*

*"I don't know for certain, but that could mean that you induce a response that's high enough - and durable enough - that you may not have to worry about what people are concerned about, needing a so-called boost every year or so."*

He continued: *"I would hope that the degree of elevation of response that we will see with the boost might actually give us a lot of wiggle room of not necessarily needing a boost often."*

*"But I have to be, as you say, we are humble and we are modest about it. We don't know the answer to that."* **You will excuse me here as I have to puke over his Jesuit doublespeak.**



**Dr. Anthony Fauci said on Thursday that *"he can't rule out indefinite COVID-19 booster shots but that he hopes that, if booster shots are needed, just one will suffice."***

Fauci said *"the only way"* the public health officials will become certain whether continued booster shots will be needed will be by conducting clinical and observational studies.

Cooper asked Fauci how future booster shots would be administered - namely if people would get them at their doctor's office and pharmacies or at mass vaccination locations. *"We don't want to get ahead of ourselves,"* Fauci said. **I would say that is a good idea for someone facing capital punishment for his crimes against humanity!**

The U.S. Food and Drug Administration is working with vaccine makers Pfizer and Moderna to let some vulnerable people receive a third booster shot of their COVID-19 vaccines to improve their immune response.

Rochelle Walensky, director of the Centers for Disease Control and Prevention, said on Thursday *“that the shots would be available to certain people who are moderately and severely immunocompromised.”*

That group, which she estimates sits at less than 3% of U.S. adults, would include people who have had organ transplants and some cancer patients.

He told Cooper that breakthrough infection sufferers are still at risk of long COVID, a term for those who suffer from lingering symptoms for months after their body clears the infection.

*“Certainly if you get vaccinated and you get a breakthrough infection, you can get long COVID,”* Fauci said. Fauci makes up the story as he goes on. *“We don’t have enough data in that to say if it’s the same kind of risk of getting long COVID of others. But it is likely it would be less because you got a good deal of protection from your vaccine.”*

Fauci also warned that children can get long COVID - but the incidence of it is significantly lower than an adult. **Dr. Fauci keeps changing the language, using terms like “long COVID” and “Breakthrough Cases.” These are—simply word games to confuse and obfuscate their lies. This is part of the con being foisted upon the public in their fear-mongering campaign!**

*“It’s just a few percent of children, whereas with the adult it’s anywhere from 10% to up to 30%,”* he said.

Mayo Clinic researchers has conducted an alarming study, which was published on a pre-print server medRxiv.org - meaning it has not yet been peer-reviewed.

The study found that the Pfizer-BioNTech vaccine was only 42% effective against infection in July while the Moderna vaccine was only 76% effective.

It has been noted that the drop in efficacy happened around the time the Delta variant of the coronavirus started sweeping the globe - raising concerns that booster shots will be needed to particularly protect against it and other future variants.

Earlier this month, Pfizer and Johnson & Johnson expressed that they were still confident that their vaccines can protect against COVID-19 variants despite a recent report warning about hundreds of breakthrough infections in a Massachusetts town.

The recent CDC study focused on an outbreak in the Cape Cod town of Provincetown, a heavy tourist hotspot in Barnstable County, after the July 4 weekend.

It found 469 cases of COVID-19 associated with multiple summer events and large public gatherings - even though 69% of Massachusetts residents were vaccinated.

Researchers said that 346 cases - or 74% - occurred in fully vaccinated people. Scientists did DNA sequencing on 133 of those patients and found that 119 of them, or 89%, had the Delta variant. **Remember, the CDC has admitted they never verified the existence of Covid-19, and so how can you claim a new variant "Delta" exists when its original does not exist. This is to keep the public in a state of fear!**

The study found that 79% of vaccinated patients with "breakthrough" infection were symptomatic. There were five COVID-19 patients who were hospitalized, four of whom were fully vaccinated - though no deaths were reported.



Researchers found that the Delta variant is “*highly transmissible*” but that “*vaccination is the most important strategy to prevent severe illness and death.*”

The study found that viral loads, which indicate the likelihood that someone could transmit the virus to others, were similar among 127 fully vaccinated people and 84 people who were unvaccinated or partially vaccinated. **More obfuscation mumbo jumbo!**

The new study came after the CDC recommended that even those who are fully vaccinated should wear masks in indoor public settings in areas where COVID-19 transmission is high or substantial. **Remember, it was the doctors who prescribed this and pharmaceutical companies who made Thalidomide who are to blame - not "the women who took it."**
