The Biblical Tribulation has not begun as of yet although it may seem it has. Did Naftali Bennett just threaten to cancel the Messiah? Israel's Prime Minister called for all Israelis to get vaccinated but implicit in his words was a message that non-vaccination would postpone the Messiah.

Two weeks ago Israeli Prime Minister Naftali Bennett told old people in Israel to get their “booster” shot of the Pfizer vaxx, or they would not get to see the Messiah! He said that he would cancel Rosh HaShanah. I believe he was jokingly subtly making a threat but none the less coercing the Sephardic elderly to get the third shot, which is the “kill” shot. Most people will miss the hidden Satanic innuendo in Bennett's words! Naftali Bennett is an ethnic Ashkenazi Jew. This means he is not a descendant of Abraham, Isaac, and Jacob. He is of the Synagogue of Satan. As of August 15th almost a million Jews have taken their third Pfizer shot. Bennett's intention was clearly a warning that if there was not an increase in vaccinations, there would be a shutdown during the upcoming Jewish holidays. This threat is proving contentious as political and social pressure led the government to issue an exemption to synagogues under the newly instated Green Pass restrictions. The new restrictions that kicked in on Sunday limited gatherings of any size, indoors and out, to those who have been vaccinated, recovered from the virus, or who present a negative COVID test. While the plan originally included synagogues and other houses of worship, these were eventually exempted in prayer services with fewer than 50 participants. Many politicians were angered by the exemption.

Though Bennett's prophetic implications in mind, coming together to hear the shofar is not only the symbol of the Jewish New Year. The shofar also is an essential element of the final redemption of Israel, as stated explicitly by Isaiah as signaling the pre-Messiah ingathering of the exiles:

“And in that day, a great shofar shall be sounded; and the strayed who are in the land of Assyria and the expelled who are in the land of Egypt shall come and worship Hashem on the holy mount, in Yerushalayim.” -(Isaiah 27:13)

This is one of the bases for blowing the shofar on Rosh Hashanah as it symbolizes the coronation of God as king. Biblical kings were coronated to the sound of shofar blasts and the final shofar of redemption will be the ultimate coronation of God as King when He will be one and His name will be one.

In the context of Isaiah's prophecy, Bennett's threat takes on dire implications, suggesting that the key to the arrival of the Messiah is acquiescing to the government's vaccination program. Few (if any) Israelis believe that being declared prime minister bestows upon Bennett the power to permit or forbid the arrival of the Messiah.

According to the Centers for Disease Control and Prevention, the White House and most mainstream media, what we have now is a “pandemic of the unvaccinated.”¹

According to the official narrative, 99% of COVID-19 deaths and 95% of COVID-related hospitalizations are occurring among the unvaccinated. In a July 16, 2021, White House press briefing,² CDC director Dr. Rochelle Walensky claimed “over 97% of people who are entering the hospital right now are unvaccinated.”

But as reported by Fox News anchor Laura Ingraham on “The Ingraham Angle,” “that statistic is grossly misleading,”³ and in an August 5, 2021, video statement, Walensky inadvertently revealed how that 95% to 99% statistic was created.

Grossly Misleading Data Manipulation

As it turns out, to achieve those statistics, the CDC included hospitalization and mortality data from January through June 2021. It does not include more recent data or data related to the Delta variant, which is now the most prevalent strain in circulation. The problem is, the vast majority of the United States population was unvaccinated during that timeframe.

January 1, 2021, only 0.5% of the U.S. population had received a COVID shot. By mid-April, an estimated 31% had received one or more shots,⁴ and as of June 15, 48.7% were fully “vaccinated.”⁵ Keep in mind that you’re not “fully vaccinated” until two weeks after your second dose (in the case of Pfizer or Moderna), which is given six weeks after your first shot. This is according to the CDC.⁶

So, those receiving an initial dose in June, for example, won’t be “fully vaccinated” until eight weeks later, sometime in July or August.

By using statistics from a time period when the U.S. as a whole was largely unvaccinated, the CDC is now claiming we’re in a “pandemic of the unvaccinated,” in an effort to demonize those who still have not agreed to receive this experimental gene modification injection.

Selective Pressure Promotes Emergence of New Variants

Here’s what Canadian viral immunologist and vaccine researcher Dr. Byram Bridle told Ingraham about the claim that we’re in a pandemic of the unvaxxed, and that the unvaccinated are hotbeds for dangerous variants:

“Absolutely, it’s untrue to be calling this a pandemic of the unvaccinated. And it’s certainly untrue ... that the unvaccinated are somehow driving the emergence of the novel variants. This goes against every scientific principle that we understand.

The reality is, the nature of the vaccines we are using right now, and the way we’re rolling them out, are going to be applying selective pressure to this virus to promote the emergence of new variants. Again, this is based on sound principles.

We have to look no further than ... the emergence of antibiotic resistance ... The principle is this: If you have a biological entity that is prone to mutation — and the SARS-CoV-2, like all coronaviruses is prone to mutation — and you apply a narrowly

focused selective pressure that is nonlethal, and you do this over a long period of time, this is the recipe for driving the emergence of novel variants.

This is exactly what we're doing. Our vaccines are focused on a single protein of the virus, so the virus only has to alter one protein, and the vaccines don't come close to providing sterilizing immunity.

People who are vaccinated still get infected, it only seems particularly good at blunting the disease, and what that tells you therefore is that these vaccines in the vast majority of people are applying a nonlethal pressure, narrowly focused on one protein, and the vaccine rollout is occurring over a long period of time. That's the recipe for driving variants."

Natural Immunity Offers Far Superior Protection

Bridle also explains why natural immunity offers robust protection against all variants, whereas vaccine-induced immunity can't. When you acquire the infection naturally, your body develops antibodies against ALL of the viral proteins whereas the COVID shots only trigger antibodies against one, namely the spike protein.

As mentioned above, when you have antibodies against just one of the viral proteins, the virus only needs to mutate that one protein in order to evade your immune system. When you have natural immunity, on the other hand, your antibodies will recognize all parts of the virus, so even if the spike protein is mutated, your body will recognize other parts of the virus and mount an attack against those.

That SARS-CoV-2 works the same way other viruses do was shown in a Nature Reviews Immunology study⁷ by Alessandro Sette and Shane Crotty, published in October 2020. The study, "Cross-Reactive Memory T Cells and Herd Immunity to SARS-CoV-2" argued that naturally-acquired immunity against SARS-CoV-2 is potent, long-lasting and very broad in scope, as you develop both antibodies and T cells that target multiple components of the virus and not just one.

If we are to depend on vaccine-induced immunity, as public health officials are urging us to do, we'll end up on a never-ending booster treadmill. Boosters will absolutely be necessary, as the shot offers such narrow protection against a single protein of the virus. Already, data around the world show vaccine-induced protection is waning rapidly in the face of new variants, and Moderna has publicly stated that the need for additional boosters is expected.⁸

How Dangerous Is the Delta Variant?

According to Dr. Anthony Fauci, the Delta variant is both more transmissible and more dangerous than the original virus and previous variants. July 4, 2021, he told NBC [News](#).⁹

"It is more effective and efficient in its ability to transmit from person to person. And studies that we've seen where they have been the variant that's dominated in other

countries, it's clear that it appears to be more lethal in the sense of more serious — allow you to get more serious disease leading to hospitalization, and in some cases leading to deaths.”

In a June 29, 2021, interview,¹⁰ Fauci called the Delta variant “a game-changer” for unvaccinated people, warning it will devastate the unvaccinated population while vaccinated individuals are protected against it.

The Delta is more contagious but it's far less deadly, far less worrisome. In fact, it's a much weaker virus than both the U.K. [Alpha] and the South African [Beta] variants. ~ Dr. Peter McCullough

Remember, Fauci is not a clinician and has never treated someone infected with SARS-CoV-2. Other health experts and practicing physicians who treat COVID-19 patients disagree with Fauci's claims, arguing that not only is the Delta variant not more dangerous, it's certainly not more dangerous for the unvaccinated.

As reported by Ingraham in June 2021 (video above), there's an evolutionary genetics theory called Muller's Ratchet, which states that as an outbreak starts to peter out, the virus tends to mutate into a more transmissible form, but at the same time it grows weaker, causing far less serious infection. According to epidemiologist and cardiologist Dr. Peter McCullough, this is exactly what we're seeing. He told Ingraham:

“The good news is on the 18th of June, the United Kingdom presented their 16th report¹¹ on the mutations — and they're doing a great job, much better than our CDC — and what they demonstrated is that the Delta is more contagious but it's far less deadly, far less worrisome. In fact, it's a much weaker virus than both the U.K. [Alpha] and the South African [Beta] variants.”

Spike Mutations Render Vaccinated Vulnerable to Delta

Importantly, the Delta variant contains three different mutations, all in the spike protein. This, McCullough explains, allows this variant to evade the immune responses in those who have received the COVID jabs — but not those who have natural immunity which, again, is much broader. In a June 30, 2021, appearance on Fox News (video above), McCullough stated:¹²

“It is very clear from the UK Technical Briefing¹³ that was published June 18th that the vaccine provides no protection against the Delta variant. It's a very mild variant.

Whether you get the vaccine or not, patients will get some very mild symptoms like a cold and they can be easily managed ... Patients who have severe symptoms or at high risk, we can use simple drug combinations at home and get them through the illness. So, there's no reason now to push vaccinations.”

Children's Health Defense chief scientific officer Brian Hooker, Ph.D., has echoed McCullough's sentiments. The Defender quotes Hooker:¹⁴

“What we’re seeing is virus evolution 101. Viruses like to survive, so killing the host (i.e. the human who is infected) defeats the purpose because killing the host kills the virus, too. For this reason, new variants of viruses that circulate widely through the population tend to become more transmissible but less pathogenic. In other words, they will spread more easily from person to person, but they will cause less damage to the host.

The vaccine focuses on the spike protein, whereas natural immunity focuses on the entire virus.

Natural immunity — with a more diverse array of antibodies and T-cell receptors — will provide better protection overall as it has more targets in which to attack the virus, whereas vaccine-derived immunity only focuses on one portion of the virus, in this case, the spike protein. Once that portion of the virus has mutated sufficiently, the vaccine no longer is effective.”

Real-World Data Show Most of Infected are Fully ‘Vaccinated’

Real-world data from areas with high COVID jab rates show the complete converse of what media, the CDC and White House officials are telling us. In addition to the British Technical Briefing No. 16,¹⁵ cited above, we have additional data from Israel, Scotland, Massachusetts and Gibraltar:

- August 1, 2021, director of Israel’s Public Health Services, Dr. Sharon Alroy-Preis, announced half of all COVID-19 infections were among the fully vaccinated.¹⁶ Signs of more serious disease among fully vaccinated are also emerging, she said, particularly in those over the age of 60.

A few days later, August 5, Dr. Kobi Haviv, director of the Herzog Hospital in Jerusalem, appeared on Channel 13 News, reporting that 95% of severely ill COVID-19 patients are fully vaccinated, and that they make up 85% to 90% of COVID-related hospitalizations overall.¹⁷ As of August 2, 2021, 66.9% of Israelis had received at least one dose of Pfizer’s injection, which is used exclusively in Israel; 62.2% had received two doses.¹⁸

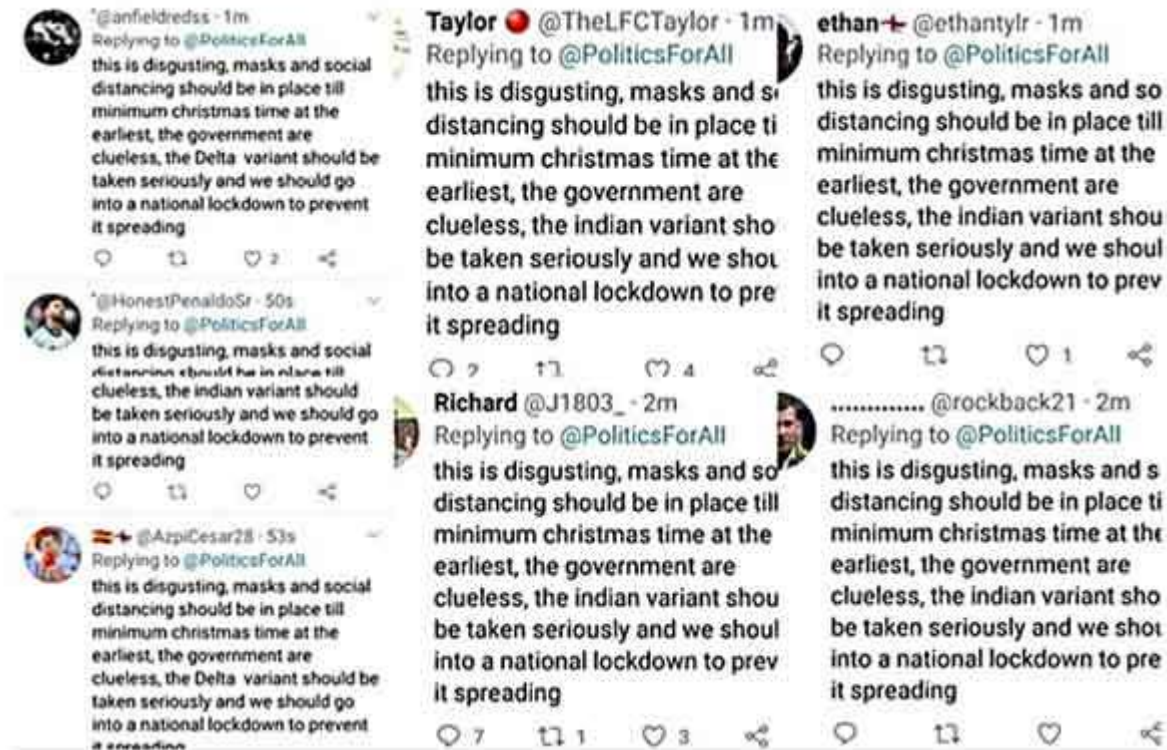

Reports of Injuries, Deaths After COVID Vaccines Climb Steadily, as FDA, CDC Sign Off on Third Shot for Immunocompromised

VAERS data released Friday by the CDC showed a total of **571,831 reports of adverse events** from all age groups following COVID vaccines, including **12,791 deaths** and **77,490 serious injuries** between Dec. 14, 2020 and Aug. 6, 2021. **[NOTE THIS REPORT SHOULD HAVE BEEN RELEASED LAST WEEK. Data released Aug. 13 by the Centers for Disease Control and Prevention (CDC) showed that between Dec. 14, 2020 and Aug. 6, 2021, a total of **571,831 total adverse events** were reported to VAERS, including **12,791 deaths** — an increase of 425 over the previous week. There were **77,490 reports of serious injuries**, including deaths, during the same time period — up 7,385 compared with the previous week.

Excluding “[foreign reports](#)” filed in VAERS, [451,049 adverse events](#), including [5,859 deaths](#) and [36,871 serious injuries](#), were reported in the U.S. Of the 5,859 U.S. deaths reported as of Aug. 6, [13% occurred](#) within 24 hours of vaccination, [19% occurred](#) within 48 hours of vaccination and [33% occurred](#) in people who experienced an onset of symptoms within 48 hours of being vaccinated.

FDA authorizes extra vaccine doses for immunocompromised patients

The U.S. Food and Drug Administration (FDA) on Aug. 12 [authorized a third dose](#) of Pfizer-BioNTech and Moderna COVID vaccines for people with [compromised immune systems](#).

The CDC also [gave final approval](#) to the third dose, following the Aug. 13 [unanimous recommendation](#) of the agency's Advisory Committee on Immunization Practices (ACIP).

As [The Defender reported](#) Aug. 13, neither vaccine has yet received full FDA approval, and [neither has completed](#) late-stage clinical trials proving a third dose will boost immunity or work against COVID variants.

The FDA's [amended](#) Emergency Use Authorization allows people who have had an organ transplant, or those with a similar level of weakened immune system, to get an extra [COVID vaccine](#) dose. The J&J vaccine was not included because there was not sufficient data on boosters, [according to the agency](#).

The FDA's decision *"allows doctors to boost immunity in certain immunocompromised individuals who need extra protection from COVID19,"* Dr. Janet Woodcock, FDA acting commissioner, [tweeted Aug. 12](#).

"Others who are fully vaccinated are adequately protected & do not need an additional dose of COVID-19 vaccine at this time," Woodcock tweeted.

The vulnerable group of patients makes up less than 3% of U.S. adults, [according to](#) CDC Director Dr. Rochelle Walensky.

Heart inflammation after COVID vaccines more common than CDC claims, new research shows U.S. public health officials claim cases of myocarditis and pericarditis following [COVID](#) vaccination are rare — but new research [published online](#) in the

Journal of American Medical Association (JAMA) shows they may happen [more often than reported](#).

Post-vaccine myocarditis and pericarditis also appear to represent two “distinct syndromes,” Dr. George Diaz, with the Providence Regional Medical Center Everett, [told Medscape Cardiology](#).

Diaz and colleagues [reviewed](#) 2,000,287 electronic medical records (EMR) of people who received at least one COVID vaccination. The records, obtained from 40 hospitals in Washington, Oregon, Montana and California, showed 20 people had vaccine-related myocarditis (1.0 per 100,000) and 37 had pericarditis (1.8 per 100,000).

A [recent CDC report](#), based on VAERS data, [suggested an incidence of myocarditis](#) of about 4.8 cases per 1 million following receipt of an mRNA COVID vaccine.

The new JAMA [study](#) showed a “*similar pattern [to the CDC study], although at higher incidence [of myocarditis and pericarditis] after vaccination, suggesting vaccine adverse event under-reporting.*”

The JAMA report also stated: “*Additionally, pericarditis may be more common than myocarditis among older patients.*”

“*Our study resulted in higher numbers of cases probably because we searched the EMR, and [also because] VAERS requires doctors to report suspected cases voluntarily,*” Diaz [told Medscape](#).

The [researchers calculated](#) the average monthly number of cases of myocarditis or pericarditis during the pre-vaccine period of January 2019 through January 2021 was 16.9 compared with 27.3 during the vaccine period of February through May 2021. The mean numbers of pericarditis cases during the same periods were 49.1 and 78.8.

The [authors said](#) limitations of their analysis include potential missed cases outside care settings and missed diagnoses of myocarditis or pericarditis, which would underestimate the incidence, as well as inaccurate EMR vaccination information.

Mom of 14-year-old who developed myocarditis after Pfizer vaccine no longer trusts public health officials.

In an [exclusive interview](#) last week with The Defender, Emily Jo said before her son, Aiden, got his first dose of Pfizer’s vaccine, she was led to believe his chance of suffering an adverse reaction was “one in a million.”

Jo said her son tires easily and his recovery will be a long process. She said all her kids are fully vaccinated and she was one of the most trusting advocates of the CDC and American Academy of Pediatrics — until her son experienced his vaccine injury.

The plan is still [subject to approval](#) from the FDA and the CDC's vaccine advisory committee, but officials say they are prepared to begin the rollout of booster shots starting the week of Sept. 20. [The FDA said Friday, they are going to approve the Pfizer Vaxx on Monday, August 23, 2021!](#)

However, the CDC has pushed back by one week a meeting by a group of outside advisers who were set to review COVID booster shots as debate heats up over the need for a third dose, [according to Bloomberg](#).

The CDC's Advisory Committee for Immunization Practices, was scheduled to meet and possibly make a recommendation about the need for boosters on Aug. 24, but is now set to convene over two days [starting Aug. 30](#).

The first boosters are likely to go to nursing home residents, healthcare workers and emergency workers, followed by older people who were near the front of the line when vaccinations began late last year and then the general population.

Federal health officials are waiting for more data before offering guidance for J&J vaccine recipients. However, officials expect a booster will also be needed.

- Peters: So they're lying to the whole world – they're trying to hide this. Kingston: Yes. Fact-checking publications are also lying.
- **Why is G.O. being used if it's a poison? Because it's a great conductor of electricity and it can host a magnetic field. So it can connect you to the internet.**

- **Who's behind this?** Shanghai Nanotechnology filed a patent for the use of graphene oxide as excipients in the vaccines. On their website, **Tal Zaks**, the Moderna CEO, was there. All studies and/or reports in the possession, custody or control of the CDC and/or the Agency for Toxic Substances and Disease Registry (ATSDR) describing the purification of any "COVID-19" virus (including B.1.1.7", "B.1.351", "P.1" and any other "variant") (via maceration, filtration and use of an ultracentrifuge; also referred to at times by some people as "isolation"), directly from a sample taken from a diseased human, where the patient sample was not first combined with any other source of genetic material (i.e. monkey kidney cells aka Vero cells; fetal bovine serum).

In a response letter dated June 7th, 2021, the CDC responded:
A search of our records failed to reveal any documents pertaining to your request. Specifically, the National Center for Immunization and Respiratory Disease apprises that CDC does not purify or isolate any COVID-19 virus in the manner the requestor describes.

The FOIA request is identified as #21-01075-FOIA.
In other words, the CDC has never isolated and purified any covid-19 virus, period.
[The website of Dr. Robert O. Young](#) reveals additional documents showing that the CDC has never isolated and purified the HPV virus, the Measles virus, the MERS virus, the Zika virus or the Polio virus, among others.

(We are working to reach out to Christine Massey to confirm the extent of her FOIA requests and invite her for an interview.)

On July 21st of this year, [the CDC announced it is withdrawing its authorization of the current PCR test for covid-19](#), saying the PCR test would no longer be considered valid science after December 31st of this year. It then states that a new PCR test will, "facilitate detection and differentiation of SARS-CoV-2 and influenza viruses," meaning the new test will reportedly be able to tell the difference between covid and the common cold. This implies that the current test — the one used to push global covid pandemic hysteria — does not achieve such a differentiation.

In effect, it appears the CDC has been fabricating the science behind global "pandemics" for decades, using the media to spread mass hysteria where no pandemic

existed. One of the best and most recent cases is the recent Zika virus, where mainstream media outlets were screaming that babies born to new mothers in Florida would be born with shrunken heads (microcephaly) because of the Zika virus. Dr. Mikovits: SARS-CoV-2 is actually a lab-made monkey cell virus, readily deployed through the flu, MMR and polio vaccine supply

Dr. Judy Mikovits was [recently interviewed on Brighteon Conversations](#), and she did not hold back unveiling the real causes of transfection behind SARS-CoV-2 and the scientific fraud that was used to promote a pandemic and suppress people’s immune systems. Dr. Mikovits was formerly a government virologist who purified and studied viruses. She created cell lines that support viral replication, to understand how they create infection in humans. She is the author of *‘Ending Plague, A Scholar’s Obligation in an Age of Corruption.’*

Dr. Mikovits confirmed that isolated, certified reference material for SARS-CoV-2 does not exist. The virus has never been isolated from human cells and was never a human virus in the first place. The SARS-CoV-2 virus can only be manufactured and replicated in the vero monkey kidney cell line, which is a group of epithelial cells extracted from African green monkeys in the 1960s. These monkey cell lines, readily contaminated with latent retroviruses, have been injected into the population since the mid-90s through the flu, MMR and polio vaccine supply, and are the only originating vector by which SARS-CoV-2 can manifest disease in humans.

Evidence points to SARS-CoV-2 being deployed through vaccine supply.

Every bio-safety level 4 lab that claimed to isolate SARS-CoV-2 from humans ultimately placed the sample in a monkey kidney cell line to “prove” its replication. This virus is not a truly isolated human virus because it could only be replicated in the monkey kidney cell line. To determine whether SARS-CoV-2 is an infectious human virus, it must be taken from the blood, sputum, or lung lavage of an infected human, but the infectious RNA of SARS-CoV-2 was never cultured in a continuously growing human cell line that supports the replication of SARS-CoV-2. Since this novel coronavirus only replicates demonstrably in vero monkey cell lines, it has never been proven to originate or spread from human-to-human, let alone spread from healthy people.

Since the current flu, MMR and polio vaccines contain these same vero monkey cell lines, the only way to deploy SARS-CoV-2 is through transfection via these needles. SARS-CoV-2 is a lab-made sequence that originates and spreads through the existing influenza vaccine supply. This could be why the Department of Defense discovered that flu vaccine recipients from 2017-2018 were [increasingly susceptible to coronavirus interference](#).

“When you take a synthetic part of a virus and you grow it in the monkey cells, you can get recombination events of all the monkey viruses, so it’s a monkey virus,” Mikovits confirmed, referring to the respiratory infections seen in covid-19. The HIV component comes from the Simian immune deficiency virus, which is also a natural monkey virus.

Mikovits confirmed that Fauci knew about, funded and acquired cell lines and genetic material from biosecurity labs in the U.S. that could be further weaponized in Wuhan. Mikovits said these virus experiments using the monkey cell line can create endless variants. *“Two amino acid changes in the envelop of the spike can change a leukemia virus to a Parkinson-causing virus,”* she said, citing her previous lab research. These sequences can be readily changed in the lab, creating endless variants of the same causative agent.

Yet, the errors of vaccine science are easily blamed on nature, which is why Dr. Anthony Fauci and everyone involved in these unethical human-virus experiments are rushing to force and mandate new vaccines onto the population, to control the narrative and cover up their crimes. If you do not learn anything that I have shared in this series, do not allow yourself to be vaxxed and do not submit to nasal swab tests or any future booster Vaxxes.

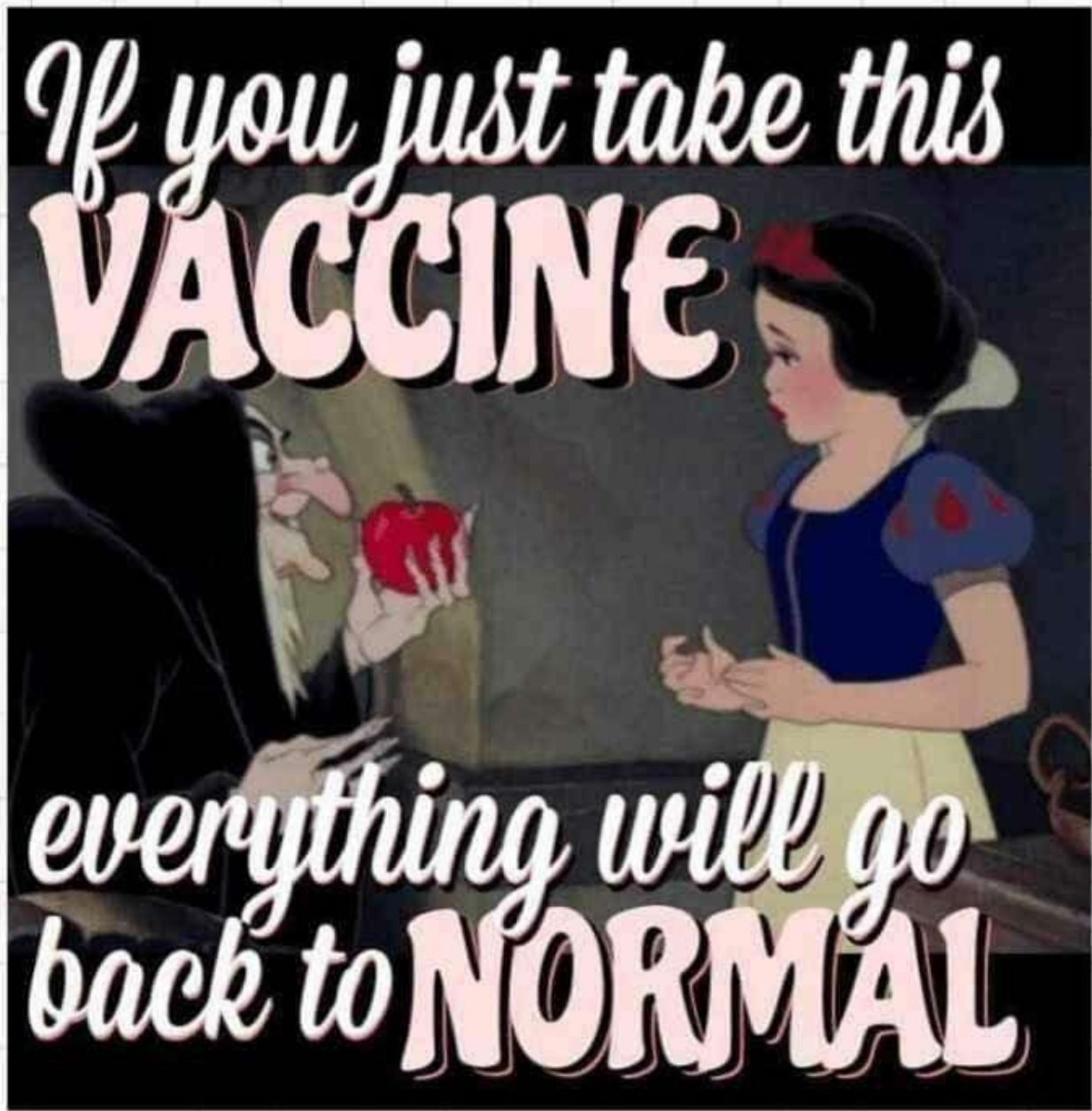
The Pfizer pharmaceutical have stated people will need booster shots every six months.
