Dr. Judy Mikovits said early on in 2020, that 55-million would die from the vaxx in five years. Those numbers were also confirmed by Dr. Luc Montagnier, the 2008 Nobel Peace Prize winner in Medicine for his discovery of the HIV virus.

Vaccine giant Pfizer pumped millions of dollars into the Food and Drug Administration (FDA), the Centers for Disease Control and Prevention (CDC) and Congress, potentially influencing the authorization and controversial quasi-approval of its COVID-19 jab.



Pfizer has been the biggest tax dodger of all Big Pharma firms. The vaccine oligarch spent over \$21.8 million in 2019–20 and \$6.7 million from January–August 2021 on lobbying the government, making it the biggest spender of any individual drug company during the COVID-19 crisis, according to Senate Office of Public Records

Pfizer's direct funding for the FDA may have also influenced the regulator's Biologics License Application (BLA) approval for the Pfizer-BioNTech Comirnaty brand COVID-19 vaccine — not widely available in the United States — and the extension of the Emergency Use Authorization (EUA) granted to the readily available Pfizer jab.

FDA Financially, Ethically Compromised

In a blatant conflict of interest, the FDA gets 45% (\$2.7 billion) of its funding from drug companies, called "*industry user fees*." What's more, "*human drugs regulatory activities*" — **lobbying** — **accounts for one-third (33%) of the FDA's budget, with 65% of this paid for by the regulated companies.** All told, more than three-quarters (78%) of the drug industry regulator's budget is bankrolled by the drug-makers it claims to regulate, rendering it what many observers call a "captured" (financially compromised) agency.

"As pharma companies underwrite three-fourths of the FDA's budget for scientific reviews, the agency is increasingly fast-tracking expensive drugs with significant side effects and unproven health benefits," [ProPublica](#) media noted.

Thirty scientists, clinicians and patient advocates signatories petitioned the FDA in June to *"delay any consideration of a 'full approval' of a COVID-19 vaccine,"* urging the regulator to *"slow down and get the science right"* as *"there is no legitimate reason to hurry."*

As pharma companies underwrite three-fourths of the FDA's budget for scientific reviews, the agency is increasingly fast-tracking expensive drugs with significant side effects and unproven health benefits.

[The Conversation](#) observed that because so much of the FDA's funding comes from drug-makers, the agency essentially tells its regulated companies how to apply for new drug approvals, greasing the skids for the approval process instead of leaving onus on the drug-makers to pass muster.

The FDA's financial entanglement with Big Pharma, it claims, makes the agency "quicker and more willing to discuss what it wants to see in an application with manufacturers."

"Most recently, the COVID-19 pandemic has seen the FDA provide emergency use authorization for potential treatments in a matter of weeks, not months," the pro-vaccine magazine noted.

According to available figures, pharma companies paid **75%** (\$905 million) of the FDA's scientific review budgets for branded and generic drugs in 2017.

"What we are seeing is a clear example of regulatory capture, which is a phenomenon that is at the heart of much of the evil at work in the world at present," Dr. Pat Morrissey said, *"Regulatory capture has compromised so much of public life that people seem unable to perceive the corrupting effect of it."*

"Another blatant example is Bill Gates' funding of the Medicines & Healthcare products Regulatory Agency (MHRA) in the United Kingdom," the sister organization to the FDA, the Irish Catholic doctor added.

In 1992, Congress passed the Prescription Drug User Fee Act, moving the FDA from a fully taxpayer-funded body to one partly funded through prescription drug user fees paid by pharma manufacturers who pay the fees when applying to the FDA for drug reviews.

The FDA is in bed with Big Pharma with no regard for patient safety. British medical ethicist Dr. Niall McCrae has stated. As a National Health Service (NHS) ethics research committee member for 11 years, I find it difficult to believe how established standards of ethical governance have been abandoned. But I have also woken up to the

facade of compliance and unscrupulous practice that predates the COVID-19 scam.

It is now clear that drug companies such as Pfizer, and the Bill & Melinda Gates Foundation, have been funding the regulatory authorities and ensuring the best commercial conditions for their global greed. Conflict of interest is not a barrier to Big Pharma; they are the *modus operandi*.

Covert Political Influence is central to Big Pharma's profit-making is shaping politics. A groundbreaking 2020 investigation by the Journal of the American Medical Association (JAMA) revealed that pharma companies spent \$4.7 billion between 1999 and 2018 — an average of \$233 million per year — lobbying federal agencies and Congress.

From 1999 to 2018, the industry also spent \$414 million on contributions to political candidates, including \$22 million to presidential candidates and \$214 million to congressional candidates — in all, over \$1.3 billion on political campaign contributions.

Pfizer was the biggest corporate spender over the period, with the vaccine oligarch accounting for \$219 million in lobbying (93% of the industry total) and \$23 million in campaign contributions (around 10% of the industry's giving to politicians).

A 2020 Oxfam report slammed Pfizer for failing to disclose how much it spent on lobbying states or trade unions. The report elaborated:

And Pfizer does not disclose its membership in tax-exempt organizations that write and endorse model legislation, such as the American Legislative Exchange Council (ALEC). Pfizer is also a major contributor to politically active social welfare organizations, yet the full list, disclosure about the amounts, and about possible misalignments, is lacking.

Transparency about drug-makers' and the federal regulators' interests in pushing vaccines to market is also woefully missing, Oxfam warned, saying, "*similar misalignment*" in their COVID-19 response "*is apparent*."

Dodging Taxes, Subverting Democracy

A 2018 Oxfam report titled "Prescription for Poverty" blasted Pfizer for "systematically" stashing its profits in overseas tax havens. Pfizer's \$199 billion held offshore was the second most of any U.S. corporation.

In seven Third World countries alone, Pfizer may have underpaid \$22 million annually in taxes. Oxfam listed the developing countries as Chile, Columbia, Ecuador, India, Pakistan, Peru, and Thailand. In First World nations, Pfizer may have underpaid taxes by \$1.1 billion.

"Perhaps even more galling than these corporations' sophisticated tax avoidance is their subversion of democratic politics," Oxfam pointed out. "They are also adept at placing their own people in powerful government posts."



Corrupting influence of Big Pharma lobbying

Pfizer and Big Pharma systematically engage in *"tax dodging, high prices and influence peddling,"* victimizing the most vulnerable while they *"funnel super profits from people living in poverty to wealthy shareholders and corporate executives,"* Oxfam's report lamented.

Despite Pfizer's dubious ethics — having been fined **\$2.3 billion** in 2009 for what was then the largest health care fraud settlement ever — the Vatican invited Pfizer CEO Dr. Albert Bourla to address its May conference *"Exploring the Mind, Body and Soul."* Vaccine start-up Moderna was one of the funders of the conference.

Pope Francis: Big Pharma Sellout

Pope Francis has repeatedly endorsed the Pfizer vaccine, receiving it (or maybe a placebo) himself without addressing the systemic injustices perpetrated by the pharma oligarch. Francis' Jesuit communities — at the forefront of social justice campaigns — have remained silent on Pfizer's crony capitalism, on the contrary, compelling community members, employees, faculty and students of Jesuit-run institutions to get the jab. Weeks ago, Pope Francis mandated all Vatican employees be vaxxed. Pfizer has likely given the pope a generous donation to the shrinking Vatican coffers, as Catholics leave the church in droves. Pope Francis remains silent on Big Pharma's injustices. The Vatican's Congregation for the Doctrine of the Faith (CDF) in a note on the morality of the abortion-tainted vaccines, urged *"a moral imperative for the pharmaceutical industry"* to ensure that vaccines are effective, safe, ethically acceptable and accessible to the poorest countries.

However, despite an increasingly close relationship with Big Pharma, the Vatican remains tight-lipped on the systemic unethical practices of the vaccine industry and its close relationship with health regulators and government.

Big Profits, Little Transparency

Pfizer expects to generate \$33.5 billion in vaccine sales in 2021. It profited to the tune of \$9.2 billion in vaccine sales in the second quarter of 2021 alone, compared to \$1.2 billion during the same period last year.

Pharmaceutical oligarchs pushing COVID-19 vaccines had disclosed only 7% of contracts with governments and published clinical trial protocols for just 12% of trials.

The FDA has a history of approving unsafe drugs. In 2005, whistleblower Dr. David J. Graham, associate director of the FDA's Office of Drug Safety, revealed the *"FDA is inherently biased in favor of the pharmaceutical industry" and views Big Pharma as "its client, whose interests it must represent and advance,"*

**Denmark will scrap ALL Covid restrictions in two weeks

Denmark's health officials will lift all of the country's Covid restrictions by September 10, as they believe the virus no longer poses 'a critical threat to society'.

More than 70 per cent of Danes are fully vaccinated and the low levels of Covid in the country led the health minister on Friday to announce that the virus is now 'under control'.

'The epidemic is under control, we have record vaccination levels. That is why, on September 10, we can lift the special rules we had to introduce in the fight against Covid-19,' Health Minister Magnus Heunicke said.

However, he stressed that 'the epidemic is not over' and said the government 'will not hesitate to act quickly if the pandemic once again threatens the essential functioning of society.'

Health officials will lift all of the country's Covid restrictions by September 10, as they believe the virus no longer poses 'a critical threat to society'

Danish Health Minister Magnus Heunicke said: 'The epidemic is under control, we have record vaccination levels. That is why, on September 10, we can lift the special rules we had to introduce in the fight against Covid-19'

Denmark was one of the first countries to introduce a partial lockdown in March 2020, and in April 2021 introduced a 'corona passport' granting holders access to businesses like restaurants, cinemas, gyms and hair salons

It has relaxed and reinforced its measures throughout the pandemic, and in April introduced a 'corona passport' granting holder's access to businesses like restaurants, cinemas, gyms and hair salons.

That requirement was already lifted in some places such as museums on August 1, and masks have not been mandatory on public transport in Denmark since August 14.

A number of further restrictions are set to end on September 1. From the start of the month, people will no longer be required to show a valid corona pass to sit in restaurants and bars, though a pass will still be required to enter nightclubs and other large events such as football matches until September 10.

The change in the classification of Covid-19 will not, however, affect rules on travel into Denmark, which are governed by a separate inter-party agreement which is due to expire in October, a spokesperson for the health ministry said.

Denmark has not seen more than five coronavirus-related deaths per day since February.

According to the official narrative, 99% of [COVID-19](#) deaths and 95% of COVID-related hospitalizations are occurring among the unvaccinated. But as [reported by](#) Fox News anchor Laura Ingraham on “The Ingraham Angle,” *“that statistic is grossly misleading,”* and in an August 5 video statement, **Walensky inadvertently revealed how that 95% to 99% statistic was created.**

Grossly misleading data manipulation

As it turns out, to achieve those statistics, the CDC included hospitalization and mortality data from January through June 2021. It does not include more recent data or data related to the [Delta variant](#), which is now the most prevalent strain in circulation. The problem is, the vast majority of the U.S. population was unvaccinated during that timeframe.

By Jan. 1, only 0.5% of the U.S. population had received a COVID shot. By mid-April, an estimated [31%](#) had received one or more shots, and as of June 15, [48.7%](#) were fully “vaccinated.” Keep in mind that you’re not “fully vaccinated” until two weeks after your second dose (in the case of [Pfizer](#) or [Moderna](#)), which is given up to six weeks after your first shot. This is [according to the CDC](#).

So, those receiving an initial dose in June, for example, won’t be “fully vaccinated” until eight weeks later, sometime in July or August.

By using statistics from a time period when the U.S. as a whole was largely unvaccinated, the CDC is now claiming we’re in a “pandemic of the unvaccinated,” in an effort to demonize those who still have not agreed to receive this experimental gene modification injection.

Selective pressure promotes emergence of new variants

Here’s what Canadian viral immunologist and vaccine researcher Dr. Byram Bridle told Ingraham about the claim that we’re in a pandemic of the unvaxxed, and that the unvaccinated are hotbeds for dangerous variants:

“Absolutely, it’s untrue to be calling this a pandemic of the unvaccinated. And it’s certainly untrue ... that the unvaccinated are somehow driving the emergence of the novel variants. This goes against every scientific principle that we understand.”

“The reality is, the nature of the vaccines we are using right now, and the way we’re rolling them out, are going to be applying selective pressure to this virus to promote the emergence of new variants. Again, this is based on sound principles.”

“We have to look no further than ... the emergence of antibiotic resistance ... The principle is this: If you have a biological entity that is prone to mutation — and the SARS-CoV-2, like all coronaviruses is prone to mutation — and you apply a narrowly focused selective pressure that is nonlethal, and you do this over a long period of time, this is the recipe for driving the emergence of novel variants.”

“This is exactly what we’re doing. Our vaccines are focused on a single protein of the virus, so the virus only has to alter one protein, and the vaccines don’t come close to providing sterilizing immunity.”

“People who are vaccinated still get infected, it only seems particularly good at blunting the disease, and what that tells you therefore is that these vaccines in the vast majority of people are applying a nonlethal pressure, narrowly focused on one protein, and the vaccine rollout is occurring over a long period of time. That’s the recipe for driving variants.”

Bridle also explains why [natural immunity](#) offers robust protection against all variants, whereas vaccine-induced immunity can’t. When you acquire the infection naturally, your body develops antibodies against ALL of the viral proteins whereas the COVID shots only trigger antibodies against one, namely the [spike protein](#).

Just 1 in 1.7 Million Children Died with Covid-19 in 18 Months, Whilst 1 in 9 Suffered Serious Adverse Reaction to the Covid-19 Vaccine in the Clinical Trial HAF August 20, 2021

The Pfizer Covid-19 injection has been given emergency use authorization to be used in children over the age of 12 in the UK by the MHRA, whilst the Joint Committee on Vaccination and Immunization (JCVI) have decided that vulnerable children over the age of 12 and all 16 and 17 year olds should be offered the Pfizer jab. If this is the case, then the MHRA and JCVI need to explain how they came to this conclusion when just 1 in every 1.7 million children have died with Covid-19 in 18

months, whilst 1 in every 9 children suffered a serious adverse reaction to the Pfizer vaccine in the small and short clinical trial which left them unable to perform daily activities.

According to official NHS data published weekly, between March 2020 and the 11th of August 2021 a total of 3,743 people have died with Covid-19 in UK hospitals who had no underlying conditions, whilst 85,410 have allegedly died with Covid-19 who had other serious underlying conditions.

These conditions include ailments such as chronic kidney disease, chronic neurological disease, chronic pulmonary disease, heart disease, and dementia, chronic kidney disease, chronic neurological disease, chronic pulmonary disease, heart disease, and dementia.

However, the vast majority of these deaths have occurred in people over the age of 80, and people between the age of 60 and 79; the vast majority of which are closer to the age of 79.

Whilst the people who have died with Covid-19 since March 2020, between the ages of 0 and 19, who had no other known underlying conditions stands at just 9.

NHS of people who have died with Covid-19 there are approximately 15.6 million people aged 19 and under in the United Kingdom which means just 1 in every 410,526 children and teenagers have allegedly died with Covid-19 in 18 months, who had other serious pre-existing conditions.

Whilst just 1 in every 1.7 million children have allegedly with Covid-19 in 18 months, who had no know pre-existing conditions.

Every death is of course a tragedy, especially when it is somebody so young, but we need to put these numbers into context now that an experimental injection is going to be given to children in the United Kingdom in the name of protecting them from Covid-19.

During the clinical trial to test the efficacy and safety of the Pfizer Covid-19 vaccine in children aged 12 and over, 1,127 children were given one dose of the mRNA jab, but only 1,097 children received the second dose. This fact in itself raises questions as to why 30 children did not receive a second dose of the Pfizer jab.

Of the 1,127 children who received a first dose of the jab a shocking 86% experienced an adverse reaction. Of the 1,097 children who received a second dose of the jab a shocking 78.9% experienced an adverse reaction.

78.9% experienced an adverse reaction. Of course these adverse reactions include things such as a sore arm, so therefore it is vital to know the rate of serious adverse reactions that occurred during the limited clinical trial.

For children 12 to 15 years of age, the Pfizer COVID-19 vaccine clinical trial found the overall incidence of severe adverse events which left them unable to perform daily activities, during the two-month observation period to be 10.7%, or 1 in 9, in the vaccinated group and 1.9% in the unvaccinated group, resulting in a vaccine risk of 8.8% or 1 in 11 vaccinated children.

Consequently, children who received the vaccine had nearly six times the risk of a severe adverse event occurring in the two-month observation period compared to children who did not receive the vaccine.

In addition, the incidence of Covid-19 in the unvaccinated group was 1.6%, therefore, there were almost seven times more severe adverse events observed in the vaccinated group than there were Covid-19 cases in the unvaccinated group.

In Italy the Vaxx is no longer legally approved for use

In Italy, like in many nations the Covid-19 experimental serums were put into use under extraordinary authorization. That authorization has just expired, making the Vaxx passport a dead letter.

The authorization was allowed in an extraordinary manner because it was alleged there were no other cures, and no other cures were approved.

In the European Union, there exist two forms of extraordinary authorization: Conditional Approval to Commercially Distribute, and Emergency Authorization.

Emergency Authorization does not include permission for commercial distribution and requires each Member State of the EU to take legal responsibility. For that reason, the EU members opted for Conditional Approval.

Under conditional approval, [a vaccine must meet a unmet need](#), that is, it can only be requested for such approval if there are no other approved cures.

That Conditional Approval for Commercial use authorization has expired, in law, with the official recognition by AIFA, the Italian Pharmaceutical Approval Agency, of the use of other monoclonal anti-bodies as an effective cure for SarsCov19 infection.

Vaccines of any kind [cannot be commercially employed in Italy](#) without AIFA's authorization.

AIFA has approved only 2 mRNA vaccines: [Pfizer and Moderna](#).

And only 2 Viral Vector vaccines: [AstraZeneca and Johnson and Johnson](#).

The announcement appeared recently on their website, but it took effect on August 7, 2021.



America took a giant step Monday toward extinguishing what's left of freedom and setting up a bifurcated society in which at least a third of its population gets treated as second-class citizens unfit for employment, buying or selling.



The U.S. government crossed another hurdle in its determination to use Covid as an excuse to snuff out equality and even the pretense of individual freedom when the U.S. Food and Drug Administration granted its full approval Monday to the Pfizer so-called “vaccine.” **Several health sites quickly spotted a huge lie in the FDA letter authorizing something that will not be available to the public for three more years. The FDA did a slick sleight of hand. They did give approval to a vaccine that will not be available until 2024. The fine-print detail of the FDA letter was highly misleading and they only authorized the continued use of the EUA or Emergency Use Application. There is no new vaccine until three more years in to the future. The media did not report the full details of the FDA letter. The FDA again lied to deceive the public into taking a flawed vaxx.**

And now one of Pfizer’s own board members is bragging that businesses will “fall in line” and mandate his company’s pharmaceutical injection.

Scott Gottlieb, a former FDA commissioner who now sits on the Pfizer board, appeared Monday, August 23, [on Squawk Box](#) to talk about the FDA approval for the Pfizer jab just minutes before the announcement was made.

Gottlieb predicted the businesses would “fall in line” now and start to broadly mandate the Pfizer shot.

“But I don’t think there’s going to be a rush of people who have been waiting for this binary moment in time who now are going to go out to CVS and Walgreens because it’s been FDA approved.”

“With respect to businesses, I have talked to a lot of businesses that have said that they don’t feel comfortable mandating the vaccine until it gains full approval, that they feel they’ll be on stronger legal ground to mandate the vaccine,” Gottlieb said. “So I would expect a lot of businesses now to fall in line in terms of mandates.”

This injection has already killed and seriously injured tens of thousands, according to the government’s own database, the Vaccine Adverse Event Reporting System or VAERS. Along with the shots from Moderna and Johnson & Johnson, the three vaccines have killed more people, more than 12,000 at last count, than all other vaccines combined since the government set up its VAERS reporting system in 1990. And yet, wearing this grotesque safety record as a badge of honor, Pfizer gets its serum approved in record time by the FDA.

FDA ‘playing bait and switch’ with Americans, tricking them into believing shots currently being offered have been granted full approval when they have not

The U.S. Food and Drug Administration's announcement Monday that it had granted “full approval” to the Covid shots being offered by Pfizer is riddled with deceptions

meant to trick the American public into thinking they have no choice but to take the jab while at the same time protecting a major pharmaceutical company from legal liability.

What was actually given full approval was a separate Pfizer-BioNtech vaccine product which goes by the name *Comirnaty*.

But *Comirnaty* is not even currently available in the U.S.

This is part of a cynical plot to protect Pfizer from broad legal liability and also to snooker U.S. employers into mandating the vaccine for their employees.

Watch Dr. Robert Malone, inventor of the mRNA technology on which the Covid vaccines are based, explain the chicanery the FDA is using to fool the American people. The FDA on Monday [approved](#) a [biologics license application](#) for the Pfizer Comirnaty vaccine. The Biden White House, with cover from its corporate media skills, immediately [reported](#) that [vaccine mandates](#) are now legal for military, healthcare workers, college students and employees of just about any business.

But as [Children's Health Defense reports](#), *"there are several bizarre aspects to the FDA approval that will prove confusing to those not familiar with the pervasiveness of the FDA's regulatory capture, or the depths of the agency's cynicism."*

The FDA acknowledges that while [Pfizer](#) has insufficient supplies of the newly licensed Comirnaty vaccine actually available, there is "a significant amount" of the Pfizer-BioNTech COVID vaccine — which has been produced under [Emergency Use Authorization](#) (EUA) and will continue to be offered under the same EUA status, CHD reports.

The FDA [in its convoluted letter of approval](#) for the Pfizer vaccine under the EUA should remain unlicensed but can be used "interchangeably" ([page 2, footnote 8](#)) with the newly licensed Comirnaty product [which is currently unavailable].

According to the FDA, the newly licensed Pfizer Comirnaty vaccine and the existing vaccine, while "legally distinct," are not any different in terms of their "impact safety or effectiveness."

The below analysis by [Children's Health Defense](#) explains the trickery in which the FDA has engaged — all for the legal benefit of the Big Pharma giant Pfizer and the detriment of American citizens.

There is a huge real-world difference between products under an EUA compared with those that FDA has fully licensed. EUA products are [experimental](#) under U.S law.

Both the [Nuremberg Code](#) and Federal Regulations provide that no one can force a human being to participate in this experiment. Under [21 U.S. Code Sec.360bbb-3\(e\)\(1\)\(A\)\(ii\)\(III\)](#), "authorization for medical products for use in emergencies," it is

unlawful to deny someone a job or an education because they refuse to be an experimental subject. Instead, potential recipients have an absolute right to refuse EUA vaccines.

U.S. laws, however, permit employers and schools to require students and workers to take licensed vaccines.

EUA-licensed vaccines have an extraordinary liability shield under the [2005 Public Readiness and Preparedness Act](#). Vaccine manufacturers, distributors, providers and government planners are immune from liability. The only way an injured party can sue is if he or she can prove willful misconduct, and if the U.S. government has also brought an enforcement action against the party for willful misconduct. No such lawsuit has ever succeeded.

The government has created an extremely stingy compensation program, the [Countermeasures Injury Compensation Program](#), to redress injuries from all EUA products.

The program's parsimonious administrators have compensated [under 4% of petitioners](#) to date — and not a single COVID vaccine injury — despite the fact that physicians, families and injured vaccine recipients have reported more than [600,000 COVID vaccine injuries](#).

At least for the moment, the Pfizer Comirnaty vaccine has no liability shield. Vials of the branded product, which say “Comirnaty” on the label, are subject to the same product liability laws as other U.S. products.

When the Centers for Disease Control and Prevention's (CDC) Advisory Committee for Immunization Practices places a vaccine on the mandatory schedule, a childhood vaccine benefits from an generous retinue of liability protections.

But licensed adult vaccines, including the new Comirnaty, do not enjoy any liability shield. Just as with Ford's exploding Pinto, or [Monsanto's herbicide Roundup](#), people injured by the Comirnaty vaccine could potentially sue for damages.

And because adults injured by the vaccine will be able to show that the manufacturer knew of the problems with the product, jury awards could be astronomical.

Pfizer is therefore unlikely to allow any American to take a Comirnaty vaccine until it can somehow arrange immunity for this product.

Given this background, the FDA's acknowledgement in its approval letter that there are insufficient stocks of the licensed Comirnaty, but an abundant supply of the EUA Pfizer BioNTech jab, exposes the “approval” as a cynical scheme to encourage businesses and schools to impose illegal jab mandates.

The FDA's clear motivation is to enable Pfizer to quickly unload inventories of a vaccine that science and the [Vaccine Adverse Events Reporting System](#) have exposed as unreasonably dangerous, and that the [Delta variant](#) has rendered obsolete.

Americans, told that the Pfizer COVID vaccine is now licensed, will understandably assume that COVID vaccine mandates are lawful. But only EUA-authorized vaccines, for which no one has any real liability, will be available during the next few weeks when many school mandate deadlines occur.

The FDA appears to be purposefully tricking American citizens into giving up their right to refuse an experimental product.

While the media has trumpeted that the FDA has approved COVID vaccines, the FDA has not approved the Pfizer BioNTech vaccines, nor any COVID vaccines for the 12- to 15-year age group, nor any [booster doses](#) for anyone.

And FDA has not licensed any [Moderna](#) vaccine, nor any vaccine from [Johnson & Johnson](#) — so the vast majority of vaccines available in the U.S., if not all, remain unlicensed EUA products.

Here's what you need to know when somebody orders you to get the vaccine:; Ask to see the vial. If it says "Comirnaty," it's a licensed product. If it says "Pfizer-BioNTech," it's an experimental product, and under [21 U.S. Code 360bbb](#), you have the right to refuse.

If it comes from Moderna or Johnson & Johnson (marketed as Janssen), you have the right to refuse.


The FDA is playing bait and switch with the American public — but we don't have to play along. If it doesn't say Comirnaty, you have not been offered an approved vaccine.



WHO Warns That New Covid Variant Called ‘Mu’ May Be More Vaccine Resistant

B.1.621 better known as Mu, was first identified in Colombia in January and outbreaks of cases have been recorded in South America and Europe.

[The WHO has designated Mu a variant of interest](#) and say they are closely monitoring the strain.

In July this year Public Health England (PHE) also declared that they had the Mu variant under investigation.

[The Hindu](#) reports: The cases of the Mu variant have also been reported in the U.K., Europe, the U.S. and Hong Kong. 22,082.

The new 'variant of interest' is being closely monitored, the U.N. health agency said.

Although the global prevalence of the Mu variant among sequenced COVID-19 cases is currently below 0.1%, its prevalence in Colombia (39%) and Ecuador (13%) has consistently increased, it said.

The new variant was added to the WHO's watchlist on August 30 after it was detected in 39 countries and found to possess a "*constellation of mutations that indicate potential properties of immune escape,*" it said.

Reports on the variant's prevalence should be "*interpreted with due consideration*" given the low sequencing capacity of most countries, the U.N. agency said.

Mu is the fifth variant of interest to be monitored by the WHO since March. It has a number of mutations that suggest it could be more resistant to vaccines, the WHO warned, but said that further research would be needed to confirm this.

The preliminary data shows it may evade immune defences in a similar way to the Beta variant first discovered in South Africa, the UN agency said, adding that this needs to be confirmed by further work.

“More studies are required to understand the phenotypic and clinical characteristics of this variant,” it said, adding that the epidemiology of the Mu variant in South America, particularly with the co-circulation of the Delta variant, will be monitored for changes.

As of August 29, over 4,500 sequences (3,794 B.1.621 sequences and 856 B.1.621.1 sequences), genome sequences, analysed samples of the virus taken from patients, have been designated as Mu in the past four weeks. The sequences are used to track how it moves through the population, on an open-source genome repository, known as GISAID.

Most of these have been reported in the U.S (2,065) and Colombia (852), Mexico (357) and Spain (473).

Meanwhile, South African scientists are closely monitoring the development of another new variant there.

This report from the WHO is another example of fear-porn. The so-called sequences noted are nothing more than mumbo jumbo nonsense. There are thousands of viruses and have been for centuries. For the period of February 1 through August 2, there were COVID Delta variant cases for 47,000 people who had received 2 vaccine doses, and for 151,054 people who were unvaccinated.

In the first group of vaccinated people, there were a total of 402 deaths, and in the second much larger group of unvaccinated people, there were 253 deaths. To get the death rate you divide the number of deaths by the total number of infection cases.

That gives a death rate of .86 percent among the vaccinated and .17 percent among the unvaccinated. That is an amazing difference. The death rate among vaccinated was just over five times greater than that for the unvaccinated.

In other words, unvaccinated people who got infected were enormously safer from death. How can we explain this huge difference in terms of medical science? It should also be noted that it was determined that the measured viral load in both groups was the same.

So, why are vaccinated people dying more frequently than the unvaccinated? Here are some plausible explanations.

First, there is something very dangerous and unsafe in the COVID vaccines associated with spike proteins that are causing people to die at a higher rate. For example, as discussed [elsewhere](#), all current vaccines have been associated with serious blood problems, notably both large and microscopic blood clots. Many people have died from brain bleeds and strokes, for example.

There are also many, many other types of adverse side effects causing a host of medical problems. Two famous virologists [warned](#) against using the current vaccines because they are fundamentally unsafe and could be killing people. They loudly proclaimed that the mass vaccination program should be halted. Instead, they advocated the use of treatments using generic medicines like ivermectin, and herbal medicine.

Second, it is reasonable to believe that most unvaccinated people have acquired natural immunity from some prior COVID infection. And that natural immunity is far [more protective](#) than the artificial or vaccine immunity obtained from jabs. Yet the US, like many other countries, does not give credit for natural immunity on a

par with vaccine immunity when it comes to COVID passports and mandates. Very few nations do the right thing by honestly following the science.

Third, vaccinated people are susceptible to breakthrough infections, which means that they are not protected against infection after they have been originally infected. Phony and dangerous COVID vaccines do not destroy the virus, nor prevent transmitting it to others.

Conclusion

The new data from England involving very large numbers of people should be headline news. But the biased and dishonest big media suppress this kind of critical data. Why? Clearly, if vaccinated people die at a much higher rate than unvaccinated people, then why should people be enthusiastic about being vaccinated? They should not. This is especially true for the millions of people who have [natural immunity](#).

Senior FDA leaders resign amid furor over COVID-19 booster shots, proving vaccine decisions are all about politics, not science

But even as that debate rages and additional studies show that the best immunity from COVID is natural immunity after actually getting the disease and recovering from it — like 99.5 percent of people have — now, suddenly, talk of *COVID boosters* has come up.

In recent days, the man who's been most wrong about the coronavirus and who reportedly helped fund its development, "Dr." Tony Fauci, said he's "certain" that Americans are going to need booster vaccines.

"I'm certain we're going to need that third dose, looking at the data that we're seeing," the White House chief medical advisor [told NBC's "Meet the Press."](#)

"Right now, we're sticking with eight [months] but we're totally open to any variation in that based on the data," Fauci said.

"I believe that mandating vaccines for children to appear in school is a good idea," Fauci would later [say on CNN](#). *"We've done this for decades and decades, requiring polio, measles, mumps, rubella, hepatitis. So this would not be something new."*

Well, sure, but those vaccines weren't 10 minutes out of being experimental.

Obviously, not everyone agrees with the world's most incorrect man on COVID-19, and that could include a pair of formerly high-ranking officials at the Food and Drug Administration, the agency that is supposedly in charge of approving (or disapproving) booster vaccines.

Two of the FDA's most senior vaccine leaders are exiting from their positions, raising fresh questions about the Biden administration and the way that it's sidelined the FDA.

Marion Gruber, director of the FDA's Office of Vaccines Research & Review and 32-year veteran of the agency, will leave at the end of October, and OVRD deputy director Phil Krause, who's been at FDA for more than a decade, will leave in November. The news, first reported by BioCentury, is a massive blow to confidence in the agency's ability to regulate vaccines.

The announcement, which is fairly earth-shattering, comes as the agency weighs whether or not to approve COVID boosters and shots for younger children. In addition, they leave as the Biden regime has announced that [the booster shots](#) may actually be 'ready' for roll-out later this month, even though the FDA has yet to give its approval.

"FDA is losing two giants who helped bring us many safe and effective vaccines over decades of public service," FDA's former acting chief scientist Luciana Borio noted on Twitter.

There are a number of factors that led to the departure of Krause and Gruber, but the overarching reason, according to sources who spoke to Endpoints, was Fauci and the regime coming out early and saying boosters are happening. They believe those decisions are strictly in the wheelhouse of their former agency.

"These two are the leaders for Biologic (vaccine) review in the US. They have a great team, but these two are the true leaders of CBER. A huge global loss if they both leave," Former BARDA director Rick Bright noted regarding news of the departures. *"Dr. Gruber is much more than the Director. She is a global leader. 


In the report we read the following interesting paragraph:

It was recently announced by the ‘*Wall Street Journal*’ and other outlets that Israeli officials no longer consider someone fully vaxxed if they have only received the initial two doses of the injection – instead, fully vaxxed people must have received the third booster shot, too!

Health freedom advocates raise legitimate concerns over this news: how many jobs must people take in order to comply with mandates and live freely in society? Where and when will it end? And are there examples here in the United States of officials [changing definitions](#) in order to fit their pandemic narrative and push the jab?

CDC misleads the public by claiming unjabbed people nearly 30 times more likely to be hospitalized with COVID than people who get the COVID shot – but just wait until you see how they define “unjabbed”

A recent study from the U.S. Centers for Disease Control and Prevention (CDC) looking at pandemic data from Los Angeles County concluded that people who have not received the COVID injection are 5 times as likely to become infected with SARS-CoV-2 and 29 times as likely to be hospitalized, compared to individuals who have gotten the jab.

However, you’ll notice when reading [the study](#) that unvaxxed people are defined as anyone who is within 2 weeks of their first dose of a COVID injection. Here’s why people are calling this definition misleading:

If someone gets a COVID shot, then shortly thereafter tests positive for COVID-19 and ends up in the hospital or dies within two weeks of getting their injection, they are counted as an “unvaccinated” case.

Do NOT ignore the health dangers linked to toxic indoor air. These chemicals - the 'off-gassing' of paints, mattresses, carpets and other home/office building materials - increase your risk of nasal congestion, fatigue, poor sleep, skin issues plus many other health issues.

Would such a death be reported to Vaccine Adverse Event Reporting System ([VAERS](#))? Would there be any way to tell whether a person actually died of complications related to COVID-19 instead of complications from the injection itself?

The CDC's definition of unjabbed people is misleading and is being used to support further COVID shot mandates, passports, and [booster shots](#). It also fails to capture the true number of deaths or serious injuries caused by the COVID shots.

To add more context to this story: Natural immunity shown to be much more effective than immunity from injection, a recent article published in the *Science* magazine dropped some astounding news:

Research now suggests having natural immunity to SARS-CoV-2, the so-called virus that can cause COVID-19, is MORE effective than immunity garnered from an injection. In fact, according to the data cited – which comes from a large Israeli study – people who are unjabbed and had been previously infected with SARS-CoV-2 were up to 13 times LESS likely to get infected with the Delta variant compared to vaxxed people who never got COVID-19.

To be clear, the conventional science admits: unjabbed, previously-infected people were also up to 13 times less likely than jabbed individuals to develop symptoms or require hospitalization in the rare case they did test positive COVID-19.

In other words, contracting the virus and then recovering from it – which will happen for at least 99.8% of people who test positive for COVID, despite the fear-based messaging you hear in the news – seems to be more beneficial for protecting you against the novel coronavirus than lining up for one, two, and eventually three injections.

Does this mean you should go out and try to get COVID-19? Of course not! But, the evidence continues to call into question the utility and efficacy of these shots as a way to protect your health.
