**CDC: 1,739 DEAD 38,444 Injuries
Following Experimental COVID-19 mRNA 'Vaccines'**

CDC Ignores Inquiry Into Increasing Number of Deaths, Injuries Reported After COVID Vaccines

VAERS data released today showed 38,444 reports of adverse events following COVID vaccines, including 1,739 deaths and 6,286 serious injuries since Dec. 14, 2020.



Data released today by the Centers for Disease Control and Prevention (CDC) on the number of injuries and deaths reported to the [Vaccine Adverse Event Reporting System \(VAERS\)](#) following [COVID vaccines](#) showed [38,444 reports of adverse events](#) since Dec. 14, 2020.

On March 8, [The Defender](#) contacted the CDC with questions about how the agency is investigating reports of deaths and injuries after COVID vaccines. We provided a written list of questions asking the status of investigations on deaths reported in the media, if autopsies are being done, the standard for determining whether an injury is causally connected to a vaccine and the known issues with VAERS — namely whether healthcare providers are reporting all injuries and deaths that might be connected to the

COVID vaccine, and what education initiatives are in place to encourage and facilitate proper and accurate reporting. We asked for a reply within two days.

As of today, 11 days later, the CDC has not answered our questions. Instead, when we call them, they respond saying, “they have received our email, they will escalate it and it is in the system.” When we asked if we could speak with the person reviewing the email, we were told that information could not be provided. When we emailed them to follow up, we received no response.

Every Friday, [VAERS](#) makes public all vaccine injury reports received by the system as of Friday of the previous week. The 34,444 adverse events reported between Dec. 14, 2020, and March 11 includes [1,739 deaths](#) and [6,286 serious injuries](#).

† Because some cases have multiple vaccinations and symptoms, a single case can account for multiple entries in this table. This is the reason why the Total Count is greater than 38444 (the number of cases found), and the Total Percentage is greater than 100.

This week’s data included reports of [478 cases of Bell’s Palsy](#). Of those, 66% of cases were reported after [Pfizer-BioNTech](#) vaccinations — almost [twice as many](#) as reported (36%) following vaccination with the Moderna vaccine.

The first [Johnson & Johnson](#) (J&J) COVID vaccine [was administered](#) in the U.S. on March 2. As of March 11, [nine anaphylactic reactions](#) associated with J&J’s vaccine had been reported to VAERS. As [The Defender reported](#) earlier this month, the J&J vaccine contains [polysorbate 80](#), known to trigger allergic reactions, The [Moderna](#) and [Pfizer](#) vaccines contain [polyethylene glycol](#) (PEG), also known to trigger anaphylactic reactions.

In the U.S., [98.2 million](#) COVID vaccine doses had been administered as of March 11.

VAERS is the primary mechanism for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

For the most part, today's data reflect trends that have emerged since [The Defender](#) first began tracking VAERS reports related to [COVID vaccines](#).

This week's VAERS data show:

- Of the [1,739 deaths](#) reported as of March 11, 30% occurred within 48 hours of vaccination, 21% occurred within 24 hours, and 46% occurred in people who became ill within 48 hours of being vaccinated. By comparison, during the same period, there were only [85 deaths](#) reported following flu vaccines.
- Nineteen percent of deaths were related to cardiac disorders.
- Fifty-three percent of those who died were male, 44% were female and the remaining death reports did not include gender of the deceased.
- The [average age](#) of those who died was **77.9** and the youngest death was an 18-year-old.
- As of March 11, [289 pregnant women](#) had reported adverse events related to COVID vaccines, including 90 reports of [miscarriage or premature birth](#). None of the COVID vaccines approved for [Emergency Use Authorization](#) has been confirmed safe or effective for pregnant women, although [J&J said](#) earlier this month it would begin testing on pregnant women, infants and the immunocompromised.
- There were [1,689 reports of anaphylaxis](#), with 59% of cases attributed to the [Pfizer-BioNTech](#) vaccine and 41% to [Moderna](#).

The average age of death reported remains **77.9**, however the youngest reported death this week dropped from 23 to 18. [According to VAERS](#), the teenager developed fatigue, body aches and a headache one day after receiving the Moderna vaccine on March 3. On March 5 he complained of chest pain, and died in his sleep later that day.

The latest data also includes [the report](#) of a 22-year-old woman with a "significant, lifelong underlying medical condition" who died 24 days after the vaccine.

According to the [CDC's website](#), "the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated."

To date, the only information the CDC has published related to the investigation of COVID vaccine-related deaths and how those investigations were conducted is a [COVID-19 Vaccine Safety Update](#) via the Advisory Committee on Immunization Practices (ACIP) published on Jan. 27.

The safety update analyzed only the 198 reported deaths that occurred within the first month after the first COVID vaccine was administered in the U.S. It is unknown whether the CDC has investigated any of the 1,541 reported deaths since or, if investigations were conducted, what the results showed.

On March 16, [The Defender reported](#) that more than 20 countries suspended use of [AstraZeneca's](#) COVID vaccine after reports of blood clots, some resulting in death, in healthy people who received the vaccine. The World Health Organization (WHO) [said](#) an ongoing analysis by its vaccines advisory committee had not established a causal link between the vaccine and blood clots and that countries should keep using it.

On March 18, the European Medicine Agency (EMA) [released the results](#) of its investigation into the AstraZeneca vaccine. The EMA [said Thursday](#) the vaccine “may be associated with very rare cases of blood clots,” but the agency still considers it to be “safe and effective” and countries should continue to use it.

The EMA determined AstraZeneca's vaccine was not associated with an “overall risk” of blood clots in those vaccinated and there was no evidence of a problem related to specific batches of the vaccine or manufacturing sites, [The Defender reported](#).

[According to Reuters](#), about a dozen countries resumed use of AstraZeneca's COVID vaccine today, including Germany, Indonesia and France as EU and British regulators said the benefits outweighed any risks of potential blood clots. AstraZeneca's vaccine is not yet approved for emergency use in the U.S.

On March 18, [The Defender reported](#) Pfizer's chief financial officer told analysts and investors during a recent earnings call that the company plans to turn its COVID vaccine with German company BioNTech into an even bigger cash cow once the pandemic ends.

Pfizer's vaccine is already the second-highest revenue-generating drug in the world. The vaccine maker expects revenues of \$15 billion in 2021 based on current contracts for its [COVID vaccine](#), but that number could double as Pfizer says it can potentially deliver 2 billion doses this year.

Leaked documents obtained as a result of a cyberattack on the EMA and reviewed by [The BMJ](#) revealed regulators had major concerns over unexpectedly low quantities of intact [mRNA](#) in batches of the Pfizer's COVID vaccine developed for commercial production, [as reported this week by The Defender](#).

A leaked email identified “a significant difference in % RNA integrity/truncated species” between the clinical batches and proposed commercial batches — from around 78% to 55%. Pfizer was not manufacturing vaccines to the specifications expected, and the impact of this loss of RNA integrity on safety and efficacy of the vaccine was not identified, according to the email. The EMA responded by filing two “major objections”

with Pfizer, along with a host of other questions it wanted addressed. It's unclear if the agency's concerns were satisfied.

Mycoplasma is so small that it goes undetected and most labs are unaware of its existence until after World War II when the U.S. military classified it top secret and began using it against Iraqi soldiers in the Gulf War. Scientists believe it was the cause of what has been called the Gulf War Syndrome. Dr. Garth Nichols conducted the official study of the GWS, and concluded it was Mycoplasma that was the cause. The military have denied it as it would be liable for damages to our veterans who came home and died prematurely.

I have written five articles on Mycoplasma and how it attacks the body as well as ways to keep it in check, there is no cure, and if not treated results in death. The pharmaceutical industry has a terrible record for fraud and corruption, and this includes the CDC, NIH, FDA, and the public health services. They are protected from being sued by legislation signed into law during the Reagan administration.

Activation of Mycoplasma can be induced through 5G Electroporation. It can be remotely activated, intentionally or unintentionally. It is only visible under 50,000X magnification power of an Electron-Microscope. The wireless energy operates at a band width considered to be in the millimeter range. If anyone is in a work environment using 5G beyond the 7-GHz level, they are in danger of radiation poisoning. This is because Mycoplasma is monitoring four indicators of the human body. These include:

- Blood oxygen level
- pH balance
- immune system
- stress factors

The most recent segment on Mycoplasma is Part 5, posted February 17, 2021. This past year, during the lock down imposed, the telecommunications industry were exempt and worked six days a week installing 5G antennas, base stations, sub-stations, and have been pummeling residential customers with their super-fast download Wi-Fi. I get three or four advertisements a month from AT&T, T-Mobile, and Dish Network, along with two other not so familiar names in Kentucky.

Elon Musk has in orbit 1,261 satellites. Each of his SpaceX Starlink launches carries around 30 of the small satellite. So far, the company has launched 1,325 Starlink satellites, although 64 of these have reentered the Earth's atmosphere leaving 1,261 in orbit. SpaceX now owns around one-third of all the active satellites in orbit above the Earth. Each satellite weighs around 570 pounds, according to the company.

The telecommunications industry expects to have close to 50,000 satellites in LEO or low earth orbit and MEO – mid earth orbit, by 2025. Unfortunately, the public is oblivious to what this means for human life. By 2025 or sooner the Earth will be bathed in 5G EMF toxic wireless energy. Most of the band width being auctioned off around the world is in the 3-5-GHz range, deliberately to minimize health issues related to Wi-Fi health issues. Health issues will still continue from 3G and 4G wireless, but more difficult to prove as causal sickness related.



Company Who Knew Asbestos Was in Its Baby Powder Now Distributing COVID-19 Vaccine

After Pfizer/BioNTech and Moderna, Johnson & Johnson became the third vaccine to be authorized for distribution in the United States. After its approval, [controversy](#) quickly arose as the US Conference of Catholic Bishops, and other dioceses from across the country released statements expressing “moral concerns” over the shot due to its use of lab-grown cells that descend from cells taken in the 1980s from the tissue of aborted fetuses. While fetal tissue may be a legitimate concern for many, it is fairly common in plenty of other vaccines. And Johnson & Johnson has given us far greater reasons to be skeptical of their products.

Johnson & Johnson [knew for decades](#) their baby powder was tainted with carcinogenic asbestos and they kept that information from regulators and the public. A government-funded study from the mid-1990s found that Johnson’s baby powder caused cancer in rats and other studies have found an increased risk of cancer in women who used their talc-based products. The potential risks have been known to the company for decades.

What’s more, in 2018, the pharma giant [was ordered](#) to pay \$4.7 billion to thousands of victims who reportedly developed cancer from using Johnson & Johnson’s products. In that case, 22 women alleged the company’s talc-based products, including its baby powder, contained the known carcinogen, asbestos, which caused them to develop cancer. According to reports, there are over 9,000 similar talc lawsuits against the company.

Currently faced with [several major lawsuits for fueling the opioid crisis in the United States](#), Johnson & Johnson also has a [history of bribing doctors and government officials](#). Even more disturbing still, a [Reuters investigation found that J&J knowingly sold a baby powder product that they knew had asbestos in it](#), which causes mesothelioma.

One example is Alabama resident Jacqueline Salter Fox who filed a lawsuit prior to her death in October 2015. Her complaint was part of a broader claim in Missouri, which involved nearly 60 people. This subsequently led to a torrent of lawsuits against the company resulting in billions in settlements.

Following Fox's death at the age of 62, her son took over as a plaintiff in the case. Fox's family received \$10 million in actual damages and \$62 million in punitive damages in 2016.

In her suit, Fox said she had used Baby Powder and Shower to Shower for feminine hygiene for more than 35 years before being diagnosed with ovarian cancer in 2012. Her attorneys argued that Fox's terminal ovarian cancer was directly caused by the talc inside the personal hygiene products.

They also claimed that the company had known about the risk of cancer for decades, but failed to warn customers in a race for profit.

Speaking at the hearing on February 16, 2016, Allen Smith, an attorney for the family, argued that the company "valued profits over human life".

"Johnson & Johnson was aware of every one of these studies going back 30 to 40 years," Smith said, referring to a mid-1990's government study that revealed that talc caused cancer in rats."

Their alleged corruption doesn't end in the baby powder realm either. In 2018, a lawsuit was filed on behalf of members of the American military who were injured or killed in attacks from 2005 to 2009. The lawsuit alleged that Johnson & Johnson as well as the other vaccine manufacturers Pfizer and Astrazeneca [funded terrorism in Iraq](#).

According to a report in the NY Times, the Justice Department subsequently launched an investigation over the claims that these major drug and medical device companies doing business in Iraq **knew that the free medicines and supplies they gave the government to win business there would be used to underwrite terrorist attacks on American troops.**

To be clear, no one here is claiming that the vaccine will hurt massive amounts of people or that it will not be beneficial in stopping the virus. However, by the very definition of the phrase, "long term effects" the literal long term effects of the vaccine are completely unknown. Nevertheless, under pressure from citizens, industry insiders, and

the media, governments around the world have developed methods to “fast track” and “warp speed” the approval of these vaccines.

The process has been so fast that even those working on the front lines of the pandemic are expressing their concerns and refusing to take the jab.

While there are certainly some outlandish claims based on complete nonsense made by those who oppose vaccinations as well as the rabid pro-vaxxers, the examples listed above prove there are very real reasons to advocate for informed consent and vaccine safety. No one here at TFTP is telling anyone what to do in regard to vaccinations. We are however, advocating for safety at all levels of this process. Nevertheless, those who promote vaccine safety are increasingly being treated as outcasts and lawmakers and media alike are calling for [them to be silenced](#).

Skepticism is not dangerous, as the media would have you believe. It is necessary for producing a safe product yet Johnson & Johnson and Pfizer both have highly questionable histories with operating procedures that are the antithesis of safety.

In 2000 the *Washington Post* published a major exposé [accusing](#) Pfizer of testing a dangerous new antibiotic called Trovan on children in Nigeria without receiving proper consent from their parents. The experiment occurred during a 1996 meningitis epidemic in the country. In 2001 Pfizer was [sued](#) in U.S. federal court by thirty Nigerian families, who accused the company of **using their children as human guinea pigs**.

In 2006 a panel of Nigerian medical experts [concluded](#) that **Pfizer had violated international law**. In 2009 the company [agreed](#) to pay \$75 million to settle some of the lawsuits that had been brought in Nigerian courts. The U.S. case was [settled](#) in 2011 for an undisclosed amount.

Classified U.S. State Department cables made public in 2010 by Wikileaks [indicated](#) that Pfizer had hired investigators to dig up dirt on Nigeria’s former attorney general as a way to get leverage in one of the remaining cases. Pfizer had to [apologize](#) over the revelation in the cables that it had falsely claimed that the group Doctors Without Borders was also dispensing Trovan during the Nigerian meningitis epidemic.

In 2011, Johnson & Johnson [agreed](#) to pay \$70 million to settle civil and criminal charges of bribing doctors in Europe and paying kickbacks to the Iraqi government to illegally obtain business.

Are we supposed to forget the track record of these companies who deliberately misled regulators about the hazards of their products, knowingly [contributing to the deaths](#) of more than 125 people? Or who experimented on children? Or who has paid out hundreds of millions [in settlements](#) for the deaths of scores of patients?

The fact is that these companies have track records that include bribing government officials to illegally testing products on children to making false claims about drugs and illegally marketing them. These companies include Johnson & Johnson, whose penalty total on Violation Tracker is [\\$4.2 billion](#), AstraZeneca ([\\$1.1 billion](#)), GlaxoSmithKline ([\\$4.4 billion](#)) and Sanofi ([\\$641 million](#)).

Now, Johnson & Johnson, a company with a history of death and destruction, has announced they will begin testing the COVID-19 [vaccine on newborns and children](#) — whose chances of dying from the virus [are almost zero](#).

Definition for Mass Murder: **The systematic killing of a population, either entirely or the majority thereof. A mass murder may be perpetrated with the tacit or active support of a community or a group in the society in which it occurred, and usually is a single event. History's largest mass murders have been attempts to exterminate an ethnic and other group—i.e., genocide.**

It is very important that you know this is not about a virus. This is genocide first and foremost, yet being masked as a virus that no scientist in the world has ever been able to find this illusive virus.
