Story at-a-glance

- In a surreptitious move to support the vaccine narrative, the CDC quietly changed the over 20-year definition of a vaccine, so it no longer says that vaccines produce immunity
- The World Health Organization changed the definition of a pandemic, so it no longer says there are “enormous numbers of deaths and illnesses,” only that there is a new virus without known human immunity
- Health experts are pushing the vaccine program based on the promise of herd immunity. However, the NIAID has said that you can have breakthrough infections and spread those infections to others
- The WHO defines herd immunity from vaccines as those that protect you from getting the disease and passing it on. This means by the WHO definition the shots will never provide herd immunity; how long will it take for the WHO to change the definition again?

CDC Changes the Definition of Vaccines

In a surreptitious move to support the vaccine narrative, the Centers for Disease Control and Prevention quietly changed the definition of a vaccine,^{1,2} which they have held since at least February 24, 2011.³ At first glance, it might seem like a small change, but it has massive repercussions.

The meaning of words can change over time, and can be influenced by social, economic, political, religious and technological factors. Many of the words we use today have vastly different meanings than they did 10 or 100 years ago.⁴ However, changing medical words and definitions has a significant impact on bias in perception. One study demonstrated that a simple switch in terminology could result:⁵

“... in a disease being perceived as more serious, more likely to be a disease, and more likely to be a rare condition. These findings regarding the conceptualization of disease have implications for many areas, including medical communication with the public, advertising, and public policy.”

For example, medical literature has redefined the meaning of “health” over several decades to move from the absence of disease to a state of well-being. That definition continues to evolve in light of value-based health care, which some recommend should now include “specific patient needs, and the organizational, value-based system required to satisfy those needs.”⁶

This change in definition then affects health care delivery, public perception and interpretation of the meaning of health. This strategy was not lost on the CDC when they removed critical words from the definition of a “vaccine” to change the public perception of any administered therapy that may impact a person’s immune system.

This opens the door to the administration of other “products” or “preparations” that may affect your immune system, still while calling it a vaccine. And, let’s face it, for much of the public, the word “vaccine” continues to have positive implications.

CDC Removes Critical Words From Vaccine Definition

To fully understand the importance of the change, it’s crucial to note that, before the COVID pandemic, the definition of a vaccine had been relatively stable for nearly a couple decades with minor word changes occurring every few years. All through that time the intent of a vaccine — to give you immunity by protecting you from a specific disease — had remained basically the same.

For example, according to an archived snapshot of the CDC’s website, the definition of a vaccine February 24, 2011, was:⁷

“A product that produces immunity therefore protecting the body from the disease. Vaccines are administered through needle injections, by mouth and by aerosol.”

By July 2015, the wording had changed to:⁸

“A product that stimulates a person’s immune system to a specific disease, protecting the person from that disease. Vaccines are usually administered through needle injections, but can also be administered by mouth or sprayed in the nose.”

The wording was the same in June 2017⁹ and likewise in June 2019¹⁰ and June 2020.¹¹ By August 26, 2021,¹² however, the definition had changed slightly to add the words “to produce immunity”.¹³

“A product that stimulates a person’s immune system to produce immunity to a specific disease, protecting the person from that disease. Vaccines are usually administered through needle injections but can also be administered by mouth or sprayed into the nose.”

Then, less than a week later, just days after the FDA gave final approval to Pfizer’s mRNA jab, the definition changed again, September 1, 2021 — this time, significantly. The definition of a vaccine now reads:¹⁴

“A preparation that is used to stimulate the body’s immune response against diseases. Vaccines are usually administered through needle injections, but some can be administered by mouth or sprayed into the nose.”

As you’ll note, the second sentence remains the same. It is the first part of the definition that has dramatically changed. In the latest definition, a vaccine:

- Is no longer a “product” but instead is a “preparation”
- No longer directly stimulates the immune response, but is used to stimulate the system
- Does not produce immunity
- Stimulates the immune response against diseases, not against a specific disease
- No longer protects a person from the disease

These dramatic changes were likely created to allow the CDC, FDA and other governmental agencies to call the genetic therapy experiment being administered worldwide a “vaccine” — while they knew full well the so-called “vaccine” was not created to either produce immunity or prevent transmission of disease. In fact, by any definition of a vaccine in use before 2021, this jab is not a vaccine.

Organizations Are Changing the Goal Posts

Alex Berenson was once a reporter for ‘The New York Times’ and is now an award-winning author. He published a timeline of events on a Substack page that he calls “**A Lawsuit in Three Acts.**”¹⁵ In Act I is an August 26, 2021, screenshot of the CDC website, with the prior definition of a vaccine as you can see above. Act II is a screenshot of a tweet Berenson posted August 28, 2021:

“It doesn’t stop infection. Or transmission. Don’t think of it as a vaccine. Think of it — at best — as a therapeutic with a limited window of efficacy and terrible side effect profile that must be dosed IN ADVANCE OF ILLNESS. And we want to mandate it? Insanity.”



Following the release of that tweet, Twitter ruled the information misleading and suspended his account¹⁶ for “violations of our COVID-19 misinformation rules.”¹⁷ As Berenson writes, “*This defamatory act prevents me from using my account anywhere in the world.*”¹⁸

Within days of Berenson’s ban, Act III occurred. The CDC changed the definition of vaccine, removing the standard that had been in place for at least 20 years that vaccines produce immunity. In his last comment, Berenson alludes to the acts of censorship that have been ongoing in social media platforms since the beginning of this pandemic, writing, “Discovery’s gonna be awesome!”¹⁹

September 8, 2021, one of Berenson’s followers, Carol Jones, commented, “LOL!!! My lawyer husband just laughed when he read this. That is a slam dunk.” As a side note, Merriam-Webster Dictionary’s definition of a vaccine once was:²⁰

“... a preparation of killed microorganisms, living attenuated organisms, or living fully virulent organisms that is administered to produce or artificially increase immunity to a particular disease.”

However, before the CDC changed its definition, **Merriam-Webster had already changed theirs, which now includes a secondary description of the experimental COVID-19 genetic therapy.**²¹ Interestingly, when they made the change, the definition evolved from a simple, single line to a much more complex 12-paragraph definition that is a reflection of the times we live in.

The movement toward changing the definition of a vaccine may help protect the pharmaceutical industry and health agencies from violating a Federal Trade Commission act that regulates deceptive practices in medical claims. According to this it is unlawful to say:²²

“... that a product or service can prevent, treat, or cure human disease unless you possess competent and reliable scientific evidence, including, when appropriate, well-controlled human clinical studies, substantiating that the claims are true at the time they are made.”

And further, you cannot have a vaccine that does not meet the definition of a vaccine. Currently, the COVID-19 genetic therapy injection program does meet the vaccine definition of the CDC and Merriam-Webster — but only after the definitions changed.

What Is a Pandemic?

The definition of a vaccine is not the only thing that has changed since 2020. To continue promoting mandates, lockdowns and emergency use authorization of genetic therapy injections, the infection must be causing a pandemic.

According to the World Health Organization, their original definition of a pandemic specified that there must be simultaneous epidemics experienced worldwide “with enormous numbers of deaths and illnesses.”²³

While the published documents with the definition of a pandemic have since been pulled offline and cannot be accessed any longer through the Wayback machine, the WHO published a paper refuting the allegations that they had changed the definition “for the simple reason that it has never formally defined pandemic influenza.”²⁴

They argued that while they had described a pandemic influenza, it was never a “*formal definition.*” In their explanation they say that since 2003 their pandemic preparedness page had contained this statement:²⁵

“An influenza pandemic occurs when a new influenza virus appears against which the human population has no immunity, resulting in several simultaneous epidemics worldwide with enormous numbers of deaths and illness.”

They claim that was changed in response to a query from a CNN reporter just weeks before they declared a swine flu pandemic after only 144 people died from the infection worldwide. The new statement removed the phrase “enormous numbers of deaths and illnesses” and was revised to:²⁶ “An influenza pandemic may occur when a new influenza virus appears against which the human population has no immunity.”

The Council of Europe apparently had the same question and cited this alteration in their page as evidence that the WHO could declare a pandemic without demonstrating the severity of the disease against which we didn’t have immunity.²⁷

Unfortunately, the number of excess deaths that can be attributed directly to COVID-19 is likely not be the result of the infection itself, but from the CDC’s and NIAID’s suppression of successful treatment modalities that can save lives.^{28,29,30,31,32}

Vaccine Sales Pitch: Herd Immunity

Health experts promote the idea of herd immunity, hoping 100% of the public will become vaccinated. However, in July 2021 the news reported that 100 fully vaccinated crew members aboard the British defense aircraft carrier HMS Queen Elizabeth had tested positive while onboard. At the time, it was unclear whether any had symptoms.³³

This was one of the first reports that vaccinated individuals could have breakthrough infections, aka, “vaccine failure.” Vaccine failure would indicate that herd immunity is impossible. But, of course, that depends on your definition of herd immunity.

In June 2020, WHO’s definition was posted on their COVID-19 Q&A page and was in line with widely accepted standards for infectious diseases. Courtesy of the Wayback machine, the original definition was:³⁴

“Herd immunity is the indirect protection from an infectious disease that happens when a population is immune either through vaccination or immunity developed through previous infection.”

Since humans have been alive, immunity has developed from previous infection. Your immune system is designed to work in response to exposure to an infectious agent, not to a vaccine. However, since October 15, 2020, the WHO believes this is no longer the case, as they updated their definition of herd immunity to a “concept used for vaccination” or, rather, to support vaccination.³⁵

“‘Herd immunity’, also known as ‘population immunity’, is a concept used for vaccination, in which a population can be protected from a certain virus if a threshold of vaccination is reached. Herd immunity is achieved by protecting people from a virus, not by exposing them to it.

Vaccines train our immune systems to create proteins that fight disease, known as ‘antibodies’, just as would happen when we are exposed to a disease but — crucially — vaccines work without making us sick. Vaccinated people are

protected from getting the disease in question and passing it on, breaking any chains of transmission.”

The page was again updated on December 31, 2020:³⁶

“‘Herd immunity’, also known as ‘population immunity’, is the indirect protection from an infectious disease that happens when a population is immune either through vaccination or immunity developed through previous infection. WHO supports achieving ‘herd immunity’ through vaccination ...

Vaccines train our immune systems to create proteins that fight disease, known as ‘antibodies’, just as would happen when we are exposed to a disease but – crucially – vaccines work without making us sick. Vaccinated people are protected from getting the disease in question and passing on the pathogen, breaking any chains of transmission.

To safely achieve herd immunity against COVID-19, a substantial proportion of a population would need to be vaccinated, lowering the overall amount of virus able to spread in the whole population.”

As you can see from the areas I put in **boldface in the two definitions above**, the WHO definition of a vaccine and the CDC definition are not congruent. In this statement, the WHO says that vaccines protect the individual from getting the disease or passing on the pathogen. The current CDC definition³⁷ says that vaccines merely “stimulate the body’s immune response against diseases” without mention of immunity, protection or passing pathogens.

This means the definition of a vaccine by the WHO does not cover the function of the COVID-19 genetic therapy program, since the mRNA gene therapy’s purpose is only to lessen symptoms. The NIAID admits that after the mRNA shots people can still get breakthrough infections³⁸ (so they aren’t protected from getting the disease) and will have enough pathogens in their nasal cavity to spread the disease³⁹ (they are passing on the pathogen).

Even with the changes the WHO made to their definition of herd immunity, it is apparent that the COVID-19 injection program will never meet the standards of herd immunity set by the WHO. **The only question is how long will it take the WHO to change their definition again?**

Living in a World Where Goal Posts Are Constantly Changing

In his short video, Rep. Jim Jordan, R-Ohio, gives an accounting of Dr. Anthony Fauci vacillating on his recommendations regarding masking in public. Fauci was appointed as the director of the NIAID in 1984 which, by 2020, should have made him an expert on the transmission of infectious diseases.

Yet, as is apparent by this historical recounting, the recommendations evolve depending on the current climate, just as the definitions of herd immunity, vaccines and pandemics have evolved.

These definitions have been changed to fit the new narrative being churned out by public health officials and mainstream media that promote fear and ignore science. In many ways, you're living in a fog of war right now — a fog of COVID war — according to Jeffrey Tucker, editorial director of the American Institute for Economic Research.⁴⁰

During such a fog, ***“It is often unclear who is making decisions and why, and what the relationships are between the strategies and the goals. Even the rationale can become elusive as frustration and disorientation displace clarity and rationality.”***⁴¹ Seeing through the fog is the first step to coming out of the battle unscathed.

A whistleblower has provided government data documenting 48,465 deaths within 14 days of COVID-19 vaccination among Medicare patients alone, according to medical freedom rights attorney Thomas Renz.

The announcement Saturday was made by the Ohio-based attorney, who remains involved in several major cases brought against federal agencies relating to fraud and violations of medical freedom rights.

In his presentation, Renz expressed his appreciation for whistleblowers that were coming forward to provide the public with such important information from the Centers for Medicare & Medicaid Service (CMS). He described the CMS database as the largest available in the U.S. for the study of COVID-19 trends because it contains the data of approximately 59.4 million Medicare beneficiaries.

One slide showed that the number of "persons who died within 14 days of a COVID-19 vaccine" equated to 19,400 for those younger than 81 years old, and 28,065 for those 81 and over, totaling 48,465 deaths.

"This is raw data," Renz explained. "There's no analysis." And, he emphasized, these death numbers are from less than 20% of the U.S. population.

"Do you want to know why 14 days is important?" he asked. "Because if you die with 14 days, you're not considered vaccinated." According to the Centers for Disease Control and Prevention (CDC), one is not considered as being "vaccinated" until 14 days after their completed injection regimen, raising the

question of whether government authorities have been classifying these fatalities as something other than vaccination-related deaths.

Renz provided screenshots of the *“raw data from the Medicare servers,”* calling it *“a present for the scumbag ‘fact-checkers’ who keep lying.”*

In July, a whistleblower who works professionally as a computer programmer in health care data analytics, made a declaration under penalty of perjury that CMS data revealed **“at least 45,000” vaccine-related deaths due to experimental COVID-19 vaccine injections.** USA Today and others “fact-checked” the claim and called it misinformation.

A press release on Renz’s website responds, **“Today’s revelations solidify that the ‘Trusted News Initiative’ is actually the source of misinformation and propaganda, and that [the] Attorney Thomas Renz Whistleblower was correct all along.”**

Since the roll-out of the COVID-19 gene-based vaccines began last December, with adverse reactions, including death, being passively reported on the CDC’s Vaccine Adverse Events Reporting System (VAERS), many have believed the actual numbers of injuries to be much higher.

The most recent data from the CDC’s VAERS system released last Friday reveals reports of **726,965 adverse events in the U.S.** following vaccination, including **15,386 reports of deaths and 99,410 reports of serious injuries,** between December 14, 2020, and September 17.

Yet the presumption of significantly higher real numbers is supported by a 2010 Harvard Pilgrim study which found that “less than 1% of vaccine injuries” are reported on VAERS. In addition, even vaccine manufacturers have calculated at least a “fifty-fold underreporting of adverse events” on this system.

SHOCKER: Three existing covid vaccines actually contain DNA (not just RNA) for spike protein synthesis inside your body

The various COVID vaccines being rushed into existence do not operate as traditional biologics (vaccines) and are being **falsely represented and regulated as such.** Standard vaccines introduce attenuated (weakened) forms of a target virus, in conjunction with inflammatory adjuvant and other chemicals. These new mRNA, adenovirus-vectored, and DNA vaccines utilize the “software” of the virus, forcing the body to make copies of it.

Professor Jonathan Gershoni from Israel’s Tel Aviv University explains that **three covid vaccines on the market are actually DNA vaccines.** Inoculations manufactured by Sputnik V, AstraZeneca and Johnson & Johnson contain DNA

(not just RNA) that is inserted into the nucleus of human cells to ultimately translate and replicate lab engineered spike proteins.

India is getting a new type of DNA vaccine made by Zydus Cadila; it will be called ZyCoV-D. This vaccine contains less DNA than the other DNA vaccines and that DNA is not concealed by a viral vector (adenovirus). For these vaccines, the 1,200 amino acid sequence of the coronavirus spike protein is contained in a plasmid, and it is administered intra-dermally in a three dose, three-month protocol using a high-pressure stream of liquid containing the DNA.

Gene experiments, cellular reprogramming and the destruction of the innate immune system.

The adenovirus-vectored covid vaccines all contain DNA from the engineered spike protein. These vaccines stealthily deliver DNA from the bioweapon, concealing it in an adenovirus shell. Once the spike protein DNA bypasses the innate immune system, its genetic instructions are transcribed into the human cells, mass producing lab engineered spike proteins.

The pharmaceutical media and the fact checkers continue to lie about the experimental, gene-altering science behind new COVID vaccines. In unison, they claim that the vaccines do not alter human DNA or change genetic expression. However, these vaccines are genetic experiments designed to keep humans dependent on vaccine updates; the inoculations were designed to breach the innate immune system for the purpose of altering how cells read the body's own genetic code.

The adenovirus-vectored vaccines carry the spike protein DNA into the cell by using the adenovirus to subvert the innate immune response. The mRNA vaccines use lipid nano-particles to conceal the instructions and slip them into the ribosomes of the cell. In the initial process of subverting the immune system, these vaccines do not beckon a strong enough T cell response to elicit adequate T helper 1, T helper 2, and memory B cells. Because the innate immune system is not exposed to the whole virus, including the envelope and the nucleocapsid, the immune system SUFFERS. This incomplete and subverted immune response primes the body for severe disease upon subsequent re-infection.

No guarantee these gene-altering experiments are temporary
With this new vaccine technology, the messenger RNA or the DNA of a foreign, lab engineered spike protein is inserted into the body to overwrite the natural protein synthesis of the affected cells. Once this natural transcription process is re-engineered by the vaccines, there's no guarantee that the cells will stop using this foreign code. There are no studies mapping where the spike proteins travel to in the body, how long they might last, or if their replication alters protein synthesis indefinitely and becomes a part of human cells or human DNA.

Because DNA is unable to transcribe by itself, the [DNA vaccines](#) must insert the foreign DNA into the nucleus of the human cell. This allows messenger RNA to make a disposable copy of the DNA, preparing instructions for protein synthesis in the ribosome. The RNA has the ability to interact with the ribosomes of the cell, and is responsible for encoding the type of protein the cell is instructed to manufacture.

As predominant mutations of the spike protein are discovered in the wild, vaccine makers can study that DNA and retool the DNA and mRNA in their vaccines, to replicate new sequences of spike protein in humans each year.

The Google-owned site is now openly engaged in viewpoint regulation to force users to view only those sources that are consistent with the corporate agenda. Facebook banned misinformation on all vaccines [seven months ago](#) and Twitter regularly bans those questioning vaccines.

These companies are being encouraged by many on the left to expand censorship.

Faculty and editors are now actively [supporting modern versions of book-burning](#) with blacklists and bans for those with opposing political views. Columbia Journalism School Dean Steve Coll has [denounced the “weaponization” of free speech](#), **which appears to be the use of free speech by those on the right. So the dean of one of the premier journalism schools now supports censorship.**

Free speech advocates are facing a generational shift that is now being reflected in our law schools, where free speech principles were once a touchstone of the rule of law. As millions of students are taught that free speech is a threat and that [“China is right” about censorship](#), these figures are shaping a new society in their own intolerant images.

In [one critical hearing](#), tech CEOs appeared before the Senate to discuss [censorship programs](#). Twitter CEO Jack Dorsey apologized for censoring the Hunter Biden laptop story, but then pledged to censor more people in defense of “electoral integrity.”

Delaware Sen. Chris Coons, however, was not happy. He was upset not by the promised censorship but that it was not broad enough.

He noted that it was hard to define the problem of “misleading information,” but the companies had to impose a sweeping system to combat the “harm” of misinformation on climate change as well as other areas. “The pandemic and misinformation about COVID-19, manipulated media also cause harm,” Coons said. **“But I’d urge you to reconsider that because helping to disseminate climate**

denialism, in my view, further facilitates and accelerates one of the greatest existential threats to our world.”



Connecticut Sen. Richard Blumenthal also warned that he and his colleagues would not tolerate any “backsliding or retrenching” by “failing to take action against dangerous disinformation.” He demanded “the same kind of robust content modification” from the companies – the new Orwellian term for censorship.

This is the face of censorship. As demanded, the companies are now sanitizing their sites to remove opposing views on these subjects. Rather than offer a free forum for the full debate on such issues, anti-free speech advocates have again prevailed in silencing those with opposing views.

AT LEAST 5 TIMES MORE DEATHS VACCINE DEATHS ARE SEVERELY UNDERREPORTED

VAERS data from the American CDC shows that as of August 26, 2021 already half a million people suffered severe side effects, including stroke, heart failure, blood clots, brain disorders, convulsions, seizures, inflammations of brain & spinal cord, life threatening allergic reactions, autoimmune diseases, arthritis, miscarriage, infertility, rapid-onset muscle weakness, deafness, blindness, narcolepsy and cataplexy.

Besides the astronomical number of severe side effects, the CDC reports that approx. 16,000 people died as a result of receiving the experimental injections. However, according to a CDC whistleblower who signed a sworn affidavit, the actual number of deaths is at least five times higher. This is what the CDC healthcare fraud detection expert Jane Doe officially stated in a sworn affidavit:¹

'I have, over the last 25 years, developed over 100 distinct healthcare fraud detection algorithms, both in the public and private sector. (...) When the COVID-19 vaccine clearly became associated with patient death and harm, I was inclined to investigate the matter. It is my professional estimate that VAERS (the Vaccine Adverse Event Reporting System) database, while extremely useful, is under-reported by a conservative factor of at least 5 (...) and have assessed that the deaths occurring within 3 days of vaccination are higher than those reported in VAERS by a factor of at least 5.'

The CDC is also vastly underreporting other adverse events, like severe allergic reactions (anaphylaxis). The Informed Consent Action Network (ICAN) reported that a study showed that the actual number of anaphylaxis is 50 to 120 times higher than claimed by the CDC.^{2,3}

On top of that, a private researcher took a close look at the VAERS database, and tried looking up specific case-ID's. He found countless examples where the original death records were deleted, and in some cases, the numbers have been switched for milder reactions. He says:

“What the analysis of all the case numbers is telling us right now is that there’s approximately 150,000 cases that are missing, that were there, that are no longer there. The question is, are they all deaths?”⁴

How criminal the CDC is, was also revealed a few years ago, when researchers investigated the link between vaccines and autism. They found that there indeed is a direct connection. So what did the CDC do?

All the researchers came together and a large dustbin was placed in the middle of the room. In it they threw all the documents that showed the link between autism and vaccinations. Thus, the evidence was destroyed.

REASONS FOR UNDERREPORTING THE POPULATION IS UNAWARE AND MISINFORMED

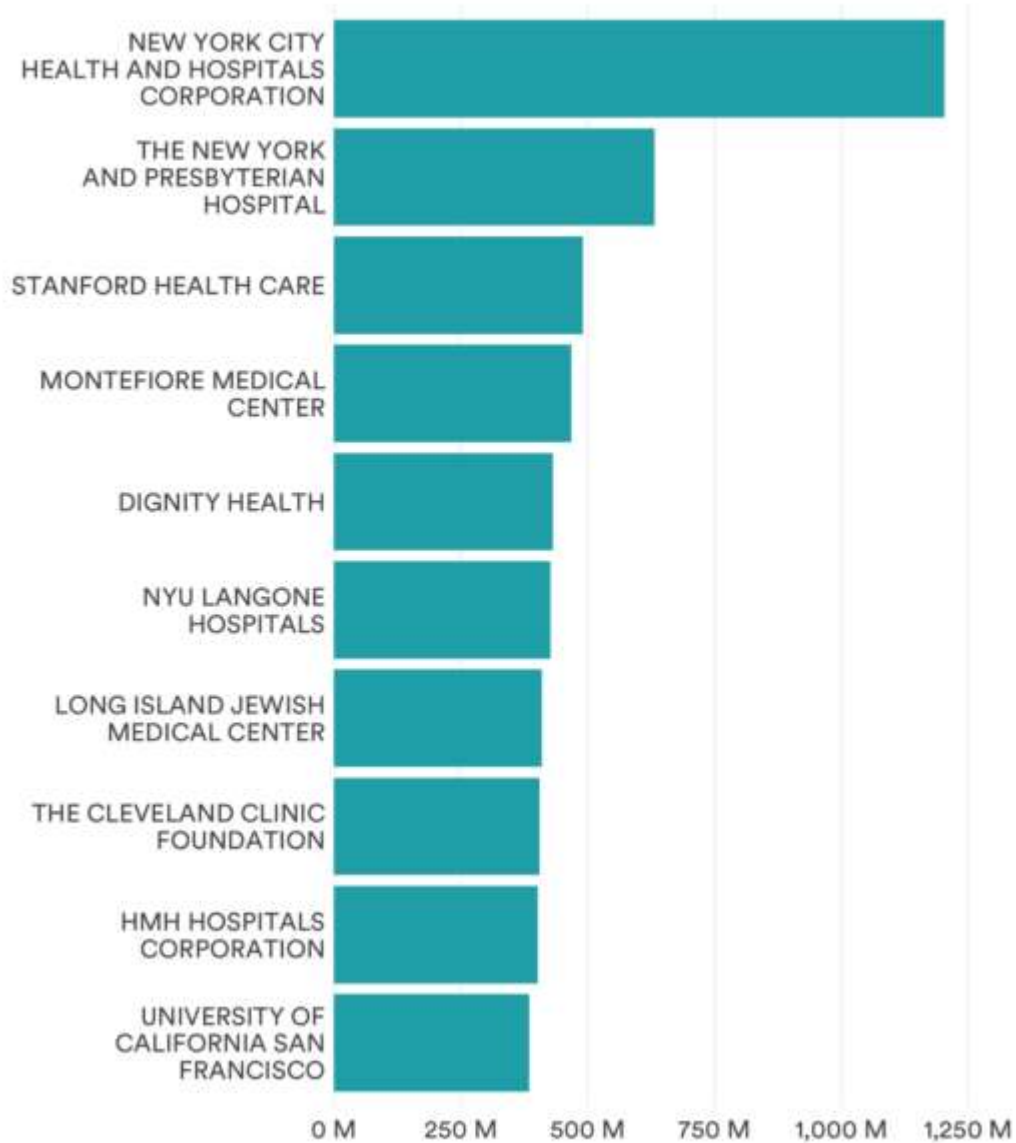
Congress set up a massive, \$178 billion fund in 2020 meant to help mitigate the impacts of the Covid-19 pandemic on health care providers, known as the Provider Relief Fund. **Money buys silence with health institutions that have cash problems.**

The Trump and Biden administrations haven't always been [reliable about sending out the money](#) — or sending it on time. But STAT's new analysis of a Health and Human Services database of the money reveals where it's flowing and who has received the most so far.

By far, the largest payments were made to the nation's biggest hospital systems. Fully five of the top 10 recipients of cash were New York City-area hospitals or health systems; together, they received some \$3.1 billion. The New York and Presbyterian Hospital (usually styled "NewYork-Presbyterian") alone brought in \$631 million, topped only by the \$1.2 billion that went to the New York City Health and Hospitals Corporation, a group that operates New York City's sprawling system of public hospitals and clinics.

As Reports of Deaths After COVID Vaccines Near 16,000, CDC Urges Pregnant Women to Get the Vaccine

VAERS data released Friday by the CDC included a total of **752,803 reports of adverse events** from all age groups following COVID vaccines, including **15,937 deaths** and **105,758 serious injuries** between Dec. 14, 2020 and Sept. 24, 2021.


Data released Friday by the Centers for Disease Control and Prevention (CDC) showed that between Dec. 14, 2020 and Sept. 24, 2021, a total of **752,803 adverse events** following COVID vaccines were reported to the Vaccine Adverse Event Reporting System (VAERS). The data included a total of **15,937 reports of deaths** — an increase of **551** over the previous week.

There were **105,758 reports of serious injuries**, including deaths, during the same time period — up 6,348 compared with the previous week.

Excluding “**foreign reports**” filed in VAERS, **581,851 adverse events**, including **7,215 deaths** and **45,952 serious injuries**, were reported in the U.S. between Dec. 14, 2020 and Sept. 24, 2021.

Of the 7,215 U.S. deaths reported as of Sept. 24, [11% occurred](#) within 24 hours of vaccination, [16% occurred](#) within 48 hours of vaccination and [29% occurred](#) in people who experienced an onset of symptoms within 48 hours of being vaccinated.

In the U.S., 388.2 million COVID vaccine doses had been administered as of Sept. 24. This [includes](#): 223 million doses of [Pfizer](#), 151 million doses of [Moderna](#) and 15 million doses of [Johnson & Johnson](#) (J&J).

The data come directly from reports submitted to VAERS, the primary government-funded system for reporting adverse vaccine reactions in the U.S.

Every Friday, [VAERS](#) makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Historically, VAERS has been shown to report only 1% of [actual vaccine adverse events](#).

This week's U.S. data for 12- to 17-year-olds show:

- [20,907](#) total adverse events, including [1,256 rated as serious](#) and [21 reported deaths](#). Two of the 21 deaths were suicides. The most recent deaths involve a 17-year-old male (VAERS I.D. [1689212](#)) with cancer who was vaccinated April 17, tested positive for COVID on July 20, was hospitalized and passed away Aug. 29; and a 16-year-old female (VAERS I.D. [1694568](#)) who died from a pulmonary embolism nine days after receiving her first Pfizer dose.

Other recent reported deaths include two patients [VAERS I.D. [1655100](#)] who died after their second dose of Pfizer, including a 13-year-old female, a 15-year-old boy (VAERS I.D. [1498080](#)) who previously had COVID, was diagnosed with cardiomyopathy in May 2021 and died four days after receiving his second dose of Pfizer's vaccine when he collapsed on the soccer field and went into ventricular tachycardia; and a 13-year-old girl (VAERS I.D. - [516 reports](#) of myocarditis and pericarditis (heart inflammation) with [508 cases](#) attributed to Pfizer's vaccine.

CDC overrules agency's own vaccine safety committee, sides with FDA on boosters

In an "[unusual move](#)," Dr. Rochelle Walensky, CDC director, on Thursday overruled her agency's vaccine advisory committee recommendation to limit Pfizer's COVID booster shot for people 65 and older, long-term care facility residents and certain people with underlying conditions.

Instead, Walensky aligned with the U.S. Food and Drug Administration's (FDA) authorization of a third dose of [Pfizer's](#) vaccine for a broader population, including healthcare workers, grocery store workers, teachers and others whose jobs put them at "high risk" of infections, plus residents of prisons and homeless shelters.

President Biden today acted on the news, announcing his administration will begin to deliver booster shots this week, [Politico reported](#).

The CDC's vaccine advisory panel in a meeting Thursday [voted unanimously to approve](#) booster doses of Pfizer's COVID vaccine for people 65 and older, long-term care facility residents and certain people with underlying conditions. The booster dose would be given at least six months after being fully vaccinated.

However, the advisers voted against recommending a booster dose for people whose jobs or situations put them at high risk of vaccine [breakthrough infection](#).

Covid Deaths in Perspective: Propaganda vs. Facts!

In the U.S.A., [an average of 7,900 people dies every day](#), from dozens of different reasons. The pharmaceutical “gene” therapy tests conducted in 2020 on the **lab animals all died** within two days, and so the lab tests were suspended, and then the FDA given EAU or Emergency Application Use to vaxx the public. They counted on the public to be ignorant of the facts, and so frightened that they would never ask what it was they were being jabbed into their arm.

Dr. Judy Mikovits said early on in 2020, that 55-million would die from the vaxx in five years. Those numbers were also confirmed by Dr. Luc Montagnier, the 2008 Nobel Peace Prize winner in Medicine for his discovery of the HIV virus. Dr. Montagnier says the variants are the result of the vaxxes. Dr. Montagnier said in May 18, 2021, **“it is the vaccination that is creating the variants.”**

While it is understood that viruses mutate, causing variants, Dr. Montagnier contends that *“it is the vaccination that is creating the variants. It is the antibodies produced by the virus that enable an infection to become stronger. It’s what we call Antibody Dependent Enhancement (ADE), which means antibodies favor a certain infection. The antibody attaches to the virus, from that moment it has the receptors, the antibodies, we have them in the macrophage (a white blood cell that consumes infectious cells).”*

Professor Dr. Montagnier referred to the vaccine program for the coronavirus as an “unacceptable mistake”. Mass vaccinations are a *“scientific error as well as a medical error,”* he said. *“It is an unacceptable mistake. The history books will show that, because it is the vaccination that is creating the variants.”*

“There are antibodies, created by the vaccine, forcing the virus to find another solution or die. This is where the variants are created. It is the variants that are producing and

result from the vaccination. You see it in each country, it's the same: the curve of the vaccination is followed by the curve of deaths."



- 4 criteria designed to **verify that the microorganism** is the **causal agent** for the disease.
- 4 rules / steps:
 - The suspected pathogen must be consistently **associated** with the diseased plant
 - The microorganism must be isolated from the diseased organism and **grown in pure culture**.

Dr. Judy Mikovits based her remarks on the Xenotropic murine leukemia virus-related virus (XMRV) is *"a laboratory-derived mouse virus that was generated through recombination between two endogenous murine retroviruses during propagation of a prostate cancer xenograft in the mid-1990's"*. In 2007, Mikovits met a co-discoverer of xenotropic murine leukemia virus-related virus (XMRV), Robert Silverman, at a conference. Silverman had found XMRV sequences, which are highly similar to mouse genomic sequences, in prostate cancer specimens several years earlier. Using tools obtained from Silverman, Mikovits began to look for XMRV in her CFS samples. **Dr. Mikovits pointed out that the national blood supply was contaminated with the XMRV virus with CFS and HIV1 viruses. CFS or Chronic Fatigue Symptoms was later predesignated as the HIV1 by Dr. Robert Gallo and Dr. Anthony Fauci.**

In this interview, Dr. Peter Breggin — known as “the conscience of psychiatry” for his instrumental role in preventing the return of lobotomy as a psychiatric treatment in the early 1970s — discusses

There’s no doubt anymore that we are in the middle of the biggest, most effective propaganda war in the history of the world. Nothing even comes close. As a result, a mass psychosis has developed, where many normally rational people have completely lost their capacity to reason. You can show them reams of solid indisputable information and they’ll simply refuse to believe any of it. What’s at the heart of this mass psychosis? Breggin explains:

“It’s extremely important to get over this attempt to make us all helpless, obedient and docile. We have to know, who are the masters driving this? On the other hand, we have to understand the mechanisms for this [manipulation] ... It’s a subtle reign of terror ... We’re looking at a revolution against us that wants to make us feel helpless like children.”

“In psychotherapy, we often see people who’ve been terribly abused by their parents, but they cannot face it. They can’t identify it as evil ... We can’t bear to think there are people out to harm us and manipulate us. You can’t bear to think there are people different from us — people who actually take pleasure from injury and domination ...”

“So, I want to identify first who these people are. Who’s doing this to us? It’s time to face it and to get rid of the idea that this is chance, or is this is crazy, or this is bizarre, or this makes no sense.

How does it make sense that they’re absolutely ignoring the fact that, in America, we now have over 14,000 reports of deaths from the [COVID] ‘vaccine’ and no one is investigating it? No one’s doing anything. In the years before this, if a vaccine had more than 20 or 30 [deaths], and certainly over 100, it would be a catastrophe.

Now we have a vaccine that has more deaths than all the other vaccines put together. How can we ignore that? On the other hand, we get all these huge [falsely inflated] numbers of deaths from COVID-19 ... So, we’re looking at this situation and [asking] is that crazy?

Well, no, it makes perfect sense. If you’re trying to intimidate and overwhelm a population, you exaggerate the danger. You take a flu-like illness that is safer than the flu in terms of how it spares children and young adults and attacks people my age, I’m 85. [It’s] killing people who are already past their predicted lifespan. So, you take this relatively benign epidemic and make it into a horror show by exaggerating everything.”

The question that must be asked and answered is: What is the goal? We can determine the goal by looking at what we know. We know:

What do these facts, taken together, tell us? What are "the powers that be" getting out of this? Breggin explains:

"The spike protein is the spearhead of an assault on humanity. That has nothing to do with COVID-19 whatsoever, but is planned through COVID-19 in order to vastly increase the wealth of numerous institutions and individuals ... many of them unfortunately originating from America, who are working in collaboration with the communist, Chinese Communist Party, to increase this vast exploitation of the world ..."

The Chinese have been sinking their teeth into us for a long time, because we are the seat of liberty in this world ... So, it all begins to make sense ... The forces are most locked into those of us who are now free, and they're aiming to destroy us. This is terrifying, but it shouldn't make you ... helpless. It should rouse you to look with reason at what is happening in the world."

The Decade of Vaccines

In 2010, Bill Gates announced “the decade of vaccines.” A partner in that declaration was Dr. Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases (NIAID), as well as a number of other globalists, including the United Nations.

A decade later, we have COVID-19. Is that a coincidence? In 2015, a scientific paper³ assured that gain-of-function researchers had the means to create a pandemic. This research was funded by the NIAID and carried out by two top Chinese researchers at the Wuhan Institute of Virology (WIV) and, according to Breggin, all scientists in China work on behalf of the Chinese Communist Party (CCP).

“It’s called military civil fusion,” Breggin says. “They all work together ... That’s the nature of the totalitarian state. People don’t realize that, but Fauci had to know he was funding a potential pandemic virus.”

In fact, in the last few days, it’s come out from his emails obtained through a Freedom of Information Act (FOIA) request ... that he [Bill Gates] actually gave them instructions for how to combine ... several SARS-Cov-type virus systems to make an actual source code.”

COVID Shot Failure Was Entirely Predictable

According to Breggin, the CCP has been working with SARS-CoV-type viruses since at least 2003, and there have been four different leaks of SARS viruses since then.

“So here we have China and America making what are essentially biological weapons, the excuse being, ‘We’re going to make vaccines.’ But ... the vaccines aren’t going to work and they know it, because the coronavirus mutates all the time.”

So, if you make a vaccine for the Chinese virus, it’s not going to last long because it’ll just help force these mutations to come out because if you’re suppressing [strain] of a virus, then one of the many others that are floating around will take its place ...”

Bill Gates’ Pandemic Business Plan

The failure of the COVID shots was predicted by many physicians and scientists well before the middle of 2020, and there’s virtually no chance the vaccine makers were unaware of the many objections brought forth, and the scientific rationale behind them.

“So, Bill Gates knows, in 2015, that a pandemic virus can be made and [that] labs in China and the U.S. are collaborating and he knows Fauci, who’s been his key guy since at least 2010. So, Gates, in 2016, creates a business plan. I don’t know how I found this one. I think it was God just pulling the strings of my fingers, but I

pulled out of [Klaus] Schwab's website [Bill Gates' business plan for the world for the next pandemic](#).

It's about 65 pages long. You can find it on my website. [Go to the coronavirus resource center on breggin.com](#) and then look for the [background materials for the book](#), and you will become one of the first people in the world outside of the predators to see the business plan they made in 2016.

That business plan lays out everything that's happening to us now. In particular, it lays out that Bill Gates will be working with CEPI [Coalition for Epidemic Preparedness Innovations], an organization that Gates founded in 2017 — but that he's describing in 2016 — with Schwab, the man who will eventually announce the Great Reset in 2020 that he's been working on his whole life.”

In that document linked above, “CEPI Preliminary Business Plan 2017-2021,” it is stated that the drug industry will incur no expenses during the coming pandemic. All expenses, including indirect costs, will be covered. Yet another document describes the enormous profits expected. Gates’ business plan also describes the creation of what eventually became Operation Warp Speed.

In July 2017, [CEPI created a PowerPoint presentation for the World Health Organization](#), which you can also view on Breggin’s website. That presentation reviews Gates’ plan and explains the WHO’s role in setting the standards for pandemic science and medicine.

Amazingly, the PowerPoint includes a statement that CEPI has created a Memorandum of Understanding of what the WHO is. According to Breggin, that’s “the next thing to an absolutely binding contract with the WHO.”

Who Are the Predators?

In his book, Breggin also details the other partners in this scheme, which include the U.S. Food and Drug Administration, the U.S. Centers for Disease Control and Prevention, the National Institutes of Health, NIAID and the Biomedical Advanced Research and Development Authority (BARDA).

In short, the evidence points to the COVID-19 pandemic — with all the senseless and irrational decisions made in its name — being a scheme to enrich certain individuals, companies and organizations at the expense of everyone else.

“Rick Bright, [director of] BARDA, was key, a point man, [in] preventing everybody from having easy access to very effective treatments,” Breggin says. “Again, why? Because it was a decade of vaccines. It's all it was ever about. It was never about anything else. [It was always about] finding a way to get rich and powerful.”

So far, then, we can list the following predators:

Bill Gates and his organizations Klaus Schwab and the World Economic Forum (WEF)

Drug companies Fauci and the NIH/NIAID

The Wellcome Trust FDA

CDC BARDA

The WHO

What Are the Predators Working Toward?

So, just what are they working toward? In videos dating back to 2017, Gates discusses the development of RNA vaccines. Fast-forward to 2020, and mRNA injections were the immediate choice for the fast-tracked COVID shots. And, as detailed in Gates' business plan, Pfizer and Moderna were both given billions of dollars from the U.S. federal government through BARDA and the NIH/NIAID.

This, despite the fact that no mRNA injection has ever made it to market before this, and the fact that no coronavirus vaccine has ever made it to market in the 20 years they've been working on it. For some reason, coronavirus vaccines routinely cause severe illness and increased lethality when exposed to the wild virus, a phenomenon known as antibody dependent enhancement (ADE).

In his book, Breggin cites a 2020 paper by independent researchers warning that all of the COVID vaccines, not just the mRNA and the DNA shots but also those using killed viruses, are too dangerous to even try on humans.

"So, they know all of this," Breggin says. "There are no surprises to them. They knew what they were doing ... But don't get scared. Get angry, but don't get demoralized. They want that. You know, there's a whole school of public health that talks about how to intimidate and engender fear to get people to do what you want. It's called fear appeal."

So, it's systematic, and public health people have always been totalitarian in nature. It's all about public health people telling the communities what they must do come the next public health threat. They don't say preserve the Bill of Rights. They don't say, 'make sure we check this out in the courts or a body supervising us for our ethics to protect the folks.'"

Recognize the Abuse, Then Stand Up Against It

So, how can we break the mass psychosis spell that so many are currently under, which makes them unable to see reality and understand that complying with the globalist predators will result in their own ruin? Breggin comments:

“Human beings are born into a state of helplessness ... And the reason for that, I believe, is that we are a social animal. The brain doubles in size in the first year of life, which occurs in a social environment. So, we have a social brain. We are very tied to each other. That's the whole purpose of that socialization, that slow growth, that dependency over the years ...

Being social allowed us as an extended family to survive and to be different than all other creatures. It's our social relationships that make us unique. They also give us our pleasure.

In the grief now built into all of us is that potential for feeling very helpless. We can become in moments [like] little children again. When we start feeling guilt or shame or anxiety or overwhelmingly afraid, we can easily become helpless. And that's basically what's going on. I think it's fine to call it a psychosis, but I prefer to call it an overwhelming helplessness that overcomes the nation.

Now, if in childhood you're abused, then that helplessness remains with you into adulthood. That's how powerful those early years are, and you have to work hard to overcome it ... We to identify what was done to us. If you're an adult, it really helps to identify that, yes, you were sexually abused or, yes, you really were bullied by your older brother or your big sister ...

You look back and you see what's going on and what happened. And that helps you ... We are being oppressed by evil people. Nothing is by chance. We might as well be children being tormented. We have to say to each other, ‘No more. No more helplessness, no more lamenting, no more complaining, no more saying What's happening to us? It's very clear, what's happening to us.’

It's not crazy. It's intentional and purposeful and we must stand up to it. We must understand and not allow ourselves to be abused and rendered out again. We need to give each other comfort and love and inspiration. We need to support from a tactical viewpoint.

We need to get involved together. [My wife] Ginger and I made the terrifying decision to take on COVID-19 ... [and] join many other people fighting for America's freedom. It was a scary choice, but once we did, we started meeting tons of people.

I never imagined knowing Peter McCullough, a great cardiologist who wrote an introduction to [my book], who risked his life and his whole reputation to declare

that there is a good treatment ... We're all re-founders of America in a critical moment in time.

And instead of feeling sorry for ourselves, think to yourself, 'God put us in a place where we can make one of the hugest differences, or we can have effects beyond anything we imagined' ... We need to know that there is a war against us ... They have a stealth war against us ... So be proud, be an American, be a patriot. Stand up for liberty.

Look at the Declaration of Independence, the Constitution, especially the Bill of Rights. That's your legacy. You were throwing it away. You were doing nothing to protect it, probably since the civil war. This is the biggest threat to freedom in America. And it's much bigger than the civil war. It's a war against all of Western democracy."

More Information

As made clear in Breggin's book, "[COVID-19 and the Global Predators: We Are the Prey](#)," the end goal is complete totalitarian control of all nations, very similar to the kind of societal control already in place in China, and unless we unite against the implementation of this plan, there will be no happy ending for any of us.

It's not going to be easy, because the globalist predators have infiltrated government, NGOs, academia, entertainment, business and every other major aspect of American life. The way forward will necessitate taking back control over each and every area, one by one.

Editorial Observations

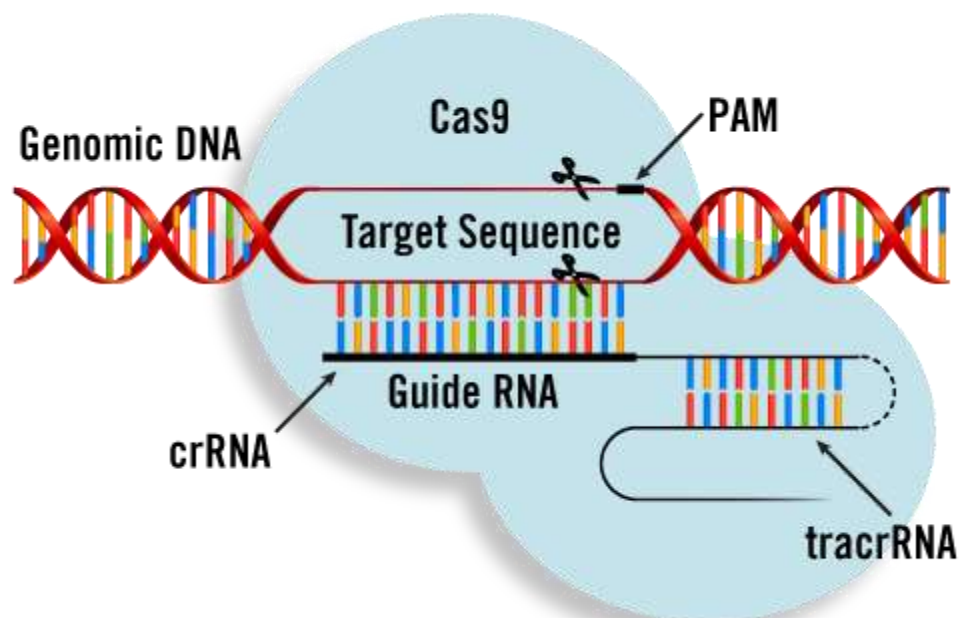

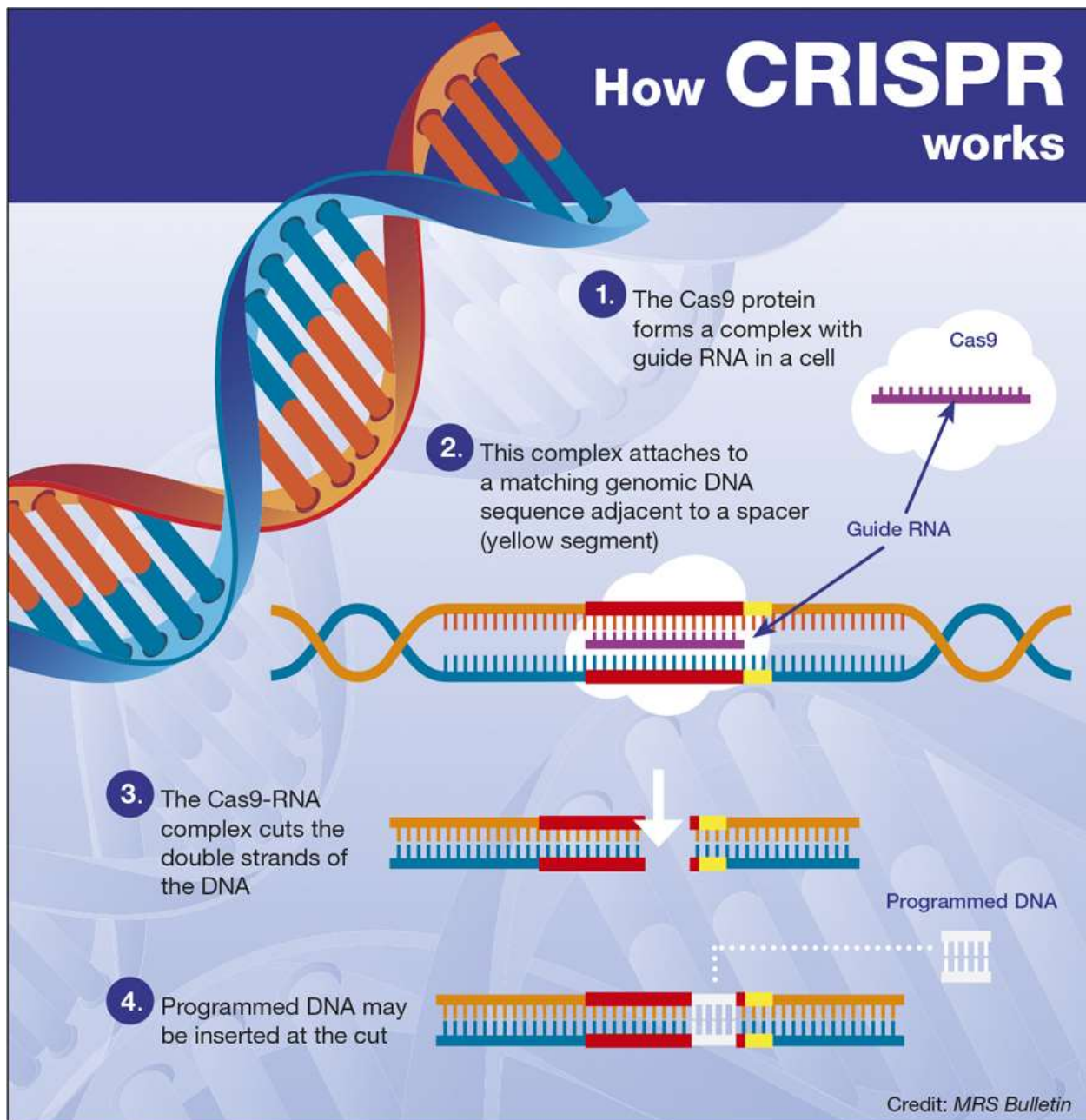
