2 More Teen Deaths Reported to VAERS, as FDA Panel Recommends Moderna, J&J Booster Shots

VAERS data released Friday by the CDC included a total of 798,636 reports of adverse events from all age groups following COVID vaccines, including 16,766 deaths and 117,399 serious injuries between Dec. 14, 2020 and Oct. 8, 2021.

Data released Friday by the Centers for Disease Control and Prevention (CDC) showed that between Dec. 14, 2020 and Oct. 8, 2021, a total of <u>798,636 adverse events</u> following COVID vaccines were reported to the Vaccine Adverse Event Reporting System (VAERS). The data included a total of <u>16,766 reports of deaths</u> — an increase of 456 over the previous week, and two more reports of teens who died after being vaccinated.

There were <u>117,399 reports of serious injuries</u>, including deaths, during the same time period — up 5,478 compared with the previous week.

Excluding "<u>foreign reports</u>" to VAERS, <u>604,160 adverse events</u>, including <u>7,674 deaths</u> and <u>48,958 serious injuries</u>, were reported in the U.S. between Dec. 14, 2020 and Oct. 8, 2021.

Of the 7,674 U.S. deaths reported as of Oct. 8, <u>11% occurred</u> within 24 hours of vaccination, <u>16% occurred</u> within 48 hours of vaccination and <u>28% occurred</u> in people who experienced an onset of symptoms within 48 hours of being vaccinated.

In the U.S., 400.3 million COVID vaccine doses had been administered as of Oct. 8. This <u>includes</u>: 232 million doses of <u>Pfizer</u>, 153 million doses of <u>Moderna</u> and 15 million doses of <u>Johnson & Johnson</u> (J&J).

The data come directly from reports submitted to VAERS, the primary government-funded system for reporting adverse vaccine reactions in the U.S.

Every Friday, <u>VAERS</u> makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Historically, VAERS has been shown to report only <u>1% of actual vaccine adverse</u> <u>events</u>.

This week's U.S. data for 12- to 17-year-olds show:

• <u>21,652</u> total adverse events, including <u>1,304 rated as serious</u> and <u>24 reported deaths</u>. Two of the 24 deaths were suicides.

The most recent death involves a 15-year-old male who died six days after receiving his first dose of Pfizer's COVID vaccine. According to his VAERS report (VAERS I.D. 1764974), the previously healthy teen complained of brief unilateral shoulder pain five days after receiving his COVID vaccine. The next day he played with two friends at a community pond, swung on a rope swing, flipped into the air, and landed in the water feet first. He surfaced, laughed and told his friends "Wow, that hurt!" He then swam toward shore underwater, as was his usual routine, but did not re-emerge.

An autopsy showed no external indication of a head injury, but there was a small subgaleal hemorrhage — a rare, but lethal <u>bleeding disorder</u> — over the left occiput. In addition, the boy had a mildly elevated cardiac mass, increased left ventricular wall thickness and small foci of myocardial inflammation of the lateral wall of the left ventricle with myocyte necrosis consistent with <u>myocardial infarction</u>.

Another recent death includes a 16-year-old female (<u>VAERS I.D. 1757635</u>) who complained of fatigue and died one day after receiving Pfizer's COVID vaccine.

- <u>57 reports</u> of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death with 96% of cases attributed to Pfizer's vaccine.
- <u>529 reports</u> of myocarditis and pericarditis (heart inflammation) with <u>508</u> cases attributed to Pfizer's vaccine.
- 117 reports of blood clotting disorders, with all cases attributed to Pfizer.

This week's U.S. VAERS data, from Dec. 14, 2020 to Oct. 8, 2021, for all age groups combined, show:

- 19% of deaths were related to cardiac disorders.
- 54% of those who died were male, 42% were female and the remaining death reports did not include gender of the deceased.
- The average age of death was 72.7.
- Of the <u>2,973 cases of Bell's Palsy</u> reported, 51% were attributed to <u>Pfizer</u> vaccinations, 41% to <u>Moderna</u> and 8% to <u>J&J</u>.
- 661 reports of <u>Guillain-Barré syndrome</u>, with 40% of cases <u>attributed to Pfizer</u>, 31% to <u>Moderna</u> and 28% to <u>J&J</u>.
- <u>1,995 reports</u> of anaphylaxis where the reaction was life-threatening, required treatment or resulted in death.
- <u>10,131 reports</u> of blood clotting disorders. Of those, <u>4,407 reports</u> were attributed to Pfizer, <u>3,654 reports</u> to Moderna and <u>2,018 reports</u> to J&J.
- <u>2,818 cases</u> of myocarditis and pericarditis with <u>1,782 cases</u> attributed to Pfizer, <u>915 cases</u> to Moderna and <u>111 cases</u> to J&J's COVID vaccine.

FDA panel unanimously backs Moderna, J&J booster shots for older and high-risk people.

According to CNBC, an advisory panel to the U.S. Food and Drug Administration (FDA) today unanimously voted to recommend J&J's single-dose COVID vaccine to the more than 15 million Americans who have already received the first dose.

The panel recommended boosters for everyone 18 and over, at least two months after they received the first dose.

Many committee members said it should be considered a two-dose vaccine, much like the Moderna and Pfizer vaccines.

On Thursday, the FDA's advisory panel unanimously recommended booster doses of Moderna's COVID vaccine for Americans 65 and older and those at high risk of severe illness or occupational exposure to the virus, Reuters reported.

"The data itself is not strong, but it is certainly going in the direction that is supportable of this vote," said Dr. Patrick Moore of the University of Pittsburgh School of Medicine. Moore said he voted in favor of Moderna boosters based largely on a "gut feeling rather than truly serious data."

Moderna shares were up nearly 3% at \$330.71 after the vote.

If the FDA signs off on the panel's recommendation for booster doses of J&J and Moderna's COVID vaccines, the CDC will make <u>specific recommendations</u> on who should get the shots. The CDC's vaccine advisers are scheduled to meet next week.

White House tells governors to get ready to vaccinate young kids, even though FDA hasn't approved it.

In a private phone call Tuesday with the nation's governors, the White House told states to <u>prepare to vaccinate children</u> as young as 5 by early November, even though the FDA has not yet granted Emergency Use Authorization for COVID vaccines for the 5 to 11 age group.

According to <u>NBC News</u>, the Biden administration purchased 65 million pediatric doses of the <u>Pfizer/BioNTech vaccine</u> — enough to vaccinate an estimated 28 million children who would be eligible should the FDA approve Pfizer's request to vaccinate the younger age group.

The administration told providers last week the vaccine for children will be delivered to thousands of sites, including states, pharmacies, schools and medical groups within one week of FDA authorization. The pediatric Pfizer vaccine will be one-third of what is given to adults.

Indiana parents say children are suffering adverse reactions after mistakenly given adult dose of COVID vaccine.

Joshua and Alexandra Price took their four-year-old son and five-year-old daughter to a Walgreens in Indiana for the <u>flu shot</u> a week ago, but the children and parents were all mistakenly given the Pfizer COVID vaccine, <u>The Hill reported</u>. The parents say their children, Sophia and Lukas, are experiencing side effects from the vaccine — which is only approved for ages 12 and older — including

fever, body aches, cough, headache and nausea. The children received a dose three times higher than is being tested for children in clinical trials.

"The 4- and 5-year-old are also under treatment of a pediatric cardiologist for tachycardia and elevated blood pressure, respectively," the Prices' attorney, Dan Tuley, said in a statement.

For the parents, Peter Hotez, dean of the National School of Tropical Medicine at Baylor College of Medicine, told CNN, the COVID shot would essentially be a booster shot since the parents were already vaccinated back in April

.

New data links Parsonage-Turner syndrome to mRNA COVID vaccines According to an article <u>published in Medscape</u> Oct. 14, Parsonage-Turner syndrome (PTS) has been highlighted as a potential adverse effect of mRNA COVID vaccines in a recent <u>pharmacovigilance monitoring report</u> from the French National Agency for the Safety of Medicines and Health Products (ANSM).

PTS is a rare condition characterized by the sudden onset of severe shoulder pain, followed by arm paralysis. The reaction appears to be more common in men than in women.

Six serious cases of the syndrome related to the <u>Pfizer's Comirnaty vaccine</u> were reported since the start of the monitoring program, with four cases occurring from Sept. 3 and 16.

All six cases associated with Pfizer's vaccine involved patients 19 to 69 years old two women and four men — who developed symptoms within 50 days after vaccination. Half of the cases occurred after the first dose and half after the second. Four patients are currently recovering, and the outcomes of the other two are unknown.

In the case of Moderna's COVID vaccine, two cases of PTS were reported. Two cases occurred in men — one in his early 30s and one in his early 60s — within 18 days after vaccination. One case occurred after the first dose and one after the second dose.

This timing indicates a possible link between the syndrome and the vaccine, the report stated. A third case occurred more than 50 days after vaccination.

This signal of mRNA vaccines is now "officially recognized," according to the report. It is also considered a "potential signal" of the <u>AstraZeneca</u> vaccine, according to a <u>pharmacovigilance report</u>, released Oct. 8, which describes eight cases of PTS after vaccination.

Data show COVID risk for kids 'not extraordinary threat'

As <u>The Defender reported</u> Oct. 12, new data from King County, Washington — which contains some of the country's most detailed COVID data — showed risks for unvaccinated children look similar to the risks for vaccinated people in their 50s.

According to <u>The New York Times</u>, nationwide statistics from the UK showed an even larger age gap. Unvaccinated children under 12 appeared to be at a lower risk of COVID infection than vaccinated people in their 40s, if not 30s.

For children without a serious medical condition, the danger of severe COVID was so low as to be difficult to quantify. For children with such a condition, the danger is higher but still lower than many people believe, the Times reported.

Eudra Vigilance

The European Union database of suspected drug reaction reports is <u>EudraVigilance</u>, ^[1] and they are now reporting **27,247 fatalities**, and **2,563,768 injuries**, following COVID-19 injections.

A *Health Impact News* subscriber from Europe reminded us that this database maintained at EudraVigilance is only for countries in Europe who are part of the European Union (EU), which comprises 27 countries.

The total number of countries in Europe is much higher, almost twice as many, numbering around 50. (There are some differences of opinion as to which countries are technically part of Europe.)

So as high as these numbers are, they do NOT reflect all of Europe. The actual number in Europe who are reported dead or injured following COVID-19 shots would be much higher than what we are reporting here.

The EudraVigilance database reports that through September 25, 2021 there are **27,247 deaths and 2,563,768 injuries** reported following injections of four experimental COVID-19 shots:

- COVID-19 MRNA VACCINE MODERNA (CX-024414) [2]
- COVID-19 MRNA VACCINE PFIZER-BIONTECH [3]
- COVID-19 VACCINE ASTRAZENECA (CHADOX1 NCOV-19) [4]
- COVID-19 VACCINE JANSSEN (AD26.COV2.S [5])

From the total of injuries recorded, almost half of them (1,222,818) are **serious** injuries. "**Seriousness** provides information on the suspected undesirable effect; it can be classified as 'serious' if it corresponds to a medical occurrence that results in **death**, is life-threatening, requires inpatient hospitalization, results in another medically important condition, or prolongation of existing hospitalization, results in persistent or significant disability or incapacity, or is a congenital anomaly/birth defect."

A "Physicians' Declaration" produced by an international alliance of physicians and medical scientists strongly condemns the global strategy to treat COVID, accusing policy-makers of potential "crimes against humanity" for preventing physicians from providing lifesaving treatments for their patients and suppressing open scientific discussion.

The document states that "one size fits all" treatment recommendations have resulted in needless illness and death.

As of 1:00 Friday afternoon, the declaration had garnered over 7,100 signatures from doctors and scientists around the world.

A group of physicians and scientists met in Rome, Italy earlier this month for a three day Global Covid Summit to speak "truth to power about Covid pandemic research and treatment."

The summit, which was held from September 12 to September 14, gave the medical professionals an opportunity to compare studies, and assess the efficacy of the various treatments that have been developed in hospitals, doctor's offices and research labs throughout the world.

The document, reprinted below in its entirety, <u>sprang from a physician's</u> <u>conference in Puerto Rico</u>.

The Physicians' Declaration was first read at the Rome Covid Summit, catalyzing an explosion of active support from medical scientists and physicians around the globe. These professionals were not expecting career threats, character assassination, papers and research censored, social accounts blocked, search

results manipulated, clinical trials and patient observations banned, and their professional history and accomplishments altered or omitted in academic and mainstream media.

Dr. Robert Malone, architect of the mRNA vaccine platform, read the Rome Declaration at the summit.

WHEREAS, physicians and other health care providers working on the front lines, utilizing their knowledge of epidemiology, pathophysiology and pharmacology, are often first to identify new, potentially lifesaving treatments;

WHEREAS, physicians are increasingly being discouraged from engaging in open professional discourse and the exchange of ideas about new and emerging diseases, not only endangering the essence of the medical profession, but more importantly, more tragically, the lives of our patients;

WHEREAS, thousands of physicians are being prevented from providing treatment to their patients, as a result of barriers put up by pharmacies, hospitals, and public health agencies, rendering the vast majority of healthcare providers helpless to protect their patients in the face of disease. Physicians are now advising their patients to simply go home (allowing the virus to replicate) and return when their disease worsens, resulting in hundreds of thousands of unnecessary patient deaths, due to failure-to-treat;

WHEREAS, this is not medicine. This is not care. These policies may actually constitute crimes against humanity.

NOW THEREFORE, IT IS:

RESOLVED, that the physician-patient relationship must be restored. The very heart of medicine is this relationship, which allows physicians to best understand their patients and their illnesses, to formulate treatments that give the best chance for success, while the patient is an active participant in their care.



RESOLVED, that we invite physicians of the world and all health care providers to join us in this noble cause as we endeavor to restore trust, integrity and professionalism to the practice of medicine.

RESOLVED, that we invite the scientists of the world, who are skilled in biomedical research and uphold the highest ethical and moral standards, to insist on their ability to conduct and publish objective, empirical research without fear of reprisal upon their careers, reputations and livelihoods.

RESOLVED, that we invite patients, who believe in the importance of the physician-patient relationship and the ability to be active participants in their care, to demand access to science-based medical care.



What's Insane in This? BREAKDOWN OF COVID DEATHS IN THE U.S. BY AGE

According to the U.S. Centers for Disease Control (CDC), very few people under age 19 have died of Covid. Of the total deaths attributed to Covid (700,951),

181 were age 0-4 and 406 were 5-18, for a total of 587 deaths in the 0-18 age category (or .08% of the total) ("Provisional Covid-19 Deaths," data.cdc.gov, Oct. 6, 2021).

The CDC does not list comorbidities for children, so it is impossible to know whether they died of Covid alone or of cancer, heart or kidney disease, etc., exacerbated by Covid, but of the pediatric deaths by influenza in the 2019-2020 season, 43% had a pre-existing medical condition ("2019-20 Season's Pediatric Flu Deaths," CDC, Aug. 21, 2020).

More than half of the deaths attributed to Covid by the CDC were of the elderly 75 and over (378,496 or 54%). The U.S. life expectancy is about 78 years old.

FROM NBC NEWS on Thursday, October 14th: The Biden administration has purchased 65 million pediatric doses of the Pfizer/BioNTech vaccine, enough to vaccinate (poison) the estimated 28 million children who would be eligible should the Food and Drug Administration approve Pfizer's request to vaccinate children ages 5 to 11, said an official of the Department of Health and Human Services.

Pfizer and BioNTech said this month that they had submitted an emergency request for authorization for children ages 5 to 11, and an FDA advisory committee plans to meet to discuss the request on October 26.
