### **Four Parasites Found in Pfizer and Moderna COVID911 Jabs**

Ramola D of The Everyday Concerned Citizen is new to me and I love the way she presents information and puts things together.

She has an update for us on the now FOUR different kinds of parasite that have been imaged in the Pfizer and Moderna vials.

We've previously spoken about the findings of microscopy expert, Dr. Robert Young, who published his images of the contents of the four publicly-available jabs using various methods, including Phase Contrast Microscopy, Transmission and Scanning Electron Microscopy and Energy-Dispersive X-Ray Spectroscopy. It was Dr. Young who first reported to have found Trypanosoma cruzi in the vaccines.

Ramola reads recent entries in the VAERS system that corroborates Dr. Young's findings. One tells of a woman who is a regular blood donor and that after her second vaccination, her blood donation tested positive for the Trypanosoma cruzi parasite, the same as what Dr. Young found in the vaxx.

These parasites are transmissible by blood and organ donation and they cause incurable Chagas disease. Luckily, donor organs and blood are now routinely screened for Chagas antibodies – and that's how these were discovered.

Myocarditis and fluid accumulation around the heart have been reported in many vaxxed people (often, in the young and athletic). These are known severe symptoms of early-stage Chagas disease.

Ramola finds the three other cases of people reported in VAERS who were screened for this parasite (two teenagers and a 60-year-old) had all presented with heart problems after being vaxxed. She's then surprised to find it's now becoming routine to screen all vaxxed patients with heart issues for *T. cruzi*.

Ramola found an additional three people in the VAERS system, whose symptoms were labeled as "*Trypanosoma brucei*". *T. brucei* is protozoan related to *T. cruzi* from Africa that causes sleeping sickness in humans.

Patients listed in VAERS as suffering from the symptoms of sleeping sickness are having their symptoms labeled as this exotic parasite species, which does not affect members of the US population. Ramola says this points to an awareness within the medical community that there are parasites in the vaxx.

Interestingly, a primary drug used to treat infection with *T. brucei* is suramin, which has been touted in the health freedom community for much of 2021 as helpful in mitigating the effects of the vaxx – and of the spike proteins being shed by the vaxxed.

Ramola dives deeper into the transhumanist potentials of *Hydra vulgaris* and other Cnidaria species and other interesting findings in this most thorough report I've yet seen on the topic.

### BREAKDOWN OF COVID DEATHS IN THE U.S. BY AGE

According to the U.S. Centers for Disease Control (CDC), very few people under age 19 have died of Covid. Of the total deaths attributed to Covid (700,951),

**181** were age 0-4 and

**406** were 5-18, for a total of 587

deaths in the 0-18 age category (or .08% of the total)

("Provisional Covid-19 Deaths," data.cdc.gov, Oct. 6, 2021).

The CDC does not list comorbidities for children, so it is impossible to know whether they died of Covid alone or of cancer, heart or kidney disease, etc., exacerbated by Covid, **but of the pediatric deaths by influenza in the 2019-2020 season, 43% had a pre-existing medical condition** ("2019-20 Season's Pediatric Flu Deaths," CDC, Aug. 21, 2020).

More than half of the deaths attributed to Covid by the CDC were of the elderly 75 and over (378,496 or 54%). The U.S. life expectancy is about 78 years old.

**FROM NBC NEWS on Thursday, October 14th:** The Biden administration has purchased 65 million pediatric doses of the Pfizer/BioNTech vaccine, enough to

vaccinate (poison) the estimated 28 million children who would be eligible should the Food and Drug Administration approve Pfizer's request to vaccinate children ages 5 to 11, **said an official of the Department of Health and Human Services.**

Pfizer and BioNTech said this month that they had submitted an emergency request for authorization for children ages 5 to 11, and an FDA advisory committee plans to meet to discuss the request on October 26. The vaccine doses for the youngest age group wouldn't be interchangeable with those for adults, who have different dosage and dilution requirements.

Government threatens to keep lockdowns and restrictions in place until children are mass injected.

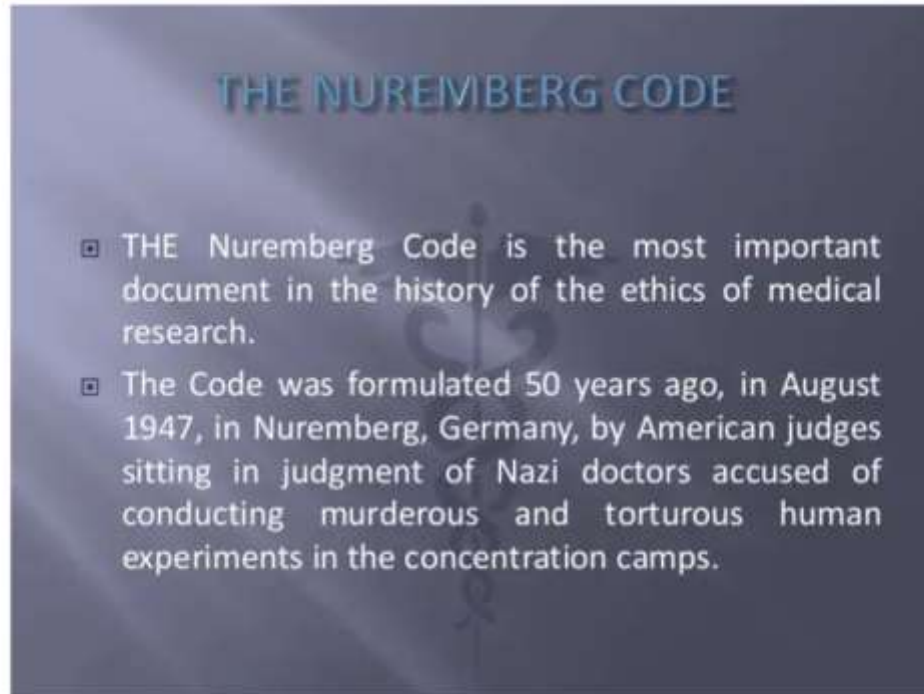

**1,000 Lawyers and 10,000 Doctors Have Filed a Lawsuit for COVID-19

**A large team of more than 1,000 lawyers and over 10,000 medical experts, led by Dr. Reiner Fuellmich, has initiated legal proceedings against the Centers for Disease Control (CDC), World Health Organization (WHO), and the Davos Group, for crimes against humanity.**

**Fuellmich and his team present the incorrect PCR test and the order for doctors to describe any comorbidity death as a Covid death – as fraud.**

**The PCR test was never designed to detect pathogens and is 100% inaccurate at 35 cycles. All PCR tests monitored by the CDC are set at 37 to 45 cycles. The CDC acknowledges that tests over 28 cycles are not allowed for a positive reliable result.**

**This invalidates over 90% of the alleged Covid cases / “infections” detected by the use of this incorrect test.**

**In addition to the incorrect tests and fraudulent death certificates, the “experimental” vaccine itself violates Article 32 of the Geneva Convention.**

**Under Article 32 of the 1949 Geneva Convention, “mutilation and medical or scientific experiments not required for the medical treatment of a protected person” are prohibited.**

**According to Article 147, conducting biological experiments on protected persons is a serious breach of the Convention.**

**The “experimental” vaccine violates all 10 Nuremberg codes – which carry the death penalty for those who try to break these international laws.**

**1) Provides immunity to the virus**

**This is a “leaky” gene therapy that does not provide immunity to Covid and claims that they reduce the symptoms, but double-vaccinated are now 60% of patients who need ER or ICU with covid infections.**

**2) Protects the recipients from getting the virus**

**This gene therapy does not provide immunity and the double vaccine can still catch and spread the virus.**

**3) Reduces deaths due to viral infection**

**This gene therapy does not reduce deaths from the infection. Double-vaccinated people infected with Covid have also died.**

**4) Reduces the circulation of the virus**

**This gene therapy still allows the virus to spread because it gives zero immunity to the virus.**

**5) Reduces the transmission of the virus**

**This gene therapy still allows transmission of the virus because it does not confer immunity to the virus.**

**The following violations of the Nuremberg Code apply:**

**Nuremberg Code # 1: Voluntary consent is important**

**No person should be forced to take a medical experiment without informed consent.**

**Many media, political and non-medical people urge people to take the injection.**

**They do not provide information about the negative effects or dangers of this gene therapy. All you hear from them is – “safe and effective” and “the benefits outweigh the risks.”**

**Countries use blockades, coercion and threats to force people to take this vaccine or are banned from participating in free society under the mandate of a vaccine pass or Green Pass.**

**During the Nuremberg trials, the media were also prosecuted and members were killed for lying to the public, along with many of the doctors and Nazis found guilty of crimes against humanity.**

**Nuremberg Code # 2: Yields with fruitful results that cannot be produced by other means**

**As mentioned above, gene therapy does not meet the criteria for a vaccine and does not offer immunity to the virus. There are other medical treatments that give fruitful results against Covid, such as Ivermectin, vitamin D, vitamin C, zinc and strengthened immune system for flu and colds.**

**Nuremberg Code # 3: Basic experiments as a result of animal experiments and natural history disease**

**This gene therapy skipped animal experiments and went directly to human experiments.**

**In mRNA research used by Pfizer – a candidate study on mRNA with rhesus macaques monkeys using BNT162b2 mRNA and in that study all monkeys developed pneumonia but the researchers considered the risk low because these were young healthy monkeys from 2-4 years of age.**

**Israel has used Pfizer and the International Court of Justice has accepted a requirement that 80% of recipients with pneumonia should be injected with this gene therapy.**

**Despite this alarming development, Pfizer continued to develop its mRNA for Covid, without animal testing.**

**Nuremberg Code # 4: Avoid all unnecessary suffering and injury**

**Since the launch of the experiment and listed under the CDC VAERS reporting system, over 4,000 deaths and 50,000 vaccine injuries have been reported in the United States. In the EU, more than 7,000 deaths and 365,000 vaccine injuries have been reported. This is a serious violation of this code.**

**Nuremberg Code # 5: No experiment should be performed if there is reason to believe that injury or death will occur**

**See No. 4, based on fact-based medical data, this gene therapy causes death and injury. Previous research on mRNA also shows several risks that have been ignored for this current experimental gene experiment. A 2002 study of SARS-CoV-1 nail proteins showed that they cause inflammation, immunopathology, blood clots and inhibit Angiotensin 2 expression. This experiment forces the body to produce this nail protein that inherits all these risks.**

**Nuremberg Code # 6: The risk should never exceed the benefit**

**Covid-19 has a recovery rate of 98-99%. Vaccine damage, death, and adverse side effects of mRNA gene therapy far outweigh this risk.**

**The use of “leaky” vaccines was banned for agricultural use by the US and the EU due to the Marek Chicken study which shows “hot viruses” and variants appear... make the disease even more deadly.**

**Nevertheless, this has been ignored for human use by the CDC aware that the risk of new, more deadly variants arises from leaky vaccinations. The CDC is fully aware that the use of leaky vaccines facilitates the emergence of hotter (more deadly) strains. Yet they have ignored this when it comes to humans**

**Nuremberg Code # 7: Preparations must be made for even remote possibilities of injury, disability or death**

**No preparations were made. This gene therapy skipped animal experiments. The pharmaceutical companies’ own clinical phase 3 studies will not end until 2022/2023. These vaccines were approved in an emergency**

**Use only action to force on a misinformed public. They are NOT FDA approved.**

**Nuremberg Code # 8: Experiments must be carried out by scientifically qualified persons**

**Politicians, the media and actors who claim that this is a safe and effective vaccine are not qualified. Propaganda is not medical science.**

**Many stores such as Walmart & drive-through vaccine centers are not qualified to administer experimental medical gene therapies to the uninformed public.**

**Nuremberg Code # 9: Everyone must have the freedom to end the experiment at any time**

**Despite the call from over 85,000 doctors, nurses, virologists and epidemiologists – the experiment does not end. In fact, there are currently many attempts to change laws to enforce vaccine compliance.**

**This includes mandatory and mandatory vaccinations. Experimental “sprayers” are planned every six months without using the growing number of deaths and injuries already caused by this experiment.**

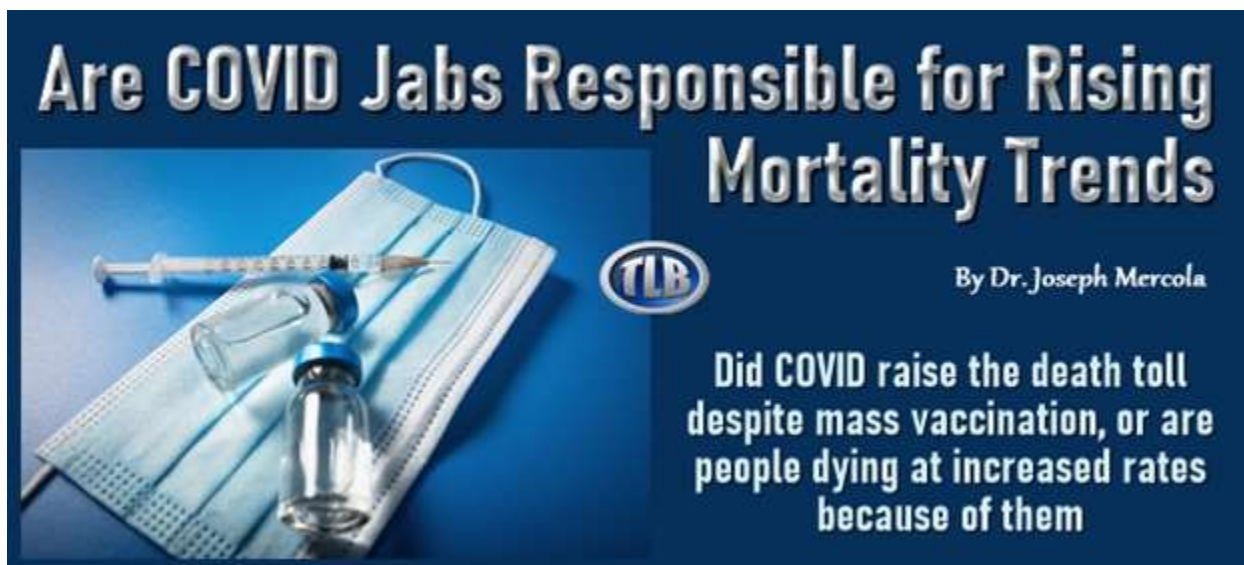
**These update images will be administered without any clinical trials. Hopefully, this new Nuremberg trial will put an end to this crime against humanity.**

## **Are the COVID Jabs Responsible for Rising Mortality Trends?**

*Analysis by Dr. Joseph Mercola*

According to all-cause mortality statistics,<sup>1</sup> the number of Americans who have died between January 2021 and August 2021 is 16% higher than 2018, the pre-COVID year with the highest all-cause mortality, and 18% higher than the average death rate between 2015 and 2019. Adjusted for population growth of about 0.6% annually, the mortality rate in 2021 is 16% above the average and 14% above the 2018 rate.

The obvious question is, why did more people die in 2021 (January through August) despite the rollout of COVID shots in December 2020? Did COVID-19 raise the death toll despite mass vaccination, or are people dying at increased rates because of the COVID jabs?

### **Vaccine-Induced Mortality**

In a two-part series,<sup>2</sup> Matthew Crawford of the Rounding the Earth Newsletter, examined mortality statistics before and after the rollout of the COVID shots. In Part 1,<sup>3</sup> he revealed the shots killed an estimated 1,018 people per million doses administered (note, this is doses, not the number of individuals vaccinated) during the first 30 days of the European vaccination campaign.

Between 800,000 and 2 million so-called ‘COVID-19 deaths’ may in fact be vaccine-induced deaths.

After adjusting for deaths categorized as COVID-19 deaths, he came up with an estimate of 200 to 500 deaths per million doses administered. With 4 billion doses having been administered around the world, that means 800,000 to 2 million so-called “COVID-19 deaths” may in fact be vaccine-induced deaths. As explained by Crawford:<sup>4</sup>

*“This does not even include vaccine-induced deaths that have not been recorded as COVID cases, though I suspect that latter number is smaller since the only good way to hide the vaccine mortality signal is to smuggle deaths through the already-established COVID death toll.”*

Corroborating Crawford’s calculations are data from Norway, where 23 deaths were reported following the COVID jab at a time when only 40,000 Norwegians had received the shot.



Not taking into account the possibility of underreporting in Norway, that gives us a mortality rate of 575 deaths per million doses administered. What's more, after conducting autopsies on 13 of those deaths, all 13 were determined to be linked to the COVID jab. As reported by Norway Today back in January 2021:<sup>5</sup>

*“The reports might indicate that common side effects from mRNA vaccines, such as fever and nausea, may have led to deaths in some frail patients,” chief physician Sigurd Hortemo in the Norwegian Medicines Agency noted.*

*The Norwegian Medicines Agency and the National Institute of Public Health (FHI) jointly assess all side effects reports. As a result, the FHI has updated the corona vaccination guide with new advice on the vaccination of frail elderly people.*

*‘If you are very frail, you should probably not be vaccinated,’ Steinar Madsen at the Norwegian Medicines Agency said at a webinar on corona vaccine for journalists ...”*

**Is the COVID Jab Responsible for Excess Deaths?**

Crawford goes on to look at data from countries that have substantial vaccine uptake while simultaneously having very low rates of COVID-19. This way, you can get a better idea as to whether the COVID jabs might be responsible for the excess deaths, as opposed to the infection itself.

He identified 23 countries that fit these criteria, accounting for 1.88 billion individuals, roughly one-quarter of the global population. Before the COVID jabs rolled out, these nations reported a total of 103.2 COVID-related deaths per million residents. Five nations had more than 200 COVID deaths per million while seven had fewer than 10 deaths per million.

As of August 1, 2021, 25.35% of inhabitants in these 23 nations had received a COVID jab and 10.36% were considered fully vaccinated. In all, 673 million doses had been administered. Based on these data, Crawford estimates the excess death rate per million vaccine doses is 411, well within the window of the 200 to 500 range he calculated in Part 1.

Equally intriguing is the finding that the number of new COVID cases (i.e., positive tests) after the start of the COVID jab campaign is 3.8 times higher than it was before the rollout of the shots, and the daily COVID death rate is 3.82 times higher.

Morocco and Saudi Arabia were the only two nations in which the case rate and COVID death rates went down after the vaccination campaign started. “If deaths were scaled by 3.82 due to the vaccines, then there were 276,465 excess deaths during this time span,” Crawford writes.

He goes through a number of adjustments to remove outliers that might skew the data sets, so for a more detailed review, see the original article. But in summary, after removing nations with more than 100 COVID deaths per million before their vaccination program (to evaluate the impact of the shots alone), he came up with 13 countries with a combined population of 354 million.

The number of doses administered in these 13 countries is similar to the original cohort. The adjusted number of excess deaths per million is now 318, which is still within the 200 to 500 per million range.

Remarkably, though, the number of COVID deaths in these 13 countries is 11.61 times higher post-vaccination, compared to before the jabs were rolled out. In five of the 13 countries, a whopping 90% of their COVID-19 fatalities have been logged after their vaccination campaigns began! This obliterates any fantasy that the COVID injections are actually helping.

*“On face, these results reinforce the case that the experimental vaccines are killing people,” Crawford writes. “At the very least, this is one more dramatic [lack of] safety signal that should spur authorities who care about our health to come to the table for a discussion about how to refine the data they’re not analyzing to anyone’s knowledge ...*

*More concerning is that numerous of these nations — largely located in Asia — seemed to have no susceptibility at all to the pandemic prior to vaccination. There are a lot of theories as to why this might be aside from just vaccines triggering deaths.*

- *Might PCR testing pick up signals from attenuated virus vaccines, resulting in case explosions (from almost none) to match the [new] deaths?*
- *Could some of these vaccines have faulty production ... during polio vaccine rollout? This could result in cases and deaths?*
- *Paraguay has by far the greatest signal of vaccine-induced mortality. It stands out as one of the only nations on Earth to use both Chinese and also Western vaccines. Is there any reason such a combination could result in more volatile disease spread?*
- *Do we really believe that the braintrust at the FDA and CDC are entirely unaware of these observations?*

*Meanwhile, health authorities still seem to have no issue with the lack of risk report or risk-benefit analysis performed by any of the vaccine manufacturers or anyone else. This strikes me as one of the worst signs in my lifetime that corporations have taken over government on an essentially complete level.”*

### **US Whistleblower Highlights Under-reporting**

In mid-July 2021, America's Frontline Doctors, represented by Renz Law,<sup>6</sup> filed a lawsuit<sup>7</sup> against the secretary of the U.S. Department of Health and Human Services, Xavier Becerra. In that lawsuit, they cite whistleblower testimony by a computer programmer with expertise in health care data analytics and access to Medicare and Medicaid data maintained by the Centers for Medicare and Medicaid Services (CMS).

According to this whistleblower, the U.S. Vaccine Adverse Event Reporting System (VAERS) under-reports deaths caused by the COVID shots by a conservative factor of five or more. She claims the number of Americans killed by the shots was at least 45,000 as of July 9, 2021.

At that time, VAERS reported 9,048 deaths following COVID injection. That number is now 16,310 (as of October 1, 2021<sup>8</sup>). Using an under-reporting factor of five, that gives us an estimated death toll of 81,550.

### **COVID Shots May Have Killed More Than 200,000 in the U.S.**

Steve Kirsch, executive director of the COVID-19 Early Treatment Fund, has come up with even more drastic numbers. In the video "Vaccine Secrets: COVID Crisis,"<sup>9</sup> he argues that VAERS can be used to determine causality, and shows how the VAERS data indicate more than 212,000 Americans have already been killed by the COVID shots.<sup>10</sup>

Anywhere from 2 million to 5 million have also been injured by them in some way. Kirsch is so confident in his analyses, he's offered a \$1 million academic grant to anyone who can show his analysis is flawed by a factor of four or more. He's even offered \$1 million to any official willing to simply have a public debate with him about the data, and none has accepted the challenge.

### **Woman's Obituary Blames COVID Vaccine for Her Death**

While it may be challenging to determine exactly how many people have died as a direct result of the COVID shots, we can be certain that deaths are occurring.

One Oregon woman's obituary<sup>11</sup> went viral after her family blamed side effects of the COVID-19 vaccine on her death. The family minced no words, calling out state and local governments for their "heavy-handed vaccine mandates." Jessica Berg Wilson left behind a husband and two young daughters, aged 5 and 3.

*"Jessica Berg Wilson, 37, of Seattle, Washington, passed away unexpectedly September 7, 2021 from COVID-19 vaccine-induced thrombotic thrombocytopenia (VITT) surrounded by her loving family," the obituary states.<sup>12</sup>*

*"Jessica was an exceptionally healthy and vibrant 37-year-old young mother with no underlying health conditions ... Local and state governments were determined to strip away her right to consult her wisdom and enjoy her freedom.*

***She had been vehemently opposed to taking the vaccine, knowing she was in good health and of a young age and thus not at risk for serious illness. In her mind, the known and unknown risks of the unproven vaccine were more of a threat.***

***But, slowly, day by day, her freedom to choose was stripped away. Her passion to be actively involved in her children's education — which included being a Room Mom — was, once again, blocked by government mandate.***

***Ultimately, those who closed doors and separated mothers from their children prevailed. It cost Jessica her life. It cost her children the loving embrace of their caring mother. And it cost her husband the sacred love of his devoted wife."***

### **COVID Jab Effects Are Rapidly Waning**

**To add insult to injury, there's ample evidence showing that whatever benefit you glean from the COVID jab is short-lived, requiring you to risk life and limb yet again with another booster shot (and probably more to come after that).**

**If you need a refresher on the potential mechanisms of harm, download and read Stephanie Seneff's excellent paper,<sup>13</sup> ["Worse Than The Disease: Reviewing Some Possible Unintended Consequences of mRNA Vaccines Against COVID-19,"](#) published in the International Journal of Vaccine Theory, Practice and Research in collaboration with Dr. Greg Nigh.**

**Among those incriminating data sets is an analysis by Humetrix,<sup>14</sup> which assessed the effectiveness of mRNA COVID-19 vaccines against the delta variant among 5.6 million Medicare beneficiaries, aged 65 and older. Three key questions answered by the data analysis are:**

1. Is vaccine effectiveness waning over time?
2. Is vaccine effectiveness reduced for the delta variant?
3. Does the need for a booster shot vary by sub-population?

The executive summary lays out the answers:

1. Yes, the effectiveness of both Moderna and Pfizer's injections rapidly wane in this cohort.
2. As of mid-August 2021, the vaccine effectiveness against delta infection was only 41% and effectiveness against hospitalization due to the delta variant was 62%, both of which are "lower than previously reported."
3. The shots were even less effective in those over the age of 75, and a breakthrough hospitalization risk model suggests prioritizing people over age 65 for boosters.

#### **Breakthrough Infections Don't Seem so Rare in the Elderly**

According to Humetrix, between January 2021 and August 14, 2021, 5.6 million Medicare beneficiaries (out of 20 million) were fully vaccinated with either two doses of Pfizer or Moderna, or one dose of Janssen.

Of those, 148,000 experienced a breakthrough infection, 30,000 required hospitalization and 9,400 needed intensive care. That means breakthrough infections in this age group occur at a rate of about 1 in 38, which doesn't strike me as being particularly rare.

As per Centers for Disease Control and Prevention guidance, patients were only considered fully vaccinated two weeks after the second dose. So, anyone who developed COVID-19 symptoms before then were not counted.

While the analysis reports success, saying the hospitalization rate for breakthrough infections was reduced by one-third compared to the hospitalization rate between March and December 2020, and the death rate in breakthrough infections was reduced six-fold, a central problem remains.

The shots don't protect you for very long. As shown on Page 8 of the PowerPoint, the breakthrough infection rate at five and six months' post-vaccination is double the rate at three and four months' post-vaccination.

Considering the risk of lethal vaccine injury is elevated in the elderly — as noted by the Norwegian Medicines Agency — starting them on a treadmill of booster shots strikes me as an idea that can only end in heartbreak for families around the world.

## **17,000+ Deaths Reported After COVID Vaccines, Including New Report of 12-Year-Old Who Died After Pfizer Vaccine**

VAERS data released Friday by the CDC included a total of **818,044 reports of adverse events** from all age groups following COVID vaccines, including **17,128 deaths** and **122,833 serious injuries** between Dec. 14, 2020, and Oct. 15, 2021.

Data released Friday by the Centers for Disease Control and Prevention (CDC) showed that between Dec. 14, 2020, and Oct. 15, 2021, a total of [818,044 adverse events](#) following COVID vaccines were reported to the Vaccine Adverse Event Reporting System (VAERS).

The data included a total of [17,128 reports of deaths](#) — an increase of 362 over the previous week, and a [new report](#) of a 12-year-old who died after getting the Pfizer vaccine.

There were [117,399 reports of serious injuries](#), including deaths, during the same time period — up 5,434 compared with the previous week.

Excluding “[foreign reports](#)” to VAERS, [612,125 adverse events](#), including [7,848 deaths](#) and [50,225 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and Oct. 15, 2021.

Of the 7,848 U.S. deaths reported as of Oct. 15, [11% occurred](#) within 24 hours of vaccination, [15% occurred](#) within 48 hours of vaccination and [28% occurred](#) in people who experienced an onset of symptoms within 48 hours of being vaccinated.

In the U.S., 406.1 million COVID vaccine doses had been administered as of Oct. 15. This [includes](#): 237 million doses of [Pfizer](#), 154 million doses of [Moderna](#) and 15 million doses of [Johnson & Johnson](#) (J&J).

The data come directly from reports submitted to VAERS, the primary government-funded system for reporting adverse vaccine reactions in the U.S.

Every Friday, [VAERS](#) makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Historically, VAERS has been shown to report only [1% of actual vaccine adverse events](#)

### This week's U.S. data for 12- to 17-year-olds show:

- [21,921](#) total adverse events, including [1,325 rated as serious](#) and [25 reported deaths](#). Two of the 25 deaths were suicides.

The most recent death involves a 12-year-old girl ([VAERS I.D. 1784945](#)) who died from a [respiratory tract hemorrhage](#) 22 days after receiving her first dose of Pfizer's vaccine. Another recent death includes a 15-year-old male who died six days after receiving his first dose of Pfizer's COVID vaccine. According to his VAERS report ([VAERS I.D. 1764974](#)), the previously healthy teen complained of brief unilateral shoulder pain five days after receiving his COVID vaccine.

The next day he played with two friends at a community pond, swung on a rope swing, flipped into the air, and landed in the water feet first. He surfaced, laughed and told his friends "Wow, that hurt!" He then swam toward shore underwater, as was his usual routine, but did not re-emerge.

An autopsy showed no external indication of a head injury, but there was a small subgaleal hemorrhage — a rare, but lethal [bleeding disorder](#) — over the left occiput. In addition, the boy had a mildly elevated cardiac mass, increased left ventricular wall thickness and small foci of myocardial inflammation of the lateral wall of the left ventricle with myocyte necrosis consistent with [myocardial infarction](#).

- [57 reports](#) of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death — with 96% of cases attributed to [Pfizer's vaccine](#).
- [535 reports](#) of myocarditis and pericarditis (heart inflammation) with [527 cases](#) attributed to Pfizer's vaccine.
- [119 reports](#) of blood clotting disorders, with all cases attributed to Pfizer.

### **Michigan woman died from blood clots after J&J vaccine, autopsy confirms**

A 60-year-old woman [died from blood clots](#) after receiving J&J's COVID vaccine, according to an autopsy report released Sept. 20 by Dr. Michael Caplan, a forensic pathologist at [Michigan Medicine](#).

Autopsy confirms 60-year-old Sandra Jacobs died from cerebral venous sinus thrombosis, a rare blood-clotting disorder, after receiving Johnson & Johnson's COVID vaccine.

Sandra Jacobs "appears to have succumbed" to a "rare but nevertheless documented" complication associated with the viral vector vaccine — [cerebral venous sinus thrombosis](#) (CVST) — Caplan wrote in the summary. This condition brought about "hemorrhagic cerebral infarct," or stroke caused by brain bleeding, and brain swelling, [Caplan wrote](#).

The death certificate listed the cause of death as "complications of cerebral venous sinus thrombosis" and "recent administration" of a COVID vaccine as the contributing condition.

Caplan deemed the manner of death "natural," but said it may also be considered a "therapeutic complication" since this is a known vaccine issue. Under "final diagnosis," Caplan first listed the COVID vaccine.



Jacobs died 13 days after [receiving](#) the single-dose J&J vaccine at a CVS pharmacy on April 8 — just five days before federal health agencies [temporarily paused](#) the vaccine while they examined an unusual blood-clotting disorder.

### **FDA clears Moderna and J&J COVID vaccine boosters, allows ‘mix-and-match’ shots**

The U.S. Food and Drug Administration (FDA) on Wednesday authorized booster doses of both J&J’s and Moderna’s COVID vaccines, [CNBC reported](#). U.S. regulators also authorized “mixing and matching” vaccines — allowing Americans to get a booster of a different COVID vaccine than their initial doses.

In an [email to The Defender](#), Dr. Brian Hooker Ph.D., P.E., [Children’s Health Defense](#) chief scientific officer and professor of biology at Simpson University said:

*“To my best knowledge, the data that FDA used to make these assertions [that mix-and-match boosters are safe] doesn’t exist. Israel, which has the most aggressive booster program in the world, distributes Pfizer vaccines only. At this point, my strong assumption is that they’re doing anything and everything they can to assure vaccine compliance, despite the huge numbers of vaccine injuries reported on VAERS.”*

The FDA’s [decision](#) was handed off to the CDC’s vaccine advisory committee, which met Thursday to discuss Moderna’s and J&J’s booster data. Dr. Rochelle Walensky, CDC director, endorsed the advisory committee’s recommendations, [expanding eligibility for COVID booster](#) shots to include people:

- 65 years and older.
- Age 18+ who live in long-term care settings.
- Age 18+ who have underlying medical conditions.
- Age 18+ who work or live in high-risk settings.

For the nearly 15 million people who got the J&J shot, booster doses are recommended for those who are 18 and older and who were vaccinated two or more months ago.

According to CDC data, the [most common side effects](#) reported after getting a third shot of Pfizer or Moderna were pain at the injection site, fatigue, muscle pain, headache and fever, followed by chills and nausea.

The data available for J&J was more limited, but people reported fever, fatigue and headache after receiving a second dose, according to the agency.

### **White House, CDC prepare to vaccinate 5- to 11-year-olds prior to FDA authorization**

The White House, on Oct. 20, [unveiled plans](#) to roll out COVID vaccines for children ages 5 to 11, even though vaccine safety experts — who advise U.S. drug regulators and review safety and efficacy data — have not yet met to discuss whether Pfizer’s COVID vaccine should be authorized for use in the pediatric age group.

The Biden administration said it will secure enough vaccine doses to vaccinate the 28 million children ages 5 to 11 who would become eligible if the vaccine is authorized for that age group.

The White House will also help equip more than 25,000 pediatric and primary care offices, hundreds of community health centers and rural health clinics and thousands of [pharmacies](#) to administer the shot,

The CDC last week [issued guidance](#) outlining key aspects of a COVID vaccination program for children younger than 12 years old “designed to [inform jurisdictional planning](#) under the assumption of FDA authorization and CDC recommendations of at least one COVID-19 vaccine product for children of this age.”

Beginning Oct. 20, states and other jurisdictions could preorder doses of the Pfizer-BioNTech COVID vaccine formulated for children ages 5 to 11, in anticipation of a rollout that could begin as early as Nov. 3.

### **FDA delays decision on Moderna vaccine for adolescents citing heart problems**

The FDA is [delaying a decision](#) on authorizing Moderna’s COVID vaccine for adolescents to assess whether the shot may lead to a heightened risk of a rare inflammatory heart condition, according to the [Wall Street Journal](#).

The FDA’s review of Moderna’s application is ongoing, an FDA spokesperson [told Reuters](#), adding that while the agency cannot predict how long the process may take, it is evaluating the data as expeditiously as possible.

In June, the FDA [added a warning](#) to the literature accompanying Pfizer and Moderna mRNA COVID vaccines, to indicate an increased risk of myocarditis. However in May, a few weeks before the FDA added the warning, the agency authorized Pfizer’s [COVID vaccine](#) for ages 12 to 17, despite the [known risk](#) of myocarditis.

### **Scientists concerned mRNA boosters could cause heart inflammation in young adults**

The risk of mRNA COVID booster shots [causing heart inflammation](#) in young adults continues to [worry top scientists](#), Dr. Ofer Levy, director of the Precision Vaccines Program at Boston Children’s Hospital and voting member of the FDA’s advisory panel, said last week.

Some committee members voiced concern about authorizing a third mRNA dose for people 12 and older, due to the risk of two rare heart inflammation conditions — myocarditis and pericarditis.

Levy said younger age groups are [less at personal risk](#) of severe COVID, but “somewhat more at risk of this inflammatory heart condition with mRNA vaccines.”

“So it’s a risk-benefit analysis, and that’s why you’re seeing that deliberation,” Levy told CNBC’s [Closing Bell](#).

## **French health regulator suspends Moderna boosters over myocarditis concerns**

As [The Defender reported](#), France's health regulator said Oct. 15, it would no longer allow booster doses of Moderna's COVID vaccine. Only Pfizer-BioNTech's vaccine will be used for the booster campaign moving forward.

The new recommendation applies to people over 65, immunocompromised people and their relatives and people at risk — including healthcare workers. The announcement came amid reports that Sweden, Denmark, Norway, Iceland and Finland [suspended use](#) of Moderna's COVID vaccine for certain age groups over reports of heart inflammation.

Table 18 of the [report](#) confirms that the majority of Covid-19 cases were among the fully vaccinated population in the week beginning September 18th 2021, accounting for 37,992 cases. Whilst the not-vaccinated population did not lag far behind recording 32,217 cases.

The totals number of cases by vaccination status as confirmed by the above table between September 18th and October 15th 2021 were as follows –

- Not-vaccinated population = 32,217 cases
- Partly vaccinated population = 3,971 cases
- Fully-vaccinated population = 37,992 cases

This means the vaccinated population accounted for 56% of Covid-19 cases between September 18th and October 15th, whilst the not-vaccinated population accounted for 44%.

However, the difference between the vaccinated and unvaccinated gets much worse when it comes to hospitalizations, with the fully vaccinated now accounting for the majority of Covid-19 hospitalizations since at least July 2021.

The above table shows that the not-vaccinated over-60's accounted for just 11% of Covid-19 hospitalizations between September 11th and October 15th, whilst the vaccinated over 60's accounted for 89%.

A similar trend can also be seen in the 30 to 59 year-old age group with the not-vaccinated accounting for just 38% of Covid-19 hospitalizations, whilst the vaccinated accounted for 62%.

The totals number of hospitalizations by vaccination status for all age groups between September 18th and October 15th 2021 as confirmed by table 19 of the PHS [report](#) were as follows –

- Not-vaccinated population = 684
- Partly vaccinated population = 81
- Fully vaccinated population = 1672

This means the vaccinated population accounted for 72% of Covid-19 hospitalizations between September 18th and October 15th 2021, whilst the not-vaccinated accounted for just 28%.

But yet again the difference between the vaccinated and unvaccinated gets much worse when it comes to deaths allegedly related to Covid-19.

Vaccination status is determined as at the date of positive PCR test according to the definitions described in Appendix 9. A confirmed COVID-19 related death is defined as an individual who has tested positive by PCR for SARS-CoV-2 at any time point and has COVID-19 listed as an underlying or contributory cause of death on the death certificate. Age-standardised mortality rates per 100,000 people per week, standardised to the 2013 European Standard Population (see Appendix 9). This definition is for the purposes of evaluating the impact of the COVID-19 vaccine on confirmed COVID-19 deaths. The numbers reported in this section may differ from other published COVID-19 death data. Data are based on date of registration. In Scotland deaths must be registered within 8 days although in practice, the average time between death and registration is around 3 days. More information on days between occurrence and registration can be found on the NRS website.

The totals number of alleged Covid-19 by vaccination status between September 11th and October 8th 2021 as confirmed by table 20 of the PHS [report](#) were as follows –

- Not-vaccinated population = 96 deaths
- Partly vaccinated population = 16 deaths
- Fully vaccinated population = 436 deaths

This means the vaccinated population accounted for 83% of Covid-19 deaths between September 11th and October 8th, whilst the not-vaccinated accounted for just 17%.

Some people may argue that this is expected if the majority of the population has been vaccinated. Which would be true if official data didn't show that the number of Covid-19 deaths in September / October, 2021 are over 2000% higher than the number recorded during the same period in 2020.

The above is for Scotland and we are seeing the pattern becoming evident in the U.S. From several sources, we are seeing a 400% increase in U.S. mortality rates. ### **White House To “Quickly” Vaccinate 28 Million Children Age 5-11 as Deaths and Injuries Continue to Increase among 12 to 19-Year-Olds Who Received a COVID-19 Shot**

The Biden administration on Wednesday unveiled its plan to ‘quickly’ vaccinate roughly 28 million children age 5-11, pending authorization from the Food and Drug Administration (FDA).

The jab – which [doesn't prevent transmission](#) of Covid-19 will be available at pediatricians, local pharmacies, and possibly even at schools, according to the White House, which expects FDA authorization of the Pfizer shot for children – the least likely to fall seriously ill or die from the virus, in a matter of weeks, according to the [Associated Press](#).

***Federal regulators will meet over the next two weeks to weigh the benefits of giving shots to kids, after lengthy studies meant to ensure the safety of the vaccines. Within hours of formal approval, expected after the Centers for Disease Control and Prevention advisory meeting scheduled for Nov. 2-3, [doses will begin shipping to providers across the country](#), along with smaller needles necessary for injecting young kids, and within days will be ready to go into the arms of kids on a wide scale. – AP***

According to the announcement, the White House has secured enough to supply more than 25,000 doses for pediatricians and primary care physicians who have already signed up to deliver the vaccine, while the country now has enough Pfizer vaccine to jab roughly **28 million kids** who will soon be eligible, meaning this won't be a slow roll-out like we saw 10 months ago when doses and capacity issues meant adults had to wait.

Meanwhile, **the White House is rolling out an ‘advertising’ campaign to convince parents and kids that the vaccine is safe and effective.** According to the report, “the administration believes trusted messengers — educators, doctors, and community leaders — will be vital to encouraging vaccinations.” ([Full article](#).)

There is actually no data supporting the claim that the Pfizer COVID-19 shot is “safe and effective” for children, and plenty of data showing that it is harmful, causing severe reactions such as death and heart disease.

The most recent data entered into the government's *Vaccine Adverse Event Reporting System* (VAERS) shows that for children and teenagers between the age of 12 and 19, there have been:

- 54 Deaths
- 315 Permanent Disabilities
- 4381 Visits to an Emergency Room
- 2433 Hospitalizations
- 465 Life Threatening Events

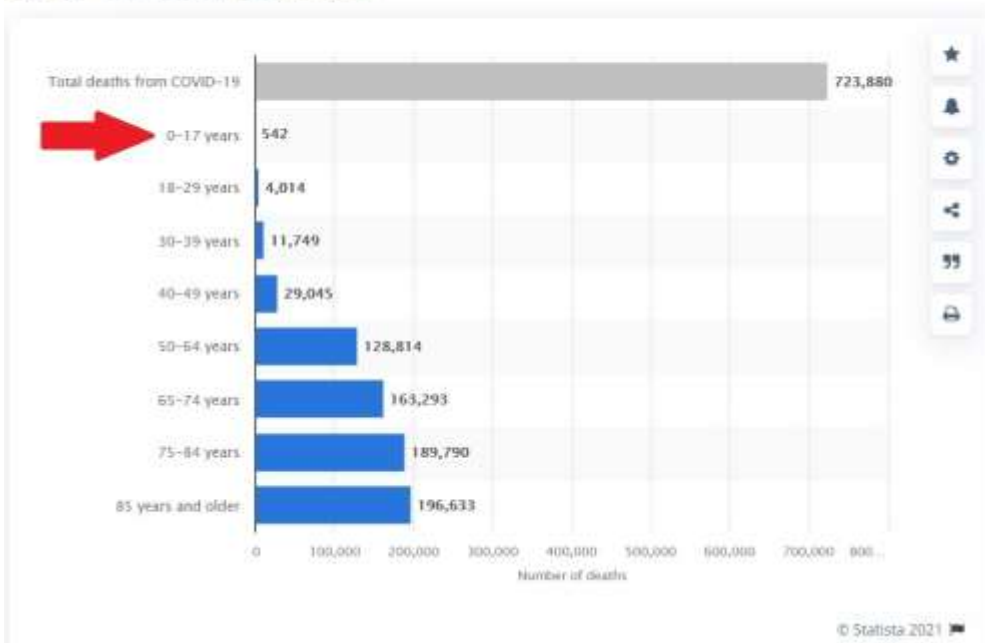
So the true numbers for adverse events from 12 to 19-year-olds would be closer to this:

- 2,268 Deaths
- 13,230 Permanent Disabilities
- 184,002 Visits to an Emergency Room
