
Allowing someone to inject your child with a needle is child abuse, and an act of belief on your part in the demonic world system the Bible teaches us to oppose.

BERLIN (<u>LifeSiteNews</u>) – The president of Bayer's Pharmaceuticals Division told international "experts" during a globalist health conference that the mRNA COVID-19 shots are indeed "<u>cell and gene therapy</u>" marketed as "vaccines" to be palatable to the public.

Stefan Oelrich, president of Bayer's Pharmaceuticals Division, made these comments at this year's World Health Summit, which took place in Berlin from October 24-26 and hosted 6,000 people from 120 countries. Oelrich told his fellow international "experts" from academia, politics, and the private sector that the novel mRNA COVID "vaccines" are actually "cell and gene therapy" that would have otherwise been rejected by the public if not for a "pandemic" and favorable marketing.

"We are really taking that leap [to drive innovation] – us as a company, Bayer – in cell and gene therapies ... ultimately the mRNA vaccines are an example for that cell and gene therapy. I always like to say: if we had surveyed two years ago in the public – 'would you be willing to take a gene or cell therapy and inject it into your body?' – we probably would have had a 95% refusal rate," stated Oelrich.

"Our successes over these 18 months [the duration of the COVID 'pandemic'] should embolden us to fully focus much more closely on access, innovation and collaboration to unleash health for all, especially as we enter, on top of everything else that is happening, a new era of science — a lot of people talk about the Bio Revolution in this context," continued the businessman.

According to the McKinsey Global Institute, the "Bio Revolution" is "a confluence of advances in biological science and accelerating development of computing, automation, and artificial intelligence [that] is fueling a new wave of innovation. This Bio Revolution could have significant impact on economies and our lives, from health and agriculture to consumer goods, and energy and materials."

In addition to <u>gene therapy</u> and a biological "revolution," Oelrich also mentioned the role his company has, along with other prominent institutions and figures, in pushing contraception on developing countries.

"We also need to focus on what is socially responsible outside of Europe and ensure sustainable action there. We pledged, this past year, to give an additional hundred million women access to contraception in the world. We've invested 400 million this year into new plants that are dedicated to produce long-acting contraceptives for women in low-and-middle income countries ... Together with Bill and Melinda Gates we're working very closely on family planning initiatives," said Oelrich, implying one of the methods of attaining a "sustainable" world is by reducing births, and subsequently reducing the planet's population.

Oelrich's words echo a similar agenda as the infamous "<u>Great Reset,</u>" a radical <u>socialist plan</u> designed by globalist elites, gathering at the World Economic Forum (WEF) in Davos, Switzerland once a year, <u>which</u> "seeks to 'push the reset button' on the global economy."

In the announcement of the Great Reset initiative, the WEF also credited the COVID-19 "pandemic" for putting them in an advantageous position to march towards their global revolutionary goals.

"COVID-19 lockdowns may be gradually easing, but anxiety about the world's social and economic prospects is only intensifying. There is good reason to worry: a sharp economic downturn has already begun, and we could be facing the worst depression since the 1930s. But, while this outcome is likely, it is not unavoidable," wrote the WEF's founder Klaus Schwab in June 2020.

But, "one silver lining of the pandemic is that it has shown how quickly we can make radical changes to our lifestyles. Almost instantly, the crisis forced businesses and individuals to abandon practices long claimed to be essential, from frequent air travel to working in an office," added the economist.

"To achieve a better outcome, the world must act jointly and swiftly to revamp all aspects of our societies and economies, from education to social contracts and working conditions. Every country, from the United States to China, must participate, and every industry, from oil and gas to tech, must be transformed. In short, we need a 'Great Reset' of capitalism," stressed Schwab.

Both Oelrich and Schwab have been major advocates for the widespread use of the novel and experimental mRNA COVID vaccines. These same shots, which <u>do not complete clinical trials</u> until 2023, have been linked to <u>millions of injuries</u> and tens of thousands of deaths worldwide.

Seemingly in line with Bayer, WEF, and the Gates Foundation's goal of reducing births, many of the notable COVID-19 vaccine adverse effects have also played a role in reducing births. World Health Organization (WHO) data <u>reports</u> many cases of stillbirths, vaginal hemorrhaging, menstrual cycle irregularities, and miscarriages linked to the injections.

According to an ex-vice president at Pfizer, Dr. Michael Yeadon, the COVID jabs present "a severe risk to your ability to conceive and carry a baby to term," and even worse, Yeadon says "[the infertility risks] are deliberate acts which I believe whoever is doing it is lying about it to hide it and they're smearing people who are trying to warn you."

Further pushing the birth control agenda, earlier this month the U.S. State Department announced a gift of \$5 million in taxpayer funds to the United Nations Population Fund (UNFPA) supplies program, another organization tied to Gates, which aids women abroad in accessing contraceptives, abortion-inducing drugs, and abortion-performing "manual vacuum aspirator" (MVA) devices. The U.N.'s "Sustainable Development Goals" seek to "Ensure universal access to sexual and reproductive health and reproductive rights," which is phraseology commonly used to refer to abortion and contraception.

Concluding his statements, the "globally thinking" Oelrich told the summit that the global health system "is not just about donating medicines, or giving medicines at a lower price. It is also being on-site to help put this into practice."

"I think this pandemic has also opened many people's eyes to innovation in a way that was not possible before," stated Oelrich. "We need to make sure that the knowledge

that is created in our universities, in our academia, is translated... before it goes into 'shiny' paper publications, it is translated into patents."

"In my vision I see a joint effort of government, working hand-in-hand with science organizations and civil society."

Vaccine Researcher Admits 'Big Mistake,' Says Spike Protein Is Dangerous 'Toxin'

"The coronavirus spike protein from COVID-19 vaccination unexpectedly enters the bloodstream"

'Terrifying' new research finds vaccine spike protein unexpectedly in bloodstream. The protein is linked to blood clots, heart and brain damage, and potential risks to nursing babies and fertility.

New research shows that the coronavirus spike protein from COVID-19 vaccination unexpectedly enters the bloodstream, which is a plausible explanation for thousands of reported side-effects from blood clots and heart disease to brain damage and reproductive issues, a Canadian cancer vaccine researcher said last week.

"We made a big mistake. We didn't realize it until now," said Byram Bridle, a viral immunologist and associate professor at University of Guelph, Ontario, in an interview with Alex Pierson last Thursday, in which he warned listeners that his message was "scary."

"We thought the spike protein was a great target antigen, we never knew the spike protein itself was a toxin and was a pathogenic protein. So by vaccinating people we are inadvertently inoculating them with a toxin," Bridle said on the show, which is not easily found in a Google search but went viral on the internet this weekend.

Bridle, a vaccine researcher who was awarded a \$230,000 government grant last year for research on COVID vaccine development, said that he and a group of international scientists filed a request for information from the Japanese regulatory agency to get access to what's called the "biodistribution study."

"It's the first time ever scientists have been privy to seeing where these messenger RNA [mRNA] vaccines go after vaccination," said Bridle. "Is it a safe assumption that it stays in the shoulder muscle? The short answer is: absolutely not. It's very disconcerting."

Vaccine researchers had assumed that novel mRNA COVID vaccines would behave like "traditional" vaccines and the vaccine spike protein — responsible for infection and its most severe symptoms — would remain mostly in the vaccination site at the shoulder muscle. Instead, the Japanese data showed that the infamous spike protein of the coronavirus gets into the blood where it circulates for several days post-vaccination and then accumulated in organs and tissues including the spleen, bone marrow, the liver, adrenal glands, and in "quite high concentrations" in the ovaries.

"We have known for a long time that the spike protein is a pathogenic protein. It is a toxin. It can cause damage in our body if it gets into circulation," Bridle said.

The SARS-CoV-2 spike protein is what allows it to infect human cells. Vaccine manufacturers chose to target the unique protein, making cells in the vaccinated person manufacture the protein which would then, in theory, evoke an immune response to the protein, preventing it from infecting cells.

A large number of studies has shown that the most severe effects of SARS-CoV-2, the virus that causes COVID-19, such as blood clotting and bleeding, are due to the effects of the spike protein of the virus itself

"What has been discovered by the scientific community is the spike protein on its own is almost entirely responsible for the damage to the cardiovascular system, if it gets into circulation," Bridle told listeners.

Lab animals injected with purified spike protein into their bloodstream developed cardiovascular problems, and the spike protein was also demonstrated to cross the blood brain barrier and cause damage to the brain.

A grave mistake, according to Bridle, was the belief that the spike protein would not escape into the blood circulation.

"Now, we have clear-cut evidence that the vaccines that make the cells in our deltoid muscles manufacture this protein — that the vaccine itself, plus the protein — gets into blood circulation," he said.

Bridle cited the recent publication of a peer-reviewed study which detected spike protein in the blood plasma of three of 13 young healthcare workers that had received Moderna's COVID-19 vaccine. In one of the workers, the spike protein circulated for 29 days.

Effects on heart and brain

Once in circulation, the spike protein can attach to specific ACE2 receptors that are on blood platelets and the cells that line blood vessels. "When that happens it can do one of two things: it can either cause platelets to clump, and that can lead to clotting. That's exactly why we've been seeing clotting disorders associated with these vaccines. It can

also lead to bleeding." Bridle also said the spike protein in circulation would explain recently reported heart problems in youths who had received the shots.

The results of this leaked Pfizer study tracing the biodistribution of the vaccine mRNA are not surprising, "but the implications are terrifying," Stephanie Seneff, a senior research scientist at Massachusetts Institute of Technology, told LifeSiteNews. "It is now clear" that vaccine content is being delivered to the spleen and the glands, including the ovaries and the adrenal glands.

The Centers for Disease Control and Prevention (CDC) recently announced it was studying reports of "mild" heart conditions following COVID-19 vaccination, and last week 18 teenagers in the state of Connecticut alone were hospitalized for heart problems that developed shortly after they took COVID-19 vaccines.

AstraZeneca's vaccine was halted in a number of countries and is no longer recommended for younger people because of its link to life-threatening and fatal blood clots, but mRNA COVID vaccines have been linked to hundreds of reports of blood clotting events as well.

FDA warned of spike protein danger

Pediatric rheumatologist J. Patrick Whelan had warned a vaccine advisory committee of the Food and Drug Administration of the potential for the spike protein in COVID vaccines to cause microvascular damage causing damage to the liver, heart, and brain in "ways that were not assessed in the safety trials."

While Whelan did not dispute the value of a coronavirus vaccine that worked to stop transmission of the disease (which no COVID vaccine in circulation has been demonstrated to do), he said, "it would be vastly worse if hundreds of millions of people were to suffer long-lasting or even permanent damage to their brain or heart microvasculature as a result of failing to appreciate in the short-term an unintended effect of full-length spike protein-based vaccines on other organs."

Vaccine-associated spike protein in blood circulation could explain myriad reported adverse events from COVID vaccines, including the 4,000 deaths to date, and nearly 15,000 hospitalizations, reported to the U.S. government's Vaccine Adverse Event Reporting System (VAERS) as of May 21, 2021. Because it is a passive reporting system, these reports are likely only the tip of an iceberg of adverse events since a Harvard Pilgrim Healthcare study found that less than one percent of side-effects that physicians should report in patients following vaccination are in fact reported to VAERS.

Nursing babies, children and youths, frail, most at risk

Bridle said the discovery of vaccine-induced spike protein in blood circulation would have implications for blood donation programs. "We don't want transfer of these pathogenic spike proteins to fragile patients who are being transfused with that blood," he said.

The vaccine scientist also said the findings suggested that nursing babies whose mothers had been vaccinated were at risk of getting COVID spike proteins from her breast milk.

Bridle said that "any proteins in the blood will get concentrated in breast milk," and "we have found evidence of suckling infants experiencing bleeding disorders in the gastrointestinal tract" in VAERS.

Although Bridle did not cite it, one VAERS report describes a five-month-old breastfed infant whose mother received a second dose of Pfizer's vaccine in March. The following day, the baby developed a rash and became "inconsolable," refused to nurse, and developed a fever. The report says the baby was hospitalized with a diagnosis of Thrombotic Thrombocytopenic Purpura, a rare blood disorder in which blood clots form in small blood vessels throughout the body. The baby died.

The new research also has "serious implications for people for whom SARS Coronavirus 2 is not a high risk pathogen, and that includes all of our children."

Effect on fertility and pregnancy?

The high concentration of spike protein found in testes and ovaries in the secret Pfizer data released by the Japanese agency raises questions, too. "Will we be rendering young people infertile?" Bridle asked.

There have been thousands of reports of menstrual disorders by women who had taken a COVID-19 shot, and hundreds of reports of miscarriage in vaccinated pregnant women, as well as of disorders of reproductive organs in men.

Vicious smear campaign

In response to a request, Bridle emailed a statement to *'LifeSiteNews'* on Monday morning, stating that since the radio interview he had received hundreds of positive emails. He added, too, that *"a vicious smear campaign has been initiated against me. This included the creation of a libelous website using my domain name."*

"Such are the times that an academic public servant can no longer answer people's legitimate questions with honesty and based on science without fear of being harassed and intimidated," Brindle wrote. "However, it is not in my nature to allow scientific facts to be hidden from the public."

He attached a brief report outlining the key scientific evidence supporting what he said in the interview. It was written with his colleagues in the Canadian COVID Care Alliance (CCCA) — a group of independent Canadian doctors, scientists, and professionals whose declared aim is "to provide top quality, evidence-based information about COVID-19, intent on reducing hospitalizations and saving more lives."

A focus of the statement was the risk to children and teens that are the target of the latest vaccine marketing strategies, including in Canada.

As of May 28, 2021, there have been 259,308 confirmed cases of SARS-CoV-2 infections in Canadians 19 years and under. Of these, 0.048% were hospitalized, but only 0.004% died, according to the CCCA statement. "Seasonal influenza is associated with more severe illness than COVID-19."

Given the small number of young research subjects in Pfizer's vaccine trials and the limited duration of clinical trials, the CCCA said questions about the spike protein and another vaccine protein must be answered before children and teens are vaccinated, including whether the vaccine spike protein crosses the blood-brain barrier, whether the vaccine spike protein interferes with semen production or ovulation, and whether the vaccine spike protein crosses the placenta and impacts a developing baby or is in breast milk.

'LifeSiteNews' sent the Public Health Agency of Canada the statement of CCCA and asked for a response to Bridle's concerns. The agency responded that it was working on the questions but did not send answers before publication time.

Pfizer, Moderna, and Johnson & Johnson did not respond to questions about Bridle's concerns. Pfizer did not respond to questions about how long the company was aware of its research data that the Japanese agency had released, showing spike protein in organs and tissue of vaccinated individuals.

I recall well this report back in May, 2021. I was blocked from saving it and when that happens I know different ways to save it and share it later. In this case, I shared this report in three different articles and clearly the pharmaceuticals were well aware of what was going to happen since all the early lab experiments on animals resulted in the death of the various animal studies, which led to an immediate shutdown of lab tests to keep quiet the results. I have discovered some extremely concerning findings in the Pfizer Phase I-II-III clinical trial data. The first thing the jumps out of these figures is that Pfizer trial participants had a death rate of 17/19 per 21,921/6 per 6 months. Whereas the general U.S. population has a death rate of 111.2 per 21,923 per 6 months. So Pfizer trial participants were over 6x less likely to die than the general public.

So Pfizer must have done some extremely heavy exclusions of morbidities to get such an absurdly low mortality figure. Their study protocol reveals that they excluded – Clinicaltrials.gov.

The next thing is the incredible match between the unvaccinated Covid and cardiovascular death rates (10.5% and 26.3%) and those in the general population for 2020 (10.3% and 25.3%). So even though the numbers of deaths are small. They appear to be a very good representation of the reality in general public.

Now we turn to the double vaccinated cardiovascular and sepsis rates and we see (52.9% and 23.5% death rates) compared to the general population (and the unvaccinated) who suffer only (26.3% and 1.1% or 25.3% and 0%).

And there is the toxicity of the Pfizer vaccination laid bare. It weakens the immune system to the point where people succumb to microbial infections and die at 21 times the normal rate in the first 6 months after vaccination.

To that end, here is an edited copy letter recently sent to the UK's Scientific Advisory Group for Emergencies (SAGE):

Dear Members of SAGE

I write to inform you of an oversight in your scientific advice on Covid-19.

1. As you will all be aware, the only acceptable scientific method for determining the safety or effectiveness of a medical intervention is to compare its effect upon a randomly chosen experimental group with a control group preferably of similar size for statistical reasons.

In the phase III clinical trials for Pfizer there were 21,921 participants in the vaccinated group and 21,926 in the placebo group, the control group.

The control group, the placebo group is the yardstick with which we measure the effectiveness of the intervention. Only by comparison with a control group can a researcher determine whether an intervention has a statistically significant effect on an experimental group, and the possibility of drawing a false conclusion is mathematically and precisely defined. This A B comparison between intervention and control groups is called the Scientific Method.

So without a control group the Scientific method has been abandoned, we are no longer following any science at all, and no statistically valid conclusion can be drawn from the intervention. Instead science and its method have gone out of the window and we are back in the dark ages of Papal decrees.

2. The medium term (1-3 year) safety or efficacy of the Adenovirus-DNA vaccines and the lipid nanoparticle-mRNA vaccines is not yet known because they have not yet been examined in the general population for more than 10 months.

In this country the intervention group for these vaccines in the age demographic over 18 years old is now over 90% of the population

Why has the Scientific Advisory Group for Emergencies failed to advise the UK government to follow the scientific method and formulate a commensurate control group who do not take the vaccines?

How are we to assess the effectiveness of these vaccine interventions in the absence of such a group?

How can a group of scientists fail so spectacularly to follow not only 'the science' but actually any science at all in what is undoubtedly the most important medical intervention in the UK in the history of science and of medical practice?

May I therefore insist in the name of Science that you put your lab coats back on and advise the Government of this country without further delay to preserve all presently unvaccinated people as members of a vastly undersized, under represented depleted and sadly less than commensurate control group in order that this entire vaccination experiment can actually reach a statistically valid and meaningful conclusion and in order to demonstrate to the government and to the British public and to the world in general – what science actually is.

Furthermore if you are going to use children as lab rats for the benefit of adults and against the advice of the JCVI, then would you please ensure that only 50% of them are vaccinated and the remaining 50% are kept free of intervention as a properly sized control group in order that we can learn something from the government's hideous medical experimentation on them.




(<u>Natural News</u>) Just a few months before the Wuhan coronavirus (COVID-19) was publicly announced, scientists from the <u>Massachusetts Institute of Technology</u> (MIT) announced the completion of a <u>Mark of the Beast "tattoo" technology for children</u> to keep track of their vaccination records.

The microchip, which can be implanted directly into the skin, was designed with special invisible dye that can be picked up with a special mobile phone filter. That dye is not visible to the naked eye.

Lasting up to five years, this dye is detected using near-infrared light, which is shined onto the skin in the area where it was injected. It has already been tested on pigs and rats, and the presumable next step is to start injecting actual children with it.

Billionaire eugenicist Bill Gates <u>called for this</u> back in the early days of the *plandemic*, suggesting that digital jab "passports" for the Chinese Virus include people's injection records.

"The system – which has not yet been tested in children – would provide quick and easy access to vaccination history, avoid the risk of clerical errors, and add little to the cost or risk of the procedure," reported *'Scientific American'*, citing a study about the project that was published in the journal *Science Translational Medicine*.

Once again using the poor as an excuse to create an abomination like this, the scientists involved with the project claim that it will help developing countries to achieve better health outcomes in children.

"Especially in developing countries where medical records may not be as complete or as accessible, there can be value in having medical information directly associated with a person," commented Mark Prausnitz, a bioengineering professor at the <u>Georgia Institute of Technology</u> (Georgia Tech), who was not involved in the research.

"This, I think, is a pretty interesting way to accomplish those goals."

It also accomplishes the prophetic goal of <u>merging people's identifying information into a microchip injection</u> or tattoo that can be scanned for purposes of buying and selling, accessing restricted buildings, driving and engaging in social activities.

According to MIT bioengineers Robert Langer and Ana Jaklenec, small patches full of microneedles are first stamped on children's skin to inject them with vaccines. After that, their proof of injection is stored on the other injectable components.

With the simple scan of the wrist, forehead, or wherever else these components are injected, the government can quickly check whether or not a child is "up to date" on the vaccine schedule, which now includes Fauci Flu shots.

"The team ended up using a technology called quantum dots, tiny semiconducting crystals that reflect light and were originally developed to label cells during research," reported Scientific American. "The dye has been shown to be safe in humans."

Not everyone is on board with the plan, as you might expect. Privacy experts say that there are risks involved with having people walk around with microchips in their bodies that contain all of their personal information.

"Different people and different cultures will probably feel differently about having an invisible medical tattoo," added Prausnitz.

Not at all a surprise is the fact that the Bill & Melinda Gates Foundation funded this Mark of the Beast research. It was launched because of a "direct request" from Gates himself, who claims he wants these microchips inside people's bodies for the purpose of "eradicating disease."

"If we don't have good data, it's really difficult to eradicate disease," Jaklenec added in support of Gates' agenda.

Together, these donations total \$166,216,526. The money is generally directed towards issues close to the Gates' hearts.

For example, the \$3.6 million CNN grant went towards "report[ing] on gender equality with a particular focus on least developed countries, producing journalism on the everyday inequalities endured by women and girls across the world," while the 'Texas Tribune' received millions to "to increase public awareness and engagement of education reform issues in Texas."

Given that Bill is one of the charter schools' most <u>fervent supporters</u>, a cynic might interpret this as planting pro-corporate charter school propaganda into the media, disguised as objective news reporting.

The Gates Foundation has also given nearly \$63 million to charities closely aligned with big media outlets, including nearly \$53 million to BBC Media Action, over \$9 million to

MTV's Staying Alive Foundation and \$1 million to The New York Times Neediest Causes Fund.

While not specifically funding journalism, donations to the philanthropic arm of a media player should still be noted.

Gates continues to underwrite a wide network of investigative journalism centers as well, totaling just over \$38 million, more than half of which has gone to the D.C.-based International Center for Journalists to expand and develop African media.

The foundation also puts up the money to directly train journalists all over the world, in the form of scholarships, courses and workshops.

Today, it is possible for an individual to train as a reporter thanks to a Gates Foundation grant, find work at a Gates-funded outlet, and to belong to a press association funded by Gates.

This is especially true of journalists working in the fields of health, education and global development, the ones Gates himself is most active in and where scrutiny of the billionaire's actions and motives are most necessary.

The BMGF also pays for a wide range of specific media campaigns around the world. For example, since 2014 it has donated \$5.7 million to the Population Foundation of India in order to create dramas that promote sexual and reproductive health, with the intent to increase family planning methods in South Asia.

Meanwhile, it allotted over \$3.5 million to a Senegalese organization to develop radio shows and online content that would feature health information.

Supporters consider this to be helping critically underfunded media, while opponents might consider it a case of a billionaire using his money to plant his ideas and opinions into the press.

\$319.4 million and (a lot) more

Added together, these Gates-sponsored media projects come to a total of \$319.4 million.

However, there are clear shortcomings with this non-exhaustive list, meaning the true figure is undoubtedly far higher. First, it does not count sub-grants — money given by recipients to media around the world.



And while the Gates Foundation fosters an air of openness about itself, there is actually precious little public information about what happens to the money from each grant,

save for a short, one- or two-sentence description written by the foundation itself on its website.

Only donations to press organizations themselves or projects that could be identified from the information on the Gates Foundation's website as media campaigns were counted, meaning that thousands of grants having some media element do not appear in this list.

A case in point is the BMGF's partnership with ViacomCBS, the company that controls CBS News, MTV, VH1, Nickelodeon and BET. Media reports at the time <u>noted</u> that the Gates Foundation was paying the entertainment giant to insert information and PSAs into its programming and that Gates had intervened to change storylines in popular shows like ER and Law & Order: SVU.

However, when checking BMGF's grants database, "Viacom" and "CBS" are nowhere to be found, the likely <u>grant</u> in question (totaling over \$6 million) merely describing the project as a "public engagement campaign aimed at improving high school graduation rates and postsecondary completion rates specifically aimed at parents and students," meaning that it was not counted in the official total.

There are surely many more examples like this. "For a tax-privileged charity that so very often trumpets the importance of transparency, it's remarkable how intensely secretive the Gates Foundation is about its financial flows," Tim Schwab, one of the few investigative journalists who has scrutinized the tech billionaire, told MintPress.

Also not included are grants aimed at producing articles for academic journals. While these articles are not meant for mass consumption, they regularly form the basis for stories in the mainstream press and help shape narratives around key issues.

The Gates Foundation has given far and wide to academic sources, with at least \$13.6 million going toward creating content for the prestigious medical journal 'The Lancet'.

And, of course, even money given to universities for purely research projects eventually ends up in academic journals, and ultimately, downstream into mass media. Academics are under heavy pressure to print their results in prestigious journals; "publish or perish" is the mantra in university departments.

Therefore, even these sorts of grants have an effect on our media. Neither these nor grants funding the printing of books or establishment of websites counted in the total, although they too are forms of media.

Low profile, long tentacles

In comparison to other tech billionaires, Gates has kept his profile as a media controller relatively low. <u>Amazon</u> founder <u>Jeff Bezos's</u> purchase of *'The Washington Post'* for \$250 million in 2013 was a very clear and obvious form of media influence, as was eBay

founder Pierre Omidyar's creation of 'First Look Media', the company that owns 'The Intercept'.

Despite flying more under the radar, Gates and his companies have amassed considerable influence in media.

We already rely on Microsoft-owned products for communication (e.g., Skype, Hotmail), social media (LinkedIn), and entertainment (Microsoft XBox). Furthermore, the hardware and software we use to communicate often comes courtesy of the 66-year-old Seattleite.

How many people reading this are doing so on a Microsoft Surface or Windows phone and doing so via Windows OS? Not only that, Microsoft owns stakes in media giants such as Comcast and AT&T. And the "MS" in MSNBC stands for Microsoft.

Media Gates keepers

That the Gates Foundation is underwriting a significant chunk of our media ecosystem leads to serious problems with objectivity. "The foundation's grants to media organizations ... raise obvious conflict-of-interest questions: How can reporting be unbiased when a major player holds the purse strings?" wrote Gates's local Seattle Times in 2011.

This was before the newspaper <u>accepted</u> BMGF money to fund its "education lab" section.

Schwab's <u>research</u> has found that this conflict of interests goes right to the very top: two 'New York Times' columnists had been writing glowingly about the Gates Foundation for years without disclosing that they also work for a group — the Solutions Journalism Network — that, as shown above, has received over \$7 million from the tech billionaire's charity.

Earlier this year, Schwab also declined to co-report on a story about COVAX for The Bureau of Investigative Journalism, suspecting that the money Gates had been pumping into the outlet would make it impossible to accurately report on a subject so close to Gates's heart.

Sure enough, when the article was <u>published</u> last month, it repeated the assertion that Gates had little to do with COVAX's failure, mirroring the BMGF's stance and quoting them throughout. Only at the very end of the more than 5,000-word story did it reveal that the organization it was defending was paying the wages of its staff.

"I don't believe Gates told The Bureau of Investigative Journalism what to write. I think the bureau implicitly, if subconsciously, knew they had to find a way to tell this story that didn't target their funder. The biasing effects of financial conflicts are complex but very real and reliable," Schwab said, describing it as "a case study in the perils of Gates-funded journalism."

MintPress also contacted the Bill & Melinda Gates Foundation for comment, but it did not respond.

Gates, who amassed his fortune by building a monopoly and zealously guarding his intellectual property, bears significant blame for the failure of the coronavirus vaccine rollout across the world.

Quite aside from the COVAX fiasco, he <u>pressured</u> Oxford University not to make its publicly-funded vaccine open-source and available to all for free, but instead to partner with private corporation <u>AstraZeneca</u>, a decision that meant that those who could not pay were blocked from using it.

That Gates has made over 100 donations to the university, totaling hundreds of millions of dollars, likely played some role in the decision. To this day, fewer than 5% of people in low-income countries have received even one dose of COVID vaccine. The death toll from this is immense.

Unfortunately, many of these real criticisms of Gates and his network are obscured by wild and untrue conspiracy theories about such things as inserting microchips in vaccines to control the population.

This has meant that genuine critiques of the Microsoft co-founder are often demonetized and algorithmically suppressed, meaning that outlets are strongly dissuaded from covering the topic, knowing they will likely lose money if they do so. The paucity of scrutiny of the world's second-richest individual, in turn, feeds into outlandish suspicions.

Gates certainly deserves it. Quite apart from his deep and potentially decades-long ties to the infamous Jeffrey Epstein, his <u>attempts</u> to <u>radically</u> change African society, and his <u>investment</u> in controversial chemical giant <u>Monsanto</u>, he is perhaps the key driver behind the American charter school movement — an attempt to essentially privatize the U.S. education system.

Charter schools are deeply unpopular with teachers' unions, which see the movement as an attempt to lessen their autonomy and reduce public oversight into how and what children are taught.

All the way to the bank

How "self made" billionaires got their start









In most coverage, Gates's donations are broadly presented as altruistic gestures. Yet many have pointed to the inherent flaws with this model, noting that allowing billionaires to decide what they do with their money allows them to set the public agenda, giving them enormous power over society.

"Philanthropy can and is being used deliberately to divert attention away from different forms of economic exploitation that underpin global inequality today," <u>said Linsey McGoey</u>, Professor of Sociology at the University of Essex, U.K., and <u>author</u> of "No Such Thing as a Free Gift: The Gates Foundation and the Price of Philanthropy." She adds:

"The new 'philanthrocapitalism' threatens democracy by increasing the power of the corporate sector at the expense of the public sector organizations, which increasingly face budget squeezes, in part by excessively remunerating for-profit organizations to deliver public services that could be delivered more cheaply without private sector involvement."

None of this means that the organizations receiving Gates' money — media or otherwise — are irredeemably corrupt, nor that the Gates Foundation does not do any good in the world.



We are tremendously proud of our employees for their dedication to the people we care for," Geer Village Senior Community CEO Kevin O'Connell said in a statement.

NBC Connecticut reported:

Eight people are dead and just shy of 100 more have become infected with COVID-19 after an outbreak at a Connecticut nursing home.

The outbreak at the Geer Village Senior Community, a nursing home and rehabilitation center in Canaan, started around the beginning of October when the nursing home was reporting three positive COVID-19 cases.

Now, eight residents have died, and 67 residents and 22 staff members caught COVID-19 sometime in the past month and a half. Nursing home officials said 48 residents and 21 staff members have recovered from the virus.

The state Department of Public Health said they're monitoring and providing on-site consultation at this facility.

"Family members of residents in long-term care facilities should also encourage their loved ones being cared for in these facilities to get a booster vaccine," a spokesperson for the DPH said.

<u>Corona 'Vaccines': A Programmed Self-Destruction Of The Body</u> - Dr. Christian Fiala

First our immune system is highly complex and it recognizes a pathogen or foreign cell on the basis of the cell surface and destroys the cell that carries these antigens. This principle is used in vaccinations. For this purpose, a pathogen is usually weakened or killed so that it can no longer cause an infection.

An essential feature of the immune system is the strict differentiation between one's

own cells and foreign cells. Only in this way is a healthy life possible at all. It is precisely this fundamental distinction and basis of life that is being challenged with what is currently known as the jab, and being propagated as a corona "vaccination". The much-cited spike proteins are a recognition feature of the Corona virus, an antigen.

Friendly fire

When the Corona virus enters the body, the immune system recognizes the invader on the basis of the spike protein antigen and destroys the virus or the cells that have already been infected by the virus.

With the mRNA corona "vaccination", body cells are for the first time in history deliberately and genetically programmed by means of the mRNA to produce the spike protein as a (foreign) antigen on the cell surface, although they are completely healthy and not infected with the virus.

The mechanism of action of the corona "vaccination" is to falsely mark healthy cells as foreign.

As a consequence, the immune system reacts immediately; it recognizes the antigen as foreign, forms antibodies against it and destroys the spike protein by destroying the cell that carries this spike protein. [1,2]

This means that the corona "vaccination" fools our immune system and tricks it into attacking and destroying our own healthy cells. In the military it is this is called 'friendly fire' when soldiers attack their own troops. This represents a fundamental danger not only for our health but also to our survival. We know this situation with the rarely occurring autoimmune diseases. These are usually severe and can even be fatal.

The dose makes the poison

To better assess the danger of the Corona "vaccination", it is important to know how much mRNA is administered with one dose of the vaccine, i.e. how many body cells are stimulated to produce the spike protein and thus released to be destroyed by the immune system. Unfortunately, this important information is also not mentioned in the approval studies. There is only a scientific estimate of the number of particles in which the mRNA is transported by the so-called lipid nanoparticles: about 2 trillion particles.

Not every particle reaches a healthy cell and some cells in the body are affected by more than one particle. Moreover, not all particles may be fully functional. Nevertheless, the number of particles is extremely relevant when one considers that the human body consists of approximately 37 trillion cells.

Which organs does the Corona "vaccination" damage?

The corona "vaccination" is programmed in such a way that the immune system

destroys the body's own cells that have produced the spike protein on its surface. Could this happen on vital organs?

The answer to this question can be found, among others, in animal experiments by the vaccine manufacturer BionTech/Pfizer. The spike protein blueprint is found in a gene segment, the so-called mRNA, and is embedded in very small spheres of fat, the so-called lipid nanoparticles. After 1 hour, half of them were already distributed throughout the body. The lipid nano-particles were detected in all organs in the above-mentioned animal experiment, especially in the liver.

They were also detected in the brain, which proves they were able to cross the blood-brain barrier. They were also detected in the ovaries and testes. This means the body's cells form the spike protein in the respective organs, which probably explains why the very numerous side effects and vaccine damage are also found randomly distributed in many organs. [6,7,8]

Since the lipid nanoparticles are distributed in the blood, especially the so-called endothelial cells get affected.[9] This explains the numerous blood clots (thromboses or embolisms) observed as a result of the Corona "vaccination". These also occur in the brain, among other places, and lead to partially irreversible damage. This is particularly worrying because it shows that even those organs that are separated from the immune system by a special barrier are now vulnerable.

Booster "vaccination" - enough is not enough

The Corona "vaccination" is designed to be given at short intervals. Thus the vaccination expires after 6 or 9 months and the vaccinated persons will then be considered unvaccinated.[10] Many governments have already ordered tens of millions of doses to be given in the coming years. In Israel, a large part of the population has already been vaccinated for the 3rd time.[13]

The key question becomes: what effect does a repeated injection have on the body?

Our immune system is capable of learning. When a pathogen enters the body for the first time, it is recognized as foreign, but it takes a few days for the immune system to kick in. During this time, the pathogen has the upper hand for a short time. Only after a few days is the immune system strong enough to destroy the pathogen and we become healthy.

Fortunately, the second time, the immune system remembers the "appearance" of the pathogen and it is activated much faster and much more powerfully. This strong defense protects us and we do not fall ill again; we are immune.

This vital mechanism also takes place with every further corona "vaccination", but the massive reaction of the immune system with each further injection is not directed against a pathogen but **against our own healthy body cells that have once again**

been marked with the spike protein. Viewed as a pathogen, this otherwise healthy cell is targeted to be destroyed. The effectiveness and ferocity of this destruction of healthy cells is increased with each injection. This means that the healthy "spiked cells" in the body are destroyed even more efficiently than in the first injection.

Thus, this memory capacity of the immune system becomes a dangerous weapon against ourselves.

Instead of making foreign pathogens harmless, the immune system now destroys the body's own cells which were instructed to produce the spike protein. Every further injection of a Corona "vaccine" consequently poses a great risk. This corresponds to the observation that more and stronger vaccination complications occur with the second vaccination.

As Reports of Injuries After COVID Vaccines Near 1 Million Mark, CDC, FDA Clear Pfizer, Moderna Boosters for All Adults

VAERS data released today by the CDC included a total of **894,145 reports of adverse events** from all age groups following COVID vaccines, including **18,853 deaths** and **139,126 serious injuries** between Dec. 14, 2020, and Nov. 12, 2021.

The Centers for Disease Control and Prevention (CDC) released new data today showing a total of <u>894,145 adverse events</u> following COVID vaccines were reported between Dec. 14, 2020, and Nov. 12, 2021, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of <u>18,853 reports of deaths</u> — an increase of 392 over the previous week — and <u>139,126 reports of serious injuries</u>, including deaths, during the same time period — up 3,726 compared with the previous week.

Excluding "<u>foreign reports</u>" to VAERS, <u>654,413 adverse events</u>, including <u>8,664 deaths</u> and <u>54,962 serious injuries</u>, were reported in the U.S. between Dec. 14, 2020, and Nov. 12, 2021.

<u>Foreign reports</u> are reports received by U.S. manufacturers from their foreign subsidiaries. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product's labeling, the manufacturer is required to submit the report to VAERS.

Of the 8,664 U.S. deaths reported as of Nov. 12, <u>10% occurred</u> within 24 hours of vaccination, <u>15% occurred</u> within 48 hours of vaccination and <u>26% occurred</u> in people who experienced an onset of symptoms within 48 hours of being vaccinated.

In the U.S., 436.9 million COVID vaccine doses had been administered as of Nov. 12. This <u>includes</u>: 254.5 million doses of Pfizer, 166.3 million doses of Moderna and 16.1 million doses of Johnson & Johnson (J&J).

Every Friday, VAERS publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Historically, VAERS has been shown to report only 1% of actual vaccine adverse events.

This week's U.S. data for 5- to 11-year-olds show:

- 1,426 total adverse events, including 9 rated as serious and 1 reported death that occurred in an 11-year-old girl from Georgia vaccinated Sept. 14, prior to the authorization of Pfizer's COVID vaccine in the 5 to 11 age group.
- 444 <u>adverse events</u> have been reported in the 5 to 11 age group since Nov. 1.
- The rest of the reports in VAERS for children in the 5 to 11 age group occurred prior to the authorization of Pfizer's COVID vaccine, and are due to "product administered to patient of inappropriate age."

This week's U.S. data for 12- to 17-year-olds show:

23,105 total adverse events, including 1,429 rated as serious and 30 reported deaths.

The most recent death includes a 16-year-old girl from Missouri (VAERS I.D. <u>1823671</u>) who died after receiving her second dose of Pfizer.

Other reported deaths include a 17-year-old female from Washington (VAERS I.D. 1828901) who died Oct. 29 reportedly from a heart condition after receiving her second dose of Pfizer; a 12-year-old girl from South Carolina (VAERS I.D. 1784945) who hemorrhaged 22 days after receiving Pfizer's COVID vaccine; and a 13-year-old girl from Maryland (VAERS I.D. 1815096) who died from a heart condition 15 days after receiving her first dose of Pfizer's vaccine.

FDA, CDC sign off on Pfizer, Moderna COVID boosters for all adults

The U.S. Food and Drug Administration (FDA) today authorized Moderna and Pfizer COVID boosters for all adults. The agency made its decision without input from its advisory committee, whose members, on Sept. 17, voted 16 to 2 against recommending boosters, citing a lack of long-term data and stating the risks did not outweigh the benefits.

Hours after the FDA announced its decision, the CDC's Advisory Committee on Immunization Practices (ACIP) signed off with an unanimous endorsement.

The ACIP said 18- to 49-year-olds "may" get a booster, but people 50 and older should get one. CDC Director Dr. Rochelle Walensky is expected to clear the doses, which will allow boosters to be administered broadly to the general public.

Speaking for the FDA, Dr. Peter Marks, head of the agency's Center for Biologics Evaluation and Research, said in a statement:

"The FDA has determined that the currently available data support expanding the eligibility of a single booster dose of the Moderna and Pfizer-BioNTech COVID-19 vaccines to individuals 18 years of age and older."

Dr. Paul Offit, director of the Vaccine Education Center at Children's Hospital of Philadelphia, and an FDA advisory panel member took issue with how the FDA arrived at its decision.

In an email to <u>The Epoch Times</u>, Offit said, "I think it would have been of value for the public to hear an open discussion about the need for boosters. I wish we had had the chance to discuss this."

The FDA said it did not hold a meeting because "the agency previously convened the committee for extensive discussions regarding the use of booster doses of COVID-19 vaccines and, after review of both Pfizer's and Moderna's [Emergency Use Authorization] requests, the FDA concluded that the requests do not raise questions that would benefit from additional discussion by committee members."

Pfizer and BioNTech <u>requested authorization</u> last week after submitting the results of a phase 3 trial involving more than 10,000 participants.

Moderna <u>resubmitted its application</u> for its 50-microgram booster dose for all adults just two days ago. The company said the FDA based its decision on the "totality of scientific evidence <u>shared by the company</u>," including data that showed neutralizing antibodies had waned at about six months.

14-year-old Kentucky girl mistakenly given J&J vaccine

A 14-year-old Kentucky girl was mistakenly given J&J's COVID vaccine, which is not authorized for anyone under the age of 18, <u>International Business Times reported</u>. The girl was given the jab Oct. 16 at a vaccine drive-in at a high school in Covington.

The girl's mother, Rolina Mason, said her daughter was reluctant to get vaccinated and wanted the J&J vaccine because it was only one dose. Mason agreed that the nurse could administer J&J, but didn't realize it wasn't authorized for use in children.

Mason said she trusted the nurse who told them that it was okay for her daughter to get it.

The health department contacted Mason a week later and informed her that her daughter should have received Pfizer's COVID vaccine instead. Mason's daughter reportedly experienced skin rashes after receiving the shot.

States bypass CDC, gave out COVID boosters to all adults before authorization State officials from California to Maine encouraged and allowed adult residents to get COVID vaccine boosters despite recommendations by the FDA and CDC to reserve the shots for elderly and high-risk groups, CNBC reported.

California also told medical providers not to turn away any adults who requested a booster.

Arkansas, Colorado, Louisiana, Kansas, Kentucky, Maine, New Mexico, Vermont and West Virginia are also promoting widespread rollout of boosters for any fully vaccinated adult, with governors in Colorado and New Mexico signing executive orders a week before the FDA authorized the shots for the general population.

Gov. Jim Justice of West Virginia called for all adults in-state to get their boosters, adding that fully vaccinated residents would be "very foolish" not to register for the third dose.

Arkansas Gov. Asa Hutchinson said during a briefing Monday he wanted to make sure everybody 18 and over was eligible and encouraged to get a booster. Danyelle McNeill, a spokesperson for the Arkansas Department of Health, told CNBC in an email "the great majority of adults in Arkansas" were already considered high risk by the CDC before Hutchinson issued his recommendation.

Kentucky approved boosters for fully vaccinated adults on Wednesday, while Connecticut, Kansas, Louisiana, Maine, Massachusetts and Vermont expanded their booster programs this week before the FDA and CDC signed off, today.

Several children in California sick after receiving wrong COVID vaccine doses At least two children in California are sick after a clinic <u>administered the wrong doses</u> of a COVID vaccine to 14 kids.

Denise Iserloth said she took her two children, ages 8 and 11, to a clinic where they received 20 micrograms of dosage instead of the recommended 10 micrograms.

Sutter Health said in a statement it warned parents of the mistake as soon as they learned of it, and contacted parents to advise them of CDC guidance. But Iserloth said she wasn't made aware of the error until 10 hours after her children were vaccinated.

Both of her children stayed home from school on Monday with bad stomach aches, and her oldest child fell down twice in the hours following the shot, Iseroth said.

"I understand the mandate, I tried to comply with it, and my children now have been given a double dose and I don't know the long-term side effects," Iserloth said. "[...] It is unacceptable and negligent, completely negligent on their part."

COVID hospitalizations on the rise among fully vaccinated

COVID hospitalizations and emergency room visits are on the rise among people who are <u>fully vaccinated</u>, according to <u>Dr. Anthony Fauci</u>, director of the National Institute for Allergy and Infectious Diseases.

"What we're starting to see now is an uptick in hospitalizations among people who've been vaccinated but not boosted," Fauci said Tuesday. "It's a significant proportion, but not the majority by any means."

In a White House COVID-19 Response Team <u>briefing</u> Wednesday, Fauci stressed the importance of vaccines and highlighted how well they work. At the same panel, CDC

Director Walensky reported a decline in vaccine effectiveness among the elderly and residents of long-term care facilities, many of whom were the first to be eligible to be vaccinated last winter.

The current seven-day rate of COVID <u>hospital admissions</u> is about 5,300 per day, according to the CDC.

It's not clear how many hospitalizations are <u>breakthrough cases</u> as the agency stopped reporting hospitalizations among fully vaccinated people and its <u>website shows data</u> only through Aug. 28.

CDC admits to not tracking data on natural immunity

In response to a Freedom of Information Act (FOIA) request, the <u>CDC said</u> it has no record of an individual previously infected with COVID becoming re-infected or transmitting the virus to others — because the agency doesn't collect that data.

The <u>FOIA request</u>, submitted Sept. 2 by attorney Aaron Siri of the Siri & Glimstad law firm on behalf of the Informed Consent Action Network, sought documents reflecting any documented case of an individual who: (1) never received a COVID vaccine; (2) was infected with COVID once, recovered, and then later became infected again; and (3) transmitted SARS-CoV-2 to another person when re-infected.

The CDC responded Nov. 5, stating:

"A search of our records failed to reveal any documents pertaining to your request. The CDC Emergency Operations Center (EOC) conveyed that this information is not collected."

According to Siri, the revelation that the CDC <u>does not collect data</u> on people who have acquired natural immunity to the virus raises questions about vaccine mandates, specifically how the government or employers can mandate vaccines for people who may not need them and who could be at a greater-than-average risk of experiencing an adverse reaction to the shots.

Stunning new research published in *Viruses*, part of the SARS-CoV-2 Host Cell Interactions edition of MDPI (Open Access Journals) reveals that vaccine spike proteins enter cell nuclei and wreak havoc on cells' DNA repair mechanism, suppressing DNA repair by as much as 90%.

The research paper is entitled, "SARS–CoV–2 Spike Impairs DNA Damage Repair and Inhibits V(D)J Recombination In Vitro" and is authored by Hui Jiang and Ya-Fang Mei, at the Department of Molecular Biosciences, The Wenner–Gren Institute, Stockholm University, SE-10691 Stockholm, Sweden, and the Department of Clinical Microbiology, Virology, Umeå University, SE-90185 Umeå, Sweden, respectively.

In the conclusion of the paper, authors write, "We found that the spike protein markedly inhibited both BRCA1 and 53BP1 foci formation (Figure 3D–G). Together, these data show that the SARS–CoV–2 full–length spike protein inhibits DNA damage repair by hindering DNA repair protein recruitment."

The DNA repair mechanism, known as NHEJ (Non-Homologous End Joining) is a kind of intracellular "emergency response" system that repairs double-stranded DNA breaks. Without the NHEJ mechanism, all advanced multi-cellular life would cease to exist. No human being, animal or plant can survive with the integrity of its genetic code being protected and constantly repaired through multiple mechanisms.

DNA damage can be caused by exposure to radiation, chemicals found in foods and personal care products, or even exposure to mammography equipment. Excessive sunlight exposure can also cause DNA breaks, and minor DNA mutations occur spontaneously in all living organisms. Airline pilots, for example, are routinely exposed to ionizing **5G** radiation due to flying at altitude.

In a normal, healthy person, the NHEJ mechanism repairs the DNA and prevents a pathogenic mutation from occurring. But in the presence of the vaccine spike protein, **NHEJ effectiveness is suppressed by as much as 90%**, meaning it is unable to do its job due to the suppressed ability to recruit proteins for repair.

As a result, the following "errors" are introduced into chromosomes inside the nuclei of human cells, all due to the presence of the spike protein from mRNA vaccines:

- Mutations or "errors" in the genetic sequence.
- DELETIONS of entire segments of genetic code.
- INSERTIONS of incorrect segments.
- Mixing and matching / permutations of genetic code.

These errors, when expressed through cell division and replication, result in:

- An explosion of cancer and cancer tumors throughout the body
- Loss of production of immune system B and T cells (i.e. induced immunodeficiency)
- Autoimmune disorders
- Accelerated aging and reduced telomere length
- Loss of functioning of complex organ systems such as circulatory, neurological, endocrine, muskuloskeletal, etc.
- Cellular damage resembling radiation poisoning as cells destroy themselves from within

Many of these effects are, of course, fatal. Others will burden vaccine victims with horrendous debilitating injuries and organ malfunctions that will require a lifetime of medical intervention.

Spike protein goes into the nucleus of the cell

From the paper linked above:

Mechanistically, we found that the spike protein localizes in the nucleus and inhibits DNA damage repair by impeding key DNA repair protein BRCA1 and 53BP1 recruitment to the damage site.

This means that the spike protein, which is generated in cell ribosomes after the cells have been hijacked by mRNA vaccines, doesn't always leave the cell and enter the bloodstream as we are told by mRNA vaccine proponents. In some cases, **the spike protein enters the cell nucleus**. There, it interferes with the DNA repair mechanism as described throughout this article.

"Surprisingly, we found the abundance of the spike protein in the nucleus (Figure 1A)," concluded study authors.

This means, without question, mRNA vaccines result in chromosomal alterations in the body's cells. It is confirmation that such vaccines are, indeed, wreaking havoc with genetic integrity and are exhibiting side effects that have not been anticipated or described by mRNA vaccine proponents.

Dr. Thomas Levy writes about the toxicity of the spike protein on Orthomolecular.org: Concern has been raised regarding the dissemination of the spike protein throughout the body after vaccination. Rather than staying localized at the injection site in order to provoke the immune response and nothing more, spike protein presence has been detected throughout the body of some vaccinated individuals. Furthermore, it appears that some of the circulating spike proteins simply bind the ACE2 receptors without entering the cell, inducing an autoimmune response to the entire cell-spike protein entity. Depending on the cell type that binds the spike protein, any of a number of autoimmune medical conditions can result.

More alarmingly, Dr. Levy explains that current evidence shows the spike protein continues to produce in the body, following the initial mRNA injection. He explains:

While the underlying pathology remains to be completely defined, one explanation for the problems with thrombotic tendencies and other symptomatology seen with chronic COVID and post-vaccination patients relates directly to the persistent presence of the spike protein part of the coronavirus. Some reports assert that the spike protein can continue to be produced after the initial binding to the ACE2 receptors and entry into some of the cells that it initially targets. The clinical pictures of chronic COVID and post-vaccine toxicity appear very similar, and both are likely due to this continued presence, and body-wide dissemination, of the spike protein (Mendelson et al., 2020; Aucott and Rebman, 2021; Levy, 2021; Raveendran, 2021).

Full-length spike protein resulted in the greatest suppression of NHEJ DNA repair mechanism

See the figures below. SARS-CoV-2 viral fragments are named "Nsp1, Nsp5" and so on. The full-length spike is called "Spike" and the nucleocapsid — another structural part of the whole spike protein pathogen — is identified separately.

What these data show is that the greatest suppression of NHEJ activity is measured when the full spike protein is present. From the study:

Together, these data show that the SARS–CoV–2 full–length spike protein inhibits DNA damage repair by hindering DNA repair protein recruitment.

The presence of the spike protein interferes with normal immune function and leads to immunodeficiency (an AIDS-like condition)

This research also finds that spike proteins from mRNA vaccines can lead to immunodeficiency conditions, similar to AIDS. This is consistent with what we have previously reported about immune function dropping roughly 5% per week in those who have taken covid vaccines. From the study:

...[L]oss of function of key DNA repair proteins such as ATM, DNA–PKcs, 53BP1, et al., leads to defects in the NHEJ repair which inhibit the production of functional B and T cells, leading to immunodeficiency.

Immune function is also critically affected by the presence of the spike protein, potentially leading to cancerous mutations throughout the body's cells. As the study explains:

DNA damage repair, especially NHEJ repair, is essential for V(D)J recombination, which lies at the core of B and T cell immunity.

As Science Direct also explains:

Maintaining genomic integrity is imperative for the survival of an organism. Among different DNA damages, double-strand breaks (DSBs) are considered as most deleterious since they can lead to cell death if left unrepaired or chromosomal rearrangements when mis-repaired, leading to cancer.

Further, mutations in NHEJ genes including Ku70 and Ku80 have been associated with **shortened life spans in mice** [54]. In addition, defects in DNA-PKcs (DNA-dependent protein kinase) resulted in **impaired telomere maintenance** and shortened life span in mice [55]. Taken together, these lines of evidence suggest that NHEJ plays an important role in preventing age-related increase in genomic instability and functional decline.

In effect, this means the spike protein's suppression of the NHEJ DNA repair mechanism also leads to reduced lifespan and accelerated aging.

By some estimates, 50% of the people injected with mRNA vaccines will be dead within five years. Now we have a deeper understanding of the mechanisms by which those vaccine-induced fatalities may occur.

Please note that in order for the pharmaceutical companies and the government health agencies to make a claim that COVID-19 "vaccines" are "safe," there must be a safety monitoring system in place in order to make such a claim. Otherwise, their claims would be without basis, because nobody would know whether those claims are true or not.

The CDC admits this in this statement on their website. And they go on to explain that this safety monitoring system is called VAERS, the *Vaccine Adverse Event Reporting System*.

Based on the VAERS reporting system, the <u>CDC goes on to state</u>: Serious adverse events after COVID-19 vaccination are rare but may occur.

For public awareness and in the interest of transparency, CDC is providing timely updates on the following serious adverse events of interest:

They then list four adverse events they have noticed from VAERS, and also make a statement regarding deaths.

Here are the four adverse events they admit are recorded in VAERS:

- Anaphylaxis after COVID-19 vaccination
- Thrombosis with thrombocytopenia syndrome (TTS) after Johnson & Johnson's Janssen (J&J/Janssen) COVID-19 vaccination
- CDC and FDA are monitoring reports of **Guillain-Barré Syndrome** (GBS) in people who have received the J&J/Janssen COVID-19 Vaccine.
- Myocarditis and pericarditis after COVID-19 vaccination are rare.
- Reports of death after COVID-19 vaccination are rare.

Notice how they frequently use the word "rare" to describe these adverse events following COVID-19 vaccinations. But how many people even know about these "rare" side effects *prior* to receiving a COVID-19 shot?

Two of the side effects are only linked to one of the three FDA authorized COVID-19 "vaccines," the J&J shot, which is the one least used.

The nice thing about the Government VAERS database is that it is open to the public, and anyone can search it. I use the MedAlerts front end to search the database, and you can find that here.

So anyone around the world can do their own search of the data in the VAERS database and fact-check the CDC's claims, which represent the view of the pharmaceutical industry and the government health agencies and their heads.

And that's what I am going to do in the rest of this article.

Please note that I am not dealing with the issue of under-reporting in VAERS in this article. Everyone admits that the data in VAERS is vastly under-reported, which is why when the CDC states that an adverse reaction that they admit is seen in VAERS is "rare" based on how many doses of the vaccine have been distributed, we should not take their statement at face value, because *they actually do not know how rare it is*.

So I am only going to deal with the available data to fact-check their claims, the very same data that they are using.

What I am going to do is compare the data on adverse reactions to the COVID-19 shots to the data recorded for the past 30 years for all other vaccines, as this will be a truer "apples to apples" comparison, and it is also a simple one that anyone can search themselves.

Yale Epidemiologist Cautions About Child Vaccination

The next wave of vaccination mandates will involve children. Since anyone raising concerns about this is considered an enemy of society, it's been impossible to have a rational discussion about it.

Here's what Harvey Risch, professor of epidemiology at the Yale School of Public Health and the Yale School of Medicine had to say about it this week.

"As far as I can tell, it's a top-down structure, and most doctors do not get their information by going back and reading the original studies and making up their own minds. They get fed the information from pharma reps or from what they're told from societies. The conflicts are legion. So it's no surprise that most doctors don't pay attention and think what they're told..."

"If the child has chronic conditions that make their risk appreciable, then there is a reason that they should be considered for vaccination. Other than that, if it were my child, I would homeschool them. Honestly, I would organize with other parents to take them out of the school and create a homeschooling environment."

There is no choice. Your child's life is on the line.

"It's not a high risk. Vaccination is not a high risk that's going to kill every child by doing so. However, it's enough of a risk that on the average the benefit is higher for homeschooling than it is for vaccination and being in school."

Martin Kulldorff of Harvard is saying something similar:

"They can be infected, just like they can get the common cold, but they're not a big threat. They don't die from this, except in very rare circumstances. So if you want to talk about protecting children or keeping children safe, I think we can talk about traffic accidents, for example, which they are really at some risk.... And there are other things that we should make sure [of] to keep children safe. But COVID is not a big risk factor for children."

Kulldorff points to the experience of his native Sweden. Beginning with the first wave in the spring of 2020, Sweden "decided to keep daycare and schools open for all children ages 1 to 15.

And there are 1.8 million such children who got through the first wave without vaccines, of course, without masks, without any sort of distancing in schools.

If a child was sick, they were told to stay home. But that was basically it. And you know how many of those 1.8 million children died from COVID? Zero. Only a few hospitalizations. So this is not a risky disease for children."

He concludes: "If you're a child, even if you haven't had COVID, the risk of serious disease or death is minuscule ... So it's not at all clear that the benefits outweigh the risks for children."
