CDC: 2,050 DEAD 44,606 Injuries
Following Experimental COVID-19 mRNA 'Vaccines'

Data released today by the Centers for Disease Control and Prevention (CDC) on the number of injuries and deaths reported to the <u>Vaccine Adverse Event Reporting System</u> (VAERS) following <u>COVID vaccines</u> showed that between Dec. 14, 2020 and March 19, 2021, there were 44,606 <u>reports of adverse events</u>, including <u>2,050 deaths and</u> <u>7,095 serious injuries</u>.

In the U.S., <u>118.3 million</u> COVID vaccine doses had been administered as of March 19.

VAERS is the primary mechanism for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Every Friday, the CDC makes public all VAERS vaccine injury reports received as of the previous week.

This week's VAERS data included <u>2,306 reports of anaphylaxis</u>. Fifty-five percent of anaphylaxis reports were attributed to the <u>Pfizer-BioNTech</u> vaccine, 45% to <u>Moderna</u> and 1% to the <u>Johnson & Johnson (J&J) vaccine</u>, which was <u>rolled out</u> in the U.S. on March 2.

As <u>The Defender reported</u> earlier this month, the J&J vaccine contains <u>polysorbate 80</u>, known to trigger allergic reactions. The <u>Moderna</u> and <u>Pfizer</u> vaccines contain <u>polyethylene glycol</u> (PEG), also known to trigger anaphylactic reactions.

The latest <u>news report</u> of an anaphylactic reaction to a <u>COVID vaccine</u> was of a 68-year-old Kansas woman who died a day after receiving the vaccine. According to EMS dispatch records, the woman had an allergic reaction at a vaccine clinic site around 4 p.m. on Tuesday, <u>KMBC</u> reported. She had difficulty breathing and speaking and was injected with an EpiPen.

Kansas Department of Health and Environment spokesperson Kristi Zears told <u>The Wichita Eagle</u> that Evans had an anaphylactic reaction during a waiting period after receiving the shot. She was transported to the hospital and pronounced dead a day later. It is not clear whether Evans had underlying health conditions and the Kansas health agency did not indicate which COVID vaccine was administered.

According to the <u>CDC's website</u>, "the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated."

To date, the only information the CDC has published related to the investigation of COVID vaccine-related deaths and how those investigations were conducted is a <a href="COVID-19 Vaccine Safety Update">COVID-19 Vaccine Safety Update</a> via the Advisory Committee on Immunization Practices (ACIP), published on Jan. 27.

On March 8, <u>The Defender</u> contacted the CDC with questions about reported deaths and injuries related to COVID vaccines. We provided a written list of questions about how the CDC conducts investigations into reported deaths, the status of investigations on deaths reported in the media, if autopsies are being done and the standard for determining whether an injury is causally connected to a vaccine.

We also inquired about whether healthcare providers are reporting all injuries and deaths that might be connected to the COVID vaccine, and what education initiatives are in place to encourage and facilitate proper and accurate reporting.

As of today, 18 days later, the CDC has not responded or followed up with our calls or emails. We have contacted them numerous times and are either told "they received the email," "they will escalate it and it is in the system" or their press officers are still reviewing it. After our most recent follow up call this Wednesday and giving them an updated deadline of 48 hours, we still have not heard back.

#### A look at the numbers

Overall, the data released today reflects trends that have been emerging since <u>The Defender</u> first began tracking VAERS reports related to <u>COVID vaccines</u>.

This week's VAERS data show:

- As of March 19, <u>321 pregnant women</u> had reported adverse events related to COVID vaccines, including 97 reports of <u>miscarriage or premature birth</u>. None of the COVID vaccines approved for <u>Emergency Use Authorization</u> has been confirmed safe or effective for pregnant women, although <u>J&J said</u> earlier this month it would begin testing on pregnant women, infants and the immunocompromised.
- <u>535 cases of Bell's Palsy. Of those</u>, 64% of cases were reported after <u>Pfizer-BioNTech</u> vaccinations almost <u>twice as many</u> as reported (36%) following vaccination with the Moderna vaccine. Three cases of Bell's Palsy were reported with J&J's vaccine (about 1%).

#### Physicians sound alarm about need for pre-screening

Meanwhile, concerns about mass vaccination continued to make national and international headlines this week.

As <u>The Defender</u> reported Tuesday, Dr. Hooman Noorchashm, <u>cardiothoracic surgeon</u> and patient safety advocate, said we're taking the COVID pandemic problem — where a half-percent of the population is susceptible to dying — and compounding it by vaccinating people who are already infected. In an interview with Fox News host and political commentator, Tucker Carlson, Noorchasm said public health officials are making a "dramatic error" by promoting a "one-size-fits-all" COVID vaccination program: "... the signal is deafening, the people who are having complications or adverse events are the people who have recently or are currently or previously infected [with COVID]. I don't think we can ignore this."

Noorchashm believes that a <u>#ScreenB4Vaccine campaign</u> could save millions from vaccine injuries. He is promoting a screening campaign that consists of "PCR or Rapid Antigen test to determine if there is an active infection and an IgG antibody test that would allow determination of a past infection. If either of these tests are positive, vaccination ought to be delayed for a minimum of 3 – 6 months," <u>Noorchasm told The Defender</u>. "If at that time IgG levels are waning, it is reasonable to consider getting a vaccine shot. But even then, blood IgG levels should guide whether or not a person gets vaccinated."

Noorchasm sent a <u>third communication</u> to the U.S. Food and Drug Administration this week, warning that deaths like that of 32-year-old <u>Benjamin G. Goodman</u>, who died after receiving the Johnson & Johnson vaccine, could have been prevented, and that there will be more deaths unless people are screened before being vaccinated.

An article in The Hill this week, by several physicians, also suggested that people be prescreened for COVID before being vaccinated.

The physicians wrote:

"A closer look at the level of protection obtained by a single shot vaccine regimen for those who are 'COVID-primed' is needed. Rigorous, effective and efficient antibody prescreening tools to identify these individuals would be required as well."

#### AstraZeneca under fire in U.S. and Europe

As far as individual vaccines, AstraZeneca garnered the most headlines this week, in Europe and the U.S.

On March 22, <u>The Defender reported</u> that two independent research teams in Norway and Germany identified antibodies that provoke immune reactions leading to the type of blood clots experienced by some people who received AstraZeneca's COVID vaccine.

Although many countries resumed their vaccination program with AstraZeneca's vaccine after the EMA's <u>preliminary findings</u>, some countries, including France, Denmark, Norway, Sweden and Finland, did not lift their restrictions on its use.

According to Reuters, Finland announced Wednesday it was still looking into two cases of blood clots but would resume using the AstraZeneca vaccine against COVID for people aged 65 and over. Finland plans to complete its investigation by April 6 at the earliest.

On March 23, U.S. health officials accused AstraZeneca of misrepresenting efficacy data when it included "outdated information" in its clinical trial results, which may have led to the vaccine maker providing the public with an incomplete view of its efficacy data, The Defender reported.

The statement by the National Institute of Allergy and Infectious Diseases came less than a day after the pharmaceutical company said its vaccine was 79% effective against COVID and 100% effective against severe or critical disease and hospitalization.

AstraZeneca <u>released updated information</u> on its COVID-19 clinical trial Wednesday which showed an efficacy rate of 76% against symptomatic COVID infection instead of the 79% figure released Monday. The estimated efficacy in people over 65 rose slightly, from 80% to 85%. The vaccine maker identified no safety concerns related to the vaccine.

On March 24, the Ukrainian government urged the public not to jump to conclusions after a servicewoman died two days after getting the AstraZeneca COVID vaccine, reported Fox News. Although the woman reportedly had chronic cardiovascular disease and other comorbidities, she experienced no side effects from the vaccine before she suddenly lost consciousness.

<u>According to Reuters</u>, nine other people were given the vaccine from the same batch on the same day and had no ill effects.



Let's say that again: Science shows mRNA technology can fuel cancer tumor growth.

Substantial amount of people with blood cancer have the SAME inactivation of tumorsuppressor genes at the mRNA level.

Scientists also discovered that a substantial amount of people with blood cancer, a.k.a. chronic lymphocytic leukemia (CLL), have the same exact inactivation of tumor-suppressor genes at the mRNA level. In fact, the mRNA changes they detected could possibly account for the missing DNA mutations, and that spells out bad news for everyone who thinks the Covid vaccine series is "safe and effective." It's effective alright, at suppressing anti-cancer proteins, one might conclude. HOWEVER, "When someone who appears to have devoted most of their career to developing and helping roll out vaccines globally decides to blow the whistle on the current global mass vaccination program, only an incautious person would choose to ignore it. indicator of just how incautious this communication vehicle has become." quoted from a related report from childrenshealthdefense.org.

His warning sent chills down my spine after I read the entire report. Why? Because he has been "in the club" so to speak. He adamantly believes the current mass Covid vaccinations (the consequences thereof) may theoretically substantially cull the human population!!

Geert Bossche is pleading with the WHO, the world, to immediately halt the current mass vaccinations, right now.

#### **Viral Immune Escape**

The core of his warning is something called "viral immune escape," which begets a weakened natural immunity and vaccine resistance to variants. "This type of prophylactic vaccines are completely inappropriate, and even highly dangerous, when used in mass vaccination campaigns during a viral pandemic,"

"It's becoming increasingly difficult to imagine how the consequences of the extensive and erroneous human intervention in this pandemic are not going to wipe out large parts of our human population."

Vanden Bossche suggests that herd immunity will not be achieved with the current vaccines, as they "turn vaccine recipients into asymptomatic carriers who are shedding virus."

#### (NK) Natural Killer Cells Instead

He calls for the use of vaccines that would be completely different from conventional vaccines in that they're not inducing the B and T cells, but rather the natural killer (NK) cells.

According to Vanden Bossche, there is compelling scientific evidence that the NK cells play a key role in facilitating complete elimination of COVID-19 at an early stage of infection in asymptomatic infected subjects.

Vanden Bossche has already warned various organizations, including the WHO, about his findings and recommendations.

Immediate Cancellation of ALL Ongoing Covid-19 Mass Vaccination Campaigns For him, "immediate cancellation of all ongoing Covid-19 mass vaccination campaigns should now become THE most acute health emergency of international concern," and he urges an immediate international debate on the issue.

#### It's Likely Too Late Already – The Worst Is Yet To Come

The worst of the pandemic is still to come. Bossche argues we are now experiencing the calm before the storm. <u>Vanden Bossche predicts the next wave of infection will be dramatic</u> — far worse than anything we've seen to-date.

This is because there will be more mutants to which the adaptive immune system provides little resistance, and this will come at the expense of decreased innate immune effectiveness.

While he mentions that NK cell-based vaccines, which he claims to have been researching for the last decade or so but about which he also says he has no commercial interest, are the ultimate solution, he believes it is likely too late to escape the storm.

Of all the reports I've read or heard or watched to-date, this one has me the most concerned.

#### 2.1 Cell culture of SARS-CoV-2 and electron microscopy

Vero/hSLAM cells (African green monkey kidney cells transfected to express the human signaling lymphocytic activation molecule (SLAM; also known as CDw150)<sup>1</sup> were grown at 37°C, 5% CO<sub>2</sub> in maintenance media consisting of 10mL Earle's minimum essential medium (EMEM), 7% fetal bovine serum (FBS) (Bovogen Biologicals, Keilor East, AUS) 2mM L-glutamine, 1 mM sodium pyruvate, 1500mg/L sodium bicarbonate, 15 mM HEPES and 0.4mg/ml geneticin to 95% confluency in 25cm<sup>2</sup> flasks. Prior to use for isolation, maintenance media was removed from the flask and 500μL of respiratory swab inoculum was overlaid on the cell monolayer. The flask was returned to the 37°C incubator to allow/the virus to adsorb for 1 hour before addition of 10 mL viral culture media (EMEM as above but FBS reduced to 2%). Flasks were monitored for viral cytopathic effect and 140μL aliquots of supernatant removed every 48 hours to assess virus burden by TaqMan real-time RT-PCR. First passage culture grown virus isolate was subsequently shipped nationally and internationally in packaging compliant with UN 2814 Category A shipping requirements using credentialed, specialised courier services under the appropriate Australian government export approvals processes and receiving country import permissions.

If you are new to the topic of "virus isolation/purification", I strongly recommend reading the Statement On Virus Isolation by Dr. Andrew Kaufman, Dr. Thomas Cowan and Sally Fallon Morell, MA.

A colleague in New Zealand (<u>Michael S.</u>) and I have been submitting Freedom of Information requests to institutions in various countries seeking records that describe the isolation of a SARS-COV-2 virus from any unadulterated sample taken from a diseased patient.

Our requests have not been limited to records of isolation performed by the respective institution, or limited to records authored by the respective institution, rather they were open to any records describing "COVID-19 virus" isolation performed by anyone, ever, anywhere on the planet.

Thus far (February 21, 2021) 19 Canadian institutions have provided their responses: Public Health Agency of Canada, Health Canada, the National Research Council of Canada, Vaccine and Infectious Disease Organization-International Vaccine Centre (VIDO-InterVac), Canadian Institutes of Health Research, Natural Sciences and Engineering Research Council of Canada, Ontario Ministry of Health, Institut National de Sante Publique du Quebec, British Columbia's Provincial Health Services Authority, Vancouver Coastal Health Authority (re "the variant"), Newfoundland Labrador Department of Health & Community Services, McGill University, the City of Toronto, the Region of Peel (Ontario), KFL&A Public Health (Kingston, Frontenac, Lennox and Addington, Ontario, re "any variant"), the University of Toronto, Sunnybrook Health Sciences Centre, McMaster University and Mount Sinai Hospital (Toronto) (note that researchers from the last 4 institutions had publicly claimed to have "isolated the virus", as had VIDO-Intervac).

Every institution has indicated the same: that they searched their records and located none describing the isolation of any "COVID-19 virus" directly from a patient sample that was not first adulterated with other sources of genetic material. (Those other sources are typically monkey kidney aka "Vero" cells and fetal bovine serum).

### It's All About the Money!

## And You Paid For It and Likely in More Ways Than One!

Pfizer's COVID Vaccine Could Become Most Lucrative Drug in the World Pfizer's vaccine is already the second-highest revenue-generating drug in the world. Once the pandemic ends, the vaccine maker plans to hike prices.



Pfizer's COVID vaccine is already the <u>second-highest revenue-generating</u> drug in the world — but the company plans to turn the vaccine into an even bigger cash cow once the pandemic ends, according to news reports.

Citing comments made by <u>Pfizer</u> CFO Frank D'Amelio, <u>Forbes</u> and <u>FiercePharma</u> reported that the company "is going to get more on price" once the pandemic wanes and "we are no longer in a pandemic pricing environment," D'Amelio said.

The vaccine maker expects 2021 sales of <u>about \$15 billion</u> based on current contracts for its <u>COVID vaccine</u>, but that number could double as Pfizer says it can potentially deliver 2 billion doses this year, <u>according to The Guardian</u>.

One **analyst speculated** that Pfizer could be targeting a price 3 to 4 times higher than the \$19.50 the company currently charges the U.S. government — or even up to \$156 per dose.

Pfizer based the vaccines' current price on the need for governments to secure doses and get the virus under control. The company <u>splits the profits 50-50</u> with German partner, BioNTech.

Under Operation Warp Speed, Pfizer agreed to supply the U.S. government with 100 million doses of its vaccine for \$1.95 billion, so Americans can receive the vaccine for free. But remember there is no free lunch, since the taxpayers paid for it in their taxes.

Pfizer's initial contract included an option for the government to buy up to 500 million more doses at \$19.50 per dose. That's well below the \$150 or \$175 per dose the drug maker typically pulls in for a vaccine, D'Amelio said during the February earnings call.

In comparison, the Moderna vaccine is priced at \$15 per dose, Johnson & Johnson (J&J) is \$10 and AstraZeneca's COVID vaccine is \$4 per dose, reported Fierce Pharma.

Pfizer executives unveiled the company's \$15 billion sales estimate as part of the company's 2021 guidance, based on doses set to be delivered in 2021 under existing contracts.

To put \$15 billion into perspective, Pfizer also markets the bestselling vaccine outside of COVID — pneumococcal shot Prevnar 13. In 2020, Prevnar 13 revenues were \$5.85 billion. Pfizer's entire vaccine franchise pulled in \$6.56 billion in 2020, reported Fierce Pharma.

As initial demand for its COVID vaccine subsides, the company could make significant profits by charging higher prices and implementing routine booster doses for new variants of the virus, Pfizer CEO Albert Bourla told analysts, big banks and investors during the February earnings call.

During the Barclays' Global Health Conference, D'Amelio said the company doesn't see this as a one-time event, but "as something that's going to continue for the foreseeable future."

Pfizer has already <u>launched a study</u> of a third vaccine dose to address variants, called for <u>annual boosters</u> and <u>told investors</u> to expect a revenue stream similar to <u>flu vaccines</u>.

"Every year, you need to go get your <u>flu vaccine</u>," Bourla <u>said</u>. "It's going to be the same with COVID. In a year, you will have to go and get your annual shot for COVID to be protected."

That will mean even more sales — and more profits — from the vaccine, reported WRCB-tv, a CBS subsidiary.

According to <u>Forbes</u>, some critics say the dramatic increase in the cost of the vaccine is a "bait and switch" operation that could result in Pfizer being called to Capitol Hill to justify the expense to the American public.

But the drug maker isn't alone in viewing vaccine pricing differently during the pandemic. J&J and AstraZeneca have each pledged to sell their vaccines at cost during the pandemic with the contractual right to deem the pandemic "over" in July 2021, paving the way for price increases, reported the Financial Times.

Moderna indicated it may raise prices after the pandemic turns into an endemic. During a House Committee on Energy and Commerce hearing last summer, manufacturers were asked whether they would sell the vaccine at cost.

Moderna said it would not sell its vaccine at cost, despite the fact that development and manufacturing of the vaccine was almost entirely funded by U.S. tax dollars. Moderna subsequently earned an award for the "worst example of profiteering and dysfunction in healthcare" by the Lown Institute in Boston.

Like Pfizer, rival Moderna is poised to make billions from its COVID vaccine. As of mid-January, Moderna had secured \$11.7 billion in advance purchase orders from various governments and organizations, and the company was in the process of negotiating more deals, according to Fierce Pharma.

Moderna CEO Stephane Bancel said in an interview the company could join the ranks of the largest vaccine players by revenue this year.

Unlike Moderna, "Pfizer's COVID-19 vaccine development and manufacturing costs have been entirely self-funded, with billions of dollars already invested at risk," the company said in a Nov. 16, 2020 press release.

Dr. Reshma Ramachandran, a physician-fellow in the Yale National Clinicians Scholars Program testified <u>last month before U.S. lawmakers</u> about vaccine pricing and the refusal of the government and drug manufacturers to reveal information about the arrangements they've reached around their vaccines.

In an interview with YaleNews, Ramachandran explained that when Pfizer moves away from "pandemic pricing" and towards price points that are in line with other vaccines it has on the market, at \$150 or \$175 per dose, insurance companies will have to shoulder the cost and they'll pass it down to the public through insurance premiums.

We've already seen this with flu vaccines — "a publicly funded vaccine technology has continued to increase in price over the past two decades with significant impacts on our public health program budgets and our insurance premiums," Ramachandran said. "It's not the companies that have taken on the risk of developing and manufacturing vaccines. It's the American people."

The World Health Organization (W.H.O.) has an article titled, The Moderna COVID-19 (mRNA-1273) vaccine: what you need to know. It contains a lot of useful information for those deciding whether they should receive the vaccine or not.
