Sentara Norfolk General Hospital in Virginia is Murdering its Patients for Money

Dr. Paul Marik is chief of pulmonary and critical care medicine at Eastern Virginia Medical school and director of Intensive Care at Sentara Norfolk General Hospital. He has been prevented by the hospital from saving patients' lives with known safe treatments for Covid. Instead, Sentara requires him to use ineffective but expensive drugs like Remdesivir, which also attacks the body's organs such as the kidneys, because the hospital has financial incentives to use Remdesivir. Therefore, the hospital sacrifices people's lives for its revenues.

Dr. Marik has filed a lawsuit against the hospital over its ban on administering life-saving drugs to Covid patients. In an effort to deny the doctor standing in the law suit, the hospital suspended Dr. Marik from his duties but withheld that information from the court. In his motion, Marik said patients are dying "unnecessarily and unlawfully" because Sentara Healthcare is "preventing terminally ill COVID patients from exercising their right to choose and to receive safe, potentially life-saving treatment determined to be appropriate for them by their attending physician."

In an interview with The Defender, Marik said the hospital is prohibiting the use of a COVID protocol called "Math +." The protocol includes treating COVID patients with many drugs approved by the U.S. Food and Drug Administration (FDA) which has determined the drugs are safe and effective.

Instead, according to the lawsuit, Sentara recommends doctors use "toxic drugs" like Remdesivir — an expensive medication associated with severe side effects — because the hospital receives a bonus each time doctors prescribe it.

The UK's minimum gap for Covid-19 booster jabs will be halved from six months to three, after the UK Government accepted advice from the Joint Committee on Vaccination and Immunizations to speed up the programmer.




With the <u>most recent data</u> showing the vaccinated population accounted for 61% of all cases, 66% of all hospitalizations, and 81% of all Covid-19 deaths between October 25th and November 21st

Why is Trump given a hall pass on killer injections?

The "vaccines" now being forced on the global population are shaping up to be perhaps the most successful eugenics program in human history, and the scam of the century is that these shots are being sold as a treatment that will keep you healthy, wink, wink.

Even the CDC has admitted the injections have failed to prevent people from getting the very virus it purports to "protect" us from. "A lot of our people don't want to take vaccines. You know, I don't know what this is exactly. Republicans? Don't know what it is. I encourage them to take it. I do." Hannity then asked Trump if he received the injections. "Yes I did. I had [COVID] and I took [the "vaccine"]."

"That's the worst thing the FDA could have done" re: pausing the J&J viral vector DNA injection in April after several cases of blood clots.

3. Trump to New York Post: "I'm all in favor of the vaccine" - April 22, 2021

Here are the rest of his quotes via 'New York Post' columnist Michael Goodwin:

"It's pretty amazing stuff. If we didn't have a vaccine, it would have been just like the 1918 Spanish flu. The vaccine is a great thing and people should take advantage of it. Nobody should be forced, we have our freedoms. But I strongly recommend it because it's a real lifesaver."

4. Trump tells crowd at Alabama rally: "I recommend [you] take the vaccines." August 2021

It's almost like the crowd didn't know how to react. The "chosen one" is encouraging them all to receive injections of an experimental nature when he's supposed to be the anti-Fauci. "It was three days less than nine months, and you know what, it's great... but I recommend taking the vaccines, I did it, it's good, take the vaccines... But, you got your freedoms but I happened to take the vaccines. If it doesn't work, you'll be the first to know... but it is working."

5. Trump tells conservative radio host John Fredericks: *"I'm very proud of [the vaccines]."* September 2021

"I am a strong believer. You wouldn't have vaccines if it wasn't for me. And, please, I love our people. So I want our people to take the vaccines."

Fredericks chimed in and said he got the Moderna injection, helping the former president push his narrative that Covid "vaccines" are good for us. I wonder if Fredericks and Trump have made their appointments for their "boosters" yet.

Let's be clear. Trump won the 2020 election, which was stolen by the deep state and handed to the illegitimate administration of Joe Biden. Trump should be the president right now, period. Eighty House Republicans voted with Democrats on Tuesday to pass the Immunization Infrastructure Modernization Act, which if passed by the Senate and signed into law would fund a federal vaccination database. This is dangerous legislation, more government overreach! According to the bill, also called H. R. 550, the government would provide \$400 million in taxpayer dollars to fund "immunization system data modernization and expansion," a system otherwise defined as "a confidential, population-based, computerized database that records immunization doses administered by any health care provider to persons within the geographic area covered by that database." The text specifically outlines an expansion of Centers for Disease Control and Prevention (CDC) and Public Health Department capabilities and the ability for state and local health departments, as well as public and private health care providers, to share health data with the federal government.

In a <u>statement</u>, the bill's main sponsor, Democrat Rep. Ann Kuster (NH), said the system would be used to "remind patients when they are due for a recommended vaccine" and identify areas with low vaccination rates to "ensure equitable distribution of vaccines." Notably, the bill has four Republican co-sponsors: Reps. Larry Bucshon (R-IN), James Baird (R-IN), David McKinley (R-WV), and Brian Fitzpatrick (R-PA). Not one Democrat voted in opposition to the bill.

Rep. Mary Miller (R-IL), who was one of the 130 Republicans to vote "no," told Breitbart News exclusively on Wednesday that the legislation would enable the federal government to "track" unvaccinated Americans who "will be targeted and forced to comply with Biden's crazy 'global vaccination' vision."

"These systems are designed to allow for the sharing of crucial information and maintenance of records. Do we really trust the government to protect our medical records?" Miller said. "The bill's author even bragged in her press release that these systems will help the government remind patients when they are due for a recommended vaccine and identify areas with low vaccination rates to ensure equitable distribution of vaccines. This was clearly a legislative tool to enforce vaccine mandates and force their Orwellian rules onto those who do not comply."

Rep. Byron Donalds (R-FL) also voted "no" on the bill, citing *"Democrats' habitual pattern of reckless and wasteful spending"* in an exclusive statement to Breitbart News. The congressman said the legislation only serves to expand the power of the federal government and trample individual rights.

"This legislation would unnecessarily appropriate millions of taxpayer funds intended to expand bureaucracy in Washington. A database solely created to record and collect confidential vaccination information of Americans explicitly encroaches upon individuals' fundamental right to medical privacy," Donalds said. "As a fiscal conservative, I cannot in good faith support legislation that contributes to the Democrats' habitual pattern of reckless and wasteful spending and the intrusive heavy hand of government."

Miller noted that the legislation paves the way for the government to give blue states millions in taxpayer's funds to enforce vaccine mandates. According to the bill's text, the government could award grants and cooperative agreements to health departments or other local governmental entities for agreeing to adopt the new data collection guidelines set by the CDC. Any agencies hoping to receive a grant must agree to comply with security standards to protect personal health information.

The government may also develop "public-private partnerships" to help with "technical assistance, training, and related implementation support." When Breitbart News asked

Miller if public-private partnerships could potentially obscure data collection activities from the public, she said the government cannot be trusted to be transparent.

"...The government has become so large, you cannot expect them to keep anything private anymore. There is hardly any congressional oversight into studies these agencies conduct," she added.

Kuster is urging the Senate to quickly pass the legislation, saying the pandemic showed just how underprepared the country's *"vaccine infrastructure"* is. She emphasized that the legislation would help better prepare healthcare systems for *"future public health crises."* She said in part:

COVID-19 pulled back the curtain on our vaccination systems and highlighted the urgent need for upgrades. I'm proud the House passed my bipartisan Immunization Infrastructure Modernization Act to expand the enrollment and training of vaccine providers, update public health information technology to efficiently manage vaccine supply, and allow patients and providers to communicate securely in real-time.

Miller contended that the government has "no reason" to collect more vaccination data on Americans.

"As I've said many times before, the government is not your doctor. The federal government has no business inserting itself into private healthcare matters of Americans. There is no reason for them to collect this data, it is an affront to our liberties and health freedoms," she said. "This kind of legislation is always passed because the government has its hands in everything nowadays, often at the expense of the freedoms and privacy of Americans. This bill would allow the government to collect, study, and share your private health data. There are endless ways the government could potentially use that information against you – purposefully and accidentally."

As Dr. Judy Mikovits revealed in her new book 'Plague of Corruption', Big Pharma has more lobbyists at the federal government level than all the senators and legislators combined. That represents 535 Big Pharma lobbyists waving cash to their re-election campaign every two years for legislators and every six years for senators. Dr. Fauci demands Fox punish Lara Logan for comparing him to Nazi 'Angel of Death' Josef Mengele: Hints at legal action as he calls the attack 'slanderous' and 'disgusting' might be a bit premature once you read Robert Kennedy's new book *'The Real Dr. Fauci'*! It was my thought all along that Dr. Fauci's own words would convict him of his crimes.

Dr. Anthony Fauci criticized Fox Nation host Lara Logan Thursday for her comments comparing him to an infamous Nazi war criminal earlier this week, calling the conservative journalist's comparison 'slanderous' and 'disgusting.'

Speaking to MSNBC host Chris Haye Thursday night, Fauci called on Fox to take disciplinary action against the journalist - who faced backlash Monday after she compared the chief White House medical adviser to Josef Mengele, a Nazi doctor whose hideous experiments on Jewish concentration camp victims during World War II earned him the chilling moniker 'Angel of Death.'

"It's an insult to all of the people who suffered and died under the Nazi regime in the concentration camps," Fauci, 80, fumed on Hayes' primetime political commentary program All In.

"I mean, it's unconscionable what she said."

"What I find striking, Chris," the irate immunologist continued, "is how she gets no discipline whatsoever from the Fox network."

"How they can let her say that with no comment and no disciplinary action? I'm astounded by that!"

Logan, 50, slammed Fauci Monday during a discussion on <u>Fox News</u> Primetime about the Biden administration's response to the new super-mutated <u>Omicron COVID-19</u> variant.



Fox Nation presenter Lara Logan sparked a firestorm on Monday when she compared Dr Anthony Fauci to the Nazi doctor Josef Mengele.

During the televised talk, the journalist - whose career took a hit in 2013 when a 2012 report on the Benghazi attack from the then CBS correspondent was exposed as false - offered her insight on the emergence of new Omicron variant after host Pete Hegseth, a known critic of coronavirus vaccine mandates and masking policies, accused the Biden administration of overhyping the still largely unknown strain.

'There's no justification for putting people out of there jobs or forcing mandates for a disease that's ultimately very treatable, it's cheap to treat, medicines are available all over the world, and it has death rates that compare very much to seasonal flu,' Logan declared during the Monday night discussion.





"This is what people say to me, that he doesn't represent science to them. He represents Joseph Mengele,' Logan said of Dr Fauci. Mengele, dubbed the 'Angel of Death,' was a doctor at the Auschwitz death camp in occupied Poland who performed hideous experiments on prisoners."

The South African journalist, who joined Fox last year, then set her sights on Fauci, and made the contentious comparison.

"In that moment, what you see on Dr. Fauci, what people say to me, is that he doesn't represent science to them. He represents Josef Mengele – the Nazi doctor who did experiments on Jews during the second world war and in the concentration camps."

Logan added: "I'm talking about people all across the world who are saying this."

"The response from COVID,' she continued, 'what it has done to countries everywhere, what it has done to civil liberties, the suicide rates, the poverty - it has obliterated economies. The level of suffering that has been created because of this disease is now being seen in the cold light of day, i.e. the truth - and people see that there is no justification for what is being done."

The comments prompted immediate backlash from a slew of social media users and organizations aligned against anti-Semitism, like the Anti-Defamation League and American Jewish Committee - both demanding apologies from the firebrand journalist.

Fox, meanwhile, has remained silent amid the controversy - whereas Logan has stood by her comments, going as far as to encourage attacks on the Auschwitz Museum for condemning her Nazi analogy.

Appearing on MSNBC's All In on Thursday night, Fauci was asked by host Hayes to weigh in on the Fox personality's incendiary remarks, playing a short clip highlighting Logan's attack on the medical adviser - hours after he appeared at a press conference beside President Joe Biden to talk about the new variant, encouraging Americans to get renewed doses of the vaccine to quell its spread.

"I know that you want to talk about Omicron and I want to talk about Omicron, and I want to talk about the winter," Hayes, 42, began in the Thursday interview.

"But I feel like I'm talking to you and you've become this character, in the imagination of tens of millions of people in this country, because they think that you represent some tyrannical plot to keep the boot of COVID restrictions on the neck of free people."

The anchor then asked Fauci how he felt about Logan's comments, spurring the medical professional to go on a tirade condemning the journalist. *"I just wonder how you respond to that,"* Hayes asked.

"Look, Chris," Fauci began after viewing the contentious clip, visibly agitated. "I think the response is with so many people throughout the country and the world are responding to that absolutely preposterous and disgusting comparison that she makes."

Fauci added: "So not only is she being slanderous and disrespectful to so many people who were killed in the concentration camps by Dr. Mengele, but she absolutely has no idea what she's talking about. She's completely incorrect in everything she says."

Republican Senators Paul and Cruz slammed the scientist Sunday, after Fauci stated during an interview on CBS' Face the Nation that those who criticize him actually criticize science.

Republican Senators Rand Paul and Ted Cruz slammed Fauci on separate Fox News interviews Sunday, after the White House's chief medical adviser stated during an

interview on CBS' Face the Nation earlier that day that those who criticize him criticize science.

Paul slammed Fauci for displaying 'absolute hubris' through his comments, which he viewed as overly brazen, while Cruz contended that Fauci has done more to hurt the credibility of science and doctors by being 'dishonest,' 'political,' and 'partisan.'


During the interview, Fauci dismissed the political attacks against him as nothing more than *'nonsense'* and *'noise.'*

Fox talking head Tucker Carlson also took a shot at Fauci this week, after his appearance alongside Biden Monday, comparing the infectious disease expert to another disreputable figure from that period of history - Fascist dictator Benito Mussolini. Since one study is typically not enough to prove something like this, Dr. Malhotra also referenced additional research at a prestigious British research institution that he says a whistleblower told him is being suppressed due to fear that the pharmaceutical industry will stop supplying grant money.

Researchers in the department of that facility that deals with this kind of thing identified a direct link between inflammation around the coronary arteries and the injections they are calling covid "vaccines."

"We know since July there's been almost 10,000 excess non-covid deaths," Dr. Malhotra told the host. "And most of those, or a significant proportion of those, have been driven by circulatory disease, in other words heart attack and stroke."

"There's been a 30 percent increase in people dying at home, and often these are because of cardiac arrest."

Dr. Malhotra's own father is part of these statistics as he died of cardiac arrest at his home on July 26.

COVID mRNA shots are a 'technology designed to poison people': Canadian doctor

WATERLOO, Ontario (LifeSiteNews) — A Canadian doctor and microbiologist explained the toxic dangers of the mRNA COVID vaccines and why he considers the shots a *"technology designed to poison people."* Dr. Michael Palmer, a Canadian board-certified doctor, medical microbiologist, and professor of pharmacology and toxicology at the University of Waterloo, <u>briefly explained</u> in a video posted online last month how the mechanisms within the novel mRNA COVID-19 vaccines function. He also articulated why he thinks the experimental injections present a serious and potentially fatal toxicity risk to recipients.

"[The mRNA shots] have two components. One is the messenger RNA (mRNA) which contains the blueprint for ... the spike protein that occurs normally on the surface of the virus particles, and the idea is to sneak this messenger RNA into our own body cells in order to have them make the actual protein to which the immune system responds to," Palmer explained.

"The second component is the lipid nanoparticles," the doctor continued. "These lipids, fat-like molecules, they encase the messenger RNA and they serve two purposes. One is to protect the messenger RNA while it is in transport and secondly also to help it enter the body cells."

According to Palmer, the issue that arises from this is that one of the components of these lipid nanoparticles, the *"cationic"* or *"electrically positively charged lipid,"* is *"known to be quite toxic"* as a *"general property."*

As a result, once these toxic lipids enter the cell, *"they tend to disrupt the mitochondrial respiration, the cell respiration,"* which is a process that humans need *"for producing energy."* Palmer states that if this process is disrupted, the oxygen from respiration is not properly *"reduced to water"* but instead is reduced to *"reactive oxygen species"* that can *"react with anything,"* including *"our DNA"* in a way that inflicts *"damage."*

Even worse, Palmer elaborates that the result of this mechanism is the same result radiation treatments for cancer patients produce, which he says means there are strict limits on how much the human body can withstand before dying.

"With radiation there is a ... total lifetime dose limit that you can survive," Palmer outlined. "What that means is the total lifetime dose of these messenger RNA vaccines that you can tolerate before you die is limited. We don't know the exact amount because there [is] simply not enough experimental data."

"That's one of the great scandals of these vaccines is that no proper toxicity studies have been carried out ... But ... we can be certain that in principle, we can be quite certain that the total dose of these vaccines that you can tolerate before you die is limited," Palmer added. "So this is really a technology designed to poison people, there's really no two ways about it. That is my considered opinion as a medical doctor." This is not the first time Palmer has sounded the alarm regarding the COVID-19 vaccines. In October, Palmer wrote a letter to his employer, the University of Waterloo, condemning them for imposing a vaccine mandate for everyone wishing to go on campus.

At the time, Palmer fielded similar concerns regarding the safety of the experimental jabs and told <u>LifeSiteNews</u> by email that his opposition to the vaccine was *"not in spite of [his] medical education, but BECAUSE of it."*

"There is just no way that any competent medical scientist who makes an honest effort to himself could not see that these vaccines – in particular the mRNA vaccines, which are touted as 'the safe choice' – will cause grave harm, and with a sufficient number of cumulative doses certain death."

Despite approval from the likes of Health Canada, all currently available COVID-19 vaccines are experimental, with <u>clinical trials not set for completion</u> until 2023. Court Orders FDA To Comply With FOIA and Release Information On Pfizer Vaccine – First Batch of Documents Shows Over 1,200 Vaccine Deaths WITHIN FIRST 90 DAYS

The Food and Drug Administration (FDA) released the first batch of documents related to Pfizer's Covid-19 vaccine after a federal judge ordered that they must

comply with a massive Freedom of Information Act (FOIA) request that was filed by a government accountability group called <u>Public Health and Medical</u> <u>Professionals for Transparency</u>.

The esteemed group of more than 30 professors and scientists asked the federal government to share any and all data that factored into the agency's hasty decision to grant Pfizer's experimental mRNA vaccine an emergency use authorization (EUA) – which amounts to a trove of over 329,000 documents.

In a shameless effort to bury the information, the FDA challenged the FOIA request in court. After the agency was told that it must turn over the documents, **Justice Department lawyers representing the FDA asked a federal judge to allow them an unthinkable 55 years to process the request, saying that they would be able to release just 500 pages a month.**

In other words, Elon will make it to Mars way before the documents would be fully released – in the year 2076.

A <u>motion</u> that was also filed by the same group of doctors and scientists is currently pending in federal court that would force the FDA to expedite processing and releasing these documents.

Meanwhile, the FDA still has to comply with the original order to begin turning over documents. Lo and behold, the first release is a bombshell.

According to an official Pfizer document that is titled <u>Cumulative Analysis of Post-Authorization Adverse Event Records Reports</u>, in just the first 90 days of the vaccine's roll out under the FDA's EUA – from December 1st. 2020 – February 28th, 2021 – there were TENS OF THOUSANDS of reported adverse reactions, including OVER 1200 DEATHS.

The report only included adverse events to the vaccine that researchers considered "serious cases," **there were thousands more submissions that were left out of this data.**

Any cases deemed "non-serious" would be processed within 90 days, but this report was released before 90 days of Pfizer's vaccine being available had even passed.

"Due to the large numbers of spontaneous adverse event reports received for the product, **the MAH has prioritized the processing of serious cases**, in order to meet expedited regulatory reporting timelines and ensure these reports are available for signal detection and evaluation activity.

Non-serious cases are processed as soon as possible and no later than 90 days from receipt. Pfizer has also taken a multiple actions to help alleviate the large increase of adverse event reports."

In all, the report states that there were a total of 42,086 case reports of individuals who had an adverse reaction to Pfizer's vaccine worldwide, with the largest number (13,739) coming from the United States and from the UK (13,404).

According to the documents women (29,914) were over **3x more likely to experience a reaction** than men (9182). A total of **1223 individuals had a fatal reaction** to the experimental Pfizer vaccine.

How did the FDA not immediately pull the experimental jab out of circulation? Let alone grant multiple extensions of the EUA to Pfizer while working with the fraudulent Biden regime to push a needle into the arm of every single American.

The document also makes it clear that the data only includes *"recorded adverse events,"* which even the author admits is likely just a portion of the true number of adverse reactions that took place.

Again, keep in mind, this is within the first 90 days of the Pfizer jab's availability.

From the Pfizer document:

"Reports are submitted voluntarily, and the magnitude of underreporting is unknown."

"Some of the factors that may influence whether an event is reported include: **length of time since marketing, market share of the drug, publicity about a drug or an AE, seriousness of the reaction, regulatory actions, and awareness by health professionals and consumers of adverse drug event reporting, and litigation.**"

Pfizer's "confidential" Covid-19 vaccine adverse reaction review ends with thousands of conditions that are of "special interest" and could possibly develop after taking their experimental jab. The single-space typed list continues for an astonishing 9 pages.

Yet somehow the paper concludes that the "review of available data" was good enough and demonstrated a "favorable benefit-risk balance" for the rushed vaccine.

A local family and their community are left mourning after a beloved young girl died unexpectedly last week.

"There are no words for the pain within our family at this time," Erica Gibson said about her niece, Destiny Gibson. "Destiny was an outgoing child filled with love and light that she shared with everyone she comes in contact with."

Destiny, 9 years old and a third grade student at John J. Doran Community School, suffered a severe asthma attack and died at her family's Fall River home on Thanksgiving.

Eric Bradley, Doran's principal, said on Monday they had extra counselors from across the Fall River school district on hand at the school to speak with students who needed support. Other administrative staff worked at Doran to free up more counselors from things like lunch and recess duty. He said that, especially because students attend Doran from kindergarten through eighth grade, the school feels like a real family and has been hit hard by the sudden loss of a student.

"We definitely recognize that there's no one correct way to manage grief. We've been really trying to let kids feel how they need to feel and have the adults here for them so they can feel heard and safe and remind them they're going to be okay," he said. (<u>Full</u> <u>article</u>.)

VAERS data released today by the Centers for Disease Control and Prevention included a total of **927,740 reports of adverse events** from all age groups following COVID vaccines, including **19,532** deaths and **146,720** serious injuries between Dec. 14, 2020, and Nov. 26, 2021.

The Centers for Disease Control and Prevention today released new data showing a total of <u>927,740 reports of adverse events</u> following COVID vaccines were submitted between Dec. 14, 2020, and Nov. 26, 2021, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of <u>19,532 reports of deaths</u> — an increase of 283 over the previous week — and <u>146,720 reports of serious injuries</u>, including deaths, during the same time period — up 3,325 compared with the previous week.

Excluding "<u>foreign reports</u>" to VAERS, <u>672,373 adverse events</u>, including <u>8,986 deaths</u> and <u>57,143 serious injuries</u>, were reported in the U.S. between Dec. 14, 2020, and Nov. 26, 2021.

<u>Foreign reports</u> are reports received by U.S. manufacturers from their foreign subsidiaries. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product's labeling, the manufacturer is required to submit the report to VAERS.

Of the 8,986 U.S. <u>deaths reported</u> as of Nov. 26, 20% occurred within 24 hours of vaccination, 26% occurred within 48 hours of vaccination and 61% occurred in people who experienced an <u>onset of symptoms</u> within 48 hours of being vaccinated.

In the U.S., 454 million COVID vaccine doses had been administered as of Nov. 24. This <u>includes</u> 264 million doses of Pfizer, 173 million doses of Moderna and 16 million doses of Johnson & Johnson (J&J).

Dagoury said he now struggles to reach an 8-minute breath-hold, feels an urge to breathe doing 40-minute dives, can't keep his heart rate low and experienced a 30% decrease in his diving performance.

<u>Jeremy Chardy</u>, a 34-year old professional tennis player ranked 73rd in the world, suspended his season due to a severe adverse reaction to a COVID vaccine, which left him unable to engage in intense activity.

<u>Kyle Warner</u>, a 29-year-old professional mountain bike racer, developed pericarditis, postural orthostatic tachycardia syndrome (POTS) and reactive arthritis following his second dose of Pfizer's COVID vaccine.

Warner's <u>reaction</u> was so severe that, as of October, he was still spending days in bed, overwhelmed by too much mental or physical exertion.

Two professional soccer players collapse during games

A professional soccer player collapsed suddenly on Nov. 25, during a Real Madrid's Champions League game with Sheriff Tiraspol, a Moldovan soccer club, <u>ZeroHedge</u> <u>reported</u>.

Adama Traore, 26, a winger for Sherriff Tiraspol, was seen clutching his chest as he slumped to the ground in the middle of the game as medics rushed to revive him. The reasons behind Traore's collapse and why he was suffering from chest pains have not been confirmed.

Traore's collapse occurred the night after another player, Sheffield United's John Fleck, went down during a match against Reading. Fleck was taken off on a stretcher after receiving lengthy treatment.

When a radio pundit questioned whether Fleck had <u>received the COVID vaccine</u>, his live feed to the show was cut.

A major German newspaper, <u>Berliner Zeitung</u>, recently published a report attempting to answer why an "unusually large number of professional and amateur soccer players have collapsed recently."

The article listed many recent cases of players who experienced heart problems or collapsed on the field — in some cases resulting in death.

Pfizer seeks authorization for boosters shots for 16- and 17-year-olds

Pfizer CEO Albert Bourla <u>said in a tweet</u> on Tuesday the pharma giant, along with BioNTech, formally asked the FDA to authorize COVID booster doses for 16- and 17-year olds.

If approved, the shot would be the first booster available to people under 18.

The FDA could approve <u>Pfizer's booster doses</u> for 16- and 17-year olds as soon as next week, according to people familiar with the matter.

COVID vaccines may be associated with heightened risk of myopericarditis among men

To help determine whether a <u>correlation exists</u> between COVID vaccines and myopericarditis, researchers tracked data from more than 268,000 adults in Massachusetts who received at least one dose of a COVID vaccine between August 2020 and May 2021.

The researchers compared the data to a control group made up of 235,000 of the same patients — from 2018 and 2019, well before they had received any doses of a COVID vaccine.

In a study <u>published</u> in the American Journal of Cardiology, the researchers found the age-adjusted incidence rate of myopericarditis in men was higher in the vaccinated than the control population, while the incidence rate of myopericarditis in women was the same between the vaccinated and control populations.

They also found an increased incidence of myocardial injury in both men and women in 2021 compared to 2019, although they suggested some of the apparent increase in the diagnosis of myopericarditis after vaccination may be attributable to factors unrelated to the COVID vaccines.

Moderna CEO says Omicron COVID booster could be ready by March

Moderna President Stephen Hoge said Wednesday boosters of its COVID vaccine targeting the <u>Omicron variant</u> could be ready for U.S. authorization as early as March.

Moderna is also developing a multivalent vaccine targeting Omicron and three other COVID variants, although the shot will not be available for several more months, <u>Forbes</u> reported.

March is the earliest date an Omicron booster could be approved under current FDA guidelines, though the company can start manufacturing the vaccine during testing.


Hoge said he thinks existing vaccines "will be able to slow down, if not completely stop, the Omicron variant."

New York, fresh from deploying Covid to kill <u>15,000</u> nursing home residents, pivoted to kids with a <u>bribery</u> campaign conceived in the pits of hell. Mayor de Blasio announced that jabbed kids are eligible for a \$100 gift, which he cheerfully informed them "buys a whole lot of candy." Already, Pfizer is boasting that it will make as much money from its Covid vaccine in 2021 than it made from all its products in 2020. And wait until 2022, when Fauci assures us that even babies and toddlers will be stabbed with the jab! The vaccine is already proven to be dangerous. On November 12th, the CDC released the <u>latest figures</u> from the VAERS (Vaccine Adverse Event Reporting System). Among the deaths: a 17-year-old girl from Washington, a 12-year-old girl from South Carolina, a 13-year-old girl from Maryland, and a 17-year-old girl from Texas. 59 cases of life-threatening anaphylaxis were reported in this age group – with 96% attributed to Pfizer's vaccine. 552 cases of myocarditis and pericarditis (heart inflammation) were reported, with all but 10 linked to Pfizer, and 131 cases of blood clotting disorders, with 100% linked to Pfizer.

Mrs. de Garay documented Maddie's medical records and <u>submitted</u> them to the CDC, FDA, and NIH's National Institute of Neurological Disorders and Stroke without getting any meaningful response. Pfizer has categorized Maddie's systemic injuries as "functional abdominal pain."

Sweden, Denmark, Finland, and Taiwan have stopped vaccinating younger groups because of reported heart damage and other injuries. (See here, here, and here.) All four countries report worrisome rates of myocarditis and pericarditis, which cause heart inflammation, in younger people injected with Covid vaccines. And in Germany, federal data shows that children aged 12 to 17 were far more likely to be damaged from Covid vaccines than from Covid. Children were hospitalized post-vaccine

with myocarditis, pericarditis, thrombosis, pulmonary embolism, and Guillain-Barre Syndrome. Around the world, children are suffering from Covid vaccines.

Pfizer conducted NO long-term studies on their vaccine's impact on kids – none, nada, zilch, zip. Pfizer <u>admits</u> in its application to the FDA that they will study the longterm effects on kids AFTER they receive authorization. Pfizer's clinical trials consist of just two small studies of approximately 2,000 kids each. One group was followed for about two weeks after vaccination; the other for two months. That's it. Two months! What on earth happens to our future if something goes wrong?

Fauci and the FDA admit they don't know if the vaccines are safe for kids. "The real question that we have not yet answered is the safety data of an mRNA vaccine in young people vis-a-vis myocarditis," Fauci <u>told</u> Reuters in October. And Dr. Eric Rubin, a voting member of the FDA panel that endorsed the vaccine and editor-in-chief of The New England Journal of Medicine, casually <u>noted</u>, *"We're never going to learn about how safe the vaccine is unless we start giving it. Children's risk of Covid death or serious illness remains extremely low. 

In his interview with Attorney Reiner Fuellmich last July, he explained how there are no variants of COVID-19. They are all computer simulations of specific gene sequences. We extracted about 19 minutes of that interview and it is on our <u>Bitchute channel</u>.

At around the 14-minute mark of this video, Dr. Martin states: There is no such thing as an alpha, or beta, or gamma delta variant. This is a means by which what is desperately sought is a degree to which individuals can be coerced into accepting something that they would not otherwise accept.

There has not been in any of the published studies in what has been reportedly the delta variant, there has not been a population "are not" calculated, which is the actual replication rate.

What has been estimated, are computer simulations.

There has been no ability to identify any clinically altered gene sequence, which then has a clinically expressed variation.

And this is the problem all along. This is the problem going back to very beginning of what's alleged to be a pandemic, is that we do not have any evidence that the gene sequence alteration had any clinical significance whatsoever.

There has not been a single paper, published by anyone, that has actually established that anything novel since November of 2019 has clinical distinction from anything that predates November of 2019.

The problem with the 73 patents that I described, is that those 73 patents all contain what was reported to be novel in December and January of 2019 and 2020 respectively. So the problem is that even if we were to accept that there are idiopathic pneumonias, even if we were to accept that are some set of pathogen induced symptoms, we do not have a single piece of published evidence that tells us that anything about the subclades Sars-CoV-2 has clinical distinction from anything that was known and published prior to November 2019 in 73 patents dating to 2008.

There is no, and I am going to repeat this, there is no evidence that the Delta variant is somehow distinct from anything else GISAID.

The fact that we are now looking for a thing does not mean it is a thing, because we are looking at fragments of things, and the fact is that if we choose any fragment, I could come up with, you know, I could come up with variant "omega" tomorrow.

And I could come up with variant "omega" and I could say I'm looking for this sub strand of either DNA or RNA, or even a protein, and I could run around the world going "Oh my gosh! Fear the omega variant!"

And the problem is, that because of the nature of the way in which we currently sequence genomes, which is actually a compositing process, is what we call in mathematics an "inter-leaving," we don't have any point of reference that actually know whether or not the thing we are looking at is in fact distinct from either clinical or even genomic sense.

And so we're trapped in a world where unfortunately, if you go and look, as I have, at the papers that isolated the Delta variant, and actually ask the question, is the Delta variant anything other than the selection of a sequence in a systematic shift of an already disclosed other sequence, the answer is, it's just an alteration in when you start and stop what you call the reading frame.

Israel Simulates COVID-19 "War Game Omega Exercise" on November 11, 2021

Two weeks before this current new variant suddenly appeared in Africa and started making the news cycle, Israel, which has been Pfizer's human laboratory to test their

COVID shots, ran a "war games" simulation to prepare for a "deadly new variant" which at the time had not yet been named. They called this future variant "Omega," and <u>the simulation was carried out on November 11, 2021</u>.

The Jerusalem Post reported:

Dozens of top officials took part in what Prime Minister Naftali Bennett called a COVID-19 war exercise on Thursday to gauge the country's preparedness for the next wave of the pandemic.

"We are starting an unprecedented event here," the prime minister said at the start of the exercise – "not only on an Israeli scale but on a global level. We are conducting a war exercise to prepare for a new variant that does not even exist yet."

The "Omega Exercise," as Bennett called it, was held in the format of a "war game," the Prime Minister's Office said. Bennett has regularly referred to the "Omega strain," the next harmful COVID-19 variant that has not yet been discovered. A war game is a game of the mind; no physical exercises took place.

Africa is Chosen to be the Source of the New Variant Scam

Up until now, Africa has been an enigma to the Globalists' narrative on the COVID-19 plandemic, as the continent has the lowest rates of COVID-19 vaccination, while also having the fewest amounts of "COVID-19 deaths." [It also has the smallest footprint for **5G** technologies, could there be a correlation here and **5G**/Covid? -Pastor Bob]

Ryan McMaken of the Mises Institute reported:

Since the very beginning of the covid panic, the narrative has been this: implement severe lockdowns or your population will experience a bloodbath. Morgues will be overwhelmed, the death total toll will be astounding. On the other hand, we were assured those jurisdictions that do lock down would see only a fraction of the death toll. Then, once vaccines became available, the narrative was modified to "Get shots in arms and then covid will stop spreading. Those countries without vaccines, on the other hand, will continue to face mass casualties."

The lockdown narrative, of course, has already been thoroughly overturned. Jurisdictions that did not lock down or adopted only weak and short lockdowns <u>ended</u> <u>up with</u> covid death tolls that were either similar to—or even better than—death tolls in countries that adopted draconian lockdowns. Lockdown advocates said locked-down countries would be overwhelmingly better off. These people were clearly wrong.

Undaunted by the increasing implausibility of the lockdown narrative, the global health bureaucrats are nonetheless doubling down on forced vaccines—as we now see in Austria—and we continue to be assured that only countries with high vaccination rates can hope to avoid disastrous covid outcomes.

Yet, the experience in sub-Saharan Africa calls both these narratives into question: Africa's numbers have been far, far lower than the experts warned would be the case.

For example, <u>the AP reported this week</u> that in spite of low vaccination rates, Africa has fared better than most of the world:

There is something "mysterious" going on in Africa that is puzzling scientists, said Wafaa El-Sadr, chair of global health at Columbia University. "Africa doesn't have the vaccines and the resources to fight COVID-19 that they have in Europe and the U.S., but somehow they seem to be doing better," she said....

Fewer than 6% of people in Africa are vaccinated. For months, the WHO has described Africa as "one of the least affected regions in the world" in its weekly pandemic reports. Yet disaster for Africa has long been predicted for several reasons even beyond the availability of vaccines. For instance, it is known that lockdowns are especially impractical in the poorest parts of the world.

This is because populations in places with undeveloped economies can't simply sit at home and live off savings or debt. Rather, these people must go out into the world and earn a living on a day-to-day basis. Starvation is the alternative.

Moreover, much of this work is done in the informal economy, so enforcing lockdowns becomes especially difficult.

It was also assumed covid would be especially deadly in Africa due to the fact many large households live in small housing units.

But that "conventional wisdom" flies in the face of the reality of covid in Africa, which is that there have been fewer deaths. (*Full article here*.)

But this new fake variant has been reportedly found in South Africa, with the supposed first detections coming from Botswana. The variant now has a name, Omicron, and while the corporate media is hyping it up and creating fear over it, the people in Africa themselves are not concerned.

Paul Joseph Watson of <u>Summit News reports</u>: The new 'Omicron' variant of COVID-19 was first detected in four people who were fully vaccinated, according to a public statement by the Botswana government.

The new variant, which some claim is three times more contagious, was initially discovered in Botswana before it spread across South Africa.

The news was met with global alarm, prompting financial markets to plummet and new travel bans to be put in place.

According to a public statement by the Botswana government, the new mutation was first discovered in four people who had received both doses of the COVID-19 vaccine. The Botswana Government says that the new COVID variant (named Omicron) was first detected in four patients who were FULLY VACCINATED for COVID. <u>https://t.co/twfaWmK2Gu</u>

"The preliminary report revealed that all the four had been completely vaccinated for COVID-19," according to Botswana authorities.

In a subsequent statement, the government revealed that the new variant "was detected on four foreign nationals who had entered Botswana on the 7th November 2021, on a diplomatic mission."

Meanwhile, South Africa's medical chief Dr. Angelique Coetzee described the panic as a "storm in a teacup," adding that she had only seen "very very mild cases" of the variant so far. (Full article here.)

South African Health Minister, Joe Phaahla, has also stated that the corporate media is making this into more of an issue than it should be.

What are the Globalists Planning to do with this New Fake Variant?

This is not a difficult question to answer. All one has to do is turn on their TV to a corporate news broadcast, or read one of their publications, because they will all mostly say the same thing.

Kit Knightly, writing for **Off-Guardian.org reports**:

If you want to know exactly how the Omicron variant is going to affect the narrative, well The Guardian has done a handy <u>"here's all the bullshit we're gonna sell you</u> over the next couple of weeks" guide:

- The Omicron variant is more transmissible, but they don't know if it's more dangerous yet (keeping their options open).
- It originated in Africa, possible mutating in an "untreated AIDS patient" (sick people are breeding grounds for dangerous "mutations").

- "it has more than double the mutations of Delta...scientists anticipate that the virus will be more likely to infect – or reinfect – people who have immunity to earlier variants. (undermining natural immunity, selling more boosters, keeping the scarefest going).
- "Scientists are concerned" that current vaccines may not be as effective against the new strain, they may need to be "tweaked" (get your boosters, and the new booster we haven't invented yet)
- "Scientists expect that recently approved antiviral drugs, such as Merck's pill, will work as effectively against the new variant" (more on this later)
- It's already spreading around the world, and travel bans may be needed to prevent the need for another lockdown

We're already seeing preparations for more <u>"public health measures"</u>, with the press breathlessly quoting "concerned" public health officials. We're being told that a new lockdown won't be necessary...as long as we remember to get boosted and wear masks and blah blah.

Generally speaking, it's all fairly boilerplate scary nonsense. (<u>Source</u>.)

And of course, Big Pharma already has their "magic pills" almost ready for emergency use authorization to come in and *"save the world."*

Kit Knightly continues:

Let's go back to the Guardian's "Omicron" bullet points, above:

- Scientists are concerned by the number of mutations and the fact some of them have already been linked to an ability to evade existing [vaccine-created] immune protection.
- Scientists expect that recently approved antiviral drugs, such as **Merck's pill**, [will work effectively] against the new variant

The "new variant" is already being described as potentially resistant to the vaccines, but NOT the new anti-viral medications.

Pharmaceutical giants Merck and Pfizer are both working on "Covid pills", which as recently as <u>three days ago</u>, were being hyped up in the press:

US may have a 'game changer' new Covid pill soon, but its success will hinge on rapid testing In the US, an emergency use authorization can only be issued if there is no effective medication or treatment already available, so the vaccines not being proof against Omicron would be vital to rushing the pills onto the US market, at least.

If Omicron is found to be "resistant to the vaccines", but NOT the pills, that will give governments an excuse to rush through approving the pills on an EUA, just as they did with the vaccines.

So, you bet your ass that testing is gonna be "rapid". Super rapid. Blink-and-you'll-missit rapid. Rapid to the point you're not even sure it definitely happened. And now they have an excuse.

Really, it's all just more of the same.

A scare before the new year. An excuse to make people believe their Christmas could be in peril. graphene hydroxide you have an OH group. The electrons are delocalized (fully mobile).

The piece is 50nm (nanometre) long but only 0.1nm thick. These C6 structures are extremely stable. You can make braking pads out of this. It is not biologically decomposable.

These nanoscale structures can best be described as razor blades.

These razor blades are injected into the body.

Nano-scale tiny razor blades. Only one atom thick layer.

The OH hydroxy groups can split off a proton. When the proton is split off, they gain a negative charge spread out over the whole system.




"I think we're going to have an annual revaccination and that should be able to keep us really safe," Bourla added.

When we run the exact same search in VAERS and exclude the COVID-19 shots, we find 2,225 fetal deaths following ALL vaccines injected into pregnant women for the past 30+ years.

Last month (October, 2021) the New England Journal of Medicine admitted that the original study used to justify the CDC and the FDA in recommending the shots to pregnant women was flawed.

Since then, researchers in New Zealand have conducted a new study on the original data, and concluded: A re-analysis of these figures indicates a cumulative incidence of spontaneous abortion ranging from 82% (104/127) to 91% (104/114), 7–8 times higher than the original authors' results.

Platelets are specialized cells that stop bleeding, and they have ACE2 receptors, which is what the SARS-CoV-2 spike protein binds to. When the spike protein binds to the ACE2 receptor on the platelets, it activates them.

This platelet activation can lead to disseminated intravascular coagulation, i.e., a pathological overstimulation of your coagulation system that can result in abnormal, and life threatening, blood clotting, as well as thrombocytopenia (low platelet count) and hemorrhaging.

Doctors for COVID Ethics described this mechanism in a February 28, 2021, letter to the European Medicines Agency (EMA). In that letter, they warned that, based on this

mechanism, spike protein-based COVID shots are likely to cause blood clots, cerebral vein thrombosis and sudden death, which is precisely what we've been seeing ever since.

In essence, you basically end up with so many blood clots throughout your vascular system that your coagulation system is exhausted, hence the low platelet count. The low platelet count, in turn, is what allows for hemorrhaging (abnormal bleeding).

A mystery that remains to be solved is why only certain people with antibodies to the spike protein (anti-spike antibodies) go on to develop symptoms of platelet activation and thrombocytopenia. Why not all of them? "One hypothesis is that platelet activation is dependent on unique spike protein epitopes, which are only recognized by a minority of identified antibodies," the authors suggest. In closing, they state:

"Our case ... highlights the applicability of the SRA to detect platelet activation disorders aside from HIT [heparin-induced thrombocytopenia]. Although classically done in the presence of heparin, it can be modified to include various antigens to elicit immune complex formation and identify platelet activation ..."

Ultimately, the role of SARS-CoV-2 Spike protein requires further clarification in regards to platelet activation, as well as the role of vaccine- and PEG-dependent platelet activation. We postulate that a small subset of antibodies against the Spike protein, formed after vaccination, can activate platelets and cause thrombocytopenia.

The prevalence of this phenomenon remains to be clinically determined. Regardless, the modified SRA presented here may be a useful diagnostic test as more cases of vaccine-induced thrombocytopenia are recognized."

Since well before the rollout of these COVID shots, scientists and doctors have sounded the alarm, pointing out a host of potential mechanisms by which they may cause harm. 
To remind you of where this article started, people who have received two mRNA shots have more than doubled their five-year risk of acute coronary events, on average. If

What Can You Do if You Have Jab Remorse?

If you now believe that getting the COVID jab was a mistake and wish to lessen your doubled risk of cardiac complications, there a few basic strategies I would advise.

1. Make certain you measure your blood vitamin D level and take enough vitamin D orally (typically about 8,000 units/day for most adults) to make sure your level is 60 to 80 ng/ml (150 to 2000 nmol/l).

2. Eliminate all vegetable (seed) oils in your diet, which involves eliminating nearly all processed foods and most meals in restaurants unless you convince the chef to only cook with butter.
