## **120 Teens Hospitalized, 3 Dead Following Pfizer Vaccine Rollout for 15- to 17-Year-Olds in Vietnam**

The Vietnamese province of Thanh Hoa suspended a batch of Pfizer's COVID vaccine after more than 120 teens were hospitalized after being vaccinated. According to news reports, three Vietnamese teens have died after getting the Pfizer vaccine.

The Vietnamese province of Thanh Hoa [suspended](#) a batch of Pfizer-BioNTech's [COVID vaccine](#) after more than 120 teens were hospitalized after being vaccinated.

According to the province's Center for Disease Control (CDC), the teens were hospitalized for symptoms ranging from nausea and high fevers to breathing difficulties — with 17 children exhibiting severe reactions.

Thanh Hoa authorities have yet to confirm [Pfizer's](#) COVID vaccine caused the teens' symptoms, [VN Express International](#) reported.

Vu Van Chinh, director of the Ha Trung District General Hospital, said side-effects following vaccination are normal but are more likely to happen in children than adults.

Luong Ngoc Truong, director of the CDC, said although the province stopped using the [current vaccine batch](#), “We still have other batches, also Pfizer vaccines, so we will continue vaccinating the children.”

The suspended batch was put into storage and could be used later for other groups like adults, Truong added.

Last week, four workers in Thanh Hoa's Kim Viet Shoe factory died — also due to “overreaction” — after receiving the Vero Cell COVID vaccine, [authorized in May](#) by the World Health Organization for emergency use.

Three Vietnamese children die after Pfizer vaccine

Vietnam on Nov. 30 rolled out its COVID vaccination program for children 15 to 17 years old with Pfizer's vaccine. Since then, three children have died after receiving their first dose. The cause of death was “overreaction to the vaccine.”

One of the three deaths reported in Vietnam includes a [12-year-old boy](#) in the southern province of Binh Phuoc who died one day after his first Pfizer shot.

The boy received his vaccine Monday afternoon and was sent home to rest. After dinner, he experienced dizziness, abdominal pain and diarrhea. He was taken to a local hospital and then transferred to two others, but died Tuesday morning.

The Binh Phuoc Department of Health set up an expert panel to determine the cause of the 12-year-old's death.

A 16-year-old boy in the northern Bac Giang Province, and a ninth-grade girl in Hanoi, both died Sunday after receiving Pfizer's COVID vaccine.

The Health Ministry said both deaths were caused by "overreaction to the vaccine," not by a problem with the quality of the vaccine or the vaccination process.

Drug makers Pfizer and Merck on Nov. 24 agreed to [give licenses to firms](#) in Vietnam to produce COVID treatment pills — paxlovid (Pfizer) and [molnupiravir](#) (Merck).

Vietnam is one of 95 low- and middle-income countries allowed to produce the pills through a [voluntary licensing agreement](#) with [Medicines Patent Pool](#), an international public health group backed by the United Nations.

According to the latest data from the U.S. Vaccine Adverse Event Reporting System, there have been [18,558 reported adverse](#) events following Pfizer's COVID vaccine among 12 to 17-year-olds.

## **666 Cases of Heart Disease in 12 to 17-Year-Olds After COVID Shots – Less than 2 Cases Per Year Following All Vaccines for Past 30+ Years**

The COVID-19 shots cause heart disease, mainly myocarditis and pericarditis, which is destroying the health of our young people. This is a fact that is no longer in dispute, as even the CDC admits this, as [their most recent report](#) states:

As of November 24, 2021, VAERS has received 1,949 reports of myocarditis or pericarditis among people ages 30 and younger who received COVID-19 vaccine. Most cases have been reported after mRNA COVID-19 vaccination (Pfizer-BioNTech or Moderna), particularly in male adolescents and young adults. ([Source](#).)

The only debatable points are, 1, whether or not these cases are "rare," and 2, if the benefits of COVID-19 mass vaccination of young people outweigh the risk for heart disease.

And [it is on these two points that the CDC is lying to the public](#), as I will conclusively prove in this article.

The second point is actually very easily debunked, by simply looking at publicly available statistics on COVID-19 deaths for this age group.

As of December 1, 2021, out of 779,402 alleged COVID-19 deaths covering almost 2 years now, only 630 of those were under the age of 17.

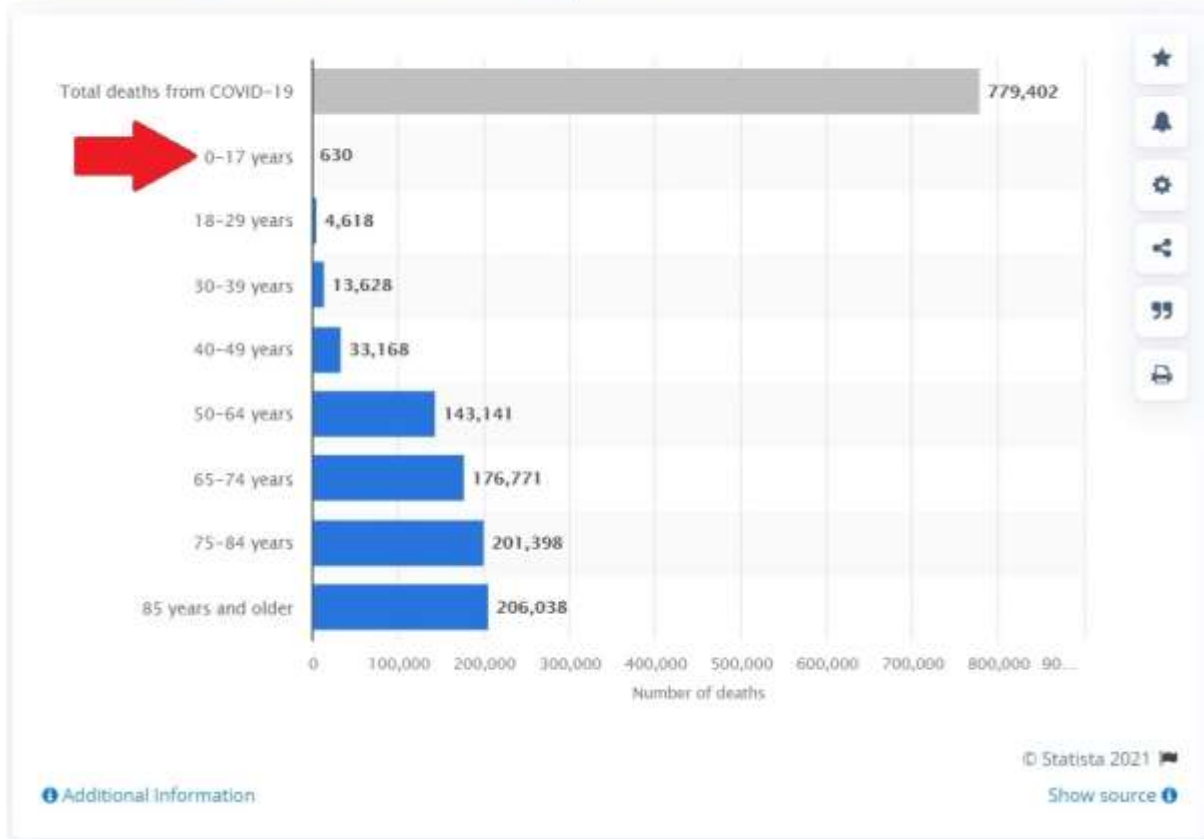
And even those 630 alleged deaths in this age group are not necessarily caused by COVID-19. It just means that when they died, they tested positive for COVID-19.

So there is no benefit to vaccinating children under the age of 17 for COVID-19 when they have almost a statistically zero percent chance of dying from COVID-19, when it is known that these shots cause heart disease.

As to the claim by the CDC that instances of heart disease caused by COVID-19 shots are “rare,” the factual evidence states otherwise.

I ran a search in VAERS, the U.S. Government’s *Vaccine Adverse Events Reporting System*, for all cases of “carditis” following COVID-19 shots for this age group, and from the 11/26/2021 release of VAERS data, it returned a result of **666 cases**. ([Source.](#))

Next, I performed the exact same search for the same age group excluding COVID-19 shots and including all other vaccines listed in VAERS for the past 30+ years, and it returned a value of **40 cases**, less than 2 cases per year. ([Source.](#))

Keep in mind that the 666 cases in this age group following COVID-19 shots are for only 6 months for 12 to 15-year-olds in the U.S., as the Pfizer shot was only given emergency use authorization for that age group in May of this year (2021).

Children between the ages of 5 and 11 were just given emergency use authorization last month, November, 2021, but there are already 2 cases of heart disease also reported in this age group, a 6-year-old and 8-year-old, both boys. ([Source.](#))

### Spike Protein Induced By COVID Vaccines Inhibits DNA Repair & Is Linked To Cancer Finds Major Swedish Study

According to a major Swedish study, spike protein induced by COVID vaccines weakens the immune system and may also lead to cancer. The study found that the [spike protein localizes in the nucleus and inhibits DNA damage repair](#).

"Spike Protein Induced By COVID Vaccines Weakens Immune System & Is Linked To Cancer Finds Major Swedish Study " Spike Protein weakens Immune System and inhibits DNA Repair.

A Swedish laboratory study (read below) published in mid-October found that spike protein related to Covid-19 virus and its experimental vaccines penetrated the cell nucleus and severely interferes damage repair functions of the DNA.

This should be no surprise had people heard and paid serious attention to what Dr. Sherri Tenpenny said in the fall of 2020 about the spike Protein (PEG).

This also compromises an individual's adaptive immunity and even might lead to the formation of cancer cells.

The study, titled "SARS-CoV-2 Spike Impairs DNA Damage Repair and Inhibits V(D)J Recombination In Vitro," was published by the Department of Molecular Biosciences at Stockholm University.

This study began with a discussion of the widespread effects of COVID-19 disease in the contemporary world and the need for healthy adaptive immunity so that people can fight SARS-CoV-2 infection.

However, the researchers pointed out that various clinical studies have shown *"that patients with severe COVID-19 exhibit delayed and weak adaptive immune responses"* for reasons that are unclear.

To provide a reasonable answer to this question, the authors *"report that the SARS-CoV-2 spike protein significantly inhibits DNA damage repair, which is required for effective V(D)J recombination in adaptive immunity."*

*"Mechanistically, we found that the spike protein localizes in the nucleus and inhibits DNA damage repair,"* they wrote. *"Our findings reveal a potential molecular mechanism by which the spike protein might impede adaptive immunity and underscore the potential side effects of full-length spike-based vaccines."*

In an online lecture that addressed the study, Dr. Mobeen Syed highlighted how B cells and T cells, which are part of the adaptive immune system, differ significantly in binding to a specific invasive antigen. This *"variability is produced by intentionally damaging the DNA [of each cell] and then repairing it."*

In addition, "when our cells are dividing, there are strict mechanisms to make sure that the DNA is correctly repaired and correctly copied and there is no damage otherwise the cell will become a cancer cell," he said.

Two relevant DNA repair mechanisms involves enzymes that are compared to "repair workers" as in those pf nucleus of a cell. "Imagine there are repair workers in our body, in our nucleus, that would rush to the place of a DNA break and go and fix it."

"Now imagine if these two enzymes cannot do their function. Imagine if they cannot even be produced," he said. In such a case, when spike and nonstructural proteins are present in the nucleus, "reduced proliferation of the cells occurs."

This means, with regards to our B and T cells alone, "our capability to respond to infections will not be good," he said.

COVID Vaccines alter DNA



In an episode of The High wire, journalist Jeffery Jaxen discusses how these pathogens get into the nucleus, which is particularly worrying.

“The nucleus of the cell is the main control center,” he said. **“Nothing should be getting in there, like a spike protein. And even at the beginning when these mRNA vaccines were getting rolled out, we were told the vaccines do not enter the nucleus. We were told they do not alter the DNA. So, this study appears to fly in the face of those statements.”**

In addition, Jaxson cites a Swedish study of how researchers analyzed “key checkpoint proteins” in the BRCA1 and 53BP1 regeneration pathways and “found that the spike protein markedly inhibited both BRCA1 and 53BP1 foci formation.”

ICYMI, here's a [chart from a recent post by my good friend Mathew Crawford](#). It basically shows, **the more you vaccinate, the more cases and deaths you get.**

**ER: Here we are adding a bit of comment from the author of this chart, Mathew Crawford:**

Let's talk about the chart above. For **each of the 219 nations** with data pulled from the Github repository of **Our World in Data**, I tallied COVID-19 cases and deaths from **day 1 of each nation's vaccination program through 10/20/2021**. I made small corrections for deaths using spot case fatality rates and the last 18 days of new case reports to estimate COVID-19 death tolls. I compute the correlations between proportions of populations at least once vaccinated on each of the dates above with those 10/20/2021 case/death statistics.

Observations:

- Every correlation is positive, meaning that **more vaccination is associated with more COVID-19 cases and more COVID-19 deaths**, as reported. I plan to set up various time-lagged endpoints and create heat maps for a bigger picture view.
- **Correlations trended more strongly positive as vaccination campaigns matured** toward their nearly present state.

*"But, but, but Pfizer said..."*

Critics would argue, *"it's confounded! more elderly are vaccinated."* But the same critics **cannot show us this is false**. They can only do "hand-waving" arguments that it must be wrong. Not very convincing.

But to be fair, we can't cite this as definitive proof either that the vaccines are unsafe.

**Governments won't release the data to show vaccinations are safe. I wonder why?**

We actually agree with the critics that it is confounded, but here's why: **governments don't release the breakdowns publicly, so we can't do any better than this**. If the vaccines are so safe, why don't they release the data to the public to show this?

Is this just a fluke? I don't think so. [Watch this video starting at 7:00](#). The line goes the wrong way. The more you vaccinate, the worse it gets.

Of course, "we" all know why this is:

1. The vaccine **depresses your immune system** immediately after the shot and for an unknown time after that. It can well be permanent.
2. The vaccines can kill you due to **blood clots and inflammation**.

Although we expect to submit BLAs for our mRNA-based product candidates in the United States, and in the European Union, **mRNA therapies have been classified as gene therapy medicinal products**, other jurisdictions may consider our **mRNA-based product candidates to be new drugs, not biologics or gene therapy medicinal products, and require different marketing applications.***

*“Any product candidates we develop may not be effective, may be only moderately effective, or may prove to have undesirable or unintended side effects, toxicities or other characteristics that may preclude our obtaining marketing approval or prevent or limit commercial use.”*

Pg. 16: ***“Currently, mRNA is considered a gene therapy product by the FDA...Our product candidates may not work as intended, may cause undesirable side effects or may have other properties that could delay or prevent their regulatory approval, limit the commercial profile of an approved label, or result in significant negative consequences following marketing approval, if any.”***

Vaccines normally take 10-15 years before getting approval for mass distribution. The first injections were rolled out in hospitals on Dec. 14, 2020. That SEC filing was last day of 2019 before production began. **Clinical trials are scheduled through 2023, so yes, humans on this planet are being used as test subjects.**

There is no FDA-approved vaccine to prevent COVID-19.”*

### **Lawsuits**

Fortunately for Americans, there’s been some skirmishes won in the courts while some lawsuits are still grinding along six months after filing. [Two More Biden Vax Mandates Blocked in Court](#), Dec. 1, 2021 – “U.S. District Judge Terry Doughty in Monroe, Louisiana, temporarily blocked the Centers for Medicare and Medicaid Services (CMS) from enforcing its vaccine mandate, saying that the government agencies — CMS and HHS, which developed the rule — have exceeded their authority.

*“None of the numerous regulations and statutes cited by the government defendants have “given them the ‘superpowers’ they claim,” per the ruling. It continued, “Not only do the statutes not specify such superpowers, but principles of separation of powers weigh heavily against such powerful authority being transferred to a government agency by general authority.”*

“Separately, U.S. District Judge Gregory Van Tatenhove in Frankfort, Kentucky, blocked the mandate that requires federal contractors to receive COVID jabs by January 4. Per the ruling,”

*“Can the president use congressionally delegated authority to manage the federal procurement of goods and services to impose vaccines on the employees of federal contractors and subcontractors? In all likelihood, the answer to that question is no.”*

## **BOMBSHELL: Video Emerges Where Fauci and Others Planned for a “Universal mRNA Flu Vaccine” Which Became the “COVID-19 mRNA Vaccine” Because People were not Afraid Enough of the Flu Virus**

Last night (December 6<sup>th</sup>) Alex Jones of [infowars.com](http://infowars.com) did a special broadcast regarding an October, 2019 video that they had just become aware of that was a panel discussion hosted by the Milken Institute discussing the need for a Universal Flu Vaccine.

The video clip that they played of this event was a 1 minute and 51 second dialogue between the moderator, Michael Specter, a journalist who is a *'New Yorker'* staff writer and also an adjunct professor of bioengineering at Stanford University, Anthony Fauci, the director of the National Institute of Allergy and Infectious Diseases, and Rick Bright, the director of HHS Biomedical Advanced Research and Development Authority (BARDA).

In this short clip, which was extracted from the hour-long panel discussion, Anthony Fauci explains that bringing a new, untested kind of vaccine like an mRNA vaccine, would take at least a decade (“if everything goes perfectly”) to go through proper trials and be approved by the FDA.

He would know, because he had been trying to do it for about a decade already by then (October, 2019), trying to develop an mRNA based vaccine for HIV.

But now they were discussing something much bigger than just a vaccine for AIDS patients. They are talking about a “*Universal Flu Vaccine*” that everyone would have to take – a huge market for Big Pharma!

Rick Bright, the director of HHS Biomedical Advanced Research and Development Authority (BARDA), then speaks and states that what could happen is that “an entity of excitement that is completely disruptive and is not beholden to bureaucratic strings and processes” could change that.

I have not had a chance to watch these yet, as I went and found the original 1 hour panel discussion video, and spent the day listening to and analyzing that, so that I could supply this report to our readers.

Joining Fauci, Rick Bright, and Michael Specter at this event were:

- Margaret Hamburg, Foreign Secretary, National Academy of Medicine
- Bruce Gellin, President, Global Immunization, Sabin Vaccine Institute
- Casey Wright, CEO, FluLab

In short, this panel discussion focused on what they perceived as the need for a universal flu vaccine, but they admitted that the old way of producing vaccines was not sufficient for their purposes, and that they needed some kind of global event where

many people were dying to be able to roll out a new mRNA vaccine to be tested on the public.

They all agreed that the annual flu virus was not scary enough to create an event that would convince people to get a universal vaccine.

And as we now know today, about 2 years after this event, that “*terrifying virus*” that was introduced was the COVID-19 Sars virus.

And so now we know why the flu just “*disappeared*” in the 2020-21 flu season. It was simply replaced by COVID-19, in a worldwide cleverly planned “*pandemic*” to roll out the world’s first universal mRNA vaccines.

This was always the goal, and previous efforts through various influenzas, AIDS, Ebola, and other “viruses” were all unsuccessful in leading to the development of a universal vaccine to inject into the entire world’s population.



Margaret Hamburg stated regarding getting a “Universal Vaccine” into the market:

*“It’s time to stop talking, and it’s time to act.”*

*“I think it is also because we haven’t had a sense of urgency.”*

Michael Specter asks:

*“Do we need lots of people to die for that sense of urgency to occur?”*

Hamburg replies that: *“There are already lots of people dying”* from the flu each year.

Bruce Gellin states that basically people just are not afraid enough of the term *“the flu.”*

There are so many things that are revealed about how Big Pharma and government health authorities think in this panel discussion. For example, they bemoan the fact that if they do too good of a job in public health, then they lose funding to develop products that fight viruses.

Michael Specter states: *“It seems to me that one of the curses of the public health world is, if you guys do your job well, everyone goes along well and healthy.”*

Hamburg: *“And they cut your funding.”*

Rick Bright complains that the yearly distribution of flu vaccines is inefficient in terms of collecting data, and in the process actually admits that some vaccines just don't work well:

*“We distribute 150 million doses of the seasonal (flu) vaccines every year, we don't even know how many people are being vaccinated from the doses that are delivered to the people, which doses they got, and what the real outcome was, so that we can learn from that knowledge base on how to optimize or improve our vaccine. So there are opportunities that we have today...”*

*I think if we uncloaked the poorest performing vaccines in the market place today, it might be very revealing to tell us which of the technologies we have, and allow us to go deeper into those technologies to determine why they are more effective. There are vaccine licenses today that are more effective. I think that we're just afraid to admit the truth.”*

So much for the public mantra that is espoused by Big Pharma and government that the “science” of vaccines is “settled,” and that they are completely “safe and effective.”

Casey Wright repeats the mantra that was publicized every year, before COVID, about just how deadly the flu virus was: *“650,000 people die every year from the flu.”*

As we have documented many times over the past decade here at *Health Impact News*, this is simply not true. This is an estimate because actual laboratory confirmed cases of influenza each year are very small, probably less than 1000 in the U.S.

Most flu-like symptoms are never tested in a lab to determine what is causing the symptoms. They were always just classified as “flu” to inflate the numbers to justify the very profitable flu shot each year. Some of our previous coverage of this issue:

So as they have inflated the COVID-19 cases since last year, they are simply continuing their policy of inflating flu numbers each year in order to sell their vaccines. They

obviously could not have done both last year, as the public would have quickly seen that the math doesn't work.

And yet, so many in the public bought the lie that the COVID-19 measures got rid of the flu, but not COVID-19.

Ultimately, this panel discussion can be boiled down to: Nobody wants to fund research for a universal flu vaccine. So how do we change that? Create a pandemic of fear over the flu (but they couldn't call it the "flu" because people are no longer afraid of influenza, and the fear over "AIDS" had also subsided).

Fauci then addressed this "perception problem."

*"There's this perception (about the flu), if it's so serious, how come people get the flu each year and it isn't a catastrophe?"*

*When you're dealing with a disease like HIV, if you get HIV, it's serious. Whether you're young, whether you're middle aged, or whether you're old. If you get cancer, that's bad. Whether you're young, whether it's intermediate... whereas if it's influenza, some people, they go throughout life and it doesn't impact them at all.*

*There isn't anyone who is afraid of influenza. You go into a focus group and you say: Are you afraid of getting HIV if you're at risk? Oh, absolutely.*

*Are you afraid of getting cancer? Absolutely. Are you afraid of the flu? Don't bother me. That's the reality of how people perceive flu.*

*And it is going to be very difficult to change that, unless you do it from within and say, I don't care what your perception is, we're going to address the problem, in a disruptive way...."*

Specter then asks:

*In the long run, over time, if the 2009 pandemic had been much more deadly, would that have ended up being a better thing for humanity?"*

Everyone is silent as they obviously were thinking about how to answer that, and Specter says: "Come on gang."

Fauci ultimately answers and says "No" because there were other years that were worse than 2009 and it didn't change a thing in terms of creating a universal vaccine. Hamburg then states:

*"The sad truth is that when there is a major crisis, it focuses attention and usually resources and some significant mobilization follows.*

*We need, #1, this time to be different, and we also need to really organize ourselves in a way where there will be accountability for sustained action, and not just response.”*

Specter states:

*“Craig Venter, who is a controversial person, but interesting to me, has written that he thinks we ought to have a vaccine, such that, if you take off in a plane from Hong Kong, and are infected, by the time your plane lands in New York, there ought to be a vaccine assembled and deliverable to you.*

*How crazy is that? How far are we from that? Are we ever going to get there?”*

Bright replies:

*“I’m not going to say how far away, but I don’t think that’s too crazy.*

*I think that if we move towards the era of synthetic-based vaccines, I think we remove the dependencies of thinking the vaccine has to be grown into something else, an egg, a cell, or insect cell – any type of dependency embryo.*

*If we can move into more synthetic, the nucleic acid based, messenger RNA based, those sequences can be rapidly shared around the world.*

He then goes on to talk about using a 3D printer to print out a “vaccine patch” that people use to administer the “vaccine.”

We also learn in this panel discussion why Anthony Fauci is so opposed to natural immunity, because natural immunity for influenza, according to his view, translates to an immune response against other strains of a particular influenza virus, which will interfere with what they are trying to do with the vaccines.

That is why he wants to inject infants as young as 6 months old with a universal vaccine, as he states here, to prevent that “confused” natural immunity from happening before the child grows older.

**So the big question that this panel was tackling, was how do they implement their strategies, and what is holding them back?**

Certainly the government/regulatory issue is a big one, and now two years later we can see exactly how they did that, by controlling the FDA and the CDC to promote the “*killer virus pandemic*” narrative as long as possible to justify taking emergency measures that short-cut the normal procedures for bringing novel, new drugs to the market.

It also clearly explains the vicious opposition to existing, cheap therapeutics that very easily treated what is really just the seasonal flu “virus,” which stood in their way of rolling out a universal vaccine.

Casey Wright then made a rather remarkable comment about “philanthropy” and its role in this effort:

*“There’s a potential role for philanthropy to play there... we are in a position to take on a little more risk (she smiles eerily as she says this), to be open to a little bit more experimentation and methods in how we do things. That’s what I think is unique about FluLab, and is unique about other philanthropies.*

*I think they can play a really important role there, and fund a set of bolder, maybe earlier promising concepts.”*

Bingo! Think Bill and Melinda Gates Foundation, the Rockefeller Foundation, and other “philanthropies” that are “unburdened” by regulatory issues as they spend their money pretty much unchecked, with no accountability, all in the name of “science” and the “greater good.”

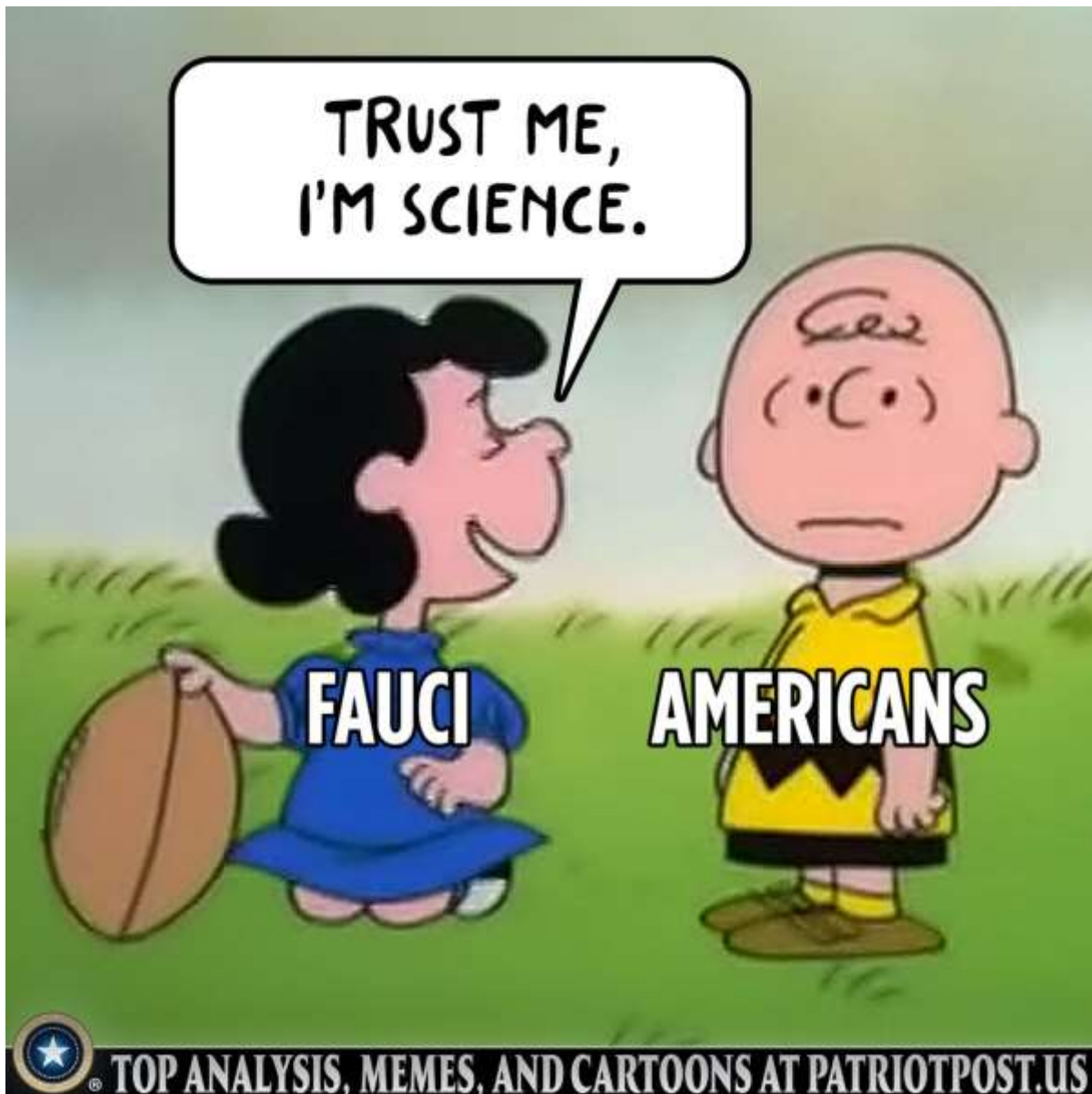


### **Your Life Only has Value as a Lab Rat to These Satanic Tyrants**

Look at Anthony Fauci, for example. Does he look like an 80-year-old man? What does he do to stay looking so young?

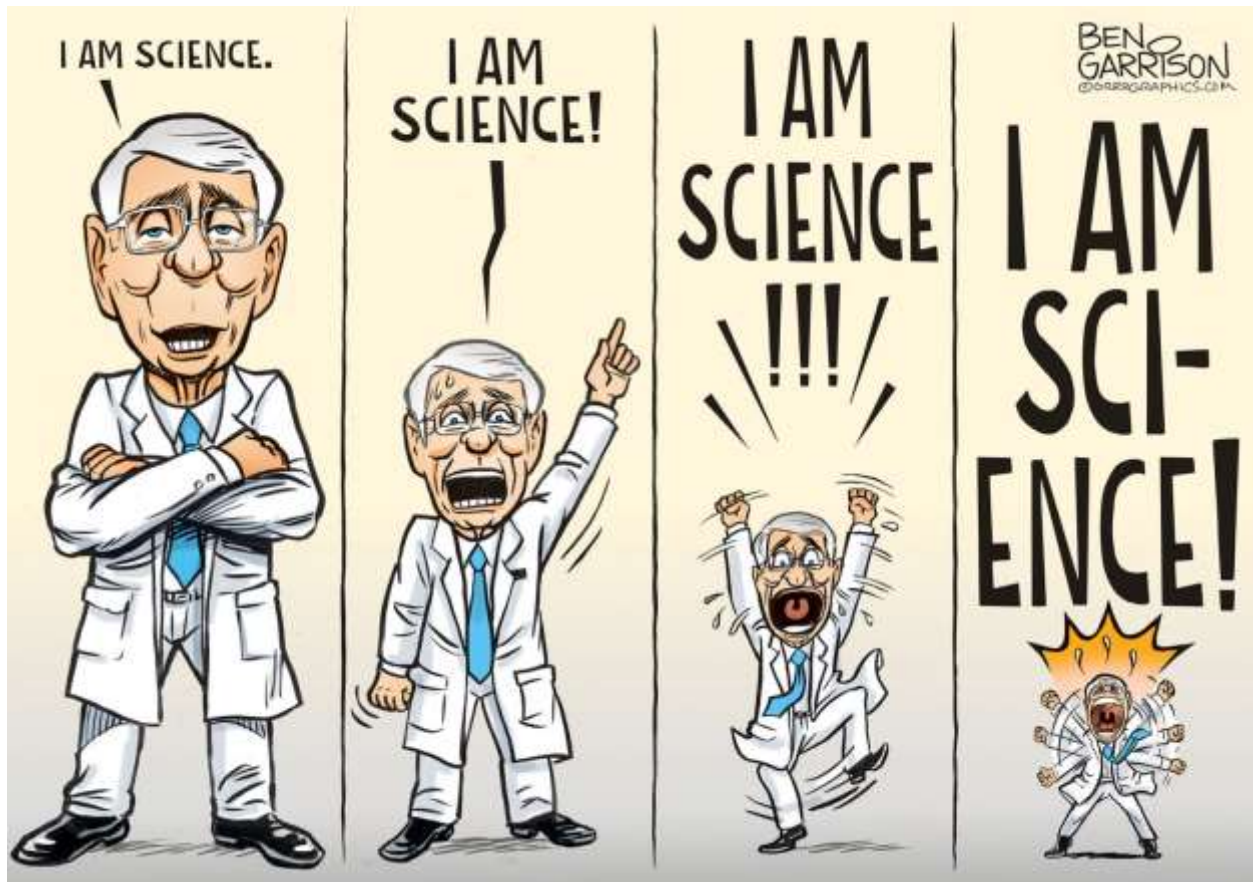

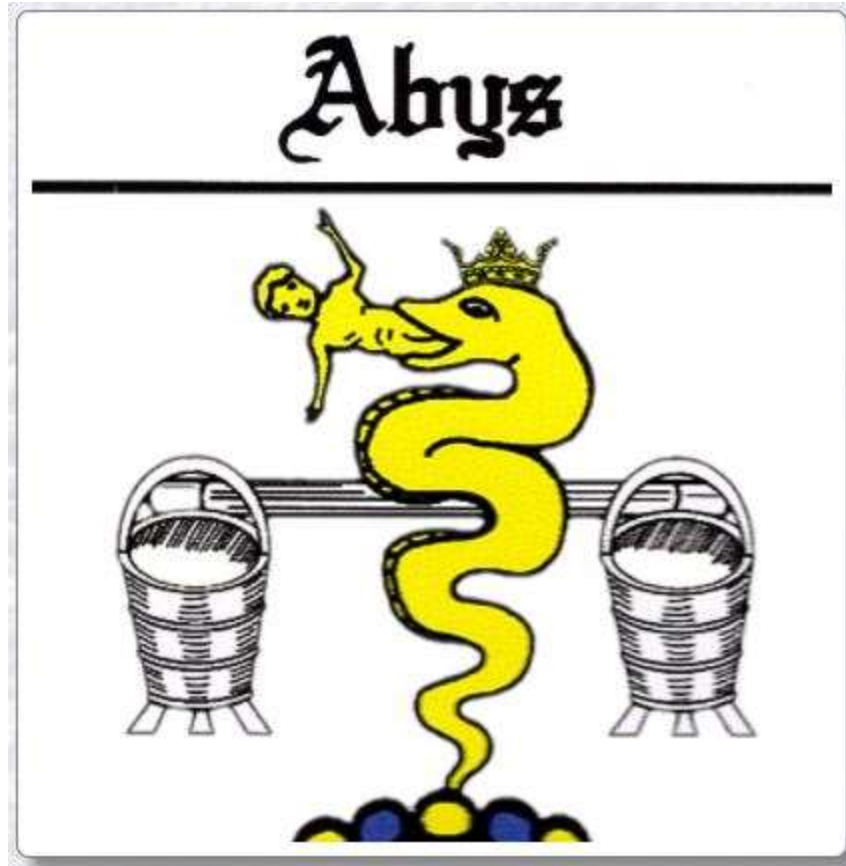

### **Regulatory agencies turned into pharmaceutical companies**

Because of financial entanglements between pharmaceutical companies and the agencies that regulate them, public health agencies in the U.S. have been turned into veritable pharmaceutical companies. The U.S. Food and Drug Administration, for instance, receives 45% of its annual budget from Big Pharma, Kennedy [explains](#).

"It is the biggest vaccine company in the world," Kennedy says. The NIH actually owns half the patent for Moderna's COVID-19 injection, which means that if the shot is approved and/or mandated, it will make billions of dollars as a result.

"Tony Fauci was able to choose, to designate, four of his high-level employees who each get individual patent shares," Kennedy [explained](#). "They will collect \$150,000 a

year for life if the Moderna vaccine is approved, which it has been.” Fauci’s agency, the NIAID, in particular, no longer looks out for public health — and Fauci doesn’t either; his priority is pharmaceutical promotion.

### **How Rockefeller took control of the medical school system**

One of the important parts of Kennedy’s new book is exposing the connection of Fauci to Bill Gates and helping uncover how Gates patterned his strategy after Rockefeller. In 1984, when Fauci was appointed director of NIAID, 11.8% of Americans had a chronic disease. Contrast that to today, when 54% are now suffering from chronic illness. Fauci doesn’t talk about this public health failure — at least not publicly — but as Kennedy noted, it was Fauci’s job to figure out why autism, allergies and so many other diseases have increased, identify the toxins causing them and eliminate them.

“Fauci could have prevented the whole thing,” Kennedy noted, referring to the epidemic of chronic diseases now plaguing Americans, but instead of running a true public health agency Fauci turned it into an incubator for pharmaceutical products. According to Kennedy, between 2009 and 2016, 240 new drug products were approved by the FDA, and all of them came from Fauci.

“He has a \$6.1 billion budget that he distributes to colleges and universities to do drug research for various diseases,” Kennedy said. “He has another \$1.7 billion that comes from the military to do bioweapons research, and that is why he had to do the gain of function ... He was locked into that; 68% of his personal salary comes from doing military/bioweapons research that used to be called ‘dual use’.”

### **Fauci has long promoted Gain-of-Function research**

Dual use research is so named because it involves research on select agents and toxins that could either benefit society or destroy it, depending on whether or not it falls into the wrong hands. Fauci specifically spoke about dual use research of concern (DURC), which involves 15 potentially deadly pathogens like smallpox and Ebola virus, at a [hearing](#) before the Committee on Homeland Security and Governmental Affairs at the U.S. Senate, held April 26, 2012.

DURC involves seven categories of research experiments, according to the CDC, which includes gain of function (GOF) and which may enhance the harmful consequences of the agent or toxin, [among](#) others. Because GOF and DURC can be used to make pathogens more readily able to infect humans, they pose major biosecurity risks.

After the 2001 anthrax attacks, the CIA began pouring money into bioweapons research. The Pentagon was nervous about conducting such studies because it was prohibited, so cohorts funneled money to Fauci to do it, Kennedy said. Because he called it dual use “vaccine research,” it was allowed to continue.

Another moratorium was placed on U.S.-funded GOF research in October 2014, after a string of concerning events, including publication of controversial GOF studies and high-profile “incidents” at U.S. biocontainment laboratories, [led](#) to more than 300 scientists launching a petition calling for an end to GOF research.

That moratorium was lifted in December 2017, but in the meantime Fauci continued his controversial research by funneling money to the Wuhan lab in China, partnering with Chinese military scientists, and teaching them how to take bat coronaviruses, and make them transmissible to human beings.

“Fauci was giving them millions and millions of dollars,” Kennedy said, “but the biggest contributor was the CIA, and the Pentagon through DARPA.” The three were all working in tandem, teaching the Chinese how to weaponize bat viruses.

### **Fauci experiments killed at least 85 children**

Fauci's sordid past goes back to the AIDS crisis, which is now being used as a template for what's happening during COVID-19, and the fabrication of past pandemics, including Zika virus, for the purpose of selling pharmaceuticals and advancing totalitarian control. One of the most atrocious acts, however, included barbaric and illegal experiments that the NIAID conducted on children, testing pharmaceuticals. *Fauci "got control of foster homes in seven states and turned pharmaceutical companies loose on these children," Kennedy [said](#).*

*"The children were tortured. They did not have legal representation, which is illegal. They did not have guardians. You cannot put a child into a clinical trial in this country without a legal guardian. And he made sure that those kids did not have guardians. They were literally tortured to death ... many of the kids did not have HIV, they were just guinea pigs.*

*The children who refused or were noncompliant were sent to Columbia Hospital and had feeding tubes installed in them so the drug companies could administer the drugs even when the kids fought back. At least 85 of these kids died during the experiments."*

A graveyard was found in Hawthorne, New York, with a pit covered by an Astroturf carpet that had hundreds of tiny coffins piled up with the bodies of these children inside, Kennedy said. *"After New York, he took that roadshow to Africa and ended up killing many pregnant mothers and getting away with it."*

### **Using fear to disable critical thinking**

Waking up to Fauci's façade is necessary to understand the orchestrated planned use of pandemics to clamp down totalitarian control. One sign of the ensuing control is the deep involvement of intelligence agencies in the pandemic process, even though they're not health agencies. Kennedy [explains](#):

*"The intelligence agencies and health agencies have developed these extraordinary techniques for using fear to disable critical thinking. If you look at the whole rationale behind this pandemic, all of these rationales collapse.*

*Why are we mandating vaccines that don't prevent transmission? What is the possible reason? That's just one of many absurdities of what we're doing today. But people who are subsumed in the orthodoxy, which is the product of orchestrated fear, misinformation and propaganda, need to be woken up."*

He references the now-infamous experiment conducted by Yale University psychologist Stanley Milgram in 1962, during which he tested the limits of human obedience to authority. The Milgram experiment was conducted following the trial of Nazi Adolf Eichmann, who used the Nuremberg defense, or "befehl ist befehl," which translates to "an order is an order."

The [Milgram experiment](#) clearly showed that people would act against their own judgment and harm another person to extreme lengths simply because they were told to



do so. What does this mean for the future, if people blindly obey and submit to totalitarian control? Kennedy [said](#):

*“I think this is historical jeopardy to humanity that we’ve never seen before. You know, the black plague and WWII are arguably rivals for it. But I would argue that this is the worst thing that has ever happened to humanity because the essential ambition of the totalitarian state is to control, not just conduct, but self-expression and thought.*

*And for the first time in history, because of the technological revolution, the capacity for totalitarian forces to literally control every aspect of human expression and even human thought is now unprecedented.”*

### **Waking up to the truth**

In China, a vast array of facial recognition technology that claims to be able to read guilt on a person from a distance has reportedly already been deployed. *“This is precrime,”* Kennedy [says](#), like the movie *“Minority Report.”* In such a technocratic world, however — unlike at any point in history — there’s nowhere to run, and nowhere to hide:

*“In Hitler’s time you could run for the border, and there were ways that a certain number of people were going to escape. They were going to regroup and there was opposition from other countries.*

*Today, we have this situation where the U.S. military and the CIA are conspiring with the Chinese CDC and military scientists, developing bioweapons together and conspiring to lie to the public ... We have U.S. federal officials who are conspiring with Chinese military officials to hide truth from the American public.”*

*“I would say this is Armageddon,”* Kennedy said. *“This is the apocalyptic forces of ignorance and greed and totalitarianism. This is the final battle. We need to win this one,”* and the first step to doing so is waking up to the truth.

A recent study published in the MDPI or Multidisciplinary Digital Publishing Institute found that **people taking vitamin D daily and who have at least 50 ng/mL in their blood have a mortality rate of zero for COVID-19.**

*“Mortality rates from clinical studies were corrected for age, sex, and diabetes. Data were analyzed using correlation and linear regression. Results: One population study and seven clinical studies were identified, which reported D3 blood levels pre-infection or on the day of hospital admission.*

*The two independent datasets showed a negative Pearson correlation of D3 levels and mortality risk ( $r(17) = -0.4154$ ,  $p = 0.0770$ / $r(13) = -0.4886$ ,  $p = 0.0646$ ). For the combined data, median (IQR) D3 levels were 23.2 ng/mL (17.4–26.8), and a significant Pearson correlation was observed ( $r(32) = -0.3989$ ,  $p = 0.0194$ ). Regression suggested a theoretical point of zero mortality at approximately 50 ng/mL D3.”*

According to the paper, without calcium supplementation even very high vitamin D3 supplementation does not cause vascular calcification. The authors say that vitamin D3 supplementation in the range of 4000 to 10,000 units (100 to 250 µg) is needed to generate an optimal 40–60 ng/mL level.

Supplementing vitamin D with approximately 200 µg of vitamin K2 is recommended by the authors of the paper to help filter calcium into the bones instead of the blood.

Another recent study found that among COVID-19-positive patients, the group with vitamin D levels of more than 30 ng/ml had significantly lower hospital stays, and no difference was found among the groups in terms of age and gender distribution.

According to the paper, elevated vitamin D levels could even decrease COVID-19 PCR positivity.

Many media outlets, as well as politicians, have been highlighting the higher death rate from coronavirus for black Americans than White and Asian Americans, but differing vitamin D levels and obesity are the likely culprits.

Furthermore, according to the CDC the death rate from diabetes is highest among non-Hispanic black adults and lowest among non-Hispanic white adults. During 2004–2017, the death rate decreased from 438.3 per 100,000 to 391.1 among non-Hispanic white adults, from 602.0 to 485.7 among Hispanic adults, and from 804.3 to 607.0 among non-Hispanic black adults.

Data from the National Health and Nutrition Examination Survey (NHANES) III shows that non-Hispanic blacks are at more than 10 times greater risk than non-Hispanic whites of being in the lowest quartile of 25(OH) vitamin D serum measurements. ## Is “Dr.” Bill Gates Folding? Yes, No, Maybe, or Hope So!

The “acute phase” of the Covid-19 pandemic will end in 2022, billionaire Microsoft founder and vaccine enthusiast Bill Gates has predicted on his blog, also deeming the rise of the Omicron variant “concerning.”

Pharmaceutical companies have historically had trouble selling the flu shot to populations due to its comparatively low effectiveness rate, which is largely due to scientists having to guess what strain of influenza will be most prevalent in any given year.

Gates, however, is bullish on therapeutics, pointing out that pharmaceutical giant Merck recently received FDA approval for its molnupiravir antiviral for high-risk people. The pill *“significantly reduces your chances of being hospitalized or dying from Covid-19 (although not as much as we’d initially hoped),”* he said.

The tech mogul acknowledged that despite the rollout and mass uptake of Covid-19 vaccines around the world, more people had died with the virus in 2021 than in 2020, adding that the improvement in the pandemic situation this year had not been as “dramatic” as he’d hoped.

Gates himself can securely rest on his laurels, however, having beefed up his net worth to \$137 billion during the pandemic.

The billionaire attempted to bridge the class divide between himself and his readers, declaring 2021 had been *“the most unusual and difficult year of his life,”* while *“suspect[ing] a lot of the people reading this might say the same.”*

Gates called the emergence of the Omicron variant of the virus *“concerning,”* but said the world is *“better prepared to tackle potentially bad variants”* than it previously was. The South African scientists who discovered the Omicron variant have mostly suggested the symptoms are mild and not a huge cause for concern.

Gates has repeatedly complained about the inequity of vaccine distribution worldwide, calling it the “biggest disappointment” to him during the pandemic and saying it “doesn’t make sense” to vaccinate low-risk people before older and vulnerable populations in poorer countries.

His many vaccine-related NGOs have struggled to convince wealthy countries to pony up the funds to vaccinate African nations, many of which have been handling the

pandemic better than expected, thanks to longstanding familiarity with cheap and widely-available anti-parasitic and anti-malaria drugs.

Microsoft cofounder Bill Gates said he is hopeful that the critical phase of the COVID-19 pandemic will end in 2022. *"In a couple years, my hope is that the only time you will really have to think about the virus is when you get your joint COVID and flu vaccine every fall,"* he said. 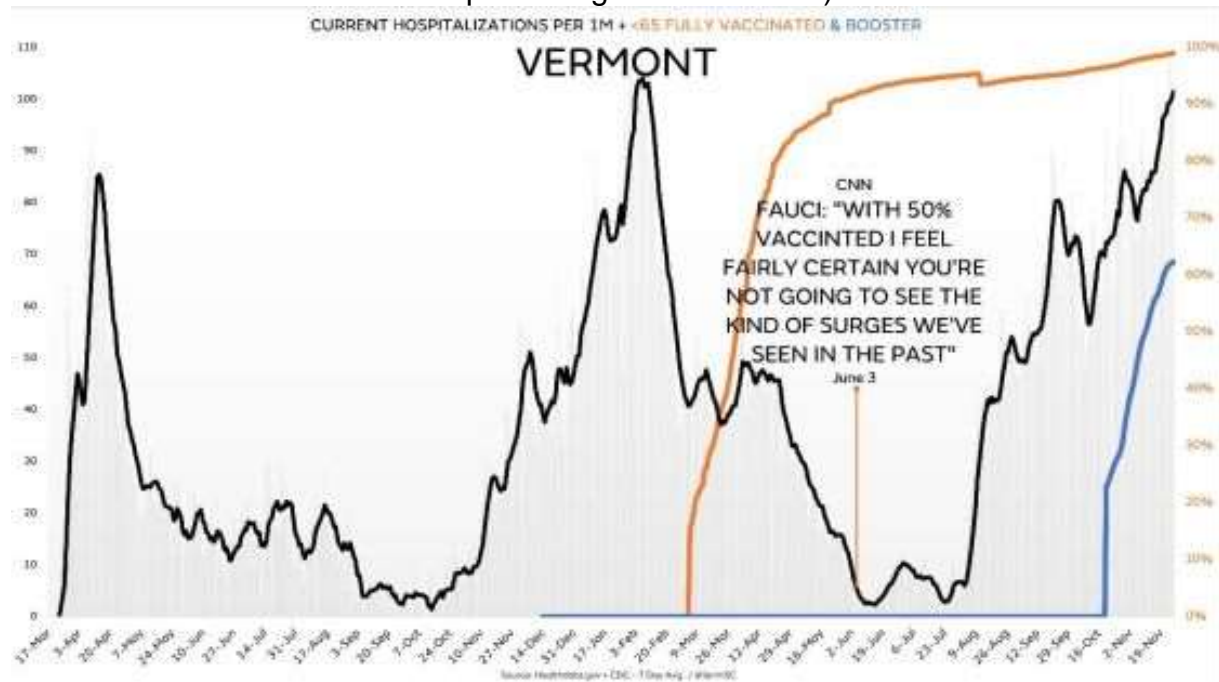
## Whatever you do, do not look at this chart, citizen

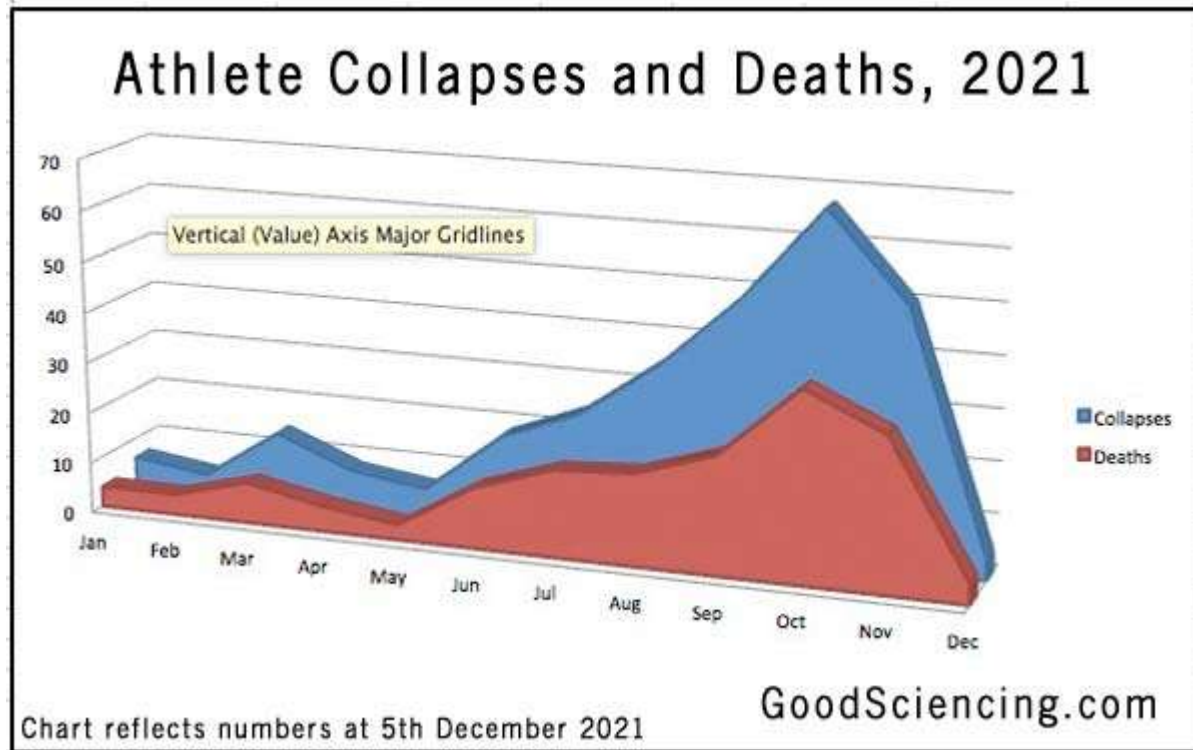

#### **CDC Pushes 3rd Shot for Teens, as Number of Deaths Reported to VAERS After COVID Vaccines Nears 20,000**

VAERS data released today by the Centers for Disease Control and Prevention included a total of **946,463 reports of adverse events** from all age groups following COVID vaccines, including **19,886 deaths** and **150,946 serious injuries** between Dec. 14, 2020, and Dec. 3, 2021.

The Centers for Disease Control and Prevention today released new data showing a total of **946,463 reports of adverse events** following COVID vaccines were submitted between Dec. 14, 2020, and Dec. 3, 2021, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of **19,886 reports of deaths** — an increase of **354** over the previous week — and **150,946 reports of serious injuries**, including deaths, during the same time period — up **4,226** compared with the previous week.

Excluding “[foreign reports](#)” to VAERS, [681,962 adverse events](#), including [9,136 deaths](#) and [58,503 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and Dec. 3, 2021.

[Foreign reports](#) are reports received by U.S. manufacturers from their foreign subsidiaries. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product’s labeling, the manufacturer is required to submit the report to VAERS.

Of the 9,136 U.S. [deaths reported](#) as of Dec. 3, 20% occurred within 24 hours of vaccination, 25% occurred within 48 hours of vaccination and 61% occurred in people who experienced an [onset of symptoms](#) within 48 hours of being vaccinated.

In the U.S., 466 million COVID vaccine doses had been administered as of Dec. 3. This [includes](#) 271 million doses of Pfizer, 178 million doses of Moderna and 17 million doses of Johnson & Johnson (J&J).

Every Friday, [VAERS](#) publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Historically, **VAERS has been shown to report only 1% of actual vaccine adverse events.**

FDA, CDC sign off on Pfizer boosters for 16- and 17-year-olds, suggest 3rd shot for younger kids may come soon.

The CDC on Thursday [signed off](#) on Emergency Use Authorization of booster doses of the Pfizer-BioNTech vaccine for 16- and 17- year olds.

Approval from CDC Director Dr. Rochelle Walensky came hours after the U.S. Food and Drug Administration (FDA) authorized booster doses for the same age group.

Walensky said in a statement initial data suggest a third shot will help strengthen protection against [Omicron](#) and other variants, and she urged older teens to get the booster.

The FDA on Thursday authorized the booster doses for 16- and 17-year-olds at least six months after receiving their second dose of the vaccine, the [New York Times reported](#).

The FDA broadened Pfizer's authorization to cover the younger age group on an emergency basis as [initial research](#) suggested the new Omicron variant undermines antibody protection of two doses of Pfizer's vaccine.

Pfizer boosters will be available to 16- and 17-year-olds at least six months after they received their initial two doses of Pfizer's COVID vaccine. The [Moderna](#) and [Johnson & Johnson](#) vaccines remain authorized only for adults.

Meanwhile, the [CDC today said](#) it was "considering" boosters for 5- to 11-year-olds. "We're first starting to get our 5- to 11-year-olds vaccinated," Walensky said. "We'll look again at the 12- to 15-year-olds, of course, as with the FDA, in real-time."

Roughly two-thirds of parents of elementary school-aged children are either holding off on getting their younger kids vaccinated or refuse to do so, according to ABC7 in New York.

### **Breakthrough cases surge in Missouri, Massachusetts, Connecticut**

The [latest data](#) from Missouri show 730 people died from COVID despite being fully vaccinated. According to the [Missouri Department of Health and Senior Services](#), the state recorded 760,035 COVID cases as of Dec. 9.

More than 11,321 fully vaccinated people in Massachusetts [tested positive](#) for COVID last week — an increase of 71% over the 6,610 breakthrough infections reported the previous week.

Breakthrough cases in Massachusetts account for 40% of the state's overall cases in recent months as the vaccine's effectiveness wanes after six months. In all, 88,968 fully vaccinated people have tested positive for the virus since Dec. 14, according to data from the state's Department of Public Health on Tuesday.

Data [provided](#) by the Connecticut Department of Public Health showed an increase in breakthrough cases over the past four weeks. A total of 4,143 breakthrough cases were reported over the previous week ending Wednesday — an increase from Dec. 2, when there were a total of 2,553 new breakthrough cases.

Of the 4,143 identified [breakthrough cases](#) in Connecticut most occurred among patients between the ages of 35 and 64. There were 802 breakthrough cases in patients 35 to 44, 842 cases in patients aged 55 to 64, 33 breakthrough infections among children aged 12 to 15 and 321 cases in patients 75 and older.

### **Definition of fully vaccinated will change to include 3rd dose**

It's only a matter of time before the [definition of fully vaccinated](#) is changed to include a third dose, [Dr. Anthony Fauci](#), director of the National Institute of Allergy and Infectious Diseases, said Wednesday.

According to the CDC [website](#), "fully vaccinated persons are those who are  $\geq 14$  days post completion of the primary series of an FDA-authorized COVID-19 vaccine."

The term fully vaccinated refers to a person who has received two doses of Pfizer or Moderna COVID vaccines or a single shot of Johnson & Johnson. The [definition has implications](#) because it is used by those imposing [vaccine mandates](#) across the country, including federal mandates for healthcare workers, government contractors and private businesses with more than 100 employees.

### **Four doses of COVID vaccine likely needed to combat Omicron variant**

Pfizer CEO Albert Bourla said Wednesday people may [need a fourth dose](#) of the COVID vaccine sooner than expected after preliminary research showed the Omicron variant can undermine antibody protection in people who only received two doses.

Pfizer and BioNTech [released results](#) from their initial lab study showing a third dose was protective against the new variant, but the initial two-dose series dropped significantly in its ability to protect against the new strain.

Bourla said three doses against Omicron are equivalent to the two doses' effectiveness against the original variant, although more data is needed from tests using the actual virus. Real-world results will be more accurate and are expected in the next two weeks, he said.

Bourla [previously predicted](#) a fourth dose would be needed 12 months after the third dose, but said with Omicron, "we may need it faster."

120 teens hospitalized, 3 dead following Pfizer vaccine rollout for 15- to 17-year-olds in Vietnam. The Vietnamese province of Thanh Hoa [suspended a batch](#) of Pfizer-BioNTech's COVID vaccine after more than 120 teens were hospitalized after being vaccinated.

According to the province's CDC, the teens were hospitalized for symptoms ranging from nausea and high fevers to breathing difficulties — with 17 children exhibiting severe reactions.

Since the rollout began on Nov. 30, three Vietnamese teens died after receiving Pfizer's vaccine, including two 12-year olds and a 16-year-old.

The Health Ministry said the deaths were caused by "overreaction to the vaccine," not by a problem with the quality of the vaccine or the vaccination process.

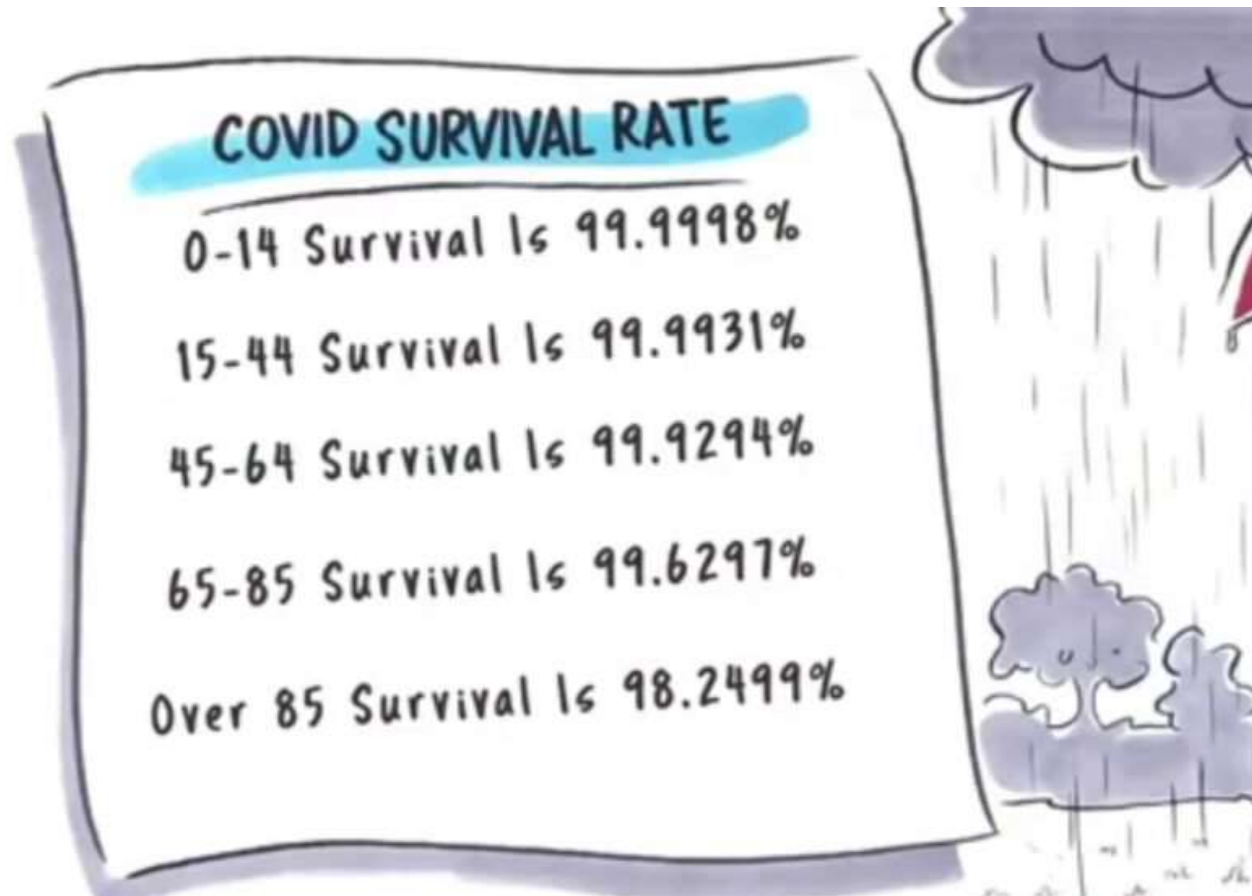

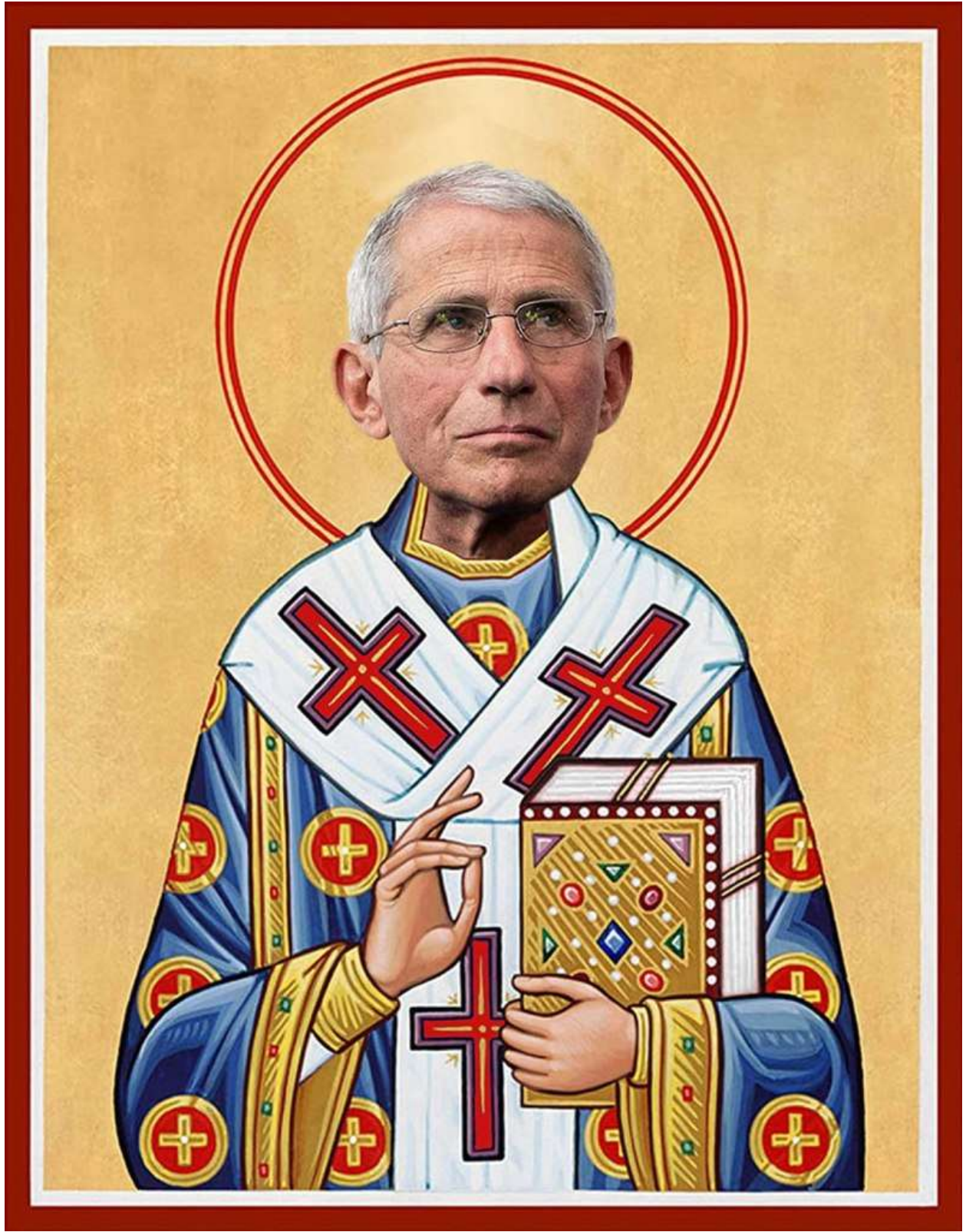

### **Court Orders FDA to Comply With FOIA and Release Information On Pfizer Vaccine – First Batch of Documents Shows Over 1,200 Vaccine Deaths WITHIN FIRST 90 DAYS**

The Food and Drug Administration (FDA) released the first batch of documents related to Pfizer's Covid-19 vaccine after a federal judge ordered that they must comply with a massive Freedom of Information Act (FOIA) request that was filed by a government accountability group called [Public Health and Medical Professionals for Transparency](#).

The esteemed group of more than 30 professors and scientists asked the federal government to share any and all data that factored into the agency's hasty decision to grant Pfizer's experimental mRNA vaccine an emergency use authorization (EUA) – which amounts to a trove of over 329,000 documents.

In a shameless effort to bury the information, the FDA challenged the FOIA request in court. After the agency was told that it must turn over the documents, **Justice Department lawyers representing the FDA asked a federal judge to allow them an unthinkable 55 years to process the request, saying that they would be able to release just 500 pages a month.**

In other words, Elon will make it to Mars way before the documents would be fully released – in the year 2076.

A [motion](#) that was also filed by the same group of doctors and scientists is currently pending in federal court that would force the FDA to expedite processing and releasing these documents.

Meanwhile, the FDA still has to comply with the original order to begin turning over documents. Lo and behold, the first release is a bombshell.

According to an official Pfizer document that is titled [Cumulative Analysis of Post-Authorization Adverse Event Records Reports](#), **in just the first 90 days of the vaccine's roll out under the FDA's EUA – from December 1st, 2020 – February 28th, 2021 – there were TENS OF THOUSANDS of reported adverse reactions, including OVER 1200 DEATHS.**

The report only included adverse events to the vaccine that researchers considered “serious cases,” **there were thousands more submissions that were left out of this data.**

Any cases deemed “non-serious” would be processed within 90 days, **but this report was released before 90 days of Pfizer's vaccine being available had even passed.**

*“Due to the large numbers of spontaneous adverse event reports received for the product, **the MAH has prioritized the processing of serious cases**, in order to meet expedited regulatory reporting timelines and ensure these reports are available for signal detection and evaluation activity.*

***Non-serious cases are processed as soon as possible and no later than 90 days from receipt.*** Pfizer has also taken a multiple actions to help alleviate the large increase of adverse event reports.”

In all, the report states that there were **a total of 42,086 case reports of individuals who had an adverse reaction to Pfizer’s vaccine worldwide**, with the largest number (13,739) coming from the United States and from the UK (13,404).

According to the documents women (29,914) were over **3x more likely to experience a reaction** than men (9182). **A total of 1,223 individuals had a fatal reaction to the experimental Pfizer vaccine.** This should serve as a word to the wise!

How did the FDA not immediately pull the experimental jab out of circulation? Let alone grant multiple extensions of the EUA to Pfizer while working with the fraudulent Biden regime to push a needle into the arm of every single American.

**The document also makes it clear that the data only includes “recorded adverse events,”** which even the author admits is likely just a portion of the true number of adverse reactions that took place.

***“Reports are submitted voluntarily, and the magnitude of underreporting is unknown.”***

***“Some of the factors that may influence whether an event is reported include: length of time since marketing, market share of the drug, publicity about a drug or an AE, seriousness of the reaction, regulatory actions, and awareness by health professionals and consumers of adverse drug event reporting, and litigation.”***

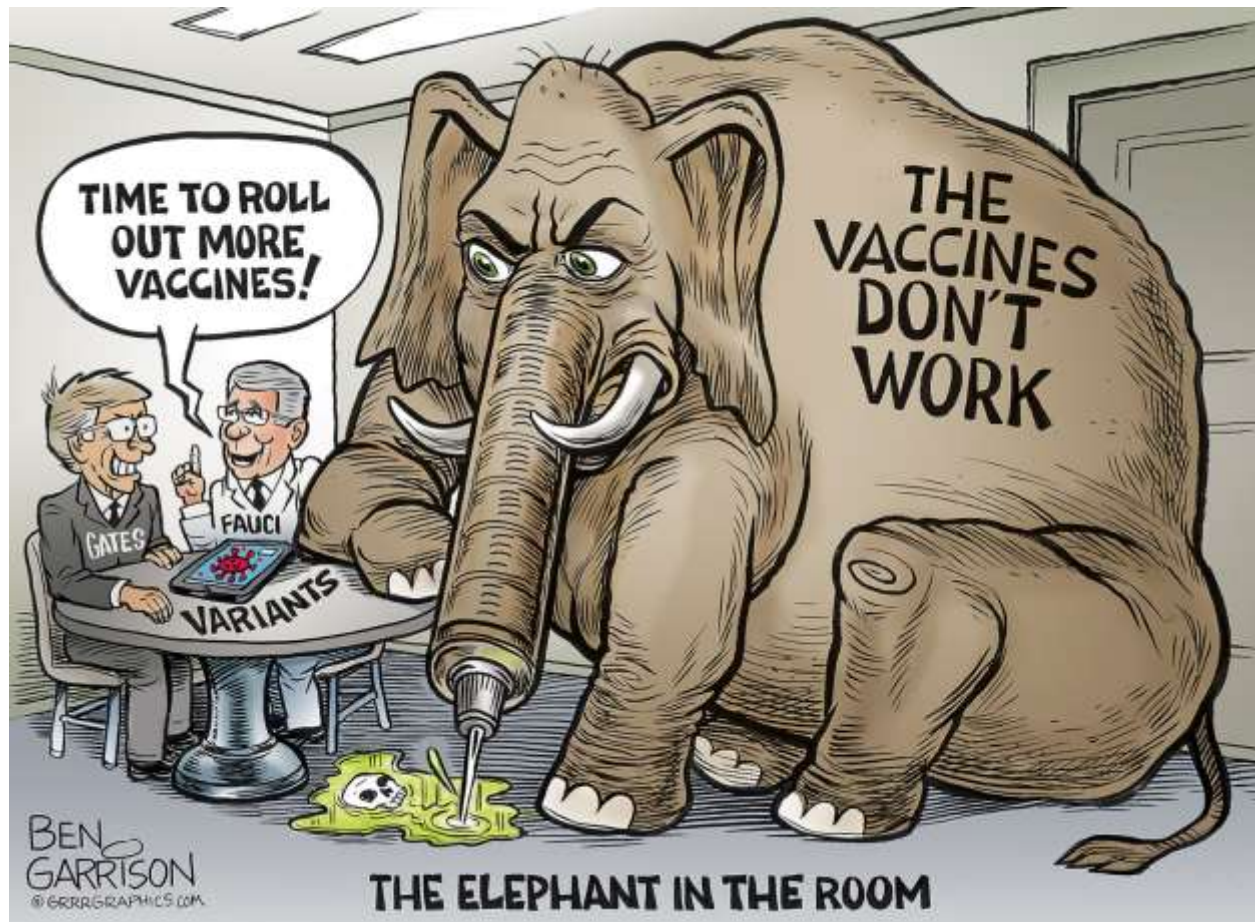
The FDA clearly agreed with Pfizer, extending the EUA despite the high number of deaths and serious reactions in the short amount of time Pfizer's jab had been available.

Pfizer's clinical trials consist of just two small studies of approximately 2,000 kids each. One group was followed for about two weeks after vaccination; the other for two months. That's it. ## **Disclosing Pfizer vaccine data 'may take until 2096'**

The US Food and Drug Administration is cooperating with a Freedom of Information Act request for clinical data associated with Pfizer's Covid-19 vaccine, but may require 75 years to do so – even longer than a prior estimate.

The FDA has insisted it cannot commit to a faster release of the medical data associated with the approval of the Pfizer-BioNTech coronavirus vaccine, according to a [legal brief](#) filed on Tuesday in response to the FOIA request. The agency reiterated that after processing 12,000 pages in about a two-month period, it will only be able to process 500 pages per month going forward. With tens of thousands of additional files up for review, plaintiffs fear the process may drag on two decades longer than the previous 55-year estimate.

Lawyer Aaron Siri sued the FDA on behalf of a group of doctors calling themselves Public Health and Medical Professionals for Transparency, who had previously complained the FDA wasn't supplying the data they had requested in a timely fashion. Having pointed out last month that the FDA had looked through Pfizer's documents in a mere 108 days in order to license the vaccine, Siri questioned why the agency now required a whopping 20,000 days to make the same documents public.

Approximately 451,000 pages regarding the clinical trials for a vaccine millions of Americans are being mandated to take will remain floating in legal limbo for up to 75 years if the agency has its way, Siri [warned](#). He called it "dystopian" for the government to pay Pfizer billions of dollars, shield it from lawsuits and require citizens to be injected with its product, only to refuse access to the documents used to grant its licensure in the first place.

The FDA has justified the unusual timetable by pointing out its Center for Biologics Evaluation and Research – the body tasked with reviewing the records – only has 10 staffers, two of whom are "new." The FDA also complained that stepping up the pace would divert "significant resources away from the processing of other FOIA requests that are also in litigation."
