Medicare Data Shows 48,465 Deaths Over 80 Within 14 Days Of Shots: Scrubbed As Non Vaccinated: Renz

At 3:53 of the Thomas Renz video linked below, he reveals raw data from the Medicare servers, “CMS servers.” 18.1% of Americans are on Medicare, or 59.4 million people.

48,465 people over the age of 80 died within 14 days of their first or second dose. “This is raw data,” says Renz. “Raw. There’s no analysis.” He goes on to remind us of the insult-to-injury fact that the system rigged it such that if a person dies within 2 weeks of a ‘vaccine,’ they are counted as *unvaccinated*.

Have you ever heard anything like this in your life?

More raw data: Of those patients given Remdesivir, 25.9 % died. More than a *quarter* of those, 46% died within 14 days of treatment. This is what Fauci considers a “life-saving treatment.”

“With regard to these Pfizer documents, Dr Bryan Ardis of Texas uncovered a list of possible serious Covid-19 vaccine-induced adverse outcomes that the FDA has been withholding/hiding from the medical community, from authorized dispensers, and from all potential Covid-19 “vaccine” recipients. German Chemist, Dr. Andreas Noack, Found DEAD After Exposing Graphene Hydroxide in Covid 'Vaccines'

On Nov. 23, a world-renowned German chemist by the name of Dr. Andreas Noack put out a video (which you can watch below) exposing the presence of graphene hydroxide in Wuhan coronavirus (Covid-19) "vaccines." Three days later, Noack [mysteriously died](#).

While the specific circumstances surrounding Noack's death remain unknown, it is being reported that he was "attacked," which resulted in his passing. This is according to Noack's pregnant wife, who published her own video after his death to sound the alarm.

"On the day of his graphene hydroxide video, he developed breathing difficulty and died in the early morning on Nov. 26, 2021," Noack's wife revealed in the video.

Noack's wife further made the suggestion that perhaps Noack was targeted with a directed energy weapon, or DEW, since he was not attacked in an obvious sense with a blunt object.

Instead, Noack developed some kind of strange respiratory ailment on the very same day that he exposed one of the contents of Fauci Flu shots.

"It was on the day when the graphene hydroxide video was released and the interview with herald Thiers took place," Noack's wife explained in German. *"Then we went upstairs onto the gallery; we relaxed, talked, laughed, told each other how much we love each other."*

"Then, he wanted to go downstairs into the kitchen to get something to nibble on, and normally he does not spend more than one minute there, so I went downstairs and said jokingly, 'you eat everything away from me again.' In that moment, he started to sway and I thought he was making fun of me – it looked like he was playing."

Was Noack murdered by the powers that be?

It was at this point that Noack's wife still thought he was pretending and tried to kiss him, telling him to stop. But Noack did not stop, and what happened next is even more shocking.

"In that moment, the electricity went off and the whole thing happened 20-30 minutes after the interview, and then Andreas collapsed in his arms," she went on to explain. "He began to moan, had severe pain."

"His body completely tensed, and all of a sudden he could not talk anymore. At first, I thought he might have been poisoned because he made some choking sounds. So, I instilled him with Sole (like salt water), then he vomited what he had eaten during the day, which wasn't much. I just couldn't do anything."

Noack's wife stayed with him while he remained "paralyzed" in a way that she could not describe, and helped keep his body upright so he would not strike his head. Noack was eventually able to go upstairs on his own but continued to have trouble breathing before eventually succumbing to a second round of paralysis.

"He couldn't breathe anymore and I started to scream," she recalls. "I yelled at him that he should get out of this condition and come back to me. I cried and he tried to comfort me. I was busy then to make sure Andreas can breathe well."

Emergency responders tried to help Noack's wife resuscitate him over the phone for what she says felt like hours. Eventually, six of them showed up in person and connected him to machines, as well as to a ventilator.

Noack's wife was told that her husband would be saved during this process, but that never panned out. He was taken to the hospital where he would never leave, with doctors saying that "his large heart valve ha[d] failed completely" due to a heart attack.

90% of all “covid” deaths since August occurred in those fully vaccinated

([Natural News](#)) The corporate media is once again spreading hysteria about the latest new “variant” of the Wuhan coronavirus (Covid-19), which has been dubbed “Omicron” which is an anagram for (*Moronic*). What the world is *not* being told, however, is that the only people affected by it are the “*fully vaccinated*.”

Not only that, but nine out of 10 “covid” deaths since August [are fully vaccinated deaths](#), meaning almost no unvaccinated people are dying after testing “positive.”

At this point in time, the only *plandemic* that exists is the one that is spreading among people who took the jabs. This is fully evidenced by official government data, which shows an almost clean bill of health for the remaining unvaccinated population.

In its weekly report on cases, hospitalizations and deaths by vaccination status, Public Health Scotland (PHS) is reporting that the vast majority of serious injuries and deaths from “covid” are occurring in people who got injected. The non-injected are mostly doing just fine.

“By analyzing the data contained within the report alongside data from previous reports that stretches as far back as Aug. 14, 2021, we can see that Scotland has very much been experiencing a ‘Pandemic of the Fully Vaccinated’ since at least August,” reports the *Daily Exposé*.

“Proving the introduction of new restrictions has nothing to do with the worry that the new Omicron variant may impact the effectiveness of the Covid-19 vaccines, and instead has everything to do with control, because the jabs have proven to be ineffective for months.”

The data is clear: Getting vaccinated massively increases your risk of death.

The data from PHS clearly shows that since August, the number of unvaccinated cases has been progressively declining. At the same time, the number of fully vaccinated cases has been spiking.

The overall trends show that the unvaccinated are staying healthier and better protected against the latest variants while the fully vaccinated are succumbing more and more to whatever it is that is being injected into their bodies.

As for hospitalizations, very few unvaccinated people ever even have to go to the hospital because their symptoms are mild or non-existent. The same cannot be said of the fully vaccinated, who are flooding hospitals at a growing rate.

“As you can see from above the data proves that it is the fully vaccinated population who have been putting a strain on the healthcare system and not the unvaccinated as the authorities and mainstream media would have you believe,” the *Daily Exposé* reported.

The most shocking data point of all is the death toll between vaccinated and unvaccinated. The disparity is so dramatic that there is no longer any denying that the jabs are what is killing people; not some “virus” floating around in the air.

By a long shot, fully vaccinated people account for nearly all deaths attributed to “covid.” Conversely, there are almost no unvaccinated people dying from covid, even using official government metrics for calculation. While the number of unvaccinated deaths has pretty much flat-lined, the number of fully vaccinated deaths is going exponentially parabolic – and as time goes on, the growth curve will likely get even steeper.

“The data available from Public Health Scotland stretching back 14 weeks proves very much that this is a pandemic of the fully vaccinated, and with the vaccinated accounting for 6 in every 10 cases (57%), 7 in every 10 hospitalizations (70%), and 9 in every 10 Covid-19 deaths (85%) since at least August, this also proves that the Covid-19 vaccines have already been ineffective for months,” the *Daily Exposé* warns.

Covid “vaccines” are triggering psychiatric disorders in hundreds of thousands of people, data reveal

[\(Natural News\)](#) The World Health Organization's (WHO) VigiBase [currently shows](#) that at least 121,559 people who got "vaccinated" for the Wuhan coronavirus (Covid-19) now suffer from one or more psychiatric disorders.

The most common problem is insomnia followed by anxiety, a "confusional state," "sleep disorders," "nervousness," "disorientation," "acute stress disorder," "restlessness," hallucinations, depression, "depressed mood," "panic attacks," "poor sleep quality," "delirium," "agitation," nightmares, "abnormal dreams," eating disorders, a "psychotic disorder" or "acute psychosis" or "psychotic behavior," and tic disorder.

VigiBase also shows 213 reports of Near Death Experience following injection, 57 completed suicides and 25 cases of "exploding head syndrome," a condition that *LifeSiteNews* describes as "hear[ing] a very loud noise like an explosion, gunshot or cymbals clanging as though it is right next to them."

Nearly 30,000 cases of psychiatric disorder post-injection have also been reported to the British Yellow Card, an adverse event reporting system in the United Kingdom.

"The virus that causes COVID –SARS-CoV-2 is known to trigger a powerful immune response, which includes the release of large amounts of proinflammatory cytokines," say case report researchers.

"It has been hypothesized that a COVID-19 triggered cytokine storm may increase the risk of psychosis," they added, citing 42 reported cases of psychosis linked to this form of inflammation.

Seeing as how the so-called "vaccines" provoke an inflammatory response in recipients, it is believed that this is the cause behind this sharp uptick in psychiatric disorders.

Are covid "vaccines" causing people to become possessed by demons?

A 2018 study, it turns out, found that college-aged students with higher levels of serum interleukin-6 (IL-6) after vaccination showed some of the most severe depressive symptoms. This was before Fauci Flu shots, of course, but the premise is the same.

Another pilot study from 2017 that looked at childhood vaccine records found that kids who were diagnosed with neuro-psychotic conditions such as anorexia nervosa, obsessive compulsive disorder (OCD) and tic disorder were more likely than healthy kids to have recently been vaccinated.

Fast-forward to the present time and people who recently got injected for Chinese Germs are [flooding hospitals](#) with all sorts of strange new illnesses that authorities are calling "covid."

32,649 Deaths 3,003,296 Injuries Following COVID Shots in European Database of Adverse Reactions as Young, Previously Healthy People Continue to Suffer

The European Union database of suspected drug reaction reports is [EudraVigilance](#), and they are now reporting **32,649 fatalities**, and **3,003,296 injuries**, following COVID-19 injections.

A *Health Impact News* subscriber from Europe reminded us that this database maintained at EudraVigilance is only for countries in Europe who are part of the European Union (EU), which comprises 27 countries.

The total number of countries in Europe is much higher, almost twice as many, numbering around 50. (There are some differences of opinion as to which countries are technically part of Europe.)

So as high as these numbers are, they do NOT reflect all of Europe. The actual number in Europe who are reported dead or injured following COVID-19 shots would be much higher than what we are reporting here.

The EudraVigilance database reports that through December 4, 2021 there are **32,649 deaths and 3,003,296 injuries** reported following injections of four experimental COVID-19 shots:

Dr. McCullough Describes 'Sinister Ways' Doctors Worldwide Are Restricted From Treating COVID Patients

On the latest episode of the “Joe Rogan Experience” podcast, Dr. Peter McCullough and Joe Rogan discussed the pandemic, COVID vaccines, alternative COVID treatments and what McCullough termed the “mass-psychosis” that’s come over the medical profession amid the [COVID](#) crisis.



McCullough, a practicing world-class internist, cardiologist and epidemiologist, and chief medical advisor of [Truth for Health Foundation](#), told Rogan that from the outset of the pandemic, there were a number of sinister ways doctors worldwide were restricted from prescribing hydroxychloroquine — even though the science shows it’s an effective [early treatment](#) for COVID patients, and it’s already approved by the U.S. Food and Drug Administration to treat other illnesses.

McCullough referred to hydroxychloroquine as *“the leading drug worldwide to treat COVID-19.”*

He explained that early on in the pandemic the U.S. *“had the right idea,”* and stockpiled hydroxychloroquine — only later to refuse to release any of the millions of doses from the stockpile.

At the same time, he explained, France redesignated hydroxychloroquine from an over-the-counter drug to prescription-only, making it much more difficult for people to use.

In Australia, doctors who used their best judgment and prescribed hydroxychloroquine to treat COVID patients were threatened with jail time, McCullough said.

During this time, one of the world's largest hydroxychloroquine manufacturing facilities "mysteriously burnt down" outside Taipei, Taiwan, McCullough said.

"It seems to me, early on, there was an intentional, very comprehensive, suppression of early treatment in order to promote fear, suffering, isolation, hospitalization and death," he said. *"And it seemed to be completely organized and intentional in order to create acceptance for, and then promote mass vaccination."*

McCullough told Rogan the reason so few medical professionals are willing to speak up against the new, anti-scientific COVID regime is they're under a "mass formation psychosis," meaning the COVID fear-mongering and propaganda has placed almost the entire professional field in a state of irrational complacency.

"In the U.S. only about 500 doctors really understand what's going on ... and there's about a million," he said.

When asked by Rogan why so many people are fine after getting a COVID vaccine, McCullough said *"the human body is a miraculous thing,"* but shared his worries about the health ramifications of an ongoing [booster](#) campaign.

"The [spike protein](#) stays in the body for at least 15 months ... if we start vaccinating every six months, I think the spike protein will never get out of the body," he said. *"[The spike protein] accumulates and progressive accumulation is very worrisome."*



US Pilot Deaths increase by 1,750% after Covid Vaccine Rollout

Previously healthy U.S. airline pilots [are passing away at an unprecedented rate](#). Pilots are required to be in tip-top physical condition, but in 2021, the entire airline industry conspired against the pilot's individual health and threatened them with termination if they did not partake in the covid-19 vaccine experiment. As a result, over one hundred young pilots have mysteriously passed away in 2021, as countless other pilots suffer silently from adverse events and [depleted immune systems](#).

A total of one hundred eleven pilots died in the first eight months of this year!

This is a 1,750% increase from 2020, when the world was supposed to be in the middle of a pandemic. A list of the deceased individuals was published in the *Air Line Pilot Association* magazine. In comparison, there were 6 airline pilot deaths in 2020, and only one death in 2019.

Surge in pilot deaths is a warning sign to all

Most of the 111 deaths occurred after the covid-19 jabs were rolled out en masse. Because there are no medical codes for vaccine-induced death, most of the deaths are blamed on other causes. These causes may be related to the pathological evidence behind vaccine injuries, but are never coded as such. [Pathological evidence is often ignored](#), and the deaths of young men and women are often referred to as “sudden” or “unexplained” – with no pathological investigation.

Only 5 deaths were recorded from January-March in 2021, when vaccine uptake was low. Peculiarly, a total of (39) deaths occurred in July and (34) occurred in August — right after governments and private companies used vaccine mandates to violate the privacy of their employees and punish them. Even though these intimidation tactics are illegal, these [vaccine mandates were used to scare pilots into submission](#). Like in many professional fields, pilots went against their own beliefs and against their private medical situation, accepting the subjugation. Young, previously healthy athletes are seeing the same trend in mortality as the pilots are. [Goodsciencing.com tracked over 300 post-vaccine medical incidents](#) from January 1 to December 10. These incidents involved young, previously healthy athletes who suddenly collapsed on the playing field in 2021. Out of these unexplained medical incidents, 170 of the athletes ended up dead. Deadly vaccine issues have been pushed aside for decades, as the world wakes up to the industry's hidden horrors

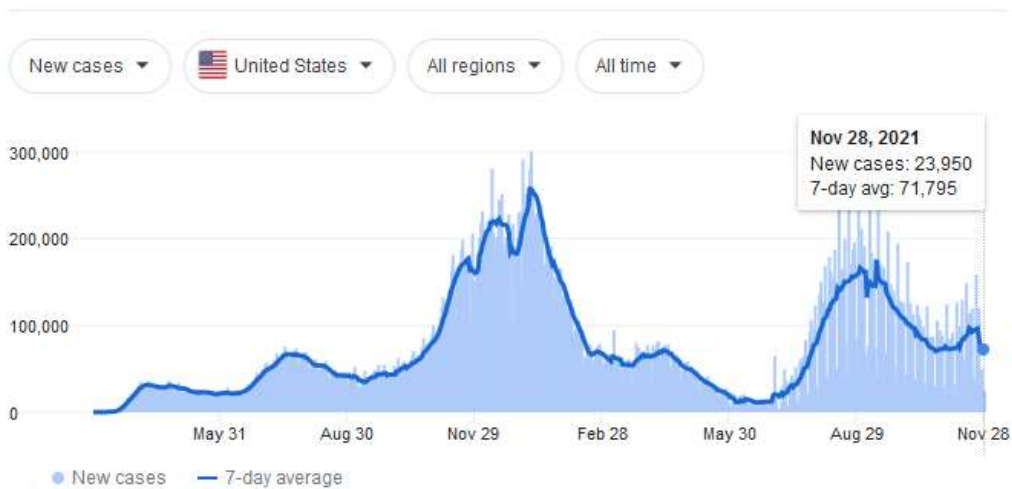

for endless boosters now. Their dominion over governments and their endless money supply will allow them to steal, kill and destroy using propaganda, coercion and force.

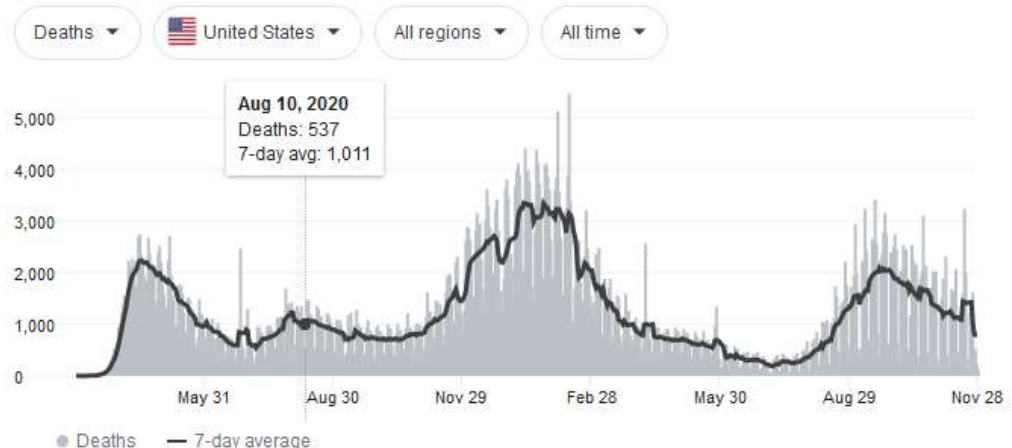
THEY NEEDED THE OMICRON VARIANT

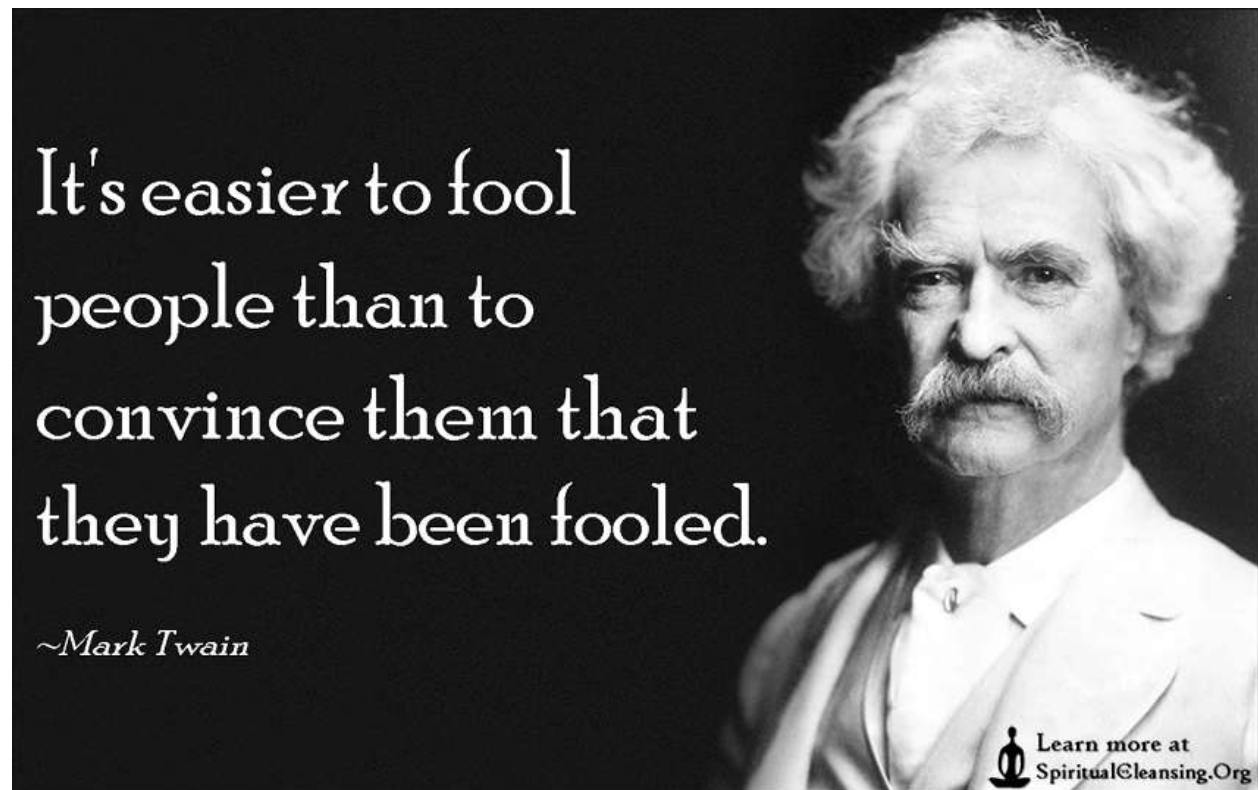

Big Pharma, Gates, Fauci, UK officials accused of crimes against humanity in complaint to International court

(LifeSiteNews) – A group that includes former Pfizer vice president Dr. Michael Yeadon filed a complaint with the International Criminal Court (ICC) on behalf of UK citizens against Boris Johnson and UK officials, Bill and Melinda Gates, chief executives of Big Pharma companies, World Economic Forum executive chairman Klaus Schwab, and others for crimes against humanity.

The UK group, including an astrophysicist and a funeral director, additionally charged Dr. Anthony Fauci; Tedros Adhanom Ghebreyesus, director-general of the World Health Organization (WHO); June Raine, chief executive of Medicines and Healthcare products regulatory agency (MHRA); Dr. Radiv Shah, president of the Rockefeller Foundation; and Dr. Peter Daszak, president of EcoHealth Alliance, as “responsible for numerous violations of the Nuremberg Code ... war crimes and crimes of aggression” in the UK and other countries.

After repeated unsuccessful attempts to raise a case with the English Court system, the applicants resorted to calling with “the utmost urgency” for the ICC “to stop the rollout of COVID vaccinations, introduction of unlawful vaccination passports and all other types of illegal warfare ... being waged against the people of the UK.”

In the group’s complaint filed December 6, they present evidence that COVID-19 “vaccines” are in fact experimental gene therapies engineered with gain-of-function research from bat coronaviruses, arguing that these “vaccines” have caused massive death and injury and that the UK government has failed to investigate such reported deaths and injuries; that COVID case and death numbers have been artificially inflated; that face masks are harmful due to hypoxia, hypercapnia and other causes; and PCR tests are “completely unreliable” and “contain carcinogenic ethylene oxide.”

They furthermore argued that effective treatments for COVID-19 such as hydroxychloroquine and ivermectin, were suppressed, leading to a greater death toll from COVID-19 than what should have occurred.

They make the case that the lockdowns were enacted under the pretext of artificially inflated infection and death numbers from an engineered virus, as well as the experimental “vaccines” have resulted in:

Massive short-term damage and death, with at least 395,049 reported adverse reactions to COVID “vaccines” in the UK alone; a sharp uptick in ChildLine calls from vulnerable children during lockdowns; “destruction of wealth and businesses” through imposed lockdowns; “severe deprivation of physical liberty in violation of fundamental rules of international law,” including bans on travel and gatherings, and forced quarantine and self-isolation; apartheid due to segregation by vaccine passport

possession; and “expected reduction in fertility” after “vaccination,” among other harmful physical and psychological effects.

In addition, the applicants maintain that “the suppression of safe and effective alternative treatments for Covid-19 amounts to murder and warrants a full investigation by the court.” They noted that besides censorship of online information on and promotion of these alternative treatments, “some academic journals are blocking the publication of studies showing the effectiveness of drugs such as ivermectin and hydroxychloroquine.”

The applicants also cited quotes from Holocaust survivors who have drawn “stark parallels between Covid restrictions and the beginning of the Holocaust.” In an open letter, the Holocaust survivors have asked medical regulatory authorities to “stop this ungodly medical experiment on humankind immediately,” which they maintain violates the Nuremberg Code.

They even allege that “another holocaust of greater magnitude is taking place before our eyes.” One survivor, Vera Sharav, noted in an interview cited in the complaint,

“The stark lesson of the Holocaust is that whenever doctors join forces with government and deviate from their personal, professional, clinical commitment to do no harm to the individual, medicine can then be perverted from a healing, humanitarian profession to a murderous apparatus.”

“What sets the Holocaust apart from all other mass genocides is the pivotal role played by the medical establishment, the entire medical establishment. Every step of the murderous process was endorsed by the academic, professional medical establishment. Medical doctors and prestigious medical societies and institutions lent the veneer of legitimacy to infanticide, mass murder of civilians.”

According to the applicants, all of the damaging consequences of the “vaccines,” lockdown and virus meet the criteria for genocide, crimes against humanity, and war crimes against the people of the UK, because the guilty “members of the UK government and world leaders have both knowledge and intent with respect to these alleged crimes.”

In fact, they argue that the destructive consequences of the “vaccines,” lockdowns and engineered virus are deliberate attempts at depopulation and societal destabilization as part of a globally coordinated plan to consolidate wealth and power in the hands of a few.

They argue that these measures therefore also constitute a “*crime of aggression*,” that is, the effort “*effectively to exercise control over or to direct the political or military action of a State.*” In this case, they claim, the goal is to “*dismantl[e] all the Democratic Nation States, step by step,*” and to “*destroy small and medium sized businesses, moving the*

market shares to the largest corporations,” owned by the ultra-rich, to give this “elite” group greater political and monetary control.

20,000+ Deaths Reported to VAERS Following COVID Vaccines

VAERS data released today by the Centers for Disease Control and Prevention included a total of **965,843 reports of adverse events** from all age groups following COVID vaccines, including **20,244 deaths** and **155,506 serious injuries** between Dec. 14, 2020, and Dec. 10, 2021.

The Centers for Disease Control and Prevention today released new data showing a total of [965,843 reports of adverse events](#) following COVID vaccines were submitted between Dec. 14, 2020, and Dec. 10, 2021, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of **20,244 reports of deaths** — an increase of 358 over the previous week — and **155,506 reports of serious injuries**, including deaths, during the same time period — up 4,560 compared with the previous week.

Excluding “[foreign reports](#)” to VAERS, [691,884 adverse events](#), including [9,295 deaths](#) and [59,767 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and Dec. 10, 2021.

[Foreign reports](#) are reports received by U.S. manufacturers from their foreign subsidiaries. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product’s labeling, the manufacturer is required to submit the report to VAERS.

Of the 9,295 U.S. [deaths reported](#) as of Dec. 10, 21% occurred within 24 hours of vaccination, 26% occurred within 48 hours of vaccination and 61% occurred in people who experienced an [onset of symptoms](#) within 48 hours of being vaccinated.

In the U.S., 480 million COVID vaccine doses had been administered as of Dec. 10. This [includes](#) 279 million doses of Pfizer, 184 million doses of Moderna and 17 million doses of Johnson & Johnson (J&J).

Every Friday, [VAERS](#) publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Historically, VAERS has been shown to report only [1% of actual vaccine adverse events](#).

U.S. VAERS data from Dec. 14, 2020, to Dec. 10, 2021, for 5- to 11-year-olds show:

- 4,181 [adverse events](#), including [80 rated as serious](#) and [2 reported deaths](#). One death occurred in an 11-year-old girl from Georgia vaccinated Sept. 14, prior to the authorization of Pfizer's COVID vaccine in the 5 to 11 age group.

The second death (VAERS I.D. [1890705](#)) occurred in a 5-year-old girl who died four days after her first Pfizer shot.

U.S. VAERS data from Dec. 14, 2020, to Dec. 10, 2021, for 12- to 17-year-olds show:

- 24,893 [adverse events](#), including [1,488 rated as serious](#) and [33 reported deaths](#). The most recent deaths involve a 13-year-old girl from Texas (VAERS I.D. [1913198](#)) who died 31 days after receiving her COVID vaccine. According to her VAERS report, the girl received her first dose of Pfizer on Aug. 1.

Two weeks later, she complained of vague upper back pain and was diagnosed with a [rare soft tissue cancer](#) located on her heart despite having no previous medical history. Parents requested a VAERS report be filed in case her cancer was related to the vaccine. Her cancer and heart condition rapidly and progressively worsened and she died Dec 1.

- [61 reports](#) of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death — with 96% of cases attributed to [Pfizer's vaccine](#).
- [571 reports](#) of myocarditis and pericarditis (heart inflammation) with [561 cases](#) attributed to Pfizer's vaccine.
- [143 reports](#) of blood clotting disorders, with all cases attributed to Pfizer.

U.S. VAERS data from Dec. 14, 2020, to Dec. 10, 2021, for all age groups combined, show:

- 19% of deaths were related to cardiac disorders.
- 54% of those who died were male, 42% were female and the remaining death reports did not include the gender of the deceased.
- The [average age](#) of death was **72.7**.
- As of Dec. 10, [4,584 pregnant women](#) reported adverse events related to COVID vaccines, including 1,446 reports of [miscarriage or premature birth](#).
- Of the [3,285 cases of Bell's Palsy](#) reported, 51% were attributed to [Pfizer](#) vaccinations, 41% to [Moderna](#) and 8% to [J&J](#).
- 791 reports of [Guillain-Barré syndrome](#) (GBS), with 42% of cases [attributed to Pfizer](#), 29% to [Moderna](#) and 27% to [J&J](#).
- [2,206 reports](#) of anaphylaxis where the reaction was life-threatening, required treatment or resulted in death.
- [11,680 reports](#) of blood clotting disorders in the U.S. Of those, [5,198 reports](#) were attributed to Pfizer, [4,159 reports](#) to Moderna and [2,275 reports](#) to J&J.
- [3,405 cases](#) of myocarditis and pericarditis with [2,118 cases](#) attributed to Pfizer, [1,137 cases](#) to Moderna and [140 cases](#) to J&J's COVID vaccine.

CDC endorses Pfizer, Moderna vaccines over J&J

An advisory panel to the CDC on Thursday [voted](#) 15 – 0 to “[preferentially recommend](#)” mRNA COVID vaccines Pfizer and Moderna over the J&J shot for adults 18 years and older.

The recommendation came after the agency's advisory panel [said](#) the rate of rare blood-clotting disorders following the J&J vaccine was higher than expected.

The CDC [signed off](#) on the panel's updated guidance late Thursday.

The panel effectively discouraged vaccine providers and adults from using J&J's shot but stopped short of recommending the vaccine be pulled from the market. The interim recommendation applies to J&J's primary series vaccine dose and the booster dose.

CDC officials acknowledged 54 cases of [thrombosis with thrombocytopenia syndrome](#) (TTS) among J&J recipients, including nine deaths.

The CDC's COVID-19 Vaccine Task Force [excluded](#) “reports where [the] only thrombosis is [ischemic stroke](#) or myocardial infarction,” which significantly reduced the number of cases involving blood-clotting disorders.

16,000 physicians and scientists say kids shouldn't get COVID vaccines

COVID vaccines are “irreversible and potentially permanently damaging,” said Dr. Robert Malone, [in a statement](#) explaining why 16,000 physicians and medical scientists around the world signed a declaration publicly declaring healthy children should not be vaccinated against COVID.

Makary told members of the House Select Committee on the Coronavirus Crisis some COVID policies have become “*too extreme, too rigid and are no longer driven by clinical data.*”

Makary criticized the CDC's rush to push boosters for 16- and 17-year-olds based on lab experiments suggesting boosters raise antibody levels against Omicron.

He reminded committee members that, despite a combined annual budget of about \$58 billion, neither the CDC nor the National Institutes of Health have produced a credible study on natural immunity to COVID.

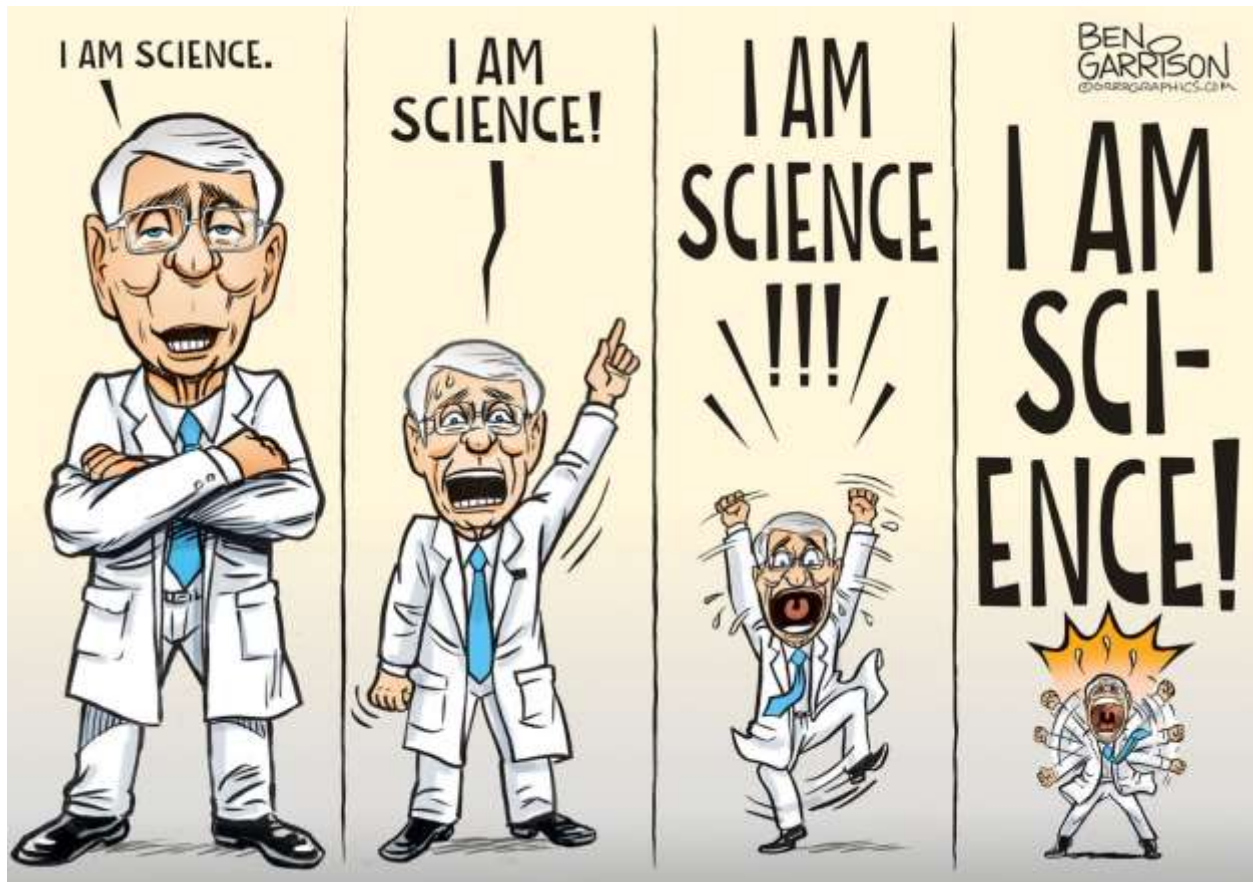
Studies show Pfizer vaccine less effective against Omicron

I was astonished to realize that the pervasive web of deep financial entanglements between Pharma and the government health agencies had put regulatory capture on steroids. The CDC, for example, owns 57 vaccine patents[1] and spends \$4.9 of its \$12.0 billion-dollar annual budget (as of 2019) buying and distributing vaccines.[2][3] NIH owns hundreds of vaccine patents and often profits from the sale of products it supposedly regulates.

In August 2021, Dr. Fauci’s acolyte—CNN’s television doctor, Peter Hotez—published an article in a scientific journal calling for legislation to “expand federal hate crime protections” to make criticism of Dr. Fauci a felony.[14] In declaring that he had no conflicts, Dr. Hotez, who says that vaccine skeptics should be snuffed out,[15] evidently forgot the millions of dollars in grants he has taken from Dr. Fauci’s NIAID since 1993,[16] and more than \$15 million from Dr. Fauci’s partner, Bill Gates, for his Baylor University Tropical Medicine Institute.[17],[18]

As we shall see, Dr. Fauci’s direct and indirect control—through NIH, Bill & Melinda Gates Foundation, and the Wellcome Trust of some 57 percent of global biomedical research funding[19]—guarantees him this sort of obsequious homage from leading medical researchers, allows him to craft and perpetuate the reigning global medical narratives, and can fortify the canon that he, himself, is science incarnate.

High-visibility henchmen like Hotez—and Pharma’s financial control over the media through advertising dollars—have made Dr. Fauci’s pronouncements impervious to debate and endowed the NIAID Director with personal virtues and medical gravitas supported by neither science nor his public health record. By the latter metric, his 50-year regime has been calamitous for public health and for democracy. His administration of the COVID pandemic was, likewise, a disaster.

As the world watched, Tony Fauci dictated a series of policies that resulted in by far the most deaths, and one of the highest percentage COVID-19 body counts of any nation on the planet. Only relentless propaganda and wall-to-wall censorship could conceal his disastrous mismanagement during COVID-19’s first year.

The U.S., with 4 percent of the world’s population, suffered 14.5 percent of total COVID deaths. By September 30, 2021, mortality rates in the US had climbed to 2,107/1,000,000, compared to 139/1,000,000 in Japan.

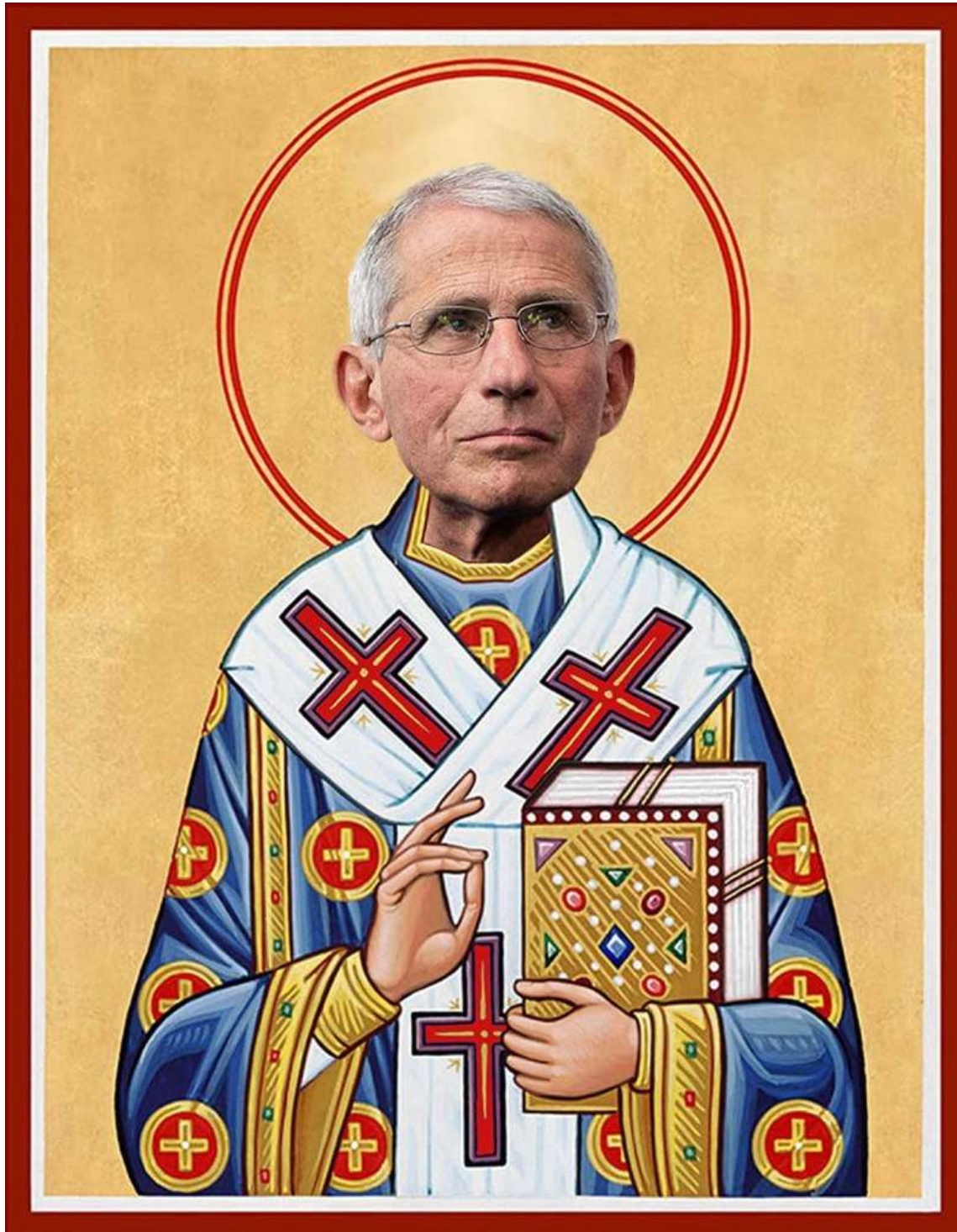

Court Orders FDA to Comply With FOIA and Release Information On Pfizer Vaccine – First Batch of Documents Shows Over 1,200 Vaccine Deaths WITHIN FIRST 90 DAYS

The Food and Drug Administration (FDA) released the first batch of documents related to Pfizer's Covid-19 vaccine after a federal judge ordered that they must comply with a massive Freedom of Information Act (FOIA) request that was filed by a government accountability group called [Public Health and Medical Professionals for Transparency](#).

The esteemed group of more than 30 professors and scientists asked the federal government to share any and all data that factored into the agency's hasty decision to grant Pfizer's experimental mRNA vaccine an emergency use authorization (EUA) – which amounts to a trove of over 329,000 documents.

In a shameless effort to bury the information, the FDA challenged the FOIA request in court. After the agency was told that it must turn over the documents, **Justice Department lawyers representing the FDA asked a federal judge to allow them an unthinkable 55 years to process the request, saying that they would be able to release just 500 pages a month.**

In other words, Elon will make it to Mars way before the documents would be fully released – in the year 2076.

A [motion](#) that was also filed by the same group of doctors and scientists is currently pending in federal court that would force the FDA to expedite processing and releasing these documents.

Meanwhile, the FDA still has to comply with the original order to begin turning over documents. Lo and behold, the first release is a bombshell.

According to an official Pfizer document that is titled [Cumulative Analysis of Post-Authorization Adverse Event Records Reports](#), **in just the first 90 days of the vaccine's roll out under the FDA's EUA – from December 1st, 2020 – February 28th, 2021 – there were TENS OF THOUSANDS of reported adverse reactions, including OVER 1,200 DEATHS. There was once a time when 1 DEATH would have resulted in shutting down the experiment for good!**

The report only included adverse events to the vaccine that researchers considered “serious cases,” **there were thousands more submissions that were left out of this data.**

Any cases deemed “non-serious” would be processed within 90 days, **but this report was released before 90 days of Pfizer’s vaccine being available had even passed.** *“Due to the large numbers of spontaneous adverse event reports received for the product, **the MAH has prioritized the processing of serious cases**, in order to meet expedited regulatory reporting timelines and ensure these reports are available for signal detection and evaluation activity.*

Non-serious cases are processed as soon as possible and no later than 90 days from receipt. Pfizer has also taken a multiple actions to help alleviate the large increase of adverse event reports.”

In all, the report states that there were **a total of 42,086 case reports of individuals who had an adverse reaction to Pfizer’s vaccine worldwide**, with the largest number (13,739) coming from the United States and from the UK (13,404).

According to the documents women (29,914) were over **3x more likely to experience a reaction** than men (9182). A total of **1,223 individuals had a fatal reaction** to the experimental Pfizer vaccine. **This should serve as a word to the wise!**

How did the FDA not immediately pull the experimental jab out of circulation? Let alone grant multiple extensions of the EUA to Pfizer while working with the fraudulent Biden regime to push a needle into the arm of every single American.

The document also makes it clear that the data only includes **“recorded adverse events,”** which even the author admits is likely just a portion of the true number of adverse reactions that took place.

Again, keep in mind, this is within the first 90 days of the Pfizer jab’s availability.

From the Pfizer document:

“Reports are submitted voluntarily, and the magnitude of underreporting is unknown.”

“Some of the factors that may influence whether an event is reported include: length of time since marketing, market share of the drug, publicity about a drug or an AE, seriousness of the reaction, regulatory actions, and awareness by health professionals and consumers of adverse drug event reporting, and litigation.”

Pfizer’s “confidential” Covid-19 vaccine adverse reaction review ends with thousands of conditions that are of “special interest” and could possibly develop

after taking their experimental jab. The single-space typed list continues for an astonishing 9 pages.

Yet somehow the paper concludes that the “review of available data” was good enough and demonstrated a “favorable benefit-risk balance” for the rushed vaccine.

What’s the benefit-risk balance on a virus that has a 99.9% recovery rate? The benefit – at least for Pfizer – is clear; It doesn’t matter how many otherwise healthy lives are lost – they are CASHING IN to the tune of \$1,000 PER SECOND with a projected \$36 BILLION in profit this year from the vaccine alone – it’s criminal.

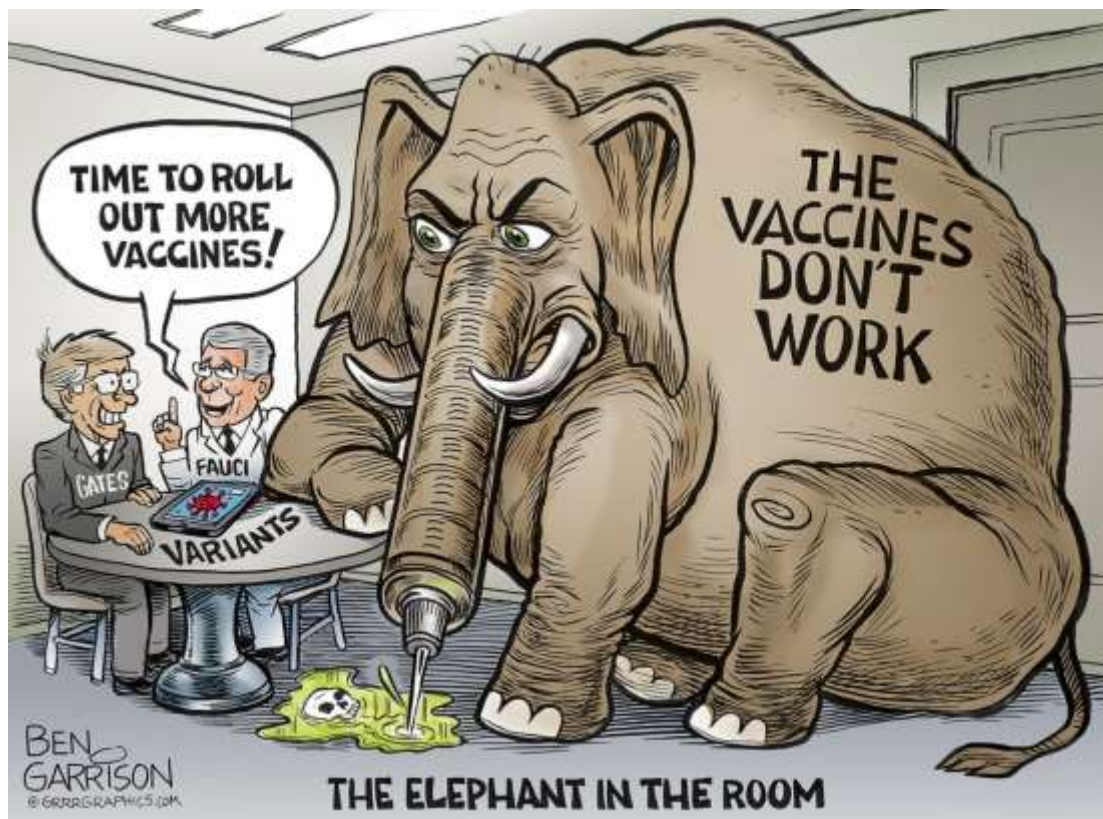
The FDA clearly agreed with Pfizer, extending the EUA despite the high number of deaths and serious reactions in the short amount of time Pfizer’s jab had been available.

The CDC claims these are “covid” deaths, but of course they are actually vaccine deaths. Covid vaccines inject people with toxic spike proteins or the mRNA instructions to manufacture [spike protein nanoparticles](#). These particles are the disease, and they cause widespread vascular, neurological and reproductive damage. The side effects of these vaccines are identical to the “symptoms” of covid for the simple reason that the vaccines are the pandemic. Thus, when people are injected with the vaccines, they are “given” covid. Once they die, they are said to have died from covid instead of from the vaccine.

Natural News has learned that the CDC’s early warning alert system which is tied into U.S. hospitals is throwing out a large number of red flags indicating the leading edge of

In a panic, the CDC put its propaganda machine into gear and issued announcements that have been picked up by the world's controlled media, [including the UK Daily Mail](#) which covered the CDC news, describing the upcoming mass deaths prediction as “grim.” From the Daily Mail, we see the shocking admission that one of the “largest outbreaks” of Omicron in the USA occurred among the “fully vaccinated:”

It is feared that a ‘tidal wave’ of Omicron is headed for U.S. shores, with the UK recording its biggest one day case total ever on Thursday- 78,610 – with 10,000 of those cases confirmed as Omicron.

One of the largest US outbreaks of the Omicron variant to date is believed to have occurred at Cornell University in Ithaca, New York, where almost all 930 cases over the past week are believed to be of the variant.

All of the confirmed Omicron cases in the Cornell University are among people who are fully vaccinated, and some of them are in people who’ve also had booster.

Understand that so far, to our knowledge, there isn’t a single recorded case of an unvaccinated American dying from Omicron.

Rather, the Omicron variant — and Delta before that — appear to inflict the vaccinated. That’s because the vaccinated have destroyed their immune systems by taking vaccine shots and booster shots.

Get the body bags ready... the vaccines are kicking in.

The 15,600 deaths per week that the CDC says will take place in America by Christmas are actually deaths of vaccinated people who are dying from: 1) Destroyed immune systems colliding with Omicron, a very mild strain. Globally, total vaccine deaths will likely exceed ten million people by mid-2022, dwarfing the number of Jews who were murdered by the Nazi regime in World War II.

Bombshell new study finds vaccines are virtually useless against Omicron.

The Pop Culture Brigade unleashed Big Bird to [tweet](#) about the joys of the jab, promised kids [super powers](#) from the vaccines in a grotesque Pfizer ad, and invited a [pop star](#) to the White House to push “Let’s end this pandemic together” to kids.

The medical establishment enthusiastically joined the attack. The American Medical Association [urged](#) parents to “seize the opportunity to vaccinate younger kids against Covid-19,” warning them, “Now it is time for parents to act.” The American Academy of Pediatrics [flogged](#) the need for instant FDA approval, while its New York branch demanded vaccine mandates for kids to attend school, helpfully [adding](#) that “religious or philosophical exemptions should not be given.”

And, of course, the government struck hard with the ultimate power of coercion. California became the first state to [mandate](#) vaccines for kids ages 5 and older, denying kindergartners an education until they’re jabbed. New York, fresh from deploying Covid to kill [15,000](#) nursing home residents, pivoted to kids with a [bribery](#) campaign conceived in the pits of hell. Mayor de Blasio announced that jabbed kids are eligible for a \$100 gift, which he cheerfully informed them “buys a whole lot of candy.” Sugar destroys the immune system and sets up kids for a lifetime of metabolic dysfunction, but who cares about that? The vaccines are for their health!

The tyrants have been consistent in their messaging onslaught from the beginning: healthy living and natural immunity play no part in overcoming Covid; only the divine gift of pharmaceutical experiments can confer redemption from the viral demon. Now the tyrants are salivating at the profits to be made by plunging lucrative gene modulators into children's flesh. Already, Pfizer is **boasting** that it will make as much money from its Covid vaccine in 2021 than it made from all its products in 2020. And wait until 2022, when Fauci assures us that even babies and toddlers will be stabbed with the jab! The tyrants have decreed their right to colonize and exploit your children's bodies, and your job as parents is to thank them, pay them, and submit.

In this face of this blitzkrieg of intimidation, coercion, and agitprop, how can parents protect their children? What weapons do parents have to fight back? As in any war, the way to win is through courage, unity, and knowledge of the enemy. So, I've provided some facts to fortify your information and share with others.

The vaccine is already proven to be dangerous. On November 12th, the CDC released the **latest figures** from the VAERS (Vaccine Adverse Event Reporting System). To date, children ages 12 to 17 have suffered 22,782 total adverse events, including 1,400 rated as serious, and 29 reported deaths. Among the deaths: a 17-year-old girl from Washington, a 12-year-old girl from South Carolina, a 13-year-old girl from Maryland, and a 17-year-old girl from Texas. 59 cases of life-threatening anaphylaxis were reported in this age group – with 96% attributed to Pfizer's vaccine. 552 cases of myocarditis and pericarditis (heart inflammation) were reported, with all but 10 linked to Pfizer, and 131 cases of blood clotting disorders, with 100% linked to Pfizer.

Vaccine injuries in kids are being censored from the media and buried by the FDA. Maddie de Garay is a 13-year-old girl in Ohio whose mother signed her up for Pfizer's Covid vaccine clinical trial. She is now catastrophically disabled and has been hospitalized three times in recent months. Yet Comcast **refused** to show an ad about Maddie, frustrating Maddie's mother who hoped it would force those responsible to admit to Maddie's injuries. You can see Maddie's ad **here**. Mrs. de Garay documented Maddie's medical records and **submitted** them to the CDC, FDA, and NIH's National Institute of Neurological Disorders and Stroke without getting any meaningful response. Pfizer has categorized Maddie's systemic injuries as "functional abdominal pain."

Sweden, Denmark, Finland, and Taiwan have stopped vaccinating younger groups because of reported heart damage and other injuries. (See **here**, **here**, and **here**.) All four countries report worrisome rates of myocarditis and pericarditis, which cause heart inflammation, in younger people injected with Covid vaccines. And in **Germany**, federal data shows that children aged 12 to 17 were far more likely to be damaged from Covid vaccines than from Covid. Children were hospitalized post-vaccine

with myocarditis, pericarditis, thrombosis, pulmonary embolism, and Guillain-Barre Syndrome. Around the world, children are suffering from Covid vaccines.

Pfizer conducted NO long-term studies on their vaccine's impact on kids – none, nada, zilch, zip. Pfizer [admits](#) in its application to the FDA that they will study the long-term effects on kids AFTER they receive authorization. Pfizer's clinical trials consist of just two small studies of approximately 2,000 kids each. One group was followed for about two weeks after vaccination; the other for two months. That's it. Two months! That's the entire basis for injecting millions of kids with experimental vaccines that have unknown consequences for their genetic, reproductive, neurological, immunological, respiratory, and cardiovascular health. What on earth happens to our future if something goes wrong?

Fauci and the FDA admit they don't know if the vaccines are safe for kids. "The real question that we have not yet answered is the safety data of an mRNA vaccine in young people vis-a-vis myocarditis," Fauci [told](#) Reuters in October. And Dr. Eric Rubin, a voting member of the FDA panel that endorsed the vaccine and editor-in-chief of The New England Journal of Medicine, casually [noted](#), "We're never going to learn about how safe the vaccine is unless we start giving it. That's just the way it goes." In other words, what's important to these "experts" isn't protecting your kids. It's protecting the vaccine, with your kids as the unfortunate guinea pigs.

Children's risk of Covid death or serious illness remains extremely low. Large studies in Britain [confirm](#) that children's risk of being hospitalized or dying from Covid is negligible. 25 children out of 12 million kids in Britain died of Covid, and most of them had severe co-morbidities. Furthermore, children are [not](#) significant drivers of infection, and pose almost no risk to adults. They do not get frequently infected, and if they do, they typically have mild symptoms.

Prominent doctors have formed [The Unity Project](#) to help parents and groups fight vaccine mandates for children.

The tyrants who want your children's bodies are relentless. They've orchestrated the battlefield so that you're mandated to permanently alter your children's biology with unknown substances for protection against a disease for which they're not at risk.
