#### Official Government Data From Germany Suggests Covid Fully Vaccinated People Will Develop AIDS

By the end of the month, most people who are "fully vaccinated" will have developed full-blown Wuhan coronavirus (Covid-19) injection-induced acquired immunodeficiency syndrome (AIDS), new government data suggests.

German government researchers found that the immune systems of the fully vaccinated have already degraded to an average of -87 percent, depending on when they got jabbed. That degradation will only continue until their immune systems are completely gone. (Related: Fauci Flu shots are also <u>spreading prion disease</u>.)

The Robert Koch Institute (RKI) put out the data, which shows that the fully vaccinated now have, on average, an 87.7 percent lower immune response to the new Omicron (Moronic) variant than the unvaccinated.

"This means that the average German is down to the last 12.3 percent of his or her immune system for fighting certain classes of viruses and certain cancers," reports the Daily Exposé.

Interestingly, RKI did not produce the normal vaccine effectiveness tables in its December 30 weekly report.

"This may have been due to the holidays (the British gave up completely on December 23) or may have been because the table would be disastrous for the vaccines," the Exposé added.

"But we can help the Germans out here by doing the calculation for them using Pfizer's vaccine effectiveness formula: Vaccine effectiveness = immune system effectiveness = (1-8.12)/8.12 = -7.12/8.12 = -87.7%."

Fully vaccinated immune systems are doing WORSE than the predictive models estimated.

Back in October, it was projected that this type of thing would occur. Scientists looked at data from the UKHSA Vaccine Surveillance Report, concluding that immune system degradation would become progressively worse in the fully vaccinated.

Those figures were mocked by some for being too "doomsday." It turns out, however, that they were actually *underestimates*.

The fully vaccinated are doing *worse* in terms of immune strength than even the most "pessimistic" data modelers anticipated.

"So Germany, at 87.7% immune system degradation, has done 6.7% worse than our model which predicted, an 81.0% degradation this year (for over 18s based on 2 doses of the anti-vaccine rather than 3)," the Exposé reported.

"It is the 3rd dose that really kills the immune system as can be seen from the ONS data for Omicron ... These figures mean that if you have Covid and you have had 3 doses of the vaccine then you are 4.45x more likely to have Omicron than if you are an unvaxxed Covid case. But the above was merely an estimation."

Based on the latest data out of Germany, we now know that the fully vaccinated are 812 percent more likely to develop a Moronic infection than the unvaccinated. The unvaccinated are basically eight times better protected from Moronic than people who took the jabs.

"And the more jabs you take the faster the degradation of your immune system progresses," the Exposé added. "It also looks like the unvaxxed are reaching sub herd immunity against Covid-19 whereas the fully vaxxed are being prevented from reaching it by the vaccines."

"The German figures have destroyed the case for vaccine passports and by themselves prove instead the case for an immediate gene therapy and spike protein vaccination ban."

It turns out that we were right, too. So-called *"vaccine immunity"* is really just *fake* immunity. It is flawed, at best. At worst, it destroys the immune system, leaving it unable to naturally fend off infections of any kind.

"By the end of January every fully vaccinated person in both countries over 30 years old will have full blown vaccine mediated AIDS," the Exposé concluded. "However much of the immune system that is presently left with the ability to fight Omicron will have gone." #### Covid cases in the US triple in two weeks and hospitalizations hit near-record high of 130,000 but deaths remain low after CDC director Rochelle Walensky said 75% of people who die of the virus have at least four comorbidities

<u>January 10, 2022</u> [Discernment recommended in this report, this is cold and flu season] Omicron cases are continuing to rise in the U.S but deaths and hospitalizations caused by the virus are not following at the same rate, signaling the variant that has grinded much of America into a standstill is not making people as sick as the Delta variant.

Cases have more than tripled over the past two weeks alone, up from 198,326 per day to 709,850 per day. The number of Americans hospitalized with Covid is nearing record levels as well, reaching 130,000 this week.

Not all of these hospitalizations are directly caused by the virus, though. Many people who go to the hospital for reason outside of Covid, such as injury or other ailments, are being tested while there. Since Omicron variant is so prevalent at the moment, many of these people are testing positive and being added to the total despite not having severe symptoms.

Deaths are not growing at the same rate, though, with 1,648 Americans dying from the virus every day - an 11 percent increase from two weeks ago. This signals either the effectiveness of the vaccines, or the more mild nature of the new strain.

The U.S. also surpassed 60 million cases of the virus as of Monday morning according to Johns Hopkins University, another grim milestone for the country.

The record surge began in December, only weeks after the new variant was discovered by South African health officials. Omicron is the most infectious strain of the virus yet, and its ability to evade vaccine immunity has presented additional challenges.

Albert Bourla, CEO of Pfizer, says that the world should be able to control Covid and even return to normal in the future - but only if people receive an annual vaccine, but it could require a decade of annual vaccination.

Pfizer - which produces the most commonly used vaccine in America and in much of the world, has benefitted greatly from the sale of its joint vaccine project with the German company BioNTech.

Bourla appeared on CNBC's 'The Squawk Box' Monday morning to discuss the future of the Covid pandemic and the role his company can play in fighting it. His statements come as the virus tears through the U.S. for a second consecutive January, and national health leaders go all-in on vaccines as a strategy to fight Covid.

American health leaders, like Dr. Rochelle Walensky of the Centers for Disease Control and Prevention, and Dr. Anthony Fauci of the National Institute of Allergies and Infectious Disease, have centered vaccines in their fight against the virus - even in the wake of a vaccine resistant strain. While the variant can evade the immunity provided by the initial vaccine regimens, experts have found that vaccine booster shots can re-establish some of those protections. Breakthrough infections are also more mild than those in unvaccinated people, and the Omicron variant is found to be a more mild strain, less likely to cause infection or death than other strains of the virus.

Because of the rise of Omicron, and the potential for future variants with similar vaccine resistant properties to arise as well, some fear Covid may never be fully ended. As long as the virus continues to mutate, it will always be able to find away around vaccines, and the protection people receive from the shots seems to wane in a matter of months anyways.

Bourla told CNBC that Covid will likely be around for the next ten years - if not longer - though it can be controlled with a robust booster campaign.

*"We will have perfectly normal lives, with just injection maybe once a year,"* he said. Does this guy look like someone you can trust?

Currently, around 130,000 people are hospitalized with Covid in the U.S., though many of those people went in for treatment for a different issue and tested positive while there.

Pfizer's vaccine has been deemed the gold standard worldwide, as the safest and most effective jab in the world. The shot has been administered over 300 million times in the U.S., almost 60 percent of total shots distributed, and is the only shot available to minors.

The success of the shot has led to a large windfall for the New York based firm, with an analysis by the People's Vaccine Alliance finding that Pfizer, its partner BioNTech and Moderna - producer of the second most popular vaccine - make a combined profit of over \$1,000 every second. Continued use of the vaccines for the next decade will likely keep that figure high.

Pfizer has also been accused of using its leverage and control over the jabs to take advantage of developing nations. Denying them their ability to receive donations of the shots, and even writing clauses into contracts that would allow the company to seize state assets. The company even worked to get around intellectual property rights for vaccine technology in other countries, as Bourla publicly called the idea of doing so in America 'dangerous', according to a report by Public Citizen last year.

On CNBC, the Pfizer CEO said that getting these low income countries to a point where they can administer more vaccines at a faster pace is a key to controlling the virus. *"Particularly in low income countries, they have more than they can absorb right now,"* he said.

"I think all the effort should be, right now... to build the infrastructure in low income countries so they can absorb more vaccines. Also, the campaigns that will convince the population [to get the shots]."

In England, which the U.S. often follows around two weeks behind of, cases are actually declining. The nation was struck hard and early by the Omicron variant, but the new strain seems to be burning out. Infections have dropped by six percent over the past week, and hospitalizations could be nearing a peak as well.

Getting a handle on America's Covid situation has become a challenge in recent weeks. Long lags in reporting combined with testing shortages have led to the current case count constantly fluctuating, and likely being lower than actual totals. Hospitalizations and deaths, on the other hand, could be over-counted, with many being hospitalized or dying from another cause extraneously being listed as a death from the virus.

On Sunday, Dr. Walensky appeared on Fox News, and failed to answer whether or not many deaths currently being attributed to the virus actually have other causes. She also told ABC's Good Morning America last week that 75 percent of people who have died from the Omicron variant in the U.S. have at least four comorbidities - in what she called "encouraging news".

According to data from Johns Hopkins, the U.S. is averaging 709,850 new cases every day, and 1,648 deaths per day. Since the pandemic began, America has suffered 60 million infections and over 837,000 deaths.

Things may soon change, though, if America follows the path of England. Across the pond, cases have dropped by six percent over the past week. While hospitalizations (up 27 percent) and deaths (up 12 percent) are still rising, the growth has slowed in recent

days - signaling the peak of the surge may have been reached. Both figures often lag behind cases as well.

London, once a global hotspot of the new variant, now finds not of its boroughs among the 25 in England with the largest Covid outbreaks - another positive sign that the new strain is burning out.

A <u>MailOnline.com</u> analysis on English data finds the new strain could be very mild, even potentially more mild than the flu. Currently in the UK, around 0.15 percent of Covid cases are fatal, compared to 0.1 percent of flu cases. While one in every 1,000 people who catch the flu die, a Washington University analysis finds that one in every 1,400 people who catch Omicron will succumb to the virus.

Data from the CDC from the 2019 to 2020 flu season - before the pandemic - found that 30 million Americans suffered a symptomatic case of the virus that year. Around 20,000 died, or a death rate of 0.05 percent.

Some experts are hopeful that the high infectiousness of the variant, combined with the relatively mild symptoms of Omicron could mean that the pandemic is soon coming to a close. Dr. Jim Baker, an immunologist at the University of Michigan, wrote in blog that the virus is showing similar signs to the 2011 flu pandemic that it will burn out soon.

"We have been focused on number of infections with COVID-19 because of the very sensitive and accurate diagnostic tests (PCR) we have developed," he said.

"In contrast, as we look at the end of the pandemic, we now need to focus less on infections and more on deaths. That is truly the important marker of a pandemic's impact and the only comparable measure to the 1918 flu epidemic where there were no diagnostic tests."

"In the 1917 flu pandemic, after the initial burst of infections and deaths, two waves of deaths followed, each one less impactful. This is how pandemics end; two "echo" waves each being less and less significant. It is because in each wave the most susceptible individuals have been killed off as the rest of the population develops immunity. A similar pattern was seen in the 2011 Influenza A pandemic and it has now emerged with COVID-19. This pattern shows the COVID-19 pandemic is burning out."

Denmark emerged as an early Omicron hotspot. Cases in the Nordic nation reached a record of over 20,000 per day at the start of the year, but dipped back down to 19,000 this week - signaling the variant may have peaked in the country.

Other countries have not been as lucky as Denmark and England, though. In Germany, cases are on the rise to start the year after declining for much of January. The country is averaging 49,000 cases per day, approaching the record of around 57,000 per day set late last year.

France's rocketing rise in Covid cases continues as well, up to nearly 300,000 per day, up from around 70,000 cases per day only two weeks ago.

When the corrupt U.S. Government addressed COVID they put in place unique ways of reporting deaths. They began by claiming every death where someone was suspected of having COVID when they died was to be recorded as a COVID death.

This resulted in thousands of deaths being reported as COVID deaths that were not. We reported on this in August 2020. Ours and others' articles received a huge amount of attention as word got out that only 6% of all deaths reported as COVID deaths were actually due to COVID only. The remaining 94% of the deaths reported as COVID deaths were deaths with COVID where those who died had multiple other co-morbidities as well. On average, those who were labeled as dying from COVID had more than two other co-morbidities.

President Trump shared this story as well as his son Don Jr and many others on Twitter. "6%" was shared all over the Internet and into the mainstream. Now, you are starting to see it in actuarial data with life insurance companies. The life insurance companies have been paying out claims like they never have before, and they are noticing the deaths cannot be explained by Covid. If you look at the actual morbidity and mortality from the CDC . . . 2019, 2020 and 2021 in the ages of 18 to 64 . . . you'll see in America, starting in quarter two of the year 2021 (when the vaccines started), the mortalities started to rise, and it rose from 120% above normal to 140% above normal, and it's far exceeded the death rates in 2020. The difference in 2020 and 2021, we had covid in both years. In 2021, we had the vaccines. They know the amount of deaths they are reporting cannot be explained by Covid. . . . There is something else driving a huge and extremely terrifying mortality signal in the U.S. population. To think that it is anything but the vaccines, if we get this wrong and if you keep saying they are safe, that line which is already in a significant and steep incline will continue the more we boost and the more we vaccinate. . . . This has to stop. We have to stop, people are dying."

Meanwhile, the captured regulatory agencies like the CDC and FDA are trashing and cutting off proven scientific cures for Covid such as Ivermectin. Dr. Kory says Ivermectin has been proven effective in defeating Covid infections, and he says, "It is "one of the safest drugs ever brought to market." Dr. Kory also says the so-called experimental vaccines "are not safe and not effective." So, why do government agencies push them anyway? Dr. Kory says, "I have had a front row seat to see this.".

. And he goes on to say government agencies are suffering from "regulatory capture" by big Pharma. Meaning, the FDA and CDC push ineffective and dangerous vaccines so Big Pharma can make money off them, while disregarding cheaper, safer and more effective drugs like Ivermectin. Dr. Kory gives a real-world example during the pandemic and explains, "Prescriptions in this country (for Ivermectin) in August were hitting 90,000 per week. So many doctors were using it for Covid that it spooked the pharmaceutical companies. . . . In response to the massive uptake in the use of Ivermectin by physicians with prescriptions and pharmacists filling them, the CDC went on the attack. They sent a bulletin to every state department of health which was full of propaganda and misinformation screaming the FDA has not approved lvermectin (for treating Covid) and it's not a proven drug, and it's dangerous and there are overdoses and all of these things that were false. It went to all state departments of health. But guess what happened next? The medical boards and the pharmacy boards started sending that to every licensed physician and pharmacist in the land. The average physician and pharmacist, I am sorry to say this, is not well read. They are not keeping up with data. They are overwhelmed and they are easily influenced. That's why in this country you have a war between the physicians that know that Ivermectin is effective . . . and are at war with the pharmacies. A huge proportion of pharmacists will refuse to fill a decades-old safe drug for Covid because they have been threatened and manipulated by their boards. They are afraid to lose their licenses. It all smokes. It's all B.S.

because you cannot lose your license for use of a safe drug. . . . We need our doctors to do doctoring, and we need our pharmacists to do pharmacy and stop being influenced by propaganda by pharmaceutical companies who don't want you to use this drug. We have to stand up, and we have to resist on behalf of our patients. We are finding that with compounding pharmacies and small pharmacies we can still get access (to lvermectin), but it is a battle and you do have to navigate."

Former Pfizer VP Dr. Michael Yeadon said this week, "Max vaccination is leading to mass death." Dr. Kory agrees and explains, "It's not only data from a life insurance company that came out this week that is based on CDC data that can't be explained by Covid alone, there are huge increases of dying in this country this year. . . . They have done huge analysis of the European mortality data as well as the U.S. mortality data and they controlled for vaccination status. They found that for every age range that they looked at, the all-cause mortality of the vaccinated were increased over the unvaccinated. All-cause mortality and that means that you are more likely to die of something if you are vaccinated. . . . All-cause mortality is coming out of actual databases by credible scientists. You have life insurance companies showing the data, and you have our own federal government showing unexplained large rises in dying. ... Don't you think a good scientific question and a good hypothesis to test would be 'Could these be the vaccines?' The answer is 'the vaccines,' and I cannot find a better fit to answering that hypothesis than that, it's this mass explosion of this vaccination policy with single, double and booster shots. It's going like wildfire through the population. If the mortality of the vaccinated is higher than the unvaccinated, you have the data that you can safely and confidently conclude the vaccines are associated with and causing death."

In closing, Dr. Kory says, "What has happened in the last month or so is the data for adverse reactions and effects are no longer hidden and suppressed. They are coming out on servers . . . and actuarial tables."

#### 3. Summary of the Geographic Spread of Influenza

State and territorial health departments report the estimated level of geographic spread of influenza activity in their jurisdictions each week through the **State and Territorial Epidemiologists Report**. This level does not measure the severity of influenza activity; low levels of influenza activity occurring throughout a jurisdiction would result in a classification of "widespread". Jurisdictions classify geographic spread as follows:

- No Activity: No laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.
- Sporadic: Small numbers of laboratory-confirmed influenza cases or a single laboratoryconfirmed influenza outbreak has been reported, but there is no increase in cases of ILI.
- Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.
- Regional: Outbreaks of influenza or increases in ILI and recent laboratory confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.
- Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratoryconfirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

Now, one year later, it appears that those additional deaths attributed to 2020 were basically being pre-added to cover up the deaths that were going to be caused by the experimental COVID-19 "vaccines" for 2021.

As you can see, according to the CDC, flu deaths have all but disappeared, as they dropped from their already record low number of 8,785 in 2020, to only 932 in 2021.

And in spite of the fact that hundreds of millions of the American population were injected with the experimental gene-therapy shots for COVID-19 in 2021, COVID deaths, according to the CDC, increased from 385,443 in 2020 to 444,951 in 2021.



### New Pentagon Documents Point To COVID-19's Laboratory Origin as a Chinese Bioweapon and U.S. Government Complicity

As described in a Gateway Pundit article last year, for over 15 years China has conducted bio-warfare research on genetically-engineered viruses coupled to a vaccine-production program to protect its own military from those China-made bioweapons.

Hold on to that thought for a moment.

The just-released <u>memorandum</u> written on August 21, 2021, by U.S. Marine Major Joseph Murphy to the Inspector General of the U.S. Department of Defense (DoD) is highly revealing, both for what it says and for what it doesn't say.

Major Murphy's analysis is based on a \$14.2 million <u>research grant application</u> "Project DEFUSE: Defusing the Threat of Bat-borne Coronaviruses" by now-disgraced scientist Peter Daszak, head of the EcoHealth Alliance, and submitted to the DoD's Defense Advanced Research Projects Agency (DARPA), as well as other documents to which we do not yet have access.

Daszak's research team included the "Bat Woman" Zheng-Li Shi of the Wuhan Institute of Virology, Ralph Baric of the University of North Carolina, Linfa Wang of the Duke

University-National University of Singapore Medical School, Tonie Rocke of the United States Geological Survey National Wildlife Health Center in Wisconsin, and Jerome Unidad of the Palo Alto Research Center in California.

#### A summary of the memorandum:

1. "SARS-CoV-2 [COVID-19] is an American-created recombinant bat vaccine, or its precursor virus."

#### The intent of Daszak's DARPA proposal was to immunize bats in Chinese caves by spraying them with a vaccine based on coronaviruses that would likely "jump" from bats to humans, thereby, preventing a pandemic.

Sound far-fetched? Stand by, the details get worse.

The DEFUSE team would collect a large number of bat coronaviruses from Chinese caves, test them for their ability to infect humans, select those most likely to make the "jump" from bats to humans, analyze their structures and map evolutionary pathways.

Of course, the concept of a vaccine based on an evolutionary model, given the highly unpredictable nature of bat coronavirus mutations is, on its face, scientifically preposterous.

Yet, if they had stopped at that point and created a bat vaccine based on a natural bat coronavirus, the project would have been a failure, but at least there would not have been a COVID-19 pandemic.

They planned to isolate the spike protein, the component of coronaviruses that regulates infectively, and genetically manipulate it to make it more infectious to humans and insert it back into a bat coronavirus backbone as a virus precursor for making a bat vaccine.

The DEFUSE team writes about introducing "human specific" structures, like furin polybasic cleavage sites, where they do not occur naturally, highly indicative of bioweapon development and consistent with the Chinese military's joint pathogen development/vaccine production program.

#### The DEFUSE proposal read like a recipe for COVID-19.

Ultimately, the Daszak DEFUSE proposal was rejected because it included such dangerous "gain of function" research, the product of which also having dual use capability as a bioweapon.

### Nevertheless, the money kept flowing from Anthony Fauci's National Institute of Allergy and Infectious Diseases, through Peter Daszak, to China.

2. Without providing the evidence upon which his conclusion is based, Major Murphy stated that **an incomplete precursor virus was released, presumably through a** 

*laboratory accident*, in August 2019 and thereafter, again presumably, circulating and mutating within the Chinese population until reaching an epidemic-producing state in November-December 2019.

3. Major **Murphy also questioned the DoD's vaccine mandate**, given the **potential toxicity of mRNA vaccines based on the COVID-19 spike protein**, as well as opposing the official suppression by the U.S. government of early intervention **therapeutics**, like ivermectin and hydroxychloroquine, which his analysis found efficacious for treating coronavirus infections.

Based on a preponderance of evidence, COVID-19 was made in a laboratory in China as part of a bio-warfare program, which was facilitated by U.S. government officials and U.S.-based scientists, who then tried to cover up their complicity and implemented flawed public health policies, all of which likely led to the unnecessary deaths of hundreds of thousands of Americans.

## U.S. CDC's Conditional Sailing Order for Cruise Ships Set to Become Voluntary

The U.S. Center for Disease Control and Prevent's conditional sailing order for cruise ships is set to switch to a voluntary program later this month, even as cases of the omicron variant of COVID-19 are on the rise, according to multiple media reports.

Cruise ships sailing from the United States have been under a conditional sailing order since the lifting of the CDC's original "No Sail Order," first implemented in March 2020 at the beginning of the COVID-19 pandemic. The "No Sail Order" was later extended four times prior to the CDC issuing a Framework for Conditional Sailing Order, issued on October 30, 2020, paved the way for cruise ships to return to passenger operations in Spring 2020 with strict health and safety protocols in place to prevent the spread of the virus.

The <u>current conditional order</u> is set to expire January 15, 2022, at which point it is set to transition to a voluntary program. A spokesperson for the CDC now tells the cruise industry website Cruise Critic that there will be no extension to the conditional sailing order upon its pending expiration.

"After the expiration of the Temporary Extension & Modification of the CSO on January 15, 2022, CDC intends to transition to a voluntary program, in coordination with cruise ship operators and other stakeholders, to assist the cruise ship industry to detect, mitigate, and control the spread of COVID-19 onboard cruise ships," a CDC spokesperson told Cruise Critic.

The transition of the program, from mandatory to voluntary, comes as the omicron variant spreads rapidly in the United States. Just last month, the CDC raised its COVID-19 travel health notice level for cruise ships to its highest warning level, citing reports of COVID-19 outbreaks on cruises, and said <u>all people should avoid traveling on cruise ships</u> regardless of their vaccination status.

The CDC's <u>cruise ship tracker</u> shows that all cruise ships operating approved for passenger operations in the United States have had reported.

VAERS data released Friday by the Centers for Disease Control and Prevention included a total of **1,033,994 reports of adverse events** from all age groups

following COVID vaccines, including **21,745 deaths** and **170,446 serious i**njuries between Dec. 14, 2020, and Jan. 7, 2022. By Megan Redshaw

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of <u>1,033,994 reports of adverse events</u> following COVID vaccines were submitted between Dec. 14, 2020, and Jan. 1, 2022, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of 21,745 reports of deaths — an increase of 363 over the previous week — and 170,446 reports of serious injuries, including deaths, during the same time period — up 3,840 compared with the previous week.

Every Friday, <u>VAERS</u> publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Historically, VAERS has been shown to report only <u>1% of actual</u> <u>vaccine adverse events</u>

Excluding "<u>foreign reports</u>" to VAERS, <u>723,042 adverse events</u>, including <u>9,936 deaths</u> and <u>64,406 serious injuries</u>, were reported in the U.S. between Dec. 14, 2020, and Jan. 7, 2021.

<u>Foreign reports</u> are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product's labeling, the manufacturer is required to submit the report to VAERS.

Of the 9,936 U.S. <u>deaths reported</u> as of Jan. 7, 19% occurred within 24 hours of vaccination, 24% occurred within 48 hours of vaccination and 61% occurred in people who experienced an <u>onset of symptoms</u> within 48 hours of being vaccinated.

In the U.S., 516 million COVID vaccine doses had been administered as of Jan. 7, <u>including</u> 303 million doses of Pfizer, 197 million doses of Moderna and 18 million doses of Johnson & Johnson (J&J).

### Supreme Court strikes down OSHA mandate, allows healthcare mandate to proceed

The U.S. Supreme Court on Thursday issued two opinions on the Biden administration's <u>COVID vaccine mandates</u> on whether to stay or to grant temporary injunctions requested by plaintiffs in a <u>number of lawsuits</u> challenging the emergency mandates for millions of Americans.

First, the justices rejected the Biden administration's mandate requiring employees of large businesses to be vaccinated against <u>COVID</u> or undergo weekly testing and wear a mask indoors while working.

The court's conservative majority said the administration overstepped its authority by imposing the Occupational Safety and Health Administration's (OSHA) vaccine-or-test rule on U.S. businesses with at least 100 employees.

In a second ruling, the justices said the mandates for workers in healthcare facilities that receive Medicare or Medicaid funding could stay in place while the lawsuits work their way through the lower courts.

The mandate is estimated to affect 10.3 million healthcare workers in the U.S., but allows for religious and medical exemptions.

Pfizer CEO says 2 shots offer 'very limited protection, if any' against COVID During an <u>interview</u> on CNBC's "Squawk Box" on Monday, Pfizer CEO Albert Bourla said two doses of Pfizer's COVID vaccine — initially referred to as a full regimen — "offers very limited protection, if any" against the <u>Omicron</u> variant.

When a third, or booster dose, is administered the vaccine offers only "reasonable protection" against hospitalization and death from Omicron and "less protection against infection," Bourla said.

Bourla previously claimed a two-dose regimen was "100% effective."

#### EU regulators, WHO call for end of boosters

European Union drug regulators on Tuesday warned <u>frequent COVID boosters</u> could risk overloading the immune system and said there are currently no data to support repeated doses.

This comes a month after the regulators <u>said</u> it made sense to "administer COVID-19 vaccine boosters as early as three months after the initial two-shot regimen," amid concerns over the Omicron variant.

The World Health Organization's Technical Advisory Group on COVID-19 Vaccine Composition on Jan. 11 also <u>warned</u>, "a vaccination strategy based on repeated booster doses of the original vaccine composition is unlikely to be appropriate or sustainable."

The group said giving additional doses of already existing vaccines as new strains of the virus emerge is not the best way to fight a pandemic, as currently available COVID vaccines do not prevent infection or transmission and the current composition of COVID vaccines need to be updated.

#### Djokovic's visa canceled second time over unvaccinated status

Australian authorities today revoked Novak Djokovic's visa due to his unvaccinated status, in the latest twist in the <u>ongoing battle</u> over whether the nine-time Australian Open champion will be allowed to defend his title.

As <u>The Defender reported</u>, Australian Minister Alex Hawke used his ministerial discretion to cancel the No. 1 ranked Tennis player's visa citing "health or good order grounds," just three days before the Australian Open begins and four days after a federal judge ordered Djokovic be released from hotel detention when his visa was revoked the first time.

Djokovic's lawyers are contesting the visa cancellation in court, in an attempt to allow him to play in the prestigious tennis tournament. If unsuccessful, Djokovic will face deportation.

This fact, combined with the realization that nurses are being actively ordered to *avoid* VAERS reporting on covid vaccines, means the URF of 40X is far too low. Given the environment of extreme suppression now leveled against doctors and nurses to try to cover up vaccine injuries, a more legitimate estimate of the URF would be 200X.

If accurate, this would mean that 21,000+ VAERS reports actually translated into **4.2** million US deaths from these vaccines so far.

Bookmark that thought as we look at other numbers that paint a truly frightening picture. Vaccines kill people in three phases, taking as long as a decade for all the vaccine-induced cancer deaths to play out.

Although we've all seen people literally keel over dead from vaccine-induced heart attacks, most people who are on track to die from covid vaccines don't die right away.

There are three phases of covid vaccine mortality, described in this chart below:

### Covid vaccines are known to cause myocarditis.

Myocarditis alone is fatal in 56% of patients in less than 5 years. Giant-cell myocarditis causes over 80% mortality in 5 years.

Remember that according to Dr. Ryan Cole, a Mayo Clinic trained, board-certified anatomic pathologist, 62% of patients injected with mRNA vaccines show micro blood clots. Dr. Cole presents this evidence in the following video from the White Coat Summit:

Micro blood clotting is an early sign of vascular damage and heart damage. People receiving covid vaccines are often diagnosed with myocarditis, which has a **56% fatality** rate over five years.

A <u>study published by the American Heart Association</u> — then widely censored by Big Tech — found that mRNA covid vaccines greatly increased the risk of vascular inflammation and therefore heart attacks and other vascular events. The risk of heart attack alone increased by 127% in a group of 500 patients, according to this one study.

#### As DailyExpose.uk explains:

A new study suggests the mRNA injections produced by both Pfizer and Moderna are raising inflammatory blood markers used to estimate the risk of a person suffering a heart attack.

Dr. Aseem Malhotra, a consultant cardiologist, points out that in the UK there have been 10,000 excess non-Covid deaths — many of which were due to heart attack and stroke. A few days after these ominous results came out, a whistleblower and researcher from a different group contacted Dr. Aseem Malhotra to say that in imaging studies they have found inflammation in the coronary arteries after vaccination. But they decided not to publish this yet because they are afraid of losing future grant money from the drug industry. The whistleblower was quite upset about this.

Dr. Charles Hoffe (Canada) is also reporting substantial increases in blood clotting among mRNA vaccine takers. <u>Via LifeSiteNews</u>:

The core problem he has seen are microscopic clots in his patients' tiniest capillaries. He said, "Blood clots occurring at a capillary level. This has never before been seen. This is not a rare disease. This is an absolutely new phenomenon."

Most importantly, he has emphasized these micro-clots are too small to show up on CT scans, MRI, and other conventional tests, such as angiograms, and can only be detected using the D-dimer blood test, a standard test that indicates whether blood clots are being actively formed somewhere within a person's vascular system.

Using the latter, he found that 62 percent of his patients injected with an mRNA shot were positive for clotting, not a small fraction that can be easily dismissed.

#### Myocarditis fatalities and inhibition of DNA damage repair

Through simple math, if we take 62 percent of covid vaccinated people who show micro blood clots — leading to myocarditis — and multiply by the known myocarditis 56% fatality rate over five years, this alone would mean that **36% of mRNA vaccine takers** 

**will be dead in five years**. Granted, this assumes that all the micro blood clot people end up with myocarditis, and that relationship isn't yet satisfactorily documented. So this 36%, based entirely on heart attack deaths, may be too high by itself.

Yet this only begins to tell the story of deaths from other causes such as vaccineinduced cancer. Another fact we now know is that once mRNA vaccines start producing spike protein nanoparticles in a person's body, some percentage of those spike proteins **enter cell nuclei** and achieve about a 90% suppression of the NHEJ mechanism, which is the chromosomal repair mechanism that maintains genetic integrity for the body.

That article cites a critical research paper entitled, "SARS–CoV–2 Spike Impairs DNA Damage Repair and Inhibits V(D)J Recombination In Vitro," authored by Hui Jiang and Ya-Fang Mei, at the Department of Molecular Biosciences, The Wenner–Gren Institute, Stockholm University, SE-10691 Stockholm, Sweden, and the Department of Clinical Microbiology, Virology, Umeå University, SE-90185 Umeå, Sweden, respectively. In the conclusion of the paper, authors write, "We found that the spike protein markedly inhibited both BRCA1 and 53BP1 foci formation (Figure 3D–G). Together, these data show that the SARS–CoV–2 full–length spike protein inhibits DNA damage repair by hindering DNA repair protein recruitment."

The study finds that the suppression of NHEJ activity exhibits a dose-dependent response to the presence of spike protein. This means that spike proteins in the cells will cause the suppression of chromosomal repair mechanisms, leading to **loss of genetic integrity over time**.

In effect, once people are injected with mRNA vaccines, when they are subsequently exposed to even mild sources of ionizing radiation — sunlight, mammography, highaltitude commercial air flights, food plastics chemicals, etc. — their bodies may initiate the growth of new cancer tumors that cannot be suppressed because the NHEJ system is no longer functioning.

In effect, **people will become mutants** because they can no longer maintain genetic integrity due to the spike protein suppression of the NHEJ repair mechanism.

We are already seeing reports of alarming increases in cancers among the vaccinated. For example, as <u>reported from Cancer.news</u>:

Women recently injected with experimental covid vaccines are showing symptoms of BREAST CANCER

A group of Utah doctors have discovered something terrifying in recent mammogram screenings taken at the Breast Care Centre in Salt Lake City, Utah. Women who were recently injected with experimental COVID vaccines suffer from abnormal inflammation of the lymph nodes in their breasts. According to the Intermountain Healthcare doctors, women who take the covid-19 vaccines are showing symptoms of breast cancer.

Dr. Brett Parkinson, MD., warns, "Whenever we see these on a normal screening mammogram, we call those patients back because it can either mean metastatic breast cancer which travels to the lymph nodes or lymphoma or leukemia." Instead of dealing with the cause of this problem (vaccines), the doctors are now telling women not to get mammograms after vaccination.

And from Vaccines.news: <u>Idaho doctor reports "20 times increase</u>" in cancer among those "vaccinated" for covid:

In a video produced by the Idaho state government's "Capitol Clarity" project, Cole revealed how he is now seeing a 2,000 percent chronic illness increase in folks who took [the vaccine].

"Since January 1, in the laboratory, I'm seeing a 20-times increase of endometrial cancers over what I see on an annual basis," Cole stated in the video.

*"I'm not exaggerating at all because I look at my numbers year over year, and I'm like 'Gosh, I've never seen this many endometrial cancers before."* 

In a "normal" year, there are around **600,000** cancer deaths in the United States. With the spike protein suppressing NJEH by 90%, and with doctors already reporting a 2000% increase in one type of cancer (endometrial) from early 2020, it's clear that cancer deaths are going to substantially increase in the coming years due to covid vaccines.

Add that data point to the big picture here.

A 40% increase in all-cause mortality, says life insurance CEO

Providing an additional clue to all this, we have recently <u>reported on the shocking</u> <u>interview with Scott Davison, CEO of OneAmerica, a life insurance company</u>. Davison reveals that **all-cause mortality is up 40%** among their life insurance policy holders, which covers a wide range of people, aged 18 - 64. Davison refers to this as, "the highest death rates we have seen in the history of this business – not just at OneAmerica."

This observation is based on third quarter data from 2021. The numbers for Q4 will look far worse due to the well documented fact that VE numbers (Vaccine Effectiveness) plummet with each passing week after vaccination, representing a continued destruction of the immune system. As more time goes by, those who took the vaccines have weaker and weaker immune systems, making them more vulnerable to common infections and flu strains that would normally be of little threat. This is confirmed by

official government data from the UK as well as independent research such as this study from the Francis Crick Institute in the UK: <u>Pfizer vaccine destroys T cells</u>, <u>weakens the immune system – study</u>:

A study from the Francis Crick Institute in the United Kingdom has found that the Pfizer-BioNTech Wuhan coronavirus (COVID-19) vaccine destroys T cells and weakens the immune system... It found that only 50 percent of the people who received a single dose of the Pfizer vaccine had a quantifiable neutralizing antibody response against the alpha variant of COVID-19. This number decreased even further to just 32 percent and 25 percent for the delta and beta variants, respectively.

A 40% increase in all-cause mortality, if applied across all age groups, means that an additional **3,100 Americans** are dying each day. That's over 90,000 people per month being killed by the vaccine as of Q3, 2021. (The normal pre-covid death rate is around 7,700 per day in the USA.)

We estimate that by the time Q1, 2022 data are available, we will likely see up to a 60% increase in all causes mortality, leading to **an additional 4,600 deaths per day**. This alone is nearly **1.7 million deaths per year**, or about half a percent of the entire US population.

My (conservative) prediction is that as post-vaccine cancer deaths take hold, we are going to see, at minimum, a **400% increase in cancer deaths** starting in 2022. That's roughly **2.4 million vaccine-related cancer deaths per year** for the foreseeable future, very likely continuing through the next decade.

#### 93% of post-vaccine deaths attributed to the vaccine itself

One more factor to consider in all this is the astonishing research conducted by Drs. Bhakdi and Burkhardt, <u>commented on by Steve Kirsh at Substack.com</u>.

Although the sample size was small (15 autopsies), it showed that 93% of people who died after being vaccinated were, in fact, **killed by the vaccine**. As Kirsh explains:

The coroner or the public prosecutor didn't associate the vaccine as the cause of death in any of the cases. However, further examination revealed that the vaccine was implicated in the deaths of 14 of the 15 cases. The most attacked organ was the heart (in all of the people who died), but other organs were attacked as well. The implications are potentially enormous resulting in millions of deaths. The vaccines should be immediately halted.

Importantly, as Dr. Bhakdi explains on video, these autopsies showed that people were killed by **killer lyphocytes attacking their own organs such as the heart and lungs**. In other words, mRNA covid vaccines caused the body's own immune system to start growing lymphocyte tissues in places where it doesn't belong, such as the heart and other organs.

This shocking finding caused former Pfizer VP Mike Yeadon to write Steve Kirsh and explain, "This is about the worst 15 min (video) I've ever seen. Mass covid19 vaccination is leading to mass murder."

Essentially, what Dr. Bhakdi's findings reveal is that **far more people are now dying from the vaccine than from natural causes**. This would imply that the pre-covid daily death rate of 7,700 Americans (that's per day) is about to be dwarfed by vaccine-induced deaths which will, at some point, emerge as a *multiple* of 7,700.

It's not unreasonable to imagine that over the next few years as cancer tumors and lymphocyte attacks accelerate, we could start to see *daily* deaths in America exceeding 16,000 or even 30,000 as the post-covid vaccine deaths accelerate.

At 30,000 deaths per day, by the way, the number of dead in a year reaches nearly 11 million people, or about 3.3% of the total U.S. population expiring in a given year. Over a decade, that's about a third of the current population. These are projections, of course, but they are rooted in early evidence and observation.

### Conservatively, one-third of all who received covid vaccines will likely die over the next decade... and another third will be debilitated

Based on the cancer deaths, myocarditis deaths, autoimmune deaths, heart attack deaths and the increased risks of strokes, neurological disorders and organ failure, we can conservatively conclude that roughly:

- One-third of those who took mRNA covid vaccines will be dead over the next ten years.
- One-third will be injured or debilitated and unlikely to be capable of participating in society in a meaningful way.
- One-third will be relatively unaffected.

Interestingly, this appears to coincide with the statistical analysis of covid vaccine lot numbers, where roughly one-third of the lots are associated with heart attacks and deaths, another third are associated with injuries (but not death), and a final third appear to be harmless (suspected to be saline).

Again, these are rough numbers and there will be disagreement about many of the projections made here, but this is an **early snapshot and projection** based on what we know so far. Obviously, these conclusions are subject to change as new data appear, and the final number by the end of 2032 could be radically different from these projections (far worse or perhaps far better).

#### 30 million people per day are being vaccinated around the world

Now let's look at what this means globally if we conclude that roughly one-third of vaccinated people will die over the next decade.

Right now, about **30 million people** are being vaccinated each day across the globe, <u>according to OurWorldInData.org.</u>

That same site says that **58.5%** of the world's population has been vaccinated with at least one dose, and that **9.25** billion doses have been administered (data accessed on 1/4/2022).

If one-third of vaccinated people are set on a path to die from the vaccine over the next decade, then each day that these vaccines continue, **about 10 million people are being sentenced to death**.

If this continues for just one more year — 365 days — this would mean an additional **3.65 billion people** will be exterminated by vaccines and die from vaccine-induced fatalities over the next decade or so. That's roughly **half the world's population**, by the way.

If you're wondering how more than one-third of the world's population can be exterminated if only one-third of the vaccine lots are so-called "kill shots," remember that people are being given multiple injections via "boosters." Thus, one person can be injected five or six times with mRNA shots, and even if only one-third of those shots are "kill shots," their chances of escaping the kill shot dwindle rapidly. It's like playing *vaccine roulette*.

Statistically speaking, here are the odds of EVADING a kill shot if a person continues to take more injections, given the assumption that one-third of the lots are deadly:

- 1<sup>st</sup> injection: 66.6% chance of evading death. 2<sup>nd</sup> injection: 44.4% chance of evading death. (.666 ^ 2) 3<sup>rd</sup> injection: 29.5% chance of evading death. (.666 ^ 3) 4<sup>th</sup> injection: 19.7% chance of evading death. (.666 ^ 4) 5<sup>th</sup> injection: 13.1% chance of evading death.
- 5 Injection. 15.1% chance of evaluing death.
- 6<sup>th</sup> injection: 8.7% chance of evading death.

As you can see, if the governments of the world can coerce people into taking six shots, they can kill over 90% of the world's population, given that one-third of vaccine lots are kill shots and assuming a 100% kill rate over time.

Thus, the only way to stop this vaccine holocaust is to stop the vaccines.

For each additional day that the depopulation globalists run their vaccine holocaust campaign, they are likely exterminating an additional 10 million people over time.

That's a World War II Nazi Holocaust every 14.4 hours, in terms of innocent lives destroyed.

It also means that nearly 7,000 lives are being destroyed *per minute* as this vaccine holocaust continues.

This also means that each day *earlier* that we stop the holocaust, **we potentially save 10 million lives**.

The important question becomes: Can human civilization remain intact if we lose over 50% of the population?

### Life insurance voided because covid vaccines are "medical experiments"?

According to reports, many who took the experimental gene therapy from "Operation Warp Speed" program are now coming to the realization that their death benefits have been voided.

Apparently the life insurance industry considers the emergency use-authorized injections to be an "experimental medical intervention" – which is exactly what they are. Consequently, they do not qualify for a payout.

Only vaccines that have undergone the normal testing and vetting process are covered, in many cases. These rushed-to-market injections, conversely, are not covered.

"Some insurers are delaying applications if you are currently testing positive for coronavirus and need to provide medical evidence, but this does not mean you cannot apply again in the future," reports indicate.

Some insurers are still covering their existing clients who got jabbed while others are "delaying" applications for new clients who got their shots before applying.

Among the questions that life insurance carriers are now asking their potential clients include the following:

• Have you tested positive for coronavirus?

- Are you currently in self-isolation?
- Have you had any symptoms of coronavirus?

• Have you been in direct contact with anyone who has been diagnosed or suspected of having a coronavirus?

"Note in the last question that it asks about having a coronavirus, not just the 'novel' coronavirus," reports *Principia Scientific*.

"This means that anyone who is testing 'positive' for any coronavirus, including the one associated with the common cold, could be denied life insurance coverage."

Answering yes to any of the above questions could result in an applicant's decision being "delayed" until he or she has "recovered."

"The decisions may vary between insurers," reports explain.

Covid "positive" patients could be denied coverage until they fully recover.

"Some insurers are delaying applications if you are currently testing positive for coronavirus and need to provide medical evidence, but this does not mean you cannot apply again in the future," reports further explain.


Even testing positive for the common cold, which is a type of coronavirus, could disqualify a person from coverage until he or she is able to procure a negative test suggesting a clean bill of health.

"High-risk" people who answer yes to any of the aforementioned questions could be denied coverage *forever* if they also have other health conditions such as diabetes, asthma, autoimmune disease or heart disease.

"This is why getting tested and playing the *plandemic* game is a no-go for people who still want their lives to be insured for the safety and protection of their families in the event that they die from the vaccine or some other cause," *Principia Scientific* reports. ### The first case of Spanish Flu occurred at a military base in Kansas where vaccine experiments were taking place.

Because Spain remained neutral during both the first and second world wars *and* did not censor its press like was occurring elsewhere, it would become the first country in the world to report a flu epidemic in 1918.

This would explain why Spain ended up being scapegoated for what would later be called the "Spanish Flu." However, it turns out that that first real case of the deadly disease actually occurred in Kansas at a military base where vaccine experiments were taking place.

In preparation for World War I, military servicemen at Fort Riley, where numerous prior vaccines had been developed, conducted a massive vaccination experiment. This would lead to "patient zero" appearing in the United States rather than Spain.

If history was honest, it would actually be called the 1918 United States Military Flu. However, thanks to prolific influence from the likes of the Rockefeller family and other Big Pharma globalists, the blame got shifted to Spain. "The fledgling pharmaceutical industry, sponsored by the 'Rockefeller Institute for Medical Research,' had something they never had before – a large supply of human test subjects," explains Martingano.

There was no Spanish Flu: it was bacterial meningitis caused by vaccines It would take until long after the war for autopsies to show that the millions of people who died from the "Spanish Flu" actually died from vaccine-induced bacterial meningitis. "It was caused by random dosages of an experimental 'bacterial meningitis vaccine,' which to this day mimics flu-like symptoms," Martingano explains. "The massive, multiple assaults with additional vaccines on the unprepared immune systems of soldiers and civilians created a 'killing field.""

Interestingly, the only people who were not affected by the so-called Spanish Flu were those who avoided taking the injections. Those people, including McBean, would go on to live normal lives and even tell all about what they witnessed at that horrific time.

While it all started out with mostly soldiers getting the injections, a massive leftover cache of the shots would eventually be given to civilians. This resulted in mass death on a wide scale among the American civilian population.

*"Fearing that soldiers coming home would spread diseases to their families, the U.S. government pushed the largest vaccine 'fear' campaign in history,"* Martingano writes.

"They used the human population as a research and development lab to field test experimental vaccines ... Tens of millions of civilians died in the same manner as did the soldiers."

Just like today, the doctors of that day mostly ignored what they were witnessing occur as a result of the mass injection campaign. Instead of stopping it in order to save lives, they actually proceeded to *intensify* the jab drive, resulting in many more deaths.

"Seven men dropped dead in a doctor's office after being vaccinated," McBean writes in her book about the propaganda that was being spread at the time. "Letters were sent to their families that they had been killed in action."

In total, WWI soldiers from the U.S. were given anywhere from 14-25 untested, experimental injections, all within just a few days of one another. This triggered a cascade of intensified diseases all at once, which the medical system blamed on the "Spanish Flu."

*"The doctors called it a new disease and proceeded to suppress the symptoms with additional drugs or vaccines,"* Martingano further explains.

The CDC has only ever tested MMR and Thimerosal for a link to autism. The remaining 15 vaccines and 37 common ingredients remain untested for links to autism.





THERE ARE RISKS | YOU HAVE CHOICES

Neither test has been authorized, cleared, or approved by the FDA for distribution or use in the United States.

The LuSys Laboratories COVID-19 Antigen Tests (Nasal/Saliva) and COVID-19 IgG/IgM Antibody Tests may also be sold under the company names Luscient Diagnostics or Vivera Pharmaceuticals, or with the trade name EagleDx. The FDA believes that these tests were distributed for use in laboratories or for at-home testing.

Omicron variant and the hysteria around it made Americans panicking, and they tested themselves for the minor ailment to make sure they did or didn't have C-19.

The testing sites in many urban zones made people stand in lines waiting outside in the cold. NYC is a place where you can see thousands of asymptomatic and mildly ill people waiting to get their C-19 nasal swabs. Thousands of New York City residents have been waiting in lines in below-freezing temperatures for hours to get tested for the new COVID Omicron variant, which typically presents with symptoms similar to the common cold.pic.

So, a lot of people decide to get home test kits only to avoid the crowd. So, it increased the demand for test kits in the holiday season.

The Biden admin. invoked the Defense Protection Act to give \$3 billion so the Americans could get the home testing kits. It's crucial to mention that kits aren't FDA approved. They have emergency use authorization.

The C-19 testing kit has a lethal ingredient causing past deaths even in small doses. Abbott's BinaxNow C-19 Antigen Self Test is the item that is questioned for having the ingredient called sodium azide.

The CDC shared some facts about sodium azide:

• Sodium azide is a rapidly acting, potentially deadly chemical that exists as an odorless white solid.

• When it is mixed with water or an acid, sodium azide changes rapidly to a toxic gas with a pungent (sharp) odor. It also changes into a toxic gas (hydrazoic acid) when it comes in contact with solid metals (for example, when it is poured into a drain pipe containing lead or copper).

• The odor of the gas may not be sharp enough, however, to give people sufficient warning of the danger.

*"Survivors of serious sodium azide poisoning may have heart and brain damage,"* according to the public health agency.

There is a warning on the instructions saying:

11. Do not dip the swab into the liquid reagent or other liquid before inserting the swab into the nose.

However, who will read the instructions before they use the test kit? So, people aren't aware of the dangerous ingredient. The test could be administered to young children at two or three. Open your eyes and read carefully.

If that is not enough, reports go so far as to say there are a dozen ways that can make the tests unreliable.

There are other reports of issues with the vaxx test kits and what the public does not realize is that we are engaged in a nano-war where the weapons are invisible to the eye
