All They Want is Your DNA – To Be Added to PCR Test

People most at risk from coronavirus can be identified with a simple genetic check, health officials say. This report exposes the real reason for Covid-19. It begins with a huge secret that was revealed accidentally, yet makes the connection to a much larger issue that most people are ignorant of. This is the “last hurrah” for Satan of the Bible.

The Polish Health Ministry is planning to introduce a new type of screening for coronavirus after a specific gene was discovered that determines the likelihood of a patient suffering from severe or fatal Covid-19.

People most at risk of suffering the severest effects or even dying of coronavirus can be identified using a genetic test, health officials in Poland revealed this week. The study that resulted in the discovery was supported by the country’s Ministry of Health and Medical Research Agency, and involved around 1,500 patients with Covid-19. Researchers from the Medical University of Bialystok identified a gene in chromosome 3 that significantly influences how badly the virus will affect an individual.

“After more than a year and a half of work, it was possible to identify a gene responsible for a predisposition to becoming seriously ill [with Covid],” Health Minister Adam Niedzielski said at a press conference on Thursday.

The findings will now be applied to help identify patients at increased risk from the virus when or even before they contract the infection. The Health Ministry plans to develop and launch a “relatively simple” and quick genetic test that can be performed alongside PCR screening within a few months.

It could also be implemented around the world to help people with apparent genetic preconditions, Polish officials said.

“This is a step towards personalized medicine, which is the medicine of the future – when, knowing our genome, we will know what harm to expect when it comes to our health,” Joanna Zajkowska, a professor at the University of Bialystok, told Polish Radio.

If at least one version of the gene is present in the chromosome, a patient is more than twice as likely to suffer the worst effects of Covid-19 or die, according to the study of genetic individual susceptibility led by Marcin Moniuszko and Miroslaw Kwasniewski. The gene is the fourth-most-important factor responsible for acute disease, and is said to be an even more important risk factor than comorbidity. It comes after age, obesity

and gender (men are believed to suffer from Covid worse than women), according to the study. The VAERS death ratio confirms this on page 48 below.

The gene is present in around every 10th person in Europe, while in India the rate is almost three times higher, with some 27% of the population being genetically prone to severe Covid. In Poland, where the death rate from the virus is higher than the EU average, around 14% of the population carries the gene.

“From the beginning of the pandemic, we have been trying to understand why, even among people of similar age, some are infected asymptotically while others fight for their lives,” said a spokesman for the university. *“Thanks to the research, we are getting closer to understanding this phenomenon.”*

The Polish study is not the first to suggest correlation between certain genetic factors and patients’ reactions to Covid-19. A genome-wide analysis of Italians and Spaniards in 2020 studied blood types and a chromosome 3 gene cluster in association with respiratory failure caused by coronavirus. Extreme susceptibility to severe illness was found in persons with certain DNA markers, while the study also showed that people with type A-positive blood are at higher risk of respiratory failure from Covid.

Other research from Germany also detected correlation between a gene cluster on the same chromosome and the risk of severe infection. A mutation which helps fight off RNA viruses, inherited by some people from our Neanderthal ancestors, has been found.

At this point, we need to understand the Human Genome Project was completed at the beginning of the 21st century. It was in April of 2003 when The Human Genome Project (HGP) was one of the great feats of exploration in history. Rather than an outward exploration of the planet or the cosmos, the HGP was an inward voyage of discovery led by an international team of researchers looking to sequence and map all of the genes -- together known as the genome -- of members of our species, Homo sapiens. Beginning on October 1, 1990 and completed in April 2003, the HGP gave us the ability, for the first time, to read nature's complete genetic blueprint for building a human being.

When the human genome was first deemed “complete” in 2000, the news was met with great international fanfare. The two rival groups vying to finish the genome first—one a large government-led consortium, the other an underdog private company—agreed to declare joint success. They shook hands at the White House. Bill Clinton presided. Tony Blair beamed in from London. *“We are standing at an extraordinary moment in scientific*

history,” one prominent scientist declared when those genomes were published. “It’s as though we have climbed to the top of the Himalayas.”

But actually, the human genome was not complete. Neither group had reached the real summit. As even the contemporary coverage acknowledged, that version was more of a rough draft, riddled with long stretches where the DNA sequence was still fuzzy or missing. The private company soon pivoted and ended its human-genome project, though scientists with the public consortium soldiered on. In 2003, with less glitz but still plenty of headlines, the human genome was declared complete once again.

But actually, the human genome was still not complete. Even the revised draft was missing about 8 percent of the genome. These were the hardest-to-sequence regions, full of repeating letters that were simply impossible to read with the technology at the time.

Finally, May, 2003, a separate group of scientists quietly posted a preprint online describing what can be deemed the first truly complete human genome—a readout of all 3.055 billion letters across 23 human chromosomes. The group, led by relatively young researchers, came together on from around the world to finish the task abandoned 20 years ago. There was no splashy White House announcement this time, no talk of summiting the Himalayas; the paper itself is still under review for official publication in a journal. But the lack of pomp belies what an achievement this is: To complete the human genome, these scientists had to figure out how to map its most mysterious and neglected repeating regions, which may now finally get their scientific due.

“I consider this a landmark,” says Steven Henikoff, a molecular biologist at Fred Hutchinson Cancer Research Center, who was not involved in the project. Henikoff studies one of those enigmatic, hard-to-sequence regions where previous human-genome projects had given up: centromeres, which are the slightly pinched middles of each chromosome. Chromosomes, of which humans have 23 pairs, each consist of a long, continuous stretch of DNA that can be condensed into a rod shape; the DNA at the centromere is particularly dense.

On five human chromosomes, the centromere is not in the middle but very close to one end, dividing the chromosome into one long and one very short arm. These short arms are also full of repeats that had never been entirely sequenced until now. Centromeres, short arms, and other types of repeating regions made up most of the 238 million letters the consortium ultimately added or corrected in the human genome.

The repeat-rich segments of the human genome do not usually contain genes, which is one reason they’ve long been neglected. Geneticists have focused largely on genes because their function is obvious and simple: A gene encodes a protein. (One big surprise of the earlier drafts of the human genome is how little of our DNA actually encodes proteins—only 1 percent. The role of the remaining 99 percent is becoming clearer.) Indeed, there have been hints that these repeat-rich regions also play

important roles in how genes get expressed and passed on, and anomalies in them have been linked to cancer and aging. The consortium found 79 new genes hidden among the repeats too. With a map of these repeating regions finally in hand, scientists can probe more carefully their function.

The effort to finish the genome was “entirely grassroots,” says Adam Phillippy, a computational geneticist at the National Institutes of Health who co-leads the Telomere-to-Telomere (T2T) consortium that completed the genome. (Telomeres are the regions at the ends of chromosomes, so telomere to telomere means “end to end.”) Phillippy and Karen Miga, a geneticist at UC Santa Cruz, decided to create the consortium in 2018, after a call when they realized that they both harbored ambitions of finishing the human genome.

“I’m in love with repeats,” says Miga, who came to the project as a biologist trying to understand what those repeats do. Phillippy, a computer scientist by training, brought technical chops. Traditional sequencing technologies fragment DNA into small pieces, and computer algorithms have to reassemble them like puzzle pieces. The problem is that the pieces from repeating regions all look nearly the same. Now two new “long-read” sequencing technologies—called PacBio HiFi and Oxford Nanopore—allow scientists to read longer stretches of the genome. These sequencers still can’t handle chunks big enough to cross an entire centromere or a short arm, but at least the algorithms have larger puzzle pieces to assemble.

The role of centromere sequences, like many other repeating regions, is not yet fully understood, but they are most classically known as the key to cell division. When a cell divides in two, a protein spindle attaches to the centromeres, yanking the chromosomes apart to make sure that each cell gets the right number. When this goes wrong in eggs or sperm, babies can be born with chromosomal anomalies such as [Down syndrome](#) or Turner syndrome. When it goes wrong in other parts of the body, we can end up with blood cells, for example, that have too many or too few chromosomes. This is a hallmark of aging: It’s not unusual for men older than 70 [to have lost the Y chromosomes](#) in their blood cells. In one of two companion papers uploaded alongside the complete genome, the T2T consortium showed that Oxford Nanopore’s long-read technology can also be used to map where exactly the protein spindle attaches to the centromere. Examining the sequences in those regions might yield new clues to chromosomal anomalies.

The repeat-rich short arms of the chromosomes are similarly mysterious. They definitely play some role in the cellular machinery that translates genes into proteins, and knowing their sequences could shed more light on that function. Brian McStay, a biologist at the National University of Ireland at Galway, likens the complete genome to a “parts list” for chromosomes that allows scientists to try taking out the building blocks one by one. *“Knowing what this parts list is, we can say, ‘This is exactly what our chromosome looks like,’”* McStay says. *“Let’s delete this and see what the impact on the function of that chromosome is.”*

As impressive as the technical feat of sequencing a complete human genome is, scientists told me that one genome is only one snapshot. Seeing how these repeating regions change over time from person to person, species to species, will be far more interesting. *“What happens in cancer? What happens in development? What happens if you compare offspring to parents?”* Henikoff says. The consortium proved that these repeating regions are sequenceable with the new long-read technologies. Now they can be applied to more genomes, allowing scientists to compare one with another.

Indeed, Miga says that the ultimate dream is to make every genome that scientists attempt to sequence complete from end to end, telomere to telomere. But first, the group has a more immediate goal in mind. If you wanted to fault the new genome for not being “complete,” you could point to the fact that it comprises only a single set of 23 chromosomes, whereas normal human cells have 23 pairs. To simplify the task, the group used cells from a particular type of tumor that develops from an abnormal fertilized egg and ends up with just 23 single chromosomes. The team will have to use different cells, with 23 pairs of chromosomes, to complete what is known as a “diploid” genome.

“The next major milestone would be routine diploid genomes,” says Shilpa Garg, a geneticist at the University of Copenhagen, in Denmark. Garg [has used PacBio HiFi](#) to rapidly assemble human genomes—minus some tricky regions such as the centromeres—at a rate of a few per day. That speed could help in clinical settings too, by making it easier for doctors to more regularly diagnose patients using genome sequencing. (In comparison, she says, assembling genomes from older sequencing technology takes as long as three weeks.) *Truly* complete genome sequencing, repeating regions and all, is getting easier and faster. Soon, another complete human genome will not be news at all.

Over the past twenty years or so, most of us went about living life unaware that scientists were busy. We were engaged in education of our selves, children, buying homes, planning for retirement, establishing our bucket lists, totally oblivious to what scientists were doing in their labs. Then came along CRISPR-Cas9, and man's ability to play God! Two years ago Albert Bourla CEO of Pfizer made the declaration, *“We have cracked the Code of life!”* He was saying in modest fashion that man could now create life. That is a no no, a huge NO NO! On May 21, 2010, Genetics pioneer J. Craig Venter announced Thursday that he and his team have created artificial life for the first time.

Using sequences of genetic code created on a computer, the team assembled a complete DNA of a bacterium, then inserted it in another bacterium and initiated synthesis, or in Venter's words "booted up" the cell.

In a statement, Venter called the results "the proof of principle that genomes can be designed in the computer, chemically made in the laboratory and transplanted into a

recipient cell to produce a new self-replicating cell," controlled only by the synthetic genome. Venter answered questions Thursday about the achievement.

CNN: What exactly have you done?

J. Craig Venter: We announced the first cell that is totally controlled by a synthetic chromosome that we designed in a computer based on an existing chromosome.

We built it from four bottles of chemicals.. that's over a million base pairs [of chromosomes]. We assembled that and transplanted it into a recipient cell and that new chromosome started being read by the machinery in the cell, producing new proteins, and totally transformed that cell into a new species coded by the synthetic chromosome.

So it's the first living self-replicating cell that we have on the planet whose DNA was made chemically and designed in the computer.

So it has no genetic ancestors. Its parent is a computer.

Time.com: Scientist creates life. That's a good thing, right?

CNN: What's its name?

Venter: "It is software.. It's DNA software."

CNN: How big a deal is this?

Venter: It's for others to describe. It's a big deal for us. We've been working on it for 15 years. It gives us tools to work with that haven't existed before. And we have some huge challenges.

We need new tools in science. Allowing us, for example, new organisms that more efficiently can capture CO₂ and convert it into fuel so we can get weaned off of oil.

We can create new food substances. ... We can create new ways to create clean water. We are already going to create new vaccines to treat diseases that emerge each year like the flu, so it's a new tool for scientists to work with.

But it's also a change conceptually. This is the first time we had a life form whose genetic code was made chemically. It tells us about the dynamic nature of life...That it changes second to second.

You take away the DNA, we're dead very quickly. You can't have life without the genetic code.

CNN: What does this mean for the average person?

Venter: This is a basic science breakthrough that now takes us from what was a hypothetical possibility -- that we could have synthetic life in these tools -- to rapidly advance to get some breakthroughs.

This is the first baby step that allows us to do that.

But it's a conceptual change... because we know it's possible. It should give people hope that we have new tools to tackle these problems.

CNN: Did you create new life?

Venter: We created a new cell. It's alive. But we didn't create life from scratch. We created. as all life on this planet is out of a living cell.

CNN: Some critics suggest you shouldn't make life from a computer.

Venter: People have been discussing this for the past decade since we've made incremental steps trying to get to this point. This is the fourth scientific publication in a series since 2003, so you can find 100,000 blogs out there discussing philosophically what this means, where does it take us, we can build things based on our imagination. So I think this will stimulate a lot of thinking, a lot of discussion.

CNN: Could you build an actual living organism - Frankenstein like?

Venter: Well these are very small cells. They are living. They are self-replicating. But if you're trying to advance life forms like you and me, I think that's still in the realm of science fiction.

CNN: This is a big deal ... What's next?

Venter: People keep asking me that at various dates. I was asked that 10 years ago after sequencing the human genome - you couldn't possibly top that - so we consider this a more important accomplishment than sequencing the human genome. So, following through on that is what's next for us, and see if we can create some of these cures for the planet.

CNN: How excited were you? Did you pop champagne?

Venter: We did, but our initial emotion was more one of relief that it finally worked. You can imagine 99 percent of your experiments fail for one reason or another. This, when it finally worked, we were more relieved than excited.

CNN: What does it mean to you?

Venter: When you work on something for 15 years, it's a great sense of accomplishment. This is a demonstration of what new multidisciplinary team science is about and I couldn't be prouder of our team.

The revelation is perhaps no great surprise, given that the Vatican [exclusively administers](#) (and now [mandates](#)) Pfizer's [abortion-tainted](#) COVID-19 injection for employees, and Pope Francis has been one of the foremost promoters of COVID shots.

Pentin wrote that the meetings were confirmed by "Vatican sources" as the meetings were not included in the Vatican's daily announcements, noting also that the topics discussed were still a mystery.

LifeSiteNews contacted both the Vatican's press office and Pfizer for further comment on the meetings, but as yet has received no reply. When Pentin queried Pfizer about the meetings, he was told: *"We can't confirm or deny as, per our policy, the movements of our executives are considered confidential."* The Holy See Press Office *"did not respond to repeated requests to confirm the meetings,"* Pentin added.

U.K. author and catechist Deacon Nick Donnelly commented that the revelations explained Pope Francis' persistent promotion of the COVID-19 injections. Pfizer and Pope Francis' Vatican

Pfizer has developed a close link with the Vatican since its abortion-tainted injections have been in use there since January 2021, when Pope Francis and Pope Emeritus Benedict XVI were [among the first](#) in the sovereign state to receive one of the injections. At the time, head of the Vatican health service Dr. Andrea Arcangeli suggested the Vatican would initially be using the Pfizer vaccine, but that others would be administered subject to approval.

However, the Vatican's agreement with Pfizer is to only offer the Big Pharma's injection to employees and residents. In an unrelated report a week ago Pfizer eliminated several hundred sales positions, considered not needed with the Pfizer vaxx selling itself!

Bourla later made a public appearance at the Vatican in May 2021, [joining a host of abortion supporters](#) at the Vatican's fifth International Health Conference on "Exploring the Mind, Body & Soul."

Taking the virtual stage with CNN's Sanjay Gupta, Bourla's discussion dealt with: *"The global response to COVID-19 has been accelerated by collaboration in data sharing, research, and epidemiological surveillance. As we re-examine our global health architecture, how do we improve future rapid response and build on lessons learned around preparedness, new vaccine development and distribution and, importantly, prevention?"*

Pope Francis gave a private address to the members of the conference. It is not known whether one of his meetings with Bourla occurred at this time.

Pfizer's [production of abortion pills](#), along with its production of a COVID-19 injection involving [tests using the HEK 293 cell line](#) – derived from kidney tissue taken from a healthy baby who was aborted in the Netherlands in the 1970s – has not seemed to deter the Pontiff from meeting with Bourla.

The link between the Vatican, which solely uses Pfizer's jab, has been further strengthened as the Vatican's secretary of state, Cardinal Pietro Parolin, recently [mandated](#) a COVID jab for Vatican employees and visitors, removing the option to test "negative" for the virus, and allowing only proof of recovery from the virus as an alternative to the injection.

A mandate has been in place for some time in the Vatican for certain employees, resulting in three Swiss Guards being sent home to Switzerland after they refused to comply with the mandated shot.

In comments to the National Catholic Register about his most recent mandate, Cardinal Parolin echoed the language of Archbishop Vincenzo Paglia, and defended Pfizer's jab from those concerned about its connection to abortion.

He acknowledged that cell lines from an aborted baby were used *"in the preliminary stages of vaccine testing in the laboratory,"* but rejected any moral objection to the shot on this basis. *"Therefore, it seems that not wanting to undergo vaccination with this motivation cannot be justified, since the vaccine that is currently used is precisely the Pfizer that uses the mRNA method,"* Parolin stated.

Bourla and Francis are consistently pushing COVID shots.

At the time of the May, 2021 conference, Pfizer was hailed for creating an "effective" injection against COVID-19, and Bourla spoke of the many potential applications of the mRNA technology. In April, 2021, he had even claimed the injection was "100%" effective against the CDC's definition of "severe" COVID-19.

The data also showed the vaccine was 100% effective against severe #COVID19 as defined by @CDCgov and 95.3% effective against severe COVID-19 as defined by @US_FDA. Very reassuring news. (2/4)

However, only days ago, Bourla backtracked on the claimed efficacy of his company's jab. *"We know that the two doses of the vaccine offer very limited protection, if any,"* said Bourla in an interview with Yahoo! Finance.

Bourla instead pushed the booster jab, saying “three doses with a booster, they offer reasonable protection against hospitalization and deaths – against deaths, I think, very good, and less protection against infection.”

Speaking to the BBC in December, Bourla pushed for normalizing COVID shots, suggesting that they could be part of normal life for “years to come.”

Pope Francis has also regularly pushed for people to take the COVID shots, with his rhetoric becoming even stronger in recent days when he spoke of the “moral obligation” of taking the abortion-tainted injections. In August 2021, Francis notably joined a number of cardinals in issuing a public service announcement video, saying the shots bring “hope” of an end to the pandemic and called receiving the vaccine “an act of love.”

"I think it's nonsense," [Richardson told reporter Jeff Stein](#). He continued with this antenna-raising quote, as it relates to potential deployment of an ethno-bomb:

"Even if an ethno-bomb were developed in a petri dish, [Richardson] said, 'there's a long leap from having a mechanism to having an environmental viability, a weapon, or vector, or means of dissemination,'" he said.

Of course the Johnson & Johnson and AstraZeneca COVID-19 “vaccines” are viral vectors. J&J, specifically, uses Adenovirus 26 to deliver DNA that instructs cells to produce spike proteins.

Apartheid South Africa Origins of Ethno-Bombs

Every report on the Israeli ethno-bomb to kill Arabs said that Israeli scientists used South Africa research as the baseline. The Europeans who ruled South Africa attempted developing a biological weapon that only kills Black people in the 1980s. The above-linked UPI story says the following:

Foreign Report in October cited unnamed South African sources saying Israeli scientists used South African research in a bid to develop an ‘ethnic bullet’ against Arabs. The head of a South African chemical and biological warfare plant, Dr. Daan Goosen, said his team was ordered in the 1980s to develop a ‘pigmentation weapon’ to target only Black people. He said the team discussed spreading a disease in beer, maize or even vaccinations but never managed to develop one.

The story goes on to say that Israeli scientists discovered Arab-specific genetic traits that they could exploit with biological weapons. “The intention is to use the ability of viruses and certain bacteria to alter the DNA inside their host’s living cells,” the story says.

The good [Dr. Lee Merritt](#), in a recent broadcast with attorney Reiner Fuellmich, clarified the foregoing further. She spoke about how Australian scientists utilized “[immunogenic contraceptive](#)” technology to vastly decrease the population of mice.

The rodents were captured and injected with self-disseminating “vaccines” that kill the female ovaries. The injected mice were released back into nature, and transmitted the vaccines to other mice via shedding. It sterilized thousands of them. Dr. Merritt said that the mouse DNA vaccines were built exactly like the J&J shots. Note – the video is further down in the article, as it is referred to again.

Project Coast in South Africa

Dr. Merritt said there was no such thing as “emerging infectious diseases” until Ebola and HIV “came out of the jungles in Africa.” [Project Coast](#) was the name of the aforementioned chemical and biological weapons program in South Africa. The goal was to make these weapons so they were [untraceable and undetectable](#). They’d kill, maim and manipulate slowly so it’s more difficult to pinpoint the cause. It was reported that these weapons could not only sterilize and paralyze, but also change Black men’s personalities to be more docile, and prevent rebellions.

The aforementioned Dr. Goosen headed Project Coast. The weapons were never fully developed because Project Coast was disbanded once Nelson Mandela took power in 1994. But Dr. Goosen said, ***“the weapons placed in the wrong hands could have killed millions.”***

Who developed the COVID-19 “vaccines?”

Albert Bourla has been with Pfizer since 1993. He was promoted to Chief Operating Officer in January 2018, before being appointed CEO later that year. Thus he has been in charge of Pfizer since the so-called pandemic commenced.

Bourla frequently speaks about his [love of Israel](#) and how his parents survived World War II. In fact he [accepted the Theodor Herzl](#) award on November 9, 2021. The award was created by Herzl’s World Zionist Organization, and is [given to the most influential and important Zionist](#) in the world. In his acceptance speech, Bourla compared November 9, 1938 ([Kristallnacht](#)) to November 9, 2020 when Pfizer [announced that their mRNA injections](#) were effective against COVID-19. Dr. Mace Rothenberg was [promoted to Chief Medical Officer](#) by the new CEO Bourla in January 2019. Rothenberg [led the entire development effort](#) for Pfizer’s mRNA injections. He [quit his job at Pfizer in January 2021](#), as soon as the mRNA shots he developed were deployed on the human race. Rothenberg [is a Zionist](#). Mikael Dohlsten is the company’s Chief Scientific Officer and head of research and development. He [is a Zionist as well](#).

Tal Zaks – Moderna

Dr. Tal Zaks was appointed [Chief Medical Officer of Moderna](#) in March 2015. He was the man in charge of developing the Moderna mRNA injections. Zaks was born in Israel and served in the Israel military as a [medic and ambulance driver](#). He [frequently talks about his Israeli heritage](#), making no bones about where his loyalty lies.

Coincidentally or otherwise, Zaks stepped down from his Moderna CMO position last February, around the same time Rothenberg left Pfizer. Zaks is now a board member for [Israeli pharmaceutical company Teva](#).

There’s also Facebook, YouTube and Google. The three platforms are the primary COVID-19 and “vaccine” propaganda machines. They are owned by Mark Zuckerberg, Sergey Brin and Larry Page. [All of them are Zionists.](#)

Smoking Gun Evidence that Moderna Created SARS-CoV-2

We would never use that term lightly, as it could destroy credibility. But there is a fascinating report that this blogger will attempt to summarize and explain in layman’s terms since it is highly scientific and virtually indisputable.

First, we must give credit to Prashant Pradhan of the Department of Nuclear Medicine at Sanjay Gandhi Postgraduate Institute of Medical Sciences in Lucknow, Uttar Pradesh (India). His article also introduced this blogger to the [Basic Local Alignment Search Tool](#) (BLAST) administered by the National Institutes of Health. It took reading his article three times and toying around in BLAST for 2-3 hours to grasp the scientific truth being presented. We also had two biology professors at two different U.S. universities read Dr. Syed’s article, and asked them to refute it. Both said the research and analysis was rock solid.

But Why Would Israel Poison Their Own People With The Injections?

Two of the first 13 stories we wrote on The COVID Blog back in January 2021 were about Israel. [At least four Israelis died and 13 others developed Bell’s Palsy](#) after Pfizer mRNA injections by January 16 last year. But the more interesting story was about the Helsinki Committee for Human Rights accusing Israel of running [unauthorized human trials](#) in the country. White Europeans and Americans (except the Finnish) have 54% up-regulation of the ACE2 receptors, the highest of all humans. Thus they are the most susceptible to post-injection adverse reactions and deaths. Black Americans and Black Africans have 39% up-regulation. Dr. Merritt said Black Americans have the same 54% up-regulation as

White Americans, while Black Africans are at 39%. This blogger did not see that in the study. But Dr. Merritt is the doctor, so perhaps we missed something thereof.

There's also the December 2020 study published in the journal *'Biochemistry and Biophysics Report'*. It concluded that ACE2-K26R decrease electrostatic attraction of spike proteins. What does all this mean?

Dr. Tom McCall and Dr. Arnold Fruchtenbaum are highly-respected Bible scholars who recognize what I am sharing here with the reader.

Furthermore, many have assumed that the role of Israel ended with the coming of the Messiah of Jesus Christ. This is a false assumption. As a result, most Christians are insufficiently aware of our indebtedness to the heritage that will benefit us all in the future. This study is essential to understanding today's events in the Middle East. Although this issue of Satan against Israel has been discussed in other articles, I am going to provide the big picture as to why this is significant in the times which we live.

- ✓ When the surrounding nations tried to destroy Israel during the time of the Judges.
- ✓ When the surrounding nations tried to destroy Israel during the time of the kings.
- ✓ When the Assyrian army destroyed Israel and much of Judah.
- ✓ When the Babylonian army destroyed the Temple and Jerusalem.
- ✓ When the refugees from Babylon and Persia were restoring the Temple and Jerusalem
- ✓ When Haman attempted to destroy all the Jews throughout the Persian Empire.
- ✓ Mordecai's Triumph by Pieter Eastman Cir 1617
- ✓ When the Greco-Syrian forces tried to Hellenize Judea under Antiochus Epiphanes
- ✓ When the Roman army destroyed Judea and Jerusalem twice (70 AD and 135 AD)
- ✓ When the Jewish people were scattered and persecuted throughout the world for 2,000 years.
- ✓ When Hitler organized the Holocaust and destroyed over Six million Jews.
- ✓ When the Jews attempted to return to Israel against extensive international opposition.
- ✓ When Israel declared its independence in 1947 and was invaded by Egypt, Jordan, and Syria.
- ✓ When Israel was invaded in 1967 and 1973 by its surrounding neighbors
- ✓ When Israel was disrupted by numerous intifadas from Palestinians and Jihadists.
- ✓ When Hamas hurled thousands of rockets from Gaza into Israel in 2014.
- ✓ [The Beast system mandates a vaxx for every person on the planet] Since Israel was scattered in the Diaspora, Biblical Jews can be found living almost everywhere in the world today!]

So we can see, for 4,000 years the Jewish people have faced relentless persecution, opposition and attempts to annihilate and destroy them. If it were any of other people, it

would seem totally irrational and insane. However, with Israel, there appears to be a certain rational, though Satanic, strategy behind this animosity.

Satan is the Boss of Hollywood, the cesspool of iniquity of the world! [Hollywood's Satanic Antichrist Preparation](#).

Whereas the Bible prophesies that Jesus Christ Himself will return one day to sit upon the literal throne of David and reign over the earth triumphant from Jerusalem; the Antichrist is Satan's gimmick (substitute) for Christ, professing himself that he is the Messiah, God -(2nd Thessalonians 2:4). 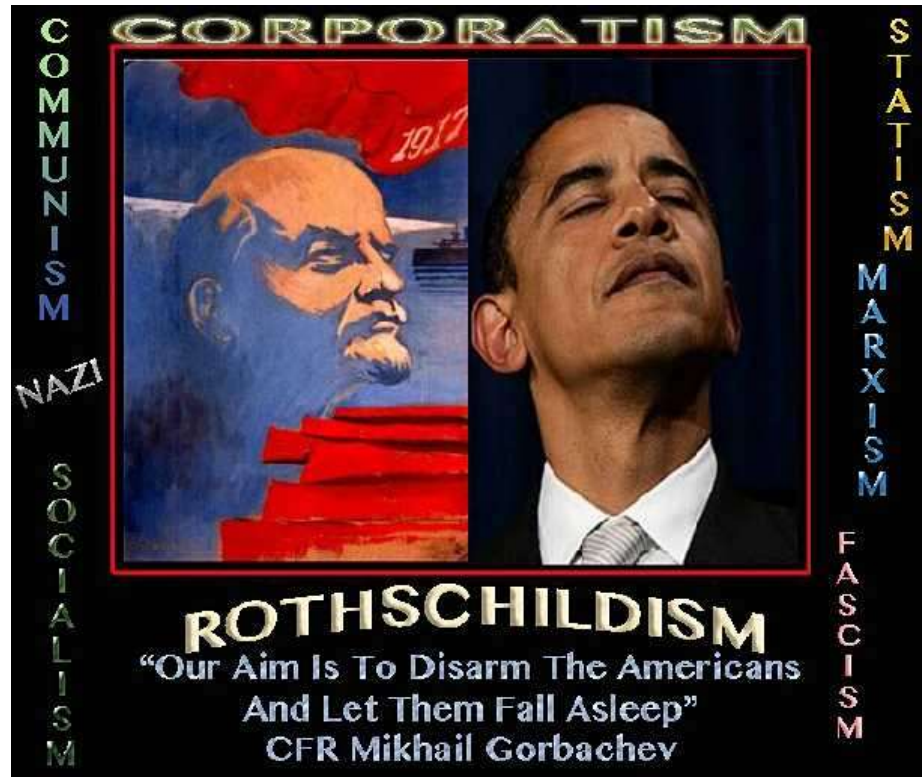

Holocaust survivors struggling to make ends meet in Israel

Ros Dayan survived horrors of Nazi persecution but now says she does not have enough money to buy food or clothes

Jewish prisoners in a Nazi concentration camp. Holocaust survivors are increasingly finding it hard to make ends meet in Israel. Despite the horrors of a childhood in the shadow of the Holocaust, Ros Dayan survived to build a life she

could be proud of in the new Jewish state of Israel.

She trained as a nurse, she sang in a choir that toured the world. She learnt Hebrew, though she never lost her central European accent. She paid her taxes and eventually bought the tiny house in Jaffa that she had rented at a subsidized rate for years. She even learned to live with the pain of three broken vertebrae, the result of an assault by a Nazi soldier.

But, now, in the last years of her life, Ros is ashamed. One of the 198,000 Holocaust survivors still alive in Israel, she is also one of the growing proportion who cannot make ends meet, who struggle with insufficient funds on a daily basis. Wiping a single tear with a shaking hand, she says: *"For the first time, I don't have enough money for food or clothes. I used to have pride, now I am ashamed."*

As Israel commemorates Holocaust Day on Thursday, Ros resents those who mourn the six million Jews that died without considering the penury of some of those still living. *"On Holocaust Day, they make a parade, those who do not know what a Holocaust is, what hunger is. The people who suffered in the Holocaust are left behind, hungry."*

According to studies, around a quarter of Holocaust survivors in Israel live below the poverty line, struggling to pay for food, heating, housing, medication and care.

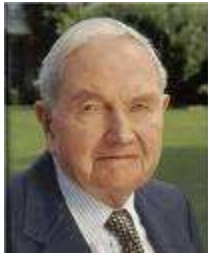

World's Most Corrupt Jab Giant

Pfizer was fined \$2.3 billion in 2009 for what was then the largest health care fraud settlement ever. The company spent over \$21.8 million in 2019–2020 and \$6.7 million from January–August 2021 on lobbying the government, making it the biggest spender of any individual drug company during the COVID-19 crisis.

Pfizer was the biggest corporate spender from 1999–2018, spending \$219 million on lobbying (93% of the industry total) and \$23 million on campaign contributions (around 10% of the industry's total giving to politicians), Church Militant earlier reported.

"I think the optics raise concerns that there could be potential financial conflicts of interests between Pfizer and the Vatican," Moy, CEO and co-founder of biotech company Cellular Engineering Technologies, said.

"If Pfizer has an exclusive contract with the Vatican for their vaccine, then there needs to be full disclosure and transparency about this contract or any other financial relationships," Moy, a faithful Catholic, insisted.

A lay-Catholic group Church Militant asked the Holy See Press Office if the Vatican would disclose agreements between Pfizer and the Holy See in the interests of transparency (as vaccine behemoths like Pfizer have disclosed only 7% of their contracts with governments and published clinical-trial protocols for just 12% of trials).

Pfizer's Secret Deals

A report by Transparency International and the University of Toronto titled "For Whose Benefit?" warns of dangerous levels of secrecy that reveal *"a disturbing trend of governments censoring key details of their [vaccine] orders from drug companies."*

Dutch politician and European Parliament member Sophie in 't Veld has asked the E.U. Parliament to release text messages between commission president Ursula von der Leyen and Bourla, noting that the secrecy violates regulation 1049/2001 (regarding public access to documents).

The optics raises concerns over potential financial conflicts of interests between Pfizer and the Vatican. Bourla and von der Leyen were in frequent contact by phone and text message for over a month while they negotiated an undisclosed deal for 1.8 billion doses of the Pfizer vaccine, according to a *'New York Times'* report.

It is not clear if Vatican City receives its Pfizer shots as part of this agreement. Pope Francis, however, enjoys close ties to von der Leyen and received her at a private meeting in May 2021, where the two discussed vaccine distribution (among other topics).

The Holy See administers only the Pfizer-BioNTech COVID-19 jab to the residents and staff of the world's smallest sovereign nation. Leaked Pfizer contracts show the company is protected from all damages and liabilities in the case of adverse effects from the shot.

"We can't confirm or deny as, per our policy, the movements of our executives are considered confidential," Pfizer told Vaticanist Edward Pentin, author of 'The Next Pope: The Leading Cardinal Candidates', refusing to reveal if Francis met Bourla in secret. There needs to be full disclosure and transparency.

Moy explained that the meeting between Francis and Bourla *"is an important issue that needs to be uncovered, since Francis and other senior Vatican leaders are touting that Catholics have a moral obligation to be vaccinated — despite the lack of vaccine effectiveness and safety concerns of Pfizer's vaccine."*

Abortion-tainted Jab is Junk

The scientist's words come in the wake of Bourla's [admission](#) that two doses of his company's vaccine may not be effective at preventing the omicron variant of COVID-19.

Last week, at a health care conference hosted by J.P. Morgan, Bourla commented: *"The two doses, they're not enough for omicron. The third dose of the current vaccine is providing quite good protection against deaths and decent protection against hospitalizations."*

The revelations also follow Vatican secretary of state Cardinal. Pietro Parolin's granting an ["abortion absolution"](#) exclusively to the Pfizer jab, pursuant to his claim that Pfizer used *"cell lines from aborted fetuses only in the preliminary stages of vaccine testing in the laboratory, but no cell lines from aborted fetuses are included in either the composition or production."*

Lying Pfizer Gets Busted

Despite a devastating [Project Veritas](#) exposé of top company officials and leaked emails revealing Pfizer uses aborted fetal tissue in its vaccine program, Parolin refused to grant religious exemptions on grounds of conscientious objections to the abortion-tainted jab.

Pfizer's own [stem-cell-research policy](#) acknowledges Pfizer has been using human embryonic stem cells in its research which *"may provide even greater potential due to their increased ability for self-renewal and capacity to form a wide variety of cells and tissues."*

All Vatican employees are currently forced to get vaccinated or show proof of recovery from COVID-19. Failure to do so will be considered *"unjustified absence with the consequent suspension of pay for the duration of the absence."*



Francis welcomes E.U. President Ursula van der Leyen to the Vatican

From Jan. 31, all visitors and staff will have to get the booster as a condition of entry to the Vatican. The mandate extends to all Holy See personnel and to all its institutions within the extra-territorial areas of the Vatican.

"Pope Francis' rhetoric is inconsistent with the December 2020 statement from the Congregation for the Doctrine of Faith that vaccine acceptance should be voluntary," Dr. Moy told Church Militant.

China Bribes Vatican

Meanwhile, the hush-hush parleys between the pope and Pfizer are reigniting speculation over the Vatican's secret concordat with China — renewed by Cardinal. Parolin in October 2020 despite fierce global opposition condemning it as a *"deal with the Devil."*

The two doses, they're not enough for omicron.

Months before Parolin renewed the deal, exiled dissident Guo Wengui accused the Vatican of receiving \$1.6 billion every year since 2014 in bribes from the Chinese Communist Party because Beijing *"wanted the Vatican to shut up about China's religion policies."*

Wengui also claimed the Chinese government was paying the Holy See \$100 million before 2014. The tycoon did not specify when the payments initially started. Beijing has branded Wengui an attention-seeking criminal. But the Vatican has yet to deny the allegations.

After Bourla's second meeting with Francis, the vaccine oligarch struck a \$70 million deal with Shanghai-based biotech giant LianBio and invested \$200 million in Hong Kong-based CStone Pharmaceuticals.

In Dec. 2021, a leaked database of registered members of the CCP exposed a mass communist infiltration of American companies, including 69 infiltrators in four Pfizer branches in Shanghai. Pfizer did not respond to press inquiries for comment.

Rome's Elitist Club

Francis and Bourla also have close links to the [World Economic Forum](#) — the elite Davos club of transnational globalists pushing the "[Great Reset](#)" that seeks to "subdue all of humanity, imposing coercive measures with which to drastically limit individual freedoms and those of entire populations," [according](#) to whistleblower Archbishop. Carlo Maria Viganò.

The WEF lists [Pope Francis](#) and [Albert Bourla](#) as "agenda contributors" on its website. Bourla also serves as co-chair of the WEF task force working for "[a great reset in health care](#)." The WEF [praises](#) Francis for "*put[ting] his stamp on efforts to shape what's been termed a "great reset" of the global economy in response to the devastation of COVID-19.*"

In May 2021, the Vatican featured Bourla as a key speaker at its conference on global health. Faithful Catholics were outraged after it became known that the gig was partly funded by the Mormon cult and vaccine-maker Moderna. The Vatican did not list Pfizer as a co-sponsor but noted that some of its benefactors had "*asked to remain anonymous.*"

Bourla Benefits Bigtime

Leading Catholics have expressed concern over the pontiff's habit of cozying up to the world's elites — despite world oligarchs' piggybacking on the pandemic to enrich themselves to the tune of billions of dollars.

In November 2021, Bourla, who has led Pfizer since early 2019, sold \$5.6 million in shares on the same day the drug giant announced positive early data on its China-virus vaccine, according to a filing with the Securities and Exchange Commission.

Pfizer compensated Bourla, a Greek-born Sephardic Jew, with a total pay package of \$21-million last year — a 17% increase from before the pandemic (when Bourla's compensation in 2019 was a total of \$17.9 million).

A newly published Oxfam report slams the vaccine monopolies held by Pfizer, BioNTech and Moderna for creating five new billionaires during the pandemic and allowing their corporations to make over \$1,000 *per second* in profit.

While Pope Francis often rails against capitalism, he has remained silent on the corruption of Big Pharma and the emergence of a plutocracy as a result of the pandemic.

Swiss Olympic Sprinter Gets Pericarditis After Pfizer Booster, 22,193 Deaths After COVID Shots Reported to CDC

VAERS data released Friday by the Centers for Disease Control and Prevention included a total of **1,053,830 reports of adverse events** from all age groups following COVID vaccines, including **22,193 deaths** and **174,864 serious injuries** between Dec. 14, 2020, and Jan. 14, 2022. [The true numbers of each category may be as high as 40X what is reported on the weekly report.]

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of [1,053,830 reports of adverse events](#) following COVID vaccines were submitted between Dec. 14, 2020, and Jan. 14, 2022, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of [22,193 reports of deaths](#) — an increase of 448 over the previous week — and [174,864 reports of serious injuries](#), including deaths, during the same time period — up 4,418 compared with the previous week.

Excluding “[foreign reports](#)” to VAERS, [732,883 adverse events](#), including [10,162 deaths](#) and [66,059 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and Jan. 14, 2022.

[Foreign reports](#) are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product's labeling, the manufacturer is required to submit the report to VAERS.

† Because some cases have multiple vaccinations and symptoms, a single case can account for multiple entries in this table. This is the reason why the Total Count is greater than totalized (the number of cases found), and the Total Percentage is greater than 100.

Of the 10,162 U.S. [deaths reported](#) as of Jan. 14, 19% occurred within 24 hours of vaccination, 24% occurred within 48 hours of vaccination and 61% occurred in people who experienced an [onset of symptoms](#) within 48 hours of being vaccinated.

In the U.S., 525.2 million COVID vaccine doses had been administered as of Jan. 14, [including](#) 307 million doses of Pfizer, 200 million doses of Moderna and 18 million doses of Johnson & Johnson (J&J).

Every Friday, [VAERS](#) publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Historically, VAERS has been shown to report only [1% of actual vaccine adverse events](#).

U.S. VAERS data from Dec. 14, 2020, to Jan. 14, 2022, for 5- to 11-year-olds show:

- [6,722 adverse events](#), including [147 rated as serious](#) and [3 reported deaths](#).

The most recent death involves a 7-year-old girl (VAERS I.D. [1975356](#)) from Minnesota who died 11 days after receiving her first dose of Pfizer's COVID vaccine when she was found unresponsive by her mother. An autopsy is pending.

- [14 reports](#) of myocarditis and pericarditis (heart inflammation).
- [22 reports](#) of blood clotting disorders.

U.S. VAERS data from Dec. 14, 2020, to Jan. 14, 2022, for 12- to 17-year-olds show:

- [27,205 adverse events](#), including [1,559 rated as serious](#) and deaths. The most recent death involves a 15-year-old girl from Minnesota (VAERS I.D. [1974744](#)), who died 177 days after receiving her second dose of Pfizer from a pulmonary embolus. An autopsy is pending.
- [65 reports](#) of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death — with 96% of cases attributed to [Pfizer's vaccine](#).
- [594 reports](#) of myocarditis and pericarditis with [583 cases](#) attributed to Pfizer's vaccine.
- [152 reports](#) of blood clotting disorders, with all cases attributed to Pfizer.

U.S. VAERS data from Dec. 14, 2020, to Jan. 14, 2022, for all age groups combined, show:

- 19% of deaths were related to cardiac disorders.
- 54% of those who died were male, 41% were female and the remaining death reports did not include the gender of the deceased.
- The [average age](#) of death was **72.7**.
- As of Jan. 14, [4,879 pregnant women](#) reported adverse events related to COVID vaccines, including 1,560 reports of [miscarriage or premature birth](#).
- Of the [3,450 cases of Bell's Palsy](#) reported, 51% were attributed to [Pfizer](#) vaccinations, 40% to [Moderna](#) and 8% to [J&J](#).
- 849 reports of [Guillain-Barré syndrome](#) (GBS), with 41% of cases [attributed to Pfizer](#), 30% to [Moderna](#) and 28% to [J&J](#).
- [2,272 reports](#) of anaphylaxis where the reaction was life-threatening, required treatment or resulted in death.
- [1,522 reports](#) of myocardial infarction.
- [12,543 reports](#) of blood clotting disorders in the U.S. Of those, [5,574 reports](#) were attributed to Pfizer, [4,455 reports](#) to Moderna and [2,467 reports](#) to J&J.
- [3,761 cases](#) of myocarditis and pericarditis with [2,316 cases](#) attributed to Pfizer, [1,271 cases](#) to Moderna and [162 cases](#) to J&J's COVID vaccine.

40% rise nationwide in excess deaths among 18- to 49-year-olds, CDC Data Show
Death certificate data from the CDC [show excess deaths](#) increased by more than 40% among Americans 18 to 49 years old during a 12-month period ending in October 2021,

compared to the same time period in 2018-2019 before the pandemic. COVID caused only about 42% of those deaths.

Excess deaths are defined as the difference between the observed number of deaths during a specific time frame and the expected number of deaths during that same period.

State-level data for the same 12-month period also show increases. For example, in Nevada, excess deaths were as high as 65%, with COVID accounting for only 36%. The District of Columbia saw an increase of 72% — with COVID not being a factor in any of the deaths.

Increases in excess deaths were most noticeable in the Midwest and western and southern states, while states seeing the lowest increases were primarily from the Northeast.

Swiss Olympic sprinter gets pericarditis after Pfizer's COVID booster

In a Jan. 17 [social media post](#), Swiss Olympic sprinter Sarah Atcho said she is [experiencing pericarditis](#) after receiving a Pfizer booster shot.

On Dec. 22, Atcho received a booster because she “didn’t want to struggle with this when the season started” and was told it was safer to get Pfizer — even though she had Moderna the first time — to avoid cardiac side effects.

On Dec. 27, Atcho said she started experiencing tightness in her chest and felt dizzy while walking. A cardiologist diagnosed Atcho with pericarditis — inflammation of the thin membrane that surrounds the heart.

Atcho is not allowed to get her heart rate up for several weeks to allow her heart to rest and heal from the inflammation. Said she is upset nobody talks about the “heavy side-effects” young and healthy people are experiencing after receiving COVID vaccines.

Experts call on UK regulators to reassess COVID vaccines for 12- to 15-year-olds

In a letter to the UK’s Joint Committee on Vaccines and Immunization, more than 30 politicians, doctors and medical experts in immunology [asked UK regulators](#) to overhaul the country’s COVID vaccine rollout for 12- to 15-year-olds based on new data showing a high risk of [myocarditis](#) in that age group.

The experts said data proved “for males under 40, risk of myocarditis was up to 14 times higher after vaccination than after infection” and the risk of myocarditis in young men and boys increased “significantly after a second dose of the vaccine.

They also argued vaccines are less effective “at stemming the transmission of [Omicron](#) compared to [Delta](#)” and therefore there may be few advantages to exposing young people to the potential increased risks and long-term harm.

Prior COVID infection more protective than vaccination during Delta wave

People with a history of previous COVID infection were better protected against infection and related hospitalization during periods of predominantly Alpha and Delta variant transmission, suggesting [natural immunity was more protective](#) against the variants than vaccines, [according to the CDC](#).

New data released Wednesday by the CDC showed people who survived a previous infection had lower rates of COVID than people who were vaccinated alone.

Hospitalization rates were also lower among people who had recovered from COVID than among those who had been vaccinated.

[For the study](#), health officials in California and New York gathered data from May through November 2021, which included the period when the Delta variant was dominant. The agency said there were limitations to the study and results were not applicable to the new Omicron variant.

However, the agency concluded vaccination “remains the safest and primary strategy to prevent SARS-CoV-2 infections, associated complications and onward transmission,” due to the risks associated with COVID infection.

The agency did not compare the risks of infection in those with and without underlying medical conditions and did not analyze the risks associated with vaccinating those with a history of previous COVID infection.

Major businesses, attorneys general, respond to Supreme Court ruling

The U.S. Supreme Court’s [ruling](#) last week striking down the Biden administration’s vaccine-or-test mandate for private businesses has left many companies scrambling to decide whether they should abandon the mandate or force their employees to be vaccinated anyway while the case plays out in the lower courts.

As [The Defender reported today](#), Starbucks was the first major business to announce it would not enforce its COVID vaccine mandate against employees in light of the Supreme Court’s ruling, while Carhartt CEO Mark Valade announced in an [email](#) to staff the company’s vaccine mandate for its 3,000 U.S. employees would remain in place.

Both decisions sparked backlash on social media with calls to boycott both companies.

Meanwhile, a coalition of attorneys general from 27 states is calling on the Occupational Safety and Health Administration to rescind its Emergency Temporary Standard for private businesses with more than 100 employees because it lacks the authority to issue a broad vaccine mandate.

The CDC has only ever tested MMR and Thimerosal for a link to autism. The remaining 15 vaccines and 37 common ingredients remain untested for links to autism.



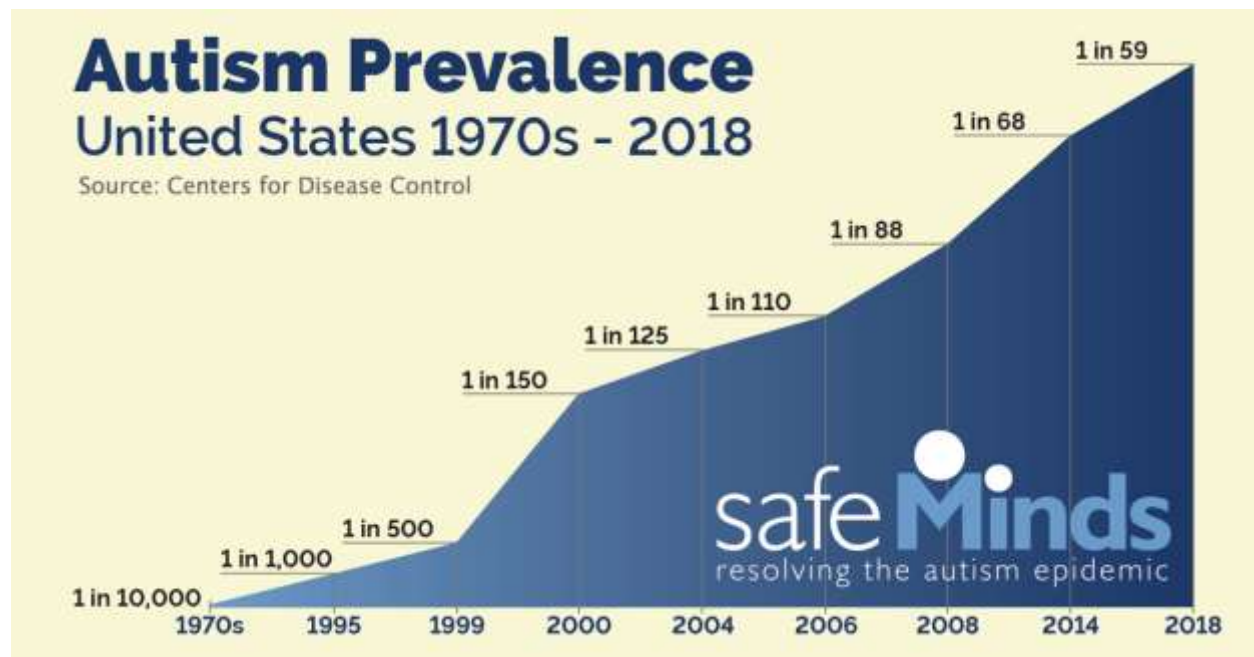
