NEW study reveals COVID jab triggers unwanted changes in human physiology

In the latest round of updated COVID-19 data that the mainstream media might be reluctant to share, a recent study straight out of Ground Zero – the Wuhan Institute of Virology (WIV) in Wuhan, China – has revealed that getting the COVID shot has a "consistent" effect on someone's immune health.

The effect? Making a person's immune system more vulnerable. As public health officials continue to ramp up their COVID test and N95 disbursement efforts, let's pay close attention to when and whether evidence like this will be properly acknowledged and discussed.

CAUTION: Getting the COVID shot causes "consistent pathophysiological alterations" in the human immune system.

The study in question was published in October 2021 in Cell Discovery and conducted by Chinese researchers from WIV.

It's important to know in this case, the researchers used a vaccine available in China called VeroCell. According to the World Health Organization (WHO), VeroCell "is an inactivated vaccine ... which [stimulates] the production of antibodies and [makes] the body ready to respond to an infection with live SARS-CoV-2. This vaccine is adjuvanted (with aluminum hydroxide), to boost the response of the immune system."

While the WIV study is small and includes only 11 participants, it did generate some alarming conclusions regarding COVID shot safety. By assessing kidney function, blood work, and other metrics in the participants, the researchers determined that the shots clearly "mimicked an infection" with SARS-CoV-2 and led to "consistent alterations in gene expression of many different immune cell types."

"These data," the authors write, "suggested that after vaccination, at least by day 28, other than generation of neutralizing antibodies, people's immune systems, including those of lymphocytes and monocytes were perhaps in a more vulnerable state."

They continue (with our emphasis added): "Our study postulates that it is imperative to consider the potential long-term impact of vaccination to certain medical conditions or to general human health."

This study also adds context to the official position of the European Medicines Agency (EMA), who earlier this month stated that repeated COVID booster shots could impair immune response and lack feasibility as a public health measure.

Growing evidence of negative immune health effects caused by COVID shot raises yet another important ethical question that public health officials seem unwilling to address.

Let's unpack this scenario a bit more clearly:

Here we have one of several scientific studies presenting evidence that COVID shots – which currently lack any and all long-term safety data – are associated with "dramatic changes in immune cell gene expression" that could actually impair a person's immunity, especially if that person has one or more chronic health conditions.

Next, we need to consider an interesting trend in drug studies:

Usually, only young and healthy volunteers are recruited to participate in clinical drug trials that purport to assess the safety and efficacy of a drug (as was the case for this study from WIV). Yet the majority of people who would be expected to take the drug – including a whopping 6 in 10 American adults with at least one chronic disease and nearly 43% of American adults with obesity, according to the U.S. Centers for Disease Control and Prevention (CDC) – are either older than 65 or not healthy by most definitions.

This brings up an important question:

If a growing amount of evidence suggests that COVID shots could plausibly cause longterm harm to immune health, particularly in people with chronic health conditions, isn't it unethical to coerce American citizens into taking them since the majority of these citizens live with at least one chronic health issue?

Heart disease, cancer, kidney disease, Alzheimer's disease, and chronic lung disease are rampant in this country. Shouldn't individuals living with these conditions get to choose whether they want to take their chances on the COVID shot in the hopes that the benefits of the drug will outweigh the risks? And regardless of health status or age, shouldn't everyone get to make that risk assessment for themselves and their children?

It truly has never been more important to improve your overall health and the health of your loved ones.

Data shows more than forty percent of hospitalizations in New York City are NOT due to COVID

As the world rounds the corner into the third year of the highly politicized coronavirus pandemic, it seems clear that people on both sides of the political aisle are becoming weary of the mitigation measures and suspicious of the shifting narratives. And even in places like New York – where lockdowns, vax mandates, school closures, and other obvious power grabs are rampant and quickly becoming normalized – state officials appear to be changing their tune to help explain their abject failure in "slowing the spread."

From acknowledging the truth behind COVID-positive hospitalization rates to clarifying the cause of death for the hundreds of thousands of Americans who have died over the past two years with a COVID diagnosis, the changing messages echo what "conspiracy theorists" have been saying since the beginning.

Significant proportion of COVID-positive Americans admitted to the hospital right now are admitted for reasons OTHER than COVID-19

In a January 7, 2022 news conference, New York Governor Kathy Hochul acknowledged that more than 40% of the state's current COVID+ hospitalized patients are admitted with COVID-19, not for COVID-19. The ratio between hospitalized "with" and hospitalized "for" COVID-19 appears to vary across the state, with nearly 80% of COVID-positive patients in central New York admitted "with" while the split is closer to "50-50" in New York City.

Hochul released these numbers publicly after calling on hospitals in the state to begin clarifying the reasons for patient hospitalization – finally.

"Think of all the other reasons people end up in a hospital," Governor Hochul said, mentioning car accidents, drug overdoses, and heart attacks (no mention, of course, of hospitalizations due to adverse effects from the Pfizer, Moderna, and Johnson & Johnson COVID shots). It's a good point – and a point that critics of the state and national government overreach have been saying for months.

Why admit this now? Why take so long to be forthcoming about what has been so evident to so many? Why have officials for so long denied the reality that testing everyone for COVID-19 – even if they are asymptomatic or hospitalized for a completely unrelated reason – could artificially bloat the hospitalization rates and therefore sway the fear and alarmist attitude surrounding the pandemic?

A tough pill to swallow

This is not to suggest that SARS-CoV-2 hasn't hit people hard. Indeed, it has caused many Americans serious illness, suffering, and even death. But to finally acknowledge that there is nuance behind the "cases" in our country, or that the cause of death for some COVID-positive victims (most of whom have 3 to 4 comorbidities, according to the U.S. Centers for Disease Control and Prevention) has little to nothing to do with COVID itself, is something that seems almost too-little-too-late to admit to the public.

New York is not alone in this "with vs. for" trend. On January 10, New Jersey Governor Phil Murphy announced that the Garden State has more than 6,000 COVID-positive people in hospitals. Fewer than half were actually admitted for coronavirus.

It's worth noting that this is the first time New Jersey has surpassed 6,000 COVID-positive hospitalizations since April 2020 ... back when the mRNA COVID shot wasn't available.

Who Owns Big Pharma + Big Media? You'll Never Guess.

- <u>Big Pharma</u> and mainstream media are largely owned by two asset management firms: <u>BlackRock and Vanguard</u>.

- Vanguard and BlackRock are the top two owners of Time Warner, Comcast, Disney and News Corp, four of the six media companies that control more than 90% of the U.S. media landscape.
- BlackRock and Vanguard form a secret monopoly that own just about everything else you can think of too. In all, they have ownership in 1,600 American firms, which in 2015 had combined revenues of \$9.1 trillion. When you add in the thirdlargest global owner, State Street, their combined ownership encompasses nearly 90% of all S&P 500 firms.
- Vanguard is the largest shareholder of BlackRock. Vanguard itself, on the other hand, has a unique structure that makes its ownership more difficult to discern, but many of the oldest, richest families in the world can be linked to Vanguard funds.

What do 'The New York Times' and a majority of other legacy media have in common with Big Pharma? Answer: They're largely owned by BlackRock and the Vanguard Group, the two largest asset management firms in the world. Moreover, it turns out these two companies form a secret monopoly that owns just about everything else you can think of too. As reported in the featured video:

"The stock of the world's largest corporations is owned by the same institutional investors. They all own each other. This means that 'competing' brands, like Coke and Pepsi aren't really competitors, at all, since their stock is owned by exactly the same investment companies, investment funds, insurance companies, banks and in some cases, governments."

"The smaller investors are owned by larger investors. Those are owned by even bigger investors. The visible top of this pyramid shows only two companies whose names we have often seen ... They are Vanguard and BlackRock."

"The power of these two companies is beyond your imagination. Not only do they own a large part of the stocks of nearly all big companies but also the stocks of the investors in those companies. This gives them a complete monopoly."

"A Bloomberg report states that both these companies in the year 2028, together will have investments in the amount of 20 trillion dollars. That means that they will own almost everything."

Who is the Vanguard?

The word "vanguard" means "the foremost position in an army or fleet advancing into battle," and/or "the leading position in a trend or movement." Both are fitting descriptions of this global behemoth, owned by globalists pushing for a <u>Great Reset</u>, the core of which is the transfer of wealth and ownership from the hands of the many into the hands of the very few.

Interestingly, Vanguard is the <u>largest shareholder</u> of <u>BlackRock</u>, as of March 2021. Vanguard itself, on the other hand, has a "unique" corporate structure that makes its ownership more difficult to discern. It's owned by its various funds, which in turn are owned by the shareholders. Aside from these shareholders, it has <u>no outside investors</u> and is not publicly traded. As <u>reported</u> in the <u>featured</u> video:

"The elite who own Vanguard apparently do not like being in the spotlight but of course they cannot hide from who is willing to dig. Reports from Oxfam and Bloomberg say that 1% of the world, together owns more money than the other 99%. Even worse, Oxfam says that 82% of all earned money in 2017 went to this 1%."


"In other words, these two investment companies, Vanguard and BlackRock hold a monopoly in all industries in the world and they, in turn, are owned by the richest families in the world, some of whom are royalty and who have been very rich since before the Industrial Revolution."

While it would take time to sift through all of Vanguard's funds to identify individual shareholders, and therefore owners of Vanguard, a quick look-see suggests Rothschild Investment Corp., and the Edmond De Rothschild Holding is two such stakeholders. Keep the name Rothschild in your mind as you read on, as it will feature again later.

The video above also identifies the Italian Orsini family, the American Bush family, the British Royal family, the du Pont family, the Morgans, Vanderbilts and Rockefellers, as Vanguard owners.

BlackRock/Vanguard own Big Pharma.

According to Simply Wall Street, in February 2020, BlackRock and Vanguard were the two largest shareholders of GlaxoSmithKline, at 7% and 3.5% of shares respectively. At <u>Pfizer</u>, the ownership is reversed, with Vanguard being the top investor and BlackRock the second-largest stockholder.



Keep in mind that stock ownership ratios can change at any time, since companies buy and sell on a regular basis, so don't get hung up on percentages. The bottom line is that BlackRock and Vanguard, individually and combined, own enough shares at any given time that we can say they easily control both Big Pharma and the centralized legacy media — and then some.

Why does this matter? It matters because drug companies are driving COVID-19 responses — all of which, so far, have endangered rather than optimized public health — and mainstream media have been willing accomplices in spreading their propaganda, a false official narrative that has, and still is, leading the public astray and fosters feat based on lies.

To have any chance of righting this situation, we must understand who the central players are, where the harmful dictates are coming from, and why these false narratives are being created in the first place.

As <u>noted in Global Justice Now's</u> December 2020 report "The Horrible History of Big Pharma," we simply cannot allow drug companies — "which have a long track record of prioritizing corporate profit over people's health" — to continue to dictate <u>COVID-19</u> responses.

In it, they review the shameful history of the top seven drug companies in the world that are now developing and manufacturing drugs and gene-based "vaccines" against COVID-19, while mainstream media have helped suppress information about readily available older drugs that have been shown to have a high degree of efficacy against the infection.

BlackRock/Vanguard own the media

When it comes to 'The New York Times', as of May 2021, BlackRock is the <u>second-largest stockholder</u> at 7.43% of total shares, just after The Vanguard Group, which owns the <u>largest portion</u> (8.11%).

In addition to The New York Times, Vanguard and BlackRock are also the top two owners of Time Warner, Comcast, Disney and News Corp, four of the <u>six media companies</u> that control more than 90% of the <u>U.S. media landscape</u>.

Needless to say, if you have control of this many news outlets, you can control entire nations by way of carefully orchestrated and organized centralized propaganda disguised as journalism.



If your head is spinning already, you're not alone. It's difficult to describe circular and tightly interwoven relationships in a linear fashion. The world of corporate ownership is labyrinthine, where everyone seems to own everyone, to some degree.

However, the key take-home message is that two companies stand out head and neck above all others, and those are BlackRock and Vanguard. Together, they form a hidden monopoly on global asset holdings, and through their influence over our centralized media, they have the power to manipulate and control a great deal of the world's economy and events, and how the world views it all.

Considering BlackRock in 2018 <u>announced</u> that it has "social expectations" from the companies it invests in, its potential role as a central hub in the Great Reset and the "build back better" plan cannot be overlooked.



BlackRock/Vanguard also own shares of a long list of other companies, including Microsoft, Apple, Amazon, Facebook and Alphabet Inc. As illustrated in the graphic of BlackRock and Vanguard's ownership network below, featured in the 2017 article "These Three Firms Own Corporate America" in The Conversation, it would be near-impossible to list them all.

In all, BlackRock and Vanguard have ownership in some 1,600 American firms, which in 2015 had combined revenues of \$9.1 trillion. When you add in the third-largest global owner, State Street, their <u>combined ownership</u> encompasses nearly 90% of all S&P 500 firms.



A global monopoly few know anything about

To tease out the overarching influence of BlackRock and Vanguard in the global marketplace, be sure to watch the 45-minute-long video featured at the top of this article. - Pulmonary embolisms: a 467% increase
- Myocardial infarction: a 269% increase
- Bell's palsy: a 291% increase

- Miscarriages: a 300% increase in 2021 over the five-year average. The five-year average was 1,499 codes for miscarriages per year. During the first 10 months of 2021, it was 4,182.
- Congenital malformations (for children of military personnel): a 156% increase
- Female infertility: a 471% increase

DMED is quite literally an epidemiological surveillance program designed for the express purpose of detecting surges in illness and injury to make sure the military is combat-ready. It's about national security even more than public health. Why would the military not have blown the whistle and warned the CDC right away about this data? On the military health system website, the Armed Forces Health Surveillance Division (AFHSD) is described as "the central epidemiologic resource for the U.S. Armed Forces, conducting medical surveillance to protect those who serve our nation in uniform and allies who are critical to our national security interests."

To date, over 80% of US residents over the age of 5 have gotten at least one dose of a vaccine, while nearly 68% are fully vaccinated.



Children 2-4 years old will require three shots of the Pfizer COVID-19 vaccine, Dr. Anthony Fauci said Wednesday after a previous trial failed to establish the shots' efficacy in young people.

"It turned out that the other dose, namely the other group, from 24 months to four years did not yet reach the level of non-inferiority, so the studies are continued," said Fauci, the director of the National Institute of Allergy and Infectious Diseases and the chief medical adviser to President Joe Biden. "It looks like it will be a three-dose regimen. I don't think we can predict when we will see an [emergency use authorization] with that because the company is still putting the data before the FDA."

Clinical trials of the Pfizer vaccine in children under five are underway. One trial is testing the efficacy and safety of the shots in children between the ages of 6 months and 2 years, as well as a study in children 2 to 4 years old. Pfizer announced last month that children between the ages of 2 and 5 did not mount an adequate immune response after receiving two full doses of the vaccine and that it would begin testing a third low dose for children under 5 to be taken two months after the second dose.


"We make recommendations based on the scientific data (sic)."

Nearly 35,000 Reports of COVID Vaccine Injuries Among 5- to 17-Year-Olds, CDC Data Show

VAERS data released Friday by the Centers for Disease Control and Prevention included a total of **1,071,856** reports of adverse events from all age groups following COVID vaccines, including **22,607** deaths and **178,994** serious injuries between Dec. 14, 2020, and Jan. 21, 2022. The Centers for Disease Control and Prevention (CDC) today released new data showing a total of 1,071,856 reports of adverse events following COVID vaccines were submitted between Dec. 14, 2020, and Jan. 21, 2022, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of <u>22,607 reports of deaths</u> — an increase of 414 over the previous week — and <u>178,994 reports of serious injuries</u>, including deaths, during the same time period — up 4,130 compared with the previous week.

Excluding "<u>foreign reports</u>" to VAERS, <u>740,000 adverse events</u>, including <u>10,316 deaths</u> and <u>67,496 serious injuries</u>, were reported in the U.S. between Dec. 14, 2020, and Jan. 21, 2022.

<u>Foreign reports</u> are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product's labeling, the manufacturer is required to submit the report to VAERS.

Of the 10,316 U.S. <u>deaths reported</u> as of Jan. 21, 19% occurred within 24 hours of vaccination, 24% occurred within 48 hours of vaccination and 61% occurred in people who experienced an <u>onset of symptoms</u> within 48 hours of being vaccinated.

In the U.S., 532.4 million COVID vaccine doses had been administered as of Jan. 21, <u>including</u> 312 million doses of Pfizer, 202 million doses of Moderna and 19 million doses of Johnson & Johnson (J&J).

Every Friday, <u>VAERS</u> publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Historically, VAERS has been shown to report only <u>1% of actual vaccine adverse events</u>.

U.S. VAERS data from Dec. 14, 2020, to Jan. 21, 2022, for 5- to 11-year-olds show:

- 7,052 adverse events, including 152 rated as serious and 3 reported deaths. The most recent death involves a 7-year-old girl (VAERS I.D. 1975356) from Minnesota who died 11 days after receiving her first dose of Pfizer's COVID vaccine when she was found unresponsive by her mother. An autopsy is pending.
 - <u>14 reports</u> of myocarditis and pericarditis (heart inflammation).
 - 24 reports of blood clotting disorders.

U.S. VAERS data from Dec. 14, 2020, to Jan. 21, 2022, for 12- to 17-year-olds show:

- <u>27,772 adverse events</u>, including <u>1,588 rated as serious</u> and <u>37 reported deaths</u>. The most recent deaths involve a 13-year-old male (VAERS I.D. <u>2042005</u>) from an unidentified state who died from a sudden heart attack seven months after receiving his second dose of Moderna, and a 17-year-old female from an unidentified state (VAERS I.D. <u>2039111</u>) who died after receiving her first dose of Moderna. Medical information was limited and it is unknown if an autopsy was performed in either case.
 - <u>68 reports</u> of anaphylaxis among 12- to 17-year-olds where the reaction was lifethreatening, required treatment or resulted in death — with 96% of cases attributed to Pfizer's vaccine.
 - 609 reports of myocarditis and pericarditis with 597 cases attributed to Pfizer's vaccine.
 - 154 reports of blood clotting disorders, with all cases attributed to Pfizer.

U.S. VAERS data from Dec. 14, 2020, to Jan. 21, 2022, for all age groups combined. show:

- 21% of deaths were related to cardiac disorders.
- 54% of those who died were male, 41% were female and the remaining death reports did not include the gender of the deceased.
- The average age of death was 72.7.
- As of Jan. 21, 4,925 pregnant women reported adverse events related to COVID vaccines, including 1,575 reports of miscarriage or premature birth.
- Of the <u>3,474 cases of Bell's Palsy</u> reported, 51% were attributed to <u>Pfizer</u> vaccinations, 41% to <u>Moderna</u> and 8% to <u>J&J</u>.

Unvaccinated man denied heart transplant by Boston hospital

DJ Ferguson, 31, was <u>removed</u> from the top of a heart transplant at Boston's Brigham and Women's Hospital because he was not vaccinated against COVID.

Ferguson on Tuesday <u>received a mechanical heart pump</u> — called a left ventricular assist device — that should keep him alive for up to five years, but he won't have much of a life, his father said.

According to <u>ABC News</u>, Ferguson, a father of two children with another baby on the way, didn't want the vaccine because he feared it would complicate his heart condition. He also said <u>getting vaccinated</u> would go against his basic principles.

"The organs are scarce, we are not going to distribute them to someone who has a poor chance of living when others who are vaccinated have a better chance post-surgery of surviving," Dr. Arthur Caplan, who runs Medical Ethics at NYU Grossman School of Medicine told MassLive.

Despite the open-heart surgery, Ferguson still <u>needs a transplant</u> due to his rapid deterioration, Ferguson's parents told "Tucker Carlson Tonight" on Wednesday.

COVID vaccine regime for children under age 4 will include 3 doses, Fauci says White House chief medical advisor Dr. Anthony Fauci on Wednesday said the COVID vaccine regime for kids younger than 4 years old will likely include three doses when it's authorized because two shots did not induce an adequate immune response in 2- to 4-year-olds in Pfizer's clinical trials.

"Dose and regimen for children 6 months to 24 months worked well, but it turned out the other group from 24 months to 4 years did not yet reach the level of non-inferiority, so the studies are continued," Fauci said, referencing effectiveness standard comparison to adults.

Fauci said he hopes the U.S. Food and Drug Administration will authorize the Pfizer and BioNTech COVID vaccine for children under 5 years old next month, although he can't say for sure when the agency will render its decision.

Sweden decides against COVID vaccines for children 5 to 11

Sweden won't recommend COVID vaccines for kids under 12 years old because the benefits did not outweigh the risks, but will "constantly" reassess the situation, Reuters reported.

The Public Health Agency of Sweden <u>said in a press release</u> on Thursday the medical benefit for a child aged 5-11 who has received a vaccine against COVID "is currently small."

Britta Bjorkholm, a Sweden health official, said during a news conference, "With the knowledge we have today, with a <u>low risk</u> for serious disease for kids, we don't see any clear benefit with vaccinating them."

Karin Tegmark Wisell, director-general of the Public Health Agency of Sweden, said updated guidance would be provided prior to the fall term.

COVID vaccines causing miscarriages, cancer, neurological disorders among Military

In a <u>hearing</u> organized this week by Sen. Ron Johnson (R-Wis.), attorney Thomas Renz told a panel of experts data provided to him by three whistleblowers show COVID vaccines are causing catastrophic harm to members of the U.S. military while not preventing them from getting the virus.

Renz summarized data obtained from the Defense Medical Epidemiology Database — the military's longstanding epidemiological database of service members.

The data show miscarriages and cancer increased 300% in 2021 over the previous five-year average. Neurological disorders increased 1000% in 2021 over the past five-year average, increasing from 82,000 to 863,000 in one year.

"Our soldiers are being experimented on, injured and sometimes possibly killed," Renz said.

Following Renz's presentation, attorney Leigh Dundas reported evidence of the DOD doctoring data in DMED to conceal cases of myocarditis in service members vaccinated for COVID.

OSHA withdraws **COVID** vaccine mandate

The U.S. Department of Labor this week <u>announced</u> it is withdrawing the Biden administration's <u>COVID vaccine-or-test mandate</u> for large employers. Huge news!https://t.co/L4uWVQxRQr

In pulling the rule, the department said it recognized the Emergency Temporary Standard could not be revived after the U.S. Supreme Court blocked it earlier this month and will plan instead to set a permanent standard for the vaccine mandate, according to a <u>notice</u> provided to the court by the Occupational Safety and Health Administration (OSHA).

The Labor Department's decision to withdraw the rule means pending legal proceedings in the 6th Circuit will be dropped.

OSHA could move a version of the vaccine-or-test rule through its rule-making process, but would still likely face legal challenges.

All They Want is Your DNA – To Be Added to PCR Test

People most at risk from coronavirus can be identified with a simple genetic check, health officials say. This report exposes the real reason for Covid-19. It begins with a huge secret that was revealed accidentally, yet makes the connection to a much larger issue that most people are ignorant of. This is the "last hurrah" for Satan of the Bible.

The Polish Health Ministry is planning to introduce a new type of screening for coronavirus after a specific gene was discovered that determines the likelihood of a patient suffering from severe or fatal Covid-19.

People most at risk of suffering the severest effects or even dying of coronavirus can be identified using a genetic test, health officials in Poland revealed this week. The study that resulted in the discovery was supported by the country's Ministry of Health and Medical Research Agency, and involved around 1,500 patients with Covid-19. Researchers from the Medical University of Bialystok identified a gene in chromosome 3 that significantly influences how badly the virus will affect an individual.

"After more than a year and a half of work, it was possible to identify a gene responsible for a predisposition to becoming seriously ill [with Covid]," Health Minister Adam Niedzielski said at a press conference on Thursday.

The findings will now be applied to help identify patients at increased risk from the virus when or even before they contract the infection. The Health Ministry plans to develop and launch a "relatively simple" and quick genetic test that can be performed alongside PCR screening within a few months.

It could also be implemented around the world to help people with apparent genetic preconditions, Polish officials said.

"This is a step towards personalized medicine, which is the medicine of the future – when, knowing our genome, we will know what harm to expect when it comes to our health," Joanna Zajkowska, a professor at the University of Bialystok, told Polish Radio.

If at least one version of the gene is present in the chromosome, a patient is more than twice as likely to suffer the worst effects of Covid-19 or die, according to the study of genetic individual susceptibility led by Marcin Moniuszko and Miroslaw Kwasniewski. The gene is the fourth-most-important factor responsible for acute disease, and is said to be an even more important risk factor than comorbidity. It comes after age, obesity and gender (men are believed to suffer from Covid worse than women), according to the study. The VAERS death ratio confirms this on page 48 below.

The gene is present in around every 10th person in Europe, while in India the rate is almost three times higher, with some 27% of the population being genetically prone to severe Covid. In Poland, where the death rate from the virus is higher than the EU average, around 14% of the population carries the gene.

"From the beginning of the pandemic, we have been trying to understand why, even among people of similar age, some are infected asymptomatically while others fight for their lives," said a spokesman for the university. "Thanks to the research, we are getting closer to understanding this phenomenon."

The Polish study is not the first to suggest correlation between certain genetic factors and patients' reactions to Covid-19. A genome-wide analysis of Italians and Spaniards in 2020 studied blood types and a chromosome 3 gene cluster in association with respiratory failure caused by coronavirus. Extreme susceptibility to severe illness was found in persons with certain DNA markers, while the study also showed that people with type A-positive blood are at higher risk of respiratory failure from Covid.

Other research from Germany also detected correlation between a gene cluster on the same chromosome and the risk of severe infection. A mutation which helps fight off RNA viruses, inherited by some people from our Neanderthal ancestors, has been found.

At this point, we need to understand the Human Genome Project was completed at the beginning of the 21st century. It was in April of 2003 when The Human Genome Project (HGP) was one of the great feats of exploration in history. Rather than an outward exploration of the planet or the cosmos, the HGP was an inward voyage of discovery led by an international team of researchers looking to sequence and map all of the genes -- together known as the genome -- of members of our species, Homo sapiens. Beginning on October 1, 1990 and completed in April 2003, the HGP gave us the ability, for the first time, to read nature's complete genetic blueprint for building a human being.

When the human genome was first deemed "complete" in 2000, the news was met with great international fanfare. The two rival groups vying to finish the genome first—one a large government-led consortium, the other an underdog private company—agreed to declare joint success. They shook hands at the White House. Bill Clinton presided. Tony Blair beamed in from London. "We are standing at an extraordinary moment in scientific history," one prominent scientist declared when those genomes were published. "It's as though we have climbed to the top of the Himalayas."

But actually, the human genome was not complete. Neither group had reached the real summit. As even the contemporary coverage acknowledged, that version was more of a rough draft, riddled with long stretches where the DNA sequence was still fuzzy or missing. The private company soon pivoted and ended its human-genome project, though scientists with the public consortium soldiered on. In 2003, with less glitz but still plenty of headlines, the human genome was declared complete once again.

But actually, the human genome was still not complete. Even the revised draft was missing about 8 percent of the genome. These were the hardest-to-sequence regions, full of repeating letters that were simply impossible to read with the technology at the time.

Finally, May, 2003, a separate group of scientists quietly posted a preprint online describing what can be deemed the first truly complete human genome—a readout of all 3.055 billion letters across 23 human chromosomes. The group, led by relatively young researchers, came together on from around the world to finish the task abandoned 20 years ago. There was no splashy White House announcement this time, no talk of summiting the Himalayas; the paper itself is still under review for official publication in a journal. But the lack of pomp belies what an achievement this is: To complete the human genome, these scientists had to figure out how to map its most mysterious and neglected repeating regions, which may now finally get their scientific due.

"I consider this a landmark," says Steven Henikoff, a molecular biologist at Fred Hutchinson Cancer Research Center, who was not involved in the project. Henikoff studies one of those enigmatic, hard-to-sequence regions where previous humangenome projects had given up: centromeres, which are the slightly pinched middles of each chromosome. Chromosomes, of which humans have 23 pairs, each consist of a long, continuous stretch of DNA that can be condensed into a rod shape; the DNA at the centromere is particularly dense.

On five human chromosomes, the centromere is not in the middle but very close to one end, dividing the chromosome into one long and one very short arm. These short arms are also full of repeats that had never been entirely sequenced until now. Centromeres, short arms, and other types of repeating regions made up most of the 238 million letters the consortium ultimately added or corrected in the human genome.

The repeat-rich segments of the human genome do not usually contain genes, which is one reason they've long been neglected. Geneticists have focused largely on genes because their function is obvious and simple: A gene encodes a protein. (One big surprise of the earlier drafts of the human genome is how little of our DNA actually encodes proteins—only 1 percent. The role of the remaining 99 percent is becoming clearer.) Indeed, there have been hints that these repeat-rich regions also play important roles in how genes get expressed and passed on, and anomalies in them have been linked to cancer and aging. The consortium found 79 new genes hidden

among the repeats too. With a map of these repeating regions finally in hand, scientists can probe more carefully their function.

The effort to finish the genome was "entirely grassroots," says Adam Phillippy, a computational geneticist at the National Institutes of Health who co-leads the Telomere-to-Telomere (T2T) consortium that completed the genome. (Telomeres are the regions at the ends of chromosomes, so telomere to telomere means "end to end.") Phillippy and Karen Miga, a geneticist at UC Santa Cruz, decided to create the consortium in 2018, after a call when they realized that they both harbored ambitions of finishing the human genome.

"I'm in love with repeats," says Miga, who came to the project as a biologist trying to understand what those repeats do. Phillippy, a computer scientist by training, brought technical chops. Traditional sequencing technologies fragment DNA into small pieces, and computer algorithms have to reassemble them like puzzle pieces. The problem is that the pieces from repeating regions all look nearly the same. Now two new "long-read" sequencing technologies—called PacBio HiFi and Oxford Nanopore—allow scientists to read longer stretches of the genome. These sequencers still can't handle chunks big enough to cross an entire centromere or a short arm, but at least the algorithms have larger puzzle pieces to assemble.

The role of centromere sequences, like many other repeating regions, is not yet fully understood, but they are most classically known as the key to cell division. When a cell divides in two, a protein spindle attaches to the centromeres, yanking the chromosomes apart to make sure that each cell gets the right number. When this goes wrong in eggs or sperm, babies can be born with chromosomal anomalies such as Down syndrome or Turner syndrome. When it goes wrong in other parts of the body, we can end up with blood cells, for example, that have too many or too few chromosomes. This is a hallmark of aging: It's not unusual for men older than 70 to have lost the Y Chromosomes in their blood cells. In one of two companion papers uploaded alongside the complete genome, the T2T consortium showed that Oxford Nanopore's long-read technology can also be used to map where exactly the protein spindle attaches to the centromere. Examining the sequences in those regions might yield new clues to chromosomal anomalies.

The repeat-rich short arms of the chromosomes are similarly mysterious. They definitely play some role in the cellular machinery that translates genes into proteins, and knowing their sequences could shed more light on that function. Brian McStay, a biologist at the National University of Ireland at Galway, likens the complete genome to a "parts list" for chromosomes that allows scientists to try taking out the building blocks one by one. "Knowing what this parts list is, we can say, 'This is exactly what our chromosome looks like," McStay says. "Let's delete this and see what the impact on the function of that chromosome is."

As impressive as the technical feat of sequencing a complete human genome is, scientists told me that one genome is only one snapshot. Seeing how these repeating regions change over time from person to person, species to species, will be far more interesting. "What happens in cancer? What happens in development? What happens if you compare offspring to parents?" Henikoff says. The consortium proved that these repeating regions are sequenceable with the new long-read technologies. Now they can be applied to more genomes, allowing scientists to compare one with another.

Indeed, Miga says that the ultimate dream is to make every genome that scientists attempt to sequence complete from end to end, telomere to telomere. But first, the group has a more immediate goal in mind. If you wanted to fault the new genome for not being "complete," you could point to the fact that it comprises only a single set of 23 chromosomes, whereas normal human cells have 23 pairs. To simplify the task, the group used cells from a particular type of tumor that develops from an abnormal fertilized egg and ends up with just 23 single chromosomes. The team will have to use different cells, with 23 pairs of chromosomes, to complete what is known as a "diploid" genome.

"The next major milestone would be routine diploid genomes," says Shilpa Garg, a geneticist at the University of Copenhagen, in Denmark. Garg has.used.pac8io.hiF it to rapidly assemble human genomes—minus some tricky regions such as the centromeres—at a rate of a few per day. That speed could help in clinical settings too, by making it easier for doctors to more regularly diagnose patients using genome sequencing. (In comparison, she says, assembling genomes from older sequencing technology takes as long as three weeks.) *Truly* complete genome sequencing, repeating regions and all, is getting easier and faster. Soon, another complete human genome will not be news at all.

Over the past twenty years or so, most of us went about living life unaware that scientists were busy. Pentin wrote that the meetings were confirmed by "Vatican sources" as the meetings were not included in the Vatican's daily announcements, noting also that the topics discussed were still a mystery.

LifeSiteNews contacted both the Vatican's press office and Pfizer for further comment on the meetings, but as yet has received no reply. When Pentin queried Pfizer about the

meetings, he was told: "We can't confirm or deny as, per our policy, the movements of our executives are considered confidential." The Holy See Press Office "did not respond to repeated requests to confirm the meetings." Pentin added.

Pfizer and Pope Francis' Vatican

Pfizer has developed a close link with the Vatican since its abortion-tainted injections have been in use there since January 2021, when Pope Francis and Pope Emeritus Benedict XVI were among the first in the sovereign state to receive one of the injections. At the time, head of the Vatican health service Dr. Andrea Arcangeli suggested the Vatican would initially be using the Pfizer vaccine, but that others would be administered subject to approval.

However, the Vatican's agreement with Pfizer is to only offer the Big Pharma's injection to employees and residents. In an unrelated report a week ago Pfizer eliminated several hundred sales positions, considered not needed with the Pfizer vaxx selling itself!

Bourla later made a public appearance at the Vatican in May 2021, joining a host of abortion supporters at the Vatican's fifth International Health Conference on "Exploring the Mind, Body & Soul."

Taking the virtual stage with CNN's Sanjay Gupta, Bourla's discussion dealt with: "The global response to COVID-19 has been accelerated by collaboration in data sharing, research, and epidemiological surveillance. As we re-examine our global health architecture, how do we improve future rapid response and build on lessons learned around preparedness, new vaccine development and distribution and, importantly, prevention?"

Pope Francis gave a private address to the members of the conference. It is not known whether one of his meetings with Bourla occurred at this time.

Pfizer's <u>production of abortion pills</u>, along with its production of a COVID-19 injection involving <u>tests using the HEK 293 cell line</u> – derived from kidney tissue taken from a healthy baby who was aborted in the Netherlands in the 1970s – has not seemed to deter the Pontiff from meeting with Bourla.

The link between the Vatican, which solely uses Pfizer's jab, has been further strengthened as the Vatican's secretary of state, Cardinal Pietro Parolin, recently mandated a COVID jab for Vatican employees and visitors, removing the option to test

"negative" for the virus, and allowing only proof of recovery from the virus as an alternative to the injection.

A mandate has been in place for some time in the Vatican for certain employees, resulting in three Swiss Guards being sent home to Switzerland after they refused to comply with the mandated shot.

In comments to the National Catholic Register about his most recent mandate, Cardinal Parolin echoed the language of Archbishop Vincenzo Paglia, and defended Pfizer's jab from those concerned about its connection to abortion.

He acknowledged that cell lines from an aborted baby were used "in the preliminary stages of vaccine testing in the laboratory," but rejected any moral objection to the shot on this basis. "Therefore, it seems that not wanting to undergo vaccination with this motivation cannot be justified, since the vaccine that is currently used is precisely the Pfizer that uses the mRNA method," Parolin stated.

Bourla and Francis are consistently pushing COVID shots.

At the time of the May, 2021 conference, Pfizer was hailed for creating an "effective" injection against COVID-19, and Bourla spoke of the many potential applications of the mRNA technology. In April, 2021, he had even claimed the injection was "100%" effective against the CDC's definition of "severe" COVID-19.

The data also showed the vaccine was 100% effective against severe #COVID19 as defined by @CDCgov and 95.3% effective against severe COVID-19 as defined by @US_FDA. Very reassuring news. (2/4)

However, only days ago, Bourla backtracked on the claimed efficacy of his company's jab. "We know that the two doses of the vaccine offer very limited protection, if any," said Bourla in an interview with Yahoo! Finance.

Bourla instead pushed the booster jab, saying "three doses with a booster, they offer reasonable protection against hospitalization and deaths – against deaths, I think, very good, and less protection against infection."

Speaking to the BBC in December, Bourla pushed for normalizing COVID shots, suggesting that they could be part of normal life for "years to come."

Pope Francis has also regularly pushed for people to take the COVID shots, with his rhetoric becoming even stronger in recent days when he spoke of the "moral obligation" of taking the abortion-tainted injections. Those of you that might be reading this series may recall that I have listed for several weeks this headlined segment: (Courtesy of Patrick O'Carroll -- Cabalist Jews Playing Key Roles In The COVID GENOCIDE:) There was a reason for doing that, and Brian's article above provides the link to which I am trying to make clear to the reader. Most people who read the Bible do not see the text through a supernatural perspective; they do not see the war that exists between Satan and God in our time, which is a serious mistake. God chose the lineage of Abraham, Isaac, and Jacob to present a Biblical message to folks today through the expression of the Israelites or the Jews. The Jewish nation was infiltrated in the 7th century by the Khazar nation which converted to Judaism. Satan worked through the Khazars to undermine God's covenant with the Biblical Jews. Since the late 19th century Satan has worked

through the political movement known as "Zionism" to gain control over the land of Israel, the Temple Mount, and all the key Biblical sites. Today, Israel is 85-90% Ashkenazi sect and 10-15% Sephardic (of which those descending from Abraham, Isaac, and Jacob).

Most theologians, even the Hebrew scholars miss the point of this dichotomy. All those who call themselves Jews are not necessarily Jews. That point is brought out by the Lord Jesus Christ, in His final words of Revelation 2:9 and 3:9. This is a powerful confirmation to what I have been addressing for more than twenty-five years. I do not know of one living Bible prophecy teacher today that addresses this important genealogical distinction. The late Dr. Chuck Missler was the only Bible teacher who taught this Biblical lesson and its importance for our understanding the Bible.

From Genesis 12 to Acts 2, the Bible is all about Israel. Five-sixths of the Bible deals with a subject that tends to get overlooked in most textbooks on "Systematic Theology": the role of Israel as the key element of God's plan for the redemption of mankind. Dr. Chuck Missler, Dr. Tom McCall and Dr. Arnold Fruchtenbaum are highly-respected Bible scholars who recognized years ago what I am sharing here with the reader.

Furthermore, many have assumed that the role of Israel ended with the coming of the Messiah of Jesus Christ. This is a false assumption. As a result, most Christians are insufficiently aware of our indebtedness to the heritage that will benefit us all in the future. This study is essential to understanding today's events in the Middle East. Although this issue of Satan against Israel has been discussed in other articles, I am going to provide the big picture as to why this is significant in the times which we live.

A number of Bible experts have addressed this overarching Biblical theme, including the late Dr. Chuck Missler and Dr. Tom McCall. To miss this essential doctrine is to miss the whole reason for the Rapture and the Second Coming as well. In articles that I have addressed this topic, I have referred to it as "God's Remnant!" Dr. Arnold Fruchtenbaum, a Messianic Christian addresses "God's Remnant" in his books as well.

Why does Satan believe he must destroy Israel and wipe them off the face of the earth? For thousands of years Satan has demonstrated an insane and insatiable drive to wipe out the Jewish people, but so far has not been able to fully accomplish his goal. Let's review some of his major attempts:

- ✓ When Abraham went to Egypt and lied about Sarah, nearly causing Pharaoh to violate her.
- ✓ When Abraham had Ishmael with Hagar, bypassing Sarah.
- ✓ When Ishmael ridiculed Isaac, attempting to usurp Isaac's position.
- ✓ When Esau attempted to gain Jacob's blessing from Isaac.
- ✓ Esau Sells his Birthright to Jacob.
- ✓ When Pharaoh ordered all male Hebrew infants to be murdered.
- ✓ When Pharaoh attempted to destroy Israel backed up against the Red Sea.
- ✓ When Israel decided to worship the Golden Calf at Mt. Sinai.

- ✓ When Israel decided to stay in the wilderness rather than go into Canaan.
- ✓ When Moab tried to destroy Israel and stop them from entering Canaan.
- ✓ When the Canaanites amassed all their armies to destroy the invading Israelites.
- ✓ When the surrounding nations tried to destroy Israel during the time of the Judges.
- ✓ When the surrounding nations tried to destroy Israel during the time of the kings.
- ✓ When the Assyrian army destroyed Israel and much of Judah.
- ✓ When the Babylonian army destroyed the Temple and Jerusalem.
- ✓ When the refugees from Babylon and Persia were restoring the Temple and Jerusalem
- ✓ When Haman attempted to destroy all the Jews throughout the Persian Empire.
- ✓ Mordecai's Triumph by Pieter Eastman Cir 1617
- ✓ When the Greco-Syrian forces tried to Hellenize Judea under Antiochus Epiphanes
- ✓ When the Roman army destroyed Judea and Jerusalem twice (70 AD and 135 AD)
- ✓ When the Jewish people were scattered and persecuted throughout the world for 2,000 years.
- ✓ When Hitler organized the Holocaust and destroyed over Six million Jews.
- ✓ When the Jews attempted to return to Israel against extensive international opposition.
- ✓ When Israel declared its independence in 1947 and was invaded by Egypt, Jordan, and Syria.
- ✓ When Israel was invaded in 1967 and 1973 by its surrounding neighbors
- ✓ When Israel was disrupted by numerous intifadas from Palestinians and Jihadists.
- ✓ When Hamas hurled thousands of rockets from Gaza into Israel in 2014.
- ✓ [The Beast system mandates a vaxx for every person on the planet] Since Israel was scattered in the Diaspora, Biblical Jews can be found living almost everywhere in the world today!]

So we can see, for 4,000 years the Jewish people have faced relentless persecution, anti-Semitism, opposition and attempts to annihilate and destroy them. If it were any of other people, it would seem totally irrational and insane. However, with Israel, there appears to be a certain rational, though Satanic, strategy behind this animosity.

For Satan, the destruction of Israel is a matter of self-preservation. Ultimately, the survival of Israel results in the eternal perdition of Satan. How can this be? Because when Israel repents and nationally invites the Lord Jesus Christ to be their own Redeemer/Messiah, that generation of Israel will be saved, and Satan's plan to destroy the Jews will be finally defeated. Jesus Christ will return to the earth, destroy the Satanic Antichrist and his armies at Armageddon, establish His Kingdom over Israel and the world for 1,000 years, and then cast Satan into the Lake of Fire forever and ever.

The key is that Israel must survive to receive Christ nationally as their own Messiah. As Jesus said when He lamented over Jerusalem from the Mount of Olives a few days before He died and rose from the dead at His First Coming:

Matthew 23:39 – 24:1 "For I say to you, from now on you shall not see Me until you say, 'Blessed is He who comes in the name of the Lord!"

While a remnant of Israel in every generation would receive Him all during the long period between His First and Second Comings (the Church Age), the nation Israel will not receive Him until after the Rapture of the Church and the Seven Year Tribulation. Thus, when Israel receives Christ, this will usher in the events that spell the doom of Satan and his cohorts.

From Satan's point of view, he must keep Israel from surviving to the point in time when they will be ready to receive Jesus as their long awaited Messiah/Redeemer. They had a great opportunity to receive Him at His First Coming, but as John states:

John 1:11-12 ¹¹ "He came to His own, and those who were His own did not receive Him. ¹²But as many as received Him, to them He gave the right to become children of God, even to those who believe in His name."

Israel did not know it's great "hour of visitation" when Jesus came the first time, but when He comes again, the nation of Israel as a whole that survives the Tribulation will at last be ready, willing and eager to receive Him as Savior and Lord.

Thus Satan has strived mightily to destroy Israel through the centuries up until this present time so that there would be no Israel to invite Jesus to return to the earth. Why hasn't Satan been able to accomplish his repeated purpose to kill off this small nation of only a few million people? It is because God has promised to preserve His covenant nation forever, as Jeremiah so eloquently explains:

Jeremiah 31:35-36 ³⁵"Thus says the LORD, Who gives the sun for light by day, And the fixed order of the moon and the stars for light by night, Who stirs up the sea so that its waves roar; The LORD of hosts is His name: ³⁶"If this fixed order departs From before Me," declares the LORD, "Then the offspring of Israel also shall cease From being a nation before Me forever."

God here states what it would take to destroy Israel. One would have to first destroy the sun, moon and stars. Once that had been accomplished then, and only then, could someone go about destroying Israel. The last time I looked, the sun, moon and stars were still functioning, so that must mean Israel has not ceased being a nation.

Satan wants to destroy Israel so that he can keep God from sending him into eternal perdition, but God will not allow Satan to destroy His Chosen Nation. Israel is the apple of God's eye, so it must survive as a nation before Him for all time.

For example, in 1991 Bible scholar Chuck Missler and Hal Lindsey, two prophecy scholars, were up late at night discussing the Gulf War. Hal purportedly turned to Chuck and guipped, "If you want to see spiritual warfare in action, turn on CNN."

They turned on the television news and saw a report. Israel had been attacked by Scud Missiles from Iraq. At that point, Israel did not fight back. Yet, intelligent, educated Arabs with college degrees were discussing why the attack was all Israel's fault.

Mind you, it was Israel who had been attacked by those Scud missiles! The mental contortions necessary to blame Israel for this defied all logic! Yet, we see rational minds following Satan's lead.

All of what we are seeing today is that of a Supernatural Phenomenon. In twenty or more years not much has changed, has it? World citizens still blame Israel for every problem in the Middle East. After a while we begin to realize this is a supernatural phenomenon.

World's Most Corrupt Jab Giant

Pfizer was fined \$2.3 billion in 2009 for what was then the largest health care fraud settlement ever. The company spent over \$21.8 million in 2019–2020 and \$6.7 million from January–August 2021 on lobbying the government, making it the biggest spender of any individual drug company during the COVID-19 crisis.

Pfizer was the biggest corporate spender from 1999–2018, spending \$219 million on lobbying (93% of the industry total) and \$23 million on campaign contributions (around 10% of the industry's total giving to politicians),

"I think the optics raise concerns that there could be potential financial conflicts of interests between Pfizer and the Vatican," Moy, CEO and co-founder of biotech company Cellular Engineering Technologies, said.

"If Pfizer has an exclusive contract with the Vatican for their vaccine, then there needs to be full disclosure and transparency about this contract or any other financial relationships," Moy, a faithful Catholic, insisted.

A lay-Catholic group Church Militant asked the Holy See Press Office if the Vatican would disclose agreements between Pfizer and the Holy See in the interests of transparency (as vaccine behemoths like Pfizer have disclosed only 7% of their contracts with governments and published clinical-trial protocols for just 12% of trials).

Pfizer's Secret Deals

A report by Transparency International and the University of Toronto titled "For Whose Benefit?" warns of dangerous levels of secrecy that reveal "a disturbing trend of governments censoring key details of their [vaccine] orders from drug companies."

Dutch politician and European Parliament member Sophie in't Veld has asked the E.U. Parliament to release text messages between commission president Ursula von der Leyen and Bourla, noting that the secrecy violates regulation 1049/2001 (regarding public access to documents).

The optics raises concerns over potential financial conflicts of interests between Pfizer and the Vatican. Bourla and von der Leyen were in frequent contact by phone and text message for over a month while they negotiated an undisclosed deal for 1.8 billion doses of the Pfizer vaccine, according to a 'New York Times' report.

It is not clear if Vatican City receives its Pfizer shots as part of this agreement. Pope Francis, however, enjoys close ties to von der Leyen and received her at a private meeting in May 2021, where the two discussed vaccine distribution (among other topics).

The Holy See administers only the Pfizer-BioNTech COVID-19 jab to the residents and staff of the world's smallest sovereign nation. Leaked Pfizer contracts show the company is protected from all damages and liabilities in the case of adverse effects from the shot.

"We can't confirm or deny as, per our policy, the movements of our executives are considered confidential," Pfizer told Vaticanist Edward Pentin, author of 'The Next Pope: The Leading Cardinal Candidates', refusing to reveal if Francis met Bourla in secret. There needs to be full disclosure and transparency.

Moy explained that the meeting between Francis and Bourla "is an important issue that needs to be uncovered, since Francis and other senior Vatican leaders are touting that Catholics have a moral obligation to be vaccinated — despite the lack of vaccine effectiveness and safety concerns of Pfizer's vaccine."

Abortion-tainted Jab is Junk

The scientist's words come in the wake of Bourla's <u>admission</u> that two doses of his company's vaccine may not be effective at preventing the omicron variant of COVID-19.

Last week, at a health care conference hosted by J.P. Morgan, Bourla commented: "The two doses, they're not enough for omicron. The third dose of the current vaccine is providing quite good protection against deaths and decent protection against hospitalizations."

The revelations also follow Vatican secretary of state Cardinal. Pietro Parolin's granting an "abortion absolution" exclusively to the Pfizer jab, pursuant to his claim that Pfizer used "cell lines from aborted fetuses only in the preliminary stages of vaccine testing in the laboratory, but no cell lines from aborted fetuses are included in either the composition or production."

Lying Pfizer Gets Busted

Despite a devastating <u>Project Veritas</u> exposé of top company officials and leaked emails revealing Pfizer uses aborted fetal tissue in its vaccine program, Parolin refused to grant religious exemptions on grounds of conscientious objections to the abortion-tainted jab.

Pfizer's own <u>stem-cell-research policy</u> acknowledges Pfizer has been using human embryonic stem cells in its research which "may provide even greater potential due to their increased ability for self-renewal and capacity to form a wide variety of cells and tissues."

All Vatican employees are currently forced to get vaccinated or show proof of recovery from COVID-19. Failure to do so will be considered "unjustified absence with the consequent suspension of pay for the duration of the absence."



Francis welcomes E.U. President Ursula van der Leyen to the Vatican

From Jan. 31, all visitors and staff will have to get the booster as a condition of entry to the Vatican. The mandate extends to all Holy See personnel and to all its institutions within the extra-territorial areas of the Vatican.

"Pope Francis' rhetoric is inconsistent with the December 2020 statement from the Congregation for the Doctrine of Faith that vaccine acceptance should be voluntary," Dr. Moy told Church Militant.

China Bribes Vatican

Meanwhile, the hush-hush parleys between the pope and Pfizer are reigniting speculation over the Vatican's secret concordat with China — renewed by Cardinal. Parolin in October 2020 despite fierce global opposition condemning it as a "deal with the Devil."

The two doses, they're not enough for omicron.

Months before Parolin renewed the deal, exiled dissident Guo Wengui accused the Vatican of receiving \$1.6 billion every year since 2014 in bribes from the Chinese Communist Party because Beijing "wanted the Vatican to shut up about China's religion policies."

Wengui also claimed the Chinese government was paying the Holy See \$100 million before 2014. The tycoon did not specify when the payments initially started. Beijing has branded Wengui an attention-seeking criminal. But the Vatican has yet to deny the allegations.

After Bourla's second meeting with Francis, the vaccine oligarch struck a \$70 million deal with Shanghai-based biotech giant LianBio and invested \$200 million in Hong Kong-based CStone Pharmaceuticals.

In Dec. 2021, a leaked database of registered members of the CCP exposed a mass communist infiltration of American companies, including 69 infiltrators in four Pfizer branches in Shanghai. Pfizer did not respond to press inquiries for comment.

Rome's Elitist Club

Francis and Bourla also have close links to the <u>World Economic Forum</u> — the elite Davos club of transnational globalists pushing the "<u>Great Reset</u>" that seeks to "subdue all of humanity, imposing coercive measures with which to drastically limit individual freedoms and those of entire populations," <u>according</u> to whistleblower Archbishop. Carlo Maria Viganò.

The WEF lists <u>Pope Francis</u> and <u>Albert Bourla</u> as "agenda contributors" on its website. Bourla also serves as co-chair of the WEF task force working for "a great reset in health care." The WEF <u>praises</u> Francis for "put[ting] his stamp on efforts to shape what's been termed a "great reset" of the global economy in response to the devastation of COVID-19."

In May 2021, the Vatican featured Bourla as a key speaker at its conference on global health. Faithful Catholics were outraged after it became known that the gig was partly funded by the Mormon cult and vaccine-maker Moderna. The Vatican did not list Pfizer as a co-sponsor but noted that some of its benefactors had "asked to remain anonymous."

Bourla Benefits Bigtime

Leading Catholics have expressed concern over the pontiff's habit of cozying up to the world's elites — despite world oligarchs' piggybacking on the pandemic to enrich themselves to the tune of billions of dollars.

In November 2021, Bourla, who has led Pfizer since early 2019, sold \$5.6 million in shares on the same day the drug giant announced positive early data on its China-virus vaccine, according to a filing with the Securities and Exchange Commission.

Pfizer compensated Bourla, a Greek-born Sephardic Jew, with a total pay package of \$21-million last year — a 17% increase from before the pandemic (when Bourla's compensation in 2019 was a total of \$17.9 million). [We have reason to suspect that Albert Borla may be Ashkenazi and not a Sephardic Jew as claimed.]

A newly published Oxfam report slams the vaccine monopolies held by Pfizer, BioNTech and Moderna for creating five new billionaires during the pandemic and allowing their corporations to make over \$1,000 per second in profit.

While Pope Francis often rails against capitalism, he has remained silent on the corruption of Big Pharma and the emergence of a plutocracy as a result of the pandemic.

Avoid the Covid FREE test Kits if you want to remain Alive and "Unvaxxed!"

Two weeks ago the Biden administration was promoting the availability of FREE virus test kits to the public. The original order was to be for 500-million self or home test kits and on Thursday, Biden or Arthur Roberts, Biden's double increased the order by an additional 500-million. Thankfully <u>Public Health and Medical Professionals for Transparency</u> filed a lawsuit after the FDA denied their request to expedite the release of the records, and the records are being released, albeit still too slowly.

Among the first reports handed over by Pfizer was a 'Cumulative Analysis of Post-authorization Adverse Event Reports' describing events reported to Pfizer up until February 2021. You can download this entire report here.

Look at table 6 from this Pfizer report. It is titled "Missing Information". Its first heading under the topic "Missing Information" is "Use in pregnancy and lactation". It includes this paragraph:

"Pregnancy outcomes for the 270 pregnancies were reported as spontaneous abortion (23), outcome pending (5), premature birth with neonatal death, spontaneous abortion with intrauterine death (2 each), spontaneous abortion with neonatal death, and normal outcome (1 each). No outcome was provided for 238 pregnancies (note that 2 different outcomes were reported for each twin, and both were counted)."

On the surface this states that of 270 pregnancies, there were 23 spontaneous abortions, 5 "outcomes pending", 2 premature birth with neonatal death, 2 spontaneous abortions with intrauterine death, 1 spontaneous abortion with neonatal death, and 1 normal outcome. But note also "no outcome was provided for 238 pregnancies".

FOIA Docs Reveal Pfizer Shot Caused Avalanche of Miscarriages, Stillborn Babies

So really we have no idea what happened with 243 (5 + 238) of the pregnancies of these injected women; they have just not been included in the report. What we do know is that of 27 reported pregnancies (270 subtract 243), there are 28 dead babies! This appears to mean that someone was pregnant with twins and that 100% of the unborn babies died.

Here is an excellent article by LifeSite News which goes into greater depth about these shocking revelations. LifeSite News cuts Pfizer some slack on the 5 "outcomes pending" which creates the possible impression that 87.5% of the babies of the injected women died. With all respect to LifeSite, I feel correct in not counting the 5 "outcomes pending" and hence arrive at the conclusion that 100% of the unborn babies died in the injected women for whom results are presented.

The LifeSite News article also reveals deceptive number games in another article titled "Safety and Efficacy of the BNT162b2 mRNA Covid-19 Vaccine", which was published in the *'New England Journal of Medicine'* on December 31, 2020. These deceptive practices attempted to cover up the fact that in first trimester pregnancies, the Pfizer injection produced 82% miscarriages.
