A July survey by British market research firm OnePoll answers an important question. Why has this sloppy, so-called pandemic been so successful at duping seemingly-intelligent people into oblivion? The survey found that 88% of Brits trust their doctors' advice [completely or most of the time](#). They especially trust pediatric doctors, with 94% saying they [mostly or completely](#) believe and have faith in said doctors.

Of course since 2020, politics has entered doctors' offices. A December 2021 Pew survey found that 71% of self-identified American Democrats trust their doctors, up from 68% in 2010. Only 60% of self-identified Republicans had those sentiments, down from 73% in 2010. Seemingly-intelligent people are far too indoctrinated to think otherwise despite all the revelations regarding the medical industry since 2020.

The Center for Medicare and Medicaid Services website says in plain English that doctors receive [\\$40 for every COVID-19 "vaccine" they administer](#). That means doctors make \$120 for every patients [who receive three injections](#). U.S. primary care physicians have anywhere from [1,200 to 2,500 regular patients](#). Using the average of about 1,800 patients, American doctors made about \$216,000 each in extra income last year if they talked all of their patients into receiving three shots.

There is clear financial incentive for doctors to push the poisonous injections. Doctors are also paid handsomely for classifying all sicknesses and deaths as "COVID-19." Even the so-called "fact checkers" couldn't twist and propagandize the fact that doctors are paid [anywhere from \\$13,000 to \\$39,000](#) for treating COVID-19 patients. D.J. Ferguson denied heart transplant for being non-vaccinated.

Mr. D.J. Ferguson is a husband, father of two and expecting another child. He is in "severe-stage heart failure," [according to his GoFundMe page](#). He's been at [Brigham and Women's Hospital](#) in Boston since November after a congenital heart defect caused blood and other fluids to accumulate in his lungs. The only thing that will save him is a heart transplant. Despite being at the front of the line for a heart transplant, Brigham

Chad Carswell was denied kidney transplant because he's non-vaccinated

Mr. Carswell found 100 people willing to donate a kidney. But Atrium Health Wake Forest Baptist Hospital in Winston-Salem, North Carolina refuses to do the transplant surgery because Mr. Carswell is non-vaccinated. The hospital's reason for refusing to save this man's life is that *"transplant patients are at high-risk of severe illness if they [don't get the vaccine]."* Hospital officials failed to speak about the obvious risks associated with receiving the mRNA and viral vector DNA injections.

Military Doctors: DoD Medical Data Shows 300% Increase in Cancer, Miscarriages, Infertility After Jab Approved

According to the U.S. military, the Defense Medical Epidemiology Database (DMED) is the Armed Forces Health Surveillance Branch's (AFHSB) "web-based tool to remotely query de-identified active component personnel and medical event data contained within the Defense Medical Surveillance System (DMSS)." It contains every International Classification of Diseases (ICD) medical billing codes for any medical diagnosis in the military submitted for medical insurance billing. Because it is a closed system for the DoD, the data within DMED is highly accurate which is why the following information is incredibly shocking.

According to three military doctors who have come forward, after the approval of the covid-19 vaccine, the data shows that in the first 11 months of 2021, military members experienced a sudden and shocking spike in nearly every ICD code associated with common vaccine injuries.

On Monday, during a 5-hour long hearing on a "Covid-19: Second Opinion," held by Sen. Ron Johnson (R-WI), Ohio attorney Thomas Renz presented the DMED data. The numbers are incredibly shocking.

Conservative pundit Daniel Horowitz detailed some of the issues on Twitter after he interviewed Renz.

"The video of Renz is here. I know 2 of the 3 cited whistleblowers. Their credentials are impeccable. Lt. Col. Chambers is one of the only Green Beret doctors in the military."

"Unlike VAERS where the naysayers can suggest that anyone can submit, this is only by military doctors and quantifies every single ICD code in the military for tri care billing of Humana. This is the ultimate defined and finite population with excellent surveillance."

"One of the biggest takeaways here is that the data is beyond reproach and widely accessible by the DoD, CDC, FDA, and across the Biden-Harris regime. In other words, they are all very well aware that the jabs are almost certainly causing an untenable increase in cancer in otherwise young and healthy military-age Americans and they're keeping that information away from the people."

While correlation doesn't necessary equate to causation, the number of young and healthy military members coming down with these ailments — as shown in their own data — is a massive red flag and should warrant immediate investigation. Yet the establishment media have completely ignored it.

“We have substantial data showing that we saw, for example, miscarriages increasing by 300% over the five-year average, almost. We saw almost 300% increases in cancer over the five-year average,” Renz said.

“We saw, this one’s amazing, neurological. So, neurological issues which would affect our pilots, over 1000% increase. 1000,” Renz continued.

The data was apparently so shocking that Johnson interrupted Renz, confirming, *“Ten times”?*

“That’s ten times the rate.” Renz affirmed, and pointed out that they saw an increase of *“82,000 neurological issues per year to 863,000 in one year.”*

That is not all either. According to Renz, the three military doctors, Samuel Sigoloff, Peter Chambers, and Theresa Long have declared under penalty of perjury that these numbers are across the board in multiple disorders. Horowitz explains:

- Some other numbers he did not mention at the hearing but gave to me in the interview are the following:
- myocardial infarction –269% increase
- Bell’s palsy – 291% increase
- congenital malformations (for children of military personnel) – 156% increase
- female infertility – 471% increase
- pulmonary embolisms – 467% increase

Doctor use Bluetooth applications to detect MAC address network signals in people “vaccinated” for covid

Since 1960, fewer than 5% of M.Div. programs require Greek for graduation. That fact is a two-edge sword depending on whether one wants to know the truth or a deception.

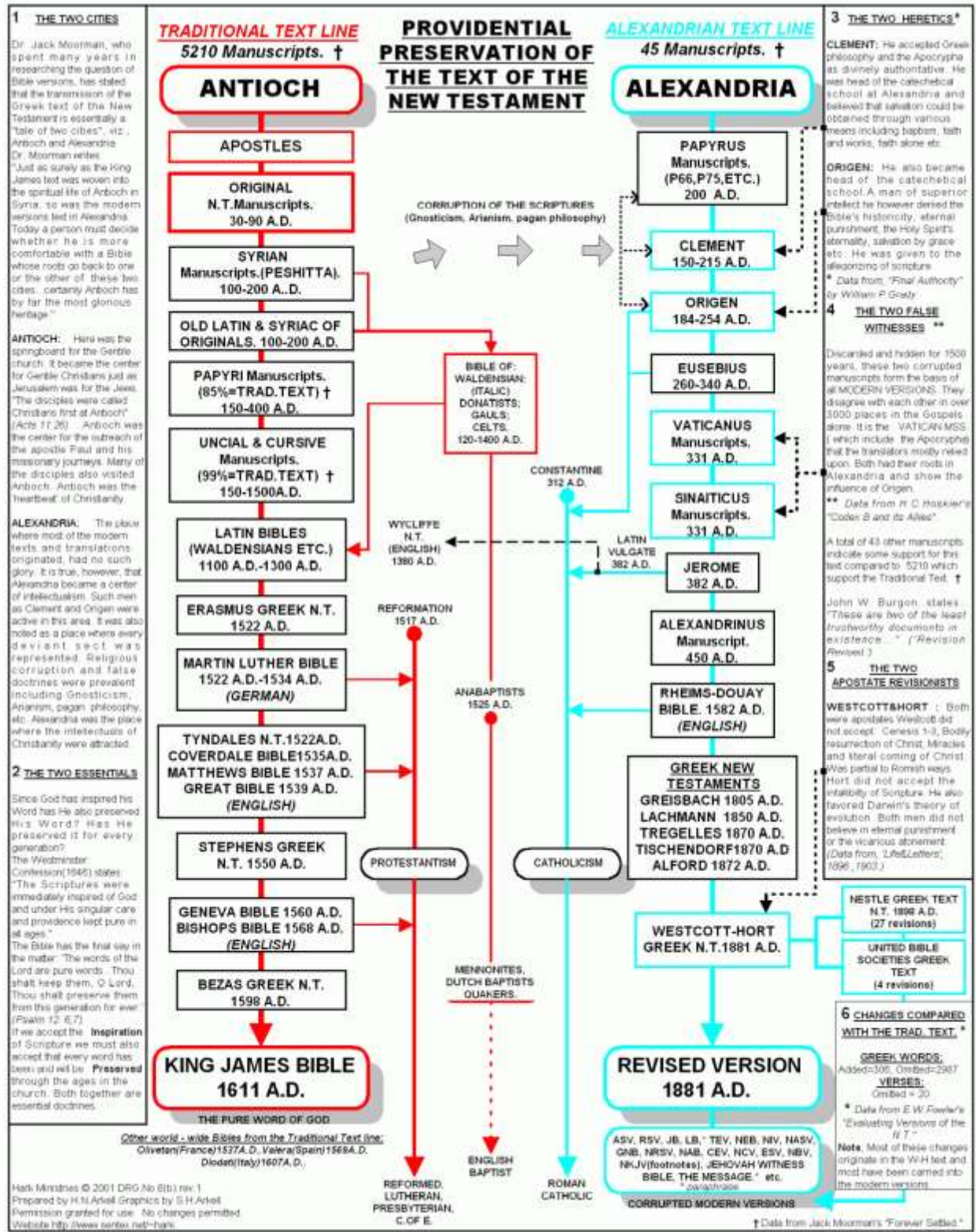

[This is not true by Irenaeus' own writings! He was only one generation away from the Apostle John, the “Revelator” who recorded the Lord’s Words in the Book of Revelation.](#)

What is most important is that this 'fragment' uses an "Alexandrian type" rather than the Byzantine type used by the Majority View; and as such, are copies of the original. Covid vaccine vial contents found to be highly toxic when spilled – Imagine the damage caused when injected

[\(Natural News\)](#) A few months back, workers transporting vials of a Wuhan coronavirus (Covid-19) “vaccine” drug called CoronaVac suffered serious injuries after a shipment was damaged and spilled.

[A study](#) on the incident, which took place in Thailand, found that health personnel exposed to the evaporated vial contents suffered ocular surface erosion and skin rashes.

“Proximity and timing suggest CoronaVac correlation with the ocular and skin reactions,” the paper’s authors wrote, adding that *“we recommend caution during vaccine handling and fastidious clean-up of any spills.”*

“Cautions should be taken to avoid broken vials, spills, and aerosolization of CoronaVac during the vaccination.”

Reading this, one would think that a highly corrosive industrial chemical of some kind was leaked, resulting in serious injuries. But these were supposedly “medicines” that were spilled – medicines that are being injected into people’s bodies.

If these drugs cause such health problems on the outside of the body upon exposure, what might they be doing to people’s *insides*, we wonder?

CoronaVac shots contain aluminum hydroxide

It turns out that CoronaVac injections are made in China and contain beta-propiolactone inactivated SARS-CoV-2 viral particles (or so they say, since SARS-CoV-2 has [never actually been isolated](#)).

The jabs have a claimed efficacy rate of just 50.4 percent, and that is the “official” number. In reality, it is likely closer to zero percent efficacy just like for the other injections from Pfizer-BioNTech and Moderna.

Concerning CoronaVac specifically, the study looked at a three-day jab campaign that took place at Rajavithi Hospital in Thailand. A total of 20 health personnel worked in the vaccination room of an indoor facility and all received the jab within the first two days.

On the third day, a single dose of the vaccine was accidentally dropped on the floor by a nurse, resulting in breakage. She promptly wiped it up with a piece of tissue paper and disposed of it in a trash can where it remained for the rest of the day.

That one broken vial caused 15 different personnel to experience skin rashes and ocular surface erosion anywhere from 3-17 hours after the accident. These same 15

people worked in the affected rooms for between 3-6 hours either during or after the incident occurred while another five who were also there showed no adverse reactions.

“All 15 personnel with ocular symptoms had some degree of conjunctivitis including: eye irritation (9); red eyes (7); tearing (7); and swollen eyelids (4),” reported the *Daily Exposé*.

“The nurse who accidentally dropped the vaccine vial and the assistant who wore contact lenses manifested the most severe and longest clinical manifestations, for 2 weeks.”

Interestingly, none of the 2,296 recipients of the injections reported any symptoms, at least not immediately.

“We hypothesize, after finding no other likely association, such as contamination of cleaning agents or malfunction of ventilation system, that the evaporated solution of the vaccine was associated with ocular surface erosions of the affected personnel,” the study authors wrote.

“... the excipients or aluminum hydroxide adjuvant may be the likely chemicals that associated with the adverse reactions.”

In the comments, someone wrote that a doctor who previously researched the contents of the vials, focusing primarily on the nanotech aspects, said before his death that the secret to finding out what is actually in them is to wait three days while it dries.

“And people are happy to be injected with this toxic fluid?” asked another. *“Astounding.”* Over at *Natural News*, a commenter reiterated the fact that SARS-CoV-2 has never been isolated and that the media is just fabricating fear and terror over what amounts to a bad seasonal flu.

The U.S. Food and Drug Administration (FDA) on Monday granted full approval of Moderna’s Spikevax COVID vaccine for people 18 and older.

Similar to the agency’s [licensing](#) last year of Pfizer’s [Comirnaty](#) vaccine, the approval raised a number of legal questions related to mandates and product availability.

Spikevax is a two-dose primary series, approved also for administration as part of a heterologous (“mix and match”) single booster dose for individuals who previously completed their original series of vaccinations with the [Pfizer](#) or [Johnson & Johnson COVID](#) vaccines.

According to the FDA, Spikevax “*has the same formulation as the [Emergency Use Authorization (EUA)] Moderna COVID-19 Vaccine and ... can be used interchangeably with the EUA Moderna COVID-19 Vaccine to provide the COVID-19 vaccination series.*”

However, in its [approval letter](#), the FDA said Spikevax is “*legally distinct*” from the Moderna EUA vaccine:

“The licensed vaccine has the same formulation as the EUA-authorized vaccine and the products can be used interchangeably to provide the vaccination series without presenting any safety or effectiveness concerns. The products are legally distinct with certain differences that do not impact safety or effectiveness.”

The FDA made the same distinction between the Pfizer-BioNTech EUA vaccine and the Pfizer Comirnaty vaccine, which the agency [fully licensed](#) in August, 2021, a move that [raised questions](#) about liability and the legality of vaccine mandates.

After Monday’s announcement, media outlets were quick to [reassure](#) the public the two Moderna vaccines are the same and that this was just a [marketing](#) ploy, where Moderna simply “[rebranded](#)” what is otherwise the same vaccine. It’s actually more like “heads I win, tails you lose”!

No ‘fully licensed’ COVID actually available

While Moderna’s Spikevax vaccine is now fully licensed, the original Moderna vaccine will remain under EUA. Indeed, the FDA on Jan. 7 [reissued](#) the EUA.

The FDA has also made it clear the Spikevax vaccine will not be available to the American public, [announcing](#):

“Although SPIKEVAX (COVID-19 Vaccine, mRNA) and Comirnaty (COVID-19 Vaccine, mRNA) are approved to prevent COVID-19 in certain individuals within the scope of the Moderna COVID-19 Vaccine authorization, there is not sufficient approved vaccine available for distribution to this population in its entirety at the time of reissuance of this EUA.”

These claims parallel the chain of events that followed the FDA’s full approval of the Pfizer Comirnaty vaccine in August 2021.

At the time, Pfizer and the FDA [claimed](#) Comirnaty was not yet available, as there were sufficient stocks of the Pfizer-BioNTech EUA vaccine still available to be administered.

As of this writing, the FDA states, via its [website](#), that Comirnaty products are “*not orderable at this time.*”

The FDA has not indicated when, or if, the Spikevax and Comirnaty vaccines will be available for distribution in the U.S.

Are EUA and fully licensed vaccines really interchangeable?

As reported by [The Defender](#), there is a significant legal distinction between products authorized under EUA and those fully licensed by the FDA. This is more akin to a legal move to obstruct law suits for harmful effects to victims suing for damages.

EUA products are [experimental](#) under U.S. law. Under the [Nuremberg Code](#) and federal regulations, no one can force a human being to participate in this experiment.

Specifically, under [21 U.S. Code Sec.360bbb-3\(e\)\(1\)\(A\)\(ii\)\(III\)](#), “authorization for medical products for use in emergencies,” it is unlawful to deny someone a job or an education because they refuse to be an experimental subject. Instead, potential recipients have an absolute right to refuse EUA vaccines.

That’s an issue military members, unable to find any vaccination sites that offer the fully licensed Comirnaty vaccine, cited in [various lawsuits](#) challenging vaccine mandates.

Notably, on Nov. 12, 2021, a federal judge [rejected](#) an argument by the U.S. Department of Defense, in defending the military’s vaccine mandate, that the Pfizer Comirnaty and Pfizer-BioNTech vaccines are “*interchangeable*.”

U.S. law also [requires](#) the EUA designation be used only when “*there is no adequate, approved and available alternative to the product for diagnosing, preventing or treating such disease or condition*.”

This means that, in legal terms, all EUA products should be withdrawn once alternative products have received full approval.

Perhaps the most significant legal distinction, however, pertains to the legal protections afforded vaccine manufacturers, depending on how their product is classified.

Under the 2005 [Public Readiness and Preparedness \(PREP\) Act](#), EUA-approved vaccines enjoy a significant liability shield. Specifically, vaccine manufacturers, distributors, providers, and government officials involved in the policymaking, approval, and distribution process are [immune](#) from any legal liability.

Under such regulations, the only way an injured party can sue is if he or she can prove willful misconduct, and if the U.S. government has also brought an enforcement action against the party for willful misconduct.

No such lawsuit [has ever succeeded](#).

Conversely, fully licensed vaccines, such as Spikevax and Comirnaty, do not have a liability shield, and are instead [subject](#) to the same product liability laws as other products.

This means the Spikevax and Comirnaty vaccines could expose pharmaceutical companies to significant financial claims if individuals injured by the vaccines chose to sue the vaccine makers.

The rush to get COVID vaccines authorized for all ages — a ploy to avoid liability? On Friday, February 4th, NBC's Pittsburgh, PA affiliated station channel 11 announced this on its noon news: "CDC advisors give Moderna COVID-19 full approval. The advisory panel for the Centers for Disease Control and Prevention has unanimously voted to give the Moderna COVID-19 vaccine full approval."

This is outright murder and the agencies are playing games to protect the various parties in this scam against legal suits that will bankrupt them if gotten away with.

There's another reason Pfizer and Moderna don't want their fully licensed vaccines to be available yet — they're waiting for the vaccines to be authorized, then licensed, for children [as young as 6 months old](#).

Why? Because once a vaccine is fully licensed by the FDA, the [only way](#) its manufacturer can be shielded from legal liability is if the vaccine is added to the Centers for Disease Control and Prevention's [childhood vaccination schedule](#).

The [National Childhood Vaccine Injury Act \(NCVIA\)](#), passed into law in 1986, provides a legal liability shield to drugmakers if they [receive](#) full authorization for all ages and the vaccine is added to the mandatory schedule.

Reporting on the FDA's approval of Spikevax, investigative journalist Jordan Schachtel [wrote](#):

"Are Pfizer and Moderna waiting for full authorization for children's shots to distribute Comirnaty and Spikevax to the masses? There's plenty of litigators who have suggested that this is exactly what is going on in Big Pharma world."

By creating the public perception that the Pfizer and Moderna EUA vaccines are fully approved, businesses, schools and other institutions [are emboldened](#) to impose vaccine mandates that violate existing law and allow the vaccines to be administered without informed consent.

It has also been [argued](#) that by relabeling the product, any previous data regarding vaccine injuries and side effects identified in association with the EUA vaccine are not counted in the safety studies for the approved vaccine.

The FDA approval of the Pfizer Comirnaty vaccine, its subsequent lack of availability and the continued administration of the Pfizer-BioNTech EUA vaccine led [Children's Health Defense](#) (CHD) to [file](#) a [lawsuit](#) against the FDA and its acting director, [Dr. Janet Woodcock](#), for their allegedly deceptive and [rushed](#) approval of the Comirnaty vaccine, arguing that [the approval represented a classic "bait and switch" tactic](#).

CHD further alleged in its lawsuit that the FDA violated federal law when it simultaneously licensed Pfizer's Comirnaty vaccine and extended Pfizer's EUA — as

the agency has now done with Moderna and Spikevax — for a vaccine that has the “same formulation” and that “can be used interchangeably,” according to the FDA.

FDA admits no safety data for Spikevax use among pregnant women

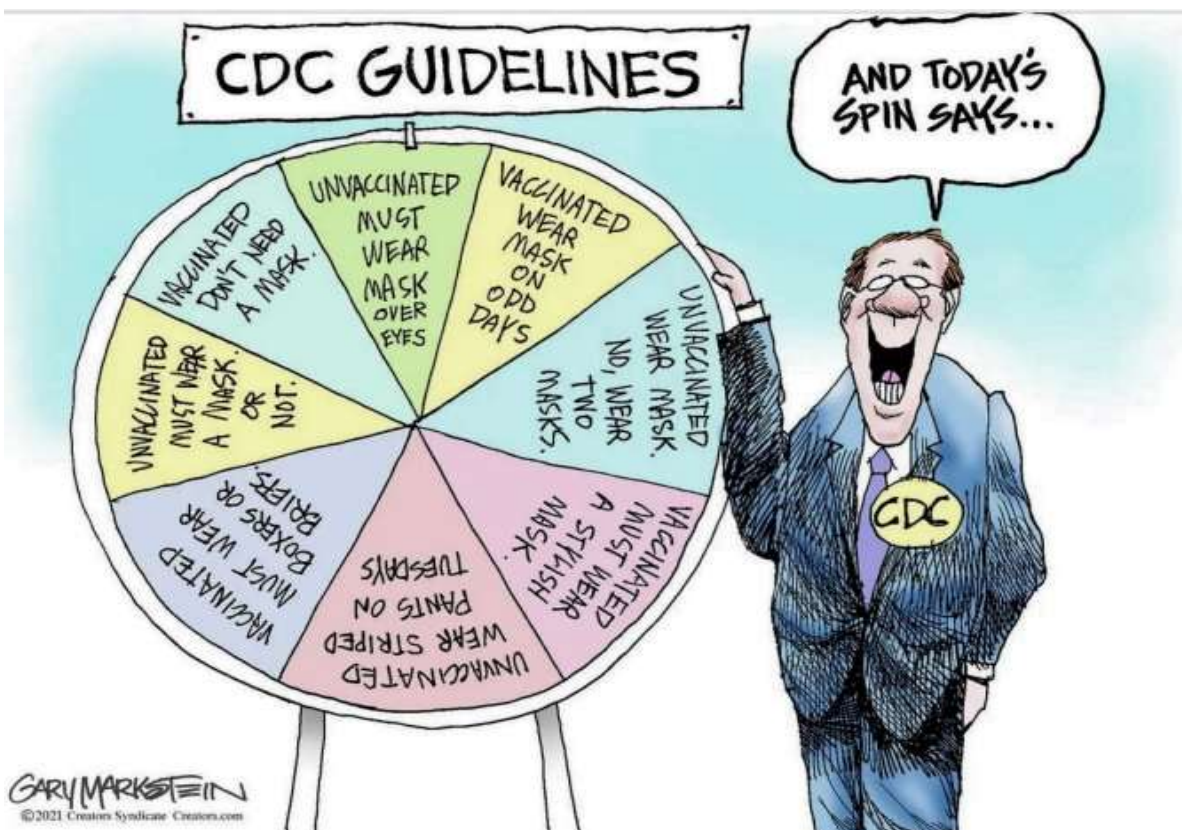
Beyond the legal questions raised by the FDA’s approval this week of Spikevax, the approval also raises safety questions.

For instance, the FDA [admitted](#) Spikevax was insufficiently tested on [pregnant women](#), stating that “[a]vailable data on SPIKEVAX administered to pregnant women are insufficient to inform vaccine-associated risks in pregnancy.”

Furthermore, Spikevax was approved [without](#) having been tested for its ability to provide protection against the [Omicron](#) variant, which is reported to account for 99.9% of current U.S. COVID cases — it was approved only for providing protection against mutations that are no longer circulating.

And yet, the FDA [cited](#) the Omicron variant as the reason behind its decision to pull its EUA for monoclonal antibody products. The FDA claims that these products have not been shown to provide protection against the Omicron variant.

Mainstream scientists now embracing vaccine depopulation explanation for why the vaccines are killing so many people

— Vaccine makers are currently still experimenting with doses to find out which ones are the most lethal, Dr. Füllmich stated, citing the Corona Investigative Committee. Those findings constitute evidence for massive punitive damages and charges of murder and attempted murder.

— Indian lawyers have already filed a case alleging premeditated murder.

— There is a concentrated smear campaign being waged against anyone of authority or knowledge who speaks out against the vaccines or any pandemic-related mandates and regulations. They are being labeled “right-wing extremists” and their reputations are being attacked in an effort to silence and/or discredit the opposition. That [includes former Pfizer VP Mike Yeadon](#).

— If the lawsuits are successful, then at least \$1 million per person will be demanded.

— Earlier in the pandemic, just 10 percent of adverse effects were being reported, but that figure has now fallen to around 1 percent, according to the experts.

— “Over the span of this past year there has been an excess mortality of 40 percent,” the CEO of a life insurance company in Indiana has testified, which is believed to be due to the vaccines.

— “Any vaccine is a poison, it is the dosage which makes the difference. This is not a vaccine, as a vaccine provides immunity, while these products demand incessant injections. Either a vaccine works or it does not,” the outlet reports, citing the interview.

It turns out that the ethno-bomb that Richardson claimed did not exist was at least attempted in South Africa back in the 1980s. The plan was to create and unleash an “ethnic bullet,” as it was also called, for research purposes in order to test out its viability for potential later expanded use.

Dr. Daan Goosen says that he and his colleagues were ordered at the time to develop a “pigmentation weapon” that targeted only black people. They discussed spreading it in beer, maize (corn) and vaccinations, though a UPI report claims that such a weapon was never actually developed – at least not at that time.

Fast-forward to today and what was described back then is eerily similar to what we are now seeing today with covid jabs, except on a global scale. WARNING: 'Vaccine is Worse than We Feared, Could be Looking at Hundreds of Thousands More Dead'

Columbia’s underreporting factor estimates that **20x times that number, or around 400,000 deaths, is far more accurate.**

Children Dying

Doctors are testifying that COVID-19 vaccines are giving people cancer and AIDS

(Natural News) More individuals fully vaccinated against the Wuhan coronavirus (COVID-19) are developing cancer and even AIDS. This is according to prominent physicians Dr. Ryan Cole and Dr. Vladimir “Zev” Zelenko.

Cole, a board-certified pathologist and owner of a diagnostics lab in Idaho, was called to participate in Wisconsin Sen. Ron Johnson’s Senate panel called “COVID-19: A Second Opinion.”

This discussion panel featured world-renowned doctors and medical experts who were given a chance to provide alternate opinions regarding the experimental and dangerous COVID-19 vaccines. (Related: Fully vaccinated people make up 71% of new cases and 60% of COVID hospitalizations in US.)

Cole, who was originally invited to talk about early at-home COVID-19 treatments, also provided his testimony.

According to Cole, he conducts around 40,000 biopsies a year as a pathologist and he has been seeing more cancers pop up in people who ordinarily would not be susceptible to developing the kinds of cancers he has been seeing. The only similarity between all of these people is that they have all been vaccinated.

Cole collected all of his data and attempted to contact other laboratories to aggregate a bigger dataset. For pointing out what he has observed, Cole said he was ridiculed and maligned.

“I have oncologists, I have radiation oncologists [tell me] ‘I am seeing an uptick in cancers,’ ‘I’m seeing these odd stable cancers take off like wildfires after the vaccines,’” said Cole. *“It is happening. We need federal funding. The NIH [National Institutes of Health] isn’t looking at this. Getting a grant to look at anything related to the vaccines is next to impossible.”*

This is not the first time Cole has spoken about the rise in cancers among those vaccinated against COVID-19. In Sept. 2021, Cole went viral after a video of him talking about seeing a rise in cancers and autoimmune diseases among the fully vaccinated was made public.

“Since Jan. 1 [2021], in the laboratory, I’m seeing a 20 times increase of endometrial cancers over what I see on an annual basis,” said Cole in the video. *“I’m not exaggerating at all because I look at my numbers year over year. I’m like, ‘Gosh, I’ve never seen this many endometrial cancers before.’”*

Vaccine’s immunity-killing properties cause immune deficiency problems among the fully vaccinated

On Jan. 11, Zelenko, a Ukrainian-American family physician, was interviewed by Clay Clark, host of the Thrive Time Show on Brighteon.TV to talk about how the fully vaccinated patients he has been seeing are experiencing immune deficiency problems.

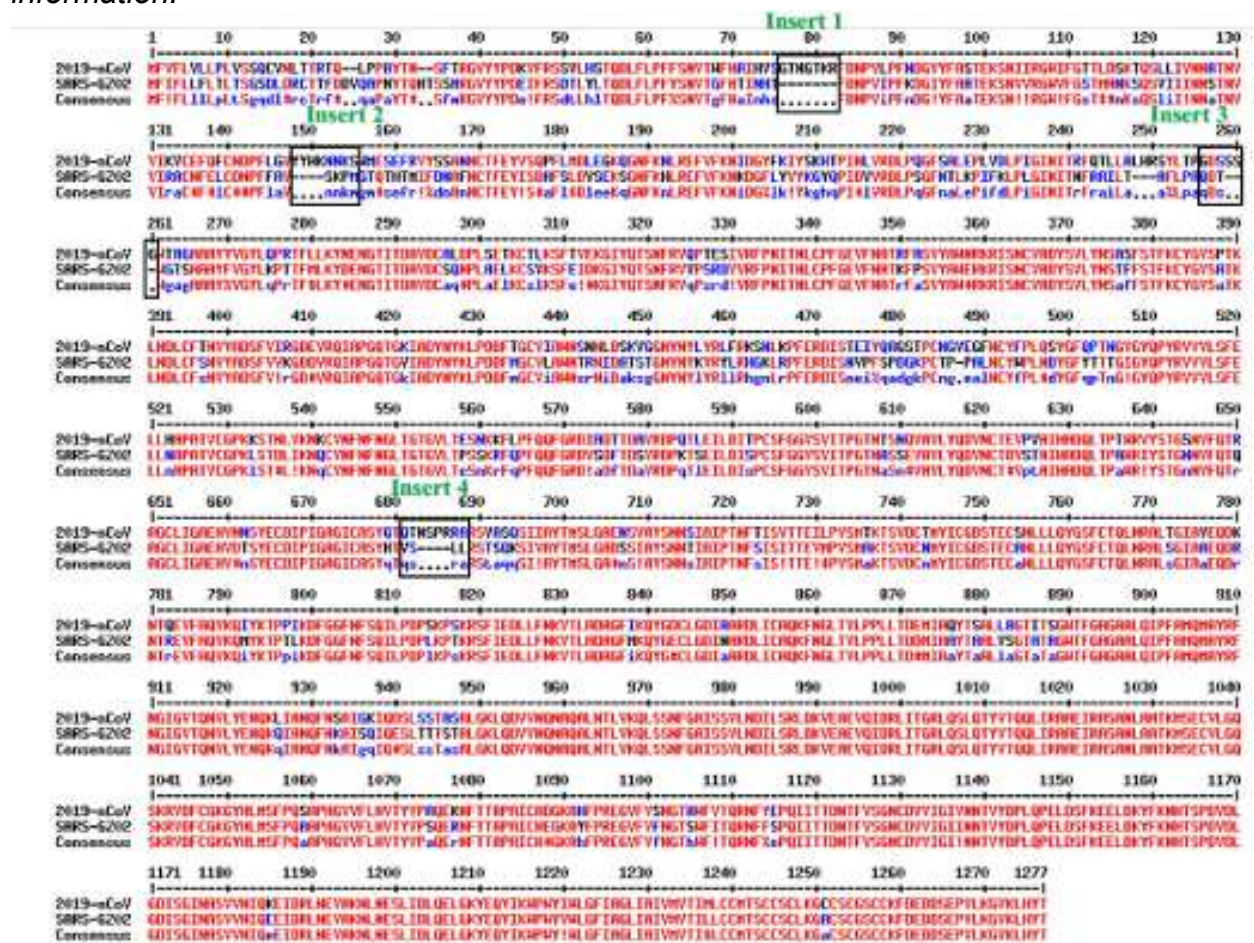
“They have AIDS. But it’s not HIV-induced AIDS,” said Zelenko. *“HIV damages your killer T cells and weakens your immune system. So, that syndrome is called AIDS. But there are other things that damage your immune system.”*

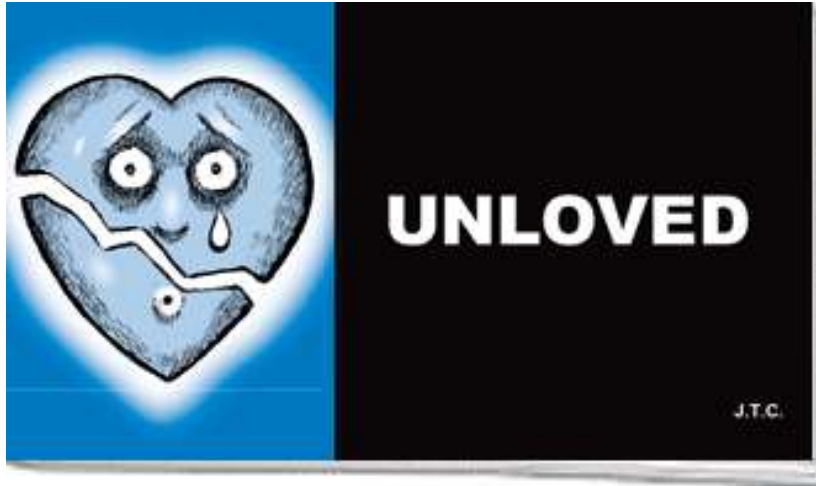

Documents on Moderna FDA Approval Missing From FDA Website

On January 31, the U.S. Food and Drug Administration (FDA), without convening its expert vaccine advisory panel, gave [full approval](#) to a Moderna COVID shot that will be marketed as Spikevax and used in people 18 and older. While the agency claims that the jab “meets the FDA’s rigorous standards for safety, effectiveness and manufacturing quality,” federal regulators removed the key documents that they used to reach that conclusion.



According to [The Epoch Times](#), the FDA document “Summary Basis for Regulatory Action,” which “explain[s] why the agency approved Moderna’s COVID-19 vaccine,” was “removed from the agency’s website overnight.”

Among other important metrics, that document included references to an unpublished analysis that found that the rates of post-vaccination heart inflammation “were *higher than any U.S. agency had found before*,” per the outlet.

‘The Epoch Times’ said that once their team reviewed the document they reached out to the FDA with questions, but found that the summary was nowhere to be found on the FDA website. FDA representatives emailed the outlet saying they were aware of the issue and would try to repost the summary as soon as possible. The agency implied that the document disappeared because of technical problems with its website.

Barbara Loe Fisher, president of the National Vaccine Information Center, a nonprofit organization that advocates for informed consent, told the outlet that the agency must make public the crucial information on the shot’s safety and efficacy.

She said, “*Lack of transparency only fosters distrust in government agencies charged with protecting public health. FDA should immediately release all information related to the incidence of myocarditis and other serious adverse events following mRNA COVID-19 vaccinations, whether that information has been provided to the agency by vaccine manufacturers or discovered through in-house analyses of additional data collected by federal officials.*”

'The Epoch Times' noted that the meta-analysis, now scrapped from the FDA's website, examined data from four health-care claims databases and estimated that, among males aged 18 to 25, the rate of myocarditis following Moderna's primary series was 148 per million males vaccinated.

How bad is that?

Well, the Centers for Disease Control and Prevention's (CDC) [baseline](#) for myocarditis in males aged 18 to 25 is *one to 8 cases per year*. There are some [30.8 million](#) Americans of both sexes in that age group, so the number of males would be roughly 15.4 million. Using the FDA's estimate above of 148 per million, if every young man in the age group receives the Moderna shots, 2,280 will likely develop myocarditis.

Notably, young females also increasingly developed myocarditis following mRNA vaccinations, as did men in older age groups, as shown in [the CDC chart](#).

Myocarditis, or inflammation of the heart muscle, is not a mild and easily treated condition, as the CDC [tries to paint it](#). Myocarditis can cause blood clots to form because of the inflamed heart's inability to pump out blood properly, leading to serious health complications such as heart attack, heart failure, sudden cardiac arrest, and stroke.

Moreover, [according](#) to Dr. Lee Merritt, myocarditis has a mortality rate of 66 percent in a five-year span. In other words, two-thirds of those young people who come down with vaccine-induced myocarditis will probably be dead within five years.

The heart issues occurring in young men after vaccination with Moderna's Spikevax are so off the charts that the Nordic countries [have suspended](#) the use of that brand altogether.

Researchers in the United Kingdom [found](#) that men under 40 were much more likely to suffer from heart inflammation after Moderna's second shot than from COVID itself. Women under 40 were also at risk, but to a lesser extent.

The CDC's Advisory Committee on Immunization Practices is [scheduled](#) to meet on Friday to review data on Spikevax.

Currently, the CDC [recommends](#) adults who have been inoculated with Moderna to come back for an additional dose at least five months after completing their initial series, and recommends those who developed myocarditis or pericarditis after their first dose to wait until the symptoms resolve and then proceed to get a second dose.

The U.S. Vaccine Adverse Event Reporting System contains nearly [30,000 cases](#) of myocarditis/pericarditis associated with COVID vaccines. As Dr. Lee Merritt noted above, these 30,000 will likely be dead in five years.

Steve Kirsch, founder and executive director of the [Vaccine Safety Research Foundation](#), highlighted some of the other issues associated with Moderna shots. In a [speech](#) prepared for the CDC's vaccine advisory committee, Kirsch pointed to the [high rates](#) of pulmonary embolism linked to the Moderna shot. He wrote, *"We are seeing 415 times more events [of pulmonary embolism] than a normal year. If it wasn't the vaccine that caused these events, then what did? The CDC cannot find this safety signal which is life threatening."*

Kirsch also compiled [a chart](#) of the top 37 symptoms most elevated when compared to baseline. The chart includes a number of various heart and blood issues, as well as menstrual and neurological disorders.

"If this isn't a safety signal, I don't know what is," Kirsch lamented. He also predicted the committee would unanimously approve the shot despite the damning evidence of its dangers.

"A false claim has been circulating online that (mass-jabbing) will threaten women's fertility by harming the placenta (sic)."

“Studies show that (mass-jabbing) does not trigger miscarriages (sic).”

“There are no documented risks to the fetus” from jabs (sic).

According to a Pharma-linked obstetrician quoted by the Times:

“Not offering pregnant women the opportunity to be (jabbed) is not a wise strategy (sic).”

A Pharma-linked immunologist the Times quoted defied science by claiming that “women’s lives depend on” jabs (sic).

In its rigged, rushed trials, Pfizer excluded pregnant women for good reason.

I’ve written before about vital analysis conducted by Dr. Jessica Rose, PhD (in computational biology), MSc (in immunology), and BSc (in applied mathematics).

“Analysis suggests that (covid jabs) are likely the cause of reported deaths, spontaneous abortions, and anaphylactic reactions in addition to cardiovascular, neurological and immunological AEs.”

Together with researcher Matthew Crawford, she said the following:

“Analysis of the Vaccine Adverse Event Reporting System (VAERS) database can be used to estimate the number of excess deaths caused by (flu/covid jabs).”

“A simple analysis shows that it is likely that over 150,000 Americans have been killed by (jabs) as of August 28, 2021.”

“Anaphylaxis (a severe, potentially life-threatening allergic reaction) is a well-known side effect” from jabs. Pharma-controlled CDC VAERS data “underreport(ed) (it) 50X to 123X” — to cover up numbers of deaths from jabs. Estimates of underreporting and numbers of deaths following jabs “were validated multiple independent ways.”

“There is no evidence that these (jabs) save more lives than they cost.”

“Pfizer’s own study showed that adverse events consistent with (its mRNA jabs) were greater than the lives saved...”

“Without an overall statistically significant all-cause mortality benefit, and evidence of an optional medical intervention, (it’s) likely (that jabs) killed over 150,000 Americans” in 8 months.

Yearend 2021 estimates put the number at over 400,000 after one year of mass-jabbing — in the US alone.

Jabbing *“mandates are not justifiable and should be opposed by all members of the medical community.”*

“Early treatments using a cocktail of repurposed drugs with proven safety profiles are a safer, more effective alternative which always improves all-cause mortality in the event of infection, and there are also safe, simple, and effective protocols for prophylaxis.”

In late January, Rose’s analysis showed an epidemic of spontaneous abortions from toxins in flu/covid jabs that number over 416,000.

CDC VAERS data reported a tiny fraction of this total.

Commenting on Rose’s analysis, researcher Steve Kirsch called it “medical malpractice to recommend (flu/covid jabs) to pregnant women.”

The Pharma-controlled agency defied indisputable science by calling them safe for most everyone, including in all age groups.

According to a Public Health and Medical Professionals for Transparency Lawsuit — based on Pfizer’s documents — all pregnant women jabbed with its mRNA drug miscarried.

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of [1,088,560 reports of adverse events](#) following COVID vaccines were submitted between Dec. 14, 2020, and Jan. 28, 2022, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of [23,149 reports of deaths](#) — an increase of 542 over the previous week — and [183,311 reports of serious injuries](#), including deaths, during the same time period — up 4,317 compared with the previous week.

Excluding “[foreign reports](#)” to VAERS, [747,760 adverse events](#), including [10,527 deaths](#) and [69,089 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and Jan. 28, 2022.

[Foreign reports](#) are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product’s labeling, the manufacturer is required to submit the report to VAERS.

Of the 10,527 U.S. [deaths reported](#) as of Jan. 28, 19% occurred within 24 hours of vaccination, 23% occurred within 48 hours of vaccination and 60% occurred in people who experienced an [onset of symptoms](#) within 48 hours of being vaccinated.

In the U.S., 536.8 million COVID vaccine doses had been administered as of Jan. 28, [including](#) 315 million doses of Pfizer, 204 million doses of Moderna and 18 million doses of Johnson & Johnson (J&J).

Every Friday, [VAERS](#) publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed. Historically, VAERS has been shown to report only [1% of actual vaccine adverse events](#).

U.S. VAERS data from Dec. 14, 2020, to Jan. 28, 2022, for 5- to 11-year-olds show:

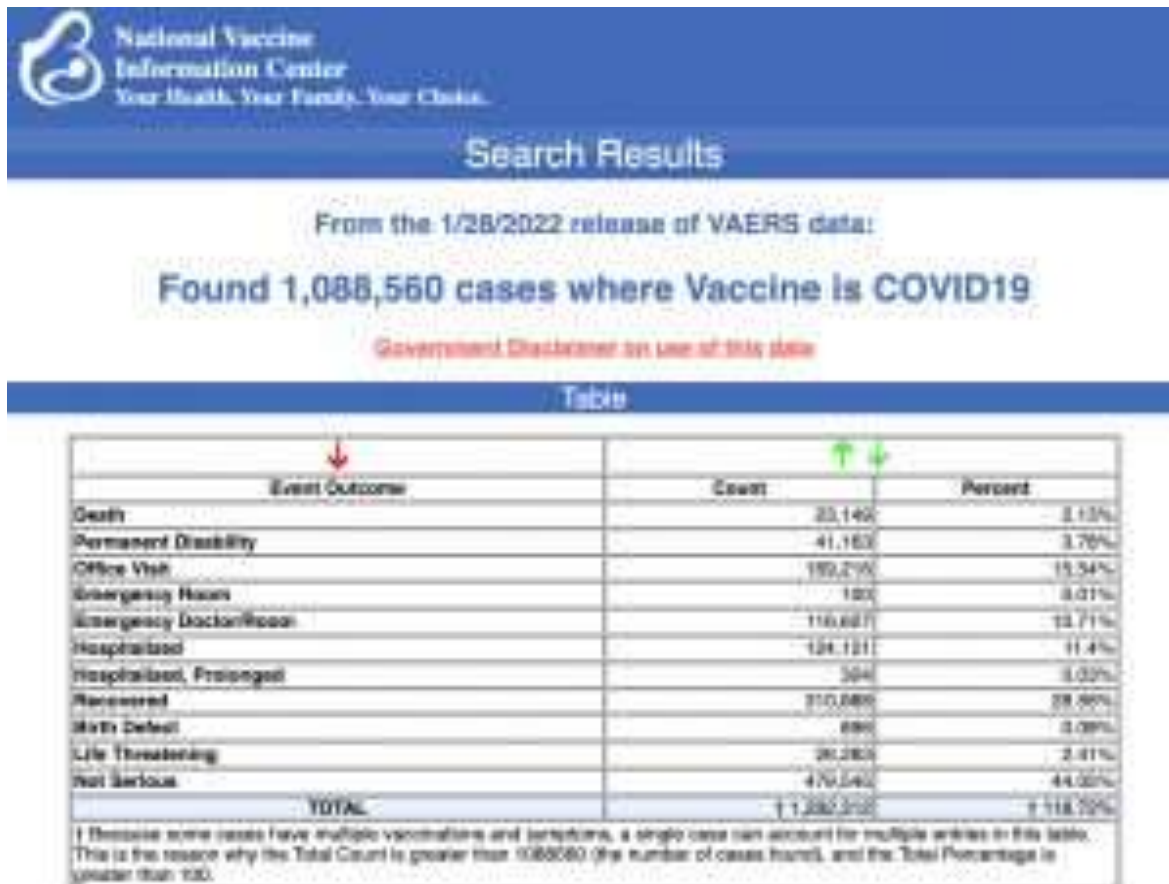
- [7,391 adverse events](#), including [159 rated as serious](#) and [3 reported deaths](#).

The most recent death involves a 7-year-old girl (VAERS I.D. [1975356](#)) from Minnesota who died 11 days after receiving her first dose of Pfizer’s COVID vaccine when she was found unresponsive by her mother. An autopsy is pending.

- [14 reports](#) of myocarditis and pericarditis (heart inflammation).
- [26 reports](#) of blood clotting disorders.

U.S. VAERS data from Dec. 14, 2020, to Jan. 28, 2022, for 12- to 17-year-olds show:

- [28,449 adverse events](#), including [1,609 rated as serious](#) and [37 reported deaths](#).



The most recent deaths involve a 13-year-old male (VAERS I.D. [2042005](#)) from an unidentified state who died from a sudden heart attack seven months after receiving his second dose of Moderna, and a 17-year-old female from an unidentified state (VAERS I.D. [2039111](#)) who died after receiving her first dose of Moderna. Medical information was limited and it is unknown if an autopsy was performed in either case.

- [68 reports](#) of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death — with 96% of cases attributed to [Pfizer's vaccine](#).
- [615 reports](#) of myocarditis and pericarditis with [603 cases](#) attributed to Pfizer's vaccine.
- [155 reports](#) of blood clotting disorders, with all cases attributed to Pfizer.

U.S. VAERS data from Dec. 14, 2020, to Jan. 28, 2022, for all age groups combined, show:

- 19% of deaths were related to cardiac disorders.

- 54% of those who died were male, 41% were female and the remaining death reports did not include the gender of the deceased.
- The [average age](#) of death was **72.3**. [Note how the average age of death has remained steady at 72 years+ over the past 49 weeks.]
- As of Jan. 28, [4,992 pregnant women](#) reported adverse events related to COVID vaccines, including 1,597 reports of [miscarriage or premature birth](#).
- Of the [3,509 cases of Bell's Palsy](#) reported, 51% were attributed to [Pfizer](#) vaccinations, 40% to [Moderna](#) and 8% to [J&J](#).
- 850 reports of [Guillain-Barré syndrome](#) (GBS), with 41% of cases [attributed to Pfizer](#), 30% to [Moderna](#) and 28% to [J&J](#).
- [2,300 reports](#) of anaphylaxis where the reaction was life-threatening, required treatment or resulted in death.
- [1,560 reports](#) of myocardial infarction.
- [12,864 reports](#) of blood clotting disorders in the U.S. Of those, [5,730 reports](#) were attributed to Pfizer, [4,580 reports](#) to Moderna and [2,506 reports](#) to J&J.
- [3,878 cases](#) of myocarditis and pericarditis with [2,387 cases](#) attributed to Pfizer, [1,313 cases](#) to Moderna and [166 cases](#) to J&J's COVID vaccine.

CDC advisory panel votes unanimously to recommend Moderna 'Spikevax' vaccine for 18 and older.

The CDC's Advisory Committee on Immunization Practices (ACIP) today [voted 13-0](#) to recommend Moderna's Spikevax COVID vaccine for adults 18 and older.

Dr. Rochelle Walensky, the agency's director, is expected sign off on the recommendation, making it official.

The vote came after the FDA on Monday [granted](#) full approval of the [Spikevax vaccine](#) making it the second fully licensed COVID vaccine in the U.S.

Yep! Spikevax was approved without having been tested for its ability to provide protection against Omicron, accounting for 99.9% of current U.S. COVID cases—it was approved only for providing protection against mutations that are no longer circulating. <https://t.co/K7NBJ1R2nw>

However, similar to the [licensing](#) last year of Pfizer's [Comirnaty](#) vaccine, the FDA approval and CDC recommendation of the Moderna vaccine raised a number of legal questions.

According to the FDA, Spikevax “has the same formulation as the [Emergency Use Authorization (EUA)] Moderna COVID-19 Vaccine and ... can be used interchangeably with the EUA Moderna COVID-19 Vaccine to provide the COVID-19 vaccination series.” However, in its [approval letter](#), the FDA said Spikevax is “legally distinct” from the Moderna EUA vaccine.

The FDA made the same distinction between the Pfizer-BioNTech EUA vaccine and the Pfizer Comirnaty vaccine, which the agency [fully licensed](#) in August, 2021.

In the case of both Comirnaty and Spikevax, the FDA and the manufacturers of the vaccines acknowledge the fully licensed versions of their products are not available for distribution in the U.S. — a fact that caused some observers of today's meeting to question the rush to approve it.

Dr. Meryl Nass, who listened to today's meeting, said while the committee voted unanimously to recommend Spikevax fully, "No one mentioned that it won't be available and so nothing just happened."

Nass said:

"Strangely, not a single ACIP member, nor their CDC briefers, acknowledged there was no plan to make the vaccine available to Americans in the near term. Therefore, the people making this decision have either been kept in the dark, or are trying to keep us in the dark. No one admitted that the purpose of today's recommendation was to convince people they were getting a licensed product when they would instead get an EUA."

Dr. Madhava Setty also questioned the panel's decision, not only because the fully licensed Spikevax product isn't available, but also because it was designed in response to earlier variants of the virus.

Setty said:

"Perhaps the biggest elephant in that room was that the data presented was outdated and did not reflect the vaccine's effectiveness against [Omicron](#), the dominant strain in this country at this time. What then is the purpose of approving this product? We learned later the reasons were clear: to extinguish vaccine hesitancy."

Spikevax is a two-dose primary series, approved also for administration as part of a heterologous ("mix and match") single booster dose for individuals who previously completed their original series of vaccinations with the [Pfizer](#) or J&J COVID vaccines.

Moderna awaits authorization for teens as FDA reviews heart inflammation risk

Moderna is still waiting for health agencies to [authorize its vaccine](#) for use in teenagers 12 to 17 years old.

The CDC met today to review the risk of what the agency characterized as a "rare" but serious form of heart inflammation affecting mostly young men after receiving an mRNA vaccine.

Moderna applied for Emergency Use Authorization in June for the adolescent age group, but the FDA told the company in October its review of the vaccine for kids

wouldn't be finished before January as it examined the risk of [myocarditis](#) in vaccines based on mRNA technology.

The FDA, in a [statement to CNBC](#) on Wednesday, said it is conducting the review as fast as possible, but it cannot predict how long the evaluation will take.

Vaxxed Democrat Senator Suffers Stroke At Age 49, Threatening Dems' Slim Senate Majority

The Democrats slim majority in the Senate is currently in disarray after New Mexico Senator Ben Ray Lujan suffered a stroke at the age of 49.

Lujan was one of the first New Mexicans to receive the coronavirus vaccine.

"As the first New Mexicans receive the coronavirus vaccine, I have a responsibility to lead by example and show my constituents that this vaccine is safe and effective," tweeted on Dec 19, 2020. *"There is nothing to fear about getting vaccinated to protect yourself from this deadly disease."*

290 fully vaccinated residents in Massachusetts die of COVID over 1 week

Nearly 300 [residents in Massachusetts](#) died of COVID over the past week despite being fully vaccinated.

According to the [International Business Times](#), between Jan. 22-29, Massachusetts health officials reported 290 additional [breakthrough](#) COVID deaths, bringing the state's total death toll among the fully vaccinated to 1,789. The figure represents 0.03% of the state's vaccinated population.

During the same period, health officials recorded 27,530 new breakthrough infections and 555 additional hospitalizations. The state has now reported a total of 422,132 cases and 6,440 admissions among the fully vaccinated.

CDC admits natural immunity trumps vaccine immunity.

A Jan. 19 [report from the CDC](#) showed natural immunity against [COVID](#) was at least three times as effective as vaccination alone at preventing people from becoming infected with the [Delta](#) variant.

Overall, the study showed natural immunity outperformed vaccine immunity when it came to preventing infection and hospitalization from Delta.

The results contradicted a previous CDC [study](#), published in August 2021, which concluded vaccination was better than natural immunity.

The CDC issued a media statement about the August study, which was widely covered by mainstream press, but when a much larger [Israeli study](#) was published two weeks later with different findings, the agency did not acknowledge the new analysis.

Shaquille O’Neal says COVID vaccines should not be forced
Former Lakers star Shaquille O’Neal, who has been a vocal supporter of COVID vaccines for athletes, spoke out Thursday against vaccine mandates, [Sports Illustrated reported](#).

Speaking with Entertainment Tonight’s Nischelle Turner on “[The Big Podcast with Shaq](#),” O’Neal said he is not against the vaccine, but people should not have to choose between keeping their jobs and getting vaccinated.

“Look, I encourage everybody to be safe and take care of your family, I do,” [O’Neal said](#), “but there’s still some people that don’t wanna take it. And you shouldn’t have to be forced to take something you don’t want.”

Turner stated her employer, CBS, has a vaccine mandate for workers. O’Neal responded, *“That’s forced.”*

When Turner disagreed, O’Neal said: *“It is forced. Because if the man don’t take it, the man gonna get fired.”*

O’Neal’s new position comes after he previously slammed Kyrie Irving for not getting vaccinated. In September, O’Neal said on his podcast if he was a teammate with Irving, he would have told him to *“get his a!! up out of here.”*

‘Vaccine Mania’: Fauci, Big Pharma Detail Plans for ‘Indefinite’ Rollout of Shots

At a virtual meeting held the first day of the World Economic Forum’s Davos Agenda 2022, Moderna CEO Stéphane Bancel and colleagues, including Dr. Anthony Fauci, detailed their plans for “vaccine mania” to persist indefinitely.

Many experts have [sounded the alarm](#) that the [COVID-19](#) pandemic was all about the shot and a [larger agenda](#) to impose totalitarian control worldwide. Already, one shot has turned into two doses and a third [booster](#).

A [fourth booster](#) is also being discussed, including by [Moderna](#) CEO Stéphane Bancel, [who said](#) that the efficacy of the third shot is likely to decline over several months, necessitating another shot soon thereafter.

“I will be surprised when we get that data in the coming weeks that it’s holding nicely over time — I would expect that it’s not going to hold great,” [Bancel said](#) in an interview with Goldman Sachs.

Conveniently, Moderna is working on an [Omicron](#)-specific jab that they hope to [release](#) as early as March 2022 — and this is only the beginning.

Writing on Substack, contributor [Eugyppius explained](#):

“Moderna, just one of multiple [pharmaceuticals](#) eager to exploit our new vaccine mania, are expanding their manufacturing capacity to produce as many as 6 billion mRNA vaccine doses per year.”

The information came straight from the horse’s mouth, at a virtual meeting held the first day of the World Economic Forum’s (WEF) [Davos Agenda 2022](#), at a session titled [“COVID-19: What’s Next?”](#)

Along with Bancel, the meeting was attended by [Dr. Anthony Fauci](#), director of the U.S. National Institute of Allergy and Infectious Diseases (NIAID), Richard Hatchett, CEO of the Coalition for Epidemic Preparedness Innovations, and professor Annelies Wilder-Smith from the London School of Hygiene and Tropical Medicine, who together detailed their plans for “vaccine mania” to persist indefinitely.



Combined shots planned to avoid ‘compliance issues’

During the discussion, Bancel states that Moderna is actively preparing for “*what should the vaccine be in the fall of 2022, and what should it contain.*” The company is “*working with public health experts like Fauci’s team to figure this out. Because soon we’re going to have to decide what goes into the vaccine for fall of 2022,*” he said [\(6:25\)](#).

Fauci’s NIAID is part of the U.S. National Institutes of Health (NIH), which, some may be surprised to learn, actually owns half the patent for Moderna’s COVID-19 injection.

In fact, the NIH owns thousands of pharmaceutical patents, and the U.S. Centers for Disease Control and Prevention spends \$4.9 billion a year out of its \$12 billion budget buying and distributing vaccines.

“Tony Fauci was able to choose, to designate, four of his high-level employees who each get individual patent shares,” [according to Robert F. Kennedy Jr.](#) in an interview with James Corbett. “They will collect \$150,000 a year for life if the Moderna vaccine is approved, which it has been.” [\(8:31\)](#)

In addition to working closely with Fauci, Moderna is planning to combine multiple shots, such as a COVID-19 shot, a [flu shot](#) and a respiratory syncytial virus (RSV) shot, into one injection — coming in 2023 — to help avoid “*compliance issues.*” [Fauci said:](#)

“The other piece we’re working on is for 2023, is how do we make it possible from a societal standpoint that people want to be vaccinated?”

“And we’re going to do this by preparing combinations, we’re working on the flu vaccine, we’re working on an RSV vaccine, and our goal is to be able to have a single annual booster, so that we don’t have compliance issues, where people don’t want to get two to three shots a winter, but they get one dose, where they get a booster for corona, and a booster for flu and RSV, to make sure that people get their vaccine.”

When asked how soon this would occur, he continued [\(7:20\)](#):

“So the RSV program is now in Phase 3, the flu program is in Phase 2 and soon in Phase 3, I hope as soon as second quarter of this year. So the best case scenario would be the fall of 2023, as a best case scenario, I don’t think it would [be available] in every country, but we believe it’s possible to operate in some countries next year.”

Vaccines for at least 20 pathogens in the works

SARS-Cov-2 isn’t the only virus that Moderna and other pharmaceutical companies, along with health officials, are intent on targeting with more shots. Remember the zika virus, which Kennedy described as another pandemic fabricated for the purpose of selling pharmaceuticals and advancing totalitarian control? [\(34:10\)](#) There’s a vaccine on the way for it.

How about Nipah virus? Nipah virus, a zoonotic pathogen for which no treatments exist, is the inspiration for the film “**Contagion**.” The virus can only be experimented on in BSL-4 laboratories. As an aside, the National Bio and Agro-Defense Facility in Kansas will be the [first biocontainment facility](#) in the U.S. where research on Nipah (and Ebola) can be conducted on livestock.

In 2019, Nipah Malaysia was also among the deadly virus strains [shipped](#) from Canada’s National Microbiology Lab to the Wuhan Institute of Virology. If you haven’t heard of Nipah yet, you likely will soon — another vaccine is in the works for it. [Bancel said \(43.45\)](#):

“We’re working with Dr. Fauci’s team, we’re working with Richard [Hatchett], to work on many more pathogens ... The entire scientific community has known for years that there’s at least around 20-ish pathogens that are a risk for which we need vaccines, you know we have zika vaccine in Phase 2 ... we’re working on a Nipah vaccine, those are viruses that not everybody has heard of.

“Because we need to have the data. What dose, what construct from a genetic standpoint is required ... so that if a new pathogen emerges from that family we can very quickly move into a Phase 3.”

More mRNA shots are coming

Many other vaccines are also under development, including a Phase 3 study looking at combining [Pfizer](#)’s COVID-19 injection with their [Pneumovax 20™](#) (pneumococcal 20-valent conjugate vaccine) for adults aged 65 and older.

In a related news release, Kathrin U. Jansen, Ph.D., senior vice president and head of vaccine research and development at Pfizer spoke about the importance of “*raising awareness of the importance of adult*” vaccinations, echoing Bancel in their desire to create combination shots so adults can get multiple vaccines at one doctor or pharmacy visit.

“As the COVID-19 vaccines and booster doses continue to be administered, we believe that health care providers have an opportunity to talk to their adult patients about other recommended vaccines in line with CDC guidance,” [she said](#).

An agreement between Pfizer and BioNTech to develop the first mRNA [shingles](#) vaccine was also [reached in January 2022](#). According to a [Pfizer news release](#):

“While there are currently approved vaccines for shingles, there is an opportunity to develop an improved vaccine that potentially shows high efficacy and better tolerability, and is more efficient to produce globally, by utilizing mRNA technology.”

A Phase 1 study by Moderna for its mRNA Epstein-Barr virus shot is also underway. The first dose of the experimental shot was given to a study subject Jan. 5. In a [news](#)

[release](#), Moderna detailed their intent on rolling out additional mRNA vaccines against a number of additional viruses as well:

“The start of this Phase 1 study is a significant milestone as we continue to advance mRNA vaccines against latent viruses, which remain in the body for life after infection and can lead to chronic medical conditions. Moderna is committed to developing a portfolio of first-in-class vaccines against latent viruses for which there are no approved vaccines today, including vaccines against CMV [cytomegalovirus], EBV and HIV.”

“Our research team is working to bring even more vaccines against latent viruses to the clinic. We believe these vaccines could have a profound impact on quality of health for hundreds of millions of people around the world.”and make them richer and buy politician votes to make them mandatory for all to receive!

Other mRNA shots also in development include:

- An mRNA cancer vaccine for non-small cell lung cancer ([NSCLC](#)).
- mRNA influenza shots, which are under development by several companies, including Pfizer, Moderna, [Sanofi](#) and Translate Bio.
- An mRNA HIV vaccine, one of which is being studied by Moderna in collaboration with the NIH.
- Various additional mRNA cancer vaccines, including one targeting advanced melanoma — being [developed by BioNTech](#) and Regeneron Pharmaceuticals — and several being [developed by Moderna](#), targeting melanoma, NSCLC, colorectal cancer and pancreatic cancer.

Ramping up production for billions of doses

In case there were any doubts that the powers that be intend to use injections as an increasingly integral part of your health care routine and daily life, Bancel described plans for billions of doses of shots to be manufactured in a matter of months. [He said](#) during the WEF session ([43:45](#)):

“The other piece is manufacturing. If you look in 2020, we were able to ship 20 million doses to the U.S. government when the vaccine was authorized. That is not a lot.”

“But this year we’re going to have 2 to 3 billion doses of capacity in a six-month timeframe, which is what I believe it will take us to get authorization of a vaccine, if all the work has been done before ... you could have 1.5 billion doses available in six months, and that’s just from Moderna. And you have other platforms, it could be a much bigger number ...”

With censorship now so pervasive, and [Big Tech](#) colluding with dictators and pharmaceutical companies to bury the harms occurring through these experimental vaccines — including death — it’s now more important than ever to let your voice be heard in support of medical freedom and opposition of government health officials

What is a disease without a cause?

A disease without a cause is called a business model.

You make a list of symptoms. You say many people are experiencing this cluster of symptoms.

You give a label to this list of symptoms. A name. The name of a disease or a disorder or a syndrome.

Over time, through promotion, the name sticks.

Like the old fashion cold is now Covid-19.

If there's a name, a label, there is money in it.

You fund research to find the cause of the disease. This research can stretch out for a long time. Possibly forever. Example, Dr. Fauci's 40 year search for a cure for HIV:AIDS. He got the government to give him more than a half billion of your tax dollars In his HIV scandemic.

Meanwhile, you develop and sell drugs to treat the disease. Money.

You keep reporting "progress" on finding the cause. *"At first, we looked for environmental factors. But now we know the basis is almost certainly genetic. We're homing in on the specific genetic dysfunction..."*

Over time, what's forgotten is this: is there really a single disease with a single cause?

And think it through; if you can't verify a single cause, you don't have a disease. You just have the original list of symptoms.

Alzheimer's would be an example. Microcephaly (babies born with small heads and brain damage) would be another. The disease names seem to carry the day. *"Well, if there's a name, a label, there must be a unique disease."*

Wrong.

If there's a name, a label, there is money.

Money for research, for drug development, money from drug and vaccine sales.

Researchers are tasked with making the list of symptoms seem compelling. *"We've done brain studies. There are remarkable similarities among patients who have Disease X. As you can see from these scans, in Figure A..."*

Still, no dice. No verified cause. Therefore, no justification for using the disease label or claiming you have found a unique disease.

But it doesn't matter, because the business model is working well.

Here's another example. ADHD. Has a single cause been found for this list of symptoms? No. Therefore, there is no laboratory test for ADHD. No test to confirm the diagnosis of ADHD. Because a test would detect the cause is present in the patient—and there is no cause to look for.

In fact, if you examine the complete catalog of all so-called mental disorders—about 300 of them—there is no defining lab test for ANY of them. Not a one. Each so-called disorder is simply a list of behaviors which have been clustered together by committees of psychiatrists and given a name. ADHD. Bipolar. Clinical depression. And so on.

But it doesn't matter. Because the business model is working. Money is pouring in. Drugs are selling.

Let's take this even further. A hundred years of Rockefeller medicine have "established" that there are thousands of separate and distinct and unique diseases, disorders, and syndromes. And each one has a cause. For many diseases, the cause "*hasn't been discovered yet.*" Meaning: "*We're writing fiction. We have no justification for calling these diseases, diseases.*"

The drugs and the vaccines are the \$\$\$ payoff

For many other diseases, researchers claim, the causes have been found. The most popular type of cause? A virus.

A virus that had never been seen before. A virus that was "discovered" in a lab.

A lab—as [I've discussed in depth](#)—that lets in no outsiders, no truly independent observers, to see, in detail, what's actually going on.

For that reason, and several others, there is no solid reason to believe these viruses, these causes are actually being discovered. Are actually real.

Which leaves us with thousands of lists of symptoms.

But there is always a business model. The full Rockefeller model is worth trillions of dollars. More dollars every day.

The drugs and the vaccines are the \$\$\$ payoff.

I've spent decades demonstrating their toxicity.

Here's a very interesting medical trick. A criminal trick. The researchers say a brain disorder called ABC exists but they haven't found the cause yet. A parent has a child with severe problems and takes him to the doctor. The doctor pronounces a diagnosis: "*Yes, your boy has ABC.*"

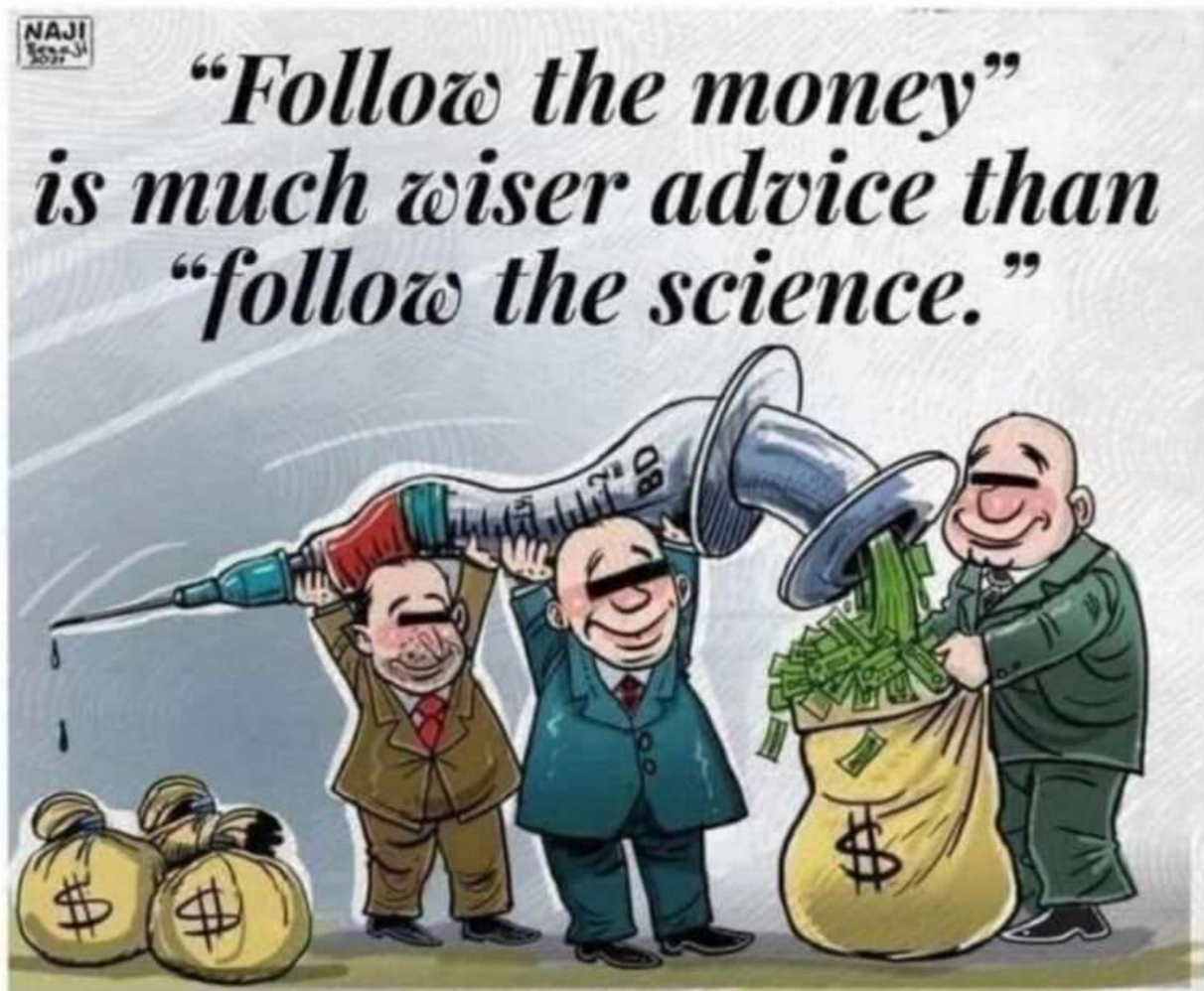
What is a disease without a cause?

Look at table 6 from this Pfizer report. It is titled “Missing Information”. Its first heading under the topic “Missing Information” is “Use in pregnancy and lactation”. It includes this paragraph:

“Pregnancy outcomes for the 270 pregnancies were reported as spontaneous abortion (23), outcome pending (5), premature birth with neonatal death, spontaneous abortion with intrauterine death (2 each), spontaneous abortion with neonatal death, and normal outcome (1 each). No outcome was provided for 238 pregnancies (note that 2 different outcomes were reported for each twin, and both were counted).”

On the surface this states that of 270 pregnancies, there were 23 spontaneous abortions, 5 “outcomes pending”, 2 premature birth with neonatal death, 2 spontaneous abortions with intrauterine death, 1 spontaneous abortion with neonatal death, and 1 normal outcome. But note also “no outcome was provided for 238 pregnancies”.
