664 Reports of Myocarditis in 5- to 17-Year-Olds after COVID Shots, VAERS Data Show

VAERS data released Friday by the Centers for Disease Control and Prevention included a total of **1,195,396 reports of adverse events** from all age groups following COVID vaccines, including **26,059 deaths** and **211,584 serious injuries** between Dec. 14, 2020, and March 18, 2022.

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of [1,195,396 reports of adverse events](#) following COVID-19 vaccines were submitted between Dec. 14, 2020, and March 18, 2022, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of [26,059 reports of deaths](#) — an increase of 418 over the previous week — and [211,584 reports of serious injuries](#), including deaths, during the same time period — up 3,375 compared with the previous week.

Excluding “[foreign reports](#)” to VAERS, [795,783 adverse events](#), including [11,943 deaths](#) and [77,404 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and March 18, 2022.

[Foreign reports](#) are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product’s labeling, the manufacturer is required to submit the report to VAERS.

Of the 11,943 U.S. [deaths reported](#) as of March 18, 17% occurred within 24 hours of vaccination, 21% occurred within 48 hours of vaccination and 59% occurred in people who experienced an [onset of symptoms](#) within 48 hours of being vaccinated.

In the U.S., 558 million COVID vaccine doses had been administered as of March 18, [including](#) 329 million doses of Pfizer, 210 million doses of Moderna and 19 million doses of Johnson & Johnson (J&J).

† Because some cases have multiple vaccinations and symptoms, a single case can account for multiple entries in this table. This is the reason why the Total Count is greater than 1195936 (the number of cases found), and the Total Percentage is greater than 100.

Every Friday, [VAERS](#) publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Historically, VAERS has been shown to report only [1% of actual vaccine adverse events](#).

U.S. VAERS data from Dec. 14, 2020, to March 18, 2022, for 5- to 11-year-olds show:

- [9,463 adverse events](#), including [228 rated as serious](#) and [5 reported deaths](#). The most recent death involves a 7-year-old boy (VAERS I.D. [2152560](#)) from Washington who died 13 days after receiving his first dose of Pfizer's COVID vaccine when he went into shock and suffered cardiac arrest. He was unable to be resuscitated and died in the emergency department.
- [16 reports](#) of myocarditis and pericarditis (heart inflammation). The CDC uses a [narrowed case definition](#) of "myocarditis," which [excludes cases](#) of cardiac arrest, [ischemic strokes](#) and deaths due to heart problems that occur before one has the chance to go to the emergency department.
- [36 reports](#) of blood clotting disorders.

U.S. VAERS data from Dec. 14, 2020, to March 18, 2022, for 12- to 17-year-olds show:

- [30,591 adverse events](#), including [1,755 rated as serious](#) and [42 reported deaths](#). The most recent deaths involve a 17-year-old boy (VAERS I.D. [2171083](#)) from Illinois with [Duchenne muscular dystrophy](#) who died from cardiac arrest after receiving his second dose of Pfizer's COVID vaccine, and a 14-year-old boy from Guam (VAERS I.D. [2157944](#)) who died one week after his first dose of Pfizer when he suddenly committed suicide. The boy's VAERS report states:

"Sudden suicide one week after the vaccine. Patient was a perfectly happy child. After the vaccine, he became much more tired and achy and lost interest in doing his sports. One week later, without any warning, he hung himself."

- [68 reports](#) of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death — with 96% of cases attributed to [Pfizer's vaccine](#).
- [648 reports](#) of myocarditis and pericarditis, with [636 cases](#) attributed to Pfizer's vaccine.
- [163 reports](#) of blood clotting disorders, with all cases attributed to Pfizer.

U.S. VAERS data from Dec. 14, 2020, to March 18, 2022, for all age groups combined, show:

- 20% of deaths were related to cardiac disorders.
- 54% of those who died were male, 41% were female and the remaining death reports did not include the gender of the deceased.
- The [average age](#) of death was [72.7](#).
- As of March 18, [5,294 pregnant women](#) reported adverse events related to COVID vaccines, including 1,679 reports of [miscarriage or premature birth](#).
- Of the [3,621 cases of Bell's Palsy](#) reported, 51% were attributed to [Pfizer](#) vaccinations, 40% to [Moderna](#) and 8% to [J&J](#).
- 869 reports of [Guillain-Barré syndrome](#), with 41% of cases [attributed to Pfizer](#), 30% to [Moderna](#) and 28% to [J&J](#).
- [2,371 reports](#) of anaphylaxis where the reaction was life-threatening, required treatment or resulted in death.
- [1,647 reports](#) of myocardial infarction.
- [13,602 reports](#) of blood-clotting disorders in the U.S. Of those, [6,077 reports](#) were attributed to Pfizer, [4,848 reports](#) to Moderna and [2,633 reports](#) to J&J.

Mother calls for more vaccine studies after 12-year-old experiences severe pericarditis
An Australian mother is [calling for long-term studies](#) on mRNA COVID vaccines and better advice for parents after her 12-year-old son was hospitalized for pericarditis just hours after getting the Moderna shot.

The mother, referred to in the media only as “Nat,” vaccinated her son despite being hesitant about the long-term health risks because she believed she was doing the right thing. But within seven hours of being vaccinated, her son was unable to sit or lie down without severe chest pain and complained of breathing difficulties.

ER doctors confirmed Nat’s son had [pericarditis](#), a condition characterized by inflammation of the membrane around the heart.

Nat said she was angry because she was hesitant about giving him the vaccine, but still chose to vaccinate him anyway. Now, she wants the federal government to [present better information](#) to parents on the risks of COVID vaccines to help them make a more informed choice on whether to immunize their children.

CDC removes tens of thousands of deaths ‘accidentally’ attributed to COVID

The CDC on March 15 [removed](#) from its data tracker website tens of thousands of deaths attributed to COVID, including nearly a quarter of the deaths attributed to children. The CDC said it made adjustments to the mortality data because its website’s algorithm was “accidentally counting deaths that were not COVID-19-related.”

Prior to the adjustment on March 15, the CDC reported 851,000 COVID deaths, including 1,755 pediatric deaths. After the change, COVID-related deaths dropped to 780,000.

The change resulted in the removal of 72,277 deaths previously reported across 26 states, including 416 pediatric deaths — a reduction of 24% to 1,341, the [agency said](#).

According to [The Guardian](#), the error arose from two questions the CDC asks states when they report COVID fatalities. One data field asks if a person died “from illness/complications of illness,” and the field next to it asks for the date of death.

When the answer is “yes,” then the date of death has to be provided. But if a respondent included the date of death but put “no” or “unknown” in the other field, the CDC’s system assumed the answer was an error and switched the answer to “yes.” This resulted in an over count of COVID deaths in the demographic breakdown.

The agency said once it discovered the problem, it corrected it, but it is unknown how long inaccurate COVID deaths were reported.

The CDC’s COVID statistics, used to justify which age groups [should receive vaccines](#), were used by U.S. health agencies to support the authorization of Pfizer’s COVID vaccine for children 5 to 11 years old.

Moderna to request authorization of COVID vaccine for kids 5 to 11

Moderna on March 23 [announced](#) plans to request [Emergency Use Authorization](#) (EUA) for its pediatric COVID vaccine, citing preliminary data showing

the two-dose regimen was safe for children under age 6, but may not be effective at reducing severe COVID.

The company [released partial results](#) from its two pediatric clinical trials in 6,900 children showing the mRNA shots were only about 44% effective at preventing symptomatic infection in children 6 months to 2 years old, and only 37% effective in children aged 2 to 5.

FDA [guidelines](#) for EUA products stipulate the product must show 50% efficacy. The company said the [majority of COVID cases](#) observed were mild and no severe disease, hospitalizations or deaths were reported among any of the children who participated in the trial, making it impossible to detect the vaccine's protective effect against the worst outcomes.

Moderna did not report details on types of side effects except for data on children who experienced fevers. The company said about 15% of children had fevers higher than 100.4 degrees, and 1 in 500 [experienced a fever](#) higher than 104 degrees.

However, [data show](#) the vaccine may not be effective at reducing severe COVID in children, who make up only a [small percentage](#) of SARS-CoV-2 infections — most of which are [asymptomatic and mild](#).

4th COVID shot offers little protection against infection

[A small study](#) conducted by Researchers at Sheba Medical Center in Israel found efficacy of a fourth dose of Pfizer and Moderna COVID vaccines resulted in only marginal protection from SARS-CoV-2 infection.

According to the [study](#), published in the New England Journal of Medicine, a fourth Pfizer dose showed 30% efficacy in preventing infection and Moderna's fourth dose showed only 11%.

The study's [authors said](#) a fourth dose provided “moderate protection against symptomatic infection” (Pfizer = 43%; Moderna = 31%), with symptomatic infection defined as a fever lasting either more or less than 48 hours. Other systemic symptoms included fatigue, myalgia, and headache.

However, these efficacy numbers fall short of the required [50% threshold](#) required by the FDA for EUA products in the U.S.

About 25.2% of fourth dose recipients experienced moderate-to-severe local reactions and 6.5% had moderate-to-severe systemic reactions to a second booster, while the majority of all COVID cases in participants were asymptomatic or had negligible symptoms.

On the same day that the FDA authorized a fifth mRNA COVID injection for immunocompromised individuals (and a fourth for the general population over 50), one of the FDA's top bureaucrats is already projecting more mRNA doses to come.

"I don't want to shock anyone, but there may be a need for people to get an additional booster in the fall," Peter Marks, the director of the FDA's Center for Biologic Evaluation and Research, [told reporters](#).

For mRNA compliant citizens, that round of shots would mark a fifth or sixth injection of a [non FDA-approved](#) experimental mRNA vaccine — which can cause significant side effects with each additional dose for some — within a two year window.

Marks explained that an FDA advisory committee will discuss the probability of another mRNA dose next week. That committee was supposed to meet before the latest booster authorization to evaluate the safety and efficacy of a fourth and fifth round of shots. The FDA decided to bypass that process entirely.

"It's not actually clear yet what the optimal booster should be," Marks said. "We're hoping by taking this action, we will help allow people to take steps to protect themselves should we have another wave to come through this country."

He added that the next dose might be one that is reformulated for a more current variant, but did not commit one way or another.

The current mRNA shot was designed by both Pfizer and Moderna to target the ostensibly original Wuhan strain of 2019. This strain no longer exists in circulation, and according to gene sequencing, it has not been the dominant strain for about two years.

The 2019 shot has never been updated, despite claims of an update being as easy as a computer-generated “copy and paste” procedure. Pfizer and Moderna both claimed that they were working on an Omicron vaccine — projecting that it would be ready in March of 2022 — but seem to have scrapped the plan, for reasons unknown to the public.

([Natural News](#)) For the past two years, we were told that the answer to the Wuhan coronavirus (Covid-19) *plandemic*, and the thing that would “save lives,” was everyone taking the Operation Warp Speed “vaccines.” It turns out; however, that population growth in the United States has [reached an all-time low](#) ever since the jabs were introduced.

In 2021, the year when most of the “fully vaccinated” got their jabs, the U.S. saw its population growth reach the lowest levels ever. This is according to the latest data from the Census Bureau.

The year prior, 2020, was not much better, as the population growth rate in America has been declining for some time. But things really ramped up in the depopulation department right after the “cure” for the Fauci Flu was introduced on a broad scale.

“U.S. growth didn’t slowly fade away: It slipped, and slipped, and then fell off a cliff,” wrote Derek Thompson for *The Atlantic*.

“The 2010s were already demographically stagnant; every year from 2011 to 2017, the U.S. grew by only 2 million people. In 2020, the U.S. grew by just 1.1 million. Last year, we added only 393,000 people ... What’s going on?”

Thompson answers his own question in a roundabout way by pointing out that the vast majority of deaths in America occurred *after* the shots were released. He adds that they were particularly concentrated in 2021, which is when most people got jabbed.

“Last year, deaths exceeded births in a record-high number of U.S. counties,” Thompson further points out. *“Never before in American history have so many different parts of the country shrunk because of ‘natural decease,’ which is the difference between deaths and births.”*

Rather than blame the jabs for declining population numbers, *The Atlantic* says there isn’t enough immigration

Between 2019 and 2021, excess deaths accounted for 50 percent of the difference in population growth. Thompson blames the “pandemic” for this, but the reality is that a bulk of those deaths occurred after the jabs were introduced, and after they were plunged into people’s arms.

He stops short of linking the two things together, of course, but it is clear from his deduction as to the true cause of much of this death: the so-called “vaccines.” (Related: Covid vaccines have [been linked](#) to causing AIDS.)

Amazingly, Thompson goes into a lengthy diatribe blaming a lack of immigration in recent years on America’s declining population numbers. Back in 2016, he says, as many as one million new people from other countries legally immigrated to the U.S. Now, that figure is around 250,000 a year.

Gates Foundation created Moderna to experiment on human genetics for years to come How did Bill Gates predict future pandemic years prior to the COVID-19 scandal? How did Bill Gates know that 2020 would be a great year to invest in new vaccines? Why was Bill Gates so adamant about locking down the economy and holding people hostage in their homes?

Back in 2016, the Bill & Melinda Gates Foundation granted [\\$20 million to a little-known biotech company named Moderna](#). The funds were used to support their “initial project related to the evaluation of antibody combination in a pre-clinical setting

as well as the conduct of a first in human Phase 1 clinical trial of a potential mRNA medicine.”

Under the framework agreement, the Bill & Melinda Gates Foundation granted Moderna up to \$100 million in funding for “follow-on projects” that can only be approved by the Gates Foundation. As part of the agreement, Moderna is obligated to grant the Gates Foundation certain non-exclusive licenses. These non-exclusive licenses allow the Gates Foundation to exploit the mRNA technologies created by Moderna to allow other licensees to profit from this same intellectual property. Bill and Melinda Gates are therefore [profiting from the Moderna mRNA injections](#) that they funded. These inventions were developed long before COVID-19, and were even launched before a global pandemic was declared.

In fact, Moderna was used as a vessel to patent precise genetic sequences of the SARS-CoV-2 bioweapon. Scientists from Switzerland, India, Italy, and the United States [published a paper](#) showing that [Moderna patented a specific 19-code nucleotide sequence](#) that gave SARS-CoV-2 its enhanced properties for infectivity. The authors wrote that there is only a one in three trillion chance that this 19-code nucleotide sequence would appear naturally and contain the unique furin cleavage site. Moderna patented that gene sequence (US9587003B2) on February 4, 2016. These Moderna patents also include US9149506B2, US9216205B2, US9255129B2, and US9301993B2 from December 16, 2013. The enhanced coronavirus was developed six years prior to COVID-19, and was rapidly generated with funds from the Bill and Melinda Gates Foundation.

The final codon patented by Moderna is as follows: “CTCCTCGGCGGGCA.” The CGG coded Furin Cleavage site is as follows: “CCTCGGCGGGCACGT.” These sequences do not occur naturally in viruses, but they do occur naturally in cows, plants, bacteria and humans. Since bacteria cannot naturally insert their genes into viruses, there is only one way this precise bacterial DNA could end up inside the SARS-CoV-2 virus. It could only be inserted through laboratory interference [using precision gain-of-function techniques](#) such as serial passage or no-see-um manipulations.

Moderna and NIAID transferred mRNA vaccine candidates to UNC before the causative agent was officially identified for the Wuhan outbreaks.

In the beginning of the COVID-19 scandal, pneumonia of “unknown cause” was discovered on December 31, 2019. On January 9, 2020, the [WHO determined](#) that the pneumonia outbreak in Wuhan China was the result of a new causative agent, SARS-CoV-2. Astonishingly, mRNA coronavirus vaccine candidates developed by Moderna were transferred to the *University of North Carolina* three weeks prior (on December 12, 2019). It had been several years since a coronavirus posed a threat to humans, yet Moderna was ready with a “vaccine” to respond to outbreaks in Wuhan, China before a causative agent could be identified, before a pandemic could be quantified.

A confidential agreement between Moderna and Fauci's NIAID, (dated December 12, 2019) agreed to transfer "mRNA coronavirus vaccine candidates" to recipients at UNC. The NIH, the FDA and the CDC were all in on it, too. Ralph Baric and Jacqueline Quay signed the agreement on Dec 12th and Dec 16th, respectively. It was also signed on December 12, 2019 by NIAID representatives Amy F. Petrik and Barney Graham. Moderna's investigator, Sunny Himansu, and Moderna's Deputy General Counsel Shaun Ryan also signed the mRNA vaccine transfer agreement on December 17, 2019.

The genetic sequences, the patented evidence and the time stamps for vaccine transfers point to the reality that there was a well-funded conspiracy behind COVID-19. There was a predatory vaccine development program that relied on the intentional [release of a bioweapon](#) and subsequent lock downs and medical tyranny. Since this collusion began, Moderna has profited billions from this predatory vaccine development and pharmaceutical racketeering. Several licensees have also taken advantage of this mRNA technology, which was originally funded and approved by the Bill & Melinda Gates Foundation, and forced onto populations using the NIAID and Fauci's human rights violations.

Corrupt FDA trying to ban NAC, which detoxifies the body and wards off COVID

[\(Natural News\)](#) Because of how effective it is against the Wuhan coronavirus (COVID-19) and presumably other bioweapons, n-acetyl-cysteine (NAC) is [in the crosshairs](#) of the U.S. Food and Drug Administration (FDA), which is trying to ban it.

A powerful antioxidant (you can learn more about it in one of our [earlier articles](#)), NAC helps to detoxify the body of harmful compounds, including potentially the spike proteins associated with the Fauci Flu.

The first phase of detoxification involves oxidizing harmful toxins in order to break them down and move them through the body's detoxification pathways. Consuming foods that are rich in antioxidants, such as B vitamins, vitamin C, and magnesium, helps to activate these pathways.

The second phase of detoxification involves actually moving the broken-down toxins out of the body. This is where NAC (and glutathione, which is made by NAC) come into play.

“NAC is a selective immune system enhancer, and, as mentioned above, helps remove free radicals, which contribute to neurodegenerative diseases and aging,” explains the Alliance for Natural Health USA (ANH-USA).

“NAC is also a precursor to glutathione, one of the body's most important antioxidants. Glutathione plays crucial roles in human health, particularly in detoxification.”

Call or write your representatives and tell them to stop the FDA from banning NAC.

The FDA's argument against NAC is that it was supposedly a “drug” before it was ever a supplement. Truth be told, NAC is a naturally occurring nutrient, despite what the FDA claims.

Even so, Big Pharma wants to turn NAC into an expensive drug using a new indication. And since the pharmaceutical industry has deep pockets, the FDA is attempting to pull NAC from the supplement market.

“This is outrageous on a number of fronts,” ANH-USA maintains. *“Consider that NAC is used in hospitals to treat acetaminophen poisoning precisely because it helps detoxify – yet the FDA threatens to remove NAC as a supplement and make it harder for consumers to obtain?”*

In order to actually ban NAC, the FDA would have to willfully misinterpret the law as directed by the Dietary Supplement Health and Education Act of 1994, also known as DSHEA.

That law states that if an ingredient is investigated as a drug before it is sold as a supplement or a “new supplement” notification has been filed, then that substance cannot be designated as a supplement.

“But DSHEA is not supposed to have a retroactive effect; that is, the law going forward from DSHEA’s enactment is, if an ingredient is studied as a drug after 1994, and that ingredient wasn’t sold as a supplement before studied, it cannot be a supplement,”

ANH-USA further reveals.

“It would be unfair and inconsistent with Congressional intent to retroactively apply this provision to all substances studied as drugs since drug approval began. Otherwise, supplements that was legal before 1994 (like NAC) and sold for decades can suddenly and absurdly become illegal.”

Because NAC is a critical nutrient for many things beyond just covid, helping to protect our bodies against a constant onslaught of toxins and pollutants from a variety of sources, it is imperative that the FDA be stopped from banning it.

ANH-USA has created [an Action Alert page](#) through which you can write to Congress and urge its members to block the FDA from implementing a ban.

“This is a direct threat to a supplement that many integrative doctors and patients rely on to address a variety of health conditions,” ANH-USA warns. “We cannot let the FDA get away with removing these supplements from the market.”

This type of action by the FDA is not new. The UN has been attempting to ban supplements since the Codex Alimentarius was introduced in the 1960s. Codex Alimentarius Summarized in 7 Points

HealthFreedomUSA.org, the website of the Natural Solutions Foundation, is beholden to no one: our only interest is health freedom. Rima E. Laibow, MD, successful natural medicine physician since the 1970s, has studied 16,000 pages of Codex documentation. Her conclusion is that people who say that Codex is "consumer protection", "voluntary", or "harmless" are, at best, seriously mistaken.

1) Started in 1962 by UN, Imposed by WTO Sanctions

Codex Alimentarius was created in 1962 as a trade Commission by the UN to control the international trade of food. Its initial intentions may have been altruistic but it has been taken over by corporate interests, most notably the pharmaceutical, pesticide, biotechnology and chemical industries.

Codex Alimentarius is backed up by the crippling trade sanctions of the World Trade Organization (WTO). Any non-Codex-compliant nation would face huge economic punishment since they would automatically lose in any food-trade dispute with a Codex compliant country.

2) "Nutrients are Toxins" Is Junk Science

Codex Alimentarius Commission (CAC) has two committees which impact nutrition.

One of them, the "Codex Committee on Nutrition and Foods for Special Dietary Uses" (CCNFSDU), is chaired by Dr. Rolf Grossklauss, a physician who believes that nutrition has no role in health. This is the "top-guy" for Codex nutritional policy, and he has stated that "nutrition is not relevant to health".

As unbelievable as it may sound, Dr. Grossklauss actually declared nutrients to be toxins in 1994 and instituted the use of toxicology (Risk Assessment) to prevent nutrients from having any impact on humans who take supplements! It is worth mentioning that Dr. Grossklauss happens to own the Risk Assessment company advising CCNFSDU and Codex on this issue. This company makes money when its toxicology services are used for the "assessment" of nutrients. Here in the U.S. we call that a "conflict of interest".

Codex is made up of thousands of standards and guidelines. One of them, the Vitamin and Mineral Guideline (VMG), is designed to permit only ultra-low doses of vitamins and minerals (and make clinically effective nutrients illegal). How can the VMG restrict dosages of vitamins and minerals? By using Risk Assessment (toxicology) to assess nutrients.

While Risk Assessment is a legitimate science (it is a branch of toxicology), it is the wrong science for assessing nutrients! In fact, in this context, it is actually junk science. Biochemistry, the science of life processes, is the correct science for assessing nutrients. Codex Alimentarius treats nutrients as toxins, which is literally insane.

Nutrients are not toxins - they are essential for life.

No matter what Codex Alimentarius officials say to convince you that Risk Assessment is a "science-based" approach to nutrients, it is not.

And it is worth repeating that Dr. Grossklauss, the head of Codex Alimentarius, owns the Risk Assessment company advising CCNFSDU and Codex on the "benefit" of using Risk Assessment to assess nutrients.

3) Not Consumer Protection - That's Propaganda

Contrary to the propaganda, Codex Alimentarius has nothing to do with consumer protection. Nothing! Codex is about the economic ambitions of multi-national corporations, in particular, the pharmaceutical industry.

Using their multibillion-dollar marketing budgets, these industries have launched a massive media propaganda campaign to paint Codex Alimentarius as a benevolent tool of "consumer protection", as well as to negatively taint the image of natural health options and mislead people to fear them as "dangerous", so they will take drugs (which really are dangerous). Natural health products and options have an amazing safety record and are remarkably effective, especially when compared to pharmaceutical drugs.

Unfortunately, one-time defenders of health freedom such as National Nutritional Foods Association (NNFA) and Council for Responsible Nutrition (CRN) have joined the propaganda bandwagon and are spreading false information saying that Codex Alimentarius is either "harmless" or benevolent "consumer protection". Neither is true.

The membership of these one-time defenders of health freedom has become permeated by people from the pharmaceutical industry (for example, CRN counts as its member's corporations such as Monsanto® and Bayer®).

4) Codex: Serious Threat to Health and Health Freedom

If Codex Alimentarius is implemented in the United States of America, therapeutic dosages of vitamins and minerals (and all other nutrients soon to follow) will become unavailable because they will literally become illegal.

Here's how it would work, in a nut-shell:

Due to the junk science use of Risk Assessment (toxicology) to assess supposedly toxic nutrients, a false belief is being engineered saying that "nutritional supplements are dangerous to people's health".

Using this false belief generates calls to "protect" people from these "toxic" nutrients. After the calls come the bills to set ultra-low permissible dosages (remember, nutrients are deemed "dangerous toxins" under this false belief). If enough of us and our Congressional delegates buy this nonsense, we and Congress would blindly comply with Codex Alimentarius' VMG. And blind compliance is what the industries behind Codex Alimentarius intend.

One of the subtle tricks played by the FDA has been to lower the recommended RDA for vitamins and supplements. Being a health advocate since the 1990s, it was not long before I soon discovered most vitamins and supplements were "downgraded" or the RDA (recommended daily allowance) level is so much lower and thus ineffective for the human body.

Blind compliance goes hand-in-hand with lack of activism. This lack of activism allows our protective laws, classifying nutrients as foods with no upper limits (such as DSHEA), to be easily repealed and replaced with draconian laws to classify nutrients as toxins. And "harmonization" with the pro-illness, pro-pharmaceutical industry Vitamin and Mineral Guideline is there to fill the void.

Only intentionally ineffective, ultra-low dose supplements would be legal, with or without a prescription, on the VMG list. If enough people do not take action, we can expect to watch nutritional supplement manufacturers and, thus health food stores, to go out of business, in a domino effect. The only player left standing would be Big Pharma.

Therapeutic grade vitamins, minerals, and amino acids would be eliminated from the marketplace (although a few low-dose supplements would be allowed by Codex, as a symbolic measure to avoid suspicion about their ulterior motive).

Natural health professionals would lose the tools of their trade (nutritional supplements) and health conscious people would be unable to choose natural health options for health promotion and disease treatment.

And that is, in a nutshell, how Codex Alimentarius is poised to make Natural and Nutritional Medicine (NNM) disappear from the legal health world and go underground. Who benefits? Big Pharma.

It would take a few years for the above scenarios to be feasible (Codex Alimentarius is meant to go into full global effect by 2010). The slower the process takes, the less alarmed people will be. That's probably the logic of the architects of Codex Alimentarius.

5) Serves Economic Interests of Sickness Industries Through WTO and Napoleonic Code

More and more people are turning to natural health products globally. The "wellness" trend is a major trend in today's society. The more natural health products people use, the fewer drugs they buy. The pharmaceutical industry, which is part of the "Sickness Industry", fears the inevitable shift toward natural health care.

Instead of accepting the will of the people and rethinking the future of the pharmaceutical industry, the industry has decided upon an unethical course of action: the use of deception and deceit to eliminate natural health products completely.

Codex Alimentarius is a shrewd vehicle for protecting the pharmaceutical industry from the loss of income it stands to suffer due to the inevitable growth of natural healthcare.

Codex Alimentarius is the resistance of the dinosaurs to inevitability: the burgeoning desire of humanity for a healthier, saner, and more sustainable way of life.

The World Trade Organization (WTO) intends to force Codex Alimentarius upon the nations of the world, including the U.S. This would be done under the threat of massive economic sanctions if WTO-countries do not comply with Codex Alimentarius.

Furthermore, Codex is based in the Napoleonic Code, not Common Law. That means that under Codex Alimentarius, anything not explicitly permitted is forbidden. Under Common Law, we hold that anything not explicitly forbidden is permitted. The difference is the difference between health freedom and health tyranny. Codex Alimentarius would be able to ban supplements by default.

6) DSHEA Protects America From Codex Alimentarius

The Dietary Supplement Health and Education Act (DSHEA, 1994), an American law classifying our supplements and herbs as foods (which can have no upper limit set on

their use), was passed by unanimous Congressional consent following massive grass-roots support organized by health food stores. Millions of American activists told Congress, in no uncertain terms:

"Protect nutritional supplements as foods or we will remove you from office".

Congress listened and carried out the will of the people.

DSHEA appropriately classifies nutritional supplements as foods which can have no upper limits set on their use. DSHEA recognizes that people use nutrients safely to deal with their individually differing needs for nutrients. The concept of biochemical individuality means that people have different needs for nutrients at different times. Are nutrients toxins? No, they are not toxins. They are substances essential to prevent, treat and cure any chronic condition, in differing doses at different times in different people.

DSHEA protects the US from Codex Alimentarius' deadly Vitamin and Mineral Guideline. We must reach our Congressional members, educate them about the facts on Codex Alimentarius and direct them to vote against anything that would threaten DSHEA.

Congress holds the keys to our health freedom. And it is their job to listen to us. Let's not allow cynicism to tell us otherwise. We did it for DSHEA in 1994. We can do it again in 2005.

Dr. David Martin: COVID vaccines are bioweapons designed for genocide

"This is a pandemic of the bio weaponization of the human organism. This is not public health. And Anthony Fauci is the architect of this genocide," Martin said when he appeared in the March 24 episode of "The Stew Peters Show." Martin added that [these proteins are known to be damaging](#) and are subject to the biological and chemical weapons, treaties and laws that have been enforced in the United States. These chimeric viruses resulted from the deliberate manipulation of SARS-CoV-2, to incorporate nucleic acids into the virus, which is illegal.

With the fourth COVID-19 shot now underway in the U.S., Fauci is talking about possibly doing another round of lockdowns, and it seems that plenty of Americans will participate because many have been brainwashed by the so-called experts.

SARS-CoV-2 chimeric viruses a result of deliberate manipulation

However, that is not the same track, which the lawyers reminded me last night is a longer track of the attorneys – these 250 attorneys – deliberating and creating subcommittees and making decisions themselves, and asking for follow-up documents from the volunteers. That’s going to be a longer process, and it’s also a confidential process.”*

Just a few days ago, Edward Dowd, who was once a portfolio manager at Blackrock, discussed the Pfizer agenda and how data and facts are destroying it. He told Robert F. Kennedy Jr., *“The rate of change [in all-cause mortality] is the smoking gun. The rate of change and the acceleration into mandates and boosters. Basically, in my mind, it’s case closed.”*

That wouldn’t be the only time Dowd spoke out against the COVID-19 narrative, as he explained to WND that the CDC data shows the jab was one of the main causes of deaths among the millennial generation. Yet, it is still being pushed, glorified, and promoted even today.

Millennials, about ages 25 to 40, experienced an 84% increase in excess mortality in the fall, he said, describing it as the [“worst-ever excess mortality, I think, in history.”](#) It was the highest increase in excess deaths of any age group last year, seven times higher than the Silent Generation, those who are older than 85.

The increase coincided with the vaccine mandates and the approval of the booster shots.

He said the insurance expert with whom he worked is presenting the data to a financial group and will reveal his identity. 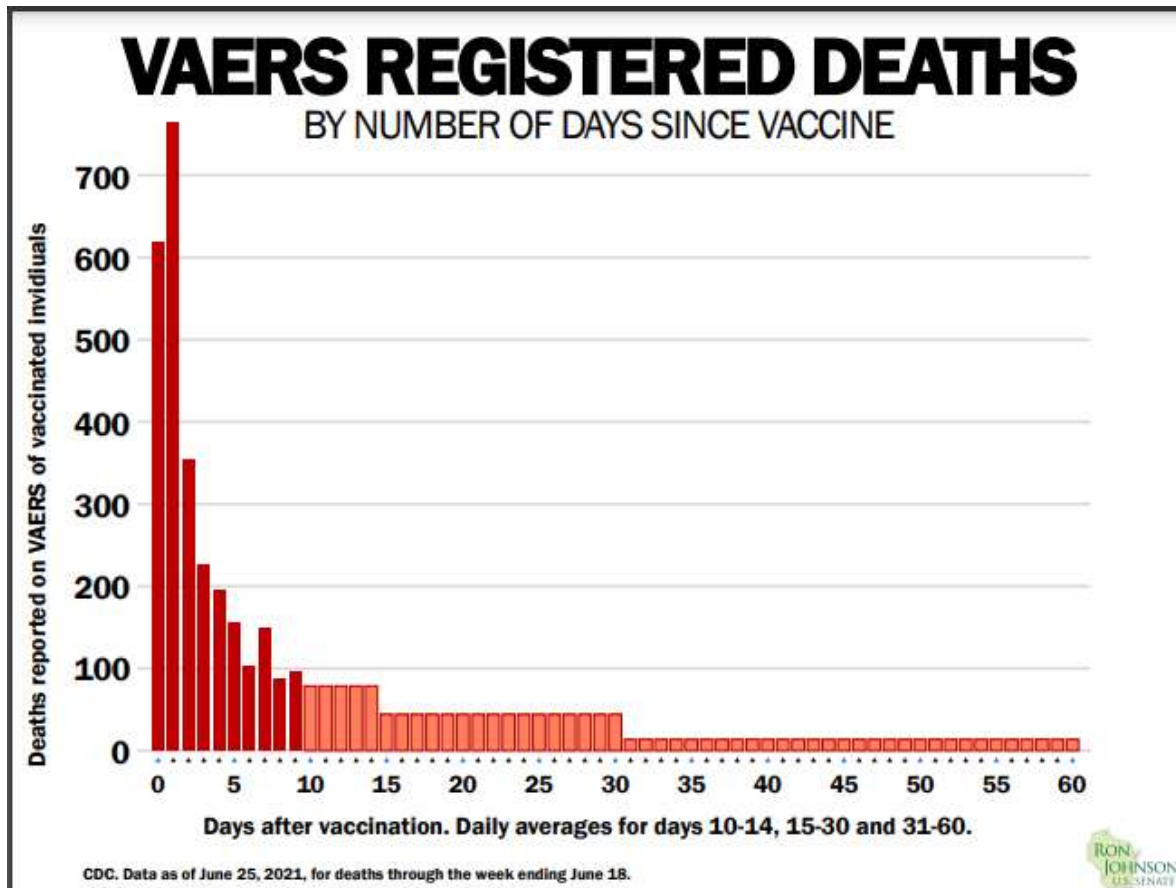

It measures viral particles, nucleic acid....I can continue to be positive with a PCR...after recovering and not being transmissible at all.... it doesn't give you any indication of whether or not you're transmissible.”** Nevertheless, lockdowns, quarantines, and “contact tracing” are now ordered on the basis of PCR tests, and the resulting “case” numbers.

World-Class Pathologists Report Bizarre Attacks on Organs by the Body’s Own Immune System

At the [pathology conference series attacked by Reuters](#), held in Germany last fall, Doctors Arne Burkhardt and Walter Lang reported that never-before-seen immune system attacks on the body’s own organs were present in multiple autopsies they had performed of people who died suddenly soon after receiving the injections.

[Dr. Arne Burkhardt has taught](#) at the Universities of Hamburg, Berne and Tübingen. He has published more than 150 scientific articles in German and international scientific journals, and has audited and certified institutes of pathology in Germany.

[Prof. Dr. Walter Lang](#) was a pathologist at the Hannover Medical School from 1968-1985. Afterwards, for 25 years, Lang directed a private institute for pathology, which he founded, specializing in transplant pathology, extragynecological cytology, thyroid tumors, and lung/pleural pathology.

[The Epoch Times](#) reported on September 22, 2021 (click on Google translate from German to English):

“The doctors suspect autoimmune phenomena, reduction in immune capacity, acceleration of cancer growth, vascular damage “endothelitis”, vasculitis,

perivasculitis and erythrocyte “clumping” as further corona vaccination side effects with potential fatal consequences...Burkhardt described it as “extreme” that among the ten deceased examined, three very rare autoimmune diseases were found, namely Sjögren’s syndrome, leukoclastic vasculitis of the skin and Hashimoto’s disease.”

[The Epoch Times](#) wrote:

“[Burkhardt] can only think of one term for what [he] has been investigating with his colleagues over the past few months – “lymphocyte amok”, potentially in all tissues and all organs.”

The study cited in the [Reuters article](#) is “[COVID-19 Vaccination and Non-COVID-19 Mortality Risk.](#)” It finds that in a sampling of 11 million people, all-cause mortality is actually lower in vaccinated people than unvaccinated. Quoting a researcher with a PhD in philosophy, Reuters wrote: *“Dr. Cornish...contrasted the [autopsy studies] with a U.S. study of roughly 11 million people aged 12 and above which ‘showed that recipients of COVID-19 vaccines had slightly lower rates of (non-COVID-19) mortality than unvaccinated individuals.”*

But again, if you die before 14 days has passed since your last shot, you are “unvaccinated.”

Burkhardt and Lang’s Findings Support Dr. Peter Schirmacher’s, Director of the Pathological Institute of the University of Heidelberg

Reuters “Experts” Include a Veterinarian

For other “experts,” the [Reuters](#) hit piece dredges up a veterinarian, [Professor Neil Mabbot](#), to snipe that he would be “very surprised” if a “preprint” passes review, without saying why, and Prof. Kevin McConway, emeritus professor of applied statistics at the Open University, an online college. Concern is expressed over the size of the sample of cadavers, even though the pathologists conducting the studies have never claimed that they had a statistically conclusive sample. They claim their findings are already alarming enough to call a halt to all further vaccinations, and warrant further study.

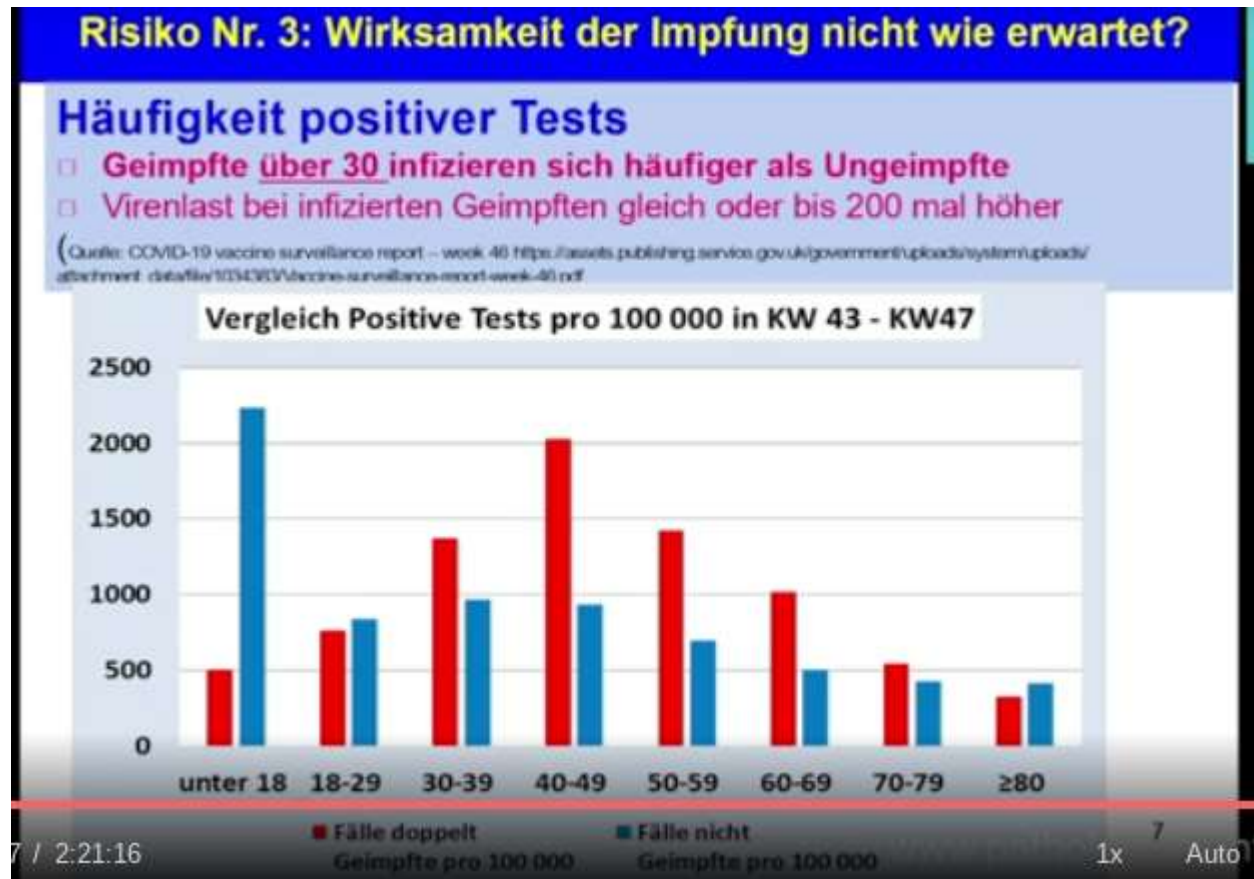

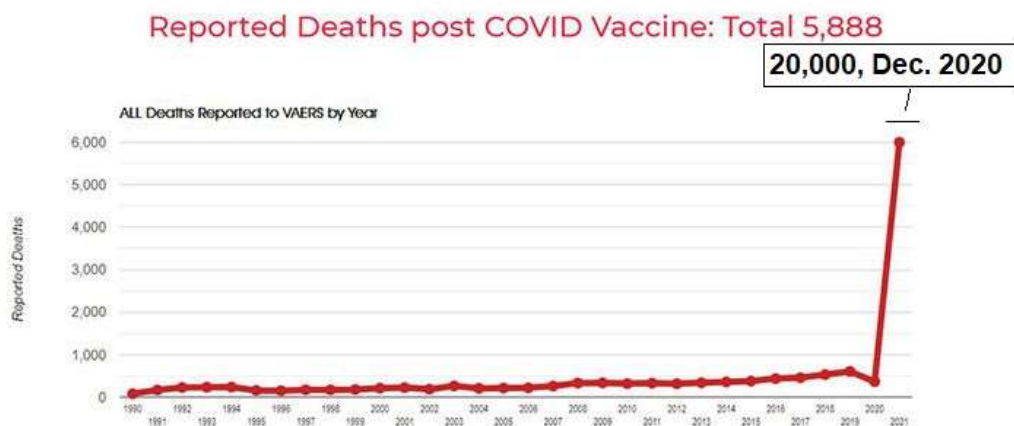
Dr. Bhakdi and Dr. Burkhardt have authored a joint statement, entitled [“On COVID vaccines: why they cannot work, and irrefutable evidence of their causative role in deaths after vaccination,”](#) posted at [Doctors for Covid Ethics](#).

In October of 2021, the peer-reviewed, highly-regarded science journal [Toxicology Reports](#) published a study which estimated deaths directly caused by the vaccines **“could be in the hundreds of thousands for the USA,”** and stressed that long-term effects are as yet unknown.

Another pathologist, [Dr. Ryan Cole, MD](#), who holds medical degrees from Virginia Commonwealth University School of Medicine and the Mayo Clinic School of Medicine, has made similar warnings about the vaccines. Doctors for COVID Ethics last April sent [letters to all members of European parliaments](#) who were mandating the experimental vaccinations that they are committing Crimes Against Humanity. The average time for bringing any new drug or vaccine to general [use is 10 years](#), including typically [three to six years of animal trials](#) before human testing.

Last June, enlisting the aid of certain doctors and scientists, the media launched [into attack mode immediately](#) after a Canadian immunologist warned that the Pfizer/Moderna injections might pose a danger to the body's organs, in particular the heart, brain, and through blood clotting issues.

Dr. Bridle's concerns were echoed by [Dr. Robert Malone, one of the inventors](#) of the mRNA technology now being used by Pfizer and Moderna. Pfizer has requested in the past that the clinical trials data for its COVID injection be kept hidden [from public view for 75 years](#). Hospitals take in an average of [\\$160,000 extra per COVID case](#) from the US government. And in his new book, [The Real Anthony Fauci](#), Robert F. Kennedy Jr. reveals that high FDA officials are allowed to own parts of patents on the very drugs they are charged with regulating, and can keep up to [\\$150,000 per year in royalties](#), for life.

it is the new agent that is causing it. And you are obliged to go and find out. You are not allowed to turn away, you are not allowed to turn away.”

Best estimates are that COVID is a 99.9% recovery rate virus, similar to flu, according to Stanford [epidemiologist Dr. John Ioannadis](#). Common flu is 99.9%.

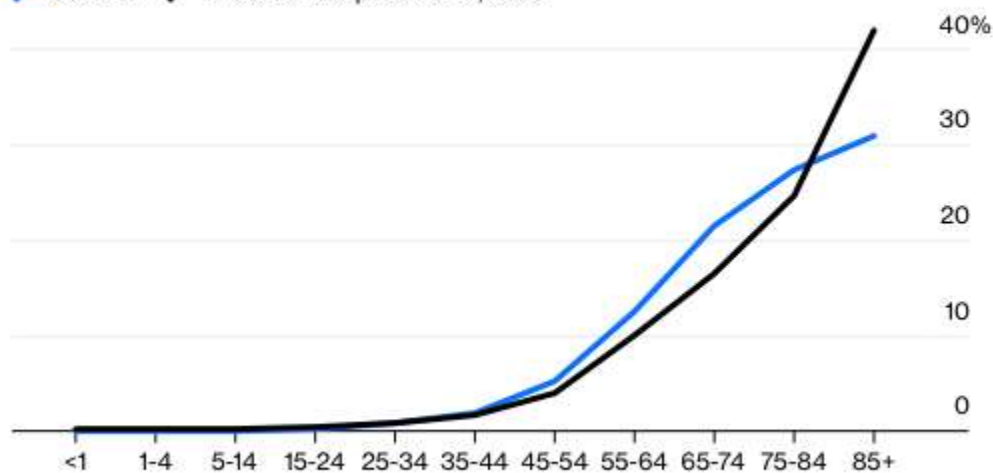

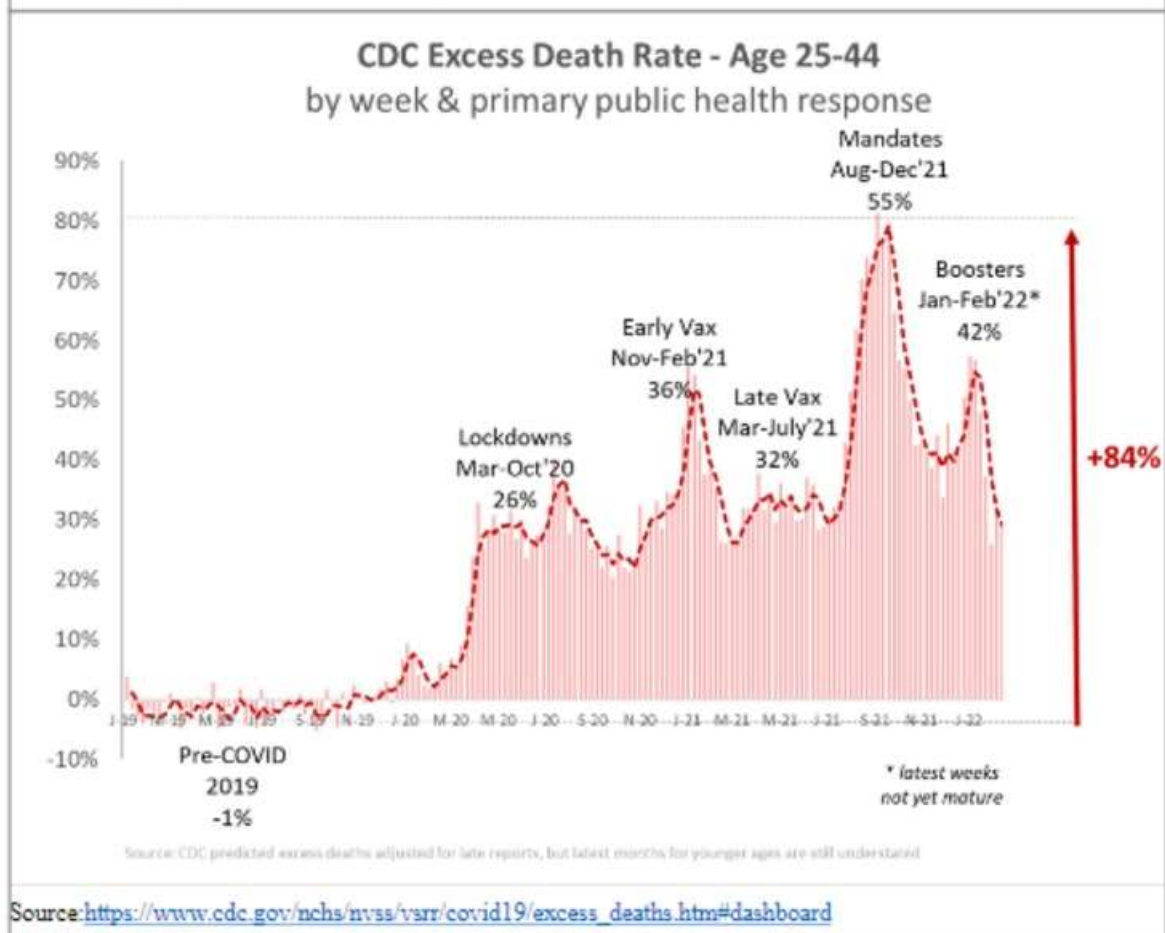

Greatest fraud in modern history: Multiple studies show COVID-19 vaccines do not stop infections, transmissions, hospitalizations and deaths

([Natural News](#)) Studies on the Wuhan coronavirus (COVID-19) vaccines found that they do not effectively stop the transmission of the disease, bringing into question the necessity of mandating them.

Epidemiologist Paul Alexander recently published a round-up of some of the newest evidence that [calls into question the safety and efficacy of COVID shots](#).

Among the studies that he summarized was one from Israel that showed vaccinated individuals who have never been previously infected with SARS-CoV-2 had a 13-fold increased risk of getting infected with the delta variant compared to those who have been unvaccinated but have been previously infected, showing that natural immunity is more effective.

Another study from the *European Journal of Epidemiology* found that there is no significant relationship between COVID-19 cases and the number of people getting vaccinated on a countrywide level. In other words, getting more people injected does not necessarily lower the spread of the virus.

Official data from the United Kingdom also showed that fully vaccinated adults now have a higher risk of COVID-19 infection, hospitalization and death compared to the unvaccinated.

Based on the studies, Alexander concluded that COVID vaccines are not to be expected to contribute to eliminating the communal spread of the virus or reaching herd immunity. He also said the studies “unravel the rationale for vaccine mandates and passports.” (Related: [Over 400 studies show COVID-19 measures are failures... lockdowns don't work, masks don't work and school closures help no one](#).)

Alexander also noted that taking the vaccine escalates the person's risk of getting infected. This is called negative efficacy, which is jargon for [disease-promoting effects in drugs](#). In the case of a vaccine, this means that the vaccinated person is more likely to get infected compared to the unvaccinated.

This is bad, in particular, because evidence shows that the vaccines are non-sterilizing and that they do not stop infection, transmission, hospitalization or death. They never worked.

For Alexander, what is happening with the COVID vaccines is reminiscent of the negative vaccine efficacy of the dengue vaccines that killed children in the Philippines in 2017, where the shots should not have been used.

Today, the repercussions of COVID vaccines show a massive [increase in all-cause mortality numbers](#) reported by insurance companies. Excess deaths are also showing up in almost all age cohorts and cannot be explained away by other causes, and the COVID-19 vaccine is now being referred to as the “greatest fraud” in modern history.

Embalmers, funeral directors reveal that COVID-vaccinated bodies show “unusual blood clots”

([Natural News](#)) All around the world, embalmers and funeral directors are [coming forward](#) to tell all about how the state of human remains has changed for the worst ever since Wuhan coronavirus (COVID-19) “vaccines” emerged.

Debra Heine of the *Minnesota Sun* reported that strange, rubbery, worm-like clots are evident in the veins and arteries of deceased, fully vaccinated bodies – which Richard

Hirschman, a funeral director and embalmer from Alabama with more than 20 years of experience in the field, said he never saw until around mid-2021.

Hirschman recently told Steve Kirsch, the executive director of the Vaccine Research Center (VRC), that in January of 2022, 37 out of 57 bodies he processed, or 65 percent, showed these suspicious clots.

Before the injections were introduced under Operation Warp Speed, blood clots would occasionally show up in bodies that died with COVID-19, but not to the degree that they are now appearing ever since the shots were widely administered.

Cary D. Watkins, who has more than 50 years of experience as a funeral director and embalmer, corroborated Hirschman's observations, as did Anna Foster, an embalmer from Missouri with 11 years of experience.

Foster revealed in an interview that a shocking 93 percent of her last 30 cases died due to unusual blood clots completely overtaking the victims' vascular systems. These sure sounds like jab-induced spike protein damage that for many results in death.

Fully vaccinated corpses contain "white, fibrous, wormlike" blood clots

Across the pond in England, Funeral Director John O'Looney said he is seeing a massive increase in thrombosis deaths. In an interview, O'Looney revealed that it is not just *"a two- or three-fold increase – it's around a 500 or 600 percent increase."*

"I've got doctors and police ringing me, nurses ringing me, all saying the same thing. It's a total lie," he is quoted as saying.

"On our media, they are saying the hospitals are full of the non-vaccinated. That's a total fabrication. It's the polar opposite. Nine out of 10 patients in there, full of blood clots, are the vaccinated. I've heard that from so many professionals that I've lost count. So, whether you choose to believe it or not, it makes it no worse. That is the truth. That is the reality. You can lead a horse to water, but you can't make it drink."

At first, O'Looney was not sure if he should come forward at all. Like the others in his field who are seeing the same thing, O'Looney recognizes that governments and media outlets are pushing a pro-jab narrative, and that anything opposing it will be mocked and ridiculed.

In a worst-case scenario, O'Looney and the others could lose their jobs for telling the truth. But it is a risk they ultimately decided was best to take in the interest of public health.

"It pretty much has to be a novel injectable product, first used in 2021 those results in blood clots and is injected into well over 50 percent of the population," Kirsch wrote on his Substack. *"There is only one drug that fits that bill: the COVID vaccines."*

It seems to be the case that some batches of the injections are more toxic than others, which would explain why some people who got the injections appear to be just fine while others [are suffering](#) or dead.

Those who get the worst of it can end up with long blood clots that morph into white and fibrous “wormlike” abominations, Kirsch revealed.

“That white, fibrous stuff just isn’t normal,” Kirsch told Dr. Jane Ruby. “Typically, a blood clot is smooth – it’s blood that’s coagulated – but if you squeeze it, or touch it, or try to pick it up, it generally falls apart.
