## Judicial Watch sues government over refusal to disclose COVID “vaccine” side effects

**(Natural News)** The U.S. Department of Health and Human Services (HHS) is refusing to comply with requests for data surrounding adverse side effects caused by Wuhan coronavirus (COVID-19) “vaccines,” so Judicial Watch is suing.

According to reports, the legal watchdog group has filed a Freedom of Information Act (FOIA) suit against the HHS for ignoring an August of 2021 request for:

*“All emails sent to and from members of the Vaccines and Related Biological Products Advisory Committee regarding adverse events, deaths and/or injuries caused by investigatory vaccines for the prevention or treatment of SARS-CoV-2 and/or COVID-19 currently produced by Pfizer / BioNTech, Moderna and/or Johnson & Johnson.”*

HHS of course failed to procure any of this information, so Tom Fitton, president of Judicial Watch, did what he usually does: *take action*.

*“The government’s unlawful stonewall on this issue, which will now take a federal FOIA lawsuit to resolve, suggests that there is something to hide,” Fitton says. “Americans have a right to know about any and all safety issues tied to the COVID vaccines.”*

### **America: Your government is working against you, not for you**

In an article he wrote for *The Federalist*, Dr. David Gortler, a pharmacologist, pharmacist, and an FDA (U.S. Food and Drug Administration) and health policy fellow at the Ethics and Public Policy Center, questioned why the government is insisting upon keeping Americans in the dark about Fauci Flu shots.

*“The FDA, Centers for Disease Control, Pfizer, and Moderna knew about myocarditis and pericarditis risks from the mRNA vaccines since day one, yet made no formal warnings to Americans in the form of recommending labeling changes or any other warnings, such as letters to warn physicians, pharmacists, or the American public,” Gortler writes.*

*“Elementary drug safety education tells us that when any risk appears in small, preliminary, highly controlled, manufacturer-sponsored initial studies with specially selected subjects by the sponsor, there is significant potential that it would translate to many people having that risk when that same drug is administered to, say, much of the planet.”*

It is critical, Gortler added, that those conducting these trials, as well as the government, pay close attention to any adverse events that manifest during the early stages of experimental drug testing, including with the all-new mRNA (messenger RNA) technology that was used in the injections from Pfizer-BioNTech and Moderna.

*“Under the normal run of things, the responsibility of notifying consumers and prescribers of updates in safety and efficacy would fall upon manufacturers,” Gortler maintains.*

*“But since COVID-19 vaccinations were mandated by the White House for all workers until the Supreme Court took action (they are still mandated for health care professionals), and the fact that Pfizer and Moderna still have a federally granted liability shield, the duty of safety monitoring must fall under the auspices of the FDA.”*

Has the FDA done its duty, though? Hardly. As far as we can tell, the FDA has done nothing but hide the truth while fast-tracking approval for the drugs at *warp speed*, putting hundreds of millions of American lives at risk.

Much of that risk has already become reality for the millions of Americans who now suffer from deadly, spike protein-induced blood clots, cardiovascular problems, neurological damage, and other [jab-caused illnesses](#).

“Today, unquestionably serious cardiovascular, thrombotic, and neurologic adverse events related to the vaccine have occurred around the world,” Gortler says.

*“The FDA’s own vaccine adverse event tracking system (the Vaccine Adverse Event Reporting System, or VAERS) shows substantial and serious risks from the vaccine, even though the FDA only collects an estimated 10 percent of all adverse events.”*

Despite all this, federal agencies like the HHS refuse to tell the truth to the American public. Why do you think that is?

**17-Year-Old Died ‘Suddenly in Sleep’ 6 Months After 2nd Pfizer Shot  
VAERS data released Friday by the Centers for Disease Control and Prevention** included a total of **1,205,755 reports of adverse events** from all age groups following COVID vaccines, including **26,396 deaths** and **214,521 serious injuries** between Dec. 14, 2020, and March 25, 2022.

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of **1,205,755 reports of adverse events** following COVID vaccines were submitted between Dec. 14, 2020, and March 25, 2022, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of **26,396 reports of deaths** — an increase of 337 over the previous week — and **214,521 of serious injuries**, including deaths, during the same time period — up 2,937 compared with the previous week.

Excluding “**foreign reports**” to VAERS, **799,732 adverse events**, including **12,103 deaths** and **78,227 serious injuries**, were reported in the U.S. between Dec. 14, 2020, and March 25, 2022.

**Foreign reports** are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product’s labeling, the manufacturer is required to submit the report to VAERS.

Of the 12,103 U.S. **deaths reported** as of March 25, 17% occurred within 24 hours of vaccination, 21% occurred within 48 hours of vaccination and 59% occurred in people who experienced an **onset of symptoms** within 48 hours of being vaccinated.

In the U.S., 559 million COVID vaccine doses had been administered as of March 18, **including** 330 million doses of Pfizer, 210 million doses of Moderna and 19 million doses of Johnson & Johnson (J&J).

Every Friday, [VAERS](#) publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Historically, VAERS has been shown to report only [1% of actual vaccine adverse events](#).

U.S. VAERS data from Dec. 14, 2020, to March 25, 2022, for 5- to 11-year-olds show:

- [9,771 adverse events](#), including [234 rated as serious](#) and [5 reported deaths](#). The most recent death involves a 7-year-old boy (VAERS I.D. [2152560](#)) from Washington who died 13 days after receiving his first dose of Pfizer’s COVID vaccine when he went into shock and suffered cardiac arrest. He was unable to be resuscitated and died in the emergency department.
- [17 reports](#) of myocarditis and pericarditis (heart inflammation). The CDC uses a [narrowed case definition](#) of “myocarditis,” which [excludes cases](#) of cardiac arrest, [ischemic strokes](#) and deaths due to heart problems that occur before one has the chance to go to the emergency department.
- [37 reports](#) of blood clotting disorders.

U.S. VAERS data from Dec. 14, 2020, to March 25, 2022, for 12- to 17-year-olds show:

- [30,771 adverse events](#), including [1,771 rated as serious](#) and [43 reported deaths](#).

The most recent death involves a 17-year-old boy (VAERS I.D. [2189006](#)) from Georgia who “suddenly died in his sleep” six months after receiving his second dose of Pfizer’s COVID vaccine. The boy had an autopsy but the results were not disclosed. He had no underlying health conditions.

- [68 reports](#) of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death — with 96% of cases attributed to [Pfizer’s vaccine](#).
- [650 reports](#) of myocarditis and pericarditis, with [638 cases](#) attributed to Pfizer’s vaccine.
- [165 reports](#) of blood clotting disorders, with all cases attributed to Pfizer.

U.S. VAERS data from Dec. 14, 2020, to March 25, 2022, for all age groups combined, show:

- 20% of deaths were related to cardiac disorders.
- 54% of those who died were male, 41% were female and the remaining death reports did not include the gender of the deceased.
- The [average age](#) of death was **72.7**.
- As of March 25, [5,341 pregnant women](#) reported adverse events related to COVID vaccines, including 1,687 reports of [miscarriage or premature birth](#).
- Of the [3,637 cases of Bell’s Palsy](#) reported, 51% were attributed to [Pfizer](#) vaccinations, 40% to [Moderna](#) and 8% to [J&J](#).
- 874 reports of [Guillain-Barré syndrome](#), with 42% of cases [attributed to Pfizer](#), 30% to [Moderna](#) and 28% to [J&J](#).
- [2,373 reports](#) of anaphylaxis where the reaction was life-threatening, required treatment or resulted in death.
- [1,655 reports](#) of myocardial infarction.

#### **Woman dies from rare brain disorder after second Pfizer shot.**

In an exclusive [interview with The Defender](#), Richard Sprague said his wife, Jennifer, developed Creutzfeldt-Jakob Disease (CJD) after her second Pfizer shot and died within five months of the second dose.

[Jennifer](#), a healthy 60-year-old woman from Missouri, experienced her first “event she couldn’t explain” four days after receiving the second Pfizer dose. Over the following weeks, her symptoms worsened until she could no longer work, pour coffee or walk without assistance.

Jennifer was [later hospitalized](#) and diagnosed with CJD, a fatal prion disease that causes degeneration of the brain. Her health rapidly deteriorated until she could no longer sit up on her own or communicate.

When Jennifer's insurance would no longer cover her injury, she was placed on hospice and sent home. She died Feb. 21.

Sprague, who remains unvaccinated, encouraged others to avoid COVID vaccines unless they have full knowledge of potential adverse events and an understanding that the vaccine is experimental.

### **Heart damage found in teens months after second Pfizer shot.**

A new [peer-reviewed study](#) published March 25 in the Journal of Pediatrics showed more than two-thirds of adolescents with COVID vaccine-related myopericarditis had persistent heart abnormalities months after their initial diagnosis — raising concerns for potential long-term effects.

Researchers at Seattle Children's Hospital reviewed cases that occurred between April 1, 2021, and Jan. 7, 2022, of patients younger than 18 who presented to the hospital with chest pain and an [elevated serum troponin](#) level within one week of receiving a second dose of Pfizer's vaccine.

While 35 patients fit the criteria, 19 were excluded for various reasons. Cardiac magnetic resonance imaging (MRI) of the remaining 16 patients was performed three to eight months after they were first examined.

The MRIs showed 11 had persistent abnormal findings and [late gadolinium enhancement](#) (LGE), although levels were lower than in previous months.

According to the study, *"The presence of LGE is an indicator of cardiac injury and fibrosis and has been strongly associated with worse prognosis in patients with classical acute myocarditis."*

### **Pfizer's COVID vaccine less effective against Omicron for children 12 and older.**

Pfizer's COVID vaccine [showed](#) "reduced effectiveness" against the Omicron variant among children 12 and older, according to a [study](#) published Wednesday in The New England Journal of Medicine.

The study, funded by the CDC, involved 1,185 patients, 88% of whom were unvaccinated.

During the "Delta-predominant period" (July 1 to Dec. 18, 2021), researchers reported vaccine effectiveness against hospitalization for COVID among adolescents 12 to 18 years old was 93% two to 22 weeks after vaccination.



During the “Omicron-predominant period” (Dec. 19, 2021, to Feb. 17), among adolescents in the same age group, vaccine effectiveness fell to 40% against hospitalization for COVID, 79% against critical COVID and 20% against noncritical COVID. This group’s median interval since vaccination was 162 days.

The study [did not assess](#) effectiveness of Pfizer’s COVID vaccine against the BA.2 Omicron sub-variant, which is now the [most dominant strain](#) in the U.S.

### **Incurable neurological disorder, aphasia, linked to COVID vaccines**

News Wednesday that actor Bruce Willis was [diagnosed with aphasia](#), requiring him to “step away” from his career, cast a spotlight on the incurable neurological disorder, which has also been linked to COVID-19 and COVID vaccines.

According to the [National Institute of Deafness and Other Communication Disorders](#), aphasia is a disorder that results from damage to areas of the brain responsible for language.

The condition often occurs suddenly, but frequently follows a stroke or head injury, or could occur as a result of a brain tumor or progressive neurological disease.

Although [The Defender](#) found no evidence Willis’ diagnosis is linked to either COVID or COVID vaccines, reports of aphasia following the vaccine continue to pile up in VAERS.

In 2019, there were only [52 cases of aphasia](#) reported to VAERS for all vaccines combined.

According to the latest data, between Dec. 14, 2020, and March 25, 2022, there were [3,079 cases](#) of aphasia reported following COVID vaccines, with [342 cases](#) occurring in those aged 65 to 74.

### **Moderna weighing vax for kids under 6**

Moderna last week said it [will seek](#) Emergency Use Authorization (EUA) for its [COVID-19](#) pediatric vaccine, after announcing its two-dose regimen reduced cases of symptomatic disease by 43.7% in children 6 months to 2 years old and by 35.7% in children ages 2 to 6.

The company said its Phase 2/3 KidCOVE study of its mRNA-1273 in children “successfully met its primary endpoint.”

However, as [Politico reported](#) Wednesday, and as experts told [The Defender](#), some doctors and scientists question whether Moderna’s clinical trial data will be sufficient for the U.S. Food and Drug Administration (FDA) to grant EUA for the vaccine.

Experts cited the trials’, small sample size, low efficacy rates and reliance on a research workaround called immunobridging as weaknesses that could hinder Moderna’s case.

*“Given the other data that surrounds it, I don’t know that it’s a slam dunk that the FDA will move forward in terms of releasing it for emergency use,”* Peter Hotez, professor of pediatrics and molecular virology and microbiology at the Baylor College of Medicine, [told Politico](#).

“We’re still learning about the relationship between virus-neutralizing antibodies and effectiveness,” Hotez said, adding the FDA might need to raise its standards.

Multiple experts also raised questions about the risk-benefit ratio of the COVID vaccines for an age group with a [statistically insignificant](#) risk of severe illness.

## **DEPOPULATION CONFIRMED: Ever since covid vaccines were introduced, U.S. population growth has plummeted**

[\(Natural News\)](#) For the past two years, we were told that the answer to the Wuhan coronavirus (Covid-19) *plandemic*, and the thing that would “save lives,” was everyone taking the Operation Warp Speed “vaccines.” It turns out; however, that population growth in the United States has [reached an all-time low](#) ever since the jabs were introduced.

In 2021, the year when most of the “fully vaccinated” got their jabs, the U.S. saw its population growth reach the lowest levels ever. This is according to the latest data from the Census Bureau.

The year prior, 2020, was not much better, as the population growth rate in America has been declining for some time. But things really ramped up in the depopulation department right after the “cure” for the Fauci Flu was introduced on a broad scale.

*“U.S. growth didn’t slowly fade away: It slipped, and slipped, and then fell off a cliff,”* wrote Derek Thompson for *The Atlantic*.

*“The 2010s were already demographically stagnant; every year from 2011 to 2017, the U.S. grew by only 2 million people. In 2020, the U.S. grew by just 1.1 million. Last year, we added only 393,000 people ... What’s going on?”*

Thompson answers his own question in a roundabout way by pointing out that the vast majority of deaths in America occurred *after* the shots were released. He adds that they were particularly concentrated in 2021, which is when most people got jabbed.

*“Last year, deaths exceeded births in a record-high number of U.S. counties,”* Thompson further points out. *“Never before in American history have so many different parts of the country shrunk because of ‘natural decease,’ which is the difference between deaths and births.”*



**Rather than blame the jabs for declining population numbers, *The Atlantic* says there isn't enough immigration**

Between 2019 and 2021, excess deaths accounted for 50 percent of the difference in population growth. Thompson blames the “pandemic” for this, but the reality is that a bulk of those deaths occurred after the jabs were introduced, and after they were plunged into people’s arms.

He stops short of linking the two things together, of course, but it is clear from his deduction as to the true cause of much of this death: the so-called “vaccines.” (Related: Covid vaccines have [been linked](#) to causing AIDS.)

Amazingly, Thompson goes into a lengthy diatribe blaming a lack of immigration in recent years on America’s declining population numbers. Back in 2016, he says, as many as one million new people from other countries legally immigrated to the U.S. Now, that figure is around 250,000 a year.

If true, this still does not explain the excess deaths that all occurred since the start of the *plandemic* when patients were being killed with respirators and remdesivir – this was pre-jab – as well as from late-2020 onward after the injections were widely administered.

Back in 2016, the Bill & Melinda Gates Foundation granted [\\$20 million to a little-known biotech company named Moderna](#). The funds were used to support their “initial project related to the evaluation of antibody combination in a pre-clinical setting as well as the conduct of a first in human Phase 1 clinical trial of a potential mRNA medicine.”

Under the framework agreement, the Bill & Melinda Gates Foundation granted Moderna up to \$100 million in funding for “follow-on projects” that can only be approved by the Gates Foundation. As part of the agreement, Moderna is obligated to grant the Gates Foundation certain non-exclusive licenses. These non-exclusive licenses allow the Gates Foundation to exploit the mRNA technologies created by Moderna to allow other licensees to profit from this same intellectual property. Bill and Melinda Gates are therefore [profiting from the Moderna mRNA injections](#) that they funded. These inventions were developed long before COVID-19, and were even launched before a global pandemic was declared.

In fact, Moderna was used as a vessel to patent precise genetic sequences of the SARS-CoV-2 bioweapon. Scientists from Switzerland, India, Italy, and the United States [published a paper](#) showing that [Moderna patented a specific 19-code nucleotide sequence](#) that gave SARS-CoV-2 its enhanced properties for infectivity. The authors wrote that there is only a one in three trillion chance that this 19-code nucleotide sequence would appear naturally and contain the unique furin cleavage site. Moderna patented that gene sequence (US9587003B2) on February 4, 2016. These Moderna patents also include US9149506B2, US9216205B2, US9255129B2, and US9301993B2 from December 16, 2013. The enhanced coronavirus was developed six years prior to COVID-19, and was rapidly generated with funds from the Bill and Melinda Gates Foundation.

The final codon patented by Moderna is as follows: “CTCCTCGGCGGGCA.” The CGG coded Furin Cleavage site is as follows: “CCTCGGCGGGCACGT.” These sequences do not occur naturally in viruses, but they do occur naturally in cows, plants, bacteria and humans. Since bacteria cannot naturally insert their genes into viruses, there is only one way this precise bacterial DNA could end up inside the SARS-CoV-2 virus. It could only be inserted through laboratory interference [using precision gain-of-function techniques](#) such as serial passage or no-see-um manipulations.

Moderna and NIAID transferred mRNA vaccine candidates to UNC before the causative agent was officially identified for the Wuhan outbreaks.

In the beginning of the COVID-19 scandal, pneumonia of “unknown cause” was discovered on December 31, 2019. On January 9, 2020, the [WHO determined](#) that the pneumonia outbreak in Wuhan China was the result of a new causative agent, SARS-CoV-2. Astonishingly, mRNA coronavirus vaccine candidates developed by Moderna were transferred to the *University of North Carolina* three weeks prior (on December 12, 2019). It had been several years since a coronavirus posed a threat to humans, yet Moderna was ready with a “vaccine” to respond to outbreaks in Wuhan, China before a causative agent could be identified, before a pandemic could be quantified.

A confidential agreement between Moderna and Fauci’s NIAID, (dated December 12, 2019) agreed to transfer “mRNA coronavirus vaccine candidates” to recipients at UNC. The NIH, the FDA and the CDC were all in on it, too. Ralph Baric and Jacqueline Quay signed the agreement on Dec 12th and Dec 16th, respectively. It was also signed on December 12, 2019 by NIAID representatives Amy F. Petrik and Barney Graham. Moderna’s investigator, Sunny Himansu, and Moderna’s Deputy General Counsel Shaun Ryan also signed the mRNA vaccine transfer agreement on December 17, 2019.

The genetic sequences, the patented evidence and the time stamps for vaccine transfers point to the reality that there was a well-funded conspiracy behind COVID-19. And Anthony Fauci is the architect of this genocide,”* Martin said when he appeared in the March 24 episode of “The Stew Peters Show.” During the course of the program, Martin talked about the [chimeric model of spike proteins and how this is affecting the body](#).

Mainstream science has come up with the news that the Wuhan coronavirus (COVID-19) vaccines persist in the human body for an indeterminate period, and will survive up to eight weeks in the lymphatic system, where it will continually produce the spike protein. Scientists see evidence that spike proteins are showing up in waste streams at alarmingly high rates.

Martin added that [these proteins are known to be damaging](#) and are subject to the biological and chemical weapons, treaties and laws that have been enforced in the United States. These chimeric viruses resulted from the deliberate manipulation of SARS-CoV-2, to incorporate nucleic acids into the virus, which is illegal.

With the fourth COVID-19 shot now underway in the U.S., Fauci is talking about possibly doing another round of lockdowns, and it seems that plenty of Americans will participate because many have been brainwashed by the so-called experts.

#### **SARS-CoV-2 chimeric viruses a result of deliberate manipulation**

SARS-CoV-2 chimeric viruses are a result of any deliberate manipulation of the virus to incorporate nucleic acids for SARS-CoV-2 virulence factors. This actually shows up in three sections of the Code of Federal Regulations subjected to the biologic and toxin agent program defined under Chapter 18 U.S. Code Section 178.

## **Gearing up for the BIG REVEAL: HHS releases FDA gene editing guidance, may soon admit mRNA COVID shots are actually gene therapy products**

([Natural News](#)) The *Department of Health and Human Services* (HHS) recently released the *Food and Drug Administration* (FDA) draft guidance for [human gene therapy](#) products.

Entitled “Human Gene Therapy Products Incorporating Human Genome Editing; Draft Guidance for Industry,” the document provides recommendations to sponsors developing human gene therapy products incorporating genome editing of human somatic cells.

Medical professional and veteran [pharmaceutical drug development expert](#) Dr. Jane Ruby told host Stew Peters during a recent episode of “The Stew Peters Show” that the FDA has been actually creating guidance documents since 2015 and that these documents tell pharmaceutical companies how they want them to run studies and look at safety and efficacy in gene editing or human genome editing.



[Genome editing](#) is an area of research seeking to modify genes of living organisms to improve the understanding of gene function and develop ways to use it to treat genetic or acquired diseases.

*“And you know this is why I want to reiterate that it’s so incredibly important to stop calling it a vaccine. You’ve heard Dr. David Martin say you’re using the words of the criminals. By continuing to call it a vaccine, you’re really saying you don’t have to use as many safety studies, you don’t have to do as much follow up [when developing a vaccine]. You’re putting them off the hook,” said Ruby.*

At least one Big Pharma executive has already admitted that the [mRNA vaccines are actually a form of gene therapy](#). It may not be long before federal agencies like the HHS and the FDA do the same.

### **COVID-19 mRNA vaccines are really for gene editing**

The host of “Live with Dr. Jane Ruby” and “The Dr. Jane Ruby Show” pointed out that the mRNA vaccines are really for gene editing and these were seen in the vials that had been analyzed. She added that Big Pharma companies like Moderna and Pfizer have also talked with the *European Medicines Agency* (EMA), which is the equivalent of the FDA, to let them live with just 50 percent of the vials containing mRNA and the rest as a sort of leeway that they can do anything they want.

Peters noted that the Wuhan coronavirus (COVID-19) shots can’t be called vaccines because they don’t protect people or provide immunity from anything. He added that the COVID-19 shots have negative efficacy and that you are more likely to get sick after the injection.

Peters added that the so called adverse events or side effects are actually intended and planned consequences.

*“If you let them keep calling it a vaccine and you’re not calling it gene editing, [human genome editing](#), they’re getting away with not looking at safety and efficacy,”* stressed Ruby, who added that the FDA itself has laid out certain parameters in the new guidance document.

### **CRISPR snips out portion of human gene**

Ruby said gene editing technology like CRISPR is chemically snipping out a portion of the God-given human genes in a line and a double strand of DNA to insert something else. She warned that a person has no idea what is going to happen to their body over the years when they undergo gene editing. She added that Moderna and Pfizer are now actively seeking the approval for emergency use authorization of mRNA jabs for six-month-old babies.

*"That's why they want you to keep taking it. It's a priming mission. The more graphene you get into your body, the more you are filled with what is going to potentially be self assembling circuitry for the ability to control functions in your body from an external source. ## **COVID-19 vaccines used to kill people in what is shaping to be the largest genocide in history**

([Natural News](#)) Numerous intel briefings from military and scientific experts showed that the Wuhan coronavirus (COVID-19) vaccines are bioweapons that deliver payloads for mass genocide and dehumanization. She also mentioned the presence of carbon nanotubes that engage with people's brains and short-circuit them.

*"It's all boiling down to three focal points. Mass genocide, building and controlling hybrid people from within and thirdly, inserting and testing circuitry in humans," Ruby said.*

She also shared that there is a particular theory emerging that indicates there are many different components to this bioweapon that must be injected at different time points in an effort to mimic biochemical reaction, to make the weapon as close to what the body would normally do.

### **The Vaccine. Hidden Agenda?**

The vaccine does not save lives nor does it contain the pandemic, because there is no pandemic. It’s a money-making operation for Big Pharma in the hundreds of billions of dollars (see data below).

While “Big Blood Clots” resulting from the vaccine are revealed and reported by those vaccinated, an important study by Canada’s [Dr. Charles Hoffe](#), suggests (yet to be fully confirmed) that the mRNA vaccine generates “*microscopic blood clots*”.

### **Big Pharma. Pfizer’s Near Global Monopoly**

Hundreds of billions of dollars are at stake. **This is the largest and most expensive vaccine project in World history which is slated to be financed by tax dollars Worldwide**, putting an obvious strain on the public debt of numerous countries.

The vaccine program is accompanied by a “timeline” consisting of recurrent mRNA inoculations over “the next two years and beyond”. As documented above, it will have devastating impacts on mortality and morbidity Worldwide.

What is at stake is a multi-billion dollar Big Money operation for Big Pharma with Pfizer in the lead.

Ironically, in the EU, the reported deaths and injuries were used by the European Commission to cancel the renewal of the contract with AstraZeneca, despite the fact that there were substantially more deaths and injuries associated with the Pfizer-BioNTech vaccine.

In April 2021, the EU Commission confirmed that it would “end AstraZeneca and J&J vaccine contracts at expiry”. “The Pfizer shot will take precedence”. Never mind your follow-up dose with AstraZeneca, the health authorities have instructed people to get their second or third jab with Pfizer or Moderna (thereby visibly violating medical norms).

Having sidelined its competitors, Pfizer-BioNTech has jacked up the price of the vaccine vial. Pfizer has literally cornered both the EU and U.S. markets. **A near global vaccine monopoly is in the making.**

### **The European Union**

In mid-April 2021 the President of the European Commission confirmed that Brussels is in process of negotiating a contract with Pfizer for the production of **1.8 billion mRNA vaccine doses, which represents 23 percent of the World’s population.**

That’s **exactly four times the population of the 27 member states of the European Union** (448 Million, 2021 data), which confirms that several follow-up doses of the “killer vaccine” are envisaged, despite the trend in mortality and morbidity which the governments and the media are attempting to suppress as part of a hideous disinformation campaign.

## Pfizer and the US Market

A similar pattern is occurring in the US and Canada. In July 2020, Pfizer signed a \$1.95 billion contract with the U.S. government for [100 million doses](#). And then in December 2020 another 100 million doses were delivered.

In Canada, another 35 million doses of Pfizer and Moderna vaccine vials are slated to be delivered.

And now July 2021 the Biden administration has ordered **200 million more doses of the Pfizer vaccine**. “for children’s shots and possible boosters”

But that’s not all: in early June 2021, Biden ordered **500 million Pfizer-BionTech doses of the “killer virus” to be sent as “US Aid” to developing countries** (courtesy of Uncle Sam). What is the underlying intent?



In most Western countries including the US and Canada, the retail price of the vaccine is “Free”.

In the US, the purchase of 900 million doses of Pfizer-BionTech vaccine vials is Big Money for Big Pharma: Massive profits for Pfizer, all of which are slated to be financed by tax revenues coupled with a dramatic expansion of the US public debt.

In the first quarter of 2021 (January through March 2021), the gross revenues accruing to [Pfizer and Moderna were as follows](#):

#1. Pfizer-BioNTech COVID-19 vaccine. U.S. sales were **\$2.038 billion**; global sales were **\$5.833 billion**.

#2. Moderna COVID-19 vaccine. U.S. sales, **\$1.358 billion**; global sales, **\$1.733 billion**.

Recently announced (23 July 2021), Pfizer has jacked up the price of its vaccine vial from \$19.50 to \$28.00.

Multiply \$28.00 by three vaccine doses per person for a World population of 7.9 billion, What do you get?

This is not an estimate, it’s an “order of magnitude”: 663.6 billion dollars ( $\$28.00 \times 3 \times 7.9 \text{ billion} = \$663.6 \text{ billion}$ ).

It is all for a good cause: save lives?

We are talking about a multi-billion dollar operation at tax payers expense, which has resulted in a **pattern of vaccine related deaths and injuries**. And the governments are fully aware of what is happening.

### **Pfizer's Criminal Record**

### **Pfizer to Acquire A Near Monopoly of the Global Covid Vaccine Market**

And now among all major Big Pharma actors, it's a company with a criminal record which has established a de facto near monopoly at a World Level.

### Concluding Remarks. The Vaccine Passport

The data from official sources quoted above confirm unequivocally that the Covid-19 “vaccine” has resulted in an upward trend in vaccine related mortality and morbidity.

**Covid-19 versus Influenza (Flu) [Virus A and Virus B \(and subtypes\)](#)** (Bear in mind seasonal influenza is not a coronavirus)

## 2. The Measurement of Covid Positive Cases is Invalid

**We are told that there is a pandemic characterized by a rising Worldwide trend of Covid-19 infection.** This alleged trend is said to be corroborated by a rapidly increasing number of **covid positive cases**.

The methodology used to generate these figures is dependent upon the WHO sponsored **Real Time Reverse Transcription Polymerase Chain Reaction (rRT-PCR)** test, the estimates of which are tabulated Worldwide by the national health authorities.

While the estimates of the rRT-PCR have been questioned from the very outset, it is now confirmed beyond doubt that the rRT-PCR test adopted as a means to detecting the SARS-COV-2 virus cases is **TOTALLY invalid**.

(This pertains to Covid positive data tabulated since late January 2020).

***The Real Time Reverse Transcription Polymerase Chain Reaction (rRT-PCR) test was adopted by the WHO on January 23, 2020 as a means to detecting the SARS-COV-2 virus, following the recommendations of a Virology research group (based at Charité University Hospital, Berlin), supported by the [Bill and Melinda Gates Foundation](#). *Exactly one year later on January 20th, 2021, the WHO retracts. They don't say "We Made a Mistake". The retraction is carefully formulated. (See [original WHO document here](#))*

*While the WHO does not deny the validity of their misleading January 2020 guidelines, they nonetheless recommend "Re-testing" (which everybody knows is an impossibility). The contentious issue pertains to the number of amplification threshold cycles (Ct). According to Pieter Borger, et al*

The number of amplification cycles [should be] less than 35; preferably 25-30 cycles. In case of **virus detection, >35 cycles** only detects signals which do not correlate with infectious virus as determined by isolation in cell culture... ([Critique of Drosten Study](#))

The World Health Organization (WHO) tacitly admits one year later that ALL PCR tests conducted at a 35 cycle amplification threshold (Ct) or higher are INVALID. But that is what they recommended in January 2020, in consultation with the virology team at Charité Hospital in Berlin.

If the test is conducted at a 35 Ct threshold or above (which was recommended by the WHO), segments of the SARS-CoV-2 virus cannot be detected, which means that **ALL the so-called confirmed "positive cases" tabulated in the course of the last 14 months are invalid**.

According to [Pieter Borger, Bobby Rajesh Malhotra, Michael Yeadon, et al](#), the Ct > 35 has been the norm "in most laboratories in Europe & the US".

## The WHO's Mea Culpa

Below is the WHO's carefully formulated "Retraction". The full text with link to the original document is in annex:

WHO guidance [Diagnostic testing for SARS-CoV-2](#) states that **careful interpretation of weak positive** results is needed (1). **The cycle threshold (Ct)** needed to detect virus is inversely proportional to the patient's viral load. Where test results do not correspond with the clinical presentation, **a new specimen should be taken and retested** using the same or different NAT technology. (emphasis added)

WHO reminds IVD users that disease prevalence alters the predictive value of test results; as disease prevalence decreases, **the risk of false positive increases** (2). This means that the probability that a person who has a positive result (SARS-CoV-2 detected) is truly infected with SARS-CoV-2 decreases as prevalence decreases, irrespective of the claimed specificity.

### "Invalid Positives" is the Underlying Concept

This is not an issue of "**Weak Positives**" and "**Risk of False Positive Increases**". What is at stake is a "Flawed Methodology" which leads to **invalid estimates**.

What this admission of the WHO confirms is that **the estimate of covid positive from a PCR test** (with an amplification threshold of 35 cycles or higher) is **invalid**. In which case, the WHO recommends retesting: "**a new specimen should be taken and retested...**".

The WHO calls for "**Retesting**", which is tantamount to "**We Screwed Up**".

That recommendation is pro-forma. It won't happen. Millions of people Worldwide have already been tested, starting in early February 2020. Nonetheless, we must conclude that unless retested, **those estimates (according to the WHO) are invalid**.

Another issue which has bearing on the Validity of the rTC-PCR test is that **the SARS-1, (2003) was used in the PCR-test as a proxy for SARS-COV-2, because no information was available pertaining to the "isolation" and "identity" of SAR-CoV-2. This was recommended to the WHO on the grounds that the genetic fragments of SARS-1 are similar to those of SARS-CoV-2.**

What it also implies is that **statement regarding "variants" and mutations pertaining to SARS-CoV-2 are totally meaningless** inasmuch as the PCR test from the outset included a similar 2003 virus as a proxy for SARS-CoV-2. i.e. mutations in relation to what? SARS-2 or SARS-Co-2 (the identity of which has not been made public.

The RT-PCR data cannot under any circumstances be used to justify the imposition of a vaccine, which is presented to public opinion as a means to saving lives, when in fact it is leading to an upward trend in vaccine related mortality and morbidity.

### 3. The Covid-19 Mortality Data is Manipulated

We are told that there is a rising trend of Covid-19 mortality, namely deaths which are allegedly the result of SARS-2 viral infection.

There is ample evidence that these Covid-19 related “probable” causes of death and the underlying data on Covid-19 mortality are manipulated by the national health authorities. In the US, the mortality statistics pertaining to Covid-19 are **TOTALLY invalid**.

#### The “More Often than Not” Clause

On March 21, 2020 the following specific guidelines were introduced by the CDC regarding Death Certificates (and their tabulation in the National Vital Statistics System (NVSS)). The instructions to the certifiers are to identify COVID-19 as the “**Underlying Cause of Death**” “**More Often Than Not**”.

Will COVID-19 be the underlying cause of death? This concept is fundamental. **The underlying cause of death** is defined by the WHO as “the disease or injury that initiated the train of events leading directly to death”.

What the CDC is recommending with regards to statistical coding and categorization is that COVID-19 is expected to be the underlying cause of death “**more often than not.**” The CDC combines these two criteria. “**underlying cause of death**”, **more often than not**.

The above directive is categorical. **Below are CDC concepts and justifications** “The underlying cause depends upon what and where conditions are reported on the death certificate. However, the rules for coding and selection of **the underlying cause of death are expected to result in COVID- 19 being the underlying cause more often than not.**”

#### Will COVID-19 be the underlying cause?

The underlying cause depends upon what and where conditions are reported on the death certificate. However, the rules for coding and selection of the underlying cause of death are expected to result in COVID-19 being the underlying cause more often than not.

#### What happens if certifiers report terms other than the suggested terms?

If a death certificate reports coronavirus without identifying a specific strain or explicitly specifying that it is not COVID-19, NCHS will ask the states to follow up to verify whether or not the coronavirus was COVID-19. As long as the phrase used indicates the 2019 coronavirus strain, NCHS expects to assign the new code. However, it is preferable and more straightforward for certifiers to use the standard terminology (COVID-19).

The certifier cannot depart from the CDC criteria. Covid-19 is imposed. Read carefully the CDC criteria above:

#### **“What happens if certifiers report terms other than the suggested terms?”**

There are no loopholes. These CDC directives have contributed to categorizing Covid-19 as the recorded “cause of death”. Two fundamental concepts prevail throughout:



The “underlying cause of death”

The “More Often than Not” Clause which falsifies the Cause of Death

And these criteria are imposed despite the fact that the RT-PCR test used to corroborate the “cause of death” provides misleading results.
