Will everyone who got “vaccinated” for COVID be dead by 2025?

(Natural News) Attorney Todd Callender, CEO of a large insurance group, is warning that excess mortality and “every kind of disease” is skyrocketing among the “fully vaccinated” for the Wuhan coronavirus (COVID-19).

Callender spoke via a video call about how excess mortality is up 84 percent while excess diseases are up 1,100 percent. In 2022 alone, he said, his company is expecting a 5,000 percent increase in deaths, compliments of Operation Warp Speed.

“I happen to be in the morbidity business,” Callender explained during the call. “I don’t think that it’s by coincidence, by the way, that Moderna has now just received licensure of their emergency use authorization HIV vaccine. So, they gave everybody AIDS, and here’s your salvation, another vaccine.”

Preliminary mortality data from the *Centers for Disease Control and Prevention* (CDC) from 2021 shows an expected death count of 2,948,273. In actuality, there were 3,447,405 deaths, meaning there were 499,132 excess deaths for the year.

With a 5,000 percent increase in excess deaths so far in 2022, Callender estimates that as many as 25,455,732 jabbed people in the United States could die just this year alone.

“Add to that the 2.95 million expected deaths, and the result is: 28,405,732 total deaths for 2022,” Hal Turner reported.

Did the DoD know about future mass COVID job deaths back in 2015?

At this rate, assuming it continues on the current trajectory, everyone who got injected for the Chinese Flu will be dead by 2025. This was also forecasted in the population reduction charts that have been posted at the Deagel website for many years.

Before scrubbing the information, Deagel.com’s forecast for the U.S. population in 2025 is 100 million fewer people. For Germany during the same time period, there is expected to be 25 million fewer people.

“About one-third of Germany’s population remain unvaxxed,” Turner explained. *“Today’s population is 83 million, so Deagel’s report may be quite accurate.”*

Since Deagel has been around since 2015, the Department of Defense (DoD) guy who runs it appears to have known since at least that far back that there was going to be a *plandemic*, and that many, if not all, of the people who got “vaccinated” for it will soon die.

“Deagel has always had the forecast at the year 2025,” Turner said. *“The numbers may have fluctuated but the date never did.”*

We also **now know** that Big Pharma and the *Food and Drug Administration* (FDA) have known for at least the past year-and-a-half – and likely long before that – that the COVID-19 “vaccines” damage the immune system and trigger antibody-dependent enhancement (ADE).

In essence, the jabbed now have vaccine-induced AIDS (VAIDS) and could succumb to a deadly cytokine storm (ADE) at any moment. For some, this has already happened and they are now chronically ill or deceased. For the rest, well, time will certainly tell what becomes of them.

“It’s hard to overstate just how devastating the pandemic has been for Americans with diabetes,” Dr. Giuseppina Imperatore, who oversees diabetes prevention and treatment at the [Centers for Disease Control](#) and Prevention told the paper in a story published on Sunday.

According to data from the [National Institute of Health](#), diabetes draws less funding than diseases like cancer and [heart disease](#) despite impacting 37 million Americans.

[The Center for Disease Control and Prevention](#) found that the number of adults diagnosed with diabetes more than doubled in the past 20 years and 96 million Americans have prediabetes.

‘Not Surprising to See, but Sad’: Experts Alarmed by Large Number of Teens Experiencing Emotional Abuse.

The [Centers for Disease Control](#) and Prevention [released](#) new statistics on high school students’ [mental health](#). Among its findings was an alarmingly high number of U.S. teens reporting emotional abuse at home: more than half.

Defined by the survey as being sworn at, insulted or put down by a parent or other adult in their home, 55 percent of the more than 7,700 high school students polled said they had experienced emotional abuse.

The survey responses, which were collected in the first half of 2021, asked about experiences in 2020, which included the height of [pandemic](#)-related lockdowns.

FDA Says COVID Vaccines May Need to Be Updated to Ensure High Level of Effectiveness Against Virus

The currently approved [COVID-19](#) vaccines may need an update to ensure a high level of protection as the virus continues to evolve, according to the Food and Drug Administration.

The FDA, [in a briefing document](#) published ahead of an advisory committee meeting this week, said scientists still don't entirely understand COVID variants and the effectiveness of the [vaccines](#). For example, mutations to the spike protein, which is used by the virus to invade human cells, have reduced the effectiveness of current [vaccines](#). That's because today's COVID shots were developed to target the spike protein in the original strain of the virus that emerged in [Wuhan](#), China in late 2019.

The FDA's advisory committee of outside vaccine experts on Wednesday will discuss how the U.S. can develop a transparent process to make recommendations about changing the composition of the current ones if needed. [Pfizer](#) and [Moderna](#) are conducting clinical trials on vaccines based on the [Omicron](#) variant, the dominant version of the virus worldwide.

The effectiveness of [Pfizer](#) or [Moderna's](#) two-dose vaccines against mild illness from Omicron dropped from 70% to just 10% 25 weeks after the second shot, according to the [U.K. Health Security Agency](#).

U.S. FDA Advisers to Discuss Additional COVID Vaccine Shots, Booster Design [Reuters reported:](#)

The U.S. Food and Drug Administration's expert advisers will discuss the timing of additional [COVID-19](#) vaccine [boosters](#) and the people eligible for the extra shots in a meeting later this week, the health agency said on Monday.

The independent advisers will also discuss at the April 6 meeting the FDA's role in how future versions of COVID vaccines are created to help fight new variants. It could be similar to the current process of selecting the composition of the seasonal [flu shot](#), where regulators pick the strain to use for the coming year's vaccines, FDA staff said in briefing documents ahead of the meeting.

The FDA's staff said on Monday that new variants are often more infectious, transmissible and distinct from earlier virus strains.

COVID COVER-UP: NIH secretly deleted information about genetic sequencing of SARS-CoV-2

([NaturalHealth365](#)) It used to be that discussing the lab leak theory was grounds for deplatforming from social media. Today, even mainstream media outlets are pointing to the major discrepancies and questions surrounding SARS-CoV-2, adding to the growing suspicion that the wet market theory is not as cut and dry as Fauci and others at the National Institutes of Health (NIH) would like us to believe.

The issues for NIH don't end there, either. [New data](#) revealed by a Freedom of Information Act (FOIA) request show that the NIH played a part in suppressing critical information regarding the COVID-19 virus and its origins.

US government acquiesces to China, hides information about COVID-19 virus at the start of the pandemic

According to emails and other documents uncovered by the nonprofit, nonpartisan group Empower Oversight Whistleblowers & Research (EMPOWR), the NIH agreed to delete information related to the genetic sequencing of SARS-CoV-2 at the beginning of the pandemic.

The gene sequencing data was originally submitted to the NIH's Sequence Read Archive by an unidentified researcher from Wuhan University in China in March 2020 – a mere two months after the virus was officially detected and the same month that the World Health Organization officially declared a pandemic. After submitting additional gene sequencing data about SARS-CoV-2 in June 2020, the scientist then asked the NIH to retract the submission, claiming there was an error with the data.

According to documents revealed by EMPOWR, **the now-deleted data potentially supports the theory that the pandemic virus was indeed man-made in the [virology lab in Wuhan](#), as a result of gain of function research funded by the NIH.**

Dr. Jesse Bloom of the Fred Hutchinson Cancer Research Center, a researcher who studies *“evolution using viruses and viral proteins as models,”* published a paper about this matter in the December 2021 issue of *Molecular Biology and Evolution*. Dr. Bloom is also quoted in several of the documents revealed by the FOIA, saying that this data suppression suggests that the *“trusting structures of science have been abused to obscure sequences relevant to the early spread of SARS-CoV-2 in Wuhan”* and *“violates scientific norms and the code of trust essential to science.”*

Will the public ever learn the unobscured truth? From the origin of COVID virus to vaxx “tech,” questions and discrepancies remain

Concerns about genetic sequencing and the origin of the pandemic virus are one of several issues raised by critics of the pandemic and official mitigation policies. Another issue that continues to be hotly contested is whether the brand new mRNA technology behind the Pfizer and Moderna [COVID shots](#) should be considered gene therapy.

This issue is relevant for two main reasons:

- Gene therapy is relatively new (beginning only in the 1990s) and is still considered experimental, which suggests a lack of long-term data for many applications within this field
- Medical ethics tell us that people should understand the type of medical treatment they are consenting to and the full range of benefits vs risks of said treatment.

“Fact-checkers” certainly insist that the mRNA COVID shots *shouldn't* be classified as gene therapy, even though these jabs have been referred to as cell and gene therapy by Big Pharma officials. According to their sources, even mainstream media like Reuters acknowledge that the shots are at the very least classifiable as “genetic-based therapy,” according to their sources.

Here's the current Wikipedia definition of gene therapy: “*Gene therapy is a medical field which focuses on the genetic modification of cells to produce a therapeutic effect or the treatment of disease by repairing or reconstructing defective genetic material.*” And from the US National Library of Medicine via MedlinePlus: “*Gene therapy is a medical approach that treats or prevents disease by correcting the underlying genetic problem. Gene therapy techniques allow doctors to treat a disorder by altering a person's genetic makeup instead of using drugs or surgery.*”

We acknowledge the confusion over the distinction. But despite the general consensus that mRNA COVID shots are not directly entering the nuclei of human cells and are supposedly not altering DNA, [new evidence](#) has shown that the mRNA shots do indeed integrate into and modify human DNA. Time may reveal new revelations surrounding this matter, especially as we gain more clarity on the potential long-term impacts of COVID jabs.

What does seem evident is that gene therapy technology was involved in the research and development of these shots, as explained in sources such as, an October 2021 article published in *International Immunology* (“Development of COVID-19 vaccines utilizing gene therapy technology”). With this in mind, we continue to advocate for informed consent and the right to bodily autonomy, which should be more important than any effort to mandate emerging (“experimental”) medical treatments.

Between hyperinflation and World War III, most of humanity doesn't stand a chance

It’s not over: Globalists still using COVID-19 to MIND CONTROL people into submission

(Natural News) The globalists are still using the Wuhan coronavirus (COVID-19) pandemic [to exert control over the global population](#). In China, they’re doing this through dehumanizing lockdown restrictions, including separating children from their parents and forcing people to kneel while they wait to get their vaccine passports checked.

This is according to *InfoWars* founder and host Alex Jones, who said that creating a unified world government is only the beginning for the globalists.

“For globalists, global government is just the beginning,” said Jones. *“They want to carry out forced depopulation. They’ve got to get you stunned and poisoned, they’ve got to get us to submit and to degrade ourselves and let our basic human rights be violated.”*

As an example, he pointed to the now-viral video of Chinese citizens being forced [to kneel in the street](#) while Chinese authorities check their COVID-19 vaccine passports. The footage was recorded in Jinan in eastern China, a city of over nine million people.

“Generations of indoctrination come to this: People lining up, on their knees, waiting for Chinese storm troopers [to] scan their movement licenses-QR code vaccine passports,” wrote Twitter user Songpinganq, one of the first people to publish the video on Western social media platforms.

The video shows a long line of people either crouching or kneeling in the middle of the street or on the side. Several individuals in full personal protective wear are seen going through the line scanning people’s COVID-19 vaccine passports on their phones while they kneel.

“It makes it easier [to make you submit] if you kneel,” said Jones. *“And so you have to wait in a stress position kneeling, in some cases for hours, until they come to you.”*

Control programs escalating in China – parents now being separated from their children. Another situation Jones pointed out is how China’s tyrannical “zero-COVID” strategy has failed to do as it claims and prevent the spread of the coronavirus in China.

Shanghai is currently the epicenter of the current COVID-19 outbreak. This has prompted [a fresh wave of lockdowns](#) as Beijing orders the city to implement its ineffective “zero-COVID” strategy. Reports coming out of the locked-down city include locals claiming that the [authorities are separating children from their parents](#), even if both are forced into COVID-19 quarantine facilities.

Reports coming in from Shanghai include many locals saying that authorities are forcibly separating children and babies from their parents, supposedly under the guise of keeping them safe from COVID-19.

Parents who bring their children in for testing and possible treatment at one of the city’s designated facilities [are browbeaten into complying with authorities](#) who want to take their children away from them and move them to official quarantine centers.

If both parent and child test positive, they are refused the chance of riding out the coronavirus together in the facility. This has left many families in the dark about the state of their children. On at least one occasion, a three-month-old child who was still breastfeeding was forcibly separated from his mother.

Captured images and videos of crying children being separated from their parents have gone viral on Chinese social media networks. Some were saved and copied onto Western social media platforms before Chinese censors took them down on their networks.

“Isn’t that insane?” said Jones. *“All of it is a giant exercise of power and control.”*

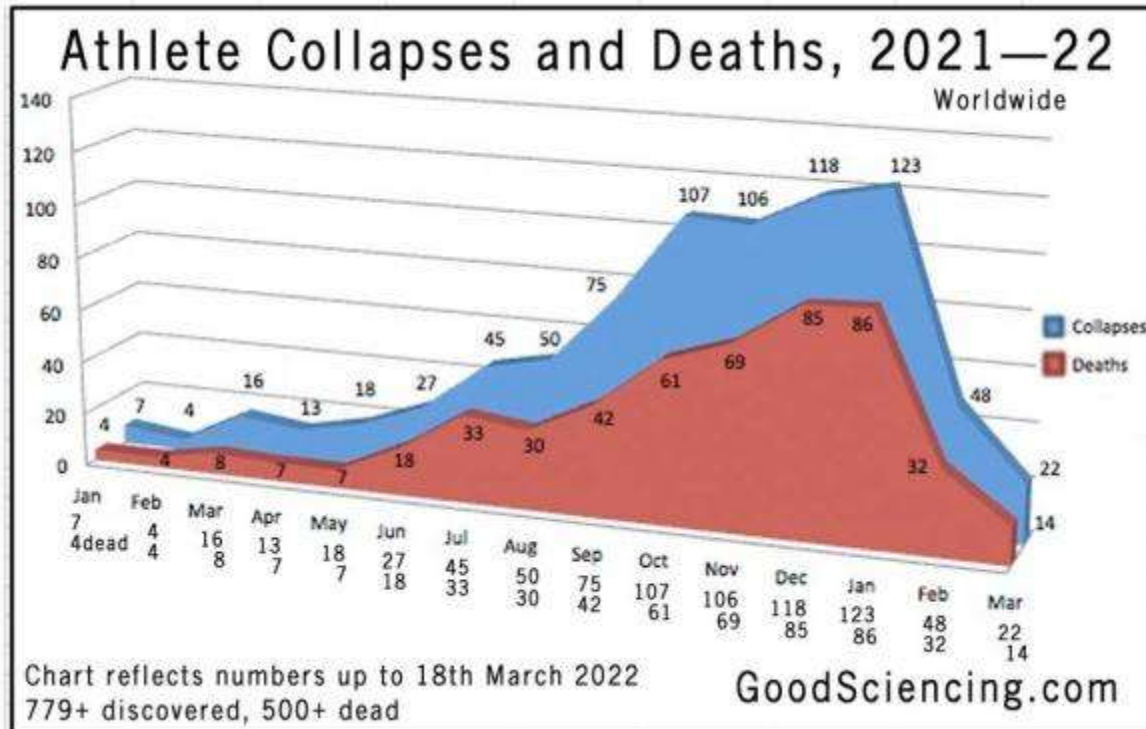

“Initially, many of these were not reported. We know that many people were told not to tell anyone about their adverse reactions and the media was not reporting them. They started happening and ramping up after the first Covid vaccinations. The mainstream media still are not reporting most, but sports news cannot ignore the fact that soccer players and other stars collapse in the middle of a game due to a sudden cardiac arrest. Many of those die – more than 50%.”

“Most, if not all of these athletes have suffered heart problems after Covid vaccines. At the time of initial writing, 28 died. That was not normal, but then, 10 days later, 56 deaths were listed, and the numbers are climbing. Any other real vaccine would have been pulled off the market long before now. The media would be asking questions. They would be pressuring governments. But they are not. And governments continue

running TV and radio and newspaper ads encouraging people to get their 1st, 2nd, 3rd, 4th shot.”

Many posts on Facebook, Instagram, Twitter, forums and news stories are being removed. *“So now we are receiving some messages saying there is no proof of the event or of vaccination status. That is partly because this information is being hidden,”* Good Sciencing notes, *“more people are writing to tell us that in many cases, we didn’t mention a person’s vaccination status. There is a good reason for that. None of the clubs want to reveal this information. None of their sponsors want to reveal it. The players have been told not to reveal it. Most of their relatives will not mention it. None of the media are asking this question.”*

[Daily Mail reported](#) on 28 January that Sunderland FC manager Lee Johnson suggested the Covid injection could be behind his goalkeeper Lee Burge being ruled out of playing with an ‘inflamed heart’ and said ‘it happens a lot after these injections’. Two days later [the club confirmed](#) Johnson had been sacked. *“Form your own conclusions as to why the club would sack the manager who cares about his players,”* Good Sciencing wrote.

“We know there is a concerted worldwide effort to make this information go away, so that fact alone tells us it must be collected, investigated and saved so other researchers can look at it to see if there are any useful patterns ... Pfizer documents reek of FRAUD; Big Pharma liability shield starts to unravel

(Natural News) Recently released Pfizer documents show that its Wuhan coronavirus (COVID-19) vaccine can cause systemic damage to the body. This is likely the reason why the pharma giant, through the *Food and Drug Administration* (FDA), previously asked a judge to keep the data from the public for as long as possible – [around 55 years, to be more precise.](#)

In the April 1 episode of “The Ben Armstrong Show,” [the host talked about the Pfizer document dump.](#) With over 55,000 pages of data to be dumped in April, a team has been assembled to go through parts of the massive document.

Pfizer obviously doesn’t want the public to know just how dangerous the COVID-19 vaccine is, and that the [company has committed fraud](#) by saying it is safe and effective. Unfortunately, also involved in the scheme are the government, the FDA, the *Centers for Disease Control and Prevention* and several media companies. Pfizer and Moderna know from their studies how dangerous the vaccines are, and if independent researchers will ever prove fraud, they will lose their liability protection and people will be allowed to sue them.

When the FDA granted Pfizer the full approval for their vaccine in 2021, there are already known side effects. But there is no way to sue the drug manufacturer for vaccine injury.

“If it could be proven that Pfizer’s data shows increased all-cause mortality and that the company hid this to encourage people to take the vaccine, then there is an existence of fraud,” said former Blackrock executive and investment adviser Edward Dowd. All the protections Big Pharma is enjoying at the moment will be gone.

This is why Pfizer wants to keep its documents away from the public's eye for as long as possible. "If you didn't do anything wrong, you wouldn't care if people looked at your stuff, that you know is supposed to be public record in the first place," Armstrong said.

Armstrong also showed an interview with Dr. Naomi Wolf, whose team found how dangerous the COVID vaccines are. Wolf indicated that authorities are using these vaccines to experiment on people and use them as lab rats. She said these are not vaccines at all. According to Wolf, the mRNA injections made by Pfizer and Moderna manipulate genes – making them a form of gene therapy rather than a vaccine.

Pfizer's efforts to conceal data indicate fraud in itself. Meanwhile, Dowd considers Pfizer's attempt to conceal data that shows the actual risks of its COVID-19 vaccine as an obvious evidence of fraud. He pointed out the Herculean efforts of Pfizer in withholding its data despite legal challenges to release it.

"Many reports have also shown that there had been more deaths in the vaccinated compared to the unvaccinated. FDA's backing of Pfizer in its initial refusal to release the data is an attempt to conceal vaccine deaths", Dowd said.

"Pfizer got blanket immunity with EUA [emergency use authorization]. If there is fraud and it comes out, fraud eviscerates all contracts – that's case law," Dowd noted. (Related: [Whistleblower: Pfizer FORGED signatures of trial participants, falsified and fabricated trial data.](#))

Another whistleblower, Dr. Jessica Rose, also obtained information from the Pfizer document dump, which shows that toxic fats have been used in the vaccine and are causing problems in people. These toxic fats apparently go to the organs.

DIE-OFF CONTINUES: Mainstream media censors information about rising COVID vaccine deaths

([Natural News](#)) Mainstream media outlets are trying to hide the [sheer number of deaths associated with the Wuhan coronavirus \(COVID-19\) vaccines](#). Fortunately, those numbers are recorded through the government's own Vaccine Adverse Event Reporting System (VAERS) and same kinds of technology around the world.

According to the Pfizer and AstraZeneca U.K. data, injuries associated with the COVID-19 vaccine include strokes, heart attacks, miscarriages, Bell's Palsy, sepsis, paralysis and more. There had also been reports that the COVID-19 vaccines have been causing blood clots.

The European database also verified that there had been over 32,649 fatalities and 3,003,296 injuries following injections of four experimental COVID-19 shots: Pfizer-BioNTech, Moderna, AstraZeneca and Johnson & Johnson (J&J).

In a summary of data through December 18, 2021, Pfizer vaccines alone caused 15,788 deaths and 1,476,269 injuries; Moderna caused 9,612 deaths and 431,805 injuries; Oxford/AstraZeneca logged in 6,862 deaths and 1,103,016 injuries; and there had been 2,075 deaths and 109,349 injuries for J&J.

These estimates were based on reports submitted to EudraVigilance, and totals are expected to be much higher based on the percentage of adverse reactions that have been reported.

In Scotland, the statistical report showed that the number of cases by vaccination status still proves that the majority of the cases come from the vaccinated population, with thousands being confirmed to be among those who have had their boosters.

In late 2021, it was found that around [45 percent of deaths following COVID vaccination](#) happen in the first two weeks. Peter Schirmacher, a top pathologist, said around 30 to 40 percent of people who died within two weeks after vaccination were killed not by the virus, but by the vaccine.

In taking a conservative view regarding the reports recorded on VAERS, this will show that around 1,145 people have been killed by the vaccine at minimum. However, taking this ratio to the over 230 million vaccinated, then the numbers would fall to around 4.9 deaths per million killed by the vaccine.

This means that the COVID-19 vaccines are at least five times deadlier than the smallpox vaccines, which were deemed to be too unsafe to use. These estimates only assume deaths in the first two weeks following vaccination, and all excess deaths afterward were assumed to have been caused by something else. (Related: [SCIENCE](#))

CDC continues to float false narratives about vaccines.

In mid-2021, the *Centers for Disease Control and Prevention* (CDC) was **[caught driving the false narrative](#)** that vaccines are protecting people against COVID-19. However, this only appeared so because the agency stopped testing “vaccinated” people for the virus.

Reports say the CDC has decided to test only the unvaccinated people for the virus to make it appear that they were the only ones catching the variants.

“The CDC stopped monitoring non-severe COVID-19 cases among vaccinated people in May. It’s hard to assess delta’s risk without knowing what mild breakthrough cases look like – or whether they’re becoming more common,” according to a report.

This is why governments try to claim that the **[only people getting sick from the virus are the unvaccinated](#)**. By refusing to test or monitor anyone who had been inoculated, the data will of course suggest that the vaccines “work.”

In a July 2021 motion, America’s Frontline Doctors (AFLDS) called for an **[immediate stop to COVID-19 vaccination](#)**. According to them, the vaccines were only granted emergency use authorization by the *Food and Drug Administration*, and should not have been given the green light.

In a press release, the group specifically asked that COVID-19 vaccinations be halted for three groups: young Americans aged 18 and below who are at “zero risk” from dying of COVID; those who have recovered from COVID who have acquired natural immunity; and those who have not received informed consent as defined by federal law.

The AFLDS said at the time: *“It is unlawful and unconstitutional to administer experimental agents to individuals who cannot make an informed decision as to the true benefits and risks of vaccines.”*

Cardiac Disorders Account for 20% of 1.2 Million Injuries Reported After COVID Vaccines, VAERS Data Show

VAERS data released Friday by the Centers for Disease Control and Prevention included a total of **1,217,333 reports of adverse events** from all age groups following COVID vaccines, including **26,699 deaths** and **217,301 serious injuries** between Dec. 14, 2020, and April 1, 2022.

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of [1,217,333 reports of adverse events](#) following COVID vaccines were submitted between Dec. 14, 2020, and April 1, 2022, to the Vaccine Adverse Event Reporting System (VAERS). VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of [26,699 reports of deaths](#) — an increase of 303 over the previous week — and [217,301 of serious injuries](#), including deaths, during the same time period — up 2,780 compared with the previous week.

Excluding "[foreign reports](#)" to VAERS, [803,613 adverse events](#), including [12,304 deaths](#) and [79,094 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and April 1, 2022.

[Foreign reports](#) are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product's labeling, the manufacturer is required to submit the report to VAERS.

Of the 12,304 U.S. [deaths reported](#) as of April 1, 17% occurred within 24 hours of vaccination, 21% occurred within 48 hours of vaccination and 59% occurred in people who experienced an [onset of symptoms](#) within 48 hours of being vaccinated.

In the U.S., 561 million COVID vaccine doses had been administered as of April 1, [including](#) 331 million doses of Pfizer, 211 million doses of Moderna and 19 million doses of Johnson & Johnson (J&J).

Every Friday, [VAERS](#) publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Historically, VAERS has been shown to report only 1% of actual vaccine adverse events.

34-year-old dies two weeks after Pfizer vaccine, CDC fails to investigate

A 34-year-old man [died suddenly](#) just two weeks after receiving his first dose of Pfizer's COVID vaccine from an acute [aortic dissection](#) — an uncommon medical emergency in which the inner layer of the large blood vessel branching off the heart's aorta tears. The condition mostly affects men in their 60s and 70s.

In an exclusive interview with [The Defender](#), Victor Castillo Simoes' mother, Henrietta, said her son's only symptom was the chest pain he experienced shortly before he died.

After his death, Henrietta said testing ruled out genetic factors that could have caused the heart condition, and a prestigious researcher working with the family shared her suspicion the vaccine triggered the event.

Henrietta on Sept. 9, [reported her son's death](#) to VAERS. The CDC offered its condolences but did not investigate Simoes' death.

According to the VAERS website, the CDC follows up only on reports classified as serious by *"attempting to obtain medical records to better understand the event."*

In the case of many [vaccine injury stories](#) reported by [The Defender](#) — including Simoes' — medical records are not available for those who suddenly die after receiving a COVID vaccine and did not make it to a hospital for treatment.

According to the VAERS [website](#), this means the CDC is not following up on these reported deaths.

FDA vaccine advisors discuss waning vaccine efficacy, ignore vaccine-injured

The FDA's vaccine advisory panel met Wednesday to [discuss second booster doses](#) of COVID vaccines for the American public.

After nine-and-a-half hours, the Vaccines and Related Biological Products Advisory Committee (VRBPAC) [failed to reach](#) a consensus, even though last week both the CDC and FDA [quietly authorized](#) an additional booster for people over age 50 and the immunocompromised.

During the meeting, committee members determined a second booster dose might be effective — but they weren't sure for how long. The panel didn't know how to define effectiveness or when a new vaccine formulation would be needed to address new variants.

It was also revealed a second dose was authorized based on data from Israel that had not been peer-reviewed. The government of Israel offered the second booster to Israelis over age 60 (not 50) at least four months after their third dose and only followed participants for 8 weeks.

Results showed vaccine effectiveness began to wane early after the second booster (four weeks with regard to infection and seven weeks with regard to severe illness).

Severe illness defined in the study was different than the committee's position, which had always defined severe illness as that which required hospitalization.

Dr. Peter Marks, director of the FDA's vaccine division, Center for Biologics Evaluation and Research, admitted during the meeting the fourth vaccine dose approved last week was a "stopgap measure" — in other words, a temporary measure to be implemented until a proper solution may be found in the future.

Pfizer secretly hired 600+ people to process vaccine injury reports

Newly [released documents](#) obtained via a Freedom of Information Act Request revealed Pfizer hired about 600 additional full-time employees to process adverse event reports during the three months following the [Emergency Use Authorization](#) of its COVID-19 vaccine.

The company said it expected to hire a total of 1,800 additional resources by the end of June 2021, according to the documents.

The [10,000-page document](#) cache [released](#) April 1 by the FDA showed through Feb. 28, 2021, there were a total of 42,086 case reports (25,379 medically confirmed and 16,707 non-medically confirmed) containing 158,893 adverse events received from 63 countries.

Most reported adverse events were in "System Organ Classes" with reactogenicity events including general disorders and administration site conditions (51,335), nervous system disorders (25,957), musculoskeletal, connective tissue disorders (17,283) and gastrointestinal disorders (14,096).

Despite the findings, Pfizer told the FDA its vaccine was "*safe and well-tolerated in healthy adults 18 to 55 years of age, with no unanticipated safety findings.*"

Pfizer knew natural immunity was as effective as COVID vaccine

As [The Defender reported](#) on April 6, the Pfizer documents released April 1 also confirmed Pfizer knew natural immunity was as effective as the company's [COVID](#) vaccine at preventing severe illness.

In a discussion with "Rising" co-hosts Robby Soave and Ryan Grim, Kim Iversen identified what she said was the "*first bombshell*" in the documents: the fact that "*natural immunity works, and Pfizer knows it.*"

Iversen said clinical trial data showed those with previous COVID infection had no difference in outcome compared to those who were vaccinated.

In the limited trial, none of the vaccinated or those with previous infection experienced severe disease as defined by either the CDC or FDA.

The data also showed infection rates were “statistically identical” among the vaccinated and those with natural immunity.

FDA, CDC Guilty Of Clinical Malpractice And Scientific Fraud

- Where are the "Dear Pharmacist" letters to pharmacists who are still daily administering thousands of boosters to kids and other young healthy people?

"Vanuatu must not entertain any treaty to expand the powers of the WHO in Vanuatu in times of Pandemic in the near future," said Andrew Napuat, MP for Tanna Constituency. Vanuatu MPs have become aware of efforts of the World Council for Health (WCH) a coalition of scientists, doctors, lawyers, and civil society advocacy organizations opposing the World Health Organization (WHO)'s moves to implement a power grab in the form of a global pandemic agreement.

Gearing up for the BIG REVEAL: HHS releases FDA gene editing guidance, may soon admit mRNA COVID shots are actually gene therapy products

([Natural News](#)) The *Department of Health and Human Services* (HHS) recently released the *Food and Drug Administration* (FDA) draft guidance for [human gene therapy](#) products.

Entitled “*Human Gene Therapy Products Incorporating Human Genome Editing; Draft Guidance for Industry*,” the document provides recommendations to sponsors developing human gene therapy products incorporating genome editing of human somatic cells.

Medical professional and veteran [pharmaceutical drug development expert](#) Dr. Jane Ruby told host Stew Peters during a recent episode of “The Stew Peters Show” that the FDA has been actually creating guidance documents since 2015 and that these documents tell pharmaceutical companies how they want them to run studies and look at safety and efficacy in gene editing or human genome editing.

[Genome editing](#) is an area of research seeking to modify genes of living organisms to improve the understanding of gene function and develop ways to use it to treat genetic or acquired diseases.

“And you know this is why I want to reiterate that it’s so incredibly important to stop calling it a vaccine. You’ve heard Dr. David Martin say you’re using the words of the criminals. By continuing to call it a vaccine, you’re really saying you don’t have to use as many safety studies, you don’t have to do as much follow up [when developing a vaccine]. You’re putting them off the hook,” said Ruby.

At least one Big Pharma executive has already admitted that the [mRNA vaccines are actually a form of gene therapy](#). It may not be long before federal agencies like the HHS and the FDA do the same.

COVID-19 mRNA vaccines are really for gene editing

The host of *“Live with Dr. Jane Ruby”* and *“The Dr. Jane Ruby Show”* pointed out that the mRNA vaccines are really for gene editing and these were seen in the vials that had been analyzed. She added that Big Pharma companies like Moderna and Pfizer have also talked with the *European Medicines Agency* (EMA), which is the equivalent of the FDA, to let them live with just 50 percent of the vials containing mRNA and the rest as a sort of leeway that they can do anything they want.

Peters noted that the Wuhan coronavirus (COVID-19) shots can’t be called vaccines because they don’t protect people or provide immunity from anything. He added that the COVID-19 shots have negative efficacy and that you are more likely to get sick after the injection.

Peters added that the so called adverse events or side effects are actually intended and planned consequences.

“If you let them keep calling it a vaccine and you’re not calling it gene editing, [human genome editing](#), they’re getting away with not looking at safety and efficacy,” stressed Ruby, who added that the FDA itself has laid out certain parameters in the new guidance document.

CRISPR snips out portion of human gene

Ruby said gene editing technology like CRISPR is chemically snipping out a portion of the God-given human genes in a line and a double strand of DNA to insert something else. She warned that a person has no idea what is going to happen to their body over the years when they undergo gene editing. She added that Moderna and Pfizer are now actively seeking the approval for emergency use authorization of mRNA jabs for six-month-old babies.

It's all about control, according to Ruby.

"That's why they want you to keep taking it. It's a priming mission. The more graphene you get into your body, the more you are filled with what is going to potentially be self-assembling circuitry for the ability to control functions in your body from an external source. And I'm not getting conspiracy theories. I'm actually basing this on a whole host of evidence documents. It's more than just patents. This is known information," Ruby explained.

COVID-19 vaccines used to kill people in what is shaping to be the largest genocide in history

([Natural News](#)) Numerous intel briefings from military and scientific experts showed that the Wuhan coronavirus (COVID-19) vaccines are bioweapons that deliver payloads for mass genocide and dehumanization. CRISPR technology is being used to alter human genes, and they have [graphene oxide as hardware to get inside the body](#).

In a clip from the "Dr. Jane Ruby Show," the host said people are being injected with hardware and repeated injections are bringing software under the guise of helping people avoid what is essentially the flu.

While Ruby noted that she didn't really have a response to these observations as they are not scientific, she did mention that the number of queries she received has been more frequent.

She also mentioned the presence of carbon nanotubes that engage with people's brains and short-circuit them.

“It’s all boiling down to three focal points. Mass genocide, building and controlling hybrid people from within and thirdly, inserting and testing circuitry in humans,” Ruby said.

She also shared that there is a particular theory emerging that indicates there are many different components to this bioweapon that must be injected at different time points in an effort to mimic biochemical reaction, to make the weapon as close to what the body would normally do.

Essentially, what is happening in the body is that there are multiple programs going on at once. First is distributing graphene intra-body for future circuitry. - Metabiota investors include In-Q-Tel, a CIA venture capital firm that specializes in high-tech investments that support or benefit the intelligence capacity of U.S. intelligence agencies, Hunter Biden's investment fund, Rosemont Seneca and the U.S. Department of Defense's Threat Reduction Agency (DTRA), which contracted Metabiota to run operations in U.S.-connected labs in Ukraine.
- In addition to having close ties to the WEF and its Great Reset agenda, Nathan Wolfe, the founder of Metabiota, has also served on the EcoHealth Alliance's editorial board since 2004. In 2017, he co-wrote a study on coronaviruses in bats together with EcoHealth president Peter Daszak, Ph.D. EcoHealth worked closely with the Wuhan Institute of Virology (WIV) in China, where SARS-CoV-2 is suspected of having originated.
- Metabiota's Global Partnerships are led by Andrew C. Weber, former assistant secretary of defense for Nuclear, Chemical and Biological Defense, who created the DTRA.

As evidence of a potential bioweapons cover-up has started emerging, a company called Metabiota is gaining prominence.

The links between Metabiota and several key players in the [COVID](#) pandemic and/or the Ukraine labs story are manifold, so there's no really simple way to unravel it in a logical sequence. That said, let's start with what Metabiota does and the connections of its founder, and expand from there.

Metabiota's mission

[Metabiota's mission](#) is to make the world more resilient to epidemics by providing “*data, analytics, advice and training to prepare for global health threats and mitigate their impacts.*”

Through data analysis, they help “*decision makers across government and industry*” to estimate and mitigate pandemic risks. But they also claim to support “sustainable development,” which seems to have little to do with pandemic risk management.

That term, “*sustainable development,*” is one promoted by Klaus Schwab, founder of the World Economic Forum (WEF). It's part and parcel of Schwab's plan for a global Great Reset and transhumanist revolution (aka, the Fourth Industrial Revolution).

It's not surprising, then, to find out that the founder of Metabiota, Nathan Wolfe, not only has close ties to the WEF, but is also a rising star there. He's a WEF Young Global Leader graduate and was awarded the WEF's Technology Pioneer award in 2021.

Metabiota and the search for pandemic viruses

Metabiota was a core partner of a United States Agency for International Development's (USAID) Pandemic Threat Program called PREDICT, which sought to identify viruses with pandemic potential.

Contractors funded through this program have included the EcoHealth Alliance, headed by Peter Daszak. The PREDICT program, directed by Dennis Carroll, appears to have served as a proof of concept for the Global Virome Project that Carroll founded.

According to a recent investigation by [U.S. Right to Know](#) (USRTK), Carroll appears to have diverted government funds from the PREDICT program while he was still running it, to fund this personal side project, which was set up with the intention to collect, identify and catalogue 1 million viruses from wildlife in an effort to predict which ones might cause a human epidemic.

Metabiota's funding

Metabiota receives [funding](#) from several interconnected organizations and agencies, including:

- Pilot Growth Management, cofounded by Neil Callahan. Callahan is also a cofounder of Rosemont Seneca Technology Partners, and he sits on Metabiota's board of advisers.
- The [Global Virome Project](#), which reportedly paid (or was planning to pay) Metabiota \$341,000 to conduct a cost-benefit analysis.
- In-Q-Tel, a CIA venture capital firm that specializes in high-tech investments that support or benefit the intelligence capacity of U.S. intelligence agencies.
- The U.S. Department of Defense's Threat Reduction Agency (DTRA). Specifically, in 2014, [DTRA](#) awarded Metabiota \$18.4 million in [federal contracts](#) for scientific and technical consulting services to the DTRA's labs in Ukraine and Georgia.

- By outsourcing work to private companies, DTRA is able to circumvent Congressional oversight. Russia is now accusing the U.S. of funding secret and illegal bioweapons research in these Ukraine labs, and claims this was the real reason behind its invasion.
- [Rosemont Seneca](#), an investment fund co-managed by [Hunter Biden](#). If Russia's accusations turn out to be true, this tie may prove deeply problematic for the White House, as this means the Biden family was more or less directly involved in the funding of that research.

Wolfe has also received more than \$20 million in [research grants](#) from Google, the NIH and the Bill & Melinda Gates Foundation, just to name a few, and was a friend of now-deceased Jeffrey Epstein.

In his 2012 book, *"The Viral Storm,"* Wolfe thanked friends for their support, including Epstein and Boris Nikolic. Nikolic, a biotech venture capitalist, was named *"back-up executor"* in Epstein's will.

[Epstein](#), who besides being a convicted pedophile and accused child sex trafficker, had a robust interest in eugenics. It's now well-known that he dreamed of creating a *"superhuman"* race of his own by impregnating dozens of women at a time at his New Mexico ranch.

Epstein also managed to secure meetings with [Bill Gates](#), whose family history is also marked by an interest in eugenics and population control.

Metabiota's founder tied to suspect in COVID pandemic

In addition to having close ties to the WEF and its Great Reset agenda, Wolfe, the founder of Metabiota, has also served on the EcoHealth Alliance's editorial board since 2004. In 2017, he even co-wrote a study on coronaviruses in bats together with EcoHealth Alliance president, [Peter Daszak](#).

As you may recall, [EcoHealth Alliance](#), a nonprofit organization focused on pandemic prevention, worked closely with the [Wuhan Institute of Virology](#) (WIV) in China, where SARS-CoV-2 is suspected of having originated.

Daszak — who received funding for coronavirus research from the National Institute of Allergy and Infectious Diseases (NIAID), led by Dr. Anthony Fauci, and the [U.S. State Department](#) — subcontracted some of that work to Shi Zheng-li at the WIV. He was also the coauthor on research projects at the WIV.

Once rumors of SARS-CoV-2 being man-made first began, Daszak played a central role in the plot to obscure the [lab origin](#) by crafting a [scientific statement](#) condemning such inquiries as *"conspiracy theory."* This manufactured *"consensus"* was then relied on by the media to counter anyone presenting theories and evidence to the contrary.

This, despite the fact that he, in 2015, warned that a global pandemic might occur from a [laboratory incident](#) — and that “the risks were greater with the sort of virus manipulation research being carried out in Wuhan!”

In 2021, two investigations into the origins of the COVID pandemic were opened, one by the [World Health Organization](#) and another by [The Lancet](#), and Daszak somehow managed to end up on both of these committees, despite having openly and repeatedly dismissed the possibility of the pandemic being the result of a [lab leak](#).

Editor’s note: The WHO reference has been scrubbed from both the agency’s website and internet archives, but several news stories like this one from [NPR](#), published after the investigation was launched, are still live and accessible.

Interestingly, one of [EcoHealth Alliance’s](#) policy advisers is a former Fort Detrick commander named David Franz. Fort Detrick is the principal U.S. government-run “*biodefense*” facility, although Franz himself has publicly admitted that “*in biology ... everything is dual use — the people, the facilities and the equipment.*”

Metabiota and the DTRA

In late May 2016, Metabiota hired [Andrew C. Weber](#), a member of the Council on Foreign Relations, to head up its [Global Partnerships](#). Between 2009 and 2014, Weber served as assistant secretary of defense for Nuclear, Chemical and Biological Defense under then-president Obama.

Weber is credited with creating the [Defense Threat Reduction Agency](#) (DTRA) — a combat support agency within the U.S. DoD, specializing in countering weapons of mass destruction, including biological weapons — and as mentioned earlier, the [DTRA](#) has reportedly funded Metabiota to operate U.S.-funded biological research labs in Ukraine.

The DTRA has also issued a number of grants to the [EcoHealth Alliance](#), totaling at least \$37.5 million, including a [2017 grant](#) for [\\$6.5 million](#) to “understand the risk of bat-borne zoonotic disease emergence in Western Asia.”

According to a December 2020 report by [The Defender](#), EcoHealth Alliance had tried to hide most of the Pentagon funding that it had received between 2013 and 2020, most of which came from the DTRA.

Metabiota’s bungled ebola response

In 2016, CBS News published a scathing critique of Metabiota’s response to the 2014 [Ebola](#) epidemic in West Africa. Metabiota had been hired by the WHO and the local government of Sierra Leone to monitor the spread of the epidemic, but according to an investigation by The Associated Press, “*some of the company’s actions made an already chaotic situation worse.*”

In a July 17, 2014, email obtained by AP, Dr. Eric Bertherat, medical officer at the WHO's Department of Epidemic and Pandemic Alert and Response, complained about misdiagnoses and "total confusion" at the small laboratory Metabiota shared with Tulane University in Kenema, Sierra Leone.

According to Bertherat, there was *"no tracking of the samples"* and *"absolutely no control on what is being done."* *"This is a situation that WHO can no longer endorse,"* he wrote. Similarly, Sylvia Blyden, special executive assistant to the president of Sierra Leone, [told AP](#) Metabiota's response was a disaster:

"They messed up the entire region," she said. She called Metabiota's attempt to claim credit for its Ebola work 'an insult for the memories of thousands of Africans who have died.'"

U.S. health official Austin Demby, who evaluated Metabiota's and Tulane's lab work at the request of the U.S. Centers for Disease Control and Prevention and the government of Sierra Leone, was also critical.

In one email, Demby noted used needles were left out and there was no ultraviolet light for decontamination. The space was also too small to safely process blood samples. *"The cross-contamination potential is huge and quite frankly unacceptable,"* he wrote.

Anja Wolz, an emergency coordinator with Doctors Without Borders, told AP she witnessed Metabiota workers entering homes of suspected Ebola patients without protective gear, and leaving high-risk areas without performing any kind of decontamination procedure.

She also accused Metabiota of miscalculating the severity of the outbreak, while insisting that they had the situation under control when clearly, they didn't.

Tulane microbiology professor Bob Garry was also critical of Metabiota's choice to have Dr. Jean-Paul Gonzalez run the operation, as Gonzalez, in 1994, had accidentally gotten infected with a rare hemorrhagic fever while working in a Yale University lab.

He failed to notify anyone about the exposure for more than a week, a delay that put more than 100 other people at risk. Gonzalez was ordered to take a remedial safety course, but according to Garry, such carelessness was a red flag, and he didn't think Gonzalez was the right man to teach Sierra Leoneans about Ebola.

"Do you really want the person who infected himself with hemorrhagic fever going around explaining to people how to be safe?" Garry asked in an email to a Metabiota media representative. Wolfe defended his company, saying there was no evidence they'd done anything wrong. Some of the problems he blamed on misunderstandings, and others on commercial rivalry.

Lab accident 'most likely,' yet least probed cause of COVID

In a March 28, 2022, [report](#), U.S. Right to Know (USRTK) revealed the contents of a 2020 State Department [memo](#) obtained by the group. USRTK [writes](#):

“Origin of the outbreak: The Wuhan labs remained the most likely but least probed,’ reads the topline. The memo is written as a BLUF — ‘bottom line up front’ — a style of communication used in the military. The identity of the author or authors is unknown ...”

“BLUF: There is no direct, smoking gun evidence to prove that a leak from Wuhan labs caused the pandemic, but there is circumstantial evidence to suggest such is the case,’ the memo reads. Apparently drafted in spring 2020, the memo details circumstantial evidence for the ‘lab leak’ theory — the idea that COVID-19 originated at one of the labs in Wuhan, China, the pandemic’s epicenter.

The memo raises concerns about the ‘massive amount’ of research on novel coronaviruses apparently conducted at the Wuhan Institute of Virology and the nearby Wuhan Center for Disease Control lab ... The memo also flags biosafety lapses at both labs, calling the Wuhan Institute of Virology’s ‘management of deadly viruses and virus-carrying lab animals ... appallingly poor and negligent.’

The memo provides an extraordinary window into behind-the-scenes concerns about a lab accident among U.S. foreign policy leaders, even as this line of inquiry was deemed a conspiracy theory by international virologists, some of whom had undisclosed conflicts of interest.

“The memo also calls into question these virologists’ impartiality. Shi Zhengli, a Wuhan Institute of Virology coronavirus researcher nicknamed the ‘Bat Woman,’ has forged wide-reaching international collaborations, including with prestigious Western virologists, the memo notes.”

“Suspicion lingers that Shi holds an important and powerful position in the field in China and has extensive cooperation with many [international] virologists who might be doing her a favor,” it reads ...

The memo laments that ‘the most logical place to investigate the virus origin has been completely sealed off from inquiry by the [Chinese Communist Party]’ ... The memo even suggests that other hypotheses may have served as a distraction from a probe of the city’s extensive research on novel coronaviruses. ‘All other theories are likely to be a decoy to prevent an inquiry [into] the WCDC and WIV,’ it states ...

The memo cites a 2015 [paper](#) coauthored by Shi titled ‘A SARS-like cluster of circulating bat coronaviruses shows potential for human emergence’ that described creating a ‘chimera,’ or engineered virus, with the spike protein of a coronavirus from a Chinese horseshoe bat.

“Editors at ‘Nature Medicine’ added a note in March 2020 cautioning that the article was ‘being used as the basis for unverified theories that the novel coronavirus causing

COVID-19 was engineered' ... But the memo shows that the State Department indeed considered the paper relevant to the pandemic's origins."

NIH retracted gene sequence at WIV researcher's request

While we've yet to obtain bulletproof evidence that SARS-CoV-2 was developed as a bioweapon, there's plenty of [circumstantial evidence](#) that points in that direction.

Disturbingly, as time goes on, more and more of this circumstantial evidence seems to highlight the United States' involvement. If one proverbial finger is pointing at China, four others are pointing back at us.

This is profoundly bad news, but it really ought to strengthen our resolve to get to the bottom of it. None of us are safe until the mad scientists responsible for this pandemic are brought to justice. It doesn't matter who they are. In all likelihood, we'll find that blame cannot be pinned on a single nation. At bare minimum, the U.S. and China appear to be covering for each other.

As just one example, there are the deletions of information that have occurred both at the National Institutes of Health and the WIV, either at the other's request, or as what appears to be a favor.

As reported by [Just the News](#), NIH deleted a genetic sequencing submission of SARS-CoV-2 from its Sequence Read Archive (SRA) at the request of a researcher at the WIV.

[Emails](#) obtained via FOIA request to the NIH by Empower Oversight show a WIV researcher who had submitted two genetic sequences to the SRA, one in March 2020, and a second in June 2020, asked to have the last one retracted.

NIH initially stated that it would be better to edit or replace the submission rather than retracting it, but the researcher insisted it be removed, which they did. To be fair, the NIH also states it has retracted at least eight SRA submissions in total, most from American researchers, at their request.

However, emails also show the NIH directed reporters on how to provide more favorable and less sensationalized coverage of the deletion of the Chinese sequence. Just the News [writes](#):

"[Empower Oversight] says one of the most disconcerting elements of the emails is evidence showing the NIH has refused to participate in a transparent process to examine data on the deleted sequences."

"Most importantly, why has NIH refused to examine archival copies of deleted sequences in an open scientific process to determine whether any of that information might be able to shed light on the origins of the COVID-19 pandemic?' the group asked.

“However, that argument was dismissed by NIH official Steve Sherry. Although sequences are never fully deleted, according to the agency, Sherry told a researcher who asked for transparency, ‘As you know, when data sets are withdrawn from the database, that status does not permit use for further analyses.’”

WIV deleted mentions of U.S. collaborators

The WIV has also deleted information in what appears to be an effort to shield the NIH. Shortly after Fauci testified in a [Senate hearing](#) in March 2021, the WIV quietly deleted all mentions of its collaboration with Fauci’s NIAID, the NIH and other American research partners from its website. As reported May 15, 2021, by [The National Pulse](#):

“March 21st, 2021, the lab’s website listed six U.S.-based research partners: University of Alabama, University of North Texas, EcoHealth Alliance, Harvard University, the National Institutes of Health (NIH), the United States, and the [National Wildlife Federation](#).”

“One day later, the page was revised to contain just two research partners — EcoHealth Alliance and the [University of Alabama](#). By March 23rd, EcoHealth Alliance was the sole [partner](#) remaining.”

“EcoHealth Alliance is run by long-standing Chinese Communist Party-partner Dr. Peter Daszak, who National Pulse Editor-in-Chief Raheem Kassam has repeatedly claimed will be the first ‘fall guy’ of the Wuhan lab debacle ...”

“Beyond establishing a working relationship between the NIH and the Wuhan Institute of Virology, now-deleted [posts](#) from the site also detail studies bearing the hallmarks of gain-of-function research conducted with the Wuhan-based lab.”

Indeed, a now-deleted WIV web page titled “Will SARS Come Back?” [stated that](#):

“Prof. Zhengli Shi and Xingyi Ge from WIV, in cooperation with researchers from University of North Carolina, Harvard Medical School, Bellinzona Institute of Microbiology ... examine the disease potential of a SARS-like virus, SHC014-CoV, which is currently circulating in Chinese horseshoe bat populations.”

“Using the SARS-CoV reverse genetics system, the scientists generated and characterized a chimeric virus expressing the spike of bat coronavirus SHC014 in a mouse-adapted SARS-CoV backbone.”

“The results indicate that group 2b viruses encoding the SHC014 spike in a wild-type backbone can efficiently use multiple orthologs of the SARS receptor human angiotensin converting enzyme II (ACE2), replicate efficiently in primary human airway cells and achieve in vitro titers equivalent to epidemic strains of SARS-CoV.”

“Evaluation of available SARS-based immune-therapeutic and prophylactic modalities revealed poor efficacy; both monoclonal antibody and vaccine approaches failed to neutralize and protect from infection with CoVs using the novel spike protein.”

“On the basis of these findings, they synthetically re-derived an infectious full-length SHC014 recombinant virus and demonstrate robust viral replication both in vitro and in vivo ...”

The WIV’s deletions of American research partners from its website (with the exception of EcoHealth Alliance), and its deletion of the article discussing genetic research on the SARS virus only served to strengthen suspicions of a cover-up. At the time, the most surprising thing about it was that they were covering up American involvement and not just their own.

Are We the Bad Guys?

Alas, as noted by [Maajid Nawaz](#), a former Islamist revolutionary who became an anti-extremism activist, if it turns out that the U.S. did in fact engage in illegal bioweapons development in Ukraine, it might just turn out that we’re the bad guys here. He [writes](#), in part:

“On the 24th February 2022, the very day of Russia’s invasion, some of us were already worried about the prospect of biological weapons laboratories existing in Ukraine ...”

“The existence of bio-weapons labs on Ukraine’s border with Russia has since been confirmed by both Russia and the US (I say both because the Ukrainian government is essentially serving as a US proxy). The only remaining question is around what we were doing in those laboratories.”

“It is no longer in doubt that we funded bio-weapons research in the Wuhan lab in China, from where it is now believed that COVID most likely leaked from. So were we doing the same in Ukraine too? Russia has certainly made the allegation ...”

“The official representative of the Russian Ministry of Defense, Major General Igor Konashenkov [stated](#) ‘In the course of a special military operation, the facts of an emergency cleansing by the Kiev regime of traces of a military biological program being implemented in Ukraine, funded by the US Department of Defense, were uncovered.’”

“With this, he released this document drop [alleging](#) ... that these papers substantiated their case. If Russia’s allegations hold up, the US and her proxy Ukrainian regime would be in violation of the first article of the [UN Convention on the Prohibition of Bacteriological \(Biological\) and Toxin Weapons.](#)”

“Russia’s announcement appears to have forced America’s hand to admit that such bio labs do indeed exist. US Undersecretary of State Victoria Nuland framed this admission by stating that these labs were for defensive research only.”

“Under Secretary Nuland however continued to make the case that such labs would be dangerous if they fell into Russian hands, without apparently noticing the contradiction inherent in her position that such labs are only dangerous because they can be weaponized ...

“Matching Russian precision strikes to a map of bio lab locations inside Ukraine certainly does suggest that Putin’s ‘special military operation’ appears to be targeting some of these dangerous labs.”



Indeed, Nawaz highlights a 2021 Ukrainian [petition](#), to president [Zelensky](#), asking for a) the immediate closure of “*American bio-laboratories in the territory of Ukraine,*” b) an investigation into the activities of those labs, and c) an investigation into potential Ukrainian participation in the creation of SARS-CoV-2.

In other words, at least some Ukrainians, by 2021, were wondering whether the U.S. labs in their country might have been involved in the creation of this pandemic.

Denouncements Ring Hollow

Not surprisingly, the U.S. State Department took a hard line, denouncing all [allegations](#) with the statement that “*The United States does not have chemical and biological weapons labs in Ukraine.*” In another [statement](#), the State Department “*clarified*” that the labs were for “*biodefense,*” not biological weapons, thus semantically cleansing their criminal activities.

The problem with that is that there’s no hard line between biodefense and bioweapons research. As admitted by [EcoHealth Alliance’s](#) policy advisor and former Fort Detrick commander David Franz, it’s all “*dual use — the people, the facilities and the equipment.*” Biodefense implies biowarfare, as it involves the creation of more dangerous pathogens for the alleged purpose of finding treatments against them.

Bioweapons expert Francis Boyle, who drafted the Biological Weapons Anti-Terrorism Act of 1989, has also pointed out that most BSL-4 labs are dual use: “*They first develop the offensive biological warfare agent and then they develop [the supposed vaccine.](#)*” And then, there’s the weapons proliferation [agreement](#) between the U.S. and Ukraine, signed at the end of August 2005.

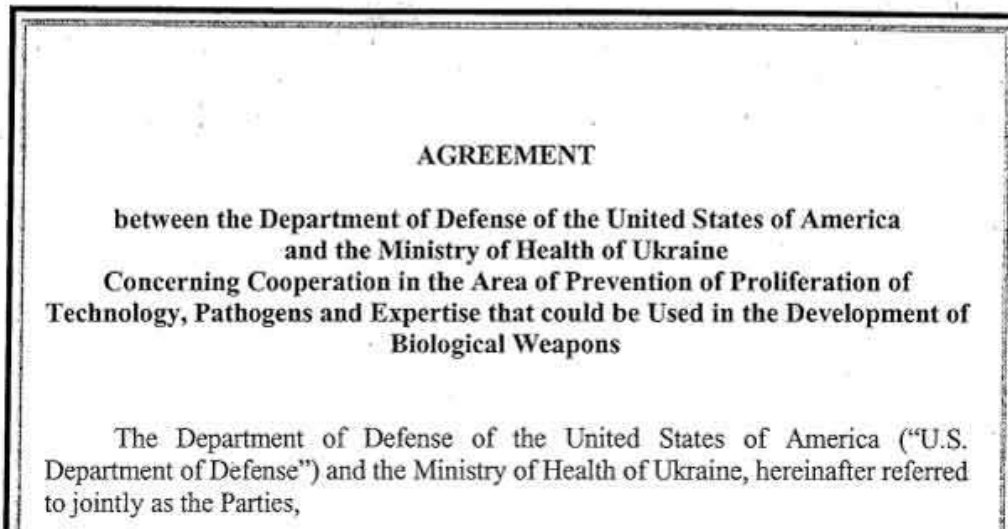

Incidentally, former President Barack Obama spearheaded the project to construct these Ukrainian labs back in 2005, when he was still a senator and, curiously, the [online announcement](#) of his involvement in this project has also been deleted from the web.

According to this agreement, the U.S. Department of Defense will assist the Ministry of Health in Ukraine, at no cost, to prevent "*proliferation of technology, pathogens and expertise*" found in a number of Ukraine labs that "*could be used in the development of biological weapons.*"

The burning question of intent

So, the agreement itself clarifies that they're working on pathogens that COULD be used as biological weapons, and Nuland's stated concerns back this up. The only question remaining then is one of intention. What's the intended use of these pathogens? Defense? Or offense? And is there really a difference?

As noted by Nawaz, the U.S. clinging to the defense of “biodefense” and anti-bioweapons proliferation is *“the equivalent of denying that Einstein’s discovery of splitting the atom to generate energy is not also something that could be used to make nuclear weapons. After the COVID outbreak, the notion that bio labs can be weaponized should simply be presumed as a rule.”*

Also, consider the network of players reviewed earlier. The Ukrainian-American collaboration to study pathogens capable of weaponization is run by the DTRA, which funds Metabiota, which is run by a WEF leader with close personal ties to the one person — Daszak — suspected of being a key player in the creation of SARS-CoV-2, a go-between of the NIH and the WIV, and a central force in the cover-up of the lab leak theory.

Interestingly, Metabiota is also financially backed by [Hunter Biden’s](#) investment company, and let’s not forget that young Biden also collected a six-figure salary from a Ukrainian gas company for doing literally nothing, other than supplying his *“powerful name.”*

Circumstantial or not, it just doesn’t look good. And, by now, it should be crystal clear that any lab doing defensive work is equally capable of churning out offensive weapons. Debating that point is just silly, as it all boils down to semantics.

According to Bulgarian journalist [Dilyana Gaytandzhieva](#), Metabiota is a key player in the Ukrainian labs. David Horowitz, a political writer, has noted that Metabiota is *“a company that tracks the trajectory of outbreaks and sells pandemic insurance, but also seems to have its hand in the actual labs that ... might be the source of some of these outbreaks.”*

In other words, could it be that [Metabiota](#) has been producing biological agents under diplomatic cover and then selling pandemic insurance and pandemic trackers to *“help countries get ahead of what they are putting out?”*

[Nawaz asks](#), *“was ensuring that a ‘next pandemic’ doesn’t occur by taking out these bio labs, what Putin had in mind by his phrase ‘special military operation?’”* At this point, it seems a valid question.

Data points to Increased Mortality of the Vaccinated: Canada and Israel Are Suffering from “A Pandemic of the Fully Vaccinated”

More evidence has come in confirming that the Wuhan coronavirus (COVID-19) vaccines [do not work](#).

Data from highly vaccinated countries like Canada and Israel shows that an overwhelming majority of new [alleged] COVID-19 cases and deaths have come from their fully vaccinated populations.

Canada and Israel are among the world's [most highly vaccinated nations](#). In Canada, 83 percent of the population is fully vaccinated and nearly half the population has received an additional dose. In Israel, 68 percent of the people are fully vaccinated and 58 percent have received a booster dose of the COVID-19 vaccine.

None of the vaccines that flooded Canada have saved it from its current COVID-19 onslaught. Data provided by the federal government of Canada itself shows that [seven out of every 10 COVID-19 deaths](#) are among the fully vaccinated.

The data was taken between Jan. 9 to 15. During that period, Canada had 683 COVID-19 deaths. Of those deaths, 22 were partially vaccinated, 194 were unvaccinated and 467 were fully vaccinated.

This means that 68 percent of COVID-19 deaths are fully vaccinated. If the fully and partially vaccinated deaths are combined, 71.5 percent of deaths will come from the vaccinated.

Previous data from the Canadian government confirms the fact that more vaccinated Canadians are dying from COVID-19.

Israel also suffering as fully vaccinated flood hospitals

According to the *Israeli Ministry of Health*, the country [recorded 14,460 new COVID-19 cases](#) on Monday, March 21. This is a nearly 12 percent increase from the number of new COVID-19 cases reported on Sunday, which was 12,929. (Related: [Highly vaccinated Israel has the most COVID-19 cases per capita IN THE WORLD.](#))

Of the 14,460 people diagnosed with COVID-19 on Monday, the Health Ministry reported that a vast majority of them were vaccinated.

According to the data, 83.1 percent of the new COVID-19 cases that day were vaccinated and just 16.1 percent were unvaccinated. The remaining 0.8 percent had no listed vaccination status.

Nearly 17 percent of all COVID-19 tests taken on Monday came back positive, a nearly two-time increase from a week ago, when just around 10 percent of COVID-19 tests came back positive. This is the highest infection rate increase in Israel in more than a month.

The country's infection coefficient, which gauges how infectious the current outbreak is, also rose to 1.33 – a 33 percent rise from just a week ago when the

coefficient was just 1.00. This means Israel is experiencing another wave of COVID-19 cases, and it is accelerating.

Earlier last month, the medical director of one of the largest hospitals in Tel Aviv reported in an interview that between 70 to 80 percent of serious COVID-19 cases in their hospital were fully vaccinated individuals.

“Right now, most of our severe cases are vaccinated,” said Dr. Yaakov Jerris, director of the Tel Aviv Sourasky Medical Center. *“They had at least three injections. Between 70 and 80 percent of the serious cases are vaccinated. So, the vaccine has no significance regarding severe illness, which is why just 20 to 25 percent of our patients are unvaccinated.”*
