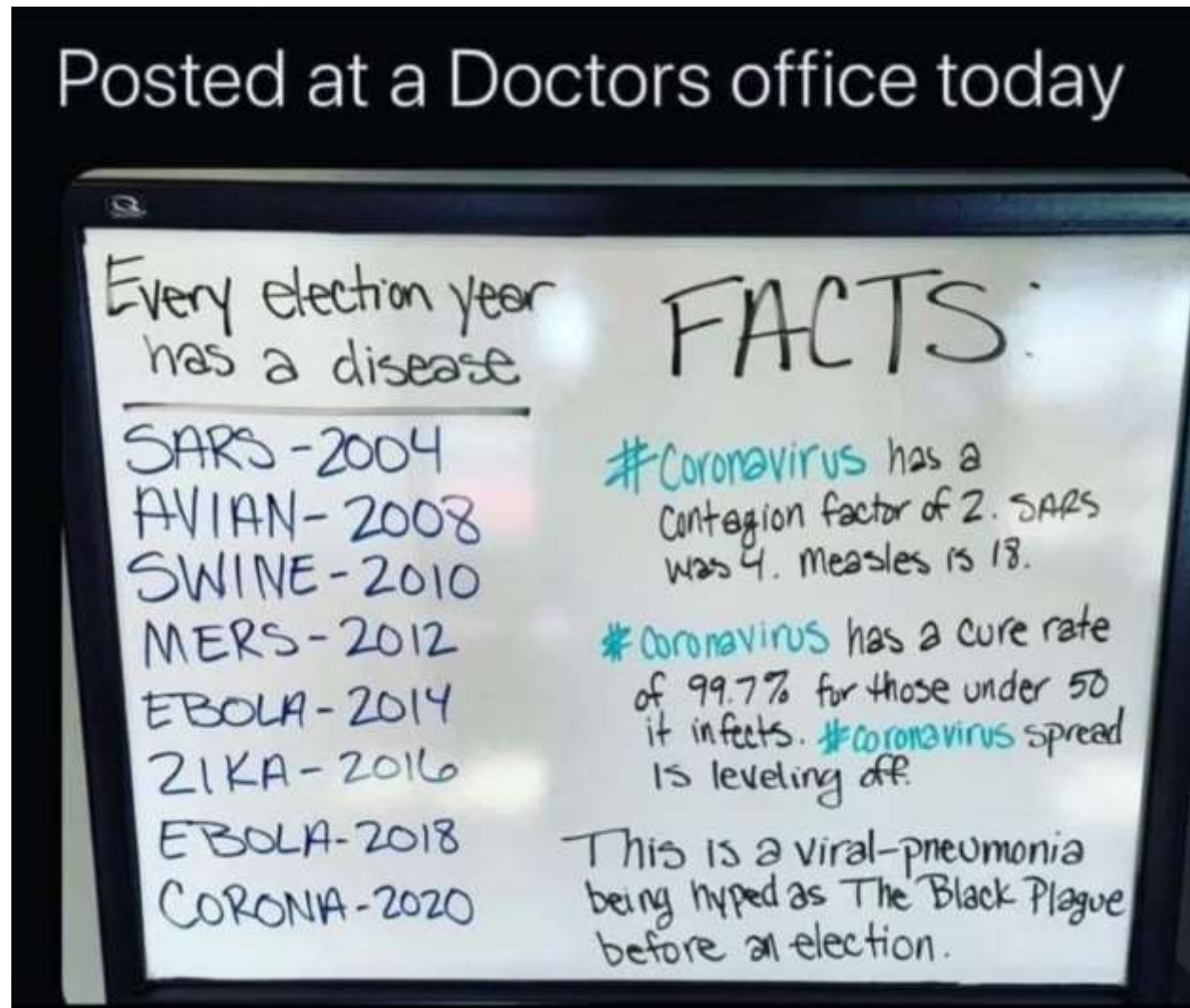


# Mass Murder

## Part 6

VAERS data released today showed **56,869** reports of adverse events following COVID vaccines, including **2,342 deaths** and **7,971 serious injuries** between Dec. 14, 2020 and April 1, 2021. But this does not tell the whole story and the death rate is growing more than expected and predicted.

Data released today by the Centers for Disease Control and Prevention (CDC) on the number of injuries and deaths reported to the [Vaccine Adverse Event Reporting System \(VAERS\)](#) following [COVID vaccines](#) confirmed that numbers are still rising, but no new trends emerged.

VAERS is the primary mechanism for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Every Friday, [VAERS](#) makes public all vaccine injury reports received to the system for the previous week. Today's data show that between Dec. 14, 2020 and April 1, a total of **56,869 total adverse events** were reported to VAERS, including **2,342 deaths** — an increase of **93** over the previous week — and **7,971 serious injuries**, up **245** over the same time period.

[At first glance the lower weekly deaths and side effect issues might seem to be positive numbers by their lower level from previous weeks. This may repeat in next week's data reported by VAERS. The Easter season and spring break could bias reporting and recording of data. As Robert F. Kennedy's report notes below that the CDC has not responded to inquiries and questions for a full month.

The government agencies are under no obligation to provide timely or accurate information and rely on their ability to stonewall watchdog groups seeking accountability in providing this information.] As such they cannot be trusted as truthful and forthcoming.

\* Because some cases have multiple vaccinations and symptoms, a single case can account for multiple entries in this table. This is the reason why the Total Count is greater than 56869 (the number of cases found), and the Total Percentage is greater than 100.

Of the 2,342 deaths reported as of April 1, **28% occurred** within 48 hours of vaccination, 19% occurred within 24 hours and **42% occurred** in people who became ill **within 48 hours** of being vaccinated.

### [Ask Congress to Investigate COVID Origins - Take Action](#)

In the U.S., **153.6 million** COVID vaccine doses had been administered as of April 1. This **includes** 71.3 million doses of Moderna's vaccine, 78.2 million doses of Pfizer and 3.4 million doses of the Johnson and Johnson's (J&J) COVID vaccine.

This week's VAERS data show:

- 19% of deaths were related to cardiac disorders.
- 55% of those who died were male, 43% were female and the remaining death reports did not include gender of the deceased.
- The **average age** of those who died was **77.5** and the youngest death was an 18-year-old. There are a few reported deaths in children under 18, but these reports contained errors.
- As of April 1, **379 pregnant women** had reported adverse events related to COVID vaccines, including 110 reports of **miscarriage or premature birth**.
- Of the **620 cases of Bell's Palsy reported**, 61% of cases were reported after **Pfizer-BioNTech** vaccinations — almost twice as many as reported (37%) following vaccination with the Moderna vaccine. Fifteen cases (2%) of Bell's Palsy were reported with J&J.
- There were **72 reports of Guillain-Barré Syndrome** with 57% of cases attributed to Pfizer, 43% to Moderna and 6% to J&J's COVID vaccine.

- There were [16,876 reports of anaphylaxis](#) with 50% of cases attributed to [Pfizer's COVID vaccine](#), 44% to [Moderna](#) and 7% to [J&J](#) vaccine.

According to the [CDC's website](#), “the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated.”

On March 8, [The Defender](#) contacted the CDC with questions about reported deaths and injuries related to COVID vaccines. We provided a written list of questions about how the CDC conducts investigations into reported deaths, the status of investigations on deaths reported in the media, if autopsies are being done and the standard for determining whether an injury is causally connected to a vaccine.

We also inquired about whether healthcare providers are reporting all injuries and deaths that might be connected to the COVID vaccine, and what education initiatives are in place to encourage and facilitate proper and accurate reporting.

Twenty-two days later a representative from the CDC's Vaccine Task Force responded by saying the agency had never received our questions — even though the employees we talked to several times said their press officers were working through the questions we sent. We provided the questions again and requested a response by April 7. To date, the CDC has not responded despite our repeated follow-up attempts.

Update on investigation into death of Florida doctor after Pfizer vaccine.

As [The Defender reported today](#), Florida health officials [said Thursday](#) their joint investigation with the CDC into the death of 56-year-old Dr. Gregory Michael confirmed Michael's death was caused by immune thrombocytopenia, a [blood disorder caused by an immune reaction](#).

Michael developed symptoms of the disorder three days after receiving his first dose of the Pfizer COVID vaccine, and died 12 days after that.

An official with the Florida Department of Health said investigators could not determine with “medical certainty” if there was a link between the vaccine and Michael's death, leading them to conclude the doctor died of natural causes.

What I am now about to share is very alarming but in line with what I predicted in the last two reporting dates of Mass Murder. From April 1<sup>st</sup> to April 5<sup>th</sup> (Easter Weekend) there was a huge increase in deaths. A total of **545 deaths** were added, more than doubling the weekly trend for March, 2021.

In what is becoming the most censored story probably in the history of the United States, the CDC has reported this week that **2,794 deaths** have been reported to VAERS as of April 5, 2021, following injections of the three experimental, non-FDA approved, COVID-19 injections.

The Vaccine Adverse Event Reporting System (VAERS) is a U.S. Government funded database that tracks injuries and deaths caused by vaccines.

To put this into some perspective, there were a total of 345 deaths recorded in VAERS following vaccines for all of 2020.

From 2010 through the end of 2020, an entire decade spanning 11 years, there were a total of 2,588 deaths recorded following vaccines.

So deaths following vaccines during the first three months of 2021 have now exceeded total deaths for the past 11 years.

How is this not headline news?

And judging by reported surveys among Americans who plan to get one of these experimental injections, more than half the population actually believes the CDC that these THOUSANDS of deaths following the injections are “coincidence” and have nothing to do with the injections.

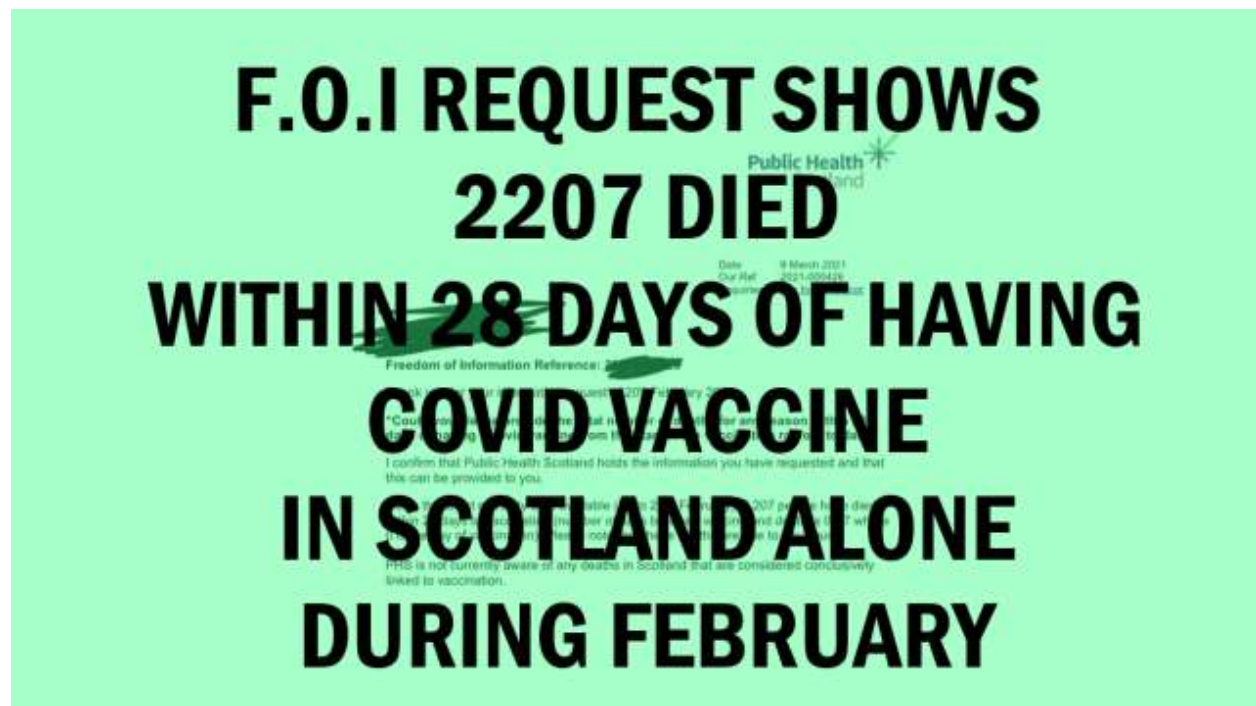

The weekly figures from VAERS actually seem rather low for other reasons. The below Freedom of Information Request is from Scotland, pertaining to 2,207 deaths in February. What is alarming is that Scotland only has a population of 5.4 million. The U.S. population is 331-million from the official Bureau of Census data.



Without doing some detail statistical analysis, my guess is that the U.S. numbers being reported are being under-reported. Doctors such as Dr. Sherri Tenpenny and others are on record saying that 90% of side effects will go unreported to the public health and physicians. When the death rate spikes in the fall with colder weather, it becomes more difficult to differentiate causal and correlation between side effects. And if they get their way and implement a [new COVID Vaccine Passport](#) <sup>[3]</sup>, they will be mandated for many other activities in society, such as air travel, entrance to places of business, etc.





A growing number of U.S. colleges are announcing plans to mandate the vaccination of students returning to campus this fall, in line with President Joe Biden's pledge to make all adults in the country eligible for COVID-19 jabs by early summer.

At least six colleges – Cornell University, Rutgers University, Fort Lewis College, Nova Southeastern University, St. Edward's University, and Roger Williams College in Rhode Island – have so far said that *all students would need to be vaccinated before a fall return*. Two more colleges have been added to the list, their names were not known at the time of the posting of this information.

Three COVID-19 vaccines have been authorized for emergency use by the Food and Drug Administration (FDA) in the United States so far – Pfizer/BioNTech's two-dose vaccine, Moderna's two-dose vaccine, and Johnson & Johnson's single-shot vaccine. Emergency use authorization is a faster, *less rigorous process* compared to full FDA approval.

Vaccines that have previously been required by U.S. colleges, for example shots for rubella or measles, had full FDA approval.

Rutgers President Jonathan Holloway said in a statement that its vaccine requirement will apply to three of the university's main campuses—New Brunswick, Newark, and Camden. Beginning this fall, students will be required to present “proof of vaccination” *before they are allowed to move into their dormitories, or attend physical classes*.

*“Adding COVID-19 vaccination to our student immunization requirements will help provide a safer and more robust college experience for our students,” Holloway said in the statement, noting that students may file for an exemption for religious or medical reasons.*

Fort Lewis College President Tom Stritikus said in a letter that the requirement will provide “*our best hope for returning to the hands-on, inclusive, experiential, and personalized learning environment that we have all come to love.*”

*“As such, all students enrolling at FLC for the fall 2021 semester will be required to get a COVID-19 vaccine,”* Stritikus said.

Cornell University President Martha E. Pollack wrote in a letter that it plans to require students returning to Ithaca, Geneva, and Cornell Tech campuses this fall to be

vaccinated against COVID-19, the disease caused by the CCP (Chinese Communist Party) virus.

The decision was made following “*recent announcements of expanded vaccine eligibility in New York and other states, and increasing vaccine production,*” Pollack said.

On Friday, Nova Southeastern University said in a statement that it intends to resume “full, in-person classroom learning for on-ground courses” in the fall, and that *all students, faculty, and staff will need to be vaccinated.*

At St. Edward’s University, *all employees and students aged 16 and above will be required to be vaccinated* for a return to campus this fall semester, its COVID-19 Steering Team announced ([pdf](#)). Pfizer’s vaccine is the only one with FDA authorization for use in people as young as 16.

According to The New York Times, since Jan. 1, more than 120,000 CCP virus cases have been linked to U.S. colleges and universities, with more than 100 deaths involving students and employees since the beginning of the pandemic. The majority of those who have died have been employees, and most of the deaths occurred last year, the report states, citing case data through open records requests at public universities.

## Euro Court of Human Rights rules Mandatory Vaccination is Legal

In another blow to those fighting for freedom the European Court of Human Rights (ECHR) has ruled that mandatory vaccinations are legal and may be necessary in democratic societies.

The ruling has come in response to a complaint made to the court by families in the Czech Republic in regards to compulsory vaccination of children. The ECHR said "*the measures could be regarded as being 'necessary in a democratic society'*".

The court's ruling was not in relation to the experimental Covid-19 vaccines, however it has now set a dangerous precedent in which countries can now comfortably believe they are not breaking the convention on human rights if they are to make inoculation with the experimental jabs mandatory.

This judgment "*reinforces the possibility of a compulsory vaccination under conditions of the current COVID-19 epidemic,*" according to Nicolas Hervieu, a legal expert specializing in the ECHR.

The decision said that the compulsory vaccines administered by Czech health authorities were in line with the "*best interests*" of children. "*The objective has to be that every child is protected against serious diseases, through vaccination or by virtue of herd immunity,*" it added.

The court ruled that the Czech health policy was not in violation of Article 8 on the right to respect for private life in accordance with the European Convention on Human Rights. By Czech law, children must be vaccinated against nine diseases including diphtheria, tetanus, whooping cough, hepatitis B and measles. The case was brought to the court by families that had been fined or whose children had been refused access to a nursery for failing to comply with their legal vaccination duty.

The ruling is bound to please Tony Blair who has been working tirelessly to ensure the United Kingdom enforces a “vaccine passport” system. *Something which if it came to fruition would essentially be a freedom pass.*

## Covid's "Third Wave" Will See Mass Death Among the VACCINATED

Natural News) There is a "third wave" of the Wuhan coronavirus (Covid-19) barreling our way. And those affected by it will be the "vaccinated" who agreed to get injected with experimental gene therapy cocktails that have forever altered their DNA and made them more susceptible to disease and death.

Buried within a report compiled by the Scientific Pandemic Influenza Group on Modeling (SPI-M) is an admission that most of the people who will die during the so-called third wave will have already been fully injected for the Chinese virus.

*"The resurgence in both hospitalizations and deaths is dominated by those that have received two doses of the vaccine, comprising around 60 per cent and 70 per cent of the wave, respectively,"* the report reveals.

*"This can be attributed to the high levels of uptake in the most at-risk age group,"* it further explains.

The group's reasoning is that around 10 percent of people over 50 who are vaccinated will not derive any protection from the vaccine, this based on a supposed 90 percent "efficacy" rate. This 10 percent equates to around 2.9 million people.

One analyst predicts around 40,000 deaths while another says there will be closer to 60,000 deaths. Either way, this is a lot of deaths caused by a "vaccine" that in and of itself is completely unnecessary based on the fact that the Chinese virus itself is not even that high-risk.

While one in 200 people were said to have died during the "first wave" – and we know this was drastically overinflated – as many as one in 70 will die during the third wave, experts predict, all thanks to the vaccine.

**Summertime sees fewer infections across the board, but just wait until fall and winter.**

After bearing criticism for supposedly being too "pessimistic," some modelers have since painted a rosier picture about how everyone who has been vaccinated will be just fine. This makes people feel good and will thus likely be the narrative that is perpetuated moving forward.

When people start dropping dead, however, will they make the connection to the jabs, or will the unvaccinated simply get blamed? The medical establishment always seems to have a way of assigning blame to something other than the true cause.

Still, not all sources are predicting beautiful outcomes for the vaccinated. One analyst says the controversial AstraZeneca jab will only reduce "infections" by about 31 percent after two doses. Others say the shots might perform a little better at around 63-65 percent.

AstraZeneca, meanwhile, is claiming an efficacy rate of 94 percent, ignoring the hordes of job recipients who are [dropping dead from blood clots](#) caused by the injection.

The seasonality aspect must also be considered as greater sunlight exposure and other factors tend to mean less sickness during the warmer months. Just wait until fall and winter, though, when seasonal illness starts to “spread” and every vaccinated person whose body has been primed to react unnaturally to pathogenic exposure sees his or her immune system kick into overdrive.

Think cytokine storms the likes of which this world has never seen, resulting in mass sickness and death.

### **Skip the Jab and Just Live Your Life**

The report also predicts a spike in the reproduction rate, or “R” number, of the Wuhan coronavirus (Covid-19), bringing it back to, or even higher than, what it supposedly was at the start of this whole thing.

The model suggests that the R-rate will rise to 2.2 by May 17, which is what it was during the previous Tier Two restrictions that were imposed throughout the U.K.

Even outlets that support vaccination are starting to admit that people’s natural immune response is attributable to declining infection rates, even without the jabs. At the same time, they are pushing them as a way to supposedly keep the R-rate low, despite the fact that many expect it to raise because of mass injection campaigns.

*“... it’s worth bearing in mind that a substantial proportion of these unvaccinated people will already have immunity from a prior infection, or at least some natural immunity from other coronavirus,”* points out one source that would otherwise seem to support vaccination.

On the flip side, the dire models that admit vaccinations are going to cause more death are also being used to suggest that lockdowns and restrictions should remain, which the same quoted source above points out should not be the case.

*“Continuing to base policy on models which are already out of date by the time they are presented cannot be a sensible way to make decisions about the nation’s freedom,”* it contends.

*“It’s time to move on – cautiously, but resolutely – with the release of restrictions based on data not dates, and certainly not models.”*
