SOUTHLAKE, Tex. — The Rutherford Institute is challenging attempts by a Texas school district to prohibit its employees from publicly criticizing the school or its policies. In a letter to officials at the Carroll Independent School District, Rutherford Institute attorneys warn that the non-disparagement clause included in the District's employment contracts, which requires employees to *"agree to not disparage, criticize, or defame the District, and its employees or officials, to the media,"* constitutes a restriction on speech in violation of the First Amendment that would likely not hold up in court.

"As public bodies entrusted with the care and education of America's children, schools should be free speech forums that encourage critical thinking skills," said constitutional attorney John W. Whitehead, president of The Rutherford Institute and author of *Battlefield America: The War on the American People*. *"Forcing teachers to muzzle their concerns about the government's policies or actions sends a chilling message to students that there is no room for transparency and accountability in government."*

In 2021, the Texas legislature enacted House Bill 3979, commonly referred to as Texas' *"critical race theory law,"* which requires teachers who choose to discuss *"controversial issues of public policy or social affairs"* in the classroom to strive

to present multiple perspectives. During a training session, an administrator at the Carroll Independent School District suggested that if teachers have a book on the Holocaust, they should also provide a book from an opposing perspective. The suggestion dismayed teachers, spurring them to speak out publicly on the issue and resulting in significant media attention and criticism of the school district for its interpretation of House Bill 3979. Several months later, apparently in response to the media backlash, a non-disparagement clause was included in the District employees' annual contracts. The clause prohibits criticism of the District, its officials, and employees to the media but does not prohibit employees from praising or commending the District and its officials. However, as Rutherford Institute attorneys warn in a legal analysis provided to the District, muzzling teachers in order to avoid bad press is unconstitutional. Whether the individual is a teacher, parent, student or member of the community, the right to publicly criticize a government body is firmly grounded in the First Amendment. Moreover, such content-based restrictions on speech *"are presumptively unconstitutional."* As the letter notes, *"public school teachers... cannot 'constitutionally be compelled to relinquish the First Amendment rights they would otherwise enjoy as citizens to comment on matters of public interest in connection with the operation of the public schools in which they work."* Non-disparagement policies by government employers have also been found unconstitutional. Rutherford Institute attorneys concluded by calling on the Carroll Independent School District to remove the non-disparagement clause from the District's employment contracts in order to ensure that its policies align with the spirit and the letter of the Constitution.

Two weeks ago it was reported that, Northern Ireland faces the loss of 1 million sheep and cattle to meet climate targets – ‘Farming sector to reach net-zero carbon emissions by 2050’.

Northern Ireland Assembly’s first climate act will require the farming sector to reach net-zero carbon emissions by 2050.

Northern Ireland will need to lose more than 1 million sheep and cattle to meet its new legally binding climate emissions targets, according to an industry-commissioned analysis seen by the Guardian.

The large-scale reduction in farm animals comes after the passing of the jurisdiction’s first ever climate act, requiring the farming sector to reach net-zero carbon emissions by 2050 and reduce methane emissions by almost 50% over the same period.

About a third of human-caused methane emissions come from livestock, mostly from the burps and manure of beef and dairy cattle. **Analysis by KPMG, commissioned by industry representatives including the Ulster Farmers’ Union (UFU), estimates more than 500,000 cattle and about 700,000 sheep would need to be lost in order for Northern Ireland to meet the new climate targets.**

Separate analysis by the UK government’s climate advisers suggests chicken numbers would also need to be cut by 5 million by 2035. Both the pig and poultry sectors in Northern Ireland have seen rapid growth in the past decade.

Northern Ireland has for some years been the only devolved administration without dedicated climate legislation and targets for emissions reduction. The region’s agrifood industry and associated farming groups have long raised concerns about the expected impact of emissions reductions.

Agriculture accounts for about 27% of Northern Ireland’s greenhouse gas emissions, with the vast majority coming from livestock. Its heavily export-driven meat industry principally supplies Great Britain, but it also exports to China and North America. But Irish agriculture is under huge pressure: 35% of national greenhouse gases come from the sector, the highest level in Europe, where the

average is 11%. And more than 60% of that comes from methane associated with belching by ruminant animals.

The country's principal poultry processor, Moy Park (a subsidiary of the Brazilian meat giant JBS), has grown into one of Europe's biggest such firms and Northern Ireland's largest company, while the Armagh-based JMW Farms pig producer saw its gross turnover [nearly treble to £54m](#) between 2011 and 2020.

A spokesperson for KPMG said: "Under the [Climate Change Act's] net-zero target, we have assumed that 'beef and other cattle', 'dairy' and 'sheep' do the most work to decarbonize due to these sectors accounting for the largest livestock-related impact on NI's carbon emissions.

"Both the 'pig' and 'poultry' sectors have a minor impact on agriculture carbon emissions (2% and 1%, respectively) and, therefore, any effort to decarbonize can be assumed to have a minor impact on total carbon emissions."

At the December, 2021 COP26 Glasgow Summit, More than 100 countries pledged to reduce methane emissions by 30% by 2030 in Glasgow on Tuesday in an initiative put forward by the U.S. and the EU. Although methane breaks down relatively quickly in the atmosphere, it is a more potent greenhouse gas than carbon dioxide. Reducing these emissions has been touted as one of the most immediate opportunities to slow global heating.

KPMG looked at four scenarios, concluding that rural Ireland faced a €4bn hit to the economy and the loss of more than 56,000 jobs if the government opted for the 30% target.

It also warned that a 30% cut would require a 20% cut in cattle numbers, 22% of the beef herd and 18% of the dairy herd. With 6.5 million cattle in the country according to official Central Statistics Office data this equates to a reduction of 1.3 million of the national herd.

The lower target of 21% would mean a reduction of about 5%, or 325,000 cattle, according to the KPMG analysis.

"Farmers desperately hope that it doesn't come to this [culling]," said Phelim O'Neill, editor of the 'Irish Farmers Journal'. "There is widespread acknowledgement that we need to reduce emissions", he said but he had commissioned the report to put some facts back into the "heated debate" that is giving farmers "climate anxiety" about their futures.

The debate has pitted Dublin versus rural Ireland, with farmers feeling they are being unfairly targeted without government assessments of the impact on their industry.

The president of the Irish Farmers' Association, Tim Cullinan, said it was "extraordinary" to hear the Taoiseach say the report was scaremongering.

Martin told RTE on Tuesday: *"I think we need to be very careful of that scaremongering,"* after reports that targets at the lower end of the scale would result in 10,000 fewer jobs in agriculture. *"Farming will have to change,"* he said.

Cullinan said: *"We have repeatedly asked for such an exercise to be carried out by our government, but they have refused to do so. Micheál Martin is shooting in the dark and he has no idea what the economic or social impact of these ceilings will be in rural areas."*

Ireland has committed to reducing carbon emissions by 50% by 2030 with a cabinet subcommittee meeting on Wednesday to finalize the sector details.

Four years ago, Kim Stanley Robinson wrote in the 'UK Guardian', "Empty half the Earth of its humans. It's the only way to save the planet."

Ginger is one of 12 Holstein cows participating in an experiment being conducted by Roque's animal science professor, Ermias Kebreab, into reducing methane emissions from livestock by supplementing their diets with a specific type of seaweed. Methane is a potent greenhouse gas, with roughly 30 times more short-term, heat-trapping power than carbon dioxide. In California alone, 1.8 million dairy cows, together with a smaller number of beef cattle, emit 11.5 million metric tons of carbon dioxide equivalent every year — as much as 2.5 million cars.

In the U.S., domestic livestock contribute 36% of the methane humans cause to be put into the atmosphere. The U.S. "\$3.5 Trillion Infrastructure package includes an animal agriculture tax on dairy cows in the amount of \$6,500.00 and \$2,600.00 per head of other cattle." "It also includes an agriculture tax in the amount of \$500.00 on swine (pigs- hogs) raised in the United States," the post says. "AND that would be for each and every year." The UC Davis study will contribute to a global store of knowledge on how to limit the methane produced by "enteric fermentation" — the digestive process in a ruminant's upper stomach chamber, or rumen, where microbes predigest fiber and starch, releasing gases when they belch and exhale. It's "one of a handful of options in various stages of development that seem to have the potential to

reduce [enteric] methane by 30 percent or more,” says Ryan McCarthy, science advisor to the Air Resources Board.

Kebreab’s experiments with seaweed additives to cattle feed have now surpassed that 30% figure, with one type of seaweed slashing enteric methane by more than 50%. In the fight to slow climate change, such reductions are no small matter: In the United States alone, domestic livestock — including cattle, sheep, goats, and buffalo — contribute 36% of the methane humans cause to be put into the atmosphere, according to the U.S. Environmental Protection Agency.

The enormity of those numbers, in part, motivated California lawmakers to pass a law to reduce methane emissions and other short-lived “climate pollutants” by 40% below 2013 levels by 2030. The California Air Resources Board subsequently ordered a majority of the reductions in the new law to come from the dairy industry. Other cuts will come from diverting organic waste from landfills and eliminating fugitive emissions associated with oil and gas operations.

Has all of what I have written to this point got your attention? Agenda 2030 does not begin in 2030, it began several decades ago and now nations are forced to deliver on their commitment obligations. At the 1992 Earth Summit in Rio, there was an agreed voluntarily treaty signed by 105 or so countries to reduce their population. Did you catch that word “reduce”? America is well into a growing food crisis, with shelves empty of baby formula and serious egg shortages. Now there’s also a major hiccup in the chain of chicken products. Tyson and Perdue have had frequent recall of product. Wayne Farms previously recalled 30,285 pounds of ready-to-eat chicken breast fillet

products because they may be undercooked, according to the U.S. Department of Agriculture.

BTW an article published by the London *'Daily Mail'* on June 19, 2020, revealed that Bill Gates, Mark Zuckerberg, Jeff Bezos, and other billionaires invested in a new startup company to produce artificial breast milk from cultured human mammary epithelial.

According to the article, U.S. firm BIOMILQ has received \$3.5 million from an investment fund that is co-founded by Bill Gates, Jeff Bezos, Richard Branson, and Mark Zuckerberg to 'prevent climate change due to gases created in formula manufacturing.'

An artificial breast milk start-up that offers a green alternative to baby formula has received \$3.5 million (£2.8m) from an investment fund co-founded by Bill Gates. According to the company’s website, in 2021, they successfully produced the world’s first cell-cultured human milk outside of the breast.

“Our team is thrilled to announce that we have produced the world’s first cell-cultured human milk outside of the breast. We find ourselves at the frontier of lactation science, helping to advance the entire field by putting mothers and babies at the forefront.”

According to UC Davis Human Milk Researcher & BIOMILQ Technical Advisor Dr. Jennifer Smilowitz, *“human milk is tremendously complex in both composition and structure which has made it impossible to replicate outside of the lactating parent.”* Until now that is!

In just 11 months, we have moved the field of lactation science from proof of concept to proof of complexity, producing milk compositions that look more like a symphony than a concerto. We’re a HUGE step closer to empowering parents with another infant feeding option, one that provides much of the nutrition of breastmilk with the practicality of formula.

Cracker Barrel meatloaf dinner in Kentucky was \$17 on Mother's Day but came down to \$11 the following Sunday. Even pancakes are \$10 a plate minus your beverage choice!

While the PPI focuses on prices, the PPI data for April shows exactly that service side contraction now taking place. Wholesale inflation in goods is determined heavily by higher costs for raw materials and processing. However, the rate of inflation within the service sector is more connected to what consumers can afford to spend.

Economic collapse and war are factors in what we will see, however, they are secondary symptomatic factors of the real insidious issue here. "DEPOPULATION" is the real agenda and if you do not understand that you are greatly deceived and destined to be the victim of Agenda 2030.

"DEPOPULATION" has been the World's #1 issue since 1967 following the publishing of Dr. Paul Ehrlich's book, *'The Population Bomb'*. It was the focus of the *'Iron Mountain Report'* and numerous confidential studies held in the years following. Subtitled "ON THE POSSIBILITY AND DESIRABILITY OF PEACE", the *'Iron Mountain Report'* was written the same year Dr. Ehrlich's book was published. The *'Iron Mountain Report'* was about a world free of war and the impact of peace upon the world's population. It is likely the reason President Lyndon B. Johnson decided not to run for re-election during the Vietnam War!

Refugees have been pouring out of the Ukraine since February. Approximately 5.5 million Ukrainians have left the country as of May 2, 2022 and that figure is expected to grow to \$12 million in the months ahead. Many of the refugees have gone to stay with relatives abroad, which seems natural.

But what about the millions without personal connections overseas?

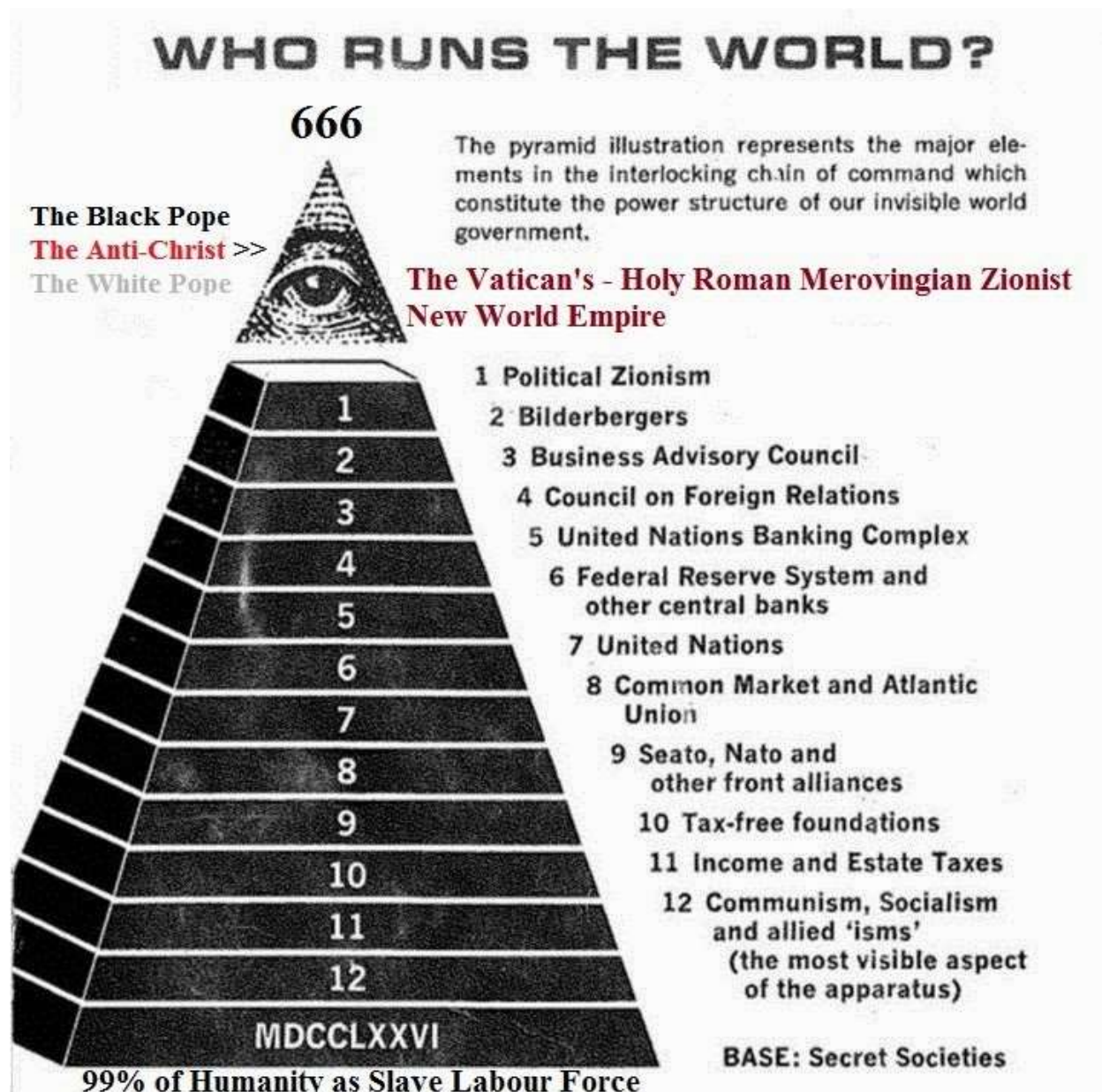
Not surprisingly, virtue-signaling politicians in the European Union and the United States quickly opened their borders. However, providing immediate housing for that many people presents a huge logistical challenge. 5+ million is just a lot of people. Resources in many European countries have already been tapped out by the waves of refugees from war-torn areas in the Middle East.

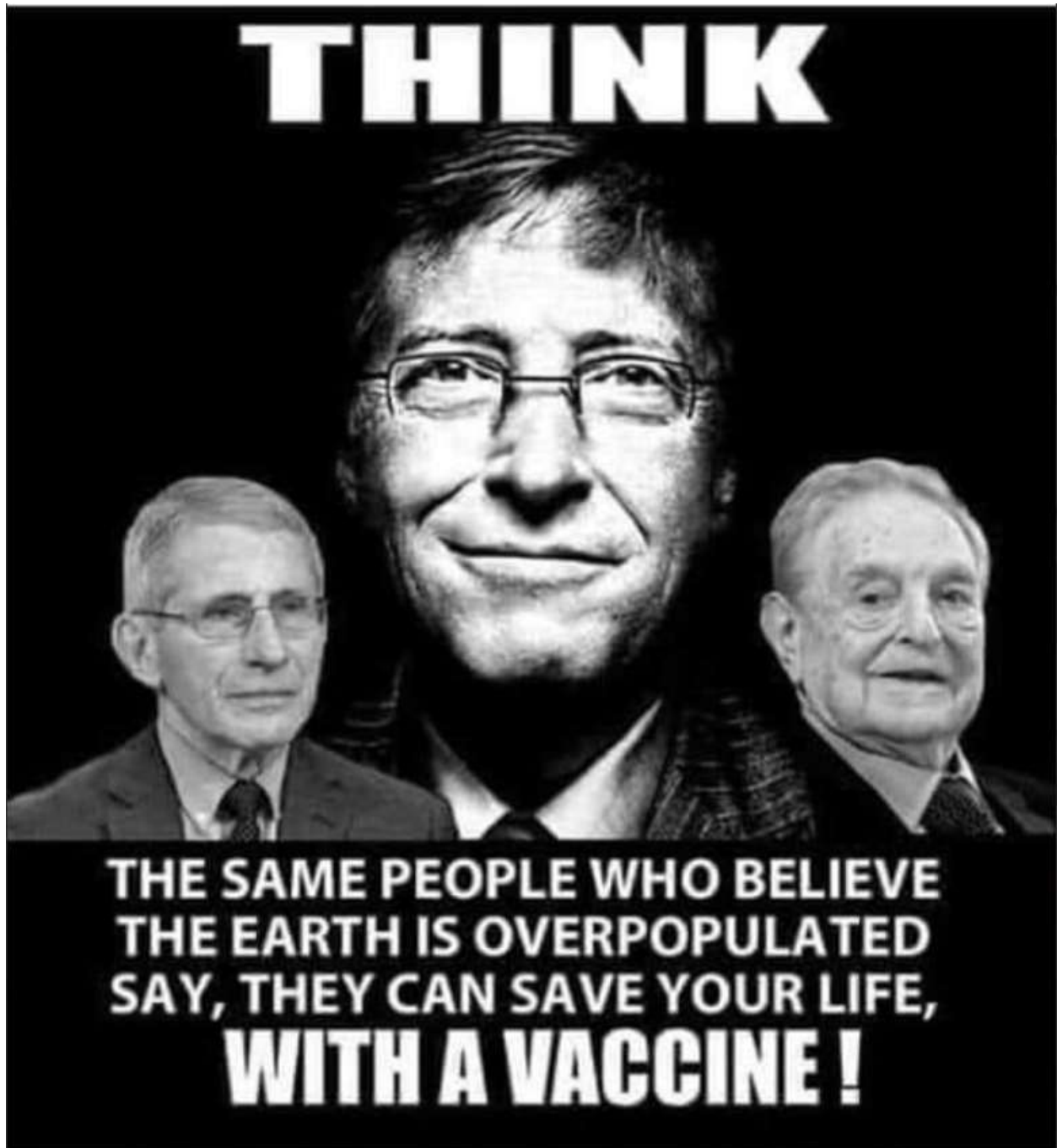
So, some European countries have been offering money to households that voluntarily take in Ukrainian refugees.

What could possibly go wrong here?

For starters, not everyone opening their homes is a Good Samaritan. Every nation has predators, and when you leave your home due to fear of violence, you may just be running from one set of problems to another.

Within a month of the UK's program paying households £350 per month to host refugees, female refugees were asking to be re-homed after unwanted sexual advances.





For Irish hosts, the promise of pay hasn't yet materialized. Even in the best of circumstances, with gracious hosts and undemanding guests, tensions will rise once bills pile up.

And lack of payment is only the tip of a very strange iceberg. In 2021, a bill came in front of the Irish legislature expanding the ability of the Irish government to seize private properties in the name of the "*public good.*"

It's similar to the concept of eminent domain in the United States. "Eminent domain" began back in the days of the railroads. Not all landowners wanted to sell to the U.S. government, but the government deemed railroads so essential to the development of the nation that they gave themselves the right of eminent domain, the right to declare seizures of certain properties essential to the well-being of the nation.

In retrospect, it seems silly that a group of ornery farmers in the middle of the Plains at one time had the ability to stymie the plans of East and West coast developers. But without the government's ability to forcefully seize property for the railroad companies, that could have happened.

But of course, the politicians and railroad barons didn't let it happen, and eminent domain didn't confine itself to roads and railroad tracks, either. Today it's regularly used to bulldoze lower-income neighborhoods in valuable urban areas to put in shopping areas or high-cost homes for rich people.

Britain and Ireland have generally had more stringent property protection, but that's changing too. And one can't help but wonder at the timing.

Just last month on April 22, Ireland's Minister for Justice, Helen McEntee, announced that there would be no limit to the number of Ukrainian refugees Ireland would accept. Keep in mind that Ireland is a small island nation with approximately 5.04 million residents. Opening the doors of a little country like Ireland to a refugee population larger than the nation itself seems crazy if not stupid. But it gets more concerning.

In McEntee's announcement that the Irish would not limit the numbers of refugees they would accept, she also said, ". . . Government will avoid, if possible, forcing people or businesses to give up property or open their homes to Ukrainian refugees."

Pay attention to that *"if possible."* The Irish government is not promising anything here.

And she went on to say, *"Every option is being explored. . . We want to encourage people to come forwards, not to force anybody to have to give up their property or accommodation."*

So, the Irish government passed a bill strengthening its ability to seize private property a year before they're faced with a potential need to seize private property in the name of housing refugees.

Why on earth would the Irish do this to themselves?

And why is this happening to the Ukrainians? I am not unsympathetic to refugees. I've known enough of them personally to know that they don't want to be refugees. They want to be back at home.

They don't want to assimilate. They feel like changes have been forced upon them (because they have). They want to return to what they feel is "normal." If refugees truly cannot return home, every effort should be made to keep them as close to "home," within cultures as close to their own, as possible. It's hard to thrive after being traumatized and then culturally uprooted. It's not impossible. But it's really, really hard. Host countries cannot just assume it will happen.

And yet the Irish government blasts ahead, full force. In fact, they've opened up more spots in schools than the Ukrainians are ready to take. The Ukrainians thus far have been hesitant to enroll their children in schools, probably because most of them hope to return home before too long. But the Irish government and the E.U. as well, seem to assume the Ukrainians will all be camping out for years.

So again, why the Irish?

Did the Irish government come up with the idea of seizing property in the name of housing refugees on its own, or are other forces at play? Is this situation rearing its head in Ireland because they have proved so compliant with other global movements since 2020?

Like many other European countries, Ireland ended all Covid mandates in January 2022. The Irish proudly attribute their reopening to their willingness to vaccinate almost the entire country. Ireland happily boasts that, at 93% of the population, they are the most-vaccinated country in Europe. Unlike many other countries, such as the U.S., which needed to rely on a mixture of incentives (lottery tickets, free donuts, etc.) and threatening mandates ("no jab, no job"), Irish citizens readily lined up, without coercion.

In some ways, this is unsurprising. Ireland has been home to many biological and pharmaceutical companies for years, and the sector keeps growing. Twenty years ago, Ireland hosted approximately 50 biopharma companies. As of 2022, they host more than 300. Within Ireland, these companies are trusted institutions.

Their trust is misplaced.

I don't know how much gets into the Irish press, but I know that in the U.S., enough evidence has accumulated to open the eyes of anyone curious about the pharmaceutical industry. Pfizer bears the unfavorable distinction of being ordered to pay the largest criminal settlement in history. And anyone who wants to really dive deeply into the relationship between Big Pharma and Big Government can buy RFK Jr.'s meticulously researched book, *'The Real Anthony Fauci.'*

So, reasonably or not, the Irish have not caused trouble for the central planners over the last two years.

And an awfully big central planner, Klaus Schwab of the World Economic Forum, is now famous for saying, *“By 2030, you will own nothing, and you will be happy.”* Flooding a small nation with desperate people and then throwing a giant monkey wrench into laws regarding property ownership looks like a big step toward making the citizens of a country *“own nothing.”* But will they be happy?

Could this be some kind of test run, a pilot program?

Five years ago, we would have thought this was crazy. But time keeps proving the conspiracy theorists right, so let’s look at this one a little more closely. In October 2019, the World Economic Forum, the Bill and Melinda Gates Foundation, and various government leaders participated in Event 201, a simulation designed to practice responding to a pandemic. Two months later, we all watched as Covid began spreading.

We lived in managed chaos for the next two years. Not because the disease was particularly deadly (well over 99% of people under 70 who catch it will survive) but because of government actions worldwide.

Many people went along with measures for the first few months simply because Covid was so new. But as time went on, measures seemed more arbitrary.

2020 and 2021 felt like being a pawn in a game played by government officials. But it wasn’t a game. The stress was real. Suicides spiked but were not related to Covid but due to substance abuse.

Stress on ordinary people worldwide became impossible to ignore, and in 2022, mandates started dropping like flies.

And then, almost immediately, Russia invaded Ukraine, and chaos ensued. Instead of hating anti-vaxxers, now we’re supposed to hate the Russians, and grocery stores are once again half-full, though this time, there is no pretense about things going back to normal any time soon.

Cardinal Vigano could not have said it any better. This chaos has been orchestrated. Global elites have not hidden the fact that they want individuals in First World countries to dramatically lower their standard of living. All the events of the past two years—the arbitrary rules, the coerced medical interventions, the supply chain disruptions, and most of all, the expansion of government power—these all point to a precipitous decline in quality of life.

The World Economic Forum is quite serious about us *“owning nothing.”* Events of the past two years have been means to that end.

Forceful seizures of private property have not started in Ireland yet. But the legal framework was laid out last year, and this year, if enough Ukrainians flood the country, the government may have its excuse to implement such measures. It is possible that the U.S. is experiencing the same thing through the invasion of illegals coming from South and Central America. They are moved by air nightly from U.S. air bases in Texas to airports around the country where unmarked tour buses spread out across the states to new residences where the government provides them EBT and bank cards with U.S. dollars. The U.S. may have as many as twenty million illegals throughout the land.

Many within alternative media have spent the last two years insisting that we cannot comply our way out of oppression. The Irish tried complying their way out of the Covid crisis, and this may be their reward: to be the guinea pig in the global elites' next game, simulation, or whatever you want to call it.

Do I think this will happen in the U.S.? We've definitely got our own limitless flood of desperate people flooding across the Rio Grande border that the government seems intent on ignoring. I think the migrant crisis is one of many situations being used to destabilize the U.S.

And before I get accused of xenophobia or something like that: I don't think the migrants at the Southern border are evil, just like I don't think the Ukrainians plotted an Irish invasion. I think the world is full of desperate people who are being used by a small number of very bad people to create chaos. We have known George Soros has been the paymaster for the human invasions both here in the U.S. and Europe as well. Who does George Soros work for? The Vatican and the House of Rothschild.

The Ukrainians and Irish should not be enemies. Americans and those from Central and Southern America should not be enemies.

We should look at how we are being played off against each other. We should spend more time questioning why things have gotten so bad in various countries that so many people are willing to take the risks of fleeing.

It may be too early to panic regarding property seizures, but it's never too early to pay attention.

Yes, Ireland is a small, isolated country with relatively low rates of gun ownership compared to the U.S. But we are all connected and what goes on in the small nations of the world affects us all.

Maybe the best thing to do right now is simply to call attention to these quiet threats and potential abuses.

It's possible that if enough Irish feel encouraged by the international community, they will gain the confidence to set realistic boundaries for themselves regarding refugee housing and refuse to let their properties be commandeered by the state.

We can't comply our way out of this.

This past Christmas I read the book *'Bet the Farm: The Dollar and Cents of Growing Food in America.'* Beth Hoffman was living the good life: she had a successful career as a journalist and professor, a comfortable home in San Francisco, and plenty of close friends and family. Yet in her late 40s, she and her husband decided to leave the big city and move to his family ranch in Iowa—all for the dream of becoming a farmer, to put into practice everything she had learned over decades of reporting on food and agriculture. There was just one problem: money.

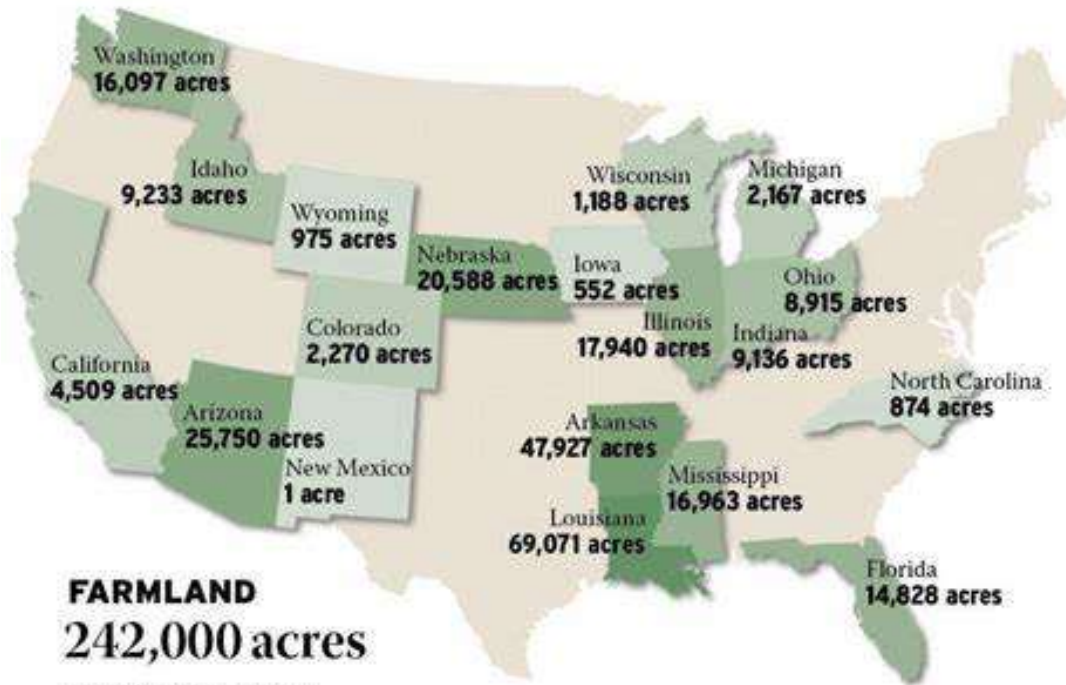
Half of America's two million farms made less than \$300 in 2019. Between rising land costs, ever-more expensive equipment, the growing uncertainty of the climate, and few options for health care, farming today is a risky business. For many, simply staying afloat is a constant struggle.

'Bet the Farm' chronicles this struggle through Beth's eyes as a beginning farmer. She must contend with her father-in-law, who is reluctant to hand over control of the land. Growing oats is good for the environment but ends up being very bad for the wallet. And finding somewhere, in the midst of Covid-19, to slaughter grass-fed beef is a nightmare. The couple also must balance the books, hoping that farming isn't a romantic fantasy that takes every cent of their savings.

Even with a decent nest egg and access to land, making ends meet at times seems impossible. And Beth knows full well that she is among the privileged. If Beth can't make it, how can farmers who confront racism, lack access to land, or don't have other jobs to fall back on? *'Bet the Farm'* is a first-hand account of the perils of farming today and a personal exploration of more just and sustainable ways of producing food.

Bill Gates may own 268,984 acres of prime farm land in the U.S., but I doubt that he has ever turned a spade of dirt, or drove a tractor in one of his fields. So, it makes you wonder what he hopes to prove by buying up agriculture land at farm auctions.
