The so-called "clinical trials" that Pfizer conducted on its messenger RNA (mRNA) Wuhan coronavirus (Covid-19) "vaccine" appear to have been completely fraudulent, which means the company could one day be held liable for all associated injuries and deaths.

Documents released in November 2021 by the U.S. Food and Drug Administration (FDA) as part of a court-mandated information dump reveal that enrollment at one particular trial site happened at warp speed, just in time to meet the safety deadline for the FDA's VRBPAC meeting on Dec. 10, 2020.

This meeting is where the FDA discussed granting Emergency Use Authorization (EUA) for the Pfizer-BioNTech injection in people 16 years of age and older.

"The allegedly suspicious-looking clinical trial data surrounds 'the biggest recruiter by far,' site 1231 (site 4444 was assigned site id 1231) in Argentina," reported Undercover DC.

"Adding to the confusion, in five short days before the safety deadline (including a Sunday, 9/27/20), the trial recruited 1,275 of the 4,501 people using site number 4444. In just three weeks, the site recruited 4,501 patients – 10% of the entire trial at one site."

"Overall, Pfizer rapidly recruited roughly 44,000 people for their trial, which took place at 152 locations worldwide and was overseen by numerous investigators, including Dr. Fernando Polack, who led the Argentinian study at Hospital Militar Central."

Does Pfizer do ANYTHING honestly and above board?

Polack, as explained by investigative reporter Steve Kirsch, holds the position of Scientific Director at the INFANT Foundation in Buenos Aires. This Vanderbilt-affiliated foundation facilitates biomedical translational research and pediatric rotations at hospitals and medical centers throughout the city.

Polack personally coordinates 26 hospitals in Argentina involving 467 doctors who were all immediately recruited into the Pfizer trial. Kirsch says that on paper, the data that resulted "looks too good to be true," though he says "it's quite possible they pulled it off" by coordinating the trial in record time.

"So if all 26 hospitals participated fully then that's 57 patients per week per hospital which is possible if the sites have done this before and have a coordination framework for getting all 26 sites up and running at the same time," Kirsch writes. "This means that everyone who was doing something else dropped what they were doing to switch over to the trial all at the same time."

Prof. Norman Fenton from <u>Queen Mary University of London</u> added in his own two-part Substack series that what was supposedly pulled off in Argentina on behalf of Pfizer is "basically impossible."

"If this really happened," he wrote, "it would be a wonder of the world, and they should publish the process with pride and win 27 different prizes for it."

"They claim to have enrolled seven days a week for three weeks with zero gaps. Each patient requires a 250-page case report form," Fenton added. "The lead investigator seems to have been Fernando Polack."

"If indeed, the best way to get things done is to give them to busy people, then this was a great choice because, from the look of things, Fernando is one busy fellah and connected up the wazoo to boot. He also works with Vanderbilt, the FDA, and the Infant Foundation, funded by the Gates Foundation and the NIH."

In the disclosure forms associated with a 'New England Journal of Medicine' (NEJM) paper on Pfizer's injection, Polack's conflicts of interest are revealed. They show personal fees he accepted from not only Pfizer but also Janssen (Johnson & Johnson), Regeneron (monoclonal antibodies), Merck & Co. and Novavax.

Should any of this make it to court, Pfizer will be in a whole lot of trouble – and rightfully so. Perhaps justice will eventually prevail.

# FDA Authorizes Pfizer Booster for Kids 5 to 11, Bypasses Advisory Panel

The U.S. Food and Drug Administration today granted Emergency Use Authorization for Pfizer's COVID-19 booster for children ages 5 to 11, without convening its vaccine advisory panel and despite the latest data showing higher case rates in vaccinated children compared with those not vaccinated. The U.S. Food and Drug Administration (FDA) today authorized a booster dose of the Pfizer-BioNTech COVID-19 vaccine for children ages 5 to 11, without convening its vaccine advisory panel of independent experts to discuss Pfizer's data on 5- to 11-year-olds — and based on a study subset of only 67 children, CNBC reported.

The FDA granted Emergency Use Authorization (EUA) for the boosters despite data showing <a href="https://example.com/higher-infection-rates">higher infection rates</a> among fully vaccinated children in the 5 to 11 age group compared to unvaccinated children, no studies <a href="testing-the-efficacy-of-the-vaccine-against">testing the efficacy-of-the-vaccine-against</a> the current dominant <a href="BA.2">BA.2</a> COVID-19 variant and <a href="two-new-studies">two-new-studies</a> showing that for vaccinated people who get Omicron, the infection provides better protection against future infections than a second booster dose. The vaccine advisory panel for the Centers for Disease Control and Prevention (CDC) is scheduled to meet Thursday. The agency and its director, Dr. Rochelle Walensky, are expected to sign off on the boosters, <a href="mailto:The Washington-Post-reported">The Washington Post-reported</a>.

Dr. Peter Marks, director of the FDA's Center for Biologics Evaluation and Research, said data increasingly show protection provided by two shots wanes over time, but the agency determined a third shot could help boost protection for children in the 5 to 11 age group and the "benefits outweigh the risks."

The FDA authorized the third shot after analyzing data from an ongoing Pfizer clinical trial in which a small subset of only 67 children in the age group had higher antibody levels one month after receiving a booster dose.

As <u>The Defender reported</u>, antibody levels alone are not indicative of immune protection. When it comes to COVID-19, T cell and natural killer cell responses are the crucial part of immune protection.

Pfizer <u>has not published</u> its actual data, precluding experts from conducting this analysis.

The authorized booster dose, the same strength as the first two doses, generated neutralizing antibodies to Omicron and the ancestral Wuhan version of the virus, according to The New York Times.

The FDA said it did not identify <u>any new safety concerns</u> and found the children in the trial experienced the <u>same mild side effects</u> other people do after receiving a booster.

However, a subset of only 67 children is not <u>large enough to detect</u> potential adverse events like <u>myocarditis</u>, and it is unknown how rapidly any protection provided wanes because trial participants were not followed beyond a 28-day period.

About <u>8.1 million</u>, or 28%, of children ages 5 to 11, received their primary series of two COVID-19 vaccine doses as of May 11, <u>according to data</u> from the American Academy of Pediatrics.

Those children <u>will now be eligible</u> for a third dose five months after their second dose based on data obtained from the 67 children who were followed for only one month.

COVID cases higher in vaccinated children aged 5 to 11, CDC data show.

According to the latest <u>CDC data</u>, since February, higher COVID-19 case rates were recorded among fully vaccinated children compared to unvaccinated children in the 5 to 11 age group.

The CDC on Feb. 12 <u>reported</u> a weekly case rate of 250.02 per 10,000 population in fully vaccinated children ages 5 to 11, compared to 245.82 for unvaccinated children in the same age group.

The trend continued through the third week of March, which is the latest week of available data.

"Several factors likely affect crude case rates by vaccination and booster dose status, making interpretation of recent trends difficult," CDC spokesperson Jasmine Reed told The Epoch Times in an email.

"Limitations include higher prevalence of previous infection among the unvaccinated and unboosted groups, difficulty in accounting for time since vaccination and waning protection, and possible differences in testing practices (such as at-home tests) and prevention behaviors by age and vaccination status," Reed said. "These limitations appear to have less impact on the death rates presented here."

According to <u>CDC data</u>, the gap between fully vaccinated and unvaccinated individuals in all age groups has <u>grown increasingly smaller</u>, with the death rate showing the same trend for people over age 50.

For people under age 50, death rates are almost identical between the vaccinated and unvaccinated since the beginning of the vaccine rollout.

Data show COVID-19 vaccines have a "negligible effect" on people, said Dr. Peter McCullough, a prominent cardiologist and epidemiologist.

"With these results in hand, it is clear the vaccines are having a negligible effect in populations," McCullough told The Epoch Times in an email.

"Given the overall poor safety profile and lack of any assurances on long-term safety, Americans should be cautious in considering additional injections of these products."

Having COVID may be more effective than getting a booster, studies show.

Two new studies show, for people who are vaccinated against COVID-19, getting a breakthrough Omicron infection may provide better protection than receiving a second booster, <u>Fortune reported</u>.

One study conducted by German biotechnology company BioNTech SE <u>assessed</u> <u>vaccinated individuals</u> who had breakthrough COVID-19 infection associated with the Omicron variant.

BioNTech found these individuals had a better B-cell response than individuals who had received a booster but had not been infected.

According to MD Anderson Center, B cells are a type of white blood cell that creates antibodies that bind to pathogens or foreign substances and neutralize them. B cells bind to a virus and prevent it from entering a normal cell causing infection. They also recruit other cells to help destroy infected cells.

A <u>second study</u> by the University of Washington and Vir Biotechnology investigated the immune responses of various groups based on vaccination and infection status.

The study analyzed blood samples of individuals who had been vaccinated and then caught the Delta or Omicron variants and compared them with those who had COVID-19 first and were then vaccinated, those who had been vaccinated but were not previously infected and those who were infected but had never received a COVID-19 vaccine.

The study found vaccinated individuals with breakthrough Omicron infection produced antibodies that formed a strong defense against other variants of the virus. Unvaccinated people who caught Omicron did not have a similarly robust immune response.

Efficacy of Pfizer's COVID vaccine wanes rapidly.

A <u>study</u> published May 13 in the Journal of the American Medical Association (JAMA) found protection from Pfizer's COVID-19 vaccine turned negatively effective among children and adolescents five months after receiving a second dose — meaning recipients were more likely to get COVID-19 five months after being vaccinated.

Vaccine effectiveness "was no longer significantly different from 0 during month 3 after the second dose," the researchers wrote. They also found protection against hospitalization waned significantly over time.

In adolescents, the authors said, efficacy increased again with boosters.

Most <u>non-randomized studies</u> attempting to determine vaccine efficacy (VE) had "common flaws," including no accounting for baseline prior COVID-19 infection, no reporting for those who received a booster within a six-month time window and no adjudication of hospitalization or death due to COVID-19 or other conditions, McCullough told The Epoch Times.

"As a result, most studies of COVID-19 VE have biases towards overestimating any clinical benefit of vaccination," McCullough said.

As <u>The Defender reported</u> on May 13, a different study published in JAMA showed second and third doses of Pfizer's COVID-19 vaccine provided protection against the Omicron variant for only a few weeks.

"Our study found a rapid decline in Omicron-specific serum neutralizing antibody titers only a few weeks after the second and third doses of [the Pfizer-BioNTech] BNT162b2," the authors wrote.

A <u>preprint study</u> released in February showed Pfizer's two-dose regimen of its COVID-19 vaccine for children was <u>only 12% effective</u> against Omicron in children ages 9 to 11, and the effectiveness of the vaccine "declined rapidly" for children 5 to 11.

Researchers at the New York State Department of Health and the University at Albany School of Public Health examined the effectiveness of the vaccine in children 5 to 11 and adolescents 12 to 17 from Dec. 13, 2021, to Jan. 30, 2022, and determined the effectiveness of Pfizer's COVID-19 vaccine declined rapidly for children, particularly those 5-11 years.

According to a <u>Danish study</u> of 128 people who had received two or three doses of Pfizer's COVID-19 vaccine, levels of Omicron-specific "neutralizing" antibodies decline rapidly after a second and third dose of Pfizer's shot.

Compared to original and Delta variants, <u>researchers found</u> the proportion of Omicron-specific antibodies detected in participants' blood dropped "rapidly" from 76% four weeks after the second dose to 53% at weeks 8 to 10 and 19% at weeks 12 to 14.

After the third shot, neutralizing antibodies against Omicron fell 5.4-fold between week 3 and week 8.

Last month, Moderna requested <u>EUA</u> for its COVID-19 vaccine for children aged 6 months to 6 years. Pfizer plans to seek EUA for a three-dose regimen for the same age group.

The FDA's top vaccine official told a congressional committee on May 6 COVID-19 vaccines for children under 6 will not have to meet the agency's 50% efficacy threshold required to obtain EUA.

A no-win for those who went with the crowd, or were willfully obtuse, intellectually lazy, or arrogant.



Just like the COVID situation, there are medications that Dr. Chambers can talk about, there is therapeutics. I think it's getting its Emergency Use Authorization, right now, which also tells us this is going to happen.

# VAERS Data Show New Deaths, Injuries After COVID Vaccines, As CDC Signs Off on 3rd Shot for Kids 5-11

VAERS data released Friday by the Centers for Disease Control and Prevention show 1,268,008 reports of adverse events from all age groups following COVID-19 vaccines, including 28,141 deaths and 230,364 serious injuries between Dec. 14, 2020, and May 13, 2022. By Megan Redshaw

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of 1,268,008 reports of adverse events following COVID-19 vaccines were submitted between Dec. 14, 2020, and May 13, 2022, to the Vaccine Adverse Event Reporting System (VAERS).

VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of <u>28,141 reports of deaths</u> — an increase of 173 over the previous week — and <u>230,364 serious injuries</u>, including deaths, during the same time period — up 1,887 compared with the previous week. There were 6,859 additional total adverse events reported to VAERS over the previous week.

Excluding "<u>foreign reports</u>" to VAERS, <u>817,538 adverse events</u>, including <u>12,961</u> <u>deaths</u> and <u>82,544 serious injuries</u>, were reported in the U.S. between Dec. 14, 2020, and May 13, 2022.

<u>Foreign reports</u> are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product's labeling, the manufacturer is required to submit the report to VAERS.

Of the 12,961 U.S. <u>deaths reported</u> as of May 13, 16% occurred within 24 hours of vaccination, 20% occurred within 48 hours of vaccination and 59% occurred in

people who experienced an <u>onset of symptoms</u> within 48 hours of being vaccinated.

In the U.S., 581 million COVID-19 vaccine doses had been administered as of May 13, <u>including</u> 343 million doses of Pfizer, 219 million doses of Moderna and 19 million doses of Johnson & Johnson (J&J).

Every Friday, <u>VAERS</u> publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Historically, VAERS has been shown to report only <u>1% of actual vaccine adverse</u> <u>events</u>.

U.S. VAERS data from Dec. 14, 2020, to May 13, 2022, for 5- to 11-year-olds show:

- <u>10,745 adverse events</u>, including <u>279 rated as serious</u> and <u>5 reported</u> deaths.
- 22 reports of myocarditis and pericarditis (heart inflammation). The CDC uses a narrowed case definition of "myocarditis," which excludes cases of cardiac arrest, ischemic strokes and deaths due to heart problems that occur before one has the chance to go to the emergency department. The Defender has noticed over previous weeks that reports of myocarditis and pericarditis have been removed by the CDC from the VAERS system in this age group. No explanation was provided.

• 43 reports of blood clotting disorders.

U.S. VAERS data from Dec. 14, 2020, to May 13, 2022, for 12- to 17-year-olds show:

- 31,572 adverse events, including 1,824 rated as serious and 44 reported deaths. VAERS reported 44 deaths in the 12- to 17-year-old age group last week.
- 64 reports of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death — with 96% of cases attributed to Pfizer's vaccine.
- <u>651 reports</u> of myocarditis and pericarditis with <u>639 cases</u> attributed to Pfizer's vaccine.
- 168 reports of blood clotting disorders with all cases attributed to Pfizer.

U.S. VAERS data from Dec. 14, 2020, to May 13, 2022, for all age groups combined, show:

- 20% of deaths were related to cardiac disorders.
- 54% of those who died were male, 41% were female and the remaining death reports did not include the gender of the deceased.
- The average age of death was 73.
- As of May 13, <u>5,527 pregnant women</u> reported adverse events related to COVID-19 vaccines, including 1,732 reports of <u>miscarriage or premature</u> birth.
- Of the <u>3,622 cases of Bell's Palsy</u> reported, 51% were attributed to <u>Pfizer</u> vaccinations, 40% to <u>Moderna</u> and 8% to <u>J&J</u>.
- 880 reports of <u>Guillain-Barré syndrome</u>, with 42% of cases <u>attributed to Pfizer</u>, 30% to <u>Moderna</u> and 28% to <u>J&J</u>.
- <u>2,291 reports</u> of anaphylaxis where the reaction was life-threatening, required treatment or resulted in death.
- 1.707 reports of myocardial infarction.
- 13,972 reports of blood-clotting disorders in the U.S. Of those, 6,266 reports were attributed to Pfizer, 4,989 reports to Moderna and 2,679 reports to J&J.
- <u>4,194 cases</u> of myocarditis and pericarditis with <u>2,570 cases</u> attributed to Pfizer's, <u>1,427 cases</u> to Moderna's and <u>183 cases</u> to J&J's COVID-19 vaccines.

CDC vaccine advisory panel follows FDA lead, endorses 3rd Pfizer shot for kids 5 to 11.

The CDC's independent vaccine advisory panel on Thursday endorsed a third dose of the Pfizer-BioNTech COVID-19 vaccine for children ages 5 to 11.

CDC Director Dr. Rochelle Walensky signed off on the Advisory Committee on Immunization Practices (ACIP) recommendation, clearing the way for healthcare workers to begin administering the shots.

The ACIP recommendation came two days after the FDA <u>granted Pfizer's</u> request for Emergency Use Authorization (EUA) of a single booster dose for this age group, saying the third shot should be administered at least five months after the initial two-dose primary series with the Pfizer-BioNTech vaccine.

The FDA granted the EUA without convening its vaccine advisory panel of independent experts to discuss Pfizer's data on 5- to 11-year-olds.

The authorization was based on a study subset of only 67 children who exhibited higher antibody levels one month after receiving a booster dose.

The FDA granted EUA for the boosters despite data showing higher infection rates among fully vaccinated children in the 5-to-11 age group compared to unvaccinated children, no studies testing the efficacy of the vaccine against the current dominant <a href="Mailto:BA.2 COVID-19 variant">BA.2 COVID-19 variant</a> and <a href="two new studies">two new studies</a> showing that for vaccinated people who get Omicron, the infection provides better protection against future infections than a second booster dose.

The FDA said it did not identify any new safety concerns and found the children in the trial experienced the same mild side effects other people do after receiving a booster.

However, a subset of only 67 children is not <u>large enough to detect</u> potential adverse events like <u>myocarditis</u>, and it is unknown how rapidly any protection provided wanes because trial participants were not followed beyond a 28-day period.

Pfizer documents show many adverse events deemed 'unrelated' to vaccine.

The <u>latest release</u> by the FDA of Pfizer vaccine documents raises questions about how frequently adverse events experienced by clinical trial participants were reported as "unrelated" to the vaccine.

The 80,000-page document cache <u>released</u> May 2 includes an extensive set of Case Report Forms (CRFs) from Pfizer trials conducted at various locations in the U.S.

The reports are from participants who suffered some type of adverse event during their participation in Pfizer's vaccine trials.

As the <u>documents reveal</u>, despite the occurrence of a wide range of symptoms including serious cardiovascular events, almost none were identified as being "related" to the vaccine.

Only one adverse event is clearly specified as being related to the vaccination: a participant who suffered from psoriatic arthritis, with no prior history of the condition.

In addition, several CRFs indicated exposure during pregnancy or during a partner's pregnancy. However, the documents provided do not appear to have provided any follow-ups regarding any outcomes or potential adverse events for the participants, their partners or their newborn babies once born.

In some instances, while the CRFs claimed the adverse events suffered by patients were unrelated to the vaccine, their cause was unspecified — simply indicated as "other" — while in another case, a participant's "unplanned" small bowel obstruction and panic attacks were listed as being unrelated to the vaccination despite no relevant medical history pertaining to the severe adverse events in question.

Louisiana governor reverses COVID vaccine mandate for students.

Louisiana Democratic Governor John Bel Edwards on Wednesday reversed the <u>state's mandate</u> requiring students in daycare through college to be fully vaccinated against COVID-19.

The announcement reversed an <u>earlier decision</u> by the governor's administration and the Louisiana Health Department (LHD) requiring students to be fully vaccinated beginning in the 2022-23 school year.

Edwards <u>said</u> he based the decision on the fact that the FDA has not fully approved the vaccines for people under age 16, and his administration will continue to recommend all children age 5 and over get the vaccine — a recommendation the LHD endorsed Wednesday in a <u>news release</u>.

In their statements, the governor and the LHD implied COVID-19 vaccines for people over age 16 are fully approved.

However, while the FDA did grant full licensing to Pfizer's Comirnaty and Moderna's Spikevax COVID-19 vaccines — for people 16 and older and 18 and older, respectively — those vaccines are not available in the U.S.

All COVID-19 vaccines being administered in the U.S. are still available only under EUA.
