to Exempt Future COVID-19
Shots from Clinical Trials.

ICAN attorneys and research staff watch every meeting of the FDA's Vaccines and Related Biological Products Advisory Committee (VRBPAC) and the CDC's Advisory Committee on Immunization Practices (ACIP). What is seen over the course of many meetings are the patterns and methods by which these agencies rig the approval process to achieve pre-determined outcomes. Now VRBPAC and ACIP are gearing up to pre-approve all future COVID-19 shots, regardless of formulation, with no additional clinical trials!

After VRBPAC's [April 6, 2022 meeting](#), ICAN, through its attorneys, wrote a [letter](#) to FDA Commissioner Robert Califf, the members of VRBPAC, and the

Senators and Representatives responsible for the FDA's budget, explaining our concerns in detail.

To summarize, VRBPAC appears to be following the same plan it follows for the flu vaccine every year and we know how well that works. Each year, they engage in "[the flu strain selection process](#)" and agree on the strains that will be included in the flu vaccine that year. Vaccine manufacturers love this because they can create a single flu vaccine and sell it worldwide. Most importantly, however, they can then skip the regulatory review process because these new formulations are automatically deemed safe and effective since they are "biologically similar" to previous versions of the flu vaccine.

The problem from a public health perspective is that this process does not work. As ICAN has [noted previously](#), at best, FDA's own data show flu vaccine effectiveness in the previous season was between 8% and 14%. Evidence from an influenza outbreak at a large university campus showed flu vaccine effectiveness was [zero](#).

What does all of this have to do with COVID-19 shots? The White House, FDA, and CDC have come up with a disturbing plan: they are proposing to take the flu strain selection process (that does not work) and apply it to future COVID-19 shots!

What this means is that each year, FDA/VRBPAC and CDC/ACIP (under the direction of the WHO) will engage in an elaborate performance of "COVID-19 variant selection." They will potentially choose between 1 and 4 strains to put into the COVID-19 shots (for example, combining spike proteins from Wuhan, Beta, Delta, and Omicron variants in a single shot). The worst part? They will argue that this new formulation is biologically similar to previous COVID-19 shots, and therefore they will not require pharmaceutical companies to conduct any new clinical trials.

ICAN is already fighting back, and you can also take action. You can join us in pushing back before [VRBPAC](#) and [ACIP](#) meet again in June regarding this proposal by contacting your elected officials today to tell them to reject this dangerous proposal and hold the FDA and CDC accountable if they do succeed. ICAN also intends to legally challenge this proposal if it is adopted but let's hope that won't be necessary.

I have been saying for thirty years, that the governments of the world are in collusion to reduce their population which was established at

the Rio Summit of Agenda 21 held in Rio de Janeiro, Brazil. But first some background of the event few today knew took place.

The UN Conference on Environment and Development that took place in Rio de Janeiro (Brazil) in June 1992 is referred to as the Rio Summit or the Earth Summit (1992). It was convened to discuss issues related to development and the environment. Representatives from over 178 countries were in attendance.

PUBLIC LAW 105—85—NOV. 18, 1997: USE OF HUMAN SUBJECTS FOR TESTING OF CHEMICAL OR BIOLOGICAL AGENTS



"(1) any test or experiment involving the use of a chemical agent or biological agent on a civilian population; or
(2) any other testing of a chemical agent or biological agent on human subjects.
(e) BIOLOGICAL AGENT DEFINED.—In this section, the term "biological agent" means any micro-organism (including bacteria, viruses, fungi, rickettsiac, or protozoa), pathogen, or infectious substance, and any naturally occurring, bioengineered, or synthesized component of any such micro-organism, pathogen, or infectious substance, whatever its origin or method of production, that is capable of causing—
(1) death, disease, or other biological malfunction in a human, an animal, a plant, or another living organism;
(2) deterioration of food, water, equipment, supplies, or materials of any kind; or
(3) deleterious alteration of the environment." - quote from the law.

This "law" is publicly available for everyone to read, you have been "informed".

The U.S. Government has a Social Security unfunded liability that is projected to be \$17.5 trillion dollars. The Medicare unfunded liability is actually projected to be much higher. Medicare actually has parts

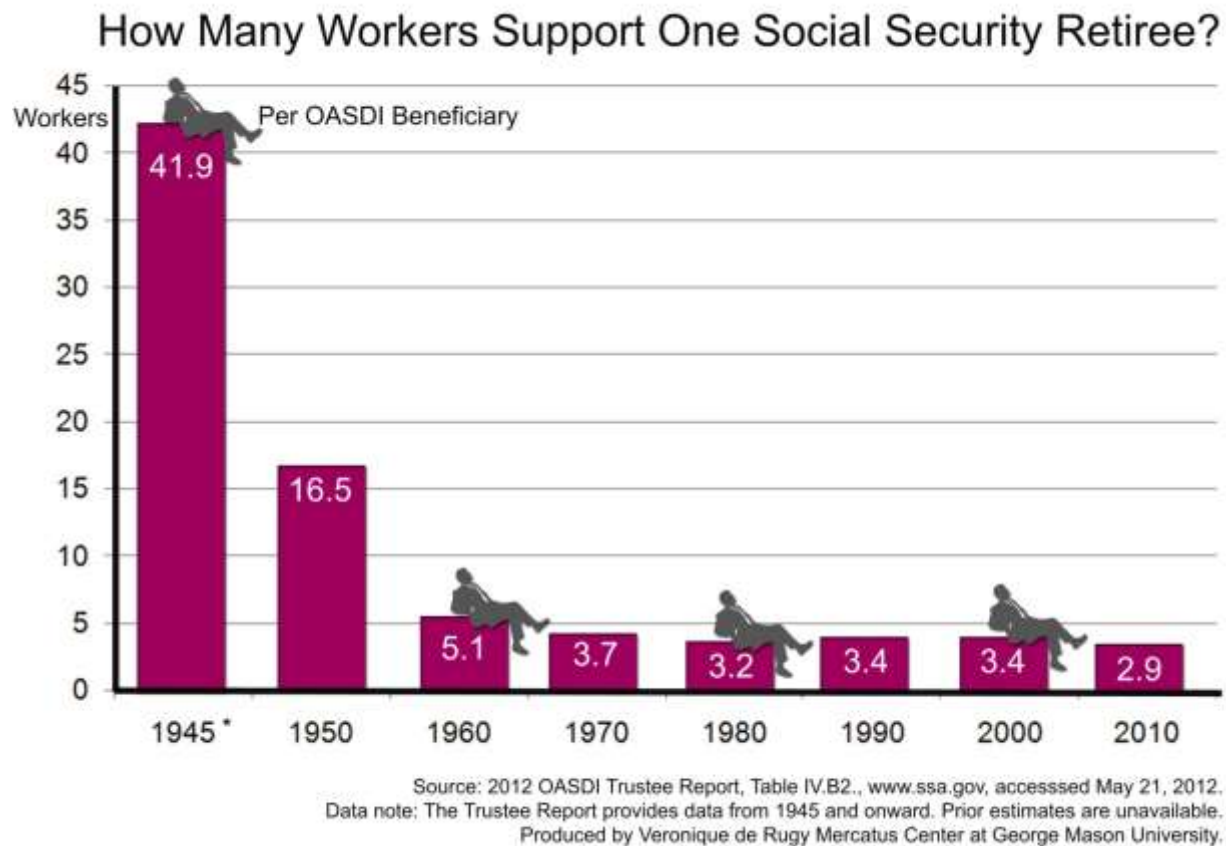
A, B, and D, Part A funds hospital care. Part B funds Medical visits, and part D funds prescription drugs.

This is on top of the already existing \$30 trillion dollars of the National Debt. As early as 1983, I was of the view that I would never see my Social Security but this was way before I retired and what I have learned since then. **In 1999 the people at the highest level of the government decided that the country would never be able to pay off the National Debt, which in their way of bean counting included Social Security and Medicare/Medicaid.** Dr. David L. Martin says the government could have taken measures in 1999 to keep the system afloat through a combination of raising withholdings rates and lengthen the work years until retirement eligibility for retirement at full benefits.

With fewer and fewer workers contributing into the Social Security Trust Fund (which was stolen to pay for the wars since 1990), the nation needs all the illegal immigrants they can flood the country with to keep the Social Security System afloat a few more years. The worker-to-beneficiary ratio has been on a steady decline for more than a decade, and will continue to slide until about 2035. That's a decline from 2.8 workers to 1 beneficiary in 2017 to 2.2-to-1 by 2035. This is why the system is broke and cannot be fixed. The powers at be decided not to try to fix it but simply allow the system to go broke around 2026 or 2028. But a scientific discovery changed the picture in 2013. This scientific discovery provided the powers at be an exit ramp from the government's social contract with Americans.

What became critical in the past twenty-five years has been due to the influx of immigrants [legal and illegal] receiving benefits without having met the standard requirements of working years/quarters to be eligible to receive full benefits. Waivers have been issued to millions of immigrants from Afghanistan, Iraq, Syria, and other countries where war and civil unrest led to the influx of those seeking asylum in the U.S. There is an estimated 20-million illegals that have been coming across our borders and the government has been resettling them across the fruited plane, and providing them financial support from the Social Security Trust Fund [non-existent according to George W. Bush when he was in the White House]. These illegals are

flown into smaller airports around the country and then bussed to Catholic Charities facilities for resettling near you.



Now back to the scientific discovery now that will explain much the public does not know about or for the most part have not heard about. Many see CRISPR-Cas9: The most important discovery of the century.

CRISPR-Cas-9 is a method of genetic editing, and one of the most significant scientific discoveries of the millennium. The two scientists who discovered it, Emmanuelle Charpentier and Jennifer A. Doudna, were awarded the 2020 Nobel Prize in Chemistry (also the first all female Nobel prize winning team) for their pioneering discovery of the mechanism. In this article I will explain how it works, and some of its applications.

CRISPR-Cas9 is a natural process, only recently harnessed in labs. When viruses attack a bacterium, the bacterium cuts a section of the virus's DNA and stores it. When the same type of virus attacks again, the bacterium copies the stored viral DNA into a section of RNA called guide RNA, which seeks out its matching sequence on the virus's

genetic code. This directs an enzyme called Cas-9 towards this sequence. Cas-9 then cuts this section of the virus's DNA, and stops the virus from reproducing. In 2011, Emmanuelle Charpentier discovered the mechanism in the bacteria *Streptococcus pyogenes*. In 2012, Jennifer A. Doudna and Emmanuelle Charpentier figured out how to program this mechanism to turn genes off and on. **They can also be used to cut out sequences of DNA and splice new ones in.**

Note especially this last sentence above. I will be returning to it and explain how this is being turned and used against humanity.

CRISPR-Cas9 has virtually unlimited applications. CRISPR is much easier and quicker than previous methods of genetic modification. Another crucial difference is that while recombinant genetic modification introduces DNA from entirely different species to obtain certain traits, CRISPR can be used to redesign the genetic code of an organism to get the same trait without having to introduce genetic material from another species. There has been considerable resistance to genetic modification, as it is viewed as unsafe, despite wide scientific consensus that the danger is minimal. However, CRISPR simply alters an organism's own genetic code, which farmers have been doing through selective breeding for around 12,000 years, albeit at a vastly slower pace.

One of the main applications of CRISPR is in agriculture, especially in plants where ethical concerns are considerably less than in animals. A team in Japan has used CRISPR to extend the shelf life of tomatoes by turning off genes that control ripening, potentially reducing food waste. CRISPR can also be used to cure diseases. This is achieved by editing genes that cause the disease, or editing genes to produce a resistance against the disease.

Recently, a clinical trial used CRISPR gene editing to successfully treat transthyretin amyloidosis, a genetic disease that causes heart disease, pain and death. It is caused by a build-up of a protein called transthyretin. CRISPR editing reduced the production of this protein in the liver, helping to treat the disease. This could work for virtually all genetic diseases, such as sickle cell anemia, cystic fibrosis and hemophilia.

One of the more ethically questionable uses, but one that could save millions of lives, is altering disease vectors. A disease vector is an animal that carries a disease. For humans, mosquitoes are by far the most deadly, killing over 700,000 people a year. The most deadly disease carried is malaria, which kills 600,000 people a year. Mosquitos can also carry Zika, West Nile Fever and dengue fever among many others. CRISPR could be used to alter the genetic code of mosquitos to ensure that their offspring will be sterile. If enough were released, a population of a mosquito species could be made extinct in a generation (around two weeks). Luckily, few species actually carry disease, only a few species of the Anopheles genus carry malaria. All mosquitoes have similar ecological roles, so making a few species extinct would have very little impact on the ecosystem, and save a huge number of human lives.

However one area that has particularly large ramifications is ‘human germline genetic engineering’, genetic modifications that could be inherited. This has actually occurred. In 2018, a Chinese scientist called He Jiankui announced that he had used CRISPR technology to genetically modify two babies called Lulu and Nana to make them immune to HIV. There was widespread outrage and Chinese authorities sentenced him to a \$430,000 fine and three years in jail. The World Health Organization has issued a call to halt all work on human genetic modification. The ethical impacts of having the very real power to create superhuman is massive and outside the scope of this article.

To conclude, CRISPR technology has the potential to do massive amounts of good, but also has the power to play God and profoundly alter the nature of life on Earth. Therefore, the world needs to ensure that this power can be regulated for the good of humanity.

This discovery is not without inherent problems of its own but our concern is what can be done with it when in the hands of people like Dr. Anthony Fauci, Bill Gates, the WHO, Dr. Peter Daszak of the Eco-Alliance, the CCP in Wuhan, China, and other Eugenicists that have projected their message through the Georgia Guidestones, which calls for reduction of the world population to a half billion.

These Satanic worshippers have a strange ethic one in which they have to tell you in advance of what they are going to do. It is referred to as **“Projection”** or **“Predictive Programming”** This need then is projected through symbols, art, movies, television programming, music lyrics, etc. We see this in people such as William & Melinda Gates, Dr. Anthony Fauci, and through secret societies such as Freemasonry and Skull & Bones. This weird egotism is flaunted by their language. **Bill Gates said that the next virus will get our attention.** They are anxiously eager to tell you what is coming next as if they want to inflict more pain through fear-mongering. The Monkeypox is the newest man-made virus! **They know what fear-mongering can do to human stress levels in people to accelerate mortality. Stress is one of the four factors in activating Mycoplasma the “Death Gene” (Pastor Bob’s term for this parasite!). The four factors Mycoplasma monitors during its dormant phase, which can be decades:**

- **Blood/Oxygen Level**
- **Body pH balance [pH scale ranges from 0 to 14)**
- **Immune status**
- **Stress**

When one or more of these factors is out of balance, the dormant parasite carried by virtually every human being recognizes changes and begins its attack on a person’s weakest point or predisposed health issue or condition. (All four factors can be influenced or affected by wireless energy.)

The fourth factor is perhaps the least understood and underestimated in terms of effect and need to mediate against. According to the American Stress Institute:

- **Work-related stress causes 120,000 deaths and results in \$190 billion in healthcare costs yearly.**
- **83% of US workers suffer from work-related stress.**
- **Stress takes one million workers offline in the U.S. every day.**
- **43% of employees — less than half — think their employers care about their work-life balance.**
- **U.S. businesses lose up to \$300 billion yearly as a result of workplace stress.**

- Depression costs the American economy \$51 billion due to absenteeism and \$26 billion in treatments. Those are sobering numbers.

It is Pastor Bob's belief that the fear-mongers like Freemasonry, Bill Gates, Dr. Anthony Fauci, Dr. Robert Redfield and Dr. Debra Berx were all aware of this as others part of the Illuminati New World Order and have profited in the process of enabling fear-mongering as a tactic to cripple public health and function in a co-fashion way to bring on decline of human well-being. Before you dismiss this idea, you need to be aware of the behavioral branch of the psychological world have engaged in creating stress for animal studies for over a century. Decades ago I had a psychology course at the University of Pittsburgh and saw first-hand the effects of animal stress. The world was subjected to television-generated stress when the "Diamond Princess" was the focus of the world in early 2020. The media was used to condition the public to be less resistant to the plandemic vaxx program.

At this point I want to go back to that sentence above I noted: *"They can also be used to cut out sequences of DNA and splice new ones in."*

Since the human Genome was mapped at the turn of the millennium, geneticists, it was inevitable that it would be only a few years before CRISPR-cas9 would be discovered. This technology has lowered both time and costs in what it can do for those in the field of genetics.

It was another Nobel Peace Prize winner who confirmed that 18 fragments of the HIV1, HIV2, and 4 fragments of SARS2 had been meticulously injected into the gene of the common cold virus. Dr. Luc Montagnier, the French biochemist who received the 2008 Nobel Peace Prize for medicine, was the first to discover the HIV virus. In another article on Covid-19, I shared the genetic sequence code map found by a group of Indian scientists in March of 2020. Dr. Montagnier died at the age of 89 from cancer this past February 8th.

At this point I will depart some from the known and provable to that of a hypothetical thesis. We do know that Bill Gates has had a working relationship with the DARPA, CIA and the DoD. Bill Gates is a

proponent of vaccines, financially invested in the industry, citing his investment provided a 20-to-1 return on investment. Bill Gates would have learned about CRISPR-cas9 within days of its announced discovery. We do know that both Bill Gates and Richard Rothschild hold patents on the Coronavirus known as Covid-19, years before it was declared a pandemic.

Dr. David L. Martin has identified over 4,000 patents related to the key people doing the research on SARS-Cov2 back to the 1990s. He presented all that evidence to the U.S. Dept. of Justice several years ago but the DoJ has sat on what is the “slam dunk” case for prosecution of Dr. Fauci. As Dr. David L. Martin has said, *“A single course case victory would end the entire virus scam in its tracks and make the pharmaceutical industry liable for damages.”*

My hypothesis is that there exists a conspiracy between Bill Gates, Dr. Fauci, the World Health Organization, the Pirbright Institute in Surrey, UK, the CIA, DARPA, and the DoD to “weaponize” a benign virus, to splice in new DNA sequences of HIV1, HIV2, and SARS2 into what many refer to as the common cold virus, thus using the gain-of-function of the inserted genome fragments to increase the virility of the virus. In the background of all this, most of those who died had comorbidity issues, or related health issues. Quite a few studies show that upwards of 90% of Covid-19 deaths had other life-threatening health issues that led to their death. The spike in new Covid-19 infections is occurring in those who were previously fully vaxxed and considered safe from re-infection.

The government is saying that a million U.S. citizens have died as of the results of Covid-19. The VAERS data reports the average age of those who have died so far from this virus is 73 years of age. The fact that those who first died of this pandemic were passengers on the cruise ship “Diamond Princess”. Over 700 passengers and crew were infected with the Coronavirus and 15 passenger died while sequestered at sea on the cruise ship for nearly a month. Those who died were elderly in their 70s and 80s. The “Diamond Princess” had been equipped with new 5G wireless communications a few months before it began its Asian Pacific cruise.

I have addressed the issue of **5G** wireless EMF elsewhere many times, however, entangled in the Covid cover story, is the matter of those nations who signed on to the informal agreement treaty to lower their own nation's population. **Covid-19 never came close to the projected fatality level as Bill Gates and his friend at Imperial College in the UK who predicted up to 265-million deaths worldwide. That figure was "projection psychology" to function as a scare tactic to get people to take experimental vaccines [really gene therapy kill shots] that have proven to be fatal; however, not until months later when Covid-19 will not be remembered or forgotten to be an issue. With a death few will ever think about a possible connection between a vaxx the victim might or might not have taken last year or at some future time of an individual victim's death.**

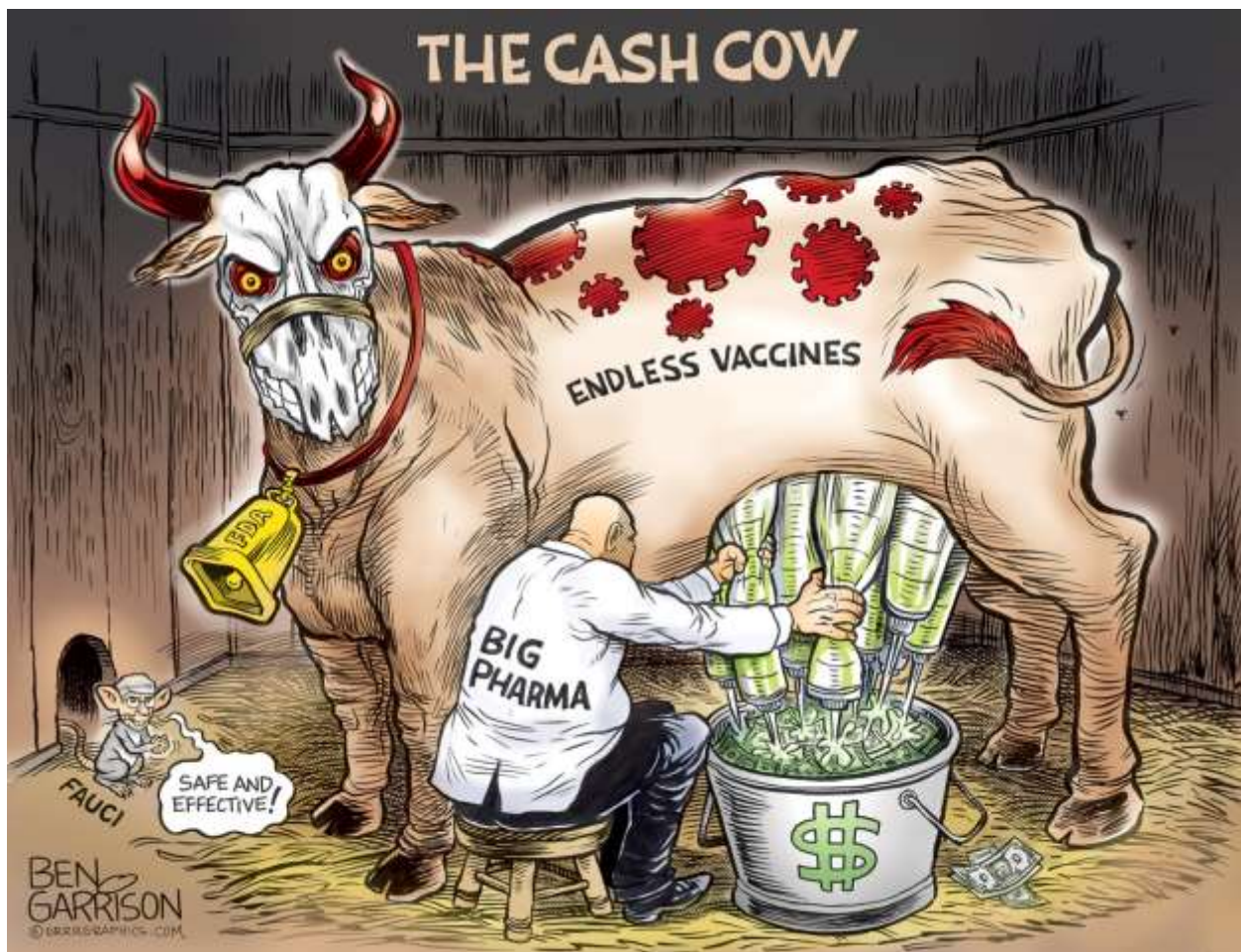
When the WHO declared the pandemic on March 10, 2020, nations were ordered not to do autopsies of alleged Covid-19 victims. Hospitals were paid to put Covid on death certificates as the cause of death, numbers were inflated regardless of a person's reason to be hospitalized, and now lastly, we are seeing excess deaths in various age groups. **Aside from the fact that those of greatest risk of death has been in the elderly, there are high incidences of those with damaged reproductive systems, heart, lung, and kidney issues that will lead to reduced life span. All the government protocols of therapy were 100% opposite of what should have been the treatment!**

It has been shown that hospitals received as much as \$100,000 for every Covid-19 patient as compensation for following the Fauci protocol, which proved to be a death sentence!

When the Social Security Act was signed into law in 1935, a person could not collect Social Security benefits until age 65, even though longevity or life span was only in the middle 50s. **58.9 for a male, 62.9 for a female!** Think about that for a moment. Only a small percentage lived to retirement age!

As it stands at present, Agenda 2030 has required Ireland to meet a 30% reduction of the carbon footprint of agriculture worldwide. It has to dispose of 1.5-million beef cattle, dairy cows, and lambs. This equates to a loss of a corresponding percentage of jobs (56,000 in Ireland), mouths to feed around the world, and the elimination of 2.5-

billion fewer people fits the Globalist plan for Prince Charles' Sustainable Development plan.



There are around 10,000 people (taking the total of retiring males and females) turning 65 each day for the next two decades. That figure declines after 2025. However, if they die before signing up for their Social Security, the winner is the government hands down! There are 77-million baby boomers, born from 1946 to 1964. Think on that for a while! This represents 77-million reasons to reduce the U.S. population. The Generation-X that follows will be another 62-million.

According to the AARP, 10,000 baby boomers are turning 65 every single day, and this is expected to continue into the 2030s. This means that nearly seven baby boomers are turning 65 every minute. This is the main reason why the Social Security and Medicare

programs are expected to run into financial trouble in the coming decades.

With the CRISPR-cas9 discovery, Bill Gates and his eugenics crowd can create a new virus at will in a matter of hours to days without breaking a sweat. Young Boy Died of Myocarditis After Pfizer Vaccine, Says CDC Before Signing Off on 3rd Shot for Kids 5-11

VAERS data released Friday by the Centers for Disease Control and Prevention show **1,277,980 reports of adverse events** from all age groups following COVID-19 vaccines, including **28,312 deaths** and **232,694 serious injuries** between Dec. 14, 2020, and May 20, 2022.

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of [1,277,980 reports of adverse events](#) following [COVID-19](#) vaccines were submitted between Dec. 14, 2020, and May 20, 2022, to the Vaccine Adverse Event Reporting System (VAERS). That's an increase of 9,972 adverse events over the previous week.

VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of [28,312 reports of deaths](#) — an increase of 171 over the previous week — and [232,694 serious injuries](#), including deaths, during the same time period — up 2,330 compared with the previous week.

Excluding “[foreign reports](#)” to VAERS, [820,788 adverse events](#), including [13,045 deaths](#) and [82,974 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and May 20, 2022.

[Foreign reports](#) are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product's labeling, the manufacturer is required to submit the report to VAERS.

Of the 13,045 U.S. [deaths reported](#) as of May 20, 16% occurred within 24 hours of vaccination, 20% occurred within 48 hours of vaccination and 59% occurred in people who experienced an [onset of symptoms](#) within 48 hours of being vaccinated.

In the U.S., 583 million COVID-19 vaccine doses had been administered as of May 20, [including](#) 344 million doses of Pfizer, 220 million doses of Moderna and 19 million doses of Johnson & Johnson (J&J).

Every Friday, VAERS publishes vaccine injury reports received as of a specified date. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Historically, VAERS has been shown to report only [1% of actual vaccine adverse events](#).

CDC acknowledges boy died of myocarditis, signs off on COVID for kids 5 to 11
 A young boy between the age of 5 and 11 died after receiving his first dose of the Pfizer-BioNTech COVID-19 vaccine, [according to](#) the CDC.

Yet, the CDC's vaccine advisory panel and its director, Dr. Rochelle Walensky, [signed off on a third dose](#) for the young age group despite their knowledge of the boy's death.

Dr. Tom Shimabukuro, a member of the agency's vaccine safety team, said during a virtual meeting held by the Advisory Committee on Immunization and Practices (ACIP) a young male died 13 days after receiving his first dose of Pfizer's COVID vaccine.

The boy [experienced a fever](#) 12 days after his first dose. A day later, he experienced abdominal pain and vomiting. He passed away the same day. Evidence showed the boy suffered from heart inflammation known as [myocarditis](#).

"This patient had a rapid clinical course. From the time they started experiencing their abdominal pain day 13 after dose one until the time they were brought into the [emergency department] and subsequently died was on the order of a couple of hours," [Shimabukuro said](#).

"Histopathological evidence of myocarditis was present on autopsy, and that was resolved to be the cause of death," he added.

The death was [reported to VAERS](#) and verified by the CDC through an interview with the healthcare provider.

Tests conducted on the boy by the CDC's infectious disease pathology branch "*did not find evidence of viral infection at the time of death,*" Shimabukuro said.

The ACIP did not ask questions or discuss the death, but instead, determined the benefits of Pfizer's COVID vaccine outweigh the risks.

Family of 26-year-old who died 13 days after AstraZeneca shot weighs legal action

A [final hearing](#) began on May 23 in the investigation into the death of a 26-year-old man who died last year from "catastrophic" blood clots in his brain 13 days after receiving the AstraZeneca [COVID-19](#) vaccine.

The family of Jack Hurn hopes the inquest will answer questions about the circumstances of his death — including why healthcare providers declined Hurn's request for a Pfizer vaccine instead of the AstraZeneca shot, which is [associated](#) with blood clots in individuals under age 30.

Staff at the vaccine center where Hurn and his girlfriend received their vaccines allegedly told them the Pfizer vaccine was not available and assured them the AstraZeneca jab was safe.

Coroners in England and Wales must hold inquests in cases where deaths are sudden, unexplained or could have resulted from medical errors or negligence. The final hearing is expected to last three days.

A spokesperson for Portman-Hann's law firm [told the Daily Mail](#), "*The family are looking at a clinical negligence claim but are waiting for the results of the inquest to decide on next steps.*"

Increased risk of Guillain-Barré syndrome following J&J COVID vaccination

You now know why the world has been racing to debut its 5th generation of wireless energy. That said, they are well along in the process of work on the next stage that will make humans dispensable.
