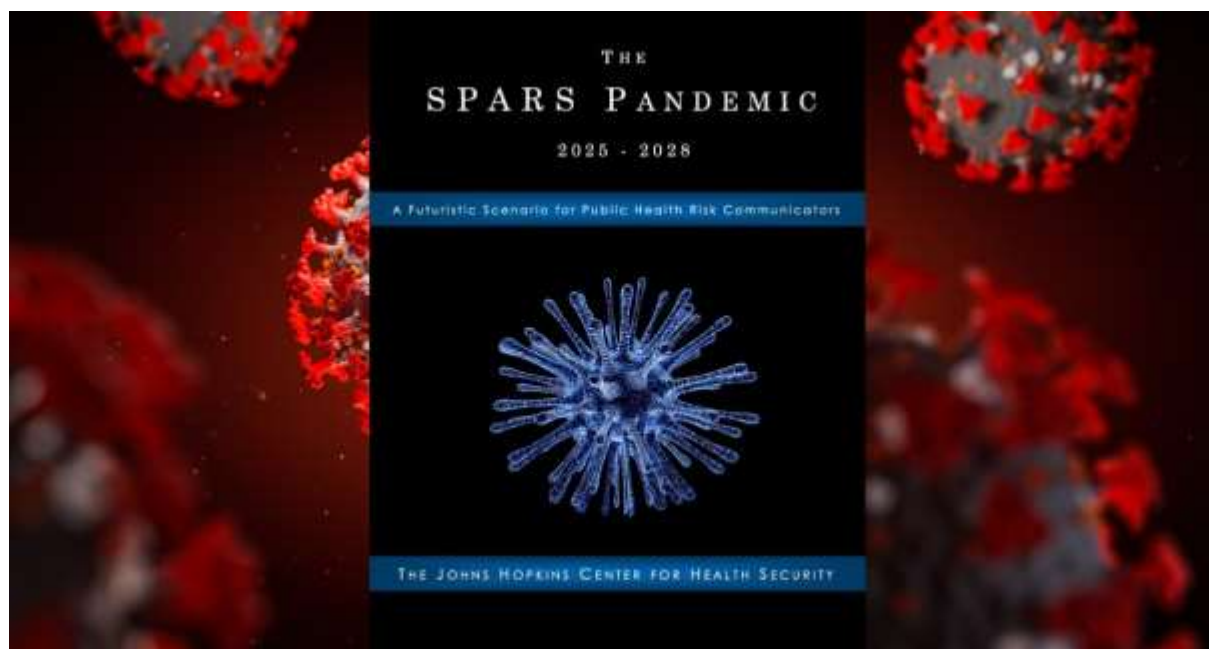

## The SPARS Pandemic of 2025 – 2028 “Genocide by Center for Disease Creation”

In 2017, the Johns Hopkins Center of Health Security ran a simulation of a coronavirus pandemic known as SPARS. What can we learn from this exercise?

In the months since SARS-CoV-2 was declared a pandemic, researchers and journalists have spent countless hours searching for relevant information that might

shed some light on the origins of what has come to be known as COVID-19. This research has led some to a number of simulations and exercises which “war gamed” a potential viral outbreak and asked how the people and institutions of the world would respond.

### **Experts predicted a coronavirus pandemic years ago. Now it’s playing out before our eyes.**

As TLAV has extensively [documented](#), the pandemic exercises are numerous. The most well-known simulation is likely [Event 201](#), a high-level pandemic exercise organized by the Bill and Melinda Gates Foundation partnered with the Johns Hopkins Center for Health Security and the World Economic Forum on October 18, 2019. Event 201 simulated how the world would respond to a fictional coronavirus pandemic known as CAPS which swept around the planet. The simulation imagined 65 million people dying, mass lock downs, quarantines, censorship of alternative viewpoints under the guise of fighting “disinformation,” and even floated the idea of arresting people who question the pandemic narrative.

Another exercise known as **Crimson Contagion** simulated an outbreak of a respiratory virus originating from China. From August 13 to August 16, 2019, Trump’s Department of Health and Human Services (HHS), headed by Alex Azar, and partnered with numerous national, state, and local organizations for the exercise. According to the results of the [October 2019 draft report](#), the spread of the novel avian influenza (H7N9) resulted in 110 million infected Americans, 7.7 million hospitalizations, and 586,000 deaths.

Another simulation known as [Clade X](#) took place on [May 2018](#). This event examined the response to a pandemic resulting from the release of a fictional virus known as Clade X. In the simulation, the virus was released by a terror group called [A Brighter Dawn](#). As the outbreak spread through the United States, the participants asked what would be needed if the President issued a federal quarantine, noting that authorities would need to “Determine (the) level of force authorized to maintain quarantine.” The Clade X exercise also resulted in the federal government nationalizing the healthcare system.

A lesser known exercise involving the Johns Hopkins Center for Health Security took place in 2017. This exercise also involved a coronavirus pandemic sweeping the world between 2025 and 2028. While the exercise has received very little press, the details and findings of the simulation are extremely relevant to COVID-19.

### **The SPARS Pandemic, 2025-2028**

In October 2017, the Johns Hopkins Center for Health Security released their report, [SPARS Pandemic, 2025-2028: A Futuristic Scenario for Public Health Risk Communicators](#). The report is written from the perspective of someone in 2030 that is

looking back on a pandemic which swept around the world between 2025 and 2028. The document states that the creators identified major socioeconomic, demographic, technological, and environmental trends which they believe are likely to emerge during this period. The two trends they said are likely to influence public health emergencies are “varying degrees of access to information technology” and increased “fragmentation among populations along social, political, religious, ideological, and cultural lines.”

Alex Jones has given us the “smoking gun” proof confirming everything I have been saying for years. The elite want the world for themselves. This is their “Silent Weapons for Quiet Wars.” Since 1968, “Depopulation” has been the number one goal!

The document states:

*“Ultimately, a world comprised of isolated and highly fragmented communities with widespread access to information technology—dubbed “the echo-chamber”—was selected as the future in which the prospective scenario would take place. From this point, scenario-specific storylines were then developed, drawing on subject matter expertise, historical accounts of past medical countermeasure crises, contemporary media reports, and scholarly literature in sociology, emergency preparedness, health education, and risk and crisis communication. These sources were used to identify communication challenges likely to emerge in future public health emergencies.”*

The exercise describes the world of 2025 as “more connected, yet more divided” with near universal access to wireless internet. The report discusses a new technology known as internet accessing technology (IAT), which is described as *“thin, flexible screens that can be temporarily attached to briefcases, backpacks, or clothing and used to stream content from the internet.”* New social media platforms also affect the digital landscape, including ZapQ, a platform that *“enables users to aggregate and archive selected media content from other platforms and communicate with cloud-based social groups based on common interests and current events.”*

While this has allowed for an increase and ease in sharing news, many people choose to *“self-restrict the sources they turn to for information”*, creating the echo chambers.

In mid-October 2025, three deaths were reported at a church in St. Paul, Minnesota. Two church members recently returned from a trip to the Philippines. While their deaths were initially assumed to be influenza, laboratory results later disproved this theory. Eventually, the Centers for Disease Control and Prevention (CDC) confirmed that the three patients were infected with a novel coronavirus, known as the St. Paul Acute Respiratory Syndrome Coronavirus (SPARS-CoV, or SPARS).

Interestingly, the report notes that “early case fatality estimates were inflated” with the CDC estimating SPARS case fatality rate of 4.7%, and the WHO saying 14-15% and over 50% for people over the age of 64. Later studies would provide a more accurate estimate of only 0.6%. This simulated scenario mimics what we have seen with COVID-19. The CDC and WHO both initially claimed the fatality rate was much higher before later admitting that the rate was below 1%.

# IS NO ONE ELSE SEEING THIS?

The report goes on to detail how public health and medical professionals were not successful in stopping the spread of SPARS. By time Thanksgiving and Black Friday arrived the transmission of SPARS accelerated due to asymptomatic individuals traveling. By mid-December, SPARS cases were reported in 26 states, as well as Mexico, Canada, Brazil, Japan, and several European countries.

Eventually, an animal vaccine is seen as a potential solution. Ranchers had used the vaccine to treat a SPARS-like respiratory coronavirus disease in cows and pigs in the Philippines. The vaccine manufacturer, GMI, claimed the vaccine would help, but clinical trials reveal [side effects](#), including swollen legs, severe joint pain, and encephalitis leading to seizures or death. There was no data available on the long term effects of the GMI vaccine. Despite this controversy, CynBio, a US-based pharmaceutical corporation developed a SPARS vaccine based on the GMI technology.

Much like in real life, the simulation states that the Department of Health and Human Services agreed to provide liability protection to the vaccine manufacturer CynBio in the event someone is harmed from the vaccine. This is the same situation we have seen with COVID-19, where U.S. government officials have acknowledged that the [vaccine companies are going to be given indemnity](#) against potential liabilities arising from their products.

The simulation makes it clear that health officials have planned for potential vaccine injuries and the objection to vaccine mandates. In one section the report asks, “How might federal health authorities respond to critics who propose that liability protection for SPARS vaccine manufacturers jeopardizes individual freedom and wellbeing?”

The report goes on to discuss the creation of a therapeutic called Kalocivir and how a growing number of individuals begin to challenge the use of pharmaceuticals and vaccines. These individuals who promoted “*natural cures such as garlic and vitamins*” were less likely to take Kalocivir or seek medical attention for SPARS-like symptoms.

Concerns about Kalocivir increased in February 2026 when a viral video shows a three-year-old boy projectile vomiting after taking a dose of the therapeutic. The clip is shared across the U.S. with the hashtags #NoKalocivir and #NaturallsBetter. Social media activists began to use ZapQ groups to share the video and also place IAT screens on the backs of their jackets and backpacks while looping the video. By the summer the video is the most shared “Zap clip” among junior high and high school students.

Another telling line from the Center for Health Security report notes that even though SPARS cases had begun to drop off, the “*persistent social media buzz around the pandemic ensured that public anxiety remained high.*” Again, this mirrors what we are seeing with COVID-19.

By May 2026 the CDC admitted that SPARS was only fatal in 0.6% of cases in the United States. This reality was reflected on social media, where much of the public began to recognize that SPARS was not as dangerous as they had been told.

*“Combined with persisting doubts about Kalocivir and the lack of a commercially available SPARS vaccine, the new, lower case fatality rate estimate led the public to grow increasingly hostile toward continued SPARS messaging,”* the report states.

The report details how the CDC, the FDA, and other government agencies worked with “social media experts” to develop public health messaging campaigns about SPARS, Kalocivir, and the forthcoming vaccine, Corovax. Much like in the Event 201 exercise, the SPARS simulation involved enlisting the help of *“well-known scientists, celebrities, and government officials”* to make videos and give interviews promoting the government messaging campaigns.

The public did not respond well to the campaigns and instead took to social media to express their disapproval. The mainstream media even began to question the government narrative and the safety of the Corovax. The opposition to the Corovax merged with the growing anti-vaccination movement which emerged on social media. These groups were made up of Muslims who opposed the vaccine; African Americans, who did not trust the government due to fears of experimentation on the black community; the alternative medicine community; and the “anti-vaccination” community.

These vaccine opponents spread information claiming that Corovax was not properly tested and had unknown side effects. National polls conducted in mid-August 2026 showed that 68% of US citizens had seen a post or read a comment from someone expressing anti-Corovax sentiments. Even the Japanese government rejected the Corovax, leading to viral video clips of Japanese news conferences.

In response to the Corovax opposition, the U.S. government began working with social media and search companies to target advertisements to individuals searching for “anti-vaccination websites.” The CDC also began mining data from public social media sources for “positive stories” they could promote via social media. The U.S. government also asked healthcare providers to grant access to patients’ electronic health records (EHRs) in an attempt to determine the number of individuals in high risk populations in particular areas.

### **Aftermath: Long-Term Side Effects, Lawsuits and a Loss of Trust**

The report describes how adverse side effects began to emerge as more Americans received the vaccine. Parents claimed their children were experiencing neurological symptoms similar to those seen in the animals injected with the GMI vaccine. By May 2027, parents began filing lawsuits and demanding a removal of the liability protecting the pharmaceutical companies who developed Corovax. The report states that *“concern was particularly high among some African American parents who continued to question the government’s motives regarding the Corovax vaccination campaign.”*

By the end of 2027, new neurological symptoms began to appear in people who had taken Corovax. *“After showing no adverse side effects for nearly a year, several vaccine recipients slowly began to experience symptoms such as blurry vision, headaches, and*

*numbness in their extremities,”* the Center for Health Security wrote. The report says that by 2030 it was still unclear if the vaccinations were to blame for the side-effects.

The social media backlash caught the HHS off guard as they faced pressure to award compensation to those experiencing long-term effects from Corovax. The public increasingly held negative opinions regarding the vaccine and what they perceived as indifference to the victims.

As the report wraps up it examines how the world looks from 2030, five years after the SPARS pandemic began. While the pandemic officially ended in 2028, cases exist in 14 countries across Europe, Africa, and Asia. WHO experts anticipate that future outbreaks will continue to emerge unless countries maintain widespread vaccination coverage.

As the public finally goes back to “normal life” they begin to focus their frustrations on politicians and agency representatives who they blame for exaggerating the severity of the event. Eventually, several high-ranking officials within the CDC and FDA are forced to retire. However, there appears to be a lack of accountability as there is *“little desire”* to *“rehash the events of the past several years.”*

Of course, the simulation states that “conspiracy theories also proliferated across social media, suggesting that the virus had been purposely created and introduced to the population by drug companies or that it had escaped from a government lab secretly testing bioweapons.” These sorts of accusations have also been lobbed at researchers during the COVID-19 crisis and used to justify censorship.

While the “Echo Chamber” exercise is as a fictional scenario, it is important to understand what the researchers at the Johns Hopkins Center for Health Security have observed. While these events are not intended to be a prediction of things to come, history has shown that simulations and exercises of this sort can often offer a window of how governments and private institutions will respond in times of crisis to come.

## **FDA and CDC Call for Halt of COVID Vaccine That Has Already Been Given to Millions of Americans**

Federal authorities are calling for a temporary halt in the use of the Johnson & Johnson coronavirus vaccine until they assess the risk of the vaccine causing blood clots.

The Food and Drug Administration and the Centers for Disease Control and Prevention issued a joint statement Tuesday morning announcing the pause in giving the vaccine.

*“As of April 12, more than 6.8 million doses of the Johnson & Johnson (Janssen) vaccine have been administered in the U.S. CDC and FDA are reviewing data involving six reported U.S. cases of a rare and severe type of blood clot in individuals after receiving the J&J vaccine,”* the statement said.

The statement said that *“a type of blood clot called cerebral venous sinus thrombosis (CVST) was seen in combination with low levels of blood platelets (thrombocytopenia). All six cases occurred among women between the ages of 18 and 48, and symptoms occurred 6 to 13 days after vaccination.”*

The statement said that treatment for this type of blood clot was different from most clots, and that the standard treatment, involving a drug called heparin, *“may be dangerous, and alternative treatments need to be given.”*

CDC will convene a meeting of the Advisory Committee on Immunization Practices (ACIP) on Wednesday to further review these cases and assess their potential significance. FDA will review that analysis as it also investigates these cases.

A CDC committee will meet Wednesday “to further review these cases and assess their potential significance. FDA will review that analysis as it also investigates these cases.”

*“Until that process is complete, we are recommending a pause in the use of this vaccine out of an abundance of caution. This is important, in part, to ensure that the health care provider community is aware of the potential for these adverse events and can plan for proper recognition and management due to the unique treatment required with this type of blood clot,”* the statement said.

The statement noted that so far, very few cases have been reported. *“Right now, these adverse events appear to be extremely rare,”* the statement said.

The statement noted that anyone who has developed certain symptoms after getting the Johnson and Johnson vaccine should notify authorities.

*“People who have received the J&J vaccine who develop severe headache, abdominal pain, leg pain, or shortness of breath within three weeks after vaccination should contact their health care provider. Health care providers are asked to report adverse events to the Vaccine Adverse Event Reporting System at <https://vaers.hhs.gov/reportevent.html>* the statement said.

Last week, several adverse reactions to the Johnson & Johnson vaccine led Colorado authorities to close a mass vaccination site in a Denver suburb.

Johnson & Johnson issued its own statement.

*“We are aware that thromboembolic events including those with thrombocytopenia have been reported with Covid-19 vaccines. At present, no clear causal relationship has been established between these rare events and the Janssen Covid-19 vaccine,”* the statement said, according to ‘The New York Times’. Janssen is a division of Johnson & Johnson.



Earlier this year, the Astra-Zeneca vaccine, which is widely used in Europe, was put on pause after reports of rare blood clots in a few individuals who had been vaccinated. Officials in Europe have since resumed distributing the vaccine.

Johnson and Johnson, which developed a one-dose vaccine, is one of three vaccines given in the U.S.

Pfizer-BioNTech and Moderna, which are two-dose vaccines, are the major vaccine suppliers with more than 23 million doses a week, The 'Times' reported. Aside from small-scale side effects, no major health concerns have been reported with those vaccines. What about the **5,365 deaths** below as of March 27, 2021? The above total of **3,005** deaths differs from the weekly Children's Health Defense report of **2,602** deaths by nearly 400. CHD data is that reported by the 8<sup>th</sup> of April. The above chart was based on the current week's report of April 13<sup>th</sup>. The source of the chart above was noting that more have died in 4+ months this year than in 13 years from August 1, 2007 and November 30, 2020.

Data released today by the Centers for Disease Control and Prevention (CDC) on the number of injuries and deaths reported to the [Vaccine Adverse Event Reporting System](#) (VAERS) following [COVID vaccines](#) revealed reports of blood clots and other related blood disorders associated with [all three vaccines](#) approved for Emergency Use Authorization in the U.S. — [Pfizer](#), [Moderna](#) and [Johnson & Johnson](#) (J&J). So far, only the J&J vaccine has been [paused](#) because of blood clot concerns.

VAERS is the primary mechanism for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Every Friday, [VAERS](#) makes public all vaccine injury reports received through a specified date, usually about a week prior to the release date. Today's data show that between Dec. 14, 2020 and April 8, a total of **68,347 total adverse events** were reported to VAERS, including **2,602 deaths** — an increase of 260 over the previous week — and **8,285 serious injuries**, up 314 since last week.

† Because some cases have multiple vaccinations and symptoms, a single case can account for multiple entries in this table. This is the reason why the Total Count is greater than 68,347 (the number of cases found), and the Total Percentage is greater than 100.

Of the 2,602 deaths reported as of April 8, 27% occurred within 48 hours of vaccination, 19% occurred within 24 hours and **41% occurred** in people who became ill **within 48 hours** of being vaccinated.

In the U.S., **174.9 million** COVID vaccine doses had been administered as of April 8. This **includes** 79.6 million doses of **Moderna's** vaccine, 90.3 million doses of **Pfizer** and 4.9 million doses of the J&J COVID vaccine.

This week's VAERS data show:  
19% of deaths were related to cardiac disorders.



55% of those who died were male, 43% were female and the remaining death reports did not include gender of the deceased.

The [average age](#) of those who died was **77** and the youngest death was an 18-year-old. There are a few reported deaths in children under 18, but these reports contained errors.

As of April 8, [408 pregnant women](#) had reported adverse events related to COVID vaccines, including 114 reports of [miscarriage or premature birth](#).

Of the [678 cases of Bell's Palsy reported](#), 59% of cases were reported after [Pfizer-BioNTech](#) vaccinations, 38% following vaccination with the Moderna vaccine and 24 cases (4%) of Bell's Palsy were reported with J&J.

There were [77 reports of Guillain-Barré Syndrome](#) with 55% of cases attributed to Pfizer, 40% to Moderna and 10% to J&J.

There were [20,021 reports of anaphylaxis](#) with 47% of cases attributed to [Pfizer's vaccine](#), 46% to [Moderna](#) and 7% to [J&J](#).

Reports of blood clotting disorders in VAERS

[Children's Health Defense](#) queried the VAERS data for a series of adverse events associated with the formation of clotting disorders and other related conditions. VAERS yielded a total of [795 reports](#) for all three vaccines from Dec. 14, 2020, through April 8.

Of the 795 cases reported, there were [400 reports](#) attributed to Pfizer, [337 reports](#) with Moderna and [56 reports](#) with J&J — far more than the eight J&J cases under investigation, [including the two additional cases](#) added Wednesday.

As [The Defender reported](#) today, although the J&J and AstraZeneca COVID vaccines have been under the microscope for their potential to cause blood clots, mounting evidence suggests the Pfizer and Moderna vaccines also cause clots and related blood disorders. U.S. regulatory officials [were alerted](#) to the problem as far back as December 2020.

CDC ignores The Defender, no response after 39 days

According to the [CDC's website](#), “the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated.”

On March 8, [The Defender](#) contacted the CDC with a written list of questions about reported deaths and injuries related to COVID vaccines. We requested information about how the CDC conducts investigations into reported deaths, the status of ongoing investigations reported in the media, if autopsies are being done, the standard for

determining whether an injury is causally connected to a vaccine, and education initiatives to encourage and facilitate proper and accurate reporting.

After many attempts to get a response from the CDC, 22 days after our initial outreach a representative from the CDC's Vaccine Task Force responded, saying the agency had never received our questions — even though the employees we talked to several times said their press officers were working through the questions we sent.

We provided the questions again and set a new deadline of April 7. We've reached out multiple times since, but the representative has not answered our emails or returned our calls.

On April 15 we called the CDC's general media line again and were told they had our list of questions and were unsure why the representative told us she never received them. We were told the COVID response team would be informed and that we should follow up in a few days.

It has been 39 days since we first reached out and have yet to receive answers to our questions.

Johnson & Johnson paused over reports of blood clot.

On April 15, [The Defender reported](#) that a healthy 43-year old man in Mississippi suffered a stroke hours after being vaccinated with [J&J's COVID vaccine](#). Brad Malagarie, father of seven, had received the vaccine a little after Noon and was found unresponsive by co-workers at his desk.

Also on April 15, the [Cincinnati Enquirer reported that the](#) Ohio Department of Health is monitoring the investigation into what may have caused a 21-year-old University of Cincinnati student to die suddenly last Sunday, about a day after he received the J&J vaccine.

Alicia Shoults, a spokeswoman for the state health department, said the agency is waiting for the completion of a Hamilton County coroner's report, and "if necessary," further guidance from the CDC.

The two news stories came just days after federal health officials paused the J&J vaccine.

As [The Defender reported](#) April 13, the CDC and U.S. Food and Drug Administration (FDA) called for a temporary but immediate halt to the use of J&J's COVID vaccine while the agencies investigated the vaccine's possible link to potentially dangerous blood clots.

In a [joint statement](#), the agencies said the Advisory Committee on Immunization Practices (ACIP) was reviewing clinical data gathered on six women, [one who died](#),

between the ages of 18 and 48 years who developed blood clots after receiving the single-dose J&J vaccine.

On April 14, the ACIP held an emergency meeting to vote on whether to lift the pause on J&J's vaccine or change recommendations for its use. As [The Defender reported](#), the ACIP postponed the vote, [extending the pause](#) pending further analysis of data relating to blood clots. The ACIP said it would reconvene for a vote in one week to 10 days.

That same day, [J&J revealed](#) two more cases of blood clots — one that occurred in a [25-year-old man](#) who suffered a cerebral hemorrhage during a clinical trial and another case of deep-vein-thrombosis in a 59-year-old woman.

In [its review of J&J's submission](#) for Emergency Use Authorization in February, the FDA initially urged further surveillance of a slight “numerical imbalance” in blood clotting events after receiving the shot. At the time, it was concluded there was “insufficient” data to determine “a causal relationship” with the vaccine and the drugmaker [resumed the trial](#).

As [The Defender reported](#) April 12, the rollout of J&J's COVID vaccine has not been smooth. At the beginning of the month the vaccine maker had to throw out [15 million doses](#) of its vaccine after they were contaminated with [AstraZeneca](#) vaccine ingredients at an unapproved manufacturing plant in Baltimore.

The vaccine maker also has been plagued with [shutdowns](#) of its vaccine sites prior to the vaccine being paused, multiple reports of COVID [breakthrough cases](#) and [criticism](#) over its CEO's \$30 million pay package while the company pays out billions for its role in the opioid epidemic.

CDC, multiple states report ‘breakthrough’ COVID cases among fully vaccinated. Cases of fully vaccinated people getting COVID, referred to as “breakthrough” cases, continue to make news.

Calling it a [“really good scenario,”](#) the CDC yesterday reported 5,800 cases of COVID in fully vaccinated people. Of the 5,800 cases, 396 required hospitalization and 74 people died, the CDC said.

The CDC said it was *“keeping a close eye”* on the cases, but that breakthrough cases are to be expected. Tara Smith, a professor of epidemiology at the Kent State University College of Public Health in Ohio, [told NBC News](#):

*“This is a really good scenario, even with almost 6,000 breakthrough infections. Most of those have been mildly symptomatic or asymptomatic. That’s exactly what we were hoping for.”*

On April 12, the Houston Health Department reported 142 [breakthrough cases](#) of COVID that occurred in fully vaccinated people since January, according to [ABC 13 News](#). Vaccine recipients received either two doses of Moderna or Pfizer, or one dose of J&J. The report ruled out those who were said to have contracted the virus 45 days before their second scheduled shot date.

Houston Health Department said there were 2.46 positive cases out of every 10,000 fully-vaccinated people and it was unclear if those who tested positive contracted the original strand of COVID or a newer variant.

Last month, [The Defender reported](#) on breakthrough cases in Washington, Florida, South Carolina, Texas, New York, California and Minnesota. On April 6, [The Defender reported](#) on 246 breakthrough cases in Michigan, which included three people who died.

[Children's Health Defense](#) asks anyone who has experienced an adverse reaction, to any vaccine, to file a report following [these three steps](#). *"With vaccines so much in the spotlight now, we have a tremendous opportunity to draw attention to the issues of vaccine safety and vaccine choice,"* said CHD President Lyn Redwood, RN, MSN. *"But we need the public's help. That's why CHD has joined in this effort to ensure that vaccine injuries are reported, so they can be analyzed and appropriate actions can be taken."*

VaxxTracker gives people a safe place to report symptoms they believe resulted from a vaccine. Users can also view charts and graphs illustrating the types of symptoms being reported, the number of symptoms associated with specific vaccines, and other trends.

### **Mike Yeadon, formerly of Pfizer issues a Major Warning**

Mike Yeadon, as Chief Scientist at Pfizer, has stated that it is now too late to save any person who has been impacted with any Covid-19 vaccines. *He urges those who have yet been injected with the deadly compound to fight for the continuation of humans, and the lives of their children.* The world acclaimed immunologist goes on to outline the process which he says will kill the vast majority of people now alive. April 7, 2021 ([LifeSiteNews](#)) — Dr. Michael Yeadon, Pfizer's former Vice President and Chief Scientist for Allergy & Respiratory who spent 32 years in the industry leading new medicines research and [retired](#) from the pharmaceutical giant with *“the most senior research position”* in his field, spoke with LifeSiteNews in a telephone interview.

He addressed the “*demonstrably false*” propaganda from governments in response to COVID-19, including the “lie” of dangerous variants, the totalitarian potential for “vaccine passports,” and the strong possibility we are dealing with a “conspiracy” which could lead to something far beyond the carnage experienced in the wars and massacres of the 20<sup>th</sup> century.

His main points included:

1. There is “no possibility” current variants of COVID-19 will escape immunity. It is “*just a lie.*”
2. Yet, governments around the world are repeating this lie, indicating that we are witnessing not just “*convergent opportunism,*” but a “*conspiracy.*” Meanwhile media outlets and Big Tech platforms are committed to the same propaganda and the censorship of the truth.
3. Pharmaceutical companies have already begun to develop unneeded “*top-up*” (“booster”) vaccines for the “*variants.*” The companies are planning to manufacture billions of vials, in addition to the current experimental COVID-19 “*vaccine*” campaign.
4. Regulatory agencies like the U.S. Food and Drug Administration and the European Medicines Agency, have announced that since these “*top-up*” vaccines will be so similar to the prior injections which were approved for emergency use authorization, drug companies will not be required to “*perform any clinical safety studies.*”
5. Thus, this virtually means that design and implementation of repeated and coerced mRNA vaccines “*go from the computer screen of a pharmaceutical company into the arms of hundreds of millions of people, [injecting] some superfluous genetic sequence for which there is absolutely no need or justification.*”
6. Why are they doing this? Since no benign reason is apparent, the use of vaccine passports along with a “*banking reset*” could issue in a totalitarianism unlike the world has ever seen. Recalling the evil of Stalin, Mao, and Hitler, “*mass depopulation*” remains a logical outcome.
7. The fact that this at least *could be true* means everyone must “*fight like crazy to make sure that system never forms.*”

Dr. Yeadon began identifying himself as merely a “boring guy” who went “*to work for a big drug company ... listening to the main national broadcast and reading the broad sheet newspapers.*”

Continuing, he said: “*But in the last year I have realized that my government and its advisers are lying in the faces of the British people about everything to do with this coronavirus. Absolutely everything. It’s a fallacy this idea of asymptomatic transmission and that you don’t have symptoms, but you are a source of a virus. That lockdowns work, that masks have a protective value obviously for you or someone else, and that variants are scary things and we even need to close international borders in case some of these nasty foreign variants get in.*”

*“Or, by the way, on top of the current list of gene-based vaccines that we have miraculously made, there will be some ‘top-up’ vaccines to cope with the immune escape variants.”*

*“Everything I have told you, every single one of those things is demonstrably false. But our entire national policy is based on these all being broadly right, but they are all wrong.”*

### **‘Conspiracy’ and not just ‘convergent opportunism’**

*“But what I would like to do is talk about immune escape because I think that’s probably going to be the end game for this whole event, which I think is probably a conspiracy. Last year I thought it was what I called ‘convergent opportunism,’ that is a bunch of different stakeholder groups have managed to pounce on a world in chaos to push us in a particular direction. So it looked like it was kind of linked, but I was prepared to say it was just convergence.”*

*“I [now] think that’s naïve. There is no question in my mind that very significant powerbrokers around the world have either planned to take advantage of the next pandemic or created the pandemic. One of those two things is true because the reason it must be true is that dozens and dozens of governments are all saying the same lies and doing the same inefficacious things that demonstrably cost lives.”*

*“And they are talking the same sort of future script which is, ‘We don’t want you to move around because of these pesky varmints, these “variants”’— which I call ‘samiants’ by the way, because they are pretty much the same — but they’re all saying this and they are all saying ‘don’t worry, there will be “top-up” vaccines that will cope with the potential escapees.’ They’re all saying this when it is obviously nonsense.”*

### **Possible end game: vaccine ‘passports’ tied to spending allowances, thorough control**

*“I think the end game is going to be, ‘everyone receives a vaccine’... Everyone on the planet is going to find themselves persuaded, cajoled, not quite mandated, hemmed-in to take a jab.”*

*“When they do that every single individual on the planet will have a name, or unique digital ID and a health status flag which will be ‘vaccinated,’ or not ... and whoever possesses that, sort of single database, operable centrally, applicable everywhere to control, to provide as it were, a privilege, you can either cross this particular threshold or conduct this particular transaction or not depending on [what] the controllers of that one human population database decide. And I think that’s what this is all about because once you’ve got that, we become playthings and the world can be as the controllers of that database want it.”*

*“For example, you might find that after a banking reset that you can only [spend through using an app](#) that actually feeds off this [database], your ID, your name, [and] your health status flag.”*

*“And, yes, certainly crossing an international border is the most obvious use for these [vaccine passports](#), as they are called, but I’ve heard talk of them already that they could be necessary for you to get into public spaces, enclosed public spaces. I expect that if they wanted to, you would not be able to leave your house in the future without the appropriate privilege on your app.”*

*“But even if that’s not [the] true [intent of the vaccine campaign], it doesn’t matter, the fact that it could be true means everyone [reading] this should fight like crazy to make sure that [vaccine passport] system never forms.”*

*“[With such a system], here is an example of what they could make you do, and I think this is what they’re going to make [people] do.”*

*“You could invent a story that is about a virus and its variations, its mutations over time. You could invent the story and make sure you embed it through the captive media, make sure that no one can counter it by censoring alternative sources, then people are now familiar with this idea that this virus mutates, which it does, and that it produces variants, which is true [as well], which could escape your immune system, and that’s a lie.”*

*“But, nevertheless, we’re going to tell you it’s true, and then when we tell you that it’s true and we say ‘but we’ve got the cure, here’s a top-up vaccine,’ you’ll get a message, based on this one global, this one ID system: ‘Bing!’ it will come up and say ‘Dr. Yeadon, time for your top-up vaccine. And, by the way,’ it will say ‘your existing immune privileges remain valid for four weeks. But if you don’t get your top-up vaccine in that time, you will unfortunately detrimentally be an “out person,” and you don’t want that, do you?’ So, that’s how it’ll work, and people will just walk up and they’ll get their top-up vaccine.”*

### **Gov’t lies, Big Pharma moves forward, medicine regulators get out of the way, and possible ‘mass-depopulation’**

*“But I will take you through this, Patrick, because I am qualified to comment. I don’t know what [Vanden Bossche](#) is about. There was no possibility at all, based on all of the variants that are in the public domain, 4000 or so of them, none of them are going to escape immunity [i.e. become more dangerous].”*

*“Nevertheless, politicians and health advisers (to loads of governments) are [saying that they are](#). They’re lying. Well, why would you do that?”*



*“Here’s the other thing, in parallel, pharmaceutical companies have said, several of them, it will be quite easy for us to adjust our gene-based vaccines, and we can hasten them through development, and we can help you.”*

*“And here’s the real scary part, global medicines regulators like [the U.S. Food and Drug Administration] [FDA](#), the Japanese medicines agency, the [European Medicines Agency](#), have gotten together and announced ... since top-up vaccines will be considered so similar to the ones that we have already approved for emergency use authorization, we are not going to require the drug companies to perform any clinical safety studies.”*

*“So, you’ve got on the one hand, governments and their advisers that are lying to you that variants are different enough from the current virus that, even if you’re immune from natural exposure or vaccination, you’re a risk and you need to come and get this top-up vaccine. So, I think neither of those are true. So why is the drug company making the top-up vaccines? And [with] the regulators having got out of the way — and if Yeadon is right, and I’m sure I am or I wouldn’t be telling you this — you go from the computer screen of a pharmaceutical company into the arms of hundreds of millions of people, some superfluous genetic sequence for which there is absolutely no need or justification.”*

*“And if you wanted to introduce a characteristic which could be harmful and could even be lethal, and you can even tune it to say ‘let’s put it in some gene that will cause liver injury over a nine-month period,’ or, cause your kidneys to fail but not until you encounter this kind of organism [that would be quite possible]. *Biotechnology provides you with limitless ways, frankly, to injure or kill billions of people.**

*“And since I can’t think of a benign explanation for any of the steps: variants, top-up vaccines, no regulatory studies... it’s not only that I cannot think of a benign explanation, the steps described, and the scenario described, and the necessary sort of resolution to this false problem is going to allow what I just described: unknown, and unnecessary gene sequences injected into the arms of potentially billions of people for no reason.”*

*“I’m very worried ... that pathway will be used for mass depopulation, because I can’t think of any benign explanation.”*

**‘Absurdly impossible’ variants will escape immunity, ‘just a lie’**

*“If I can show you that one major thing that governments around the world are telling the people is a lie, you should take my 32 years of experienced opinion that says, most of it, if not all of it, is a lie.”*

*“The most different variant is only 0.3% different from the original sequence as emailed out of Wuhan in ... January 2020. 0.3% [is] the one [variant] that is the most different on the planet so far. And now another way of saying it is, ‘all of the variants are not less than 99.7% identical to each other.’”*

*“Now, you might be thinking, ‘hmm, .3%, is that enough [to escape immunity and become more dangerous]?’ The answer is no. Get away, ya know, get out of here ...”*

*“The human immune system is a thing of wonder. What it does is when it faces a new pathogen like this, you’ve got [professional cells](#), they’re called [professional antigen-presenting cells](#) —they’re kind of rough tough things that tend not to succumb to viruses. And their job is to grab foreign things in the near environment and tear them limb from limb [inside the cell]. They really cut them up into hundreds of pieces. And then they present these pieces on the surfaces of their cell to other bits of your immune system, and amazingly, because of the variability that God and nature gave you, huge variability to recognize foreign things, and your body ends up using 15 to 20 different specific motifs that it spots about this virus. They’re called [epitopes](#), basically they’re just like little photographs of the details about this virus. That’s what they do. And that is what is called your repertoire, your immune repertoire is like 20 different accurate photographs, close-ups, of different bits of this virus.”*

*“Now, if a tiny piece of the virus changes, like the .3% I’ve just described, if you are reinfected by that variant, your professional cells tear into that virus and cut it into pieces, present them again, and lo and behold, most of the pieces that you have already seen and recognized, are still there in the variants.”*

*“There is absolutely no chance that all of them will fail to be recognized and that is what is required for immune escape, to escape your immunity. It must present to you as a new pathogen. It must be sufficiently different that, when it is cut up by your professional checker cells, it won’t find mostly the same thing it has seen before. And that is just absurdly impossible when you have only varied .3%, so it is 99.7% (similar).”*

*“You can go and check that by looking at papers by a person called [Alison Tarke](#). There is also [Shane Crotty](#), and all of the other co-authors.”*

*“And before them, coming from my theoretical understanding of multi-locus immunity, which is what I just badly tried to describe, to what actually happens ... If your [immune system] is presented with something that contains even half of those similar pieces, there is no way your body will say, ‘that’s a new pathogen.’”*

*“And, so, the idea that 0.3% could even have a chance of getting around immunity is just a lie. It’s not [even] like an opinion difference.”*

*“I don’t think 3% would be enough. That’s 10 times more variation than has occurred in 16 months [with this virus]. I don’t even think 30% difference would be enough. So, I’m saying that 100 times more variation than has actually happened, would still leave me putting a big bet on the human immune system not being fooled that these are new pathogens.”*

*“I’ve chatted this over with several professors of immunology and they agreed with me, it’s like, ‘why are you asking me this?’”*

*“So, I think that what I’ve just said is that governments and their advisors in multiple countries are lying about variants. That’s a massive thing! You should check it out. Your readers should check it out. If it’s true, don’t you think it’s terrifying?! It was when I realized it.”*

*“So, they’re lying about variants, and then, of course, since [the variants] are not really different, you do not need a ‘top-up’ vaccine. Now you should be getting the hairs on the back of your neck up, because they are [making them right now!](#)”*

*“They are making [billions](#) of vials of it. And they will be available by the end of the year. And I think they’ll require people to first, be on the vaccine passport one-world database, and then it will roll up into the top-ups, and if it takes a bit longer it will take a bit longer.”*

*“But this is not going away. It won’t go away until enough people, if they ever do, say ‘you’re a bunch of frauds and we are taking our freedoms back, so you can just stop doing this.’”*

*“Because one person shouting into the wilderness and all of the other academics looking the other way, will have us just going down this pipe maybe a week later than if I hadn’t said anything, but we’re still going down to hell.”*

*“So, that’s why I’m frightened.”*

*“The variants aren’t different. I call them ‘samiants’... they’re pretty much the same. They’re not different. Therefore, you don’t need a top-up vaccine, so don’t go near any of them.”*

***‘Why is my government lying to me?’ Because ‘they are going to kill you.’***

*“[And if you recognize that our governments are involved in a major verifiable lie], don’t just turn your computer off and go to supper. Stop. Look out the window, and think, ‘why is my government lying to me about something so fundamental?’ Because, I think the answer is, *they are going to kill you using this method. They’re going to kill you and your family.**

*“The eugenicists have got hold of the levers of power and this is a really artful way of getting you to line-up and receive some unspecified thing that will damage you. I have no idea what it will actually be, but it won’t be a vaccine because you don’t need one. And it won’t kill you on the end of the needle because you would spot that.”*

*“It could be something that will produce normal pathology, it will be at various times between vaccination and the event, it will be plausibly deniable because there will be something else going on in the world at that time, in the context of which your demise, or that of your children will look normal.”*

*“That’s what I would do if I wanted to get rid of 90 or 95% of the world’s population. And I think that’s what they’re doing.”*

*“Now I don’t know [for certain] that they’re going to use that [system] to kill you, but I can’t think of a benign reason, and with that power they certainly could harm you, or control you, so you should object [and strenuously oppose it].”*

**People can’t deal with this level of evil, but Soviets, Hitler, Mao show its possibility**

*“It’s become absolutely clear to me, even when I talk to intelligent people, friends, acquaintances ... and they can tell I’m telling them something important, but they get to the point [where I say] ‘your government is lying to you in a way that could lead to your death and that of your children,’ and they can’t begin to engage with it. And I think maybe 10% of them understand what I said, and 90% of those blank their understanding of it because it is too difficult. And my concern is, we are going to lose this, because people will not deal with the possibility that anyone is so evil...”*

*“But I remind you of what happened in Russia in the 20<sup>th</sup> Century, what happened in 1933 to 1945, what happened in, you know, Southeast Asia in some of the most awful times in the post-war era. And, what happened in China with Mao and so on.”*

*“We’ve only got to look back two or three generations. All around us there are people who are as bad as the people doing this. They’re all around us. So, I say to folks, the only thing that really marks this one out, is its scale.”*

*“But actually, this is probably less bloody, it’s less personal, isn’t it? The people who are steering this ... it’s going to be much easier for them. They don’t have to shoot anyone in the face. They don’t have to beat someone to death with a baseball bat, or freeze them, starve them, make them work until they die. All of those things did happen two or three generations back and our grandparents or great grandparents were either victims of this, or they were actually members of it, or at least they witnessed it from overseas. That’s how close we are.”*

*“And all I’m saying is, some shifts like that are happening again, but now they are using molecular biology.”*

*“And the people going along with it, I think they would probably say, ‘I was only following orders,’ which we have heard before.”*

*“But I know, because I have talked to lots of people, and some of them have said ‘I don’t want to believe that you are right, so I’m going to just put it away because if it is true, I can’t handle it.’ And I think ... all you need to do is find a good reason to tell people, ‘Don’t take the vaccine unless you’re a medical risk of dying from the virus!’ That seems to me a pretty good line!”*

### **Towards a solution – ‘We need God’**

*“I’m a scientist, and I can tell you, talking to non-scientists, using science as a tool, will not work. It will fail.”*

*“So, we need philosophers, people who understand logic, religion, something like that, [they have] got to wrestle with this, and start talking in a language people will understand. Because if we leave it with scientists, people like me, even though I’m well-intentioned, I’m a gabbling alien as far as most people in the street are concerned. They won’t believe the government will lie to them, they don’t believe the government would ever do anything that will harm them, but they are [doing such things].”*

Finally, in an email correspondence, Dr. Yeadon concluded, *“I have latest taken to signing off with ‘May God save us’, because I think we need God now more than at any time since WW2.”*
