## **ALARMING new evidence suggests monkeypox is cover-up for COVID jab-induced adverse effect**

Take a moment to consider a world where such injections are necessary for employment, education, and other social participation. It appears as though this dystopian reality has quickly become the world we live in. [New evidence](#) makes it appear as though monkeypox is a cover-up for immune deficiency syndrome resulting from the jab.

If the evidence proves accurate, the histrionics concerning monkeypox are unjustified as this isn't the first monkeypox virus to spread across first-world nations. The symptoms of monkeypox are similar to those of herpes. However, perhaps what is most shocking is that herpes is considered a documented COVID shot adverse event by [Pfizer](#). Though this revelation was made public in the

documents published by the FDA earlier this year, the mainstream media didn't give it much credence.

Herpes symptoms typically include:

- Mild redness and tingling
- Swollen lymph glands
- Fever
- Lesions similar to blisters that become sores

It is becoming increasingly clear that the symptoms of the COVID-19 jab manifest in a form similar to those of monkeypox and herpes, prompting concerned individuals to obtain the monkeypox vaccination when the truth is it is the jab itself that is the root cause of the problems.

Here is how the COVID shot affects the immune system.

Turn on the nightly news, and you'll hear word of variant-specific boosters. The federal government now suggests that Americans receive separate booster shots specific to each unique coronavirus variant. Add up all the coronavirus shots by the end of the year, and the total might be in the double digits. It is only fair to question whether such a litany of shots will negatively impact the human immune system.

Theoretically, the coronavirus vax is designed to train the immune system to recognize the coronavirus spike protein of the original strain by turning your cells into a spike protein factory, spurring the generation of antibodies for potential use down the line. The immune system is then tasked with battling the virus, yet the vax efficacy ultimately dissipates.

**Without Clinical Trials, FDA Authorizes Modified Monkeypox Vaccine, Expands Eligibility to 'High-Risk' Children**

Bypassing normal clinical trial guidance, the U.S. Food and Drug Administration on Tuesday expanded the Emergency Use Authorization for the Jynneos monkeypox vaccine to allow for an alternative method of injection and for “high-risk” children under 18 to get the vaccine.

The U.S. Food and Drug Administration (FDA) on Tuesday [expanded](#) the Emergency Use Authorization (EUA) for the Jynneos monkeypox vaccine to allow for an alternative method of injection the agency said would help conserve low supplies.

The expanded EUA also allows the vaccine to be used in children under age 18 who are at “high risk” of infection.

Prior to issuing the expanded EUA, the FDA confirmed that “numerous” children were granted access to the vaccine on a “case-by-case basis” through a special permission process — even though the vaccine was not approved or authorized for emergency use in that age group — [ABC News reported](#) on Aug. 4.

News of the potential dose-sparing recommendations prompted some congressional staff — including from the Centers for Disease Control and Prevention (CDC) and U.S. Department of Health and Human Services — to [question federal health officials](#) about whether using the alternative injection method could affect the efficacy of the shot.

*“They seemed to have no good answers for us, other than denying that it would impact things,”* an individual who attended a briefing on the matter told Politico. *“But they didn’t present any data.”*

[According to CNBC](#), monkeypox is rarely fatal and no deaths have been reported in the U.S. However, some patients need to be hospitalized to manage lesions, which can be painful.

Under the expanded EUA, healthcare providers can administer Bavarian Nordic’s Jynneos vaccine through [intradermal injection](#) — meaning between layers of the skin rather than below the skin — instead of subcutaneously, or beneath the skin. The change in injection method will [increase available doses](#) fivefold — from 441,000 to more than [2.2 million](#) — as intradermal injection uses only a fraction of the dose but provides the same protection, health officials said at a White House briefing.

The FDA said it [determined](#) the “*known and potential benefits*” of the monkeypox vaccine “*outweigh the known and potential risks for the authorized uses.*”

FDA Commissioner Dr. Robert Califf said in a [press release](#):

*“In recent weeks the monkeypox virus has continued to spread at a rate that has made it clear our current vaccine supply will not meet the current demand. The FDA quickly explored other scientifically appropriate options to facilitate access to the vaccine for all impacted individuals.”*

*“By increasing the number of available doses, more individuals who want to be vaccinated against monkeypox will now have the opportunity to do so.”*

Jynneos was [approved](#) in 2019 for the prevention of smallpox and monkeypox in high-risk adults 18 and older. The approval specified that the vaccine was to be administered subcutaneously, in two doses 28 days apart.

Using the intradermal method, the vaccine still will need to be administered in two doses, four weeks apart, the [FDA said](#).

Children under 18 who are at high risk of monkeypox infection can receive the vaccine by subcutaneous injection, as it is easier to administer and there is not as much data available on the use of the vaccine in this age group.

The move to allow monkeypox vaccination in children under 18 is based on findings from the vaccine’s use in adults and on data on pediatric smallpox vaccination, [CNN reported](#).

According to the CDC, Jynneos is approved to be [administered subcutaneously](#) into the fatty tissue over the triceps area in the upper arm.

The [vaccine is administered](#) as a “live *Vaccinia virus* preparation that is inoculated into the skin by pricking the skin surface.”

Although the National Institute of Allergy and Infectious Diseases is conducting a dose-sparing study of the Jynneos vaccine using intradermal injection, it could take months to complete, [Politico reported](#).

In the meantime, the FDA [based its authorization](#) to allow the vaccine to be administered intradermally on data from a 2015 [study](#) of Jynneos in 524 participants, which “found a similar immune response when the vaccine was given intradermally in doses one-fifth the size of those given subcutaneously.”

Only the abstract is publicly accessible, and it is unclear from the abstract whether researchers assessed a smallpox antigen from the [variola virus](#) or an antigen from a monkeypox virus.

As [The Defender reported](#), even the FDA acknowledged [neutralizing antibodies](#) do not correlate with protection, nor does protection against one pathogen [necessarily correlate](#) to protection against another.

***“There is [no traditional assessment](#) of this vaccine ... because there weren’t smallpox cases, and the monkeypox outbreaks before this were not large enough to really do a clinical trial,”** Dr. Peter Marks, director of the FDA’s Center for Biologics Evaluation and Research, said Tuesday.*

***“We want to collect outcome data, as we do with all vaccines,”** Marks said. **“And I’d also point out that the NIH [National Institutes of Health] will be mounting a clinical trial and is working through the logistics of that now.”***

**CDC guidance ‘discourages variations from the recommended route, site, volume, or number of doses of any vaccine’**

**On a call with reporters, Califf said the “overall safety and efficacy profile [of Jynneos] will not be sacrificed” with a dose-sparing approach, which [Dr. Anthony Fauci](#), chief medical advisor to President Biden, touted as a “promising solution to the vaccine shortage.”**

**According to the CDC’s Advisory Committee on Immunization Practices, [best practice guidance](#) for the administration of a vaccine is normally “derived from data from clinical trials, practical experience, normal intervals of health care visits and theoretical considerations.”**

**The committee “discourages variations from the recommended route, site, volume, or number of doses of any vaccine” as “variation from the recommended route and site can result in inadequate protection.”**

**The CDC [website](#) lists numerous examples where the method of administering a vaccine alters [immunogenicity](#) — the ability of a foreign substance, such as an antigen, to provoke an immune response in the human body.**

**A [paper](#) published in 2015, in the Expert Review of Vaccines assessed the effect of vaccine administration modality on immunogenicity and efficacy.**

**The authors found the “route of delivery can affect the vaccine localization that may influence the priming of immune cells as well as consequential local and systemic immune responses.”**

**They went on to say that “the choice of one strategy over the other depends on the type of vaccine and protective immunity needed to conquer the disease based on the route of infection and transmission.”**

**The FDA’s decision to authorize a new route of administration for Jynneos comes less than a week after the Biden administration [declared monkeypox](#) a public health emergency, [allowing](#) government health agencies to authorize unapproved medical products or uses of approved medical products to fight the spread of the virus.**

### 1.3 million people harmed by COVID-19 injections, most recent VAERS data reveals

([NaturalHealth365](#)) Let's be clear: it's time to stop thinking about heart inflammation, blood clots, neurological damage, and other serious health issues as "*side effects*" of COVID shots. These issues are *direct* effects of the mRNA jabs that have been rolled out to the public in an unprecedented move powered by Big Pharma, global governments, and worldwide elites.

And as of Friday, July 8, 2022, the Centers for Disease Control and Prevention (CDC) released [even more data](#) that *should* sound the alarm on how harmful these experimental drugs can be.

At least 1.3 million adverse events reported following COVID shots in the past 18 months.

As of June 29, 2022, there have been more than 596 million doses of COVID shots administered in the United States. 352 million of these are from Pfizer, another 225 million are from Moderna, and just 19 million doses are coming from Johnson & Johnson.

While we know that the government's Vaccine Adverse Event Reporting System (VAERS) is historically *underreported* (meaning that the actual number of people suffering harm from these shots could be much, much higher than what the media reluctantly admits to), the most recent VAERS data dump from the CDC reveals, yet again, some worrisome correlations. (Estimates of under-reported range from 20x to 41x what VAERS reports)

The CDC's latest data release shows 1,329,135 adverse event reports following COVID shots in the United States between December 14, 2020, and July 1, 2022 – an increase of 14,541 adverse events over the prior week.

The following is just a brief breakdown of some of the data released by the CDC for the stated period (mid-December 2020 to early July 2022):

- 1,941 adverse events post-jab among kids aged [6 months to 5 years](#), including at least 65 "serious" cases and 3 deaths
- 11,638 adverse events post-jab among kids aged [5 to 11 years old](#), including at least 300 "serious" cases like myocarditis and pericarditis (23), blood clotting disorders (46), and death (7)

- 32,543 adverse events post-jab among kids aged [12 to 17 years old](#), including at least 1,843 “serious” cases and 44 deaths
- 5,629 pregnant women reported adverse events following COVID shots, including 1,761 cases of premature birth or miscarriage
- Among all age groups, 20% of reported deaths were related to problems with the heart

No shot is 100% “*safe and effective*,” and VAERS data shows that COVID jabs are NO exception.

Blood clots. Life-threatening anaphylaxis. Pericarditis. Myocarditis. Postural orthostatic tachycardia syndrome (POTS). Cardiac disorders. Miscarriage. Bell’s Palsy. Guillain-Barré syndrome. All of these and more are being newly reported in this country among people recently jabbed with the gene-based COVID drugs.

These are exactly the concerns that health experts have warned about – let alone the warning that the shots are not preventing transmission of SARS-CoV-2 and may, in fact, make some vax-recipients even *more* at risk of symptomatic infection.

The latter point was made in an article published in the *New England Journal of Medicine* earlier this month, in which researchers discovered that people who received two doses of an mRNA shot had *negative* protection against symptomatic COVID-19, whereas people who recovered from a prior SARS-CoV-2 infection had about a 50% immunity against future illness.

Listen: nobody wants to be sick. And sadly, even things like the common cold and the flu can be serious or even deadly for some individuals – this is nothing new. To be certain, the same can be said for COVID-19.

But the reality is that this viral infection has proven to be highly survivable among all age groups. It’s simply not as deadly as the mainstream media wants us to believe (and especially for young children, a demographic that the government wants to be filled with yet ANOTHER round of vaxxes).

*“The Azvudine tablet, which China approved in July last year to treat certain HIV-1 virus infections, has been given a conditional green light to treat adult patients with ‘normal type’ COVID, the National Medical Products Administration said in a statement.*

*‘Normal type’ COVID is a term China uses to refer to coronavirus infections where there are signs of pneumonia, but the patients haven’t reached a severe stage ... In a late-stage clinical trial, 40.4% of patients taking Azvudine showed improvement in symptoms seven days after first taking the drug, compared with 10.9% in the control group ...”*

### HIV Insertions Highlighted in Early 2020

January 31, 2020, ZeroHedge published an article<sup>2</sup> featuring the findings<sup>3</sup> of Indian researchers, who claimed certain segments of the viral RNA appeared more closely related to HIV than other coronaviruses. The researchers even said SARS-CoV-2 responded to HIV medications.



According to this paper, titled *“Uncanny similarity of unique inserts in the 2019-nCoV spike protein to HIV-1 gp120 and Gag,”* the presence of HIV insertions was unlikely to have occurred naturally — the implication being that SARS-CoV-2 might be an escaped bioweapon:<sup>4</sup>

*“We found 4 insertions in the spike glycoprotein (S) which are unique to the 2019-nCoV and are not present in other coronaviruses. Importantly, amino acid residues in all the 4 inserts have identity or similarity to those in the HIV-1 gp120 or HIV-1 Gag.”*

*Interestingly, despite the inserts being discontinuous on the primary amino acid sequence, 3D-modelling of the 2019-nCoV suggests that they converge to constitute the receptor binding site. The finding of 4 unique inserts in the 2019-nCoV, all of which have identity /similarity to amino acid residues in key structural proteins of HIV-1 is unlikely to be fortuitous in nature.”*

Within days, ZeroHedge’s article had caught the attention of Jeremy Farrar — director of the Wellcome Trust — who emailed it to Dr. Anthony Fauci.<sup>5</sup>

His belief that SARS-CoV-2 did contain sequences of the HIV virus<sup>6</sup> was in part why AP News named him as one of the top "superspreaders of disinformation" about SARS-CoV-2's origin in 2021.<sup>7</sup> Montagnier insisted the Indian researchers were correct in their assessment, and had been forced to retract the paper "after enormous pressure."<sup>8,9</sup>

### AIDS Awareness Back ‘In Vogue’

Then, in February 2022, AIDS was suddenly all the rage. Media seemingly abandoned COVID overnight, taking aim at AIDS instead, and when all the media start raising an issue at the same time, it’s usually a coordinated campaign directed by a PR company on the behalf of a client.

There’s a reason for it, and the reason is to sow a desired narrative in the minds of people. They plant ideas so that when something happens, people are already prepped with certain prejudices or assumptions. So, what then might be the reason for [everyone suddenly talking about AIDS](#)?

In December 2021, President Biden announced a White House plan to “*end the HIV/AIDS epidemic by 2030.*”<sup>10</sup> The same exact vow had been announced by the British Health Security Agency a week earlier.<sup>11</sup> Meanwhile, Prince Harry was out there urging everyone to get an HIV test, and Dutch researchers announced the discovery of a concerning HIV strain.<sup>12</sup>

According to researchers, this mutated HIV virus, dubbed the VB variant, is more infectious and causes more severe illness, twice as fast. As of early February 2022, there were 109 known cases of the VB variant in The Netherlands. Curiously, scientists also admitted the variant had been circulating for decades. So, how was it “news”?

All of this was happening at the same time that COVID was starting to fade out. At the time, Off-Guardian warned,<sup>13</sup> “*just because they’re giving slack on COVID does not mean the agenda behind COVID is gone. Far from it. In fact, even as they seek to dump this pandemic in a shallow grave, they are already prepping the public for the next health scare — AIDS.*”

### Convergence

Well, the AIDS scare didn’t last long either. Within a couple of months, COVID variants were again grabbing headlines, and in May 2022, the focus shifted to monkeypox. Here, multiple scenarios, facts, theories, hazards and risks suddenly converge to create some rather disturbing possibilities. To summarize:

The COVID jab may be causing AIDS-like illness by decimating immune function<sup>14</sup> — This is not to imply the shot is causing HIV/AIDS.<sup>15,16</sup> Rather, it refers to the finding that people who get the COVID jab are — at six months’ post-jab — at greater risk of symptomatic COVID than their unvaccinated peers.<sup>17</sup> They’re also at increased risk for other infections and chronic diseases, for the same reason. America’s Frontline Doctors have suggested myocarditis and other chronic health problems associated with the jabs could be the result of vaccine-acquired immunodeficiency syndrome or “VAIDS,”<sup>18</sup> which is similar to AIDS in that it involves immune deficiency. The main difference is the initial trigger.

Researchers have warned that Janssen’s and AstraZeneca’s COVID jabs may increase your risk of

being infected with HIV<sup>19</sup> — In part because these COVID shots use the same adenovirus vector (Ad5) as a failed trial in which they were trying to create an HIV vaccine.

The use of Ad5 as a vector to transport the genetic material of HIV actually increased the risk of HIV infection rather than lowered it, and the researchers worried that Ad5 might increase the risk of HIV infection in those who get adenovirus vector COVID shots as well.

Scientists have warned that mass vaccination during active outbreaks drive mutations — And, since the rollout of the COVID jabs in December 2020, the SARS-CoV-2 virus has indeed mutated to evade mRNA injection-acquired antibodies, and the last two iterations also evade natural immunity.

Human trial for mRNA HIV vaccine is underway<sup>20</sup> — The Moderna HIV vaccine will target a certain subset of B-cells known to loosely bind to HIV. The idea is that by prodding these B-cells with mRNA instructions, delivered through a series of shots, they might develop the capacity to produce neutralizing antibodies against HIV.

The question is, if the COVID shot can cause immune depletion after repeated doses, what kind of dysfunction might a series of HIV shots trigger? What's more, HIV, like SARS-CoV-2, is a rapidly mutating virus,<sup>21</sup> so an HIV vaccine is likely to drive mutations and resistance, just as we've seen with the COVID shot.

Gay and bisexual men are getting a smallpox vaccine that may worsen HIV infection — July 23, 2022, World Health Organization Director-General Tedros Adhanom Ghebreyesus declared monkeypox a “public health emergency of international concern,”<sup>22</sup> and the U.S. Centers for Disease Control and Prevention is urging those who may be at high risk for monkeypox to get vaccinated.<sup>23</sup>

The vaccine used is a smallpox vaccine that may or may not work against monkeypox,<sup>24</sup> as the only study<sup>25</sup> was done in 1988, using a smallpox vaccine that is no longer in use, against a monkeypox virus that has since mutated multiple times.

New York City started administering the smallpox vaccine in late June 2022, and by July 22, some 18,000 New Yorkers had received their first dose.<sup>26</sup>

It's unclear which of the two smallpox vaccines is being given, but it seems reasonable to assume they're using the latest one, Jynneos, which can be given to people for whom the older version (ACAM2000) is contraindicated. Jynneos is also licensed specifically to prevent monkeypox,<sup>27</sup> whereas ACAM2000 is not.

The key point here is that HIV-positive subjects who participated in Jynneos clinical trials saw a rise in HIV virus counts.<sup>28</sup> Today, gay men are the primary recipients of this vaccine, and they're also a group that tends to be more prone to have HIV-AIDS. They also, as a group, have a very high COVID jab rate.

Considering both the COVID jab and Jynneos may increase the risk of HIV infection, or worsen

existing infection, and that these men are already at increased risk for HIV and AIDS, the overall, compounded risk these men face seems to be remarkably elevated, yet no one is warning them of this.

On top of all that, we now have people who have received both the COVID jab — which spawns mutations and suppresses immune function — and the smallpox vaccine. What mutations may the smallpox vaccine trigger in the SARS-CoV-2 virus, if any?

Live smallpox vaccine can spread vaccinia virus infection — If ACAM2000 is used, the risk for populations in general starts to skyrocket, as this older smallpox vaccine contains live, replication-capable vaccinia virus. When you get it, you're infectious for about a month, and must take great care not to spread the infection. If people get ACAM2000 and fail to take such precautions, we could be looking at smallpox outbreaks.

To be clear, it's highly unlikely that ACAM2000 is being used, but I include it here as a “what if?” scenario, seeing how the U.S. has a very large stockpile of it (about 100 million doses), while Jynneos is still in short supply.

mRNA monkeypox-specific injection is in preclinical study — In March 2022, Moderna announced it is investigating mRNA-based monkeypox vaccines at a preclinical level.<sup>29</sup> If the COVID jab compromises your immune function and drives mutations, will a monkeypox mRNA jab work any differently? If an mRNA monkeypox jab is given to people who already got the COVID jab, might they combine to create a Frankenstein-type COVID-pox pathogen?

The list above raises several questions. Could these circumstances trigger a new epidemic of AIDS or AIDS-like illness? Could the focus on HIV testing amid the development of an HIV mRNA “*vaccine*” be an effort to hide the fact that the COVID jabs are destroying people's immune function (and possibly promoting HIV infection), while simultaneously manufacturing the perception that we have an urgent need for an HIV vaccine?

#### **The Fauci Connection**

Coincidentally, Fauci was a key figure during the 1980s AIDS epidemic, which led to hundreds of thousands of gay men dying from the treatment (AZT) that Fauci insisted be used. He's also been a key figure in the COVID pandemic, in which people have again been killed in large numbers by the very drugs Fauci has a vested interest in.

Fauci is also a connecting link between the COVID shots and the HIV jab. Not only has he been pushing for an HIV vaccine for the better part of his career at the National Institutes of Allergy and Infectious Diseases (NIAID) — some 36 years — but he's also been an eager proponent for the transition from conventional vaccines to this new mRNA platform.<sup>30</sup>

Is it possible that an HIV vaccine is the end game they're after, and they're 'stimulating' the emergence of AIDS-like illness with the COVID jabs to justify mass HIV vaccination?

Despite decades of effort, no HIV vaccine has reached the market. Now that the COVID jabs forced mRNA tech on the masses, Fauci's goal to launch an HIV vaccine is in reach. But AIDS is not the crisis it once was. An estimated 1.2 million Americans have HIV infection, but HIV infection doesn't necessarily progress to AIDS unless you have a coinfection.

Is it possible that an HIV vaccine is the end game they're after, and they're "stimulating" the emergence of AIDS-like illness with the COVID jabs to justify mass HIV vaccination? I don't know, but it's not outside the realm of possibility.

Then again, the immunosuppression of the COVID shot might just be an unforeseen side effect that fortuitously reopened the door for HIV vaccines, using the mRNA platform. Either way, the drug industry has been in the business of creating remedies for the side effects their other drugs caused, and this seems like more of the same. The COVID shots create AIDS-like illness and voila, here comes an HIV jab. Aren't we the lucky ones?!

#### HIV Vaccine With Coronavirus Vector

To draw the noose around COVID and HIV even tighter, researchers have — since 2006 at the latest — been looking at creating an HIV vaccine using a coronavirus vector.

*"Toward a Coronavirus-Based HIV Multigene Vaccine,"*<sup>31</sup> published in the Journal of Immunology Research in 2006, describes using a coronavirus (common cold virus) as a backbone to hold two HIV envelope glycoproteins, gp41 and gp120, to create a prototype HIV-1 vaccine.

If gp120 rings a bell, it's because I mentioned it at the beginning of this article. The Indian researchers that discovered HIV insertions in SARS-CoV-2 found *"Uncanny similarity of unique inserts in the 2019-nCoV spike protein to HIV-1 gp120 ..."*

So, to recap, coronavirus has been used in HIV vaccine research, and somehow parts of HIV envelope ended up in a coronavirus known as SARS-CoV-2. And, while Fauci has denied any link between SARS-CoV-2 and HIV research, there's clear evidence that not only did he know about the existence of coronavirus-HIV chimeras, his agency invented some of the methods used to make them.<sup>32</sup>

#### Track and Trace Now Includes HIV

Tracking and tracing of HIV/AIDS is also being revamped. The U.S. Centers for Disease Control and Prevention surveils the spread of HIV by monitoring

routinely collected blood samples. This surveillance can then be used to perform contact tracing. As reported by Medscape:<sup>33</sup>

*“Robert Suttle has seen firsthand the legal risks of having HIV. In 2008, Suttle said, a former partner accused him of not disclosing he was HIV-positive. He was charged under Louisiana law with ‘intentional exposure to AIDS virus’ ...*

*Suttle pleaded guilty, received a sentence of six months in state prison, and was required to register as a sex offender. ‘You can be criminalized, certainly, for existing as a person living with HIV,’ he said.*

*Suttle ... said his experience has him worried about a new tool being promoted by federal officials to monitor the spread of HIV ... Suttle said such data could be used in cases like his. ‘With this surveillance, you could be connected to many different people or considered to be the source that transmitted to all these other people,’ he said ...*

*Molecular surveillance has met considerable opposition since it was rolled out nationally. Service providers, health equity advocates, and people living with HIV worry the risks of the approach outweigh the benefits, and their concerns have gotten louder as awareness of the tool grows. Some have called for the practice to stop until federal health officials address concerns about patient consent, data security, and the potential for HIV criminalization.”*

The idea and possibility of HIV criminalization also fits well with what the global biosecurity state has in mind, which is to control people by any and every means possible.

HIV-infected people could even be ordered to abstain from sex, for biosecurity reasons, which would contribute to population reduction — especially if HIV infection were really widespread — and that appears to be a key goal of the technocratic, antihuman cabal.

I hope I’m wrong about the theory that HIV infection and AIDS is being encouraged to justify mass HIV vaccination. But I don’t think it’s outside the realm of possibility, so keep the converging factors in mind as we move forward, and let’s see what happens.

## **Vaccine Deaths Outnumber Covid Deaths in U.S. Households, Two New Polls Confirm**

Polls of the U.S. public continue to show that up to twice as many Americans have lost a household member to a Covid vaccine injury as have lost one to Covid.

The pooled results of five surveys of the American public, now totaling over 2,500 people, [show](#) that while 4.4% of respondents reported that someone in their household had died from COVID-19, 8.9% said someone had died as a result of Covid vaccination.

The results also showed that 8.6% said they had been injured by their vaccination, 4.9% that they had sought medical help and 3.2% that they had been hospitalized, while 3.6% said that as a result of vaccination they were no longer able to work a full day or at all. These are percentages of all respondents. If we look only at the 74.0% vaccinated with at least one dose then the figures, as a proportion of vaccinated persons, are 11.7% injured, 6.7% needing medical help, 4.4% hospitalized and 4.8% unable to work. While these figures are self-reported and there is no control group, since the unvaccinated were not asked about adverse events, they are still alarmingly high.

The results also showed that, among those who reported a Covid death in their household, more than twice as many reported that it occurred *after* the person was vaccinated than before (2.8% vs 1.2%). The proportion who said they had contracted Covid before their vaccination (13.1%) was very similar to the proportion who said they contracted it afterwards (11.7%). These figures are not indicative of a highly effective vaccine against either infection or death.

The people polled were randomly selected, representative samples of the U.S. public, of whom 74.0% were vaccinated, so the samples were not inherently biased towards or against the reporting of vaccine problems, though as in all opinion polls (especially online ones) there may be an issue of self-selection bias. I reported on the first three of these polls [last month](#). Two more have now been added, each from a different polling company, and the results of all five are strikingly similar (see summary table below), indicating that the findings are a true representation, if not of the American public, at least of the section of the American public inclined to complete polls like this.

Some commentators have expressed skepticism about the results, implying they are skewed in some way. It's true that they are funded by [Steve Kirsch](#), a technology entrepreneur who is raising awareness of safety and efficacy issues around the Covid vaccines. However, the polls are by ordinary polling companies surveying an ordinary representative sample of the U.S. population, so there is nothing to criticize on that score. The results are not under the control of the funder and the questions are neutral. The fact that they are all similar, regardless of which polling company is used, shows that the results are not anomalous. Anyone can commission a similar survey if they wish – though Steve Kirsch [discovered](#) that Google and some other polling companies refused to run surveys asking people about their experience of the vaccines.

Steve has enlisted the help of a survey expert, who he [says](#) is nationally known and well-respected, though he hasn't yet revealed his identity. The expert has done two surveys on vaccine safety, one for Steve and one for another client, and he says the safety signal is *“real, significant and gravely concerning”*.

**Phase 1: Signal Detection.** Using convenience samples, we validated that there is a significant signal that the general population is reporting a variety of issues and adverse events related to the Covid vaccine programme. While not representative of the entire population and certainly imperfect in design, the multiple iterations of the same questionnaire across two different independent survey panels validate the strong signal detection. Internal consistency matters even when dealing with subjective issues like surveys, and these data are absolutely consistent.

**Phase 2: Validation.** This first study using a more high quality sample source, and the planned duplication across at least one other independent platform, validates that the signal is real, significant and gravely concerning. The surprising level of coherence in these data, now across three unrelated sample sources, is indisputable. We'll do one more study with a fourth source, but I am confident

we'll see the same high level of validation. The signal has been detected and it is clear; something is very, very wrong.

Despite the striking consistency between the surveys, it ought to be noted that the findings don't fit neatly with what we know from other sources. For example, the surveys show 6-7% seeking medical care following vaccination, whereas government surveys have typically [found](#) just under 1%. Similarly, there are around 120 million households in the U.S, so if 4.4% of them had a Covid death (as per the surveys) then that would give 5.3 million Covid deaths – yet official figures show there have been around 1 million Covid deaths in the U.S. Why are the surveys coming up with figures that are five to seven times higher than other sources? This does need to be answered.

A further question is raised by a sixth poll commissioned by Steve Kirsch (on [July 11th](#)), this one much shorter, asking only two questions, one about household members having Covid and one about them having a vaccine injury. It found 22 of the 500 respondents (4.4%) reported a vaccine death in the household versus 40 (8%) who reported a Covid death. These proportions are still high, but they are not consistent with the other five polls, the two figures being reversed. Is this survey anomalous or would it be replicated in similar short polls? If so, it may indicate a source of bias in the length of the poll.

Nonetheless, such issues should not distract from the key point, that representative surveys of the American public are consistently finding alarmingly high reported rates of serious vaccine injury and death. This is not a safety signal that should be ignored.

## US Government Complicit In Creating Covid

[US government might have been complicit in creating Covid](#). Moscow is examining the likelihood that a Washington, DC agency was involved in the development of Covid-19.

According to the Russian Ministry of Defense, USAID's potential involvement in the development of the Covid-19 virus is being looked into.

In a press conference on Thursday, Lieutenant-General Igor Kirillov, the head of Russia's radiation, chemical, and biological defense forces, asserted that US-backed bio laboratories in Ukraine had been using Ukrainian residents in [dubious clinical trials and research](#), and that *"over 16,000 biological samples, including blood and serum samples, were exported from the territory of Ukraine to U.S. and European countries."*

He continued by mentioning that a comment made by Jason Crow, a member of the U.S. House Intelligence Committee, warning Americans that their DNA samples could be used to construct specialized biological weapons, prompted Russia's Defense Ministry to *"take a fresh look"* at the roots of the Covid outbreak.

*"Taking into account the interest of the U.S. administration in the study of narrowly targeted biological agents, such statements force us to take a fresh look at the causes of the novel coronavirus pandemic and the role of U.S. military biologists in the emergence and spread of the Covid-19 pathogen,"* Kirillov said.

According to Kirillov, who cited a Lancet article by Columbia professor Jeffry Sachs who proposed that the virus was probably made in a lab with the aid of America's most recent achievements in the field of biotechnology, Russia presently doubts that USAID possibly was directly culpable for the onset of the Covid-19 virus.

In 2009, USAID began supporting a project called *"Predict,"* which involves capturing wild bats afflicted with novel coronaviruses for scientific purposes. Kirillov noted that one of the project's contractors, Metabiota, was well-known for its military biological functions on Ukrainian soil.

The FDA discontinued the *"Predict"* initiative in 2019, and at the same time, the Johns Hopkins Center for Health Security started researching the transmission of a previously unidentified coronavirus.

*"The implementation of the COVID-19 development scenario and USAID's emergency phasing out of the Predict program in 2019 suggest the deliberate nature of the pandemic and US involvement in its occurrence,"* Kirillov said.

He continued by saying that the recent appearance of the monkeypox virus and the US's alleged history of employing biological weapons against adversaries have caused Moscow to notice a "clear trend" of pathogens that, for whatever reason, the Pentagon is interested in, subsequently developing into pandemics.

The U.S. maintains that it did not use Ukrainian bio-labs for military research and that Kiev used the *"46 peaceful Ukrainian laboratories, health facilities and disease diagnostic sites"* to help improve biological safety, security, and disease surveillance for both human and animal health. The denial persisted for several



months until evidence was submitted at the UN exposing the U.S. “peaceful” (sic) labs were engaged in weaponization of the Coronavirus SARS2-Cov-2.

The Covid-19 virus’s precise origin has not yet been proved beyond a reasonable doubt. The World Health Organization (WHO) asserted that it was most probably spread from an animal, presumably a bat, to people in February 2021.

## Monkeypox Is Related To mRNA Vaccine Claims Top Israeli Physician

Twitter censored Prof. Shapira, a top Israeli physician who claimed that [monkeypox is related to mRNA vaccine](#), hopes to draw more attention to the

death and destruction that these vaccines are delivering to so many people throughout the world.

Between 2013 to 2021, Professor Shmuel Shapira, M.D., MPH, oversaw Israel's efforts to create a coronavirus vaccine as Director General of the Israel Institute for Biological Research (IIBR).

Prof. Shapira founded and serves as the director of the Hebrew University Faculty of Medicine's Department of Military Medicine and the IDF Medical Corps. He works as a Senior Research Fellow at the Reichman University in Israel's International Institute for Counter-Terrorism (ICT).

Shapira previously held the positions of Director of the Hebrew University Hadassah School of Public Health and Deputy Director General of the Hadassah Medical Organization. He was the IDF Head of Trauma Branch and is a Full Colonel (Ret.) in the Israel Defense Forces (IDF).

He is the editor of Essentials of Terror Medicine, Best Practice for Medical Management of Terror Incidents, and Medical Response to Terror Threats and has authored more than 110 peer-reviewed scientific articles.

Last Monday, Twitter censored Prof. Shapira and made him delete a post that said: ***"Monkeypox cases were rare for years. During the last years, a single case was documented in Israel. It is well established that mRNA vaccines affect the natural immune system. A monkey pox outbreak following massive covid vaccination: \*Is not a coincidence."***

Since he first objected to the Israeli Genesis Award being given to Pfizer CEO Albert Bourla, Prof. Shapira, who started his Twitter account in January 2022, has become more critical of the mRNA vaccines.

Shapira stated on January 18, 2022 (Google's translation of Hebrew): ***"The Israeli Genesis Award was given to the CEO of Pfizer, so wretched. Instead of giving it to an Israeli scientist, and all this for a mediocre, short-acting vaccine that yielded Pfizer a profit of billions, a wretched and exiled one. Shapira enquired on February 6, 2022: ***"What grade would you give to a vaccine that people are vaccinated with three times and get sick twice (as of today)? Not to mention significant side effects[.]"***

On April 9, 2022, Shapira said: ***"The CEO of the company, millions of whose vaccines were used in Israel for vaccination, stated in an interview with NBC that Israel serves as the world's laboratory. To the best of my knowledge, this is the***

*first case in history where experimental guinea pigs paid an exorbitant rate for their participation.”*

On May 13, 2022, Shapira said: *“I received 3 vaccinations, I was physically injured in a very significant way as many others were injured[.] And in addition, my trust in the nature of the decisions and in the processes of making them has been severely eroded. No one asked and checked. I will fight with all my might so that truthful answers regarding all decisions and not just regarding the vaccine are given[.]”*

On June 8, 2020, Prime Minister Benjamin Netanyahu spoke by video conference with Israel Institute for Biological Research Director General Prof. Shmuel Shapira and congratulated him on his progress in developing a vaccine against the novel coronavirus. On November 1, 2020, clinical trials for the Israeli BriLife COVID vaccine developed at IIBR began at the Hadassah and Sheba medical centers.

On June 7, 2022, Shapira said: *“We are talking about vaccine five in two and a half years. When the vaccine is planned for the sequence from January 2020 (the great-grandfather of the great-grandfather of the current variants). A vaccine that does not prevent infection does not prevent morbidity. And it is allegedly attributed to significant side effects to say the least. Why? What is the logic? Which authority approved? And don’t say that it prevents a serious illness, no one has proven it.”*

On June 8, 2022, Shapira said: *“I will continue and ask why give an outdated fifth vaccine that does not prevent disease and apparently causes many significant common side effects.”*

Shapira talked about the “son of a 36-year-old Australian friend” who experienced “severe ventricular arrhythmias and went into heart failure” just “days after the second Pfizer vaccine” on July 5, 2022.

Shapira posted a link to the [OpenVaers](#) COVID Vaccine Adverse Event Reports on [July 31, 2022](#), with the simple comment “Safe & Efficient” above. The report indicated a total of 1,357,937 reports, including 170,151 hospitalizations and 29,790 fatalities.

In conclusion, Professor Shmuel Shapira, Director General of the Israel Institute for Biological Research, may be the most senior medical professional in the world to publicly oppose the COVID vaccines.

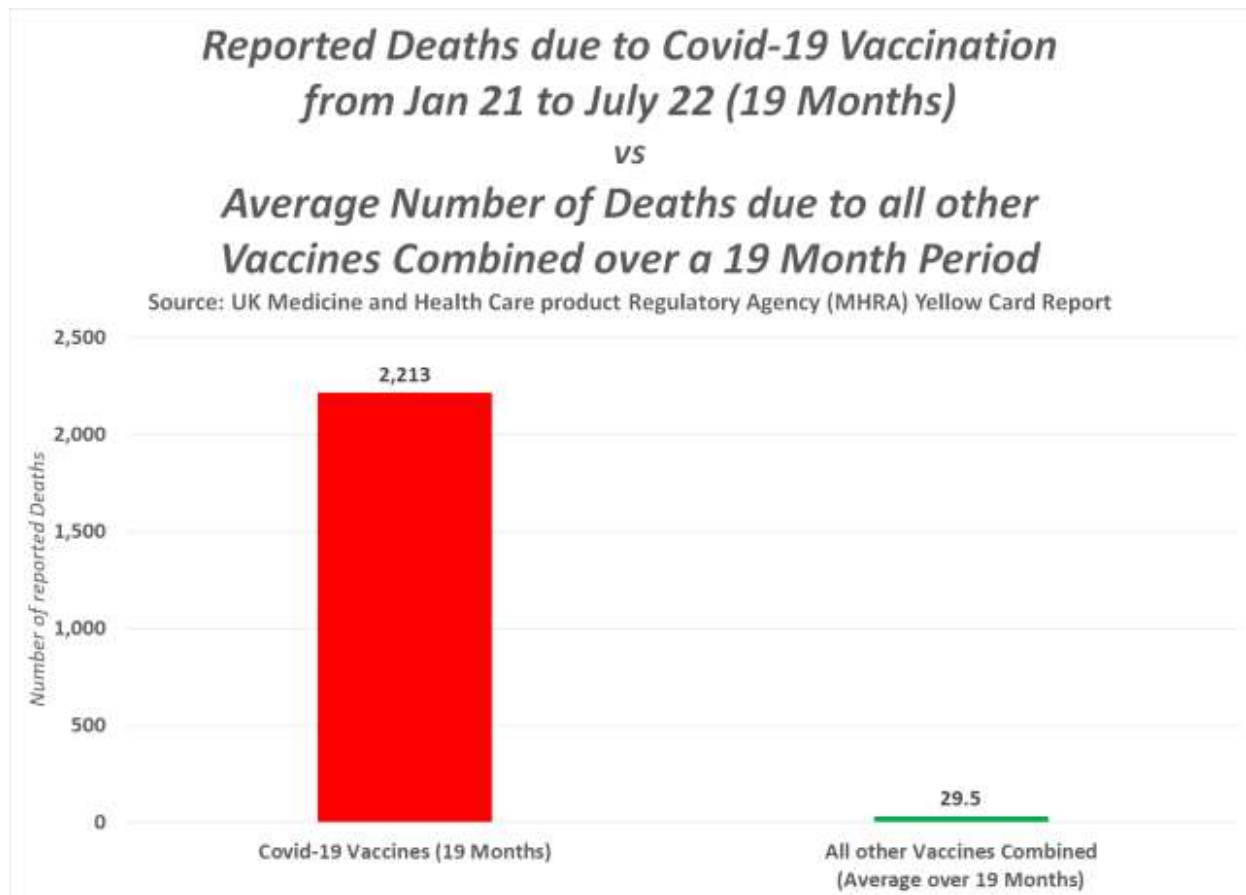

A [Freedom of Information request](#) was made via email to the Medicine and Healthcare product Regulatory Agency (MHRA) on the 6th August 2021 in which a Mr. Anderson asked the MHRA the following questions –

- Are there any other reporting AI system monitoring systems like the Yellow Card scheme?
- Are Covid-19 Vaccines still in trials?
- How many deaths has there been in last 20 years by previous Vaccines without Covid-19 Vaccines?
- What happens if a there is a new vaccine or new drug? What process and monitoring do they go through?
- What cut off point will the MHRA say a vaccine or drug is unsafe for humans?

Thank you for your email dated 6<sup>th</sup> August 2021, where you requested information on the following under the Freedom of Information (FOI) act:

- *How many Deaths has there been from all Covid-19 vaccines? Has there been deaths within 3 days or 28 day after taking the vaccine?*
- *Are there any other reporting AI system monitoring system like Yellow Card reports system others that government is tracking for ADS/adverse reactions?*
- *Are Covid-19 Vaccines still under trial stages? And getting monitored still not been approved only Emergency Authorisation is this right? Are they still not officially approved?*
- *How many deaths has there been in last 20 years by previous Vaccines without covid-19 Vaccines compared with covid-19 Vaccines related death?*
- *What happens if a there is a new vaccine or new drug? What process and monitoring do they go through?*
- *Is there ongoing on safety and effectiveness? If the Vaccine or Drug is proven unsafe what cut off point will MHRA say this is unsafe for humans because of the data and say all Covid-19 vaccines are proven unsafe? Like swine flu vaccine 53 deaths proven unsafe for humans is there cut off point with Covid-19 All Vaccines*

The MHRA responded with the usual “we do not hold this information”, as seen time and time again from Government departments.

To address your first question, whereby you asked how many deaths from all COVID-19 vaccines have there been within 3 days or 28 days after taking the vaccine, unfortunately the MHRA does not hold complete information on timing of death or death statistics and so would suggest you contact the Office of National Statistics (ONS) ([Contact us - Office for National Statistics \(ons.gov.uk\)](https://www.ons.gov.uk/contact-us)) for this particular aspect of your enquiry.

However, they did confirm that they are using other epidemiological studies, anonymized GP-based electronic healthcare records and international experience to proactively monitor safety alongside the spontaneous reports received via the Yellow Card scheme.

The MHRA also confirmed that the current Covid-19 vaccines on offer in the United Kingdom are only under a temporary authorization and that these authorizations do not constitute a marketing authorization.

You also queried if the COVID-19 vaccines are still under trial stages and are only approved for Emergency authorisation. The temporary authorisations of the Pfizer/BioNTech, Oxford/AstraZeneca and Moderna vaccines was done through an expedited rolling review. A ‘rolling review’ can be used to complete the assessment of a promising medicine or vaccine during a public health emergency in the shortest time possible. This is done as the packages of data become available from ongoing studies on a staggered basis. The temporary authorisation under Regulation 174 permits the supply of identified vaccine batches, based on the safety, quality and efficacy data submitted to MHRA. These authorisations do not constitute a marketing authorisation.

In answer to the question asked on the number of deaths due to all other vaccines in the past twenty years the MHRA provided the usual robotic response about how great the Covid-19 vaccines are and how they are the “*single most effective treatment for preventing serious illness due to Covid-19*” but what they did not do is say that they “do not hold this information”.

Instead, [they revealed that they had received a total of 404](#) reported adverse reactions to all available vaccines (excluding the Covid-19 injections) associated with a fatal outcome between the 1st January 2001 and the 25th August 2021 – a time frame of 20 years and 8 months.

The MHRA has received a total of 404 UK spontaneous suspected ADR reports for any vaccine between 01/01/2001 – 25/08/2021 associated with a fatal outcome. Please note this number excludes reports received for the COVID-19 vaccines as further information is provided on these vaccines in the weekly summary of Yellow Card reporting which can be found via the link referenced above.

But how does that fare against the number of reported adverse reactions to all temporarily authorized Covid-19 vaccines associated with a fatal outcome?

Well, since [the Pfizer injection](#) was rolled out in December 2020 there have been [808 reported deaths](#) as of 13th July 22, meaning that in just 19 months, this “vaccine” alone outnumbers the deaths due to all other vaccines combined in the past 20 years.

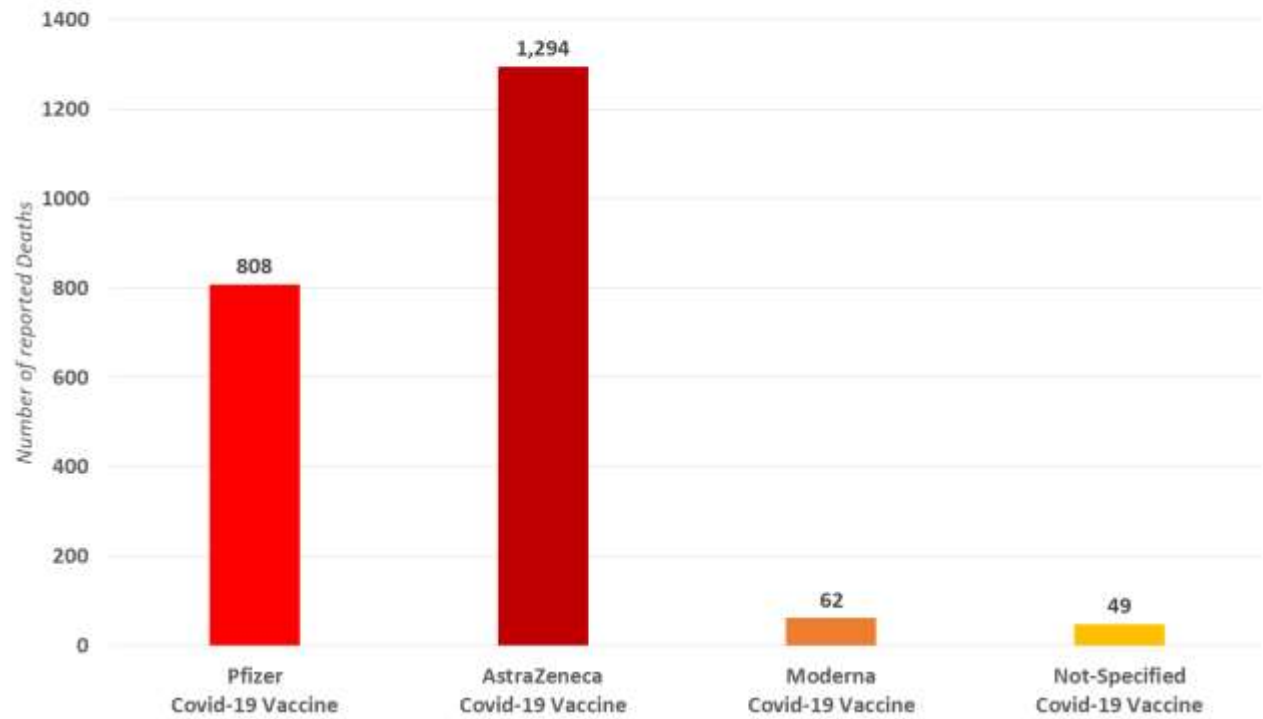

## Number of Deaths reported as Adverse Reactions to each available COVID-19 Vaccine in the UK

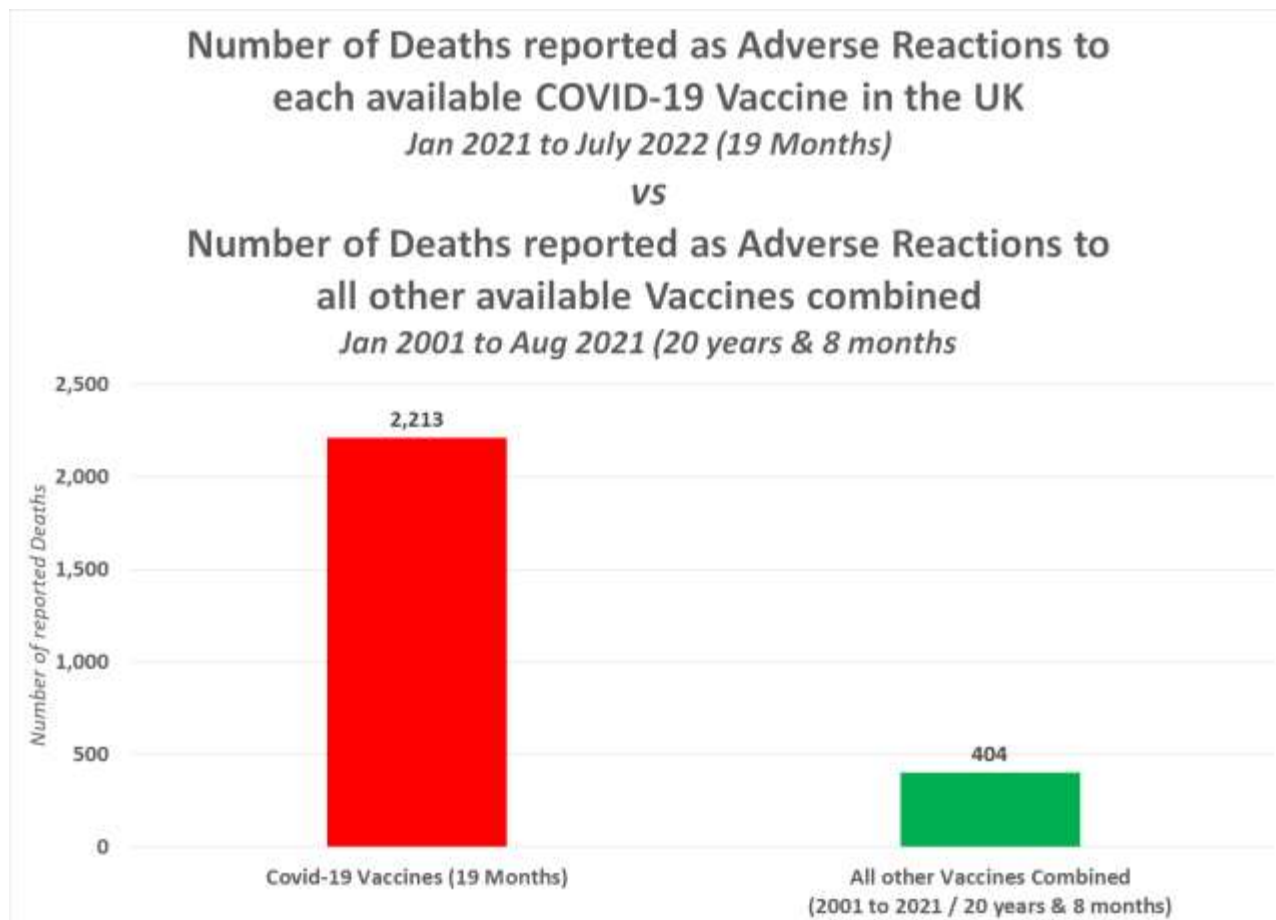
*Jan 2021 to July 2022 (19 Months)*

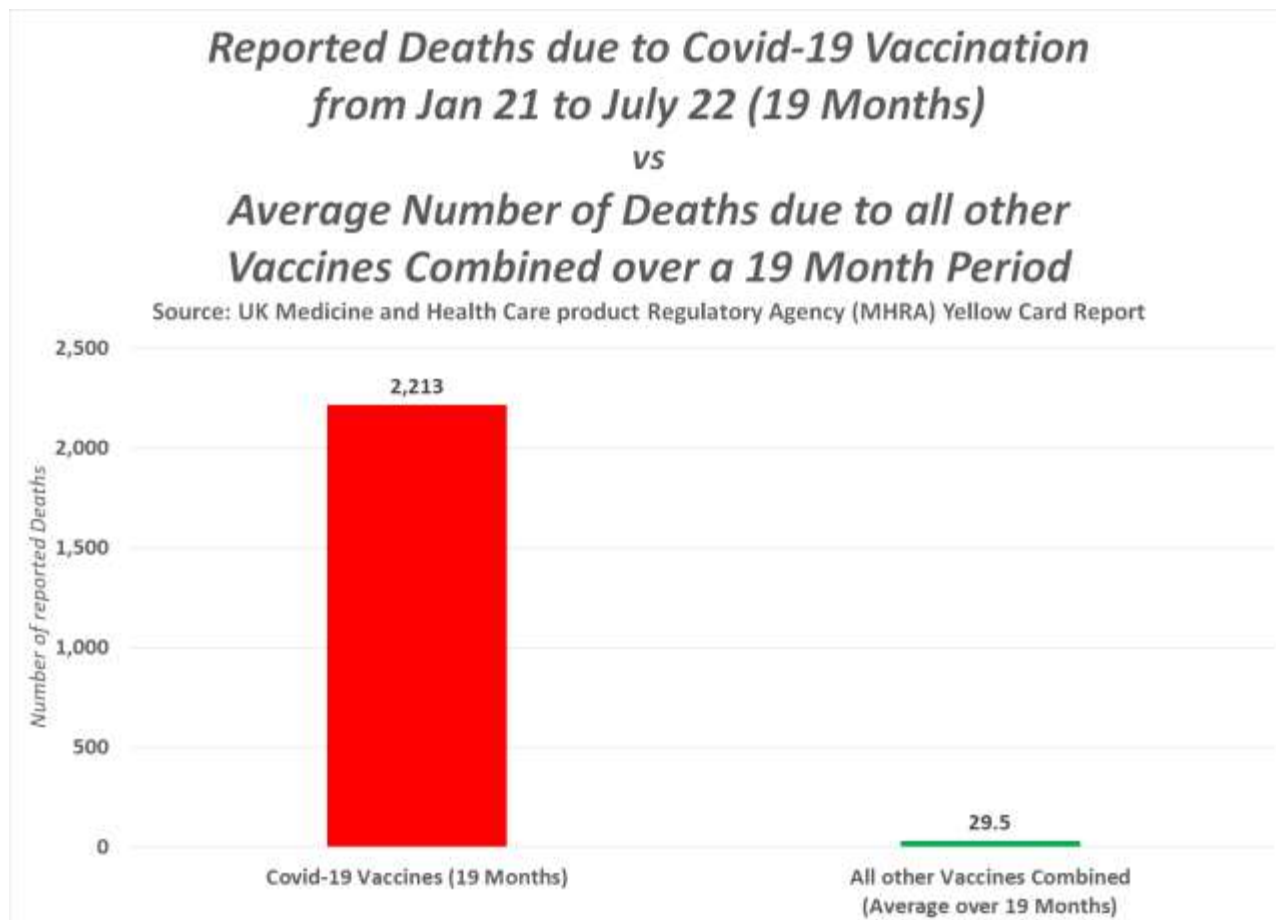

**The death business is BOOMING thanks to covid vaccines**

([Natural News](#)) North America's leading provider of funeral, cremation and cemetery services says [business is booming](#) ever since Wuhan coronavirus (Covid-19) "vaccines" were introduced under Operation Warp Speed.

Between 2020 and 2021 when [Donald "father of the vaccine" Trump](#) paved the way for a quick and highly profitable launch of the injections, Service Corporation International (SCI), which handles some 450,000 corpses per year, saw a massive increase in earnings.

*"Funerals are a solid but slow-growth business, and the trend toward cremations hasn't helped,"* writes Alex Berenson on his Substack. *"But between 2019 and 2021, SCI's earnings per share more than doubled, from \$1.90 to \$4.57."*

At first, SCI blamed a covid "*pull-forward*" event for the death surge it started seeing. What this means, in essence, is that because people who were already close to death anyway died in large numbers supposedly due to covid, the death count in future years would be less, balancing things out.

When this did not happen as expected, outsiders like Berenson came to the conclusion that the increased death tolls are not because of covid, but rather because of the shots that were introduced as the "*cure*."

*"Lucky for Service Corporation and its investors, pull-forward isn't turning out to be a problem,"* Berenson writes. *"Americans are still dying at rates well above normal, even as Covid becomes a minimal part of business this year."* (Related: If you or someone you know already took covid vaccines, you might be able to find relief using [these remedies](#).)

SCI saw \$1 billion in sales this past spring.

For those profiting from the *plandemic*, all of these deaths are resulting in massive returns on investment. SCI's spring earnings saw nearly \$1 billion in sales and \$135 million in profits.

In a statement to investors and Wall Street analysts, company CEO Tom Ryan beat around the bush in blaming "covid" for the surge in corpses that have come through the company.

*"I think that covid cases on a national basis ... it's just not material to our numbers,"* he said. *"So, like, we tried to point out at investor day, I think we're experiencing – we're servicing elevated numbers of consumers."*

The phrase "*elevated numbers of consumers*" is a very bizarre way of saying more dead bodies needing funerals, burials and cremations are flooding SCI with lots and lots of cash.

*“And you’d say, okay, what is that, Tom? Well, we’ve mentioned a little bit, we think there’s still excess deaths,” Ryan went on to say. “We think we can correlate it with lack of healthcare, people probably drinking too much, smoking too much, driving too fast, depression and access to mental health.”*

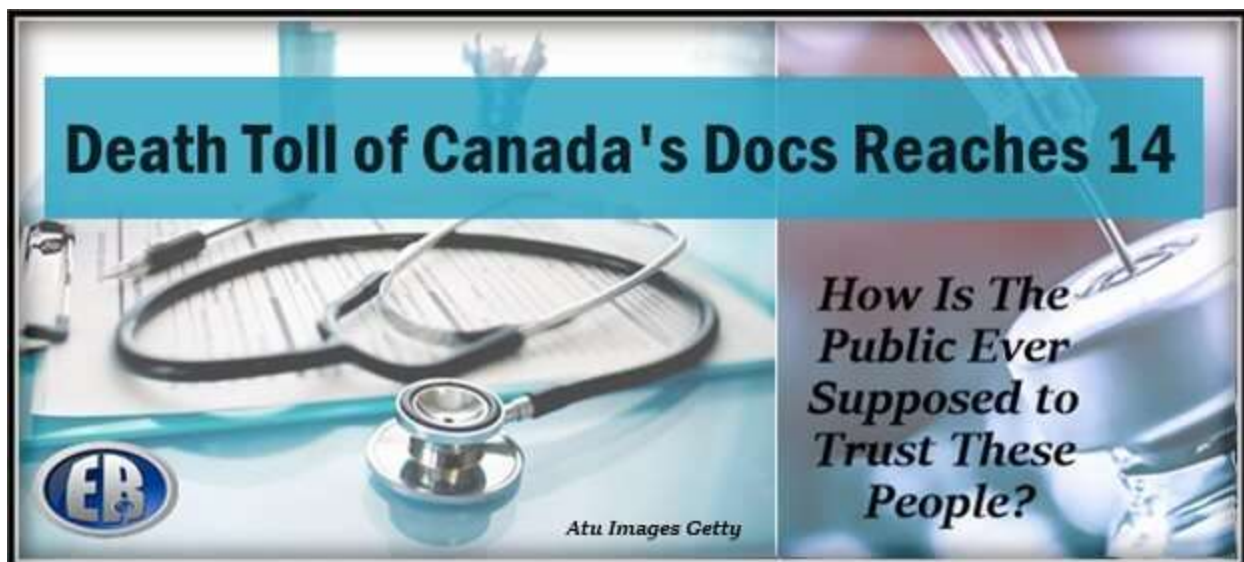

## Nobody wants to eat fake Beyond Meat burgers, McDonald's discovers

([Natural News](#)) You will no longer find artificial meat patties at McDonald's now that the fast-food chain has [scrapped a pilot program](#) involving Beyond Meat.

It turns out that Americans still prefer to eat 'all beef patties' of real meat from animals as opposed to the lab-concocted abomination known as Beyond Meat, a company in which billionaire eugenicist Bill Gates is [heavily invested](#).

A trial of the "plant-based" patties at some McDonald's restaurants failed miserably we are told. Nobody ordered the so-called McPlant burger, which is apparently even more disgusting than the fast-food chain's regular burgers.

McDonald's had signed a three-year global distribution deal with Beyond Meat back in 2021. It appears as though that deal was cut short because customers simply do not want to eat synthetic meat made from genetically modified organisms (GMOs) and other toxic chemicals.

According to Ken Goldman, an analyst at JPMorgan Chase & Co., *“the product did not sell well enough”* to keep it going. The financial news site *The Fly* joked that Beyond Meat is “McDone” as far as McDonald’s is concerned.

**Taco Bell, KFC, Pizza Hut have all discontinued Beyond Meat products as well.**

McDonald’s is not the only company that adopted Beyond Meat only to later abandon it. The full gamut of Yum! Brands companies, including KFC, Taco Bell and Pizza Hut, have all thrown Beyond Meat out the window after failed trials at its stores.

Panda Express did the same thing, as did Dunkin’, Hardee’s (Carl’s Jr.), and A&W, reports indicate.

*“You’re not going to change cultural tastes overnight,”* said John Baumgartner, an analyst for the Japanese bank Mizuho, suggesting that with enough propaganda and goading, people might eventually accept fake meat.

*“Recruiting your next phase of consumers requires more innovation and better-tasting products.”*

In the meantime, Beyond Meat has had to massively scale back its workforce as nobody wants the company’s products. Some 40 jobs have been cut from the company, which is slated to burn through all of its remaining cash in the coming months.

In 2022 alone, Beyond Meat’s stock price has fallen by about 50 percent – and this was after it fell by roughly the same amount in 2021.

*“Beyond Meat has failed to generate any positive free cash flow since going public in 2019,”* said David Trainer of the investment research firm New Constructs.

Layoffs could help, Trainer says, but *“the proof is yet to be seen until we can see how much they can slow the burn.”*

Our own readers are well aware of the fact that Beyond Meat, no matter how it is dressed up and modified to taste like real meat, will never be a healthy alternative to the real thing.

*“Gates owns a lot of land and still has plenty of money,”* wrote one of them about the dark and sinister nature of what is going on behind the scenes to try to force people away from eating real meat.

*“Now that the pipeline has been scrapped, all those small towns that had people move there to work on the pipeline will become ghost towns. I wonder if Gates (and others) will snap up that real estate for pennies on the dollar.”*

*“He’s right. We should eat synthetic meat, starting with him, Soros, Biden, Harris, Pelosi, Schumer, Waters, AOC and McConnell,”* joked another about comments made by Gates about the “need” for global humanity to eat his Beyond Meat products rather than real meat.

*“Their meat will be tough and gamey, though.”*

Others echoed that sentiment, questioning what might be hidden inside Beyond Meat patties that Gates intends for people to die from. Certainly he is not eating the stuff himself.

### **CDC Drops Quarantine, Distancing Recommendations, as 1.3 Million COVID Vaccine Injuries Reported to VAERS**

VAERS data released Friday by the Centers for Disease Control and Prevention show **1,379,438 reports of adverse events** from all age groups following COVID-19 vaccines, including **30,162 deaths** and **251,075 serious injuries** between Dec. 14, 2020, and Aug. 5, 2022.

*Editor’s note: In previous VAERS weekly updates, The Defender focused exclusively on U.S. reports in the sections where reports are broken out by age groups and types of adverse events. However, excluding foreign reports from these categories excludes thousands of vaccine injuries reported to the system, so those sections now include all — U.S. and foreign combined — reports submitted to VAERS in the categories indicated.*

The Centers for Disease Control and Prevention (CDC) today released new data showing a total of [1,379,438 reports of adverse events](#) following [COVID-19](#) vaccines were submitted between Dec. 14, 2020, and Aug. 5, 2022, to the Vaccine Adverse Event Reporting System (VAERS). That’s an increase of 7,964 adverse events over the previous week.

VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S.

The data included a total of [30,162 reports of deaths](#) — an increase of 181 over the previous week — and [251,075 serious injuries](#), including deaths, during the same time period — up 1,959 compared with the previous week.


Of the 30,162 reported deaths, [19,462 cases](#) are attributed to Pfizer’s COVID-19 vaccine, [8,038 cases](#) to Moderna, [2,613 cases](#) to Johnson & Johnson (J&J) and [no cases](#) yet reported for Novavax.

Excluding “[foreign reports](#)” to VAERS, [854,084 adverse events](#), including [13,972 deaths](#) and [87,488 serious injuries](#), were reported in the U.S. between Dec. 14, 2020, and Aug. 5, 2022.

[Foreign reports](#) are reports foreign subsidiaries send to U.S. vaccine manufacturers. Under U.S. Food and Drug Administration (FDA) regulations, if a manufacturer is notified of a foreign case report that describes an event that is both serious and does not appear on the product’s labeling, the manufacturer is required to submit the report to VAERS.

Of the 13,972 U.S. [deaths reported](#) as of Aug. 5, 7% occurred within 24 hours of vaccination, 15% occurred within 48 hours of vaccination and 54% occurred in people who experienced an [onset of symptoms](#) within 48 hours of being vaccinated.

In the U.S., 604 million COVID-19 vaccine doses had been administered as of Aug. 3, [including](#) 357 million doses of Pfizer, 228 million doses of Moderna and 19 million doses of Johnson & Johnson (J&J).

Historically, VAERS has been shown to report only 1% of actual vaccine adverse events.

VAERS data from Dec. 14, 2020, to Aug. 5, 2022, for 6-month-olds to 5-year-olds show:

- 2,975 adverse events, including 140 cases rated as serious and 5 reported deaths.
- 4 reports of myocarditis and pericarditis (heart inflammation). The CDC uses a narrowed case definition of “myocarditis,” which excludes cases of cardiac arrest, ischemic strokes and deaths due to heart problems that occur before one has the chance to go to the emergency department.
- 20 reports of blood clotting disorders.
- 38 reports of seizures.

VAERS data from Dec. 14, 2020, to Aug. 5, 2022, for 5- to 11-year-olds show:

- 13,364 adverse events, including 620 rated as serious and 22 reported deaths.
- 45 reports of myocarditis and pericarditis.
- 64 reports of blood clotting disorders.
- 169 reports of seizures.

VAERS data from Dec. 14, 2020, to Aug. 5, 2022, for 12- to 17-year-olds show:

- 32,945 adverse events, including 4,189 rated as serious and 118 reported deaths.  
According to the CDC, “VAERS data available to the public include only the initial report data to VAERS. Updated data which contains data from medical records and corrections reported during follow up are used by the government for analysis. However, for numerous reasons including data consistency, these amended data are not available to the public.”
- 268 reports of anaphylaxis among 12- to 17-year-olds where the reaction was life-threatening, required treatment or resulted in death — with 94% of cases attributed to Pfizer’s vaccine.
- 1,304 reports of myocarditis and pericarditis with 650 cases attributed to Pfizer’s vaccine.
- 298 reports of blood clotting disorders with 275 cases attributed to Pfizer.

New CDC COVID guidance ditches distinctions between vaccinated and unvaccinated.

The CDC on Thursday issued [sweeping new recommendations](#) as part of the agency's efforts to overhaul its [COVID-19 guidance](#).

*"This guidance acknowledges that the pandemic is not over, but also helps us move to a point where COVID-19 no longer severely disrupts our daily lives,"* the CDC's Greta Massetti said in a [press release](#).

Here are the [biggest changes](#) to the CDC's guidance:

- Unvaccinated people now have the same guidance as vaccinated people.
- Those who are exposed to the virus are no longer required to quarantine regardless of vaccination status.
- Students may stay in class even if they've been exposed to COVID-19.
- Six-foot social distancing is [no longer recommended](#).
- Contact tracing and routine surveillance testing of symptomatic people are no longer recommended in most settings.

According to [The New York Times](#), the CDC has been working for months on the new guidance which builds on previous guidance issued in February that reduced isolation times for those who get COVID-19.

The agency said it is making changes to its guidance now because *“vaccination and prior infections have granted many Americans some degree of protection against the virus, and treatments, vaccines and boosters are available to reduce the risk of severe illness.”*

According to [The National Law Review](#):

*“The CDC’s focus on individual responsibility, the removal of distinctions between vaccinated and unvaccinated, the removal of quarantine recommendations and the discussion of mask wearing as an individual responsibility are good news for employers who are considering relaxing COVID-19 workplace requirements.”*

*“This likely will not be the last we hear from the CDC on this topic. Indeed, the CDC stated that it intends to issue more specific guidance for settings such as healthcare, congregate living, and travel.”*

**Pfizer vaccine efficacy in teens wanes 27 days after second dose**

A [study](#) published Aug. 8 in The Lancet showed the effectiveness of the Pfizer-BioNTech COVID-19 vaccine against symptomatic infection among adolescents “rapidly declined over time,” waning from just 27 days after the second dose.

Researchers [analyzed data](#) from 503,776 COVID-19 tests of 2,948,538 adolescents — ages 12-17 — in Brazil from Sept. 2, 2021, to April 19, 2022, and 127,168 tests of 404,673 adolescents in Scotland from Aug. 6, 2021, to April 19, 2022.

The study showed vaccine efficacy began to decline 27 days after the second dose for both countries, plummeting to 5.9% (95% CI 2.2–9.4) in Brazil and dropping to 50.6% (95% CI 42.7–57.4) in Scotland at 98 days after adolescents received the second dose.

While protection against symptomatic COVID-19 dropped dramatically in both countries less than one month after the second dose, protection against severe illness — defined as hospitalization or death within 28 days — remained above 80% in Brazil from 28 days to 98 days and beyond.

The authors [sought to assess protection](#) against severe illness in Scotland but were unable to do so because so few cases of severe COVID-19 in adolescents in Scotland were reported during the time of the study.

The authors concluded that “two doses are insufficient to sustain protection against symptomatic disease” in adolescents and recommended more research be done on the need for [booster doses](#).

‘Stunning’ link between Pfizer vaccine and myocarditis in teens, study shows  
A [preprint study](#) conducted during Thailand’s national COVID-19 vaccination campaign showed what one physician described as a “[stunning](#)” association between myocarditis and the Pfizer-BioNTech vaccine.

The study analyzed 301 participants ages 13-18 who were healthy and without abnormal symptoms after receiving their first vaccine dose. Participants with a history of cardiomyopathy, tuberculous pericarditis or constrictive pericarditis and severe allergic reaction to the COVID-19 vaccine were excluded from the study.

Researchers found that 18% of the 301 teens analyzed had an abnormal electrocardiogram, or EKG after receiving their second dose of Pfizer, 3.5% of males developed myopericarditis or [subclinical myocarditis](#), two were hospitalized and one was admitted to the ICU for heart problems.

Cardiovascular adverse events observed during the study included tachycardia (7.64%), shortness of breath (6.64%), palpitation (4.32%), chest pain (4.32%) and hypertension (3.99%).

Fifty-four adolescents had abnormal electrocardiograms after vaccination, three patients had minimal [pericardial effusion](#) with findings compatible with subacute myopericarditis and six patients experienced [mitral valve prolapse](#).

All patients were male and had abnormal electrocardiograms, particularly sinus tachycardia. [Researchers said](#) the clinical course was mild in all cases.

Military using ‘Comirnaty’ vaccine produced at facility not approved by FDA  
In an [exclusive interview](#) with The Defender, a U.S. Coast Guard (USCG) service member alleged the U.S. Department of Defense (DOD) is administering COVID-19 vaccines from vials of [Pfizer’s Comirnaty-labeled vaccines](#) that are not produced in a facility approved by the FDA.

Lt. Chad R. Coppin, in a July 30 [declaration](#) submitted to Sen. Ron Johnson (R-Wis.) under penalty of perjury, detailed his personal investigation into the availability and origin of Comirnaty-labeled COVID-19 vaccine vials at U.S. military facilities.

Coppin relayed his concerns in an interview with [The Defender](#), as did Holly Freinle, the wife of a U.S. military service member stationed at Fort Detrick, Maryland, who corroborated Coppin’s claims that Comirnaty-labeled vaccine vials are appearing at military service facilities.

Until now, the DOD has claimed the Pfizer-BioNTech COVID-19 vaccine, administered under [Emergency Use Authorization](#), is “[interchangeable](#)” with the fully licensed Pfizer Comirnaty vaccine — which until recently, was said to be unavailable at military facilities.

In his [July 30 declaration](#), Coppin, who has served with the USCG since March 2002, reported that after a long period of unavailability, the “Comirnaty” vaccine began to appear at U.S. military facilities in June.

Here’s another view showing you the immense size of the Baal creature, which is illuminated with fiery red lights and smoke, indicating its origins from Hell:



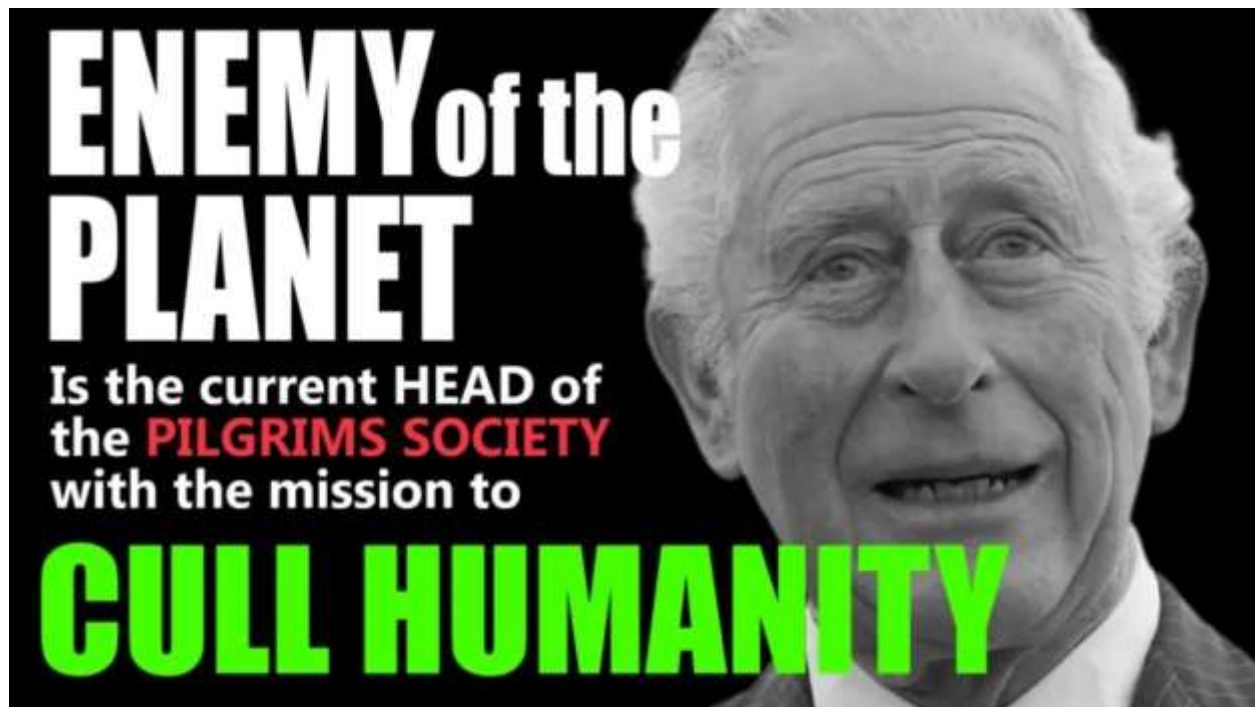


According to The Guardian, 72 nations are participating in this demon worship ritual, which was augmented by music from *Black Sabbath*, a Luciferian rock band.

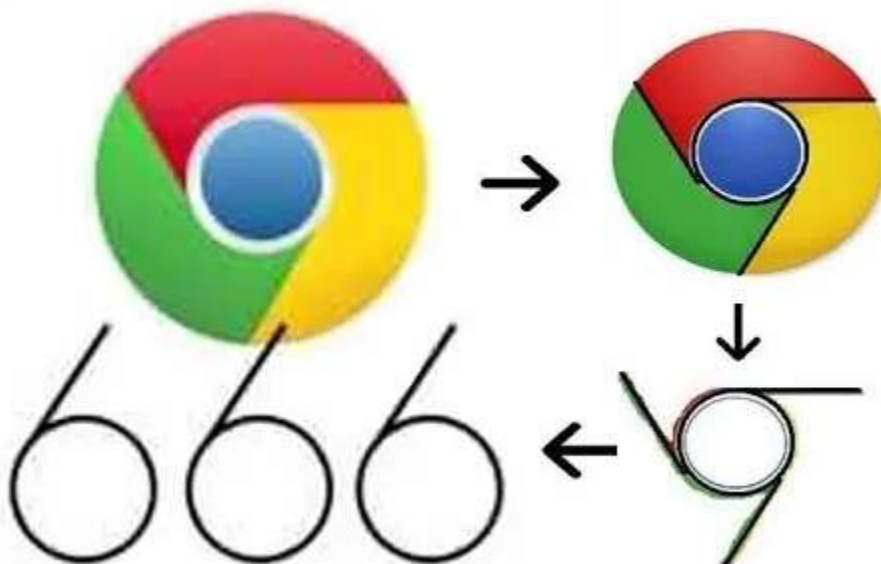

- Even the NIH — which funded the SARS-CoV-2 gain-of-function bioweapons development in China — sports a logo that clearly depicts “666.”

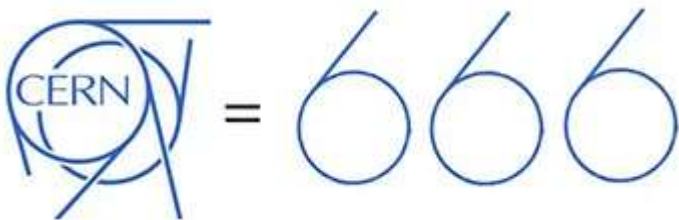

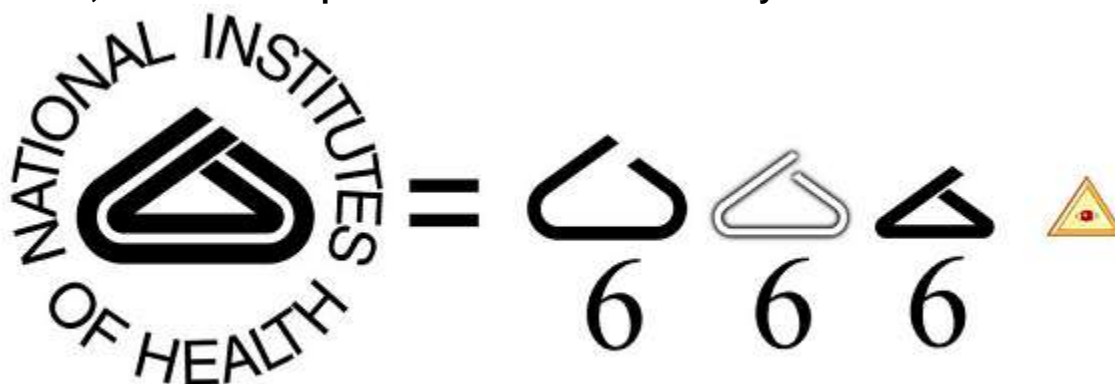

## Life Insurance claims skyrocket after COVID jab rollout, prompting insurers to take legal action against vaccine manufacturers

([Natural News](#)) Life insurance claims have skyrocketed since the COVID jab rollout, dwarfing the number of claims made during 2020 when a high-mortality-rate-pandemic was supposedly ravaging the Nation. Yale epidemiologist Harvey Risch believes that insurance companies are on the verge of [taking legal action against vaccine manufacturers](#) over vaccine-associated death risks that were downplayed from the very beginning.

Risch points to an explosion of “*early unexpected mortality claims*” after the COVID vaccine rollout. This influx of life insurance claims is not even COVID-related, and insurers are struggling to pay out. Risch says that vaccine manufacturers misrepresented the “*all-cause mortality*” from their very own clinical trials, not only deceiving the population into taking dangerous vaccines,

but also misleading the insurance companies who are now forced to pay for thousands of needless deaths in young and middle-aged adults.

Will insurance companies seek financial compensation from the COVID-19 vaccine manufacturers to cover for *“major financial risk[s] that they have to figure out how to manage”* going forward?

Epidemiologist believes life insurance companies may sue vaccine manufacturers for misleading statements.

Risch has analyzed statements made by the CEOs of various group life insurance companies. He claims that the actuaries miscalculated, estimating that the vaccinated would *“live longer than they have.”* Risch said the actuaries were deceived on *“all-cause mortality...from the original [vaccine] trials.”*

In December of 2021, OneAmerica CEO Scott Davison attended a healthcare conference and spoke up about an [“unheard of” 40 percent spike in the death rate](#) of working-age people insured by the company. The 40 percent increase in death made no rational sense because the covid-19 vaccine had been rolled out the entire year. Government and public health officials promised that this [vaccine program](#) would save lives and end the pandemic.

Davison said that a 10 percent increase in death would have required a *“one-in-200-year-catastrophe.”* There was no way the company could have predicted a 10 percent increase in death claims, let alone a 40 percent increase, when the worst of the pandemic was supposed to be in the rear-view mirror. The vaccines were safe and effective, they were told, and no one was allowed to question the god-like status of these experimental jabs.

Most shocking, Davison said that the majority of insurance claims filed ARE NOT COVID-related deaths. In 2020, almost any medical issue could be coded as COVID-19, no matter how faulty the testing was, no matter how many underlying health issues and medical errors were to blame for the deaths. For the death rate to spike 40 percent and NOT be related to COVID-19 is an anomaly of mass proportions.

Will life insurance companies get a settlement from the vaccine makers, as the cycle of depopulation is swept under the rug?

At Lincoln National, actuaries reported a 163 percent increase in death benefits paid out in 2021, after the vaccine was rolled out to the public. The large insurer paid out \$500 million in 2019, \$548 million in 2020, and a whopping \$1.4 billion in 2021.

The global pandemic didn't cause a drastic change in death benefits paid out, but for some reason, excess mortality was highest in 2021, when the COVID vaccine

promised a way out. The year of the vaccine brought a tsunami of excess mortality, spiking the death rate to levels unthinkable for insurance companies to handle. Lincoln Financial is not poised to sue the vaccine manufacturers, however. Instead, they are justifying the surge in death payouts, pointing to “less favorable returns within the company’s alternative investment portfolio” that year. Lincoln Financial spokesperson Kelly DeAngelis said the company acquired Lincoln Life Assurance Company of Boston in 2021 and took on a slew of new claims. Even this acquisition does not explain the abnormal surge in death benefits paid out in 2021.

Perhaps the insurance companies will ultimately seek some kind of [settlement from the vaccine manufacturers](#) – to brush the depopulation issue under the rug.

### **Scientists with ties to Bill Gates and Anthony Fauci admit to developing vaccine that spreads like a virus**

Scientists linked to Bill Gates said they are developing a [vaccine that spreads like a virus](#).

The research is subsidized by high-profile funding organizations with longstanding and close financial ties to the Bill & Melinda Gates Foundation. It is also supported by the National Institutes of Health, the mother agency of Dr. Anthony Fauci’s National Institute of Allergy and Infectious Diseases.

[Self-spreading vaccines](#) are rooted in efforts to reduce pest populations. The virally-spread immune-contraception hijacks the immune systems of infected animals like non-native mouse species, preventing them from fertilizing offspring.

The earliest self-spreading vaccine efforts targeted two highly lethal infectious diseases in the European rabbit population in 2001. Spanish researchers field-tested a vaccine in the wild rabbit population on a small island just off Menorca. The vaccine spread to over half the 300 rabbits on the island, and the trial was said to be a success.

While the researchers may intend to make self-spreading vaccines, there could be ways to repurpose this science to develop biological weapons, which may prove uncontrollable and irreversible.

Humans have been weaponizing biology since 2000. A new virus has been released every two years since 2000.

Humans have already weaponized biology on several occasions. As the apartheid-era South African bio-warfare program showed, social, political and scientific pressures can lead to the misuse of biological innovation.

Project Coast, as it was called, was South Africa's program primarily focused on covert assassination weapons for use against individuals deemed a [threat to the racist apartheid government](#). In addition to producing contraptions to inject poisons, Project Coast researchers developed techniques to lace sugar cubes with salmonella and cigarettes with Bacillus anthracis.

There had been many bio warfare programs, including several that were far more elaborate and sophisticated, but the South African program is important in thinking through malicious uses of self-spreading vaccines. One of Project Coast's research projects aimed at developing a human anti-fertility vaccine.

This idea came at a time when there was widespread concern over population explosion. Schalk Van Rensburg, who oversaw the fertility-related work at Project Coast, believed that this could bring his lab international acclaim and funding. (Related: [The Bill Gates globalist vaccine depopulation agenda... as revealed by Robert F. Kennedy, Jr.](#))

Van Rensburg and the director of the bio warfare program, Wouter Basson, said the military needed an anti-fertility vaccine for female soldiers not to become pregnant.

Other scientists involved in the project denied awareness of ulterior intentions or even their fertility work as part of a military endeavor. However, Van Rensburg and lab director Daniel Goosen said the real intention of the project was to selectively administer the contraceptive in secret to unsuspecting Black South African women.

In the end, the anti-fertility vaccine was not produced before Project Coast officially closed down in 1995 – 12 years after it was initiated. It ended with an earlier version tested in baboons, but never in humans. (Related: [Bill Gates pushes for a 90 percent vaccination rate worldwide](#).)

South Africa was not the only country to try to forcibly sterilize its population. European countries like Sweden and Switzerland sterilized members of the Roma minority in the early half of the 20th century, while countries like Slovakia continued beyond that.

More recently, analysts alleged that the Chinese government has been sterilizing women in Xinjiang, which is a province with a large population of Uyghur Muslims.

The Defense Advanced Research Projects Agency (DARPA) has also gotten involved in the research. The [University of California, Davis](#) has been working on a DARPA-administered project that is creating the first prototype of a self-



disseminating vaccine designed to induce a high level of herd immunity against the Lassa virus and Ebola.

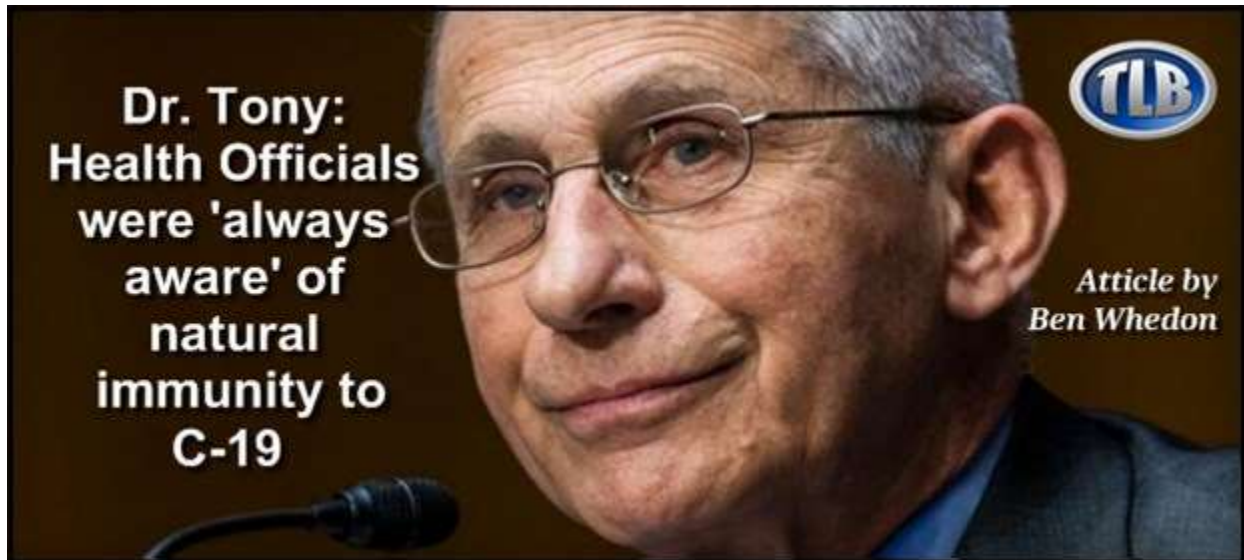

National Institute of Allergy and Infectious Diseases Director Dr. Anthony Fauci on Monday said health officials knew during the COVID-19 pandemic that contracting the disease ultimately offered a degree of natural immunity to it.

*"We were always aware that if you get infected, you have a degree of protection against reinfection,"* he told reporters, per the Epoch Times.

Critics of Fauci's push for nationwide vaccinations long argued that natural immunity offered protection against the virus and thus individuals who contracted COVID-19 didn't need to opt for one of the nation's authorized vaccines.

The NIAID director clarified that the natural immunity to COVID-19 becomes less effective over time and was not comparable to the protections one develops after contracting polio, smallpox, or measles.

At the height of the pandemic, Fauci was a high-profile advocate for strict lockdown measures and mask mandates. He often pushed the receipt of both initial vaccines and booster shots despite NIAID researchers discovering that

natural immunity led to stronger antibody responses than the Moderna mRNA vaccine.

Fauci has long drawn scrutiny, especially from Republicans, over his endorsement of strict COVID-19 policies. GOP leaders have long been open about their plans to investigate him and his agency over its handling of the virus and his public statements. Kentucky Republican Sen. Rand Paul on Monday said *“one way or another, if we are in the majority, we will subpoena his records and he will testify in the Senate under oath.”*

### **Martial Law alert: Alex Jones exposes HR 4350 amendment that will give Joe Biden dictatorial powers**

*“This [un-American amendment](#) will fundamentally and irreparably erode Congress’ constitutional oversight responsibility,”* said New York Representative Elise Stefanik, a member of the Armed Services Committee and chairwoman of the House Republican Conference.

She added that House Democrats led by Schiff are attempting to cover up for the national security crises of the weakest commander-in-chief in U.S. history.

*“Schiff got no attention until over the weekend. The Democratic Party controls the House and Senate to say no oversight over the U.S. military and domestic operations.
