Dr. Sherri Tenpenny was one of the first to point out that the Covid-19 Vaccines were "Gene" Therapy and killing machines!

Dr. Sherri Tenpenny has mapped out ten mechanisms of action for how the mRNA vaccine is going to kill people. She says, *"When you inject the mRNA, the Messenger RNA starts to code for the spike protein...the NIH is now fighting with Moderna over*

patent rights, because you can't patent anything that's out in nature, so they had to manipulate the spike protein, in order to be able to patent it and then make an antibody to the spike protein."

"Well, this anti-spike protein antibody is deadly. It's absolutely deadly. And the first three papers I went through, I found that one of the things the spike protein does is it directly attacks lung tissue and breaks it down."

"The second thing that it does is it inhibits your M2 macrophages, which are your anti-inflammatory macrophages, so you get cytokine storm and you die."

"The third is that when that Messenger RNA goes in and makes an antibody to the spike protein, it binds it loosely, carries it into a cell and causes permanent replication. So it's like having an "On" button with no "Off" button. You're constantly making this little piece of protein develop more spike proteins against it, make more destruction."

"And then, with this paper that I read last night, of this anti-spike protein, it attacks the astrocytes and the oligodendrocytes, which are two different kinds of cells in your brain. Two different kinds of central nervous system [cells]. It attacks the inner mitochondria membrane, in two different mechanisms and it attacks this neuro-filament protein, which are the motor nerves, which suddenly –we've seen those people [with strong tremors], it's because the spike protein antibody is affecting their motor neurons and their central nervous system."

"And then the primary, number one symptom that people have after they get this vaccine is debilitating fatigue, that they can't even function in the main part of their lives. Well, it's because the spike protein antibody attacks the mitochondria and it attacks the GAD 65, which is the intracellular antigen inside of your mitochondria and it can also attack you pancreas."

"If you're diabetic, it'll make your diabetes worse. If you're not diabetic, it can cause you to have diabetes, stiff-person syndrome, cerebellar ataxia, which is what thing that you're watching [massive tremors]; people not able to walk."

"In the experiment that they did, they took different tissue antigens, like skin and lung and all this other stuff and then they dropped the serum that had the antibody all over it. 27 out of 55 of the tissue types reacted adversely to the spike antibody."

"So you get this vaccine, you create this antibody, that's why in the most recent VAERS report that came out this week, 181 deaths, already that have been reported and when you start reading through them, you kind of lay out what these antibodies do, you can see it, right in the VAERS report, what has happened to these people and it's the anti-spike antibody that's attacking them and that's why the most number of deaths occurred about 19 days after the injection, because it takes a while to develop the antibody response. It doesn't happen just like that."

"Unless you have an anaphylactic reaction – probably to the polyethylene glycol– unless you have an immediate reaction to it, the delayed reaction is going to start – it takes a while – I talked to a bunch of epidemiologists in Europe and they said that it takes about 48 weeks to really see the most profound effects of autoimmune disease."

"When I found the first four mechanisms of action, I said to a few friends of mine, 'This is a perfectly-designed kill machine'."

"Perfectly-designed, because – the other thing is with that replicating thing, because with the vaccine, you're going to see mutants [of COVID]. So now, we're all talking about the mutants. The one thing they're not asking these people, who've been diagnosed with this mutant strain, is 'Have you had one of the not-approved vaccines?' Nobody's putting that together."

"So, yes, 48 weeks – so it's somewhere between 48 weeks, so it's about a year and 6 to 7 months and a couple of years into the future."

[[[Note this time span above, as several microbiologists and researchers suggest those taking the “gene” therapy shots will die within 18 months. Early reactions from the shots are confirming this reality. Sources I consult go so far as to suggest dementia and Alzheimer’s begin to appear in those taking the jabs within the first year. This is not a scare tactic but has actually been encountered over a decade ago. Dr. Ben Carson, President Trump’s Secretary of HUD, a well-known brain surgeon, once encountered this with a teenager he was getting ready to perform brain surgery on. Dr. Carson was so shocked to discover the young man’s brain had turned to mush. This “sponge form” was a prions disease.

The CDC describes prions disease as:

“Prion diseases or transmissible spongiform encephalopathies (TSEs) are a family of rare progressive neurodegenerative disorders that affect both humans and animals. They are distinguished by long incubation periods, characteristic spongiform changes associated with neuronal loss, and a failure to induce inflammatory response.

The causative agents of TSEs are believed to be prions. The term “prions” refers to abnormal, pathogenic agents that are transmissible and are able to induce abnormal folding of specific normal cellular proteins called prion proteins that are found most abundantly in the brain. The functions of these normal prion proteins are still not completely understood. The abnormal folding of the prion proteins leads to brain damage and the characteristic signs and symptoms of the disease. Prion diseases are usually rapidly progressive and always fatal.”

Several experts are now reporting many side effects and pointing to prions, and familiar symptoms with women who have taken the shots.

You may have heard of the bovine condition known as “Mad Cows Disease” or “Chronic Wasting Disease”. In humans they include “Creutzfeldt-Jakob Disease” and “Kuru” also

known as cannibalism or eating human brain tissue. Over the past five years in my research on Mycoplasma there appears to be a suggestive link (causal in nature) with the weaponized version of Brucellosis Mycoplasma and many named diseases. Unfortunately, the military secrecy over the weaponization of Brucellosis Mycoplasma information has slowed down my investigation of the pathogen. If you have read my articles on Mycoplasma, then you know I was specifically investigating the role of 5G wireless communications as a biological switch that activates this “decomposition” gene. The human body is a highly sophisticated bio-chemical-electrical entity.

What many microbiologists and researchers are claiming, and the different kinds of side-effects are indicating will happen, is that what will happen to those who have received the mRNA “gene” therapy will begin to manifest symptoms in a matter of months. Whether this is “accidental” or “intentional” is an entirely different issue. My sources are referring to it as a genocidal “Depopulation” event and that it will become evidently so if the powers at be continue to push the vaccination program well past summer. The evidence for their assumption is based upon the fact that a person’s reproductive system is being noticeably affected. Several experts in their own fields are saying this is an effort to sterilize women. Statistically speaking, more women than men have taken the shots, and one source says that if more than half of the U.S. female population takes the jab, there might be a potential extinction of the human species.]]] Dr. Sherri Tenpenny, a Christian, medical practitioner in the Cleveland, Ohio area closes her remarks here.

"So, like you were talking about the girl with meningitis vaccine? This is going to be even worse. So people have got to make some serious spiritual decisions about this...Are you going to say, 'Oh, I want to get the vaccine so I can get on an airplane,' or 'So I can go out to eat,' or I can keep my job.' That gets a little harder. Or 'So I can continue in professional school,' which gets a little bit harder."

"People are going to have to start making some really hard spiritual decisions about this."

THE GATES FAMILY – EUGENICS and Covid-19: We Cannot Fully Understand Bill Gates Until We Know About His and His Father's Agenda to "Depopulate" Our World!

In a recent candid interview, Bill Gates outlined that, despite the comparatively small threat of Coronavirus, he and his colleagues "don't want a lot of recovered people" who have acquired natural immunity. They instead are hoping we become reliant on vaccines and anti-viral medication.

Shockingly, Gates also suggests people be made to have a digital ID showing their vaccination status, and that people without this "digital immunity proof" would not be allowed to travel. Such an approach would mean very big money for vaccine producers.



On March 24, 2021 Bill Gates gave a highly revelatory 50-minute interview (above) to Chris Anderson. Anderson is the Curator of TED, the non-profit that runs the TED Talks...

At the 33:45 time stamp point, Gates drops this bomb:

"We don't want to have a lot of recovered people [...] To be clear, we're trying - through the shut-down in the United States - to not get to one percent of the population infected. We're well below that today, but with exponentiation, you could get past that three million [people or approximately one percent of the U.S. population being infected with COVID-19 and the vast majority recovering]. I believe we will be able to avoid that with having this economic pain."

It appears that rather than let the population be exposed to the virus and most develop antibodies that give them natural, long-lasting immunity to COVID-19, Gates and his colleagues far prefer to create a vast, hugely expensive, new system of manufacturing and selling billions of test kits, and in parallel very quickly developing and selling billions of antivirals and vaccines.

And then, when the virus comes back again a few months later and most of the population is unexposed and therefore vulnerable, selling billions more test kits and medical interventions.

Right after that, at 34:14, Gates talked about how he sees things rolling out from there.

“Eventually what we'll have to have is certificates of who's a recovered person, who's a vaccinated person [...] Because you don't want people moving around the world where you'll have some countries that won't have it under control, sadly. You don't want to completely block off the ability for people to go there and come back and move around. So eventually there will be this digital immunity proof that will help facilitate the global reopening up.”

[Sometime on the afternoon of March 31 the last sentence of this quote was edited out of the official TED video of the interview. Fortunately, recordings of the complete interview are archived elsewhere.]

In the October 2019 Event 201 novel-corona virus-pandemic simulation co-sponsored by the Bill & Melinda Gates Foundation, the World Economic Forum and a division of the Johns Hopkins Bloomberg School of Public Health, a poll that was part of the simulation said that **65%** of people in the U.S. would be eager to take a vaccine for COVID-19, *“even if it's experimental.”*

This will be tremendously lucrative.

Vaccines are very big business: this February 23, CNBC article, for example, describes the vaccine market as six times bigger than it was 20 years ago, at more than \$35 billion annually today, and providing a \$44 return for every \$1 invested in the world's 94 lowest-income countries. That's a huge reason to push, even mandate vaccines, regardless of their being “experimental”. The most recent figure that I have seen in print is \$80-120 billion.

Notably, the Bill & Melinda Gates Foundation - which has an endowment of \$52 billion - has given more than \$2.4 billion to the World Health Organization (WHO) since 2000, according to a 2017 *‘Politico’* article. (While over the same time frame countries have reduced their contributions to the world body, particularly after the 2008-2009 depression, and now account for less than one-quarter of the WHO's budget.) The WHO is now coordinating approximately 50 groups around the world that are working on candidate vaccines against COVID-19.

The *'Politico'* article quotes a Geneva-based NGO representative as saying Gates is *"treated liked a head of state, not only at the WHO, but also at the G20,"* and that Gates is one of the most influential people in global health.

Meanwhile, officials around the world are doing their part to make sure everyone social distances, self-isolate and/or stays locked down. The problem is that as a whole, the recovery rate for the alleged Covid-19 is 99.93%. In the U.S., the last day this year we had a death count larger than 1 per county in the U.S. was February 13th at 5,443. Even that specific date is miss-leading. The CDC reported an additional 2,000 deaths from Ohio that had been previously unreported. Did those 2,000 deaths die of Covid or with Covid? As hind sight has shown, the government inflated their numbers with an obvious agenda of misleading the public into taking a vaccine through fear-driven propaganda.

Think about this unmentioned statistic. Put it into perspective. The U.S. has 3,242 counties [100 of those are in the Territories] and for 64 days straight, deaths attributed to Covid-19 has been less than 1 per county. I live in a county of 45,000 residents The U.S. has 43 counties with a population larger than 1-million residents. Folks, this is not about a rogue virus. It is much more diabolical than anyone can imagine! I've been educated and trained in doing statistical analysis and so I can state unequivocally that the public has been lied to from the very beginning. Society has been fed with all kinds of lies, disinformation and deceptions, from the media, the medical world, and certainly the government health agencies. I have thousands of documents and files to back up what I am saying regarding this global scam being used to bring into power as the New World Order.

There is another fact that you are not hearing about yet which is every bit as relevant and significant in this plandemic. This year, the public health agencies suddenly stopped counting/reporting deaths attributed to the seasonal flu. For decades the pharmaceutical industry has made a big deal out of promoting a vaccine for the flu, except this past flu (2020/2021) season. Preliminary data for all deaths do not show any increase in the number of deaths, when comparative flu seasons are accounted for in the data. This is also true for the previous flu season of 2019/2020 when Covid data entered the picture at the closing end of the seasonal flu period. It is evident that the public health agencies and medical profession as a whole are manipulating the statistics to show justification for a global need for vaccination against an imaginary virus that more than 40+ countries have not been able to prove exists.

We have read articles ad nauseam about Covid-19 and the vaccines. But we must first understand the man, Bill Gates and his father to fully appreciate what is happening in our world today. It will help you to understand the agenda of these people.

And it will also help you in making a decision to receive the vaccine or not. Their agenda is NOT about helping people with vaccines. The agenda is all about world "depopulation" through sterilization.

The Gates Family, Eugenics and Covid-19

In the following, Ethan Nash examines links between Covid-19 ‘solutions’ and social eugenics movements, including Bill Gates Senior and Planned Parenthood, the Gates Foundation and philanthropy deceptions, vested vaccine interests and engineering a pandemic.

THE EUGENICS MOVEMENT

In the late 19th century — a critical time in development of the sciences — British scholar Sir Francis Galton, in his book *‘Inquiries into Human Faculty and Its Development’*, coined the term ‘eugenics’.

Galton, whose cousin was Charles Darwin, hoped to ‘better humankind’ through the ‘science of improving the human species’ by selectively mating people with specific desirable hereditary traits.

Decades of research on ‘controlled breeding’, including through means of sterilization, soon became **accepted mainstream science** at the turn of the century and the **eugenics movement** was born.

Supporters of eugenics believe people inherit mental illness, criminal tendencies and even poverty, and that these conditions can be ‘bred out’ of the human gene pool through forced sterilization. Not surprisingly, ‘undesirable’ traits were concentrated in poor, uneducated and minority populations.

Many professionals in the scientific and biological fields rigorously researched ways to ‘improve the human race’ through means of eliminating these ‘negative traits’, and the movement would soon garner widespread political support — particularly in Australia.

As we have explored, the likes of Professor Richard Berry and growing *Eugenics Societies of NSW* and *Victoria* played a pivotal role in mass campaigns for laws allowing the establishment of a “*lethal chamber*” to euthanize what these groups called “*the grosser types of our mental defectives*”.

Following World War I, numerous eugenics-based ideologies were beginning to enter mainstream societies across the world. However, after Hitler would adopt these concepts and implement an aggressive form of the concept, the world grew sour and a new change was needed to continue.

CULTURAL MARXISM

The concepts of eugenics were not exorcised from Western thinking following World War II, rather, they went underground or and were reinvented by assuming more “compassionate” guises.

Julian Huxley’s **significant contributions** to the movement ensured that the underlying notions associated with eugenics would transform and continue into new social movements.

During the 1950s, these groups would re-define eugenics as ‘socially progressive’, with linkages to the newly formed and comprehensive welfare states that offered ‘solutions’ to poverty and disease.

The Rockefeller Foundation **heavily financed the modern eugenics movement** and think-tanks such as the **Tavistock Institute** would give birth to many influential individuals and ‘social’ organizations.

Huxley adeptly associated the ‘new and modern’ eugenics movement with a range of reformist ideologies, such as the **popularization of birth control**, the decriminalization of homosexuality and abortion law reform. He described this process as “*eugenic modernization*”.

The basic premise remained the same, however: it is far *easier* to eliminate the poor and the suffering, than it is to eliminate the complex and tenacious sources of their poverty or their suffering. These people believe the masses are too moronic to govern themselves.

A plethora of new-age organizations and movements would arise during [the era of ‘counter-culture’](#), and this ‘progression’ continued, the now-notorious Gates family would soon enter the picture.

BILL GATES SENIOR AND PLANNED PARENTHOOD

The key to understanding Bill Gates’ exposure to eugenic concepts is to trace his family past.

Bill Gates’ father, William H. Gates, Sr., was a prominent banker and a lawyer in Preston Gates & Ellis. He also presided over many bar associations, organization boards and started the Technology Alliance — a regional push to expand technology-based jobs throughout the 20th century.

Importantly, Gates Sr. served on the board of [Planned Parenthood](#) (PP) during the group’s infancy — a re-branded organization birthed out of the [American Eugenics Society](#).

The company spread from beginnings in Cold Spring Harbor genetics and virology labs on Long Island and Berlin, to today become one of the largest organizations in the U.S. Rockefeller-Bayer Co., BASF and Hoechst petrochemical-pharmaceutical consortium were all initial funders of the group.

Make no mistake: Planned Parenthood [was built on population control schemes](#) — allied with the same groups who wanted genetic hierarchy laws to ‘preserve’ humanity and who sought to ‘beautify’ countries by stopping the “unfit” from reproducing.

In their [2014 Annual Report](#), the pro-abortion and anti-family group reported seeing over 2.5 million patients in over 4 million clinical visits, including 324,000 abortions. The

group claims to be a proponent of 'free choice', yet it is a eugenics front organization in disguise.

Planned Parenthood has recently gone through their second executive in just eight months, after sacking President Leana Wen for daring to suggest the group should focus more on women's health.

Does this sound like a group that dedicated to improving society? This one showdown revealed a genuine rift in the organization and a simple truth: promoting 'women's health' was always a cover.

Bill Gates proudly speaks on his father's involvement on the board of Planned Parenthood, which was founded on the concept that most human beings are just "*reckless breeders*". Gates' father would take the concepts learned at Planned Parenthood and incorporate them into building the foundational blueprint for a new era of philanthropy activities that remain to this day.

THE GATES FOUNDATION

William Gates Senior. would continue his eugenacist efforts by becoming instrumental in the formation of a new philanthropic brainchild called the William H. Gates Foundation in 1994.

The group, like Planned Parenthood, would first focus on 'improving' reproductive and child health in the developing world. After pioneering philanthropist activities, the company merged with the new Gates Learning Foundation to create the Bill & Melinda Gates Foundation in 2000.

The methodologies have evolved leaps-and-bounds since the early formation of the movement; however the objective remains the same. This time, the new multifaceted approach would see the philanthropist group partner with powerful United Nations organizations like the World Health Organization (WHO) and UNICEF.

Today, the group is focused on many areas that drive continued work across the world. These activities have given birth to new forms of technological, eugenic endeavors.

The organization is simply continuing the Gates family legacy of trying to dominate and control the world's systems, including in the areas of technology, medicine and now agriculture.

In 2010, the Bill & Melinda Gates Foundation purchased 500,000 shares in Monsanto valued at more than \$23 million. This is when it became abundantly clear that the so-called benevolent charity is up to something other than 'eradicating' disease and feeding the world's poor.

The evidence that GMOs cause disease has been piling up for decades, as the list of countries banning their import and cultivation grows. Bill openly promotes GMOs as the

'answer' to world hunger, but many think this is in exactly the same vein as when the British Army handed small pox-infested blankets out to desperate American Indians during the French and Indian War.

Melinda Gates has also made 'women's issues' one of the top priorities for their philanthropic work. This includes the decision to elevate contraception-promotion and population control as "*arguably the single-most important part of her work*". She has been openly criticized for these moves.

In 2017, the Gates Foundation pledged another \$375 million for 'family planning', with the goal of providing contraception to 120 million women across the world, particularly in developing countries.

This emphasis on blanketing developing countries with artificial contraception for which women aren't asking for reeks of social engineering and paternalistic eugenicist thinking.

The fact that couples in developing countries often desire and *value* large families means nothing to many Western elitist philanthropists: the not-so-subliminal underlying presumption is that women who desire large families simply don't *know* what's good for them. As such, they need to be educated and 'encouraged' with large-scale, foreign-funded advertising companies and coercion.

Now that we have explored the history of the Gates family, influences and aims of philanthropist philosophies and modern eugenics programs across the world, let's explore the relatable picture.

BILL GATES AND VACCINES

Bill Gates needs no introduction. He is one of the most influential Polyergus (parasite) of all time. For 25 years, he has controlled what has grown to become a multibillion-dollar colossus, Microsoft, and made himself one of the richest men in the world. The tech world was largely born through Gates. He accomplished this feat not by inventing new technology, but by taking existing technology, adapting it to a 'specific market', and then dominating that market.

In recent years, Gates has turned a good deal of his attention towards philanthropy by creating the largest private foundation in the world, with over \$46 billion in assets. He has secured billions of dollars in contributions from other wealthy benefactors such as Warren Buffett, and is primarily dedicated to 'enhancing healthcare' and 'alleviating poverty' across the world.

Bill Gates is heavily involved in development of new vaccines, as well as 'forecasting' international health challenges of tomorrow (such as preparing for epidemics), and works beyond the scope of national oversight and accountability in most cases.

He has spent years involved in the vaccine-manufacturing process, including quality control and clinical evaluation. This understanding has allowed Gates to 'advise' vaccine development programs and fund research into new areas of innovation for multiple disease programs:

Gates invests in expertise and platform technologies that help us make vaccines faster, 'better' and cheaper, in addition to also investing in numerous education and training programs to ensure that knowledge around vaccines is created, shared and retained. Some examples of this include:

- Adaptive trial designs.
- Streamlining the schedule and dosing of vaccines.
- Novel delivery formats for vaccines.
- Modular, automated manufacturing platforms enabling small-batch vaccine production.

The billionaire [was an early investing partner](#) in the [Global Alliance for Vaccines and Immunization](#) (GAVI), which has now grown a substantial portfolio of public-private international health partnerships that are committed to increasing access to immunization.

Today, GAVI has grown significantly. The group brings together developing country and donor governments (including Australia), the World Health Organization, UNICEF, the World Bank, the vaccine industry, research and technical agencies, civil society and other private philanthropists.

The Bill and Melinda Gates Foundation has donated \$1.56 billion to the alliance's 2016-2020 strategic period as of March 2019, and continues to advise the group on key business decisions.

Gates heavy involvement in the vaccine industry, in addition to continuing the eugenicists visions of the 'social' reformation, was fundamental in framing his positive public perception on the matter.

Considered a 'hero' in the fight to develop new technologies against growing diseases, the stage had now been set for Gates to become the new 'go to' voice if a pandemic was to ever break out.

COVID-19: A PLAN-DEMIC? 'PREDICTING' AN OUTBREAK

The Microsoft co-founder has hinted on multiple occasions [over the past decade](#) that the potential for something like the coronavirus that would soon arise and the world must be 'ready'.

In 2015, Bill Gates gave a TED Talk titled, [The next outbreak? We're not ready](#), which is being shared widely online in recent weeks given the impact of COVID-19 across the world.

The part of the talk that's [making rounds online](#) shows Gates explaining that while the greatest threat to humanity when he was growing up was nuclear war, the greatest threat now is a virus:

“If anything kills over 10 million people in the next few decades, it’s likely to be a highly infectious virus rather than a war. Not missiles, but microbes.”

However, as we have explored, there is no fundamental evidence to suggest a threat from the Corona Hoax, which has been invented as a means to usher in further mechanisms of control.

Rather, through these ‘cryptic’ messages, Gates was positioning himself in a positive light to connect with the public psyche. If something was to happen, ‘Gates would know the solution!’, they will cry. The facts and data regarding Covid-19 simply belie this panicked rhetoric of Bill Gates. His emphatic plea really suggests a disingenuous motive behind the smiling face of a con artist.

EVENT 201

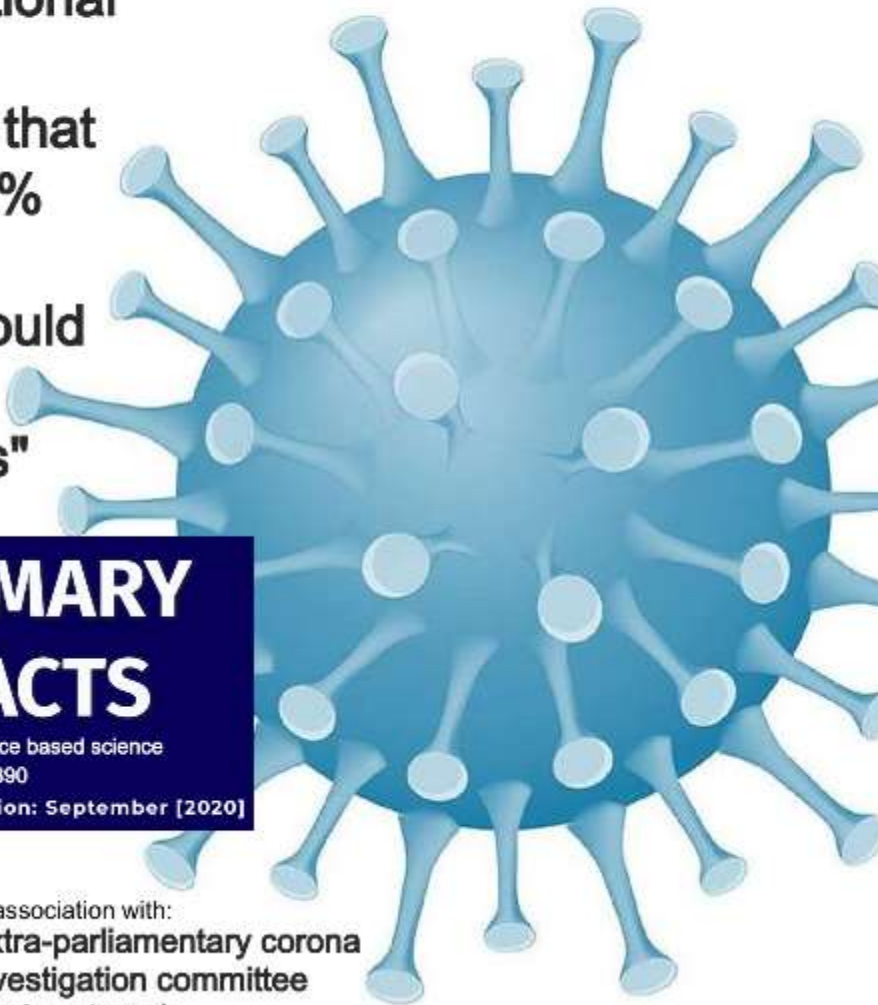

THE 'ONLY WAY OUT'

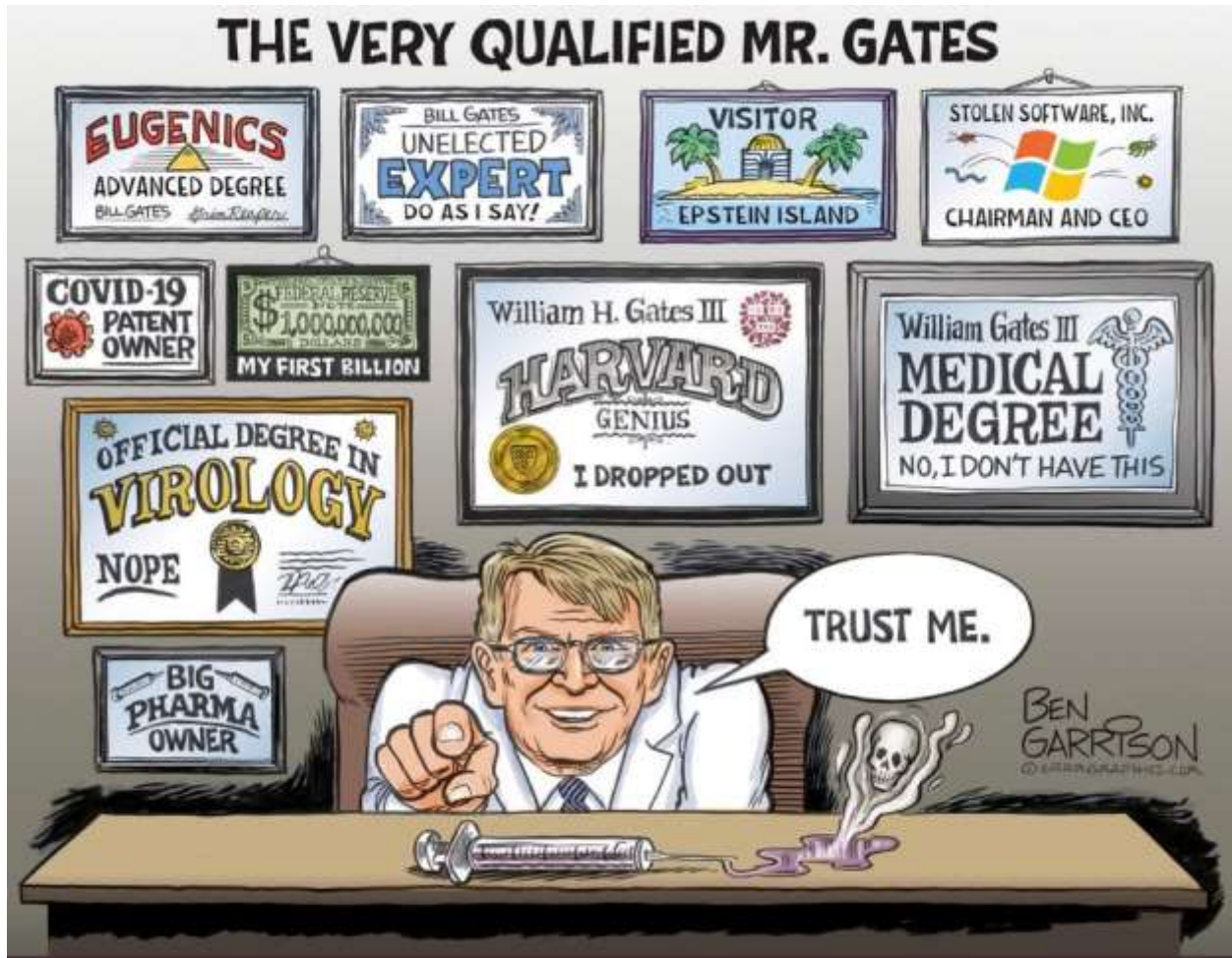

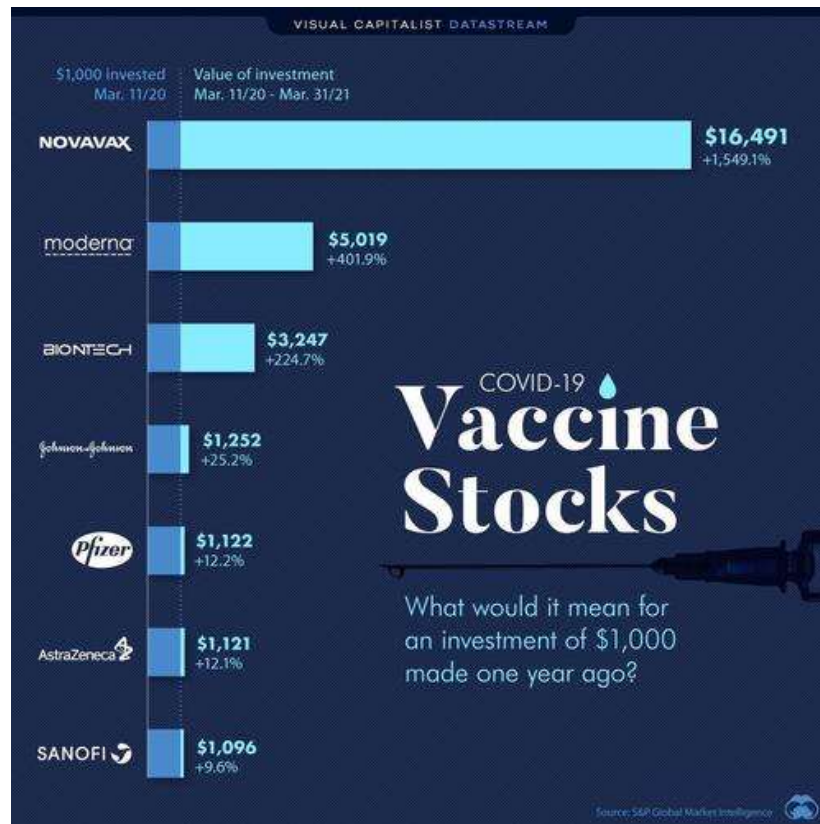

CDC Investigating 3 Deaths After J&J Vaccine, New VAERS Data Include 584 More Reports of Deaths After COVID Vaccines

VAERS data released today showed **86,080 reports of adverse events** following COVID vaccines, including **3,186 deaths** and **10,152 serious injuries** between Dec. 14, 2020 and April 16, 2021.

Data released today by the Centers for Disease Control and Prevention (CDC) on the number of injuries and deaths reported to the Vaccine Adverse Event Reporting System (VAERS) following COVID vaccines showed a notable increase in reports of injuries and deaths compared with last week's numbers.

VAERS is the primary government-funded system for reporting adverse vaccine reactions in the U.S. Reports submitted to VAERS require further investigation before a causal relationship can be confirmed.

Every Friday, VAERS makes public all vaccine injury reports received as of a specified date, usually about a week prior to the release date. Today's data show that between Dec. 14, 2020 and April 16, a total of **86,080 total adverse events** were reported to VAERS, including **3,186 deaths** — an increase of **584** over the previous week — and **10,152 serious injuries**, up 1,867 since last week.

Of the 3,186 deaths reported as of April 16, 26% occurred within 48 hours of vaccination, 17% occurred within 24 hours and 41% occurred in people who became ill within 48 hours of being vaccinated.

In the U.S., 202.3 million COVID vaccine doses had been administered as of April 16. This includes 89 million doses of Moderna's vaccine, 105 million doses of Pfizer and 8 million doses of the Johnson & Johnson (J&J) COVID vaccine.

This week's VAERS data show:

- 20% of deaths were related to cardiac disorders.
- 54% of those who died were male, 44% were female and the remaining death reports did not include gender of the deceased.
- The average age of death was **75.9** and the youngest death reported was an 18-year-old. There are a few reported deaths in children under 18, including a 5-month old who died of a rare blood clot two days after the mother received her second dose of Pfizer vaccine and a 2-year-old, but these reports have not been confirmed.
- As of April 16, **462 pregnant women** reported adverse events related to COVID vaccines, including **132 reports of miscarriage or premature birth.**

- Of the [820 cases of Bell's Palsy reported](#), 55% of cases were reported after [Pfizer-BioNTech](#) vaccinations, 41% following vaccination with the Moderna vaccine and 24 cases (6%) of Bell's Palsy were reported in conjunction with J&J.
- There were [92 reports of Guillain-Barré Syndrome](#) with 50% of cases attributed to Pfizer, 40% to Moderna and 13% to J&J.
- There were [24,841 reports of anaphylaxis](#) with 43% of cases attributed to [Pfizer's vaccine](#), 47% to [Moderna](#) and 10% to [J&J](#).

New reports of blood clots as CDC panel votes to resume J&J vaccine

Blood clotting disorders have been reported following vaccination with [Pfizer](#), [Moderna](#), [AstraZeneca](#) and [J&J](#) COVID vaccines. In the U.S., the J&J vaccine, marketed under the company's Janssen subsidiary, was [paused](#) April 13 while U.S. health officials investigated reports of rare blood clots.

The CDC's Advisory Committee on Immunization Practices (ACIP) [Friday voted](#) 10 – 4 to lift the pause and recommended continued use for persons 18 years of age and older. The panel did not recommend adding any [extra warning](#) about the risk of rare blood clotting disorders.

The ACIP [said](#) the link between blood clots and J&J's COVID vaccine was "plausible," but concluded the vaccine's benefits still outweigh the risks. The recommendation by the ACIP has to be approved by the CDC and the U.S. Food and Drug Administration (FDA) before becoming official government policy, [USA TODAY reported](#).

The [Daily News reported](#) today the CDC is investigating the deaths of two more women from a rare blood clotting disorder possibly linked to the J&J vaccine. The CDC's advisory panel found 15 women who were diagnosed with rare blood clots, including three deaths, seven who remain hospitalized and five recovering at home, according to a [slide presentation](#) shared at today's committee meeting.

Ask Congress to Investigate COVID Origins - Take Action

Only two of the women were older than 50, with the risk highest in women ages 30-39, according to the CDC's Advisory Committee on Immunization Practices. The findings appear to confirm the suspicion that younger women are more vulnerable to developing blood clots.

The Hill reported today the CDC is reviewing the death of an Oregon woman who died after receiving J&J's vaccine. The woman, in her late 50s, was vaccinated before the state issued a pause. Two weeks after receiving the vaccine, she developed a rare but serious blood clot associated with very low platelets. The Oregon Health Authority said it was notified about the death on April 20, two days after the CDC was notified on April 18.

U.S. health authorities also are investigating the report of a Texas woman who was hospitalized after receiving J&J's vaccine. The Department of State Health Services told The Hill in a statement that the CDC notified state officials on Wednesday afternoon of a

“possible case in Texas reported through VAERS. Symptoms reported “appear to be consistent with the six cases reported elsewhere last week,” the department said.

On April 21, The Defender reported that a Nevada teen underwent three brain surgeries to repair blood clots she developed about a week after receiving J&J’s COVID vaccine. Emma Burkey, 18, [suffered seizures](#), was placed in an induced coma and on a respirator before undergoing surgeries for a massive brain injury.

Burkey was one of the initial six cases under review by the CDC. A CDC panel [said](#) Burkey and other women experienced headaches and back pain prior to the discovery of blood clots, and also disclosed she was given heparin, a blood thinner which typically is standard treatment for blood clots, but in cases like Burkey’s, can make the condition worse.

Children’s Health Defense queried the VAERS data for a series of adverse events associated with the formation of clotting disorders and other related conditions. VAERS yielded a total of 1,123 reports for all three vaccines from Dec. 14, 2020, through April 16.

Of the 1,123 cases reported, there were [512 reports](#) attributed to Pfizer, [448 reports](#) to Moderna and [160 reports](#) to J&J — far more than the six J&J cases U.S. health officials were originally investigating.

As The Defender reported April 20, the European Medicines Agency (EMA) said Tuesday it found a “possible link” between the J&J COVID vaccine and blood clots, but concluded the vaccine’s benefits outweigh the risks.

[EMA’s safety committee](#) (PRAC) [said](#) a warning should be added to the [product label](#), but the blood clot-related disorders should be listed as “very rare” side effects of the vaccine. J&J had delayed the vaccine’s rollout in the EU after U.S. health officials [paused](#) the vaccine.

Woman paralyzed after Pfizer vaccine

The Defender [reported this week](#) that a healthy 33-year-old woman in Pennsylvania experienced paralysis 12 hours after getting her first dose of the Pfizer COVID vaccine. Doctors at the Cleveland Clinic performed a series of tests, but said they didn’t know what caused the woman to develop paralysis.

Although the woman, who asked to remain anonymous, regained feeling and strength in her arms, as of April 21, she had no function from her lower chest down besides very slight movement in a few toes. The woman’s family confirmed with [Channel 11](#) that her case was reported to [Pfizer](#).

CDC ignores The Defender, no response after 46 days

According to the [CDC website](#), “the CDC follows up on any report of death to request additional information and learn more about what occurred and to determine whether the death was a result of the vaccine or unrelated.”

[The Defender](#) reached out to the CDC on March 8 with a written list of questions about reported deaths and injuries related to COVID vaccines, the status of ongoing investigations reported in the media, if autopsies are being done, the standard for determining whether an injury is causally connected to a vaccine and education initiatives to encourage and facilitate proper and accurate reporting.

After repeated attempts to obtain a response, a representative from the CDC’s Vaccine Task Force contacted us March 29 and said she had never received our list of questions — even though employees we talked to several times said their press officers were working through the questions and confirmed the representative had received them. We provided multiple deadlines, none of which were met. The Defender also provided the list again and attempted to follow-up multiple times with no response.

After repeated calls to the CDC’s media department this week, we were told the COVID response unit would be informed we had still not received answers. The person we spoke with did not know why our inquiries were being ignored. We also asked why the CDC appeared to have the ability to respond to other news media outlets in a timely manner and questioned why the agency, funded by taxpayer dollars, appeared to be selectively responding to inquiries. No answer was provided.

We were told someone would get back to us. It has been 46 days since our original email was sent inquiring into VAERS data and reports.

New study shows Pfizer’s COVID vaccine may trigger herpes virus that causes shingles

The Defender also [reported this week](#) that Pfizer’s COVID vaccine may trigger a herpes virus that causes shingles. A recent [study](#) published in the journal *Rheumatology* found six women out of 491 patients developed a skin rash known as herpes zoster (HZ) infection — or shingles — within three to 14 days of receiving either the first or second dose of the Pfizer’s COVID vaccine. Five of them developed shingles infection after the first dose and one after the second.

Lead researcher Dr. Victoria Furer said five of the six patients were young, had mild cases of autoimmune disease and were taking little if any medications for it — which means they should not have been at increased risk for developing the infection, as HZ tends to develop more in people over the age of 50.

“We cannot say the vaccine is the cause at this point,” Furer said. “We can say it might be a trigger in some patients.” She said further research, including a larger epidemiological study, would be needed to prove cause and effect.

Third dose of COVID vaccines and annual boosters are on the way

The Defender reported this week, vaccine makers told investors and the media that COVID booster shots are in the works. But some independent scientists warn trying to outsmart the virus with booster shots designed to address the next variant could backfire, creating an endless wave of new variants, each more virulent and transmissible than the one before.

Dr. Ozlem Tureci, co-founder and CMO of BioNTech, which developed the vaccine with Pfizer, said she also expects people will need to get vaccinated against COVID annually, like the seasonal flu. That's because, she said, scientists expect vaccine-induced immunity against the virus will decrease over time, [CNBC reported](#).

Tureci's comments came after Pfizer CEO Albert Bourla said in an interview that aired April 15 that people would likely need a booster shot, or third dose, of the COVID vaccine within 12 months of getting fully vaccinated with possible additional shots each year.

J&J vaccine manufacturer Emergent BioSolutions shuts down

The Defender reported this week a J&J COVID vaccine manufacturing plant, where an ingredient mix-up last month resulted in 15 million doses of J&J vaccine being discarded, may have contaminated additional doses. A report released Wednesday by the FDA also identified a series of other problems at the Baltimore facility owned by Emergent BioSolutions.

Emergent, which in June received [\\$628 million](#) in taxpayer funding through the U.S. Department of Health and Human Services to establish the primary U.S. manufacturing facility for J&J's and AstraZeneca's COVID vaccines, agreed this week to temporarily shut down operations.

A congressional investigation was launched Tuesday into the company's federal vaccine contract and shareholders filed a class action lawsuit Monday for false and misleading statements that drove up stock prices and misleading statements regarding the company's readiness to mass-produce COVID vaccines.

[According to CNBC](#), an FDA inspection of the Baltimore plant in April 2020 revealed Emergent lacked necessary personnel to produce a COVID vaccine. Another inspection, in June 2020, determined Emergent's plan for producing vaccines was inadequate due to poorly trained staff and quality control problems, raising questions as to why the company did not fix problems earlier and why federal officials who oversaw its contracts did not demand better performance.

A new report has determined the Pfizer vaccine can cause Alzheimer's and other conditions!

Similarly, the FUS protein is known to cause ALS and Hereditary Essential Tremors, according to the Human Genome Database.

The experiment done for the report was to determine whether or not these two harmful proteins embed themselves into our DNA, as an mRNA vaccine is expected to do. The report determined that *“the vaccine RNA has specific sequences that may induce TDP-43 and FUS to fold into their pathologic prion confirmations,”* meaning that both proteins have the potential to embed themselves into our DNA and cause harmful neurological diseases.

National File actually reached out to the CDC to inquire as to why the Pfizer vaccine is still being distributed despite these credible allegations. No response was received prior to publication.
