Documents leaked from the EMA confirms why we aren't allowed to analyze the vaccine vials.

It's like rolling the dice for what you get in your vial. Both the FDA and EMA knew this but kept this out of the public view because if it were known, nobody would take the vaccines.

One of my readers has been trying to get my attention for 8 months on the [EMA data leak that happened nearly 2 years ago](#).

He recently posted this [substack article](#) documenting his attempts to get visibility on what the EMA document leak revealed.

The gem in the article is this video which was posted 18 months ago that few people have seen. The [video is just 14 minutes long](#) and is very well done. The findings are all consistent with what I and others have long suspected: the vials are all different.

The key finding is the reason they won't let anyone analyze the vials: mRNA is not intact. The [BMJ wrote about this](#) on March 10, 2021 [my comments are in brackets]:

1. On Nov 23, 2020, EMA knew about the quality control issues with severely compromised mRNA integrity (ranging from 78% to 55%). [It's supposed to be 100% if you want an effective vaccine.]
2. Just two days later, a source in the US said the lots were now *"back at around 70-75%, which leaves us cautiously optimistic that additional data could address the issue."*
3. *"The complete, intact mRNA molecule is essential to its potency as a vaccine,"* professor of biopharmaceutics Daan J.A. Crommelin and colleagues *"wrote in a review article in The Journal of Pharmaceutical Sciences late last year."*
4. *The BMJ* asked Pfizer, Moderna, and CureVac, as well as several regulators, what percentage mRNA integrity they consider acceptable for vaccines against covid-19. None offered any specifics. [*"Wow, that's really comforting. <sarcasm off>"*]

5. The EMA told *The BMJ* that the levels of truncated mRNA *“and the amounts of a potential protein produced by the truncated mRNA would be too low to constitute a safety risk.”* [uh... how does the EMA know that exactly?]
6. Health Canada told *The BMJ* that Pfizer had conducted investigations into the root cause of reduced integrity in the commercial vaccine batches, and *“changes were made in their processes to ensure that the integrity was improved and brought in line with what was seen for clinical trial batches.”* Health Canada said the three agencies subsequently determined that *“there was no concern with the RNA integrity or any other product specifications.”* [Whew! Now I’m relieved! No data on the new levels produced. If you can’t trust Pfizer, who can you trust?]

In general, the BMJ wasn’t happy about anything they heard from the regulators. They were basically stonewalled in their requests.

The fact that it’s illegal for anyone to analyze the vials (they are government property) doesn’t help inspire confidence at all.

Even if you are getting 100% intact mRNA which would be really rare, you’re still not getting anything that resembles the virus. So the efficacy as far as PROTECTING you will be next to nothing. However, what it will do very effectively, if you got reasonably intact mRNA, is to cause you significant harm. You are playing a game of chance with your immune system and what is in the bottle.

The [video highlights](#) some of the things we learned from the EMA data breach:

1. The EMA claims the documents were manipulated to make them look bad, but won’t say how they were manipulated. I’m not buying the EMA story at all.
2. The Members of the European Parliament (MEP) weren’t allowed to read the contracts with the vaccine makers (only heavily redacted versions). Again, if you can’t trust Pfizer and the EMA, who can you trust?
3. The mRNA is unstable, even at the required temperatures because light, movement (like shipping it to a destination), and any temperature variation disrupts it.
4. Unstable mRNA means the spike protein (which was artificially propped up) could collapse making the whole process useless to support immunity, but still dangerous in terms of damage to cells. So you get all the risk and no benefit.
5. The mRNA integrity was better in the clinical trial than commercial batches. But don’t assume that the vaccine worked in the trials since the trials were heavily gamed to produce favorable outcomes, mostly by excluding people with weak immune systems from the vaccine group (this is why [there were 5X the number of exclusions in the vax group](#)). So you’re looking at a vaccine which likely does absolutely nothing except make

people believe they are protected. This mind control works quite well. People bought the story for over a year before they realized they were getting infected at the same rate as people who didn't get the vaccine.

6. The mRNA integrity varied between countries.
7. Pfizer never told anyone that the commercial vaccines had lower mRNA integrity than the vaccines used in the trials. This is unethical, bordering on fraud.
8. The EMA tried to cover it up. Instead of protecting the public and making Pfizer look bad, the EMA basically covered up the problem.
9. Pfizer never told the public or governments about the risks associated with mRNA integrity. If it wasn't for the leak, we'd never have known. But it's all OK because the drug companies are exempt from any liability. The patient takes all the risk here, not the drug companies.
10. EMA was concerned about visible particles in the vials. The BMJ never investigated that. Is it still a problem? I don't think anyone cares to know the answer to that.
11. The deaths in the trials are all dismissed as "*unrelated to the vaccine*" without doing the proper analysis.
12. There should be an investigation into these issues, but the governments are not going to expose their own fraud since it would be too embarrassing so nothing will happen.

Summary:

This video summarizing the leaked EMA documents constitutes yet more evidence that the vaccines confer no benefits, only risk.

However, like everything else, it will be ignored by the authorities.

Moderna Sues Pfizer Over Covid Vax Patents

COVID-19 vaccine maker Moderna is suing Pfizer and the German drug maker BioNTech, accusing its main competitors of copying Moderna's technology in order to make their own vaccine.

Moderna said Friday that Pfizer and BioNTech's vaccine Comirnaty infringes on patents Moderna filed several years ago protecting the technology behind its preventive shot, Spikevax.

The company filed patent infringement lawsuits in both U.S. federal court and a German court.

A Pfizer spokeswoman declined to comment, saying the company had not been served with a copy of the litigation.

Moderna and Pfizer's two-shot vaccines both use mRNA technology to help patients fight the coronavirus.

The mRNA vaccines work by injecting a genetic code for the spike protein that coats the surface of the coronavirus.

That code, the mRNA, is encased in a little ball of fat, and instructs the body's cells to make spike copies that train the immune system to recognize the real virus.

Moderna CEO Stephane Bancel said in a prepared statement that the vaccine developer pioneered that technology and invested billions of dollars in creating it. The company said it believes its rivals' vaccine infringes on patents Moderna filed between 2010 and 2016.

Attorney: Pfizer Vaccine Whistleblower False Claims Suit Payout could Reach \$3.3 trillion "It would be enough to bankrupt Pfizer,"

Pfizer cannot use the government as a shield from liability for making false claims about its COVID-19 vaccine, lawyers for a whistleblower argued in response to Pfizer's motion to dismiss a False Claims Act lawsuit.

"Respondents claim fraudulent certifications, false statements, doctored data, contaminated clinical trials, and firing of whistleblowers can be ignored based on the theory that they contracted their way around the fraud," lawyers for Brook Jackson, who worked as regional director at one of the clinical trials used to develop the Pfizer vaccine, wrote in their Aug. 22 [response](#).

“A drug company cannot induce the taxpayers to pay billions of dollars for a product,” they countered, “that honest data would show poses more risks than benefits, and that ignores the actual contract and the law itself.”

Jackson’s lawsuit alleges that Pfizer and two of its subcontractors violated the False Claims Act by providing bogus clinical trial results to garner the FDA approval of its COVID-19 vaccine.

Under federal law, individuals can sue on behalf of the government and win treble damages if they can prove an individual or company deliberately lied to the government.

One of Jackson’s attorneys, Warner Mendenhall, told *‘The Epoch Times’* that the payout could be as much as \$3.3 trillion.

“It would be enough to bankrupt Pfizer,” Mendenhall said.

Mendenhall, whose law firm has won multimillion-dollar False Claims Act cases, based his estimates on the more than \$2 billion the U.S. government has paid Pfizer for more than 100 million doses of its COVID-19 vaccine.

In motions to [dismiss the lawsuit](#), Pfizer and its subcontractors argued that besides Jackson’s allegations being false, the government, not a private citizen, can initiate a False Claims Act complaint and that the lawsuit against them should, therefore, be dismissed.

“The Relator may not pursue the claims against Pfizer without the Government first pursuing them in an administrative proceeding,” Pfizer’s motion states.

The companies also argued that the FDA was well aware of Jackson’s claims for at least two years before the lawsuit was filed against them and that it publicly responded to Jackson’s allegations by expressing the agency’s *“full confidence”* in the data used to support the vaccine.

However, Mendenhall said a false claims action is independent of the government’s knowledge and that Jackson only has to prove Pfizer and its subcontractors presented fraudulent information to the FDA.

Jackson was third in command of the clinical trials conducted by Ventavia Research Group as part of Pfizer’s application for emergency use authorization of its COVID-19 vaccine. She was there for only 18 days before being fired by Ventavia after reporting what she called *“absolute mayhem”* and an utter [disregard for safety protocols](#) and federal regulations in developing the vaccine.

Jackson has submitted over 400 exhibits as part of her complaint. Jackson said that a former Taco's cashier was among those tasked with injecting patients with the experimental jab. She alleged that the trial staff falsified patient signatures on informed consent paperwork. And she has described a daily mess of unsanitary conditions.

Jackson also responded for the first time to Pfizer's characterization of her as an anti-vaccine, anti-government individual out for money as vengeance for her firing.

Jackson has worked on a long list of government-run clinical trials for vaccines and said she is pro-vaccine. She pointed out that her children have had all their childhood vaccines and that her entire family gets the flu vaccine yearly. Jackson received the COVID-19 vaccine as soon as it was available and was initially one of its biggest cheerleaders.

While she is seeking compensation for her termination as part of her actions against Pfizer and the other companies, Jackson said she plans to donate any money she receives under her legal action against the companies to those injured by the vaccine.

"As far as I'm concerned, it's blood money," she said. "The world should be disgusted by what went on here with the shameful actions behind this dangerous vaccine."

The virus itself can cause this to happen, but to a much much smaller extent than the vaccine (think miniscule). **Vaccines are taking an average of 5 months to kill people

Executive Summary:

We've always assumed the vaccine kills you quickly (in the first two weeks) because that's when people notice the association and report it to VAERS. This is still true; it does kill some people quickly.

However, thanks to an HHS whistleblower, we can now clearly see that most of the deaths from the vaccine are happening an average of 5 months from the last dose. That is for the second dose; it may be getting shorter the more shots you get but there are arguments both ways (since there can be survivor bias).

But this explains why the life insurance companies got off-the-charts all-cause mortality peaks for people under 60 in Q3 and Q4 rather than right after the shots rolled out.

The five month delay is also consistent with death reports where people are developing new aggressive cancers that are killing them over a 4 to 6 month period.

The 5 month death delay was also confirmed using only European data. That analysis was posted Aug 11, but I learned about it after I wrote this post.

So when you hear of a death from stroke, cardiac arrest, heart attack, cancer, and suicide that is happening around 5 months after vaccination, it could very well be a vaccine-related death.

The data from the Social Security Administration death master file (ages 18 to 55) I got this chart from a whistleblower who works for HHS. This is data you are not supposed to see. The mortality increase (60% at peak) is huge. That sort of increase can only be caused by something novel that affected massive numbers of people.

There is only one possibility that fits that: the COVID vaccine.

The peak is September 9, 2021.

***Reference to graphs have not been openly available to share.**

This graph*, which is not publicly available, is from the US Social Security death master file. It compares deaths from 2021 to deaths in 2020. You simply cannot get such a rise in deaths like that unless something very deadly is affecting massive numbers of people. This explains why insurance companies all over the world were seeing massive death spikes in Q3 and Q4 of 2021. The vaccine was simply taking an average of 5 months from the most recent injection to kill people. The peak here is September 9, 2021.

Daily vaccine doses administered in the US

The peak is April 12, 2021.

Occam's razor

The most obvious conclusion is that the vaccine takes an average of 5 months to kill people after the second dose.

The second peak in December 2021 will result in life insurance companies having spikes in Q1 and Q2 of 2022.

Here's what UK Professor Norman Fenton said

Another analysis using only European data found the exact same 5 month delay! An analysis posted at Chris Martenson's site found the same 5 month delay using different source data! That is really stunning. I had no idea when I wrote my article.

Here's the [reader comment pointing this out](#) and here's the comment on Peak Prosperity posted August 9, 2022 which was just a few weeks before I found the same thing from the US data.

What the figure shows is the "*correlation coefficient*" as function of a temporal delay, that is, time shift.

- a negative time shift indicates that excess mortality is preceding the vaccination status
- a positive time shift indicates that the administered doses precedes the excess mortality

The optimal time shift is defined as that time shift that maximizes the absolute Pearson coefficient. We search for the highest, or the lowest value. The lowest value is around -0.3, while the highest value is around 0.8. Because the absolute value of the highest, +0.8, is larger than the absolute value of the lowest, +0.3, the optimal time shift is + 5 months. That is, Administered Doses precedes Excess mortality.

As Holden indeed mentioned, we do find a negative relation also when there is no shift. However, the explanatory power of +0.8 is way larger than -0.3.

The reason why I used "*causes*" instead of causes is that there are several characteristics of causal relations. What we tested now is "*temporal precedence*". An effect cannot precede the cause, plus, a cause predicts the effect better than the cause predicts the effect.

In the cause of observational causality, another important aspect is that the cause should predict the effect better than the effect predicts itself. In this case we indeed find that Excess Mortality predicts itself poorly —of course, for a time

delay equal to 0, it does predict itself, for all other time delays, it has little to no explanatory power—.

From this we can conclude that, based on the data sets used, Administered Doses do cause Excess Mortality.

Of course, our “*brilliant experts*” are still stuck in the 19th century writ statistical methods. I do not expect that they will be able to explain the excess mortality with their current methods, simply because 5 months is a huge time delay, and because here is typically little knowledge of observational causal methods.

About the method:

The method used is based on correlations. The current state-of-the-art is based on Information Theory, but that’s too out of the ordinary for layman, and even experts, so we better not go there. When I have time in a couple of weeks I might run the information theoretical causal analytics.

About the data:

As mentioned, the data sets from Holden’s sources were used. We selected only EU countries, we did not differentiate between sexes and age groups. Finally we used monthly data due to time restrictions on my side (I simply do not have time to search for, or create weekly data sets for the excess mortality).

Alternate hypotheses:

If someone has a better explanation for this data, I’d love to hear it.

It does appear from reading the comments that it makes sense to reader and explains what they personally observed.

Implications for the Canadian doctor death data:

Armed with this new knowledge, we should stop looking just for deaths proximate to the vaccine and look at the overall death rate in Canada of young doctors, e.g., doctors 50 and younger. **What I found when I did that is that the number of young doctor deaths in Canada increased by a factor of 2.5X in 2021 vs. 2020 (15 deaths vs. 6).** I’ve requested the data for earlier years to see how this compares.

Summary:

It was wrong to assume that most of the vaccine-related deaths were happening shortly after vaccination. Some are, but most are not. It's just that they were easier to notice when there was temporal proximity to the jabs.

If someone you know died around 5 months after vaccination, you should definitely have a proper autopsy done as described in [my earlier interview with Ryan Cole](#).

hold [Fauci](#) responsible for any of his misdeeds, which include but are not limited to:

- Disastrous and contradictory [COVID-19 policies](#)
- Funding of banned gain-of-function research in Wuhan, China (discussed in the Sky News report above from June 2021)
- Colluding to destroy the reputations of scientists who called for focused protection rather than lockdowns, and
- [Lying to Congress](#) (video below)

So, it appears Fauci is making sure to get out before new Congressional members take their seats. He's probably banking on being able to plead the Fifth Amendment as a private citizen and never have to answer to anything he did while in public office, should Republicans decide to investigate him.

As noted by Batya Ungar-Sargon during an Aug. 22 episode of The Hill's "Rising" (video below), when asked about whether he had any regrets about his pandemic response, Fauci denied having made any mistakes — a surprising stance, considering his many flip-flopping and contradictory recommendations.

Amazon protects Fauci's reputation by censoring book reviews!

When Robert F. Kennedy Jr.'s best-selling book "[The Real Anthony Fauci](#)" came out in November 2021, there were 20,000 reviews of the book on [Amazon](#) but mine was number one with 7,500 "*liking*" the review. The reason I mention it is that this was my headline last summer: "*The Details Exposed in This Book Will Lead to Fauci's Resignation.*"

Then, at some point, Amazon censored the reviews, and now the top critical review has 2,485 "*likes*" and the top positive review has a measly five and my review is nowhere to be seen.

Nice job of censoring, Amazon. [Pastor Bob can confirm that Amazon does censor reviews through a variety of ways.]

["The Real Anthony Fauci"](#) is a carefully referenced, scathing critique of Fauci's career. As explained by [Kennedy in my interview](#) with him in mid-November 2021, [Fauci](#) is the highest-paid federal employee in the U.S., and 68% of his \$437,000 a year salary comes from bioweapons research.

Instead of safeguarding public health, Fauci turned the National Institutes of Health (NIH) into an incubator for pharmaceutical products and essentially sold the entire country to the drug industry.

He was instrumental in creating the vaccine "*gold rush*" in the 2000s when he [partnered with Gates](#) to vaccinate the world with a battery of new vaccines.

One of the darkest stains on Fauci's career, aside from his role in the [COVID-19](#) pandemic, was his handling of the [HIV](#) epidemic. Suppressing the use of repurposed drugs, Fauci zeroed in on AZT, a toxic drug that killed an estimated 300,000 AIDS patients.

He followed the same script during the [COVID-19](#) pandemic, with devastating consequences. He suppressed all inexpensive and nontoxic treatments and pushed the toxic and deadly remdesivir to the front of the line, making it the only drug available to hospitals, which were financially rewarded for killing patients with it.

As noted by [The Federalist](#) in a January 2021 article written by civil rights attorney Ilya Feoktistov, Fauci has failed upward ever since he joined the NIH in 1984, meaning each failure was rewarded with greater influence and funding.

Did Fauci write 'Expect the Unexpected'?

Fauci also has a book of his own, the publication of which occurred under rather suspicious circumstances. In a 2021 interview, [Fauci](#) said he was working on a [memoir](#), but was precluded from contracting with a publisher while still employed by the federal government.

In June 2021, [Fauci's book](#), *"Expect the Unexpected: Ten Lessons on Truth, Service, and the Way Forward,"* was listed for sale on Amazon and Barnes & Noble, only to be delisted almost immediately.

According to the publisher, National Geographic Books, the book was *"prematurely posted for pre-sale."*

They also stated Fauci was not actually involved in the creation of the book and would not receive royalties from it.

The original Amazon posting, however, gives a different impression, according to [Daily Wire](#):

"In his own words, world-renowned infectious disease specialist Anthony Fauci shares the lessons that have shaped his life philosophy, offering an intimate view of one of the world's greatest medical minds as well as universal advice to live by."

When, in November 2021, ["Fauci: Expect the Unexpected"](#) finally came out, it had National Geographic listed as the *"editor,"* with no author specified.

Is this Fauci's own work, repackaged and sold with National Geographic as the author/editor and publisher? If so, then Fauci has flouted the rules and committed yet another illegal act.

Violators of Nuremberg Code must be held accountable.

Many are now wondering if Fauci, through his resignation, will be able to slip through the fingers of accountability. Hopefully, justice will prevail on that point, in one way or another.

As noted by Children's Health Defense president, Mary Holland, during an event to commemorate the 75th anniversary of the [Nuremberg Code](#) (video below), *"Those who violated the Nuremberg Code must be prosecuted for crimes against humanity."*

Fauci, without doubt, deserves to be very high up on that list. During that same event, Holocaust survivor and founder of the Alliance for Human Research Protection, Vera Sharav, also stressed that the *"Nuremberg Code is our defense against abusive experimentation,"* and that to prevent another mass genocide, *"we must identify ominous current parallels before they poison the fabric of society."*

Roadmap for prosecuting COVID crimes

While many worry it might not be possible to hold COVID-19 criminals like Fauci responsible for their roles, Francis Boyle, in December 2021, laid out a viable [roadmap for prosecuting](#) these individuals.

As explained by Boyle, a professor of international law at the University of Illinois College of Law who helped write the Biological Weapons Anti-Terrorism Act of 1989, this law imposes fines and prison sentences on anyone who *“knowingly develops, produces, stockpiles, transfers, acquires, retains or possesses any biological agent, toxin or delivery system for use as a weapon.”*

The problem we face is that our federal government has been captured by forces that seek to destroy the U.S. from within. As such, we cannot trust the federal judiciary to prosecute and hold those responsible for the pandemic and the toxic [COVID-19 shots](#) accountable.

To circumvent the corrupted federal judiciary, we need to focus on locally elected prosecutors instead. Depending on the state, they may go by titles such as district attorney, state attorney, prosecuting attorney or county attorney.

Boyle recommends organizing locally to find people willing, as a group, to call on your local, elected district attorney to convene a grand jury and indict the individuals suspected of being involved in the creation of SARS-CoV-2 — which includes Fauci — and those responsible for the COVID-19 shots with *“murder and conspiracy to commit murder.”*

Even if Fauci is prosecuted and convicted of crimes against humanity, with all his ties to the Deep State and intelligence community, it is highly probable he struck a deal early on and would likely receive a presidential pardon for his crimes. So don't hold your hopes up for Fauci ever being held responsible for his crimes in this lifetime.

At this point, there are loads of evidence showing SARS-CoV-2 is a manufactured bioweapon. Dr. David Martin has identified hundreds of patents relating to its creation, spanning not years but decades, and much of this research was funded by the NIAID under Fauci's leadership.

I reviewed some of this evidence in “*Patents Prove [SARS-CoV-2 Is a Manufactured Virus](#)*,” which featured Martin’s September 2021 testimony to the German Corona Extra-Parliamentary Inquiry Committee.

It will be a difficult task to hold the COVID-19 criminals (video below) to account, but as noted by Kennedy in the interview featured above, the tide is turning against the globalist cabal, for whom the pandemic was an ideal justification for the rollout of worldwide totalitarianism.

Federal government raids Amish farm for raising livestock and growing crops the natural way

The Biden administration recently sent armed federal agents to Miller’s Organic Farm and demanded the farm [cease its operations](#) immediately. The authorities also ordered \$300,000 in fines, an amount enough to put the small, family-owned farm out of business.

The farm, which is located in the remote Amish village of Bird-in-Hand, Pennsylvania, has been around for almost 30 years. It supplies grass-fed beef and cheese, raw milk and organic eggs, dairy from grass-fed water buffalo and all

types of produce to about 4,000 private food club members who pay for high-quality whole food.

Farm owner Amos Miller said *“he’s preparing food the way God intended,”* but the government seemed to disagree. The said food clubs value their freedom of being supplied with food from an independent farmer that does not process meat and dairy at the *United States Department of Agriculture (USDA)* facilities. **Miller’s farm process does not follow the USDA process as he believes they make it less nutritious.**

Rebel News reported that Miller has used religious exemptions, protected by the First Amendment and available to the Amish by law, to maintain their traditional standard of life, including bypassing USDA artificial processing facilities.

Miller also does not use gasoline or fertilizer, which makes them unaffected by the Ukraine war and the sanctions placed by the West on Russia.

Twitter account @Stooge Report said: *“Federal Agents raid an all organic natural Amish farm! Shut it down with a \$300,000 fine. The farm feeds 1,000 residents. Apparently, they feed the people without government involvement which is unacceptable. But they can send 50 billion to Ukraine.”*

The said tyrannical effort was hidden by the government and mainstream media. *“We wouldn’t know about it if it were not for Jeremy Loffredo,”* Tucker Carlson said during his show.

Loffredo, reporter at *Rebel News USA*, told Carlson: *“By taking out the middle man – by taking out the government – you’re taking power away and taking leverage away from the government and putting that power and leverage in the hands of the community, the farmers and the people.”*

Dutch farmers warn globalists are going to attack US food supply. Earlier in the year, Dutch farmers warned that these tyrannical globalist measures would spread to the United States. The Netherlands is also illegally shutting down operations of Dutch farmers as the global food supply continues to dwindle.

The Dutch police recently arrested over 100 people in relation to demonstrations resisting *“green agenda”* plans that will cause these farmers to lose their livelihoods. This *“green deal”* is mandating farmers cut their nitrogen emissions from 50 to 95 percent, depending on their location. The only way to do this is to shut down farms and kill off cattle.

Tensions rose during the protests as police officers targeted demonstrators with gunshots. In July, the cops claimed that a threatening situation arose when the farmers tried to drive into officers and official cars. Warning shots were then fired and an officer also fired pointedly. No one was injured, but a tractor was hit.

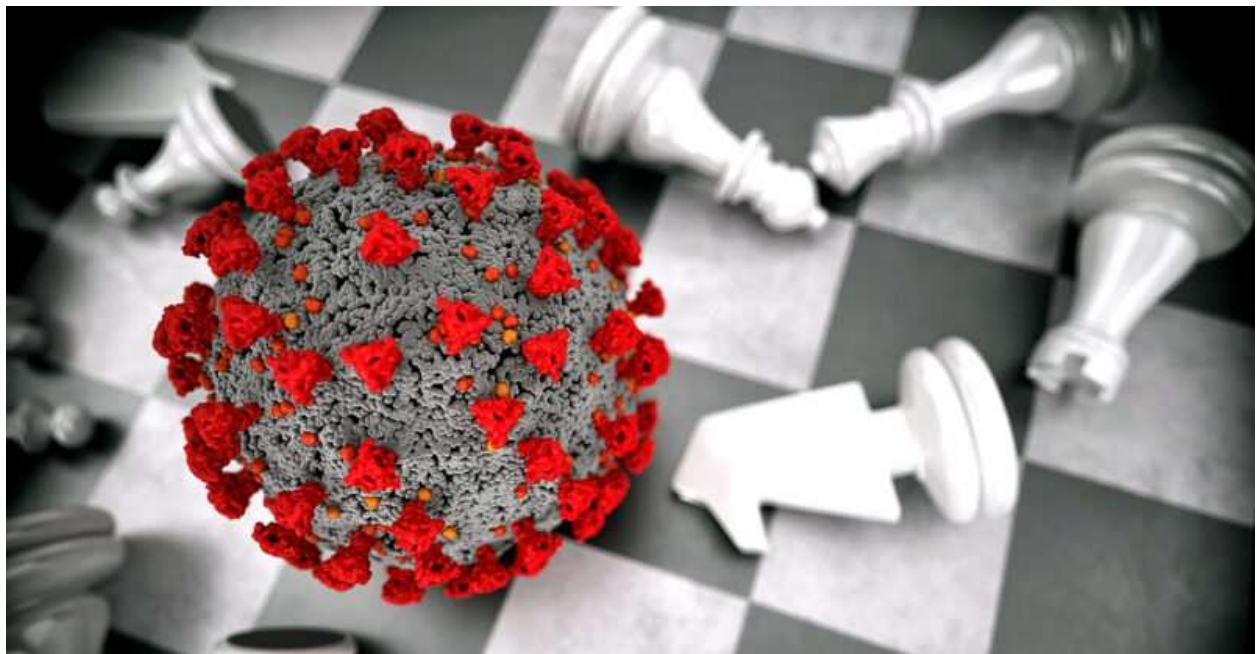

The ‘World War’ on COVID — An Arsenal of High-Tech ‘Weapons’ of Social Control

If we carefully analyze each aspect of the “world war” on COVID-19, we can see how each tactic and high-tech “weapon” has harmed human health, destabilized civil society and possibly disrupted the ecological balance between the human population and the virus, while enriching private interests and empowering financially captured government regulators.

Bill Gates has called the global response to COVID-19 a [“world war.”](#) His militaristic language has been echoed by Dr. Anthony Fauci and other architects of COVID-19 policy for the last two and half years.

To fight their *“world war,”* [Gates](#) and [Fauci](#) and their allies have deployed an arsenal of high-tech *“weapons”* and tech-enabled tools of social control — contact tracing apps, PCR tests, QR codes, digital passports, lockdowns, mask mandates, mRNA vaccines, social media censorship, mass surveillance and so on — with devastating consequences for civil societies, human health and even the environment.

As an advocate for wildlife conservation, I have been appalled as [virtually all environmentalists](#), and most others on the left, have supported this disastrous high-tech “war” on COVID-19.

I believe that an ecological perspective reveals many of the flaws inherent in an aggressive high-tech attack on a pathogen, although most environmentalists have been too blinded by progressive political ideologies and the hysteria surrounding [COVID-19](#) to see this truth.

In addition to criticisms leveled at pandemic policies by civil libertarians and public-health experts such as the authors of the [Great Barrington Declaration](#) — critiques that I appreciate — I tend to view the pandemic in accord with insights I have gained while trying to protect the planet’s biodiversity, a point of view that many critics may not have thought about, and may even be inclined to dismiss.

To me, the *“war”* on COVID-19 has been characterized by a destructive set of attitudes, beliefs and behaviors that appear to be deeply engrained in our political and economic institutions, and which form a pattern that should be recognizable to conservationists and ecologists:

1. Aggressive intervention in complex natural processes using new, poorly understood technologies designed to achieve narrowly defined short-term goals, with disregard for the potential long-term ramifications;
2. Profiteering by private interests that own the technologies, enabled by government entities and “experts” that have been financially captured by those interests;
3. Followed by a cascade of unintended consequences.

Each aspect of the *“war”* on COVID-19 can be understood in these terms.

To explain, I will first elaborate on how I see the global response to COVID-19 through the lens of ecology.

Ecology and aggressive technological “wars” against complex living systems

“The first rule of ecology is that everything is connected to everything else,” wrote the ecologist [Barry Commoner](#) in the 1970s.

Or as the legendary naturalist John Muir, founder of Sierra Club (recently [canceled](#) by his own organization), wrote a hundred years before, ***“When we try to pick out anything by itself, we find it hitched to everything else in the universe.”***

Ecological damage often ensues when people aggressively try to control complex natural processes to achieve short-term goals without truly understanding how those living systems work, or what the full range of ramifications will be, usually with new technologies that promise ***“progress”*** but have a variety of consequences that cannot be managed over the long run.

In my opinion, this is one reason why our global industrial economy, which interferes in natural processes on a massive scale across the planet, has brought about a multi-faceted [ecological crisis](#) that has seen a dramatic collapse in the [planet’s biodiversity](#), including an average 70% decline in [Earth’s wildlife populations](#) since 1970, among other symptoms of environmental degradation (I won’t even mention the “C” word).

An example of an ecologically destructive practice that fits this pattern is the [Big Ag/ Big Pharma](#) industry’s worldwide chemical ***“war”*** on plant and animal pathogens using herbicides, pesticides, antibiotics and other pharmaceuticals.

The world’s most popular herbicide, [glyphosate](#), has harmed global biodiversity over the last five decades and has potentially caused many [human health problems](#), including cancer. (Acknowledging these harms is not to endorse the anti-farmer measures recently enacted in the Netherlands, Canada and elsewhere).

The ***“war”*** on insects waged via the widespread application of the chemical insecticide DDT in the mid-20th century also caused vast ecological damage across many species that Rachel Carson exposed in her book ***“Silent Spring”*** giving rise to the modern-day environmental movement.

[Studies](#) still link DDT to elevated risks of cancer in children and grandchildren of women who were exposed to the chemical decades ago.

A similar ecologically destructive practice is the ***“war”*** that has been waged for decades on apex predators like wolves, bears and big cats at the behest of industrial agricultural interests, often accomplished through the large-scale spreading of [chemical poisons](#) across landscapes, triggering negative [“trophic cascades”](#) throughout U.S. and global ecosystems.

I cannot help but notice that the high-tech “war” on COVID-19 resembles these industrial “wars” against the natural world in many respects.

The whole “war” concept is based on a militaristic, mechanistic way of thinking that is obsessed with exerting technological control over natural processes to achieve short-term aims — often eradication of a “threat” like a pathogen or a predator — but cannot recognize the long-term consequences of interfering in the complex set of biological relationships that support natural ecosystems, and that ultimately provide the basis for human health and well-being.

[Gates](#) exemplifies this mindset, with his techno-utopian beliefs that human pathogens are like computer viruses, that human biology can be manipulated like computer code, and that vaccines can be regularly “uploaded” into the human body like software updates.

He has a wrongheaded, [war-like notion](#), as observed by economist Jeffrey A. Tucker, that “*with enough money, intelligence, and power, along with technological know-how at the helm, [a virus] can be stopped in its tracks.*”

Gates’s militaristic COVID-19 strategy of retreat (lockdowns and masks) and attack (mass mRNA vaccination) was never based on a holistic understanding of how human populations interact with pathogens and co-exist with them over time, how individual citizens remain healthy or how human societies thrive.

“*The pandemic is not a war,*” says Indian activist [Dr. Vandana Shiva](#), one of Gates’s staunchest critics, and one of the only prominent ecologists to criticize his COVID-19 policies.

“*In fact,*” she says, “*we are part of the biome. And we are part of the [virome](#) [the set of all viruses present in the human body]. The biome and the virome are us.*” In other words, co-existence with pathogens is the rule in ecology, eradication of a pathogen from nature is the [rare exception](#) and declaring “war” on any part of a complex living system can have significant unintended consequences.

But for Gates and Fauci and others in power, waging high-tech “wars” on viruses is far more amenable to their interests than a humble approach based on the subtle principle of ecology (or the traditional precepts of public health prior to March 2020).

Using new technologies to control natural processes for short-term gain, with disregard for long-term ecological consequences, is the business model. In fact, the more ecological damage that is caused, the more that further technological interventions can be justified, raising the question of whether “unintended” consequences are in some cases intended.

As explained further below, the failure of each aspect of the “war” on COVID-19 can be described and understood in ecological terms, including lockdowns, masks, mRNA mass vaccination and even the origins of the virus itself.

Origins of the virus: Who is the real bio-terrorist, Mother Nature or Anthony Fauci?

One of the great ironies of the global response to COVID-19 is that one of its prime architects, [Fauci](#), may have been partly responsible for the pandemic.

Fauci and other powerful figures in the international bio-security establishment have long ignored the ecological risks of tampering with natural viruses using bio-weapons technology.

This is an important factor that may have led to the initial outbreak of COVID-19 in [Wuhan, China](#).

As soon as the pandemic started, Fauci immediately and vigorously began promoting the unproven theory that SARS-CoV-2 jumped naturally from wild animals to humans, and he even orchestrated a [behind-the-scenes campaign](#) to discredit alternative theories.

But evidence has been steadily mounting that the novel coronavirus quite possibly came from [“gain-of-function” research](#) at the Wuhan Institute of Virology, funded in part by U.S. government grants approved by Fauci himself.

Jeffrey Sachs, a prominent Democrat and professor of sustainability at Columbia University, chaired a commission for The Lancet that investigated the origins of SARS-CoV-2 for two years.

He has [said](#), *“I’m pretty convinced it [the virus] came out of U.S. biotechnology, not out of nature . . . So it’s a blunder of biotech, not a natural spillover.”*

Sachs has [compiled evidence](#) supporting the lab-leak theory, particularly regarding the existence of an unusual feature on the virus called a *“Furin Cleavage Site,”* which may have been artificially inserted in SARS-CoV-2.

I find Sach’s reasoning and the evidence he has presented persuasive, although as a wildlife conservationist I remain concerned about the potential for natural *“spillover”* of viruses from wild animals to humans.

Environmentalists, journalists, scientists and others who focus their attention exclusively on [computer models](#) of zoonotic transmission and [statistical studies](#) favoring the natural transmission theory, while turning a blind eye to the hard evidence supporting the lab-leak theory laid out by Sachs and others, including [Matt Ridley and Alina Chan](#), authors of *‘Viral: The Search for the Origins*

of COVID-19,' are missing an important story. (Even Fauci now says he has an ["open mind"](#) about a possible lab leak.)

Most fail to realize that Fauci and other proponents of *"gain-of-function"* have long shown a reckless disregard for the risks of tampering with natural viruses, expressing a [paranoid attitude](#) toward nature that is the antithesis of respect for ecology.

Fauci and others claim that ["Mother Nature Is the Ultimate Bioterrorist"](#) to justify their Frankenstein-like efforts to [hunt down](#) the most dangerous viruses that exist in wild nature, take them to labs like the one in Wuhan and tinker around with them to make them more dangerous and deadly.

Their twisted logic seems to be that if they intentionally create super viruses, they can somehow anticipate and prepare for natural pandemics.

Most objective observers, however, say that *"gain-of-function"* is a military-industrial boondoggle that has [no practical benefit](#) whatsoever and dramatically increases the risk of pandemics (which, when they do occur, substantially increase the wealth and power of those funding and conducting the experiments). *"Gain-of-function research of concern involves the creation of new health threats,"* Dr. Richard Ebright of Rutgers University [recently testified](#) before the U.S. Senate, *"health threats that did not exist previously and that might not come to exist by natural means for tens, hundreds, or thousands of years."*

If environmentalists and others on the left were being true to their principles, they would denounce Fauci's funding of bio-weapons experimentation and cry out for a worldwide ban on *"gain-of-function"* research in the same way that earlier generations of activists sought to limit the proliferation of nuclear weapons.

"Gain-of-function" is already illegal under U.S. laws that Fauci appears to have found his way around.

It remains [inconclusive](#) whether *"gain-of-function"* research actually caused the COVID-19 pandemic, but its potential to have done so is a vivid example of how powerful actors like Fauci use technological tools to interfere with natural processes, with disregard if not outright contempt for the long-term ecological consequences, thereby creating opportunities to exercise more power.

Lockdowns: A failed bio-warfare strategy

Since 9/11 it has been part of U.S. bio-warfare planning to *"lock down"* the population in response to a deliberate biological attack or the accidental release of an engineered pathogen, which according to Sachs is exactly how SARS-CoV-2 escaped the bio-technology lab in Wuhan, China. (See chapter 12 of Robert F. Kennedy Jr.'s book, ["The Real Anthony Fauci,"](#) for a comprehensive summary of bio-warfare planning over the last 20 years).

In the Spring of 2020, this bio-warfare tactic — lockdown! — was unleashed on hundreds of millions of healthy Americans and billions of others worldwide without any understanding of the true long-term effects on human health and well-being, the vitality of our complex civil societies or the biological relationship between the population and the virus.

Authorities justified lockdowns and associated policies with oversimplified [computer models](#) that did not reflect biological reality, and which were based on the utterly false premise that limiting social contacts through the brute force of modern technology (contact tracing apps, QR codes, digital passports, mass testing, online schooling, social media messaging, etc.) would somehow “flatten the curve” of infections in some meaningful, non-temporary way.

The [Great Barrington Declaration](#), authored by epidemiologists Jay Bhattacharya, Martin Kulldorff, and Sunetra Gupta, of Stanford, Harvard and Oxford Universities, correctly predicted that lockdowns were incapable of containing or controlling the spread of the virus, which is now ubiquitous in every corner of the globe despite numerous countries enforcing lockdowns throughout 2020 and 2021.

Complex human societies — vast networks of relationships and flows of material and energy — are in many ways like complex ecosystems that cannot simply be turned on and off like a machine.

Indeed, shutting down social activity violated the first rule of public health articulated by the renowned Dr. D.A. Henderson, who patiently conducted slow and methodical work on smallpox, the only human disease ever to be eradicated (after a century-and-a-half of effort and a vaccine that prevented infection and transmission).

Henderson said:

“Experience has shown that communities faced with epidemics or other adverse events respond best and with the least anxiety when the normal social functioning of the community is least disrupted.”

By disrupting the normal functioning of society to the maximum extent, lockdowns caused immense [collateral damage](#) to the most vulnerable and [marginalized](#) people on Earth, including the global poor (100 million pushed into [dire poverty](#) by lockdowns in 2020, and 263 million more could crash into extreme poverty this year), working classes (\$3.7 trillion in [lost earnings](#) in 2020 alone and now [crippling inflation](#)) and children (massive educational deficits and an unprecedented [mental-health crisis](#)).

Lockdowns led to deaths of despair from suicide and drug and alcohol addiction, depression, skipped medical treatments and other direct [harms to human health](#),

including the impairment of millions of immune systems due to [lack of exposure](#) to pathogens, leading to [surges of infection](#) with adenovirus, rhinovirus, respiratory syncytial virus (RSV), human metapneumovirus, influenza and parainfluenza, in addition to COVID-19.

Meanwhile, billionaires who own the technological armory of lockdown added a total of \$5 trillion to their [wealth](#) from March 2020 to November 2021, and the world's ten richest men, including Gates, [doubled their fortunes](#) due to the increase in the value of their holdings in Big Tech and Big Pharma attributable to [“pandemic super profits.”](#)

According to [Oxfam International](#), *“for every new billionaire created during the pandemic — one every 30 hours — nearly a million people could be pushed into extreme poverty in 2022.”*

Lockdowns also empowered government bureaucrats (under the influence of Big Pharma, Big Tech and other multinational corporate interests) to rule by emergency decree, circumventing democratic processes and causing a massive worldwide rollback of basic civil liberties and [human rights](#), which fell to various forms of tech-enabled control: free speech gave way to social media censorship, free movement to digital passports, and freedom to earn a living or get an education to bans on *“nonessential”* activity that forced commerce and schooling online.

The real story here is how elites used lockdowns to exert an unprecedented degree of control over society and each one of us.

At the height of global lockdown mania in 2020, Vandana Shiva described their destabilizing and dehumanizing effect from her perspective as an activist who has long tried to protect India from policies that [Gates](#) and other global elites have forcefully imposed on her country, especially industrial agricultural policies that take control of the land away from traditional farmers and give it to giant multinational corporations.

Shiva used ecological terms to illustrate how technocratic elites seek to control us in the same way that they control the land:

“The coronavirus pandemic and lockdown have revealed even more clearly how we are being reduced to objects to be controlled, with our bodies and minds the new colonies to be invaded. This linear, extractive logic [of lockdown and similar policies] is unable to see the intimate relations that sustain life in the natural world. It is blind to diversity, cycles of renewal, values of giving and sharing, and the power and potential of self-organizing and mutuality. It is blind to the waste it creates and to the violence it unleashes.”

Just as an ecologically short-sighted intervention in a complex living ecosystem can destabilize it, lockdowns severely destabilized our complex civil societies, exposing them and each of us to exploitation.

For many years, we will be living with the catastrophic consequences of this heavy-handed and poorly understood bio-warfare tactic.

Toxic masquerade: The effects of petrochemical masks on health and the environment

Masks are “*weapons*” in the “*war*” on COVID-19 manufactured by the petrochemical industry that have caused enormous collateral damage to [human health](#), civil society and even the environment.

Yes, surgical and N95-style masks are made from synthetic petrochemical fibers, i.e. plastic. As I have written about previously, billions of [plastic masks](#) have already ended up in the world’s oceans, where they directly harm marine life like sea turtles, whales and especially sea birds — masks are devastating bird populations around the world.

Masks also pollute the water with countless tiny particles called “micro plastics” that infiltrate the marine food chain. Billions more plastic masks have been buried and burned in landfills and incinerators, where they release petrochemicals into the soil, water, and air.

At the height of the pandemic, the world was throwing away about [3 million masks per minute](#).

The petrochemicals in masks are toxic. Many surgical and N95 masks contain [PFAS](#), known as “*Forever Chemicals*.”

[One study](#) found that “*wearing masks treated with high levels of PFAS for extended periods of time can be a notable source of exposure and have the potential to pose a health risk.*”

The U.S. Environmental Protection Agency (EPA) recently warned that certain PFAS compounds are more [dangerous to human health](#) than previously thought and present a risk to human health even in very tiny quantities.

Recent studies have also found micro plastics in [human blood](#) and [deep lung tissue](#) for the first time ever. Those studies were not about masks, but they raise obvious questions about the effects of breathing through plastic material worn over the nose and mouth.

A [research team](#) from the Hull York Medical School in the UK found polypropylene and PET or polyethylene terephthalate, which are fibers from

synthetic fabrics such as the material that surgical and N95 masks are made from, in lung tissue.

“The surprise for us was how deep it got into the lungs and the size of those particles,” their team leader said.

Clearly, public-health agencies never paused their mask campaign long enough to consider the obvious risks that petrochemicals pose to human health and the environment.

And notwithstanding these risks, Big Plastic manufacturing giants like 3M, which sold [\\$1.5 billion](#) of surgical and N95 masks in 2021, have every incentive to keep plastic masks rolling off the assembly line.

3M and other large companies in the multibillion-dollar petrochemical industry routinely lobby officials in Washington D.C. about the supposed benefits of masking and have been handsomely rewarded with [huge public contracts](#) to provide masks to the government.

The petrochemical industry has also engaged in [heavy lobbying](#) to defeat efforts to regulate the toxic chemicals, PFAS, found in masks and other plastic products. In addition to the direct harmful effects of the toxic petrochemicals and micro plastics in masks, countless negative social, emotional, educational, and [health-related harms](#) have been suffered by the public due to the simple act of covering people’s faces, especially those of [children](#).

Forcibly covering people’s faces in plastic material, or useless cloth, is not “*low impact*” in any sense, as public-health officials wrongly declare.

Despite all this collateral damage, masks made [little to no difference](#) in the spread of the virus throughout the U.S. and the world. As with lockdowns, public-health officials rationalized mask mandates with oversimplified [computer models](#), and with ridiculous studies on [mannequins](#), as well as small inconclusive observational studies, not a robust scientific understanding of disease transmission in complex human societies.

Randomized controlled trials conducted before and during the pandemic showed that [mask policies](#) did not significantly reduce community transmission of respiratory viruses including COVID-19.

Even if masks were shown to have some modest effect, officials who mandated masks across vast swathes of society relied on the same faulty short-term logic that characterized lockdowns: the simple-minded notion that temporarily “tamping down” transmission of a respiratory virus is a legitimate and meaningful goal, regardless of the collateral damage.

Petrochemical masks are yet another failed, but profitable, bit of industrial technology produced by the “war” economy that has sprung up around COVID-19. mRNA mass vaccination: What can we learn from Big Pharma’s “war” on plant and animal pathogens?

The biggest “weapons” deployed in the “war” on COVID-19, [Pfizer and Moderna’s mRNA vaccines](#), are brand-new technologies that are unlike any other vaccine in history. Despite their technological novelty, the U.S. Food and Drug Administration (FDA) determined with unprecedented “warp speed” that mRNA shots are “safe and effective,” and initially approved them for use on an emergency basis after shockingly brief tests.

“Operation Warp Speed” was, in fact, a gargantuan military-industrial project involving [four generals and dozens of other military officers](#). Bio-warfare planners have zeroed in on mRNA products because they can be quickly formulated and manufactured in response to a biological attack or an accidental lab leak.

Clinical testing, however, takes years to complete and cannot be sped up, only curtailed. Long testing delays are unacceptable in a “war.” Putting “shots in arms” as quickly as possible is the measure of success.

But what are the long-term consequences for human health, as well as the ecology of the viral-host equilibrium in the population, due to hastily injecting nearly the entire human species with brand-new, lightly tested mRNA technologies developed by Big Pharma with “warp speed”?

We may have no way of knowing for certain, and even trying to answer the question exposes someone to the pejorative “anti-vaxxer.” There are many rational critics of mRNA vaccines who deserve credit for standing up to name-calling and censorship, and there are some irrational critics, too. I will not wade through all of those arguments here.

Instead, as a conservationist, I tend to look for answers in the worldwide industrial “war” waged by Big Pharma (in conjunction with its corporate cousin, Big Ag) against plant and animal pathogens.

To my mind, that chemical and pharmaceutical war is an important global precedent that has some disturbing parallels to the current mRNA assault on COVID-19 and may hold important lessons about what we can expect.

For example, over three hundred million pounds of the chemical herbicide, [glyphosate](#), are now dumped on U.S. soil every year.

Glyphosate is manufactured by Bayer, which recently acquired the original manufacturer, [Monsanto](#), in a \$66 billion merger between Big Ag and Big Pharma

(a confluence of corporate interests in which Bill Gates is an interested party, through his program to “revolutionize” global food production called [Gates Ag One](#)).

The [EPA](#), under the industry-friendly leadership of the Trump administration, determined that glyphosate is “safe” and “effective.” In June, however, a [U.S. Court of Appeals](#) ordered the EPA to set aside that order and reassess the risk that glyphosate poses to human health and the environment due to accumulating evidence of harms, including [biodiversity loss](#) in soils and waters laced with glyphosate.

The U.S. Supreme Court recently refused [Bayer’s appeal](#) of a major multi-million-dollar judgment based on the company’s failure to warn about glyphosate’s cancer risk.

Nevertheless, glyphosate use remains at extraordinarily high levels, particularly on crops that have been genetically modified to withstand exposure to the chemical. As weeds growing on about 150 million acres of U.S. soil have become [resistant](#) to glyphosate — you might call them weed variants — more and more glyphosate and other powerful herbicides are used to kill “super weeds” in a perpetually escalating chemical war against natural plant pathogens.

Similar practices are carried out by the Big Ag/ Big Pharma industry in the animal agriculture sector.

The widespread overuse of antibiotics and “leaky” vaccines that fail to prevent infection or transmission have created [“superbugs”](#) and “super viruses” in livestock animals.

A “leaky” vaccine for Marek’s Disease in chickens may have stimulated the evolution of viral variants that made the disease much more deadly, as explained in a 2015 article in ‘Science’ magazine (with a title that could never be printed today) titled [“Do Some Vaccines Make Viruses More Deadly?”](#)

The authors said:

“Vaccines save millions of lives every year by teaching our immune systems how to combat certain viruses or bacteria. But a new study suggests that, paradoxically, they could sometimes teach pathogens to become more dangerous as well . . . Some vaccines don’t prevent infection, but they do reduce how sick patients become . . . such ‘imperfect’ or ‘leaky’ vaccines could give deadlier pathogens an edge, allowing them to spread when they would normally burn out quickly.”

Yet the industry continues to engage in these kinds of ecologically risky (but profitable) agricultural practices on a global scale.

The parallels between Big Ag/ Big Pharma's chemical and pharmaceutical "wars" on plant and animal pathogens and Big Pharma's current mRNA "war" on a human pathogen include these striking similarities:

- Determination by corporate manufacturers and government regulators that chemical / pharmaceutical products are "safe" and "effective" before the long-term effects can possibly be known.
- Accumulating evidence of adverse health effects after widespread use. We now know, after hundreds of millions of people have received shots in the U.S. alone, that mRNA vaccines can cause [myocarditis](#), blood clots, facial paralysis, disruption of the [menstrual cycle](#) and a drop in [sperm count](#), among other problems. A [major pre-print study](#) that re-examined the original mRNA vaccine clinical trials concluded that "[t]he excess risk of serious adverse events of special interest [caused by the mRNA vaccines] surpassed the risk reduction for COVID-19 hospitalization relative to the placebo group in both Pfizer and Moderna trials."
- Use of "leaky" vaccines. In March of 2021 Director of the CDC, Rochelle Walensky, [said](#) on CNN that "vaccinated people do not carry the virus, don't get sick," and a few months later Fauci guaranteed MSNBC host [Chris Hayes](#) that "when people get vaccinated they can feel safe that they are not going to get infected." But we now know that although mRNA vaccines temporarily reduce symptoms of disease (an effect that did not decrease [all-cause mortality](#) in countries that used them), they fail to prevent infection or transmission. Even Gates himself [acknowledges](#) that the shots are "not good at infection blocking."
- Possible generation of new variants due to "leaky" products. Vaccinology expert [Geert Vanden Bossche](#) believes that mass vaccination with "leaky" mRNA shots is putting [evolutionary pressure](#) on the virus to generate new vaccine-resistant variants, and that mass mRNA vaccination has disrupted "the equilibrium in the viral-host ecosystem." He has pointed to the Marek's Disease vaccine in chickens as one potentially relevant precedent. We do not yet know whether he is right, but we do know that vaccine-resistant variants are emerging regularly. The new Omicron sub variants, [BA.4 and BA.5](#), are [highly resistant](#) to vaccine-induced immunity. A [study in the UK](#) has shown that people who receive multiple boosters after being infected with the original strain of the virus are more susceptible to Omicron infection.
- Perpetual escalation of the "war" against new variants in a vicious, but highly profitable, cycle. Pfizer CEO Albert Bourla sees no end to this cycle, as he predicts "[constant waves](#)" of COVID-19 variants accompanied by regular booster shots. Pfizer and its corporate partner BioNTech, along with Moderna, collectively had over [\\$60 billion](#) in vaccine revenue in 2021. They intend to keep the recurring-revenue business going for as long as possible, regardless of whether their own products are to blame for the emergence of variants.

- The financial “capture” of government regulators. The FDA, the CDC, the National Institute for Allergy and Infectious Diseases (NIAID), the National Institutes of Health (NIH) and the World Health Organization (WHO) get much of their funding directly from [the pharmaceutical industry](#), and from “charitable” foundations with close financial ties to that industry, including the Bill and Melinda Gates Foundation. Serious financial [conflicts of interest](#) exist at every level of the drug-approval process. Dr. Marty Makary of Johns Hopkins School of Medicine and Dr. Tracey Hoeg at the Florida Department of Health recently [wrote an article](#) about the relentless calls and text messages they are receiving from doctors and scientists at the top levels of the NIH, FDA and CDC regarding conflicts of interest and pressure to approve mRNA shots and boosters. Florida Governor [Ron DeSantis](#) summed it up best when he said, “What this whole year and a half has shown us is that these regulatory agencies of the federal government have basically become subsidiaries of the pharmaceutical industry.”

Conclusion:

If we carefully analyze each aspect of the “world war” on COVID-19, we can see how each tactic and high-tech “weapon” has harmed human health, destabilized civil society, and possibly disrupted the ecological balance between the human population and the virus, while enriching private interests and empowering financially captured government regulators.

The “war” has been characterized by the distinct pattern that I described at the beginning of this essay:

1. Aggressive intervention in complex natural processes using new, poorly understood technologies designed to achieve narrowly defined short-term goals, with disregard for the potential long-term ramifications;
2. Profiteering by private interests that own the technologies, enabled by government entities and “experts” that have been financially captured by those interests;
3. Followed by a cascade of unintended consequences.

This destructive pattern appears to be deeply ingrained in our institutions and in the outlook of our leaders. It largely defines our society’s dysfunctional relationship with the natural world.

An ecological perspective that keeps this pattern in mind, and takes into account all of the consequences of launching high-tech “wars” on pathogens or any other part of our environment may help us avoid similar catastrophes in the future, or at least to recognize them.

COVID19 Diagnosis Is Medical Fraud

An infectious disease cannot be diagnosed by identifying a virus because having the virus does not always lead to disease or even serious disease. An infection without symptoms produces immunity and this is how herd immunity is established in populations. Frank McFarlane Burnet won the Nobel Prize for this science in 1960.

In 2020 a new infectious disease appeared called 'COVID19', yet it can only be diagnosed with a test. If you don't take the test the symptoms are the same as many other "flu-like illnesses" caused by hundreds of different viruses, bacteria, medications, and vaccines.

In fact, since 2020 you don't need any symptoms at all to be classified as a "case of COVID19 disease". This means that the government can create the appearance of disease by increasing the testing of asymptomatic people and decrease the disease by stopping the testing of asymptomatic people.

On August 11, 2022 the CDC removed the requirement to test asymptomatic people. This includes people being admitted to hospitals who do not have respiratory symptoms.

Interestingly, the Australian government (and other governments) stopped monitoring for flu and pneumonia in 2020. They only monitored deaths/cases of COVID19 disease. Therefore, it appeared flu and pneumonia had disappeared in 2020 but the Australian statistics for deaths to COVID19 in 2020 were *similar* to

the annual deaths to flu and pneumonia that occur every year. This was the case in every country in 2020.

Despite the knowledge that there are multiple causes of flu-like illness, governments were only monitoring for *one virus* in 2020. This was being done with a new PCR test that was developed by the U.S. CDC *itself* and given emergency use only approval (EUO).

The Australian Health Minister, Greg Hunt, claimed in 2021 that cases of flu had plummeted due to the public health measures for the pandemic – ignoring the fact the government stopped monitoring for flu viruses.

Therefore, all flu-like illness in 2020 became COVID19 disease based on a PCR test that claimed to identify *Coronavirus 2019* (SARSCov-2). These tests were not accurately identifying this one virus because they are easily manipulated to get false positives. Government health departments were running these tests in a non-standardized fashion across countries.

The U.S. CDC admitted in 2021 that its PCR test did not allow for the identification of influenza and other viruses known to cause “flu-like illness”. Hence, they replaced this test in December 2021 with the Rapid Antigen Test and all *positive* results from this new test are called “COVID Disease” – but what is it identifying? Even an accurate identification of the virus would not indicate disease or risk.

This lack of transparency in disease diagnosis and surveillance has occurred because the traditional definition of an infectious disease has been changed. The definition of a case of an infectious disease prior to 2020 was:

“a set of standard criteria for classifying whether a person has a particular disease, syndrome, or other health condition”.

These screening tests are being misused and misinterpreted and this is allowing governments to create the illusion of a pandemic of a disease that is simply a positive test – no symptoms required.

In June 2020 the World Health Organization admitted that it did not have any evidence to claim that people without symptoms were a serious risk for COVID disease transmission. The only evidence of a ‘pandemic’ in Australia in 2020 was the huge number of cases being identified in asymptomatic (healthy) people.

This was a pandemic of testing – not disease. However, since the roll out of the “vaccine” in 2021 all countries have a significant increase in deaths and hospitalizations allegedly from “COVID disease”. This “COVID” diagnosis is being given to any patient that gets a positive test on admission to hospital –

regardless of the symptoms – and governments have made the test mandatory for hospital admission.

This mandatory test is covering up (camouflaging) all the adverse events from the “vaccine” that have resulted in increased hospitalizations and deaths in 2021. In other words, adverse events to the COVID injections – strokes, heart disease and blood clots etc. – are being *mislabeled*. This is possible because the only thing required to diagnose COVID disease is a positive test – not specific disease symptoms.

This lack of transparency in the diagnosis of disease is resulting in the deception of global populations that is leading to increased death and illness worldwide. This is iatrogenic (medical) harm from a drug that is falsely labelled a ‘vaccine’, and attributed to a virus.

The Therapeutic Goods Administrator (TGA) states a drug is not a vaccine until it has had 10 years of data to establish that the benefits outweigh the risks. So why are doctors and governments promoting this injection as a ‘vaccine’ without this data?

All humans have thousands of viruses and bacteria in us all the time so identifying them when we don’t have symptoms is not an accurate definition of disease. It is also not accurate in predicting the risk from an infectious agent. An infection has many different outcomes in individuals, including no symptoms at all, and all infections provide natural immunity both in the individual and in the community.

The claim that humans had a lack of natural immunity to this new coronavirus in 2020 by the WHO and U.S. CDC was false and this has now been proven as the unvaccinated did not get this flu-like illness *any more seriously* than the vaccinated. In fact, the vaccinated have been admitted to hospitals in much higher numbers than the unvaccinated. It is a pandemic of the vaccinated.

If we stop the testing for *Coronavirus 2019*, then COVID disease disappears completely, and we return to managing flus and colds. SO MUCH FOR SCIENCE: Vaccine industry no longer even bothering to test new covid shots before unleashing them onto the public... and the FDA is in on it

We are told that the newest formulation of Wuhan coronavirus (Covid-19) “booster” shot for the “Omicron” (*Moronic*) sub variant is ready for public release, even though the mystery concoction has never been safety tested.

According to reports, the vaccine industry has decided to not finish testing the injections on humans before asking the U.S. Food and Drug Administration (FDA) to approve them. And it appears that the FDA is fully on board with the plan.

Rather than wait to see how the jabs perform in real-life humans, the FDA is slated to just pull random data from animal research involving other jabs to issue authorization for the new covid booster jabs.

“Real world evidence from the current mRNA Covid-19 vaccines, which have been administered to millions of individuals, show us that the vaccines are safe,” declared current FDA Commissioner Robert Califf in a tweet.

When pressed for further comment, the FDA pointed inquirers to Califf’s tweet and Twitter page. (Related: Both the European Union and the World Health Organization have warned that covid “booster” shots are dangerous.)

When even Paul Offit is speaking out, you know you’ve jumped the shark.

The FDA takes the same approach to approving seasonal flu shots, which change from year to year depending on what the government claims is the most prominent circulating strain.

Instead of relying on sound scientific data for each individual type of injection, the FDA just assumes that each new jab formulation is the same as all the others: perfectly *“safe and effective.”*

“I’m uncomfortable that we would move forward – that we would give millions or tens of millions of doses to people – based on mouse data,” said Paul Offit, an FDA adviser and director of the Vaccine Education Center at Children’s Hospital of Philadelphia.

As you may recall from past reporting, Paul Offit *“For Profit”* has long been a heavy proponent of vaccines. He once stated that a child could receive 10,000 vaccine doses at once and be just fine.

This was *before* Operation Warp Speed, though. Offit now speaks like many of us, expressing perplexity at the new rules of the game that say *no testing required* when it comes to new injections.

Offit supports a *no testing* modality for flu shots because he says influenza strains mutate too fast for Big Pharma to keep up. For covid, he is against the idea of the FDA just rubber-stamping approval based on little or no testing.

We are told that the FDA will not only *not* be requiring any new human clinical trials, it will also not be convening its advisory members who would normally evaluate the data and make appropriate recommendations.

Califf indicated in his tweeting spree that the FDA has called off an advisory panel meeting, stating it has no further questions about the shot that would necessitate it.

“We’ve validated the process several times over and continue to produce safe and effective vaccines against Covid-19,” declared a spokeswoman from Pfizer, joining Moderna which made the same declaration.

What this means for the average person is that the U.S. government will once again be shoving experimental poisons down your throat – except this time, those poisons are not even being tested like the first round (sorta) were.

“If we waited for clinical trial results, thank you very much, we’d get them in the spring,” complained William Schaffner, a professor of medicine at Vanderbilt University Medical Center and a nonvoting liaison to a similar committee at the U.S. Centers for Disease Control and Prevention (CDC).

“It takes time to do clinical trials. This is just an updating of the previous vaccine that we used.”

NATURE study confirms: Triple-vaccinated developing clots associated with “long covid”

The *Nature* journal published a [new feature](#) highlighting an epidemic of “long covid” that is afflicting the triple-vaccinated.

People like Lara Hawthorne, a British illustrator who took three shots and “*felt quite protected,*” are now suffering strange illnesses linked to clots caused by the injections.

Hawthorne told *Nature* that she has been sick for *months* now with a variety of “*often debilitating symptoms*” including constant earaches, tinnitus, congestion, headaches, vertigo, heart palpitations and muscle pain, to name just a few.

Many days, Hawthorne feels so debilitated that she can barely get out of bed, which her doctors are blaming on “*long covid*” as opposed to the shots she received. (Related: It was Tony Fauci’s wife Christine who [pulled the strings](#) to get children enrolled in clot shot trials.)

Fearful about how tiny blood clots throughout the body are often to blame for long covid symptoms such as these, Hawthorne reached out to a physician in Germany who specifically treats people like herself using blood thinners and a dialysis-type process to filter and cleanse the blood.

Since there are now so many people sick and dying from the injections, Hawthorne has yet to hear back. There is apparently a waiting list a mile long with names of people who took the jabs, thought they were “protected,” and are now suffering day in and day out from all kinds of illnesses.

“I don’t want to wait on my health when I’m feeling so dreadful,” Hawthorne complained to Nature.

How long will science be “baffled” by what are clearly post-injection adverse events?

Researchers are reportedly “baffled by long covid” because they cannot figure out what is causing it – since they refuse to even consider the possibility that the shots are to blame.

An increasing number of people who took the jabs are experiencing ever-growing clots inside their bodies that are slowing and halting blood flow, eventually leading to death.

There is even a movement on Twitter called “#teamclots” that is raising awareness about the issue, but of course denying the elephant in the room known as the injections, which are the *only* logical cause of these clots.

Some desperate folks are resorting to their own remedies for these clots, to which the scientific establishment is already screaming *stop!* because such treatments are supposedly unproven.

“We’ve now got little scattered bits of evidence,” says Danny Altmann, an immunologist at [Imperial College London](#), about so-called long covid. Altmann, like his colleagues, will not dare to call out the jabs.

“We’re all scuttling to try and put it together in some kind of consensus. We’re so far away from that. It’s very unsatisfying.”

Nature is still referring to the clots as *blood* clots, even though evidence has emerged to suggest that the clots forming inside the bodies of the **“fully vaccinated”** are metallic, among other strange, non-blood substances.

It is almost as if the jabs are causing people’s bodies to form non-lifeform clots out of foreign substances that are contained within or produced by whatever is inside the “vaccine” vials.

Under a microscope, *Nature* admits, these clots resemble “a nice plate of spaghetti” with a “horrible, gunky, and dark appearance” such as “you might get if you half-boiled the spaghetti and let it all stick together,” to quote Douglas Kell, a systems biologist at [The University of Liverpool](#).

Kell and his colleagues have put together material suggesting that the fibrin in the clots has misfolded, creating a glue-like “amyloid” version of itself.

“If the first one changes its conformation, all the others have to follow suit,” Kell says, noting that the process is much like the misfolding of prions, which can lead to conditions such as Creutzfeldt-Jakob disease.

COVID-19 vaccines reprogram the immune system to ATTACK important organs

The Wuhan coronavirus (COVID-19) vaccines purportedly reprogram the immune system to turn against the body, causing lymphocytes [to attack important organs](#).

Arne Burkhardt and Walter Lang, two pathology professors from Germany, [held a press conference](#) to explain this phenomenon. They presented an analysis of 10 autopsies from people who died soon after their COVID-19 vaccination. All 10 individuals were aged 50, and died at various intervals in the two weeks following their vaccination.

Microscopic studies of tissue samples from the deceased individuals yielded an interesting find – the occurrence of a “*lymphocyte riot*.” Burkhardt and Lang discovered an alarming number of lymphocytes in various organs such as the liver, kidneys, spleen and uterus. The lymphocytes vigorously attacked the tissues in the organs and caused serious damage. (Related: [Evidence shows COVID vaccines cause serious damage to the immune system](#).)

This autoimmune horror could only be attributed to the COVID-19 vaccination. Burkhardt and two other pathologists attested to this, verifying that the vaccines triggered this pathogenesis in five of the 10 deceased individuals.

However, the medical examiners refused to acknowledge the COVID-19 shot’s role in the demise of the victims. Two of the cases reported the vaccination as a “*probable*” cause of death, while two others were noted as “*rather coincident*” or “*possibly*” caused by the vaccine.

Regardless, Burkhardt emphasized that autoimmune diseases were among the deadly side effects of the COVID-19 shot. He outlined such conditions found in the vaccinated victims such as Sjogren’s syndrome (lymphocytes attacking the glands that produce tears and saliva), leucoclastic vasculitis of the skin (blood

vessels in the skin becoming inflamed) and Hashimoto's disease (inflammation of the thyroid gland).

Several of the deaths were caused by lymphocytic myocarditis, which is caused by the lymphocytes attacking and damaging the heart muscle. While the disease occurs in both young and old people after their COVID-19 vaccination, it is often misunderstood as a general infarction and blamed on other factors.

Burkhardt also criticized medical coding standards utilized for finalizing death certificates that were currently in place. He dubbed these as “*completely unsuitable*” and “*ultimately statically worthless*,” because they make unclear arguments and do not refer to specific medical evidence.

Vaccines kill: Burkhardt and Lang's findings confirm results of an earlier analysis. Burkhardt and Lang's findings attested to the results of an earlier analysis, which looked at more autopsies. Back in August 2021, Dr. Peter Schirmacher [examined 40 autopsies of people](#) who died within two weeks of getting their COVID-19 vaccine dose.

Schirmacher, a professor at [Heidelberg University](#), concluded that one-third of the people died from the vaccination immediately, either through cerebral vein thrombosis or autoimmune diseases. He displayed microscopic details of serious tissue damage induced by the vaccines to back up his claim.

Despite criticism from health authorities, he received support from his fellow pathologists. The Federal Association of German Pathologists threw its support behind Schirmacher, stating that more autopsies of vaccinated people who died within a certain time frame after vaccination should be performed.

For his part, Schirmacher responded to the criticism by denying that he lacked competence. “*The colleagues are definitely wrong, because they cannot assess this specific question competently*,” he said.

Schirmacher also denied allegations that he was trying to spread panic and rebuked allegations that he was an opponent of vaccinations, citing the fact that he himself was vaccinated.

THE NEXT VAX: Big Pharma pushing to release ANOTHER mRNA “vaccine,” this one for RSV (respiratory syncytial virus)

(Natural News) After seeing the success, aka *dollar signs*, of the Wuhan coronavirus (Covid-19) “*vaccine*” rollout, the pharmaceutical industry – and specifically Moderna – is now [setting its sights](#) on a new mRNA (messenger RNA) injection for respiratory syncytial virus, also known as RSV.

Javara, a clinical trial company, is reportedly teaming up with Privia Health Group on behalf of Moderna to recruit clinical trial participants for the new mRNA jab. Participants from Georgia, Maryland and Texas will be asked to roll up their sleeves for the shot, which, like the mRNA shots for covid, is experimental. (Related: Big Pharma is [also pushing](#) an all-new mRNA *nasal spray* for the Chinese Virus.)

Javara claims that more than 177,000 people 65 years of age and older are hospitalized for RSV every year in the United States. Some 14,000 of them end up dying, while treatment for the others costs about \$3 billion annually.

“Second only to the flu when it comes to causing significant respiratory illness in adults, RSV represents an often unrecognized yet very real and imminent threat to our older population,” says Michael Clay, Javara’s Chief Operation Officer. *“Being able to vaccinate against this virus would save lives, prevent hospitalizations, and conserve healthcare resources.”*

“By taking this opportunity to test a promising preventive RSV vaccine, older adults increase the possibility that they will be protected from the discomforts and dangers of this virus. At the same time, by helping to move this research forward, these trial participants will be doing their part to prevent suffering and save lives around the world.”

Beware the wave of new mRNA drug products that will soon hit the market.

According to the death care industry, there is no *approved* treatment or vaccine for RSV at the current time. There are plenty of *unapproved* treatments, however – these include *not getting vaccinated* in the first place since vaccines have [been shown](#) to damage the immune system.

Moderna says its new RSV jab candidate contains the exact same mRNA technology as the company’s Fauci Flu shots, which are linked to myocarditis and a host of other deadly conditions.

“Because it does not use a weakened or inactive form of RSV, mRNA-1345 cannot cause RSV infection,” a news release from the company states.

As always, the clinical trials that have been conducted so far on the new RSV injection *“showed promising results,”* according to Moderna – because when has a drug company ever said its products are not *“safe and effective?”*

The second round of trials, which are being put together right now, will look more closely at how the mRNA injections for RSV affect elderly people.

Moderna [also announced](#) plans to unveil a multi-valent combination influenza, covid and RSV injection with mRNA technology that it claims could change the *"immunizations landscape."*

According to Francesca Ceddia, senior vice president of respiratory vaccines at Moderna, the combination drug is still in the early stages of development. By the end of this year, the company plans to launch the first phase of clinical trials.

"We have observed in preclinical results a very strong immune response against all the antigens," Ceddia claimed in an interview. *"That's another important feature of mRNA vaccines, particularly our mRNA platform, which allows for including more and more antigens in combination."*

In the future, Ceddia added, a person will be able to go to the pharmacy and receive one shot containing all of Moderna's mRNA drugs. This will be especially appealing for children, she says, as parents will no longer have to return for multiple different shots as part of a schedule.

White Clots Are Self-Assembling Circuits

Dr. Jane Ruby reports that, *"Self-assembling electrical circuit material"* are the results from Mike Adam's near-final lab analysis of the [rubbery white clots](#) that are being found by morticians in veins and arteries of the prematurely-deceased jab victims all over the world.

Mike is the only microscopy expert who's been willing to step forward and analyze these unprecedented clots and he gives us his in-depth analysis, here.

Mike says, *"The instrument that I knew that would be the most accurate for this analysis is called the ICP-MS, that's [Inductively Coupled Plasma Mass Spectrometry](#)...We took these clots from [20-year board certified embalmer] Richard Hirschman and we ran the ICP-MS analysis and we also took a live blood sample from a healthy human being who was not vaccinated and then we compared the blood to the clots with an elemental analysis breakdown."*

Mike explains that the elements found in animal life were relatively lacking from these clots. What the clots do contain in higher amounts are elements that you find in circuitry or machinery or electrically-conductive systems. Tin is being found in these clots, as well as sodium, which is an alkaline metal that is highly-conductive and aluminum, which is used in wiring, having lately come to replace copper, since copper has gotten so expensive.

"We see higher amounts of elements that you would find in AI robots or circuits, circuitboards, things like that. We have much lower concentrations of things that you might find in a human being."

Mike goes on to say that the clots are self-assembling biostructures. So, they increase in size over time and as they're increasing in size, they are accumulating or harvesting from the blood these electrically-conductive elements that we've mentioned; tin, aluminum and sodium, in particular. So in other words, these are self-assembling machines of some kind that are biologically 'compatible' for a period of time and as they grow, they take up more and more of the cross-sectional space in the arteries and blood vessels.

"Now, at first, the blood flows around them...but they can also be dislodged with a certain amount of force, such as if you're out jogging and your heart rate goes up and your blood pressure's much higher, we believe this is why some doctors are dropping dead as they're jogging, because a clot is dislodged..."

"[But] if it continues to grow, it's going to take up the entire space of the blood vessel. When it does that, then obviously, the blood flow is blocked and that person loses that blood flow through that part of the body being served by that vessel or artery and this is, I believe the explanation for quote 'Died suddenly' and it's also the explanation for some people that have to have their hands or feet amputated, because they're losing blood flow to those extremities."

"So the kicker here is that this is going to worsen over time. There are people walking around today who've had the shots and they have the clots and they're going to die at some point, as the clots get larger."

Dr. Ruby points out that Richard Hirschman, the embalmer who provided these clots for analysis has noticed that when he has stored the clot samples in a refrigerator, that they continued to grow.

"Once you understand that these clots are, in effect harvesting and organizing conductive elements from the blood – and that's a fact. It sounds like science fiction but that's a confirmed fact, at this point – you have to wonder, 'Well what is it doing with these elements?'"

Mike speculates that having these elements present in the body could also make people just as vulnerable to an EMP attack as electronic devices are.

Mike also analyzed some vaccines, as well and he's not ready to release all of that information except to say that his lab has detected several industrial metals, like cadmium in them. He will be making a report soon about his lab analysis of the vaccines.

Mike says, "What's clear to me is that this is a depopulation weapons system. The Globalists realize that in order for them to depopulate the planet, they didn't need to run Zyklon B ovens or chambers, they didn't need to shoot everybody with kinetic weapons, they didn't need to do any of that."

"All they needed to do was release a biological weapon and scare everybody into taking shots and the shots kill you over time. And they've given 12 billion doses now on the planet, which is 1.5 doses for every person on the planet. They've given, like 600 million doses in the United States, which is almost 2 doses for every American – not every person has taken a dose, obviously – some people have taken multiple doses."

"My concern is the ticking time bombs of clot death and that they're going to die over the next ten years and I don't know any way to stop the growth of these clots...we know that the anti-clotting pharmaceuticals do not, because I've interviewed physicians who have been in the emergency centers, they've tried to treat these clots with the normal drugs, like Heparin – it does nothing."

Mike believes that even if we stop vaccinating right now, we will see tens of millions of deaths from the Death Shot.

It would be great if someone besides him would be willing to investigate these clots. His ICP-MS system does not detect things at a molecular scale, e.g., the mRNA molecules and the proteins present in the vaxx and in the clots. He says, "We need a protein analysis that can handle the very large molecules of proteins. They're very high daltons, in terms of their total mass."

"We've done some analysis on this in the past, with some [time-of-flight mass-spec](#) instrumentation and there's special software you have to use and it's called [deconvolution software](#) that can reassemble the predicted structure of the proteins, because frankly, the large proteins can't survive the [liquid chromatography-mass spectrometry](#)."

"There's this statistical analysis software that tries to take a guess at what it was. If there's somebody out there who can do that, I probably will get to it, eventually. It might take us 6 more months to do that. Somebody else could do it right now, if they had the balls just to do it and release the results but my guess is nobody's gonna do it..."

"I strongly suspect that there is a phytochemical of a phytonutrient from the plant world that will halt the growth of these clots...For example, we know that [sulforaphane](#) from broccoli and broccoli sprouts halts the angiogenesis from cancer tumors. That's the process by which cancer tumors build blood vessels to rob supply of your blood in order to grow their own tumor size."

"So an anti-angiogenesis molecule would be a candidate for this but we need, frankly, in order to run those kinds of tests, you would need many millions of dollars in funding and a willingness of some institution, some university to look at the clots and run the tests and see what stops the clots and they're not gonna do that, because they're all in with the scam of mass genocide."

"We're living under a system of scientific genocide of the human race. They don't want to stop the deaths. Simple as that."

Mike says he'd like for Richard Hirshman to get him a sample of an artery with the clot attached so they could study how it attaches to the walls.

Dr. Ruby then brings on Clay Clark, who talks about [Executive Order 14067](#), Section 4., which he says mandates that by December 13, 2022, you will need to be vaxxinated in order to transact in the U.S. Central Bank Digital Currency (CBDC).

More Than 1,000 Reports of Adverse Events After COVID-19 Vaccination in Children 5 and Younger, CDC Data Shows

More than 1,000 reports of adverse events have been lodged with U.S. authorities following COVID-19 vaccination in children aged 5 and younger.

More than 1,000 reports of adverse events have been lodged with U.S. authorities following [COVID-19](#) vaccination in children aged 5 and younger.

As of Aug. 21, 996 non-serious reports have been entered into the Vaccine Adverse Event Reporting System ([VAERS](#)) for children 4 or younger who received a Pfizer vaccine and children 5 or younger who received a Moderna vaccine, Dr. Tom Shimabukuro said on Sept. 1.

Shimabukuro is a researcher with the [Centers for Disease Control and Prevention](#) (CDC), which runs VAERS with the U.S. Food and Drug Administration.

Most of the adverse event reports have been for outcomes designated non-serious, or events that did not include death, a life-threatening illness, hospitalization or prolongation of hospitalization, permanent disability, congenital anomaly or birth defect.

Of the reported events, 19 were designated serious, with nine for children who received a [Moderna vaccine](#) and 10 for children who received a [Pfizer vaccine](#). Details omitted.

The serious events were not detailed.

“Those details should not have been left out of the information released to ACIP [Advisory Committee on Immunization Practices] and the public,” Barbara Loe Fisher, co-founder and president of the National Vaccine Information Center, told The Epoch Times in an email.

[Shimabukuro was presenting](#) the [data to the ACIP](#), which advises the CDC on vaccine guidance.

The most commonly reported events after receipt of Pfizer’s vaccine were errors in dosing, such as an incorrect dose being administered. Fever, rash, vomiting, fatigue and diarrhea were also commonly reported. The most commonly reported events after receipt of Moderna’s vaccine were fever, rash, vomiting and hives.

The number of reports represented 0.06% of the doses administered to children aged 5 or younger, who only became eligible for a vaccine in mid-June.

Shimabukuro said the data from VAERS and other systems did not reveal any new safety concerns.

Anybody can make reports to VAERS, but making a false report subjects a person to a criminal charge. Health care professionals are required to report [adverse events](#) for the vaccines under emergency use authorization. Both the Pfizer and Moderna vaccines are under emergency use authorization for young children.

However, research has found that the number of reports submitted to VAERS is an undercount of the actual number of adverse events.

“Even though not every adverse event reported to VAERS is causally related to vaccination, it is also true that one [CDC-funded study](#) estimated that less than one percent of vaccine adverse events that occur are reported to VAERS,” Fisher said.

Myocarditis

No cases of heart inflammation have been reported following COVID-19 vaccination in young children.

Myocarditis and pericarditis, forms of heart inflammation, were also not detected in the original clinical trials. Studies have since [conclusively linked](#) them to the [Moderna and Pfizer](#) vaccines.

The reported rates of [myocarditis](#) after dose 2 of a primary series are elevated for males aged 5 to 49 and females aged 12 to 29. The highest reported rate is 78.7 per million second doses administered, for males between 16 and 17 years old.

The reported rates remain elevated for males 12 to 29 after a booster dose, Shimabukuro said. The rates do not remain elevated for females of any age after a booster dose, according to the VAERS data.

The CDC has verified 131 of the myocarditis case reports among people [aged 5 and up](#) after [booster shots](#).

Data from another surveillance system run by the CDC, the Vaccine Safety Datalink, showed a safety signal for a first booster for myocarditis and pericarditis after a first booster.

The Pfizer vaccine caused 61.7 excess [heart inflammation](#) events for males aged 12 to 15 and 189 excess events for males aged 16 and 17. The vaccines caused 30.9 excess events for males aged 18 to 39.

The rates were higher for both males and females aged 16 and 17 after a booster of Pfizer's shot, though the higher rates were not statistically significant because of the low number of events, Shimabukuro said.

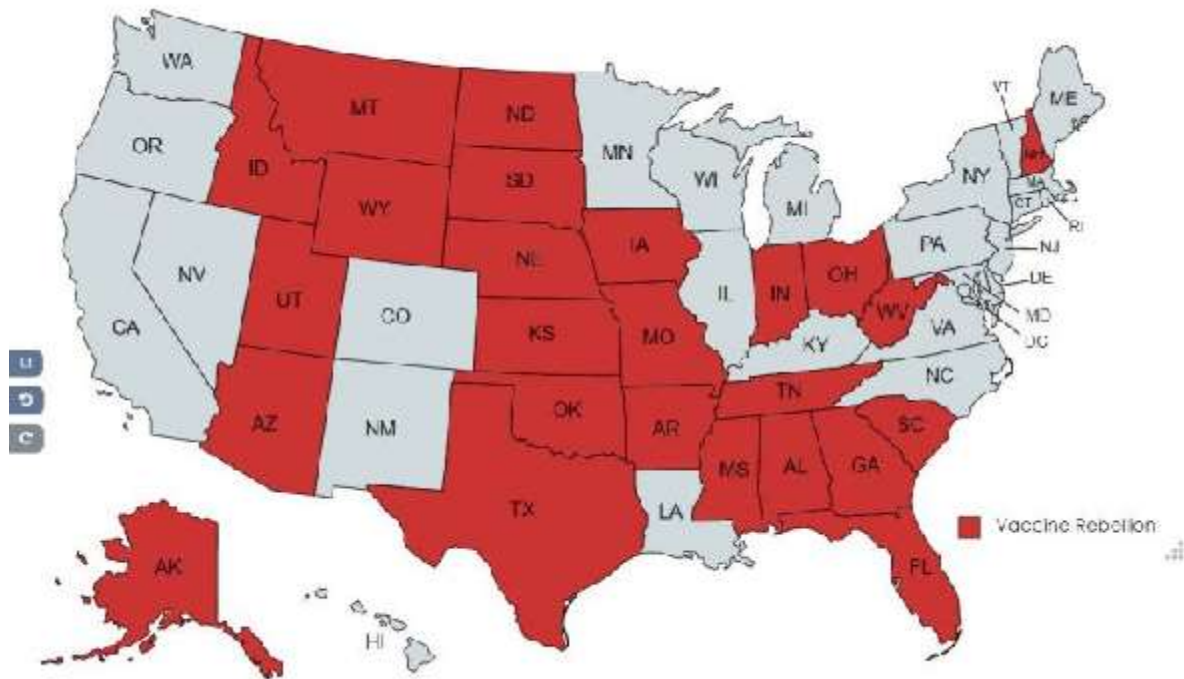

Republican-led states in the south see shocking excess mortality rates after covid vaccine rollout.

Even more shocking, the greatest excess in mortality was seen in Republican-led states during the third quarter of 2021. Data Reveals COVID Vax Has Killed 5 To 12 MILLION People Worldwide

What is the number of deaths, worldwide, from Covid injections? By doing a rough calculation Steve Kirsch arrives at a ballpark figure of 12 million.

To give the number some context, that is 40x the number of Americans who were killed in World War II (“WWII”). It’s more than double the number killed by Covid, Kirsch wrote.

WWII is recognized as beginning on [3 September 1939 when Great Britain and France declared war on Germany](#) after Germany invaded Poland. It ended in 1945 after Japan formally surrendered.

[According to Britannica](#), about 298,000 Americans died during WWII. In total, an estimated 40,000,000 to 50,000,000 people died worldwide over the six years of WWII.

The first Covid shot was delivered by [Great Britain on 8 December 2020](#) “marking the start of a historic mass vaccination program.” France [delivered its first shot](#) 19 days later on 27 December 2020.

The Covid shot campaign has, so far, been going for 20 months. According to *Our World in Data* 12.46 billion shots have been delivered, 5.89 million per day. However, [according to data collected by Bloomberg](#), “the latest rate was roughly 8.46 million doses a day ... 159 shots for every 100 people worldwide.”

Yesterday, 15 August, [Britain became the first country](#) in the world to approve Moderna’s “next generation” Covid shot – Spikevax Bivalent.

[Margaret Anna Alice](#) asked if anyone could estimate the global death toll from the Covid shots.

In my opinion, a reasonable estimate is to divide the number of doses by 1,000.

If you do that for the 600 million doses delivered in the U.S., you get 600,000 deaths which is right in the ballpark.

A more conservative number is to divide the number of doses by 2,500. This is the number [Mathew Crawford estimated from global data: 411 deaths per million doses](#). Earlier, I offered a \$1 million reward to anyone who found a significant error in his work. No takers. This is [documented on my Substack](#) and in my Twitter stream, but, of course, everything I tweeted was deleted by Twitter as being unsafe. A free \$1 million no strings attached. Nobody accepted.

So that conservative estimate gets you to 5 million killed (only 16x the number of Americans killed in World War II).

We are approaching the [6 million Jews killed in the Holocaust over 12 years](#).

But we are killing people worldwide at a rate at least 6x faster than the Germans did.

We are killing nearly close to 10,000 people every single day (the latest rate was roughly 8.46 million doses a day).

Interestingly, this is not self-limiting because [385,000 babies are born every day](#). So, the killing can go on indefinitely, even if the birth rate drops by 90% due to the shots.

In case you were wondering. I just thought I'd point that out.

RNA for Moderna's Omicron Booster Manufactured by CIA-Linked Company

Since late last year, messenger RNA for Moderna's COVID-19 vaccines, including its recently reformulated Omicron booster, has been exclusively manufactured by a little known company with significant ties to U.S. intelligence.

Earlier this week, the United Kingdom became the first country to approve Moderna's reformulated version of its COVID-19 vaccine, which claims to provide protection against both the original form of the virus and the significantly less lethal but more transmissible Omicron variant. The product was [approved by](#) the UK's Medicines and Healthcare Products Regulatory Agency (MHRA) with the support of the UK government's Commission on Human Medicines.

Described by UK officials as a "[sharpened tool](#)" in the nation's continued vaccination campaign, the reformulated vaccine combines the previously approved COVID-19 vaccine with a "[vaccine candidate](#)" targeting the Omicron variant BA.1. That vaccine candidate has never been previously approved and has not been the subject of independent study. The MHRA approved the vaccine based on a single, incomplete human trial currently being conducted by Moderna. The company promoted incomplete data from that trial in company press releases in [June](#) and [July](#). The study has yet to be published in a medical journal or peer reviewed. No concerns have been raised by any regulatory agency, including the MHRA, regarding [Moderna's past history](#) of engaging in suspect and likely illegal activity in past product trials, including for its original COVID-19 vaccine.

The approval comes shortly before several Western countries, including the UK, plan to conduct a massive COVID-19 booster vaccination campaign this fall. Moderna has also noted that approval for its Omicron booster vaccine are pending in the US, EU, Australia and Canada – all of which are also planning fall vaccination campaigns focused on COVID-19. The company's CEO, Stéphane Bancel, [has called](#) the reformulated vaccine *"our lead candidate for a Fall 2022 booster."*

However, unlike the company's original COVID-19 vaccine, the genetic material, or messenger RNA (mRNA), for this new vaccine, including the newly formulated genetic material meant to provide protection against the Omicron variant, is being manufactured, not by Moderna, but by a relatively new company that has received hardly any media attention, despite its overt links to U.S. intelligence. Last September, it was [quietly announced](#) that a company called National Resilience (often referred to simply as Resilience) would begin manufacturing the mRNA for Moderna COVID-19 vaccine products. Under the terms of the multi-year agreement, *"Resilience will produce mRNA for the Moderna COVID-19 vaccine at its facility in Mississauga, Ontario, for distribution worldwide."*

U.S. Government Complicit In Creating Covid

[US government might have been complicit in creating Covid](#). Moscow is examining the likelihood that a Washington, DC agency was involved in the development of Covid-19.

According to the Russian Ministry of Defense, USAID's potential involvement in the development of the Covid-19 virus is being looked into.

In a press conference on Thursday, Lieutenant-General Igor Kirillov, the head of Russia's radiation, chemical, and biological defense forces, asserted that U.S.-backed bio laboratories in Ukraine had been using Ukrainian residents in [dubious clinical trials and research](#), and that *"over 16,000 biological samples, including blood and serum samples, were exported from the territory of Ukraine to U.S. and European countries."*

He continued by mentioning that a comment made by Jason Crow, a member of the U.S. House Intelligence Committee, warning Americans that their DNA samples could be used to construct specialized biological weapons, prompted Russia's Defense Ministry to *"take a fresh look"* at the roots of the Covid outbreak.

“Taking into account the interest of the U.S. administration in the study of narrowly targeted biological agents, such statements force us to take a fresh look at the causes of the novel coronavirus pandemic and the role of U.S. military biologists in the emergence and spread of the Covid-19 pathogen,” Kirillov said.

According to Kirillov, who cited a Lancet article by Columbia professor Jeffry Sachs who proposed that the virus was probably made in a lab with the aid of America’s most recent achievements in the field of biotechnology, Russia presently doubts that USAID possibly was directly culpable for the onset of the Covid-19 virus.

In 2009, USAID began supporting a project called *“Predict,”* which involves capturing wild bats afflicted with novel coronaviruses for scientific purposes. Kirillov noted that one of the project’s contractors, Metabiota, was well-known for its military biological functions on Ukrainian soil.

The FDA discontinued the *“Predict”* initiative in 2019, and at the same time, the Johns Hopkins Center for Health Security started researching the transmission of a previously unidentified coronavirus.

“The implementation of the COVID-19 development scenario and USAID’s emergency phasing out of the Predict program in 2019 suggest the deliberate nature of the pandemic and US involvement in its occurrence,” Kirillov said.

He continued by saying that the recent appearance of the monkeypox virus and the U.S.’s alleged history of employing biological weapons against adversaries have caused Moscow to notice a *“clear trend”* of pathogens that, for whatever reason, the Pentagon is interested in, subsequently developing into pandemics.

The U.S. maintains that it did not use Ukrainian bio-labs for military research and that Kiev used the *“46 peaceful Ukrainian laboratories, health facilities and disease diagnostic sites”* to help improve biological safety, security, and disease surveillance for both human and animal health. The denial persisted for several months until evidence was submitted at the UN exposing the U.S. *“peaceful”* (sic) labs were engaged in weaponization of the Coronavirus SARS2-Cov-2.

The Covid-19 virus’s precise origin has not yet been proved beyond a reasonable doubt. The World Health Organization (WHO) asserted that it was most probably spread from an animal, presumably a bat, to people in February 2021.

Scientists with ties to Bill Gates and Anthony Fauci Admit to Developing Vaccine that Spreads Like a Virus

Scientists linked to Bill Gates said they are developing a [vaccine that spreads like a virus](#).

The research is subsidized by high-profile funding organizations with longstanding and close financial ties to the Bill & Melinda Gates Foundation. It is also supported by the National Institutes of Health, the mother agency of Dr. Anthony Fauci's National Institute of Allergy and Infectious Diseases.

[Self-spreading vaccines](#) are rooted in efforts to reduce pest populations. The virally-spread immune-contraception hijacks the immune

systems of infected animals like non-native mouse species, preventing them from fertilizing offspring.

The earliest self-spreading vaccine efforts targeted two highly lethal infectious diseases in the European rabbit population in 2001. Spanish researchers field-tested a vaccine in the wild rabbit population on a small island just off Menorca. The vaccine spread to over half the 300 rabbits on the island, and the trial was said to be a success.

While the researchers may intend to make self-spreading vaccines, there could be ways to repurpose this science to develop biological weapons, which may prove uncontrollable and irreversible.

Humans have been weaponizing biology since 2000. A new virus has been released every two years since 2000. Dr. David L. Martin has been studying the patents issued since the late 1990s and has confirmed this to be TRUE!

Humans have already weaponized biology on several occasions. As the apartheid-era South African bio-warfare program showed, social, political and scientific pressures can lead to the misuse of biological innovation.

Project Coast, as it was called, was South Africa's program primarily focused on covert assassination weapons for use against individuals deemed a [threat to the racist apartheid government](#). In addition to producing contraptions to inject poisons, Project Coast researchers developed techniques to lace sugar cubes with salmonella and cigarettes with Bacillus anthracis.

There had been many bio warfare programs, including several that were far more elaborate and sophisticated, but the South African program is important in thinking through malicious uses of self-spreading vaccines. One of Project Coast's research projects aimed at developing a human anti-fertility vaccine.

This idea came at a time when there was widespread concern over population explosion. Schalk Van Rensburg, who oversaw the fertility-related work at Project Coast, believed that this could bring his lab international acclaim and funding. (Related: [The Bill Gates globalist vaccine depopulation agenda... as revealed by Robert F. Kennedy, Jr.](#))

Van Rensburg and the director of the bio warfare program, Wouter Basson, said the military needed an anti-fertility vaccine for female soldiers not to become pregnant.

Other scientists involved in the project denied awareness of ulterior intentions or even their fertility work as part of a military endeavor. However, Van Rensburg and lab director Daniel Goosen said the real intention of the project was to

selectively administer the contraceptive in secret to unsuspecting Black South African women.

In the end, the anti-fertility vaccine was not produced before Project Coast officially closed down in 1995 – 12 years after it was initiated. It ended with an earlier version tested in baboons, but never in humans. (Related: [Bill Gates pushes for a 90 percent vaccination rate worldwide.](#))

South Africa was not the only country to try to forcibly sterilize its population. European countries like Sweden and Switzerland sterilized members of the Roma minority in the early half of the 20th century, while countries like Slovakia continued beyond that.

More recently, analysts alleged that the Chinese government has been sterilizing women in Xinjiang, which is a province with a large population of Uyghur Muslims.

The Defense Advanced Research Projects Agency (DARPA) has also gotten involved in the research. The [University of California, Davis](#) has been working on a DARPA-administered project that is creating the first prototype of a self-disseminating vaccine designed to induce a high level of herd immunity against the Lassa virus and Ebola.

Biden Administration to Shift COVID Vaccine Distribution to Private Sector Despite Plans to Extend Public Health Emergency

The Biden administration Aug. 30 announced it plans to shift distribution of COVID-19 therapeutics to the private sector by January 2023 — despite preparing to extend its COVID-19 public health emergency.

The Biden administration Aug. 30 announced it plans to shift [distribution of COVID-19 therapeutics](#) to the private sector by January 2023 — despite preparing to [extend its COVID-19 public health emergency](#).

Specifically, the U.S. Department of Health and Human Services (HHS) [said](#) that it expects its supply of [COVID-19](#) vaccines and treatments to be depleted in the coming months, and is now preparing for the availability of these products to transition to the commercial market.

This announcement comes despite the Biden administration's purchase of 170 million doses of [updated COVID-19 booster shots](#), which are expected to be available to the public sometime in September as part of an [autumn vaccination campaign](#).

The Hill described the announcement as one which marks *“a new phase in fighting the pandemic,”* adding that it *“would be another sign that the administration views the acute emergency phase of the pandemic as ending.”*

However, HHS, the parent agency of the Centers for Disease Control and Prevention (CDC), indicated in mid-August it will likely [extend](#) the COVID-19 public health emergency for another 90 days, when the current 90-day period expires on Oct. 15. The public health emergency had previously been [renewed](#) on July 15, its tenth extension since initially being declared on Jan. 31, 2020.

Adding to the mixed messaging, the CDC August 11 announced the [reversal of its COVID-19 guidance](#), rescinding its previous distinctions between the vaccinated and unvaccinated. This was followed by the CDC’s Aug. 17 announcement that the [agency will undergo an “overhaul”](#) as a result of its *“botched”* response to COVID-19.

The Biden administration’s plans to shift the procurement of COVID-19 vaccines and therapeutics to the [private sector](#) were first indicated the same week as the aforementioned CDC announcements.

On Aug. 16, Dr. Ashish Jha, the White House’s COVID-19 response coordinator, speaking at an event sponsored by the U.S. Chamber of Commerce Foundation, said the government was working on emerging out of the *“acute emergency phase”* and moving COVID-19 vaccines, treatments and tests to the commercial market.

In remarks made to The Defender, Mary Holland, president of Children’s Health Defense, described the Biden administration’s COVID-19 policies as *“incoherent.”* *“It seems to me that these policies are at cross-purposes,”* Holland said, referring to the Biden administration shifting distribution of COVID-19 therapeutics to the private sector while maintaining the public health emergency.

She added:

“[HHS] has asserted that there is a continuing emergency, giving the federal government the broadest of liability protections, and at the same time, HHS’ own CDC has, in a sense, walked back every dimension of their control.”

“They shouldn’t be able to have it both ways. Either there’s an emergency and they do everything possible to alleviate the burden of this disease threat in the way that they have told us to do it, or there’s no emergency and they lose all of their emergency powers, including the liability protection.”

“In this case, the Biden administration should end the Secretary of Health’s emergency declaration that still continues in effect.”

Maintaining the declared public health emergency may, however, be connected to the continued availability of the COVID-19 vaccines themselves.

As reported by Politico, although therapeutics such as COVID-19 vaccines were issued under an Emergency Use Authorization (EUA) granted by the U.S. Food and Drug Administration (FDA), it is a [separate declaration](#) — under the HHS’ Federal Food, Drug and Cosmetic Act — that allows the agency to issue EUAs in the first place.

According to Politico, the eventual termination of the COVID-19 emergency declaration will not necessarily mean that products currently being administered under EUAs will be withdrawn from the market. HHS Sec. Xavier Becerra will have to announce an end to the separate HHS declaration under the Federal Food, Drug and Cosmetic Act.

This is of particular significance considering COVID-19 vaccines that are “fully licensed” by the FDA, including [Pfizer’s Comirnaty](#) and Moderna’s Spikevax, continue to be largely or wholly unavailable throughout the U.S., with vaccines issued under EUA being administered instead.

There may also be political implications in the Biden administration’s intended shift to private distribution of COVID-19 therapeutics, and the CDC’s recent rollbacks of its COVID-19-related policies.

On Aug. 22, [Dr. Anthony Fauci](#) announced he will [step down](#) from his government positions.

In a recent interview with The Defender, [Dr. Robert Malone](#), a critic of vaccine mandates and COVID-19 countermeasures, suggested that Fauci’s sudden resignation is at least partly motivated by his flagging popularity hurting the Democrats in polls, with the midterm Congressional elections looming in November.

In March 2022, The Defender reported that the Biden administration was following the recommendations of a prominent polling firm which advised it to shift away from aggressive policies and messaging concerning COVID-19, due to flagging [poll numbers](#).

Remarking on the possibility that the Biden administration’s recent COVID-19-related moves may be politically motivated, Holland likened the government’s strategy to “Pavlovian techniques,” referencing an [MIT Technology Review article](#) published in 2020 suggesting what was to come.

She told The Defender:

“Pavlovian techniques are not constant pressure. They are pressure, release, pressure, release, freeze.”

“So they’re taking off the pressure now. And I believe after the midterm elections are over, there will be an effort to reestablish more draconian measures, like at least social distancing, recommended masks, potentially reasserting discrimination between the vaccinated and unvaccinated.”

Dr. Joseph Mercola in a recent article expressed a similar perspective, writing:

“The CDC’s about-face appears to be [politically motivated](#), to give the Biden administration a ‘win’ before the midterm elections.”

“Post-election plans include ‘the biggest vaccination campaign in history,’ so tyrannical overreaches may later resume, even as mounting data show the COVID-19 shots are causing depopulation.”

However, Holland added her view that perhaps, above all, there is simply a great deal of confusion within the Biden administration regarding its next steps pertaining to COVID-19.

She told The Defender:

“I would be hesitant to ascribe too much coherence to any of this. I think the narrative has fallen apart because the shots don’t work and they’re incredibly dangerous. They don’t stop transmission or infection.”

“The evidence that they’ve now stopped collecting data overwhelmingly supports the idea that these shots are causing all-cause excess mortality.”

“I think it’s just an incoherent situation in a sense. I would tend to think there are some people in control who don’t really know exactly what to do next.”

According to The Hill, the [Biden administration](#) likely believes that “*purchasing and distribution of measures to fight COVID-19 should [now] work more like the rest of the health care system,*” instead of the government “*playing the leading role.*”

Speaking on Aug. 16, [Jha said](#), “*My hope is that in 2023, you’re going to see the commercialization of almost all of these products.*”

In an Aug. 30 blog post, Dawn O’Connell, an assistant secretary of HHS, stated that it was always the Biden administration’s intent to shift away from its central role in coordinating the availability and [distribution of COVID-19 treatments](#), but said that the process has now been hastened due to a lack of Congressional funding for the continued procurement of therapeutics.

As a result, according to O'Connell:

"As early as January 2023, the administration anticipates no longer having federal funds to purchase or distribute vaccines and will need to transition these activities to the commercial market, similar to seasonal flu or other commercially available vaccines."

A lack of continued funding has also been cited as the reason why the government will cease making free at-home COVID-19 tests available to Americans beginning next week.

O'Connell said Congress could still provide funding that would facilitate an "orderly" transition to the private sector, allowing for *"equitable distribution and coverage for the underinsured and uninsured."*

She also argued that *"additional COVID-19 funding"* from Congress is *"urgently needed for a range of critical response needs, including the development of next-generation vaccines, therapeutics, and tests."*

Presumably, in preparation for this transition, HHS held a planning meeting with representatives of the healthcare industry, state governments and patient advocates Aug. 30, The Hill reported.

[Hospital lobbyists](#) have [pushed](#) for the "public health emergency" declaration to be maintained.

The impending transition of COVID-19 vaccine and treatment procurement to the private sector raised some concerns from [public health advocates](#), who argued that [the uninsured](#) would have a more difficult time accessing these products.

Others argued that this transition may [worsen vaccine uptake](#) and make it more difficult to overcome "vaccine fatigue" and encourage the public to receive boosters.

Concerns were also raised over ["issues of equity,"](#) based on claims that *"minority and ethnic populations will not be able to take advantage of the new updated COVID-19 vaccines as readily as better-advantaged people."*

The latter argument mirrors concerns that were recently raised in response to Washington, D.C.'s vaccine mandate for schoolchildren age 12 and over, addressing particularly low vaccination rates among African American students. The [enforcement date of the vaccine mandate](#) was ultimately postponed.

Perhaps in response to flagging vaccination rates among some minority groups, as well as white conservatives and others, the [Rockefeller Foundation](#) and the Social Science Research Council recently launched a new initiative, [The Mercury](#)

Project, aimed at developing more “effective” messaging promoting COVID-19 vaccines.

Indeed, Newsweek reports that, according to CDC data, vaccination rates have lost momentum, as “just” 51.6% of U.S. adults have received a booster shot, and only 33.7% of those age 50 and over have received the second booster, which was first recommended by the CDC in March.
