

How Close is Medical Martial Law?

It's Now Looking A Lot Closer Than We Thought

The CDC (Center for Disease Control) and the WHO (World Health Organization) are two of the most corrupt organizations in the world. That point made clear, these two government agencies have the power of Legal Authority to impose Isolation and Quarantine.

Federal isolation and quarantine are authorized for these communicable diseases:

- Cholera
- Diphtheria
- Infectious tuberculosis
- Plague
- Smallpox
- Yellow fever
- Viral hemorrhagic fevers
- Severe acute respiratory syndromes
- Flu that can cause a pandemic

Federal isolation and quarantine are authorized by Executive Order of the President. The President can revise this list by Executive Order.

Isolation and Quarantine

Isolation and quarantine help protect the public by preventing exposure to people who have or may have a contagious disease.

- Isolation separates sick people with a quarantinable communicable disease from people who are not sick.
- Quarantine separates and restricts the movement of people who were exposed to a contagious disease to see if they become sick.

In addition to serving as medical functions, isolation and quarantine also are “police power” functions, derived from the right of the state to take action affecting individuals for the benefit of society.

Federal Law

The federal government derives its authority for isolation and quarantine from the Commerce Clause of the U.S. Constitution.

Under section 361 of the Public Health Service Act (42 U.S. Code § 264), the U.S. Secretary of Health and Human Services is authorized to take measures to prevent the entry and spread of communicable diseases from foreign countries into the United States and between states.

The authority for carrying out these functions on a daily basis has been delegated to the Centers for Disease Control and Prevention (CDC).

CDC's Role

Under 42 Code of Federal Regulations parts 70 and 71, CDC is authorized to detain, medically examine, and release persons arriving into the United States and traveling between states who are suspected of carrying these communicable diseases.

As part of its federal authority, CDC routinely monitors persons arriving at U.S. land border crossings and passengers and crew arriving at U.S. ports of entry for signs or symptoms of communicable diseases.

When alerted about an ill passenger or crew member by the pilot of a plane or captain of a ship, CDC may detain passengers and crew as necessary to investigate whether the cause of the illness on board is a communicable disease.

State, Local, and Tribal Law

States have police power functions to protect the health, safety, and welfare of persons within their borders. To control the spread of disease within their borders, states have laws to enforce the use of isolation and quarantine.

These laws can vary from state to state and can be specific or broad. In some states, local health authorities implement state law. In most states, breaking a quarantine order is a criminal misdemeanor.

Tribes also have police power authority to take actions that promote the health, safety, and welfare of their own tribal members. Tribal health authorities may enforce their own isolation and quarantine laws within tribal lands, if such laws exist.

Who Is in Charge

The federal government

- Acts to prevent the entry of communicable diseases into the United States. Quarantine and isolation may be used at U.S. ports of entry.
- Is authorized to take measures to prevent the spread of communicable diseases between states.
- May accept state and local assistance in enforcing federal quarantine.

- May assist state and local authorities in preventing the spread of communicable diseases.

State, local, and tribal authorities

- Enforce isolation and quarantine within their borders.

It is possible for federal, state, local, and tribal health authorities to have and use all at the same time separate but coexisting legal quarantine power in certain events. In the event of a conflict, federal law is supreme.

Enforcement

If a quarantinable disease is suspected or identified, CDC may issue a federal isolation or quarantine order.

Public health authorities at the federal, state, local, and tribal levels may sometimes seek help from police or other law enforcement officers to enforce a public health order.

U.S. Customs and Border Protection and U.S. Coast Guard officers are authorized to help enforce federal quarantine orders.

Breaking a federal quarantine order is punishable by fines and imprisonment.

Federal law allows the conditional release of persons from quarantine if they comply with medical monitoring and surveillance.

In the rare event that a federal order is issued by CDC, those individuals will be provided with an order for quarantine or isolation. An example of a Quarantine Order for Novel Coronavirus is provided. This document outlines the rationale of the federal order as well as information on where the individual will be located, quarantine requirements including the length of the order, CDC's legal authority, and information outlining what the individual can expect while under federal order.

Federal Quarantine Rarely used

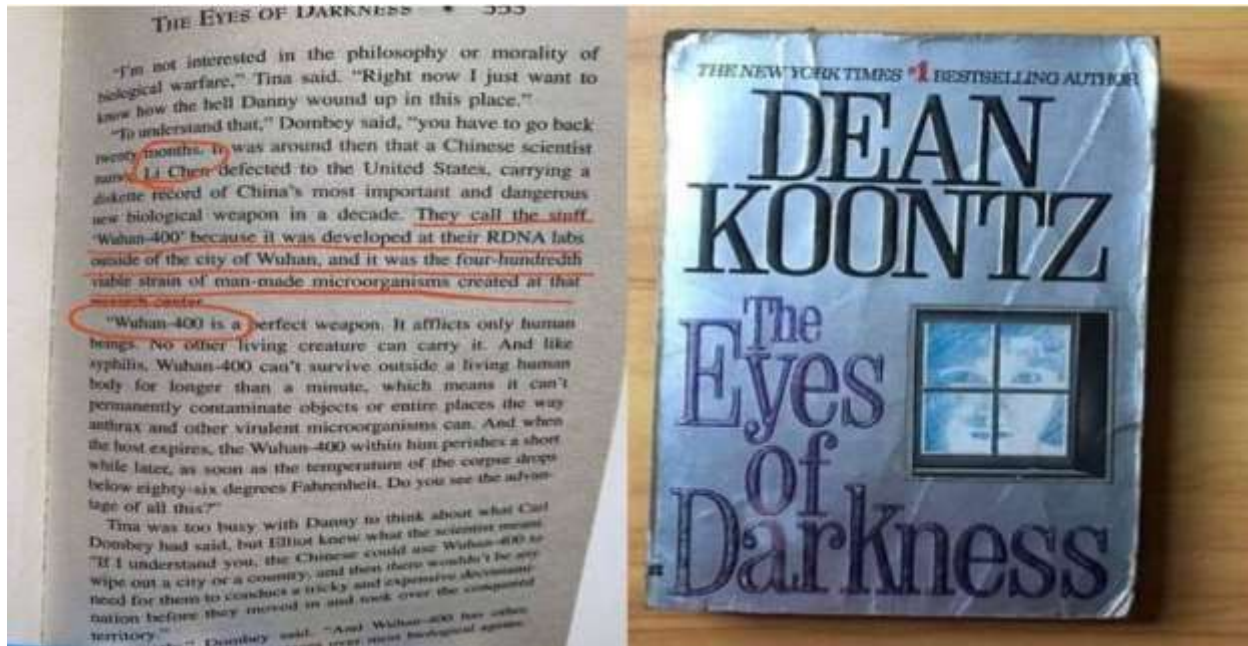
Large-scale isolation and quarantine was last enforced during the influenza ("Spanish Flu") pandemic in 1918–1919. In recent history, only a few public health events have prompted federal isolation or quarantine orders.

The information cited above comes from the CDC web site. The reason for raising this issue has been heightened by the Wuhan, China outbreak of a so-called Coronavirus. All of the evidence suggests a collaborative effort to fake a pandemic to mask the real cause of what has happened in China and its spread; namely, that this being a laboratory made race-based bioweapon. Asian and Asian-Americans as well as Iranians appear to have a higher fatality rate than other

racers. This has all the marks of an intentional release into the public pathogens that are specifically targeted to those people mentioned.

Eyes of Darkness - Co-incidence?

Fans of author Dean Koontz are insisting that a novel he wrote in 1981 predicted the coronavirus outbreak. Koontz's thriller *'The Eyes Of Darkness'* describes a killer virus named 'Wuhan-400' after the Chinese city it originated in — the same city where coronavirus (COVID-19) was first reported.



Some have suggested this research center could be referring to the Wuhan *Institute of Virology*, which is where China's only level four biosafety laboratory is located. It has the highest-level classification of labs studying the deadliest viruses and is situated 20 miles from where the current COVID-19 first broke out.

What did Dean Koontz know 38 years in advance? **Could this really be co-incidence?**

The American public is continually being sensitized or conditioned to a series of yearly viruses going back to 2004 with SARS, 2008 with the Avian Flu, 2010 with the Swine flu, 2012 MERS, 2015 with EBOLA, 2018 with ZIKA, and 2020 with the Corona COVID-19. This is not an inclusive list of so-called viruses, but it shows a pattern, since every winter season seems to bring a new bug and new fears. Remember, fear and greed are the two most powerful emotions to motivate and manipulate the public. We know to expect shortages, price gouging, rationing, out of stock situations. Even Amazon has been raising prices, ever so slightly, during the last week of February, 2020.

It is no secret that the Bible has made specific prophecies regarding a major rise in hideous disease outbreaks that would impact mankind significantly as we move closer towards the end of this age, especially in Revelation 6.

Viewing the four riders of the apocalypse the apostle John describes the fourth horse and rider using specific and un-complicated verbiage: The horse is "pale," the rider's name is "Death," and "Hades" follows him. This is the extent of the biblical description, yet even so, these provide us with sufficient clues to deduce a convincing interpretation.

First, the horse's coat is a unique and otherworldly pale. The Greek word is "**chlooros**", which we recognize as the origin of such English words as "chlorine," "chloroform," and "chlorophyll." It technically refers to a greenish-yellow color found in nature in the pale green of just-sprouted grass or new leaves -(see Mark 6:39; Revelation 8:7; 9:4; these are "**chlooros**" only other occurrences in the New Testament).

It is this last description that is probably John's intended meaning; the color of the horse reminded him of the pale, greenish-gray color of a corpse or decaying flesh. The Phillips translation renders **chlooros** as "sickly green in color"; the New English and the Revised English Bibles, as "sickly pale"; the New Jerusalem Bible, as "deathly pale"; and the New Living Translation, as "pale green like a corpse." The fourth horse sports a coat only producers of horror movies would love!

Upon the back of this gruesome beast sits one whose name is "Death." This is another unique feature of this horseman, as none of the other three riders receives a name. The Greek word is the normal word for "death," "**thánatos**", suggesting on the surface a generic application of the term. However, this would be jumping to a conclusion, for the term is probably meant to be understood more specifically as "pestilence" or "disease."

The most convincing piece of evidence for "**thánatos**" meaning "pestilence" in this passage comes from the mouth of Jesus in the Olivet Prophecy, as He describes the events leading up to His return. He prophesies to his disciples, "**And there will be famines** [third seal or horseman], **pestilences** [fourth seal or horseman], **and earthquakes in various places**" (Matthew 24:7). He does not use **thánatos** but **loimós**, which literally means "pestilence" or "disease." Once Jesus Himself weighs in, there is no argument. The pale rider brings death by disease.

Interestingly enough Revelation also mentions by the "wild animals" of the earth. Could this be a reference to sicknesses passing from animals to humans and causing widespread pandemics? Is this what we are seeing with the corona virus? Or could it mean that the powers at be want us to believe that is the case?

In January 2020 when the corona virus became national headlines we shook our head and said "*here we go again*". Sars, Swine Flu, Ebola and Zika Virus. We have seen them come and we have seen them go. However, as we now reach March 2020, there is a very uneasy feeling developing in regards to the global spread of Coronavirus.

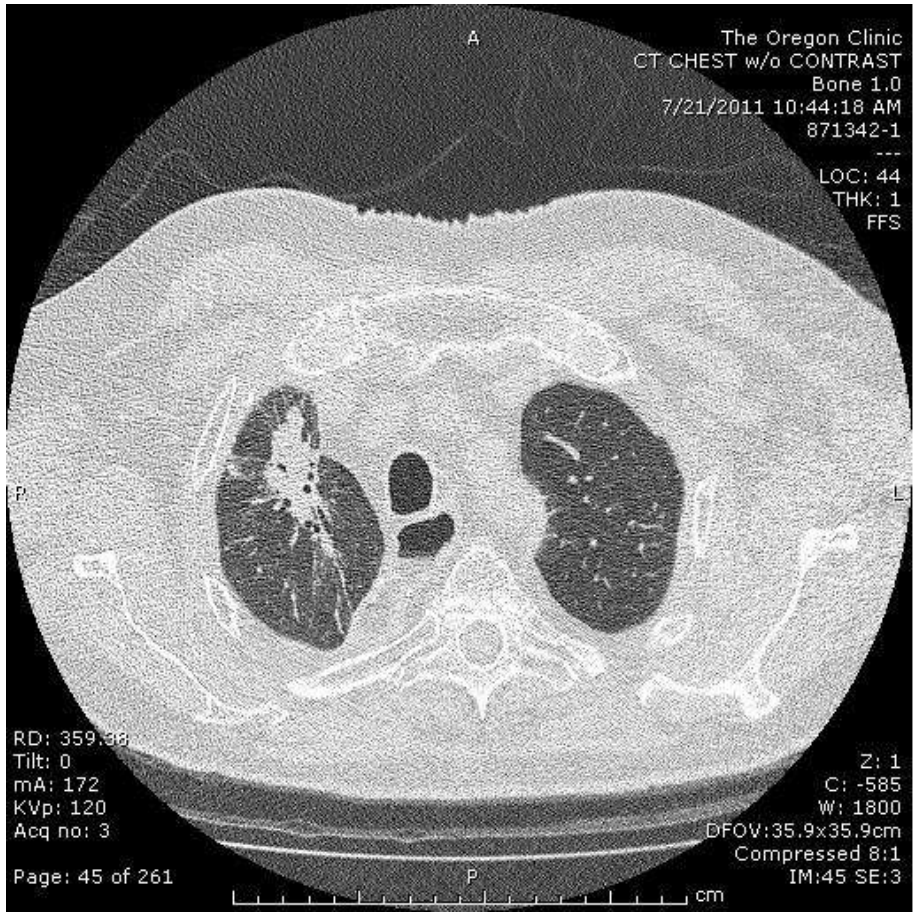
- ✓ Could coronavirus be the ultimate excuse for the microchip?

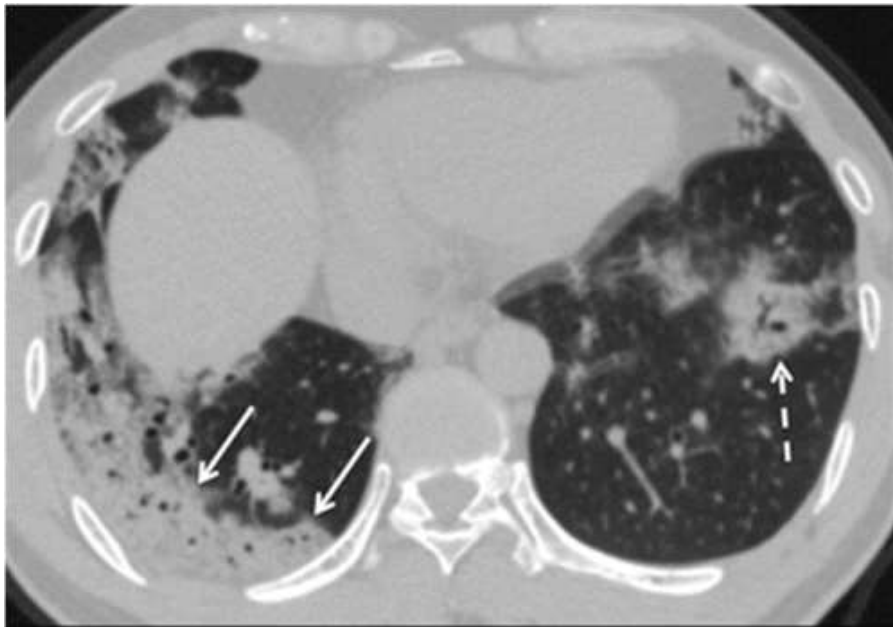

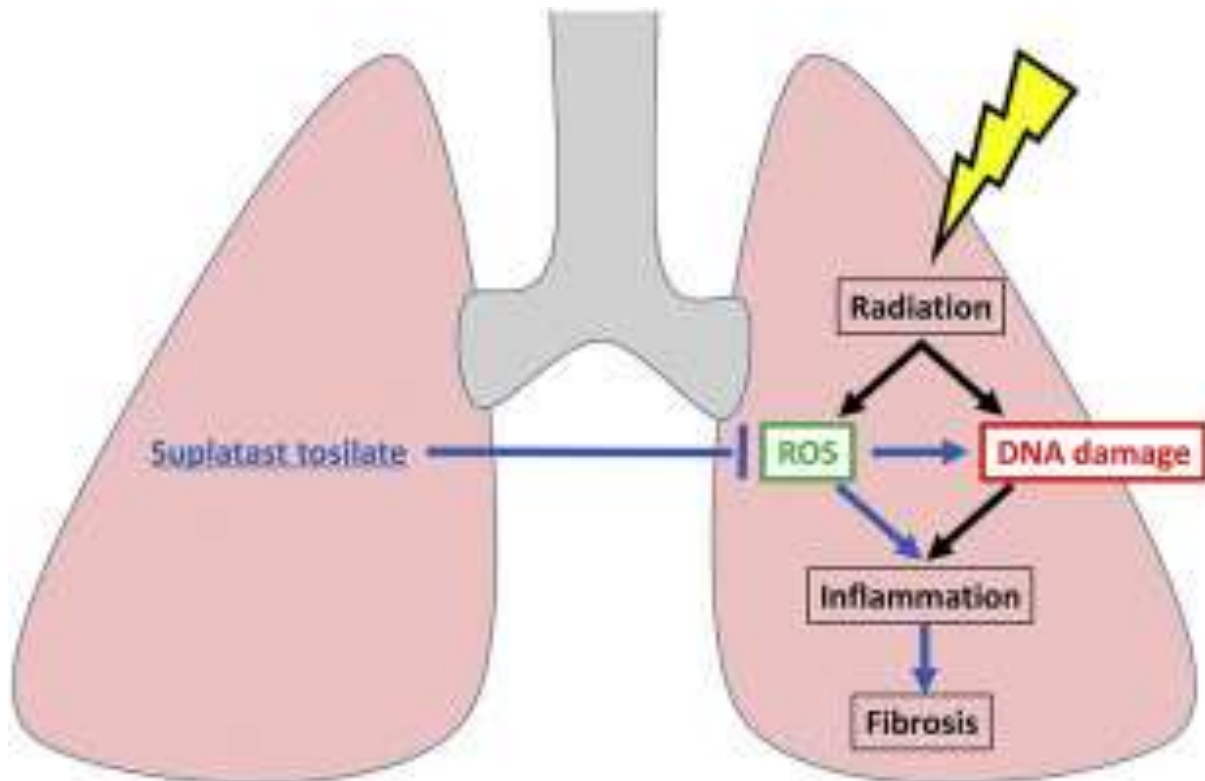
Grade 1: Mild symptoms of dry cough on exertion

Grade 2: Persistent cough requiring narcotic anti-tussive agents and/or dyspnea with minimal exertion, but not at rest

Grade 3: Severe cough that is nonresponsive to narcotic agents, and/or dyspnea at rest or radiographic evidence of acute pneumonitis

Grade 4: Severe respiratory insufficiency that requires continuous oxygen or assisted ventilation

Grade 5: Death

In the meantime, the Pentagon is preparing a plan that includes Medical Martial Law.

The Joint Chiefs of Staff (JCS) has issued an executive order (EO) calling on the United States Northern Command to start preparing for a full-blown pandemic of the Wuhan coronavirus (COVID19) here on American soil.

According to a service-wide message issued this past week to the Navy and Marine Corp, Defense Secretary Mark Esper has officially approved the EO, which orders commanders to get ready for “widespread outbreaks” of the Wuhan coronavirus (COVID19). They’re also reportedly being told to prepare for having to forcibly confine service members “with a history of travel to China.”

Similar to what communist China is doing by implementing medical martial law, the U.S. military under President Donald Trump is implementing what’s known as the Department of Defense Global Campaign plan for Pandemic Influenza and Infectious Diseases 3551-13, which the Military Times describes as “the Pentagon’s blueprint for planning and preparing for widespread dispersion of influenza and previously unknown diseases.”

U.S. Northern Command has indicated that it is now directing the Joint Staff to commence “prudent planning” based on its assigned role to synchronize the department’s various plans for handling a pandemic flu or similar disease. At the same time, it also added that this planning does not necessarily “indicate a greater likelihood of an event developing.”

“As military professionals, planning for a range of contingencies is something we owe the American people,” stated Navy Lieutenant Commander Mike Hatfield in a statement. *“We*

coordinate with other combatant commands to assess potential impacts in the event of a pandemic and we ensure the U.S. military is poised to respond as required.”

“The military profession fosters a culture of planning, and the fact that we are coordinating planning efforts across the geographical combatant commands is consistent with how we prepare to respond, if directed,” he further added.

Is the U.S. military expecting its own Wuhan coronavirus (COVID19) outbreaks at its various installations?

According to Marine Corps message MARADMIN 082/20, commanders throughout the U.S. military are being told to review their disease containment plans and take all necessary “preparatory and precautionary actions” to protect all of its service members, installations and ships stations around the globe.

Part of this includes ensuring that all plans for containment procedures are assessed from response to isolation to quarantine to restriction of movement and “community-based intervention,” according to the memo.

The Marine Corps, it further adds, has to be able to “mitigate, respond (to), and recover from the effects (of the Wuhan coronavirus (CoVid-19) in order to maintain force readiness.”

All service members and military commanders who have been to China since February 2 are being asked to stay confined to their residences, or if they live in an open barracks or share a bathroom with others to relocate to a temporary lodging facility for 14 days – even though we now know that the Wuhan coronavirus (CoVid-19) can incubate for nearly a month as opposed to just two weeks.

“The restricted service members will be assessed daily for fever by medical personnel by phone or in person and wear protective gear if they personally conduct the medical checks, according to the messages,” the Military Times reports. “Should they display symptoms, they must seek medical attention, but call their military treatment facility first to inform them of their travel.”

I know what it means to be under medical confinement. Spinal meningitis is an infection of the fluid and membranes around the brain and spinal cord. Once infection starts, it can spread rapidly through the body. Without treatment it can cause brain damage in a matter of hours and can be fatal within 24 hours. While in West Germany, our unit was under medical quarantine for an entire month during 1957.

According to the Supreme Court, the term MARTIAL LAW means the use of military force with the purpose of control over some populated area which is considered as problematic because of civil war or any other kind of chaos. Martial law by itself is very rare and a not so popular decision from above, but it is the only one in the hard periods of state instability. Sometimes, this system of ruling is misused by the government to enforce its own position through the

suspension of civil rights, constitutional law and habeas corpus. Usually, this mechanism is chosen when state authorities fail to lead the society or they are using it to contain the civilian unrest.

Martial law is differently imposed from country to country, but the structure is always and everywhere the same – you wake up and don't have any rights to do anything or go anywhere. You become a prisoner of the world you have firmly believed is free. That is the reason why martial law has been such a hot issue for interpretation among not only law makers, but also among philosophers and civil right defenders. There are no experts who know for sure when we will need martial law and how it will look like when it is implemented. All what we can do for now is to analyze and scrutinize it so if one day, should it be implemented, it will not affect society as strongly as a civil war, natural disaster or outbreak. As many of theorists say, when martial law is declared, the civilian party is over.

In the age of constant threats from new emerging infectious diseases and possible outbreaks all over, martial law is getting that new rising status – a medical one. That means that the uncertain epidemiological future of our world will challenge us with the options of imposing Medical Martial Law to save lives or simply refusing to enact martial law during the outbreak periods and protect freedom and rights, but lose human life.

Medical Martial Law is defined as a special kind of martial law which could be executed in an emergency situation of high alert from infectious disease where epidemic level grows into pandemic on specific geographic areas. In these circumstances, Medical Martial Law becomes the only way to form the quarantine, build a protocol for screening the viral disease and detect the potential infected. It would use a synthetically based bio-surveillance guide based on the outcome of carefully designed epidemiological integration processes.

It seems so simple to declare Medical Martial Law under the explanation that there is no other policy for protecting citizens other than to protect them from themselves. This is the key in opening the door of understanding interests of government in announcing the Medical Martial Law. From one point of view, that is a good helpful strategy to limit the fire into one hot zone. On the other side, that is also a tactic for a government to put the umbrella over all civilian rights and to tell us that we should forget about the freedom for a while. During the outbreaks, you do not need freedom, you need safety. But, where is the fine line between bio-safety and freedom? Would you want to have bio-security paid for by the suspension of your liberty? Those are question to ask to allow us to identify when there is a real need for Medical Martial Law, especially during the last outbreak chaos caused by Ebola spreading.

In 2014 and 2015, global Ebola has shown us that which we were blind to for such a long period of time. Society was drenched with unpreparedness for this viral threat which was familiar to scientists for more than 30 years. None expected that Ebola would get out of West Africa and step into other continents. America wasn't prepared to react on Ebola strike on its own soil. The first Ebola case in Texas Health Presbyterian Hospital involving Liberian man Thomas Duncan introduce us to inadequate procedures in dealing with this highly infectious viral

disease. With the budget of \$6.9 billion for 2014, CDC didn't make and have appropriate procedures in emergency response. In 2015, it was provided \$1.77 billion for a plan against Ebola that included \$571 million for domestic response, \$603 million for international response and \$597 million for global health agenda.

The scenario that happened in the U.S., where Ebola virus was treated as any ordinary virus, shows us that without making big step forward into biohazard policy regarding this, political background has more influence than a pure scientifically approach. The CDC, as a government body, couldn't do anything without approval by the officials. Those officials didn't want to devastate economy by limiting airplane traffic and travel fluctuations in and out the endangered zone, but they were ready to accept the particular procedure of a limited Medical Martial Law, and take away freedom from their own citizens. This, of course, doesn't come only from the current administration or the previous one. It is common to the World Health Organization (WHO) pandemic preparedness planning which states, "overrule of existing legislation or (individual) human rights in order to quell a viral outbreak, and were originally drafted around the potential of an influenza crisis."

It is more than useful to make quarantine check-in stations on the airports for new arrivals or to send quick strike team on the U.S. border to prevent possible arrivals of infected people. That is all legitimate and absolutely rational implementation of Medical Martial Law or at least one dimension of it. In many ways, Medical Martial Law in the U.S. during this first Ebola outbreak wasn't imposed radically and only some sequences were implemented around ground zero.

With the existence of the Posse Comitatus Act, what would allow and justify the use of military force against citizens? It reminds us of potential misuse of Medical Martial Law. Citizens are not invited to decide if they are sick or not, but if they are under suspicion that they could be potential carriers of deadly virus, they will be put under the new occurring quarantine rules for a while. They are detained until proven healthy. If they do not allow medical staff to process them, they will be considered a threat and will be processed as a threat through the force. What if someone seems like he is sick and is not, but current bio detection technology failed to give the right answer? He will be medicated against his will and he will be located in some FEMA camp for monitoring.

It is absolutely normal that one should be stopped from infecting thousands, but who says where the boundaries are between our freedoms and bio safety we are hoping we will achieve one day. You can't have both. At least, you can't have both which are not at odds with each others. What you can have is prepared health protocols and epidemiological measures which should be followed in every hospital, regardless of whether or not we have hot zone. We need health protocols based on common sense even more than we need freedom. Medical Martial Law is a good thing when you have professional government and informed people. If any of these features is absent, then Medical Martial Law is a badly imagined scary movie you don't want to watch.

Medical martial law has been rolled out before in Rockland County, New York, where unvaccinated citizens were barred from all public places — including schools, sidewalks, malls, churches and public transportation — all under the absurd quack science fraud that claims measles is only spread by unvaccinated people. U.S. Biowarfare Programs Have 13,000 Death Scientists Hard at Work.
America’s \$100-billion Germ Warfare Industry a “Criminal Enterprise,” Author of U.S. Biowarfare Act Says

The American legal authority who in 1989 drafted the law Congress enacted to comply with the 1972 Biological Weapons Convention says the U.S. today [October 11, 2015] is in flagrant violation of that Convention.

“Since Sept. 11, 2001, we have spent somewhere in the area of \$100 billion” on offensive biological warfare, charges Professor Francis Boyle of the University of Illinois, Champaign.

Boyle said an estimated 13,000 “death scientists” in 400 laboratories in the U.S. and abroad, are employed making new strains of offensive killer germs that will be resistant to vaccines.

For example, Dr. Yoshihiro Kawaoka’s group at the University of Wisconsin has found a way to increase the toxicity of the flu virus by 200 times! Boyle says Kawaoka is “the same death scientist who resurrected the genocidal Spanish Flu virus for the Pentagon for offensive biowarfare purposes.”

As for fighting flu, the National Institutes of Health in 2006, a typical year, got only \$120 million from Congress to fight flu, which kills an estimated 36,000 Americans annually. By contrast, Congress gave NIH \$1.76 billion for “biodefense,” even though the anthrax outbreak in 2001 killed just five persons.

“These distorted budgetary allocations,” (spending 15 times as much for germ warfare as for fighting flu) demonstrate that the priority here is not the promotion of the public health of American citizens but rather to further develop the U.S. offensive biowarfare industry that will someday ‘blowback’ upon the American people with a catastrophic pandemic,” Boyle said.

He went on to say the Pentagon and Central Intelligence Agency (CIA) are “ready, willing, and able to launch biowarfare when it suits their interests...They have a super-weapons-grade anthrax that they already used against us in October, 2001.”

Boyle here was referring to the anthrax pathogens mailed to two U.S. Senators (Tom Daschle, of South Dakota and Patrick Leahy, of Vermont) and others after 9/11 that were traced back to the Government’s biowarfare lab at Fort Detrick, Md.

Boyle’s remarks came in response to written questions from Sherwood Ross, a Miami, Fla.-based columnist. Asked if the recent outbreaks of Ebola in Sierra Leone and Liberia could be from U.S. Government-backed facilities, Boyle replied:

“These Ebola vaccines were experimental U.S. biowarfare vaccines that were being tested out in West Africa. It was a result of testing out of the U.S. biowarfare vaccines at our lab in Kenema, Sierra Leone, that created the West African Ebola pandemic in the first place.”

Boyle warned that the Galveston National Laboratory in Texas, a high-containment research lab, has been seeking for potential biowarfare agents in the wild in other parts of the world “in order to turn them into biological weapons.”

He said, “They should shut down Galveston as an ongoing criminal enterprise along the lines of the S.S. and the Gestapo — except that Galveston is far more dangerous to humanity than Hitler’s death squads ever were.”

Boyle added, “American universities have a long history of willingly permitting their research agenda, researchers, institutes, and laboratories to be co-opted, corrupted, and perverted by the the Pentagon and the C.I.A. into death science. These include Wisconsin, North Carolina, Boston U., Harvard, M.I.T., Tulane, University of Chicago, and my own University of Illinois, as well as many others.”

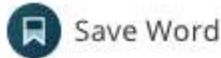
