Mark Steele on 5G, Nanotech Weapons in C19 Shots, Use of Heavy Metals as Weapons Systems

I have known **5G** was a weapons system going back to the 1990s. UK experts like Dr. Barry Trower and Mark Steele were warning the public of the roll out of **5G** towers long ago. This article expands upon what Mark Steele has previously shared with additional information on technical knowledge readably at hand for our benefit and confirms what links the alleged Covid Vaxxes with **5G** EMF/EMR radiation poisoning. We notice that three years later, following the initial scare campaign about 'Covid' and the first lockdown in the spring of 2020, the promised **5G** towers every 100 meters along our streets, with trees duly chopped down, haven't materialized. Thankfully, neither have the smart meters. In France, these were all being publicized three years ago. There is a reason for this but it will happen relatively closer than you might believe.

This explanation links more than 30+years of chem-trailing (geo-engineering), which has been dousing our air, water and land with aluminum Nano-particulates with recent vaccines and **5G** technology. In warfare, this type of metals contamination permits one side to see where its enemy is through radar. In a sense, it's logical for this purpose. But certainly not for regular life.

The difference between 4G and **5G** is this: 4G is like a lightbulb with the lamp shade off. As you move further away from it, there is less power. **5G**, however, is like a torch that scans the area around it. It's a signal, a direct energy weapon that can be beamed directly at someone. Pointed at someone's head, it could cause a stroke. Such signals can cut through stainless steel. They are ionizing, despite what we've been told. So focused **5G** energy can be used to activate metals inside the human body. The flu vaccines over the years have had metals contaminants in them. Tungsten is one of these. The mRNA vaccines are loaded up with them – aluminum, zinc, tungsten, etc. It means that with current technology, a person can be located but only as a type of ghost. If you're loaded up with tungsten and aluminum, etc., however, you can be located clearly, with the beam directly aimed at you. It's much more easily done when a person is loaded up with metal contaminants. There's no pharmacological reason for these medical products being loaded up with these metals and inserted into the human body.

People loaded up with metals become a type of RFI (antenna) – a dormant radio frequency emitter. So when radiation from external **5G** sources hit you, this causes a person with metals in them to radiate those around them. Someone next to a vaccinated person can be seen to be unvaccinated. And they will be susceptible to the radiation that the vaxxed person is giving off. Both vaxxed and unvaxxed can get sick, but the unvaccinated can get sick from the vaccinated in this way. Cities are especially toxic for this because this is where **5G** is mostly located. Example: NYC has 617 cell towers, Los Angeles has 314.

The World Economic Forum (WEF) didn't plan for 6G because, by 2025, they expected a lot of dead people, whose wealth they could appropriate. (He talks about the utter toxicity of masks here.) So there has been a chem-trailing program to load people up with metals, in conjunction with vaccine technology since 1996. But the proviso is that people MUST TACITLY AGREE TO IT. Truth be known, they know nothing!

5G towers near homes are basically ways to spy on those homes and to record what products (which would all be electronically radiative with scan tags on them) were used. People would be scanned 24/7. Local councils spend a lot in waste management, so they've been enticed by the idea that citizens will be fined for what they throw away. But this is a distraction because the equipment is basically planned for mass genocide. People who take away our trash, fix our electricity cables, etc. have no idea about this.

The vaccines can increase the effect of the radiation sprayed on you in your area. Initially, a lot of placebos were rolled out because they can't kill everyone all at once. (ER: This is a different explanation to why more people haven't been killed by the shots than the one Ryan Cole gave publicly, to do with 'degraded mRNA'.) But this is where the boosters come into purpose. A new 'variant' can be created by the weapons system picking out an area with a lot of vaccinated people in it. These people can be identified through radar, and where they are (a building) can be pulsed with EMFs. Thus you get an 'outbreak' of sick and dead people; which supports the variant 'pathogen' narrative. So it is the vaxxed that are set to be sick and hospitalized. The data then backs this up. This sets up the narrative for a need to be re-boosted. Sic but creative.

In South Korea in 2019, the **5G** system was turned on and five cities were set on fire. If you turn up the **5G** system, the electrical grids go down and equipment burns. Injecting people with a vaccine works better because the energy system doesn't have to be turned up so much. People who died in northern Italy in 2020 had been primed with the flu jab. Then **5G** was turned on, making the vaccinated more toxically susceptible to the **5G** frequencies. The kill grid with **5G** can only work if people are already injected.

Wuhan was a test: they vaccinated people in Wuhan in November 2019. Then they were put in the **5G** grid. Mark Steele has seen pictures of people projectile vomiting up blood as a result of this experiment. (So that may mean that the pictures we saw of people in Wuhan dying weren't necessarily false.) But for that to happen, people had to be vaccinated so their vaccinated bodies could be destroyed with less frequency emission. Sorbitol has been added to these vaccinations, which opens up the

blood/brain barrier. Hence nanoparticles such as those of Tungsten go directly into the brain. China did vaccinate the entire country during the summer of 2019 as part of a national program. It does indicate that China did not turn on their **5G** at full force as was first thought. They "modulated" their **5G** output to see how much energy is needed to achieve specific results. Why is this of such importance?

There is a bigger picture here that maybe Mark Steele is not aware of. As part of the Agenda 21 (2030) goals, countries must reduce their agriculture output by a third. To reduce fossil fuel consumption which is part of the 2015 Paris Accords to address climate change countries must comply or go out of business.

What is at stake here is whether it is legally binding and its consequences!

The UN Framework Convention on Climate Change is unequivocal by describing the 2015 Paris Agreement as a "legally binding international treaty on climate change." Yet the treaty itself has few legal teeth. It does not impose penalties, such as fees or embargos, for parties that violate its terms, and there is no international court or governing body ready to enforce compliance. That has prompted some prominent experts to argue the Paris accord is not a legally binding document after all.

When the Paris Agreement was being drafted by global representatives from future member countries, the question of how legal and enforceable it could be was hotly debated. For the U.S. to back the treaty, for example, it could not hold the U.S. accountable for specific outcomes. If it did, former president Barack Obama would have required approval from two-thirds of the U.S. Senate, which was at that time controlled by Republican lawmakers who opposed the deal.

Instead, treaty negotiators made a clever concession: they chose to make the treaty's required processes legally binding, not the obligation to meet prescribed goals. That means the accord legally compels countries to devise and regularly update nationally determined contributions (NDCs) to the collective effort to reach net-zero emissions by 2050 and limit global warming to 2 degrees Celsius, for example. It also demands they meet and report on their progress at conferences like COP26.

But countries are only expected to create increasingly ambitious goals for cutting emissions; technically, however, they can revise their NDCs in any direction without being tossed out of this global project. (Even despite the flexibility, Obama ratified the accord through an executive order, calling it a non-binding political agreement, rather than a treaty).

By some accounts, the accord's hybrid legal structure and its emphasis on establishing new norms from the bottom-up, explains how it attracted an impressive 195 global signatories, making it a truly transnational effort that's better positioned to succeed than its predecessor the Kyoto Protocol. By contrast, Kyoto set up rigid, top-down goals and asked developed countries to take on a greater burden than developing countries, both

of which led to far lower levels of participation and saw some members defying or withdrawing from the treaty entirely.

Larry Fink, CEO of BlackRock Fund Management, and Michael Bloomberg of Bloomberg News Media and Bloomberg Philanthropies are in the process of destroying the U.S. through their pressure on corporations to either play ball or prepare to go out of business. Since all businesses need investment capital to build and do business, they either comply with an environmental business plan that is zero carbon footprints compliant or plan to shut their doors forever.

Shell's directors are being personally sued for allegedly failing to adequately manage the risks associated with the climate emergency in a first-of-its-kind lawsuit that could have widespread implications for how other companies plan to cut emissions.

Environmental law firm ClientEarth, in its capacity as a shareholder, filed the lawsuit against the British oil major's board at the high court of England and Wales on Thursday.

It alleges 11 members of Shell's board are mismanaging climate risk, breaching company law by failing to implement an energy transition strategy that aligns with the landmark 2015 Paris Agreement.

The claim, which has the backing of institutional investors with over 12 million shares in the company, is said to be the first case in the world seeking to hold a board of directors liable for failure to properly prepare for the energy transition.

"Shell may be making record profits now due to the turmoil of the global energy market, but the writing is on the wall for fossil fuels long term," Paul Benson, senior lawyer at ClientEarth, said in a statement.

"The shift to a low-carbon economy is not just inevitable, it's already happening. Yet the Board is persisting with a transition strategy that is fundamentally flawed, leaving the company seriously exposed to the risks that climate change poses to Shell's future success — despite the Board's legal duty to manage those risks," Benson said.

The group of investors supporting the claim include U.K. pension funds Nest and London CIV, Swedish national pension fund AP3, French asset manager Sanso IS and Danske Bank Asset Management, among others. Altogether, the institutional investors hold more than half a trillion U.S. dollars in total assets under management.

"We do not accept ClientEarth's allegations," a Shell spokesperson said. "Our directors have complied with their legal duties and have, at all times, acted in the best interests of the company."

"ClientEarth's attempt, by means of a derivative claim, to overturn the board's policy as approved by our shareholders has no merit. We will oppose their application to obtain the court's permission to pursue this claim," they added.

Shell, which is aiming to become a net-zero emissions business by 2050, said it believes its climate targets are Paris-aligned.

ClientEarth said leading third-party assessments have suggested this is not the case, however, noting Shell's strategy excludes short to medium-term targets to cut the emissions from the products it sells, known as Scope 3 emissions, despite this accounting for over 90% of the firm's overall emissions.

The aspirational goal of the Paris Agreement is to pursue efforts to limit global heating to 1.5 degrees Celsius above pre-industrial levels by slashing greenhouse gas emissions. The fight to keep global heating under 1.5 degrees Celsius is widely regarded as critically important because so-called tipping points become more likely beyond this level. These are thresholds at which small changes can lead to dramatic shifts in the Earth's entire support system.

To be sure, the burning of fossil fuels, such as oil and gas, is the chief driver of the climate emergency.

The case comes shortly after Shell reported its highest-ever annual profit of nearly \$40 billion. The energy giant's 2022 earnings smashed its previous annual profit record of \$28.4 billion in 2008 and were more than double the firm's full-year 2021 profit of \$19.3 billion.

Shell CEO Wael Sawan described 2022 as a "huge year" for the company, saying he felt privileged to be stepping into the role he started on Jan. 1.

"As we look ahead, I think we have a unique opportunity to be able to succeed as the winner in the energy transition. We have a portfolio that I think is second to none," Sawan said.

Shell's results came as part of a Big Oil profit bonanza last year, bolstered by soaring fossil fuel prices and robust demand since Russia's full-scale invasion of Ukraine.

Prince Charles of Wales at the COP26 Conference at Glasgow, Scotland called for a "vast military-style campaign" to meet the guidelines of the Paris Accords. Then early 2022, Ireland was told to reduce its agricultural output by one-third; similar mandates were issued against the Netherlands and farmers were forced to sell their farms.

The fall out of these measures result in reduced food production and in many cases starvation of their populations, loss of employment, and social unrest as well. At this juncture point you may begin to see what the end game is for the virus scam. Putting in the most basic of terms, humanity is being forced to commit suicide so that Prince

Charles "Sustainable Development" can be achieved, through depopulation of much of the world's 8-billion people. The WEF's answer to this planned destruction is for people to own nothing and like it; including replace animal protein with bugs and crickets.






5G Uses Same Millimeter Waves... As US Military's Active Denial Systems

Since the original planned failed to achieve the level of recipients to take the "gene" therapy being posed as vaccines, the perpetrators have had to step back and tweak their plan for their next virus hoax.

Mark Steele has stated that in the U.S. only around 57% of the population have taken both shots plus at least one booster shot. Scientists have estimated that each booster shot reduces a person's natural immunity by 7-10%. In more everyday language, it is a way of thinking about whatever is presently occupying your mind so that you come to the best possible conclusion.

My mother would buy us 500-piece picture-puzzles at Woolworth's when I was eight years of age. I was solving 1000-piece picture-puzzles by ten years of age. My father only went to school through the fourth grade but in his youth education was a luxury. He was a formidable chess player.

The skills that one needs in order to be able to think critically are varied and include observation, analysis, interpretation, reflection, evaluation, inference, explanation, problem solving, and decision making.

Specifically we need to be able to:

- Think about a topic or issue in an objective and critical way.
- Identify the different arguments there are in relation to a particular issue.
- Evaluate a point of view to determine how strong or valid it is.
- Recognize any weaknesses or negative points that there are in the evidence or argument.
- Notice what implications there might be behind a statement or argument.
- Provide structured reasoning and support for an argument that we wish to make.

In my mail box yesterday there was an excellent piece for the use of critical thinking.

Gates again repeated a talking point about it being more important to mass vaccinate humanity than to travel to Mars.


















The above illustration has been included in other articles that I have written, what you are seeing is how **5G** interacts with your uptake of oxygen absorption. At the 60 GHz level the frequencies is telling us that **5G** energy is consuming virtually all your oxygen. In practical terms you would collapse, black out, and die from lack of oxygen.

5G depletes oxygen. Oxygen molecules have shared electrons. When we breathe in oxygen, the electrons bind to our hemoglobin, which distributes the oxygen to our red blood cells and ultimately to our vital organs. Oxygen molecules oscillate at a frequency of 60 GHz. Remember, **5G** wireless networks operate at 60 GHz and higher (up to 100 GHz!). When **5G** is transmitted, atmospheric oxygen absorbs the **5G** radiation. When this happens, the oxygen's electrons are altered making them unable to bind to hemoglobin, which means oxygen cannot be carried to your cells. The end result is oxygen deprivation at the level of the mitochondria.

This is also what happens in severe COVID-19. Other similarities between **5G** radiation and COVID-19 symptoms include:

1) Changes to the blood. Some changes to blood include increased clotting time, reduced hemoglobin that can lead to hypoxia, pulmonary embolism, and stroke.

- 2) Oxidative stress. Oxidate stress increases free radical damage and can deplete glutathione levels.
- 3) Disruption of the immune system. **5G** has the ability to both suppress the immune system and overstimulate it. When immune system suppression occurs, T lymphocytes decrease. When the immune system is hyper-activated, the result is inflammation, cytokine storms, and more.
- 4) Increased intracellular calcium. This can increase your risk of contracting viruses, as well as cause inflammation, blood coagulation and thrombosis.
- 5) Cardiac changes. Cardiac changes from **5G** include palpitations, arrythmias, myocarditis, even heart failure.

5G radiation awakens latent viruses. Viruses, bacteria, and other pathogens are always in your body. Usually your immune system is working to keep them in check. **5G** radiation excites viruses and bacteria making your immune system's job harder. In addition, the COVID-19 shots contain heavy metals such as graphene oxide and nanotechnologies. These literally turn your body into a **5G** router making it more likely that whatever latent viruses you have will be activated in the presence of **5G**. I believe this is one reason why people who have taken the shots are falling ill with COVID-19 now.

Do not assume that any frequencies between 10 and 40 GHz are safe just because you are getting sufficient oxygen. Radiation sickness at the 10 GHz level has been proven to cause cancer in airport TSA agents monitoring the body scanners passengers go through. Smart utility meters installed in many residential homes and apartments operate at 4 GHz and have caught fire causing houses to burn to the ground.

Insurance companies tell owners of electrical cars not to park inside their garage for the same basic reason. Mark Steele said recently in an interview that owners of the Tesla car are like being in a Microwave oven because of the many **5G** device functions surrounding the driver. I was stunned never giving a thought to owning a Tesla like sitting in a Microwave oven! This may be a factor in so many accidents and fatalities of the Tesla car. We do not get all the details when reported in the news and so it remains to be seen what role wireless energy is playing. Mark Steele in one of his videos took a Tri-fold meter and took multiple readings from all directions while sitting in the driver's seat of a Tesla. They were as high as any router I have seen in use with microwave ovens.

During the past 2 years, $\mathbf{5G}$ infrastructure was massively expanded across the country. To put $\mathbf{5G}$ radiation in perspective, it's notable that the natural level of radiation we have evolved to tolerate is in the range of 0.000001-0.000000000001 μ W/m2 (strength of radiation in watts per square meter). According to experts, the only place we could now find radiation this low is in a cave! By comparison the FCC recommendation for human exposure to wireless radiation is 10,000,000 μ W/m2. Add on top of that the increased

frequency of radiation with **5G** wireless networks that operate at 60 GHz and higher (up to 100 GHz!). That's a pretty big difference from what we have evolved to tolerate!

So, it goes without saying that if you are living in an area with **5G** towers and streetlights all around you, you are at increased risk adverse health events, including COVID-19.

Different frequencies have different effects on the human body as revealed by Dr. James Giordano; and has an impressive Bio: Professor in the Departments of Neurology and Biochemistry at Georgetown University Medical Center, Washington D.C., Chief of Neuroethics Studies Program and Co-Director, O'Neil Pelligrino Center of Brain Science, has served on Joint Staff of the Pentagon, and is Head of the European Union Human Brain Project.

In Dr. Giordano's lectures, he goes into explaining how different frequencies affect the body and basically is saying that torture of civilians is permissible and that neurotech may "uphold a higher moral standard" than other forms of torture. In my opinion, Giordano is a true psychopath. He cares nothing about the Constitution or your rights. He apparently does not know what Treason is, or that it can carry the death penalty.

Dr. Christiane Northrup, MD offers a number of recommendations one can follow in dealing with **5G** radiation sickness.

- 6 More Ways to Protect Yourself from **5G**, which I began to follow shortly after being hospitalized a year ago from what I believe was the result of a designated attack of a directed energy weapon.
- 1. Take magnesium. EMFs activate the voltage-gated calcium channels (VGCCs) in the outer membranes of your cells. It has been shown that effects of EMFs are reduced by calcium-channel blockers. Magnesium is a natural calcium-channel blocker. If you are deficient in magnesium, as many people are, you could feel increased effects from EMFs. Be sure to take enough magnesium to help protect your cells.
- 2. Use Zeolite. Zeolite is a natural mineral that binds to heavy metals and radioactive material in the gastrointestinal tract and helps remove them from your body. While this will most likely not protect you directly from EMFs, it can help detox the effects from the COVID shots if you have taken them, and may make you less sensitive to 5G radiation.
- 3. Eat foods to increase Nrf2. Studies show that Nrf2 promotes DNA repair and detoxification of superoxide, which is generated after exposure to radiation. The Mediterranean and Okinawan diets are said to promote Nrf2. Be sure to eat foods high

in phytochemicals and try to include the following types of foods in your diet: Cruciferous vegetables (broccoli, cauliflower); foods high in antioxidants such as bright yellow, red and purple fruits and vegetables; foods high in Omega-3 fatty acids (salmon, krill, sardines, tuna, flax, walnuts); carotenoids (carrots, squash); onions and garlic for the sulfur compounds; aromatic green herbs (basil, rosemary, thyme, oregano).

- 4. Support your thyroid. Even if you do not have thyroid disease, it's a good idea to support your thyroid if you are exposed to **5G** radiation. The best way to do this is to supplement with iodine. I recommend Lugol's solution 2%. Take 2-12 drops/day. Or, try super saturated potassium iodide (SSKI), which you can find online at available from Morgellons's Direct and many other websites. If you have thyroid problems, be sure to work with your doctor to find the right dose.
- 5. Build healthy red blood cells. To keep your red blood cells and hemoglobin healthy takes a multi-pronged approach. I suggest a good multi-vitamin with adequate levels of vitamins A, C, E, B12, folic acid, copper and iron. Eating red meat, especially organ meat, is another way to get iron if you don't like to take it in supplement form. Eggs, chicken, and leafy green vegetables are also good. You may also want to take chlorophyl, a super greens supplement, or drink green juice. There are many available. Daily exercise for 30 minutes will also help keep your red blood cells healthy. It's also a good idea to reduce alcohol consumption or cut it out altogether.
- 6. Drink alkaline water. In my own case, I distill my own from the county water system from a nearby lake. Maintaining the proper pH in your body has many benefits. Drinking alkaline water (sometimes called hydrogen water) is an easy way to rebalance your body's pH. Alkaline water has been shown to neutralize free radicals and reduce oxidative stress by activating the Nrf2 pathways. It can also help detoxify acidic waste build-up due to medications, processed foods, and environmental pollution. The main components of alkaline water are magnesium, potassium, calcium and sodium. Alkaline water ionizers can be very expensive. However, you can create your own alkaline water at home by adding baking soda, pH drops, or lemon juice to purified water. While drinking alkaline water will not replace the need for a healthy diet, it can be a good to add to your health routine. Of course, staying optimally hydrated by simply drinking (and eating) enough pure water every day will help keep your body in an alkaline state.

Central to what Mark Steele and Dr. Barry Trower have said about **5G** that it is a military weapons system and its main purpose is to kill and harm. Leakers within the national system (health, military, and intelligence) say a new pandemic will be launched in the coming three months. When the "switch is thrown" only those that were injected or boosted will be executed with the **5G** wireless EMF/EMR radiation poisoning. A final comment about the Biden May 11th end of the emergency becomes political propaganda. This did not prevent the CDC from quietly introducing a new program to track people who have not been vaccinated against COVID-19 after they visit a doctor or go to a hospital, according to documents and a video highlighted by National File but published back in 2021.

In September 2021 the ICD-10 Coordination and Maintenance Committee held a meeting to discuss new ICD-10 codes that the CDC's National Center for Health Statistics (NCHS) wanted to be created for marking people as "Partially Vaccinated for COVID-19," "Unvaccinated for COVID-19," and "Other under-immunization status." ICD-10 codes, stored in a patient health record, are used by doctors to categorize patients and insurance providers for billing.

ICD-10-CM codes were introduced by the CDC to track patients who are not vaccinated, partially vaccinated, and those who fall under the "other underimmunization status" category. The ICD-10 committee said that those who had adverse reactions to a vaccine in the past would be categorized as unvaccinated or partially vaccinated even if they cannot get other vaccines or boosters. The new codes were implemented in April 2022.
