## The Pathogen That Will Kill You without Your Knowledge! Part 1

A week ago I posted on my web page, "**Coronavirus: Proof 5G Causes Oxygen Deprivation, Part 2**". The focus of that article was to explain how a weaponized bio-weapon was created from a largely unknown pathogen during the 1940s by military biochemical warfare labs. The tragedy of the military experiments to make people sick or to kill them quietly without visible signs haunts the American public today. The U.S. government secretly conducted hundreds of experiment upon U.S. citizens, as well as other peoples to determine the lethality or effectiveness of those bioweapons.

**The U.S. government has admitted that Lyme disease is actually a bioweapon that was designed by the military to use against enemy combatants during war. But that is disputed by Dr. Sam Telford, Professor of Infectious Diseases at Tufts University. *"I started working on Lyme disease in 1985. As part of my doctoral thesis, I investigated whether museum specimens of ticks and mice contained evidence of infection with the bacterial agent of Lyme disease prior to the first known American human cases in the mid 1970s.***

***Working with microbiologist David Persing, we found that ticks from the South Fork of Long Island collected in 1945 were infected. Subsequent studies found that mice from Cape Cod, collected in 1896, were infected."***

The Lyme disease epidemic is routinely misdiagnosed as everything from "M.E." to MS to hypochondria. According to researchers at The Centers for Disease Control and Prevention (CDC), diseases such as anthrax, tularemia, cholera, lyme disease, desert valley fever and other parasitic and fungal diseases are "potential bioterrorism agents."

[Rense.com](http://Rense.com) reports: So, for the first time, a U.S. government body admits that Lyme disease is a biological warfare agent. This is the reason that hundreds of thousands of men, women and children around the world have been left to rot with wrong diagnoses, or have had their Lyme disease acknowledged but been told that it is an "easily-treated" disease, given 3 weeks' antibiotics, then told to shove off when their symptoms carried on after that.

In Britain the existence of the epidemic is denied completely, and virtually no effort made to warn or educate the public about the dangers of ticks, which carry the bacteria *Borrelia burgdorferi*.

The Borrelia genus has been a subject of biowar experimentation at least as far back as WW2, when the infamous Japanese Unit 731, which tortured and experimented on live prisoners, studied it. The head of that unit 731 went to work for the U.S. War Department, to become the Defense Department.

The reality is, Lyme disease is for many a chronic, horrendous, incapacitating disease producing crippling fatigue, constant pain, and loss of memory, possible paralysis, psychosis, blindness and even death.

It was an ideal biowar agent because it evades detection on routine tests, has an enormous range of different presentations, and can mimic everything from ADHD to multiple sclerosis to carpal tunnel syndrome to rheumatoid arthritis to chronic fatigue syndrome (M.E.) to lupus to schizophrenia. The Tuskegee Syphilis Study, also known as the Tuskegee Syphilis Experiment, Tuskegee Study of Untreated Syphilis in the African American Male, U.S. Public Health Service Syphilis Study at Tuskegee, or Tuskegee Experiment, was a clinical study conducted between 1932 and 1972 by the United States Public Health Service. That is **40 years folks!**

Every year, the Centers for Disease Control and Prevention (CDC) and pharmaceutical companies mount an aggressive campaign in the mainstream media to persuade Americans to get their flu shots. Flu shots are big business: industry analysts estimate that within the next five years, the U.S. flu vaccine market will be worth approximately \$7.5 billion annually, up from \$5 billion in 2018.

The CDC has advised the industry to hike demand through the use of a “recipe” of messaging to get your flu shot now through advertisements that include “...statements of alarm by public health authorities...prediction of dire outcomes from influenza...continued reports that influenza is causing severe illness affecting lots of people...repeated urging of influenza vaccination...” that bombard consumers.

Roughly half of the claims compensated in the NVICP (6,883 claims) have been for influenza vaccine injuries. The total compensation to date (paid for by consumers) is

over \$4.2 billion. As the Vaccine Adverse Event Reporting System (VAERS), a voluntary surveillance system, is acknowledged by the government to capture as little as one percent of actual adverse events, the flu vaccine injuries and deaths could be as high as 320,000.

The mounting amount of evidence suggests that the more shots a person receives over time weakens their overall immune system with time. This is very important as one gets older at a time one should want to have the maximum optimal immune system.

Mycoplasma is often described as a virus without its outer shell or a bacterium without a cell wall. Mycoplasma in many forms has existed in nature for centuries. It was once a fairly rare problem in humans because our bodies have many ways to defeat small natural amounts of mycoplasma.

Vitamin D deficiency causes rickets in children and will precipitate and exacerbate Osteopenia, osteoporosis, and fractures in adults. Vitamin D deficiency has been associated with increased risk of common cancers, autoimmune diseases, hypertension, and infectious diseases."* –(Vitamin D deficiency: a worldwide problem with health consequences.)

*"When I studied Lyme Disease in 1997 I found the same antibiotic treatment was used to treat Lyme as is used to treat mycoplasmal infections. My son was diagnosed with parvovirus B19 not Lyme Disease, but he responded to the antibiotic. This didn't make sense until I found that ticks carry mycoplasmas."* -(Candace Brown, Mycoplasma made in a lab).

Some 70% or so of the strange recent diseases like AIDS, MS, Fibromyalgia, Chronic Fatigue Syndrome, Lyme Disease and other strange maladies like Gulf War Syndrome and even oldies such as Rheumatoid Arthritis test positive for Mycoplasma. Mycoplasma weakens your immune system allowing simple usually harmless infections as well as AIDS retroviruses to take hold. The method Mycoplasma uses to weaken your immune system is to exhaust your cholesterol stores leading to endocrine disruption. Mycoplasma has a very serious adverse effect upon your liver due to its voracious up-take of liver-produced cholesterol, In the end your liver fails to produce enough cholesterol. That spending is highly concentrated, as the U.S. and five of Europe's largest countries account for nearly two-thirds of the entire market.

This means that billions and billions of dollars are secured by Americans being diagnosed with cancer.

That's one profitable industry; however, it could all be completely dismantled by one thing: a cure.

As Mike Adams recently reported, *"A universal cancer cure would destroy the profitability of the highly lucrative cancer industry and collapse the American Cancer Society, hospitals, oncology clinics and pharmaceutical companies that depend on chemotherapy revenues to stay profitable."*

This means that anyone moving closer to developing a cure for cancer would be considered an extreme threat to the medical establishment and likely stopped at any cost.

With that in mind, the mysterious deaths and disappearances of several natural health doctors throughout Florida is as suspicious as it is concerning.

If anyone was close to finding a universal cure for cancer and would ensure the public had access to it, it would likely be natural health doctors, or naturopaths, as they're less likely to prescribe drugs and more likely to try and heal the body naturally using holistic medicine and nontoxic approaches.

Breakthroughs using this type of medicine are extremely "controversial," as they threaten everything that the medical-industrial complex stands for, i.e. costly chemotherapy treatments (\$50,000 a pop) and cancer drugs.

Doctors leading this type of research are routinely raided and shut down by the U.S. Food and Drug Administration (FDA), after which they're treated like criminals and their reputations smeared.

This is typically orchestrated against doctors who are considered a threat by the medical establishment.

Renown holistic doctor found dead one week after FDA raids clinic

This seems to be the case with Dr. James Jeffrey Bradstreet, who was recently found dead after his body was discovered floating in a North Carolina river with a single gunshot wound to the chest. Bradstreet, a renowned physician known for his skepticism of immunizations (particularly the MMR vaccine), and his progressive autism research, was raided by the FDA one week before his mysterious death. The details of the raid remain largely unknown.

Personally affected by autism, as both his son and stepson were diagnosed with the condition, a significant portion of Dr. Bradstreet's work was dedicated to this cause. He even testified twice before the U.S. House of Representatives about the link between vaccines and autism.

As Natural News' reported, leading up to his death, Dr. Bradstreet was working with a little-known molecule that occurs naturally in the human body. GcMAF (Globulin component Macrophage Activating Factor), which is the GC protein after it combines with vitamin D in the body, has the potential to be a universal cure for cancer.

It's also believed to be capable of treating and reversing autism, HIV, liver/kidney disease and diabetes.

Dr. Bradstreet was working with a naturally occurring compound that may be the single most effective thing in the immune system for killing cancer cells

In an interview on the Hagmann and Hagmann Report, Dr. Ted Broer, an internationally recognized health and nutrition expert also based in Florida, describes how cutting edge Dr. Bradstreet's work was, as well as a discovery he made that very well may have placed him in great danger and could have been the motive for his suspected murder.

The alternative doctors who went missing and/or were killed, were reportedly "interlocked" through Dr. Bradstreet and Dr. Gonzalez's extensive research on autism, and what's causing autism, according to Dr. Broer.

Dr. Gonzalez, a renown holistic cancer treatment pioneer who helped thousands overcome the disease through alternative medicine, died of an apparent heart attack just one month after Dr. Bradstreet's body was discovered floating in a river.

Dr. Broer stated in the interview:

*"This information I'm about to give you right now is extremely controversial and a bunch of people have exited the planet who were working with it.*

*This information has been around for a while. They knew the information they were working with and they were basically being very, very careful, supposedly. And some of them were being accused of using GcMAF, and the FDA apparently raided several of their offices several weeks before they committed suicide or suddenly died.*

*It's going to sound complicated, but I'm going to break this down for everybody super, super easy tonight. When you first hear these terms they're going to sound weird to you.*

*GC protein is a protein in the body that's used by macrophages in the body. What it does is, macrophages in the body are the ones that kill cancer cells, they stop cytokines storms and can be involved in cytokines storms, we'll explain all these terms in a few minutes.*


*After defining GcMAF and how it's formulated, Dr. Broer reiterates that it's "probably the single most effective thing in the immune system to kill cancer cells."*

*However, what Dr. Bradstreet and his colleagues discovered is that the immune system is being compromised by a compound called "nagalase."*

*Nagalase is an enzyme/protein that's made by cancer cells and viruses causing immunodeficiency syndromes and has also been linked to autism as well as a "host of other problems," Dr. Broer explains.*

Doctors found dead and/or went missing felt that Nagalase was being introduced to the body through vaccines.

*"What ends up happening is when the GC protein cannot be converted to McGAF, the entire immune system is compromised."*



The illustration above shows how viruses and cancer produce Nagalase. The Nagalase then acts as an inhibitor blocking the GcMAF from getting Vitamin D<sup>3</sup> needed to do its job of allowing the Macrophages from killing the cancer cells. The illustration does not mention the word Mycoplasma, but you could put it over the two words at the top left, viruses and cancers. Note closely below how deadly the Mycoplasma is in the virus vaccine.

Some of the doctors who wound up dead or missing believed that the Nagalase protein/enzyme was being introduced intentionally into the body either virally or directly through vaccines.

*"This is such incredibly damning information to the entire medical profession and the immunological profession and those folks that [sic] are producing immunizations, that apparently they didn't want these guys around,"* Dr. Broer said.

*"I'm not saying what happened to these guys, I'm just saying they're not on this planet anymore."*

Doctor compares cancer-causing Nagalase to a stealth bomber.

Nagalase blocks the GC protein from attaching itself to vitamin D, thus preventing the immune system from doing its job and therefore causing cancer and other serious diseases. Without an active immune system, cancer and viral infections can spread rapidly.

*“Remarkably, there's a significant amount of research available on Nagalase and the GcMAF protein. Citing a chapter from ‘The GcMAF Book’ by Dr. Tim Smith, MD”, Dr. Broer said.*

Nagalase is like a stealth bomber, the Nagalase enzyme synthesized in or released from cancer cells or a virus particle pinpoints the GcMAF protein facilities on the surface of your T and B lymphocytes and simply wipes them out with an incredibly precise bomb.

How precise? Nagalase locates and attacks one specific two-electron bond located only at the 420th amino acid position on a huge protein molecule, one of tens of thousands of proteins, each containing millions of electrons.

This is like selectively taking out a park bench in a major city from 6,000 miles away. More astonishingly, if that is possible, Nagalase never misses its target, so there is no collateral damage.

As noted in a previous article, Mycoplasma is the pathogen of death and decomposition and composting. It is always looking for an opportunity to attack the human biome. This can occur when three things are out of balance:

1. pH level
2. Oxygen level
3. Immunity

It is imperative that as you get older, these three elements are given your highest priority. Vitamin D<sup>3</sup>, C, Zinc, and Elderberry fill the bill for matters of your immunity. Lifestyle, diet, and exercise cannot be ignored knowing that Mycoplasma is waiting for you to drop your guard and then attack your weakest point for the kill.

Nagalase is being found in super high concentrations in autistic children. This is most certainly prima-facia evidence that the vaccine is adulterated with toxic pathogens, i.e., Mycoplasma. Before his death, Dr. Bradstreet treated 1,100 patients with GcMAF with an 85 percent response rate – something that was deemed impossible by the medical community.
