

Nashville's Christian School Mass Shooting: A Staged, False Flag, Gladio-style Black Operation and Psyop with Several Objectives

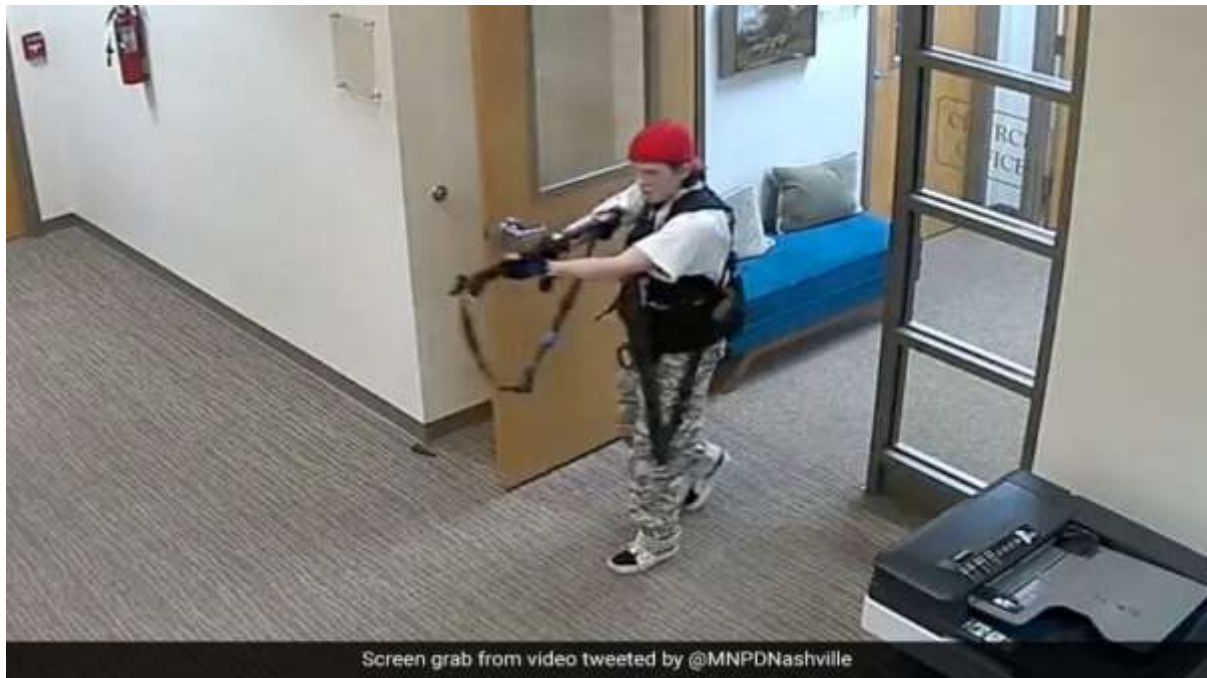
The perfectly staged photos of this transparent op tell the whole story

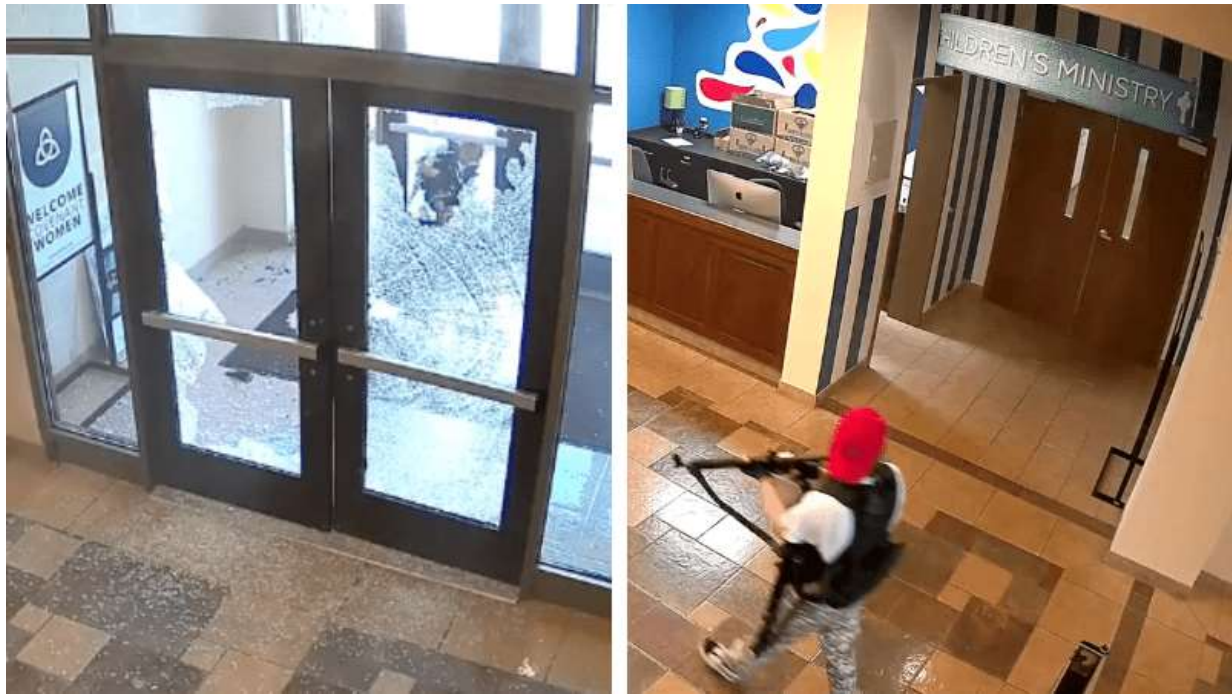
First, look at the photo above. It's all over the Internet by design.

This tragedy is fraught with outside intent to divide the U.S. and it is nothing new from what we already know. This is the 129th mass shooting this year. You would have to be dumb as a stone to not know this was done to play on the emotions of the American public and elected officials. It is directed but to one objective alone, and that is to disarm the American people and to find ways to remove the 2nd Amendment rights of the people. There are a number of things that the public are unlikely to be aware of or to think about regarding the entire tragedy. There are factors here and questions that are not being made public but may be of huge significance in obtaining true answers:

- Mentally stable women do not use weapons of the kind pictured at the top of this article, such as a 9mm Glock.
- Women are far less likely to use guns to kill people than are men. The ratio is about 8 to 1 favoring male shooters. Women are more likely to use poison, knives, hammers, blunt objects but women rarely ever use a gun unless it is a small caliber 22-pistol.
- Mentally stable women do not have the mindset or will power to kill people. It is not part of their nature or psychological disposition.
- Above all, mentally stable women do not shoot innocent children. Their natural maternal heart/mindset is to protect and nurture children.
- We need to know whether the biological female shooter was taking prescription anti-depressive medication such as Luvox, Paxil, Prozac, Zoloft, and a series of meds that were being taken by many of the serial killer's over the past twenty years. The 1999 Columbine shooters were taking psychotropic drugs for depression and mental health issues.
- Why isn't the U.S. Justice Department investigating the connection between mind-altering drugs and violent shootings?
- A few years ago constitutional attorney Jonathan Emord called on the Trump administration to investigate the possible links between psychiatric drugs and violent gun attacks in the United States. The FDA is well-aware that these drugs can cause violent behavior, yet continues to allow powerful, mind-altering drugs to be given to millions of Americans, including children.
- Why has the shooter's manifesto been kept from the public eye? She shared it with one of her friends the morning of the massacre.

- Why has the Justice Department failed to address this as a hate crime against Christians? The shooter attended this school as a child and her mother was public on Facebook about her Christian beliefs.
- While my last point may seem irrelevant; however, it would be useful to know if the female shooter had been given “Soy” milk as an infant. The fact that soy can feminize males and masculinize females is evidence of soy targeting the brain.

Why It’s NOT Good to Feed Your Baby Soy In General:

There are three reasons to refrain from going the soy route: the last reason being the worst of all.

1. Phytic acid is present in the seed coat of all seeds and blocks the absorption of critical minerals like calcium, magnesium, iron and particularly zinc. Soybeans have extremely high amounts, and it is unusually resistant to breaking down.

As early as 1967, researchers testing soy formula found that it caused negative zinc balance in every infant to whom it was given.

Zinc is the intelligence mineral; it is required for optimal brain and neurological development. As a result, deficiency of this nutrient in infants at a time when the brain is growing at its most rapid rate could have lifelong implications and possibly reduce IQ.

2. Like phytic acid, trypsin inhibitors are present in large amounts in soybeans. These inhibit digestion and absorption of nutrients. In the manufacturing process, trypsin inhibitors need application of high heat for extended periods of time to break down, but some remain in the final product and studies show their presence prevents normal growth in baby rats.

Knowing that a baby’s brain and nervous system grows to about 75% of its full size in the first year, any retardation of normal growth development is counter to helping your child reach his or her full potential.

3. The biggest danger of using soy is the phytoestrogens (plant estrogens called isoflavones) found in all soybeans whether organic, conventional or GMO. While these are not bioidentical to human estrogens, they are close enough to cause hormone disruption, and could potentially affect and alter an infant’s developing brain and physiology.

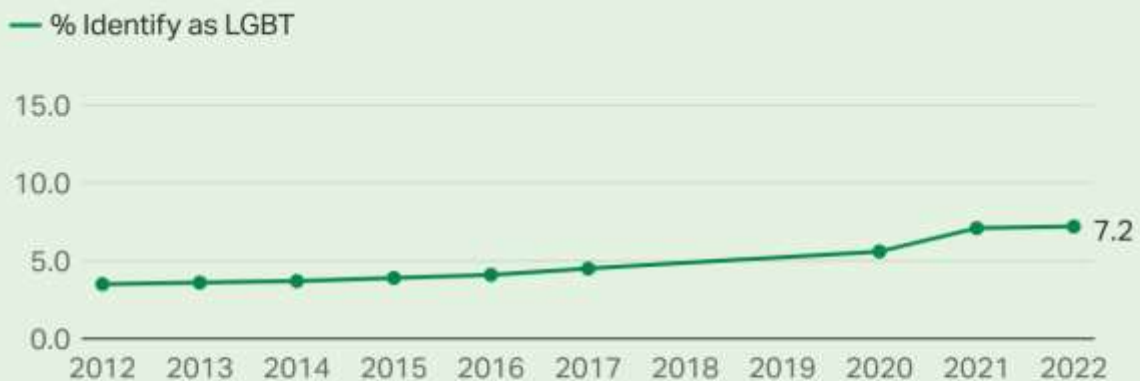
The NIH literature on this issue is accessible at Pub Med Library. Thirty years ago less than 2% of males were homosexual, and today that has increased to over 5% of males.

Gallup finds 7.2% of U.S. adults identifying as lesbian, gay, bisexual, transgender, or something other than straight or heterosexual. This percentage has doubled since Gallup first measured LGBT identification in 2012.

The Gallup polling chart below tracks a growing trend in those identified as LGBT over the course of the past decade and when you go back even further there has been a slowly growing trend with no identified reason.

Soy products are found virtually in nearly everything in the grocery stores. Today, soy is one of the three major agricultural rotational crops of corn, wheat, and soy. As a pastor I have had reason for thirty years to believe that soy infant formula and processed food products that have soy ingredients were a factor in gender dysphoria and population limiting issues.

Since "Depopulation" has been the world's #1 issue since 1968, there seems to be a correlation between birth rates in the U.S. with declining sperm levels in males. Last May, the National Toxicology Program (NTP), a federal research agency, was set to release its eagerly awaited report into the cognitive and neurodevelopmental impacts on humans from fluoride exposure.

The report was anticipated for several reasons, including its review of studies linking fluoridated water to cognitive harm in children. Water fluoridation is the long-established public policy of adding fluoride to drinking water to fight tooth decay. The report was also set to play a key role in an ongoing lawsuit, filed by government accountability nonprofit Food & Water Watch, to get the Environmental Protection Agency to regulate water fluoridation because of fluoride’s possible neurotoxic harm. More than two years ago, the judge put the case on hold in expectation of the NTP report’s public release.

Before the NTP could release the report, however, “They were blocked,” said Linda Birnbaum, NTP director until 2019. According to Freedom of Information Act (FOIA) records obtained by the plaintiffs and shared with Capital & Main, the U.S. Department of Health and Human Services (HHS) held back the release of the report after criticism of its findings from health and dental organizations that advocate for community water fluoridation. Those groups challenged the report’s scientific validity and expressed concern that it could jeopardize water fluoridation, which they said could especially impact the dental health of low income communities.

The report found that a link between typical levels of fluoride added to water and possible harm to brain development is unclear, with a recommendation for more studies, according to records. But the report did find a possible link to cognitive harm at approximately two times the current recommended water fluoridation level, records show. Some health experts believe this finding makes current water fluoridation levels potentially unsafe for developing fetuses and young children. Because many common foods and drinks contain fluoride, consuming them along with fluoridated water could amount to harmful exposure levels, these experts say.

Leading up to the report’s intended release, individuals from dental organizations including the American Dental Association (ADA) scrutinized the report’s scientific

credibility in communications with staff from other dental groups and health agencies including the National Institutes of Health and the NTP, divisions of HHS, records show.

This January, Birnbaum issued a scathing legal declaration as part of the lawsuit, writing, *"The decision to set aside the results of an external peer review process based on concerns expressed by agencies with strong policy interests on fluoride suggests the presence of political interference in what should be a strictly scientific endeavor."* Birnbaum said she issued the legal declaration in part over concerns the report might never be publicly released.

Just saying, something is very suspicious in this tragic mass murder case at a Christian church school, and the State of the Nation article is likely to be right on what they are inferring.
