

Pentagon Conducted Deadly Biological Weapons Experiments on Allied Soldiers in Ukraine and Georgia



In order to "protect its allies against Russia," the United States performed [biological weapons "experiments"](#) on Ukrainian and Georgian soldiers, newly leaked documents show. Even though both Ukraine and Georgia are considered to be American allies, the Pentagon decided to harm these countries' soldiers as part of a \$2.5 billion Defense Threat Reduction Agency (DTRA) biological engagement program, which included research on biological agents, deadly viruses and antibiotic-resistant bacteria. Each type of pathogen was unleashed on local populations in both countries as well, exposing potentially millions of people to deadly infections. (Related: The Pentagon's [secret operations programs](#) in Ukraine date at least as far back as 2005.)

A five-year Pentagon operation in Georgia, code-named GG-21, involved "[Arthropod-borne and zoonotic infections](#) among military personnel in Georgia." The project's description explains that blood samples were collected from 1,000 military recruits at the time of their registration and physical exam at the Georgian military hospital located in Gori. These samples were tested for antibodies against the following 14 pathogens:

Bacillus anthracis
Brucella
CCHF virus
Coxiella burnetii
Francisella tularensis
Hantavirus
Rickettsia species
TBE virus
Bartonella species
Borrelia species
Ehrlichia species
Leptospira species
Salmonella typhi
WNV

The 10 milliliter blood samples were to be stored indefinitely at the NCDC (Lugar Center) or the USAMRU-G, with aliquots to be sent to the Walter Reed Army Institute of Research (WRAIR) headquarters in the United States, this being the largest biomedical research facility run by the Department of Defense (DoD). Even though the experiment was not supposed to cause death, any deaths that occurred were to be "promptly reported" to the Georgian Military Hospital and WRAIR, usually within 48 hours of the PI being notified. The blood samples were also stored and further tested at the Lugar Center, a \$180 million Pentagon-funded facility in the Georgian capital of Tbilisi. If the Lugar Center sounds familiar, it could be because it has been embroiled in major controversy over the past several years. One scandal there involved drug giant Gilead, which ran a [hepatitis C program that resulted in at least 248 patient deaths](#).

Official reports listed the cause of these deaths as "unknown." *"The Georgian project GG-21 has been funded by DTRA and implemented by American military scientists from a special US Army unit code-named USAMRU-G who operate in the Lugar Center,"* reported *Arms Watch*. *"They have been given diplomatic immunity in Georgia to research bacteria, viruses and toxins without being diplomats. This unit is subordinate to the Walter Reed Army Institute of Research (WRAIR)."* Other documents obtained from the U.S. federal contracts registry show that USAMRU-G is also expanding in other nations beyond Georgia, including in Ukraine, Bulgaria, Romania, Poland and Latvia. "The next USAMRU-G project involving biological tests on soldiers [wa]s due to start in March of this year at the Bulgarian Military Hospital in Sofia," reports indicate.

Hundreds of millions of dollars have been poured into Ukraine for biological weapons programs

The Pentagon's UP-8 program in Ukraine was similar but involved intentionally spreading Crimean-Congo hemorrhagic fever (CCHF) and various hantaviruses. The research also involved patients with suspected cases of leptospirosis. That project began in 2017 and was extended a few times before ending in 2020. A description of that project reveals that 4,400 healthy soldiers in Lviv, Kharkov, Odesa, and Kyiv were experimented on. The first 4,000 were tested for antibodies against hantaviruses and

the remaining 400 for antibodies against CCHF. Just like the GG-21 experiment, UP-8 involved collecting blood samples for testing, the results of which were never provided to any of the participants. All deaths were also ordered to be reported with 24 hours. As of July 30, 2020, the DTRA allocated \$80 million for biological research programs such as this in Ukraine. The Black & Veatch Special Projects Corp. oversaw this and other programs. Another DTRA contractor operating in Ukraine is CH2M Hill, which was awarded \$22.8 to reconstruct and equip two bio-laboratories: the State Scientific Research Institute of Laboratory Diagnostics and Veterinary-Sanitary Expertise (Kyiv ILD) and the State Service of Ukraine for Food Safety and Consumer Protection Regional Diagnostic Laboratory (Odesa RDL).

"The DTRA activities in Georgia and Ukraine fall under the protection of special bilateral agreements. According to these agreements, Georgia and Ukraine shall hold harmless, bring no legal proceedings and indemnify the United States and its personnel, contractors and contractors' personnel, for damage to property, or death or injury to any persons in Georgia and Ukraine, arising out of activities under this Agreement. If DTRA-sponsored scientists cause deaths or injuries to the local population they cannot be held to account," Arms Watch explains. These major revelations show that the Pentagon is heavily vested in bioweapons operations in Eastern Europe, which just so happens to be where Russian President Vladimir Putin is performing his "special military operations."

Many believe that Putin's objective is to clean up and clear out these programs, which sit at the border of his country and threaten the Russian people just like they threaten Georgians and Ukrainians. Another perspective is that this was organized on both sides to reap massive profits from yet another war. *"All of this came to be because the globalists thrive in profits from their wars,"* wrote a commenter at *Natural News*, adding that *"scary times"* were needed as *"distractions to enact their Luciferian GREAT RESET."* *"Finally, their goal is to force their New World Order under a massively organized one world government after unleashing myriads of great destructions to keep the world of nations off balance and easily redirected into galactic cattle cars."*

President Joe Biden still expects the U.S. Senate's "okay" for the House-passed \$40 billion military aid package for Ukraine, after Republican Senator Rand Paul blocked the bill on May 12, 2022. The question is, however, what exactly the U.S. establishment is protecting in Ukraine, notes Wall Street analyst Charles Ortel.

While Joe Biden is insisting that his major objectives are to exhaust Russia, protect Ukraine's democracy and strengthen US national security, American conservative observers are growing increasingly sceptical. According to them, the \$40 billion package is unlikely to stop Ukrainian President Volodymyr Zelensky from targeting opposition journalists, while Biden's escalation of the conflict may lead to an all-out conflict between the U.S. and Russia.

The enthusiasm demonstrated by the Biden administration and some established American politicians over Ukraine could possibly stem not from their security concerns

or love for democracy but from vested interests linked either to the U.S. defense industry or Ukrainian businesses, according to Wall Street analyst and investigative journalist Charles Ortel.

"Too many relatives of prominent American politicians have been playing around in Ukraine with highly suspect oligarchs," the analyst suggests. "Some of these have taken off-market compensation and/or been given sweetheart investment opportunities. Rather than performing proper diligence on their Ukrainian partners, they may have been seduced by seemingly easy money."

Hunter Biden & Ukrainian Tycoons

To illustrate his point, Ortel recalls that the president's son, Hunter Biden, had served on the board of Ukrainian gas company Burisma, which belongs to controversial oligarch Mykola Zlochevsky, former minister of ecology and natural resources of Ukraine.

Besides that, *'The New York Post'* alleged in October 2020 that Hunter's Ukraine contact, Vadym Pozharskyi, was a "fixer" for some other shady Ukrainian oligarchs. One of them, Igor Kolomoisky, was linked to Burisma through myriad offshore companies, according to the Post. Citing emails from Hunter's notorious *"laptop from hell,"* the newspaper suggested that Pozharskyi could have met Joe Biden.

On March 24, 2022, the Russian Ministry of Defense (MoD) revealed, citing documents obtained during the Russian special operation in Ukraine, that Hunter Biden-linked firm Rosemont Seneca maintained "close ties" with the US defense contractors, including Metabiota and Black & Veatch (B&V), and participated in the financing of the Pentagon's biological programme in Ukraine. The Daily Mail confirmed on March 25th that the First Son *"helped secure millions of dollars of funding"* for Metabiota, a Department of Defense contractor which worked in Ukraine, specialising in research on pandemic-causing diseases *"that could be used as bioweapons"*.

The Clintons and Pinchuk

Yet another Ukrainian oligarch, Victor Pinchuk – a son-in-law of former Ukrainian President Leonid Kuchma – is well known for his ties to Hillary and Bill Clinton, according to Ortel. He notes that the Clinton Foundation began working inside Ukraine with Victor Pinchuk and his wife Elena Pinchuk in around 2004 or 2005.

In September 2013, less than five months before the 2014 February coup d'etat in Kiev, Pinchuk held the 10th Yalta Annual Meeting, hosting many foreign leaders, including Hillary and Bill Clinton, pushing for Ukraine's integration into *"Wider Europe"*.

After the coup, Pinchuk continued to cooperate with the Clintons. In total, he donated between 10 and 25 million dollars to their charity. *"The largest tranches from the Pinchuk Foundation to the Clinton Foundation were held in 2015 and 2016,"* exactly at the time of Hillary's presidential run, as CyberBerkut, a hacker group, alleged on July 12th, 2017.

Moreover, just two weeks before Hillary Clinton officially announced her decision to run for the presidency, Victor Pinchuk *"relentlessly"* sought to meet Bill Clinton, wanting him to *"show support for Ukraine,"* as one of the Podesta emails published by WikiLeaks indicated. According to Ortel, the aforementioned episodes resemble nothing so much as influence peddling and potential *"pay-to-play"* schemes. The Wall Street analyst believes that the interests of some U.S. political actors could be still intertwined with those of notorious Ukrainian tycoons.

Democrats Involvement in Ukraine's Biolab Activities

Meanwhile, on May 11, the Russian MoD continued to report on the extent of U.S. military biological activities in Ukraine, citing documents and other materials obtained in the course of the special operation.

The MoD has found that senior Democratic Party politicians were the chief *"ideologists"* of America's illegal operations in Ukraine-based biological laboratories. Furthermore, they have involved major multinational biotech companies in their activities, according to Igor Kirillov, the head of Russia's Radiation, Chemical, and Biological Defence Troops.

Former U.S. President Barack Obama *"in 2005 entered into partnership agreements with Ukraine to launch military biological programmes in the country,"* noted the military official, adding that former Secretary of State Hillary Clinton *"initiated the adoption of the American strategy to counter biological threats and contributed to the legalisation of dual-use research"*. Then Vice President Joe Biden *"coordinated the activities of the military biological program and was involved in financial machinations in Ukraine"*, according to the MoD.

What's Behind Washington's Denial of Biowarfare Weapons Programme in Ukraine?

Kirillov revealed that the U.S. executive branch worked to create a *"legislative framework to finance military biological research directly from the federal budget"*, as well as with funds of non-government organizations (NGOs) controlled by the leadership of the Democratic Party. These entities include charitable foundations affiliated with the Clinton family, the Rockefellers, George Soros, and the Bidens, according to the MoD. Global pharmaceutical companies, including Pfizer, Moderna, Merck, and Pentagon-affiliated biotech firm Gilead, have also become involved in these controversial "public-private" partnership schemes, the Russian military said on Wednesday.

"U.S. specialists are working [in Ukraine] on the testing of new medicines, bypassing international safety standards. As a result, Western companies seriously reduce the costs of research programmes and gain significant competitive advantages," Kirillov emphasised.

Earlier, the Russian MoD revealed that a network of more than 30 biological laboratories had been established in Ukraine, working in the interests of the Pentagon. Despite the Biden administration initially denying the MoD report, Under Secretary of

State for Political Affairs Victoria Nuland acknowledged that biological research facilities indeed exist in Ukraine and that the U.S. is striving to prevent Russia's access to them.

"Modern Ukraine is a nation where corruption is endemic," says Ortel. "Vast sums 'disappear' there even as contraband and people traffic through its borders. So, there is a need to convert illegally obtained money into clean assets such as real estate and securities that are domiciled outside Ukraine's borders. In this laundering effort, well-connected foreign politicians can play vital roles. For Deep State globalists, Ukraine is a nation that can, in theory, be used to needle Russia. These globalists can work with multilateral lending and aid organizations to promote large projects and then divert portions thereof for personal, political and statecraft purposes."

The U.S. establishment's figures have lots of skeletons in Ukraine's closet which could at least partially explain their readiness to funnel more money and weapons to the Eastern European country to keep these secrets on the hush, according to the Wall Street analyst.

Russia insists there is enough evidence on U.S. biolabs in Ukraine — diplomat Dmitry Polyansky stressed that Russia shared several hundreds of documents that contained concrete data, concrete cases, concrete companies and concrete persons UNITED NATIONS, May 13. /TASS/. Russia has furnished the United Nations Security Council with concrete evidence on U.S. companies and individuals involved in the operation of bio-laboratories in Ukraine, Russia's First Deputy Permanent Representative to the United Nations Dmitry Polyansky said on Friday.

Russia pushes for UN investigation of military biological activities in Ukraine — envoy *"We are speaking about concrete facts we have discovered, about concrete documents, which indicate that the United States has been carrying out military biological programs in biological laboratories in Ukraine. We have shared several hundreds of documents. They contain concrete data, concrete cases, concrete companies, concrete persons. If you think this evidence is not enough, then what do you think is evidence?"* he said at a United Nations Security Council meeting in reply to the remarks by the US ambassador that the documents shared with the UN Security Council by Russia provide no evidence to Moscow's statements won Washington's military biological activities in Ukraine.

"We want explanations from you," Polyansky went on to say. *"We have already said which mechanisms we are going to use. We will not drop this topic. Your attempts at turning our concrete claims and questions to you into blathering, into empty talk about Russian propaganda won't do. You will have to provide concrete explanations of the criminal activities you are engaged in Ukraine".*

Biden seems willing to risk a nuclear war with Putin over what U.S. skeletons are hidden in the Ukraine. The Ukraine does not lack for corrupt officials willing to sell their country out and Kentucky Senator Rand Paul was absolutely right by blocking the \$40-billion package that the Biden administration was prepared to give away with no fiscal oversight or accountability.



China finds new evidence regarding U.S. labs in Ukraine alarming — deputy ambassador to UN said, *"We welcome the assessment of the documents Russia presented within the framework of convention on the prohibition of biological and toxin weapons,"* Dai Bing said.

The latest evidence Russia has made public concerning U.S. bio-laboratories in Ukraine looks alarming and must be investigated, China's deputy ambassador to the United Nations, Dai Bing, said at the Russia-initiated meeting of the UN Security Council on the issue of clandestine U.S. research activities on the Ukrainian territory.

"China finds worrisome the latest evidence regarding biological activity Russia has made public. The point at issue is international security," he said. *"Any activity in the field of military research, including the evidence Russia has provided should cause the international community's great alarm. China is calling upon the parties concerned to display responsibility and to timely react and make proper checks in order to dispel doubts."*

"We welcome the assessment of the documents Russia presented within the framework of the convention (convention on the prohibition of biological and toxin weapons - TASS)," the diplomat said.

The chief of Russia's Radiation, Chemical and Biological Protection Force, Igor Kirillov, said that Ukraine had become a test site for the Western countries in developing biological weapons' components and testing new samples of medical drugs. He said that the leaders of the United States' Democratic Party were the ideologists of the U.S. military-biological activity in the Ukraine and that involved in the research were *"major pharmacological companies, such as Pfizer, Moderna and Merk and also the Gilead company, affiliated with the US Department of Defense."*

Kirillov said that Mariupol had been used as a regional center for collecting and certifying the pathogen of cholera during research conducted at Ukrainian bio-laboratories. There is evidence such work was carried out with pathogens of tularemia and anthrax.

The leak's, and I'm not speaking rhetorically, have left their marks upon people in and around the bio-weapons labs being conducted as third-party clients of the U.S. Pentagon. They may be for good reason but one can never trust any country from using the bioweapons on their own citizens.

Russian forces destroy over 3,000 armored vehicles in Ukraine operation. Also, 164 Ukraine's airplanes and 125 helicopters were destroyed since the start of the special military operation.

Over 160 Ukraine's planes as well as more than 3,000 tanks and other combat armored vehicles have been destroyed since the start of the Russian special military operation in Ukraine, Defense Ministry Spokesman Major-General Igor Konashenkov said on Thursday.

"Overall, the following targets have been destroyed since the start of the special military operation: 164 airplanes, 125 helicopters, 827 unmanned aerial vehicles, 304 surface-to-air missile systems, 3,022 tanks and other combat armored vehicles and 366 multiple launch rocket systems," Konashenkov said.

Also, 1,479 field artillery guns and mortars and 2,832 special military motor vehicles of Ukraine were destroyed in the special military operation, the spokesman added.
