Only the **Godfather** of the Medical Mafia could have gotten away with such a catastrophic crime spree against the American people—IN BROAD DAYLIGHT!





## Early life and education

Fauci was born in [Brooklyn](#), New York City, to Stephen A. Fauci and Eugenia Abys Fauci, owners of a pharmacy. His father was a [Columbia University-trained pharmacist](#), his mother and sister Denise worked the register, and Fauci

delivered prescriptions. The pharmacy was located in the [Dyker Heights](#) section of Brooklyn, directly beneath the family apartment.<sup>[5]</sup>

The carefully hidden back story, then, probably looks a lot like Nancy Pelosi's where the Italian **Black Nobility** surreptitiously pulled all the strings necessary so that Fauci would have the right pedigree to be America's top doc ... just like Pelosi is the most prominent and powerful Democrat politician in the USA. Nancy Pelosi's father was a Mafia don from Baltimore, MD.

### ***What's the essential point?***

Most of the globalist institutions are linked directly to the greatest maritime powers in history—the Republic of Venice and England. (In its glory days, the Port of London was the largest port in the world.) For it was the enormously wealthy Venetian **Black Nobility** that made the highly calculated business decision to transition to London

after “*the opening of new trade routes to the Americas and the East Indies via the Atlantic Ocean marked the beginning of Venice’s decline as a powerful maritime republic*”.

What’s the vital point here as far as the coronavirus bioweapon is concerned?

Both the Republic of Venetian (sometimes referred to as the Venetian Empire) and its greater maritime successor, the British Empire, were notorious for utilizing extreme brutality in the maintenance and expansion of their respective empires. Much of modern history and before is actually nothing but a macabre catalogue of Venetian and British colonization warmongering and terrorism (especially bioterrorism) the world over. There are actually two important points here:

**First:** That every form of terrorism that was necessary to further the globalization of the world would be employed by the hardcore globalists. That includes terrorism carried out via nuclear weapons, chemical weapons, biological weapons, mass shootings, mass bombings, mass poisonings, etc. It also includes financial terrorism, economic sanctions, corporate sabotage, currency manipulation, commodity vandalism, supply chain disruption, illegal taxation / overtaxation / tax theft, etc. Then there are the extremely destructive types of geoterrorism such as weather warfare via weaponized hurricanes and tornadoes; pyro-terrorism via DEW-triggered wildfires especially seasonal forest fires, brush fires and grass fires; scalar weapon-triggered volcanoes and earthquakes, mudslides and sinkholes, sub-seafloor and permafrost methane explosions, etc.


However, where it concerns Dr. Fauci, it is the specter and outworking of bioterrorism that was selected as the means by which the **Global Control Matrix**, which is a prerequisite to the formation of a **One World Government**, would be permanently shoehorned into place. Illicit drugs, controlled drugs, recreational drugs of every sort and kind would be controlled by the corporatocracy, especially all drug dispensaries such as pharmacies. The constant fueling of the ever-burgeoning drug culture was necessary for many reasons. Not only does a global drug society generate a LOT of profit, the never-ending proliferation of drug use (all kinds) ensures a sick populace that is easily controlled and manipulated. It also serves as an excellent control mechanism of the citizenry when there is a disease outbreak, epidemic or pandemic. The globalists know full well that whoever controls the life-saving medicines and scarce remedies controls the global population. Many times it is difficult to understand the power behind the pharmaceutical industry, yet consider this. In 2007 the drug market was estimated at

\$693 billion dollars. It is estimated to have a \$737 billion market in 2008 and above \$1 trillion for 2013. Imagine how that has grown with the events of the past 18 months.

Again, where it concerns Dr. Fauci, it's clear from his personal and family history that he was born and bred, groomed and acculturated to become one of America's premier drug dealers. Not only did his whole family run a pharmacy, Fauci himself became a glorified pharmaceutical salesman, also known as a medical doctor.

**Fauci the Jesuit**

As a good Italian-American Catholic boy growing up in New York City, Anthony Fauci was gifted with the best education money could buy which, in his case, was the most intensive Jesuit indoctrination program in the USA. The [Society of Jesus](#) used to oversee a massive and interlocking network of high schools, colleges and universities throughout the United States that was second to none in its day. Now this is where things get very interesting regarding Dr. Fauci and his Jesuit overlords. Perhaps the best place to begin this back story is with the Jesuit Oath; for it's impossible to comprehend the true depth and breadth of Jesuit criminal behavior over the past five centuries without understanding their iniquitous oath of office. What follows is an excerpt from the "[Jesuit Extreme Oath of Induction](#)" that is given to only high-ranking Jesuits.

**"I furthermore promise and declare that I will, when opportunity present, make and wage relentless war, secretly or openly, against all heretics, Protestants and Liberals, as I am directed to do, to extirpate and exterminate them from the face of the whole earth; and that I will spare neither age, sex or condition; and that I will hang, waste, boil, flay, strangle and bury alive these infamous heretics, rip up the stomachs and wombs of their women and crush their infants' heads against the walls, in order to annihilate forever their execrable race. That when the same cannot be done openly, I will secretly use the poisoned cup, the strangulating cord, the steel of the poniard or the leaden bullet, regardless of the honor, rank, dignity, or authority of the person or persons, whatever may be their condition in life, either public or private, as I at any time may be directed so to do by any agent of the Pope or Superior of the Brotherhood of the Holy Faith, of the Society of Jesus."**

It should be also noted that the Society of Jesus was founded by Saint Ignatius Loyola who was actually a crypto-Jew, as were most of the founding members of the Jesuits during the formative years of the first half of the 16th century.

*"In 1491 San Ignacio de Loyola was born in the Basque province of Guipuzcoa, Spain. His parents were Marranos and at the time of his birth the family was very wealthy. As a young man he became a member of the Jewish Illuminati order in Spain. As a cover for*

*his crypto-Jewish activities, he became very active as a Roman Catholic. On May 20, 1521 Ignatius (as he was now called) was wounded in a battle, and became a semi-cripple. Unable to succeed in the military and political arena, he started a quest for holiness and eventually ended up in Paris where he studied for the priesthood. In 1539 he had moved to Rome where he founded the JESUIT ORDER, which was to become the most vile, bloody and persecuting order in the Roman Catholic Church.”*

The word “Crypto” originates from the Greek *kryptos* (κρυπτός) meaning “hidden”. The term usually is used to describe descendants of Jews who secretly maintained their Jewish traditions while outwardly adhering to the accepted religion of whatever society they were living in.

From the fall of Jerusalem in 70 AD the Jews found themselves culturally and religiously in very precarious circumstances throughout the Middle East and Europe where they were scattered and often enslaved. While their plight differed greatly depending upon where and under what circumstances they resided the practical truth was that it was often necessary for Jews to hide their true heritage even if they had genuinely converted to Christianity.

It is important to remember that, in the Roman Empire, Christianity was considered just a sect of Judaism. It was not until Christianity became the official religion of the Empire, with the Edict of Thessalonica in 380 AD, do we begin to see a sharp cultural distinction between Jews and Christians. In some respects this Imperial alteration can be seen as the tipping point of dominance of one Jewish sect over all others as well as the dominance of one Christian sect over all others. From this point onwards the gradual religious transformation of the Old Empire accelerated until the Roman Imperial Church dominated civil and cultural life in all of Europe. All other religious traditions and practices were forced to tread a dangerous path....and secrecy was the only key to survival.

This predicament was shared by not only those still practicing Judaism but by Jewish and Arab Christians who were genuine in their conversion or had come from a completely separate Christian tradition than that of the Roman Church. As evidence of this complex state of affairs we only need to look at the trial records (preserved at the Vatican Library) of the Inquisition, which officially began in the 12th century and continued unabated for 700 years.

On June 6th, 1391, a program of forced expulsion and conversion was launched in Renaissance Spain. “*Limpieza de sangre*” or “cleanliness of blood” was the ultimate aim of these programs. Laws were enacted to permanently purify the “Old Roman Christians” of the tainted blood of those with Muslim or Jewish ancestors. This process of so-called blood purification later extended of course to all indigenous people of the New World and resulted in forced conversions and extermination of millions of Native Americans.

There is a general misconception that conversion to the Roman Church meant anything like full acceptance by the Church or “Christian Society” in general. This is where the word “Converso” comes into play, a term often associated with Crypto Judaism. Converts (Conversos) with Jewish ancestry were considered “macula”, a Latin term meaning tainted or spotted.

In 1920 the Nazi party published their The 25-point Party Program, outlining their intention to purge “Aryan” society of the tainted blood of the Jews and to strip them of their legal and civil liberties. After a brief period of relief from the Programs of the Inquisition Europe was once again plunged into a frightful period when the Jewish people, and true Christians who sought to aid and protect them, would be compelled to hide their true ancestry and faith or suffer the dreadful consequences.

Today, because of the advancement of human DNA analysis, we live in a world where it is impossible to be a Crypto Jew or a Crypto “Anyone” for that matter



## **Something to Think About in the Grand Vaxx Deception**

Since I first connected to the Internet in 1996, I have studied the history of the Jesuits and this issue comes up intermittently in Jesuit history. This statement of fact is reason for concern about the origin and purpose of the entire Vaxx program. Although I am thinking out loud here, there is the issue of Revelation 2:9 and 3:9 that will not go away. In light of the fact that our Lord brings up this issue in the very last book of the Bible, it is possible, even probable that we have been negligent when it comes to our national support of present day Israel. I submit to you that God has used the nation of Israel "old or new" -(Isaiah 66:8) to get our attention. When I say "our" I am referring to humanity! I have written 16 segments in a series entitled **"The Satanic Talmud & The Synagogue of Satan"**. The fact still remains that one of the Jesuit goals back at the turn of the 19<sup>th</sup> Century was to destroy the Church (from within) because Pope Clement XIV had banned the Jesuits. The Third Jesuit Superior-General, Francis Borgia once said, *"We came in like lambs and will rule like wolves"*. The name "Borgia" is synonymous with deception, double-dealing, betrayal, treachery, death, corruption, and their particular chosen method to murder, the "Borgia Cup" of poison. Many times people who opposed them, or were just in their way, seemed to drop dead. Some maintained that it was chanterelle, a poison favored by the Borgias. Most historians believe that it was a compound of arsenic. Arsenic poison, if dosed right, does not kill instantly. Its victim got sicker and sicker, and over a number of months and died quietly.

Think about the world today is under the Jesuit spell where the "Borgia Cup" contents are that which are being associated with a "bioweapon" in which the Vaxx is the "Kill Shot!" The Jesuits became the role model for Hitler's SS Corps. *'The Secret History of the Jesuits'*, a small book written by Edmond Paris is one of the most informative books describing the Jesuits. There is credible evidence suggesting that Hitler was being manipulated and used by the Jesuits. His infamous book *'Mein Kampf'* or "My Struggle" was authored not by Hitler but by a Jesuit priest Fr. Bernhardt Stempfle.

In 1773, they were suppressed across the world by Pope Clement XIV. It was 41 years later when another pope Pius VII undid the suppression, and 'restored' the Jesuits. The Jesuits conducted an agenda to destroy the Roman Catholic Institution from within. Many people are saying nowadays that Pope Francis provides the best demonstration of why there has never before been a Jesuit pope.

This sentiment is an example of a widespread opinion that the Society of Jesus has always been a pernicious element in the Church, a view that is understandable in the light of the order's performance in the last half-century, but which was not unknown even in earlier times.

The first thing to be said is that there was never a Jesuit pope because of the small number of Jesuit cardinals. The statutes of the Society of Jesus forbid its members to seek ecclesiastical honors, and in the past, only a few exceptional figures ever reached the Sacred College. This tradition has weakened in the last 60 years, when Jesuit cardinals have reached almost a plethora (so that the election of one of them as pope became less surprising); but if we look at the first three centuries of the Society, we find only about 20 cardinals, and they can easily be examined individually.

For the reason mentioned, the few Jesuits who did reach the cardinalate in the past tended to be unusually distinguished members not only of their order but also of the Sacred College itself, with the result that the Society's list of potential candidates proves to be an impressive one. Of the score of Jesuit cardinals before the 1950s, some, such as the illustrious Cardinal. Péter Pázmány, who never attended a conclave and were therefore not available for election.

The list of those who might have worn the tiara is headed, in every sense, by St. Robert Bellarmine, who could have been pope from 1605–1621. Many people would be prepared to concede that he would have been better than Paul V, who reigned during those years.

A similar judgment might be made on Cardinal. Juan de Lugo, who was rated by St. Alphonsus Liguori as the best theologian of the Church since St. Thomas Aquinas. He could have been pope from 1644–1660, and, again, few would dispute that he would have been better than the nasty Innocent X, who is well known from Velasquez's damning portrait. But at that period it was out of the question that a subject of the king of Spain should be elected pope.

One could cite other figures, such as the learned Giovanni Battista Tolomei, who could have been pope from 1721–1726, but such examples of a short or otherwise insignificant pontificate are of less interest.

The 40-year suppression of the Society (1773–1814) resulted in there being no Jesuit cardinal at all in the two conclaves that took place during its suppression or the four after its restoration. There was one each in the next two conclaves (1878 and 1903), but they were not Italians and were therefore not serious candidates. In the 1939 conclave,

Cardinal Pietro Boetto was eligible, but he would have had a short reign since he died in 1946.

Many are aware of the visible Pope. But few are aware of a hidden Pope behind the scenes, known as the “Black” Pope. Simultaneously a White Pope (the visible one) is in power along with a Black Pope (hidden). The Black Pope serves as the Superior-General of the Order, and the White Pope as figurehead. The current Pope, Francis, is the first time a Jesuit was elected as White Pope. This makes a White Pope and Black Pope, both Jesuits, in office at the same time, an indication that a converging goal is being reached. The Jesuits control the Vatican as we know it.

The Jesuits took over the education centers and Seminaries. Even Charles H. Spurgeon warned in a Sermon that clergy were trained under the doctrines of Jesuits and indoctrinated to preach a gospel with PORTIONS LEFT OUT, resulting in a watered-down ecumenical gospel. Many have been unwittingly subject to their doctrines through the modern churches and the means of “contemplative prayer”, as well as other indoctrinations. Jesuits are well-known for their “Liberation Theology” and ultra-liberal views in South and Central America.

The Jesuit real goal is Globalism (see Georgetown University document “Jesuits for Globalization”). They claimed their intentions are to use the Vatican as the Global Headquarters of the world with Jesuits in complete power for their brand of a New World Order. Their goal is to bring all religions under Vatican ecumenicalism and water-down the faiths to co-exist for the New Order Religion. Pope Francis has devoted his tenure as pope for this agenda.

The Jesuits were also instrumental in the development of Communism and Socialism. They influenced Karl Marx and others to bring the ideology to the public. They also crafted Liberalism and the movement of tolerance, as well as Social Justice.

Several Jesuits have come into politics and religion. Billy Graham was trained under Jesuit Bishop Fulton Sheen. You will find this unusual fact relative to Graham’s lengthy Vatican connection. This is the same Sheen that Jesuit-trained Martin Sheen (Ramón Antonio Gerardo Estévez) adopted as his surname in honor of Fulton Sheen.

The option of electing a Jesuit pope seldom arose; there was no question of a general wariness against it. No, that prejudice will begin from now on. □

The most intriguing case is perhaps that of Cardinal. Louis Billot, who could have been pope from 1914–1931. There are those prepared to say that he would have been a better pope than Pius XI. What is intriguing about his case is that he, in fact, resigned his cardinalate in 1927, allegedly at the insistence of Pius XI, who found him too right-wing for his liking.

What can be safely asserted is that if Billot had been pope, no heresy would have been heard from the Holy See or tolerated in the Church. But in any case, the bar against

Cardinal. Billot in the two conclaves he attended was not that he was a Jesuit but that he was French.

Thus, if we look at the history of conclaves since the founding of the Society of Jesus, we find that the option of electing a Jesuit pope seldom arose; there was no question of a general wariness against it.

Everything starts with Lucifer, Satan. The current power in this world is in the hands of those who worship him. And those that you think they have the power, not more than jumping jacks on the world stage. Regularly read your stories about how the Black Pope, head of the Jesuits, would be the most powerful man on earth. This is not so because above him are a number of families from The Papal (**Black Nobility**) Bloodlines, descended from Satan directly and ultimately determine what happens in the world. We have two popes, the 'White' Pope Francis, and the 'Black' Pope Arturo Soso, both Jesuits by training and mission. While you hear little about Arturo Soso, most of his remarks do reflect anti-Christian candor and are liberal and liberation in their theological beliefs and teachings.

The Jesuits never do anything out in the open where they can be exposed. If they are recognized as the culprits, they will be blamed and suffer the consequences, but if they can use someone else as the cause of the world's problems, especially an enemy they can destroy in the process, then they have simultaneously accomplished two of their objectives. It's important that you understand they work behind the scenes.

So who is fooling who? Are we under a Globalist World agenda? Are Jesuits placing their agents in high influential positions ready for a world takeover? Will they continue to use rival other Secret Societies or form into a convergence with them for One World Government? We shall see very soon what is planned for the New World Order by Prince Charles of Wales and Klaus Schwab of the World Economic Forum.

The Rothschild's are at the top of this pyramid as Jesuit agents operating under a Khazarian Jewish cover, using them [i.e., the Rothschild's] in forming the Illuminati back in 1776 effectively throws the onus of this conspiracy on the dark Khazarian Jews. The Rothschild's are certainly not the only top Jesuit agents that operate under a Zionist front.

The Jesuit Order has since 1814 onward been in complete control of the – obscenely wealthy–Vatican institution (and its Catholic clergy hierarchy) and presently also controls various other organizations together with The Elders of Zion, Knight Templars, Military Order of Malta, etc. The Jesuits secretive Modus Operandi is explained in great detail in their infamous "*The Protocols Of The learned Elders Of Zion.*" Both are practically a carbon copy of each other because the Jesuits and The Elders of Zion are simply one and the same. The Elders Of Zion are secretly at the very top of the Jesuits hierarchy. We currently know this extremely deceitful dark and evil movement as the New World order (NWO). The origin of the "Protocols" has been in dispute for over a century, which is a reflection on how talented the Jesuit masters are in their agenda.

Even Pope Gregory IX had to admit: *"The Jesuit foxes have various faces, but they all hang together by their tails."* The French Revolution was a program not only to punish the Monarchs, but to try to create an anti-religion utopian society. Its history is a complex one. *'The Grand Design Exposed'* written by John Daniel exposed the Jesuit link to the French Revolution. A host of factors caused it. The poor and middle classes accused the aristocracy of economic corruption and high taxes (including King Louis XVI and the Austrian Queen Marie Antionette. King Louis was more righteous and compassionate than the Queen was). In that time, St. Germain, who was a mystic and occultist, said that Louis XV's grandson will be beheaded. His grandson was beheaded indeed. Cagliostro was another famous person related to the French Revolutionary history. He (or Cagliostro, whose real name was Joseph Balsamo) was a disciple of St. Germain and was a Jewish Masonic founder of the Mizraim rite in Masonry. He even wanted the Pope to accept his order as a merging of Roman Catholicism with the Egyptian mysteries.

I mentioned John Daniel's book *'The Grand Design Exposed'* especially because it has been deeply researched in a way that few others I know of that address this important issue in what we commonly see as **"Mystery, Babylon the Great"** of Revelation 17:5. The Jesuits are always lurking in the shadows of their activities, never directly in the front of an issue.

The Jesuits trained many of the Revolutionaries (i.e. the Archbishop of Paris Jean Baptiste Gobel supported it. Catholic Sieyes advised the pro-Jacobin Freemason Napoleon Bonaparte, pro-Jesuit Champion de Cice supported the Revolution, and Robespierre was trained by the Jesuits in the College Louis le Grand). Voltaire supported the Jesuits and his friend was a Jesuit named Poree.

On his deathbed, according to John Daniel, Voltaire wanted to be a Catholic as he revealed to the Jesuit named Gaultier. The French Rights of Man was created in August 25, 1789. Jewish people were emancipated in 1791. Even Robespierre was beheaded in July 24, 1794. Basically, the Revolution was about extremists executing the punishment of the Monarchs for the suppression of the Jesuits and to enact the Masonic aim of a "Republic" by any means necessary. This wasn't about "Liberty, Equality, and Fraternity" (the traditional Masonic motto) but terrorism 101.

It would be the Jesuit stronghold Bavaria where the Bavarian Illuminati and Nazi Germany would be born. Illuminati-like organizations existed for thousands of years. One single example is the ancient Alumbrados of Spain during the 1500's. John Robison, Professor of Natural Philosophy, who was General Secretary of the Royal Society of Edenborough and an influential Freemason, was one of the leading intellectuals of his day. He was a witness to the influence of the Illuminati and the Jesuits within Freemasonry (Robison wrote that the Jesuits wanted to maintain their power by trying to influence Freemasonry). In 1798 he published a book titled *'Proofs of a Conspiracy'*. In his authoritative book, Professor Robison stated the following regarding the amalgamation of Freemasonry and the Illuminati as:

*“...an association has been formed for the express purpose of rooting out all religious establishments and overturning all the existing governments of Europe. I have seen this association exerting itself zealously and systematically, till it has become almost irresistible: and I have seen that the most active leaders in the French Revolution were members of this association, and conducted their first movements according to its principles, and by means of its instructions and assistance, formerly requested and obtained.”* -(JOHN ROBISON, PROOFS OF A CONSPIRACY pg. 7 (1798).

In this expose, I have been dealing with related threads in this big picture. At this point, I want to bring your attention to something extremely important in interpreting the Bible. Pay close attention here to what I am about to share, especially those of you who believe in the Pre-Tribulation Rapture because this is rich fertile soil relative to Scripture that few of your teachers know anything about. I would have never thought my academic major of history in college would be as valuable as it has been in the last third of my physical life. This will help you understand why I have been a Dispensationalist and a firm believer in the Pre-Tribulation Rapture for 54 years that began with the events of June 7, 1967.

Ignatius of Loyola's secretary, Polanco, was of Jewish descent and was the only person present at Loyola's deathbed. James Lainez, who succeeded Loyola as the second Jesuit General, was also of Jewish descent. Jews were attracted to the Jesuit order and joined in large numbers. Lacunza was no exception. He was a Jew, which explains why he introduced the eschatological teaching of a return to the Jewish animal sacrifices during the Millennium. (In a book titled *'The Coming of the Messiah in Glory and Majesty'* published in 1812, 11 years after the death of its author, Jesuit Emanuel de Lacunza who, wrote under the fictitious pen name of a purportedly converted Jew, Rabbi Juan Josepha Ben Ezra, in order to conceal his identity and to make his writings more palatable to the Protestant readers.

He promoted the writings of sixteenth century Jesuit priest Francisco Ribera, developing a futuristic perspective which restricted the prophetic fulfillments in the book of Revelation to the end of the world. Lacunza also wrote that during a millennium after the tribulation the Jewish animal sacrifices would be reinstated along with the Eucharist (the mass) of the Catholic Church. Lacunza has followed after Jewish fables and replaced the commandments of God with the commandments of men. That doctrine gives the Jews primacy in God's plan and relegates Christians to a prophetic parenthetical to be supplanted by the Jews during the thousand year earthly reign of Christ.

It is important to point out here many critics of the Pre-Tribulation Rapture err relative to their incomplete understanding of history during this period. The history of the Reformation has not been of great interest for at least two centuries at least. Several years ago I did a 3-part series on Biblical Forensics© **“Jesuit Deception on the Rapture”**. Biblical Forensics© was the title of my church bulletin insert series I did for pastors wanting to provide their congregations educational history on the church and the faith. During its time, I published approximately 1,300+ mini-lessons in a 4-page format as a worship bulletin insert. Three of those mini-lessons were on how the

Jesuits deflected the attack on the pope as being the Antichrist of the Bible. Martin Luther really only wanted to access the Greek texts in Rome's possession so that he could simply translate the Bible into his native German language. When he got to Saint Peter's he was shocked, indignant and repulsed by what he saw and experienced, in which he later called the pope the Antichrist.

Rome's answer to the Protestant Reformation was twofold, though actually conflicting and contradictory in its results. Through the Jesuits Francisco Ribera, of Salamanca, Spain, and Robert Bellarmine, of Rome, the Papacy put forth her "Futurist" interpretation. Almost simultaneously Luis Alcazar, a Spanish Jesuit of Seville, advanced the conflicting "Preterist" interpretation. These were designed to meet and overwhelm the traditional "Historical" interpretation of the Protestants. Though mutually exclusive, either Jesuit alternative suited the great objective equally well, as both thrust aside the application of the prophecies from the existing Church of Rome. In this picture, we have two Jesuits writing separate scenarios for the book of Revelation, 180-degrees different from each other.

The one ("Preterism") accomplished it by making prophecy stop altogether short of Papal Rome's career beginning. The other ("Futurism") achieved it by making it overlap the immense era of Papal dominance, crowding out the Antichrist into a small fragment of time in the still distant future, just before the Great Tribulation. It is sometimes called or referred to as the "Gap" theory. I should add here that both Roman Catholics and Protestants agree as to the origin of these two different interpretations. If you are looking for a date identifying when the "Preterist" and "Futurist" schools of thought originated, it would be 1591 A.D. for the "Futurist" and 1614 A.D. for the "Preterist" positions.

They countered accusations by creating concepts of an End-Times 70<sup>th</sup> Week of Daniel, featuring a one man Antichrist. The Roman Catholic Church enlisted Jesuit Priest Francisco Ribera, a brilliant man with a doctorate in theology, to write a 500-page commentary with an opposing view, where he interpreted prophecies in the books of Daniel and Revelation, to create an end-time 7-year tribulation Antichrist. Ribera applied all of Revelation to the End-Time rather than to the history of the church. His explanation was that the prophecies apply only to a single sinister man who will arise up at the end of time; instead of a beast, which the Bible says is a powerful kingdom (the Roman Catholic Institution).

He said that the Antichrist would be an infidel from outside the church of God; instead of someone who presents himself as Christ (i.e. the pope, who calls himself the Vicar of Christ). He said that the Antichrist would make a 7-year peace agreement with the Jews. The most important passage that Ribera manipulated is the 70 Weeks of Daniel's prophecy in Daniel 9:24-27. He applied the 70th Week of Daniel to an End Times Antichrist, and thus replacing the Roman Church view of the 7-year period of Jesus' New Covenant being offered to the house of Israel from 27-34 A.D. Because of the End Times deceptions that are based upon them, these are the four most important prophecy verses in the entire Bible. Dispensational scholars believe this to be the case.

The intent was to offer a Bible study that proves that the Covenant of the 70th Week of Daniel was from Jesus Christ and not an End Time Antichrist. This idea became known as "Futurism" thereby deflecting all accusations away from the Roman Catholic Church and the Papacy. This solved the problem for Rome as the pope being the Antichrist and so they quickly adopted this viewpoint as the Church's official position on the Antichrist.

Prophecies in Daniel and Revelation tell us about the battle between Jesus and Satan throughout history, from the time they were written to or about Jesus' Second Coming. The 'Beast of Revelation', the 'Little Horn of Daniel', the 'Son of Perdition' and the 'Babylonian Harlot', all apply to the history of the Antichrist and the Roman Catholic Church, who proclaims to be Christian, but has opposed true Christianity throughout history. This then came to be known as "Historicism". It was the common belief held by the majority of the Protestant Reformers in the decades to follow. The Catholic Church tried to counter it with Preterism and Futurism during the Counter Reformation era. This alternative view served to bolster the Catholic Church's position against attacks by Protestants, and it is viewed as a Catholic defense against the Protestant Historicist view which identified the Roman Catholic Church as a persecuting apostasy and the Pope with the Anti-Christ.

Lucifer has used both Jesuit-controlled false prophets and Christians who were misled to unwittingly promote the idea of "Futurism". Following closely behind Francisco Ribera, another brilliant Jesuit scholar emerged named Cardinal Robert Bellarmine of Rome. Cardinal Bellarmine promoted Ribera's concept in his work "*Polemic Lectures Concerning the Disputed points of the Christian Belief Against the Heretics of this Time*". His writings claimed that Paul, Daniel, and John had nothing whatsoever to say about the Papal power. He taught that Antichrist was a single individual who would not rule until the very end of time and his teachings won general acceptance among Roman Catholics.

For almost 200 years after the Council of Trent, Jesuit "Futurism" remained largely within Catholicism. For three centuries, the "Futurism" of Fr. Francisco Ribera never posed a positive threat to Protestants worldwide, and was virtually confined to the cathedrals of the Roman Church. Ribera's manipulation of the Biblical text was rejected for hundreds of years, by discerning students of the Bible, who believed differently. Meanwhile, Jesuits continued to persist with their plan to cause Protestants to adopt this doctrine. Since its inception, Ribera's basic thesis has remained virtually unchanged. He assigned the first few chapters of the Apocalypse to ancient Rome, in John's own time; the rest he restricted to a literal three-and-a-half year reign of the infidel Antichrist, who would bitterly oppose and blaspheme the saints just before the Second Coming. He taught that Antichrist would be a single individual, who would rebuild the Temple in Jerusalem, abolish the Christian religion, deny Christ Jesus, be received by the Jews, pretend to be God, and conquer the world – all in this brief space of three-and-a-half years!

It is interesting to note how the Jesuits never anticipated that future generations would be able to refine the futurist theory to how it is presently represented today. As it turns

out the Preterist theory by definition does not believe that there is a literal millennial. As far as the Preterist is concerned, the book of Revelation is reduced to little more than a relic of antiquity, with no message of importance for later generations. It eliminates God's future dealings with Israel, teaching that God is done with them nationally. The "Preterist" thesis is that all the events of the book of Revelation were fulfilled during the days of either Nero or Domitian. The book is concerned only with events of the first century. A well-known Preterist was the late Dr. D.J. Kennedy of Coral Ridge Ministries in Florida. Chuck Baldwin holds this view as well after he rejected his education taught by the late Jerry Falwell.

The "Historical" theory leads to post-millennialism, the belief that Christ Jesus will return at the end of the millennial age. The multiplicity of the interpretation of metaphors and symbols quickly becomes intolerably influenced by personal feelings, tastes, or opinions. The "Historical" thesis is a panorama of church history, from the initiation of the apostolic era to the consummation of the age.

The "Idealist" theory leads to the amillennial view that there is no literal reign of Christ Jesus on earth for one thousand years as noted in chapter 20 of Revelation (not once but 6X times). Like the "Historical" theory, the multiplicity of the interpretation of metaphors and symbols quickly become intolerably subjective. The "Idealist" thesis states that the Apocalypse is to be developed as a representation of actual events, whether past or future. The book is viewed only as a symbol or metaphor depicting the great struggle between good and evil.

The "Futuristic" theory remains the only belief that Christ Jesus will return to usher in the millennial age. It alone provides perfect harmony of the entire Bible. Far fewer interpretive enigmas are problematic with this approach. The "Futuristic" thesis begins with chapter four of the book of Revelation. The events described belong to a future age and constitutes a marvelous prophecy of God's program for the consummation of the age. It views the book of the Revelation of Jesus Christ as an overview or outline of events in the life of the Jews. Remember, the Bible does define God's plan of history!

Prophetically speaking, God used the Jesuits in such a way that what they meant for evil and deception to save the pope's bacon; however, God has used their plan for God's intended good! As the Scripture states in Genesis 50:20. ***"But as for you, ye thought evil against me, but God meant it unto good, to bring to pass, as it is this day, to save much people alive"***. I often would recall this passage when I was younger and things did not go as expected.

The inevitable conclusion of those who studied these prophecies in Scripture, before and during the Protestant Reformation, was that there was only one entity that fit all the above characteristics: and that was the Papal dynasty of the Roman Catholic Institution. Is it any wonder that the Catholic Church was so violently opposed to the Scriptures being available for everyone to read for themselves? The stir created during the Reformation caused the Fifth Lateran Council of 1512-1517 to strictly forbid anyone from publishing a book without prior censorship, and prohibited anyone from preaching

on the subject of the Antichrist. Think about how this characterizes the present days when medical experts are fired or blocked in the media when they disagree with the official narrative of the scamdemic of the Covid-19 deception.

Critics of the “Futurist” theory, and also the Pre-Tribulation Rapture are always quick to blame modern scholars for getting their Dispensational theology from the Jesuit Francisco Ribera as if that somehow proves the Pre-Tribulation Rapture doctrine is wrong. Fr. Ribera published his 500-page commentary on the book of Revelation in 1590. He died shortly thereafter in 1591 at the age of fifty-four.

In hindsight, it is surprising to realize just how close his “Futurism” theory is and even so similar when compared with Dispensationalism, the Pre-Tribulation Rapture, Daniel’s 70th Week, and the Antichrist.

**The fact remains that at the Council of Trent, the Jesuits were commissioned specifically by the pope to develop a new interpretation of the Scriptures that would counteract the Protestant Reformers application of the Bible’s Antichrist being the Roman Catholic Church.** Francisco Ribera was a doctor of theology and a brilliant Jesuit priest from Spain. Like Martin Luther, Francisco Ribera also read the Bible’s prophecies by candlelight – the prophecies of the Antichrist, the little horn, the man of sin, and the Beast. But because of his dedication and devotion to the Papacy, he came to conclusions vastly different from those of the Protestants.

For three centuries, the “Futurism” of Francisco Ribera never posed a threat to Protestantism. It was virtually contained within Roman Catholicism. Interestingly, Fr. Francisco Ribera unwittingly and unsuspectingly handed the substance of what we call Dispensational and Pre-Tribulationism to the Protestants. Note the points that Fr. Francisco Ribera makes about the Antichrist (which he saw as an infidel outside of the church), and his agenda:

- Persecutes and blasphemes the saints of God
- Rebuilds the Temple in Jerusalem
- Abolishes the Christian religion
- Denies Jesus Christ
- Will be received by the Jews
- Pretends to be God
- Kills the two witnesses of God
- Conquers the world

Along with Fr. Francisco Ribera and Cardinal Robert Bellarmine, Manuel De Lacunza, a Jesuit from Chile, wrote a manuscript in Spanish titled: ‘*The Coming of the Messiah in Glory and Majesty*’. In order to give his book better acceptance in Protestantism which was his intended audience, Lacunza wrote under an assumed Jewish name to obscure the fact that he was a Catholic. Also, an advocate of “Futurism”, Lacunza deliberately attempted to take the pressure off the Papacy by proposing the Antichrist was still off in

the distant future. Jesuit deceit to fool the Protestant reformers and laity came back to haunt the Vatican in the 19<sup>th</sup> and 20<sup>th</sup> centuries.

The point to keep mindful of here is that despite all the efforts of several Jesuit scholars who were engaged in the propagation of deception by developing the “Futuristic” theory, they all unwittingly and unintentionally really did lay the ground work which later assisted Protestant scholars who would come along later to fine-tune the “Futuristic” theory which ultimately has become the basis for the Dispensationalist view, the Pre-Tribulation Rapture teaching, Daniel’s 70th Week, a rebuilt Temple, and the Seven Year Tribulation doctrine. Keep in mind, God presents the challenge in Proverbs 25:2 to search the Scriptures and discover His Truths and the Secrets of the Creator.

From 10 years of seminary education and fifty years+ of study, I know there is not a single Bible doctrine, not one, that is virtually delivered to you on a plate as a package deal in bullet-point form. Instead it demands and requires that Biblical doctrine can only be defined by studying the whole counsel of God!

That being said, those critical of Dispensationalism and the Pre-Tribulation Rapture simply, because the teaching originated within the Jesuits, lacks any substance to dismiss the entire concept of “Futurism” as being errant. In fact, perhaps the named individuals above are deserving of our sincere gratitude and thanks, a special thanks for breaking, “turning over the soil” (i.e., Scripture).

I am not saying that “Futurism” is exclusively a Jesuit theory; on the contrary, we will find that there are many others who wrote of the Pre-Tribulation doctrine far earlier than the Reformation Era. Let us never forget and be reminded of the fact that it was the Apostle Paul who first taught the Pre-Tribulation doctrine. The early church fathers up through the beginning of the fourth century believed in the doctrine of Imminence and Millennialism. What I am suggesting is that those with an axe to grind against the Pre-Tribulation doctrine do so with such prejudiced bias which cannot really be substantiated or supported by using a “straw man” argument simply by framing Jesuit theologians for fraudulently creating the “Futurist” theology.

To begin with, they were learned theologians. Jesuits undergo twelve years of academic excellence in higher education. They are formidable scholars and debaters, and few Protestants are able to equal or best them in matters of Bible hermeneutics. I am inferring that many of those who oppose the Pre-Tribulation doctrine, are themselves lacking in their own qualifications to even consider questioning the validity of the likes of Fr. Francisco Ribera. Never lose sight of the fact that the Pre-Tribulation Rapture is not dependent on who may have noticed it first and taught certain elements of it. Pre-Tribulation is valid only if it is supported by Scripture. At the end of the day, the Bible becomes the definitive authority and arbitrator of God’s Truth.

Any question or conflict over the issue concerning “gaps” is well established showing where various passages reveal over 24 examples throughout the Bible describing where “gaps” have taken place from first mention to its actual fulfillment. Perhaps the

greatest example of a “gap” is identified where Jesus of Nazareth read Himself from the scroll of Isaiah 61:1-2, only to stop at a “comma” and close the scroll without finishing the rest of the passage. This meant that the prophecy He read is the part that was being fulfilled at that specific moment while the balance of the prophecy was to be realized at a later point in time. This experience is recorded picked up in the Gospel of Luke 4:17-21.

The Creator placed these “gaps” as a means of validating the integrity of the structure of the Divine Corpus [Old/New Testaments], particularly so to establish the connectedness between what we call the Old and New Testaments. They bridge both time and context to affirm its structural integrity. There are a few false assumptions made by those who would deny the Pre-Tribulation rapture because of its supposed Jesuit origins. There are 24 specific “gaps” that tie the Old Testament with the New Testament. They not only validate the Bible’s accuracy but establish its undivided integrity.

Consider these cogent false assumptions:

False assumption #1: They assume that, because they died for their faith, the reformers and martyrs, must have had an absolutely correct and perfect view of prophecy. This assumption elevates men above Scripture. The men of the Protestant Reformation died because they fought against revering men, they died for the right of all men to personally read, study, and respect Scripture more than men. Therefore, putting the prophetic beliefs of the reformers and martyrs upon a pedestal is exactly the opposite of the principles for which they fought and died.

If the reformers had the ability, the right, and the freedom to make Christ Jesus their head instead of the pope, and if they trusted the Words of Jesus that He would lead them into truth, and if they trusted in their intellectual capability to read and comprehend the Scriptures, then there is nothing stopping us today from doing the exact same thing ourselves.

Speaking of the beliefs of the reformers; there were many early English Bible translations before the KJV Bible in 1611. In at least six of those early English translations from the 1300’s to the 1500’s, the Greek word “**Apostasia**” in 2<sup>nd</sup> Thessalonians 2:3 was originally translated “**departure**” or “**departing**”, instead of “**falling away**” which now appears in the KJV, or “**rebellion**” in other modern translations.

What is not commonly known, unless you are a history student such as myself, by the public today is that there were serious efforts, by the Jesuits, underway to coerce the return of England back under the power and control of the Papacy. The KJV translators were doing something that would appease the Jesuits, and that we would take issue with today, and that was their attempt at being politically correct, which resulted in conceding to a watering down the English translation of the KJV Bible. A specific example of this diluting of the meaning is the most important word that deals with the Rapture in the translation of the word “**Apostasia**”. In six previous published Bibles

(English language Bibles) the translators had translated the word to read **“departure”** and the KJV translators watered it down by using the word **“falling away”**. Many in the Church of England wanted to re-unite with Rome, and that included a number of the King James translators.

False Assumption #2: They assume that the “Futurist” view of a future Antichrist is incompatible with the “historicist” view that the pope is the Antichrist. Nothing could be further from the truth. There are often double or multiple references and double or multiple fulfillments in Scripture. Just because there is an “Antichrist to come”, it does not mean there cannot now be any antichrists to come, or that the existence of antichrists were not present at the time Scripture was written. “Futurism,” and the view of the Pre-Tribulation Rapture, do not take that off the Papacy or eliminate its culpability. This point is made clear in 1<sup>st</sup> John 2:18 and 1<sup>st</sup> John 4:3, in the use of the phrases, **“even now are there many antichrist”**, and **“even now already is it in the world”**. Therefore, to conclude that the issue speaks of one where the Antichrist must either be interpreted as coming only in the future, or existing now in the present only, or is a past event is a huge fabrication. Anyone can read the Scriptures and easily arrive at the answer that Scripture means that it can have both understandings! The “either/or” thought process is inconsistent with the text. The point is Fr. Francisco Ribera did not teach the Pre-Tribulation doctrine, but merely taught “Futurism”. I would argue that Fr. Francisco Ribera was not the first, and I will list many before him shortly who did teach the Pre-Tribulation Rapture doctrine, including the Apostle Paul.

False assumption #3: Often we hear opponents of the Pre-Tribulation doctrine argue that Fr. Francisco Ribera invented the Pre-Tribulation Rapture. Again, that is completely false, if not a distortion of Fr. Ribera’s words altogether. Ribera did not teach a Pre-Tribulation Rapture, he taught primarily “Futurism”, and that an Antichrist was to come in the future.

False assumption #4: Some critics claim, on the one hand, that the few thousands of early reformers who were killed for their faith somehow proves that their prophetic interpretation of “Historicism” was true. On the other hand, these same critics who deny the Rapture will claim that the millions in China who were taught about the Pre-Tribulation rapture and were killed for their faith merely proves that they had the wrong prophetic view. Well-known TV preachers and many Internet want-to-be do it all the time. This view follows an errant line of reasoning and logic because there is a gross inconsistency in the application of this principle which views martyrs for their faith as automatically having the right prophetic views. An excellent example of this is those who will create a “straw man” argument, using a Christian named Corrie Ten Boom who went through the horrors of the Jewish Holocaust, and who said that the doctrine of the Pre-Tribulation Rapture deceived many Christians in China who were martyred because they were not prepared to be persecuted, because they were taught that persecution would only come in the future. Corrie Ten Boom’s logic and reasoning are deeply flawed but that does not stop the Pre-Tribulation Rapture critics from quoting her.

To revere Corrie Ten Boom's evaluation of the Rapture as somehow worthy of adulation because she suffered at the hands of the Nazis is the same old error of elevating the opinion of men above what the Word of God says. A number of people who oppose the Pre-Tribulation Rapture view quote her as if she was an apostle in her day. I could name at least a dozen names of well-known church leaders who attack the Pre-Tribulation Rapture position and none have done their home-work on the historical background of the people they claim as justification for their rejection.

In my series "*Pre-Tribulation Truth - 5*", I shared a partial list of early Church Fathers and leaders who believed in and wrote about the concept of Imminence and the Pre-Tribulation Rapture, noted here by Dr. H. Wayne House, a very well-respected Pre-Tribulation scholar. Here are the names of some of the early Christians who believed and taught about the idea of Pre-Tribulationism:

- Clement of Rome (bishop of Rome, 90-100 A.D.)
- Polycarp (bishop of Smyrna in western Asia Minor, 70-155/160 A.D.)
- Papias (bishop of Hierapolis in Phrygia, Asia Minor, 70-130/155 A.D.)
- Ignatius (bishop of Antioch in Syria, 98/117 A.D.)
- Author of Epistle to Barnabas (70-132 A.D.)
- Justin Martyr (Samaria and Rome, 100-165 A.D.)
- Tatian (Assyrian, Rome, Antioch in Syria, 120-180 A.D.)
- Irenaeus (Asia Minor, bishop of Lyon, Gaul [France], 120-202 A.D.)
- Hypolytus (presbyter and teacher in Rome (236 A.D.)
- Tertullian (Carthage in Northern Africa, 150-225 A.D.)
- Cyprian (bishop of Carthage, 200-258 A.D.)
- Commodianus (Africa, 200-270 A.D.)
- Victorinus (bishop of Pettau, in Austria, 240-303 A.D.)
- Coracion (Egypt, 230-280 A.D.)
- Lactantius (Italy, 240-330 A.D.)
- Methodius (Thessalonica and Slavia, 250-314 A.D.)

Another Counter-Reformation Jesuit who wrote on behalf of the traditional "Historicism" held by Protestantism was proposed by the Spanish Jesuit Luis De Alcazar (1554-1613), who wrote a commentary nearly 900 pages long called 'Investigation of the Hidden Sense of the Apocalypse'. In it, he proposed that ALL of the book of Revelation applied to the era of pagan Rome and the first six centuries of Christianity. Alcazar stated:

- Revelation, chapters 1-11 describes the rejection of the Jews and the destruction of Jerusalem by the Romans.
- Revelation, chapters 12-19 was about the overthrow of Roman paganism (the great harlot) and the conversion of the empire to the church.
- Revelation 20 describes the final persecution by the Antichrist, who is identified as Caesar Nero (54-68 A.D.), and judgment.

- Revelation 21-22 describes the triumph of the New Jerusalem, the Roman Catholic Church. Alcazar found no application of prophecy to the middle ages or to the Papacy.

The fact that his work differed so greatly from that put forth by Fr. Francisco Ribera or Cardinal Robert Bellarmine, was of no consequence to the Jesuits. The sole intent in all of their writings was to deflect the focus off the Protestant conclusion that the Papacy was seen as the Antichrist. Roman Catholicism was determined to retain religious and temporal power at all costs. It was losing adherents to the Reformation and the Jesuits came along at the right time to see that Rome held the reins of power, be it religious or temporal. It was a last ditch effort to thwart the Reformation and to counter all claims of the Reformers, regardless of whether the line of reasoning was scripturally sound or not. The Jesuits earned their reputation by becoming the pope's equivalent of the U.S. Marines.

The intent of both "Futurism" and "Preterism" was to implant a diversion, and a distraction to counter the Protestant Historical interpretation by presenting alternatives, no matter how implausible they might be. The result is evident when one notices the outcome of the effect to distract the world away from Rome. The Jesuits were able to place the Antichrist outside the Middle Ages and the Reformation Period. Fr. Francisco Ribera's "Futurism" put the Antichrist's literal three-and-a-half-years into the Future. Whereas, Alcazar's "Preterism" identified the Antichrist as Nero. What the Jesuits never counted on was the fact that Fr. Francisco Ribera was such a tremendous Bible scholar that he virtually gave later scholars and theologians enough of a basis for "Futurism", by framing the structure and providing room for future refinement as a system of modern day Dispensationalism theology. The scenario that Fr. Ribera presented actually became the essence of the foundational groundwork for the likes of John Nelson Darby in 1827-1828 and to become the Dispensational school of theology.

John Nelson Darby states that it was the 32<sup>nd</sup> chapter of Isaiah that convinced him that God was not through with Israel and that God had more to deal with in regards to mankind in the future. In all likelihood, there is no group of theologians alive today who have greater regrets for Fr. Francisco Ribera's work than the Jesuits.

The irony behind the reasons the Jesuits spawned fallacies meant to inject propaganda into Biblical doctrine was that they were intended to deflect criticism away from the Papacy. Instead, the basis of their teaching has become the foundation of the Dispensational school of theology and can only be understood in God's realm as a catalyst for "Futurism".

As a tactic designed to discredit their own basic work, the Jesuits have resorted to referring to Ribera's work as a Jesuit lie. The opponents of Dispensational Theology and the Pre-Tribulation Rapture choose to parrot these claims without ever reading for themselves the work of Fr. Francisco Ribera so that they can fairly evaluate his work from an educated and correct perspective. The likelihood of any critic of the Pre-Tribulation Rapture having ever read Fr. Francisco Ribera is close to zero, and the

reason for this is, Fr. Francisco Ribera's writings were never translated into English. I note this because most of those critical of the Pre-Tribulation Rapture in our time only "cherry-pick" scholars like Francisco Ribera, Robert Bellarmine, Charles Nelson Darby or even C.I. Scofield. Simply put, none of today's critics of the Pre-Tribulation Rapture, are not historians, let alone church historians. I do not need to name them. When you see them attacking Dispensationalism or the Pre-Tribulation Rapture, they are only exposing their ignorance!

The next time you pick up a book or commentary and wonder why it names the "four" views of interpretation the book of Revelation, you will now know the Jesuits are the origin of two of those views: "Preterism" and "Futurism".

At this point in this scenario, I want you to keep in mind that the Jesuits were early on in their establishment crypto-Jews and they figure significantly in the behind the scenes efforts of the vaccine industry today, which I noted in Part 1 of this series. When one take into the question that I raised on page 23 and 24 of this segment, we begin to see something most unusual. The pharmaceutical industry is dominated by Jews. The CDC likewise is dominated by Jews. My continued investigation of the other Big Pharma to date has been validated. Big Pharma is an extension of the International Banking Cartel owned and controlled by crypto-Jews as well. The Vatican elite are crypto-Jews masking as Jesuits. Pope Francis is the chief cheerleader for global government and has been so for several years. They are joined at the hip with their "Fiduciary Agents", the House of Rothschild.

The role of a "Fiduciary Agent" is to preserve and increase the wealth of the "Assignee", a person to whom a right or liability is legally transferred. A "Fiduciary Agent" has all the power of a "power of attorney", which gives the authority to act for another person in specified or all legal or financial matters.

Over the course of the past eighteen months, there have been indications, actually more than just indications, simple proof to suggest that there is circumstantial evidence to support the premise that the Coronavirus was really part of a global "depopulation" plan to eliminate about seven billion people on the planet. I provided substantial background to this in other articles. As we begin to focus on the various parties involved, the picture is becoming into greater focus. Keep in mind that the Rothschild's and Bill Gates patented the Covid-19 virus in 2015, five years before it was hatched upon the world! Bill Gates and Dr. Anthony Fauci have a relationship of sorts since Bill Gates has given Dr. Fauci a grant of \$100 million dollars in 2019. Other researchers have stated Bill Gates has given Dr. Fauci \$200 million dollars. This is not pocket money as my dad would say.

The former Pfizer VP Dr. Yeadon has just stated that governments lied about Virus, Vaccines to force the Global Digital ID. This is a Bill Gates program in conjunction with the World Economic Forum, known as QuantumDot/Hydrogel ID2020. We are talking "Mark" of the Beast folks!

My thoughts are that we are watching the New World Order making its move to take-over the world. It's not just an International Zionist banking cartel operation. It is made up of elements which Jesus Christ referred to in Revelation 2:9 and 3:9. These would be the Khazarians and their descendants that infiltrated Judaism in the period from the 10<sup>th</sup> to the 12<sup>th</sup> centuries. We know them as Ashkenazi Jews, not the Biblical Jews descending from Abraham, Isaac, and Jacob. They converted to Judaism from the area which we would know as Khazaria. As you can see from the map below, this area is from the area that is largely the nations of Uzbekistan, Kazakhstan, Russia, Ukraine, Azerbaijan, Georgia and Armenia.



It is important that you understand, we are differentiating between the true descendants of Abraham, Isaac, and Jacob from a group that pretended to have converted to Judaism. The Biblical blood line of Abraham, Isaac, and Jacob has been the focus of Satan for thousands of years, at which Satan was determined to destroy. Only God knows how many of the Sephardic lineage remnant exists today.

The world population of Jews in the world is estimated to be 14.8-million. The Sephardic Jews are estimated to number 3.5-million world-wide, and 1.4-million in Israel.

It is the Khazarian element of which Jesus Christ was bringing our focus to in Revelation 2:9 and 3:9.

America has been infiltrated and hijacked by the Rothschild's Khazarian Mafia, which is dead set on destroying the Christian and Deist Heritage of our Founding Fathers, along with our economy, borders, language, culture sex roles and marriage. Preston James and Mike Harris of *Veterans Today.com* provided needed information on the Khazars. I have read Aleksandr Solzhenitsyn's book '*200 Years Together Russo-Jewish History*' but it has more questions than answers.

But we need to back up some. Khazarians were known by those living in bordering countries to generally be liars, deceivers, cons, robbers, road warriors, rapists, pedophiles, murderers, identity thieves and social parasites of the worst variety. And to make matters worse, their ruler King Bulan did nothing to reverse this because he too was like them.

When Khazaria was finally destroyed in about 1250 A.D. by Russia and Persia, it had been literally terrorizing, robbing, murdering and parasitizing neighbors and travelers for over 500 years. There was no rule of law in Khazaria, only the rule of manipulation, sociopathy, might, violence and evil.

Khazarians had repeatedly preyed on travelers at their borders or anyone who tried to travel through Khazaria. Traveling in or near or through Khazaria was usually a fatal mistake. Women were often raped and then murdered afterward or, if young enough, taken as sex slaves. Khazaria was known by other surrounding nations as a lawless, evil nation that allowed the worst crimes against neighbors and travelers imaginable. Khazaria was known as the epitome of selfishness and evil, from the King all the way down to the average citizen.

The Khazarians' origin is believed to have been a hybridization between Turks and Mongols, with absolutely no genetic ties to the ancient Hebrews.

About 80% of the Palestinians carry ancient Hebrew Blood and thus are true Semites, and hold an un-abandoned, absolute ancestral right to all of Palestine, despite any Khazarian claims, which are all based on lies and political intrigue. When the U.N. decided to honor the Balfour Declaration in 1948, it was to the House of Rothschild. For years the Rothschild's had been buying up the land of Palestine on the cheap from local Arabs. As I have related in other articles, the Jesuit/Masonic messiah would be also, another crypto-Jew, Prince Charles


of Wales. I devoted Part 6 of my series **“The Satanic Talmud and the Synagogue of Satan”** to identifying and proving Prince Charles is the Antichrist.

It is now known for certain from peer-reviewed genetic studies done at Johns Hopkins that Khazarians carry absolutely no ancient Hebrew blood and are not Semites at all, and never were. This is where our dilemma begins to come into sharper focus.

The Khazars infiltrated the world of Europe, the Middle East, and even the U.S. They are crypto-Jews that hide among the following elements in the Illuminati pyramid on the next page:

Thus it is fair to claim that the Israelis are not only NOT Semites at all, but are the biggest anti-Semites in the whole world for their massive land theft of Palestinian land and genocide against Palestinians. And despite this stark reality, top Khazarians immediately accuse anyone that criticizes them or Israel of being anti-Semites – an obvious fallacy.

It is now becoming obvious to many that Israel is a deeply racist Khazarian state that is continuing the same anti-social criminal patterns that led to its destruction around 1250 A.D. They repeatedly preyed on travelers at their borders or anyone who tried to travel through Khazaria, usually a fatal mistake.

When the problem reached epic proportions and could no longer be accepted by the surrounding nations and peoples, the Russian and Persian leaders formed a coalition and delivered a stern ultimatum to the Khazarian King Bulan.

This ultimatum was that Khazaria as a nation had to immediately change its ways and to do this, King Bulan must select one of the three Abrahamic religions and institute it as the official required Khazarian state religion. King Bulan was told in no uncertain terms that the religion chosen must be indoctrinated in all Khazarians to serve as rules of conduct and as a basis for integrity and ethics that were previously completely absent.

King Bulan agreed and selected Torah Judaism as Khazaria's official religion. This worked somewhat for a while, but soon Khazarians were drifting back to their old ways of national banditry, murder and gross parasitism of others from surrounding nations.

Instead of working to establish morals and ethics in his nation by making a serious attempt to practice Torah Judaism, King Bulan and his top staff actually were inducted into the Black Arts and Black Magic of Babylonian Talmudism, better known as Baal worship or Satanism. Externally this looks a lot like Torah Judaism and can be used as false cover, which it was.

The reason this choice by King Bulan failed to become a permanent solution to the Khazarian mass sociopathy was that he himself never really accepted or practiced only Orthodox Torah Judaism and merely displayed a phony outward appearance of such.

Instead, he learned the black arts of Babylonian Talmudism and practiced the secret occult rites of Satanic demonology to gain more power, wealth and status.

King Bulan's secret worship of Babylonian Talmudism (Baal worship, Satanism) was well-disguised by his phony outward presentation of Orthodox Torah Judaism as a cover. His heart was not in setting an example and leading his people away from the cultural sociopathy, inhumanity and criminality Khazaria had become known for.

At first when the ultimatum was delivered jointly by Russia and Persia, the Khazarians backed off somewhat from their ways for a while, fearing destruction. But their culture remained the same; and their old ways of abusing, robbing and murdering neighbors started back up again – this time even worse than before.

Finally, in about 1250 A.D., the situation became completely unacceptable to both Russia and Persia and they jointly decided to invade Khazaria and destroy it top to bottom.

The current King and his court were warned by his spies, and the top Khazarian nobility was able to flee with their great wealth of silver and gold before the invasion and destruction of Khazaria.

It is hard to know all the details about where this Khazarian Royalty went, but it appears that they continued practicing the Black Magick occult arts of Babylonian Talmudism and migrated to Italy and other western European nations.

Khazarian history has been carefully excised from most libraries in the Western world and one must dig to find it. Fortunately, Solzhenitsyn documented a fair amount of Khazarian history before he died.

The Truth about King Bulan and Khazaria's destruction by Russia and Persia for its unrepentant evil is a closely guarded Khazarian secret even today, and Khazarian leaders greatly fear the disclosure of this to the masses.

These Khazarian royals who specialized in Babylonian Talmudic Satanism participated in child sacrifice because they believed it would provide them with more and more satanic powers.

These top Khazarians became known as the world's greatest impostors, usually hiding in other groups by claiming to be part of that group's genetic and cultural heritage.

Eventually, these Khazarian Royals became adept at Babylonian Talmudic "money-magick" that is, making money from nothing by the use of pernicious usury. They often assumed the identity of Judaics and claimed to have ancient Hebrew blood, when they had none and only carried Khazarian blood.

Soon they became the Vatican's Bankers and were known as "Hof Juden" or "Court Jews" by the various Kings, Queens, and royalty of the European nations.

They were easily accepted by the Old Black European Nobility families that hijacked the Vatican who also practiced Babylonian Talmudism and gained power from the satanic, dark-side using secret child sacrifice.

Khazarians became accepted as Cutouts and tools of the Old Black European Nobility who were also Satanists practicing Black Magick occult rituals. But it is clear that these Khazarians were easily accepted by the Old Black Nobility because they worshiped Satan just like they, and shared in the secret Black Arts and Occult rituals such as child sacrifice. Soon the Khazarians bred their way into the British Royal families and other European Royal Families.

These top Khazarian leaders became known for their expertise in political intrigue, human compromise, and blackmail, as well as the administration of hypnotic drugs and special poisons to create deaths that appeared to be due to medical conditions.

They gained control over the City of London when Napoleon was defeated and proceeded to eventually gain control over all the western world's monetary creation and distribution systems, which were all set up as private fiat systems with pernicious usury.

These top Khazarian "Black Magick" occult masters hijacked the American monetary creation and distribution system by setting up their own private so-called banking system – the Federal Reserve System in 1913. This was done by using sophisticated bribery, blackmail, and human compromise schemes to gain enough votes in Congress and the President's support to pass this clearly illegal, unconstitutional aberration, the greatest financial crime in history.

Once the Khazarian Kingpins established a beachhead in America, they were able to buy up, bribe or human compromise almost all elected and appointed USG officials. Those that didn't comply were sidelined or driven out by supporting competitors chosen by the Khazarian Kingpins.

Soon all the American political, governmental, corporate, law enforcement, Military and Intel systems were hijacked using the same methods. This has allowed the Khazarian Kingpins to parasitize America, which in practice means making serfs and wage slaves out of most Americans with little recourse.

America was then transformed into the Khazarian Kingpins' tool to parasitize the rest of the whole world, as so well-described by John Perkins in his classic book, *'Confessions of an Economic Hitman'*. Perkins tells how he would go into an undeveloped country and promote such things as a national infrastructure development program, through a loan program which required the country to use its natural resources as collateral to fund the development projects. The actual projects would be built using companies of the financial lenders.

The Khazarian Kingpins' motto: buy everyone if possible, otherwise sidetrack them or kill them.

Money creation and distribution systems were hijacked by the Khazarian Kingpins (called "the Moneychangers" by insiders) in every western nation of the world.

The Islamic nations refused to set up banking systems with pernicious usury; and that is why Islamic nations have been targeted for destruction by the Khazarian leaders ever since.

The U.S. government is has been used to provoke any nation like Russia and China and some Mideast nations that refuse to let the Khazarians run their banking systems. The U.S. has functioned as the mercenary military for the Rothschild's.

Khazarian Kingpins are called the leaders of the Rothschild Khazarian Mafia because that is what it is, a Khazarian Mafia run by the Rothschild family Banksters who have been alleged to be high satanic masters.

History documents what the Khazarians were as a people back in the period of 750 A.D. to 1250 A.D. before Russia and Persia destroyed Khazaria for their unrepentant and unimaginably evil ways.

Their rulers and their people, in general, were bad to the bone suggesting that criminal psychopathology was institutional and culturally based. Others have claimed it is genetic too, but this remains to be studied scientifically.

When King Bulan claimed to have selected Judaism for his own and as Khazaria's official state religion, he lied and promoted only an outward phony appearance of such while encouraging satanic Black magick practices and unimaginably evil occult rituals such as pedophilia and child sacrifice and blood-drinking.

The question needs to be asked and answered – after well over 1,400 years, have the Khazarian bloodlines and their leaders changed their ways at all?

Are they still a bandit race of hijackers, impersonators, deceivers, cheaters, thugs, and murderers?

Obviously, their top leaders have not changed at all and are in fact worse, because now they have destroyed whole nations and peoples at will, using the American military as canon fodder to commit genocide by war. Or have only their top Kingpins and their chosen Khazarians undeservedly placed in top positions of power remained so unimaginably evil and inhuman?

Since Khazaria was destroyed in about 1250 AD, over 150 nations have booted out the Khazarians for their evil ways. Now because of the Internet, there is a growing awareness that top Khazarians are anti-human thieves, mass-murderers, deceivers and parasites upon the whole world.

The Boycott, Divest, Sanction movement (BDS) by major Protestant mainline denominations is evidence of this growing awareness. It looks like soon the whole world will repeat the actions of Russia and Persia in dealing with the Khazarians, or die trying.

Yes, the whole world is getting informed fast about this Khazarian problem, the world's biggest problem, and has just about had enough of the Khazarians' abuse and inhumanity. It's almost a certainty that the Khazarian City of London private Rothschild FIAT World Banking System is going to soon be eliminated in the coming near future.

These Bolsheviks did the same thing to Germans when they entered East Germany at the end of WWII. It's a fact that Bolshevism was Khazarianism in disguise.

America has been infiltrated and hijacked by the Rothschild Khazarian Mafia, which is dead set on destroying the Christian and Deist Heritage of our Founding Fathers, along with our economy, borders, language, culture sex roles and marriage. They shouldn't have. Christians have been deceived by the State of Israel, and it has sucked this country dry since 1948. The recent massacre in Gaza is further proof of the Zionist agenda to make us think Israel is the victim. Pray for the peace of Jerusalem!

Christians should have read their Bibles and believed what God says. The Apostle Paul warned us there to beware of *"the foolishness of genealogies."* He told us not to heed "Jewish fables." He even made it clear that the Old Covenant had been replaced by the New Covenant, which was Jesus Himself. He stated that, *"Here we have no continuing City,"* that it was the heavenly Jerusalem to which the prophets and saints were looking toward. Yes, that was the Promise God made to Abraham and to us, His Children, the Saints.

Do you believe what Jesus Christ said? Do you believe the Word of God? Do you have the Promise given only to those of Faith? Are ye of Christ? Then, says the Scripture, regardless of your race, are ye ***“Abraham’s Seed and heirs according to the Promise”*** -(Galatians 4:28-29).

Considered by geneticists worldwide as the “definitive study” and peer-approved, this authoritative research confirmed Dr. Oppenheim’s earlier findings and went even further.

*“There are no blood or family connections among the Jews,”* reported Dr. Elhaik. *“The various groups of Jews in the world today do not share a common genetic origin. Their genome is largely Khazar.”*

*“Whatever Israelite blood the Khazar Jews have,”* added Dr. Elhaik, *“is miniscule.”*

Like Dr. Oppenheim, Elhaik's research connected today's Jews to the Turkic clans of Khazaria, in the Russian Caucasus.

The facts are: Israel and America are populated by people saying they are Jews who are not Jews! They are Khazarian. When Israeli Prime Minister Benjamin Netanyahu claims, "*God gave this land to our Israelite forefathers,*" he is not telling the truth. When today's Khazar Jews say they possess the land of Israel as a divine right, they are sadly mistaken.

Indeed, Elhaik and Oppenheim found that the Palestinian people may have more Israelite blood coursing through their veins than do the people who say they are Jews! A DNA test would no doubt confirm this eye-popping fact.

The Christian evangelicals have been duped. If only they had read and believed Jesus Christ - He told them what to look for in Revelation 2:9 and 3:9. He said that those who claim to be Jews are not Jews but are "**blasphemers**" and the "**Synagogue of Satan.**"


