It's happening in Ireland too! **How can heart disease explode in kids only after they roll out the vaccines for kids?** Experts are baffled as to what might be causing a sudden increase in heart disease for kids that is happening only in places that have rolled out the COVID vaccines for kids. **It's not happening to kids anymore in Uruguay for some reason (perhaps the [judge stopping the vaccine program](#) might have something to do with it).** [Unknown causes is now the leading cause of death in Alberta, Canada.](#) It wasn't that way before the vaccines rolled out. The experts dismiss that as "oh, that's because people who have had COVID are more susceptible of dying." But why would they be more susceptible of dying of **UNKNOWN** causes? And **why is it only the vaccinated that are dying of the unknown causes?** And if this is due to the COVID infection, how come it isn't happening in any country with a low COVID vaccination rate? And how do the experts explain the strange blood clots only found in vaccinated people? The press still forgets to ask these critical questions. But at least mainstream media is covering the mystery cause of deaths. It's a start. But they are allowing "hand-waving" explanations when the "experts" are just making this stuff up with no data to back it up. Any "expert" who actually talks to patients knows the side effects of the vaccine are far greater than those from COVID. So how is our "expert" not even considering the vaccine as a possibility?

[Embalmers are seeing blood clots in over 50% of patients that they've never seen in their careers.](#) It isn't caused by COVID because it only started after the vaccine rollout and the clots are only found in vaccinated patients. So how do the experts explain that?

There is a [163% rise in life insurance claims at Lincoln National.](#) They are the fifth largest insurance company in the U.S. The increase is huge. **That's not a 63% increase. It's 163% increase, almost a tripling of the death rate.** That isn't COVID. COVID doesn't kill anywhere close to that number of people. We are looking at the biggest killer in history and nobody can figure out what it is! [Watch this video.](#) You will never see a story on this on mainstream media; they ignore it. Note, part of the claims increase is due to premium increases (adding new clients).

Life insurance companies in countries all over the world are reporting record numbers of excess deaths. These are not "statistical fluctuations." The deaths are all caused by a huge intervention that is affecting the health of millions of people. And it's all new. Nothing like this ever happened before 2021. **Nothing of this magnitude has EVER happened in their history (which goes back over 100 years).**

Even John Campbell, who is pro-vaccine, admits that a troubling number of unexplained excess deaths are not just happening in the UK: **they are happening worldwide**. Just [listen to the first 30 seconds of this video](#). Of course, the CDC isn't investigating anything even though American life insurance companies are reporting deaths that are off-the-charts. The CDC is NEVER going to investigate this. It's bigger than COVID and they know full well what it is. That's why they are NOT going to investigate and 'The NY Times' is NEVER going to fault them for this. After all, it's only the biggest medical cause of death in our history.

The overall shift in the **cause of death from respiratory to cardiac** is impossible to ignore and can't be explained if the vaccines are "*safe and effective*." A friend of mine who lives in Massachusetts noticed this after he made a FOIA request for the death records in Massachusetts. He looked at the ICD-10 coded causes of deaths and noticed that [the causes of deaths shifted from primarily "J codes" \(respiratory due to COVID\) to "I codes" \(circulatory due to the vaccine\)](#). Now we learn that the exact same thing happened in the UK in 2021 according to [official UK government numbers](#). This is a huge effect and there must be a cause, but the health authorities are simply baffled and cannot explain it (because they are not permitted to blame the vaccine since that would make everyone look bad). It's safe to say that such a shift has never happened before in history. Clearly, something new happened starting in 2021 that affected massive numbers of people worldwide. I wonder what that might have been? Health authorities simply cannot come up with a single thing that was new in 2021.

The vaccine injuries of toddlers who are now having seizures cannot be explained. This is now a regular occurrence for 2 and 3-year-old kids to have seizures. It's only happening in vaccinated kids and most often between 2 and 5 days of vaccination from the COVID vaccine. Doctors are not allowed to report these events publicly (they are not allowed to share on social media or talk to the press) so each doctor thinks it is simply a "*one-off*" event that is ONLY happening to them. If doctors would be allowed to speak publicly, they would realize the massive pattern. This is why hospitals muzzle the doctors: so nobody finds out. We have multiple reports of these from nurses directly from nurses who are scared that their social media accounts are being monitored. The parents are told that it is just "*bad luck*" and the parents believe what they are told. So the parents don't speak out about it either.

Countries are starting to realize birth rates are dropping and there are more stillbirths. Sweden, the UK, Germany, etc. See [my article about birth rates](#).

The deaths and injuries are happening in plain view of everyone with no plausible explanation for all the coincidences. All of the events are only happening to vaccinated people, but because the press never mentions the vaccination status of the people who "die unexpectedly," the public never realizes the pattern:

Think about all the rock concerts that have been terminated or canceled due to medical reasons. Justin Bieber, Santana, ... Brett Michaels. They never give the cause as the vaccine so they have to make something up ([Santana](#)) or simply refuse to disclose it

([Michaels](#)). Someone sent me a list of four other concerts that were canceled within the past few months. This isn't normal folks. But most people never attend rock concerts in different parts of the country so they never figure it out. Also, Santana cancelled six upcoming concerts to recover from dehydration. All the doctors I talked to said that makes no sense. Worst case he'd get IV fluids and be back to normal in less than a day. So the explanation doesn't fit. But other celebrities are speaking out on their vaccine injuries such as [Eric Clapton](#), but they aren't well publicized (Clapton's video has just 66,000 views as of July 11, 2022).

Think about all the celebrity deaths in 2021 and 2022. These are never covered up; they can't be. What they never mention is the sheer number of unexpected deaths and they never mention the vaccination status of the deceased.

Young people virtually never die in their sleep. When you see this happening over and over, it's no accident. When you see it happening to celebrities, it's even more noticeable and impossible to cover up such as the death of Dani Hampson who died in her sleep on her wedding day. Not only was it a celebrity death but a "*young person died in her sleep*" death as well, a black swan. Many Americans realize what is going on. You can see this by looking at the Twitter comments.

Athletes are [dying in plain sight at 22X the normal rate](#). Today, [former NHL defenseman Bryan Marchment](#) died "*unexpectedly*." But few people are tracking this so they have no idea the rates are so much higher. It just seems a bit odd.

Even young [UPS drivers, like 24-year-old Estegan Chavez, Jr. are dying while delivering packages](#) which are not nearly as physically demanding. These are just the deaths you hear about though.

Pilots are having events at unprecedented rates, but the airlines are refusing to screen the pilots for cardiac issues. When American Airlines Captain [Bob Snow had a cardiac event right after he landed](#), he didn't even get a call from the CEO of American Airlines. The FAA won't require pilot screening. They know exactly what they would find. So they look the other way and say nothing and pretend these events never happened. The pilots know. Any member of the public with a working brain can figure this out. But we assume that the FAA is honest and will do the right thing. Big mistake. The [FAA was officially put on notice](#) and they have done absolutely nothing about it. They just ignored it like it never happened. Congress is doing the same: they aren't holding the FAA accountable since they know it would make them look bad. Everyone is banking on nobody ever finding out. After all, they covered up the fact that the U.S. government created the virus in the first place so the reasoning is that they can cover up all the cardiac events and pilot deaths.

Surveys ([such as this one](#)) consistently show that fewer than 50% of Americans are willing to get more shots of the vaccine. Most of America is clued in, even though none of the media people are. As a result, [the government is throwing away tens of millions of vaccine doses](#) due to insufficient demand (which is why Peter Marks of the FDA said

he'd do anything except debate the opposition to reduce vaccine hesitancy. So basically we are literally **throwing away billions of dollars of taxpayer money** to produce a product nobody wants. Is anyone in Congress complaining about the government waste: No. Not a single person. Is anyone in the mainstream media pointing out this is stupid to order a product nobody wants? Nope. Nobody in mainstream media is going to publish an op-ed like that. They all just go along as if nothing is wrong.

People's young healthy friends are having medical problems at unprecedented rates (though not everyone is realizing this). For example, today I learned that one of our country club employees (forced to vaccinate) that I knew died from a stroke at age 52. A [young candidate for US Senate, John Fetterman](#), had a stroke following his vaccination. He may never recover.

Whenever we do audience surveys, every audience always reports a comparable or excess rate of death from the vaccine vs. COVID. So even if you don't see it yourself, the live audience surveys are very convincing since there is no "bias" in these live surveys. Nobody but "misinformation spreaders" like myself are willing to do the surveys for some reason.

[User surveys done by professional third party polling firms consistently show the vaccines have killed more people than COVID has.](#) The *NY Times*, *60 Minutes*, etc. all refuse to do the surveys themselves. They don't want anyone to know. Our next step is to use a big name polling organization to promote this result so it is not coming from "anti-vaxxers." That poll should be impossible for anyone to ignore. We have never run a single poll that shows everything is fine and the vaccines are perfectly safe. That is why the mainstream media will never do these polls. But most people don't realize that they are deliberately not doing these polls. However, it may be hard for us to get this done. There have been far less devastating polls that have been done by the big polling firms and they refuse to allow the results to be used when they found out the result were against the narrative. The reason is simple: it would be bad for business to release such a poll because everyone would stop using them because they are "evil." This is why the public never sees any polls on vaccine safety: the media won't commission them and the pollsters won't do them. We welcome being proved wrong on this!

Mandates are vanishing even though COVID rates are increasing. For example, see this story about what is happening in parts of Australia where they are backing off their former recommendations with no apologies whatsoever:

The evidence shows that COVID was created in a U.S. government funded biolab. That's the direct assessment of the chairman of the independent commission tasked with looking into the cause. Professor Jeffrey Sachs was responsible for the independent Lancet investigation. He said, "I chaired the commission for the Lancet for 2 years on Covid. I'm pretty convinced it came out of a U.S. lab of biotechnology." You

will never find that statement anywhere on U.S. mainstream media. How could that not be covered? But [in this video](#), he also said that **there is absolutely no interest in learning more**, not from any country in the entire world. That tells you everything you need to know. How can there be no interest in learning more? **The only way there can be no interest in learning more is if the U.S. government did it.** Check out this article in 'Science' which tries to make Sachs look like the villain: "[Fights over confidentiality pledge and conflicts of interest tore apart COVID-19 origin probe: Former members of The Lancet task force challenge why economist Jeffrey Sachs disbanded effort.](#)" Sachs figures out Daszak is conflicted and Daszak won't produce documents showing a conflict. So the panel sides with Daszak!!! It is completely stunning that nearly the whole panel is conflicted and corrupt. Sachs emerges as the hero here. He [calls for further investigation by an unbiased commission](#) due to the smoking gun evidence of a contract that was "*supposedly*" never funded. Nobody takes him up on it because he's right; what they want is a corrupt investigation only. The contract fits the origin of COVID like a glove and [Daszak's defense is that the work "was not funded. Therefore, the work was not done. Simple."](#) But it's not as simple as that (as [the article points out](#)). It seems very clear that Daszak is lying. I double-checked with a former EcoHealth Alliance employee who was in a position to know. He was unequivocal. You have to have data to get funding on these proposals. **The bottom line is Peter Daszak shouldn't be trusted since he's in on it.** There's more, but we'll leave it at that for now.

[Vaccine injuries are now being compensated in other countries with large payouts](#), but not in America. We haven't paid out a dime to anyone, despite thousands of applicants (most others know it is fruitless to apply and don't bother). So how can the vaccines injure people outside of America, but not injure anyone who was given a shot inside America? That's simply impossible if there isn't a government cover-up. There is no third party oversight of the vaccine compensation program in America and nobody in Congress (except for Senator Ron Johnson) thinks that zero payouts to the millions of Americans who were killed, disabled, or injured is a problem.

[Our surveys](#) consistently show well over 1-Million Americans have been injured or disabled so severely by the vaccines that they are unable to work, but Congress thinks \$0 compensation is appropriate. The most extensive investigations ever done on a death, 14 months of intensive investigation, have proven that the vaccines kill people. 27-year-old Jack Last of Stowmarket was vaccinated on March 30, 2021 and died days later. [It took 14 months of investigation to determine he was killed by the vaccine.](#)

[Ed Dowd was interviewed by the Defender](#) and the [CHD Roundtable](#) and made the following points:

1. The group life insurance claims come from a younger, employed demographic dying neither from COVID nor suicide.

2. This group of largely millennials fed “a silent Vietnam War” body-count-wise (61,000 in 2021, how many insurance companies counted not stated).

3. The connection to the shots is demonstrated by the “*hockey stick*” plots of deaths versus time clearly marked by mandates and boosters: the smoking gun.

4. CEOs who mandated the shots are reluctant to publicize their responsibility for killing their employees.

5. The financial catastrophe will push these data into mainstream news sooner or later.

6. Ed was working directly with actuaries and insurance executives specifically counting group life claims, not just deaths among the general population. The exponential rates of change marked by dates of vaccine roll out, mandate implementations and boosters nails the vaccine inference for these fatalities reported this way. The argument is hard to contest. “*Smoking gun*,” as he says. This is insurance industry hard data: money paid out. This is why this is so impressive and to-the-point.

7. There is no response from any fact checkers on this.

Former highly respected blue-pilled doctors like Dr. Naureen Shaikh in Sausalito have seen enough and are now willing to come out of the closet and speak about vaccine injuries even though it means the end of her career in medicine.

Articles written by respected scientists like Peter Doshi are slammed by people who refuse to be held publicly accountable for their remarks. Read this article by Professor Norman Fenton which summarizes the bogus arguments made to smear these scientists who are speaking the truth, “[Response to Susan Oliver video “Antivaxxers fooled by p-hacking and apples to oranges comparison.”](#) Almost definitely, the “Doshi paper” [will not be published for reasons explained in this article by Phil Harper](#). Susan Oliver, who is remarkably inept, will not have a discussion with Fenton and it’s pretty obvious who is spreading the misinformation for anyone spending any time on this.

Instead of challenging Fenton, [Susan produces a second video](#). Susan [summarized her view of the paper in this tweet](#) (which included the link to the video) that was retweeted by people like Prof Sir David Spiegelhalter (a world renowned expert on probability and risk) and Prof Peter Hansen (Econometrician, Data Scientist, and Latene Distinguished Professor of Economics at UNC, Chapel Hill). Hansen and Spiegelhalter refuse to speak with Fenton as well. Fenton would LOVE to chat with any of these people in a recorded conversation so he can ask them key questions, but all of them are afraid to be challenged: **they just throw stones and then go into hiding**. That is how “science” works nowadays.

Even though key studies that destroy the government narrative will not be published (as noted in the previous point), scientists still managed to publish over [1,250 papers in medical journals on serious adverse events caused by the COVID vaccines](#).

[Two teenage boys die in their sleep](#) in different states days after vaccination and the paper concludes that the deaths were caused by the vaccine. It's [published in a peer-reviewed medical journal](#). There is no coverage of this in the U.S. mainstream media.

The best we could find is [this report on NTD News](#). Read the comments on that tweet including, *"My friend's mom woke up terrified, unable to breathe. Her husband was by her side and called 911 but she was gone via cardiac arrest. **She took a booster the morning before this transpired.** It hits especially hard to think a child, alone, went through this. Rips my heart out."* The U.S. mainstream media will continue to ignore all these deaths so that when it happens to them people will just think it is just their "bad luck," but these stories are leaking on alternate media.

The world's most respected vaccine expert, Dr. Paul Offit, **publicly admitted on a [YouTube video](#) that the whole FDA outside review process is a complete sham.** The FDA doesn't review the data, they hand the committee hundreds of pages right before the meeting (knowing that way they committee cannot review it), and then badger them to approve the vaccines without any efficacy data. Offit admitted that if there was a "hell no" option for his vote, that's what he would have done. He basically said the others on the committee are brain-dead because there was no efficacy data to justify approval: they basically vote "yes" because that's what they are expected to do and they want to stay on the committee. The government orders the drug even before they ask the FDA panel to review the data, proving the whole "review process" is a complete sham. Offit himself still hasn't figured out the vaccines aren't safe. He won't have that discussion with anyone on our side. However, Paul Offit is completely oblivious to the fact that if there are no deaths, you can't save any lives. For example, we know from the Massachusetts death data that there were zero deaths in 2020 and 2021 for ages 5 to 11 (there was just one death coded as a COVID death but we contacted the family and found out it wasn't true). So how is there a "problem"? Nobody wants to talk about that. They don't even know there were no deaths in a large state like Massachusetts.

Parents are getting wise to the scheme. Just 1.3% of eligible children under 5 have received one or two doses of a vaccine, [according to data from the CDC](#) (see this [Epoch Times article for details](#) on the failure of the CDC to dupe parents to inject their kids).

Pierre Kory told me a mainstream doc he knows admitted to him confidentially that attitudes are changing now. Doctors now realize they've been lied to, but nobody has the courage to speak out about it since they'd lose their license. So they keep quiet. But most of them know the vaccines are killing and injuring people of all ages.

One of my nurse friends said that when a child had a cardiac incident recently, the entire trauma department thought "vaccine injury" as soon as they heard there was a teenager with a cardiac issue. However, none of the members of the trauma department will ever acknowledge any of this publicly because they know they will be fired for admitting the truth.

Doctors are now willing to meet with members of Congress and brief them on what is going on. For example, I now have 25 doctors in California willing to risk their careers to speak out to members of Congress in California. These doctors work at hospitals all over California. It's not local.

Public health officials are now willing to be interviewed by me. I have one coming up on Monday July 11. Can you believe that? A public health official that will answer questions from me! I can't wait.

The journal 'Science' tacitly admitted that they aren't doing science anymore. We [requested that they ask for a correction or retraction of an obviously flawed paper](#). The request was made by a highly respected UK Professor, Norman Fenton. They ignored him! In short, junk science is fine for their journal. I really think they should rename their journal to "Junk Science" as that would be more accurate. But it's clear that they don't care about accuracy. You can be sure they will stay quiet about this junk paper. That's the way "science" works nowadays.

I spoke with the CEO of a hospital near me. As soon as I sent him information about the vaccine being dangerous and suggested he could be a world leader by being the first hospital CEO to admit the truth, he stopped talking to me. However, in the U.S., it's perfectly fine to mandate vaccination of Americans with substances that people are not permitted to know about. The people doing the mandating don't even know themselves what is inside the vaccine. They are completely clueless as well. That's just how it works. After all, it's important that the public (and the authorities doing the mandating) NOT know the true composition because if they knew, nobody would take it. That's why it has to be kept secret. Get it? It's for your own good. We basically have to trust the drug companies, even though they have a history of fraud and defective products. After all, if you can't trust Pfizer, who can you trust? Doesn't this make you want to trust them?

We are learning of huge conflicts of interest with up to \$400M in payouts given to unknown people inside the U.S. government. 2021 was 51% higher than the 7 year average.

Weaker hearts can't handle stressful swimming. Wonder why?

Post-market all-cause mortality data is the gold standard for a vaccine. We have that in the UK which tracked it. It went up by [up to 6X according to UK ONS data](#). But our own CDC cannot find any signal here, even though the VAERS death numbers and Medicare death numbers are off the charts. When the CDC looked at the VAERS death data (the [Hannah Rosenblum VAERS paper published in the Lancet](#)) they said none of the excess deaths were caused by the vaccines but they never said what caused the deaths. Why didn't anyone in the medical community or the press want to know the actual cause of the unprecedented number of excess deaths? The deaths were 50 times normal and no other vaccine has a jump in death rates, just this one. Why wouldn't the CDC want to know why? And why does Martha Sharan prohibit me from

talking to the authors? The CDC is supposed to help stop misinformation. I reached out to find the “*correct*” reason for the deaths and their response was to not talk to me. That doesn’t help correct the “*misinformation.*” I just want to know what caused all the excess deaths that only happened for the COVID vaccines. Is that too much to ask? Nobody else is asking the question, but it’s an important question to ask.

The CDC isn’t releasing any data from their BEST database. Yeah, that’s what it’s really called. You can’t make that up. But because the data isn’t supportive, they never show us. It’s kept under lock and key. Nobody gets to look at it. You’d think if the vaccine worked as advertised, they’d be showing us the data. The fact that they don’t show us the BEST data... that has to be very troubling for anyone with a working brain.

They aren’t showing the public the Medicare all-cause mortality data. Did you know it is at an all-time high since right after they rolled out the vaccines? Of course you don’t know that because the CDC will not release that data and the press isn’t asking them about it. The only reason I know about it is because I was tipped off by an honest HHS employee (yeah, we actually found one insider who is livid about the cover-up).

The [UK ONS data shows that all-cause mortality increases tremendously after each vaccination](#). If it isn’t the vaccine causing this, then what is causing it? It is a HUGE effect: up to a **6X** increase in all-cause mortality after you get each shot compared to unvaccinated in similar age groups. Nobody will explain this on camera. They are all camera shy. Nobody dares to challenge Professor Norman Fenton on this. The CDC thinks the opposite is happening, that [the vaccine makes you nearly immortal, lowering your risk of death to absurdly low levels](#). Someone is lying to you. I can safely guarantee to you that the CDC is lying because the all-cause mortality rates are so low in the CDC’s VSD study that the vaccine even prevents you from dying in accidents!

There is a very real potential that the vaccine can integrate into a person’s DNA permanently. See [Sweden Study Shows COVID Jab Can Modify DNA, Opens Doors for New Lawsuits](#). The vaccine might be permanently modifying your DNA and not for the better. They said this couldn’t happen, but now it is a real possibility and we’ll soon have confirmation if this is happening in people. In the meantime, “*are you feeling lucky?*” That is the question that the CDC should be asking people before they get the shot. Everyone should be warned about this before they get the shot. That will be true informed consent. Instead, people are kept in the dark. Nobody getting the shot has a clue. Is that really the way we do medicine in America to keep people in the dark like this?

How will they [explain away all the sudden cardiac disease now happening in kids](#) that only happens to vaccinated kids and only started happening after the vaccines rolled out?

I had doctors look at over 600 vaccine death reports. They found that 3 died from [Creutzfeldt-Jakob Disease](#) (CJD) which is extremely rare: it occurs naturally in 1 in 1 million people. Nobody can explain the .5% rate observed here. That’s 5,000 times

normal. It didn't happen by chance and the only thing these people had in common is it started right after the COVID vaccine. How can a safe vaccine cause CJD? Answer: a safe vaccine can't. Unfortunately, the medical community is still united that censorship of articles in mainstream medical journals is OK when it conflicts with the political narrative. So it's still fine with everyone that papers such as the [Rose paper on myocarditis rates after the COVID vaccines](#) which was withdrawn by the publisher because they didn't like the conclusion. There is still nobody speaking out against Elsevier for unethically censoring science. **Not one person from the pro-vax side thinks censoring science is wrong.** It's stunning because it is so objectively unethical. Nobody can defend this but everyone is silent.

There was fraud in the Pfizer trial. I've documented [over a dozen issues that would be "hard to explain" if there wasn't fraud](#) including some that are impossible to explain if there wasn't fraud. Nobody wants to explain them. But now we have something even better than my accusations of fraud: an admission from Pfizer in Federal Court that they defrauded the FDA. Haiti did not vaccinate its citizens. The current vax rate is 1.4% -- yet country has one of lowest COVID death rates in the world. How is that possible?

There don't appear to be any scientists who work in vaccine safety at the CDC anymore. I emailed a large list of internal CDC emails (all people working on the COVID vaccines) asking if anyone would consider evidence that goes against the narrative. No replies. A true scientist is always open to new data and to finding the truth. The CDC "scientists" are simply "*propagandists*." If you find someone who is willing to consider evidence that runs contrary to the narrative, let me know.

They've admitted that [nobody will defend the policies of the CDC or FDA on camera](#). We put out an open call for someone to do this and got no responses. They promote the narrative only when they are assured they will not be challenged with inconvenient things such as evidence and facts.

The FDA's head of vaccines, [Peter Marks, has said he'll do anything to help reduce vaccine hesitancy EXCEPT debate any qualified scientist with opposing views](#). Yet debating the opposition is the most effective way for Dr. Marks to achieve his goal. So why isn't he doing it? Simple. He doesn't have the facts on his side.

A paper published in a peer-reviewed journal says the "[misinformation spreaders](#)" (including myself) are telling the truth. Finally.

We are seeing medical doctors like [Andy Bostom writing a scathing op-ed about Brown University](#) where he works on the cover-up of a student who died from myocarditis after forced vaccination. So doctors armed with the facts are now willing to sacrifice their careers to tell the truth.

People are starting to wake up to the poor risk benefit of the vaccines. Our [latest surveys](#) give the same estimated number of deaths from the vaccine as the [VAERS data \(and 10 other sources\)](#): 500,000 at this point. But the estimated number of COVID lives saved based on the clinical trial is 1 in 22,000 which means around 10,000 lives saved. So we've killed 500,000 people to maybe save 10,000 people. That's dumb. Nobody will debate me on the numbers. I even offered \$1-Million to anyone who could disprove our estimates and show us the right numbers. No takers.

Elderly care homes like [Palo Alto Commons](#) can't hide in the shadows forever. The [CDC had to change the definition of "vaccine"](#) because the COVID vaccines weren't vaccines.

The numbers just aren't working out for the promoters of the vaccine. In NSW Australia, the vaccination rate is [96.7%](#). That means that if the vaccines are reducing hospitalization risk by 90%, then 25% of the people in the hospital should be unvaccinated. That's what the math says. With all that Steve Kirsch has pointed out in this conspiracy of silence, perhaps it is time to hear what the real secret is that the world is not hearing about.

If I look at New York City, it has **609 cell towers** and **7,625 antennas**.

In general theory, the greatest outbreak of EMF/EMR radiation sickness will occur in areas where you will find a greater saturation of the geography where you find larger numbers of cell towers and antennas. However, simplistic as this may seem, what matters most is your physical distance from a cell tower/antenna and the energy level being generated and the amount of time one is being bathed invisibly.

The fine-print document that comes with your cell phone does warn you about heavy use of one's cell phone and potential health matters. There's no secret there. That fact was established long ago when state troopers using the radar gun in road-side speed checks on the Interstate highway system began to experience cancer of their reproductive organs. A similar experience occurred with Navy, Marine, and Air Force pilots using onboard electronic weapons targeting radar.

Anyone can type in their address at <http://www.antennasearch.com> and it will tell you how many towers and antennas are within a 3-mile radius of the house you live in. It may be as large as a 10-mile radius but it is updated continuously.

The rollout of **5G** wireless energy began in China on October 31, 2019. Simultaneously, the Coronavirus scam was declared by the World Health Organization (WHO) on March 10/11th of 2020. **5G** was unveiled first in Wuhan, China, Seattle, WA, New York City, NY, and Milan, Italy as part of the “Smart Cities” showcase. Coincidental to the **5G** rollout in those cities they also experienced huge outbreaks of what was called Covid-19. While Covid-19 virtually occurred simultaneously in real-time around the world, the WHO was telling the world we had to lock down countries to prevent its spread. The public was being distracted by the spreading factor and how Covid became a worldwide “pandemic”. Commercial air transport was being blamed for the spread of the virus despite the outbreaks were occurring in cities and countries with the new **5G** technologies. For months, the African continent had few cases of the Coronavirus. For over a year, Africa was virus-free, and when reported, the outbreaks were in areas where major cities are located and the **5G** technology is centered.

Health experts have growing concerns regarding reinfections of the SARS-CoV-2 coronavirus, especially as more data suggest that immunity from previous infection is not as protective against the newest omicron variants. Australia’s health officials have recommended that the immune period post-infection be shortened, which would affect how often people would need to test and quarantine if exposed to a COVID case.

According to a report from July 8th, 2022, the Australian Health Protection Principal Committee acknowledge that reinfections can occur as early as within 28 days and advises that the reinfection period be reduced from 12 weeks to 28 days.

“People who test positive to COVID-19 more than 28 days after ending isolation due to previous infection should be reported and managed as new cases,” the report stated.

Australia is in the Southern Hemisphere and is experiencing winter now. There was a BA.1 omicron wave in January, and there is currently a wave driven by the BA.4 and BA.5 omicron sub-variants. These two sub-variants *“are more able to evade immunity gained from previous infection and vaccination reinfection is more likely and possible just weeks after a prior infection,”* said New South Wales Chief Health Officer Kerry Chant to ‘Cosmos’ Magazine. *“We’re urging people who have recently had COVID-19, even if they left isolation in the past four weeks, not to be complacent. If you develop symptoms again, make sure to test and isolate.”*

So far, five states in Australia have updated their official health advice to reflect the shorter reinfection period. All adults over the age of 50 are also advised to get their winter booster shots.

In the U.S., the Centers for Disease Control and Prevention’s advice says that reinfections can occur within 90 days of a first infection. U.S. government officials are warning that the BA.5 omicron variant may lead to a wave of new cases. Positivity rate, cases and hospitalizations are trending up after plateauing for a few months following the original omicron wave. Community level transmission is high or medium in many

parts of the country, although many people in cities around the country like New York seem to be ambivalent about it.

The World Health Organization's Director-General Tedros Adhanom Ghebreyesus warns that this combined with the fact that surveillance is lacking could be a problem, saying in a statement on July 12 that *"surveillance has reduced significantly – including testing and sequencing – making it increasingly difficult to assess the impact of variants on transmission, disease characteristics, and the effectiveness of counter-measures."*

Many health experts are prioritizing looking at testing positivity rate as a more accurate indicator of COVID trends, rather than number of cases. In New York, the positivity rate has risen rapidly in the last few weeks and currently is at 15 percent for the seven-day average. This rate is as high as it was in January in the middle of the first omicron wave.

"New waves of the virus demonstrate again that the COVID-19 is nowhere near over. We have safe and effective tools that prevent infections, hospitalizations and deaths. However, we should not take them for granted," Tedros said.

This information was posted on July 14, 2022 and shows the *"make up the narrative as you go strategy"*. Steve Kirsch makes that point in his analysis posted above. At some point the world will wake up to the reality that health agencies cannot produce proof of their claims about the virus. 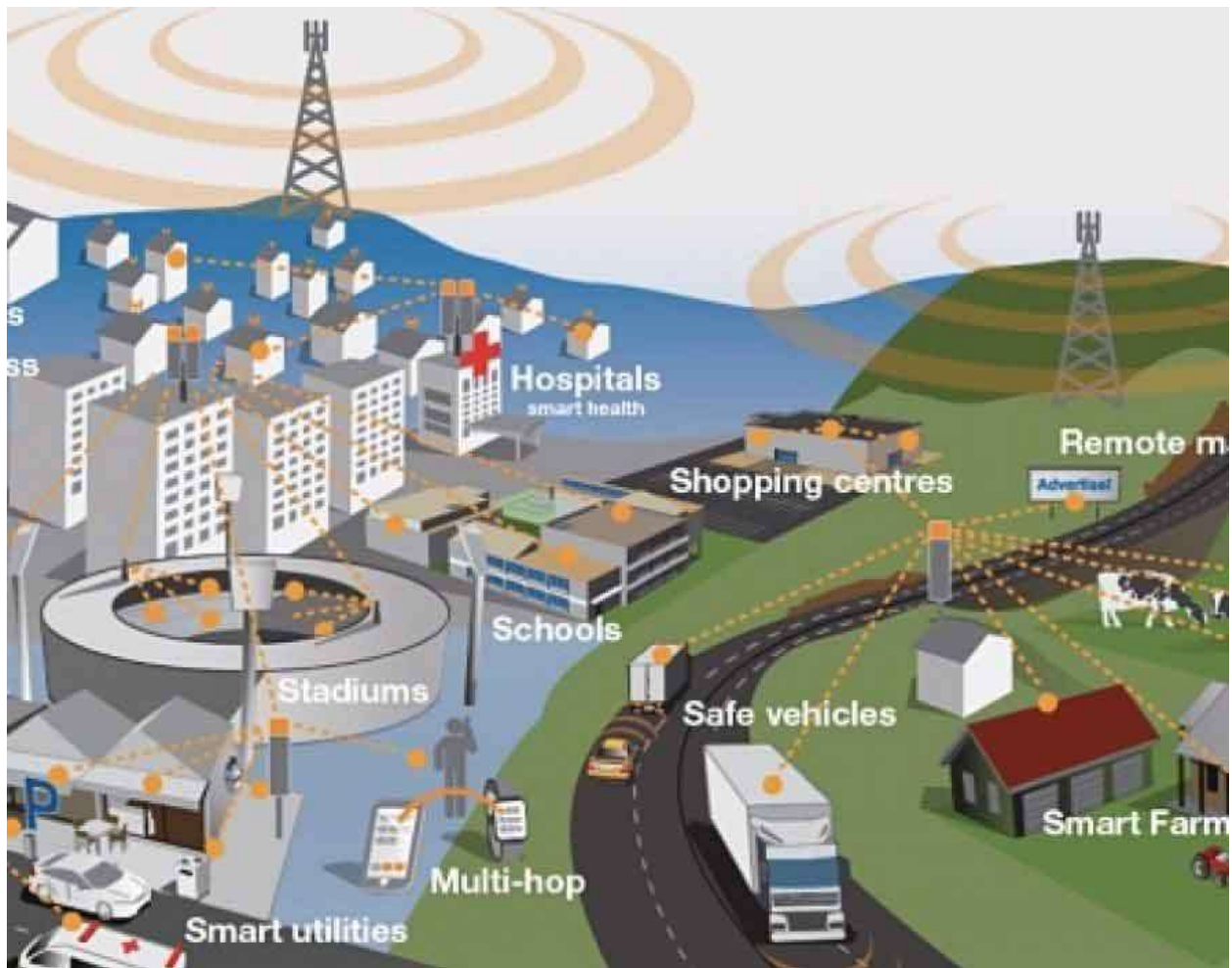

Dr. Poland said a CDC map showing community levels being mostly low in Minnesota as of Friday, is misleading. In part, due to many cases likely being underreported since state-run testing sites have closed and there's been a rise in at-home testing.

"Even though we aren't experiencing the same surge right now as much of the rest of the nation, we will be," Dr. Poland said.

Across the country, as the highly contagious Omicron BA.4 and BA.5 subvariants are on the rise, more Americans are reporting second infections. And while symptoms are often mild, a new study tracked nearly 40,000 people who had COVID at least twice and found each reinfection creates a new opportunity for serious health risks.

"Some people, when they get infected the first time, that infection may weaken their immune system in a way or produce some organ damage that makes them more vulnerable to having adverse consequences or adverse health risks after they get the second infection," says Dr. Ziyad Al-Aly, Clinical Epidemiologist at Washington University in St. Louis, who led the research.

His study found patients with two or more infections had more than twice the risk of dying compared to patients with just one infection. They had three times the risk of being hospitalized and faced higher odds of getting long COVID.

"If you've had a first infection and you managed to dodge long COVID," says Al-Aly, "having a second infection you literally are rolling the dice again." He says the risk of reinfection is increasing dramatically, and we're seeing it from all corners.

"We are still learning a lot about this virus and it's changing so quickly," Dr. Michael Osterholm, Director of the Center for Infectious Disease Research and Policy at the University of Minnesota said.

Dr. Osterholm said there's a long way to go when it comes to treatment options, but right now, the vaccine is still the best defense.

"Fortunately, we're not seeing a major increase in severe illness, hospitalizations and deaths," he said.

The Food and Drug Administration has asked manufacturers to design a booster for the fall that targets the newest Omicron variants.

The above bovine excrement comes from CBS affiliate in Minneapolis, MN home of the Mayo Clinic, which played a small collateral part in the Johns Hopkins Event 201. Event 201 was a **simulation of a corona pandemic** conducted by the Bill & Melinda Gates Foundation, the World Economic Forum and Johns Hopkins University in October 2019. Participants from the private and public sectors were presented with a scenario, not unlike the one that has unfolded in reality, and discussed what needed to be done. **We are supposed to believe their bovine excrement when Bill Gates and Richard Rothschild are the assigned agents for patents issued on Covid several years before it was a so-called "pandemic".**

We use and are exposed to nonionizing radiation sources every day. Microwave ovens use microwaves to heat food, toasters use infrared waves to heat and sometimes burn our toast, and we watch television, talk on cell phones, and listen to the radio through the use of radio waves. These are all nonionizing forms of radiation. Visible light, radar, laser light, and ultraviolet light also fall into this radiation category.

Some forms of nonionizing radiation can damage tissues if we are exposed too much. For instance, too much ultraviolet (UV) light from lying out in the sun is known to cause some skin cancers; even moderate amounts can cause skin burns.

In addition to the sun, UV waves (sometimes called UV radiation) are emitted by lights used in tanning beds, black lights, and lights used to pasteurize fruit juices. Some UV waves have an energy that is high enough to cause a structural change within atoms.

Visible light waves are also a form of nonionizing radiation, as is the light beam emitted by a laser. A laser beam can be visible, as in the case of a laser pointer, or a laser can emit an invisible beam of UV or infrared waves. With enough energy, lasers can cause biological damage, which is why they are useful in medicine to remove warts and some skin cancers and even to break up kidney stones.

As we talk about these different sources, we are moving along a continuum of energy called the electromagnetic spectrum. Ionizing radiation tops the spectrum with the highest energy, nonionizing ultraviolet waves are next. Then comes visible light waves followed by infrared waves. Infrared sources in our daily lives include toasters, toaster ovens, and heat lamps.

Non-ionizing Radiation Information

Now we get down to the lower energies where our favorite devices operate—in the radiofrequency (RF) wave range. From highest to lowest energy, this includes microwave ovens, global positioning systems, cell phones, television stations, FM radio, baby monitors, cordless phones, garage-door openers, CB radios, and AM radio. Radiofrequency waves can cause tissue heating at high energies and with high intensities.

The last type of nonionizing radiation we'll simply mention is extremely low-frequency (ELF) waves that is produced by electrical power lines and wiring. The assumption is that nonionizing is harmless but that may not be the case from recent studies of wireless energy. I will discuss more later in this article about this finding.

Note below the patent issued to Richard Rothschild in September, 2020 was first filed on October 13, 2015, five years before, indicating that the **Covid-19 virus was planned**

five years before it was even called a “pandemic” by the WHO. There is another patent with Bill Gates designated as the “assignee”, the legal term for owner of a patent, that was issued in 2013. Fact-checkers deny such claims but they are refuted by published illustrations of the patents issued by U.S. and European Patent Offices.

In previous articles I have included proof positive that William Gates, III holds a patent on the Covid virus. Remember, the U.S. Patent Office only grants a patent when a patent is certified to do what it claims. **Verification of patent declarations are investigated by Dr. David L. (57) **ABSTRACT**

A method is provided for acquiring and transmitting biometric data (e.g., vital signs) of a user, where the data is analyzed to determine whether the user is suffering from a viral infection, such as COVID-19. The method includes using a pulse oximeter to acquire at least pulse and blood oxygen saturation percentage, which is transmitted wirelessly to a smartphone. To ensure that the data is accurate, an accelerometer within the smartphone is used to measure movement of the smartphone and/or the user. Once accurate data is acquired, it is uploaded to the cloud (or host), where the data is used (alone or together with other vital signs) to determine whether the user is suffering from (or likely to suffer from) a viral infection, such as COVID-19. Depending on the specific requirements, the data, changes thereto, and/or the determination can be used to alert medical staff and take corresponding actions.

In his testimony to ACU, he reviews some of the most pertinent patents, showing SARS-CoV-2 is not a novel coronavirus at all but, rather, a manmade “bioweapon” virus that has been in the works for decades.

According to Martin, Fauci and the NIAID "*found the malleability of coronavirus to be a potential candidate for HIV vaccines,*" and in 1999, Fauci funded research at University of North Carolina Chapel Hill (where Baric has a lab) to create "*an infectious replication-defective coronavirus*" specifically targeted for human lung epithelium.

The patent for that replication-defective coronavirus that attacks human lung cells was filed April 19, 2002 (Patent No. 7279327). "*In other words, we made SARS,*" Martin says. Or perhaps more accurately, Fauci and UNC

did. Several months after that patent filing, the SARS outbreak in Asia occurred.

Coronavirus — A Biological Weapon Candidate Since 2001?

As mentioned, Martin has monitored biological and chemical treaty violations since 2001, following the anthrax attacks. Throughout the fall of 2001, an “enormous number” of bacterial and viral pathogens were patented through the National Institutes of Health, the NIAID, the U.S. Army Medical Research Institute of Infectious Diseases (USAMRIID) and their international collaborators.

“Our concern was that coronavirus was being seen as not only a potential manipulatable agent for potential use as a vaccine vector, but it was also very clearly being considered as a biological weapon candidate,” Martin says.

Before the SARS outbreak in China, Martin reported these concerns publicly. *“So, you can imagine how disappointed I am to be sitting here ... having 20 years earlier pointed that there was a problem looming on the horizon with respect to coronavirus,”* he says.

CDC Holds Patents on SARS Coronavirus

In April 2003, after the SARS outbreak in China had occurred, the U.S. Centers for Disease Control and Prevention tried to file a patent for the entire gene sequence for the SARS coronavirus (Patent No. 7220852). This is a violation of 35 U.S. Code Section 101, which states you cannot patent a naturally-occurring substance.

That CDC patent also had several derivative patents associated with it, including U.S. patent 46592703P and U.S. patent 7776521. These two patents cover the gene sequence of SARS coronavirus and the means for detecting it using RT PCR testing.

Together, these patents are highly problematic, because if you own both, then *“you have a cunning advantage to being able to control 100% of the provenance of not only the virus itself, but also its detection, meaning you have entire scientific and message control,”* Martin explains.

The CDC tried to justify the patent by saying they were being sought in order to ensure that everyone would be free to research coronaviruses. However, that is a lie, Martin says. The U.S. patent office rejected the patent on the gene sequence as unpatentable because it was 99.9% identical to a coronavirus that was already in the public domain.

The CDC paid an appeal fine in 2006 and again in 2007. They also paid an additional fee to keep the application private. In the end, the CDC overrode the patent examiner's rejection and secured the patent in 2007.

"Last time I checked, if you're trying to make information available for the public research, you would not pay a fee to keep the information private," Martin says. According to Martin, the gene sequence filed by the CDC in 2003, 2005 and 2006 is 89% to 99% identical to the sequence identified as SARS-CoV-2.

Sequoia Pharmaceuticals

April 28, 2003 — three days after the CDC filed its patent for the SARS coronavirus — Sequoia Pharmaceuticals filed a patent on an antiviral agent for the treatment and control of infectious coronavirus (Patent No. 7151163). So, the CDC files a patent on SARS coronavirus, and three days later there's a treatment?

This strongly suggests there was a working relationship behind the scenes. Sequoia Pharmaceuticals, founded in 2002, develops antiviral therapeutics with a special focus on drug-resistant viruses.⁸ Its lead investors include the Wellcome Trust.

But there's yet another problem with Sequoia's 2003 filing for an antiviral agent. It was actually issued and published before the CDC patent on SARS coronavirus had been granted, which didn't happen until 2007, and the CDC had paid to keep the application private.

"SO, THE DEGREE TO WHICH THE INFORMATION COULD HAVE BEEN KNOWN BY ANY MEANS OTHER THAN INSIDER INFORMATION BETWEEN THOSE PARTIES IS ZERO," MARTIN SAYS. "IT IS NOT PHYSICALLY POSSIBLE FOR YOU TO PATENT A THING THAT TREATS A THING THAT HAD NOT BEEN PUBLISHED, BECAUSE CDC HAD PAID TO KEEP IT SECRET."

Sanofi Holds Patents to Novel Feature of SARS-CoV-2

The next bombshell revelation occurred on June 5, 2008, when Ablynx, now a part of Sanofi, filed a series of patents detailing what we've been told are novel features of SARS-CoV-2, namely the polybasic cleavage site, the spike protein and the ACE2 receptor binding domain. The first of those patents, U.S. Patent No. 9193780, was issued November 24, 2015.

Between 2016 and 2019, a series of patents were issued to Ablynx and Sanofi covering the RNA strands and the subcomponents of the gene strands.

Between 2008 and 2017, a series of patents were also filed by a long list of players, including Crucell, Rubeus Therapeutics, Children's Medical Corporation, Ludwig-Maximilians-Universität in München, Protein Science Corporation, Dana-Farber Cancer Institute, University of Iowa, University of Hong Kong and the Chinese National Human Genome Center in Shanghai.

This series of patents detail ever single attribute that is supposed to be unique to SARS-CoV-2, according to the paper, *"A Novel Bat Coronavirus Reveals Natural Insertions at the S1/S2 2 Cleavage Site of the Spike Protein and a Possible Recombinant 3 Origin of HCoV-19."*

This paper has routinely been used to identify the so-called novel coronavirus that is SARS-CoV-2. **Yet there are 73 patents, issued between 2008 and 2019, that describe the very elements that are said to be unique to SARS-CoV-2.** Patents have been filed for SARS-CoV-2's polybasic cleavage site, the ACE2 receptor binding domain, and the spike protein.

"So, there was no 'outbreak' of SARS, because we had engineered all of the elements of that," Martin says. And by 2016, when Baric published a paper warning that SARS coronavirus was *"poised for human emergence,"* the virus in question had already been patented for commercial exploitation 73 times!

The Pandemic Virus Industrial Complex Is Swimming in Profit

Baric is one of the few people who has profited significantly from this pandemic, which he appears to have been part of creating. Another is Fauci. The same drug companies that hold patents on not-so-novel SARS-CoV-2 features are also raking in profits from their COVID shots.

In 2015, [Dr. Peter Daszak](#), head of the EcoHealth Alliance that funneled research dollars from the NIAID to the Wuhan Institute of Virology for coronavirus research, who has promoted the official narrative that SARS-CoV-2 has a natural origin, stated:⁹

“WE NEED TO INCREASE PUBLIC UNDERSTANDING OF THE NEED FOR MEDICAL COUNTERMEASURES SUCH AS A PAN-CORONAVIRUS VACCINE. A KEY DRIVER IS THE MEDIA AND THE ECONOMICS WILL FOLLOW THE HYPE. Sounds an awful lot like what we’re facing right now, doesn’t it? At the end of the day, this pandemic has primarily been about profit and the [shifting of wealth](#), from the lower- and middle-classes to the already ultra-wealthy. This is a war on the public, waged using biological weapons and information warfare, with the ultimate goal of [“resetting” life and commerce](#) as we know it.

Intentional Weaponization of Spike Protein

Martin says:

Déjà Vu: COVID-19 Outbreak on Princess Cruises Ship in Australia

When I read the news this morning that a COVID-19 outbreak involving around one-hundred passengers and crew members occurred on the *Coral Princess*, Princess's sister ship to the *Ruby Princess* which had one of the earliest outbreaks of COVID-19 in Australia two years ago, I felt as if I were trapped in a scene in [Groundhog Day](#). In the movie, comedian Bill Murray plays a weatherman who finds himself trapped in the small town of Punxsutawney, PA as he lives the same day over and over again.

[ABC News – Australia](#) reports that a COVID-19 outbreak on the Coral Princess involved “around one hundred passengers and crew members” as the Princess cruise ship arrived in Brisbane, Australia in the northeastern state of Queensland. Neither Princess Cruises nor parent company Carnival Corporation stated the actual or precise number of infected guests or crew but nonetheless released a PR statement claiming that the cruise line had been “*open and transparent*” with guests.



The government in Australia down-played the outbreak, saying that COVID-19 is everywhere and bound to happen on cruise ships. Inexplicably the Australian health officials said there were no plans to mandate face masks, and said it was up to individuals whether to wear one or not. Despite this relaxed attitude, the Princess spokesperson claimed that the “*health and well-being of our guests and crew remain our main priority*” and that the cruise line was “[doing everything possible to ensure the safety of guests and crew in the face of the outbreak.](#)” These are the usual cruise line claims and PR gobbledegook. In the same spirit, the cruise line claimed it was “*adhering*

to comprehensive protocols,” but there was no effort to even require masks or enforce social distancing.

The government also claimed that “cruise ship crew and their passengers are subject to strict requirements to minimize the COVID-19 risk to Queenslanders.” But, again, the guests were not required to wear masks or socially distance.

A number of infected guests disembarked in Brisbane, which as Australian newspaper [WAtoday](#) explained, is facing its highest level of hospitalization in six months. Thousands of staff are off sick or isolating due to coronavirus infection which is placing significant pressure on the state’s hospitals. These hospitals have already started to cancel elective procedures.

The *Ruby Princess*, a sister ship of the *Coral Princess*, was the site of an early major outbreak of COVID-19 in Australia when infected passengers were allowed to disembark in Sydney in 2020. At least [900 passengers and crew later tested positive for COVID-19, and 28 people died](#).

Crew members were forced to stay on the Princess ship as the virus spread. Some Princess crew members died and/or [ended their life](#) waiting repatriation home.

This year, the *Ruby Princess* again made the news when over 250 passengers were infected with COVID-19 during cruises at the end of March and mid-April.

Princess Cruises became the poster-child of how a cruise line should not to handle a COVID-19 outbreak based on its mishandling of outbreaks on the [Diamond Princess](#), [Grand Princess](#) and [Ruby Princess](#).

At the beginning of the coronavirus outbreak on the *Diamond Princess*, I asked Princess Cruises whether the virus could be spread through airborne particles. Just since the past month, worried savers have descended on three banks to withdraw funds amid rumors of cash shortages that were later dismissed as false. Over the weekend customers rushed to a bank in the northern Hebei province to take out money, prompting local regulators to publicly vouch for the soundness of its lenders as the police halted the run.

Confidence in the \$43 trillion Chinese banking system is eroding among the nation's more than 1 billion account holders, threatening a cornerstone of China's rise into an economic powerhouse. After several bailouts and the first bank seizure in more than two decades last year, the coronavirus outbreak and its economic fallout have exacerbated an already shaky situation in the world's largest banking system.

"The perception Chinese savers had of banks being risk free is changing even though in nearly all recent cases their deposits have been protected," said Zhang Shuaishuai, a Shanghai-based analyst at China International Capital Corp. "Once a rumor like this spreads, it brings immediate liquidity risk to a bank."

For decades, deposit-taking has provided a stable and low-cost funding base for China's financial market, playing a key part in the rise of its economy to the second largest in the world. Chinese households hold about 90 trillion yuan (\$13 trillion) of bank deposits, more than anywhere else in the world.

Regulators are now not only seeking to soothe nerves publicly, but are also raising the protection to preserve this cushion for banks. The run in Hebei came after authorities kicked off a pilot program to limit large transactions in the province.

The two-year program, which is set to be expanded to Zhejiang and Shenzhen in October to encompass 70 million people, would require retail clients to pre-report any large withdrawals or deposits of 100,000 yuan (\$14,000) to 300,000 yuan. (Some U.S. banks have been questioning large withdrawals, something that we need to be aware of as contagion spreads.)

The China Banking and Insurance Regulatory Commission on Saturday again warned that lenders are facing a surge in bad debt as the economy sputters at its slowest pace in four decades.

While stopgap measures, which have included rolling over debt and delaying loan payments, have limited an immediate surge in bad debt, the regulator said the fundamental issues of poorly managed banks and the deteriorating ability of companies and individuals to repay loans are still far from solved. They are also asking banks to forgo 1.5 trillion yuan in profit this year by offering lower lending rates, cutting fees, deferring loan repayments, and granting more unsecured loans to small businesses to help the economy.

Authorities have more than 3,000 banks to oversee, most of which are small, rural entities without ready access to capital. In another unprecedented move, China now plans to allow local governments to use about 200 billion yuan from bond sales to help smaller banks replenish their capital.

The industry overall may suffer an 8 trillion yuan increase in bad debt this year, S&P Global has estimated. Small banks are facing a \$349 billion shortfall in capital, according to an analysis by UBS Group AG. Putting that figure at only \$50 billion, the regulator said the shortfall could mean slower profit growth or even sliding profits at some institutions.

The CCP made a huge mistake to double-cross the Zionist mafia House of Rothschild. China has a history of stealing, cheating, and double-dealing. What they can't steal outright they will buy and copy by their knock-offs of others.

Failing to start a war between the U.S. and China, the UK Zionist Rothschild's decided to provoke a war between the U.S. and Russia through the Ukraine at which at the present time appears to be coming to a crisis point. The Rothschild

objective is to eliminate the two largest economic powers of China and the U.S. They have used the State of Israel as a wedge in the European Union and NATO. By pitting Russia against the U.S. the Zionists hope to use Israel and China as the Belt and Road The Belt and Road Initiative (BRI, or B&R), formerly known as One Belt One Road or OBOR for short, is a global infrastructure development strategy adopted by the Chinese government in 2013 to invest in nearly 70 countries and international organizations.

The Belt and Road Initiative, reminiscent of the Silk Road, is a massive infrastructure project that would stretch from East Asia to Europe. Some analysts see the project as a disturbing expansion of Chinese power, and the United States has struggled to offer a competing vision.

The initiative has stoked opposition in some countries involved in Belt and Road that have taken on high levels of debt. The Rothschild's plan has been to use Israel or the Ukraine as the center of this Belt and Road Initiative and to weaken the U.S. as a world power. That includes destroying the Dollar!

The original Silk Road arose during the westward expansion of China's Han Dynasty (206 BCE–220 CE), which forged trade networks throughout what are today the Central Asian countries of Afghanistan, Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan, and Uzbekistan, as well as modern-day India and Pakistan to the south. Those routes extended more than four thousand miles to Europe.

Central Asia was thus the epicenter of one of the first waves of globalization, connecting eastern and western markets, spurring immense wealth, and intermixing cultural and religious traditions. Valuable Chinese silk, spices, jade, and other goods moved west while China received gold and other precious metals, ivory, and glass products. Use of the route peaked during the first millennium, under the leadership of first the Roman and then Byzantine Empires, and the Tang Dynasty (618–907 CE) in China.

But the Crusades, as well as advances by the Mongols in Central Asia, dampened trade, and today Central Asian countries are economically isolated from each other, with intra-regional trade making up just 6.2 percent of all cross-border commerce. They are also heavily dependent on Russia, particularly for remittances—they make up one-third of the gross domestic product (GDP) of Kyrgyzstan and Tajikistan. By 2018, remittances had dipped from their 2013 highs due to Russia's economic woes.

What are China's plans for its New Silk Road?

President Xi announced the initiative during official visits to Kazakhstan and Indonesia in 2013. The plan was two-pronged: the overland Silk Road Economic Belt and the Maritime Silk Road. The two were collectively referred to first as the One Belt, One Road initiative but eventually became the Belt and Road Initiative.

Xi's vision included creating a vast network of railways, energy pipelines, highways, and streamlined border crossings, both westward—through the mountainous former Soviet republics—and southward, to Pakistan, India, and the rest of Southeast Asia. Such a network would expand the international use of Chinese currency, the renminbi, and *“break the bottleneck in Asian connectivity,”* according to Xi. (The Asian Development Bank estimated that the region faces a yearly infrastructure financing shortfall of nearly \$800 billion.) In addition to physical infrastructure, China plans to build fifty special economic zones, modeled after the Shenzhen Special Economic Zone, which China launched in 1980 during its economic reforms under leader Deng Xiaoping.

Xi subsequently announced plans for the 21st Century Maritime Silk Road at the 2013 summit of the Association of Southeast Asian Nations (ASEAN) in Indonesia. To accommodate expanding maritime trade traffic, China would invest in port development along the Indian Ocean, from Southeast Asia all the way to East Africa and parts of Europe.

China's overall ambition for the BRI is staggering. To date, more than sixty countries—accounting for two-thirds of the world's population—have signed on to projects or indicated an interest in doing so. Analysts estimate the largest so far to be the estimated \$60 billion* China-Pakistan Economic Corridor, a collection of projects connecting China to Pakistan's Gwadar Port on the Arabian Sea. In total, China has already spent an estimated \$200 billion on such efforts. Morgan Stanley has predicted China's overall expenses over the life of the BRI could reach \$1.2–1.3 trillion by 2027, though estimates on total investments vary. An Indian company was just announced as the buyer for the Israeli port of Haifa with the past few days.

What does China hope to achieve?

China has both geopolitical and economic motivations behind the initiative. Xi has promoted a vision of a more assertive China, while slowing growth and rocky trade relations with the United States have pressured the country's leadership to open new markets for its goods. China has its eyes on the U.S. agricultural base, it needs the land to feed its people. China has been preparing for a war with the U.S. for decades, it is common understanding among its military leaders that it has to take the U.S. down. J.R. Nyquist has noted the Chinese objective to war it out with the U.S.

To date, more than sixty countries—accounting for two-thirds of the world's population—have signed on to projects or indicated an interest in doing so.

Experts see the BRI as one of the main planks of a bolder Chinese statecraft under Xi, alongside the Made in China 2025 economic development strategy. For Xi, the BRI serves as pushback against the much-touted U.S. *“pivot to Asia,”* as well as a way for China to develop new investment opportunities, cultivate export markets, and boost Chinese incomes and domestic consumption. *“Under Xi,*

China now actively seeks to shape international norms and institutions and forcefully asserts its presence on the global stage,” writes CFR’s Elizabeth C. Economy.

China’s credit market is entering a new stage of its distressed cycle. As the world’s No. 2 economy contracts, payment risk is spreading from private developers to a wider variety of borrowers. Global investors have been hardest hit by defaults. China’s offshore bond delinquencies have exceeded \$26-billion dollars.

At the same time, China is motivated to boost global economic links to its western regions, which historically have been neglected. Promoting economic development in the western province of Xinjiang, where separatist violence has been on the upswing, is a major priority, as is securing long-term energy supplies from Central Asia and the Middle East, especially via routes the U.S. military cannot disrupt.

More broadly, Chinese leaders are determined to restructure the economy to avoid the so-called middle-income trap. In this scenario, which has plagued close to 90 percent of middle-income countries since 1960, wages go up and quality of life improves as low-skilled manufacturing rises, but countries struggle to then shift to producing higher-value goods and services.

What are the potential roadblocks?

The Belt and Road Initiative has also stoked opposition. For some countries that take on large amounts of debt to fund infrastructure upgrades, BRI money is seen as a potential poisoned chalice. BRI projects are built using low-interest loans as opposed to aid grants. Some BRI investments have involved opaque bidding processes and required the use of Chinese firms. As a result, contractors have inflated costs, leading to canceled projects and political backlash.

Examples of such criticisms abound. In Malaysia, Mahathir bin Mohamad, elected prime minister in 2018, campaigned against overpriced BRI initiatives, which he claimed were partially redirected to funds controlled by his predecessor. Once in office, he canceled \$22 billion worth of BRI projects, although he later announced his “*full support*” for the initiative in 2019. In Kazakhstan, mass protests against the construction of Chinese factories swept the country in 2019, driven by concerns about costs as well as anger over the Chinese government’s treatment of Uighurs in Xinjiang Province.

More such stories are likely, according to a 2018 report by the Center for Global Development, which notes that eight BRI countries are vulnerable to debt crises. The CFR’s Belt and Road Tracker shows overall debt to China has soared since 2013, surpassing 20 percent of GDP in some countries.

As history shows, powerful men, countries, are never satisfied unless they can

achieve the ultimate, i.e., global control over the planet. China decided to replace the Rothschild banking dynasty by eliminating the nearly 300-year House of Rothschild control over credit and currency. When the House of Rothschild discovered what China was doing, they had to find a way to short-circuit the CCP strategy, and they chose to use their knowledge advantage to introduce a “bioweapon” that would shut-down most of the world until they could re-establish or regain the upper hand!

To show how the name of Rothschild always seems to pop up or occurs in world events, you may recall the mysterious disappearance of Malaysia Airlines Flight 370. Malaysia Airlines Flight 370 was an international passenger flight operated by Malaysia Airlines that disappeared on March 8, 2014 while flying from Kuala Lumpur International Airport in Malaysia to its planned destination, Beijing Capital International Airport. On board that flight were a team of some 20 IBM engineers led by an American Philip Wood. The story is that missing Flight 370 passenger Philip Wood, an IBM manager and Texas native; who was able to send a picture and message to an internet message board. Phil Wood had a brand new Apple iPhone hidden in the back of his buttocks. He clicked off 2 frames which appear black but the blackened images contained the GPS coordinates from the cell phone’s physical location. Those GPS coordinates showed the missing aircraft at the end of the runway at Diego Garcia, a joint US/UK airbase in the middle of the Indian Ocean, thousands of miles in a different direction from its scheduled flight route.

The Rothschild’s became owner of the microchip controller patent by default of which Phil Wood and his team of engineers were taking to China in preparations leading to its production. With the absence of all surviving passengers holding a share in the patent of the super-secret controller chip resulted in a default of ownership to that of the patent’s assignee of the venture capital investor, being in this case the Rothschild’s. Coincidence? I don’t think so.

These facts came out later confirming those GPS coordinates were correct came in a release by Rolls Royce Corporation. Unbeknown to the world but Rolls Royce, they had electronic sensors on their jet engines powering the aircraft sending hourly performance data back to the UK via a satellite in orbit that was being forwarded hourly back to Rolls Royce where the engines were manufactured. The flight MH370 was a Boeing 777-200ER. An identical twin Boeing 777-200ER aircraft of the same configuration built at the same time side-by-side on the assembly line sat in an Israeli hangar at Ben Gurion Airport in Tel Aviv, Israel.

In the map below, the last communication point location before the aircraft's identity transponder was turned off it was clearly headed in the direction of the UK/US joint base at Diego Garcia.



I was following this story closely for more than six years after the disappearance and many interesting bits of information became published on the Internet. One of the most interesting bits of facts that came out was that aircraft was also equipped with an onboard clipper (QSR-11) chip designed to enable external remote take

over control of an aircraft in the event of onboard hijackers gaining control over the cockpit of a commercial aircraft.

Field McConnell, a 70-year retired Marine and former Delta senior pilot was the first to announce the shock claim about the QSR-11. Field McConnell ran a web site called "Abel Danger."

His next shock claim was that the Malaysian Boeing 777 aircraft involved in Flight MH-370, which disappeared on March 8th, 2014 in route to Beijing from Kuala Lumpur was the same aircraft (ID# 9M-MRO) that crashed in Ukraine during Flight MH-17 on July 17, 2014, which is what was reported at the time. A Ukraine missile was used to shoot down the aircraft, of which the Ukrainians thought they were shooting down the personal aircraft of President Vladimir Putin returning from a conference in South America. I forget as to which aircraft crossed the other's flight path (within a time of about 5 minutes) but the missing MH-370 was shot down over the Ukraine. Stuffed into the cargo hold of the aircraft, were the rotting remains of the original missing flight's passengers and crew. To this day, the Dutch government has refused to provide all information on the shot down aircraft which originated at Amsterdam. The whereabouts of MH-370 for just over four months remains a total mystery to this day.

It then became known as a result of the Malaysian MH370 that all modern commercial jet aircraft are equipped with the QSR-11 chip. In the case of MH370, the indications are that it was hijacked by an external aircraft shadowing above and behind the aircraft in flight, controlling its flight externally to a military air base in the middle of the Indian Ocean. The passengers and crew were incapacitated by some sort of gas to put them to sleep until the plane landed at the island of Diego Garcia.

This report was kept out of the media because knowing the existence of the QSR-11 fills in many blanks and answers many questions of aircraft that were flown into the World Trade Center buildings 1 and 2! Who owns the media wire services such as Reuter's, the Associated Press and United Press International? Can you guess who it might be? Would it surprise you to know that the global media is owned by the House of Rothschild?

A few years ago a business trade report was posted on the Internet announcing the Rothschild's became full owner of the mystery microchip controller as being the sole survivor of the patent as its "assignee". Coincidence? Perhaps! All the shareholders in the patent of this new super controller microchip design were either dead or missing in the disappearance of MH370; except for the "assignee" of the patent financial investor, the Rothschild's. So many coincidences, don't you think?

McConnell states, "*Broward County, Florida is connected to Ukraine, both by child trafficking, done by practitioners in Broward County Family Court and also,*

the ownership of the Twin [plane] to Malaysia Airline Systems, Boeing 777, registration identifier 9, Mike, hyphen, Mike, Romeo, Oscar (9M-MRO), which was operated as MH-370 on the 8th of March of 2014 and operated, again as MH-17 on the 17th of July, 2014.”

McConnell states that this plane was owned by GA Telesis, a Broward County corporation. As reported on May 2, 2014, two months prior to the crash of Flight MH-17 in Ukraine, GA Telesis purchased the aircraft and delivered it to Tel Aviv’s Ben Gurion Airport on November 4, 2013, where it had remained “in storage”, as recorded on the Planespotters website.

In 2014, it was reported that GA Telesis was founded and is co-owned by Abdol Moabery, son of wealthy Iranian immigrants. Moabery had previously been an executive at two George Soros-owned companies, Aviation Systems International and C-S Aviation. Moabery’s affiliations were with seven child- and youth-oriented charities: 1) His House Children’s Home; 2) Food for the Poor; 3) Kids in Distress; 4) Florence Fuller Child Development Center; 5) the ISTAT Foundation; 6) the Factor Foundation; and 7) the March of Dimes.

Do these children’s charities relate to what McConnell was referring to, when he says that the “ownership” of the plane are “practitioners” in child trafficking?

The next series of shock claims Field McConnell made were his comments on the eventuality that the 9/11 investigation will be re-opened, in which case, “Russia and Vladimir Putin may be a powerful allies, with Trump’s 4th Marine...”

The reason for Russia’s involvement has to do with three Russian transport planes downed between 2012 and 2016 by the same secret “*technology deployed on 9/11, in MH-370, in MH-17 and the 16-plus airliner murders-for-hire, collectively known as ‘The Baker’s Dozen’.*” Abel Danger news creator Field McConnell was most likely jailed for airing news the 9/11 investigation will be re-opened.

Doudna's group has learned how the hepatitis C virus synthesizes viral proteins — work that could lead to new antiviral drugs with fewer side effects. Jennifer Doudna has co-founded a number of companies to market CRISPR-related products, including Caribou Biosciences and Mammoth Biosciences. She also serves on the board of pharmaceutical and consumer healthcare giant Johnson & Johnson.



Jennifer Doudna and her family continue to live in Berkeley. Jamie Cate is a professor at the University of California and works at the nearby Energy Biosciences Institute, with a team pursuing gene editing for the production of biofuels. Jamie and Jennifer's son is also reportedly considering a career in the sciences.

In 2020, Jennifer Doudna and her collaborator Emmanuelle Charpentier were awarded the Nobel Prize in Chemistry. It is the first time two female scientists have shared the chemistry prize. In making the award, the Royal Swedish Academy of Sciences noted that they have “revolutionized basic science.”

Later that year, the COVID-19 pandemic engulfed the world, and interest in Doudna's work with RNA intensified as technology she pioneered offered the promise of a new defense against contagious viruses. Author Walter Isaacson, who had enjoyed previous success with his bestselling biographies of Benjamin Franklin and Steve Jobs, celebrated Jennifer Doudna's life and accomplishments in the acclaimed 2021 book *'The Code Breaker'*.

In March, 2022, the U.S. Patent and Trademark Office ruled that the Broad Institute deserves the credit for inventing a way to use Crispr in plants and animals. The ruling cancels certain patent applications made by the University of California and its partners regarding a Crispr system known as Crispr-Cas9, stating that they failed to provide persuasive evidence that they got the gene-editing technology to work before the Broad group did. Dr. Doudna said. "I don't

agree with it. It will be appealed.” She added, “I stand by our work. It is very clear in the scientific community what was done by whom and when.” The University of California said in a statement that the decision contains “a number of errors.”



Dr. Jennifer A. Doudna Ph.D. serves as Independent Director of the Company. She joined the faculty at University of California, Berkeley, as a Professor of Biochemistry & Molecular Biology in 2002. She directs the Innovative Genomics Institute, a joint UC Berkeley-UC San Francisco center, holds the Li Ka Shing Chancellor's Professorship in Biomedical and Health, and is the Chair of the Chancellor's Advisory Committee on Biology at UC Berkeley. Dr. Doudna is Principal Investigator at the Doudna Lab at UC Berkeley and has founded and serves on the Scientific Advisory Boards of Caribou Biosciences, Inc. and Intellia Therapeutics, Inc., both leading CRISPR genome engineering companies. She has been an Investigator with the Howard Hughes Medical Institute since 1997. Dr. Doudna is the recipient of numerous scientific awards in biochemistry and genetics. Dr. Doudna is a Director of Driver Inc. and a Trustee for Pomona College.

As the Independent Director of Johnson & Johnson, the total compensation of Jennifer Doudna at Johnson & Johnson is \$324,979. There are 18 executives at Johnson & Johnson getting paid more, with Alex Gorsky having the highest compensation of \$25,365,800. An assessment of CRISPR's discover and her fledgling bio-tech companies suggest her Nobel Peace Prize has attracted the kind of venture capital that only the House of Rothschild would pursue! Dr. Jennifer Doudna and Dr. Melanie Ott are collaborating in order to develop an effective method to rapidly diagnose those with COVID-19. Dr. Doudna's work has focused on CRISPR technology, while Dr. Ott has focused on studying viruses. By combining their expertise, these two scientists hope to develop a diagnostic

tool capable of delivering rapid results and usable in areas such as airports, ports of entry, and remote communities.

Doudna's co-discovery of CRISPR-Cas9 genetic engineering technology has disrupted human and agricultural genomics research. It has enabled scientists to change or remove genes quickly and with great precision. What is often overlooked in the discussion of CRISPR-Cas9, if not ignored totally, is the fact that this technology can be used to create "bioweapons" as well.

There is a dimension to all of this genetics issue of DNA few people know about and if they have heard of it they know little about it or do not understand its implications. This alludes to what is known or referred to in the Bible as spiritual warfare, In this approach to looking at this from the Biblical view of "End Times" *"As in the days of Noe!"*

Thus saith the LORD of hosts; If it be marvelous in the eyes of the remnant of this people in these days, should it also be marvelous in mine eyes? saith the LORD of hosts.

Thus saith the LORD of hosts; Behold, I will save my people from the east country, and from the west country; And I will bring them, and they shall dwell in the midst of Jerusalem: and they shall be my people, and I will be their God, in truth and in righteousness” -(Zechariah 8:2-8 KJV).

This has not been fulfilled. God’s jealousy means God doesn’t intend to let Satan have Jerusalem (Jesus was presented to God there; Jesus suffered and died at there; Jesus ascended into heaven at there; Jesus is coming back there; the Church began there, and more).

Jerusalem is where Isaiah and Jeremiah penned principles of righteousness that became the moral foundations of western civilization. While there is some disagreement about the meaning of "The Fig Tree Generation", there is no disagreement that it speaks to Israel in its final days. The passage is heavily nuanced in the Greek text but one cannot dismiss the potential for it to have multiple meanings, i.e., dual fulfillment prophecy. **What is most important is the point that Daymond Duck makes about Jerusalem.**

In previous remarks I have made concerning Satan's agenda to wipe out the Jews, Scripture identifies more than twenty specific examples of God delivering a "remnant" of the faithful.

Dr. Lee Merritt and Dr. Zev Zelenko raised a point that the Ashkenazi Jews were "immune" to Covid-19. The nation of Israel today is largely of the Ashkenazi sect. We think about it as an operating system."*

Scientists are rewriting the code of life with a new technology that promises to cure inherited diseases by precisely correcting genetic typos. Known as base editing, the technology empowers researchers to pick a single letter amongst the three billion that compose the human genome, erase it, and write a new letter in its place. That it has already been used unethically became known a few years ago when a Chinese scientist used CRISPR to prevent the birth of twin daughters from ever being infected with HIV. China sentenced the young scientist to three years in prison for violating guidelines of its use. Besides being condemned by fellow researchers, his gene-editing work has created risks that will not be known for years until the twin daughters are grown. CRISPR's discovery does not offer a cure-all, and becomes a harbinger that contains many potential disasters without adhering to strict protocols required in gene editing.

Base editing is an updated version of the gene editing tool CRISPR, which has revolutionized life sciences research and is making strides in treating genetic blood and liver diseases. But some scientists think base editing, sometimes billed as CRISPR 2.0, could be safer and more precise than the original. And this summer, the sequel technology is being used in patients for the first time.

Recently the Boston biotech firm Verve Therapeutics announced that it had edited the DNA of a person with a genetic condition that causes high cholesterol and predisposes them to heart disease. The base editor is designed to tweak a gene in the liver, curtail the accumulation of cholesterol, and hopefully lower the risk of heart attacks.

Verve chief executive and cofounder Sekar Kathiresan likens the approach to *“surgery without a scalpel.”* Although the trial is focused on people with the genetic condition familial hypercholesterolemia, Kathiresan hopes that the one-and-done therapy may one day be used more broadly, to permanently reduce the risk of heart disease in millions of people with high cholesterol. *“We are completely trying to rewrite how this disease is cared for,”* he said.

Base editing is making its way into studies for other conditions as well. Earlier this year, researchers at University College London quietly began a clinical trial using base editors to engineer immune cell therapies for leukemia — likely the first time base editors were used as part of any experimental medicine. And Cambridge firm Beam Therapeutics plans to use base editors to treat people with genetic blood diseases in a trial that will launch later this year. The firm also has early stage programs for cancer, liver disease, immune disorders, and vision loss.

The powerful tool that could make all these treatments possible was first conceived by David Liu at the Broad Institute of MIT and Harvard in 2013, when he realized that CRISPR was not a panacea. **CRISPR acts like a pair of molecular scissors that cut specific sequences of DNA. While that’s useful for turning problematic genes off, it doesn’t help to fix them.**

“We really need ways to correct genes, not just disrupt them,” said Liu. *“And that’s where base editing comes in.”*

Liu’s base editors are modified versions of CRISPR that act like molecular erasers and pencils, swapping one of the four bases, or letters, of DNA for another. One version, developed by his postdoctoral researcher Alexis Komor in 2016, converts a C into a T. A second base editor, developed by his graduate student Nicole Gaudelli in 2017, changes an A into a G.

These two base editors could correct about 60 percent of all single-letter typos that cause rare genetic diseases, yet that’s not what scientists are doing first. The three clinical trials of the technology starting this year will use base editors to **intentionally create typos.**

The potential power of that strategy is clear in Verve’s clinical trial. Scientists have discovered multiple genes that raise cholesterol and increase the risk of heart attacks. People with genetic mutations in one of these genes, called PCSK9, have extremely low levels of LDL cholesterol — often called *“bad cholesterol”* —

and are “*remarkably protected against heart attack,*” Kathiresan said. “*Our idea was to develop a gene editing medicine that would mimic the natural situation.*” Verve uses base editors to introduce a mutation in the PCSK9 gene of patients with familial hypercholesterolemia. The results in monkeys have been remarkable, lowering levels of LDL cholesterol by about 70 percent after two weeks. The levels remained low for at least two years, Kathiresan said.

“This seems like a bigger effect than I would have predicted,” said Dr. Sarah de Ferranti, chief of ambulatory cardiology at Boston Children’s Hospital. *“Even if it were half as effective, I still think that would be a huge game changer.”* Whether this experiment is good or bad remains to be seen, after all, they are playing God!

It may seem that I have wandered from the picture I am presenting about the House of Rothschild popping up all over the world in various places but not so. The discovery of CRISPR and CRISPR-Cas9 is something you would want to know all about, especially if you wanted to wipe out ethnic or racial populated groups of people. The discovery of CRISPR gene-editing technology was ten years old in June, 2022. In the world of genetics, microbiology, DNA, CRISPR is a huge game changer! At the time of its announcement, most of the world knew little to nothing about CRISPR.

Statistically speaking, these few examples I have noted above as well as many others are not coincidental.

Ashkenazi Jews constitute 95% of the Jews in the world today. As Dr. Lee Merritt has noted this specific ethnic group of people are immune, meaning that they will never catch or be infected by the alleged Covid-19 virus “bioweapon”. Meanwhile, scientists around the world have applied CRISPR to cell biology and a broad spectrum of plant and animal research. Commercial food scientists are employing CRISPR technology to amplify flavors and to create disease-resistant produce. Medical scientists are pursuing treatments for sickle cell anemia, cystic

fibrosis, Huntington's disease and HIV. Other researchers have extracted blood cells from patients with cancer and blood diseases, edited the cells and returned them the patients with promising results. Editing of cells within the human body is now being tested to treat diseases of the eye and liver.

Because CRISPR technology is comparatively efficient and inexpensive, many see great danger in unregulated experimentation by unaccountable researchers. The United States Food and Drug Administration is prohibited from approving any studies that involve editing the human germline — eggs or sperm — and both China and the U.S. military have been active for decades in creating bioweapons that are race and ethnic based.

The truth about the origin of Covid-19 has been established but the world will be distracted for one reason that stands above all the others. You can use it to communicate, but at the same time, you can use it to kill ... a lot of the tests that we looked at in the scientific world focused on the 18-GHz signal and this interplays with the lipid nanoparticle [in the Covid injection].”

“The pathogens inside of the lipid nanoparticles, the ones that were created and are inside of the nanoparticles, inside of vaccinated people right now, are also chimeric. According to Callender, a broadcast from 5G cell towers at 18-GHz, for a specific duration and sequence, will cause affected cells to rupture, unleashing Marburg payload bioweapons into the blood of those who took the mRNA injections.
