

Soros-Backed Bioethics ‘Expert’ Says COVID-19 Vaccine Refusers Could Lose Jobs and Face Fines or Jail Time

A bioethics “expert” is [stating that it is perfectly legal and constitutional](#) for states to fine, imprison, or deny employment to individuals who refuse to take the COVID-19 vaccine.

“States can compel vaccinations in more or less intrusive ways,” says Dov Fox, a [Soros fellow](#) who serves as the director of the Center for Health Law Policy and Bioethics at the University of San Diego. *“They can limit access to schools or services or jobs if people don’t get vaccinated. They could force them to pay a fine or even lock them up in jail.”*

Fox cites the case of *Jacobson v. Massachusetts* (1905), in which the robed lawyers on the bench decided that Massachusetts could fine individuals who refused smallpox inoculations. This has been exploited by bureaucrats to force children who are not vaccinated out of public schools.

“Courts have found that when medical necessity requires it, the public health outweighs the individual rights and liberties at stake,” Fox says.

Fox notes that enacting vaccine mandates at the state level could have significant blowback, with large protests already being waged against restrictive quarantine policies. Just because these measures are legal does not mean they should necessarily be enacted, Fox argues.

He also makes the point that religious exemptions would not be necessary for vaccine mandates, as religious liberty is essentially no more.

“Religious exemptions are not constitutionally required by the First Amendment’s Free Exercise clause, provided that the vaccine mandates don’t single out religion; they’re not motivated by a desire to interfere with it,” Fox says.

Fox believes that the states would need to enact the vaccine mandates for them to be legally binding, as a federal mandate would likely be ruled unconstitutional. The 2012 decision on the Affordable Care Act by SCOTUS made it clear that the feds cannot lawfully compel the states into adopting such a scheme against their will, even if it were perpetrated under the guise of public safety.

Big League Politics has reported on the frenzied push for mass vaccinations while the public is still in the grips of COVID-19 mass hysteria, which has resulted in the federal “Operation Warp Speed” pharmaceutical power-grab:

President Donald Trump [has launched “Operation Warp Speed”](#) to funnel resources toward Big Pharma for the purposes of creating a vaccine shot that will be ready for mass distribution throughout the country by the end of the year.

The White House is calling this a Manhattan Project-style project that aims to get vaccines into as many people as quickly as possible, in a move that must have technocratic oligarch Bill Gates grinning ear-to-ear.

“Operation Warp Speed is clearly another extension of President Trump’s bold leadership and unwillingness to accept ‘business as usual’ approaches to addressing the COVID-19 crisis,” said Michael Caputo, who works as assistant secretary for public affairs at the Department of Health and Human Services.

The project is expected to cost the U.S. taxpayer billions of dollars, with much of that money going into the coffers of Big Pharma, and they hope to have 100 million doses ready by the end of the year. It is unclear if these vaccines would even improve the public health, as the [government’s own data](#) shows that regular influenza vaccines are only effective 40 percent of the time.

The Trump administration is working along with disgraced globalist organizations like the World Health Organization (WHO) in using the coronavirus pandemic for a vaccine push.

"We are scientists, physicians, funders and manufacturers who have come together as part of an international collaboration, coordinated by the World Health Organization (WHO), to help speed the availability of a vaccine against COVID-19," dozens of so-called experts [declared](#) in a WHO press release.

"While a vaccine for general use takes time to develop, a vaccine may ultimately be instrumental in controlling this worldwide pandemic... We will continue efforts to strengthen the unprecedented worldwide collaboration, cooperation and sharing of data already underway. We believe these efforts will help reduce inefficiencies and duplication of effort, and we will work tenaciously to increase the likelihood that one or more safe and effective vaccines will soon be made available to all," they added.

Vaccine skeptics are seeing their worst nightmare come to fruition, as the right crisis has arrived to usher in coercive mandates and destroy the freedom to choose. The President has waffled on so much that I would not count on him to keep this as a strictly voluntary acceptance by the public. The President has learned the details of issuing Executive Orders and Presidential Directives. Top U.S. health official says approval of COVID vaccines unlikely before November. Any potential COVID-19 vaccine backed by the Trump administration's "Operation Warp Speed" program is unlikely to receive a green light from regulators any earlier than November or December, given the time needed for a large-scale clinical trial, the National Institutes of Health director said on Thursday.

In a call with reporters, Francis Collins said he thinks testing a vaccine in at least 10,000 people could potentially give enough evidence of safety and efficacy to clear it for wider use. U.S. late-stage vaccine trials launched so far aim to recruit up to 30,000 people.

"I would not expect to see, on the basis of what we know scientifically, that we would be at the point where the FDA could make such a judgment until considerably later than October 1st," Collins said, referring to the U.S. Food and Drug Administration. *"Maybe November or December would be my best bet."*

He added that he is confident that at least one of the six vaccines funded by the initiative will be shown to be safe and effective by the end of the year.

President Donald Trump said last week it was possible the United States would have a coronavirus vaccine before the Nov. 3 election, a more optimistic forecast on timing than anything suggested by his own White House health experts.

Collins expects that the first tens of millions of doses of vaccine produced in the United States will be allocated to those most in need, such as patients at higher risk of complications or front line healthcare workers.

The U.S. government has helped finance the development of several vaccines and therapies through the program aimed at accelerating access to medicines to fight COVID-19.

U.S. public health officials last month charged a group of independent scientists and ethicists with developing guidelines to determine who should get the first doses of a vaccine, once one becomes available.

Nothing that the government says can be comforting or trusted when the Supreme Court Justice John Roberts double-crossed the public to rule in favor of President Obama's Health Reform Act which was ruled constitutional. The Indian government announced on August 11, 2020, plans to adopt the Bill Gates plan, which I laid out in my last three chapters of my eBook:

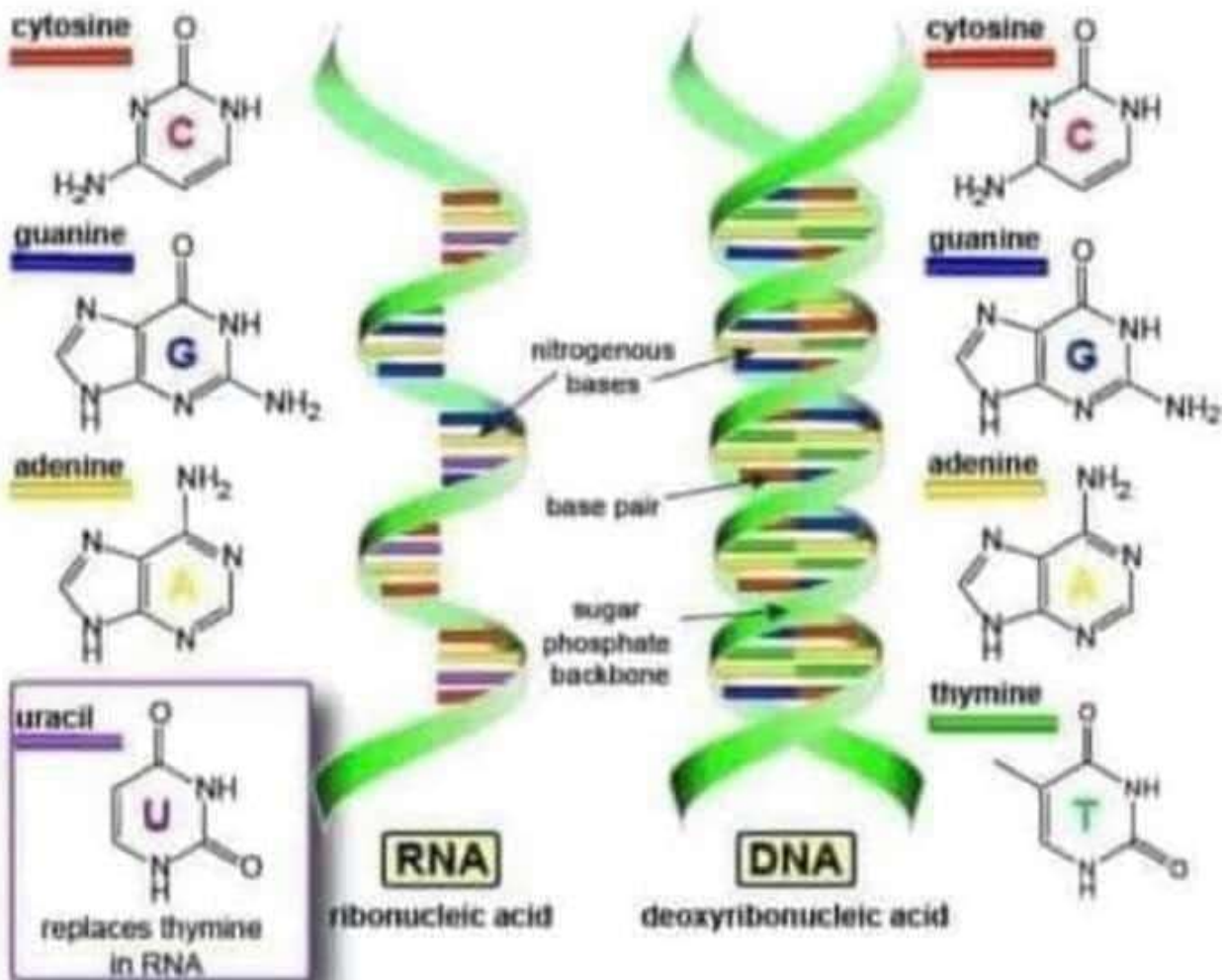
“666/999 5G, the Mark of the Beast, and the UPC Code”

One Nation One Health Card

After the 'One Nation One Ration Card' scheme, the Government is now preparing to bring 'One Nation One Health Card' scheme. Prime Minister Narendra Modi is likely to make the announcement on August 15, during the Independence Day celebrations, [reported](#) DNA.

Under the 'One Nation One Health Card' scheme, a person's medical history records, including all the treatments and tests that the person has undergone, will be digitally saved in this card.

Hospitals, clinics, and doctors will all be linked to a central server. The move is aimed at mapping the health records of every citizen of the country in a digital format. Although it is being claimed that *"it is completely up to hospitals and citizens, whether they want to opt for the 'One Nation One Health Card' scheme or not"*.

A unique ID will be issued to every citizen who opts for this card, through which he/she will be able to log in to the system. Health Card will be made on the lines of Aadhar Card, reported DNA.

The scheme will be implemented in a phase-wise manner. A budget of Rs 500 crore has been allotted for the first phase of the plan. According to DNA, *“the scope of the ‘One Nation One Health Card’ scheme will be gradually extended so that not only clinics and hospitals, but medical stores and medical insurance companies can remain connected on the server through this scheme”*.

National Digital Health Blueprint

Although the DNA report did not disclose more details about the project, the [‘blueprint’](#) of the plan to set up a health data empire in India was released by the central govt last year. Minister for Health and Family Welfare, Dr Harsh Vardhan, unveiled the ‘National Digital Health Blueprint’, saying that he was ‘taking an oath to achieve a new dream’ – of a digitized healthcare ecosystem.

In line with the vision of Hon’ble PM [@narendramodi](#) ji to create a [#DigitalIndia](#) where technology becomes an enabler for India’s development story, [@MoHFW_INDIA](#) has drafted the ‘National Digital Health Blueprint’ to provide a seamless corridor for connecting all stakeholders.

The main foundation of the blueprint is a unique health ID for citizens, with Aadhaar as a key identifier. A 2018 proposal of the NITI Aayog, the NHS has been developed in consultation with iSPIRT – an organization of private sector ‘volunteers’, some of whom have also been involved in building the Aadhaar infrastructure and running operations that leverage it.

While the government has moved ahead with sale of vehicle registration data of millions, released a tender for a nationwide facial recognition system and also passed Aadhaar amendment, the DNA Technology Bill and now the Digital Health Card, it is yet to table the data protection bill.

Lobby Group iSPIRT

Data researchers and activists, however, have expressed concerns about the development of this policy, which proposes a health data set-up on a foundation of India Stack – a bouquet of privately-owned proprietary software applications.

“The health stack was proposed by the lobby group iSPIRT,” told Srinivas Kodali, an independent researcher to [The Quint](#).

IndiaStack is a set of APIs that allows governments, businesses, startups and developers to utilize the Aadhaar infrastructure for businesses like eKYC and UPI digital payments.

“In fact it was found that NITI Aayog was emailing all consultation documents to iSPIRT while they did not place them in public domain. The Blueprint appears to give more legitimacy to stacks, which have been under criticism,” added Kodali.

WHO’s COVID-19 Surveillance Project in India

Simultaneously, the World Health Organization ([WHO](#)) [has initiated a COVID-19 Surveillance Project in India](#) in partnership with the Ministry of Health and Family Welfare. The data gathered through full-scale surveillance will be used to make future Indian strategies for containment in India.
