The US Government Is at War with Its Own Citizens

The communist plan was for a "16-year plan to overthrow the U.S.A." to a socialist-communist system but was upset when Hillary did not win the 2016 election. The FBI has responded by calling everyone "*conspiracy theorists*" That term was an old CIA-created term from the 1960s! The FBI has a long reputation of corruption at the hierarchy level, going back to J. Edgar Hoover.

Jonathan Turley posted a report stating "*When the FBI Attacks Critics As "Conspiracy Theorists", It's Time to Reform the Bureau!*" Constitutional lawyer Turley said there is a need for a new "Church Committee" to investigate and reform the Federal Bureau of Investigation (FBI) after years of scandals involving alleged political bias. In response to criticism over its role in Twitter's censorship system, the FBI lashed out against critics as "*conspiracy theorists*" spreading disinformation. However, it still refuses to supply

new information on other companies, beyond Twitter, that it has paid to engage in censorship. House Republicans have located Emails and text messages implicating Nancy Pelosi in the security stand-down on January 6th, 2020.

In the face of the overwhelming proof that members of the FBI betrayed their oaths of office and violated the most fundamental Constitutional right of the people who pay their salaries to uphold that right, the FBI's response to these Twitter-files revelations is to continue to gaslight the public.

On Wednesday before Christmas, 2022, the FBI issued a statement in which it accused the Twitter-files journalists of being "conspiracy theorists" trying to "discredit the agency". I'll bet that next the FBI designates them as "White Supremacist Domestic Terrorists".

The Twitter-files show that FBI has been Hell-bent on controlling Twitter, its users and their information that they paid Twitter \$3.4 million in tax dollars to censor, suspend and harass those who merely wanted to share the truth.



In response to these revelations, the FBI announced:

"The correspondence between the FBI and Twitter show nothing more than examples of our traditional, longstanding and ongoing federal government and private sector engagements, which involve numerous companies over multiple sectors and industries.

As evidenced in the correspondence, the FBI provides critical information to the private sector in an effort to allow them to protect themselves and their customers. The men and women of the FBI work every day to protect the American public. It is unfortunate that conspiracy theorists and others are feeding the American public misinformation with the sole purpose of attempting to discredit the agency."

How, exactly, is quoting what they said a conspiracy theory?

Kash Patel's response to this was golden:

"Hey Elon, the FBI calling you a conspiracy theorist. Good, now's your one chance to slay the kings of disinformation: release every FBI contract with Twitter, every dollar paid to Twitter by the FBI, and every instance the FBI censored free speech with Twitter based on political targeting- you got the receipts, put em on Blast with their own arrogance."

What we're also learning from the Twitter-files is that if we were de-platformed by a social media company, it was likely not due to the caprice of a militant trans- activist working for Big Tech but because a federal agent requested it. (Same difference).

So what is one to do? Former CIA contractor, Tore Maras says that we can sue. And in so doing, we'll be supporting and providing evidence to Donald Trump's Reclaiming the Right to Free Speech platform to enact a *"Digital Bill of Rights"*, on which we reported last week.

After all, it is the brutal and unprecedented suppression of our First Amendment rights that enabled the theft of our elections and the Biden Regime's campaign of forced vaxxinations and the destruction of our health, our businesses and our economy.

In his announcement, Trump had urged House Republicans to immediately send preservation letters to the Biden Administration, the Biden campaign and every Silicon Valley Tech Giant, ordering them not to destroy evidence of censorship and Tore says that we don't need to wait for Congress. After all, We the People ARE the government and we're in the mess that we're in because we delegated our responsibilities away to our *"representatives"*, who in turn, sold us out!

Sasha Latypova is a retired pharmaceutical industry executive and one of the creators of the HowBad.Info website, where you can look up your vaxxine batch number noted on your vaxxine card and see if there are any adverse event reports associated with it.

Latypova joined Lara Logan and others to say that what we're looking at is a "government-committed atrocity". Due to the PREP Act and due to the fact that the mRNA COVID vaxx is a Top Secret DOD bioweapon and not a vaccine, there is no real legal recourse that is enforceable against the manufacturers, outside of proving that Good Manufacturing Practices were not followed.

"Good Manufacturing Practices are the law – extensive law – and they are violating it a gazillion ways and it is the only part that is enforceable. Deaths and injuries are not enforceable, because of the PREP Act and other things that exempt vaccines from any liability but they're not exempt from Good Manufacturing Practices."

Latypova also explains that the Department of Defense has not been merely acting in a support role with the implementation of the COVID-19 vaxx, by doing things like offering the USS Comfort hospital ship. She says that although this has not been adequately publicized, the DOD is in fact the "CEO of Operation Warp Speed...it is in their own internal documents, which I have – and they've been declassified now."

Instead of having the FDA, CDC and the NIH in charge of the vaxxine, the Department of Defense was in charge of the project.

"This is a fundamental shift in understanding for the public," Lara affirms.

Latypova shows us the declassified organizational chart, which clearly shows that the DOD was the Chief Operating Officer of the Project, whereas the Department of Health and Human Services was the Chief Science Advisor. The Executive Summary shows that the National Security Council, DOD and BARDA were in charge of production, distribution, clinical trials, manufacturing, legal affairs and Office of General Counsel, etc. were all controlled by the U.S. Government. I posted on December 26th her report that confirms the government is trying to kill the U.S. citizenry!

Latypova says, "This explains why when Aaron Siri was arguing in court to get the Pfizer clinical trial data released, which they wanted to hide for 75 years and who was he arguing against? Pfizer's lawyers were not even present in court. It was Department of Justice lawyers."

"And everybody was saying, 'Why are they defending Pfizer's commercial interests?' Well, that's why, because the commercial interests are not really Pfizer's, they're actually the U.S. Government's."

As someone coming from the pharmaceutical industry, Latypova says this is an extremely odd structure.

As for the regulators, they were pretending that they were doing their job but they weren't. BARDA, the Biomedical Advanced Research and Development Authority, which is responsible for the procurement and development of medical countermeasures, principally against bioterrorism was in charge of distributing money to companies like ATI, which offers illegal weapons, such as bioweapons, which are deemed legal when they are labeled as "*prototypes*" or "*experimental*", which was precisely the language of Pfizer's \$10 billion contract with BARDA.

So, between the Death Shot and the Pentagon running PSYOPs on Twitter, which was just confirmed and CENTCOM's development of ScytI software, which is used in 80% of the world's elections, plus the Omnibus Bill which just passed under the protest of a great majority of Americans, it is clear that a massive element inside every agency and branch of the U.S. Government, particularly the DOD is not only at war with its citizens but with most of the citizens of the world.

They are killing and maiming us and they are railroading us into the Central Bank Digital Currency Zero-Carbon Social Credit Slave System – and THAT is what all of this COVID Era Theater of the Absurd is about! And just as the bogus January 6th Kangaroo Committee has handed criminal referrals against Donald Trump to the DOJ, House Republicans have found proof that Nancy Pelosi's office was responsible for the security failures on January 6th, as evidence mounts that the Capitol breach was preventable.

Sam Bankman-Fried has been extradited to the U.S. from the Bahamas and is now out on \$250 million bail, which proves that using stolen funds to pay bail is OK if you're the second-largest Democrat donor. This, after claiming that he only had \$100,000 to his name.

It now emerges from the Southern District of New York that his two key business partners were pleading guilty to fraud in federal court nearly a year ago, last January but the scam was allowed to continue through the midterm elections, so that the fraudulent money could be laundered to Democrats to win elections!

The FBI Infiltration of Big Tech put the U.S. on the fast track to Neofascist Technocratic Autocracy.

The recently released sixth and seventh batches of the Twitter Files shed light on the FBI's instructions to censor specific tweets and accounts for "violating" the company's terms of service.

The internal documents also lifted the veil of secrecy on how the bureau launched an apparent damage control operation prior to the publication of the 'New York Post's' bombshell concerning Hunter Biden's laptop.

On top of that, an email by Twitter's former Deputy General Counsel Jim Baker revealed that the platform collected a staggering \$3 million from the Bureau at least on one occasion.

"My opinion – based on the evidence available – is the FBI did this because the FBI is fundamentally corrupt," Jason Goodman, a U.S. investigative journalist and founder of Crowdsourcethe Truth, told Sputnik. "Failure to investigate Hunter Biden based on the evidence on the laptop is bad enough. Evidence being revealed now by Twitter's new management suggests the FBI actively worked to protect Hunter Biden from public scrutiny and hide their own lack of enforcement action. Broad knowledge of the evidence on Hunter Biden's laptop would certainly have led to public outcry at least for further investigation. We have never witnessed such a brazen criminal act by a U.S. government agency so nakedly exposed. For the past two years, any individual who even debates these facts online loses access to the major social media platforms."

The Twitter Files exposure apparently hit the FBI's raw nerve as the bureau issued an official statement claiming that *"the men and women of the FBI"* were doing their job, while *"conspiracy theorists and others are feeding the American public misinformation with the sole purpose of attempting to discredit the agency."*

While commenting on the bureau's statement, one prominent legal expert remarked that it is not clear *"what is more chilling: the menacing role played by the FBI in Twitter's censorship program or its mendacious response to the disclosure of that role."*

How It All Began:

Make no mistake here, this started long ago, noted Jason Goodman: in fact, the groundwork was laid after September 11, 2001, with the passage of the Patriot Act.

"Prior to that, Americans were protected from undue search and seizure by the fourth amendment of the constitution," the journalist explained. "In the newfound 'war on terror' the Patriot Act was sold to the American public as increased security. But it introduced several unconstitutional new laws and new law enforcement tools that removed our constitutional protection. One such tool was the National Security Letter (NSL)."

Goodman has drawn attention to the fact that prior to the advent of NSLs, investigators needed to get a warrant from a judge and had to have probable cause supported by some kind of evidence before they could lawfully investigate a person or their property, including electronic accounts, like email or Twitter.

However, with the Patriot Act, the FBI could simply write up an NSL under the suspicion that an individual was a national security threat and launch a probe into them, according to the journalist. *“No warrant or evidence was required,”* Goodman added. Moreover, the bureau could also reject the requests of those asking for proof on the basis that the evidence would risk revealing sources and methods and was also a national security threat, according to the journalist.

“These newfound powers were quickly and consistently abused,” Goodman continued. *“Former FBI General Counsel Valerie Caproni was admonished by both the House and the Senate for gross abuses of NSLs and other unconstitutional acts.”*

However, it appears that the U.S. Congress’ attempts to rein in the bureau have not borne any fruit and the FBI has only grown more brazen in the years since.

“By alleging that the FBI was engaged in a counterintelligence investigation, they no longer had to adhere to the same rules or obey the constitutional protections that existed previously,” said Goodman. *“This is exactly how the FBI began their shambolic investigation into the so-called Russian collusion with Trump.”*

Hunter’s and Hillary’s Emails & APT28

Meanwhile, the story of the FBI’s attempts to shield Hunter Biden evokes strong memories of the Democratic National Committee (DNC) leak amid the Hillary Clinton presidential campaign. The disclosure of Hunter’s bombshell emails was downplayed and smeared as a *“hack”* and *“disinformation”* by *“Russian APT28”* just as the 2016 DNC email leak was.

According to Shellenberger, the bureau took Hunter Biden’s *“laptop from hell”* from Mac Isaac, a Delaware repair shop owner, on December 9, 2019. By August 2020, Isaac still had not heard back from the FBI, even though he had found alleged evidence of criminal activity on the device. So Isaac contacted lawyer Rudy Giuliani, *“who was under FBI surveillance at the time,”* and provided him with a copy of the laptop’s hard disk. In early October, Giuliani gave the disk to the *‘New York Post’*.

On October 13, 2020, a day before the *‘Post’* planned to release its bombshell, *“FBI Special Agent Elvis Chan sent ten documents to Twitter’s then-Head of Site Integrity Yoel Roth through Teleporter, a one-way communications channel from the FBI to Twitter,”* Shellenberger revealed citing internal Twitter documents. *On October 14, 2020,* the bombshell article saw the light of day but soon was banned and suppressed by major Silicon Valley giants, including Twitter.

But that is not all. According to Yoel Roth’s testimony, during all of 2020, the FBI warned him about the forthcoming Russian *“hack and leak”* operation *“involving Hunter Biden”* prior to the 2020 election. The bureau particularly referred to APT28, claiming that it’s a group of Russian hackers linked to Moscow’s intelligence services. In one of his recent interviews, Roth said that when Hunter’s emails finally emerged *“it set off every single one of my finely tuned APT28 hack-and-leak campaign alarm bells.”*

The “laptop from hell” posed a challenge to Hunter’s father, the Democratic presidential hopeful Joe Biden, as the bombshell suggested that the latter not only knew but also participated in his son’s murky financial schemes.

Similarly, the 2016 DNC leak threatened the Clinton campaign, demonstrating, in particular, that the party’s primaries were rigged in favor of Hillary. It was Clinton campaign lawyer Michael Sussmann who requested cyber security firm CrowdStrike’s help in investigating the alleged DNC hack.

CrowdStrike “detected” and “attributed” the alleged breach of DNC servers to Russia during the 2016 election cycle. The company claimed that the perpetrators were “two Russian espionage groups”: Cozy Bear (APT29) and Fancy Bear (APT28), suggesting with a “low” to “medium”-level of confidence that they may be affiliated with Russia’s Federal Security Service (FSB) and Main Intelligence Department (GRU), respectively. Moscow denied the claim as absurd.

For its part, the FBI relied on CrowdStrike’s conclusions, although the bureau has never physically examined the DNC servers and has only been provided with their “digital copies” instead.

According to Veteran Intelligence Professionals for Sanity (VIPS), a group of former U.S. intelligence officers working within the CIA, the FBI and the NSA, there had been no hack: it was an inside job. Moreover, CrowdStrike President Shawn Henry admitted under oath in 2017 that the company does not have “concrete evidence” that the alleged “Russian hackers” exfiltrated any data from the servers.

The story of the DNC “hack” played a big role in smearing Russia and linking Donald Trump to Moscow. The Dems claimed that Moscow “hacked” the emails to help Trump win the 2016 elections. In the summer 2016, the FBI launched Operation Crossfire Hurricane on the pretext of alleged “collusion” between Trump and the Kremlin. However, Special Counsel Robert Mueller investigation found no evidence to back the allegations, which were rubbished by Moscow from the very start as nonsensical.

“The true origin of the Russiagate hoax has not yet been revealed but it is becoming increasingly clear that top executives in the FBI have been involved in an ongoing cover-up for a very long time,” said Jason Goodman. “APT28 is likely a concoction of Dmitri Alperovitch’s Crowdstrike, which itself is an obvious FBI cutout. Crowdstrike co-founder Shawn Henry left the FBI to create the company, then shortly thereafter received \$150 million from Google. Sounds fair enough but think about that for a moment. Google cannot easily hand \$150 million to the FBI, but they can invest whatever they want in a startup tech company.”

It is not clear if the U.S. public understands the legal games the FBI can play, according to the journalist.

"The FBI's infiltration of Twitter is the tippy top of tip of the upper edge of the tip of the iceberg," Goodman remarked. "We need to understand just how many private companies and non-profit organizations are secretly working with or for the incredibly dangerous and subversive U.S. 'Intelligence' community. This hidden-in-plain-sight network of government agencies, non-profit organizations, and private industry is what is spoken of as the 'Deep State'."

Operation Mockingbird and Church Committee

The FBI's attempts to control and infiltrate the work of social media giants resembles nothing so much as the U.S. intelligence Operation Mockingbird which was first mentioned by CIA Director William Colby during his briefing to the Justice Department on December 31, 1974.

Later, the issue was touched upon by Watergate reporter Carl Bernstein in *'Rolling Stone'* in 1977. Bernstein revealed how numerous journalists, including Pulitzer-prize winners, wrote fake stories and disseminated propaganda at the CIA's behest during the Cold War. The scale of the CIA's huge international media network was described by one CIA official as ranging from Radio Free Europe to a third-string guy in Quito who could get something in the local paper. According to the U.S. mainstream press, the program has never been officially discontinued.

"It is essentially an extension of Operation Mockingbird," Jason Goodman said about the U.S. intelligence community's collusion with Big Tech. "The revelations of the Church Committee showed us the CIA's intention. There is no reason to believe they would change. We see these 'retired' intelligence people on the news all the time. It should be obvious to anyone looking at the evidence if the FBI or any law enforcement or intelligence agency is doing anything other than tracking dangerous criminals on Twitter, they should not be doing it."

The Church Committee was a U.S. Senate select committee that investigated abuses by the CIA, NSA, FBI, and IRS in 1975. Presently, it's not a matter of the FBI getting away with what it has done (they already have), this is *"an inflection point like none other in American history,"* according to the journalist.

"We are in a dangerous moment," Goodman warned. "The United States has become a neofascist technocratic autocracy. The new Congress must take bold steps to shut this down immediately and begin the journey back to the constitutional republic that was established in 1776 or it will only get worse (...) Another thing the Patriot Act created that most people are not aware of is the National Cyber Investigative Joint Task Force. It is an interagency intelligence-sharing operation overseen by the FBI. Critics say it eliminates the compartmentalization that is in place to prevent the types of abuses that are commonplace today. Without oversight, who knows what these interagency operations are capable of."

Barack Obama and Hillary Clinton have been planning the disarmament of the United States for 16 years. It is now in full force moving fast with the help of our young people.

Seeing it again a few years later, it's clear that it's real and that various things that were supposed to be implemented under Hillary Clinton have been achieved, instead under Trump and Biden, including the destruction and censorship of opposing news outlets, a "Population Control Mass Extinction Event", in which "billions of dollars" would be "pocketed", open borders (i.e., an endless supply of Democrat voters) and the deliberate destruction of the economy to starve and enslave the public:

An Obama Scandal does exist: Former President Obama and his political supporters have repeatedly stated that his administration was scandal-free, unlike administrations before and after. *“We’re probably the first administration in modern history that hasn’t had a major scandal in the White House,”* Obama himself said.

Never mind that the left-leaning big media basically ignored major scandals during the Obama years, ranging from the IRS targeting scandal and the VA's deadly waiting lists for veterans to Hillary Clinton's illegal use of an unsecured, hackable home-brew server for her official duties as Secretary of State and the Fast and Furious gunwalking program tied to Barack Obama’s former Attorney General Eric Holder.

These and others were epic scandals that the media simply ignored or downplayed. Keep in mind that the media is largely owned and controlled by the House of Rothchild and their lack of trust comes as no surprise. Even FOX is not fair and balanced, yet tries to make people believe they are. It simply is a ruse to deceive.

The media have contrasted Obama's supposed honesty and forthrightness with President Trump's supposed venality and political unscrupulousness, as embodied in the year-and-a-half long Russia-Trump scandal investigation that shows few signs of letting up.

But now comes Peter Schweizer's new book, "[Secret Empires: How Our Politicians Hide Corruption and Enrich Their Families and Friends](#)," which shows that the Obama administration and its cronies were up to their necks in questionable business deals and may even have intentionally distorted public policy to accommodate their own profit-making.

The book claims *"Obama and his administration would deem industries either destructive to the environment or exploitative for the financial and professional gain of his friends, including industries such as coal mining, offshore drilling, cash advance companies, and for-profit colleges,"* wrote Katelyn Caralle of the 'Washington Examiner'.

Schweizer's book, based on extensive research, says that Obama acted to regulate certain industries in such a way that the regulations lowered the value of some of the companies, [wrote Katelyn Caralle of the Washington Examiner](#). These actions let two family friends to profit handsomely on deals through their own investment firm.

Here's how it worked: Obama buddies Marty Nesbitt and Harreld Kirkpatrick III formed a private equity investment firm called Vistria, right around the time Obama was re-elected in 2012.

Nothing wrong with that, except, as Schweizer notes in his book, *"A curious pattern began to emerge. Obama and his administration would attack industries with government power, which led to substantially lower valuations for these companies. Nesbitt and Vistria, or others close to Obama, could then acquire those assets for pennies on the dollar."*

As an example, Schweizer cites the case of for-profit higher education schools like University of Phoenix, ITT Technical Institute, and DeVry University. In 2013, Obama blamed the schools for taking advantage of students by saddling them with massive amounts of student debt, ruining their credit and making a profit on it. He ordered the Federal Trade Commission to go after them.

In the case of the University of Phoenix, its parent Apollo Education Group was suspended after a Federal Trade Commission investigation in 2015. The following year,

three companies, including Vistria, swooped in to buy what remained of Apollo at a price 90% below its share price before the investigation.

As Vistria's education investment portfolio bulged, a number of Obama Education Department officials, including Secretary of Education Arne Duncan, ended up taking high-level jobs with Vistria.

That's just one example. There are many others.

Schweizer noted in his book, for instance, that both Vice President Joe Biden and Secretary of State John Kerry were deeply involved in trade and security talks with China even as that country began its aggressive campaign to expand its military and physical presence in the South China Sea. Contrary to standard diplomatic practice, however, both played "good cop," not seriously confronting China on its misbehavior.

Remember, Biden and Kerry were close friends from their years spent together in the Senate. So there was little surprise when Biden's son, Hunter, and Kerry's stepson, Christopher Heinz, one of the heirs to the Heinz ketchup fortune, went into business together in 2009.

They created a number of equity and real estate investment firms allied to Rosemont Capital, *"the alternative investment fund of the Heinz Family Office."*

So far so good. Except, *"Over the next seven years, as both Joe Biden and John Kerry negotiated sensitive and high-stakes deals with foreign governments, Rosemont entities secured a series of exclusive deals with those same foreign governments."*

In December of 2013, for instance, Biden traveled to China for talks. He brought Hunter Biden along. While there, the senior Biden soft-pedaled China's clear aggression, and played up the bilateral trade partnership. Ten days after the trip concluded, China's central bank, the Bank of China, set up a \$1 billion investment joint venture called Bohai Harvest RST. For the record, the "RS" referred to Biden's son's firm, Rosemont Seneca. That's questionable enough.

But months later, in July 2014, Secretary of State John Kerry traveled to China, also for talks. Kerry talked little of China's clear aggression, but did conspicuously note that *"China and the United States represent the greatest economic alliance trading partnership in the history of humankind."*

He should know. In the ensuing months, Chinese government-linked firms took major stakes in several of the firms owned or controlled by Hunter Biden and Chris Heinz, and provided them with massive funding totaling billions of dollars. Nor is this the only scandal involving John Kerry.

And this just scratches the surface. The book is a catalog, a virtual roadmap, to the way corrupt business gets done in Washington — and why Americans are smart to question why their representative go to Washington as paupers, and return as millionaires.

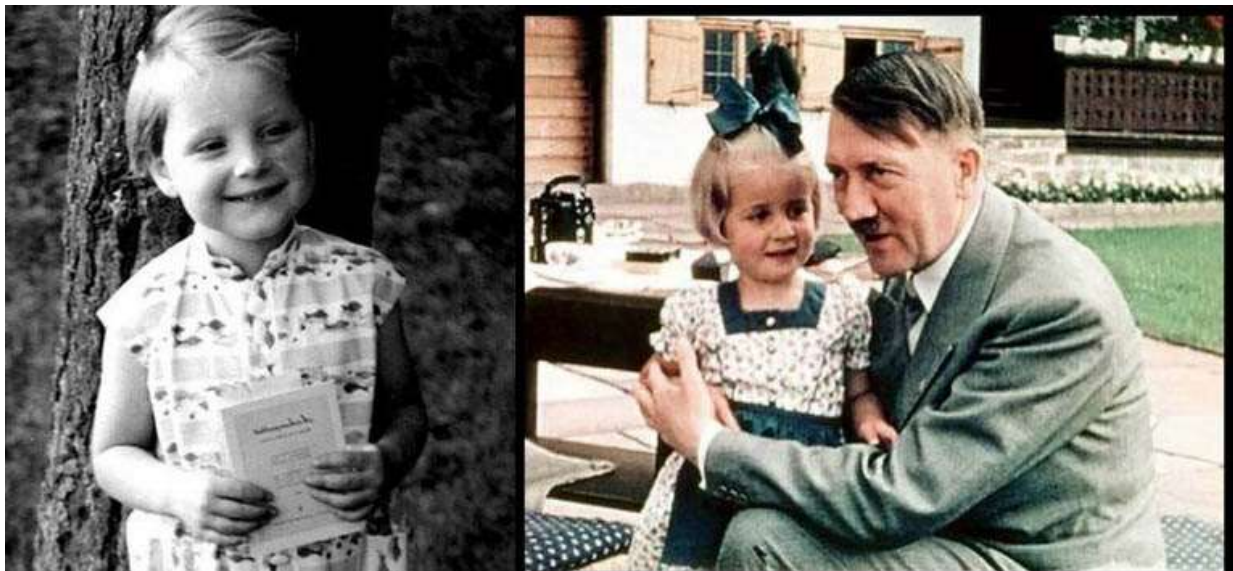

“The Stasi File According to the Stasi GDR File, the daughter of Hitler is now or was holding the same office as her father – Chancellor of Germany.”

She is said to be still one of the most powerful human beings on Earth since she was also the President of the European Union (EU) and head of the powerful Western Economic Block known as the G-8. More concerning is that Hitler's dream of uniting Europe under German/Vatican control was within his daughter's reach. I might add that her replacement was Olaf Scholz who had been Merkel's Vice Chancellor until 2021.



In 1954, a child was born, a baby girl, whom the Stasi File identifies as Angela Merkel, today's Chancellor of Germany. Her official birthday is July 17, 1954. However, the Stasi file which is currently in the Soviet KGB archives, records her birth as April 20, 1954. If this secret police citizen's file in the Ministerium für Staatssicherheit (GDR) is correct, then Hitler's daughter, Angela Merkel, was born on Adolph Hitler's birthday – April 20.

HITLER'S FROZEN SPERM

Angela Merkel's birth, as detailed in the East German Stasi file, was based on the research of the German Doctor Karl Klauberg. Dr. Klauberg was classified as one of the worst Nazi 'Angel of Death' doctors and was convicted by the Soviet Courts as a 'war criminal'. According to the reports, Doctor Klauberg was released by the Soviets after serving only seven years of his sentence in return for turning over to the KGB his hidden files on his Nazi artificial insemination experiments and, more horrifically, the frozen sperm of the former Nazi Dictator, Adolf Hitler.

Hitler's father, who took the name Hitler, was the illegitimate son of Solomon Rothschild's mistress Anna Maria Schicklgruber. Upon receipt of the Nazi files on artificial insemination, along with Hitler's frozen sperm, the Soviet Politicheskoye Buro (Politburo) authorized the experiments to 'resurrect', 'if possible', a child bearing the 'genetic markers' of Adolph Hitler. It was 'reasoned' that the combining of the genes between Hitler's sperm and Eva Braun's closest family would produce for the Soviets a 'near match' of what a child of Hitler and Eva Braun would have been, should one have been born...

Doctor Klauberg brought Gretl Braun to the GDR (Communist East Germany). She was the youngest sister of Hitler's wife, Eva Braun. Gretl Braun was chosen as the 'surrogate' mother of Hitler's offspring using artificial insemination from Hitler's frozen sperm. Gretl Braun was a member of the Social Democratic Party (SPD), whose ideology centered on the principles of Marxism and the interests of the working class and trade unions.

When Doctor Klauberg returned to West Germany, he was promptly imprisoned. He was murdered two years later while still in custody.

FALSE IDENTITY

Soon after the birth of Hitler's baby girl, an agreement between the Soviets, the Americans and the Vatican was arranged. Hitler's baby was placed under the 'control' of the Catholic Church through its 'connections' with the GDR Lutheran Church which took custody of the baby.

She was given a false date of birth, July 17, and the name Angela Dorothea Kasner, daughter of Horst Kasner, a Lutheran pastor, and his wife, Herlind – an English and Latin teacher. There in the countryside at Templin in East Germany, Merkel was raised about 50 miles north of Berlin, the capital of the socialist German Democratic Republic (GDR).

The central theme of the "agreement" of the Western Allied Powers, the Vatican, and the Soviets was that Hitler's daughter would be elevated to international power...but her ascendancy to power would not come until "the Vatican also brought to power a "German Pope". That man is known as Pope Benedict XVI who is reported to be in failing health at the age of 95.

In the wake of the death of Pope John Paul II, the former German Nazi Joseph Ratzinger was nominated. He took the name of Pope Benedict XVI on April 20, 2005, as Vicar of Rome. **Is it a coincidence that this date was the anniversary of Adolf Hitler's birthday?**

In 1977, Angela Dorothea Kasner became Angela Merkel with her marriage to physicist Ulrich Merkel, but the marriage ended in divorce in 1982.

She was elected Chancellor of Germany shortly after Pope Ratzinger assumed the Leadership of the Roman Catholic Church on Hitler's birthday.

MERKEL'S BIOGRAPHY

Merkel didn't enter politics until the age of 35 after the collapse of the Berlin Wall in 1990. She has been reluctant to discuss her past and private life. Her biography stops short of suggesting that her father worked for the Stasi, the notorious East German secret police. But it says his pro-regime attitude helped Angela's career – allowing her to study at an elite school, and go on to university, at a time when the children of clergy were routinely refused admission.

Very few people doubt that the man who raised Merkel and is known to the world as her father – was also a Stasi spy and part-time organizer. (The German chancellor herself was an active Gruppenfuherin in the FDJ.)

The teenage Merkel, like virtually all of her contemporaries, joined the Freie Deutsche Jugend (FDJ), the communist youth organization.

They say birds of a feather flock together, but there's Merkel with a group of skinheads dating from 1992 or 1993. One of the people in the photos performs a Nazi salute in the presence of a younger Merkel. At the time, no one thought anything of it but the photos were given a new significance years later.

If the Soviet record is true, and the evidence is strong, it opens up some amazing possibilities. The undeniable fact is that Angela Merkel came from obscurity to power as German Chancellor, President of the European Union, and head of the powerful G-8 economic cartel.

In an interview with the newspaper Frankfurter Allgemeine Zeitung in July 2005, Chancellor Angela Merkel admitted to an unusual obsession with the works of composer Richard Wagner, who was a Satanist. Wagner wrote the infamous composition called "*Parsifal*", which was a favorite of Adolf Hitler as well.

Hitler stated that the music of Wagner occupied his mind. Like Adolf Hitler, Angela Merkel is deeply fascinated with Wagner's "*Ride of the Valkyries*". The Valkyries were minor female deities that would ride through every battle to gather the most valiant of the slain and carry them off to a place called Valhalla where they would wait to join the army of Odin in the last battle at the end of the world.

Except for the little moustache, Merkel has a striking resemblance to Adolph Hitler. She is also a dead ringer for her mother – Gretl Braun.

“Adolf’s father, Alois Hitler, was the illegitimate son of Maria Anna Schicklgruber.

It was generally supposed that the father of Alois Hitler (Schicklgruber) was Johann Georg Hiedler. There are some people who seriously doubt that Johann Georg Hiedler was the father of Alois... (an Austrian document was) prepared that proved Maria Anna Schicklgruber was living in Vienna at the time she conceived.

At that time she was employed as a servant in the home of Baron Rothschild. As soon as the family discovered her pregnancy she was sent back home... where Alois was later born.

Langer’s information came from the high level Gestapo officer, Hansjurgen Koehler, published in 1940, under the title *‘Inside the Gestapo’*. He writes about the investigations into Hitler’s background carried out by the Austrian Chancellor, Dolfuss, in the family files of Hitler. Koehler actually viewed a copy of the Dolfuss documents which were given to him by Heydrich, the overlord of the Nazi Secret Service. The file, he wrote, *“caused such havoc as no file in the world ever caused before”* (*‘Inside the Gestapo’*, p 143).

He also revealed that:

“..The second bundle in the blue file contained the documents collected by Dolfuss. The small statured, but big-hearted Austrian Chancellor must have known by such a personal file he might be able to check mate Hitler...His task was not difficult; as ruler of Austria he could easily find out about the personal data and family of Adolf Hitler, who had been born on Austrian soil...

Through the original birth certificates, police registration cards, protocols, etc., all contained in the original file, the Austrian Chancellor succeeded in piecing together the disjointed parts of the puzzle, creating a more or less logical entity.

A little servant girl... (Hitler’s grandmother)... came to Vienna and became a domestic servant, mostly working for rather rich families. But she was unlucky; having been seduced, she was about to bear a child. She went home to her village for her confinement...

Where was the little maid serving in Vienna? This was not a very difficult problem. Very early Vienna had instituted the system of compulsory police registration. Both servants and the employers were exposed to heavy fines if they neglected this duty. Chancellor Dolfuss managed to discover the registration card.

The little, innocent maid had been a servant at the...Rothschild mansion. ..and Hitler's unknown grandfather must be probably looked for in this magnificent house. The Dolfuss file stopped at this statement."

Was Hitler's determination to take over Austria anything to do with his desire to destroy records of his lineage? A correspondent who has extensively researched this subject writes:

"It appears to me that Hitler knew about his connection long before his Chancellorship. Like his father before him, when the going got rough, the Hitler's went to Vienna.

The village of Linz, Austria was Adolph Hitler's home town. When he invaded Austria, he first went directly to Linz, seeking to get his birth certificate and related documents that revealed his roots.

Hitler's father left his home village at an early age to seek his fortune in Vienna. When Hitler was orphaned, after his mother died in December of 1907, he left for Vienna not long after the funeral.

There he seemed to drop out of sight for ten months! What happened during this ten-month stay in Vienna is a complete mystery on which history sheds no light.

It makes sense, now that it has become established that Hitler was a Rothschild, that he and his cousins were getting acquainted, and his potential for future family endeavors was being sized up".

Greg Hallet, author of the 2006 title, *'Hitler Was A British Agent'* wrote what is likely the most comprehensive and honest Hitler biography to date, and offering a whole new and unique look at all the surroundings of Adolf Hitler's rise to power. The author uses the personal assistance of a Spymaster in marshalling much new material surrounding Hitler's origins, his sexuality, and his British Training, long hidden by a conspiracy of British and American political leaders. And Hitler's grandmother, a young girl working under the same roof would not have been the subject of Salomon's desire? And this same girl became pregnant while working there?

And her grandson becomes the Chancellor of Germany, funded by the Rothschild's, and he started the Second World War which was so vital to the Rothschild-Illuminati agenda to control the world?

British journalist Gerrard Williams told 'Sky News' he and co-author Simon Dunstan found an *"overwhelming amount of evidence"* to suggest Hitler died an old man in South America. Most historians say the Nazi leader died in his Berlin bunker in 1945, but Mr. Williams claims their research, looking at newly declassified documents and forensic tests, challenges this.

"We didn't want to rewrite history, but the evidence we've discovered about the escape of Adolf Hitler is just too overwhelming to ignore," he said.

"There is no forensic evidence for his, or Eva Braun's death, and the stories from the eyewitnesses to their continued survival in Argentina are compelling."

'Grey Wolf: The Escape of Adolf Hitler' claims the Fuhrer and his mistress Eva Braun were secretly flown out of Germany in April 1945 and taken to fascist-controlled Argentina through several stages of movement by air, submarine, and boat delivery.

It is alleged Hitler lived in the country for 17 years until his death in 1962. The book also accuses U.S. intelligence of being complicit in the scam in return for access to Nazi war technology.

"Stalin, Eisenhower and Hoover of the FBI all knew there was no proof of him dying in the bunker," Mr. Williams told 'Sky News'. "It's difficult to understand why so much of the already published material we present in the book has been ignored over the years." He added that the book's new findings prove the "Hitler" skull fragments held by Russia are actually that of a young woman.

Mr. Williams said he and Mr. Dunstan conducted intensive field research in Argentina, including interviews with many eyewitnesses to Hitler's presence there. The film *"Grey Wolf"* was released in January 2012.

Adolf Hitler with his toddler daughter, Ann Eva Braun, his wife, and their daughter Ann who had been born in 1942, accompanied Hitler to Argentina. While in Argentina Eva and Adolf had at least 1 more "daughter" who was taken to Germany to be raised in the "motherland" by a Lutheran pastor. The one hard to miss is Angela Merkle (possibly born male – 1954). She was Prime Minister of Germany from 2005 until 2021.

It is at this point in time when this strange scenario become really interesting in the history of Eva Braun and become cloaked in the greatest secrecy possible by the CIA and FBI.

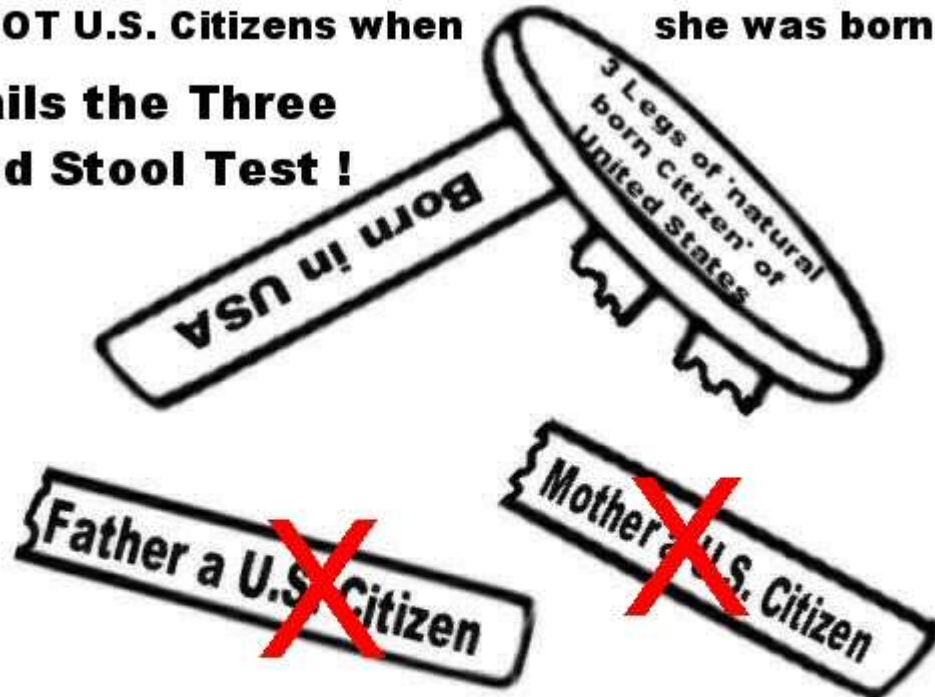

But getting back to Barack Obama, he was never forthcoming with his long-form birth certificate, and nearly all of the documents related to his background were sealed from judicial review. Dr. Corsi exposed in detail key issues with Obama's eligibility, including the fact the President has spent millions of dollars in legal fees to avoid providing the American people with something as simple as a long-form birth certificate. Davis, who is now deceased, was an African American from the Midwest who had worked as a columnist for the *'Chicago Star'*, the communist newspaper of Chicago, a city that had one of the largest CPUSA affiliates, and, in fact, hosted the September 1919 convention that launched the American Communist Party. Though Davis always tried to conceal any communist associations — ironically, Obama supporters have picked up that torch — there's no question that Davis was a communist, as is immediately evident upon reading his columns, examining his background, or consulting with people in the party (to this day) who confirm he was a communist. In 1948, Davis just happened to arrive in Hawaii the same time that leaders of the Communist Party in Hawaii — realizing the limits of national party organs like the *'Daily Worker'* and *'People's Daily World'* — established their own weekly newspaper, the *'Honolulu Record'*. In 1949, Davis began writing a regular column for the *'Record'*, titled, *"Frankly Speaking."* This was a key form of agitation work that Davis would do for the party in Hawaii for decades.

Communist Frank Marshal Davis is who Barrack Obama was writing about in *'Dreams From My Father'*.

In the video by the same title we see how the current Barrack Obama is a Natural Born Citizen, if his real Father's name was on his Original Birth Certificate, Frank Marshall Davis – FMD.

Obama And His Grandpa Hitler Are Both Rothschild's

I. Alois Hitler, father of Adolf, was the illegitimate son of Maria Anna Schicklgruber and Baron Rothschild.

The planning of the Second World War started when Adolf Hitler joined a secret society called the Thule Society in 1919. It was in this group that he found the perverted beliefs that were later to lead him in his control of the German government.

In the Thule Society the sun played a prime role, as a sacred symbol of the Aryans. In addition to sun worship, the Thule Society also practiced Satan worship:

"The inner core within the Thule Society were all Satanists who practiced Black Magic."

Adolf Rothschild Hitler

The Society was not a working-man's group as it included amongst its members:

"judges, police-chiefs, barristers, lawyers, university professors and lecturers, aristocratic families, leading industrialists, surgeons, physicians, scientists, as well as a host of rich and influential bourgeois."

The membership of the Thule Society also became the foundation of the Nazi Party: *"the Committee and the forty original members of the New German Workers' Party were all drawn from the most powerful occult society in Germany—the Thule Society."*

One of the founders of both groups, the Nazi Party and the Thule Society, was Dietrich Eckart: *"a dedicated Satanist, the supreme adept of the arts and rituals of Black Magic and the central figure in a powerful and wide-spread circle of occultists — the Thule Group. (He was) one of the seven founder members of the Nazi Party."*

Eckart claimed to be the initiator of Hitler into the secrets of Satan worship. He is quoted as saying on his deathbed: *"Follow Hitler. He will dance, but it is I who have called the tune!"*

I have initiated him into the 'Secret Doctrine'; opened his centres in vision and given him the means to communicate with 'the Powers'." (I wonder who were 'the Powers', Eckart referred to).

But it was not just the Thule Society that gave Hitler the support he needed to become the leader of the German government. There were additional sources of Hitler's strength.

One who offered an explanation of Hitler's easy rise to power was Walter Langer, a noted psychoanalyst. Langer wrote in his book *'The Mind of Adolf Hitler'* that it was his theory that Hitler was the grandson of Baron Rothschild.

He wrote:

"There is a great deal of confusion in studying Hitler's family tree. Adolf's father, Alois Hitler, was the illegitimate son of Maria Anna Schicklgruber. It was generally supposed that the father of Alois Hitler was Johann Georg Hiedler.... Alois, however, was not legitimized, and he bore his mother's name until he was forty years of age when he changed it to Hitler.

A peculiar series of events, prior to Hitler's birth, furnishes plenty of food for speculation. There are some people who seriously doubt that Johann Georg Hiedler was the father of Alois. Thyssen and Koehler, for example, claim that Chancellor Dolfuss (the Chancellor of Austria) had ordered the Austrian police to conduct a thorough investigation into the Hitler family. As a result of this investigation a secret document was prepared that proved Maria Anna Schicklgruber was living in Vienna at the time she conceived.

At that time she was employed as a servant in the home of Baron Rothschild. As soon as the family discovered her pregnancy she was sent back to her home in Spital where Alois was born."

When Hitler discovered that he was related to the Rothschild's, he re-established contact with the family. This probably explains the enormous support he received from the international banking fraternity, secretly owned by the Rothschild's and Rockefellers. The Rockefeller family is basically owned by the Rothschild's, who made them their wealth and power.

Hitler began World War II by attacking Austria. It has been theorized that he moved into this country for two reasons.

First, he wanted to silence Dolfuss who Hitler believed knew that he was a descendant of the Rothschild's, and secondly, he wished to remove all traces of his ancestry from the Austrian records in Linz, Austria.

II. Was Hitler a Rothschild?

Official history is merely a veil to hide the truth of what really happened. When the veil is lifted, again and again we see that not only is the official version not true, it is often 100% wrong.

Take the Rothschild's, the bloodline formerly known, among other names, as the Bauer's, one of the most notorious black occult bloodlines of Middle Ages Germany.

One year they gave it to Morris Dalitz, an intimate of the notorious Meyer Lansky crime syndicate which terrorized America. Perfect choice!

Of course, the strength of feeling that fans the flames of condemnation against anyone dubbed “*anti-semitic*” today is the sickening persecution of Jewish people by the Nazis of Adolf Hitler.

Paul Warburg, who manipulated into existence the privately-owned “central bank” of America, the Federal Reserve, in 1913, was on the board of American I.G.

Indeed Hitler’s I.G. Farben, which ran the slave labor camp at Auschwitz, was, in reality, a division of Standard Oil, officially owned by the Rockefeller’s, but in truth the Rockefeller empire was funded into existence by...the Rothschild’s.

See ‘*And The Truth Shall Set You Free*’ and ‘*The Biggest Secret*’ for the detailed background of this and other aspects of this story.

The Rothschild's also owned the German news agencies during both World Wars and thus controlled the flow of "information" to Germans and the outside world.

Incidentally, when Allied troops entered Germany they found that the I.G. Farben factories, the very core of Hitler's war operation, had not been hit by the mass bombing and neither had Ford factories – another Illuminati supporter of Hitler. Other factories nearby had been demolished by bombing raids.

So the force behind Adolf Hitler, on behalf of the Illuminati, was the House of Rothschild, this "Jewish" bloodline which claims to support and protect the Jewish faith and people. In fact they use and sickeningly abuse the Jewish people for their own horrific ends.

The Rothschild's, like the Illuminati in general, treat the mass of the Jewish people with utter contempt. They are, like the rest of the global population, just cattle to be used to advance the agenda of global control and mastery by a network of interbreeding bloodlines, impregnated with a reptilian genetic code, and known to researchers as the Illuminati.

Indeed, the Illuminati are so utterly obsessed with bloodline, because of this reptilian genetic code, that there was no way that someone like Hitler would come to power in those vital circumstances for the Illuminati, unless he was of the reptilian bloodline.

If you look elsewhere on this website you will see how the same bloodline has held the positions of royal, aristocratic, financial, political, military, and media power in the world for literally thousands of years.

This is the bloodline that has produced ALL 42 of the Presidents of the United States since and including George Washington in 1789. It was the bloodline of the runaway favorite to win the 2000 election, George W. Bush. Bush Senior's real name is George H. Scherff, Jr. But that is another story of its own to deal with in Part 3!

The World War Two leaders, Roosevelt, Churchill, and Stalin, were of the bloodline and also Freemasons and Satanists. They were manipulated into office, and their country's war effort funded, by the Rothschild's and the other Illuminati bloodlines.

So are we to believe, therefore, that although this same group provably funded Adolf Hitler's rise to power and his war machine that he would be the odd one out, a leader of crucial importance to the agenda who was NOT bloodline?

But hold on. Hitler couldn't be the same bloodline as, say, the Rothschild's because, as we all know, the Rothschild's are defenders of Jewish people and Hitler slaughtered them, along with communists and gypsies and others who opposed him or he wanted to eliminate. The Rothschild's are Jewish, they'd never do that.

Oh, really?!

According to a book by a psychoanalyst, Walter Langer, called *'The Mind of Hitler'*, not only was Hitler supported by the Rothschild's, he WAS a Rothschild. This revelation fits like a glove with the actions of the Rothschild's and other Illuminati bloodlines in Germany who brought Hitler to the fore as dictator of that nation.

He was also supported by the British Royal Family, the House of Windsor (in truth the German House of Saxe-Coburg-Gotha), and these included the British royal "war hero", Lord Mountbatten, a Rothschild and a Satanist.

Their royal relatives in Germany, who you would never have thought would normally support an apparent guy from the street like Hitler, were among his most enthusiastic supporters. But, of course, they knew who he really was. There is no way in the world when you do any study of the Illuminati obsession with bloodline that Hitler would not have been one of them.

Langer writes:

"Adolf's father, Alois Hitler, was the illegitimate son of Maria Anna Schicklgruber. It was generally supposed that the father of Alois Hitler (Schicklgruber) was Johann Georg Hiedler. There are some people who seriously doubt that Johann Georg Hiedler was the father of Alois... (an Austrian document was) prepared that proved Maria Anna Schicklgruber was living in Vienna at the time she conceived. At that time she was employed as a servant in the home of Baron Rothschild. As soon as the family discovered her pregnancy she was sent back home... where Alois was born."

Langer's information came from the high level Gestapo officer, Hansjürgen Koehler, published in 1940, under the title *"Inside the Gestapo"*. He writes about the investigations into Hitler's background carried out by the Austrian Chancellor, Dolfuss, in the family files of Hitler.

Koehler actually viewed a copy of the Dolfuss documents which were given to him by Heydrich, the overlord of the Nazi Secret Service. The file, he wrote, *"caused such havoc as no file in the world ever caused before"* (Inside the Gestapo, p 143).

He also revealed that:

"..The second bundle in the blue file contained the documents collected by Dolfuss. The small statured, but big-hearted Austrian Chancellor must have known by such a personal file he might be able to check Hitler...His task was not difficult; as ruler of Austria he could easily find out about the personal data and family of Adolf Hitler, who had been born on Austrian soil... Through the original birth certificates, police registration cards, protocols, etc., all contained in the original file, the Austrian Chancellor succeeded in piecing together the disjointed parts of the puzzle, creating a more or less logical entity."

A little servant girl... (Hitler's grandmother)... came to Vienna and became a domestic servant, mostly working for rather rich families. But she was unlucky; having been seduced, she was about to bear a child. She went home to her village for her confinement... Where was the little maid serving in Vienna? This was not a very difficult problem.

Very early Vienna had instituted the system of compulsory police registration. Both servants and the employers were exposed to heavy fines if they neglected this duty. Chancellor Dolfuss managed to discover the registration card. The little, innocent maid had been a servant at the...Rothschild mansion. ..and Hitler's unknown grandfather must be probably looked for in this magnificent house. The Dolfuss file stopped at this statement."

Was Hitler's determination to take over Austria anything to do with his desire to destroy records of his lineage?

A correspondent who has extensively researched this subject writes:

"It appears to me that Hitler knew about his connection long before his Chancellorship. Like his father before him, when the going got rough, the Hitler's went to Vienna. Hitler's father left his home village at an early age to seek his fortune in Vienna. When Hitler was orphaned, after his mother died in December of 1907, he left for Vienna not long after the funeral.

There he seemed to drop out of sight for ten months! What happened during this ten-month stay in Vienna is a complete mystery on which history sheds no light. It makes sense, now that it has become established that Hitler was a Rothschild, that he and his cousins were getting acquainted, and his potential for future family endeavors was being sized up."

The Rothschild's and the Illuminati produce many offspring out of wedlock in their secret breeding programs and these children are brought up under other names with other parents.

Like Bill Clinton, who is almost certainly a Rockefeller produced in the same way, these "ordinary kids from ordinary backgrounds" go on to be extraordinarily successful in their chosen field. Hitler, too, would have produced unofficial children to maintain his strand of the bloodline and there will obviously be people of his bloodline alive today.

So which Rothschild was the grandfather of Hitler? My thanks to a website correspondent for the additional, updated, information to this article, a man has researched this story in some detail.

Alois, Hitler's father, was born in 1837 in the period when Salomon Mayer was the only Rothschild who lived at the Vienna mansion. Even his wife did not live there because

their marriage was so bad that she stayed in Frankfurt. Their son, Anselm Salomon spent most of his working life in Paris and Frankfurt away from Vienna and his father.

Father Salomon Mayer, living alone at the Vienna mansion where Hitler's grandmother worked, is the prime, most obvious candidate. And Hermann von Goldschmidt, the son of Salomon Mayer's senior clerk, wrote a book, published in 1917, which said of Salomon:

"...by the 1840s he had developed a somewhat reckless enthusiasm for young girls.."
and

"He had a lecherous passion for very young girls, his adventures with whom had to be hushed up by the police."

And Hitler's grandmother, a young girl working under the same roof would not have been the subject of Salomon's desire?

And this same girl became pregnant while working there? And her grandson becomes the Chancellor of Germany, funded by the Rothschild's, and he started the Second World War which was so vital to the Rothschild-Illuminati agenda? And the Illuminati are obsessed with putting their bloodlines into power on all "sides" in a conflict?

And the Rothschild's are one of their most key bloodlines? And it is all a co-incidence?

Hitler was a Rothschild!

The Second World War was incredibly productive for the Illuminati agenda of global control. It led to an explosion of globally-centralized institutions, like the United Nations and the European Community, now Union, and many others in finance, business, and the military.

Precisely what they wanted was debt slaves. It also put countries under an enormous burden of debt on loans provided to all sides by... the Rothschild's and the Illuminati.

The Rothschild's had long had a plan to create a personal fiefdom for themselves and the Illuminati in Palestine and that plan involved manipulating Jewish people to settle the area as their "homeland."

Charles Taze Russell, of the Illuminati-reptilian Russell bloodline, was the man who founded the Watchtower Society, better known as the Jehovah's Witnesses. He was a Satanist, a pedophile according to his wife, and most certainly Illuminati.

His new "religion (mind-control cult) was funded by the Rothschild's and he was a friend of theirs, just like the founders of the Mormons who were also Rothschild-funded through Kuhn, Loeb, and Co. Russell and the Mormon founders were all Freemasons."

In 1880, Charles Taze Russell, this friend of the Rothschild's, predicted that the Jews would return to their homeland.

It was about the only prediction Russell ever got right. Why? Because he knew that was the plan. He wrote to the Rothschild's praising their efforts to establish a Zionist Jewish homeland in Palestine.

Then, in 1917, came the famous Balfour Declaration, when the British Foreign Minister, Lord Balfour, stated on behalf of his government that they supported the creation of a Jewish homeland in Palestine.

Now when you hear that phrase, the Balfour Declaration, you get the feeling that it was some kind of statement or public announcement. But it was not so.

The Balfour declaration was a letter from Lord Balfour to... Lord Lionel Walter Rothschild. Researchers say that the letter was in fact WRITTEN by Lord Rothschild and his employee, the banker, Alfred Milner. Now get this.

One of the most important secret societies of the 20th century is called the Round Table. It is based in Britain with branches across the world.

It is the Round Table that ultimately orchestrates the network of the Bilderberg Group, Council on Foreign Relations, Trilateral Commission and the Royal Institute of International Affairs. See my books for details.

How fascinating then, that Lord Balfour was an inner circle member of the Round Table, Alfred Milner was the Round Table's official leader after the death of Cecil Rhodes, and the Round Table was funded by... Lord Lionel Walter Rothschild. These were the very three people involved in the Balfour Declaration of 1917.

Two years later, in 1919, came the Versailles Peace Conference near Paris when the elite of the Round Table from Britain and the United States, people like Alfred Milner, Edward Mandel House, and Bernard Baruch, were appointed to represent their countries at the meetings which decided how the world would be changed as a result of the war these same people had created.

They decided to impose impossible reparations payments on Germany, so ensuring the collapse of the post-war Weimar Republic amid unbelievable economic collapse and thus create the very circumstances that brought the Rothschild, Hitler, to power.

It was while in Paris that these Illuminati, Round Table, members met at the Hotel Majestic to begin the process of creating the Bilderberg-CFR-RIIA-Trilateral Commission network that manipulates humanity today.

They also decided at Versailles that they now all supported the creation of a Zionist Jewish homeland in Palestine. As I show in my books, EVERY ONE of them was either a Rothschild bloodline or was controlled by them.

The American President, Woodrow Wilson, was “*advised*” at Versailles by Colonel House and Bernard Baruch, both Rothschild clones and leaders of the Round Table in the United States; The British Prime Minister, Lloyd George, was “*advised*” by Alfred Milner, Rothschild employee and Round Table leader, and Sir Phillip Sassoon, a direct descendent of Mayer Amschel Rothschild, the founder of the dynasty; The French leader, Georges Clemenceau, was “*advised*” by his Minister for the Interior, Georges Mandel, whose real name was Jeroboam Rothschild.

Who do you think was making the decisions here?

But it went further. Also in the American delegation were the Dulles brothers, John Foster Dulles, who would become U.S. Secretary of State, and Allen Dulles, who would become first head of the new CIA after World War Two.

The Dulles brothers were bloodline, would later be supporters of Hitler, and were employed by the Rothschild’s at Kuhn, Loeb, and Co. They were also involved in the assassination of John F. Kennedy and Allen Dulles would serve on the Warren Commission which investigated the assassination.

The American delegation at Versailles was also represented by the Rothschild-controlled, Paul Warburg, of Kuhn, Loeb and the American branch of I.G. Farben, while the German delegation included his brother, Max Warburg, who would become Hitler’s banker!

Their host in France during the “peace” conference was... Baron Edmond de Rothschild, the leading force at the time pressing for the creation of a Jewish homeland in Israel. See my books for fine detail.

The Rothschild’s have always been the true force behind the Zionist Movement. Zionism is in fact SIONism, Sion = the Sun, hence the name of the elite secret society behind the Merovingian bloodline, the Priory of Sion.

Contrary to most people’s understanding, Zionism is not the Jewish people. Many Jews are not Zionists and many non-Jews are.

Zionism is a political movement, not a race. To say Zionism is the Jewish people is like saying the Democratic Party is the American people. Jewish people who oppose Zionism, however, have been given a very hard time.

Now, having manipulated their puppet-governments to support their plan for a personal fiefdom in the Middle East, the Rothschild’s began the process of settling Jewish people in Palestine. As always they treated their own people with contempt.

Enter Baron Edmond de Rothschild, the “*Father of Israel*”, who died in 1934, the man who hosted the Versailles “*peace*” delegations. Edmond was from the French House,

like Guy de Rothschild. Edmond, in fact, began to settle Jews in Palestine as far back as the 1880s (when Charles Taze Russell was making his prediction).

He financed Russian Jews to establish settlements in Palestine, but it was nothing to do with their freedom or birthright, it was to advance the Rothschild-Illuminati agenda. Edmond financed the creation of farms and factories and ran the whole operation with a rod of iron.

The Jewish farmers were told what to grow and they soon found out who was in charge if they questioned his orders. In 1901, these Jewish people complained to Rothschild about this dictatorship over their settlement or "Yishuv".

They asked him:

"..if you wish to save the Yishuv, first take your hands from it, and...for once permit the colonists to have the possibility of correcting for themselves whatever needs correcting.."

Baron Rothschild replied:

"I created the Yishuv, I alone. Therefore no men, neither colonists nor organizations, have the right to interfere in my plans.."

In one sentence, you have the true attitude of the Rothschild's to Jewish people, and indeed, the human population in general.

These people are NOT Jews, they are a non-human bloodline with a reptilian genetic code who hide behind the Jewish people and use them as a screen and a means to an end.

According to Simon Schama's book, *'Two Rothschild's and the Land of Israel'* (Collins, London, 1978), the Rothschild's acquired 80% of the land of Israel. They bought up the land where Arab shepherds grazed their flocks on the cheap.

Edmond de Rothschild worked closely with Theodore Herzl, who just happened to be the founder of Zionism, the political movement created to ensure a "Jewish" homeland in Palestine.

Rothschild was also the power behind Chaim Weizmann, another leader of Zionism. As Rothschild told Weizmann:

"Without me Zionism would not have succeeded, but without Zionism my work would have been stuck to death."

So now with the Rothschild's increasing their financing of Jewish settlements in Palestine, and with their agents in governments officially supporting their plans for a

Rothschild, sorry Jewish, homeland, they needed a catalyst which would demolish Arab protests at the take-over of their country.

That catalyst was the horrific treatment of Jews in Germany and the countries they conquered by the Rothschild-funded Nazis and one of their own, a Rothschild called Adolf Hitler.

The wave of revulsion at the Nazi concentration camps gave vital and, in the end, crucial impetus to the Rothschild agenda. It was they who funded the Jewish terrorist operations like the Stern Gang and Irgun, which committed mayhem and murder to bring the State of Rothschild (Israel) into being in 1948.

These terrorist groups, who slaughtered Jewish people with equal enthusiasm, were led by the very people who later rose to lead the new Israel... people like Menachem Begin, David Ben-Gurion, Yitzhak Rabin, and Yitzhak Shamir.

It was these Rothschild-controlled Zionist gangs who murdered the international mediator Count Bernadotte on September 17, 1948, apparently because he had been intending to present a new partition resolution to the United Nations.

And the Rothschild's were not satisfied with causing the unimaginable suffering of Jewish people under the Nazis, they also stole their wealth when the war was over, just as they stole the Russian wealth during the revolution they had financed.

In early 1998, during a speaking tour of South Africa, I had a personal meeting with P.W. Botha, the apartheid President of South Africa during the 1980s.

The invitation came out of the blue when I was speaking a few miles from his home. We spoke for an hour and a half about the manipulation of South Africa and it was not long before names like Henry Kissinger, Lord Carrington, and the Rothschild's came up.

"I had some strange dealings with the English Rothschild's in Cape Town when I was president", he said, and he went on to tell me a story that sums up the Rothschild's so perfectly.

He said they had asked for a meeting with him and his foreign minister, the Illuminati operative, Pik Botha (no relation). At that meeting, he said, the Rothschild's told him there was massive wealth in Swiss bank accounts which once belonged to German Jews and it was available for investment in South Africa if they could agree on an interest rate.

This is the very wealth, stolen from German Jews who suffered under the Nazis, which has come to light amid great scandal in recent years.

The Rothschild's have been making a fortune from it since the war! Botha told me he refused to accept the money, but Pik Botha left the meeting with the Rothschild's and he could not be sure that they did not come to some arrangement.

Breathtaking? Of course it is, but the world is not how we think it is.

To this day the Rothschild's continue to control the State that has their family symbol on its flag and it is they who use that country and its people to maintain the conflict, both within its borders and with surrounding Arab countries, which has allowed the Illuminati-Rothschild's to control their so called "*Arc of Crisis*" in the Middle East through divide, rule, and conquer.

It has allowed them, not least, to control the oil-producing countries since the war when the oil really came on line.

To verify which, if any of the Rothschild's were home in September of 1836, an online enquiry was initiated with the Rothschild's London Archive.

According to dated business correspondence discovered in the files known as The Moscow Papers, Anselm Salomon von Rothschild was indeed in Vienna during September of 1836 – the month that Hitler's grandmother conceived.

Anselm's father, Salomon, had not been in Vienna at the time that Hitler's grandmother conceived in September of 1836. He left Vienna in June of that year and didn't return until sometime in 1837. (Salomon maintained a second residence in Paris where his wife's family lived. It was his custom to return to Paris for the Jewish High Holidays. His daughter, Betty, who was married to his brother, James also lived in Paris. By 1836, they had borne Salomon four grandchildren.

According to reverse ovulation calculations, Maria Anna Schicklgruber conceived on or near Rosh Hashanah, the Jewish New Year. The holiday fell that year on September 12th.

Hermann von Goldschmidt, the son of Salomon Mayer's senior clerk, wrote a book, published in 1917, which said of Salomon: "...by the 1840s he had developed a somewhat reckless enthusiasm for young girls.." and "He had a lecherous passion for very young girls, his adventures with whom had to be hushed up by the police."

FAMILY TIES

Anselm, a notorious playboy, was in Vienna with his family for the holidays that late summer to cover his father's absence. By that time, he was a full partner in the family banking business. His wife, Charlotte, gave birth in Vienna to "Puggy", the first of their three sons the following month. The resemblance between Alois and his half-brothers was striking.

British author David Icke has been banned by the UK for his outspoken remarks about the Covid pandemic, and is one of the major researchers of the 20th century. I have read David Icke's book back in the 1990s, which remain by far some of the greatest evidence that the House of Rothschild remains the greatest threat to the free world today.

Whether you choose to believe the evidence presented in this section or that of Part 1, is your choice. The evidence has been confirmed through many methods and sources.

That said, and so just like Volodymyr Zelensky, Barack Obama is pulling the strings of his puppet former Vice President Biden doppelganger double playing the role of Judas goats to lead the U.S.A. into a nuclear exchange, which as Dmitry Medvedev stated over Christmas weekend, *"The only thing that stops our enemies today is the understanding that Russia will be guided by [the doctrine] on nuclear deterrence. And if there is a real threat, we will act,"* Medvedev wrote in his article published on Sunday night – noting that in such a grim scenario there will be nobody left to argue about whether that was "a retaliatory strike or a preventive one."

I would remind you that it was Zelensky In his speech before a joint session of Congress, Zelensky clearly forgot to mention how he has eliminated freedom of speech and association in his own country as part of his war agenda, while also banning opposition parties and media and even harassing the Russian Orthodox Church. As such keep in mind that it was then President Obama who orchestrated Volodymyr Zelensky into his present position as president.

I rather suspect that the passion unleashed for the Jewish Zelensky was at least in part engineered by the usual suspects among the politically powerful Jewish groups, lobbyists and media personalities, where criticism of Ukraine, which has a large Jewish population, is considered a capital offense. *Jewish media in the U.S. hailed the impending news of the Zelensky visit, enthusing in seasonal fashion over how "Ukraine's survival" under Zelensky had been a "modern day Hanukkah miracle."*

Hatred of Russia (and of course Iran) is also a *sine qua non* among such groups and media outlets and they will twist every argument to urge U.S. military intervention in

both those countries. That is precisely what Zelensky himself does when he calls for NATO intervention even when he is the one who bombs neighboring Poland. In the current situation, you will not find the *'New York Times'* debunking the ridiculous claim that throwing hundreds of billions of dollars at Zelensky and his band of thieves is in any way related to U.S. national security requirements. **No one was threatening the United States and the war that erupted in February was clearly negotiable on two major issues: implementation of the Minsk accords of 2014-5 over autonomy for Donbas and demands for neutrality for Ukraine, i.e. no joining NATO.** It was the United States that encouraged Ukraine's abrupt tilt towards the west and refused to negotiate in any seriousness with Russia over issues that were vital to that country's actual security.

So did the Zelensky bit of kabuki theater largely engineered by the White House and Nancy Pelosi succeed in getting everything the Ukrainians wanted? Probably not, as offensive missile systems that could be used to strike deep into Russia are still on hold, but the money and other weapons are now in the pipeline. And there surely will be more to come, certain to include U.S. military *"advisers"* on the ground. No matter how it turns out, the Ukraine is a tragedy writ large and the fools sitting complacently on Capitol Hill are largely to blame for not recognizing that U.S. interests do not necessarily coincide with the aspirations of Volodymyr Zelensky and his fellow accomplices. Maybe in time when the whole house of cards has collapsed and Americans, feeling a great deal of economic and political pain, begin to wonder what took place, it will be time to throw all the bums out and replace them with folks who really care about what happens to this country.

To ignore the question, ***"who benefits from this war in the Ukraine"***, I turn to what I learned from the lessons of history from my college days. When you don't learn from history you are inclined to repeat the same mistakes. I have taught in my articles how the Hegelian Dialectic is exploited over and over again. Such is the case we are watching in the Ukraine. It is all about bringing into existence a Global New World Order. ***"Who benefits from this war is what you should be asking?"***

The Antichrist knows how to ***"divide and conquer"*** by pitting the forces of ideology, race, religion, and patriotism against one another. The AC is running the game much like the musical game of ***"musical chairs"*** to reduce and exhaust the warring parties into **submissive dependency.** And by reducing the total number of chairs (individual sovereign nations), and diminishes individual national sovereignty; and since the UN was created in 1945, its membership has grown to 194 nations through the ***"divide and conquer"*** strategy. The House of Rothschild picked them off, one by one, with its establishment of control of the purse strings (a Rothschild central bank), until they were all indebted to the Rothschild central bank.

This is evolving into CBDCs 100% digital, surveillance-based currencies. The rapid strengthening of CBDC policies and technologies across the world is (along with AI and Quantum supremacy) the new 'arm's races' for the 21st century. World powers will use the current inflation (they created), failing legacy fiat currencies (they enabled), and massive national debt (they created) as excuses to expedite the implementation of

digital centralized currencies. The process is part of the Biden-plan of his executive order signed in March 9th, 2022, Executive Order 14067.

The biggest concern for the public regarding Executive Order 14067 is the potential for a digital U.S. dollar. Although there are no published concrete plans to develop a digital greenback that we know of outside of the “still-born” Libra system by Concordia in Europe; the Biden administration has explicitly stated its plan to explore the issue. Don't bet on it not happening! It will be here in a few months. The Central Bank Digital Currency (CBDC) would be a digital fiat currency issued by the Rothschild-owned Federal Reserve. Theoretically, CBDC would be used alongside physical currency and digital balances.

Diem (formerly known as Libra) was a blockchain-based stable coin payment system proposed by the American social media company Meta Platforms. The plan also included a private currency implemented as a cryptocurrency. The launch was originally planned to be in 2020, but only rudimentary experimental code was released until the project was acquired in January 2022. We know that Swiss regulators, i.e., the BIS and company torpedoed Libra assuring its demise!

The project, currency and transactions would have been managed and cryptographically entrusted to the Diem Association, a membership organization of companies from payment, technology, telecommunication, online marketplace and venture capital, and nonprofits.

Before December 2020, the project was called "Libra", although this was changed to Diem following legal challenges regarding its name and logo.

In general, the project generated backlash from government regulators in the European Union, the USA, other countries, and among the general public over monetary sovereignty, financial stability, privacy, and antitrust concerns which ultimately helped kill the project.

Advocates of a centralized digital currency often conveniently overlook the nefarious ramifications lurking behind a transition to purely digitized dollars. While the government might initially represent a CBDC as merely an alternative to physical USD, there's nothing preventing our financial czars from eventually phasing out cash and coins.

This would give the government unprecedented oversight over the spending power of the average American, making it possible to track behavior, movement, preferences, and political and social engagement.

This depiction might sound more like a dystopia dream ideal, but its grim indications of the Draconian path centralized digital currencies might take. We had a foretaste when Prime Minister Trudeau recently leveraged emergency powers to freeze the bank accounts of Canadian truckers and their donors who were simply exercising their right to protest the Covid shots.

The World Economic Forum's (WEF) push for "The Great Reset" – a transformational economic vision for the future. Some think the WEF is strategically phasing out physical currencies to exert more control over an increasingly centralized world order. The WEF and its links to the House of Rothschild and the Jesuit-Vatican Bank assure its implementation. They were instrumental in the attack on the Libra system.

On September 13, 2019, *'Le Maire'* stated that France would not allow development of Libra in the European Union, as would be a threat to the monetary sovereignty of states. He also spoke about the potential for abuse of marketing dominance and systemic financial risks as reasons for not allowing stable coins to operate yet within the EU.

According to a Reuters report, former German Finance Minister Olaf Scholz, now Chancellor of Germany, said following a video conference of G7 finance ministers that Germany and Europe cannot accept Diem currency entry into the market while the regulatory risks are not adequately addressed. Olaf Scholz stated that he does not support private-sector digital currencies, and his remarks became detrimental to Diem and JPMorgan Coin. Olaf Scholz is in the hip pocket of the Rothschild's as was Angela Merkel.

An increasingly number of people are waking up to the fact that 99% of the Earth's population is controlled by an elite 1% – but did you know that there are theories about one family, the Rothschild, that they rule everything, even that elite 1%?
