The first two parts of this series is about the unveiling of a long-ago plan to destroy America as a Sovereign State. His life and death history was cloaked in secrecy and scripted narratives in order to preserve the 3rd Reich. I have mentioned several books that have done great work in bringing to light history that has been suppressed by the U.S., the Vatican, and Russia. The 3rd Reich did not end at the end of World War II, it merely morphed into what the late Jim Marrs referred to as the 4th Reich, in his 2009 book, *'The Rise of the Fourth Reich' – subtitled 'The Secret Societies That Threaten to Take Over America'*. It has been my view that these people killed Jim Marrs for what he revealed in his book; and I am not alone in that belief. You would have to have read his books and what he was telling.

In this segment I will provide you the background on how the Vatican State was created by the Fascist dictator Benito Mussolini. He and Hitler along with Pope Pius XII planned the war to destroy Russia and the Orthodox Church, nemesis of Rome!

During Pope Pius X pontificate, a tremendous struggle ensued to get back the lost Papal States. With the blessing of Pope Leo XIII, King Umberto I was assassinated by the British Secret Service on July 29, 1900. King Umberto I adamantly opposed the restoration of the Papal States. His son and successor, Victor Emmanuel III, was a physical and mental midget, and the next to the last king to misrule Italy.

In February 1929, "Little Caesar" Benito Mussolini signed the Lateran Accords on behalf of King Victor Emmanuel III. The Accords gave the Pope 110 acres (0.44 square km) which became known as Vatican City State, one of the Triad city states that has ruled the world as we know it over the past century.

At this point Italy now had 3 rulers: Pope Pius XI, Victor Emmanuel III, and the Benito Mussolini double!! Pius, with the help of his successor Eugenio Pacelli, negotiated a Concordat with Nazi Germany in 1933.

Pope Pius XII (1876-1958) reined from 1939 until 1958. Pope Pius XII planned the invasion of Russia with Winston Churchill and several of the Hitler doppelgängers! The Russians retreated before the Nazi juggernaut and came roaring back as usual! To the horror of imperious Pope Pius XII, the Russians entered Berlin and instead of the Hitler doppelgänger entering Moscow!

Greg Hallet's 2006 book 'Hitler Was A British Agent' answers many questions that heretofore have remained unanswered by historians. *'Hitler Was A British Agent'* covers Hitler's incestuous parentage, his training in Britain, his sex with men, his bizarre sexual habits with women, including fake suicides and murders made to look like suicides. It delves into Hitler's psychiatric condition and how, during his missing year, he was manipulated by 'deconstruction' to perform as a British Agent, that is, an agent for the British war machine. For example, one of the greatest questions is why did the Germans allowed 300,000 allied troops to escape and flee at Dunkirk on the coast of France in late May, 1940. British, French, Canadian, and Belgian troops had been forced back to the beaches of Dunkirk by the advancing German army. The Allied forces had retreated to the harbor and beaches of Dunkirk where they were trapped, a sitting target for the Germans. Nearly all the escape routes to the English Channel had been cut off; a terrible disaster had appeared inevitable. At the time Prime Minister Winston Churchill called it *"a miracle of deliverance"*. The evacuation from May 26 until June 4th, 1940 was much more than a miracle!

On May 12th, 1940, Adolf Hitler ordered the invasion of France. By May 14th, 1940, German tanks had crossed the Meuse River and had opened up a gap in the Allied front. Six days later they reached the English Channel. Allied defeat was in the hands of Germany.

The British, French and Belgium governments had seriously underestimated the strength of the German forces. As a result the British Expeditionary Force (BEF), as well as French, Canadian and Belgian troops, found themselves fighting against overwhelming odds. Before long, the Allied forces had retreated to the harbor and beaches of Dunkirk where they were trapped, a sitting target for the Germans.

The book covers Hess and doppelgänger Hess' simultaneous flight to Britain, Anthony Blunt's conception by a royal, Wallis Simpson's sexual practices with King Edward VIII and how she back-channeled leaked British secrets to Hitler.

Adolf Hitler and several doppelgänger (doubles) was the Führer from 1933 to 1945. Pius was not too distraught by the huge Russian victory because Cardinal Spellman

and the Pentagon was his new ally! In 1950, Pope Pius declared that the Virgin Mary was assumed bodily into heaven immediately after her death. It was Saint Paul that was assumed bodily into heaven . . . not the Virgin Mary.

The term “*Das Führer*” in German means “the Leader”. As a political title, it is strongly associated with the Nazi dictator Adolf Hitler. Nazi Germany cultivated the *Führerprinzip* (“leader principle”), and Hitler was generally known as just der Führer (“the Leader”).

Long-buried Vatican files reveal a new and shocking indictment of World War II’s Pope Pius XII: that in pursuit of absolute power he helped Adolf Hitler destroy German Catholic political opposition, betrayed the Jews of Europe, and sealed a deeply cynical pact with a 20th-century devil.

Pope Pius XII, largely unknown to the faithful, was a man of selfless, monk like habits of prayer and simplicity; he was a believer in the absolute-leadership principle. More than any other Vatican official of the century, he had promoted the modern ideology of autocratic papal control, the highly centralized, dictatorial authority he himself assumed on March 2, 1939, and maintained until his death in October 1958. Pius XII was often called Hitler’s Pope!

The world scrambled to return to normal after the death and devastation of World War II, while the Allied victors sought ways to punish the Nazis for their crimes against humanity across and preceding the global conflict. While some were captured, imprisoned, and executed, many managed to flee Germany and live their lives away from justice’ reach. According to ‘*The Guardian*’, new evidence shows that both the Red Cross and the Vatican helped Nazis and their collaborators escape from their Allied conquerors to a life of freedom, either by mistake or as part of an immoral plan to preserve Catholicism’s power in Europe and the world at large.

Some of this help was unwitting. Over 8,000 Nazis were able to travel to Britain and Canada because of mistakenly approved travel documents from the Red Cross — something the organization admitted to and apologized for, blaming overworked administrators. Not every Nazi that reached freedom was an accident, though: The Vatican had a hand in sending thousands of Adolf Hitler’s henchmen to a peaceful post-war life by giving them false identities in a purported scheme to return Christianity in Europe to the peak of its powers. And the number of accidental approvals on the part of the Red Cross seems to be much higher than previously admitted. Although Britain and Canada took around 8,000 Nazis in 1947, most made their way to Spain and the Americas. In particular, many sought refuge in Argentina, which ironically took in a significant number of Jewish refugees as well.

Like an underground railroad, the Catholic churches, became known as the infamous “ratlines” provided shelter, aid, food, and protection, at a price nonetheless, to those escaping mostly to the south through Switzerland, Italy, Austria, Romania, Ukraine. Some 90% of Nazi perpetrators who escaped Europe are thought to have fled across the Alps to Italy — that was the first loophole.

Their first stop was in the South Tyrol region of northern Italy: the monastery of the Teutonic Order in Merano, the Capuchin monastery near Bressanone or the Franciscan monastery near Bolzano. The war criminals would often hide out in monasteries — these ratlines are also known as the *"monastery route"* — for years, collecting money to continue their escape overseas. Sometimes, the Nazis were accommodated right next to their former victims, Jews headed to Israel.

Rome was the next stop. The Nazis who had a letter from the Catholic Church confirming their identity were handed a passport by the International Committee of the Red Cross (ICRC), which issued about 120,000 papers until 1951 — a mere formality.

"The story goes that even before the end of the war, there was a clearly thought-out and elaborate plan for Nazi escapees," Stahl said. *"That is wrong, even the likes of Franz Stangl first wandered around Rome without knowing what to do next."* Information was passed on word of mouth.

A name that regularly crops up is Alois Hudal. The Austrian bishop had clearly positioned himself as a Nazi sympathizer during Nazi rule, and later he said many of those persecuted were *"completely blameless"* and that he *"snatched them from their tormentors with false identity papers."*

Using the name Riccardo Klement, the man who organized the Holocaust fled from Bolzano to Argentina in 1950. His family later joined him. Grateful for the Vatican's help in his escape, Adolf Eichmann converted to Catholicism. He worked as an electrician at a Daimler-Benz truck factory. In 1960, he was kidnapped by Mossad, Israel's secret service, and brought to trial in Israel. He was executed in the night from May 31 to June 1, 1962.

Josef Mengele

The sadistic Auschwitz concentration camp doctor Josef Mengele fled to South Tyrol in 1949, where supporters provided him with a new passport. His new name was Helmut Gregor, 38, a Catholic and a mechanic, born in the South Tyrolean village of Tramin. The detail of his birth in South Tyrol would prove the most important condition for leaving the country. As a South Tyrolean citizen, he was considered an ethnic German as well as stateless, and therefore entitled to an ICRC passport. Mengele lived in Argentina, Paraguay and Brazil, where he suffered a stroke while swimming and drowned on February 7, 1979.

While the Vatican had an interest in preserving former Nazis within Europe, the Pope himself had his reasons for keeping Adolf Hitler's followers alive and well. Pope Pius XII was staunchly anti-Semitic and anti-Communist, and as one of his first acts as the supreme pontiff, he rehabilitated a French far-right fascist group condemned by his predecessor. Catholic apologists obfuscate the real reasons as to why Hitler was never excommunicated from the Roman Catholic Church. The length of his involvement in the Nazi migration is not fully known. But his inaction against the Holocaust and preference

for Nazis in South America to aid anti-communist governments means it is very likely that he would have approved the Vatican's methods. In addition, the Red Cross was overwhelmed with refugees and asked the Vatican to help deal with the thousands of travel papers that piled on their desks. The result was the spread of Nazis across Europe, North America, and South America — sometimes along with escaping Jews.

The Red Cross was not entirely ignorant of the Nazis crossing borders. Though the organization has since condemned their inaction, at the time it deemed itself too busy to fully deal with the situation. Meanwhile, a Nazi-sympathizing bishop named Alois Karl Hudal created a series of "ratlines," churches, and monasteries that Nazis could flee to and acquire false papers in a cruel and sinister twist on the Underground Railroad. Hudal thought himself a charitable man, rescuing scapegoats of the war, yet reportedly personally secured the safety of significant Holocaust officials. Ultimately, his actions show how far the Vatican strayed from morality during World War II and its build-up.

The ratlines extended across Europe and helped some of the most despicable war criminals of the Second World War escape into peace and obscurity in the years following 1945. Franz Stangl — a commander of two extermination camps who is responsible for the deaths of over 1 million Jews — was escorted to the Vatican and personally met by Bishop Alois Karl Hudal, who saw Stangl off to Syria and eventually Brazil. The networks of sympathetic houses and hideouts, many of them churches, stretched over the Alps and helped thousands of Nazis scurry from Austria to Genoa and other sea ports as far west as Spain and Portugal where they could board ships to sail across the Atlantic. The escape system was so heavily associated with the Roman Catholic Church that they were also referred to as the "monastery route."

From the monasteries, Nazis would receive false papers from the Church that meant receiving a passport from the Red Cross was a mere formality. It was not a highly organized system and relied heavily on word-of-mouth and a lot of waiting around on the part of the escaping Nazis. Indeed, the entire operation would likely have fallen apart without the aid and guidance of the Church and its Nazi-sympathizing individuals like Hudal and Pius XII.

While the extent of Pope Pius' XII's involvement in organizing the ratlines and escorting Nazis to safety isn't entirely known, his inaction before, during, and after the war aided Hitler's cause greatly. According to 'Smithsonian Magazine', newly opened documents from the long-closed Vatican archives reveal the Pope's silence surrounding the genocide of the Jews was not one out of ignorance: He learned of the Holocaust in late 1942, albeit having heard from his pontiff that the reports were exaggerated. Still, he followed the advice to tell the American government that they could not confirm Nazi war crimes.

By feigning ignorance of the Holocaust and failing to shed light on the atrocities, the smuggling of its perpetrators was made much easier. Villains such as the Holocaust's organizer Adolf Eichmann, Auschwitz doctor Josef Mengele, and Gestapo chief Klaus Barbie all made it to the shores of South America with their Church-earned passports in

hand. While some — like Eichmann — would eventually be captured, tried, and executed, others lived the rest of their lives in their adopted homes, fading into obscurity, never to face justice for their heinous crimes.

The 1974 film *'The Odessa File'* was based upon a novel by that name written by Frederick Forsythe. My interest into the Vatican's role in WWII came from that movie.

Follow me here as I Segway forward to 2014 when the Minsk agreement was agreed to by all parties involved in the civil war of the Ukraine and how it brought us to the point where we are today in Russian "Special Operations."

In an interview that occurred a few days ago in December, 2022 with the *"Kyiv Independent"* newspaper, former President of France, Francois Hollande, claimed that the Minsk agreements had brought Russia to the diplomatic table territory, leaving Kiev's army time to strengthen for attacking Russia directly and an intent to use nuclear weapons. This was an admission contradicting the peaceful declarations of the time.

While Vladimir Putin was advancing in the Donbass using the pro-Russian separatists (...) *"we led him to accept the Normandy format and to come to Minsk for the negotiations."* said Hollande.

The former French president aligned himself with Angela Merkel who, on December 7 in an interview at *"Die Zeit,"* claimed that the Minsk agreements had been *"an attempt to give Ukraine time"* to strengthen militarily for a future confrontation with Moscow. Keep in mind Angela Merkel was Adolf Hitler's granddaughter!

Officially, these agreements, signed on September 5, 2014 were concluded with the stated objective of restoring peace between Kiev and the Donbass Republics. That conflict left nearly 15,000 (civilians and soldiers) dead between 2014 and 2022.

To the question of whether the Minsk negotiations were intended to delay Russian progress in Ukraine, Francois Hollande replied in the affirmative: *"Yes, Angela Merkel is right on this point. The Minsk agreements stopped the Russian offensive for a time. What was important was how the West would use this respite to prevent any subsequent Russian attempt."* Russia was concerned about the eastern provinces of Ukraine which were 90% ethnic Russians and being persecuted by Zelensky.

Holland claims to have enabled the strengthening of the Ukrainian army, a respite that the West and Kiev seem to have taken advantage of: *"Since 2014, Ukraine has strengthened its military capabilities. Indeed, the Ukrainian army is completely different from that of 2014. She is better trained and better equipped. It is the merit of the Minsk agreements to have given the Ukrainian army this opportunity"* he said.

According to him, the latter also prevented the area controlled by the separatists from expanding. In winter 2015, they were at the gates of Marioupol and had just won two decisive battles, taking over Donetsk airport and the city of Debaltsevo.

Regretting divisions within the EU and German ambiguity, refusing to question the Nord Stream 2 pipeline, François Hollande reports today that he was in favor of maximum sanctions, recalling that he himself had canceled the sale of Mistral ships to Russia in 2014.

In 2022, trust between Moscow and the West disappeared. Strangely, François Hollande, who believes that a lasting solution is necessary for peace in Ukraine, completes his remarks by affirming that *"the Minsk agreements can be resuscitated to establish a legal framework already accepted by all the parties."* Russian leadership has ruled out at this point of returning to the Minsk agreement. From this point forward Russia will destroy the Zelensky corrupt regime. The Ukraine will be given two options, total surrender or death!

Angela Merkel's confession, however, already provoked a strong reaction from Russian President Vladimir Putin on December 9th, 2022. Putin said *"Trust is almost nonexistent, but after such statements, a question of trust arises: how to negotiate, on what, and if it is possible to negotiate with someone, what are the guarantees?"* Putin went on to say *"I still hoped that the other stakeholders in this process were sincere with us. It turns out that they also cheated on us. It was only a question of strengthening Ukraine with weapons, by preparing it for hostilities"* he added.

Vladimir Putin then estimated that in view of these new facts, Moscow should have, perhaps, had to launch its military operation in Ukraine earlier, stressing that Russia, for its part, hoped to be able to resolve the conflict in the Donbass through the Minsk Agreements.

Hal Turner gave the following comments and analysis:

So there you have it: Both Angela Merkel of Germany, and Francois Hollande of France, personally KNEW they were attending the Minsk Negotiations as a ruse, as a deception, for the express purpose of buying time for Ukraine to prepare for . . . WAR . . . with Russia. The very war which is taking place right now.

Back in February of 2022, when Russia finally sent its troops into Ukraine, both France and Germany, along with the United States, feigned horror that Russia was engaging in battle, when all along, that was the precise goal of Germany, France, and without doubt, the United States and the rest of NATO. Their "shock" at Russia using its military, was phony. They not only knew Russia was going to act militarily, it was THEY who set the entire stage for it!

In Hal's opinion, this was a criminal conspiracy to facilitate war.

Some may argue that both Merkel and Hollande enjoy Sovereign Immunity. They do not. Fraud vitiates everything, and both Merkel and Hollande perpetrated premeditated and willful fraud upon the peoples of Europe, Russia, and America, as the very crux of their meetings in Minsk, Belarus back in 2014.

The fraud perpetrated by Merkel and Hollande has cost the people of the United States, over \$110-billion dollars in war support for Ukraine, cost Ukraine hundreds of thousands of dead soldiers, cost Russia tens-of-thousands of dead soldiers and countless billions in war costs. The consumers in both Europe and America have had to pay Billions more in increased costs for natural gas, oil, gasoline, and diesel fuel as a result of the Sanctions imposed, over a war, they planned to start!

I want Merkel and Hollande criminally prosecuted at the world court, for Fraud and criminal conspiracy to facilitate war. In what I have shown to this point is a common hatred for Russia. These wars have all been religious wars against the Orthodox faith community. Europe has been largely Roman Catholic since the mid-4th century. Separation of church and state has not been an axiom in the nations of Europe. The power of the popes reigned supreme at least until the Schism of 1054 AD.

The Orthodox Church came from Constantinople which was founded by Emperor Constantine—the first Pope. Emperor Constantine (272-337 AD). He reigned from 306 to 337 AD). The term Caesar over the early year morphed into the Papal term "Pope"

Roman Emperor Constantine founded a new capital called Constantinople or New Rome. When New Rome fell to the Terrible Turks in 1453, Moscow became the 3rd Rome. This was the 2nd Rome. When Constantinople fell to the Muslims, Moscow became known as the 3rd Rome.

The Emperors at Constantinople called themselves Roman Emperors even though they spoke Greek and lived in the Eastern part of the Empire.

The Emperors at Rome were replaced by the popes, and the pope's followers became known as LATINS....The principal Latin nations were: Italy, France, and Iberia (later Spain and Portugal).

All true Christians –both East and West– originally called themselves CATHOLIC which means UNIVERSAL in contradistinction to the Jewish congregation which was local and restricted to Jews and proselytes only.

When Rome and Constantinople split around 1054 AD, the Latin church arrogated or claimed the name CATHOLIC, while the Greeks adopted the name Orthodox, which means adhering to the accepted or traditional and established faith.

At the time of the Reformation, a new name was given to those who followed the teachings of the Bible alone and rejected Rome's claims.... They were called Protestants . . . but they are the true CATHOLIC and ORTHODOX CHRISTIANS.

Ferocious battles were fought by the Papacy to subjugate the 2nd Rome to the Latin church. During the 4th Crusade in 1204 A.D., the Latins attacked Constantinople and completely destroyed the city.

Finally in 1453, the Papacy used the Turks to bring an end to the Constantinean Roman dynasty.

After that defeat, the Orthodox Church moved to Moscow and that city became known as the 3rd Rome.

The Orthodox Church preserved the manuscripts of the Greek New Testament....The conquest of Constantinople by the Turks caused many of the Greek scholars to flee to Italy bringing their manuscripts with them. These manuscripts of the Greek New Testament are called the "Byzantium Codex". Many scholars consider them to be the most authentic of the three major manuscripts available today.

Erasmus of Rotterdam, Holland used these ancient manuscripts to prepare Latin and Greek editions of the New Testament.

Martin Luther and the other Reformers used the Latin and Greek editions of Erasmus to translate the Scriptures into the living languages of Europe.

The ruler of Russia became known by the title TSAR which means Caesar. Caesar in Latin means "hairy" and was the title of the Roman Emperors in Constantinople. After the Fall of Constantinople, the Sultans of Constantinople . . . and the Tsars of Russia claimed to be the successors of the Caesars.

Ivan Vasilyevich was the first Russian ruler to call himself TSAR or CAESAR....That was because he saw himself as successor and protector of the Greek Orthodox Church which escaped from Constantinople to Russia.

Ivan wasn't so TERRIBLE. . . at least not before the Jesuits tried to poison him. His marriage to Anastasia Romanovna who founded the Romanov dynasty which lasted until its overthrow by the "Communists" in 1917.

One of those sumptuous poses is actually the 'hidden hand'. History teachers have tried giving an explanation why, for instance, Napoleon, was always posing with one hand inside his shirt. The reasoning goes something like this:

"Many theories have been presented as to why Napoleon is traditionally depicted with his hand in his waistcoat. Some of these theories include: he had a stomach ulcer, he was winding his watch, he had an itchy skin disease, in his era it was impolite to put your hands in your pockets, he had breast cancer, he had a deformed hand, he kept a perfumed sachet in his vest that he'd sniff surreptitiously, and that painters don't like to paint hands" -Tom Holmberg

Except that all the people we mentioned in this post had some problem with their hands, which they surely didn't, then the gesticulation has to have another obscured specific sense. As a matter of fact, yes it does. Most of the men using this gesture are members of the Freemasons. The significance of this sign in the Masonic rituals is quite big. Therefore, it's highly unlikely the repetition of it to be only a result of a coincidence.

The gesture is notable within the ceremonies of the Royal Arch Degree of Freemasonry. The world leaders that use it are elegantly saying to the others: *"This is what I'm part of, this is what I believe in and this is what I'm working on"*.

The Royal Arch Degree is also known as the Mason of the Secret. During this Degree, initiates are believed to accept grand Masonic honors.

"The members of this Degree are denominated companions, and are "entitled to a full explanation of the mysteries of the Order"; whereas in the former Degrees they are recognized by the common, familiar appellation of brothers, and kept in a state of profound ignorance of the sublime secret which is disclosed in this Chapter. This accords with the custom of Pythagoras, who thus distinguished his pupils. After a probation of five years, as stated before, they were admitted into the presence of the preceptor, called his companions, and permitted to converse with him freely. Previous to the expiration of that term he delivered his instructions to them from behind a screen" -John Fellows, Fellows' Inquiry into the Origin, History, and Purport of Freemasonry.

"If we pass on to the Royal Arch, we receive a wonderful accession of knowledge, and find everything made perfect; for this is the nec plus ultra of Masonry, and can never be exceeded by any human institution."-George Oliver, Lectures on Freemasonry

This holy name is Jahbulon, a word compound meaning “god” in Syriac, Chaldaic, and Egyptian.

1. 1. JAH. This name of God encounters in the 68th Psalm, vs. 4.
2. 2. BAAL OR BEL. This word means a lord, master, or possessor, and thus it applies to many nations of the East to stand for the Lord of all things.
3. 3. ON. This is the name Egyptians worshiped as JEHOVAH.

The initiation ritual to this title represents the return to Jerusalem of three excellent Masons who were imprisoned in Babylon.

At one instant, the initiate needs to receive a secret password and a hand sign in exchange for going through several veils.

The images below illustrates the hand sign they need to do in order to go into the second veil, as shown in Duncan’s handbook *‘Masonic Ritual and Monitor’*:

“Master of Second Veil: “Three Most Excellent Masters you must have been, or thus far you could not have come; but farther you cannot go without my words, sign, and word of exhortation. My words are Shem, Japhet, and Adoniram; my sign is this: (thrusting his hand in his bosom); it is in imitation of one given by God to Moses, when He commanded him to thrust his hand into his bosom, and, taking it out, it became as leprous as snow. My word of exhortation is explanatory of this sign, and is found in the writings of Moses, viz., fourth chapter of Exodus”:

As we said before, this hand sign got the inspiration from the Exodus 4:6. Namely, in this biblical verse, the heart (bosom) is actually what we are, the hand for what we do.

The figurative importance of this gesture might reveal the reason why the famous Masons use it so often. The 'hidden hand' allows the other initiates to know that the other person is part of this secret Brotherhood.

Moreover, the hand that performs the actions is inside the piece of cloth, which can metaphorically relate to the secret nature of Mason's activities.

Here are some famous world leaders that used the famous hand sign:

1. Napoleon Bonaparte



Napoleon Bonaparte (1769-1821) was a military and political ruler of France. His work formed the European politics in the 19th century.

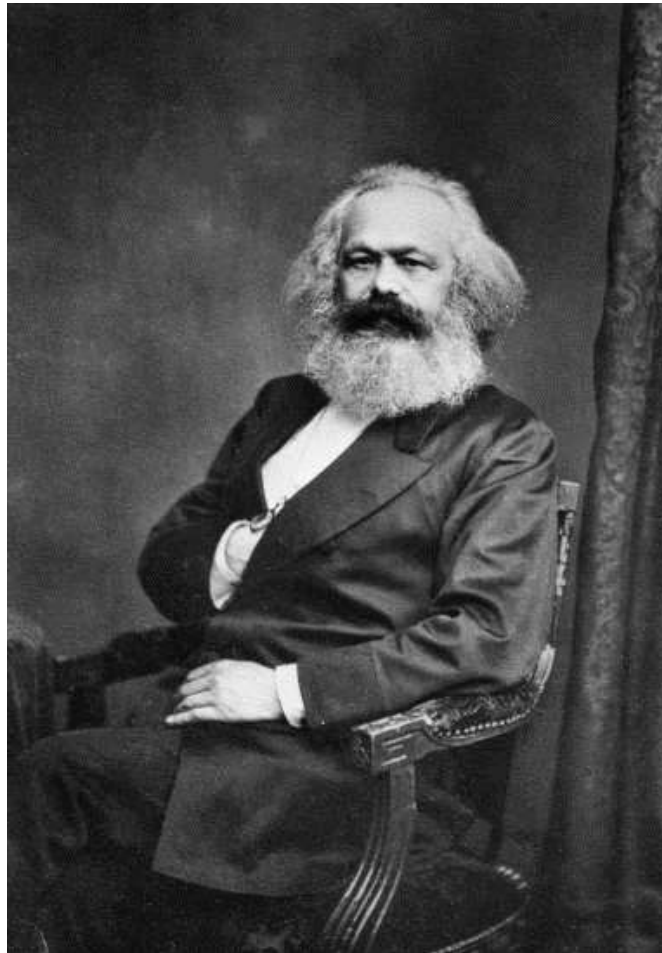
He was part of the Army Philadelphie Lodge in 1798. His brothers, Joseph, Lucian, Louis and Jerome, were also Freemasons. Similarly, five out of six members of Napoleon's Grand Council were also Freemasons.

Bonaparte's connection with Masonry has always been a subject in all the historical records. Masonic researcher J.E.S. Tuckett said:

“It is strange that evidence in favor of the Great Napoleon's membership of the Masonic Brotherhood has never been examined in detail, for the matter is surely one of interest, and — seeing the remarkable part that remarkable men played in the affairs of Europe, at a time when Continental Freemasonry was struggling out of chaos into regular order — it cannot be without an important bearing upon Masonic history”

Some people also said Napoleon had help from supernatural energies. In 1813 he lost the battle at Leipzig. Behind him, he left a “Cabinet of Curiosities” in which a Prussian officer discovered his Book of Fate and Oraculum.

2. Karl Marx



Karl Marx is the father of modern Communism. Although some Masons have rejected him, Marx is believed to have been a 32nd degree Grand Orient Freemason.

He became the representative of the atheist and socialist movement of Europe. Moreover, he proposed a substitution of monarchies with socialist republics.

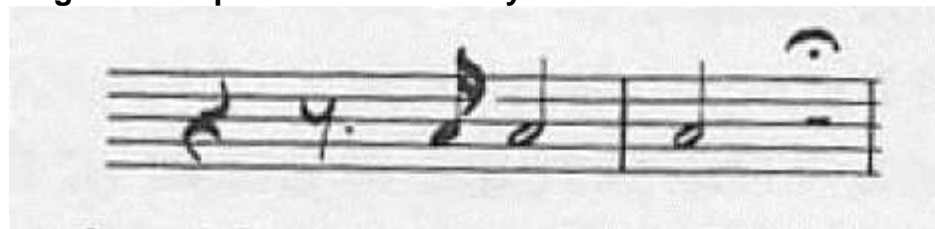
3. Wolfgang Amadeus Mozart



The wunderkind, Wolfgang Amadeus Mozart is one of the most productive composers in the music history.

He was also a Freemason, initiating in the Austrian lodge Zur Zur Wohltatigkeit in 1784.

Mozart's pieces often combined prominent Masonic elements. For example, The Magic Flute opera was essentially based on Masonic beliefs.

4. Marquis de Lafayette



Marquis de Lafayette was a 33rd degree Freemason. More than 75 Masonic organizations in the U.S. got its name after him.

According to Denslow's 10,000 Famous Freemasons, Lafayette was a French military officer, a general in the American Revolutionary War and a leader of the Garde Nationale in the bloody French Revolution.

5. Simon Bolivar



Many people envision “El Libertador” – Simon Bolivar as the “George Washington of South America”. He banded with Freemasonry in Cadiz, Spain and earned the Scottish Rite degree in Paris.

Bolivar also served as the president of Colombia, Peru and Bolivia in the 1820’s. He belonged to the Order and Liberty Lodge No. 2 in Peru.

6. George Washington



George Washington was one of the founders of the U.S. He is moreover the “most important American Mason”. Freemasonry in America has always been conflicted about Washington’s bifurcated image as being a Mason as well as the Father of the United States of America. Depending on whether one is a Freemason really depends on how one should view George Washington. We know that George Washington converted to Roman Catholicism upon his death bed. Cris Pinto writes of from an article posted on Irish Nationalism titled, “George Washington’s Death Bed Conversion to Catholicism”

George Washington, the first president of the United States, served from 1789 to 1797 in that capacity. A popular slogan concerning him was that he was “first in war, first in peace, and first in the hearts of his countrymen.”

On December 13, 1799, Washington (aged 67 years) was exposed to a storm of sleet and developed a cold. He rested in bed at his home in Mount Vernon, Virginia.

On the morning of the 14th at 3:00, he had a severe attack of membranous croup. At daybreak, Mrs. Washington sent for the only physician, Dr. Craik. Two other physicians also came, but all three together could not save him. Washington died between 10:00 and 11:00 that night.

About four hours before Washington's death, Father Leonard Neale, a Jesuit priest was called to Mount Vernon from St. Mary's Mission across the Piscataway River. Washington had been an Episcopalian, but was baptized into the Roman Catholic Church that night. After Washington's death, a picture of the Blessed Virgin Mary and one of St. John were found among the effects on an inventory of articles at his home. George Washington had an interest in Roman Catholicism for many years. His servant Juba stated that the General made the Sign of the Cross before meals. He may have learned this practice from his Catholic lieutenants, John Fitzgerald or Stephen Moylan. At Valley Forge, Washington had forbidden during "Pope's Day," the burning in effigy of the Roman Pontiff. As President, Washington slipped into a Catholic Church several times to attend Sunday Mass.

Pope Leo XIII (1878-1903) praised George Washington highly in an encyclical *Longinque Oceani* of January 6, 1893, to the bishops of America: *"We highly esteem and love exceedingly the young and vigorous American nation, in which we plainly discern latent forces for the advancement alike of civilization and of Christianity. . . Without morality the State cannot endure – a truth which that illustrious citizen of yours, whom we have just mentioned [‘the great Washington’] with a keenness of insight worthy of his genius and statesmanship perceived and proclaimed. . . Thanks are due to the equity of the laws which obtain in America and customs of the well-ordered Republic. For the Church amongst you, unopposed by the Constitution and the government of your nation, fettered by no hostile legislation, protected against violence by the common laws and the impartiality of the tribunals, is free to live and act without hindrance."*

Washington was a student of the writings on political philosophy of St. Robert Bellarmine and St. Thomas Aquinas. George Washington, James Madison, and some of the other Founding Fathers incorporated into the Constitution in 1787 some of these two saints' ideas about how to set up a Republic. In a like manner, Thomas Jefferson had studied these saints and incorporated some of their concepts into the Declaration of Independence in 1776.

A question, therefore, the reader can pose to friends is as follows: Who was the first man who served as U.S. President, who was at the time of his death a Roman Catholic? Most people will say John F. Kennedy, but the correct answer is George Washington, the Father of our Country. –(Cris Pinto, *'The Hidden Faith of the Founding Fathers'*, DVD.)

7. Joseph Stalin



Stalin's terror of ruling in the Soviet Union was the reason for the deaths of millions of his own compatriots.

However, there are no official records that point out Stalin initiated into Masonry. Of course, dictators like him controlled all information regarding themselves and their activities, making it hard to prove anything one way or the other.

To emphasize, the leaders using the hidden hand signal had a great influence on world history and many of them are proven to be Masons.

This gesture is an explicit detail, yet people widely ignore it. This suggests the leaders' belief in an obscure ideology.

Since the publication of the King James Bible, the Jesuits and their agents have been trying to replace it with other Jesuit modern versions, which bring down the deity of Jesus Christ, and which remove multitudes of verses to water it down. A watered down inaccurate Bible becomes a useless tool in the hands of a Christian, and therefore they lose their authority to come against Satan and his demons. The Jesuits are like a cunning special forces soldier that has come into the camp of the Christian, and tampered with his weapon, to give Satan an advantage and to weaken the Christians weapons. This is one way the Jesuit protects his master Satan and the demons. It is only a born again Christian who knows the Bible and has the Holy Ghost in him, who can actually entrap and cast away these notorious spirit beings (Satan and his demons) who control the illuminati.

This dumbing down of the Roman Catholic congregation is spread throughout the Protestant denominations, as the Jesuits recruit Protestant preachers through Freemasonry. As we read various reports in today's media, where we have well known Protestant Ministers saying that, we need to unite with the Vatican, we can observe the Jesuit influence has moved throughout many church denominations and is not isolated to the Roman Catholic Church. The Jesuits job is to control anyone interested in Christianity and protect Lucifer from them. The Jesuits are Satan's bodyguards on earth that is why they are so high up in the illuminati.

There are numerous publications that have documented Protestant born again Christians who know the Bible, who have interacted with Lucifer and his demons, and have successfully been able to: rebuke, control, bind and successfully fight against these spirit beings using principles outlined in the Bible. It is these people that the Jesuits fight against to protect Lucifer. According to Alberto Rivera, the Jesuits poison and murder any Christian who will not submit to the Pope's agenda. Alberto Rivera also explains how he was involved in various operations, which involved infiltrating Protestant churches and destroying them from within. The Jesuits engage in these operations to protect Lucifer and expand his Kingdom.

The Jesuits have also been involved in murdering and persecuting genuine followers of the Jewish religion. The Jesuits in control of the Bavarian illuminati raised up Hitler and the Nazi's to persecute and kill many Jews who followed the Old Testament Bible, the Jesuits also used the Nazi's to kill many Christians as well. Multitudes of Christians who wanted to follow righteousness also perished with Jews in the many Nazi death camps. Although many researchers claim the Jews run the illuminati, some people in the illuminati may be Jew by birth and have Jewish genes, but they have forsaken their Jewish religion and are following the Luciferian religion whose leadership is Jesuit. I

suspect the Jesuit places Jews in visible power positions so the blame of world problems is then blamed on the Jew. In most cases the Jew is the money manager and accountant for the Jesuit, the money Jew in the illuminati manages and operates the money under Jesuit directions.

The Masonic Jews in Israeli government who work for the Jesuits are also not managing the nation of Israel for the benefit of the many common Jews. Large chunks of land are often given away to extremist Islamic groups to create continued unrest and civil wars in the region, the Masonic Jews in political power in Israel want to keep the unrest going, so the UN can intervene and take over Jerusalem for the Jesuit Pope.

In the past Rabbi Kahane (an Israeli politician) wanted to give Arabs/Muslims living in Israel, large sums of money to relocate outside of Israel. This would have created peace and better living standards for Arabs, as Israel and Palestine have become recruiting grounds for Islamic extremists, who thrive on the poverty of Arabs and recruit them into extremist groups to attack Jews in Israel. Violence between Muslims and Jews in Israel is an ongoing civil war, Jews and Muslims have not been able to live peacefully for centuries, as both ideologies are in major conflict with each other. After Rabbi Kahane tried to give financial relocation assistance to Arabs and make Israel exclusively Jewish, he was thrown in Jail by Israeli Masonic Zionist Jewish politicians.

I do believe that the Jews deserve to be in Israel as God gave them that land in the Bible, but they are not living peacefully there as Islam and Judaism have never been able to exist peacefully. The ideal solution is to relocate the Muslims/Arabs elsewhere and give them funds to start a better life somewhere, away from the Middle Eastern civil war, and away from Islamic extremism, so they can choose an ideology and lifestyle independently, without bias coercion from extremists who thrive in poverty situations. But if you do the research, and it's my opinion that the Zionist Israeli Masonic politicians are working with Masonic Islamic leaders, to keep fomenting trouble occurring in that region, so the Jesuits can bring Israel under UN control and install their Antichrist Pope as King of Jerusalem.

Many of the top leaders in the illuminati have roots in Nazism and the Illuminati is certainly not a Jewish conspiracy, although some Jews may be working for the Jesuits in the illuminati in various offices (mainly banking).

Many of the leading personalities in the Illuminati are former Nazi's and have been trained by Nazi's, and as already discussed the Nazi's and Hitler were raised up and controlled by the Jesuits. The Nazi SS itself was designed after the Jesuit Order.

"Himmler used the Jesuits as the model for the SS, since he found they had the core element absolute obedience and the cult of the organization. Hitler is also said to have called Himmler "my Ignatius of Loyola". (Wikipedia)

The Nazi's and the SS were an expression of the Jesuit Order and illuminati, and the Nazi era itself was used as a training ground to develop many of the Jesuit Order and

Illuminati's systems. Death and prisoner camps such as Auschwitz, were used to imprison expendable people, that the Jesuit mad scientists could use as Guinea pigs, when they experimented on people with satanic ideologies and satanic science.

It was in these Nazi death camps that most of the mind control and systems the Jesuits and illuminati use today were developed. The Jesuit illuminati went through a big revival after Theodore Reuss revived the illuminati in Munich, Germany, and that revival and evolution continued in Germany as the occult revival birthed the Nazi party and Hitler. Hitler and the top level Nazi officials were members of an Illuminati organization known as the Thule Society, which sprang up in Germany as a result of Theodore Reuss's occult revival.

Once the Jesuit/illuminati Nazi's finished their experimentation at the Nazi death camps, the Jesuits used the allies to bomb and destroy the mainly Protestant Christian areas of Germany, particularly Protestant Dresden at the end of the war to kill as many Christian heretics as they could. Remember that the Jesuits controlled the allies and Nazi's at this time, and once they had used the allies to bomb the Christian heretics in Germany, they then rescued all their top Nazi Illuminati officials through programs such as Operation Paperclip. Through the American program called "Operation Paperclip", many top Nazi Scientist's and Nazi officials were brought back to the United States and absorbed into the US intelligence agencies. Upwards of 15,000 were integrated into U.S. society with false identity papers provided by the U.S. government. Many top Nazi's and SS officer's became leading Illuminati figures in the USA, as they had brought back knowledge from Germany they had learnt in the concentration camps.

Nazi SS officer Joseph Mengele became a high level figure in the U.S. branch of the Illuminati and the international illuminati. Mengele was involved in producing unquestioning Illuminati soldiers, spies, assassins and servants. There are literally too many reports of Mengele operating in the CIA and other U.S. intelligence agencies to report, he has been identified by mind control victims who have testified at public hearings on numerous occasions.

Joseph Mengele was a doctor who worked at the Nazi death camp known as Auschwitz, it is at this camp that he tortured and experimented on people. It has been reported that he would torture people to the extreme, to calculate how much torture the average person could tolerate before they died. He would later use these torture techniques to develop multiple personality disorder in his subjects, so that he could create multiple personalities in one person, and use each personality for various purposes, without the principle personality knowing what the other internal personality was up to. This phenomena was dramatized in the movie "*The Manchurian Candidate*" where a politician would receive a phone call and a key word was told to him on the phone, once this key word was recited, the politician would go into a trance and become a different person who would murder on command. After the politician would kill someone after going into a trance and literally turning into a different person, he would then forget what happened and could not even remember killing anyone. This is the sort

of mind control that Mengele had developed by experimenting with patients in Auschwitz, using various techniques that involved torture and drugs.

There have been a number of ex illuminati members who have come out of the organization, and stated that Joseph Mengele was operating as a programmer in the United States on members of the U.S. illuminati. One woman recalled how as a girl Mengele would program her by forcing her to kill a chicken (assassination programming) and when she wouldn't comply, Mengele would cut off her hair and take away her toys and belongings. This technique Mengele applied was used at Auschwitz and is basic Auschwitz programming. It's well documented that the first thing that happened to Auschwitz prisoners, was that their hair was shaved off, and their belongings and possessions were seized. This was Jesuit/illuminati experimentation on how to humiliate and mind control subjects, and get them to do what you want them to do.

According to my research, I do believe Joseph Mengele was a part of the U.S. Operation Paper Clip, and that he was absorbed into either the CIA or NSA (maybe both) and used by the Jesuits to program and control members of the Illuminati in the USA and abroad. I believe the Jesuits and Illuminati brought many Nazi's into the USA and placed them in key positions in the CIA and NSA, and I believe there is a big Nazi influence in the U.S. intelligence agencies up until today. The Nazi's in the USA's; CIA, NSA and other intelligence agencies, make up much of the Jesuit/illuminati apparatus in the USA.

A Nazi underground cell was found a half block away from where I lived as a teenager in the 1950s. The owner of the building rented it to a former Nazi SS soldier. I remember the chatter and concern of the neighbors when it became known. Two of my friends and me went inside and saw all the Nazi flags and propaganda on the walls of the basement.

Even until today, NSA agents such as Colonel Michael Aquino are known to dress up in Nazi uniforms and participate in Nazi occult rituals. Michael Aquino has stated on record that his religious beliefs sometimes do involve Nazi ideologies. So here we see that the Nazi ideology in U.S. intelligence agencies is alive today. The U.S. intelligence agencies which were full of Jesuit/Illuminati agents, embraced these Nazi's that came to them through Operation Paperclip, and also embraced many of their ideologies as they were occult Luciferian brothers. The United States today is still at war with the Nazi factions, which now fight the U.S. populace through U.S. intelligence agencies they are agents of. The Nazi's and Jesuit/Illuminati fight the U.S. through these intelligence agencies, by recruiting and training mind control slaves through CIA programs such as MKUltra, and using these slaves to assassinate and spy on their enemies in the USA. They also use the CIA and NSA to start up various cults and movements to stir up trouble in the USA.

I also believe many of the mass shootings in schools and other places in the USA are committed by Nazi, CIA, NSA mind-control victims, the Jesuit/illuminati use these mind control victims, to create these shootings so they can take away US citizen's guns.

Once US citizens have their guns seized, then the world government can send world government troops into the USA, and enforce UN laws that contradict the US constitution. If U.S. citizens have no guns, they cannot resist the: world government, world army and world police that the Jesuits want to implement over every country in the world.

The Jesuits/illuminati want a world government that's: Nazi fascist, communist and totalitarian, and remember that the first thing Hitler and the communist leaders did, was take away everyone's guns, so they couldn't defend themselves against a fascist government. The Jesuit/illuminati want to erect their Jesuit Pope as King of the world and god, whom they will force everyone to worship by placing a microchip in your forehead or hand so they can have full control of you, in the Bible this microchip is known as the mark of the beast, and if you take this mark you will be damned forever as you have made an allegiance with Satan.

“And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads: ¹⁷And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name. ¹⁸Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six”. -(Revelation 13:16-18)

Tsar Alexander I was one of Russia's greatest Tsars....He is known in history as the conqueror of Napoleon Bonaparte. The invasion of Russia and the fires of Moscow enlightened his soul to the true nature of the Bonaparte regime.

From that time onward until his untimely death, the Holy Scriptures were his constant guide. He took personal command of the army and led it all the way to Paris and the overthrow of Bonaparte. When Napoleon reached Moscow and set the city on fire, the Tsar had a mighty spiritual awakening which showed him the true nature of Napoleon Bonaparte:

Alexander went forward with his army in a state bordering on religious ecstasy. More and more he turned to the eleventh chapter of the Book of Daniel with the apocalyptic vision of how the all-conquering King of the South is cast down by the King of the North. It seemed to him as if the prophecies, which had sustained him during the dark days of autumn and early winter, were now to be fulfilled: Easter this year would come with a new spiritual significance of hope for all Europe.

'Placing myself firmly in the hands of God I submit blindly to His will', he informed his friend Golitsyn from Radzonow, on the Wkrka. 'My faith is sincere and warms with passion. Every day it grows firmer and I experience joys I had never known before....It is difficult to express in words the benefits I gain from reading the Scriptures, which previously I knew only superficially... All my glory I dedicate to the advancement of the reign of the Lord Jesus Christ.' (Palmer, 'Alexander I Tsar of War and Peace", p.260).

Napoleon was a secret agent of the British Empire so he didn't care how many French soldiers died in the bitter cold. Napoleon's disastrous retreat from Moscow cost him 570,000 soldiers. The defeat of Bonaparte ended the Jesuits dream of using Napoleon to annex the Orthodox Church to the Latin Papacy.

Napoleon arrived back in France with his Grande Armée reduced by 570,000 of his best soldiers....He was forced to abdicate and Tsar Alexander was careful to let the French people choose their own government. The victorious Allies entered Paris in March 1814, led by Tsar Alexander I.

Inspired by his new found faith, Alexander proposed a Holy Alliance of peace and Christian charity among all the states of Europe. What was most surprising was that, only Great Britain, the Vatican, and the Turks refused to sign.

The monarchy was restored when Bourbon King Louis XVIII assured the Tsar that he would respect the constitutional rights of the French people.

This GREAT Tsar was absolutely horrified by the slaughter of the Napoleonic wars, so he proposed a treaty of friendship among all the European states called the Holy Alliance. This alliance was to instill the Christian virtues of charity and peace in European political life.

In conjunction with the British Bible Society, he arranged for the translation and distribution of the Scriptures throughout Russia. This also earned the Tsar the undying hatred of the Jesuits. The Holy Alliance and the distribution of the Scriptures ended with the untimely death of the Tsar by poisoning on December 1, 1825, in the Russian city of Taganrog.

Tsar Alexander I was one of Russia's greatest Tsars....He is known in history as the conqueror of Napoleon Bonaparte.

Tsar Alexander I (1777–1825), reigned from 1801 to 1825. The invasion of Russia and the fires of Moscow enlightened his soul to the true nature of the Bonaparte regime. From that time onward until his untimely death, the Holy Scriptures were his constant guide. He took personal command of the army and led it all the way to Paris and the overthrow of Bonaparte. Napoleon was a secret agent of the British Empire so he didn't care how many French soldiers died in the bitter cold.

The defeat of Bonaparte ended the Jesuits dream of using Napoleon to annex the Orthodox Church to the Latin Papacy.

Napoleon arrived back in France with his Grande Armée reduced by 570,000 of his best soldiers....He was forced to abdicate and Alexander was careful to let the French people choose their own government.

The victorious Allies entered Paris in March 1814, led by Tsar Alexander I. The Tsar died of poisoning on December 1, 1825, in the Russian city of Taganrog.

Inspired by his new found faith, Alexander proposed a Holy Alliance of peace and Christian charity among all the states of Europe.

Only Great Britain, the Vatican, and the Turks refused to sign.

The monarchy was restored when Bourbon King Louis XVIII assured the Tsar that he would respect the constitutional rights of the French people.

Nicholas and Alexandra ruled the vast Russian empire from Poland in the West to the Pacific Ocean in the East. They had 4 daughters, and one son named Alexei.

Rasputin gained entrance to the Russian royal family by means of a close friend of the Tsaritsa. Tsarevich Alexei had a blood disease known as hemophilia which was life threatening. When Rasputin entered his presence, the bleeding miraculously stopped!!

This gave him an opportunity to become the father confessor and political adviser to the Tsaritsa and thus influence her husband the Emperor. Rasputin gained total ascendancy over the royal family through his healing of the Tsar's son. At the beginning of WWI, Rasputin's advice caused the Tsar to make disastrous decisions on the battlefield, leading to the withdrawal of Russia from the war.

Cartoons began to appear on the streets of St. Petersburg showing the Tsar as a puppet of Rasputin and the Tsaritsa as his alleged lover.

Two patriotic Russians named Prince Felix Yusupov and Grand Duke Dmitri Pavlovich decided to get rid of Rasputin in order to save their country. It's doubtful that they knew he was a Jesuit in disguise but they knew he was a menace to the royal family and the nation. On December 16, 1916, he was lured to the Yusupov's Moika Palace, and served massive amounts of cyanide. The cyanide failed to kill him, so he was shot several times, and his body was dumped into the Neva River.

The Russian Revolution was the work of the Okhrana—the Russian branch of the British Secret Service. The chief of the Western European branch of Okhrana, Pyotr Ivanovich Rachkovsky, was based in Paris. Rachkovsky worked closely with John E. Wilkie, William Melville and Harry Houdini.

The murder of Rasputin delayed . . . but did not eventually stop the Russian Revolution. The cover for the Russian Revolution was atheistic Marxist-Leninism.

This invasion, called Operation Barbarossa, seized huge amounts of territory, including the Baltic States, Belarus, and the Ukraine.

To the great regret of Hitler and Stalin, Greece and Serbia delayed Operation Barbarossa by up to 4 weeks . . . and by that delay cost Nazi Germany the war.

Nazi Germany was finally defeated by Russia in 1945 and Adolf Hitler retired to Patagonia, Argentina.

For 70 years the Soviets relentlessly attacked the Orthodox Church. The Orthodox priests were their special targets. Many were sent to the Gulag and most of their churches and schools were closed. It was the longest sustained persecution in the entire history of the world:

"For seventy years the official ideology of the USSR was "scientific atheism," carefully termed "Marxism-Leninism" for Western consumption. Lenin and Stalin were equal opportunity haters of all religions, but Russian Orthodoxy, state faith of the tsarist empire, was their special target. Khrushchev, who passed as a reformer in the West, confidently predicted that "the last remaining priest would be exhibited at a museum twenty years hence." He did not specify if this cleric would be stuffed or live, but his point was clear.

"Though Khrushchev fell from power in October 1964, the anti-Orthodox campaign did not let up. And yet, on an August afternoon in 1987, it looked as if the sun shone over a service that had been running continually since 1917. The packed cathedral, the icons, the ecstatic believers, the beautiful liturgy, and the exquisite robes of the two patriarchs seemed as if nothing had changed. Only the artificial bright lights of the Soviet television crew and its huge black boom and cameras betrayed the date." -(Garrard, 'Russian Orthodoxy Resurgent', pg. 6).

Imagine the shock of the Jesuits when the Soviet Union collapsed and Orthodoxy was not dead but showed vital signs of coming to life again under Patriarch Alexy II. One of my greatest educational experiences in college was my two-semester courses in Russian History. I always took extra courses during summer sessions and in my Junior year, I was able to do the six-credit hours during back-to-back summer session. By taking advantage of attending summer sessions, I was able to do a triple-major in my

undergraduate four years at Waynesburg College. My academic mentor who taught the course in Russian History was also a Major in the Pennsylvania National Guard unit based in Waynesburg, PA.

The information shared in this segment provides sufficient background history, proof-positive history that the Jesuit Vatican Papacy has been obsessed with the conquering of the Russian nation when the Jesuits were driven out of the country. Even as Russia’s forces struggle to pacify Ukraine, having had to retreat in recent weeks after taking ground in the country’s eastern reaches early in the February invasion, Moscow still maintains a substantial nuclear arsenal and the means to deliver warheads in ways even the U.S. could not stop, via Mach 5 Zircon hypersonic missiles.

According to investigative journalist Jack Murphy, the CIA is supposedly using long-dormant sleeper cells that have been activated by an unnamed NATO ally’s spy service, which are working to hinder Russia’s war effort from behind the lines.

“Years in the planning, the campaign is responsible for many of the unexplained explosions and other mishaps that have befallen the Russian military industrial complex since Russia’s full-scale invasion of Ukraine in February, according to three former U.S. intelligence officials, two former U.S. military officials and a U.S. person who has been briefed on the campaign,” he reported on his website. *“The former officials declined to identify specific targets for the CIA-directed campaign, but railway bridges, fuel depots and power plants in Russia have all been damaged in unexplained incidents since the Kremlin launched its full-scale invasion of Ukraine in February.”*

He went on to report:

While no American personnel are involved on the ground in Russia in the execution of these missions, agency paramilitary officers are commanding and controlling the operations, according to two former intelligence officials and a former military official. The paramilitary officers are assigned to the CIA’s Special Activities Center but detailed to the agency’s European Mission Center, said the two former intelligence officials. Using an allied intelligence service to give the CIA an added layer of plausible

deniability was an essential factor in U.S. President Joe Biden's decision to approve the strikes, according to a former U.S. special operations official.

Murphy says that operational command and control over the sabotage missions reside solely with the CIA *"for legal reasons."* Still, he added that the unnamed NATO ally has a great deal of influence over which missions are actually carried out since that country's sleeper cells are on the ground taking risks. He went on to say that the NATO ally, in particular, is not a client state for the CIA or a proxy, but rather that there is a close partnership involved. Murphy said he would not identify the country by name other than to say it is located in Europe.

Murphy also noted that any covert actions launched by the CIA must first be authorized by presidential order, most likely classified, so it's obvious Roman Catholic Biden's handlers know what is going on, even if they are not completely competent at what they are doing.

"After the U.S. intelligence community concluded that Russia had interfered with the 2016 U.S. presidential election, President Barack Obama signed such a finding for covert action against Russia before he left office, according to The Washington Post," Murphy reported. (Note: Multiple investigations have concluded that Russia did not *"collude"* with the Trump campaign to *"steal the election"* from Hillary Clinton, and in fact, her campaign paid for bogus 'dossier' that was fed to a former British spy by Russian intelligence.)

"The finding involved the National Security Agency and the military's Cyber Command in addition to the CIA and included a scheme to plant 'cyber weapons in Russia's infrastructure,' according to the Post," Murphy reported.

The journalist also noted that after Russia's invasion, alarmed NATO allies activated cells within their own countries, and they are also involved in sabotage missions inside Russia itself, outside of the CIA's purview.

Following Ukrainian President Volodymyr Zelenskyy's historic visit to the U.S. two weeks ago, Congress passed a provision to give Ukraine the assets that were seized from sanctioned Russian oligarchs. These assets are not small change and are valued at \$88-billion dollars. Put yourself in the mind of President Putin and speculate on what comes next!

The approval of the measure may have had something to do with a secret phone call between Zelenskyy and Senator Mitch McConnell, according to *'The Pittsburgh Post-Gazette'*. The outlet reported Thursday that the Ukrainian president called the Senate minority leader one day before his White House visit and address to Congress.

Three unnamed sources told the *'Post-Gazette'* about the call, in which Zelenskyy attempted to persuade McConnell that proceeds from the oligarchs' seized assets,

including super-yachts and mansions, should be used to help Ukraine rebuild from the devastation of the war.

The provision ultimately passed as an amendment to the \$1.7 trillion bipartisan spending bill that passed the Senate in a 68-29 vote on December 22, and passed the House the following day. The bill also included \$45 billion in emergency assistance to Ukraine. Total U.S. funds given to the Ukraine now total \$117 billion dollars.

President Joe Biden signed the bill into law Thursday evening.

During Zelensky's visit to the U.S. also announced an additional \$1.85 billion in military assistance to Ukraine.

The U.S. has frozen or seized billions of dollars' worth of assets belonging to sanctioned Russian oligarchs since the invasion was launched in February. The U.S. was limited in how it could use those assets, though President Joe Biden as early as April floated a plan to sell those assets to help Ukraine.

Representatives for McConnell and Zelensky did not immediately respond to Insider's request for comment.

In the larger view of this bottomless pit called Ukraine, U.S. leadership are not interested in negotiations, but rather are only interested in the prolonging of the pain and suffering. Mistakenly the Obama/Biden team is only interested in the destruction of the United States as a sovereign nation. 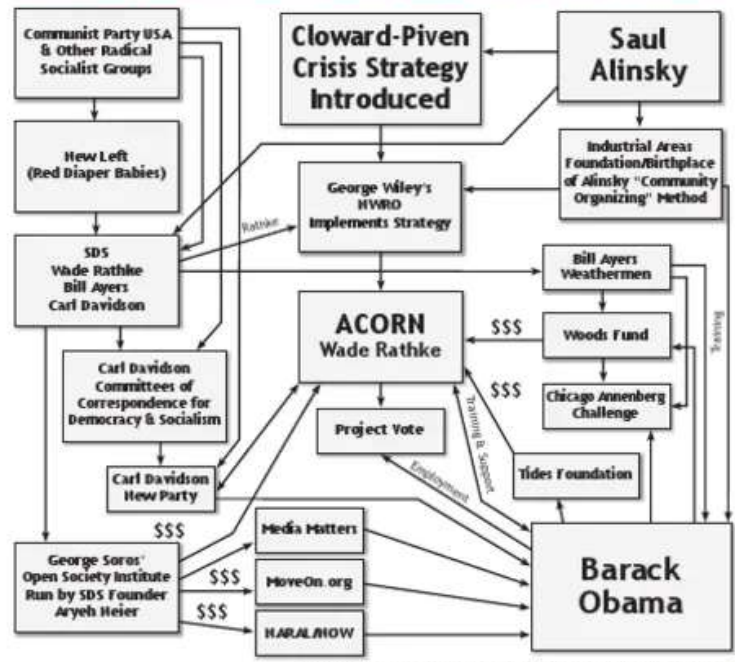

The numbers of illegals crossing over the southern border into America are staggering. In the second year of the Biden Administration, FY 2022, (ending Sept. 30, 2022) **2.7 million illegals crossed into the U.S. according to Customs and Border Patrol.** (In just 12 months, that equals the population of Chicago).

Since September, the numbers are soaring with each passing month. “Anyone that is struggling with their rent, immigrants or migrant workers from Mexico, and others that are homeless, can apply to transitional housing or homeless shelters. This Catholic Charities service gives support to people who were recently evicted or that have some other barrier, such as maybe a disability or they are a senior on a fixed income.”

“Many of the Catholic Charity clients to these temporary housing resources are people who have been in and out of the local shelters numerous times. Others are facing a one time crisis, such as a job loss. The El Paso TX Catholic Charities will try to help clients become stabilized. Then, once that has been done, the next step is to locate new permanent apartments in the community and learn to access and use other local relevant providers.”

Wait, More perks lurk....:

“Case Management and help for immigrants, migrants and asylum seekers”
“Catholic Charities, both in El Paso County Texas as well as nationwide, assists those people, no matter their race, religion, or backgrounds, that have moved to the El Paso area. There is support for refugees, immigrants, Spanish speakers, and others from out of state or the country, including from across the border. The non-profit can help people find, and pay for, county Identification Cards. This can be a driver’s license, birth certificate, or social security card among others.”

“Immigrants, migrants and asylum seekers can get assistance. There is free or low cost legal aid. Get help with acclimating to the region, such as ESL Classes or assistance in locating basic needs, including food or housing as well as hygiene items. Catholic Charities will help migrants / immigrants with trying to get Green Cards, the naturalization process, and navigating the complex process on citizenship.”

“Financial aid can be used for El Paso County Identification cards. These are critical for newcomers. As proper ID is essential for obtaining any type of government benefit or employment. As far as the legal support, this is generally low cost.” Read more on [resources for immigrants](#).”

Hold on, even more freebies await the lawbreakers....:

“Assistance for undocumented or illegal immigrants”

“Undocumented immigrants, as well as those that are legally in this country, can get assistance for their needs as well. There are states that can provide government benefits as well as several charities that offer help in an emergency. Everything from housing placement to free food for undocumented immigrants or migrants, financial assistance for paying bills, employment opportunities, legal protections, cash aid, and other support may be given to immigrants as noted below.”

“Services are often provided in many languages as well. Immigrants that speak Spanish, Mandarin, Vietnamese, or any other number of languages can apply for assistance. There is also help provided for undocumented children who tend to be most vulnerable without some form of support. Another focus is on protecting senior citizens as well as the elderly. The primary resources, as well as agencies for legal or undocumented or illegal immigrants to contact are below. Each of them focuses on different needs.”

“As noted, some assistance is generally available, especially for housing, rent, food, medical care, and critical needs. However there are no guarantees to getting help, in particular for immigrants with no documentation or identification. Many of the resources for undocumented immigrants are also very regional, as some states (as well as non-profits that operate in them) are more accommodating than others.”

“Rent as well as housing assistance is not mandated by the government. However there are many charities that offer solutions. As at the end of the day no organizations want an undocumented immigrant, or one who is in the process of applying for citizenship, to be homeless. This does not do society any good.”

“There are a few options available. The first will be financial aid that can [help with rental payments](#). This solution tends to be if the immigrant has some form of

employment and is more stable. Everything from homeless prevention to cash grants may be offered.”

“Illegal, or undocumented immigrants, without any form of stability may be better served by short term, emergency housing such as shelter or transitional units. Even these programs will tend to be more restricted, as groups such as the Salvation Army will limit who or who can’t use them. But they may be an option. Find more details on [transitional housing programs](#).”

“If the shelters are full, then vouchers can be given to pay for a motel or even hotel room. This is a government benefit for undocumented immigrants, especially those with children, that is more common in some states. It will only pay for a limited amount of time; normally a night or two. [Locate motel voucher assistance programs](#).”

Hold on, still more benefits...:

“Free or low-cost food, meals, and hunger prevention”

“One benefit that undocumented immigrants are entitled too is food as well as general hunger prevention. The federal government in fact requires states to offer this solution to migrant farm workers, immigrants, and even refugees. There are a few different options available.”

“For ongoing, long term support, [SNAP food stamps](#) are available. This assistance program will help the immigrant afford the groceries they need on a monthly basis. An EBT debit card will be issued to them which can be used at a grocery store.”

“As noted, children (especially newborns as well as babies) are a focus. Illegal immigrants with new babies, or even pregnant women, can apply for the Women, Infants and Children (WIC) program. This provides a free voucher to use for buying formula or other critical food items for the mom (or pregnant woman). The government also provides general nutritional counseling to undocumented as well as legal immigrants. Read more on [WIC benefits](#).”

“Undocumented children under the age of 5 can get free meals and/or food if they enroll into Head Start. The federal government funded benefit even provides educational support at the same time. While the kid is at school, they can eat, be given breakfast and/or a free lunch, learn about K-12 education, and learn. The assistance program therefore has many benefits for undocumented immigrants, and find more information on the [Head Start benefit](#).”

The goody list is never ending....:

“Health care for undocumented immigrants”

“The first option in Emergency Medicaid. Both the federal government as well as states contribute to this benefit. It is legally required to be offered to all people in this country, whether they are legal or not. So an immigrant can have a portion of their medical bills

paid, by given lost cost prescription drugs, and other health care. Call a local social or human service office for this form of support.”

“Illegal immigrants often turn to sliding fee or free community clinics for their medical care as well. These are located in rural communities, cities, and really most towns and counties. Most of them are set up at charity organizations and are operated by volunteers. Some doctors offer care or a dentist may even provide free checkups or tooth cleaning to undocumented immigrants, including children or the elderly. There are both [dental clinics](#) as well as those that focus on other services, including [clinics for medical care](#).”

“States often offer [health care for the uninsured](#) as well. In some parts of the country this will cover immigrants that are not documented. But some state benefits may not be as flexible. However these uninsured assistance programs are another possible way to get free or discounted medical care.”

Hang on, there’s still a pot of gold at the end of the rainbow.....:

“Immigrant financial assistance programs”

“This form of support is more difficult to get. Some charities or churches may assist, but each organization will have their own application processes for cash assistance or housing programs for undocumented immigrants as well as funding levels. Grant based programs may require proof of identification or residency, which an undocumented immigrant may not be able to receive. There may also be some loans available that are based on the immigrants’ weekly paycheck or income.”

“No matter the immigrant’s religion, race, or nationality, a church is often very willing to help. They often collect tithes from their members, or they receive donated goods from the community. This allows the parish to offer everything from a box of food to a few dollars to pay for housing, gasoline, or offer clothing. Find a listing of [financial assistance programs from churches](#).”

“Many national charities also offer free financial help to immigrants, both legal or illegal. There are dozens to try, ranging from the Salvation Army to Catholic Charities, United Way and others. Each will focus on assisting with a certain type of bill. Everything from emergency housing to food, bus vouchers, or free clothing for work may be given to undocumented workers. Other aid may also be arranged, and locate [charities that help pay bills](#) both at the local as well as national level.”

“Undocumented immigrants can also receive money from low interest rate or even [payday loans](#). However, this should really be a last resort. As the risk to an illegal immigrant in borrowing money to pay for monthly bills is very high. Using some form of loan can put the individual on a path to financial hardship, but it is an option.”

“Immigrants will also need to eventually build credit as well. This can sometimes be a challenge when entering the United States, but there is assistance available as well as

steps to take to start the process to establish a financial history. Find [how immigrants can start to build credit](#).”

“Many immigrants, whether undocumented or legal, do not have checking or saving accounts; they are unbanked. They also may tend to send money “home” or overseas to help support their families. Prepaid cards can help them write checks, save money, build credit, and have other advantages. Find [prepaid cards for the unbanked](#).”

“Immigrants can also get help in transferring their money overseas. Many have family they support if and when possible. There are smartphone apps that are free to use (or have very low fees) for sending funds, whether from a job or some other source, to foreign countries. [Find the leading apps for sending money overseas](#).”

“As noted some state governments offer their own cash assistance or benefits to undocumented immigrants. This is generally done at the local level as most federal government programs, including TANF welfare, do not assist immigrants. Therefore the state may step in to offer financial help, whether it is a disability resource, information on employment opportunities, or other support. Find more details on [assistance from the government](#).”

“When deportation occurs, or an illegal immigrant is threatened by it, **then a [free lawyer consultation may be useful](#)**. The police may arrest an undocumented immigrant. Or there may also be “raids” by the Department of Homeland Security (DHS) or some other federal government organization. If/when this occurs, and the U.S. Immigration and Customs Enforcement agency becomes involved, an immigrant can seek free legal aid from charities or even volunteer lawyers. There are resources to ensure legal rights are protected from the U.S. Immigration and Customs Enforcement (ICE) or other related government groups.”

“Jobs and employment opportunities for immigrants”

“An opportunity that is available for immigrants is to [make an income working at home](#). There are jobs out there for those of all backgrounds, nationalities, and languages. There are work from home positions for Spanish speakers, Cubans, Koreans, Chinese, and really all ethnicities.”

“The money they earn can help them supplement other jobs they may have. Normally a W-9 or identification is not needed for these work from home jobs, and their paycheck may be “under the table” and/or does not need to be reported to the IRS or the government. As an example of what may be out there for illegal or undocumented immigrants, they can do things such as find [hobbies for extra cash](#). Or there are gig economy type jobs and much more.”

No wonder there is an invasion at the border! Catholic Charities and other NGOs facilitate the distribution and access to all these inducements to break the law.

While the illegality is shocking enough, it is absolutely mind-boggling that wrongdoing would provide such a breathtaking array of taxpayer-funded benefits and conveniences for the invaders-all paid for by law-abiding American taxpayers.

The Vatican, the UN, the CIA have orchestrated the color invasion of Europe and North America for political and religious reasons. The Vatican state has only existed for less than a century. In February 1929, Benito Mussolini signed the Lateran Accords on behalf of King Victor Emmanuel III. The Accords gave the Pope 110 acres (0.44 square km) which became known as Vatican City State. The Vatican sets the agenda from which is then carried out through its UN diplomatic emissaries (papal legates) to each of the UN delegates of member states. They are also referred to by the term “nuncio” as well.

A legate expresses the pope's concern for the good of the nation in which he serves, especially with respect to questions of peace and the development of peoples. He is charged with protecting the legitimate interests of the Church in her dealings with the civil government. Occasionally and bearing in mind the advice of local bishops, he enters into negotiations with the civil government about questions of concern to both church and state. Within the limits of his mandate and in close association with the bishops and patriarchs of the region, the legate promotes ecumenical dialogue. Being under the direction of the cardinal secretary of state and the prefect of the Council for the Public Affairs of the Church, the legate reports directly to them about all his activities.

Other duties of the legate are more closely allied with internal affairs. He informs the Holy See about the spiritual condition of the local Church and communicates and interprets papal documents and curial deliberations to the local Church. He is the facilitator of the process whereby candidates for the episcopacy are selected; and he forwards their names to the proper Roman dicasteries, together with an accurate indication of which candidate seems most suitable. The legate also has the duty of studying the question of the creation, division, and suppression of dioceses. He will inform the proper Roman dicastery of the episcopal conference's recommendations on the matter.

The legate is advised to give generous assistance and counsel to individual residential bishops. Although not himself a member of the national episcopal conference, he generally attends its sessions. He is to be notified in advance of its agenda and is to inform the Holy See about it. The legate exercises similar functions with respect to religious superiors and the national conferences of religious. Whenever no official delegate or observer has been appointed to an international conference within his territory, the legate is to pursue the business of the conference, informing the Holy See of its progress. Delegates or observers at an international conference are to complete the mission entrusted to them after consulting with the legate in whose territory they happen to be.

The legation (offices of the papal legate) itself has certain legal privileges. It is exempt from the jurisdiction of the local Ordinary and the legate can grant faculties for use in the oratory of the legation. The legate has the right to bless the people and to celebrate the Liturgy of the Hours in all churches within his territory. He takes precedence over all patriarchs, archbishops, and bishops within his territory, but not over cardinals. All of these rights aim at making clear the dignity of the office of the legate and at enabling him to perform his duties more easily.

Three types of legates are recognized by canon law. A *legatus a latere* (a legate sent from the pope's side, as it were) is a cardinal who represents the pope on some special assignment with such powers as are delegated to him. *Nuncios*, *pronuncios*, and *internuncios* are sent to countries that have diplomatic relations with the Holy See; they promote friendly relations and observe and report to the pope on the state of the church in that region. *Apostolic delegates* are prelates who are appointed by the pope as his

representatives to the church of a region. They channel information between the local ecclesiastical hierarchy and the Holy See.

It has formal diplomatic relations with 179 nations. The State of Vatican City, for its part, is recognized under international law as a sovereign territory. Unlike the Holy See, it does not receive or send diplomatic representatives, and the Holy See acts on its behalf in international affairs.

With origins that can be traced back to the early centuries of the Catholic Church, the diplomatic service of the Holy See is considered to be the oldest in the world; strangely, it is also one of the least known. Early popes simply dispatched legates (or envoys) to represent them at important Church councils or for other matters, but by the fifteenth century these legates had become more permanent. During the sixteenth century they became officially known as 'apostolic nuncios' (papal ambassadors), and an exchange of representatives thus began taking place between those countries with established 'nunciatures' (papal embassies) and the Holy See.

Today the Holy See has formal diplomatic relations with 176 nations as well as the United Nations (where it enjoys Permanent Observer status) and other international agencies and secretariats. 86 countries currently maintain embassies to the Holy See. At least 13 countries do not have official relations with the Vatican. Its ambassadors are also automatically recognized as deans of the diplomatic corps wherever they are accredited, as affirmed in 1961 by the Vienna Diplomatic Convention.

What really singles the Holy See out, in this context, is its access to a vast network of missionaries, prelates and lay Catholics throughout the world, making it a valuable global 'listening post'. As a result, Vatican diplomats are themselves very well informed and in a unique position to mediate disputes, prevent conflicts and ultimately save lives. Usually these achievements take place behind closed doors and rarely make the headlines. Even within the Church, few know, for example, that in 1978 the Holy See diplomats, led by John Paul II, prevented the 'Beagle conflict' – a border dispute between Argentina and Chile over three small islands at the tip of South America – from escalating into war.

Many years ago, 1953 or 54, I was invited to go with the Youth Group of the Shadyside Methodist Church in Pittsburgh, PA on a Labor Day Weekend outing trip to New York City by train. A hundred youth and adults traveled by train to New York City for a 3-day sightseeing trip experience and when we went to the UN building to visit, I was surprised by the number of Catholic delegates going about their business as we visited the UN on a Saturday. You would be hard pressed to find a Protestant church leader at the UN in today's world.

The purpose of sharing this information is to enable you to understand how the Vatican has real-time intelligence on the world. For example, in the situation we are facing at the Southern border, the Vatican and Ashkenazi Jew George Soros are in frequent and

close contact in providing the funds to groups in Central and South America, to recruit their illegal immigrants that flood the Rio Grande at El Paso, TX.

43 lay persons.

Herman Rauschning tells us:

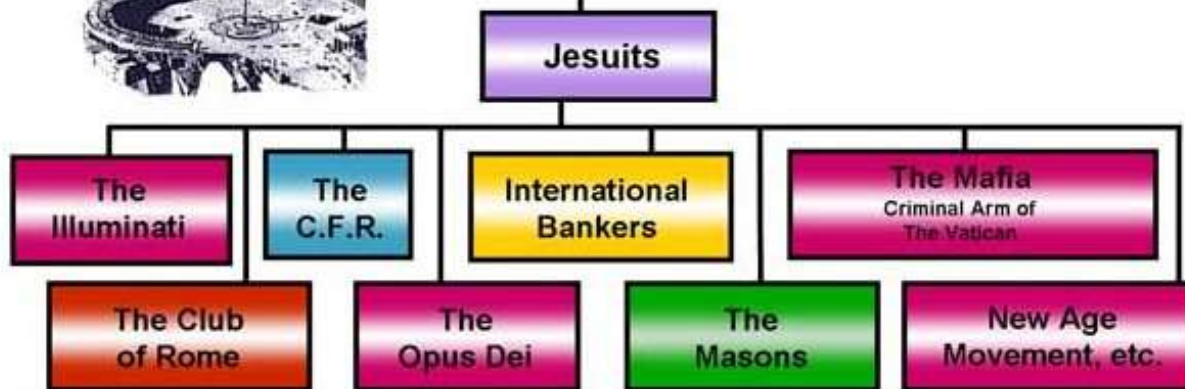
“I learnt most of all from the Jesuit Order’, Hitler told me. ‘So far, there has been nothing more imposing on earth than the hierarchical organization of the Catholic Church. A good part of that organization I have transported direct to my own party. . . . The Catholic Church must be held up as an example. . . . I will tell you a secret. I am founding an Order’.”

After the war this secret imparted by the Fuhrer was enlarged upon by the revelations of Walter Schellenberg8 who had been Chief of the German counter-espionage and Leader of the National Socialist Government of Danzig:

“The SS had been organized by Himmler according to the principles of the Jesuit Order. The rules of service and spiritual exercises prescribed by Ignatius de Loyola constituted a model which Himmler strove carefully to copy. Absolute obedience was the supreme rule; every order had to be executed without comment.” (Edmond Paris – *The Vatican Against Europe* (pg. 252-253)).

Hitler did not award the palm of Jesuitism to his chief of propaganda, though to the Gestapo’s chief, as he told his favorites: *“I can see Himmler as our Ignatius of Loyola”* Adolf Hitler: *“Libres propos”* -(Flammarion, Paris 1952, p.164) Edmond Paris, *‘The Secret History of the Jesuits’.*)

The conversion of Russia, which Rome had hoped to achieve through the Bolshevik Revolution, was now attempted through the use of a foreign army.

“Count Halke von Ledochowski, Jesuit General, was disposed to organize, on the common basis of anti-communism, a certain degree of collaboration between the German Secret Service and the Jesuit Order...”

“Von Ledochowski considered the forthcoming bellicose settling of accounts between Russia and Germany as inevitable... And the Baseler Nachrichten (March 27, 1942) did not hesitate to write: ‘One of the questions arising from German activity in Russia which is of supreme importance to the Vatican, is the question of the evangelisation of Russia.’”

“This is confirmed by Father Duclos himself in a book covered by the Imprimatur - ‘During the summer of 1941, Hitler appealed to all Christian forces... (he) authorized Catholic missionaries to go to the new eastern territories ...’”

“Nor has it been forgotten that, in France, Cardinal Baudrillart and Mgr. Mayol de Luppe recruited the L.V.F. for the crusade against Russia.’ ”

“Who were the principal Nazi murderers? Himmler, head of the Gestapo; Heydrich, his right-hand man; Kaltenbrunner, who succeeded Heydrich; Mueller and Frank, all Roman Catholics by birth and upbringing.

“Hoess, the Commandant of the infamous Auschwitz, was also a Roman Catholic. The first concentration camp was set up by Himmler at Dachau, Munich.

“Heinrich Himmler had an uncle who was a Jesuit priest. This Jesuit-Himmler director? – was arrested at the end of the war but he was not tried. He was found dead one morning in his cell. Himmler, like Goering, cheated the gallows by suicide, or so it was believed.”

To include the Jesuits in this list of groups which influenced the Nazis, will be controversial to some and perhaps even outrage a few. The Jesuits however were greatly influential on the Nazis, whether by design or not, or whether in complicity or not. Hitler had at least one renowned Jesuit among his closest advisors. Himmler greatly admired the Jesuit Order, and both believed that the organization and system of the Jesuit order were to be emulated in the Nazi Party.

The Order was founded on September 27, 1540 as the “Society of Jesus” and sanctioned by Pope Paul III in the Bull Regimini militantis ecclesiae Ignatius of Loyola greatly influenced the church training an elite corp of highly educated priests who were additionally trained in spiritual exercises. (see Basic Jesuit Spiritual Exercises.) They have had a rocky history even within the Catholic Church, and many were kicked out the fledgling American Colonies, and the order in the 1700s was shut down by the Papacy fearing division and overthrow. The Restored Jesuit Order had re-established itself by the 1800s. Himmler had been raised around Jesuits and he admired their philosophies and orders though by the time he reached power, one could hardly have called him a believing Catholic. Still, he found merit in the Order and based some SS training on the principles of the group, which in the extreme included altered states of consciousness and meditations including ‘mind-over-matter’. There were Jesuits advising Hitler and Jesuits imprisoned in the Lagers, but the relationship to Nazi Philosophies appears to be in methodology and process more than anything. The Jesuits had taken many ideas from the ancient Knight Templars, and adapted them, not unlike what Himmler sought to do for the Nazis. Most central was the idea of a Messianic figure, the fuhrer surrounded by an elite corp. Von Papen was once quoted as saying that Hitler put the organization of the Catholic Church to work for him: Himmler narrowed it to the Jesuits. shoaheducation.com

That Superior General Wlodimir Ledochowski through his Jesuit emissaries did instruct Adolf Hitler in 1929 to reform a section of the Sturmabteilung (SA) also known as Storm Troopers into Schutzstaffeln also known as the “SS”. That unlike the SA that was staffed by variously skilled persons, the Jesuits instructed Hitler that the SS was to be a most secret organization of personal bodyguards and elite, staffed with and controlled by actual Jesuit priests. That SS officers would be conferred by the authority of the Jesuits and the power of the Pope with the powers of Catholic priesthood. Furthermore,

that the SS priests were to be embedded across the organization to ensure strict control and prevent dissent. That in exchange, the Jesuits did agree to personally fund its implementation as well as introduce its substantial business funds and industry interests into Germany. That on January 6, 1929 Adolf Hitler appointed Heinrich Himmler to oversee the project. one-faith-of-god.org.



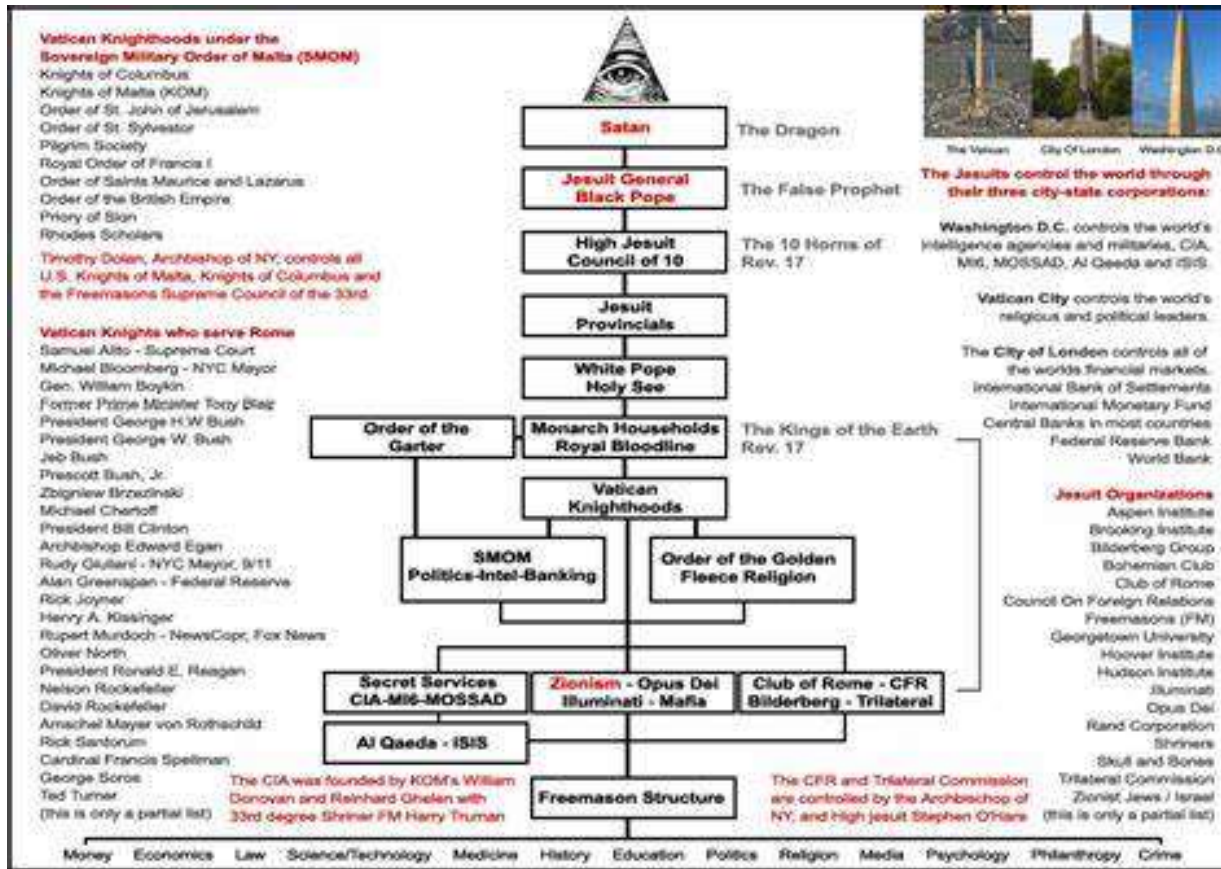
Hitler greets two Roman Catholic officials in 1934. Hitler said: “As for the Jews, I am just carrying on with the same policy which the Catholic Church has adopted for fifteen hundred years...”

“Hitler spoke of Heinrich Himmler, commander-in-chief of the SS, as ‘my Ignatius Loyola’....In many respects, the SS was indeed modeled on the Jesuits, and made deliberate use of Jesuit techniques in such spheres as psychological conditioning and education. But the Jesuits themselves had derived much of their structure and organization from the still older military-religious-chivalric orders like the Knights Templar and the Teutonic Knights (Deutschritter).” –(Baigent, Leigh & Lincoln, ‘The Messianic Legacy’)

The link between the Papacy and Nazi Germany over the past seventy years has been obscured. Although the Roman Church used to be more overt about its collaboration with the Nazis, today it is of course a no no to be associated in any promotional way with an empire as despicable and sinister as Nazi Germany. However the available evidence leaves little room for controversy. For example, the existence of a concordat closed between Nazi Germany and the Papacy (the Reichskonkordat) cannot be refuted.

“The hegemony of Protestant Prussia had to be prevented and as the Reich was to dominate Europe—to avert the Germans’ federalism—a Reich had to be reconstituted

in which the Catholics would be masters” –(Edmond Paris ‘The Secret History of the Jesuits’).



Another well informed person, the mainspring of the pact between the Holy See and Berlin and the pope’s secret chamberlain, Franz von Papen, was even more explicit: “The Third Reich is the first world power which not only acknowledges but also puts into practice the high principles of the papacy”. Robert d’Harcourt of the French Academy: “Franz von Papen, l’homme a tout faire” L’Aube, 3rd of October 1946) –(Edmond Paris, The Secret History of the Jesuits’).

In the February 29, 1929 edition of the Völkischer Beobachter (official newspaper of the Nazi Party), Adolf Hitler published an article on the new Lateran Treaty between Mussolini’s fascist government and the Vatican. According to Hitler, this treaty should demonstrate to the world that not only are fascism and Christianity not polar opposites, but that they are in fact close kin which should be working together:

“The fact that the Curia is now making its peace with Fascism shows that the Vatican trusts the new political realities far more than did the former liberal democracy with which it could not come to terms.”



...The fact that the Catholic Church has come to an agreement with Fascist Italy ...proves beyond doubt that the Fascist world of ideas is closer to Christianity than those of Jewish liberalism or even atheistic Marxism, to which the so-called Catholic Center Party sees itself so closely bound, to the detriment of Christianity today and our German people."

[...] During the same speech, Hitler further criticizes Germany's Catholic Center Party for maintaining its support for democracy:

"By trying to preach that democracy is still in the best interests of German Catholics, the Center Party ...is placing itself in stark contradiction to the spirit of the treaty signed today by the Holy See."

For their part, the best theological pens were busy demonstrating the similarity between the Catholic and Nazi doctrines. And, for that work, the sons of Loyola were the busiest. As an example, let us see how Michael Schmaus, Jesuit theologian, presented to the public a series of studies on this subject:

"Empire and Church" is a series of writings which should help the building up of the Third Reich as it unites a national-socialist state to Catholic-christianity... The national-socialist movement is the most vigorous and massive protest against the spirit of the 19th and 20th centuries... A compromise between the Catholic faith and liberal thinking is impossible... Nothing is more contrary to Catholicism than democracy...

"The reawakened meaning of "strict authority" opens up again the way to the real interpretation of ecclesiastical authority... The mistrust of liberty is founded on the Catholic doctrine of original sin... The national-socialist Commandments and those of the Catholic Church have the same aim..."

“Hitler, Goebbels, Himmler and most members of the party’s ‘old guard’ were Catholics”, wrote M. Frederic Hoffet. “It was not by accident that, because of its chiefs’ religion, the National-socialist government was the most Catholic Germany ever had... This kinship between National-socialism and Catholicism is most striking if we study closely the propaganda methods and the interior organisation of the party. On that subject, nothing is more instructive than Joseph Goebbels’ works. He had been brought up in a Jesuit college and was a seminarist before devoting himself to literature and politics...”

Every page, every line of his writings recall the teaching of his masters; so he stresses obedience... the contempt for truth... *“Some lies are as useful as bread!”* he proclaimed by virtue of a moral relativism extracted from Ignatius of Loyola’s writings...” Frederic Hoffet: *“L’Imperialisme protestant”* (Flammarion, Paris 1948, pp.172 ss.) Edmond Paris –(*The Secret History of the Jesuits*)

Nazi-Fascism is but the outcome of events in which the Catholic Church has played a decisive role for centuries. He says that National Socialism is the “fulfilment of destiny,” and goes on to say:

“It was born originally out of the most profound tendencies of the epoch, of which it is the crowning act. Undoubtedly, we now have the right to speak of an essential transformation, of the birth of a veritable new era, the accomplishments of which will remain, A new epoch has opened which will serve religion and the Church, and which will be extraordinarily well armed to carry on the fight against atheism.”

This, and much more, is quoted by Bishop Hudal to prove the fundamental identity of the aims and purposes of Catholicism and Nazi-Socialism. The Catholic bishops in the United States cannot afford to be as frank in supporting Nazi-Fascist ideology in this country. They cannot but admit, however, that their fellow-bishops in Nazi-Fascist countries have been correct in their analysis of the benefits which this anti-liberal and anti-democratic ideology will bring to the organization of Roman Catholicism. –(Leo Lehmann – *‘Behind the Dictators’* pg. 34-35). (1942)

The Jesuits had preached their Crusade for over fifty years. Their chosen vessel was now the master of the Third Reich. Imbibed with hatred for Jews, Prussian Lutherans, English Anglicans, Dutch Reformed and Slavic Orthodox peoples, the Papal Crusade would begin in 1939. Under the banner of the *sauvastika* (used by Freemasonic Kipling on title pages of his works, its right-handed “crampons” denoting the autumnal sun), *“Operation Barbarossa”* (named after the German Emperor leading the Pope’s Third Crusade) would be unleashed against Rome’s hated rival, the Slavic Orthodox Peoples. Like Frederick I, Hitler would in fact be the Holy Roman Emperor, King of Germany and King of Italy. That Crusade against the Orthodox would be commenced from two fronts: Hitler would be the *“hammer,”* aided by Islam, and Stalin would be the *“sickle,”* aided by

the Jesuit-ruled, pro-communist U.S. and UK. When finished the Crusader would turn on Germany fulfilling his purpose of destroying apostate Protestant Prussia! -('The Burden of Guilt: A Short History of Germany, 1914-1945'), Hannah Yogt, (New York: Oxford University Press, 1964). (taken from Eric Jon Phelps - Vatican Assassins III, page 1008).

Their first main effort was to employ Black Pope Vladimir (Wlodimir) Ledochowski's strategy of bringing the Catholic nations of central and eastern Europe together into a pan-German federation. To head the federation, Ledochowski required a charismatic leader charged with subduing the communistic Soviet Union on the east, Protestant Prussia, Protestant Great Britain, and republican France on the west, Ledochowski chose the Catholic militarist Adolph Hitler, who told Bishop Bernind of Osnabruch in 1936 that:

There was [no] fundamental difference between National Socialism and the Catholic Church. Had not the church, he argued, looked upon Jews as parasites and shut them into ghettos? "I am only doing," he boasted, "what the church has done for fifteen hundred years, only more effectively." -(Hitler's Pope – The Secret History of Pius XII, by John Cornwell)

"[SS General Heinrich] Himmler owned an extremely large and excellent library on the Jesuit Order and for years would sit up late studying the extensive literature. Thus he built up the SS organization according to the principles of the Jesuits. The Spiritual Exercises of Ignatius of Loyola served as the foundation; the supreme law was absolute obedience, the execution of any order whatsoever without question. Himmler himself, as Reichsfuhrer of the SS, was the general of the order. The structure of leadership was borrowed from the hierarchical order of the Catholic Church. He took over a medieval castle, the so-called Wevelsburg at Paderborn in [Roman Catholic] Westphalia, and had it repaired so that it might serve as a kind of 'SS monastery' [as all monasteries are merely military fortresses]. Here the general of the order would hold a secret consistory once a year attended by the top leadership of the order. They would take part in spiritual exercises and practice sessions in concentration [as does every professed Jesuit, while led by a guide, studies The Spiritual Exercises of St. Ignatius Loyola once a year for thirty days, much of the time spent in silence and "meditation"]. In the large meeting hall each member had his particular chair with his name engraved on a silver plaque. No doubt these mystical leanings of [Bavarian-born] Himmler go back in part to his attitude toward the Catholic Church, which might be called 'love-hate;' and in part to his strict upbringing by his [Jesuit Temporal Coadjutor] father with its stern Catholic code of conduct, from which he fled into . . . [Loyola's] romanticism . . ." [Emphasis added] Walter Schellenberg, 1950 SS/SD Nazi General The Labyrinth: Memoirs of Walter Schellenberg Eric Jon Phelps – Vatican Assassins III (page 1037).

What is a Concordat?

In general, a concordat means an agreement, or union of wills, on some matter. [...] A concordat is a law, ecclesiastical and civil, made for a certain country in regard to matters which in some way concern both Church and State, a law, moreover, possessing the force of a treaty entered into by both the ecclesiastical and civil power and to a certain extent binding upon both. [...] The purpose of a concordat is to terminate, or to avert, dissension between the Church and the civil powers. New Advent (Online Catholic Encyclopedia)

In 1933, Nazi Germany agreed to sign into law its Reichskonkordat with the Papacy:

Mr. Joseph Rovin, Catholic writer, comments on the diplomatic agreement between the Vatican and the Nazi Reich on the 8th of July 1933:

“The Concordat brought to the national-socialist government, considered nearly everywhere to be made up of usurpers, if not brigands, the seal of an agreement with the oldest international power (the Vatican). In a way, it was the equivalent of a diploma of international honorability“.

Front page of the Nazi publication, Der Stuermer. Contrary to Pope John Paul II's remarks when he spoke at Yad Vashem, the Nazis were not "Godless." This headline from the infamously anti-Semitic Nazi periodical, Der Stuermer, reads, *“Declaration of the Higher Clergy. So spoke Jesus Christ: You hypocrites who do not see the beam in your own eyes.”* -(from Matthew 7:3-5) The cartoon depicts a group of Hitler Youth. The caption reads, *“We youth step happily forward facing the sun... With our faith we drive the devil from the land.”* The devil in question was, of course, the Jews. -(emperors-clothes.com)

“The Reichskonkordat effectively removed the Catholic Church from any continued role of opposition to Hitler. More than that, as Hitler told his cabinet on July 14, it established a context that would be ‘especially significant in the urgent struggle against international Jewry.’ The deep well of Catholic antisemitism would be tapped, to run as freely as any stream of hate in Germany. The positive side of the long-standing ambivalence, which had again and again been the source of impulses to protect Jews, would now be eliminated, allowing the negative side to metastasize.” emperors-clothes.com

“The German Catholic Church has rescinded its ban on joining the Nazi Party. The Catholic Centre party has dissolved itself. [And Articles 31 and 32 prevent any revival of this democratic Catholic party which had opposed the Nazis.] In the Reichskonkordat, the Vatican has promised that German Bishops and their subordinates will be obedient to and honor the Nazi state (Article 16). It has promised that German Catholic educators will teach children patriotic love for the Nazi state (Article 21). It has requested and received the Nazi dictatorship's promise to enforce internal Church decisions (Article 10). Cardinal Bertram of Breslau has called on Catholics to avoid all subversive or illegal (by Nazi definition) activities.”

“How should you respond to the Nazi's new nightmare state? Doesn't the Catholic Church teach you to view Church officials as exemplary? Shouldn't they be emulated? Isn't the Pope's word law, and didn't the Pope sign the Reichskonkordat, an agreement with the Nazi dictatorship, that [in Article 16 contains this pledge for new bishops]:

‘In the performance of my spiritual office and in my solicitude for the welfare and the interests of the German Reich, I will endeavor to avoid all detrimental acts which might endanger it.’”

Cardinal Faulhaber, who helped negotiate the concordat with Hitler (and who ordained the present pope), assessed its international impact in a 1937 sermon:

“At a time when the heads of the major nations in the world faced the new Germany with cool reserve and considerable suspicion, the Catholic Church, the greatest moral power on earth, through the Concordat expressed its confidence in the new German government.”

Fritz Hirschberger, a Holocaust survivor, painted a Nazi officer and a faceless Cardinal (Pacelli) standing on the body of a Jewish prisoner. He titled it "The Concordat".

The following articles of the Reichskonkordat are of special relevance:

Article 5

In the exercise of their clerical activities the clergy enjoy the protection of the state in the same way as state officials. The state will proceed, in accordance with the general provisions of civil law, against any insult to their person or to their clerical capacity, as well as against any interference with the duties of their office and, if necessary, will provide official protection. concordatwatch.eu

Article 16

Before bishops take possession of their dioceses they are to take an oath of loyalty either to the Reich governor of the state (Land) concerned or to the President of the Reich respectively, according to the following formula:

“Before God and on the Holy Gospels I swear and promise, as becomes a bishop, loyalty to the German Reich and to the State (Land) of . . . I swear and promise to honor the legally constituted government and to cause the clergy of my diocese to honor it. With dutiful concern for the welfare and the interests of the German state, in the performance of the ecclesiastical office entrusted to me, I will endeavor to prevent everything injurious which might threaten it.” concordatwatch.eu

In anticipation of a possible war Germany may become involved in:

Article 27

For the German army pastoral care outside the realm of ordinary jurisdiction is conceded for its Catholic officers, officials and men, as well as for their families.

The administration of such pastoral care for the army is the duty of the army bishop. His Church appointment is to be made by the Holy See after contact has been made with the Reich Government in order, with its agreement, to select a suitable person.

The Church appointment of military chaplains and other military clergy will be made by the army bishop after prior consultation with the appropriate authorities of the Reich. He may appoint only such chaplains as receive permission from their diocesan bishop to undertake military pastoral work, together with a certificate of suitability. Military chaplains have the rights of parish priests with regard to the troops and other army personnel assigned to them.

Detailed regulations for the organization of pastoral work by chaplains will be supplied by an Apostolic Brief. Regulations for the legal aspects in terms of officials will be drawn up by the Reich Government.

And then we have the less known Secret Supplement belonging to the articles:

Secret Supplement

In case of a change in the present German armed forces in the sense of the introduction of universal conscription, the induction of priests and other members of the regular clergy and the orders into military service will, with the understanding of the Holy See, be arranged within the framework of approximately the following guiding ideas:

a) Students of philosophy and theology at Church institutions who are preparing themselves for the priesthood are to be freed from military service and the preparatory drills for it, except in the case of a general mobilization.

b) In the case of a general mobilization clerics who are employed in the diocese administration or the military chaplaincy are freed from reporting for duty. This applies to ordinaries, members of the ordinariate, provosts of seminaries and Church residences for seminarians, professors at the seminaries, parish priests, curates, rectors, coadjutors and the clerics who provide a church with worship services on a continuing basis.

c) The remaining clerics, insofar as they are considered suitable, are to join the armed forces of the state in order to devote themselves to pastoral care for the troops under the Church jurisdiction of the military bishops, if they are not inducted into the medical unit.

d) The remaining clergy in sacris or members of orders, who are not yet priests are to be assigned to the medical unit. The same shall apply when possible to the candidates for the priesthood mentioned in a) who have not yet taken their final vows.

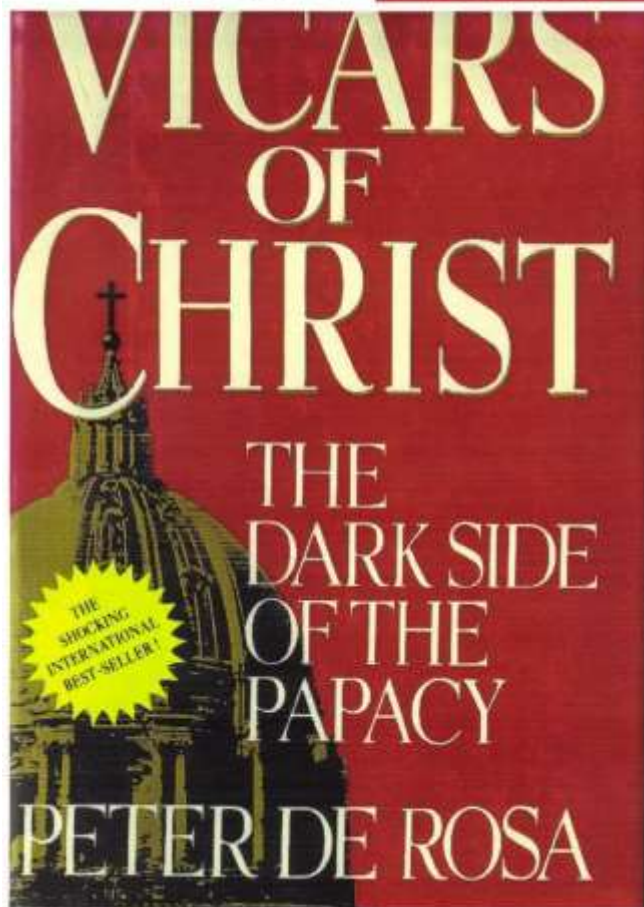

my brethren, you do unto me? That cover-up, now nearly twenty centuries old, was not perpetrated by a deviant sect but by main-line Christianity, by the Holy Roman Catholic and Apostolic Church. No doctrine was taught more universally, with less qualification – in Catholic terms, more infallibly – than that ‘Jews are cursed for killing God’, a charge still not officially withdrawn. By a bizarre twist, Jews, from whom the Saviour came, were the only ones blamed for killing him. It was not Jesus who was crucified but the race from which he sprang.

In the Third and Fourth Councils of the Lateran (1179 and 1215), the church codified all previous enactments against Jews. They had to wear a badge of shame. In England it was saffron, in the presumed shape of the tablets of Moses. In France and Germany it was yellow and round. In Italy, the badge was a red hat, until a short-sighted Roman prelate mistook a Jew for a cardinal and the colour was changed to yellow. Jews were forbidden all contact with Christians, barred from administration, deprived of lands, forbidden to own shops, herded into ghettos which were bolted at night. No system of *apartheid* was more rigorously enforced. For refusing to deny their ancestral faith and convert to Christianity, Jews were hounded from one land to another. One pope gave them a month to quit their homes in Italy, leaving them only two places of refuge. During the Crusades, they were slaughtered in their thousands, out of devotion to Christ. A Jew who showed his nose on Good Friday was virtually committing suicide, even though the Man on the Cross had a Jewish nose. Thus down the ages, millions suffered and died. Bad art and disastrous theology had prepared the way for Hitler and his ‘final solution’.

In Nazi Germany, to begin with, stars were daubed on Jewish homes and shops; it was the signal that they could be smashed and looted. Towns boasted, as they had done in medieval times, of being *Judenrein*, free from Jewish contamination. Typically, on the outskirts of the village of Obersdorf, there was a wayside shrine with a crucifix. Over Jesus’ head was the inscription, INRI (Jesus of Nazareth, King of the Jews). In the foreground was a notice: ‘*Juden sind hier nicht erwünscht*’ – ‘Jews are not welcome here.’

In 1936, Bishop Berning of Osnabrück had talked with the Führer for over an hour. Hitler assured his lordship there was no fundamental difference between National Socialism and the Catholic Church. Had not the church, he argued, looked on Jews as parasites and shut them in ghettos? ‘I am only doing, he boasted, what the church has done for fifteen hundred years, only more effectively’. Being a Catholic himself, he told Berning, he admired and wanted to promote Christianity.

It never occurred to Hitler, it seems, that Jesus, whom he referred to in *Mein Kampf* as ‘the Great Founder of this new creed’ and the scourge of Jews, was himself a Jew; and if not, why not? From

For some reason, Catholics are not eager to claim Hitler.

Even today, when I refer to Hitler's Catholicism in conversation or a speech, it immediately becomes apparent that I have said something *"not quite nice,"* and I am often challenged. Non-theists, I then explain, know that many modern tyrants, whether petty tyrants such as Richard Nixon, or more successful tyrants such as Hitler, have regarded themselves as exemplary Christians, an estimate their followers had no trouble accepting. Hitler's religiosity — he was a Catholic until his death — is often glossed over, but it is critical in understanding his motivation.

I have often reflected, wistfully, on how much happier modern history might have been had Hitler been brought up as an atheist, an agnostic, or, at least, a Unitarian. Born and bred a Catholic, he grew up in a religion and in a culture that was anti-Semitic, and in persecuting Jews, he repeatedly proclaimed he was doing the "Lord's work."

You will find it in Mein Kampf: *"Therefore, I am convinced that I am acting as the agent of our Creator. By fighting off the Jews, I am doing the Lord's Work."*

Hitler said it again at a Nazi Christmas celebration in 1926: *"Christ was the greatest early fighter in the battle against the world enemy, the Jews ... The work that Christ started but could not finish, I — Adolf Hitler — will conclude."*

In a Reichstag speech in 1938, Hitler again echoed the religious origins of his crusade. *"I believe today that I am acting in the sense of the Almighty Creator. By warding off the Jews, I am fighting for the Lord's work."*

Hitler regarded himself as a Catholic until he died. *"I am now as before a Catholic and will always remain so,"* he told Gerhard Engel, one of his generals, in 1941.

There was really no reason for Hitler to doubt his good standing as a Catholic. The Catholic press in Germany was eager to curry his favor, and the princes of the Catholic Church never asked for his excommunication. Religions encourage their followers to hold authority in unquestioning respect; this is what makes devout religionists such wonderful dupes for dictators.

When Hitler narrowly escaped assassination in Munich in November, 1939, he gave the credit to providence. *"Now I am completely content,"* he exclaimed. *"The fact that I left the Burgerbraukeller earlier than usual is a corroboration of Providence's intention to let me reach my goal."* Catholic newspapers throughout the Reich echoed this, declaring that it was a miraculous working of providence that had protected their Fuhrer. One cardinal, Michael Faulhaber, sent a telegram instructing that a Te Deum be sung in the

cathedral of Munich, *“to thank Divine Providence in the name of the archdiocese for the Fuhrer’s fortunate escape.”* The Pope also sent his special personal congratulations!

Later the Pope was to publicly describe Hitler’s opposition to Russia as a *“highminded gallantry in defense of the foundations of Christian culture.”* Several German bishops openly supported Hitler’s invasion of Russia, calling it a *“European crusade.”* One bishop exhorted all Catholics to fight for *“a victory that will allow Europe to breathe freely again and will promise all nations a new future.”*

Biographer John Toland wrote of Hitler’s religion: *“Still a member in good standing of the Church of Rome despite detestation of its hierarchy, he carried within him its teaching that the Jew was the killer of god. The extermination, therefore, could be done without a twinge of conscience since he was merely acting as the avenging hand of god — so long as it was done impersonally, without cruelty. Himmler was pleased to murder with mercy. He ordered technical experts to devise gas chambers which would eliminate masses of Jews efficiently and ‘humanely,’ then crowded the victims into boxcars and sent them east to stay in ghettos until the killing centers in Poland were completed.”*

Jews, of course, were not the only “holy” victims. In Yugoslavia, Hitler installed a Croatian, Ante Pavelic, as his puppet, and Pavelic, a Catholic like Hitler, began extermination of the Serbs, who were Greek Orthodox. One of my relatives by marriage is a Yugoslavian, a Serb, who survived World War II by going “underground” with the advent of Nazism in his country. Out of his immediate family of 17 (this includes his parents, siblings, aunts, uncles and first cousins), only three survived. His mother and sister just disappeared, his mother shortly after being given the opportunity to convert to Catholicism, an offer she refused. The Vatican was not unaware of the massacres conducted in Yugoslavia in the name of Catholicism, but Pope Pius remained diplomatically quiet. In fact, one of his actions was to receive Ante Pavelic in private audience, thereby giving his blessing to this regime.

War’s causes, of course, are complex, but it would be difficult to overestimate the disastrous role religion played in World War II. Distrust, fear and hatred of Jews was a lesson Hitler learned early in life. It was taught by his church and reinforced by his culture. It became his obsession, his version of *“the Lord’s work.”* That Hitler, that supreme villain of the 20th century, could see himself, and be seen by others, as *“providentially”* guided, protected and inspired should certainly serve as an ominous clue to the dangers of religious belief. Just as the Vatican umbrella could be maneuvered to shield the massacres of Serbs by Catholics in Yugoslavia, so can religion validate any behavior, any atrocity, any war.

Anne Nicol Gaylor (1926 – 2015) was an American atheist and reproductive rights advocate. She co-founded the Freedom from Religion Foundation and an abortion fund for Wisconsin women. She wrote the book *Abortion Is a Blessing* and edited *The World Famous Atheist Cookbook*. In 1985 Gaylor received the Humanist Heroine Award from the American Humanist Association, and in 2007 she was given the Tiller Award by NARAL Pro-Choice America.

"There has never been anything more grandiose, on the earth, than the hierarchical organization of the Catholic Church. I transferred much of this organization into my own party... I am going to let you in on a secret... I am founding an Order... In my "Burgs" of the Order, we will raise up a youth which will make the world tremble... Hitler then stopped, saying that he couldn't say any more.."

Another highly placed hitlerian, Walter Schellenberg, former chief of the German counter-espionage, completed this confidence from the Fuhrer, after the war:

"The S.S. organization had been constituted, by Himmler, according to the principles of the Jesuits' Order. Their regulations and the Spiritual Exercises prescribed by Ignatius of Loyola were the model Himmler tried to copy exactly... The "Reichsfuhrer SS"—Himmler's title as supreme chief of the SS—was to be the equivalent of the Jesuits' "General" and the whole structure of the direction was a close imitation of the Catholic Church's hierarchical order. A mediaeval castle, near Paderborn in Westphalia, and called "Webelsbourg", was restored; it became what could be called a SS monastery".

For their part, the best theological pens were busy demonstrating the similarity between the Catholic and Nazi doctrines. And, for that work, the sons of Loyola were the busiest. As an example, let us see how Michael Schmaus, Jesuit theologian, presented to the public a series of studies on this subject:

"Empire and Church" is a series of writings which should help the building up of the Third Reich as it unites a national-socialist state to Catholic-christianity... The national-socialist movement is the most vigorous and massive protest against the spirit of the 19th and 20th centuries... A compromise between the Catholic faith and liberal thinking is impossible... Nothing is more contrary to Catholicism than democracy... The reawakened meaning of "strict authority" opens up again the way to the real interpretation of ecclesiastical authority... The mistrust of liberty is founded on the Catholic doctrine of original sin... The national-socialist Commandments and those of the Catholic Church have the same aim..."

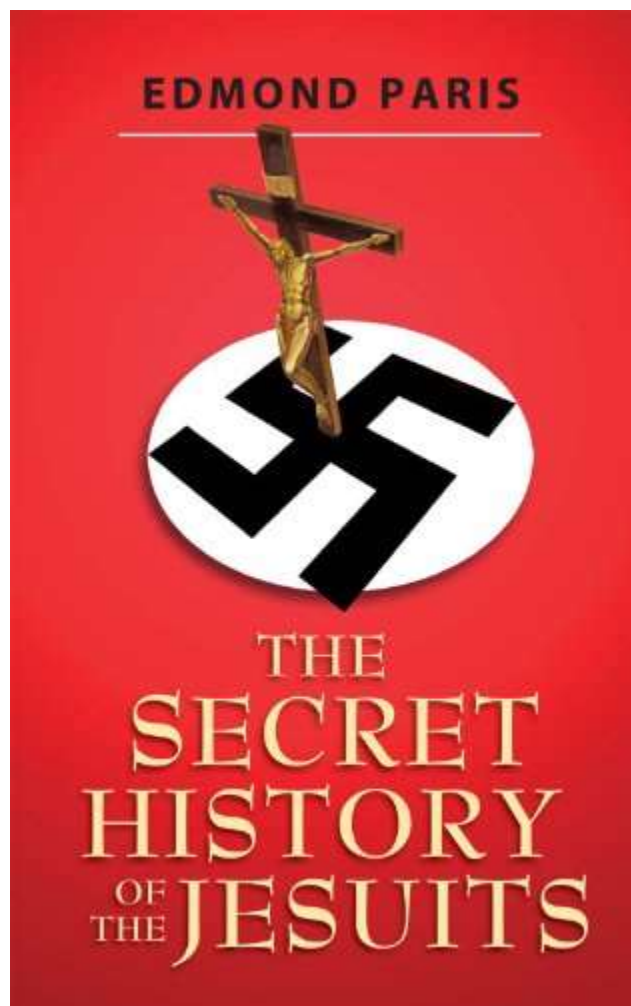
Chapter 7 of Edmond Paris' book *'The Secret History of the Jesuits'* confirms that it has always been the goal to strike at Russia and the Orthodox Church. The reason for both World War 1 and World War 2 can be summed up by these words:

"Amongst the various causes which decided the Vatican to start the first world war, by urging the emperor of Austria, Francis-Joseph, to "chastise the Serbians", the main one was, as we have seen, to strike a decisive blow against the Orthodox Church, this hated and centuries old rival. Beyond the small Serbian nation, the Vatican aimed at Russia, the traditional protector of Orthodox believers in the Balkans and the East."

M. Pierre Dominique wrote:

"To Rome, this affair became most important; a victory of apostolic monarchy over Czarism could be looked upon as a victory of Rome over the schism of the East".

"The Roman Curia was in no way concerned that such a victory could only be acquired through a gigantic holocaust. The risk, rather the certainty of it, was accepted, as the alliances made it unavoidable. Urged on by his secretary of State, the Jesuit Merry del Val, Pius X made no secret of it and the Bavarian Charge d'Affaires wrote to his government, on the eve of the conflict: "He (the pope) does not think the French and Russian armies would be successful in a war against Germany". This wicked calculation proved wrong. The first World War, which ravaged the north of France and left several millions dead, did not fulfil Rome's ambitions; it divided Austria-Hungary instead, so depriving the Vatican of its main stronghold in Europe and liberating the Slavs who were part of that double monarchy from Vienna's apostolic yoke."



"The German action in Russia poses the question of that country's evangelisation; the Vatican is most highly interested in it" And this, from a book devoted to the glorification of Pius XII: "The Vatican and Berlin signed a pact allowing the Catholic missionaries of the Russicum college to go to occupied territories and the placing of the Baltic territories under Berlin's nunciature". The "catholicization" of Russia was about to be launched,

under the protection of the Wehrmacht and SS, in the manner Pavelitch and his associates were carrying it out in Croatia, but on a much vaster scale. This was indeed a triumph for Rome! What a disappointment, then, when the hitlerian thrust was stopped at Moscow and when von Paulus and his army were trapped in Stalingrad! It was Christmas time, Christmas of 1942, and one must re-read the Message—rather the vibrant call to arms—addressed to the "Christian nations" by the Holy Father:

"This is not a time for lamentation, but action. May the Crusades' enthusiasm get hold of Christianity, and the call of "God wants it!" will be heard; may we be ready to serve and sacrifice ourselves, as the Crusaders of old..." We exhort and implore you to take upon yourselves the awful gravity of the present situation... As for the volunteers who participate in this Holy Crusade of modern times, "raise the standard high, declare war on the darkness of a world separated from God". On this day of the Nativity, we were far from "Pax Christi"! This war-like address was not the expression of the "strict neutrality" the Vatican flatters itself to observe in international matters. This address was made even more improper by the fact that Russia was the ally of England, (137) "La Croix", 7th of September 1951. "Basler Nachrichten", 27th of March 1942. and "War messages to the world", by Pius XII (Ed. Spes, Paris 1945, pp.34 and 257 ss).

UKRAINE HIT RUSSIAN BASE IN DONETSK; REPORTING 600 DEAD

Hal Turner reported on January 1st, 2023 U.S. weapons attack on a school housing 600 Russian soldiers.

Reports are starting to filter in from Ukraine claiming a HIMARS multiple launch rocket system stuck a Russian base in Makiivka (Donetsk), killing between 350 and 600 Russian soldiers. Info is sketchy, but it may have involved School #19 being used to house troops. There are also reports coming in that Ukraine stuck a hospital elsewhere, which was allegedly where Wagner PMC wounded were being housed.

According to some reports, the dead bodies of Russian soldiers were ignited and burning on the ground after the blasts.
