

Snake Venom is Credible Evidence for Covid-19

The reality is that there is an obvious reason for this imagery. You can see many images at Google of the pope's Audience Hall. Many articles have been written about this structure and what it has to say about the Vatican.

You may be asking what that reason is; why was this building built in such a way that the pope appears to be speaking from the mouth of a reptile? If you aren't asking that question, you're simply turning a blind eye. It's not that the evidence isn't present; it's that you are choosing not to see it. There are seven separate pieces that comprise the snake or reptile symbol. If it were one or two I would understand your skepticism — even three. But when seven pieces come together so beautifully, so perfectly, you know beyond any shadow of a doubt that it was intentional.

Oblivious to the world, the Catholic Church has built the biggest pagan institution that seeks to unite all the world's peoples in their religions just as the Tower of Babel was attempted. Last December, Dr. Bryan Ardis received a text message from an emergency room physician friend of his that sent him down an unexpected and bizarre rabbit hole that may explain the adverse events from the vaxxines that we've been reporting.

The text read: "Hey Dr. Ardis...If you got bit by a rattlesnake, would you go to a hospital and get anti-venom?"

Bryan had no idea what this meant and he immediately set about researching snake anti-venom. He discovered that most are either monoclonal- or polyclonal antibody treatments – just like the monoclonal antibodies that the CDC just removed as a COVID treatment, in favor of remdesevir, which is almost guaranteed to kill you but which is now nonetheless the ONLY government-approved treatment for infants and children with COVID in the U.S.

This is what I want to know: Is COVID a venom and is this why they don't want you using monoclonal antibodies?"

Bryan checked the publications saying that the original source of COVID-19 was either from bats, snakes or pangolins and he noticed that every time anyone mentioned snakes, the fact-checkers would descend upon them and spin them towards the bats.

"There's no fact-checking about bats. They keep letting you look at bats," he says. This, despite the fact that Chinese experts were saying that it could not have been bats, because these bats hibernate and COVID broke out in the middle of winter.

Plus, when they studied the antibodies of those who were sick in Wuhan, they found that the genetic sequences were not like bats, they were most similar to two snakes; proteins from the <u>Chinese krait</u> and the king cobra.

Bryan continues, "Then I find, in April of 2020 that there's a study in France where they're finding that the receptors in the brain called nicotinic acetyl choline esterase receptors, that these are actually bound most tightly to snake venom of krait and cobra. And that the spike protein from SARS-CoV-2 is most identical to Chinese krait and cobra venom."

"Then, I find out that there's an actual doctor who works at the University of Pittsburgh in May of 2020, works in a computational lab doing genetic sequencing and he's been researching for 5 months, sequencing spike proteins, trying to solve the mystery of SARS-CoV-2 victims and he says he's got a big press release to announce all of their findings and Bing Liu is his name."

Next thing you know, the young Dr. Bing Liu was dead in a lurid murder-suicide.

"And that's when I freaked out," Bryan says. "When I say to you that they have lied about everything in relationship to COVID, they've eve lied about the viral part of COVID."

Bryan cites a massive study published in January 2020 gene-mapping all of the proteins and peptides in king cobra venom, which isolated 19 venoms and peptides that specifically target organs in the body.

(<u>Natural News</u>) As the concept of "venom theory" has reverberated around the world this week, many people are shocked to realize how many pharmaceutical medications are derived almost entirely from rattlesnake venom, Gila Monster reptile venom, pit viper venom, scorpion venom and other such sources.

A pain treatment drug named Prialt (<u>see Prialt.com</u>) is actually synthesized by copying the poison of the Magical Cone Snail (*conus magus*). This poison produces hallucinations, confusion, altered states of consciousness and more. The <u>insert sheet</u> for the Prialt drug carries bizarre warnings such as, *"Patients have become unresponsive or stuporous while receiving PRIALT."*

Patients who are made unconscious by the drug may appear to be perfectly conscious, almost as if they are in a zombie state. The warning sheet explains, "During these episodes, patients sometimes appear to be conscious and breathing is not depressed. If reduced levels of consciousness occur, discontinue PRIALT until the event resolves..." We acknowledge that drugs like Prialt may have practical, beneficiary applications for people who are suffering chronic pain, yet who are unable to take highly addictive opioids for a variety of reasons. However, we take issue with the fact that **drug companies and doctors seem to be hiding the origins of these medications from patients**. Most doctors aren't even aware that toxins, poisons and venoms are used as the templates to synthesize extremely toxic peptides that are frequently used in prescription medications, including drugs for heart attacks, diabetes, high blood pressure and more.


It might also explain why so many side effects of covid vaccines seem to align so closely with the known effects of envenomation (being bitten by a snake, a viper, a scorpion, etc.).

As <u>ToxinTech.com</u> explains on their website, touting the pharmaceutical potential for the venom peptides in their library:

The biological function of animal venoms is to immobilize and kill prey or predator in seconds to minutes... venom toxins target... neuromuscular, cardiovascular, hemostatic and other life functions. Toxins bind to targets with high affinity and are chemically stable.



Unparalleled arsenal: Nature's 20 million toxins, from 150,000 venomous animal species, were selected by evolution to target key ion channels, receptors, and enzymes.

Evolution-tested

The biological function of animal venoms is to immobilize and kill prey or predator in seconds to minutes. Perfected by millions of years of evolution, venom toxins target a plethora of vital receptors key to neuromuscular, cardiovascular, hemostatic, and other life functions. Toxins bind to targets with high affinity and are chemically stable. Of 150,000 venomous animal species, there is an estimated 20 million toxins.

For the record, we do not ascribe nefarious intent on the part of ToxinTech. However, we recognize that ToxinTech's venom library may be exploited and misused by bad actors to create weapons of mass destruction, all based on venom peptides which are engineered to kill.

Interestingly, the ToxinTech home page feature image asks a rather blunt question that could be easily misconstrued: *Designed Toxins... Have a Target*?



In the context of biosciences, this means a molecular target such as a specific enzymatic pathway or channel such as calcium channels or sodium channels. But to the mind of a bad actor with nefarious intent, they might wish to target *humanity*, for example, with a venom-based depopulation weapon.

13 irrefutable facts about snake venom, Big Pharma and bioweapons

We've spent much of this week researching the venom peptide industry, and what we've found is rather astonishing. In fact, I think it's one of the biggest stories in the history of modern pharmaceutical medicine. Here's what we know so far:

Fact #1 – Big Pharma routinely uses venom and venom peptides for drug discovery. Around 150,000 animal species are known to produce toxins, and scientists estimate that 20 million toxins exist (only a small fraction have been studied).

Fact #2 – Massive venom libraries already exist (20,000+ venom peptides) and are marketed to the pharma industry for drug discovery. Two such companies are <u>Venomtech</u> (UK) and <u>ToxinTech</u> (USA).

Fact #3 – One venom library company celebrates how its venoms for Big Pharma are able to "immobilize and kill prey .. in seconds or minutes." They explain that venoms are "Perfected by millions of years of evolution" in order to target "neuromuscular, cardiovascular, hemostatic and other life functions." (<u>ToxinTech.com</u> home page, sourced April 14, 2022) This means that **venom library licensing companies recognize the toxicity of the compounds they are offering to drug companies**. In fact, they state so in their own marketing materials.

Fact #4 – Reptile venoms can be weaponized and made into biological weapons. Protein sequences are provided by the venom library companies, allowing gain-offunction research to engineer venom peptides into viral payloads or mRNA therapeutics. Because venoms are poisons, the knowledge of how to engineer and synthesize those poisons at the amino acid level is also knowledge of how to build biological or chemical weapons. **Fact #5** – Dozens of pharmaceuticals derived entirely from animal venom already exist. Many are FDA approved. A full chart has been <u>published by Natural News</u> and is also shown below.

Fact #6 – Pharma appears to be HIDING the venom origins of their products, making few or no disclosures on marketing websites about the actual origin of their drugs. You would have to read the insert sheets and understand Latin names to know that their drugs come from animal venom.

Fact #7 – Nearly zero doctors or patients know about the venom origins of venomderived medications. Thus, patients are swallowing actual reptile venom molecules but being told by their doctors that it is "medication." The FDA's approving of a venom as a medication does not magically transform it into something that is non-toxic. The toxicity is simply reframed as "therapeutic" by the FDA, which then hands the pharmaceutical company a market monopoly to sell a molecule that was actually pirated from nature.

Fact #8 – Venom molecules and venom peptides are mass synthesized in pharmaceutical factories. This is a common practice. This is referred to by numerous scientific and bioscience resources, <u>including the World Economic Forum</u>.

Fact #9 – Venoms and venom peptides are synthesized as "chemically stable" (ToxinTech.com) and are routinely delivered via liquid solutions without any preservatives. (They need no special preservatives to maintain their structure and function.) Nanocarriers are also available to further stabilize the venom peptides. (https://pubmed.ncbi.nlm.nih.gov/31223083/).

Fact #10 – Venoms can be touted by pharmaceutical companies as "naturally occurring," because they are. Yet this label can be misleading since people equate the word "natural" with "healthful" or "safe."

Fact #11 – Because venom peptides are stable in solution, they can be weaponized and mass produced, then distributed via air, water, food or contact surfaces. This means that it is entirely *plausible* that mass poisoning via venom peptides could be accomplished through the water supply, or the food supply, or dropped on cities via drones, etc. These are not outlandish ideas in the least. The U.S. Dept. of Homeland Security just recently conducted chemical weapons simulation tests in New York City, releasing "non-toxic gas" in city parks and subway stations in order to study this very thing. If it's a "crazy conspiracy theory," then somebody needs to tell DHS, because they've been drilling for this exact scenario.

Fact #12 – Some toxins are skin-penetrating and can be absorbed merely by TOUCHING. (Not a venom, but a toxin or poison.) This was all admitted in an Ecohealth Alliance proposal to DARPA, as covered in this story: <u>Leaked DARPA document</u>, <u>DRASTIC analysis confirms attack on humanity using aerosolized</u>, <u>skin-penetrating nanoparticle spike proteins</u>.

Fact #13 – Venoms and venom peptides produced for pharma are so stable that they survive stomach acid, which means the venom peptides are stable in solution, including in rather acidic (reactive) solutions. This means they do not automatically break down in city water, either. If venom toxins were not highly stable molecules, they would not be very good venoms in the first place. As ToxinTech explains, "millions of years of evolution" has perfected the functionality of these molecules.

Big Pharma uses snake venom to develop drugs and vaccines: here's the proof

(<u>Natural News</u>) The establishment is already contesting that snake venom is used in the development of pharmaceuticals, calling it a *"conspiracy theory."* But the evidence is there for anyone wanting to investigate it.

Many *"life-saving"* drugs, <u>the World Economic Forum (WEF) announced back in 2018</u>, are made from the venom of snakes. And it is not just the king cobra: There is also the pit viper, the cone snail and the Gila monster as well.

Each of these reptiles produces a different type and composition of venom that the drug industry has figured out how to manipulate in order to develop what are known as peptide therapeutics, which differ from small molecule therapeutics.

Peptide therapeutics belong to an entire field of scientific analysis known as venomics, which the WEF says offer groundbreaking solutions to health problems ranging from heart disease to diabetes to chronic pain, and so much more.

There are at least six different snake venom-based drugs that are currently approved by the U.S. Food and Drug Administration (FDA) for use in the United States. One of them is Captopril, an angiotensin-converting enzyme (ACE) inhibitor that is used to treat high blood pressure and improve survival after a heart attack.

The main ingredient in Captopril comes from a unique species of pit viper found in Brazil.

Another drug called Prialt that is used by some 22 million adults in the U.S. who suffer from severe and chronic pain. That one's main ingredient comes from the venom of cone snails.

Then there is Byetta, a type of drug that lowers blood glucose levels in patients with type 2 diabetes. Its main ingredient, exendin-4, comes from the saliva of the Gila monster, a large lizard species that is native to the U.S. Southwest and northern Mexico.

An expert in venomics by the name of Dr. Mandë Holford explained how it all works to the WEF's Alex Gray.

"Prialt is a breakthrough in treatment for pain that is non-addictive," he said. *"Prialt doesn't target the same thing, so it doesn't have the same side effects."*

"This has ushered in a whole new way for pharmaceutical industries to treat pain, they are now looking for things that target something other than opioid receptors."

The reason why venom works so well in these applications has to do with the way it works in the animal kingdom. It is a *weapon* that snakes use to defend themselves, or to catch prey.

"I like to describe venom as a cluster bomb," Holford said. "Its job is to shut down the normal function of the prey and in doing so, it fans out (and) hits several targets, which is a great thing for pharmaceutical development because you have several avenues to explore."

"Because it's so <u>fast acting, so potent and highly specific to its target</u>, venom has all of <i>the ingredients necessary for making a drug."

Does the covid bioweapon contain snake venom components?

On April 12 of this year, a company called Venomtech <u>announced a collaboration with</u> <u>Charles River Laboratories</u>, International Inc. to explore more ways to utilize venom-<u>derived compounds in pharmaceuticals</u>. Calling snake venom a *"unique natural resource,"* the Venomtech announcement explains how venom-derived peptides can be manipulated to target highly specific areas of the body, including the hardest-to-hit drug targets.

"Venomtech's Targeted-Venom Discovery Array^M (T-VDA^M) libraries provide researchers with a straightforward solution to rapidly screen thousands of individual venom fragments, with each array specifically designed to maximize hits for a specific target," the announcement explains.

"Through the new collaboration, Charles River will be able to use this innovative resource – closely supported by Venomtech – to accelerate its clients' pipelines, addressing difficult therapeutic targets, uncovering new mechanisms of action and minimizing off-target effects."

Company CEO Paul Grant added that such research has been going on for at least the past decade at Venomtech, and that a wider array of therapeutic options is available to the industry because of the innovative technology.

A form of senicide ... the bulk of the deaths around the world have been of the aged and the vulnerable," Dr. Braun said, "this has been a genocide."

Dr. Braun has tried to reach out to people and has been, for example, censored by LinkedIn for attempting to bring his information to the attention of professionals who should have been reviewing and considering his research. Dr. Braun is not worried about being censored by LinkedIn, but he wants LinkedIn to realize they are *"colluding and conspiring in crimes if they bury evidence that's going to point to how people are getting killed. So, I will probably see LinkedIn in court at some point, or in testimony in congress or the senate because this needs to stop," he said. Adding that if people are silenced and censored, it makes the world an unsafe place.*

"In high concentrations, this spike protein acts as nerve gas. You can see that in the videos ... why are we calling it a [lab] leak when you can see these are massive clouds or some other form of purposeful attack, just like China said. "You can use this particular weapon with or without a viral component."

In a 1977 paper, a lectin – a form of venom, a plant-based venom – was attached to, or combined with, a coronavirus. "You really need to think about glycoproteins, venom and plant-based venom, which are called lectins – you need to think of them like two sides of Velcro and there's interplay between the two of them. Ultimately, they act as switches and so when your body needs to understand what it's dealing with, it will have places in the body where lectins and venoms combine. And that sets off all kinds of chain reactions," Dr. Braun said.

There are two homologues, synthetic versions of the venom, in the spike protein. "You can call it a cobra venom but it may not actually be from the cobra snake. It is from a lab and even then, more importantly, it doesn't have to actually come from the cobra snake. That venom could be a perfect match, evolutionary, to a cone snail ... it could also come from parasites ... There are two venoms that are in the S protein of SARS-CoV-2 and they are cobra and krait, a coagulant and an anti-coagulant. And you have all kinds of disruptive mechanisms of those two weapons ... the venom aspect is just one aspect of this multipurpose tool that makes up the spike," Dr. Braun explained.

"There is already loads of data, there is already loads of science, around the fact that the viral component is only one part of this problem. The bigger problem is the spike protein ... They took that highly lethal pathogenic short-term and longterm poison, a venom, a venom-based poison – I cannot be any more clear – they took that and they gave you, if you took the vaccine, a code. And that code is a trick – a cell that would not normally accept that code was told 'hey suck this code in and start printing more of this poison'."

The sense of these sayings "is appropriate to the revealing quality of parables, in contrast to their concealing or secretive quality. Jesus came to reveal, to give light, and those who attend diligently to his words will experience increasing understanding."

The image of the Fauci family crest raises the question why would anyone choose as their image to represent the family name. The crown atop the snake's head sends the message of the King Cobra venomous snake.


