Mask Free Sweden Nears Zero Daily Covid Deaths

Anders Tegnell said on Friday that there was "a lot we do not know" about Delta and cautioned against drawing "far-reaching conclusions" about the coronavirus strain. He noted that the variant had been circulating in Sweden "for quite some time" with little effect, particularly in high-risk settings such as nursing homes.

His comments were made in response to newly released data from the Centers for Disease Control and Prevention (CDC) suggesting the Delta strain is more transmissible and could potentially cause more severe illness.

People who have been <u>fully vaccinated for COVID-19 yet still get infected with the delta</u> <u>strain</u> could transmit the infection to unvaccinated people, Centers for Disease Control and Prevention Director Rochelle Walensky said Tuesday in justifying renewed recommendations for mask-wearing.

The New York Times and other media outlets ran stories reporting that the CDC now believes the Delta variant is as contagious as chickenpox – but this comparison didn't seem to impress Tegnell.

"It is difficult to say how contagious Delta is, [as] when it comes to chickenpox, we have been able to follow the disease for several years. The infectivity [of Delta] seems to be very uneven – in some cases, one person infects a hundred people, then we have other occasions when an infected person does not infect anyone at all," he told Sweden's Aftonbladet.

In separate remarks, he pointed to the fact that one-third of the country's municipalities reported zero new Covid cases over the past week. At the same time, there was an uptick in cases among young people in Stockholm and other large cities.

And while U.S. health authorities are pressing Americans in *"high transmission"* areas to mask up, Sweden dropped its last remaining mask recommendation – related to public transport – on July 1.

While Sweden's public health agency has supported measures such as social distancing and remote working, it has no recommendations for the use of face coverings in public spaces.

Reviled by the media for refusing to impose harsh lockdowns, Sweden's less draconian approach to the health crisis appears to be paying off: The Scandinavian nation has <u>recorded</u> a total of eight Covid-linked deaths so far this month, an average of 0.25 deaths per day. One has to really wonder why Sweden has largely been untouched by the alleged Covid-19, which has never been proven to be true by the Koch Postulates.

Daily hospitalizations have also hovered near zero in July: On most days this month, the country saw between 0-2 Covid-cases requiring hospital treatment. At the same time, daily cases have fallen sharply since April.

Over the past fifteen months I kept reading about Sweden's open society, no lock downs, no masks, no Covid-19 or little if at all. I began to wonder could there be something so obvious that it was being overlooked! Most interesting is the fact that Sweden decided to delay auctioning and licensing the telecoms for the new 5G wireless energy communications. I came across a report by Jamie Davies posted on November 18, 2019. Sweden has been late into the 5G wireless communications picture. Sweden only began to roll out 5G earlier this year compared to the U.S. and many other countries are from a year to two ahead of Sweden. Note this date; Sweden did not auction spectrum bands for 5G until July 28, 2021.

This lag time of almost two full years between **5G** announcement and infrastructure construction since many countries were out of the starting gate in the fall of 2019, long before Sweden. This may be the explanation why for the past 18 months Sweden has been largely free of Covid-19, no lock-downs, no face diapers, and life as normal. After

all, if this was a "pandemic" as declared by the WHO in March, 2020, the pandemic escaped Sweden somehow. Sweden did face pressure by the globalists and were ridiculed for not complying, and now it becomes evident why.

Sweden decides to delay 5G spectrum allocation

The Swedish Post and Telecom Authority (PTS) has announced it will delay the allocation of spectrum in the 3.5 GHz and 2.3 GHz bands due to a security review.

The 3.5 GHz and 2.3 GHz bands spectrum bands are two of the most attractive when it comes to rolling out **5G** services, blending together a palatable compromise between increased download speeds and coverage. These spectrum auctions have proven to be some of the most interesting, though the delay will be an irritant for the ambitious telecoms. That band spectrum happens to be the least harmful to life.

Pointing towards new security implications introduced in the country's electronic communications law, which was implemented on January 1, 2020, the regulator felt it needed more time to continue discussions with police and security agencies. Details are thin on the ground for the moment, though this is hardly going to be viewed as a plus at the telecoms who have been demanding more spectrums be released.

In June, 2020 progress looked to be gathering momentum as PTS announced a public consultation to release spectrum in the 3.5 GHz and 2.3 GHz bands. 15 national blocks of at least 20 MHz in the 3.4 GHz-3.7 GHz band were set to be auctioned, as well as up to eight 10 MHz nationwide licenses at 2.3 GHz. The auction was to take place in the early part of 2020, though these plans were side-lined.

Sweden was not in a unique position when it comes to a need to free-up valuable spectrum assets, though that will come as little comfort to those who were gearing-up for an auction in the coming months. Reviews like this create a sense of uncertainty in the minds of the telecoms, and uncertainty is the enemy of investment. You only have to look at the UK for evidence of this.

Thanks to the creation of the Supply Chain Review, the position of Huawei was still an on-going unknown. This has led the telecoms to falter with deployment plans. Unless Sweden wanted to encounter the same problems, such a security review had to be completed incredibly quickly. Obligations and conditions had to be considered and relevant, as the last thing anyone wanted was protest from industry, further delaying the critical element of certainty.

Many hoped such a security review does not enter the country into the same purgatory which the UK found itself in with the Supply Chain Review, but it would surprise few if it did.

It may come as a surprise but it is interesting that Sweden did not begin its licensing telecoms until this year, 2021, almost 2 full years before the rest of the world bought into the **5G** technology bidding war.

Swedish telecom operators are planning to cover almost the entire country with **5G** in the next two to three years after a spectrum auction by the country's telecom regulator PTS.

The auction between four bidders, which had been delayed for a security review and by a lawsuit filed by Chinese telecoms equipment maker Huawei, finally took place on Tuesday. The Swedish court upheld a decision to keep Chinese company Huawei out of Sweden for security reasons.

Bidders were units or joint ventures of telecom operators Talia, Tele2, Telenor and Tre. *"We are just really happy that the auction happened now, it is critical for our continued 5G rollout and to strengthen Sweden as a digital nation in the years to come,"* Staffa Kasson, CTO Talia Sweden, said.

The Swedish Post and Telecom Authority (PTS) announced the completion of a **5G** spectrum auction through which it awarded frequencies in the 3.5 GHz and the 2.3 GHz bands to the country's operators. The sale, which was delayed twice, once for security review and the second time over a lawsuit filed by Huawei, raised 2.32 billion SEK (226 million EUR), slightly above the 1.66 billion SEK (155 million EUR) reserve price.

In a statement, PTS noted all 320 MHz at 3.5 GHz was assigned. Full allocations are as follows:

- Talia secured 120 MHz (3500-3620 MHz) for 760.25 million SEK (75 million EUR).
- Net4Mobility (a joint initiative by Tele2 and Telenor's local units) won 100 MHz (3620-3720 MHz) for 665.5 million SEK (65 million EUR).
- Hi3G got 100 MHz (3400-3500 MHz) at 491.25 million SEK (48 million EUR).
- Turaco Group which took over Net1 in 2019 took all 80 MHz on offer in the 2.3 GHz band for a total of 400 million SEK (40 million EUR).

3.5 GHz spectrum was bought at 2.2 cur/MHz/Pop for 10 years, significantly lower than in Italy, the UK, or France, and at almost the same price as Finland.

The four 3.5 GHz licenses will be valid for a period of 25 years (from January 20, 2021, to December 31, 2045).

Regarding **5G** vendors, PTS demands that equipment from Chinese Huawei and ZTE must not be used in the construction of **5G** networks due to national security concerns. The regulator stated that if existing infrastructure for central functions is to be used to provide services in the concerned frequency bands, products from Huawei and ZTE must be phased out on 1 January 2025 at the latest.

In 2020, Finnish vendor Nokia announced its selection by Telia Company to deploy its nationwide **5G** RAN and SA core. Telia Company also contracted Ericsson to deploy **5G** equipment in Sweden and Estonia. Net4Mobility partners Tele2 and Telenor selected Ericsson and Nokia to deploy their nationwide **5G** RAN. Tele2 had previously named Nokia as its core network vendor for Sweden and the Baltics.

Four players out of five mobile providers provide **5G** commercial services to date. Telenor Sweden launched commercial **5G** services in October 2020 in central Stockholm. Rival operators Telia, Tele2 and Tre respectively launched **5G** services in May and June 2020.

Huawei had opposed the sale, saying that it would be difficult to redo the auction if the court subsequently concludes that the terms were unlawful.

"China will take all necessary measures to safeguard the legitimate rights and interests of Chinese companies," a spokesman for China's commerce ministry said on Thursday.

Sweden-based Ericsson, which gets some parts of its revenue by selling telecom equipment in China, had earlier criticized the exclusion of Huawei by Swedish regulators.

A Tele2 spokesman said the company aims to cover over 99% of the Swedish population within three years.

Tele2 launched its first public **5G** network in Sweden on **24 May 2020**. The next generation mobile technology brings increased speeds, higher reliability and new security solutions. Moreover, **5G** will satisfy the ever increasing demand for data in a more energy efficient way.

In the past eight months, the number of worldwide **5G** stations has grown from 18,750 to a shade over 82,200 stations worldwide. In my area of Kentucky, primarily rural and small cities and towns, we have gone from a single **5G** station to five. The cognitive impairment from this experience cannot be described (from perfect health to vision loss, nausea, hearing loss, loss of equilibrium, inability to process information, inability to speak, read or write, seizures and so much more. I am blessed to work in health and to have gone on an immediate and rigorous detox program which helped significantly though long term-impairment may be the outcome as these are very noxious poisons. Others on our flight or other flights might not be as lucky.

THIS IS THE EXACT PROCESS THEY USE TO SANITIZE PLANES:

This is the genocide agenda:



The United States Endeavors to Lead the 5G Race

In Sept. 2018 the FCC announced its <u>5G FAST Plan</u> in an effort to advance the country's position among the countries that have deployed <u>5G</u> networks. Part of this plan includes spectrum auctions. In March 2016, prior to the official start of the <u>5G</u> FAST plan, the FCC hosted an "<u>incentive auction</u>" that began repurposing spectrum and opening up low-band spectrum for wireless broadband that can be used for <u>5G</u> networks. A second auction of the upper 37 GHz, 39 GHz, and 47 GHz bands was set for 2019. Money raised from these auctions will be used to bring high-speed broadband to the rural U.S.

In August 2020, T-Mobile U.S. became the first telecom in the world to launch an SA 5G <u>network</u> with a 5G core. This came after a merger with Sprint was completed in April 2020. This is significant, in that T-Mobile US surpassed AT&T, Verizon, and SK Telecom. AT&T was the expected winner of the race to 5G in the U.S. and SK Telecom was the favorite to have the world's first SA 5G network. Both had plans to have a network with SA 5G architecture by early 2020 but did not meet those benchmarks.

AT&T and Verizon are still part of the **5G** conversation in the U.S., although it's debated which of those two was truly first to market. In December 2018, AT&T was the first U.S. carrier to launch a standards-based mobile **5G** network servicing a dozen cities, albeit without any **5G**-enabled devices. In October 2018, Verizon was the first to have a non-standards-based deployment that was actually a fixed broadband network in four cities. In March 2019, Verizon turned on its standards-based **5G** network in Minneapolis and Chicago, also before mobile **5G** devices were available. Verizon began selling Samsung Galaxy S10 **5G** on May 16, 2019 and claims it will have **5G** in 30 cities by the end of 2019. As of August 2019, AT&T had deployed **5G** in 21 cities and claimed the **5G** network would be deployed in 30 states by the end of 2019.


