
# SARS2-CoV-02 Still Has Never Been Proven!



## World to Spend \$157 Billion on COVID-19 Vaccines Through 2025 U.S. News and World Report reported:

Total global spending on <u>COVID-19</u> vaccines is projected to reach \$157 billion by 2025, driven by mass vaccination programs underway and "<u>booster shots</u>" expected every two years, according to a report by U.S. health data company IQVIA Holdings Inc released on Thursday, April 29<sup>th</sup>, 2021. The United States is preparing for the possibility that a booster shot will be needed between nine to 12 months after people receive their first full inoculations against

COVID-19, a White House official said earlier this month. <u>Pfizer</u> Inc has also said boosters may be needed within 12 months.

The SARS-CoV-2 virus that allegedly causes COVID-19 has still, to this date, never been isolated. Countless governments and organizations worldwide have failed to produce evidence of its existence when challenged. ### #1 SARS-CoV-2 the Theoretical Virus - The Virus Has Never Been Isolated According to Koch's Postulates or River's Postulates

We'll start with this, because this is the cornerstone of the whole scam.

All the following information and evidence below stems from the fact the so-called experts have never isolated and purified the virus according to the gold standard of Koch's postulates, or even the modified *River's Postulates*.

#### Koch's postulates are:

- The microorganism must be identified in all individuals affected by the disease, but not in healthy individuals.
- The microorganism can be isolated from the diseased individual and grown in culture.
- When introduced into a healthy individual, the cultured microorganism must cause disease.
- The microorganism must then be re-isolated from the experimental host, and found to be identical to the original microorganism.

<u>River's postulates</u> were proposed by **Thomas M. River** in 1973 to establish the role of a specific virus as the cause of a specific disease.

They are a more refined, modifications of the Koch's postulates.

They are as follows:

- The viral agent must be found either in the host's (animal or plant) body fluids at the time of disease or in cells showing lesions specific to that disease.
- The host material with the viral agent used to inoculate the healthy host (test organism) must be free of any other microorganism.
- The viral agent obtained from the infected host must produce the specific disease in a suitable healthy host, and/or provide evidence of infection by inducing the formation of antibodies specific to that agent.
- Similar material (viral particle) from the newly infected host (test organism) must be isolated and capable of transmitting the specific disease to other healthy hosts.

#### Whichever set of postulates is used; SARS-CoV-2 fails the test.

Dr. **Andrew Kaufman** does a great job explaining why in this video: Hopefully, it has not been blocked or censored.

The coronavirus SARS-CoV-2 (allegedly causing the disease <u>COVID-19</u>) has not been shown to be present only in sick people and not in healthy ones.

The virus has <u>never</u> been isolated, which must be done with proper equipment such as electron microscopes and which cannot be achieved through CT scans (as the Chinese were using) and <u>the flawed PCR test</u>.

#### #3 SARS-CoV-2 the Theoretical Virus: CDC Stated No Quantified Isolate Was Available

The US CDC (Centers for Disease Control and Prevention) in its July 2020 report CDC 2019-Novel Coronavirus (2019-nCoV) Real-Time RT-PCR Diagnostic Panel admits that, It had been running PCR tests based not on an actual viral isolate (an actual sample or specimen taken from an infected human), but rather "stocks" of "transcribed RNA" taken from a gene bank to "mimic clinical specimen":

"Since no quantified virus isolates of the 2019-nCoV were available for CDC use at the time the test was developed and this study conducted, assays designed for detection of the 2019-nCoV RNA were tested with characterized stocks of in vitro transcribed full

length RNA (N gene; GenBank accession: MN908947.2) of known titer (RNA copies/µL) spiked into a diluent consisting of a suspension of human A549 cells and viral transport medium (VTM) to mimic clinical specimen." (pg.43)

### #4 SARS-CoV-2 the Theoretical Virus - CDC Admitted They Made a Digital Virus of 30,000 Base Pairs Using 37 Actual Sample Base Pairs

As covered in a previous article 'SARS-CoV-2 - The Stitched Together, Frankenstein Virus,' the CDC has already admitted that SARS-CoV-2 is a computer-generated digital virus, not a real living virus... Did you catch this? It is a "model" generated by a computer program!

#### Here is the quote:

"Whole-Genome Sequencing We designed 37 pairs of nested PCRs spanning the genome on the basis of the coronavirus reference sequence (GenBank accession no. NC045512). We extracted nucleic acid from isolates and amplified by using the 37 individual nested PCRs."

Another way to say this is that, the "virus" has been constructed using a technique called de novo assembly which is a method for constructing genomes from a large number of (short or long) DNA fragments, with no a priori knowledge of the correct sequence or order of those fragments.

A subsequent study highlighting fatal flaws in the *Corman-Drosten paper* was published entitled 'External peer review of the RTPCR test to detect SARS-CoV-2 reveals 10 major scientific flaws at the molecular and methodological level: consequences for false positive results.'

It highlights how the authors used 'in silico' or 'theoretical' sequences from computer banks, not real isolated samples from infected people. Folks, this is criminal acts against humanity!

"In silico" is pseudo-Latin for "theoretical"; in plain English, synonyms for theoretical are "imaginary" and "make-believe."

The first and major issue is that the novel Coronavirus SARS-CoV-2 (in the publication named 2019-nCoV and in February 2020 named SARS-CoV-2 by an international consortium of virus experts) is based on *in silico* (theoretical) sequences, supplied by a laboratory in China, because at the time neither control material of infectious ("live") or inactivated SARS-CoV-2 nor isolated genomic RNA of the virus was available to the authors.

On Tuesday, April 27<sup>th</sup>, 2020, the Centers for Disease Control and Prevention (CDC) revised its guidance on mask-wearing, advising that Americans who are fully vaccinated may now exercise and attend small outdoor gatherings without a mask. There is much evidence to the point that masks are totally useless, and dangerous to those who wearing them for any length of time. Politicians have fallen into the trap of the bogus science that masks are effective, of which Dr. Anthony Fauci has revealed that he is a hypocrite. The face diaper has superseded importance over the debate that a bogus virus exists. As a diversionary ploy, Dr. Fauci takes the focus off the real issue, there is no virus, and plays with our intelligence that we should wear masks all the time.

It's too little, too late, argues Stanford University Professor of Medicine Jay Bhattacharya. The public health agency's hypervigilant coronavirus response over the past 12-14 months has paved the way for what he calls "the institutionalization of hypochondria" among the American public.

"This sort of order should have come long ago," said Bhattacharya during an interview on "Just the News AM." "I think they're being entirely too cautious by saying, 'Okay, only if you're vaccinated ... People who have had the disease before are also immune. Why shouldn't they be 'allowed' to not wear masks?"

There has been "very little evidence of outdoor transmission of the disease to begin with," added Bhattacharya, coauthor of the Great Barrington Declaration, a manifesto that urges an alternative COVID-19 strategy focused on protecting those at greatest risk while minimizing disruption and damage to the larger society. The statement has been signed by close to 14,000 medical and public health scientists.

"[P]ublic health authorities, including the CDC have generated an enormous amount of fear and panic around the disease," says Bhattacharya.

On Tuesday, President Biden, who has been fully vaccinated for many months, wore a mask outside as he walked to the podium to address the press regarding the CDC's newest guidance. Last week, Biden wore a mask during a virtual climate summit with other world leaders who were maskless.

Calling masks "a palpable symbol of panic and fear," Bhattacharya said Biden's use of a mask in public "even though he has been vaccinated and is immune, sends the entirely wrong signal about the efficacy of vaccination and a whole host of other things."

"We basically have said, look at disease avoidance as the central problem in your life, no matter who you are," he explained. "It's not taking care of your kids. It's not practicing your faith. It's not doing doing as well as you can in your in your profession. None of that is as important as avoiding disease. And I think it's going to be very difficult to undo that."
