

# The Satanic Talmud & The Synagogue of Satan

## Part 4

THE JEWISH TALMUD is “Holy Writ” for a majority of the Jews and it supersedes the Old Testament in authority for them. The Talmud is the most racist, hate-mongering, blasphemous book the world has ever known. It was written *in Hebrew* between the 3rd & 6th Centuries as a codification of the so-called “*Oral Law*” that the Jewish rabbis’ claim was handed down from Moses. That is an outright lie since the “*Oral Law*” supposedly came out of the Babylonian Captivity. The Northern Kingdom went into captivity in 722 B.C. with the Assyrians. The Southern Kingdom went into captivity in 586 B.C. It ended in 538 B.C. As punishment for their failure to observe the agricultural Sabbath Rest, the Jews lost [God took from them] the three most important things in their life: The **Torah**, The **Temple**, and the **Land**. The “*Oral Law*” is what they brought out of captivity with them.

In addition, later Jesus Christ, the Messiah censored the “*Oral Law*” when He said, “***By the traditions of your elders you make void the Word of God.***” -(Matthew 15).

It should be noted that Zionism and the Zionist movement only dates to just before the 20<sup>th</sup> century, when Nathan Birnbaum, a Jewish Austrian journalist created the term “Zionism” in 1890, which was simply a code-name for “Jewish Nationalism” and was used in his journal “*Self-Emancipation.*” Portrayed as a political movement seeking to secure a homeland for the Jews, **the Rothschild’s founded the Zionist Congress to promote Zionism**, but is in reality a conspiracy for the purpose of bringing the **entire world under Jewish nationalism**, which means world government administered and controlled by Jews, in particularly, the Rothschild’s.

The first meeting of the Zionist Congress was arranged to take place in Munich, however, due to opposition from local Jews, the meeting was moved to Basel, Switzerland, 245 miles away and took place on August 29-31, 1897. The meeting was chaired by Ashkenazi Jew, Theodor Herzl. Herzl was subsequently elected president of the World Zionist Organization (WZO) which adopted the Rothschild red hexagram as the Zionist flag, which eventually ended up on the flag of Israel 51 years later (see illustration on page 4). **The true symbol of Biblical Judaism is the Menorah. It is NOT the Satanic six-pointed star that is on the Israeli National Flag.**

The distinction and difference between Ashkenazi Jews and Sephardic Jews is the point of contention that led to Jesus Christ’ prophetically exposing the fake pretenders in Revelation 2:9 and 3:9. Christian Zionists and most Bible prophecy teachers ignore this most important distinction as we will show in this article. Ashkenazi Jews were converts from the kingdom of the Khazars and claimed they were Jews, and settled in Eastern Europe. The origin of the

Khazars is unclear and they arrived in the Volga-Caucasus region at an undetermined time in history. The Khazars are generally accepted to be of Turkish origin and probably migrated to the area from Central Asia.

On the other hand, the Sephardic group of Jews originated from Spain and their name Sephardi, in Hebrew, means Jews of Spain. Their descendants came from Spain, Portugal, North Africa and the Middle East. When the Roman Empire destroyed Herod's Temple in Jerusalem in 70 A.D., the Biblical descendants of Abraham, Isaac, and Jacob, largely fled west across North Africa, to Spain and Portugal in what is known as the "Diaspora". Historical records show some groups fleeing to even as far east as India. **There were no Ashkenazi's around much before the 7<sup>th</sup> century A.D.**

The majority of Ashkenazi Jews are descended from prehistoric European women, according to a study published in the (October 8, 2013) edition of *'Nature Communications'*. While the Jewish religion began in the Near East, and the Ashkenazi Jews were believed to have origins in the early indigenous tribes of this region, **new evidence from mitochondrial DNA, which is passed on exclusively from mother to child, suggests that female ancestors of most modern Ashkenazi Jews converted to Judaism in the north Mediterranean around 2,000 years ago and later in west and central Europe.**

The new findings contradict previous assertions that Ashkenazi mitochondrial lineages originated in the Near East or from mass conversions to Judaism in the Khazar kingdom, an empire in the north Caucasus region between Europe and Asia lasting from the 7th century to the 11th century whose leaders adopted Judaism. *"We found that most of the maternal lineages don't trace to the north Caucasus, which would be a proxy for the Khazarians, or to the Near East, but most of them emanate from Europe,"* said coauthor Martin Richards, an archaeogeneticist at the University of Huddersfield in the U.K.

Richards and his colleagues story "seems reasonable," said Harry Ostrer, a human geneticist at Albert Einstein College of Medicine of Yeshiva University in New York City who was not involved in the study. *"It certainly fits with what we understand about Jewish history."*

The Ashkenazi Jews make up the majority (90%) of Jews today and most recently have ancestry in central or Eastern Europe. Previous work has demonstrated that just four mitochondrial types, passed down from four mothers, and account for 40 percent of variation in the Ashkenazi Jews' mitochondrial DNA. Some researchers have published evidence of Near Eastern origins for these Ashkenazi mitochondrial types.

To further investigate the matrilineal lines of the Ashkenazi Jews, Richards and his colleagues looked at mitochondrial genome sequences in living Jews and non-Jews from the Near East, Europe, and the Caucasus. Based on the results, the team concluded that, in contrast to the evidence for many Ashkenazi males, whose Y chromosomal DNA suggests a likely origin in the Near East, the female lineage of Ashkenazi Jews have substantial ancestry in Europe. Specifically, the researchers found that the four main Ashkenazi founder mitochondrial types

were nested within European mitochondrial lineages, not Near Eastern ones, and an analysis of more minor haplo-groups indicated that an additional 40 percent of mitochondrial variation found in Ashkenazi Jews' mitochondrial DNA was likely of European origin. The remaining variants appeared to be from the Near East or are of uncertain origin, and there was no evidence for Ashkenazi Jewish origins in the Khazar kingdom, according to the authors.

Historical evidence indicates that Jewish communities began to spread into Europe during classical antiquity and migrated north during the first millennium C.E., arriving in the Rhineland region by the 12th century. Local European women could have begun to join the Jewish population around 2,000 years ago or earlier, Richards and his colleagues suggest that the Ashkenazi's may have continued to recruit additional women as they headed north.

Eran Elhaik, a research associate studying genetics at the Johns Hopkins University School of Public Health, is split. He agreed with the study authors that the study rules out a Near Eastern origin for many mitochondrial lineages of the Ashkenazi's but disagreed that it rules out a Khazarian contribution. *"Jews and non-Jews residing in the regions of Khazaria are underrepresented, which biases the results toward Europe as we have seen in many other studies,"* he said in an e-mail to *'The Scientist'*. Elhaik recently concluded from autosomal DNA that European Jews did, in fact, have a Khazarian background.

David Goldstein, a geneticist and director of the Center for Human Genome Variation at the Duke University School of Medicine, said that the questions of whether there was a Khazar contribution to the Ashkenazi Jews' lineage, or exactly what percentage of mitochondrial variants emanate from Europe, cannot be answered with certainty using present genetic and geographical data. Even if a set of variants are present in a specific region today, that doesn't mean that the region always had that set of variants. Some variants could have been lost due to drift, or perhaps migration altered the balance of variants present in the population.

"These analyses really do not have any formal statistical inference about evolutionary history in them," Goldstein wrote in an e-mail to *'The Scientist'*. "They are based on direct interpretations of where one finds different [mitochondrial DNA] types today. And so the analyses are largely impressionistic."

Nevertheless, Goldstein noted that the new study "does offer better resolution of the [mitochondrial DNA] than earlier ones, and so the suggested interpretation could well be right."

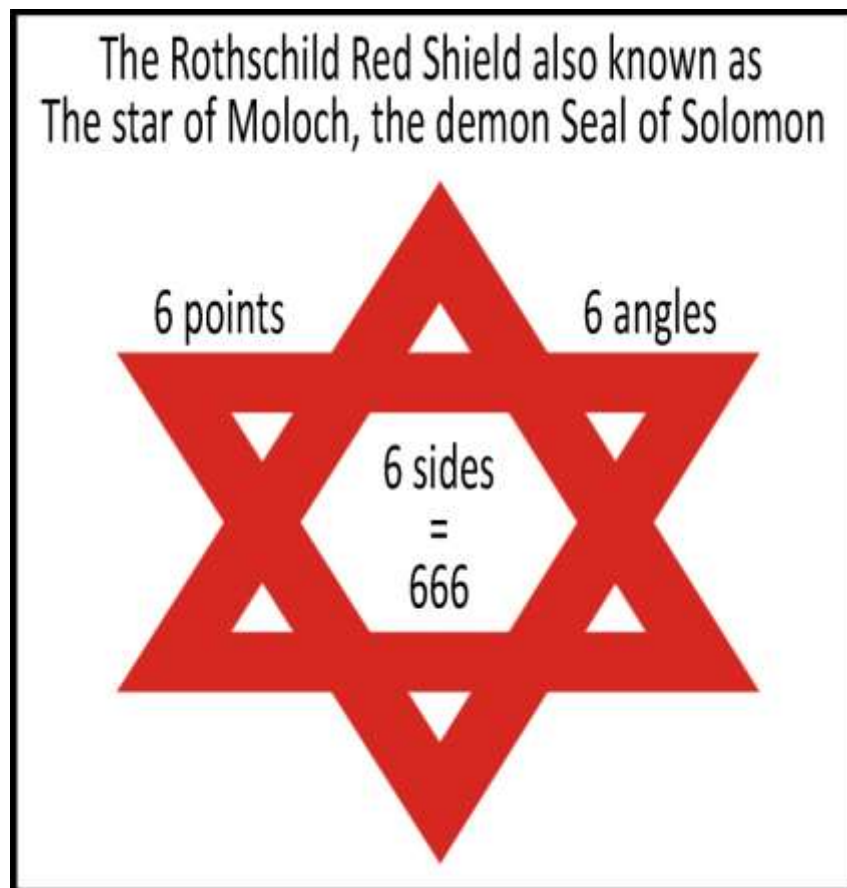

Many today contend there are few Biblical Jews in the State of Israel today, and from what studies that have been done, they do not constitute any sizeable number. In essence, Bible

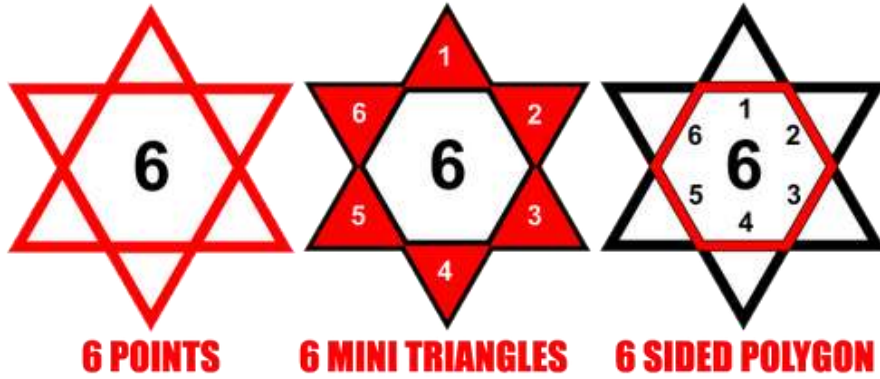

The minutes of this first Zionist Congress would be released by the world many years later as the 'Protocols of the Meetings of the Learned Elders in Zion' Many in the 20<sup>th</sup> century have tried to tag the 'Protocols' as an anti-Semitic hoax, as the Jews claim. Fortunately for the world today, that lie could not be hidden due to publishing, and subsequently, the creation of the Internet. There are a total of 24 Protocols, and few people have actually read them, despite their being published in recent decades in paperback. The content is distinctively Zionist. This is the Rothschild's shield that Mayer Amschel Bauer placed above his coin shop business in Frankfurt, Germany in 1760, after changing his name to Mayer Amschel Rothschild [**Red Shield**], In German, "**Rot**" is German for "**red**"; and "Schild" is German for "shield" or "sign". Now, ask yourself where else have you heard that number "**666**"? Is it a coincidence that it is mentioned in your Bible? I don't think so as you will soon see!

The main passage in the Bible that mentions the "Mark of the Beast" is **Revelation 13:15-18**. Other references can be found in **Revelation 14:9, 11, 15:2, 16:2, 19:20, and 20:4**. This mark acts as a seal for the followers of Antichrist and the false prophet (the spokesperson for the

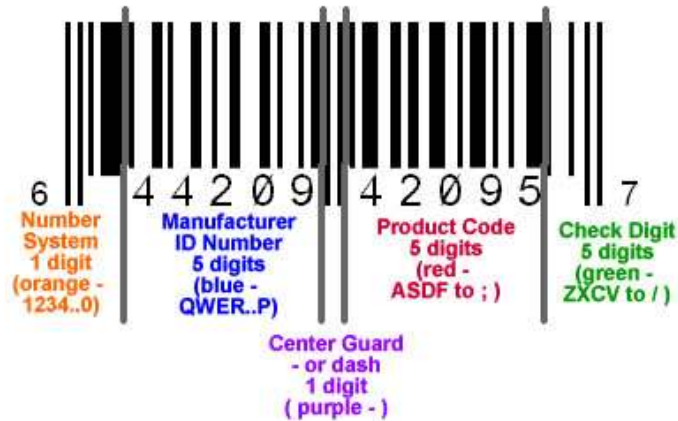


Antichrist). Since the Bible does not speak favorably about this, in that it refers to anyone receiving the “Mark” it is the kiss of death. The Mark of the Beast is predicted in the Bible to be something that the Antichrist and the Final World Empire will require of every man, woman, and child. This “Mark” will be the dividing line between life and death - Christ or Antichrist, allegiance to God or allegiance to Satan, and it will be given in the right hand or forehead. That said, I suggest that television ministries of Bible prophecy teachers should be more discerning when it comes to those they embrace and exalt and extoll in their ministries.

The concept of “666” is so simple that it is almost laughable. The first illustration above is the basic design for the UPC or Universal Product Code. Upside down “666” is “999”. The point of this is that the bar code scanner is searching for a start-read point and a stop-read point. The scanner is able to read a UPC Code regardless of its placement while moved across the scanning glass. The scanner is always looking for the longer bars noted above with the “6”. These are designated as “start/stop/start” bars (also called guard bars) that extend below the number sets. The set of numbers to the left are manufacturer’s numbers for a specific company, like Pepsi, or Heinz, etc. The set of numbers to the right are product code numbers. Every company has a manufacturer’s number and every product produced has a product number.



Why the number “6”? This is where the simplicity becomes evident. Only a “6” can be read as a “6” regardless of whether it is right-side up or upside down! The scanner is looking for those “start/stop/start” bars that extend below the bars for the other numbers.

The reader can see that the number “6” and a “9” are virtually the same number. Actually the length of the bar code is the most important element to the computer scanner. The first example at the top shows the distinction similarity of the bars that represent “6” in blue and are virtually the same as the red bars. The computer software determines that the sequence of processing is in the correct order and adjusts accordingly to correctly identify the item against a computer data base for the item’s price.

Originally, when the UPC system was first put into service in 1974, a cashier had to manually scan each item with a hand held bar-scanner, whereas today, the clerk simply passes the item across a glass-protected scanner beneath the check-out area. The only thing a parcel handler has to do in a volume facility such as UPS or FedEx is to make sure a package or parcel is positioned on a belt or roller conveyor track so that the bar code labels can be read electronically as it moves down the delivery conveyor to its destination dock.

Today, there is upwards of three dozen different type bar codes, but the basic system concept introduced in the early 1970’s remains largely the same today. The system has accommodated added features and details with little difficulty. There is nothing sinister in the UPC Bar Code we might think. Not so fast! Here is where 5G comes into the big picture. If you have a PC with wireless Wi-Fi, take your antenna out and note that it has a UPC bar code label. ALL electronic

devices have a built-in I.D. number unique to it and enable it to “hand-shake” with other electronic devices. 5G will unify a global real-time electronic wireless continuum.

Since 1974, I have believed the six Scripture references to the “Mark of the Beast” in the book of Revelation was the greatest proof of the accuracy and truth of the Bible for folks today. When you read my eBook, its connection to the House of Rothschild becomes blatantly obvious. The Apostle John penned the Revelation of Jesus Christ in 96 A.D. and it is only in the past three decades that we have seen how this symbol is being brought into the full light of day. It is absolutely astonishing to follow the Babylonian system of “666” and its evolvement to where it is integrated into our present world of banking, finance, credit, inventory, and accounting; including the very name referred to in the “*Synagogue of Satan*”, i.e., Rothschild!

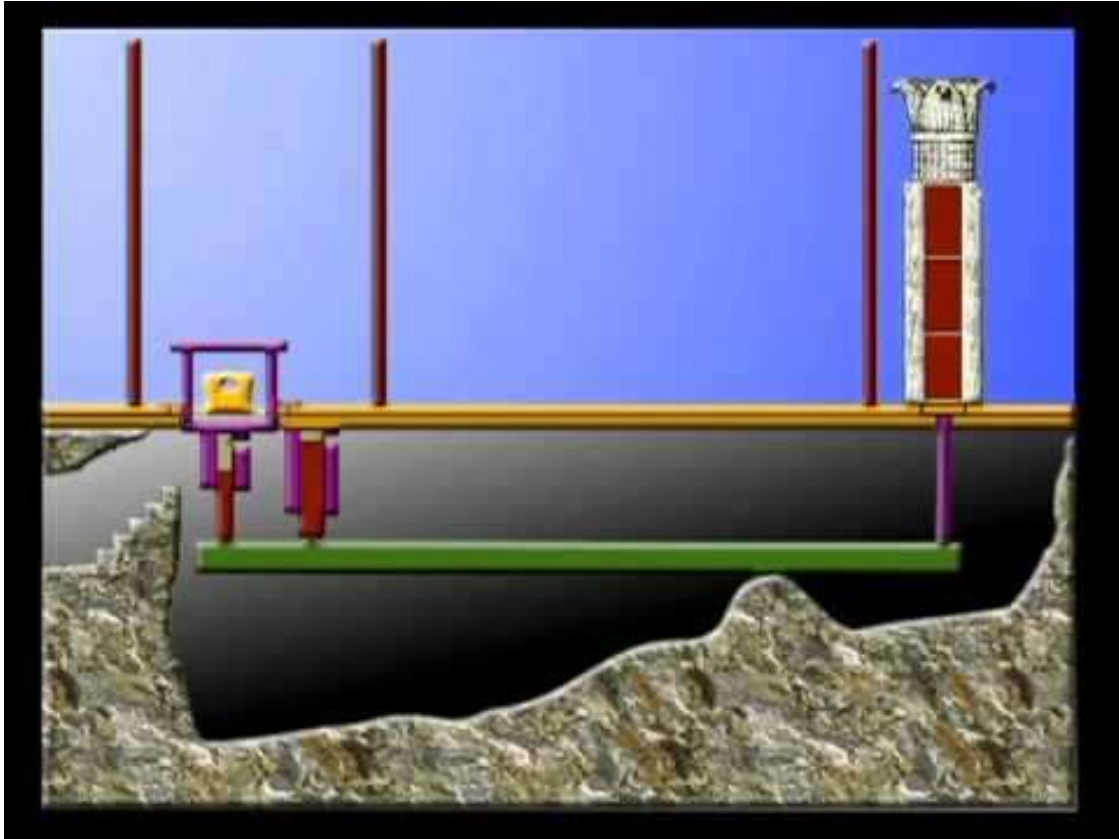
We are very close to the integration of a “cashless” society. Central banks around the world are close to the point of implementation of technology that will eliminate paper currency.

This has far greater significance than you can begin to fathom when you consider that Mayer Amschel Bauer Rothschild chose this number “666” in the form of the “hexagram” over his place of business in Frankfurt, Germany. I need to mention here that the GPS coordinates of

the photo on page 7 above sum to "666". The significance of this will become clear in the content in the pages to follow. The Dome of the Spirits is also known as the Dome of the Tablets, a reference name to the location of the Ark of the Covenant, which contained the tablets of stone inscribed with the Ten Commandments given to Moses.



Above: On both sides of the entranceway Porch of the Temple, two columns, called **Jakin** and **Boaz**, were erected. They stood alongside a "vertical" axis. The hollow columns were filled with sand. When the sand was allowed to escape through the base of the columns, the cantilever was able to raise the elevator the needed distance at the other end of the Holy of Holies, and once the Ark of the Covenant was moved to the platform, the priests would then lower the Ark of the Covenant to the passage way below and out of view and secret it out of the Temple to a safe and secure place within the limestone caves that existed beneath the Temple area to the north beneath the place of the skull, known as Golgotha.

The cut-away sketch above of the sand-hydraulic elevator illustrates the mechanics used to lower the Ark of the Covenant beneath the Holy of Holies which was hidden from view. 1<sup>st</sup> Kings 7 actually records the difference in height of the capitals, first before the sand-activated-lever was actuated and the second measurement reveals the height change once the sand-activated lever was released which took place in the bleeding off of the sand inside the two hollow columns at the entrance of the Temple porch area. The ornate columns obviously functioned for other than aesthetic purposes. The mystery of what happened to the Ark of the



Covenant is revealed in this rather ingenious method of quickly removing the Ark from being discovered and captured. The video link below shows the incredible secret of the Ark.

1<sup>st</sup> Kings 7 & 8, along with 2<sup>nd</sup> Kings in Scripture gives us a hint as to the detail and planning that likely went into the preservation and protection of the Ark of the Covenant in the advent of a military battle that anticipated the worst possible scenario.

The photograph on page 7, of the Dome of the Spirits/Dome of the Tablet is the exact location where the sand-hydraulic elevator was located in the Holy of Holies. In the blueprints of the Temple Mount on page 18 and 20, you have precise confirmation that the Dome of the Spirits/Dome of the Tablet is where the Holy of Holies was located. Beneath the Dome of the Tablet, its eight columns, and base stones, lies a square stone with four keyways that secured the sand-hydraulic elevator of Solomon's Temple.

I first came to know about the mystery of the disappearance of the Ark of the Covenant and its ingenious plan to keep it from falling into the hands of the Babylonians when Michael Rood did a presentation on "THE GREAT SECRET OF SOLOMON'S TEMPLE" for The Prophecy Club in 1998 or 1999.

As it turned out, the Babylonians did invade Jerusalem. They destroyed the Temple and carried away many of the vessels and implements to their capital city a thousand miles away. No mention is made in the Scriptures that the Babylonians took the Ark, the Menorah, or other key Temple items. If the Ark and the other implements were hidden under the Temple, why weren't they recovered and used after the Captivity? I suspect God has future reasons!

The Zionist Chabad Jews today are chomping at the bit to build their third temple [the Antichrist temple] and it will be at this exact GPS location where the temple mount exists today. A few years ago, author and modern-day Indiana Jones, Bob Cornuke disputed the location of the 2<sup>nd</sup> Temple or Herod's Temple. He set about to disprove the work of existing scholarship.

The late Dr. Chuck Missler extended a speaking platform nearly a decade ago to Bob Cornuke, a retired police investigator, who has since made a reputation for himself by disproving a number of Biblical sites. He disputed the work of Asher Kauffman, Randal Price, and other professional archeologists in Israel. Three years ago, Asher Kauffman wrote a 50-page rebuttal of Bob Cornuke's new found claim that the Temple Mount was not the true location. Dr. Kauffman has devoted his entire adult lifetime to the research and study of the Temple Mount. We know with absolute certainty that Bob Cornuke's work on this to be untrue, and I will explain.

The last historical mention of the Ark in Scripture is found in 2<sup>nd</sup> Chronicles 35:3, where King Josiah (who reigned in Judah circa 640-609 B.C.) asked the Levites to return the Ark to the

Temple where Solomon had originally housed it after completing and dedicating the Temple sometime in the 10<sup>th</sup> Century B.C. -(2<sup>nd</sup> Chronicles 5). There is no mention as to why the Levites had removed the Ark in the first place, nor is there any indication as to whether or not the Levites acquiesced to King Josiah's request. So when did the Ark of the Covenant disappear? It seems that it disappeared sometime immediately prior to the Babylonian Captivity in the 6<sup>th</sup> Century BC.

Ken Ham of 'Answers in Genesis' states, *"The Bible is silent on the Ark of the Covenant at the time of (and just prior to) the fall of Jerusalem in 586 B.C. The last Scriptural reference of the whereabouts of the Ark prior to Revelation 11:19 are from 2 Chronicles 35:3, which states that the Ark of the Covenant was still in the Holy of Holies during the 18th year of Josiah's reign (622 B.C.). Ezekiel mentions that the Glory of the Lord departed from between the Cherubim (Ezekiel 10:4, 18) during the sixth year of Jeconiah's exile (593–592 B.C.). The next possible allusion to the Ark is Lamentations 2:1 (right after the destruction of Jerusalem in 586 B.C.) which says that His Footstool was not remembered in the day of His anger (the fall of Jerusalem). Some commentators, based on their interpretations of 1 Chronicles 28:2 and Psalm 132:7, think "His Footstool" refers to the Ark of the Covenant, which was subsequently lost, captured, or destroyed."*

This could have happened only at and along with the destruction of Jerusalem in 586 B.C.; and history testifies that after the exile, the Temple had no Ark (as does Jeremiah 3:16, which stated that the Ark of the Covenant would not be remembered or rebuilt by post-exilic Jews).

It is my opinion that the Ark of the Covenant still exists and that God has future plans for its future unveiling to the world. The Ark of the Covenant is a sacred object in Jewish and Christian tradition. It was a physical representation of God among the Jewish nation. The Jews are considered God's "chosen" people (this term "chosen" has been misunderstood by Jews and Gentiles) and when Moses led them to the Promise Land, God had given them the Ark while they made their extended 40-year journey. The construction of the Ark of the Covenant is placed on the Biblical Timeline around 1445 BC.

The Ark of the Covenant is more than just a material object that represents God, His power and His deity. The Israelites carried the Ark ahead of their group as they trekked through the wilderness for over 40 years. Since the Israelites did not have any permanent structures, they didn't have a Temple to worship God. One of the reasons why God sent them the Ark was so that they could be reminded that it was God who was constantly providing for and taking care of them. The Ark was carried when they went into battle and it was used to house the Ten Commandments (Two Tablets) given to Moses by God.

God had given Moses certain instructions for building the Ark. God told Moses that the Jewish people were supposed to construct the Ark out of wood. Once the wooden part of the Ark was constructed they would then cover the inside with gold as well as the outside. The Ark was also to have a crown of gold and rings of gold as well. The staves were supposed to be made from wood and covered with gold. These staves were used to carry the Ark.

In the book of Revelation, readers are given a snapshot of the Ark as it is seen in heaven. In this particular book of the Bible, heaven opens up during end time events and the Ark of the Covenant can be seen in heaven. This is important to know because the Ark of the Covenant is patterned after God's Temple in heaven. This is an important point as to why God gave the Israelites specific instructions about how to build the Ark.

The Ark was used by the Israelites during their many battles. When Joshua was in charge of the Israelites, the Ark was used in the process of defeating Israel's enemies at Jericho. When the Ark was used by the Israelites, God's power had manifested through it as a sign that he would fight for them or give them the ability to overcome their enemies.

Israel's most famous king, David, wanted to build God a temple, but God didn't allow him. Even though the Lord was pleased with David's request. The king had shed too much blood for God to allow him to complete the task. This is why King Solomon was left with the task of building the temple to house the Ark.

Once Solomon had constructed the Temple, the Ark rested there up until the time the Babylonians destroyed the temple in 586 B.C. After this point, almost no one on Earth is absolutely sure about the whereabouts of the Ark. What actually happened to this religious relic is the subject of debate, mystery and controversy.

The reasons why I believe the Ark of the Covenant still exists and is securely hidden away has everything to do with God's Own Glory. John Piper of the web site "Desiring God" wrote an interesting article on "God's Zeal for His Own Glory". As John Piper points out, "Probably no text in the Bible reveals the passion of God for His own glory more clearly and bluntly as Isaiah 48:9-11" where God says, ***"For my name's sake will I defer mine anger, and for my praise will I refrain for thee, that I cut thee not off. <sup>10</sup>Behold, I have refined thee, but not with silver; I have chosen thee in the furnace of affliction. <sup>11</sup>For mine own sake, even for mine own sake, will I do it: for how should my name be polluted? and I will not give my glory unto another."*** John Piper named "thirty" Biblical texts that drive this point home. As I have related in another article on Ezekiel, I noted that no fewer than **54X times**, God says words to this affect, and many of those dealt with how the Jews had disgraced and defamed God's Holy Name! (See Ezekiel 36:20; 36:23; 39:7; and 39:25).

Many skeptics argue the case that there never was such an object as the Ark of the Covenant, just as they deny the crossing of the Red Sea, which has been proven to be true in the last twenty-five years. Today, I have a small library of books and research material which refute the skeptics and naysayers on the miraculous crossing of the Red Sea and the Ark of the Covenant.

While many skeptics see the Ark of the Covenant as just a gold-plated wooden box, valued only for the gold-plating, it seems to me that it has a much larger purpose here than to treat it as an obsolescent relic. No, I believe it will be revealed and when it is, it will again bring back God's

Glory. Unfortunately, it seems that even among Christians, the Ark of the Covenant has been treated in a rather blasé manner. Daniel's 70<sup>th</sup> Week is all about the restitution God required because of the Israelites failure to observe the Sabbath Rest. Payback is coming in the form of the Tribulation period. The Ark of the Covenant, and particularly the Mercy Seat, will weigh in when the Jews finally call out in repentance: ***"Behold, your house is left unto you desolate: and verily I say unto you, Ye shall not see me, until the time come when ye shall say, Blessed is he that cometh in the name of the Lord."*** -(Luke 13:35; Matthew 23:39). God will give them an opportunity to see the error of their ways by producing items they will recognize as proof of their long history of apostasy and rebellion. Above any items, the Ark of the Covenant would have profound impact upon the Jews. Repentance will be instantaneous!

Here is the Ark of the Covenant's journey recorded in Scripture from the time they crossed the River Jordan into the Promise Land:

1. It crossed the Jordan near Jericho; carried by Levite priests; the Jordan dried up to allow the Israelites' passage -(Joshua 3:3-4, 15-17).
2. First encampment at Gilgal on the **10<sup>th</sup> day of the first month of the first year** -(Joshua 4:18-19).
3. Carried around Jericho **"7"** days -(Joshua 6:4-21).
4. Carried to Mount Ebal for the recording of the Law -(Joshua 8:30-35).
5. Went back to base camp at Gilgal -(Joshua 9:6).
6. Set up at Shiloh about 5-7 years after entering Canaan -(Joshua 18:1).
7. Carried into battle with the Philistines at Ebenezer and captured near the end of the Judges -(1<sup>st</sup> Samuel 4:3-11).
8. Taken to Ashdod by the Philistines -(Joshua 4:11-15:1).
9. Sent to Gath by the Philistines -(Joshua 5:1-8).
10. Sent to Ekron by the Philistines -(Joshua 5:9-10).
11. At some point it was sent to Gaza and Askelon by the Philistines -(Joshua 6:17-18).
12. After **"7"** months, the Philistines sent it back to Israel at Beth-Shemesh -(Joshua 6:1-18).
13. Sent to Kirjath-Jearim by Beth-Shemites where it stayed approximately 75 years during Samuel's ministry. Saul's 40 years and then David's first 7-1/2 years -(Joshua 6:20-7:2).
14. David's first attempt to move it ended up in Uzzah's death; then it was left 3 months in the home of Obed-Edom, the Gittite -(2<sup>nd</sup> Samuel 6:2-11).
15. David moves it to Jerusalem to the Tabernacle he built for it. It remained there for the last half of his reign and first 11 Years of Solomon's reign -(Joshua 6:12-17; 1<sup>st</sup> Kings 6:37-38).
16. High Priest Zadok attempts to take the Ark with David in his flight from Absalom but David has him return it to the City -(2<sup>nd</sup> Samuel 15:24-29).
17. Solomon moved it from David's Tabernacle into the Temple until the destruction of Jerusalem by Nebuchadnezzar in 586 B.C. -(1<sup>st</sup> Kings 8:1-9; 2<sup>nd</sup> Kings 25:1-10).
18. The last reference to the Ark is made by King Josiah in 2<sup>nd</sup> Chronicles 35:3).

Note point #2 above for the importance of this date. **The first encampment at Gilgal was on the 10th day of the first month (Nisan) of the first year (in the Promise Land)** -(Joshua 4:18-19). Nisan is the first month of the religious New Year. Tishrei (roughly six months later in the

fall) is the first month of the secular New Year. Recall my noting that **Pattern = Prophecy**. Joshua 4:18-19 may be just such an example where pattern is hinting at the prophetic for us today. **Below are the events known to have occurred on Nisan 10 in the Hebrew calendar on this specific date:**

**\* Jesus rode into Jerusalem on Palm Saturday,  
which was on Nisan 10 of 32 A.D. ! \***

### **10th of Nisan**

- Water swells on the earth in the days of Noah. Day 100. **Genesis 7:24**
- Abraham circumcises himself, Ishmael, and his entire household. **Genesis 17:22 - 18:2 Mid.Y.16.80, (Pirke DeRabbi Eleazar 28, Yalkut Chadash 121a - Nisan 13)**
- Yocheved hides Moses after a 6-month and one day pregnancy - day 33. Artscroll Mesorah on Shavuot, page 61.
- The **Pesach** lamb (in Egypt only), without blemish, is chosen. **Exodus 12:3, Targum Pseudo Jonathan 12:3**
- The tenth day Ahiezer son of Ammishaddai, the leader of the people of Dan, brought his altar dedication offering. **Numbers 7:66**
- The Children of Israel used the manna which was in their vessels. **Kidushin 38a**
- Joshua's secret spies return from Jericho. **Day 3** in hiding in the hills of Jericho. **Joshua 2:1-23**
- Israelites cross the Jordan River and enter the promised land, camping at Gilgal. **Joshua 4:19-22, Pesikta Rabbah, Ch. 15**
- Miriam dies on the Sabbath before Pesach. *Seder Olam 10*
- The mobile well, which supplied water to the Exodus Jews, dries up. *Seder Olam 10*
- Israelites cross the Jordan and erect 12 monuments at Gilgal. **Joshua 4:20**
- Levites still consecrating the temple in Hezekiah's day, day 10. **II Chronicles 29:17**
- We read about the sun's healing power on Shabbat HaGadol. **Malachi 4:2**
- Hezekiah is healed on Shabbat HaGadol. **II Kings 20:4-11 + Chazal**
- Ezekiel gets temple measurements. **Ezekiel 40, 41, 42, 43**
- Ezra assembles the Jews at the Ahava canal prior to departing Babylon for Israel. **Day 2 Ezra 8:15**
- Tradition puts Yehoshua's composing of the second paragraph of Birkat haMazon.
- Yeshua feeds the multitude. **John 6:4-15**
- Yeshua enters Jerusalem, on the foal of a donkey, as **Messiah King**, on Shabbat. **John 12:12-15, Zechariah 9:9**
- Yeshua heals the blind and lame. **Matthew 21:14**

In another article that I posted recently, I have noted that the Holy Week of 2020 is precisely the same as it was in 32 A.D. The **10<sup>th</sup> of Nisan, or Palm Saturday is April 4<sup>th</sup>, 2020**. A number of related facts provide additional implications that strongly suggest April 4, 2020 could be a highly potential date for the Rapture of the Church. We only have two months to wait.

Asher Kauffman's drawing (on page 14) shows where the first and second temple was in relation to each other. If you notice in the drawing of the first temple, the Dome of the Tablets or Dome of the Spirits is located to the back of the Holy of Holies. Why did God allow the Ark to be removed? We must keep in mind that not only did God allow the Ark to be removed from the Temple but that He also allowed the nation to be removed from the Promised Land and the Temple to be destroyed. This was in fulfillment of the consequences which He had outlined to Moses before the nation had even entered the land. Being God's "chosen" people is not a license to sin or speak of unlimited freedom to disobey with impunity!

The Ark was lowered on the sand-hydraulic elevator and secreted away to a hiding spot beneath the Holy of Holies where it was moved to a location beneath Golgotha where Jesus Christ was crucified. Every summer during the 1980's, the late Ron Wyatt, did exploration of the limestone rock formations beneath and the caverns in the general area identified here. Before his death, Ron said that he had found the Ark of the Covenant, and the Mercy Seat was ajar atop of the Ark. The photo on page 5 is a replica image of what the Ark would have looked like when lowered to its hiding spot beneath. The Dome of the Tablets sits outside of the Moslem Mosque with the Golden Dome. In the days of the Temple, it would have been at the rear area of the Holy of the Holies. Since it was a restricted area accessible only to the High Priest, the people would have been afraid of what might happen to them if they went near this area, and they would not have been aware of the Ark being removed from the Holy of Holies.

1<sup>st</sup> Samuel 6:19 states that God struck down some of the men of Beth Shemesh, putting seventy of them to death because they had looked into the Ark of the Lord. The people mourned because of the heavy blow the Lord had dealt them.

2<sup>nd</sup> Samuel 6:2-7 (also 1<sup>st</sup> Chronicles 13:7-10) mentions the death of Uzzah. He and all his men set out from Baalah of Judah to bring up from there the Ark of the Covenant, which is called by the Name, the name of the Lord Almighty, who is enthroned between the cherubim that are on the Ark. They set the Ark of the Covenant on a new cart and brought it from the house of Abinadab, which was on the hill. Uzzah and Ahio, sons of Abinadab, were guiding the new cart with the Ark of the Covenant on it, and Ahio was walking in front of it. David and the whole house of Israel were celebrating with all their might before the Lord, with songs and with harps, lyres, tambourines, sistrums and cymbals.

When they came to the threshing floor of Nacon, Uzzah reached out and took hold of the Ark of the Covenant, because the oxen stumbled. The Lord's anger burned against Uzzah because of his irreverent act; therefore God struck him down and he died there beside the Ark of the Covenant.

The Ark of the Covenant was an embodiment of God's presence with the Israelites. The Atonement cover (or "Mercy Seat") that covered the Ark was God's throne -(2<sup>nd</sup> Samuel 6:2) and God's presence was above it -(Leviticus 16:2); it was also the place where God met Moses and gave him commands -(Exodus 25:22). If someone approached the Ark, they would effectively be in God's presence - a sinner standing before a holy God who does not tolerate evil

-(Psalm 5:4-6) - and would die as a result of their sins. For this reason, God had given the Israelites many rules concerning the Ark of the Covenant. It was to be kept in the Most Holy Place in the temple, hidden from view by a curtain -(Exodus 26:33). Only the high priest could enter the Most Holy Place, and then only after he had undergone ceremonial cleansing, made sacrifices to atone for his sins and the nation's sins, and burned incense to conceal the atonement cover -(Leviticus 16). When the Ark was moved, it was covered with at least 3 layers of cloth by the priests to protect others from seeing it -(Numbers 4:5-6, 15, 18-20); the priests/Levites carried it and everyone else had to stay about a thousand yards away -(Joshua 3:4). These laws enforced the concept of God's holiness: sinful people couldn't be in his presence, not even the high priest.

Hence, when Uzzah touched the Ark, he was profaning it and disobeying God; he should have grabbed the poles used for carrying the Ark instead, for that was their purpose -(Exodus 25:14-15). The Ark shouldn't have been on a cart anyway, but should have been carried on people's shoulders -(1<sup>st</sup> Chronicles 15:15).

The Israelites who looked in the Ark were actually violating several laws: they came near to the ark (a violation if they weren't Levites), they looked at the Ark, they touched the Ark and they moved the atonement cover, which was God's symbolic throne. Since God's presence was on/over the Ark, they were actually coming into the presence of God - and without the least sense of reverence towards Him, since they decided to poke around and play with His throne! Is it any wonder they died?

The late Ron Wyatt claimed he found the Ark of the Covenant in 1982 right below where Jesus Christ gave His life on the cross. The Ark had been placed in this secret location by Jeremiah 600 years earlier as facilitated by God. When the soldier pierced the side of Jesus, an earthquake split the rock that the cross was placed upon and Jesus' blood ran down through this crack and dripped onto the Mercy Seat of the Ark of the Covenant! All of this information has been suppressed by governments and even religious leaders around the world.

The research work of Ron Wyatt and Michael Rood provide us details and particulars that confirm the existence of the Ark of the Covenant. Michael Rood goes into the background information that Israeli authorities gave Ron Wyatt and then also to Michael Rood. They have been debunked as would be expected; however, there is far too much to this narrative than can be explained away. Between the extra-biblical writings of the Macabees, the writing of the prophet Jeremiah, and the story in 1<sup>st</sup> and 2<sup>nd</sup> Kings, we have a pretty good idea that's supports the existence of the Ark of the Covenant, today!

When Ron Wyatt collected some of this blood from the Mercy Seat of the Ark and had it analyzed, the Israeli scientists were amazed at what they saw! To their astonishment this blood was still alive! The cells were still dividing when they put it in a growth medium. They were also able to get a chromosome count which is not supposed to be possible on dried blood either because it's supposedly dead. This blood was different than any human blood ever seen.

The human genome, which is the complement of genes on the chromosomes, is composed of 22 identical pairs of chromosomes except for the X and Y chromosomes that determine whether a person is a male or a female. In a female all 23 pairs of chromosomes are identical with the 23rd pair being XX. In a male the 23rd pair is an X and a Y chromosome. In Jesus what we see is that he was formed with only half of the chromosomes of the 22 non sex-determining pairs. But in order to make Him a male the Lord supplied the Y chromosome through the Holy Spirit! If this was anything other than a Divine Conception Jesus could not have formed because he would have lacked the paired halves, the needed chromosomes of the 22 non sex-determining chromosome pairs. We can't develop without the chromosomes being paired. And yet by the power of God Jesus did form and God in all his glory provided His signature by putting his Y chromosome into the egg in Mary and thus determining Jesus to be a male!!! If Mary had been impregnated by a man then all 46 chromosomes would have to be present. The miracle of the Divine Conception of Jesus is thus proven since there were only 24 chromosomes evident in the tests!!!

When Jesus died on the cross, the blood from the spear wound in his side that pierced His heart was fulfilling the Atonement for the Biblical Jews, along with you and me as well. In real life and death, He did what the High Priest did symbolically every year when the blood of the sacrificial lamb chosen to be killed and sacrificed in the Atonement was sprinkled on the Mercy Seat for the sins of Israel. Jesus' blood dripped onto the Mercy Seat from the fissure in the crack in the rock above caused by the earthquake!

The non-canonical book of 2<sup>nd</sup> Maccabees reports that just prior to the Babylonian invasion, Jeremiah, ***“following a divine revelation, ordered that the tabernacle and the ark should accompany him and... he went off to the mountain which Moses climbed to see God's inheritance”*** [i.e., Mt. Nebo; cf. Deuteronomy 34:1]. When Jeremiah arrived there, he found a room in a cave in which he put the tent, the Ark, and the altar of incense; then he blocked up the entrance” -(2<sup>nd</sup> Maccabees 2:4-5). However, ***“Some of those who followed him came up intending to mark the path, but they could not find it. When Jeremiah heard of this, he reproved them: ‘The place is to remain unknown until God gathers his people together again and shows them mercy. Then the Lord will disclose these things, and the glory of the Lord will be seen in the cloud, just as it appeared in the time of Moses and when Solomon prayed that the Temple might be gloriously sanctified’”*** -(2:6-8). It is not known if this secondhand (see 2:1) account is accurate; even if it is, we will not know until the Lord comes back, as the account itself claims.

All of this suggests the Babylonians entered the Temple emptied of all its furnishings, leaving them basically empty-handed. But the story does not end here and it is far from being complete. What I now share with readers is reason enough for us to suggest that God in His due time will reveal the physical Ark of the Covenant. As far back as 1998, senior rabbis in Jerusalem have said they know where it is and it will be brought out at its due time.

This information along with whatever the new Sanhedrin in Jerusalem, and Jewish authorities might know could prove to be very important and relevant in the push to build the Third



Temple. Up until recently, the existence of the Ark of the Covenant was largely nebulous or unproven much beyond the narrative of Scripture. The Temple Institute has spent years in the making the furnishings, instruments, and implements needed to return to worship by the Jews. I ask the questions, how will this impact the efforts of the Satanic Zionist Chabad Jews? Will it matter at all? Will God allow them to possess the Ark of the Covenant?

The single most expensive item was the golden Menorah pictured on page 36 which presently is on display in the window of the Temple Mount Institute. Its presence serves as a visual reminder to all Jews in the Old City Quarter of Jerusalem, of their passion for their return to Temple worship. Since we know the focus of this Third Temple involves the Antichrist, it begs the question, will they unveil the hidden Ark of the Covenant or will it be: ***“And it shall come to pass, when ye be multiplied and increased in the land, in those days, saith the LORD, they shall say no more, The ark of the covenant of the LORD: neither shall it come to mind: neither shall they remember it; neither shall they visit it; neither shall that be done any more.”*** - (Jeremiah 3:16).

The Temple Mount could have been at any other altitude or any other place in the world. The place where it is located is at longitude **E 35°14'02.27** and latitude **N 31°46'33.59** and when added together they give us **66.603586°**. Let us restate clearly that the exact point of the Holy of Holies is found at the nexus point where the longitude and latitude meridians total **66.60358** degrees, or **66.6**, as in the **66.6** jubilee years from **2448** to today and **358**, the

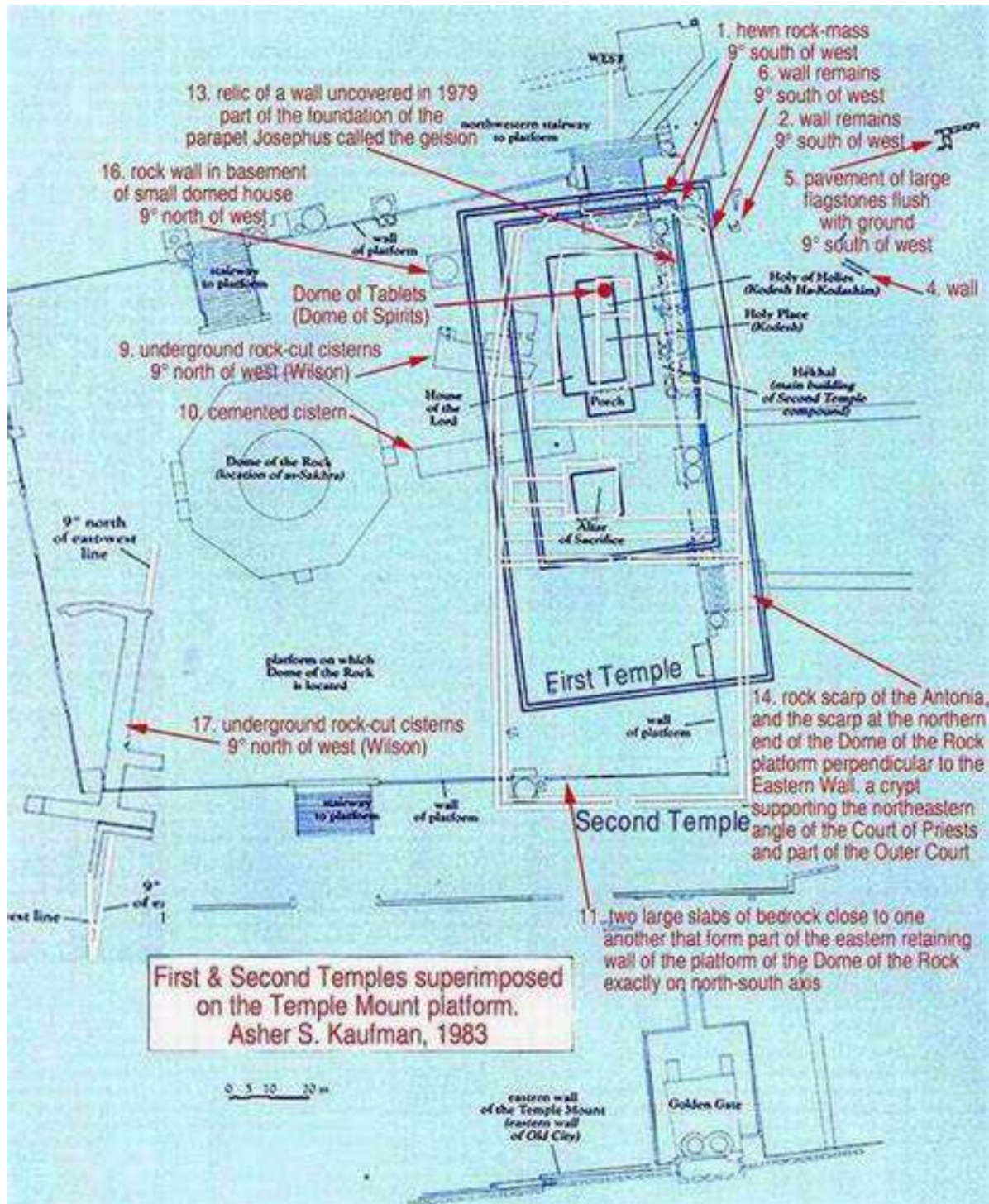

Gematria value of the title - ***Moshiach***. Yes, there are numerous places around the world and Mid-East where the meridians add up to **66.60**—that is just math—but nothing artificially made with the specific altitude of **2448'** on the Temple Mount line up with it exactly here.

It is strangely odd that we got here through the **244.8"**, which is the concealed height of the Giza, Egypt Great Pyramid's capstone with the height to base ratio of **66.60%**. Given the technology of the last few years, we could probably construct it to match the location of the Holy of Holies, but given the technology of ancient Egypt? That would have taken advanced knowledge, planning, and purpose. Chances are that all this mathematical evidence will require some time to digest for you. Some of this I shared when I wrote my eBook: ***“The Season of the Rapture: God's Threefold Witness!”*** I noted that the Great Pyramid of Giza, Egypt contained within the structure well over 100 mathematical properties which described our planet, the moon, the Sun, and confirmed the Great Pyramid is of God.

So stay with me to summarize this for you, not only is the GPS coordinates proof of the location of the first temple, at **“666”**, where latitude and longitude crisscross. The elevation of the Temple Mount is **2,448-feet** while the Great Pyramid is **2,448-inches.** The Pyramid's capstone



with the height to base ratio is 66.60%. Never mind the 244.8" height of the capstone, **the year 2448 in the Hebrew Calendar was the precise year the Jews received the Torah and it matches up with the precise 2448' location on the Temple Mount in Jerusalem.** There are many other mathematical precision points that related to the Hebrew year that was just ended this past fall in 5779, and 5780 began on Tishrei 1, September 29, 2019. If all the data is

correct, then we are reasonably close to the Rapture! **5780, this year portends prophetically as something for us to be watching, awake, and at work!** I have written about the Hebrew year **5778** in a couple of other articles, and noted that we can err in the smallest amount and be off a few years in our calculations. This is what I believe occurred with the date of **5778**.

The incredible data that I have shared here at the minimum puts the kibosh on Bob Cornuke's location of Herod's Temple; and at the maximum is telling us to get ready, ***"And when these things begin to come to pass, then look up, and lift up your heads; for your redemption draweth nigh."***

But with the information we have concerning the Dome of the Tablets, it simply destroys the speculation related to Bob Cornuke's location of Herod's Temple.

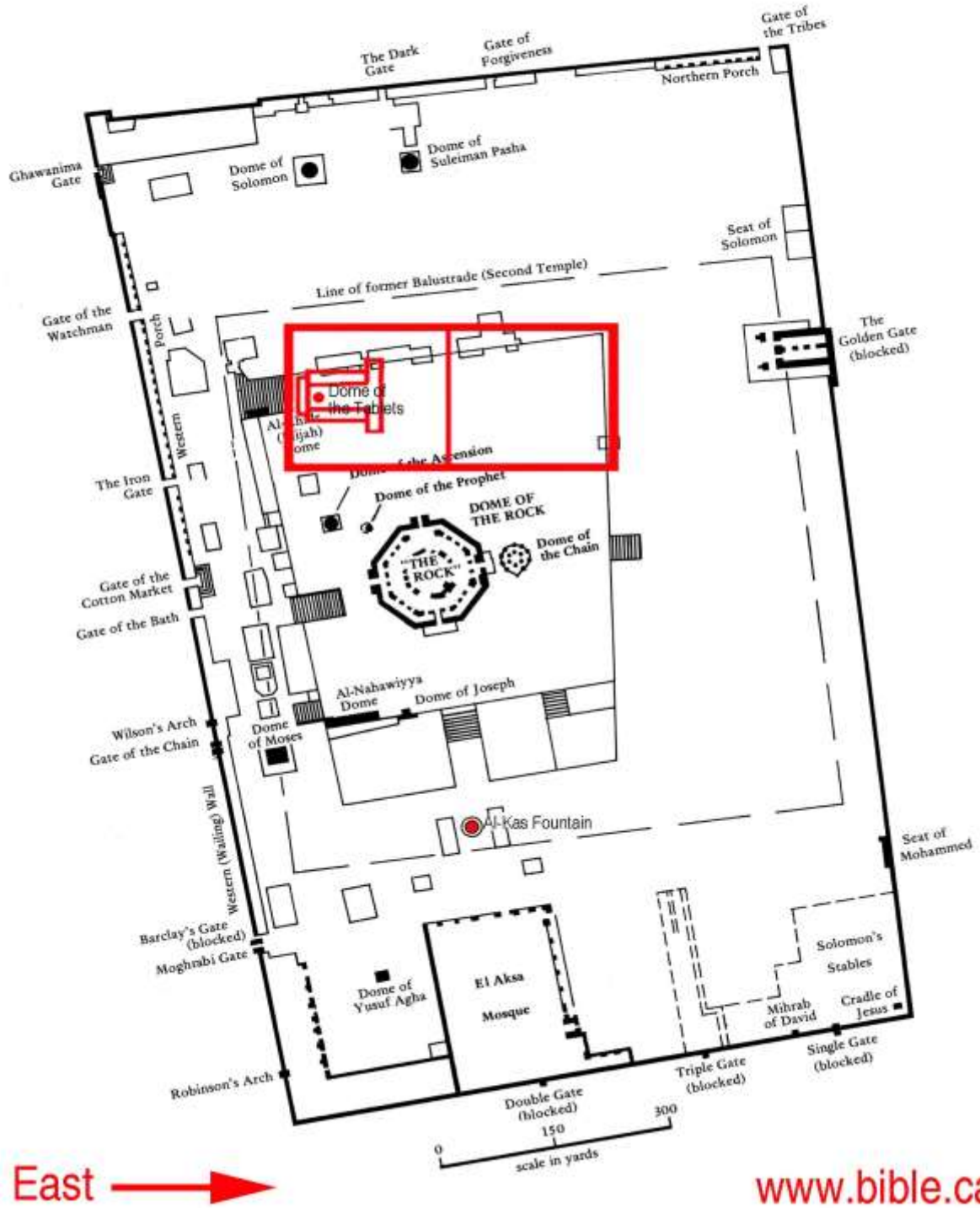
The Great Pyramid at Giza could never seriously be considered Egyptian in origin, other than its obvious location. They never possessed the knowledge, or the technology to produce it. Nor did it ever contain or have hieroglyphics, signs, statues, ornaments, or architecture typical of ancient Egypt. What it did contain was precision and information, precise information given to us in feet, inches, and cubits and how they interrelated with the pyramid's proportions and the mathematical constants of the universe.

Why 3 different measuring scales, or 3 different sets of scaling coordinates? One reason is that it makes it much easier to create and conceal advanced equations. Another is that you need to be familiar with all 3 systems in order to decipher it. The Egyptians could not. Nor could anyone utilize the metric system more than 30 years ago. Also, most of the Torah revelations are in 3's as in Triplets, 3 iterated Names, 3-letter roots, cubes, and 3-part Names. This was a central point of my eBook, ***"The Season of the Rapture: God's Threefold Witness!"***

The Great Pyramid capstone measures 32.0833' on each of the 4 bases and 20.4 feet high over its 7 levels. That height works out to **244.8 inches**, as in the year **2448** when the Torah was received at Sinai and the Israelites left Egypt, and the base measure translates to exactly 14 cubits. We are presently in the Hebrew year **5780**, which began this past Rosh Hashanah on **9-29-2019**. The Talmud, Midrash, and the Kabbalistic work, the Zohar, state that the 'deadline' by which the Messiah must appear is 6,000 years from creation. According to their tradition, the Hebrew calendar started at the time of Creation, placed at 3761 B.C. The current (2019/2020) Hebrew year is **5780**. Supposedly, they have accounted for the missing 220 years (**6,000 – 5780 = 220**). That will be for another segment in this series.

One of the most amazing measurements is the **"Christ Angle"**. In the measurements of the Great Pyramid complex, one of the most important numbers is the **"Christ Angle"** of 26-degrees, 18-minutes, 9-seconds. In the illustration on page 49, of chapter 3, of ***'The Season of the Rapture'*** we are presented with another example of how the Creator connected the Great Pyramid with the birth of the Messiah in Bethlehem of Ephrathah. This is found in the positioning of the Sphinx. The Sphinx has the body of a lion with the face of a woman. It faces due east into the rising morning Sun. The **"Christ Angle"** is 26-degrees 18-minutes 9-seconds

and is also found within the Great Pyramid in a number of places. It clearly reflects the Sacred Geometry of the Creator. By taking a compass and marking off an arc north of center from the Sphinx facing into the morning Sun rise, we can strike an angle of 26-degrees 18-minutes 9-seconds and we discover a line that bisects Bethlehem. The illustration is from Dan Matson's book *'Oracle in Stone'*. This **"Christ Angle"** is found in a variety of non-visual appearances.

The Apostle Paul spent three years and was delivered the Gospel of Grace. Jesus Christ revealed to Paul all of what he would soon face. Even more striking, and not usually noted, is that by striking off an arc south of center from the Sphinx, in the opposite direction, using the same **"Christ Angle"**, we find that it bisects the real Mount Sinai, locally known as **Jabal Al Lawz** in the land of Midian now known today as Saudi Arabia. **The Great Pyramid is the most accurately aligned structure in existence and faces true north with only 3/60th of a degree of error.** Because the position of the North Pole has moved slightly over time the pyramid was most likely exactly aligned at one time. The Great Pyramid complex is made up of three pyramids of different sizes, and these are known as Khufu's Pyramid, Khafre's Pyramid, and the smaller Menkaure's Pyramid. According to Luis Vega's website *'Postscripts, Eschatological Studies'* **the Pyramids align with what is known as the "Fibonacci Spiral", also known as the "Golden Ratio" or "Golden Spiral", further proof of a Divine origin.** This is a mathematical property found in all of nature, leaf arrangement, flower petals and pineapples. All of these examples illustrate the point that there is nothing random in nature. They clearly reinforce the understanding of a Divine designed pattern. Such evidence is the greatest proof of "Intelligent Design" or a Creator God! Helen Lehman of "Pillar of Enoch Ministry" notes in her books, that the Great Pyramid complex mirrors the stars of Orion's Belt Stars – Al Nitak, Al Ral, and Mintaka. The Belt Stars of Orion's belt was at Meridian – directly overhead - on September 23, 2017. The Great Pyramid's smooth Tura limestone casing stones were ordered stripped off by Sultan Hassan when an earthquake occurred in 1378 A.D. They were used to rebuild the mosques of Cairo. Photos exist showing casing stones removed to a height at the 420-foot level. The 144,000 casing stones weighed 5-tons each, and were so perfectly fitted together that one could not see the seams unless they were within a few feet of the pyramid.

When I first began my pyramid studies eighteen years ago, I learned an amazing fact: There are no hieroglyphics, paintings, or inscriptions found in the chambers of the Great Pyramid. There is absolutely nothing in the Great Pyramid to link it with Egypt, Egyptian culture, nothing! This is contrary to all other burial chambers in Egypt which are covered with inscriptions and paintings on the tombs. I have viewed more than thirty-hours of video about the Great Pyramid / Sphinx complex over the past ten years, and what I share in this series is not part of the Pyramid lore in Pyramid videos, or documentaries. **The Great Pyramid is an Alter to the Lord just as Isaiah 19:19-20 states.**

***"In that day shall there be an altar to the LORD in the midst of the land of Egypt, and a pillar at the border thereof to the LORD. And it shall be for a sign and for a witness unto the LORD of hosts in the land of Egypt: for they shall cry unto the LORD because of the oppressors, and he shall send them a saviour, and a great one, and he shall deliver them."*** -(Isaiah 19:19-20)

A point to keep in mind here, is that Biblical numbers can be both positive and negative in God's application and use throughout the Bible. "666" as this article has shown, reflects both aspects. In this example, it is both the GPS location of the Temple Mount, which has the significance of both the Messiah and the Anti-Messiah. The symbolism of the capstone itself, has been related largely to the Rothschild's, the NWO, the Illuminati, Adam Weishaupt, the 1782 Congress of Wilhelmsbad, the 1814-15 Congress of Vienna, the reverse side of the U.S. \$1 bill, etc., the Masonic Unfinished Great Undertaking, and the Washington Monument, to name but a few.

The Anti-Messiah chooses to counterfeit what the Creator originates. Remember, the one thing Lucifer cannot do is to "create", he can only counterfeit. This is what the LGBTQ+P1 issue is all about. It is a war on God and His ability to create, something that Lucifer could not do. We are witness to a war on God, and those who buy into this war will not escape God's Divine wrath. The word “Talmud” is the Hebrew word signifying "doctrine." The Jews say that on Mount Sinai, Moses received not only the written law which is contained in the Pentateuch but an oral law, which was first communicated by him to Aaron, then by them to the seventy elders, and finally by these to the people, and thus were transmitted by memory, from generation to generation. There is not a stitch of evidence or truth to this premise whatsoever.

This oral law was never committed to writing until about the beginning of the third century, when Rabbi Jehuda the Holy, finding that there was a possibility of its being lost, from the decrease of students of the law, collected all the traditional laws into one book, which is called the ***“Mishap,”*** a word signifying repetition, because it is, as it were, a repetition of the written law. The ‘Mishna’ was at once received with great veneration and many wise men among the Jews devoted themselves to its study.

Toward the end of the fourth century A.D., these opinions were collected into a book of commentaries, called the ‘Gemara,’ by the school at Tiberias. This work has been falsely attributed to Rabbi Jochanan; but he died in 279 A.D., a hundred years before its composition. The ‘Mishna’ and its Commentary, the ‘Gemara,’ are, in their collected form, called the ‘Talmud.’ Not being satisfied with the interpretations in this work, the Jews in Chaldea composed others, which were collected together by Rabbi Ashe into another ‘Gemara.’

The former work has since been known as the Jerusalem Talmud, and that of Rabbi Ashe as the Babylonian Talmud, from the places in which they were respectively compiled. In both works the ‘Mishna’ or law is the same; it is only the ‘Gemara’ or Commentary that is different.

The Jewish scholars place so high a value on the Talmud as to compare the Bible to water, the



'Mishna' to wine, and the 'Gemara' to spiced wine; or the first to salt, the second to pepper, and the third to spices. For a long time after its composition, it seemed to absorb all the powers of the Jewish intellect, and the labors of Hebrew writers were confined to treatises and speculations on Talmudical opinions. It dominates the bulk of Zionist Judaism, especially the Chabad.

### **The Mishna is divided into six divisions called Sederim whose subjects are**

The productions of the earth  
Festivals  
The rights and duties of women  
Damages and injuries  
Sacrifices  
Purification

Each of these Sederim is again divided into Massicoth, or treatises, of which there are altogether sixty-three.

The Gemara, which differs in the Jerusalem and Babylonian redactions, consists of commentaries on these Massicoth, or treatises.

Although the Talmud does indeed contain many passages whose peculiarities found little favor with Doctor Mackey, he deemed it, nevertheless, extremely serviceable as an elaborate compendium of Jewish customs, and it has therefore been used greatly in the stupid use of the Old and New Testaments in Freemasonry. It also furnishes many curious illustrations of the Masonic system; and several of the traditions and legends, especially of the higher Degrees, which are either found in or corroborated by the Talmud. The treatise entitled Middoth, for instance, gives us the best description still existing of the Temple of Solomon. -(Mackey's Encyclopedia of Freemasonry).

A few weeks ago, a senior Greek Orthodox clergyman in Israel attended a meeting at a government office in Jerusalem's Givat Shaul quarter. When he returned to his car, an elderly man wearing a skullcap came and knocked on his car window. When the clergyman let the window down, the passerby spat in his face. The clergyman preferred not to lodge a complaint with the police and told an acquaintance that he was used to being spat at by Jews. Many Jerusalem clergy have been subjected to abuse of this kind. For the most part, they ignore it but sometimes they cannot...

According to Daniel Rossing, former adviser to the Religious Affairs Ministry on Christian affairs and director of a Jerusalem center for Christian-Jewish dialogue, there has been an increase in

the number of such incidents recently, "as part of a general atmosphere of lack of tolerance in the country." Rossing says there are certain common characteristics from the point of view of time and location to the incidents. He points to the fact that there are more incidents in areas where Jews and Christians mingle, such as the Jewish and Armenian quarters of the Old City and the Jaffa Gate. There are an increased number at certain times of year, such as during the Purim holiday. "I know Christians who lock themselves indoors during the entire Purim holiday," he says.

A number of links to 'Publisher's Weekly' reviews have been removed that are critical of the Talmud. This is not a huge surprise since ADL and JDL exert pressure to have negative comments and reviews removed. 'Publisher's Weekly' is a major publication referenced by librarians who are responsible for library acquisitions. This speaks to something that few people know exists and understand, that being the intentional removal of books in libraries which Zionists find offensive to their cause.

'PW' is a mainstream literary magazine and website. It concerned a new book, 'Jesus in the Talmud', that exposes the shocking truth about the position of Judaism toward Jesus Christ. It was written by none other than Dr. Peter Schaefer, head of Princeton University *Judaic Studies Program* and one of the world's most famous academic authorities on Judaism. Once again my research and writings have been verified by the most respected of academics. Try to find Dr. Schaefer's book today and see if you can purchase it, it's as if the book was never published. Amazon for some strange reason made it available after it had been banned.

The facts are clear. The Talmud, which is the highest authority of Judaism, not only makes hateful and pornographic attacks against Jesus Christ, it even boasts that the Jewish community, not the Romans, arrested, tried and executed Jesus. In fact, the Talmud exudes so much hatred against Jesus that it claims the Jewish priests subjected his body to a series of four different torturous executions.

His editor at *Princeton University Press*, Brigitta van Rheinberg, laughed but agreed: “*You think, oh, whoa, this is not going to go over well in certain circles.*”

Schaefer, who heads up Princeton’s *Judaic studies program*, has collected and analyzed all the passages in the Talmud that apparently refer to the founder of Christianity, texts that were previously censored from Talmud editions for centuries. In his book he argues—against other scholars—that the scandalous passages indeed refer not to some other figure of ancient times but to the famous Jesus of Nazareth.

What exactly is so scandalous? How about Jesus being punished in Hell for eternity by being made to sit in a cauldron of boiling excrement? That image appears in early manuscripts of the Babylonian Talmud, as does a brief account of Jesus’ trial and execution—not by the Romans but by the Jewish high court, the Sanhedrin. To the extent that Jews were even aware of these excised texts, the Jewish community in general has been content to let them remain obscure and unknown.

Schaefer, a distinguished German-born Christian scholar who describes classical rabbinic literature as “*my first love*,” has now definitively let the cat out of the bag. This undermines a widespread assumption that, of Judaism’s and Christianity’s respective sacred texts, only the Christian Gospels go out of their way to assail the rival faith, whereas Judaism’s classical texts (non-Zionist) refrain from similar attacks.

It seems fair to say now, however, that the Talmud is every bit as offensive to Christians as the Gospels are to Jews.

The Talmud’s scattered portrait of Jesus unapologetically mocks Christian doctrines including the virgin birth and the resurrection. Which isn’t to say that the rabbinic invective is meant simply to insult. In his book, the author calls the Talmud’s assault on Christian claims “devastating.”

"It is a very serious argument," said Schaefer, who emphasizes that the rabbis' stories about Jesus were never intended as an attempt at a historically accurate narrative. Rather, in the classic Talmudic style, they encode legal and theological argumentation in the form of sometimes-imaginative storytelling.

One naturally wonders, when *'Jesus in the Talmud'* is published, what the results will be for Jewish-Christian relations. *"I certainly don't want to harm Jewish-Christian dialogue. God forbid,"* Schaefer said. *But dialogue requires honesty, and "I'm trying to be honest."*

I was able to read some excerpts of the book on Amazon.com and look up some terms in the text search, a very valuable option Amazon now offers. Interestingly, the professor argues that there is a distinction between Balaam and Jesus. He maintains that the Talmud says that Balaam was boiled in semen and Jesus in excrement. Of course, in Jewish Supremacism I quote major Jewish sources that say that Balaam was a pseudonym used for Jesus and cites the passage where Balaam is boiled in semen. Apparently, in at least some Talmudic passages Balaam did denote Jesus as part of their deceptive camouflage against non-Jewish folks prying into their texts. But it is no matter to me. There is not much qualitative difference offered regardless of whether one is eternally being boiled in semen or excrement.

So the only real rabbinic debate about Jesus is whether he is being boiled for eternity in semen or excrement!

It must be the height of insanity to think that probably millions of Christians at the behest of their sold-out leaders have sent money to these vile Antichrist Zionist Jewish extremists who boast of boiling Jesus in semen or excrement -- take your pick! END

### **PROOF that the Talmud Refers to Jesus Christ as Balaam!**

Under the name of "Balaam" the lowliest passages concerning Jesus appear. Proof that Jesus is called "Balaam" is found in the Jewish Encyclopedia ("Balaam") which, after enumerating loathsome qualities, states: "Hence...the pseudonym 'Balaam' given to Jesus in Sanhedrin 106b and Gittin 57a."

In the same article, we are told that the Talmud likens the Gospel, Christians, and Christ to Baal sex-worshipers because of whose abominations 24,000 Israelites died of plague at the time of Balaam. -(Numbers 25:1-9) Because Balaam had been asked to curse the Israelites but instead did not and foretold the coming Messiah -(Numbers 24:17), the flimsy excuse is made that Jesus was a curse like Balaam. "He is pictured as blind of one eye and lame in one foot and his disciples distinguished by three morally corrupt qualities... "He is called "one that ruined a people," and His churches are likened to nudist Baal worship.

And, "this hostility against his memory finds its climax in the dictum that whenever one discovers a feature of wickedness or disgrace in his life, one should preach about it." (Sanhedrin 106b) Hanging the calumny on the brief mention in the Bible that Balaam was slain (Numbers

31:8), this passage in the Sanhedrin is cited by the Jewish Encyclopedia: "In the process of killing Balaam (Numbers 31:8), all four legal methods of execution: stoning, burning, decapitating, and strangling, were employed." (Sanhedrin 1c) "He met his death at the age of thirty-three and it is stated that he had no portion in the world to come." (Sanhedrin x, 2, 90a)

Sanhedrin 90a denying "Balaam" a place in the world to come there it is stated that the resurrection is being denied by Sadducees and Samaritans "It was to oppose these that the doctrine was emphatically asserted in the second of the Eighteen Benedictions." The "sin" of pronouncing the Tetragrammaton is cited against Christ and Christians.

Turning to Sanhedrin 106a-106b we see the likening of Jesus to the supposed act of Balaam in causing 24,000 Israelites to go whoring and die of plague (some 1450 years before Christ was born). He is due for his "reward" for this infamy. His mother, Mary, is "She who...played the harlot with carpenters... They subjected him to four deaths, stoning, burning, decapitation and strangulation...he was thirty-four years old." Another says: "I... have seen Balaam's Chronicle in which it stated, 'Balaam the lame was thirty years old when Phineas the Robber killed him.'"

The footnote explains: "Balaam is frequently used in the Talmud as a type for Jesus." And the mother of Jesus is identified, the four deaths enumerated, and "...all the Balaam passages are anti-Christian in tendency. Balaam being used as an alias for Jesus, Phineas the Robber is thus taken to represent Pontius Pilate, and the Chronicle of Balaam probably to denote a Gospel." Verifying the Jewish Encyclopedia account above on Balaam being Jesus in the Talmud we see "in the case of the wicked Balaam: whatever you find written about him, lecture upon it to his disadvantage." Christian churches are likened to tents for Baal prostitution, with old women outside, young ones inside to get customers drunk and disrobe and worship the "IDOL," Jesus, in Baal manner, by prostitution.

The NWO will be Babylon the Great restored and completed, headed up by the Antichrist and the False Prophet. Then the Stone (Jesus Christ) cut out of the mountain without hands will smash the kingdoms of this earth. It's defining symbol is the Hexagram that is represented on the Israeli National Flag, and in the Rothschild's "Red Shield" or "666".

The Hexagram has gained mastery over the human world. Practitioners might appear to be upright Jews, Catholics or Masons, but they are impostors who infiltrate and subvert. Behind the evil in this world is a symbol. Understand this symbol and the cabal who use it and you can identify the evildoers and their diabolical plot. This cabal hides inside legitimate religions, and secret societies, such as Judaism, the Jesuits and the Masons, using them as shields for their evil deeds. What they all have in common is their practice of the Hexagram and its dark arts.

The Hexagram is a symbol that has been used by witchcraft and sorcery for thousands of years to conjure up spirits. The symbol can be found in many places; India, Egypt, Peru, China, Europe, Argentina, etc. Numerologists believe the Hexagram represents the evil number 6-6-6 and practitioners believe it can bind and control supernatural creatures.

To put a "hex" on someone is to put a curse on them. The word "hex" is itself derived from the number "6" in Greek; in middle German, a "Hexe" is a witch. In China, the year of the snake is the 6th year in their calendar and the I Ching consists of 64 Hexagrams.

Worshippers of the Hexagram use it for evil - they believe that by performing rituals and human sacrifices, it gains more power. Who are these worshippers? Many hide within the Jewish faith, within the Freemasons and Catholicism, and of course are more openly prominent with witches, pagans and others. Events like wars and persecutions are ritual human sacrifices performed to accrue more power using this symbol.

According to Dr. O.J. Graham (*'The Six-Pointed Star, 1999'*), "The first mention of the star was in Amos 5:26 regarding the trek from Egypt to Canaan. Then, in 922 B.C., when Solomon married the daughter of Pharaoh and then drifted into magic and witchcraft even building an altar to Ashtaroah and Moloch. The book traces the six-pointed star from Egypt to Solomon, to Arab Magic and Witchcraft, to Druid use (references are documented). It also traces the star through Freemasonry usage to Mayer Amschel Bauer, who, in the 17th century, changed his name to depict the **red** six-pointed star (or shield) which he had hung on his door in Germany, and thus began the family of "**Red** Shield" or Rothschild. The research carried on through this family, to their coat of arms, to Cabala, to Astrology, to Hitler and his use of a yellow six-pointed star to identify all Jews during the holocaust, to the Zionist symbol, and finally to the flag of the State of Israel and beyond."

The Hexagram is also used by the Freemasons who use the "Seal of Solomon" to perform evil acts. The Masonic symbol is itself derived from the Hexagram. This symbol is found on Masonic temples, and buildings constructed for the use of Masons which often have Hexagrams inside and out.

The Hexagram symbol is also plainly visible on Catholic churches like Santa Croce in Florence, Italy and in the IX XI symbols used in Jesuit rings, where the void between the X's signifies the Hexagram.

Zionism and Communism were both created by the practitioners of the Hexagram, using large scale ritual human sacrifice to impose their plot everywhere on Earth. Where this symbol goes, death and destruction follow in the form of a burnt offering, a Holocaust. Two World Wars, the Holocaust of the Jews, and 9/11 are a few of the examples of the ritual human sacrifices performed to impose Zionism.

Communism was imposed at a cost of 60 million lives in Russia and 80 million lives in China. In Russia, 60% of those involved in the plot were Jews, while in China, 85-90% of the westerners helping Mao were Jews. Ten years ago a Ph.D. writer dared to ask this question: "*Did 70 Million Die So the Jews Could Have Palestine?*" Her documented research was shunned by the media, well knowing to do so would bring the wrath of the Zionist House of Rothschild.

The Masons had a hand in this as well, with President Truman (a Mason) subduing Japan by ordering two atomic blasts (another burnt offering) and FDR (a Mason) providing material aid to Mao as well as the communists in Russia. These Holocausts continue to the present day with the persecution of Falun Gong in China that includes live forced organ harvesting - something unprecedented in history. Today, the Chinese communist party is still in control of 1.4 billion people.

This affair is 5,000 years in the making - a dark and evil witch's tool for curses and occult powers has gained dominion over people, nations and civilizations. It is used by a cabal of evildoers to impose the New World Order from Communism and Zionism.



Above – The menorah weighs one-half ton. It contains forty five kilograms of twenty four karat gold. Its estimated value is approximately three million dollars. The construction of the menorah was made possible through the generosity of Vadim Rabinovitch, a leader of the Jewish community of Ukraine. It was placed on display several years ago.

The original symbol of Judaism was the Menorah, which represented the relationship with God and the imparting of Judaic Law to man through the burning bush. Today, Kabbalah and

Zionism have replaced the original, true symbol of Judaism with the Hexagram. Unfortunately, many Jews are unaware of the true meaning of this symbol.

The key to identifying the perpetrators is to see who uses the Hexagram; the impostor Jews, impostor Catholics, secret societies and witches. Many others were corrupted; they "sold their souls" to this group to gain money or power and they are now on the side of evil. Those who are still good, but ignore the evil in their midst and still do nothing are "useful idiots". They are complicit and share the guilt of the perpetrators.

It's not too late to "get out" -- you have been misled and poisoned by the evil. Your first step is to understanding what is being done in your name and that it is evil. You need to see that good people are being persecuted by this evil all over the world and you must decide where you stand. Regardless of what others might tell you, or what you did in the past, you were made by the Creator and He alone grants you the power to choose your future.

There is so much evidence available that repudiates the Talmud as being anything more than absurd attacks on Christianity, and that it does not deserve to be equated with the Torah, which God dictated to Moses. Christians have been deceived by a race of people who co-opted the Jewish faith. It is just as Jesus stated when he said they were of the **"Synagogue of Satan"** in Revelation 2:9 and 3:9. As they declared themselves Jews in avoidance of what they faced. Jesus called them out for their blasphemy.

Like the Jews who sought to kill Jesus, they were of their father the devil. But now Jesus announces that before that prophecy can be fulfilled, Israel herself will have to come and bow down and acknowledge that Christ loves His church. When will this occur? Some theologians take this to refer to the time when every knee shall bow before Jesus Christ. As is often true, history is the key that unlocks the mysteries of prophecy. We know from the text of the prophet Ezekiel, that God will do this primarily to preserve His good and righteous name!

A book came out in 2019 that every Christian should read. The author is Denanne Loper, and the title of the book is *'Kabbalah Secrets Christians Need to Know'* This book will further show that the god of Kabbalah is none other than Lucifer, the serpent and the angel of light, whom the sages prophesy will restore the knowledge to humanity on a global scale, just as he did in Genesis.

Last year, the words of the late Rabbi Yizhak Kaduri spread around the religious and political world of Judaism.

*"On the eve of the year 5780 (the upcoming Hebrew year), the year of corrections, there will not be a government in Israel for an extended period..."*

Benjamin Netanyahu and Rabbi Yitzhak Kaduri had once met at the prime minister's office, in September, 1997. According to a report in the Hebrew daily, Israel 'Hayom', the Sephardic Kabbalist (mystic) Rabbi Yitzhak Kaduri could have predicted the political unrest surrounding recent struggles experienced by Prime Minister Benjamin Netanyahu and the Blue and White leader, Benny Gantz.

In recent days, information alluding to Kaduri's predictions spread throughout social media and on the messaging application Whatsapp as well.

Kaduri reportedly swore to Isaac and he wrote in a "hidden book", that was recently found in the Kabbalistic school of Nahalat Yitzhak, that *"On the eve of the year 5780 (the upcoming Hebrew year), the year of corrections, there will not be a government in Israel for an extended period and the various camps will quarrel much without a decision on either side, and then, on Rosh Hashana (the Jewish new year) itself, they will fight in heaven, the holy side against the side of evil, and G-d and His entourage will decide between them. And this is all I can say, and from here I swore not to reveal more secrets and hidden things."*

Rosh Hashanah began on **9-29-19**, ushering in the Hebrew year **5780**. What Rabbi Kaduri said is considered prophetic by Jews of all groups. Rav Ashlag was the greatest Kabbalist of the past century. Known as Hasulam (the ladder), he was not only the first to translate the Zohar from Aramaic to Hebrew but he wrote volumes of explanations as well and could have written hundreds more by his own account had he had the financial means to cover the pens and paper. His legacy included several other books including 'The Ten Luminous Emanations', which brought new light and understanding to the study of the Tree-of-life as taught by the Arizal 400 years earlier.

In sharing this information about **5780**, it is certainly not intended to glorify a staunch Kabbalist rabbi, but rather to make it clear that Lucifer is at work in the lives of his adherents. Satan speaks to his followers just as God speaks to His servants. We can be formidable adversaries to Lucifer by our knowledge, ***"Behold, I send you forth as sheep in the midst of wolves: be ye therefore wise as serpents, and harmless as doves."*** -(Matthew 10:16). Ephesians 5:11-13 provides our marching orders in this battle against evil. <sup>11</sup>***And have no fellowship with the unfruitful works of darkness, but rather reprove them.*** <sup>12</sup>***For it is a shame even to speak of those things which are done of them in secret.*** <sup>13</sup>***But all things that are reprov'd are made manifest by the light: for whatsoever doth make manifest is light.***" Satan must be well aware at this point that his days are numbered. This is reflected in the Zionist Chabad call to build the Temple now!

Rabbi Yehuda Halevi Ashlag died at the age of 70, on Yom Kippur, 1954, and with his last divine breath uttered these 5 words, quoted from Psalm 91:16: **בְּיִשׁוּעָתִי, וְאֶרְאֶהוּ; אֶשְׁבְּעֵהוּ, יָמִים אָרְךְ.** which translates to ***"With long life will I satisfy him, and make Him to behold My salvation."***

For 56 years since his passing, these words were shrouded in mystery. Now, for sure Rav Ashlag wasn't referring to the infamous number of Revelations, but to the year that the Kabbalistic proportion of "666" points to for the "geula" (final redemption), 5780 on the Hebrew Calendar (2020 C.E.). To the Zionist Chabad Jew, 5780 is equated to the year 6000 to them. To explain all this will require a lengthy explanation, and should be addressed separately so that one can understand its implications. As previously noted on page 17, the Zionists have an answer explaining the missing 220 years. I will deal with point in a subsequent segment. It appears that they may be engaged in building their third temple beneath the Temple Mount as I write this.

With the fulfillment of Rabbi Kaduri's words about a stalemate in the Israeli government, and numerous references to the Rav Ashlag studies of the Hebrew years 5778, 5779, and 5780, Israel is abuzz with talk of the Messiah's coming this year.

Keep in mind Rosh Hashanah this year begins **September 18<sup>th</sup>**. Keep alert to everything occurring as we approach Holy Week of 2020. Saturday, **April 4<sup>th</sup>, 2020** is a very promising date for our "Departure", or Rapture! The first six English translations of the Bible before the KJV Bible actually used the word "**Departure**", from which the KJV translators changed it to "**Falling Away**"; and while this was done to appease the Jesuit Roman sympathizers, one can see the hand of Lucifer in the shadows of the division plaguing the church. The change of words was one of a series of side consequences of those seeking unity between the Church of England and Rome at that time. The accommodation of the subtle changes done to the KJV Bible was one of many over the coming three centuries leading to where we are today.



Look closely at this picture. It is what everyone recognizes as the Washington Monument, built to honor the first president of the USA. Take a close look at the structure and walkways at the base of the monument. In recent years officials changed the walkways so that the monument sits inside two overlapping circles. The monument and the circles portray the sexual union of male and female. The Washington Monument is stark evidence of hidden occultists among America's founders and leadership.



Notice in the above, by the way...the obscene symbolism of the Washington monument with the two circles creating the "yoni" formation at the base of the obelisk. Thus, occultists are symbolically depicting a satanic sexual act. It is Satan's intention to 'violate' America, as well as the rest of the world. This symbol in sacred geometry is known as the Vesica Piscis. These two overlapping circles contain a lot of information, hidden in plain sight. It's a simple, but very powerful symbolic manifestation containing the secrets of the Universe. The Mandorla is the middle part of the Vesica Piscis, it is an Italian word for almonds or almond shaped (it also looks very much like an almond).



Yoni symbolism is seemingly popular in the world of covert occultism. Above, we have the familiar **MasterCard** logo. *And next to that* -- the symbol for **the Olympics**.

Some view the Vesica Piscis as a Christian symbol due to its similarities to the "Jesus fish" known as ICHTHUS. It also mimics the shape of the female vagina and is therefore viewed as a symbol of femininity, birth, and sexuality.

From a spiritual viewpoint, if we recognize the circle on its own as Source Energy (God or Goddess), the Vesica Piscis represents creation or the "womb of The Universe." Think of a single circle as Source Energy, adding a second circle represents the spark of creation when the universe is born. This idea is enforced with its similarities to the shape of the vagina, the starting place of birth on a human level. It is enforced again by the fact that it is the starting place of most sacred geometry.

This is why for many, the Vesica Piscis symbol is considered to be very sacred. On a spiritual level, it represents creation, birth, and the joining of spiritual and physical. Take this a step further, and without the Vesica Piscis, sacred geometry would not exist, and we would not exist. That is the common understanding of the secret societies, for which all are subordinate to in Freemasonry. Our Nation's Capital is replete with Masonic art and architecture which are largely pagan in nature, as well as sexual in their meaning and implications. Freemasonry, Judaism, Communism, Kabbalah and Mormonism are all sexually perverted and Demonic Cults! Freemasonry and Mormonism are rooted in Jewish Kabbalah, an esoteric religion of black magic. Judaism is based upon Kabbalah and the Talmud (which permits Jewish priests to have sex with 3-year old girls). Mormonism is a perverted sex-sick cult, rooted in the Jewish Kabbalah.
