

The Satanic Talmud & The Synagogue of Satan

A hard hitting Alternative News site “The Millennium Report” posted an article on January 20, 2015 bearing this headline “**70 Million Died So The Jews Could Have Palestine**” – subtitled “**The Nazi & Jewish Affair To Remember**” By Katherine Smith, PhD. It was re-posted at that site in either late January, 2020 or early February of this year. I had read it back when it was originally posted but had forgotten it existed. I scan upwards of 1,500 news items, reports, documents in the course of my day, and so, if I don’t save it, or print out the header page, it can be lost in memory. I am including the content which in essence confirms everything that I have addressed in this series.

I have added at the end of this information by Katherine Smith, PhD., an interesting press report made at the beginning of March, further evidence of the Zionist Chabad Judaism movement to surreptitiously undermine the English Bible, specifically the KJV Bible, and even the counterfeit modern translations that were watered down and diluted by those who hate the KJV Bible. I think it comes at a time when the President is under the sway of Zionism.



Premise:

The following informed-opinion essay puts forth the premise that WW I, WW II and the Holocaust can be understood if you realize that 70 million people died in order for the Jews to settle in Palestine in 1948.

Events That Changed the World in the 20th Century, edited by Frank W. Thackeray and John E. Findling is a unique resource that offers detailed descriptions and expert analysis of the 20th Century’s most important events; however, the creation of the State of Israel is not among the Events That Changed the World in the 20th Century. Without a modern State of Israel perspective, historians, scholars and researchers have spent half of the 20th Century writing hundreds of thousands of manuscripts, books, theses, dissertations, essays and journal submissions attempting to resolve the anomalies and inconsistencies of the events from 1897-1948.

The year 2009 was the first time anyone in history realized the significance of Theodore Herzl's remarks at the first Zionist conference in 1897. Herzl predicted UN Resolution GA 181, would be adopted in 1947, creating the State of Israel. [2]

The Modern State of Israel: Providence, Miracle, or What Really Happened was reviewed by Mark Weber, the director of The Institute for Historical Review (www.ihr.org) in May of 2010.

The Institute for Historical Review (IHR) continues the tradition of historical revisionism pioneered by distinguished historians such as Harry Elmer Barnes, A.J.P. Taylor, Charles Tansill, Paul Rassinier and William H. Chamberlin. It strives, in the words of Barnes, to "bring history into accord with the facts." After the review, Mark wanted to know what Robert Singer had read (The Bible, The Incredible Scofield and his Book, The Cassandra Prophecy) that allowed him to be the first one in history to connect The Scofield Bible, World Wars I, II and the Holocaust, to the Jews arriving in Palestine not in 1946 or 1950, but in 1948, Aka The Key to the Secret of the Universe. The Nazi & Jewish Affair to Remember (November 2010)

Why did the CIA create a 'safe haven' for Nazis in the US after the War? [3]

The Long-hidden report: CIA created 'safe haven' for Nazis in the US, released November 13, 2010, may be the most concrete account yet of the role that prominent members of Germany's Nazi Party played in the early, formative years of the CIA, following World War II. The report alleges the CIA created a "safe haven" for Nazis believed to be of use to the US' Cold War efforts. [4]

Notice the words alleges and believed to be of use to the US' Cold War efforts.

The 600-page report (not identified until December 10), which the Justice Department has tried to keep secret for four years, confirms what historians refer to as "a pathetic chapter" in our nation's history. The "experts" our intelligence people recruited were just a bunch of criminals and losers that never provided any useful intelligence about the Soviet Union."

Three weeks later (December 10), APNewsBreak identifies the report as Hitler's Shadow: Nazi War Criminals, U.S. Intelligence, and the Cold War, and goes into the details on the Nazi Gestapo, and the Ukrainian fascist, Mykola Lebed. Lebed led a paramilitary organization that pursued ethnic cleansing policies during the war.

The December 10 article, unlike the one on November 13, now defends the US' intelligence official's decision to provide a safe haven for Nazi criminals. The CIA, according to the report, "shielded Lebed by denying any connection with the Nazis and by arguing that he was a Ukrainian freedom fighter. The CIA concluded that Lebed's activities on behalf of American intelligence were of such 'inestimable value' that the agency could ill afford to lose him as an asset."

CIA spokesman George Little, concerned about the department's image issued this statement:

"The CIA at no time had a policy or a program to protect Nazi war criminals, or to help them escape justice for their actions during the war. The agency has cooperated for decades with the Justice Department's Office of Special Investigations."

And while the November 13 report concluded the CIA was inept or just stupid because they didn't know Lieutenant Richard Hallock had a breakthrough in 1943 when he deciphered the codes of the Red Army intelligence (The Venona Project), the December 10 article goes on to defend the CIA's policies:

"The Army's willingness to use Gestapo officials against Communists was more substantial or greater than what we had known" and in an attempt to disrupt the USSR, through penetrations in Ukraine, the agency turned to Nazi-affiliated nationalists, including "Tireless in his efforts on behalf of Ukrainian nationalism, Lebed remained one of the agency's oldest contacts until his death in 1998."

The Nazi War Crimes Disclosure Act resulted in more than 8 million documents being declassified, but the Office of Special Investigations (OSI) admits, "Yet even more records are still hidden."

In 2007, the OSI had waived more than 23,000 pages, but as of this date is keeping secret over 18,000 pages, allegedly to protect the "ongoing investigations (going on for decades) and prosecutions." [Let's see, the war ended 66 years ago, anyone who is being investigated is either deceased or over 85 years of age. Why would they need to keep secret almost half the records?]

Mysteriously, the next day (12/11), the December 10 article is rewritten by Randy Herschaft and titled Report details ties between US and ex-Nazis, but this version fails to mention the OSI is keeping secret over 18,000 pages "to protect ongoing investigations and prosecutions" of war criminals who are on their death bed.

The 12/11 report expands on the postwar efforts by U.S. intelligence officials efforts (that George Little denies) to throw the Nazi hunters off the trail:

“You can make the argument the CIA never should have gone near this guy (Lebed) because of his past,” said Norman J.W. Goda of the University of Florida, who wrote the report with Richard Breitman of American University in Washington. But Goda said the CIA found the relationship to be so valuable for getting information into and out of the Soviet Union that “the relationship couldn’t be sacrificed.” “This was somebody that was very, very useful and remained so for the entire Cold War,” he added.

Another part of the report addresses the story of Otto Von Bolschwing, an associate of Adolf Eichmann, who was instrumental in drawing up plans for ridding Germany of the Jews. [5]

Below is an excerpt by Christopher Simpson about Otto Von Bolschwing from Simpson’s Blowback America’s recruitment of Nazis, and its disastrous effect on our domestic and foreign policy, Page 252:

“The story of U.S. intelligence relations with criminals such as Brunner is of necessity fragmentary, for both the CIA and Brunner himself have taken extensive measures to keep such affairs hidden. It is clear, however, that Brunner was not an exception to the rule who managed to ingratiate himself with the Americans through guile or through an oversight. There is, in fact, at least one other known case of U.S. recruitment: Baron Otto von Bolschwing, an SS veteran of Adolf Eichmann’s “Jewish Affairs” office, the elite committee that served as the central administrative apparatus of the Nazis’ campaign to exterminate the Jews.”

Notice he worked in Eichmann’s elite “Jewish Affairs” office, not in the Third Reich’s elite “Soviet Affairs” office.

“Von Bolschwing, deeply involved in intelligence work, and in the persecution of innocent people for most of his adult life, was a supreme opportunist who succeeded in traversing the whole evolution of U.S. policy toward Nazi criminals.

He profited during the war from the Nazi confiscation of Jewish property, then later from the defeat of Nazi Germany itself. Von Bolschwing enlisted as a CIC informer for the Americans in the spring of 1945.

Von Bolschwing joined the Nazi party at the age of twenty-three, and in the years leading up to 1939, he was a leading Nazi intelligence agent in the Middle East, where he worked undercover as an importer in Jerusalem.

One of his first brushes with Nazi espionage work, according to captured SS records, was a role in creating a covert agreement between the Nazis and Fieval Polkes, a commander of the militant Zionist organization Haganah, whom Von Bolschwing had met through business associates in the Mideast. [Interesting]

Under the arrangement the Haganah was permitted to run recruiting and training camps for Jewish youth inside Germany. These young people, as well as certain other Jews driven out of Germany by the Nazis, were encouraged to emigrate to Palestine. Polkes and the Haganah, in return, agreed to provide the SS with intelligence about British affairs in Palestine.

Captured German records claim that Polkes believed the increasingly brutal Nazi persecution of the Jews could be turned to Zionist advantage—at least temporarily—by compelling Jewish immigration to Palestine, and that the Haganah commander’s sole source of income, moreover, was secret funds from the SS.” [End of Excerpt]

Consider another reason the CIA created a “safe haven” for Nazis.

Von Bolschwing, it is reasonable to assume, had access to the secret memorandum written on June 21, 1933, from the German Zionist Federation to the Nazis, which stated in part: “All German Jewish organizations, it was declared, should be dominated by the Zionist spirit.” In 1941, the “Stern Gang,” among them Yitzhak Shamir, later Prime Minister of Israel, presented the Nazis with the fundamental Features of the Proposal of the National Military Organization (NMO) in Palestine:

The NMO, which is well-acquainted with the goodwill of the German Reich government and its authorities towards Zionism activity, is of the opinion that: the NMO in Palestine offers to actively take part in the war on Germany’s side. The Iron Wall, London 1984, pp.195-197, The Wall Street Journal December 2, 1976.

“Concentration” weren’t the only camps set up by Hitler and the Gestapo. During the 1930s, in cooperation with the German authorities, Zionist groups organized a network of some 40 camps where prospective settlers were trained for their new lives in Palestine. The Transfer Agreement between Hitler’s Germany and international Zionism, implemented in 1933 and abandoned at the beginning of WWII, allowed German Jews to emigrate to Palestine. [6]

As an Eichmann insider in the “Jewish Affairs” office, Von Bolschwing could have had access to other secret memoranda that would explain why the Jew-hating Nazis were making deals with a commander of the militant Zionist organization Haganah that allowed Jews to leave for Palestine instead of being gassed in a concentration camp.

Providing a “safe haven” for Von Bolschwing and Lebed was a small price to pay to prevent the insiders at the “Jewish Affairs” office from telling the world the Final Solution wasn’t about killing Jews but was The Key to the Secret of the Universe.

The following Glossary, abbreviations and essay will help the reader understand how Theodor Herzl on August 29, 1897 predicted that within fifty years there would be a Jewish state.

Zionism: an organization of Jews who believed the Jewish people needed a nation of their own to escape persecution.

Judaism: Jews collectively who practice a religion based on the Torah and the Talmud.

Rothism or Rothschildism: abbreviation for The Zionist movement corrupted and co-opted by The House of Rothschild and their agents to advance a New World Order agenda. In 1871 Albert Pike Grand Master of the Luciferian group known as the Order of the Palladium, received a vision, which he described in a letter dated August 15, 1871 that graphically outlined plans for three world wars that were seen as necessary to bring about the One World Order.

The Third World War must be fomented by taking advantage of the differences caused by the "agentur" of the "illuminati" between the political Zionists and the leaders of Islamic World. The war must be conducted in such a way that Islam (the Moslem Arabic World) and political Zionism (the State of Israel) mutually destroy each other. Meanwhile the other nations, once more divided on this issue will be constrained to fight to the point of complete physical, moral, spiritual and economical exhaustion...We shall unleash the Nihilists and the atheists, and we shall provoke a formidable social cataclysm ... Then everywhere, the citizens, obliged to defend themselves against the world minority of revolutionaries, will exterminate those destroyers of civilization, and the multitude, disillusioned with Christianity, whose deistic spirits will from that moment be without compass or direction, anxious for an ideal, but without knowing where to render its adoration, will receive the true light through the universal manifestation of the pure doctrine of Lucifer, brought finally out in the public view. [1]

RBZJ: The Rothschild Backed Zionist Jews, acronym used when referring to anyone connected to or related to the House of Rothschild.

RAGENT: Abbreviation for a Rothschild Agent

The House of Rothschild (the Rothschild's): Global financial empire founded in the late 18th century by a dynasty of Khazars, an ancient people from Georgia. [2]

The Rothschild's control a vast portion of the world's wealth and are the hidden hand behind all the social-cataclysms: the French, Russian and American Revolutions; Communism, Capitalism, World Wars and the Modern State of Israel. The Rothschild's are not the Jews of the bible and do not practice Judaism.

Mel Gibson would have been correct if he had claimed, The Rothschild's are responsible for all the wars in the world. The "Labour Leader" newspaper of Britain on December 19, 1891 referred to the Rothschild's when they wrote:

This blood-sucking crew has been the cause of untold mischief and misery in Europe during the present century, and has piled up its prodigious wealth chiefly through fomenting wars between States which ought never to have quarreled. Wherever there is trouble in Europe, wherever rumors of war circulate and men's minds are distraught with fear of change and calamity you may be sure that a hook-nosed Rothschild is at his games somewhere near the region of the disturbance (ibid, p. 12).

In "Imperialism," writer J. A. Hobson wrote: "No Great War could be undertaken by any European State...if the house of Rothschild and its connections set their face against it" (ibid, p, 25).

The "Labour Leader" did not use the term Jew because the Rothschild's are the descendants of Khazars; they are not of Abraham's Seed.

Rothschild founded and funded the Zionist movement to further a New World Order agenda. At the first Zionist conference Theodor Herzl, a Rothschild agent (Ragent) makes it clear Rothlism (Rothlism) is not about saving Jews,

It is essential that the sufferings of Jews....become worse....this will assist in realization of our plans....I have an excellent idea....I shall induce anti-Semites to liquidate Jewish wealth....The anti-Semites will assist us thereby in that they will strengthen the persecution and oppression of Jews. The anti-Semites shall be our best friends. [3]

UN Resolution (GA 181)

August 29, 1897 Theodor Herzl, the founder of Rothlism at the First Zionist Congress predicted that within fifty years there would be a Jewish state. UN Resolution (GA 181) partitioned Palestine in 1947. Rothlism is a political movement to encourage, force if necessary, Jews to move to Palestine. All Jews were encouraged; it didn't matter if you were of Abraham's seed, you left for Palestine or else.

Herzl picking 1947 as the end of the Diaspora and the return of the Jews to the "Holy Land" is either one of those "bizarre coincidences", like the same person winning the lottery three weeks in a row, or the partition of Palestine, finalized in 1947, was part of Rothschild's plan for a New World Order, "to effect complete and total control over every human being on the planet and to dramatically reduce the world's population by two thirds."

Rothschild's secret societies, The Bavarian Illuminati, Order of Perfectibilists, the Skull and Bones are no longer classified as prehistoric science fiction and have their origins in the ancient religions and the occult: Jesuits, Knights Templar, Rosicrucians, Freemasons and the Kabbalah.

In 2003, *60 Minutes* aired a segment about Alexandra Robbins, staff member at the New Yorker. Robbins, a Yale graduate, penetrated the wall of silence around the Skull and Bones, the American branch of Rothschild's secret society and authored the best seller *Secrets of the Tomb: Skull and Bones, the Ivy League, and the Hidden Paths of Power*.

Members of the Skull and Bones include some of the most powerful men of the 20th century.

J.P. Morgan, John D. Rockefeller, Abraham Kuhn and Solomon Loeb are all connected to the Rothschild's Global financial empire and secret societies. They are members of the Federal Reserve, the Bank of England, France, and Germany or, for that matter, any central bank anywhere in the world.

Rothism was not-so-secretly funded when Baron Edmond (Binyamin) de Rothschild purchased 90,000 acres in Palestine launching Israel's future initially as an agricultural society. After the early settlers arrived, they wanted Rothschild to "take his hands from it." Baron Edmond responded, "I created the Yishuv, I alone. Therefore no men, neither colonists nor organisations have the right to interfere in my plans"

Lord Moyne, the British Secretary of State in Cairo, in 1942 tried to interfere in Baron Edmond's plan when he declared "the Jews were not the descendants of the ancient Hebrews and that they had no "legitimate claim" on the Holy Land. In favor of limiting Jewish immigration into Palestine, he was accused of being "an implacable enemy of Hebrew independence," and on November 6, 1944 Lord Moyne was murdered by two members of the Stern Gang (Yitzhak Shamir's group). A Jewish State, a sacrilege, can be found in the Bible

A Jewish state can be found in the book of Revelation. John, an Apostle of Jesus on the Isle of Patmos in 90 A.D., was told to "Write the things which thou *hast seen*, and the things which are, and the things which shall be hereafter." John wrote:

And they will tread the holy city underfoot for forty-two months (1279 days). And I will give power to my two witnesses, and they will prophesy one thousand two hundred and sixty days, clothed in Sackcloth. Revelation 11:2&3

Herzl predicted the 1947 UN partition but John, in the spirit, was taken up into heaven and *saw* that the *holy city would be underfoot for forty-two months* given over to non-Jewish people until 1967 (688 A.D. + 1279 years), when in the first hours of the Six-day war Jews took control of East Jerusalem and the prophesy in Sackcloth ended when they had their own state on May 14th 1948 (688 A.D. + 1260 years). [5]

Grand Rabbi Joel Teitelbaum, believed Rothism is "the work of Satan, a sacrilege, a blasphemy" and The Holocaust, he wept, "was a direct result of Rothism, a punishment from G-d."

Rothschild was well aware of Jewish history and Jews, according to the Christian New Testament, persecuted and crucified Jesus Christ and most of his early followers. America's traditional churches in the 19th Century would never stand for a Jewish occupation of Jesus' homeland.

God has blessed America because America has blessed the Jew. If this nation wants her fields to remain white with grain, her scientific achievements to remain notable, and her freedom to remain intact, America must continue to stand with Israel.

John McArthur, author, pastor at Grace Community Mega-Church came up with a "Just War" explanation for the Iraq War because of Scofield's "specific territory" note. On CNN he told Larry King, "Iraq is 'a just war' because Iraq has not only rejected the Gospel of Jesus Christ, but has done everything it can possibly do to stamp out the people of God, namely Israel."

Robertson, Falwell and McArthur because of Scofield, ignore the central tenets of Christianity: Seeking peace and loving one's enemies, "Peace be with you, that the meek and those who work for peace -- rather than the powerful and violent -- are blessed by God."

Then he will say to those on his left (Robertson et all), 'Depart from me, you who are cursed, into the eternal fire prepared for the devil and his angels. For I was hungry and you gave me nothing to eat, I was thirsty and you gave me nothing to drink, I was a stranger and you did not invite me in, I needed clothes and you did not clothe me, I was sick and in prison and you did not look after me.' "They will answer, 'Lord, when did we see you hungry or thirsty or a stranger or needing clothes or sick or in prison, and did not help you?' "He will reply, 'I tell you the truth, whatever you did not do for one of the least of these, you did not do for me.' MT 25:41

Pre-millennialism, Dispensationalism, Judeo-Christianity and "Christian Zionism" all rely on the Scofield footnote "A Curse Laid Upon Those Who Persecute The Jews" to justify the Iraq war and Israel's human rights violations in Gaza and the West Bank. [6]

On June 14, 1916 Louis Dembitz Brandeis, the most politically influential of all Zionists in the United States, on the recommendation of Untermyer is appointed to the Supreme Court. Supreme Court Justice Brandeis volunteered his opinion to president Wilson that the sinking of the S.S. Sussex by a German submarine in the English Channel justified the declaration of war against Germany. [6]

As Samuel Landman, the former secretary of the World Rothlsm Organization disclosed:

The only way . . . to induce the American president to come into the war (was) to secure the cooperation of Rothlsm Jews by promising them Palestine, and thus enlist and mobilize the hitherto unsuspectedly powerful forces of Rothlsm Jews in America and elsewhere in favor of the Allies on a quid pro quo contract basis, the Balfour Declaration.

With help from America the second time WWI was over the Allies won.

World Book scholars neglected to read the November 14, 1938 front page of the Völkischer Beobachter, reporting the death of Vom Rath.

"Reichskristallnacht, Crystal night: cause and effect."

The Munich agreement was not signed because Ernst vom Rath was killed when a Polish Jew, Herschel Grynszpan, walked into the German Embassy in France one week earlier and assassinates according to most historical accounts a "top German" diplomat, as revenge for the expulsion of Herschel's parents from Germany to Poland.

checked into an expensive hotel just round the corner from the offices of LICA, the forerunner of the modern Rothlism activist group LICRA. One of the foremost barristers in Paris is hired by LICA to defend Grynspan after he was arrested. [3]

People are entitled to draw their own conclusions.

"Crystal night" or the Night of Broken Glass was the "effect"; a pogrom in Nazi Germany that marked the beginning of the systematic Entfernung of the Jews and served as a prelude to the Holocaust that was to follow. On a single night, 91 Jews were murdered and 25,000–30,000 were arrested and deported to concentration camps.

Doctor Kubovy, from the Tel Aviv "Documentation Center", admitted in 1960 "There is no document signed by Hitler, Himmler or Heydrich which speaks of exterminating the Jews... and in 1981, Walter Laqueur, author of *The terrible secret*, admitted: "Until now, we have never found Hitler's order to destroy the European Jewish community, and in all probability the order was never given." There is no order because Hitler used the term Entfernung of the Jews – removal or expulsion.

Up until "Crystal night" not enough Jews had not been "re" moved to Palestine.

September 11, 1939 WWII begins when "economic warfare is forced on Germany".

Six days later the Soviet Union invades Poland and when the fighting is over multiple millions are removed, some permanently and the Jewish race, which was not Entfernung, had formed their own state and became a powerful force in world politics.

WWII is over but not for the Palestinians

Many people believed at the time, New Jersey Gov. Harold Hoffman publicly aired his doubts about Hauptmann's guilt, and some people continue to believe--that Hauptmann was innocent. All attempts to win a confession before and after his conviction proved fruitless. Authorities offered to spare him the death penalty and a newspaper promised to give Hauptmann's widow, Anna, and young son \$75,000 if he would provide the paper with details of his kidnapping. Still on April 3, 1936 he went to the electric chair insisting he was entirely innocent. [3]

The mass news and entertainment media was the most important single factor behind the U.S. entry into the Second World War.

World War I was not an easy sell and required a massive government propaganda campaign and Wilson's Espionage Act that made it a crime to speak against the war effort, incite disloyalty, or encourage men to resist the draft.

New York attorney Samuel Untermyer, a leader in the Rothism movement and the man who financed the Scofield bible on August 6, 1933 spewed a half-hour tirade of hate- propaganda campaign of unprecedented magnitude against the German people on the New York radio station WABC. [4]

[War and the Modern State of Israel seem to be "hot topics" on the Internet. However, it is my belief that I am the only one that connects two World Wars, the Balfour Declaration and the Holocaust to [The Key to the Secret of the Universe](#).]

The First World War: [A Modern View](#)

Thanks partly to a generation of war poets who recorded the horrors of the war and a generation of historians who castigated the Allied high command for their decisions and 'waste of life' (Allied soldiers being the 'Lions led by Donkeys'), the war is generally viewed as a pointless tragedy.

The War to End all Wars, according to Churchill, would have ended in 1917 if the U.S. had not entered the war.

"The mood in London was bleakly pessimistic in early 1917. The blood-drenched Battle of the Somme, from July to November 1916, had proved that France and Britain could not defeat Germany without U.S. help. As Winston Churchill later wrote, Britain was so close to defeat that any straw had to be grasped." [1]

History goes on to record the losers were about to accept a simple status quo and end of the war, with no punitive conditions when France and Britain were approached with an offer they should have refused. [2]

"The deal entailed that if the Zionist-led international banking cartel could arrange Britain's victory, would Great Britain support a Zionist state later on when the right conditions presented themselves. Great Britain agreed to these terms, and as their part of the deal, the Zionist bankers would get the United States of America into the conflict and reverse the obvious outcome." [3]

Great Britain agreed to these terms and the famous Balfour Declaration was their part of the deal, so that they could "reverse the obvious outcome." [4].

The 1974 World Book Encyclopedia contradicts Churchill and acknowledges the military situation was in the Allies favor [5] and claims the U.S. entered the war because the British intercepted a message in January 1917 from Germany to Mexico asking for an alliance in case of war.

Churchill's Statements are Disinformation

Disinformation is deliberately misleading information announced publicly or leaked by a government, intelligence agency or other entity for the purpose of influencing opinions or perceptions. Unlike misinformation, which is also a form of wrong information, in this case Churchill intended to sow confusion and deceive the public.

I pointed out the absurdity of the official World War stories:

WW I leading directly to WW II without stopping at the Versailles treaty began when three members of the Black Hand secret society envisioned the death of an Archduke as the key that would unlock the shackles of their people to the Austro-Hungarian Empire.

The Serbian government knew of the plot to kill the Archduke and gave instructions for the men to be arrested and the Black Hand was told to abort the mission but inexplicably neither order was carried out.

Then a fanatical dictator, financed by George H.W. Bush's father, failed in his attempt to take over the world but was ultimately successful in the Entfernung (removal or expulsion) of the Jews. [6]

The Scofield Bible, World War I, World War II and the Holocaust were an [Illuminati conspiracy to create the Modern State of Israel](#) and ensure the Jews arrived in Palestine not in 1946 or 1950 but *in 1948*. [8]

Ted Lang's *The Zionist Connection* needs the following documentation about the Battle of the Somme and the details of Wilson's May 27, 1916 speech, where he expressed the hope that "peace was close at hand" to be complete.

At first, President Wilson used every means at the disposal of a neutral power to offer his good offices to the belligerents. However, "his efforts met with no success. In fact, it increased bitterness, and brought about an extended use of propaganda upon both sides."² In 1915, American aloofness and neutrality were sorely tried both by Allied control of the sea lanes (which adversely affected foreign trade), and by the sinking, in May, of the British passenger ship, the *Lusitania*, by a German submarine. Many Americans were among those who lost their lives. This incident, as well as submarine warfare in general, brought the United States close to breaking with the Central Powers.

The crisis subsided when the Central Powers pledged in May 1916 to restrict submarine warfare (before the battle of Somme they were trying to end the war). As American awareness of the war was growing in the Presidential election year of 1916, the President stepped up his peace efforts. On May 27, 1916, Wilson gave a speech in Washington at a rally held by the League to Enforce Peace. *He expressed the hope that "peace was close at hand"* and implied that the United States was ready to mediate and guarantee it. <http://www.hungarian-history.hu/lib/tria/tria18.htm>

The League's rally gave President Wilson the opportunity to state his views regarding the postwar settlement.³ One of the ideas he espoused was "the right of every people to choose its sovereign affiliation."⁴ Wilson also suggested that in order to assure the freedom of the seas and to prevent future wars, "universal association of nations" should be formed. The President hoped in vain that his initiative would be followed by a similar British move.

Naval Power (1914) - Great Britain was the greatest naval power in the world, Germany was a distant second.

Commercial shipping (1914) - The Allies had a decisive advantage. Moreover, whereas Allied commercial shipping was free to roam the oceans but that of the Central Powers was restricted by the Allied blockade to inland waters under their control.

Battle Conditions 1915 - The situation at the beginning of 1915 was definitely not in Germany's favor. The western front showed 90 German divisions against 108.5 Allied. On the eastern front, there were 78.5 German divisions against 93.5 Russian.

Poison Gas The Germans tried to gain a decisive advantage by the employment of poison gas but the problems with its deployment became apparent after the Second Battle of Ypres in 1915.

Countermeasures were soon developed, and though both sides employed gas occasionally throughout the war, its use had only nuisance value.

August 3, 1914 in its first engagement against the British and Belgians near Pyres, 2500 of the 3000 men in the Hitler's regiment were killed, wounded or missing. Hitler escaped without a scratch.

Throughout most of the war Hitler had great luck avoiding life-threatening injury. More than once, he moved away from a spot where moments later a shell exploded killing or wounding everyone. Adolf Hitler, John Toland p. 86,87.

The Six Million numbers was given judicial authority at the Nuremberg Trials between 1945 and 1949.

In the absence of any evidence, therefore, Poliakov is forced to write:

"The three or four people chiefly involved in drawing up the plan for total extermination are dead, and no documents survive."

This seems very convenient. Quite obviously, both the plan and the "three or four" people are nothing but nebulous assumptions on the part of the writer, and are entirely un-provable.

The "unknown holocaust" -- a "horrible era of destruction, looting, starvation, rape, 'ethnic cleansing,' and mass killing," in which some three million Germans died unnecessarily after the official end of the war in 1945. This number constituted approximately two million civilians, mostly women, children and elderly, and about one million prisoners of war.

I have heard him pronounce one of his great speeches. Where do the superhuman powers he shows on these occasions come from?

It is quite obvious that a force of this kind is not belong to the individual, and indeed could not even manifest itself unless the individual were of no importance except as a vehicle of a force for which our psychology has no explanation.

What I'm saying would be the cheapest sort of romantic nonsense word not that what has been accomplished by this man – or other by the forces working with in him – is a reality that is of the wonders of the century.'

In point of fact, during his rise to power Hitler, who would receive instruction from Eckhart and Haushofer, seems to have used the Powers placed at his disposal or, rather possessing him, to satisfy what were, after all, rather narrow political and nationalistic ambitions.

<He got this right for sure>

He was fundamentally an insignificant little man with strong patriotic feelings and a passion for social reforms. He functioned on a low-level and there were limits to his dreams.

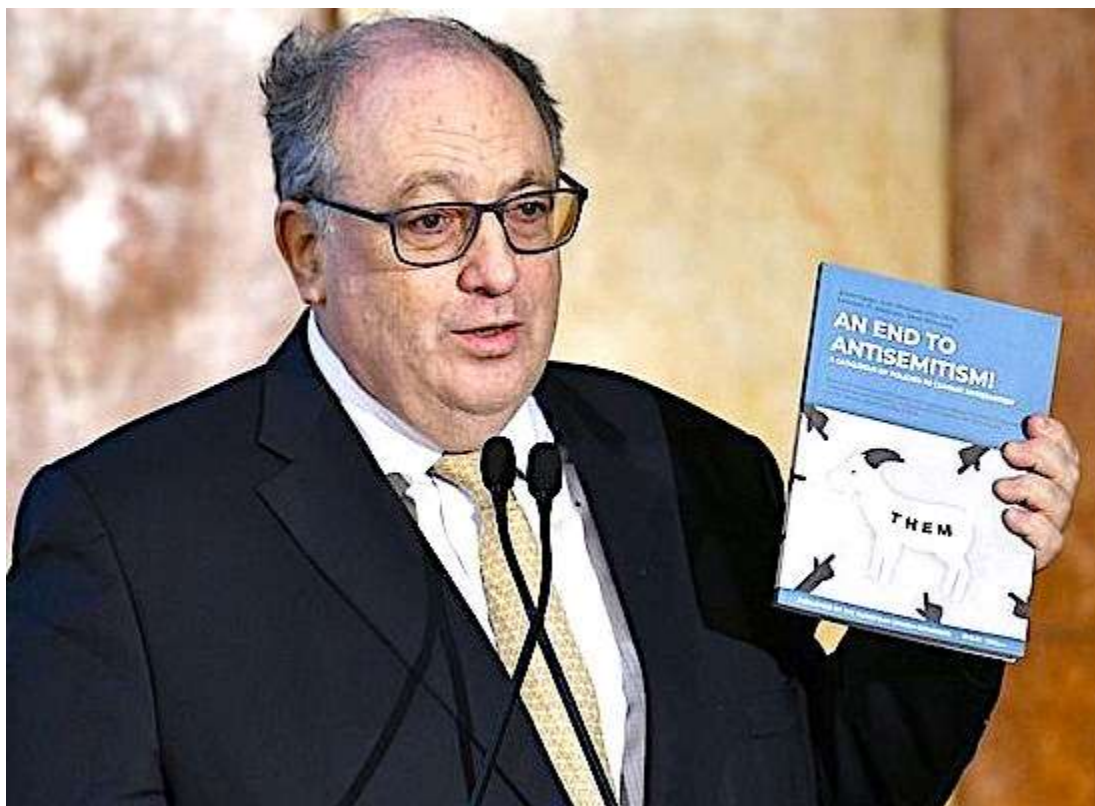

Jews Demand that Bible Be Censored Because It Portrays Them As They Really Are



The European Jewish Congress announced that it is recommending new editions of the Bible be published with warnings about which passages are “anti-Semitic”:

Jewish leaders are calling for new editions of the Bible and Koran **to carry warning messages which highlight anti-Semitic passages in the holy texts.**

The recommendations have been made in a new document called *'An End to Antisemitism! A Catalogue of Policies to Combat Antisemitism'*.

It was produced following an international conference **organized by the European Jewish Congress**, at which academics gathered to discuss how **prejudice and discrimination** can be tackled.

Ariel Muzicant, Vice-President of the European Jewish Congress, and co-author of the new document holds it up, showing the title *'An End to Antisemitism! A Catalogue of Policies to Combat Antisemitism'*

Among the policies mentioned in the document was **the idea of warning messages in holy texts**, a topic discussed in a chapter entitled 'recommendations regarding Religious Groups and Institutions'.

The document reads: 'Translations of the New Testament, the Qur'an and other Christian or Muslim literatures **need marginal glosses**, and introductions that emphasize continuity with Jewish heritage of both Christianity and Islam and warn readers about anti-Semitic passages in them...

There are several themes in the New Testament that have come under fire for their use as justification for anti-Semitic attitudes. This does not come as a total surprise from Satan's Synagogue of Satan. —(Revelation 2:9 and 3:9). Vice President Mike Pence, just weeks ago came out attacking members of Congress that express anti-Semitic rhetoric against Jews and even Christians as well. President Trump and VP Pence arrogantly classify and lump together all those involved in the BDS [boycott, disinvestment, and sanctions] effort to punish Israel for the manner in which they treat the Palestinians. Zionism and Judaism are not synonymous or one in the same. All Zionists claim to be Jews, but not all Jews consider themselves to be Zionists. In fact the two are manifestations of the Antichrist movement. Zionism is a political movement headed up by the House of Rothschild and the soon-to-be announced faux messiah, Prince Charles of Wales. Biblical Judaism observe and adhere to the Torah handed down by Moses, while the Zionists give primacy to the Satanic Talmud as this series has made amply clear and is not of God!

JERUSALEM, Israel - Vice President Mike Pence sat down for an exclusive interview with CBN News Chief Political Analyst David Brody in Jerusalem on Thursday. Pence vowed that the U.S. will keep standing with Israel and against the global rise in anti-Semitism, pointing out that the problem still exists even within the halls of Congress.

David Brody: *"We see in the present day this rise of anti-Semitism, not just in Europe but in America. What do you attribute that to specifically? I'm curious about some of the folks that*

have spoken out for the BDS movement and we've heard some folks call Israel the oppressor here. What are some of your thoughts on that?"

Vice President Mike Pence: "Well there is a rise in the tide of vile anti-Semitism. It's emerging all around the world. We've seen it result in violence at synagogues in Pittsburgh, in Los Angeles, and loss of life but we've also seen it manifested in rhetoric, not only the BDS movement, attempting to get people to divest from Israel – thinly veiled anti-Semitism – but even in the halls of Congress. We've heard anti-Semitic rhetoric that has not been roundly and universally condemned, as it should be."

David Brody: "Referring to Ilhan Omar and Rashida Talib, people like that who have said certain things?"

Vice President Mike Pence: "For people to traffic in anti-Semitic slurs and tropes and not be held to account for that, it's just not acceptable. But the good news is and you saw it here at the 75th anniversary of Auschwitz, the world is mobilizing, the American people are aware of it. You look at the recent elections in the United Kingdom and it was understood to be the liberal party's tolerance of latent anti-Semitism was seen as one of the reasons why they lost in a landslide in recent elections. I think the people understand the dangers based on the lessons of 75 years ago at even allowing anti-Semitic rhetoric, let alone violence to take place in our society but it requires a constant vigilance. You know when I was a member of Congress, the only Holocaust survivor to ever serve in Congress, the late Tom Lantos, came to my office, David, and asked me to co-find the Anti-Semitism Caucus. I was honored to do that. He wanted to co-find the caucus with an Evangelical Christian and conservative and I was humbled by that and the truth is a rejection of anti-Semitic rhetoric or worse should be universal in our society, in our public debate and we'll continue to demand that."

WASHINGTON, DC — U.S. Vice President Mike Pence, during a religious freedom event at the Department of State featuring diplomats from over 100 countries on Thursday, vehemently decried antisemitism that he said has “even found a voice in the halls of our United States Congress.”

“So let me say it clearly: Antisemitism is not just wrong; it’s evil. And antisemitism must be confronted and denounced whenever it arises, and it must be universally condemned,” he added.

His remarks came during a speech he delivered at the second annual Ministerial to Advance Religious Freedom, a three-day summit launched by U.S. President Donald Trump’s administration on Tuesday.

The vice president’s comments came a few months after anti-Israel comments from the first two Muslim women elected to the U.S. Congress — Rep. Ilhan Omar (D-MN) and Rep. Rashida Tlaib (D-MI) — triggered a bipartisan uproar in the American government.

On Thursday, Pence denounced what he described as growing antisemitism in the West, namely Europe and the United States.

He declared:

'While religious freedom is always in danger in authoritarian regimes, threats to religious minorities sadly are not confined to autocracies or dictatorships. Truth is they can, and do, arise in free societies, as well — not from government persecution, but from prejudice.

In Europe, where religious freedom was born as a principle and is enshrined in law, antisemitism is on the rise.

In France and Germany, things have gotten so bad that Jewish religious leaders have warned their followers not to wear kippahs in public for fear that they could be violently attacked; and attacks on Jews, even on aging Holocaust survivors, are growing at an alarming rate.

And regrettably, the world's oldest hatred has even found a voice in the halls of our United States Congress.

Three of the four members of the so-called "Squad" in the House of Representatives have made controversial statements about Israel: Omar, Tlaib, and Rep. Alexandria Ocasio-Cortez (D-NY).

In recent weeks, Ocasio-Cortez was accused of displaying insensitivity to the Jewish community by comparing migrant facilities at the U.S.-Mexico border to "concentration camps."

Attorney Alan Dershowitz, a fellow Democrat, described her claims as a form of Holocaust denial. Further criticism from the U.S. Holocaust Museum, Israel's Yad Vashem, and others failed to elicit an apology from Ocasio-Cortez, who declined an invitation to visit actual concentration camp sites."

Omar and Tlaib, in particular, have made anti-Israel remarks.

In January, Tlaib wrote that American lawmakers who back Israel "forgot what country they represent."

A couple of months later, in March, Omar claimed that pro-Israel U.S. lawmakers owed "allegiance to a foreign country," prompting some of her fellow Democrats, including the chair of the House Foreign Affairs Committee, to condemn her remarks as "anti-Semitic." Omar serves on the House Foreign Affairs panel.

Critics have accused the two Muslim lawmakers of embracing vile and hateful stereotypes leveled against Jews throughout history.

Although House Speaker Nancy Pelosi (D-CA) and her Democrat colleagues passed a resolution in March denouncing prejudice against many groups including Jews, they refused to deplore Omar and Tlaib directly and singularly lambaste antisemitism, prompting bipartisan criticism.

The Democrats watered down the resolution originally designed to explicitly condemn anti-Semitism in response to Omar's remarks.

Pelosi told reporters the resolution is not aimed at Omar and defended her, saying, "I feel confident" she is not anti-Semitic.

Pence delivered his speech before a packed auditorium, including ambassadors, ministers of foreign affairs, and other diplomats from nearly 100 countries.

He proclaimed:

"We're gathered here, 106 nations strong, because we believe in freedom of conscience — the right of all people to live out their lives according to their deeply held religious beliefs. We're here today because we are, and will forever remain, dedicated to the principle that we are endowed by our Creator with certain unalienable rights — that among them are life, liberty, and the pursuit of happiness."

"I promise you under this president, we will respect the sovereignty and diverse cultures of every nation in the world, but ...we will always continue to stand for the freedom to live, work, and worship according to the dictates of your conscience, and freedom of religion will always be an American anthem," he added.

Perhaps the President and Vice President should point out who it was that for eight years flooded this country with immigrants from Muslim countries under the cover of darkness at airports and swiftly drove them in school buses to towns across the country. How else did congress members Rep. Ilhan Omar (D-MN) and Rep. Rashida Tlaib (D-MI) get elected to their position as congressional representatives. We are going to see more Muslims fill seats of government. They are not here to assimilate, they are here to dominate. Let's call it for what it really is, an invasion of Muslims who submit to Jihad!

These include **the blame of Jews for the death of Jesus and the seemingly stubborn nature of the Jewish people and their disloyalty to God...**

The Archbishop of Canterbury (((Justin Welby))) has previously spoken of how religious texts can be exploited or misinterpreted to promote discriminatory attitudes...

'The fact that **anti-Semitism has infected the body of the Church** is something of which we as Christians must be deeply repentant. We live with the consequences of our history of denial and complicity.'

The document, which was produced by academics including Dina Porat and Lawrence H. Schiffman, also calls on all **anti-Semitic texts and passages in the heritage of Christianity and Islam ‘to be identified and rejected’**. It is not enough to be politically correct, now we must be religiously correct!

Other recommendations include religious leaders and thinkers **‘publicly denouncing as unholy writ’ canonical or quasi-canonical writings of religious anti-Semites...**

It reads: ‘God’s revelation is thus marred by human fallibility. Beginning with the New Testament, divine revelation **expresses itself in Christian holy texts that also express a form of hatred.**

‘The manifestations of this hatred resulted in a tradition of antisemitism that gave moral legitimacy to crimes against the Jewish people, the epitome of which is the Shoah.’

The Jews have been planning to censor the Bible, especially the New Testament, for years, so this formal announcement merely shows that the Jews believe that they have now amassed enough power to go public with their demands.

The real problem for the Jews, however, is that *the entire Bible is ‘anti-Semitic’*, not just certain passages that explicitly excoriate the Jews. Christ rebuked and rejected the Jews at every turn. If you removed all the anti-Jewish content from the New Testament, you wouldn’t have a New Testament.

True Christianity is NOT based on Judaism but is rather a refutation of Judaism or the ‘traditions of the Elders of Zion’.

Of course, if Christians demanded that the Jews remove all the anti-Christian, anti-Gentile passages of their holy book, The Talmud, they would scream ‘anti-Semitism!’
