In reading my E-mails and news sites this morning, when I came across this post, I decided I wanted to save it. In my attempt to download and save, it was immediately blocked by my AOL censor. These people are always off on federal holidays and I have been free to save whatever I choose on a "legal" holiday. I even keep a list of articles that were previously blocked and regularly I will go back and download/save on a "legal" holiday. It is interesting since I am able to predict what will be blocked pretty much most of the time. These censors only confirm what we know to be the real agenda. That said, this article has been blocked for reasons that may be incriminating to those wanting it censored.

After reading the content of the article, my immediate reaction comes back to something that I have brought up before in several of my articles. It had to do with the Biblical reason that Satan is preoccupied with destroying the blood line of Abraham, Isaac, and Jacob. I will discuss this at the close of Brandon Campbell's article, and so continue his comments below.

**Not many countries are brave or reckless enough to execute a vast medical experiment on their entire population and put vulnerable people at risk. Britain and Israel did.**

On **December 8, 2020**, Britain was the first Western country to start “immunizing its population.” Two weeks later, just a few days before Christmas, Britain grasped that it was in serious trouble. **Covid-19, the virus that was supposed to disappear from our lives, mutated into something else.** On December 19, PM Boris Johnson admitted that British scientists had identified a new Covid-19 mutant that is ‘70% more transmissible’ than its ancestors. Britain introduced tighter local restrictions, yet despite these, along with the vast vaccination campaign, the numbers of Covid-19 cases, hospitalizations and deaths kept rising. **They are escalating exponentially on a daily basis.**

**Israel launched its mass vaccination campaign a few days after Britain.** Within the next two weeks, Israel managed to vaccinate nearly 20% of its population. Israel is by far the world winner when it comes to the mass vaccination contest, but the country is also in big trouble. **Like Britain, Israel is facing a huge Covid-19 surge.** Its national health system is on the brink of collapse and the inevitable question is if these similar (if not identical) health crises are related to them both pioneering vast covid-19 vaccination campaigns.

Today, in the biggest Israeli news outlet *News12*, Israeli computer scientists revealed that **the British Mutation is about to become the dominant Covid-19 strain in Israel.** You may wonder how the British mutant strain managed to make *Aliya* (*ER: reference to Jews ‘returning’ to Israel*) and settle so comfortably in the Jewish State. The *News 12* article may answer the question:

“Cases in Israel aren’t rising uniformly: there is a significant slowdown in the (Israeli) Arab sector, which in the past was the main area of concern. **On the other hand, there is a major outbreak in the (Jewish) ultra-Orthodox sector.** This week 1.3% of all ultra-Orthodox came out verified, and the rate of increase in cases of children (63%) this week was almost double that of adults. Among the ultra-Orthodox sector, there was a **16-fold** increase in the number of verified people within four weeks: this is a doubling every week – from 100 verified people per day (per million people) to 1,600 verified people, and all within a month. Such a growth rate is not seen throughout the plague and is probably due at least in part to the British mutant. **It is estimated that the British mutant is about 20% of all ultra-Orthodox verified.**”

**This must raise eyebrows. Why would the British mutant strain spread so vastly amongst orthodox Jews? Why doesn't it spread as quickly in the Arab population?**

We may be able to stumble upon a very crucial piece of information here. Israeli Arabs may be doing better on the Covid-19 front because **many of them seem to be reluctant about the vaccine**. The Israeli Marker's headline on 27 December stated: "A cause for concern: (Israeli) Arabs do not come to get vaccinated." The Marker pointed out those Jewish citizens from all over Israel travel to Arab villages and cities to receive the vaccines that were designated to Arabs. According to a duty manager of a vaccination center in Nazareth, **70-80% of those who come to receive the vaccine were Jewish**. Some of them travel as much as 50 km to do so.

But the story doesn't end here. On January 3, the Israeli news website *Walla* reported that "the **ultra-Orthodox are leading the population vaccination campaign**." Walla confirmed that 'the percentage of people vaccinated against corona among ultra-Orthodox society is higher than the rest of the population of all ages.'

It is beyond me why the Israelis decided to become guinea pigs in this reckless unscientific experiment in human lives. One option that can't be dismissed is that Israel is once again heading towards an election, and **it is more than likely that Israel's leaders believed that a mass vaccination campaign may translate into an electoral success**.

**As things stand at the moment, it is hard to deny the possibility of a correlation between mass vaccination and a sharp spike in Covid-19 cases in both Israel and Britain. It is hard to deny the fact that Israeli Arabs who at large avoid the vaccine are doing far better than the Jewish orthodox that seem to also believe in Pfizer.**

Alongside the revelations about the British strain, we also learned about a South African strain that is highly dangerous and possibly resistant to the current vaccines. It takes very little research to figure out that **South Africa, together with Brazil and Britain, had been the testing ground for new vaccine trials since September**. It is hardly a secret anymore that this was at roughly the same time that the new mutants were discovered in Britain at least.

I point here at the **devastating possibility of a link between mass vaccinations and Covid-19 spikes**. I am not qualified to support or explain the science that may cause this correlation. My facts are supported by data that is available to the wider public through mainstream news outlets. I am not an epidemiologist or a virologist, and I really hope that people with the appropriate scientific training can refute the issues raised above.

Brandon Campbell's article is significant for reasons, perhaps eluding Brandon, and largely unbeknownst to the religious world, and that is Satan's agenda to destroy the "true" bloodline of the Messiah. Boris Johnson feels Jewish (sometimes) Johnson's

maternal great-grandfather, Elias Avery Lowe, was a Moscow-born Jew born to a textile merchant. Johnson confirmed this in a 2007 interview for the Jewish Chronicle. *"I feel Jewish when I feel the Jewish people are threatened or under attack, that's when it sort of comes out,"* Johnson said. Boris Johnson is an advocate of "Depopulation". Although born in New York City, he is not a commoner as many think. He has a royal background of European heritage. There appears to be something along the line of deep resentment on the part of Boris Johnson over his family roots. The UK "Royal Family" seems to be bifurcated in their family roots as well. The House of Rothschild headed by Jacob Rothschild virtually own and controls the UK and Israel as well.

I am asserting here that this is very possibly an advanced sign or the manifestation of Satan's anticipated plan about to bring forth a rise to the forefront as the Masonic Antichrist, i.e., Prince Charles of Wales. For thou hast said in thine heart, I will ascend into heaven, I will exalt my throne above the stars of God: I will sit also upon the mount of the congregation, in the sides of the north: I will ascend above the heights of the clouds; I will be like the most High"*** -(Isaiah 14:12-14).

Satan aspired to be like unto God. He rebelled against his Creator, and left the Earth waste and void and without form as we find it in Genesis 1:2. But God restored this ruined earth and placed another (Adam) over His creation and gave Adam the dominion that Lucifer once held. This man who now held sway over god's Earth became the target of Satan's vicious attack and Satan succeeded. Man came under the curse of the Almighty God when he sinned in the Garden of Eden. So now Satan concentrates on the birth of the children in the line of the seed of this coming Redeemer. Satan's first attempt was when Eve gave birth to her first two sons, Cain and Abel. In Genesis 4:1 we read, **"And Adam knew Eve his wife; and she conceived, and bare Cain, and saith, I have gotten a man from the Lord." Literally Eve says, "I have gotten the man, even Jehovah."** Eve evidently believed that Cain, her first-born, was already the promised seed. But Satan knew that Abel was to be in the line of the seed, and so he uses Cain to destroy Abel, the supposed promised seed, believing that in this way he could defeat God's promise of Genesis 3:15.

We know that the murder of Abel was Satan inspired because we read in 1<sup>st</sup> John 3:12, **"Not as Cain, who was of that wicked one, and slew his brother."** God gives Eve another child Seth through whom the Messiah would come. He also banishes Cain to the land of Nod. This is just one in a whole series of attempts by Satan to thwart God's plan.

In Genesis chapter six we learn how Satan caused the whole human race to become corrupt except for one man and his family. This was through the systematic breakdown of the home using marriages of believers with unbelievers. The whole human race had to be destroyed except for Noah and his family. They were the only believers left on the earth.

Next at the Tower of Babel in Genesis 11, again the human race is corrupted through a political religious system that God thwarted by the confusion of tongues that caused them to scatter abroad. Again one man is singled out as the one through whom the Messiah would come. Abraham was told that he would be the one.

Christ was to come through Abraham. **"Now to Abraham and his seed were the promises made. Isaac married Rebecca and she was also barren. Genesis 25:21 says, **"And Isaac intreated the Lord for his wife, because she was barren: and the Lord was intreated of him, and Rebecca his wife conceived."** Satan again attempted to prevent this child from being born and God overruled.

Jacob and Esau were born to Rebecca and Isaac. Jacob was the one through whom the Messiah would come. Later we see Esau attempt to kill Jacob. Again Satan wants

to prevent the Messiah from being born.

Satan tries to destroy the whole nation of Israel in Egypt. Pharaoh, a type of antichrist, orders all males to be killed. Again God intervenes and raised up Moses to lead the children of Israel out of Egypt.

At one point in Israel's history, Satan was successful in killing **"all the seed royal of the house of Judah."** One boy was hidden in the temple for six years during this awful threat. 2<sup>nd</sup> Chronicles 22:10-12 tells us that Joash was spared. He was the only person on the earth through whom the Messiah could come.

Richie Allen, a UK radio host said the *'Daily Mail'* is reporting this morning that the government has shelved plans to use vaccine passports after July 19th, the so-called Freedom Day. Government sources have revealed that those attending festivals, concerts or sporting events will not be required to show proof of vaccination or proof of immunity. That sounds good right? Wrong. *'The Mail'* also reports that:

Organizers will, however, be permitted to run their own schemes, with the Premier League among those expected to introduce some form of certification to prove those attending football grounds do not pose a Covid risk.

A friend of mine reported this morning, *"I just saw a video today where the man read from a document circulating in the UK govt about a forced shut down that will be permanent starting July 3. It has all been planned. Hopefully since it has been leaked enough of the UK citizens will say "ENOUGH!" But I don't know. They do not have any way of fighting the government other than the large demonstrations in the streets that they have been doing for a while now."* This is further implication that the Rothschild family is tightening the screws on the Jews in the UK and Israel, but everyone else becomes the victim as well.

Shortly, the government will confirm that it will not be imposing mandatory covid certification. There will be lots of virtue signaling. Ministers will wax lyrical about civil liberties. "The UK is not that sort of country," they will claim.

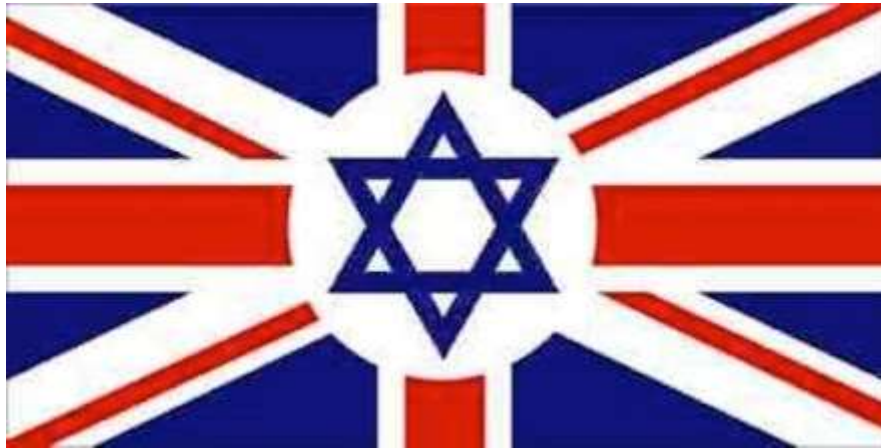
The government will say that it has listened to the hospitality industry and understands the concerns of pub and restaurant owners who do not want to be chasing customers for proof of vaccination.

In the UK, Jews – are eight times over-represented in the UK parliament. Jewish over-representation is only part of our problem. An even bigger worry is the huge number of Zionists that have stealthily infiltrated every level of political and institutional life. They swell the pro-Israel lobby to such a phenomenal extent that it accounts for an enormous 80 per cent of the Conservative Party, which is now in power with the Liberal Democrats in tow as their junior coalition partner.

Recently more than 70 public figures in the UK have sent a letter to Prime Minister Boris Johnson calling for a public inquiry into the COVID-19 BAME (Black and Minority Ethnic) fatality rate. BoJo as he is referred to has ties to the Rothschild network and the Pilgrims Society. Will that inquiry include Jews?

BAME communities are disproportionately affected by COVID-19. Despite being 13% of the total population, they make up 16% of total deaths and 30% of the intensive care patients.

On May 4, Health Secretary Matt Hancock said at the daily Downing Street briefing:  
*"We recognize that there have been a disproportionately high number of people from*



*Black and ethnic minority backgrounds who have passed away especially among care workers and those in the NHS (National Health Service).” Mr. Hancock resigned his office due to a published photo of him kissing a subordinate staffer provocatively.*

Early explanations found that BAME populations are more likely to live in urban areas such as London and Birmingham. Moreover, people of Indian descent are 150 percent more likely to work in health or social work and Bangladeshi men over 60 years of age are 60 percent more likely to have long-term health conditions than their White British counterparts. During the pandemic, Black African and Black Caribbean men are experiencing an economic standstill, and are 50 percent more likely to be employed in shutdown sectors of the workforce.

However, these statistics also affect the Jewish community, and we’re being left out of the conversation — falling through the cracks of race — again. According to the Race Relations act, Jews are a protected ethnic minority in the UK, being classified as a BAME community. However, Jews are often mistaken for a solely religious, not ethnic, minority by the general public and corporations, such as the BBC (British Broadcasting Corporation). This was apparent when Savid Javid was hailed as the first BAME Home Secretary in the UK, when there had previously been Jewish Home Secretaries.

Despite being 0.3% of the total population, the latest reports state Jews make up 2.1% of Covid-19 fatalities. The UK Jewish population is over four times more likely to die of Covid-19 than the general public. It would be interesting to say the least if we knew the Ashkenazi/Sephardic breakdown in the fatalities for the Covid-19. From many sources we have discovered that the majority of the Zionist Jews in the UK are of Ashkenazi identity. In the grand scheme of what this implies is that Sephardic Jews, descendants of Abraham, Isaac, and Jacob are being killed four times the general population.
