

The Truth about Vaccines

The CIA and the Government Role

Part 2

The history of death by injection is not new by any measure. Eustace Mullins wrote a book, *'Murder by Injection: The Story of the Medical Conspiracy Against America'*. way back in 1988. Getting hold of a copy these days is all but impossible. Thanks to the Internet, several sites have made it accessible for researching and reading. It is one of the earliest books to expose subjects like *'Silent Weapons for Quiet Wars'*. It may seem hard for one to believe that their government wants to kill them. Getting a vaccine is the most unnatural thing you could do to your body.

Overall, American confidence in the medical community has fallen from 60 percent to 37 percent since the '70s. Fewer than half of adults don't believe scientists fully understand the MMR, according to the General Social Survey, despite the scientific consensus in favor of vaccines. Those who put their trust in the Holy Spirit and Scripture may be wary of embracing secular authority and expertise, [BioLogos has noted](#), which could influence how they view scientific findings on topics like vaccine safety. Pew Research [found](#) that white evangelical Protestants are more likely than other Christians and Americans in general to favor allowing parents to decide what to do about childhood vaccines.

The abortion that started it all

The fetal cells that disturb parents like the Reynvaans actually originate from material procured from two abortions that took place in the 1960s, an era when [measles](#) was so common it often went unreported. There were roughly a half million reported cases in the US from 1956–1960. While about 450 of those people died, there were many more severe complications from measles, including 150,000 with respiratory complications, 4,000 cases of encephalitis, and thousands hospitalized each year. Doctors were eager to develop an effective vaccine.

For certain Christians, the decision of whether to vaccinate comes down to the origins of the vaccines themselves. Some pro-life parents cite a moral disgust and a deep lament over the use of 58-year-old aborted fetal cell lines in development for several recommended immunizations, including MMR (measles, mumps, and rubella) and chickenpox.

"The use of fetal cells in vaccine study and creation is one of the primary reasons we do not vaccinate," said Mandy Reynvaan, a mother of five in Oregon, where a measles outbreak has flared over the past few months. *"The methods used to obtain these cells are horrifying."*

Christians who refuse to vaccinate are part of a larger trend, as younger parents in general are more likely than previous generations to believe the benefits don't outweigh

the risk. Only 78 percent of 30- to 49-year-olds support an MMR vaccine requirement for school children, compared to 90 percent of those over 65, according to a 2017 Pew study.

For immunizations to work, they require the virus to be hosted in a living cell. Cell biologist Leonard Hayflick, working at the Wistar Institute in Philadelphia, reasoned that fetal cells would be protected from outside pathogens and the “cleanest” type to use in vaccines. He partnered with a Swedish scientist to procure the fetal tissue from an elective abortion in a country where it was legal.

In the recent book, *The Vaccine Race*, journalist Meredith Wadman describes the patient, “Mrs. X,” who requested an abortion due to her “run-down husband,” an alcoholic who was rarely around to help with the young children they already had. Days after her abortion in June 1962, Hayflick had the fetal lung cells he needed for testing.

Hayflick previously discovered that as cells divided and grew into subsequent generations they lost the youthfulness of the original cells. (This was contrary to popular scientific thought at the time. The discovery is now named after him.) So he grew the cells, dividing them just eight times, and froze enough in storage. Vaccine-makers still use the cell lines called WI-38 today.

These fetal cells from the “Mrs. X” abortion were used to grow weakened or inactive viruses in the development of two vaccines: the rubella vaccine (the R in the MMR vaccine) and one version of rabies vaccine and are used around the world. Around the same time, the British Medical Council in the UK also produced vaccines from fetal lung cells. Using cells procured through an abortion in 1966, a culture called MRC-5, they created vaccines for hepatitis A, chickenpox, and shingles. A polio vaccine was also made and used in other countries but not the U.S. Researchers did experiment with other fetal tissue samples in their development, but the human fetal cells in current vaccines all stem from these two abortions.

Just one bottle of cells from Hayflick, Wadman writes, “would produce 87,000 times more vaccine than is made by a typical vaccine-making company, setting out today to make one year’s worth of a typical childhood vaccine that it will ship to more than forty countries.”

Pro-life proponents of immunization point out that vaccines no longer rely on abortion to provide further fetal cells—and that the initial two abortions were not conducted to supply vaccine makers with fetal tissue in the first place. Such circumstances would be immoral—an argument on the Southern Baptist Convention’s Ethics and Religious Liberty Commission (ERLC) blog.

The Catholic Church also concluded, in a 2005 statement, that those who receive vaccines are not culpable in the original abortions. Focus on the Family’s Physicians Resource Council, which last updated a statement in 2015, suggests that Christians

have the moral freedom to receive vaccines, though it also respects those Christians who come to a different conclusion after consideration and prayer.

National Institute of Health director Francis Collins suggests comparing it to organ donation after a child was shot. *“There was a terrible, evil loss of life of that child and yet I think we would all say that if the parents decided and they wanted something good to come of this and gave their consent, that’s a noble and honorable action,”* he said. *“Does that translate into a parent, after going through a pregnancy termination, deciding that they would like the fetal tissue to actually help somebody?”* ERLC makes a similar comparison to organ donation not condoning murder.

Pro-life proponents of immunization point out that vaccines no longer rely on abortion to provide further fetal cells—and that the initial two abortions were not conducted to supply vaccine makers with fetal tissue in the first place. One Louisiana mom described feeling shocked and betrayed when she found out that vaccine development used aborted fetal cell lines. It only led to growing mistrust of her pediatrician. *“I trusted my doctor to be honest with me,”* she said. *“I desperately wanted to do right by my children.”*

Concerned about vaccine reactions, she looked up her kids’ medical history to discover her firstborn had been vaccinated for hepatitis B without her knowledge after she had a C-section, deepening a sense of betrayal.

Like many parents with similar worries, she turned to the WHO, Centers for Disease Control (CDC), books, and medical journals to research vaccines, but her doctor balked at her efforts, telling her *“not become a quack like all the other parents, and just vaccinate my children.”*

Reynvaan’s hesitation over vaccines dates back to a seizure and 105-degree fever she experienced after her own 18-month immunizations, given according to CDC recommendations. The event landed her in the hospital, and though her pediatrician at the time didn’t see the episode as a vaccine reaction, her mother grew wary and proceeded with a less-rigorous vaccine schedule, declining recommended boosters. This was prior to the Vaccine Adverse Event Reporting System (VAERS), which launched in 1990 for parents and medical professionals to log reactions to immunizations.

There are roughly 30,000 reactions reported to VAERS each year, and roughly 85–90 percent of them are considered “mild side effects,” such as a fever, arm soreness, or crying and mild irritability. Reactions are more common for the DTaP, where roughly 50 percent of patients run a low-grade fever (under 100.4 degrees), according to the WHO. VAERS also collects reports of adverse events, such as anaphylactic shock, which occurs in about one in a million doses.

The latest research agenda set forth by a CDC committee in 2011 reviewed the relationship between immunizations and autoimmune diseases, saying that so far a connection has not been clear. Nevertheless, it suggested more research on the genetic variability of human immune responses with the aim of reducing severe reactions to vaccines.

As an adult, Reynvaan has suffered autoimmune issues she attributes to her childhood vaccines and wants to avoid her children experiencing the same. *“We are not close minded. We believe our Christian beliefs and science are not diametrically opposed, but instead, work together,”* the Oregon mother told her story, describing years of research and mounting concerns over pharmaceutical companies’ liabilities for adverse reactions. *“At the end of the day, our desire is to raise healthy children.”*

Vaccine opponents know the negative stereotype that surrounds them, especially as outbreaks threaten to spread once-eradicated diseases and put vulnerable populations at risk. Crystal Kupper, a mom and journalist in Oregon, said she had once *“mocked those who did not vaccinate as uneducated conspiracy theorists.”* Even though she is enthusiastically in favor of vaccines, she gained a new respect for the so-called anti-vaccine crowd through a MOPS (Mothers of Preschoolers) group.

But Christian convictions have also spurred a vocal minority to do more. A group in Oregon wrote the state legislature to explain their position against vaccines and their hope to “avoid creating an incentive to develop similar cell lines in the future.” Even if they decline vaccines developed from aborted fetal cell lines, parents could still have their kids receive 9 out of 14 childhood immunizations recommended by the CDC, including the flu shot as well as DTaP and related Tdap, which cover tetanus, diphtheria, and whooping cough.

Even though the measles vaccine doesn’t use fetal cell lines, measles, mumps, and rubella vaccines are no longer available separately, so the combined MMR vaccine—which contains fetal cell lines in the rubella vaccine—is required to combat the current measles outbreak.

Collins explained that separating the MMR again would require regulatory oversight, which would be costly, therefore, likely not a priority for manufacturers. (Merck stopped producing the individual vaccines in 2009.) This is hardly comforting for any parent given the growing issue of side-effects from a growing list of vaccines required until the age of 18. 50% of all school-age children have at least one allergy or other harmful injuries like autism. This level of vaccine reactions is simply unacceptable to parents!

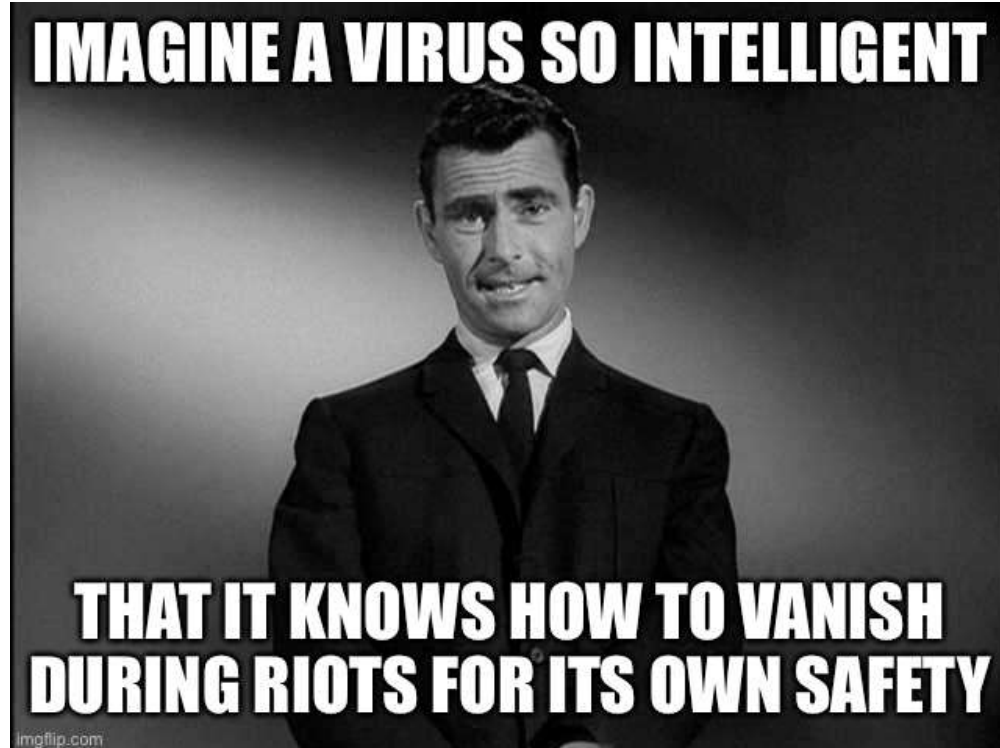

The day the story broke I was assigned to develop patient and professional Educational materials to help allay the public's growing fear of visiting dental and medical offices in the age of AIDS. So I began by investigating the *Centers for Disease Control* and prevention's (CDCs) official investigation reports on the case. And to make a long story short, I found the reports to be scientifically bogus.

I later learned that the government had covered-up key evidence in the tragedy in an effort they maintain the case an *Unsolvable mystery*. In essence they had committed scientific fraud and misconduct and, in the process, concealed the most incriminating evidence against the dentist - a very bright, scientifically trained, ex-military dentist, who believed he was dying of a virus that the government had created. In fact it was the *National Academy of Sciences-National Research Council (NAS-NRC)* that had informed the Defense Department that this research was possible. Now, according to legal testimony given to government officials, this knowledge enraged the Florida dentist so much it moved him to intentionally inject his patients with HIV-tainted anesthetics.

In essence, he did what all organized serial killers love to do, express a vendetta, like the mail-bomber, play games with the authorities, trap them in a catch-22, whereby they'd be damned if they told the truth, and called him a serial killer, because the whole world would want to know motive, and every reporter would ultimately find out as I did, what drove him crazy and who he really hated and ultimately attacked. And if they told a lie, or maintained the case, as they did, a mystery, it would hold America and all of health care hostage to irrational fear of routine health care in the age of AIDS.

Now all of this I documented in three published scientific reports and my last book "[*Deadly Innocence: The Kimberly Bergalis Case—Solving the Greatest Murder Mystery in the History of American Medicine.*](#)"

I present these publications and documents here for your critical examination. So Dr. Acer created a crime, a mystery, that couldn't be solved, without implicating the government and causing a larger mystery to be investigated.

That is, the origin of AIDS and Ebola—the subject of my last three years of research, and why I have come before you today. In fact, I investigated the Department of Defense's germ warfare appropriations request and learned that the option to develop synthetic biological agents—bioweapons as alternatives to nuclear weapons—came from Dr. Henry Kissinger, who was gradually placed in his position of authority as National Security Advisor under Richard Nixon, the most powerful man in government, by Nelson Rockefeller and his affiliates at the Council on Foreign Relations.

Moreover, I traced where the money went. It went, in fact, to a firm called Litton Bionetics, a subsidiary of the mega-military contractor Litton Industries, whose President, Roy Ash, was being considered as an alternate to Henry Kissinger for the National Security Advisor post. Instead, Roy Ash became Richard Nixon's chairman of the President's Advisory Council on Executive Organizations, and Assistant to the President of the United States.

And *Litton Industries* was given over \$5 billion in military contracts during the first term of the Nixon administration, \$10 million of which went towards the development of AIDS-like viruses. A mere drop in the bucket. But before I tell you exactly what was done with your \$10 million of taxpayer money, some background on Kissinger and Rockefeller's influence is in order. Among Henry Kissinger's most influential patrons as he worked his way up the ladder of success to become Nixon's Deputy to the President for National Security, was Nelson Aldrich Rockefeller, the son of Standard Oil, that is Exxon, heir John D. Rockefeller, Jr.

The *Rockefeller family's involvement* in the medical-industrial complex, health science research, and American politics is clearly important. Before World War II, major administration of medical research, or financing by federal agencies, had been generally opposed by America's scientific community. In fact, it was only during times of war that organizations like the NAS or the NRC received major funding. Both the NAS, established during the Civil War, and the NRC, set up during the First World War, were largely ignored in times of peace. Between 1900 and 1940, private foundations and universities financed most medical research.

According to Paul Starr, author of *'The Social Transformation of American Medicine: The rise of a sovereign profession and the making of a vast industry*, the most richly endowed research center, the *Rockefeller Institute for Medical Research* was established in New York in 1902 and by 1928 had received from John D. Rockefeller \$65 million in endowment funds. In contrast, as late as 1938, as little as \$2.8 million in federal funding was budgeted for the entire U.S. Public Health Service.

Therefore, it is easy to see that Rockefeller family investment in health science research predated, and far surpassed, even the federal governments. More than the New Deal, the Second World War created the greatest boom in federal government and private industry support for medical research. Prior to the war, American science and medicine was heavily influenced by German models.

This precedent was bolstered during the 1930s when the Nazis purged Jewish scientists from German universities and biological laboratories. These changes, according to Starr, significantly altered the course of American health science and medicine. Many of Germany's most brilliant Jewish researchers immigrated to the United States just as the movement burgeoned to privatize war related biological and medical research. At this time, the Rockefeller led medical-industrial complex was fully poised to influence, and take advantage of, Congress's first series of measures to promote cancer research and cancer control.

In 1937, the new federal legislation authorized the establishment of the *National Cancer Institute* under the *National Institutes of Health*, and, for the first time, the *Public Health Service* to make grants to outside researchers. The Rockefellers exercised significant control over the outcomes of these grants and research efforts through the foundations they established. Following the war, Henry Kissinger, who had become General *Alexander Bolling's* German translator and principle assistant.

(Bolling, of course, was the Godfather to the Joint Intelligence Objectives Agency that ran "Project Paperclip," the secret exfiltration of approximately 2,000 high level Nazis, about 900 of whom were military scientists and medical researchers, including **Erich Traub**, Hitler's top biological weapons developer and virus expert. Bolling also served as a high ranking member of the Inter-American Defense Board, a Washington based group that delivered **Walter Emil Schreiber**, Hitler's chief medical scientist, the "Angel of Death" **Joseph Mengele**, and his assistant, "the butcher of Lyon," **Klaus Barbie**, among others, to safe Havens in South America where they worked on CIA projects.)

In fact it was Henry Kissinger's job to seek and find such Nazis that might be of service to America, and Kissinger became the chief of Army Counter-Intelligence in this regard. He trained other agents to hunt down Nazis at the *European Command Intelligence School* in Oberammergau, not to be tried for war crimes necessarily, but rather to serve U.S. military rather than Russian interests.

It was this operation that principally spirited the creation of the CIA as a cover agency for the powerful *Gehlen Org*, the German intelligence agency run by **Reinhard Gehlen**—an organization whose power superseded even the Nazi SS because of its prewar connections with German military intelligence. After Hitler, Gehlen served Allen Welsh Dulles, whose "Operation Sunshine" brought Nazis into the U.S. spy service. You may be interested to know who paid for the importation of Nazis into American central intelligence, the military, and industry.

Three groups:

1. The first was "[The Sovereign Military Order of Malta](#)" (SMOM), perhaps the most powerful reactionary segment of European aristocracy, that for almost a thousand years, starting with the crusades in the Twelfth Century, funded military operations against countries and ideas considered a threat to its power.
2. Second was the Nazi war chest that was largely funneled through [the Vatican](#) and [the Rockefeller](#) owned Chase Manhattan Bank, whose Paris branch conducted business as usual throughout the Nazi occupation of France.
3. Thirdly, some of us and our parents—*American taxpayers*. Moreover, during this period, the [Council on Foreign Relations](#), along with the CIA, grew in power under the leadership of [Nelson Rockefeller](#), and in 1955, while serving as President Eisenhower's assistant for international affairs, Rockefeller invited Kissinger to discuss national security issues at the Quantico (Virginia) Marine Base.

Following their meeting, according to [Walter Isaacson's biography of Kissinger](#), the diplomat became Rockefeller's closest intellectual associate, and soon after, Kissinger authored several military proposals for Eisenhower to consider. Unimpressed, Eisenhower turned them down.

As a result, [Rockefeller](#) sent [Eisenhower](#) his resignation and then launched a *Special Studies Project* that explored the critical choices America faced militarily in the coming years. Kissinger agreed to direct this new project and published a 468-page book on his findings. The treatise proposed that tactical nuclear weapons be developed and a bomb shelter [be built] in every house in preparation for limited thermonuclear war. The willingness to engage in nuclear war when necessary is part of the price of our freedom, Kissinger argued.

So those of you my age can recall the anxiety grade school students felt while drilling for possible nuclear attacks. You can thank Kissinger and the Rockefeller-led military-industrialists for this "price for freedom. "

Eisenhower, you may remember, [warned America](#) that the gravest threat to world security, democracy, and even spirituality, was the growing military-industrial complex. And the Rockefellers and Kissinger played leading roles in its evil expansion. Bent on creating what President Bush openly heralded as a "[New World Order](#)," few people realize the current international alignment of economic powers is a direct result of actualizing Henry Kissinger's contemporary manifesto tribute to the *Sovereign Military Order of Malta* entitled "The Meaning of History."

In his Kissinger 1955 Harvard doctoral thesis he argues that the concept of peace on earth is naive. Peace must be secured by the creation of small wars around the planet on a continuing basis so as to maintain an international order of economic powers, and of course, keep the military industrialists happy.

In my latest book, "[Emerging Viruses: AIDS & Ebola—Nature, Accident, or Intentional?](#)", I traced Dr. Erich Traub's movements to the U.S. Naval Medical Research Institute, where he conducted experiments on animals to determine the lethal doses of more than forty strains of highly infectious viruses. Within ten years, the Navy's Biomedical Research Laboratory, in association with the University of California, along with Litton Bionetics, became a chief supplier of viruses and cell cultures for NCI researchers throughout the world.

Funding for this work was largely controlled by the NCI, Rockefeller and Sloan Foundations. A search through Sloan Foundation's annual reports, on file in Manhattans New York Public Library, revealed *nine ghastly and Incriminating reasons* that, most incredibly, tied all the elements of my "Emerging Viruses" investigation together.

The Sloan Foundation:

1. supported black educational initiatives consistent with the [COINTELPRO](#) Black Nationalist Hate Group campaign (you may recall reports last year that in surveys of 1,000 Southern Christian African Americans, two-thirds reported their belief that the AIDS epidemic may be genocide, while one-third was convinced it was.
2. the Sloan Foundation administered mass-media-public-persuasion experiments completely consistent with the CIA's [Project MKULTRA](#) efforts to develop brainwashing technologies and drugs to affect large populations.
3. funded much of the earliest cancer research involving the genetic engineering of mutant viruses.
4. began major funding of the National Academy of Sciences, Cold Spring Harbor Laboratory (for neuroscience and molecular genetics research), the Salk Institute (for viral research), and the Scientists Institute for Public Information between 1968 and 1970.
5. funded population control studies by Planned Parenthood-World Population, New York, N.Y.
6. funded the Community Blood Council of Greater New York, Inc., the council of doctors who established the infamous New York City Blood Bank which allowed more than 10,000 hemophiliacs and countless others to become infected with HIV because they allegedly didn't want to spend \$150 million to screen the blood.
7. maintained [Laurence S. Rockefeller](#), the director of the Community Blood Council of Greater New York the international blood bankers and the president of the Rockefeller Brothers Fund, as chairman of the board of the Memorial Sloan-Kettering Cancer Center, and a trustee for the Sloan Foundation.
8. gave in excess of \$20,000 annually to the Council on Foreign Relations.

9. maintained among its marketable securities, 16,505 shares of Chase Manhattan Bank stock (in 1967, which it apparently sold by 1970 probably to avoid conflict of interest charges) along with 24,400-53,000 shares issued by Merck & Co., Inc. (the company whose President, George W. Merck, was director of America's biological weapons industry, and whose hepatitis B and polio vaccines most plausibly transmitted AIDS throughout the world).

Also in '*Emerging Viruses: AIDS & Ebola*,' you will learn exactly what was done with the \$10 million Congress gave the DOD for the development of AIDS-like viruses, because I published the relevant contracts.

You will learn that **Dr. Robert Gallo**, the famous NCI molecular biologist, pardoned by President Clinton last year for **scientific fraud and misconduct**, and credited with the discovery of the AIDS virus, set about to develop immune system ravaging, AIDS-like viruses, along with other *Litton Bionetics* researchers.

You will learn that they took monkey viruses that were humanly benign, recombined them with DNA, RNA, and enzymes from other animal viruses that caused leukemia's, lymphomas, and sarcomas, and then to get them to jump species, they cultured these new mutant viruses in human white blood cells in some studies, and human fetal tissue cells in other studies, to produce immune-system-destroying, cancer-causing viruses that could enter humans and produce virtually identical effects to what the AIDS virus is currently doing in people around the world. Indeed, it was contaminated live viral vaccines that spread this disease and likely others, including chronic fatigue, certain leukemia's, and possibly *Gulf War Syndrome* as well, to vast populations.

Dr. Len Horowitz reveals important aspects of our public health services and the involvement of creating viruses with the idea of killing as many people as possible. The HIV issue with Dr. Robert Gallo is the scandal that dogs the conscience of Dr. Anthony Fauci of the NIAID. Dr. Anthony Fauci and the late Dr. Robert Gallo, deliberately stated that HIV = AIDS, a manufactured lie by the pair who profited by patenting a cocktail of drugs that costs AIDS victims thousands of dollars a year. This pair took the Chronic Fatigue Syndrome and labeled it AIDS. HIV had been discovered by previous researchers before Drs. Fauci and Gallo, labeled it AIDS. Interesting the SV-40 virus that children received in their Polio vaccines during the 1950s and early 1960s, continued to be injected up to the early 1980s despite what the public was told. The CDC has quickly removed a page from their website, which is now [cached here](#), admitting that more than 98 million Americans received one or more doses of polio vaccine within an 8-year span when a proportion of the vaccine was contaminated with a cancer causing polyomavirus called SV40. It has been estimated that 10-30 million Americans could have received an SV40 contaminated dose of the vaccine. The fake fact-checkers like Snopes have gone to great lengths to obfuscate the truth since at least 65 million Americans were at risk for cancer in their adult life.

SV40 is an abbreviation for Simian vacuolating virus 40 or *Simian virus 40*, a [polyomavirus](#) that is found in both monkeys and humans. Like other polyomaviruses, SV40 is a DNA virus that has been found to cause tumors and cancer.

SV40 is believed to suppress the transcriptional properties of the tumor-suppressing genes in humans through the [SV40 Large T-antigen](#) and [SV40 Small T-antigen](#). Mutated genes may contribute to uncontrolled cellular proliferation, leading to cancer.

Michele Carbone, Assistant Professor of Pathology at Loyola University in Chicago, has recently isolated fragments of the SV-40 virus in human bone cancers and in a lethal form of lung cancer called mesothelioma. He found SV-40 in 33% of the osteosarcoma bone cancers studied, in 40% of other bone cancers, and in 60% of the mesotheliomas lung cancers, writes Geraldo Fuentes.

The implications here are profound and serve as a reminder that Public Health agencies are negligent at the bare minimum and more likely criminal in what lies between manslaughter and murder. There have been far too many “accidents” that suggest a hidden agenda of genocide or euthanasia is afoot in the vaccine industry.

Dr. Michele Carbone openly acknowledged HIV/AIDS was spread by the hepatitis B vaccine produced by Merck & Co. during the early 1970s. It was the first time since the initial transmissions took place in 1972-74, that a leading expert in the field of vaccine manufacturing and testing has openly admitted the Merck & Co. liability for AIDS.

The matter-of-fact disclosure came during discussions of polio vaccines contaminated with SV40 virus which caused cancer in nearly every species infected by injection. Many authorities now admit much, possibly most, of the world's cancers came from the Salk and Sabin polio vaccines, and hepatitis B vaccines, and produced in monkeys and chimps.

It is said mesothelioma is a result of asbestos exposure, but research reveals that 50% of the current mesotheliomas being treated no longer occurs due to asbestos but rather the SV-40 virus contained in the polio vaccination. In addition, according to researchers from the Institute of Histology and General Embryology of the University of Ferrara, SV-40 has turned up in a variety other tumors. By the end of 1996, dozens of scientists reported finding SV40 in a variety of bone cancers and a wide range of brain cancers, which had risen 30 percent over the previous 20 years.

The SV-40 virus is now being detected in tumors removed from people never inoculated with the contaminated vaccine, leading some to conclude that those infected by the vaccine might be spreading SV40.

Soon after its discovery, SV40 was identified in the oral form of the polio vaccine produced between 1955 and 1961 produced by American Home Products (dba Lederle). Both the oral, live virus and injectable inactive virus were affected. It was found later that the technique used to inactivate the polio virus in the injectable vaccine, by means of formaldehyde, did not reliably kill SV40.

Just two years ago, the U.S. government finally added formaldehyde to a list of known carcinogens and admitted that the chemical styrene might cause cancer. Yet, the substance is still found in almost every vaccine.

According to the Australian National Research Council, fewer than 20% but perhaps more than 10% of the general population may be susceptible to formaldehyde and may react acutely at any exposure level. More hazardous than most chemicals in 5 out of 12 ranking systems, on

at least 8 federal regulatory lists, it is ranked as one of the most hazardous compounds (worst 10%) to ecosystems and human health (Environmental Defense Fund).

In the body, formaldehyde can cause proteins to irreversibly bind to DNA. Laboratory animals exposed to doses of inhaled formaldehyde over their lifetimes have developed more cancers of the nose and throat than are usual.

Facts Listed on The CDC Website about SV40:

- SV40 is a virus found in some species of monkey.
- SV40 was discovered in 1960. Soon afterward, the virus was found in **polio** vaccine.
- SV40 virus has been found in certain types of **cancer** in humans.

Additional Facts

- In the 1950s, rhesus monkey kidney cells, which contain SV40 if the animal is infected, were used in preparing **polio** vaccines.
- Not all doses of IPV were contaminated. It has been estimated that 10-30 million people actually received a vaccine that contained SV40.
- Some evidence suggests that receipt of SV40-contaminated **polio** vaccine may increase risk of **cancer**.

A Greater Perspective on Aerial Spraying and SV40

The Defense Sciences Office of the Pathogen Countermeasures Program, in September 23, 1998 funded the University of Michigan's principal investigator, Dr. James Baker, Jr. Dr. Baker, Director of Michigan Nanotechnology Institute for Medicine and Biological Sciences under several DARPA grants. Dr. Baker developed and focused on preventing pathogens from entering the human body, which is a major goal in the development of counter measures to Biological Warfare. This research project sought to develop a composite material that will serve as a pathogen avoidance barrier and post-exposure therapeutic agent to be applied in a topical manner to the skin and mucous membranes. The composite is modeled after the immune system in that it involves redundant, non-specific and specific forms of pathogen defense and inactivation. This composite material is now utilized in many nasal vaccines and vector control through the use of hydro-gel, nanosilicon gels and actuator materials in vaccines.

Through Dr. Baker's research at the University of Michigan; he developed dendritic polymers and their application to medical and biological science. He co-developed a new vector system for gene transfer using synthetic polymers. These studies have produced striking results and have the potential to change the basis of gene transfer therapy. Dendrimers are nanometer-sized water soluble polymers that can conjugate to peptides or arbohydrates to act as decoy molecules to inhibit the binding of toxins and viruses to cells. They can act also as complex and stabilize genetic material for prolonged periods of time, as in a "time released or delayed gene transfer". Through Dr. Baker's ground breaking research many pharmaceutical and biological pesticide manufacturers can use these principles in DNA vaccines specific applications that incorporate the Simian Monkey Virus SV40.

WEST NILE VIRUS SPRAYING

In 2006 Michael Greenwood wrote an article for the Yale School of Public Health entitled, "Aerial Spraying Effectively Reduces Incidence of West Nile Virus (WNV) in Humans." The article stated that the incidence of human West Nile virus cases can be significantly reduced through large scale aerial spraying that targets adult mosquitoes, according to research by the Yale School of Public Health and the California Department of Public Health.

Under the mandate for aerial spraying for specific vectors that pose a threat to human health, aerial vaccines known as DNA Vaccine Enhancements and Recombinant Vaccine against WNV may be tested or used to "protect" the people from vector infection exposures. DNA vaccine enhancements specifically use Epstein-Barr viral capsids with multi human complement class II activators to neutralize antibodies. The recombinant vaccines against WNV use Rabbit Beta-globulin or the poly (A) signal of the SV40 virus. In early studies of DNA vaccines it was found that the negative result studies would go into the category of future developmental research projects in gene therapy. During the studies of poly (A) signaling of the SV40 for WNV vaccines, it was observed that WNV will lie dormant in individuals who were exposed to chicken pox, thus upon exposure to WNV aerial vaccines the potential for the release of chicken pox virus would cause a greater risk to having adult onset Shingles.

CALIFORNIA AERIAL SPRAYING for WNV and SV40

In February 2009 to present date, aerial spraying for the WNV occurred in major cities within the State of California. During spraying of Anaheim, CA a Caucasian female (age 50) was exposed to heavy spraying, while doing her daily exercise of walking several miles. Heavy helicopter activity occurred for several days in this area. After spraying, she experienced light headedness, nausea, muscle aches and increased low back pain. She was evaluated for toxicological mechanisms that were associated with pesticide exposure due to aerial spraying utilizing advanced biological monitoring testing. The test results which included protein band testing utilizing Protein Coupled Response (PCR) methods were positive for KD-45. KD-45 is the protein band for SV-40 Simian Green Monkey virus. Additional tests were performed for Epstein-Barr virus capsid and Cytomegalia virus which are used in bioengineering for gene delivery systems through viral protein envelope and adenoviral protein envelope technology. The individual was positive for both; indicating a highly probable exposure to a DNA vaccination delivery system through nasal inhalation.

The question of the century is how many other viruses and toxins are within current day vaccines that we'll only find out about in a few decades?

But internal memos from Lederle Laboratories, the chief producer of polio vaccine in the United States, indicate SV40 may not have been completely removed.

According to one memo, SV40 was found in three of 15 lots of the oral vaccine seven months after the federal directive was issued in March 1961. Lederle released the contaminated vaccine to the public anyway, the memo shows.

The documents also suggest that the company failed to test the monkey-kidney seed strains used to make the bulk polio vaccine for contamination, despite a written warning from Dr. Albert Sabin, who developed the oral vaccine.

Lederle and the U.S. government insist there is no evidence that any contaminated vaccine was distributed after the directive went into effect. We know that pharmaceutical companies sell these vaccines in third world countries long after they have been withdrawn from the shelves of American companies.

Scientists discovered SV40 in the Salk polio vaccine in 1960. By then as many as 30 million Americans had been given injections of the SV40-tainted polio vaccine, which was first licensed in 1955.

In recent years more than 60 scientific studies have found SV40 in rare human brain, bone and lung-related cancers, the same kinds of tumors the virus caused in laboratory animals. Some scientists believe SV40 may play a role in causing those cancers.

One of the biggest mysteries, however, is why SV40 has been found in tumors removed from people who never received the contaminated Salk vaccine.

Researchers have several theories for how the virus could have spread from those infected through the Salk vaccine: in transmission from mother to fetus or through breast milk; through sexual activity or a flu-like virus.

But the Lederle documents, which were obtained by Philadelphia attorney Stanley Kops in litigation not related to SV40, raise the possibility the virus might have been transmitted by contaminated oral vaccine, licensed for production in 1962.

The documents include:

-- A November 1961 memo saying the virus was found in three of 15 lots of vaccine. According to the memo, Dr. Roderick Murray, head of the government's program to ensure vaccine purity, allowed the lots to be released.

To comply with the removal order, Lederle had switched from rhesus monkeys, which are natural hosts for SV40, to African green monkeys, supposedly free from SV40. However, the memo notes that SV40 was found in 10 percent of the green monkeys.

-- A letter from Sabin to Lederle in October 1962, warning that sufficient testing for SV40 contamination had not been done on one of his strains of weakened polio virus that formed the seed for bulk vaccine production.

-- A confidential memo in 1979 from a Lederle official stating: "It should be noted that Lederle did not test the original Sabin seeds for extraneous agents or neurovirulence since Dr. Sabin assured us that this had been done."

-- Another memo stating that Lederle did not test the seed "since only 50 (milliliters) or less of each seed were provided by Dr. Sabin."

The two memos added that testing was unnecessary because later vaccine samples submitted for license were free of SV40.

Kops also said that he had taken testimony in 1998 from a top Lederle official who said the company did not have the test results from many of the vaccine lots.

"The vaccine manufacturers and the government need to disclose what really happened," said Kops. "Without the facts, (scientists) will continue to look in the wrong places to explain how people were infected with SV40 after 1961."

Lederle did not respond to requests for comment.

At a 1997 conference, however, a company representative outlined the series of tests the company uses to detect SV40 contamination. The company also says that it uses antiserum to neutralize any SV40 in the "master seeds."

But it is not clear whether these procedures were in place in the years after the U.S. government issued its directive.

Last year, a lawsuit was filed in Los Angeles against Lederle by the parents of 2 1/2-year-old Alexander Horwin who died of a brain tumor that later tested positive for SV40. The suit claims that the tumor was caused by SV40 and that he became infected through a 1997 oral polio vaccine.

Kops and attorney Donald MacLachlan represent a New Jersey family that is considering a suit against vaccine manufacturers.

In 1970, surgeons removed a large brain tumor from 2-year-old Mark Moreno. He since has undergone five more surgeries and now wears a protective helmet over the large opening in his cranium where bone grafts never took. Moreno, now 33, lives with his mother and requires daily assistance.

Recent tests show Moreno's tumor was riddled with SV40, according to the lawyers.

Eileen Moreno, Mark's mother, believes her son's brain tumor was caused by SV40 and that he was infected through the oral polio vaccine in 1968.

Last year, two investigators from the U.S. Food and Drug Administration used genetic testing to examine 30 samples of bulk oral polio vaccine used in the United States going back to 1972. They reported finding no SV40.

But the government has not used the genetic tests to determine whether vaccine made prior to 1972 was contaminated.

Dr. William Egan, deputy director of the FDA's vaccine research branch, said testing went back only to 1972 because those samples were the only ones available to them. "*There was nothing sinister,*" he said. Of course, we need not expect a confession!

MacLachlan said he finds it "incredible" that the government hasn't comprehensively investigated the possibility of SV40 contamination of the oral vaccine.

Simian virus Q&A Q: How widespread is the SV40 infection?

A: Scientists and government health officials don't know, because no comprehensive studies have addressed the question. What is known is that during the 1950s and '60s, at least 10 million to 30 million Americans -- and more than 100 million people worldwide -- were given SV40-contaminated polio vaccine. The virus also has been found in people who did not receive contaminated vaccine.

Q: Can I be tested for SV40?

A: An accurate blood test does not exist. Current antibody blood tests can be inaccurate, scientists say, because they also may detect the presence of closely related viruses, and SV40 may be present at such a low level that no antibodies are produced. Researchers are working to create an effective test.

Q: In which kinds of cancers has SV40 been found?

A: The virus has been detected in rare cancers, including:

-- Mesothelioma, a fatal tumor of the membrane surrounding the lungs. Few cases were reported prior to 1950, but the incidence has grown in the United States to 2,000 to 4,000 cases a year, with greater incidence in Europe.

-- Brain cancers: Primarily ependymomas and choroid plexus tumors, but also astrocytomas, glioblastomas, medulloblastoma, and meningiomas. Less than 1,000 cases of these cancers are reported in the United States each year.

-- Bone cancers: Primarily osteosarcomas, but also chondrosarcoma and giant cell tumors. These also make up fewer than 1,000 cases annually.

Parents around the world need to stop trusting pediatric doctors except for broken bones and stitches and such because the chances are high that these doctors will inflict serious harm on their young charges.

The majority of pediatricians are ignorant of the facts and afraid to stand up to pharmaceutical manufacturers though they know how to smile and be nice, but being nice has nothing to do with being honestly caring. They would rather use their poison needles and take every opportunity to inject their young patients no matter what their condition is, even when it is known that a child who is ill with fever or other symptoms should not receive vaccination.
